[57] CLAIM

The ornamental design for an electrical connector housing, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of an electrical connector housing showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a rear elevational view thereof; FIG. 7 is a cross-sectional view thereof taken along line 7—7 of FIG. 2; FIG. 8 is a cross-sectional view thereof along line 8—8 of FIG. 5; FIG. 9 is a cross-sectional view thereof taken along line 9—9 of FIG. 2; FIG. 10 is a cross-sectional view thereof taken along line 10—10 of FIG. 2; FIG. 11 is a cross-sectional view thereof taken along line 7—7 of FIG. 2 looking in the opposite direction and showing the housing in use. The broken line showing of the conductors, terminals and the corresponding housing is included for the purpose of illustrating environmental elements only and forms no part of the claimed design; and, FIG. 12 is a front and upper right perspective view thereof shown on a reduced scale with the terminal retainers separated at the top and bottom. The broken line showing of the corresponding housing and related elements is included for the purpose of illustrating environmental elements only and forms no part of the claimed design.

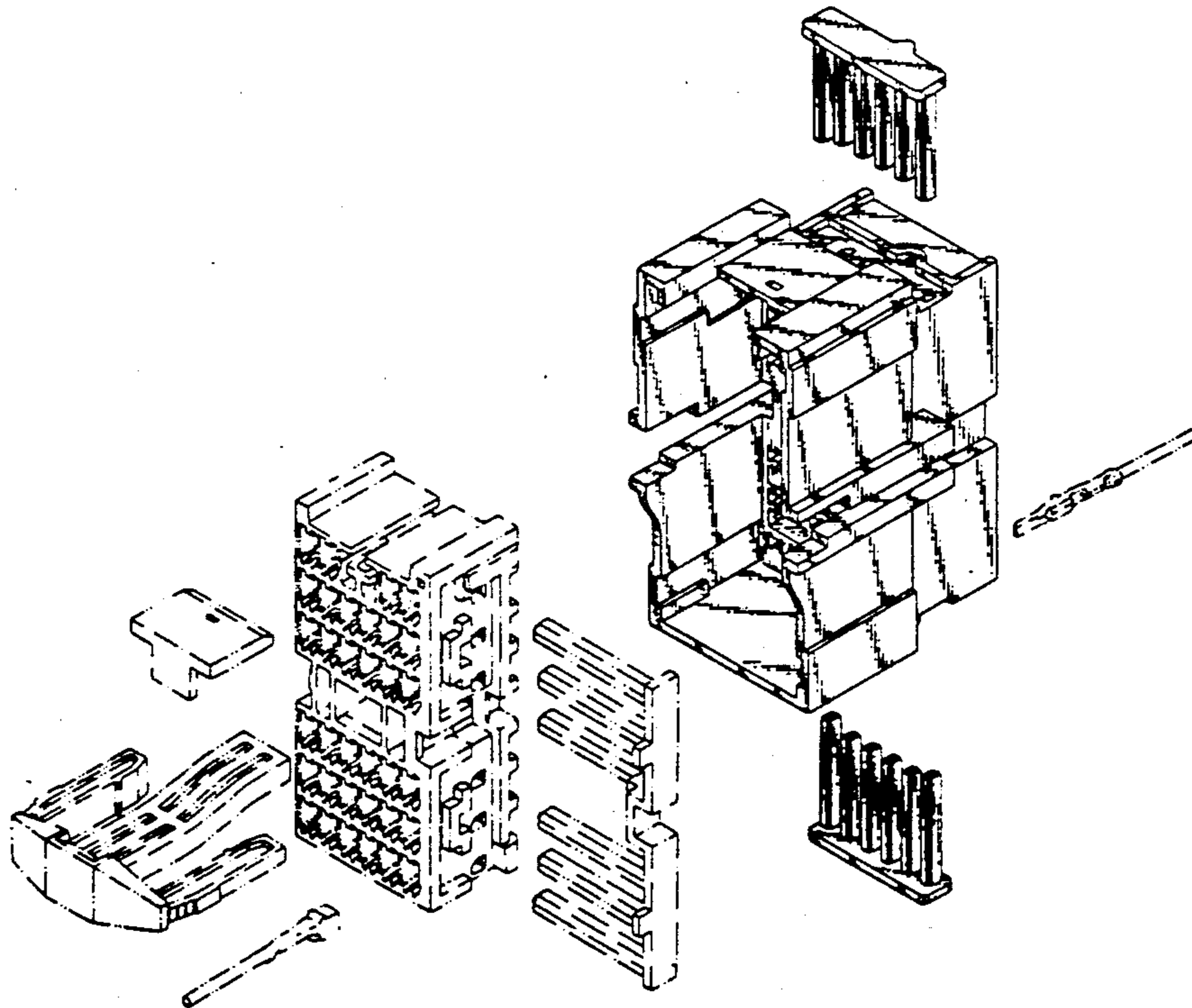

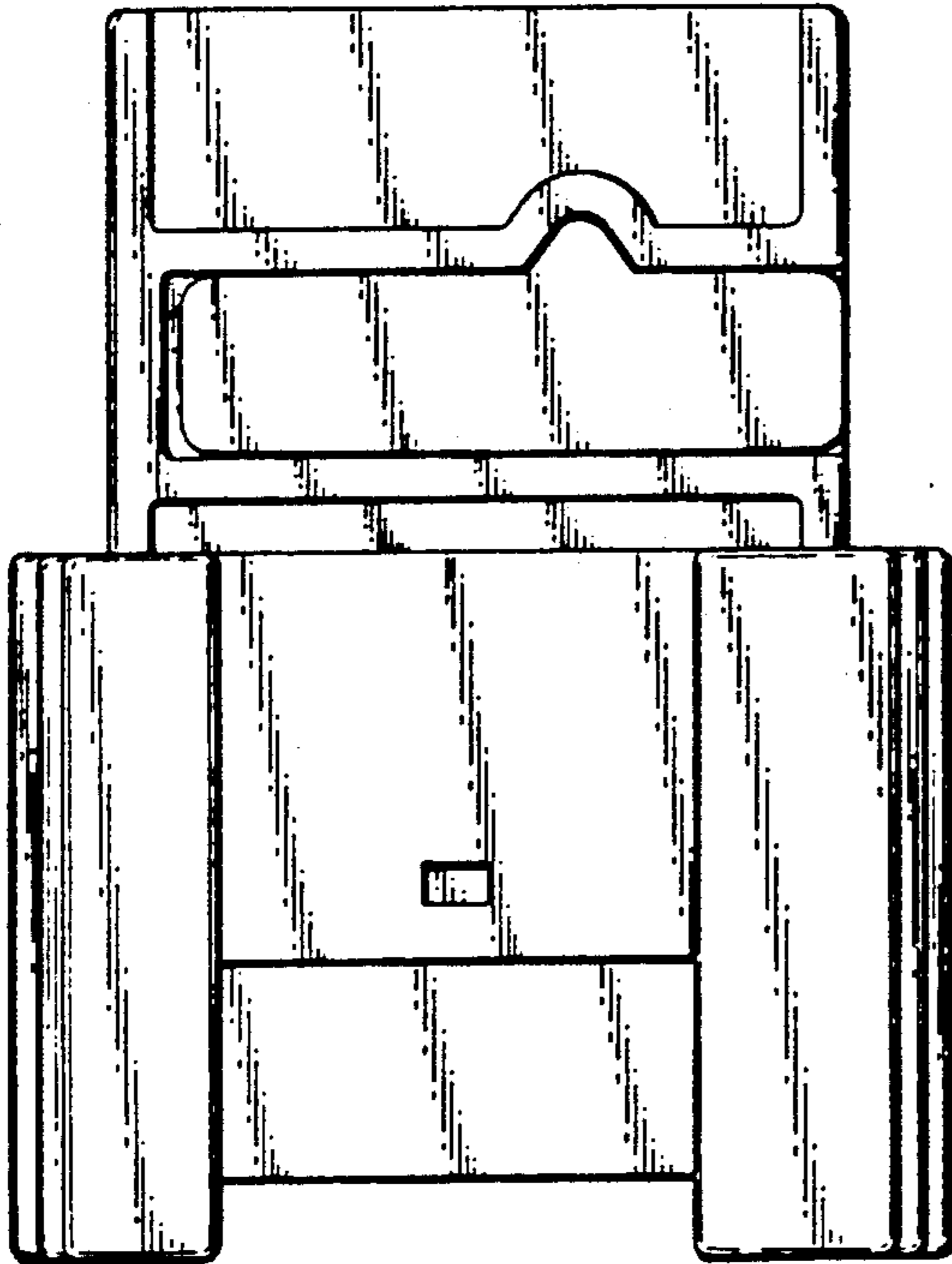

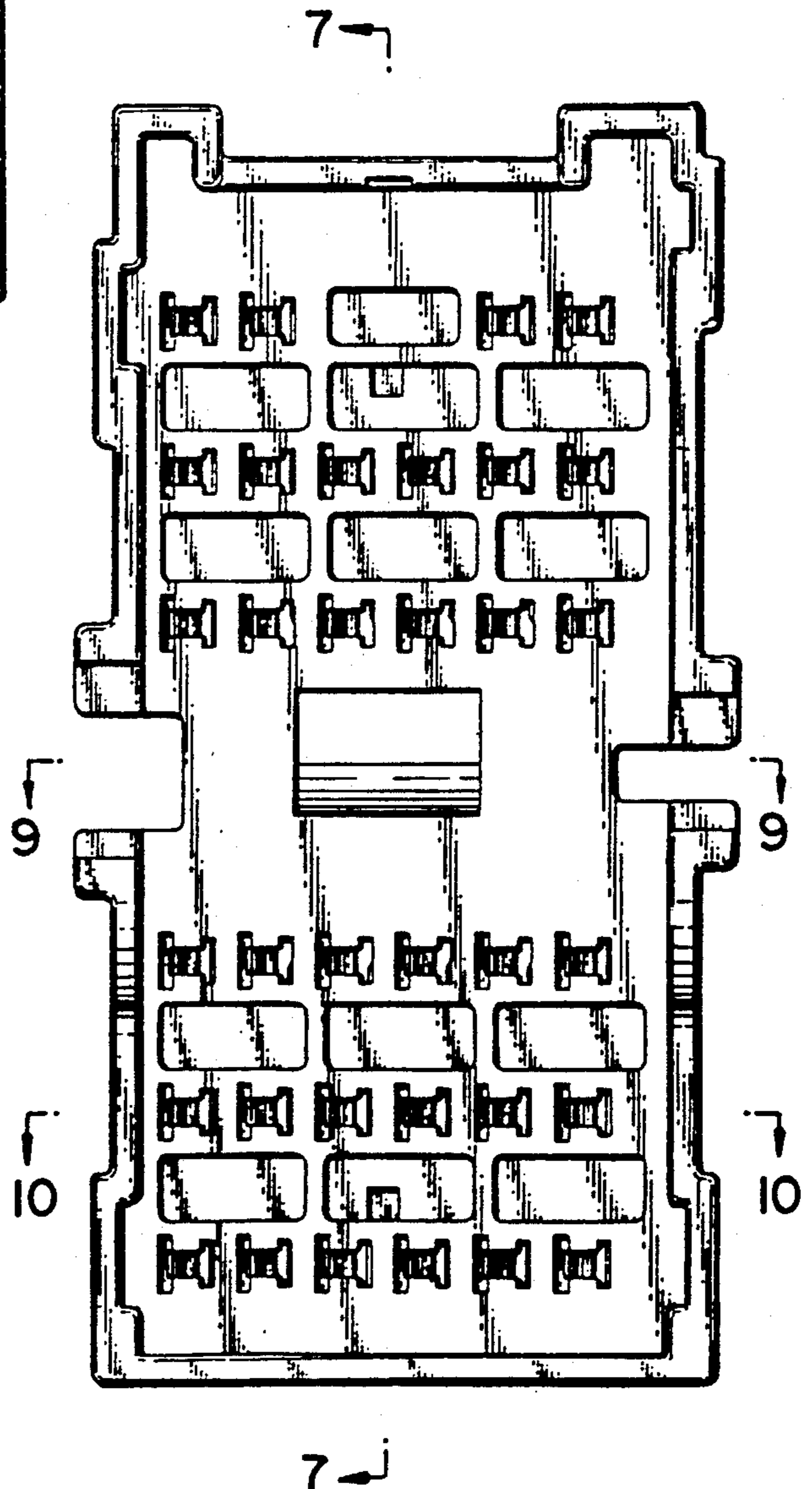

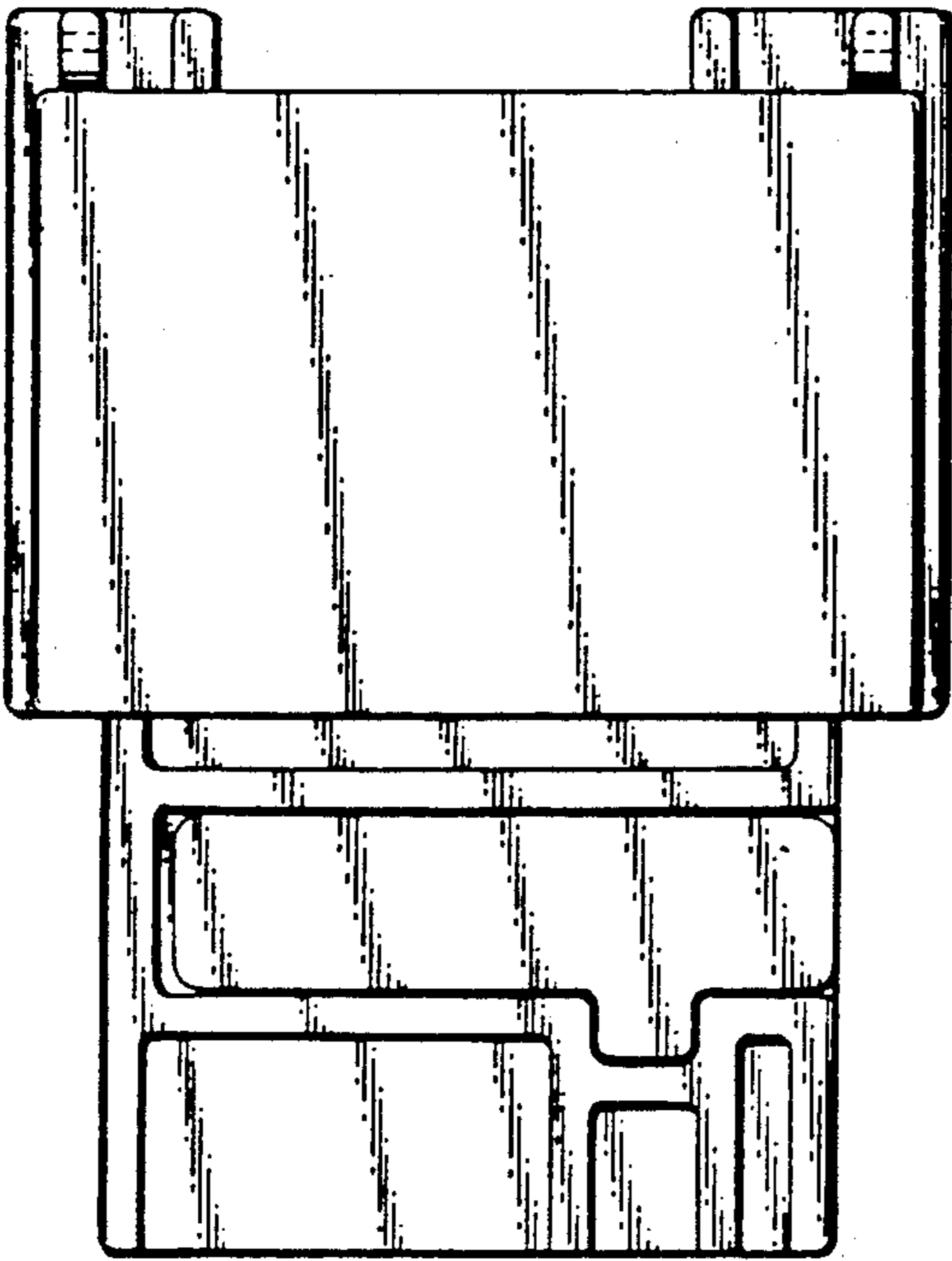

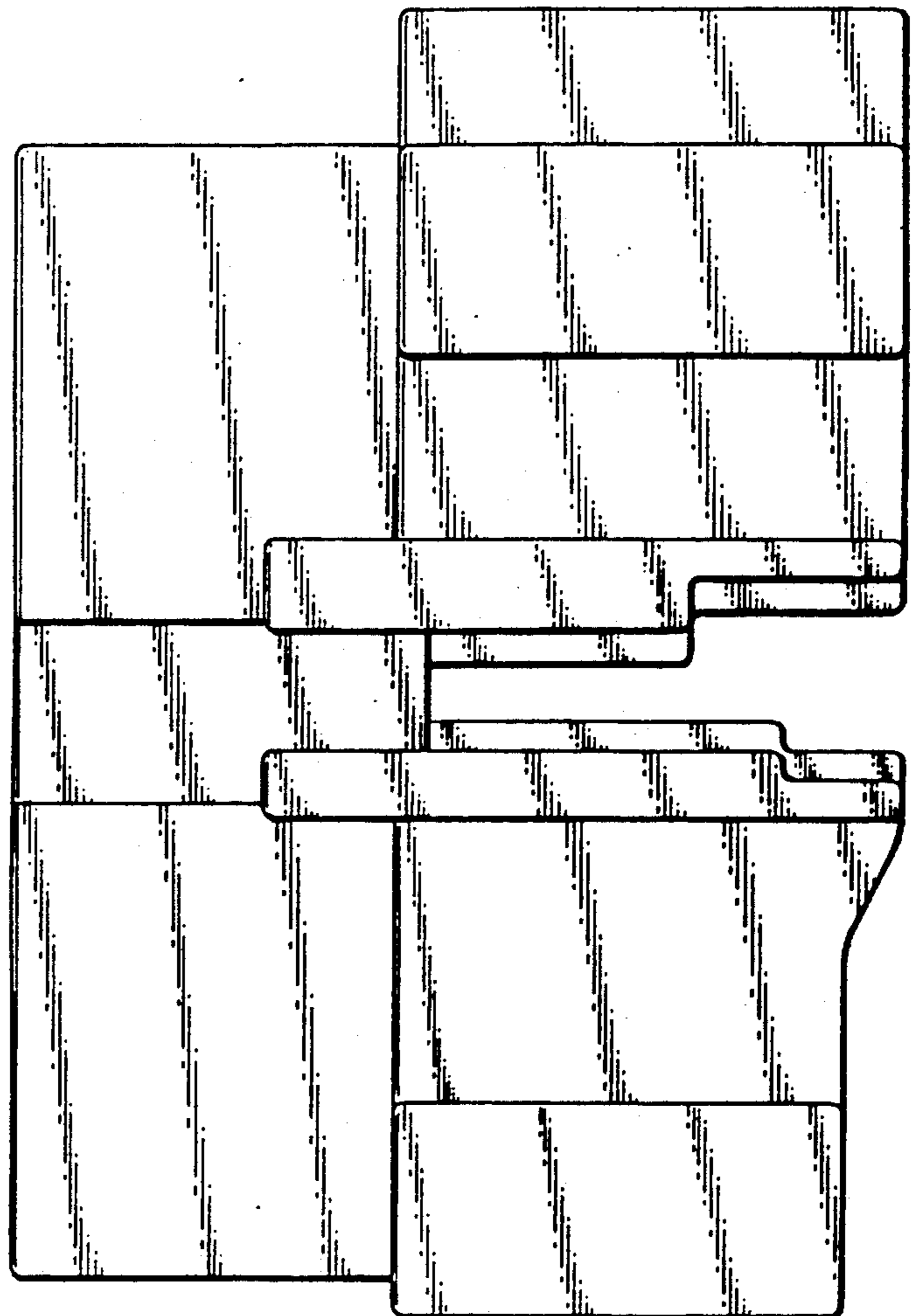

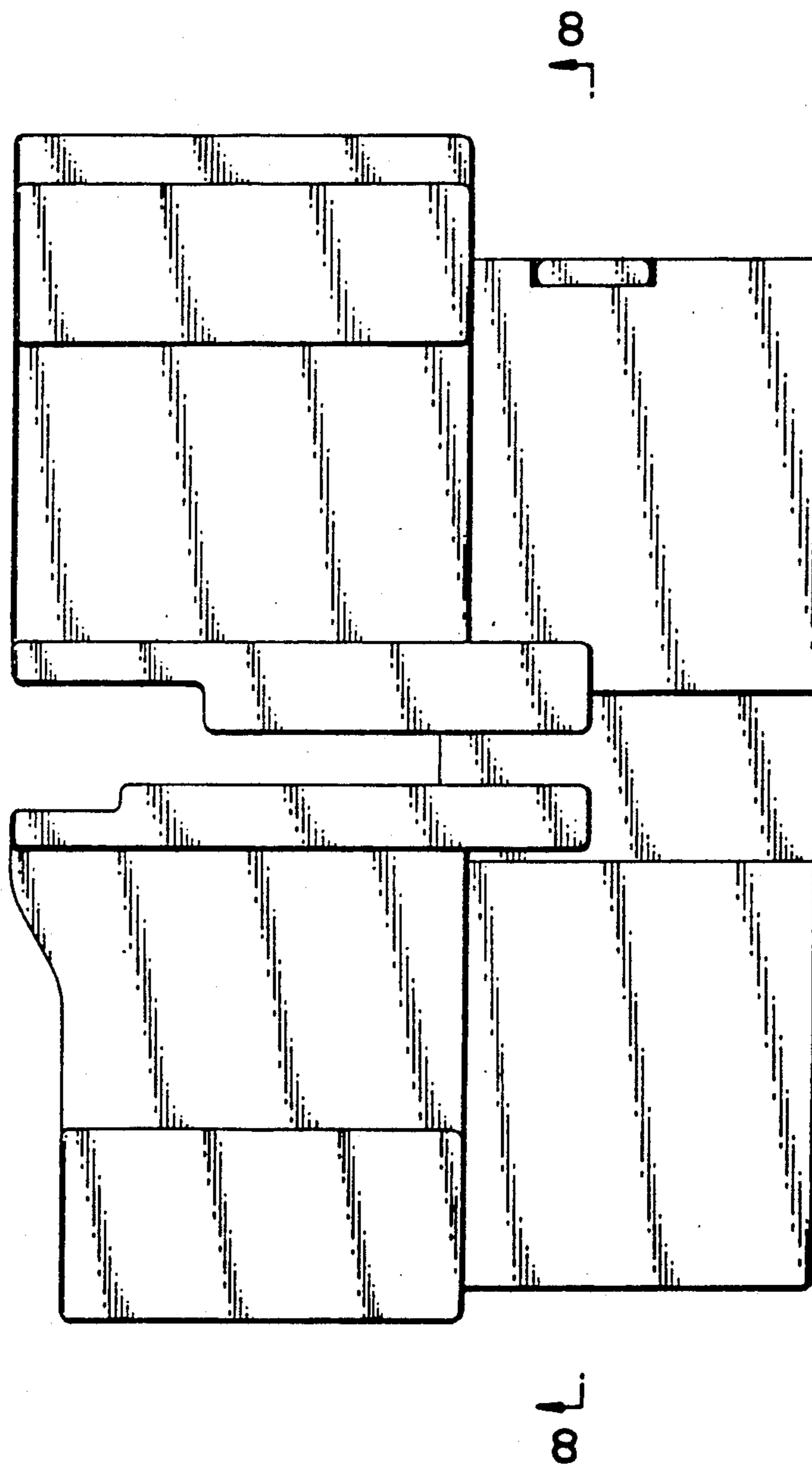

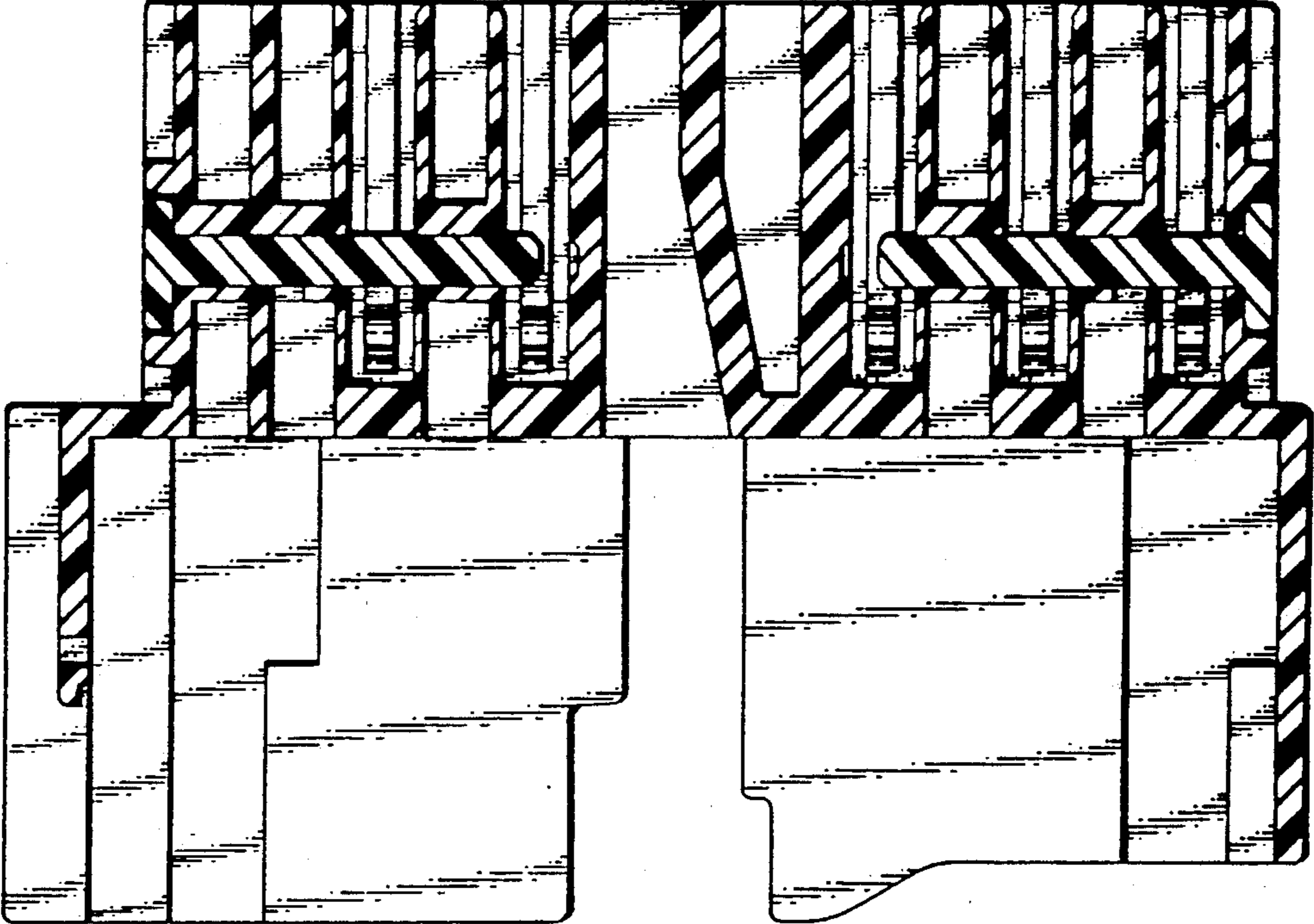

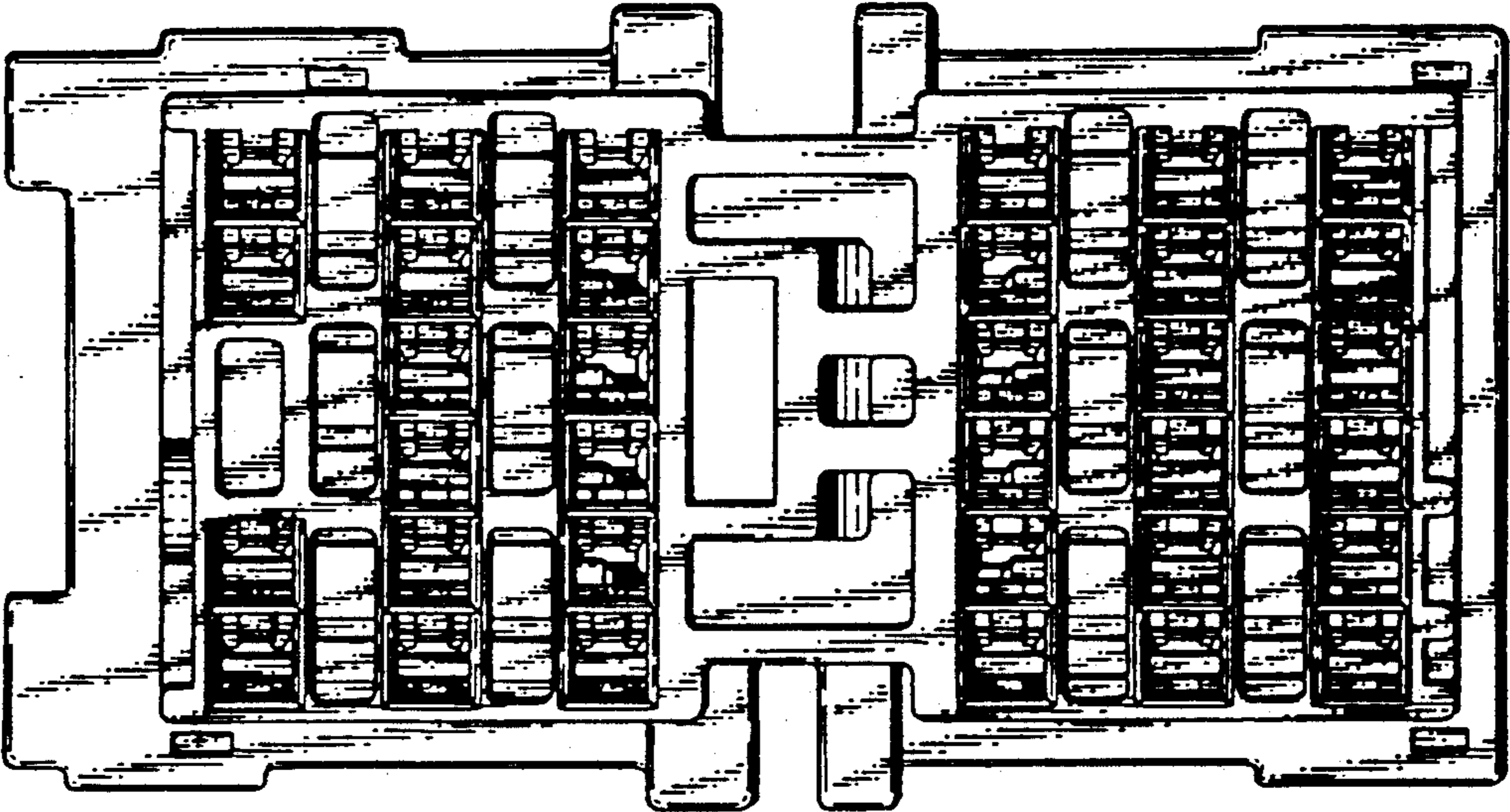

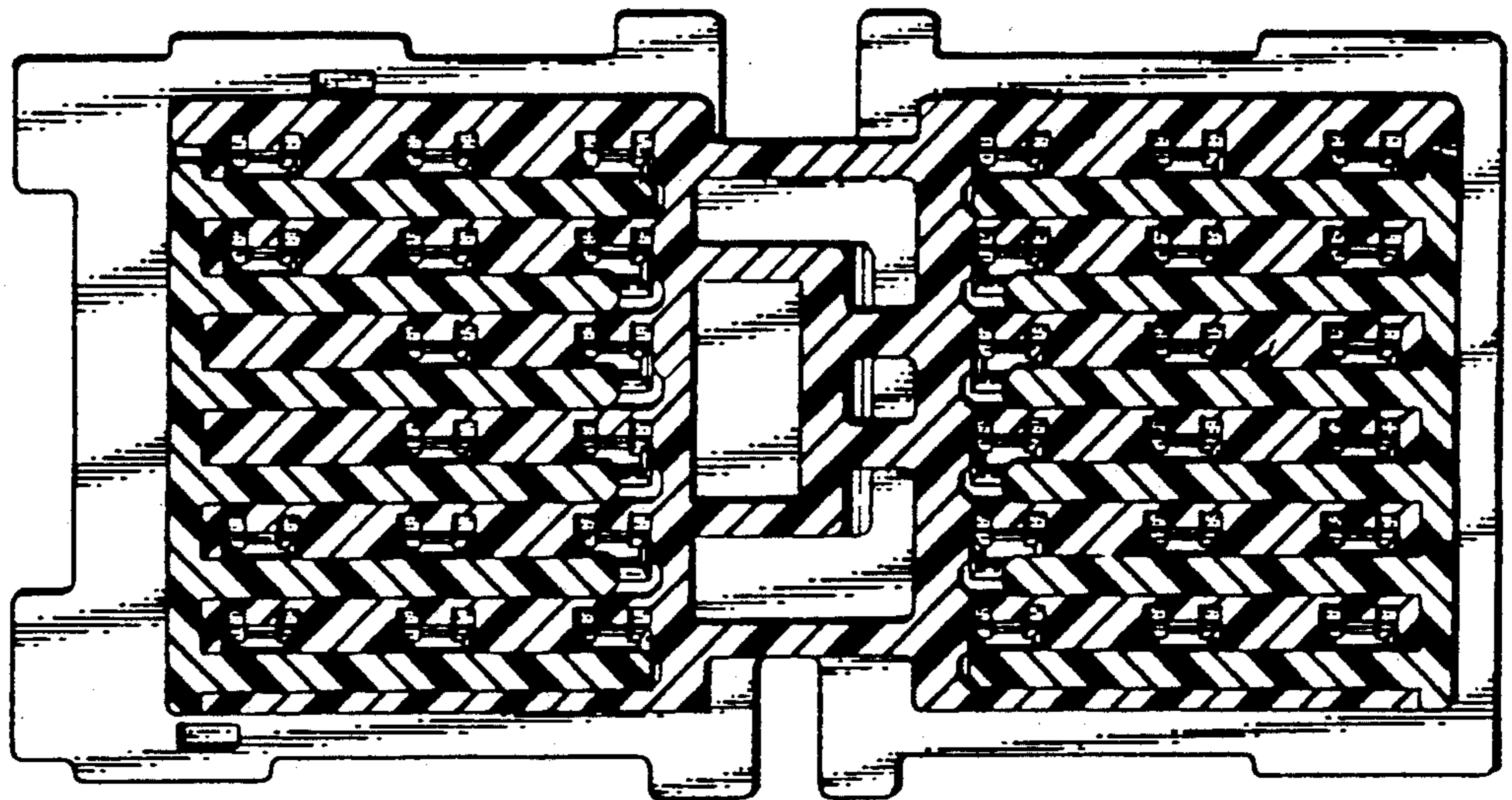

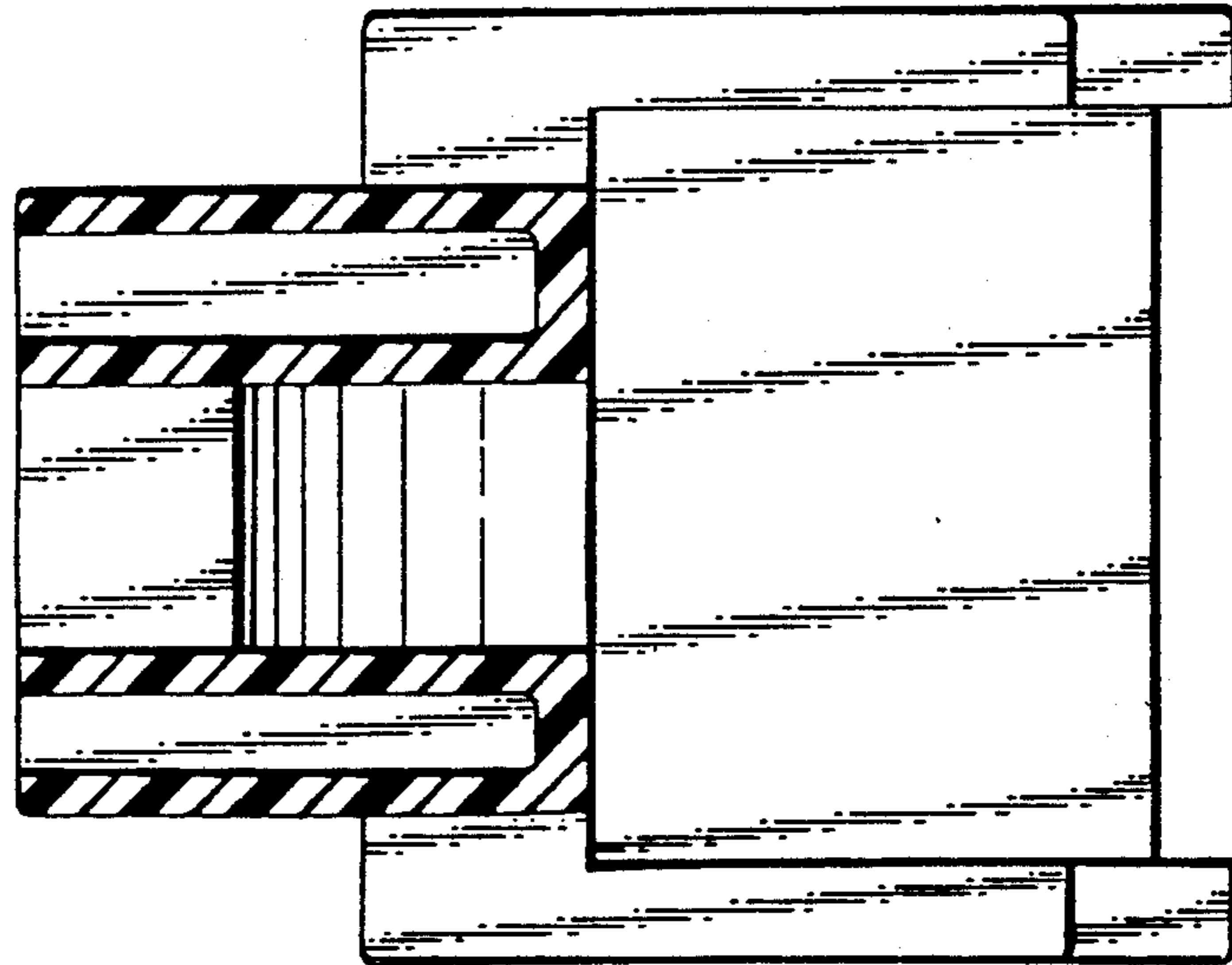

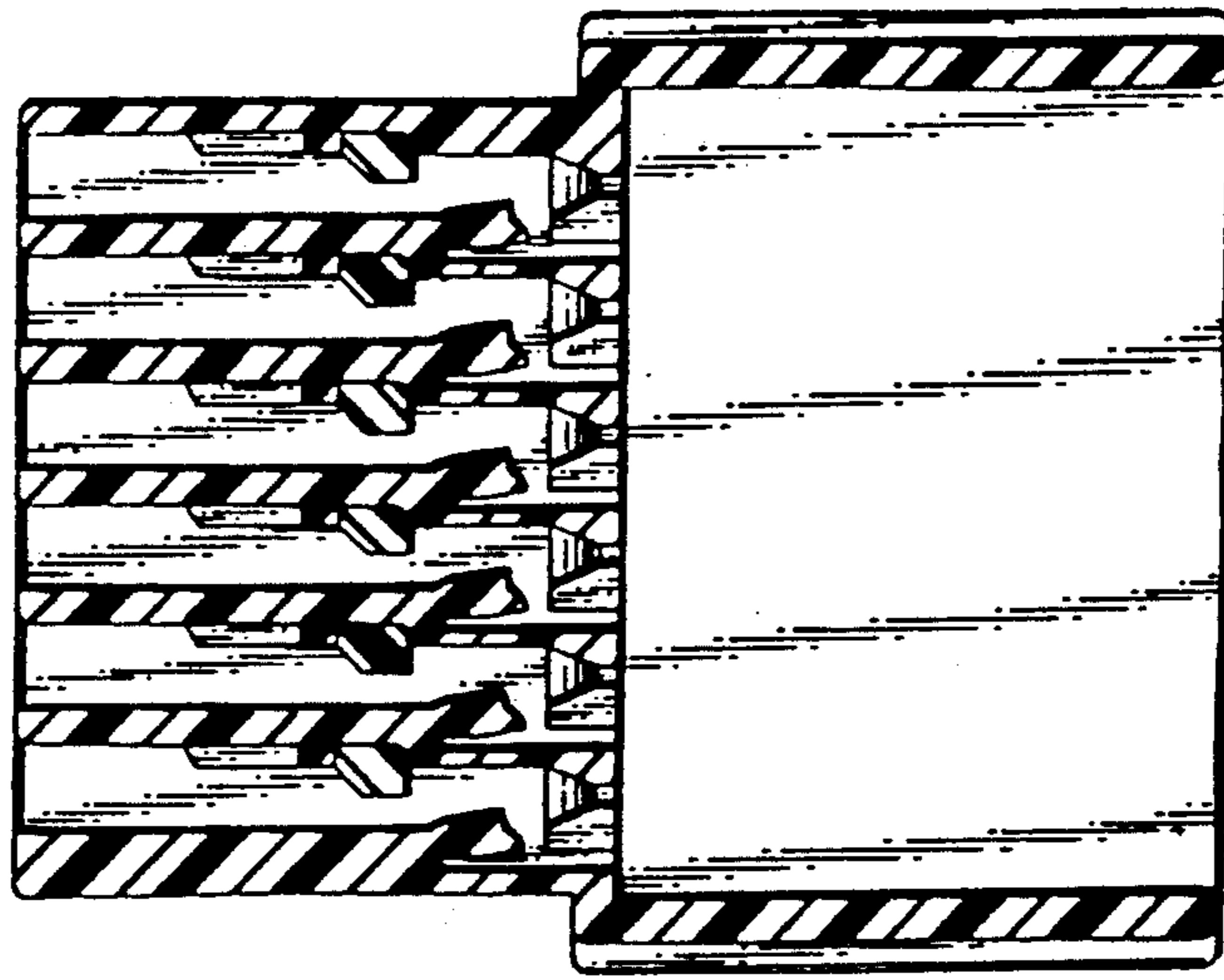
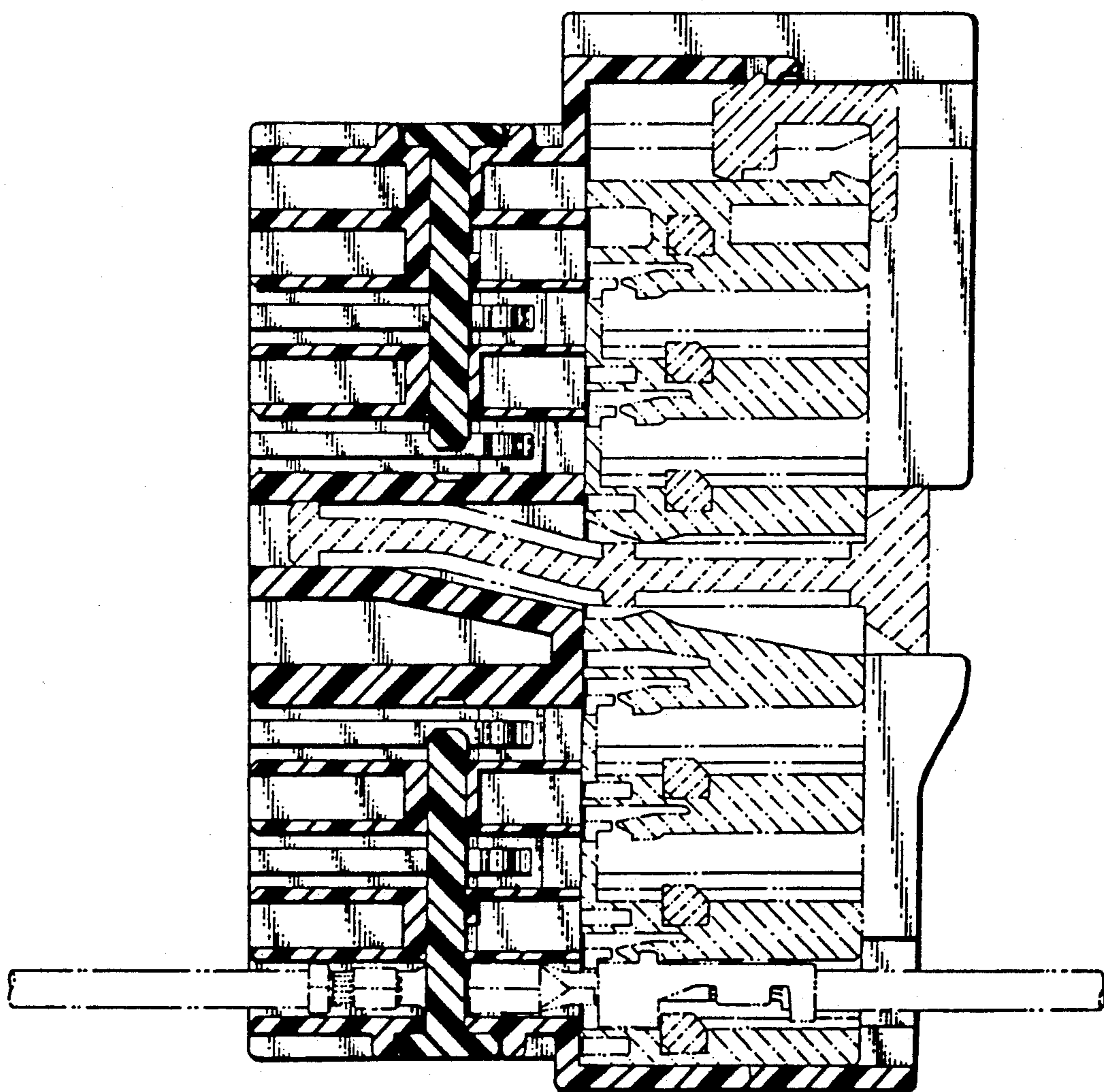

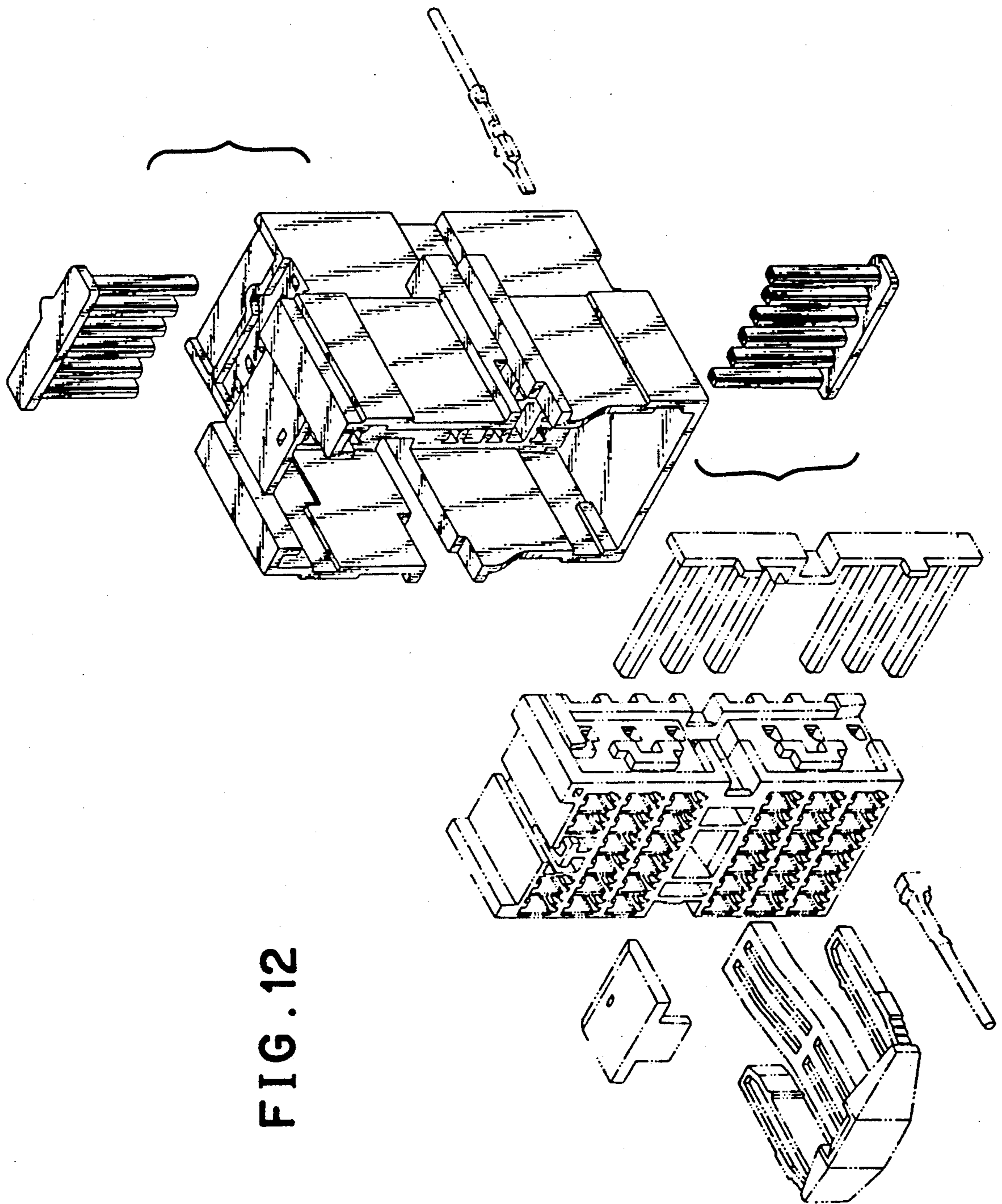
