FIG. 3 is a front elevational view of FIG. 2;

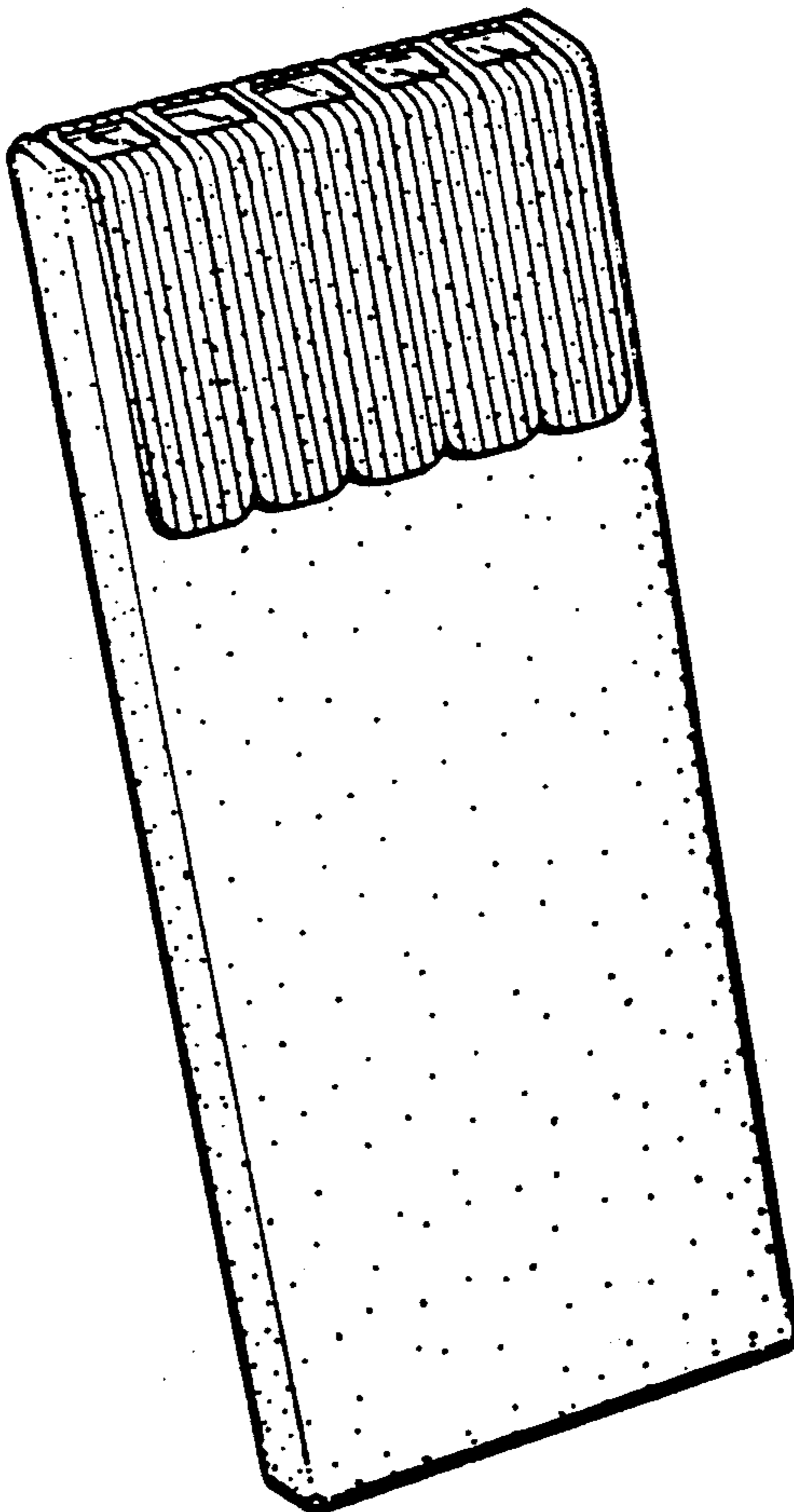
FIG. 4 is a right side elevational view of FIG. 2, the left side being a mirror image thereof;

FIG. 8 is a front elevational view of FIG. 7.



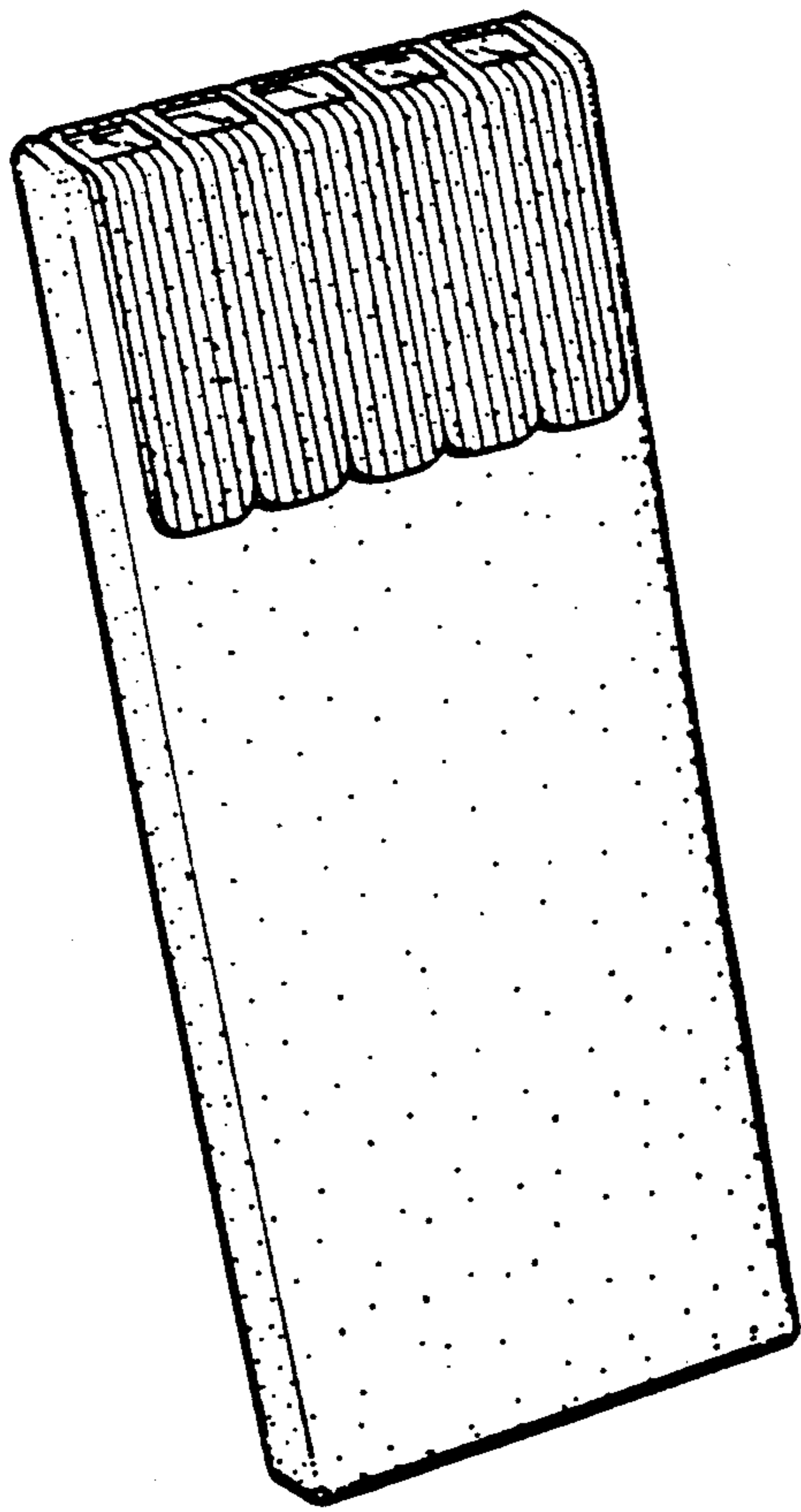

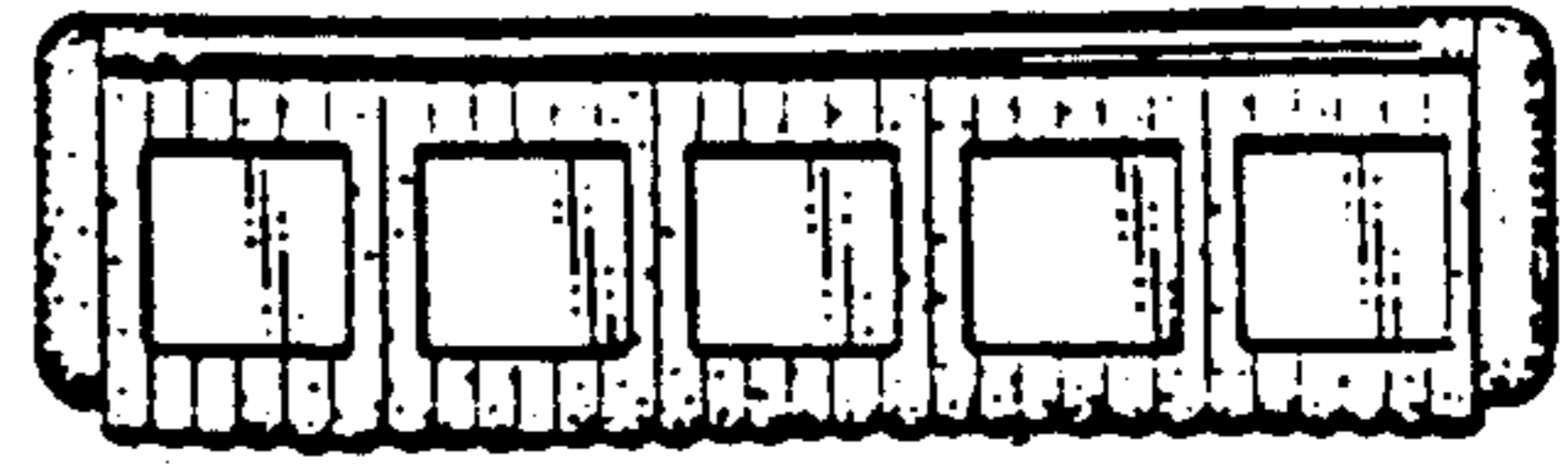

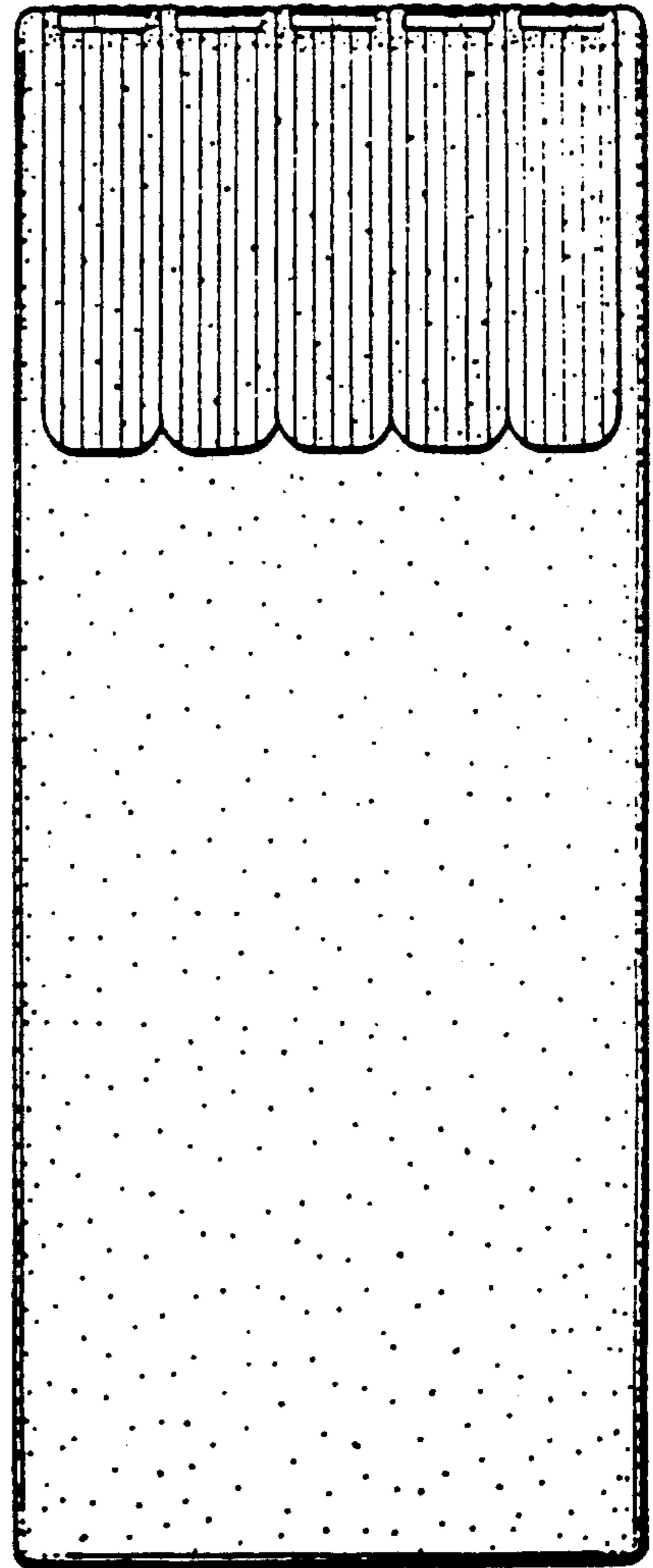
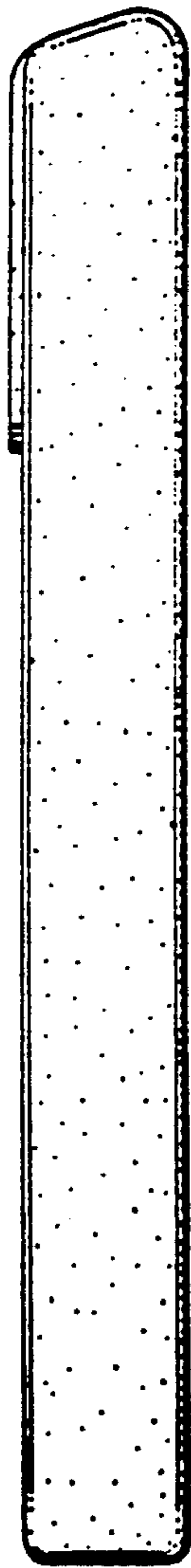


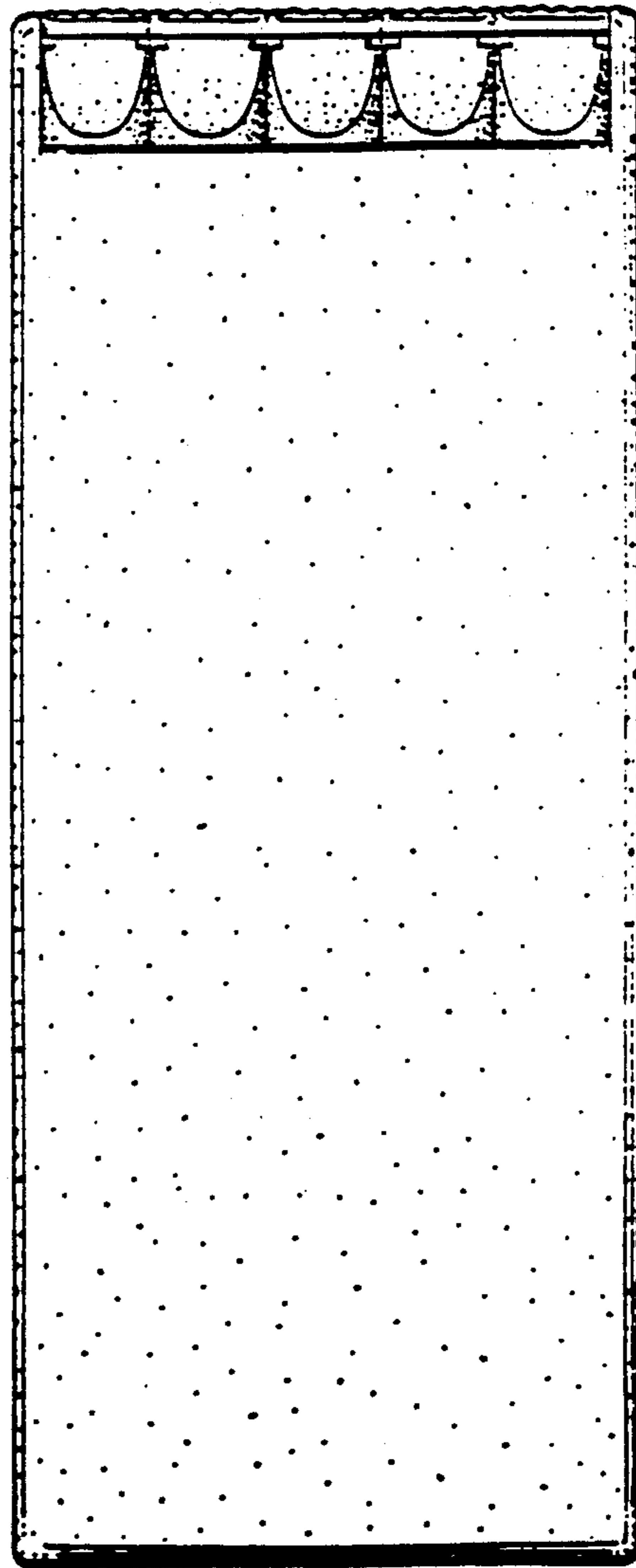

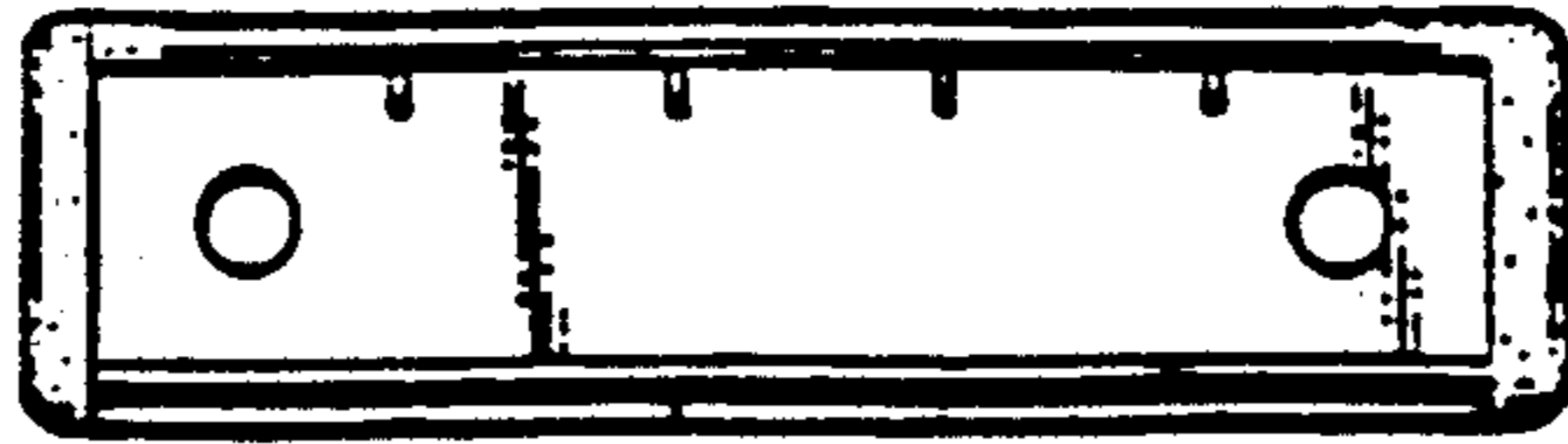

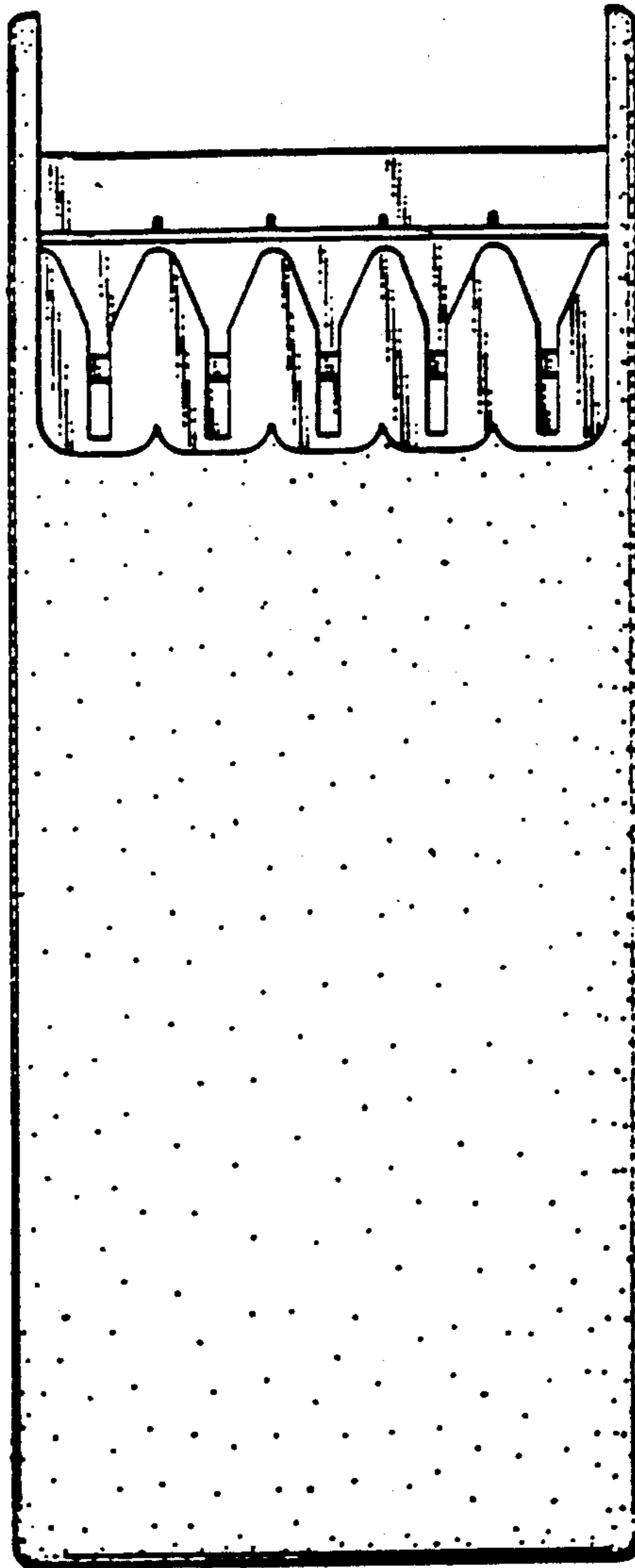
