The ornamental design for a sink, as shown and de-  
scribed.

**DESCRIPTION**

FIG. 1 is a perspective view taken from the top, front  
and right side of a sink showing our new design;

FIG. 2 is a top plan view thereof;

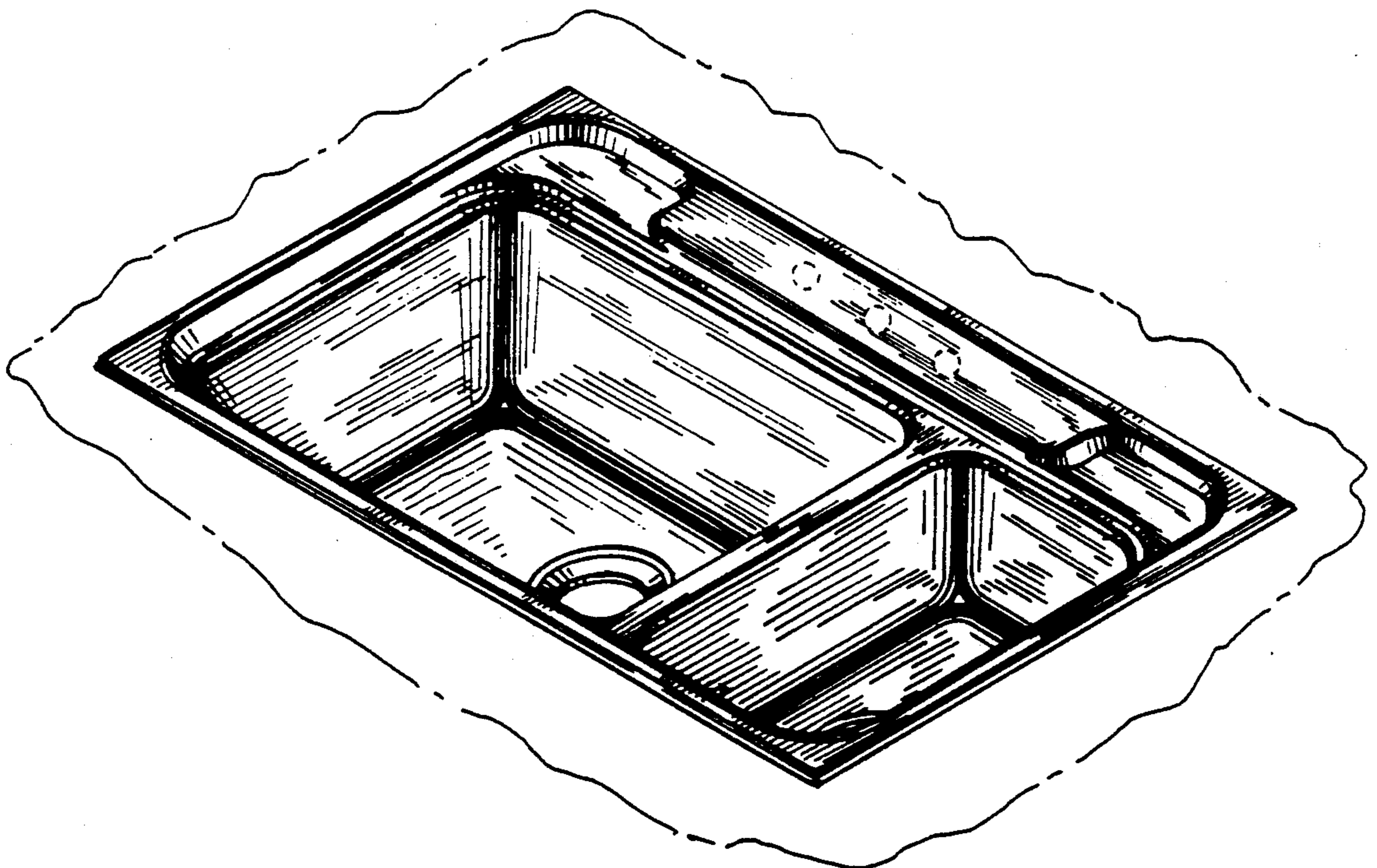
FIG. 3 is a cross-sectional view taken on line 3—3 of

part of the claimed design.



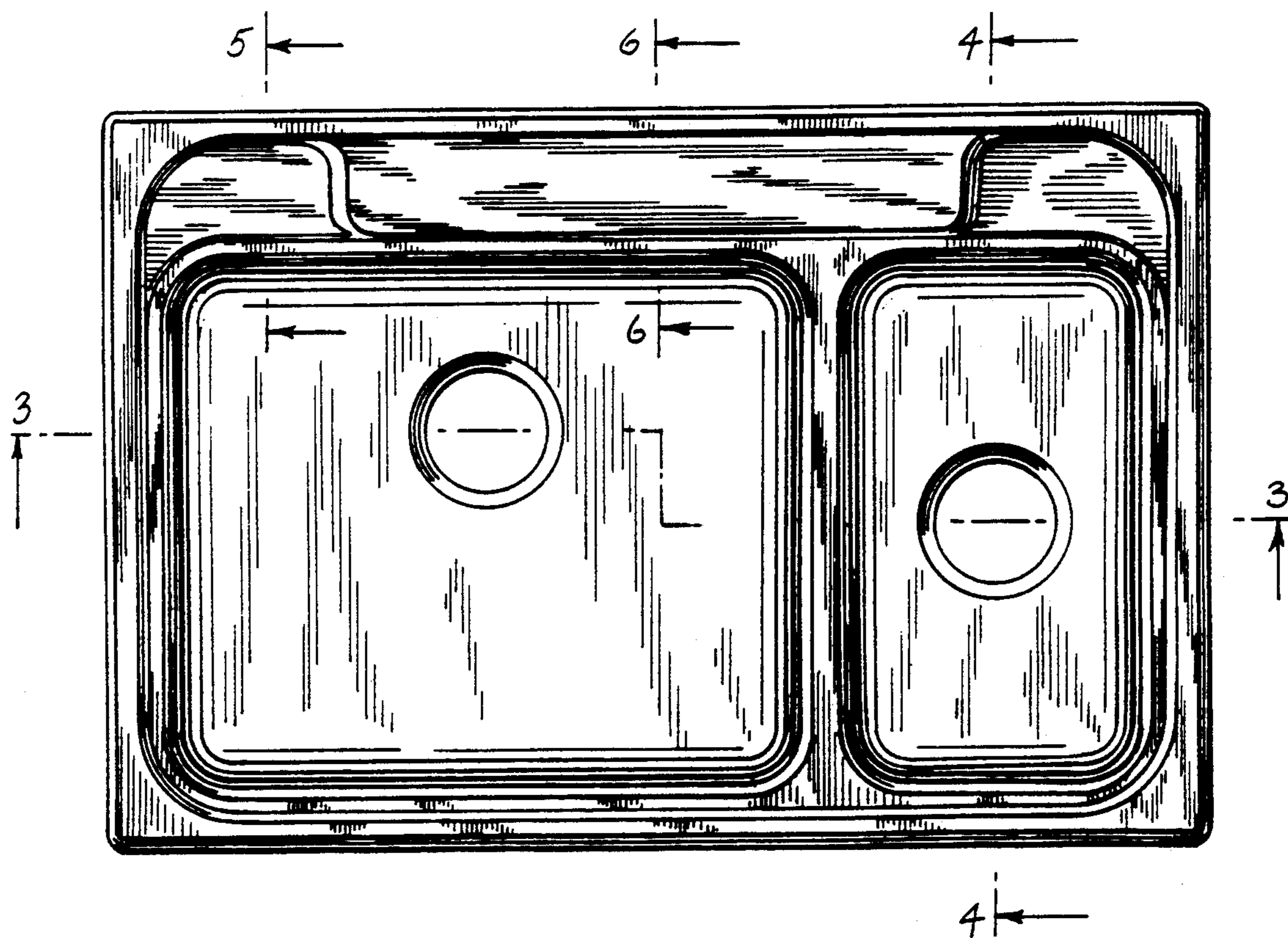
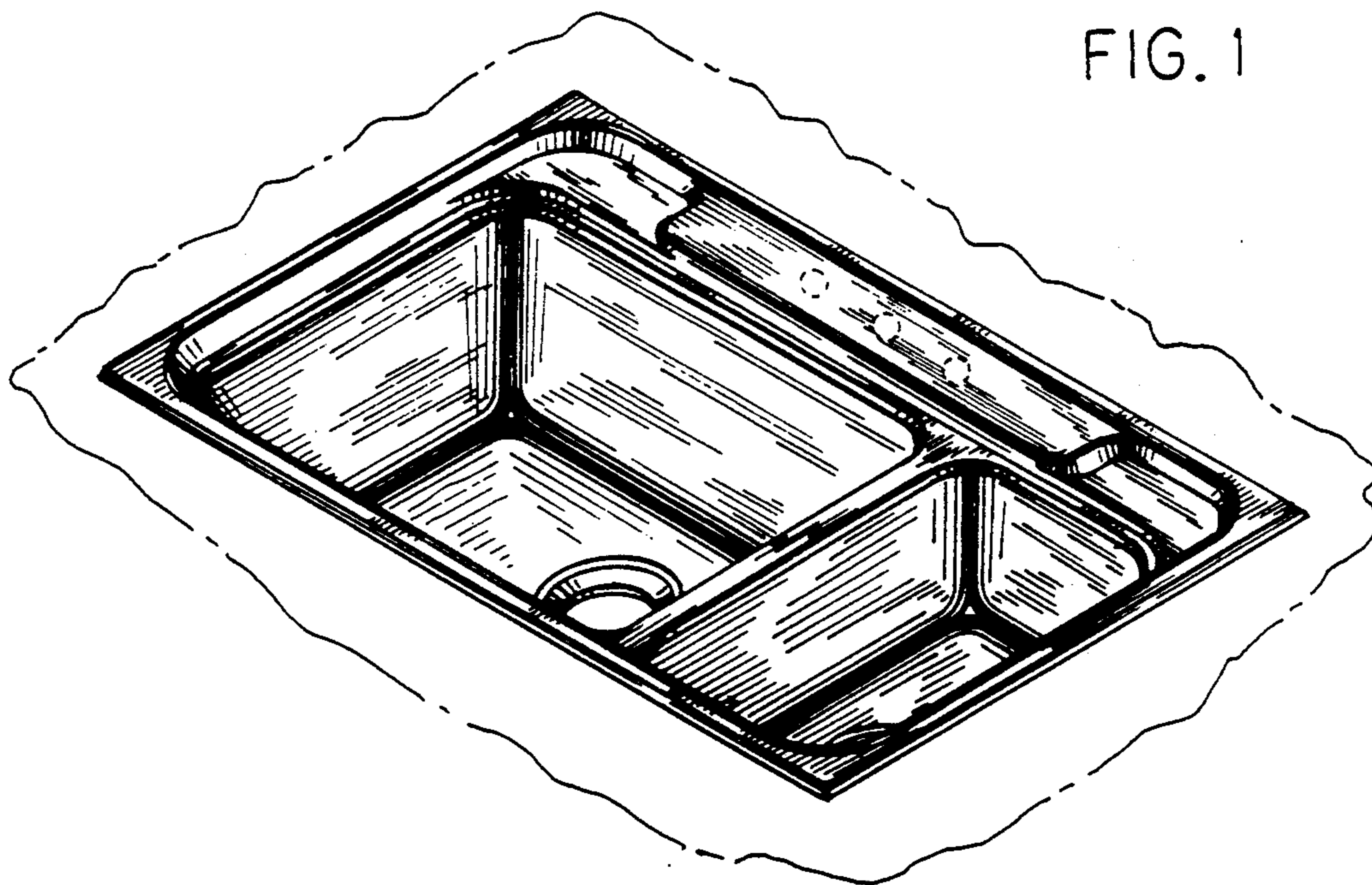

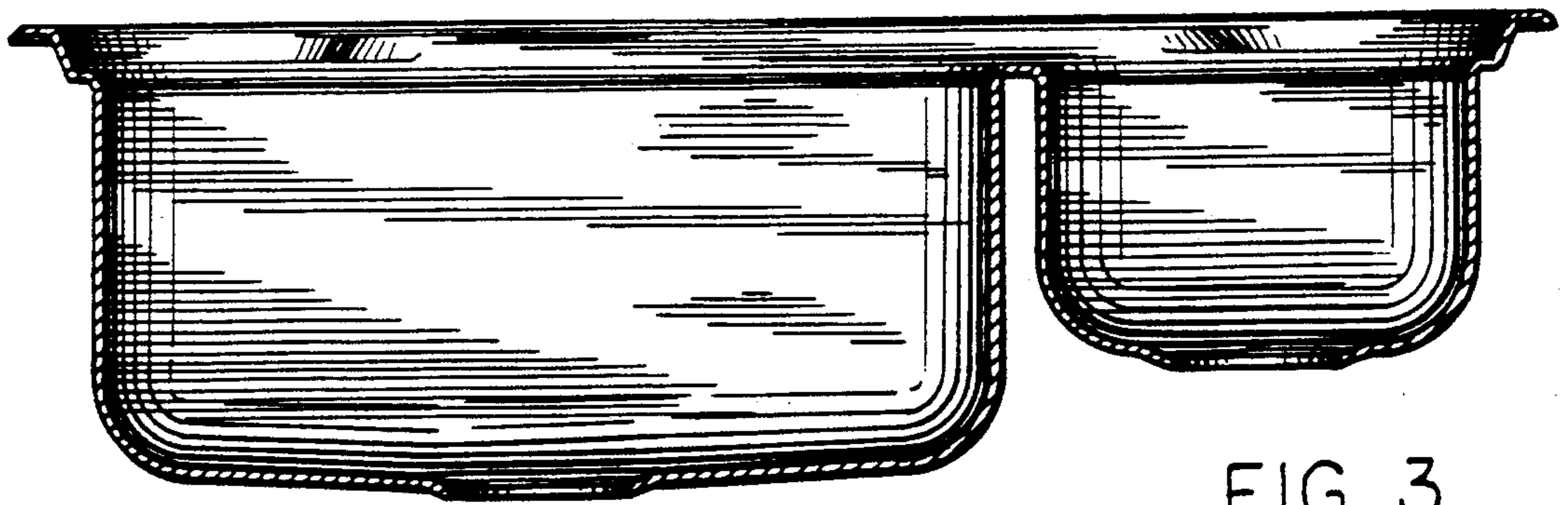

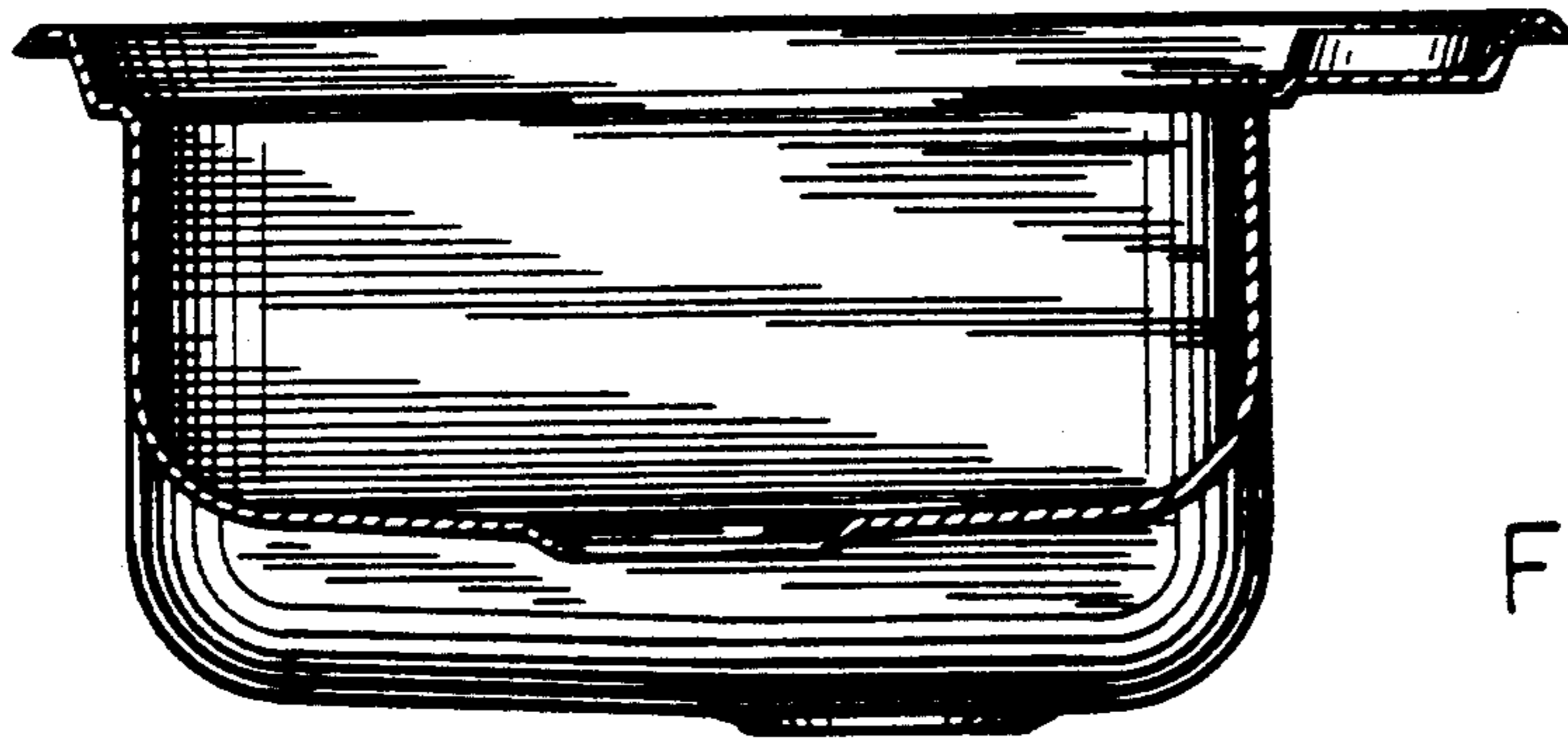

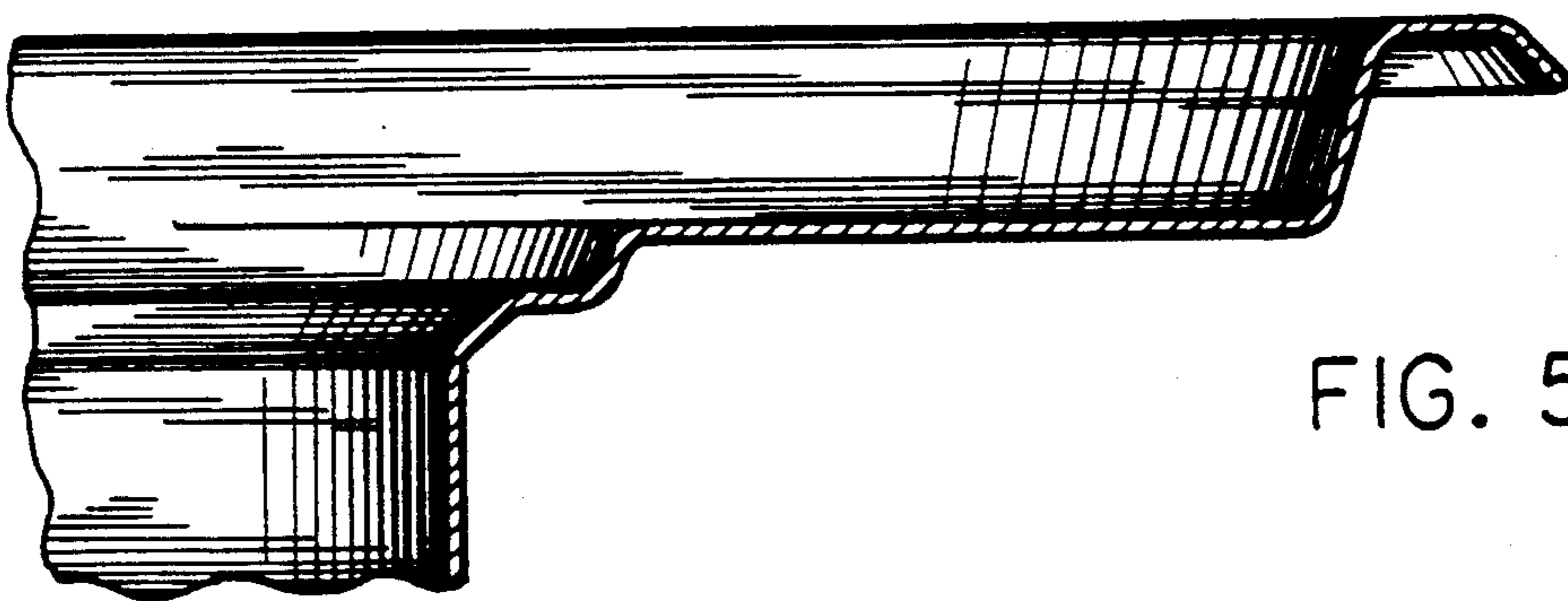

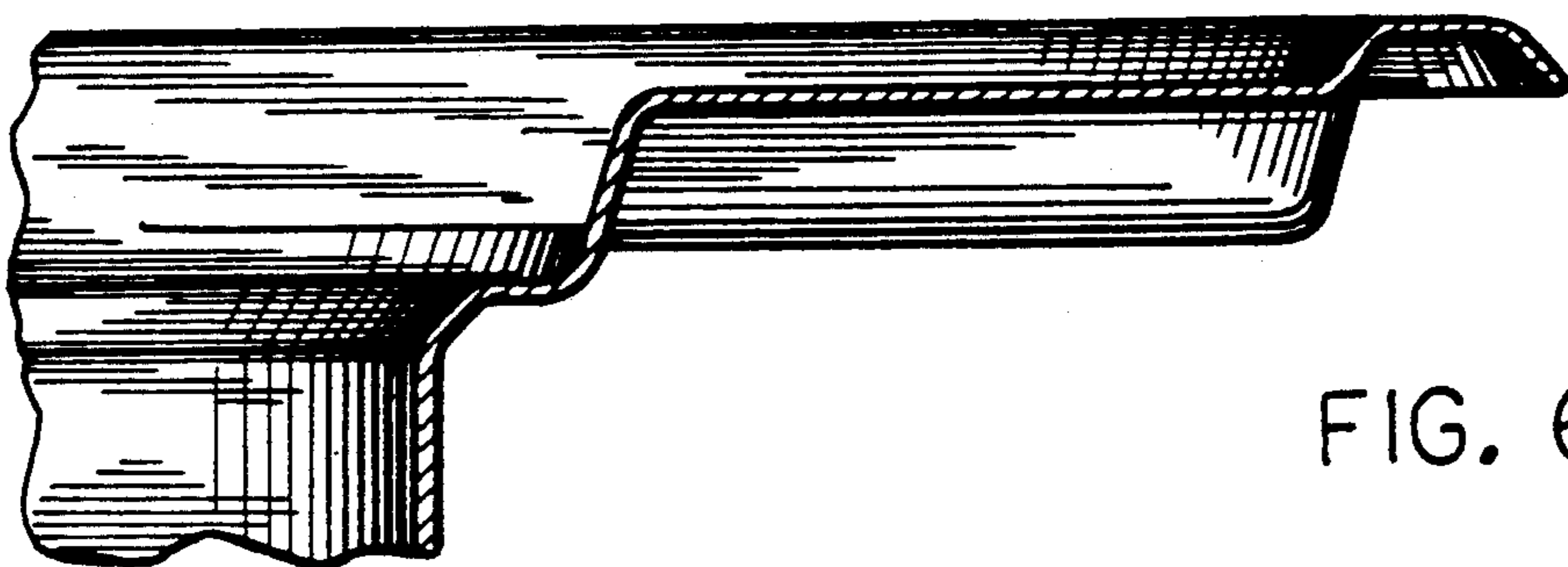
