[57] **CLAIM**

The ornamental design for a holder used for wax in coating embroidery thread or the like, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a holder for wax used in coating embroidery thread or the like showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a left side elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a sectional view taken on line 8—8 of FIG. 2;

FIG. 9 is a sectional view taken on line 9—9 of FIG. 6;

and,

FIG. 10 is a perspective view as shown in FIG. 1; the broken lines partially showing a wax disc and a segment of thread being for illustrative purposes only and forming no part of the claimed design.

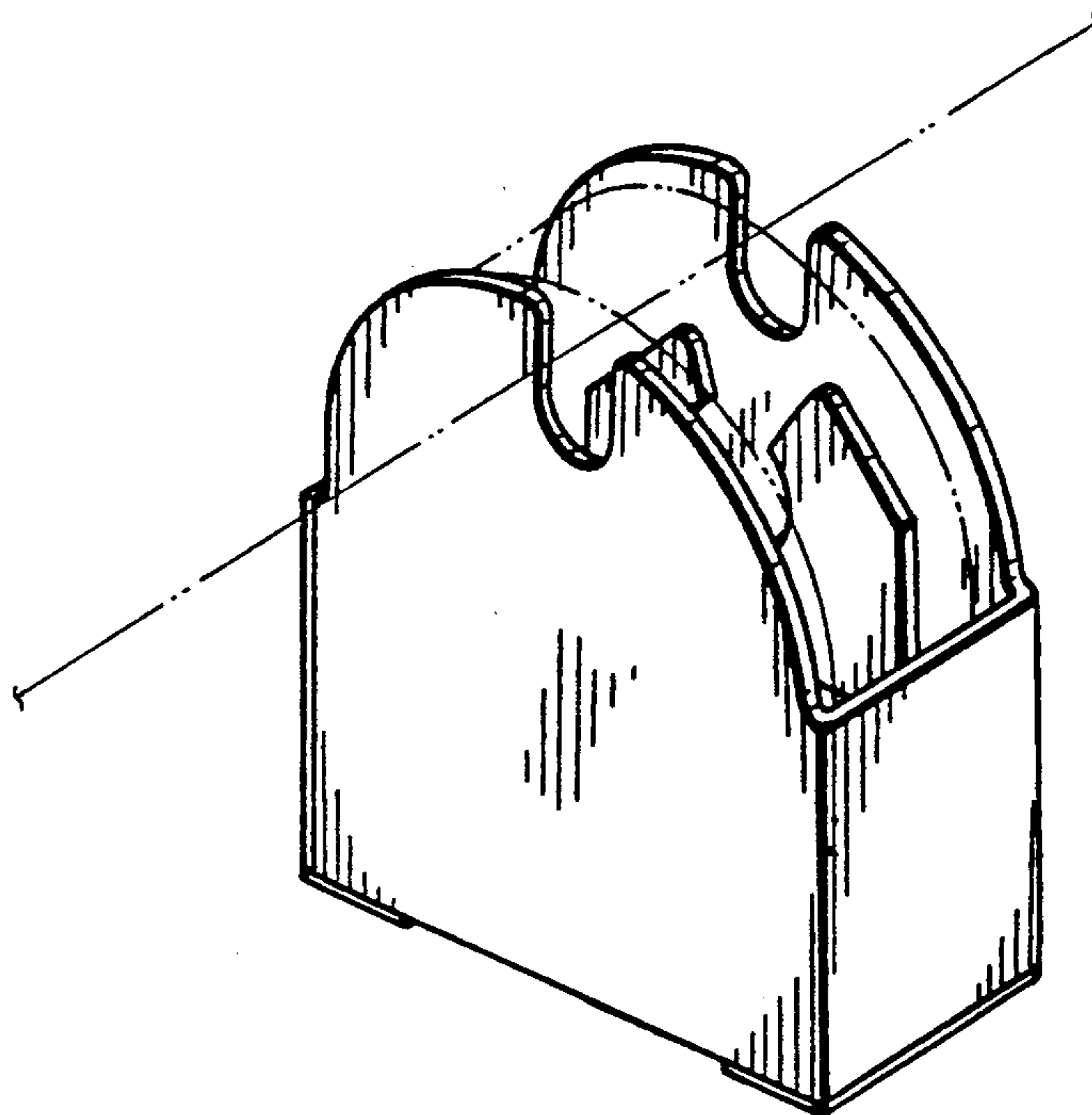

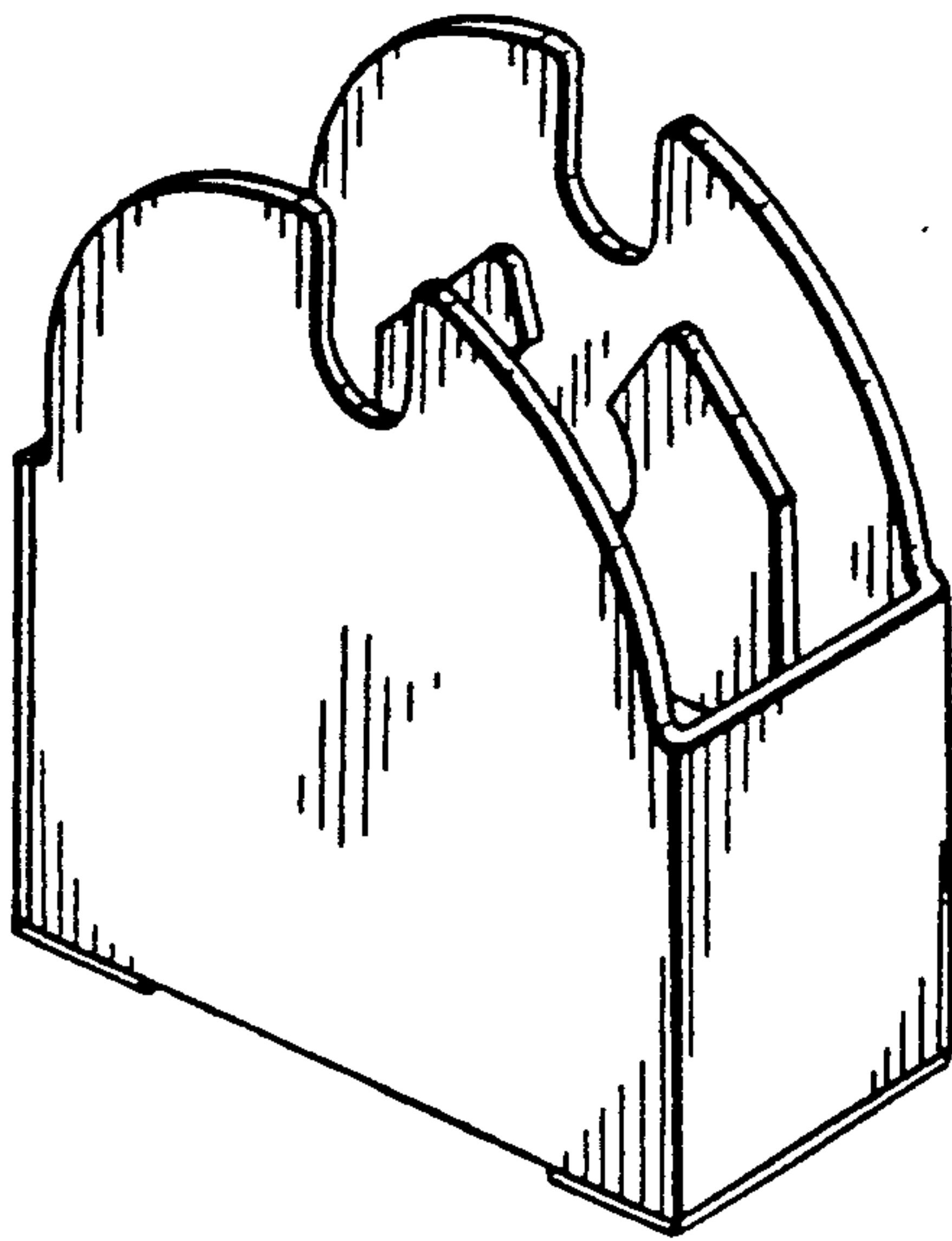

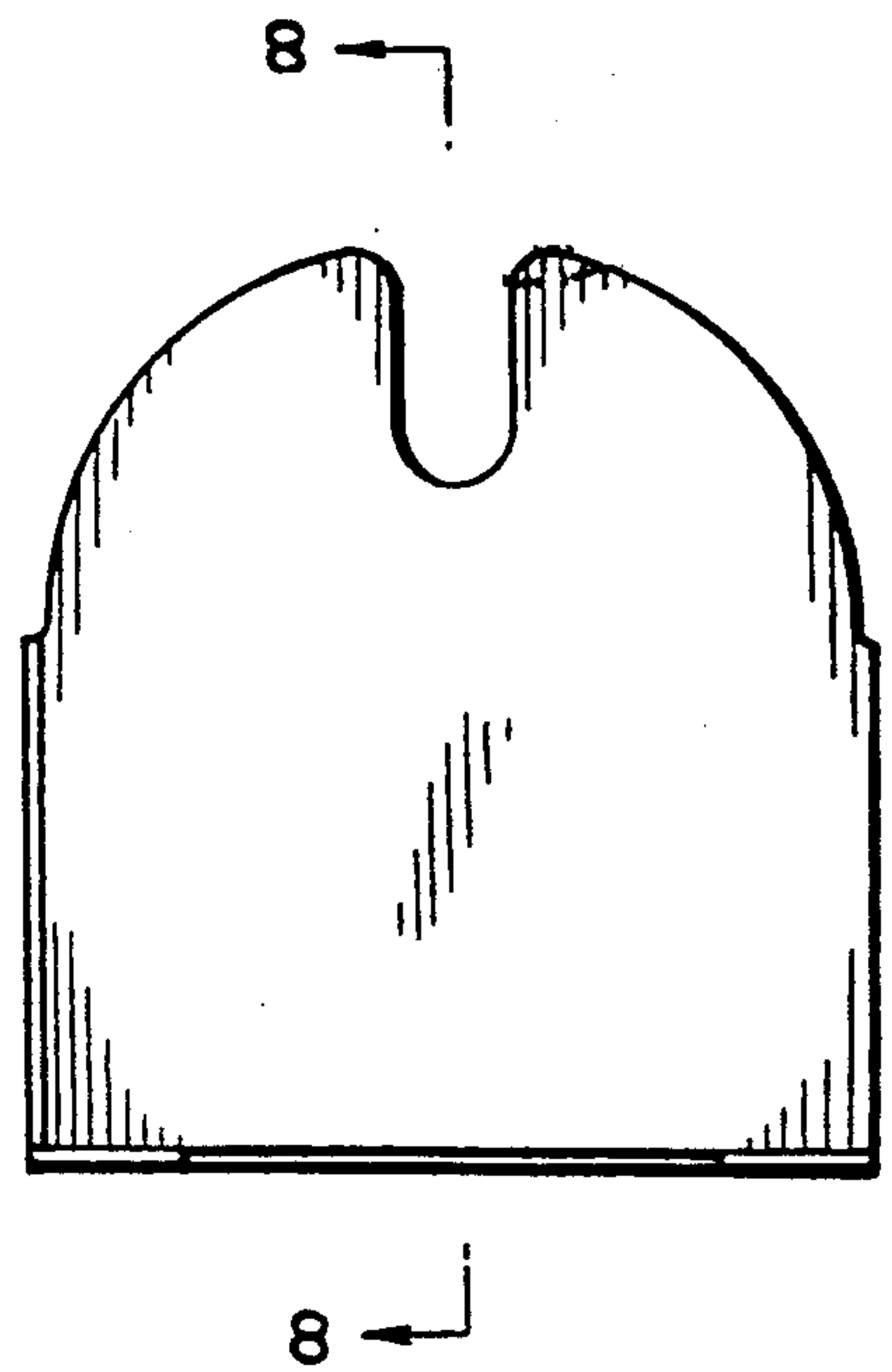

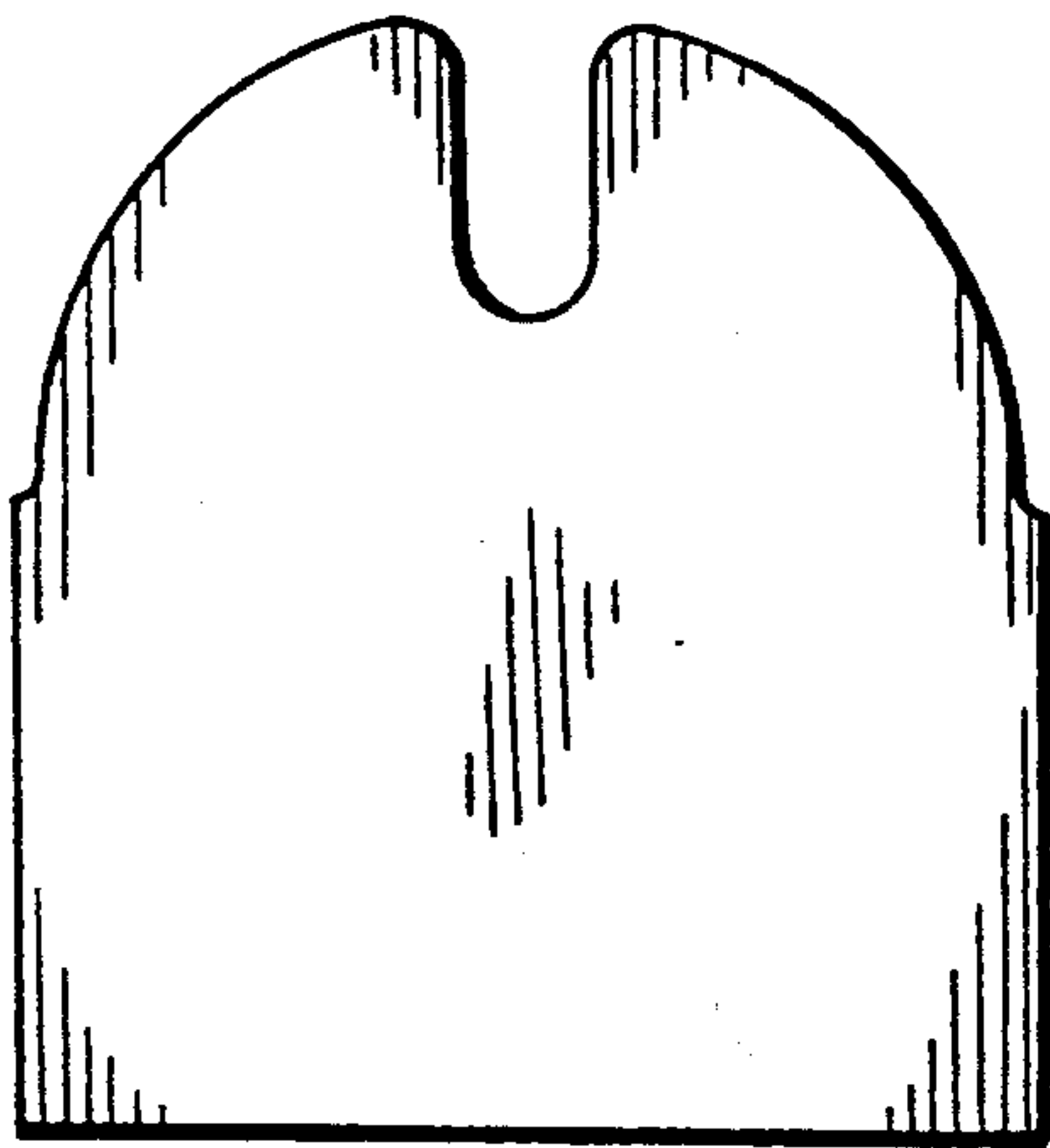

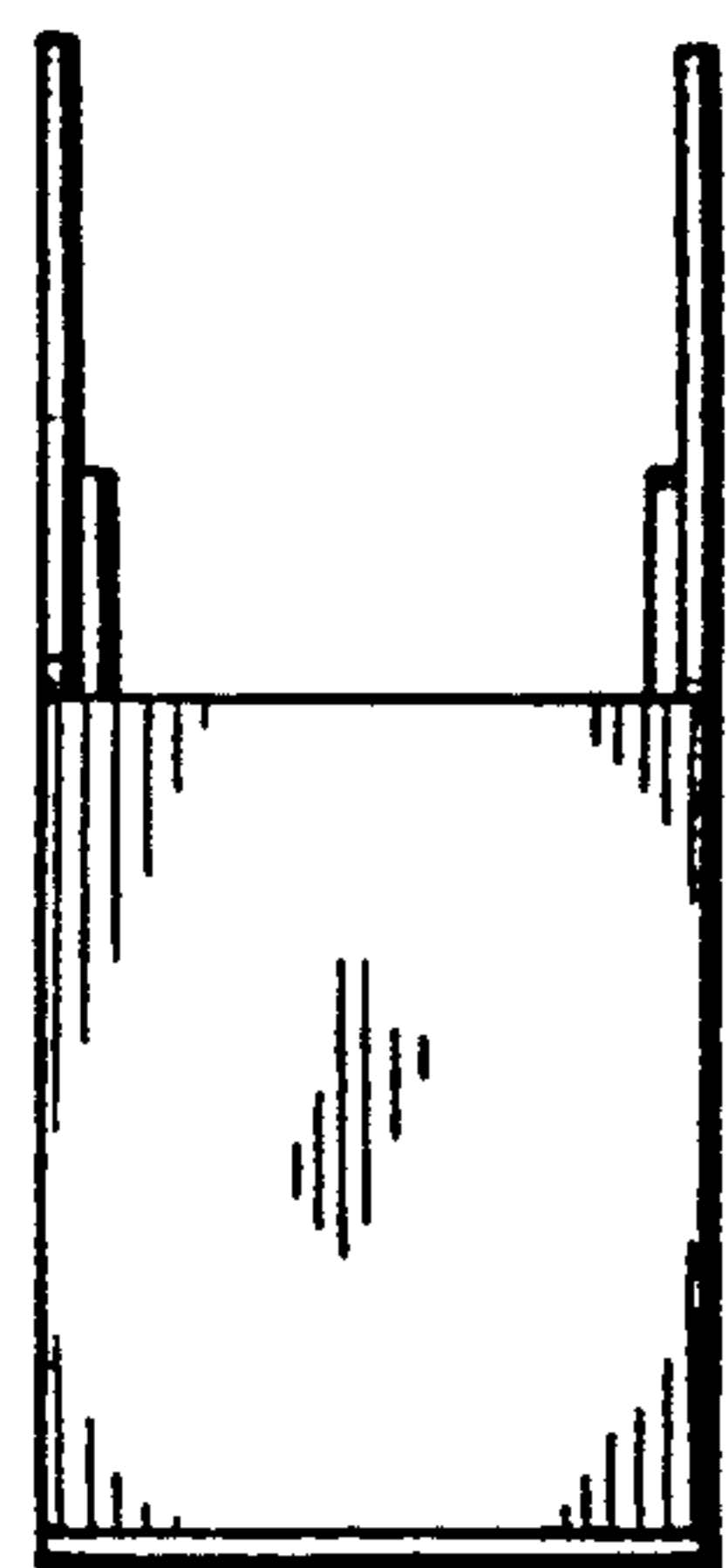

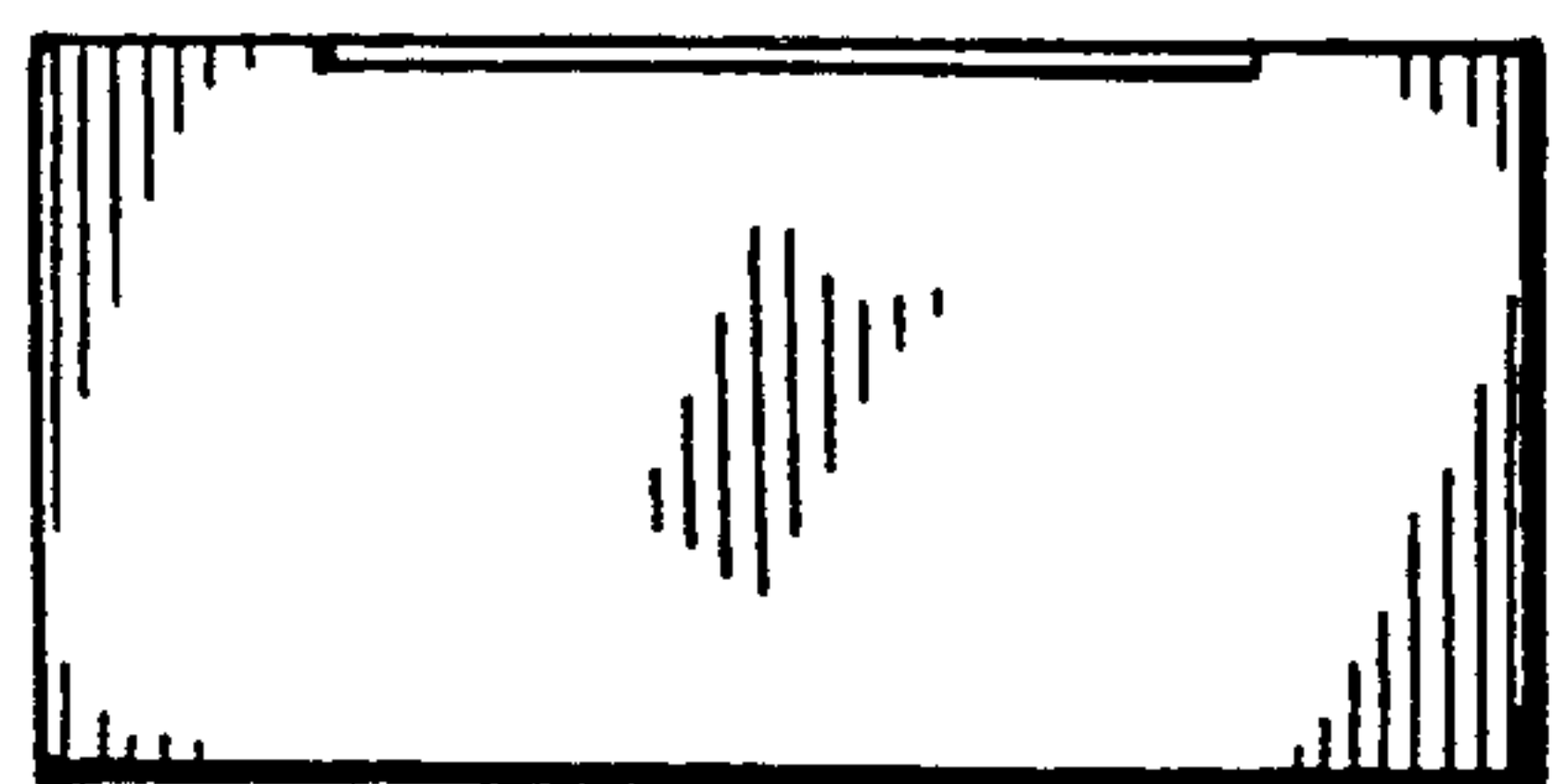

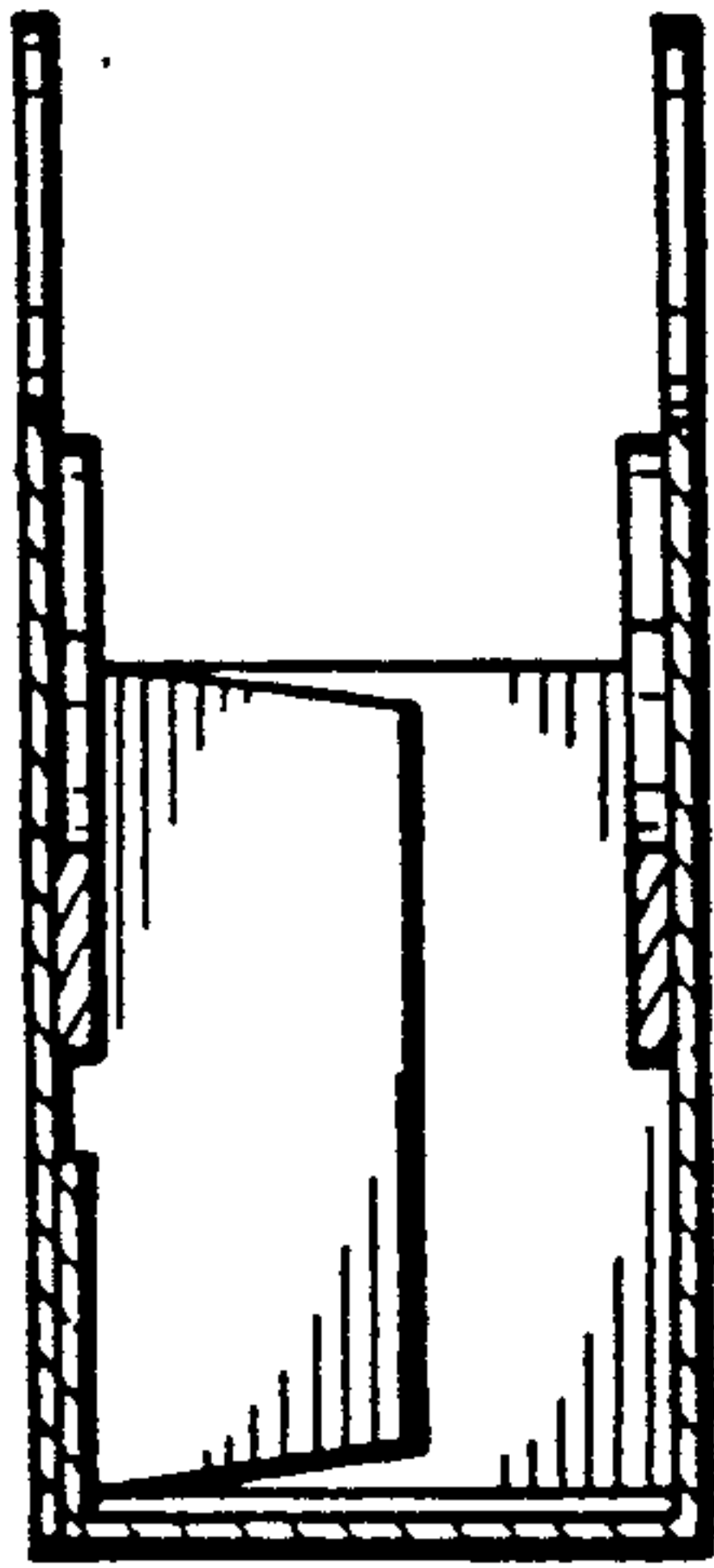

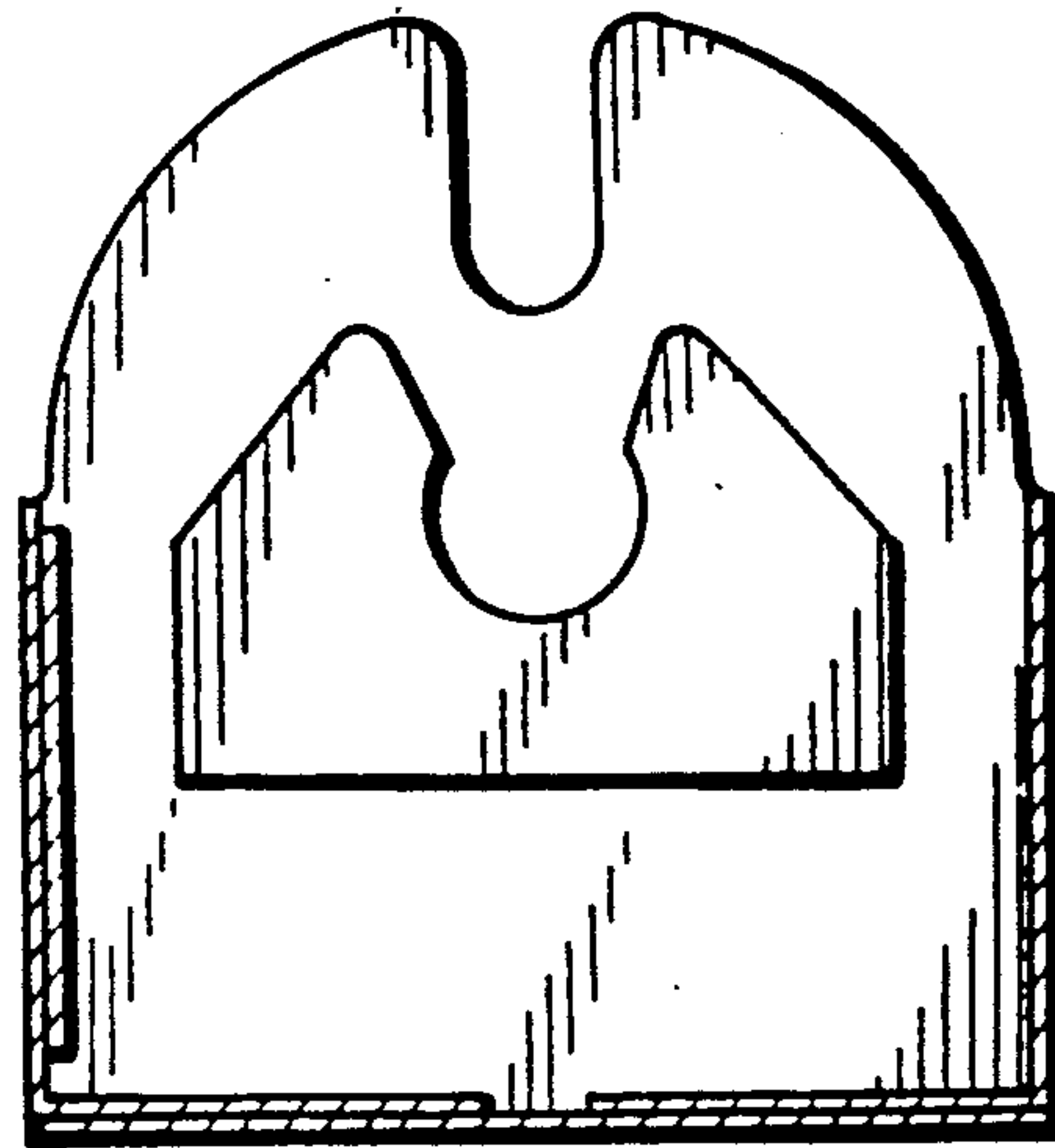
