[57] **CLAIM**

The ornamental design for a carpet installer's pouch, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, left, front perspective view of a carpet installer's pouch showing my new design in open position;

FIG. 2 is a top front, right perspective view thereof in closed position;

FIG. 3 is a top plan view thereof in an open position;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a front elevational view thereof;

FIG. 6 is a rear elevational view thereof;

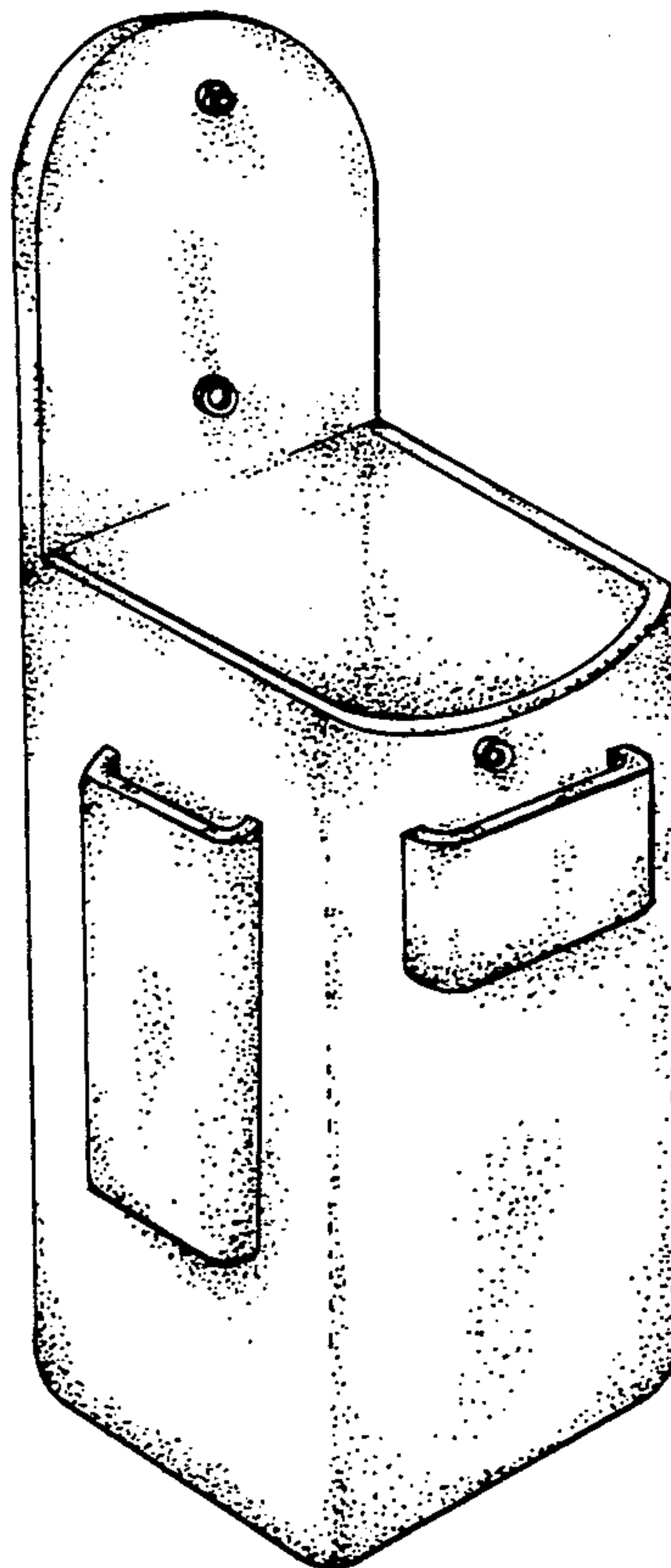
FIG. 7 is a top, right, rear perspective view of a carpet installer's pouch showing a second embodiment of my new design in closed position;

FIG. 8 is a left side elevational view thereof;

FIG. 9 is a top, front, left perspective view of the first embodiment in alternate position; and,

FIG. 10 is a top, rear, right perspective view of a carpet installer's pouch showing a third embodiment of my new design in closed position, the other views being identical to those of the first embodiment.

The broken line showing of a portion of a belt strap in FIGS. 5, 9 and 10 is for illustrative purposes only and forms no part of the claimed design.



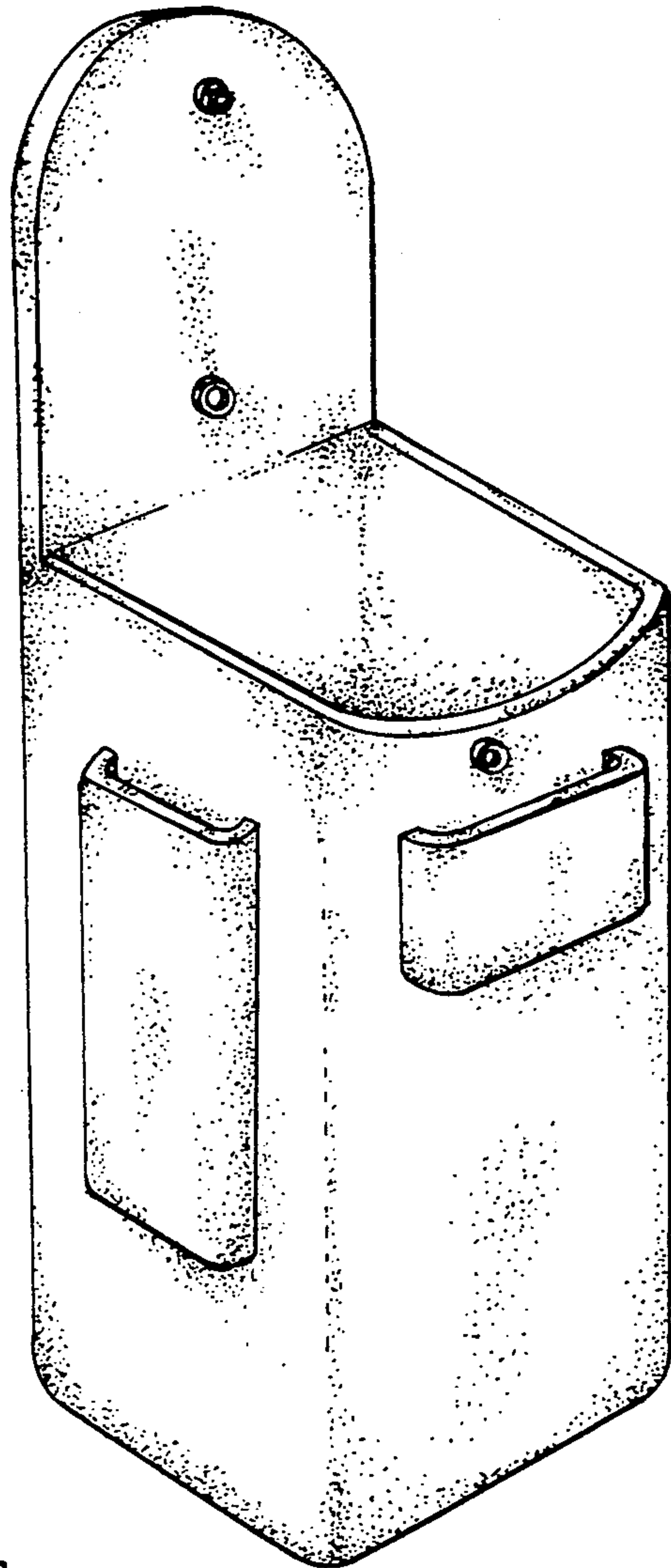

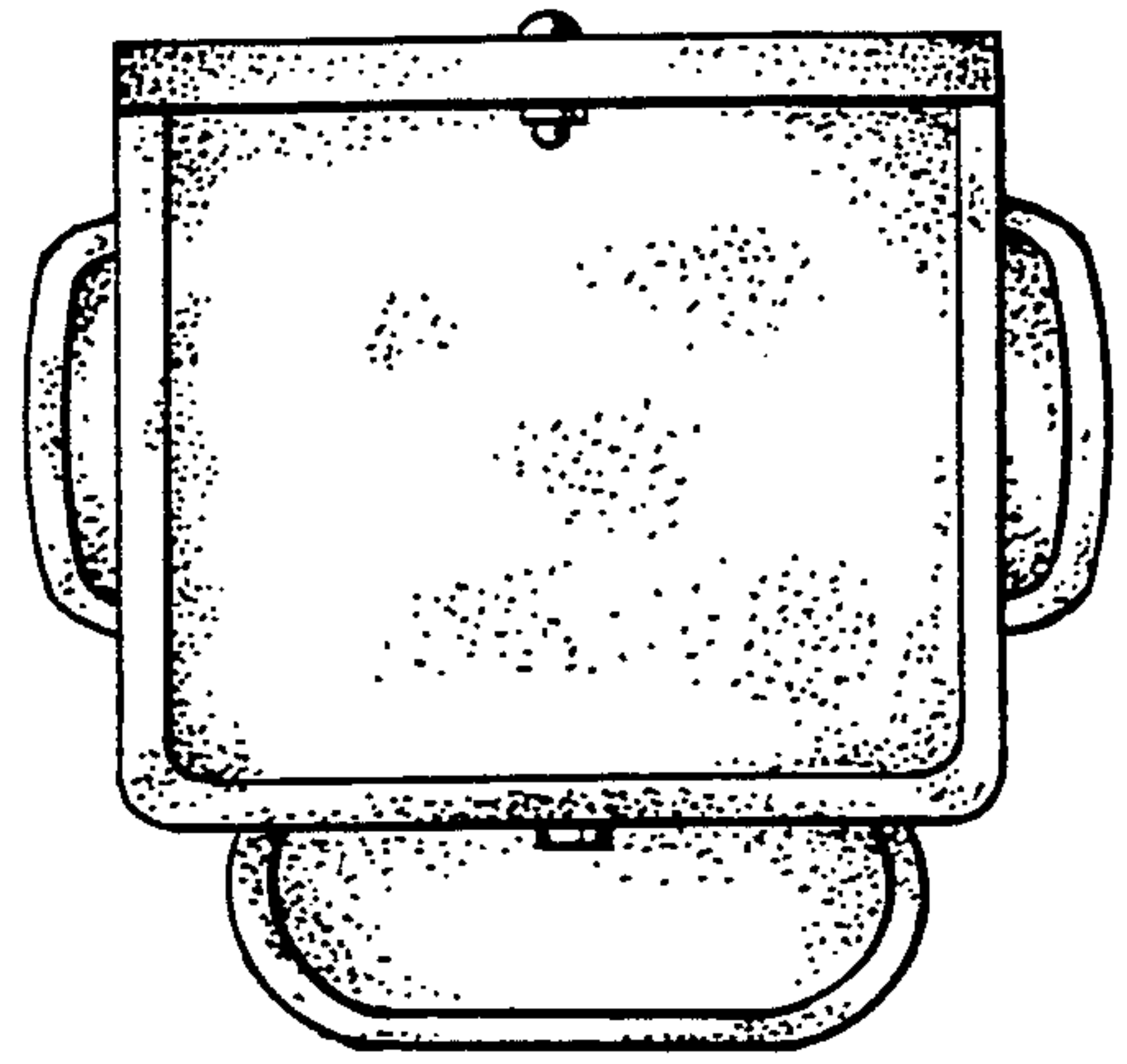

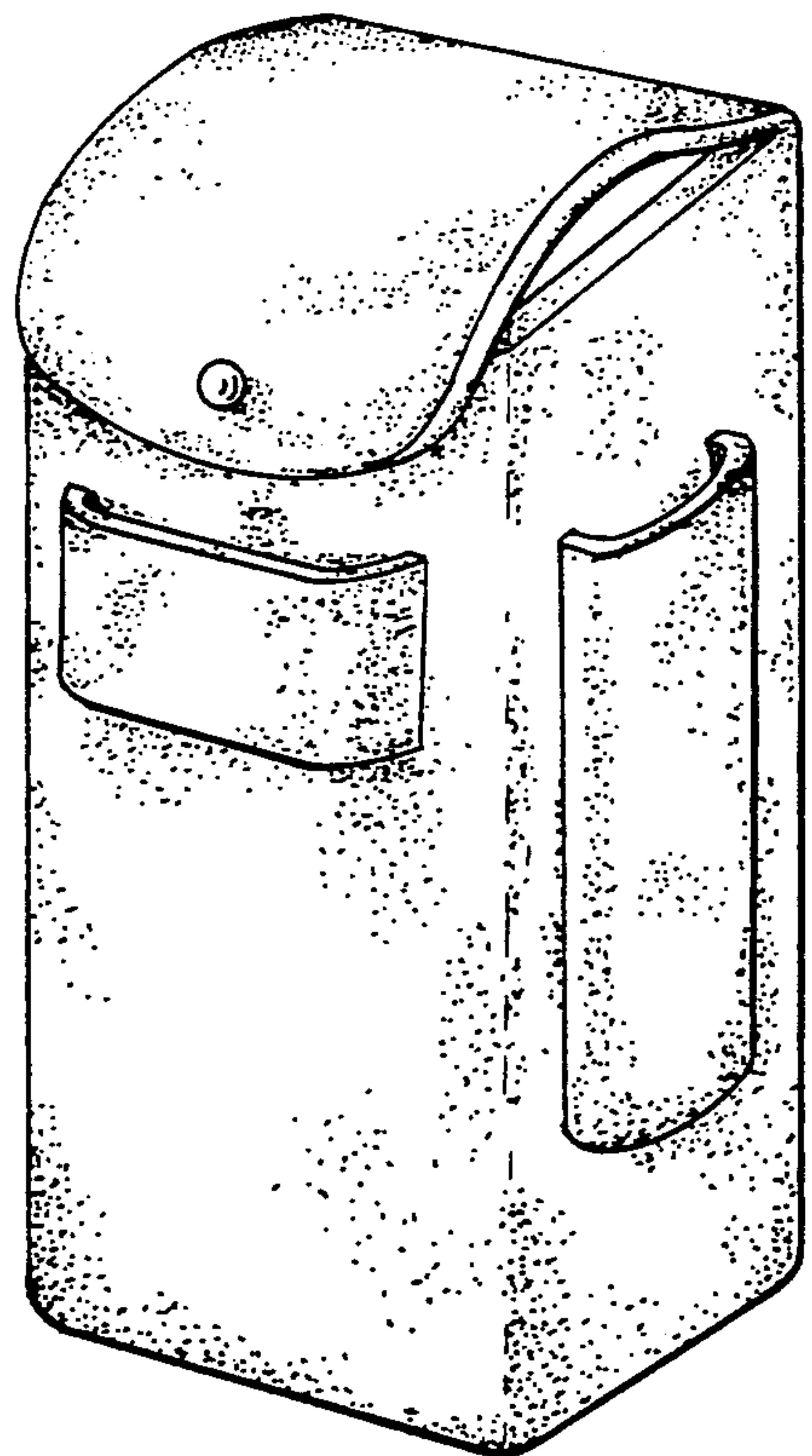

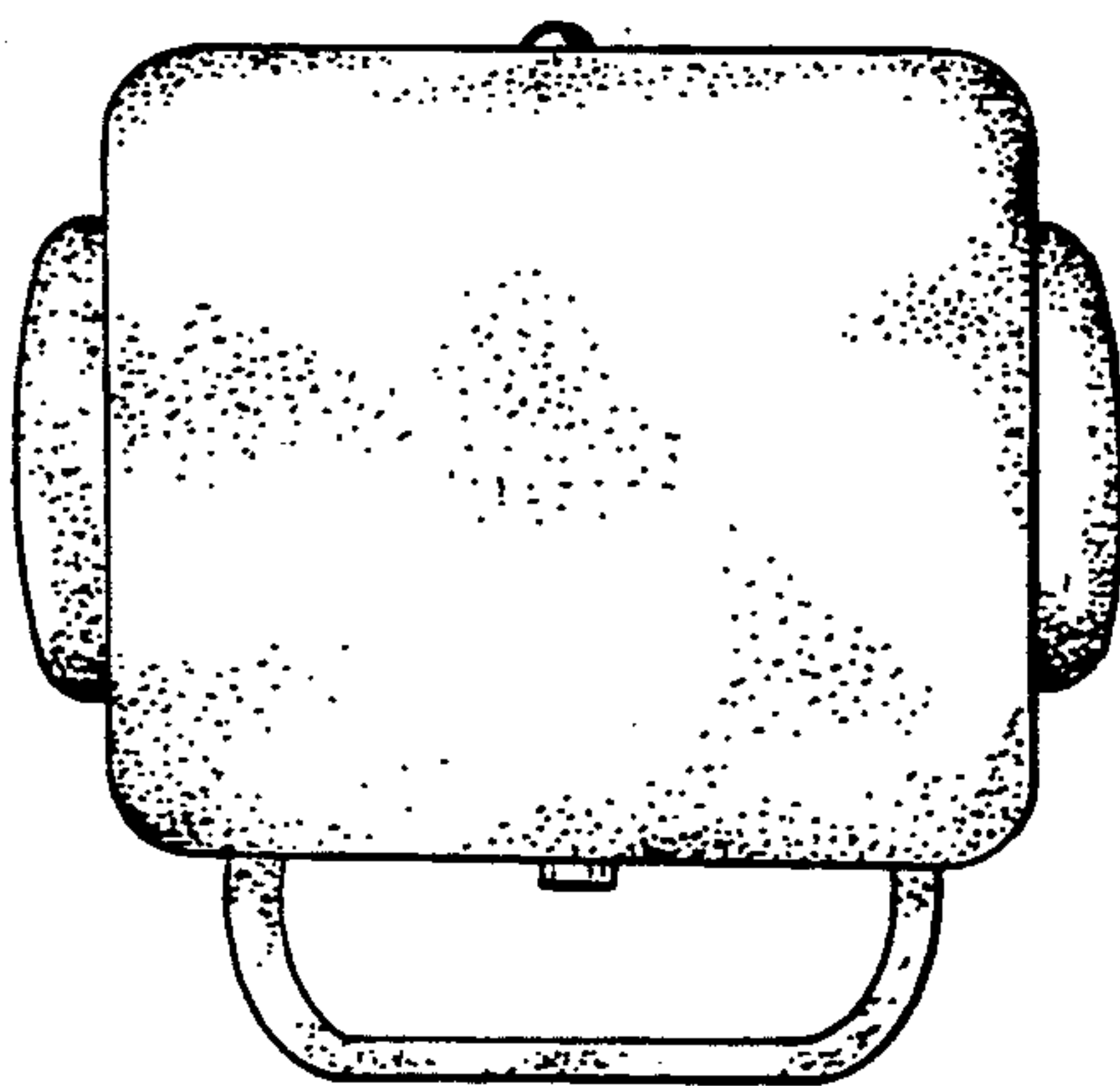

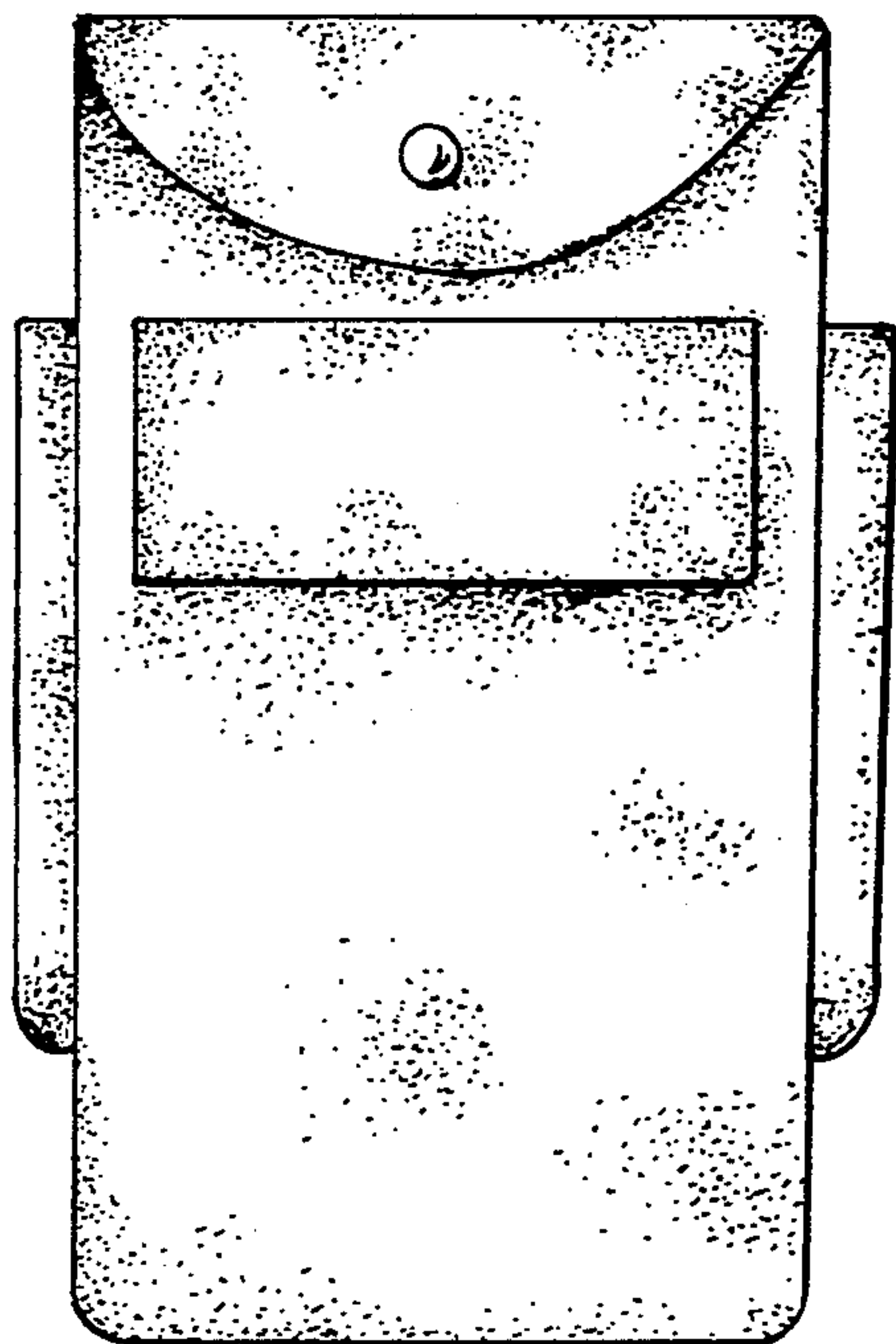

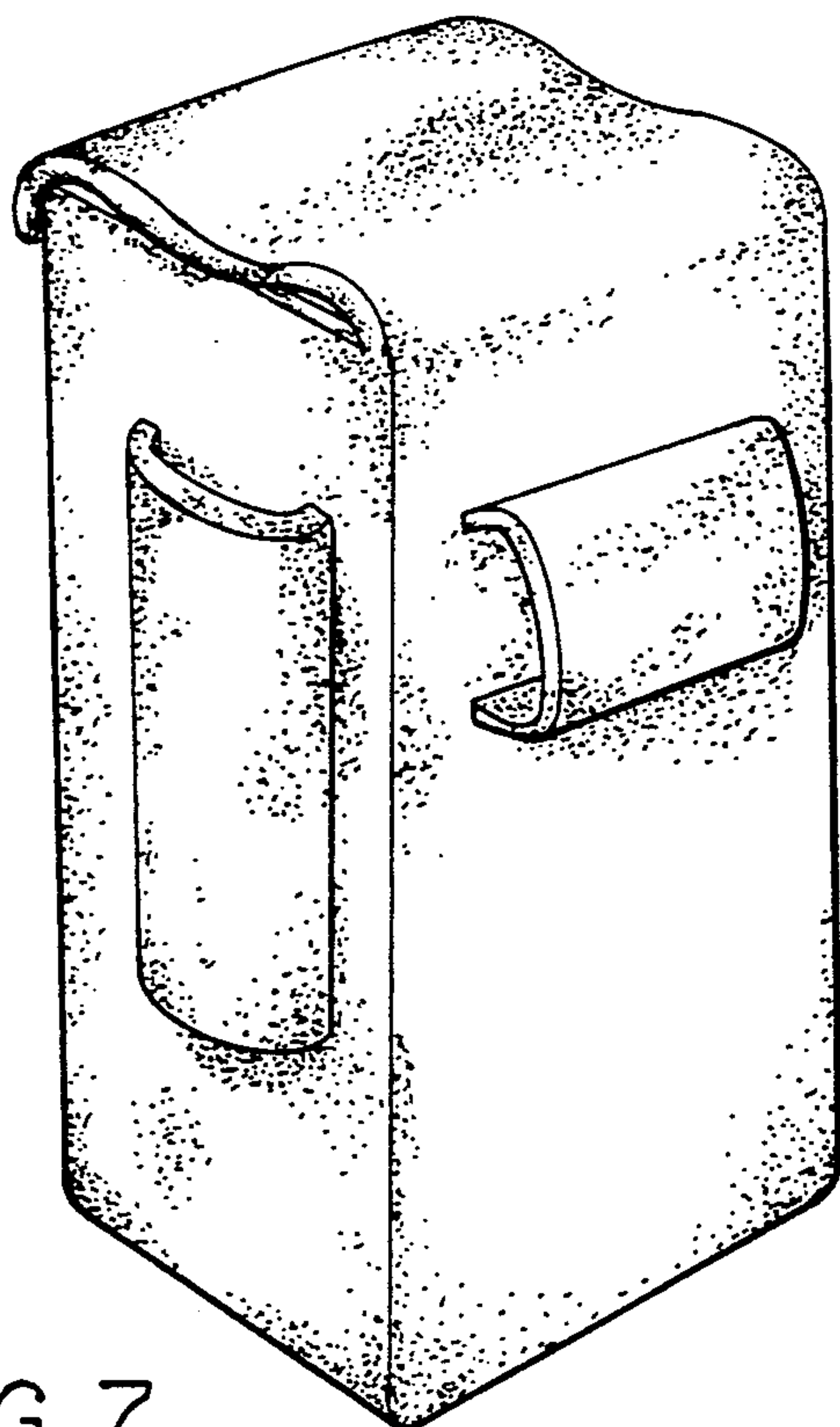
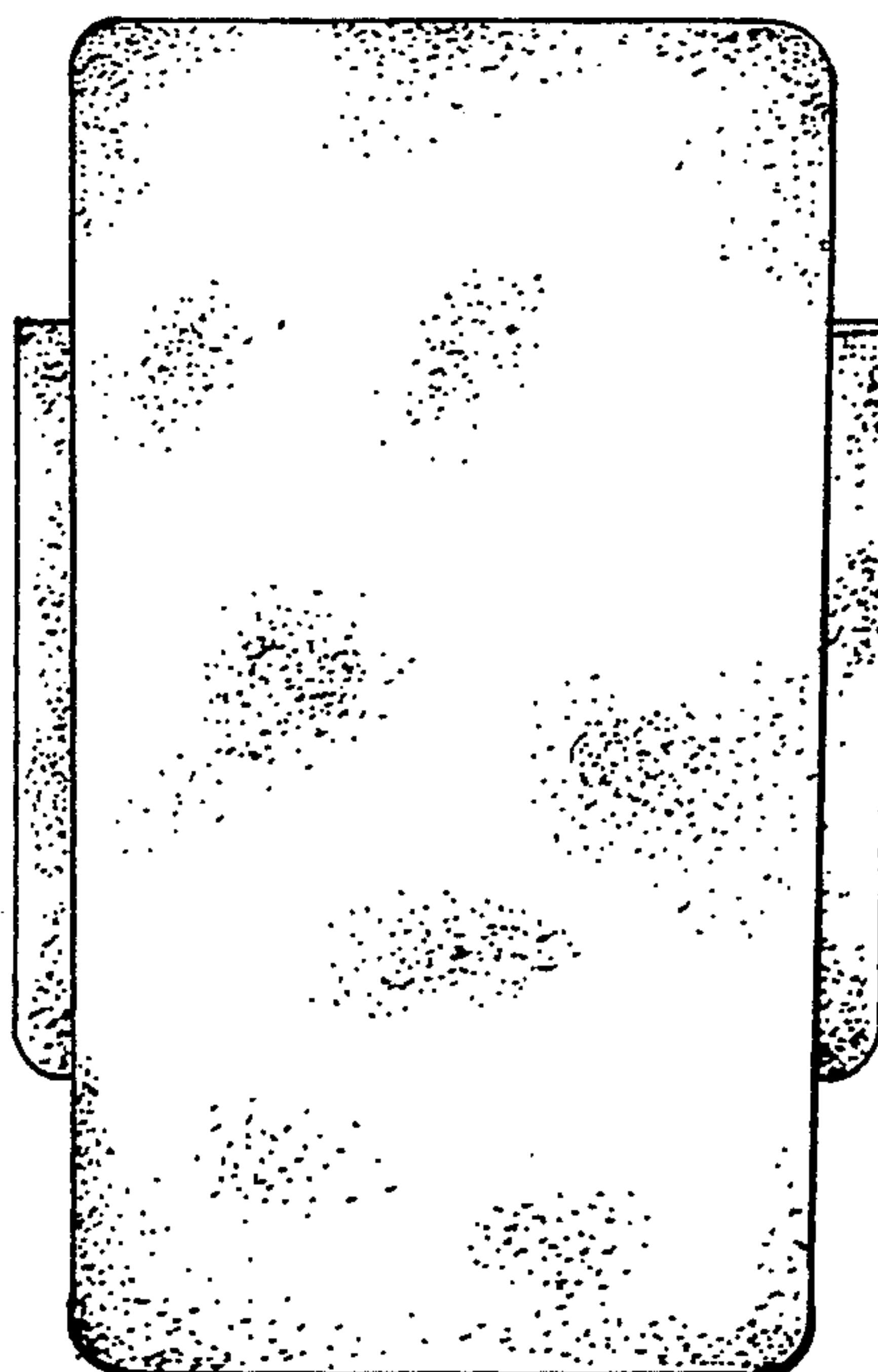

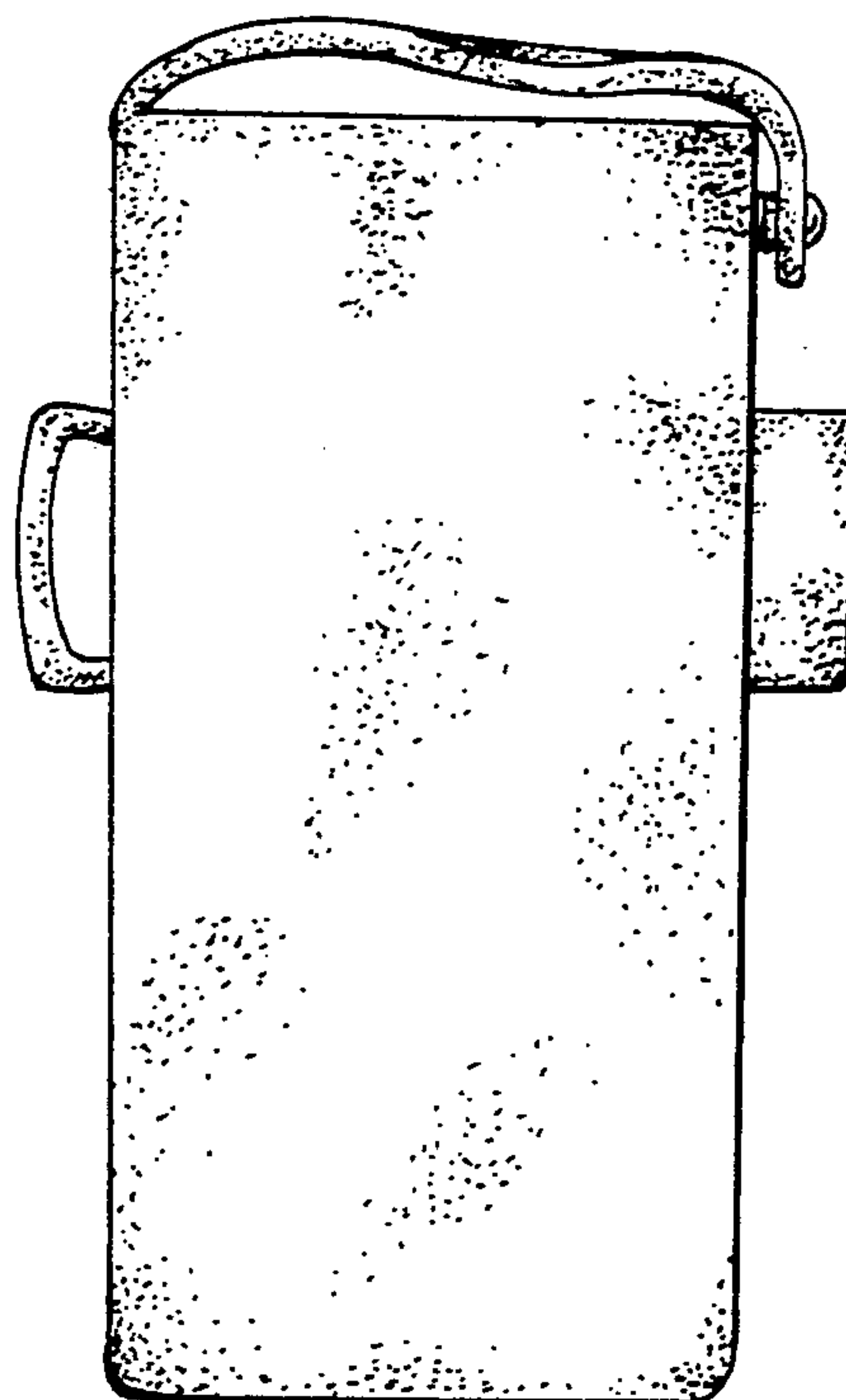

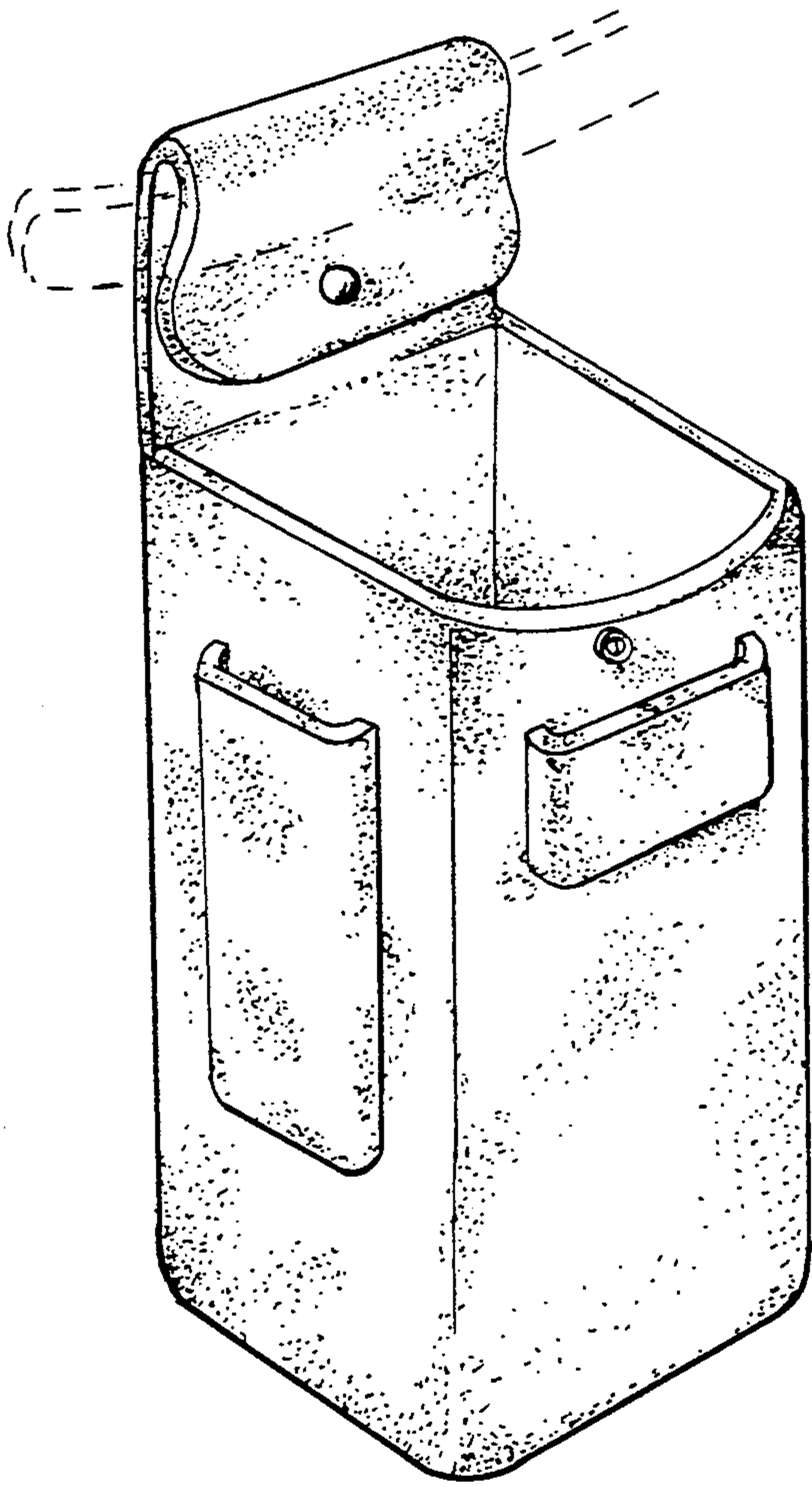

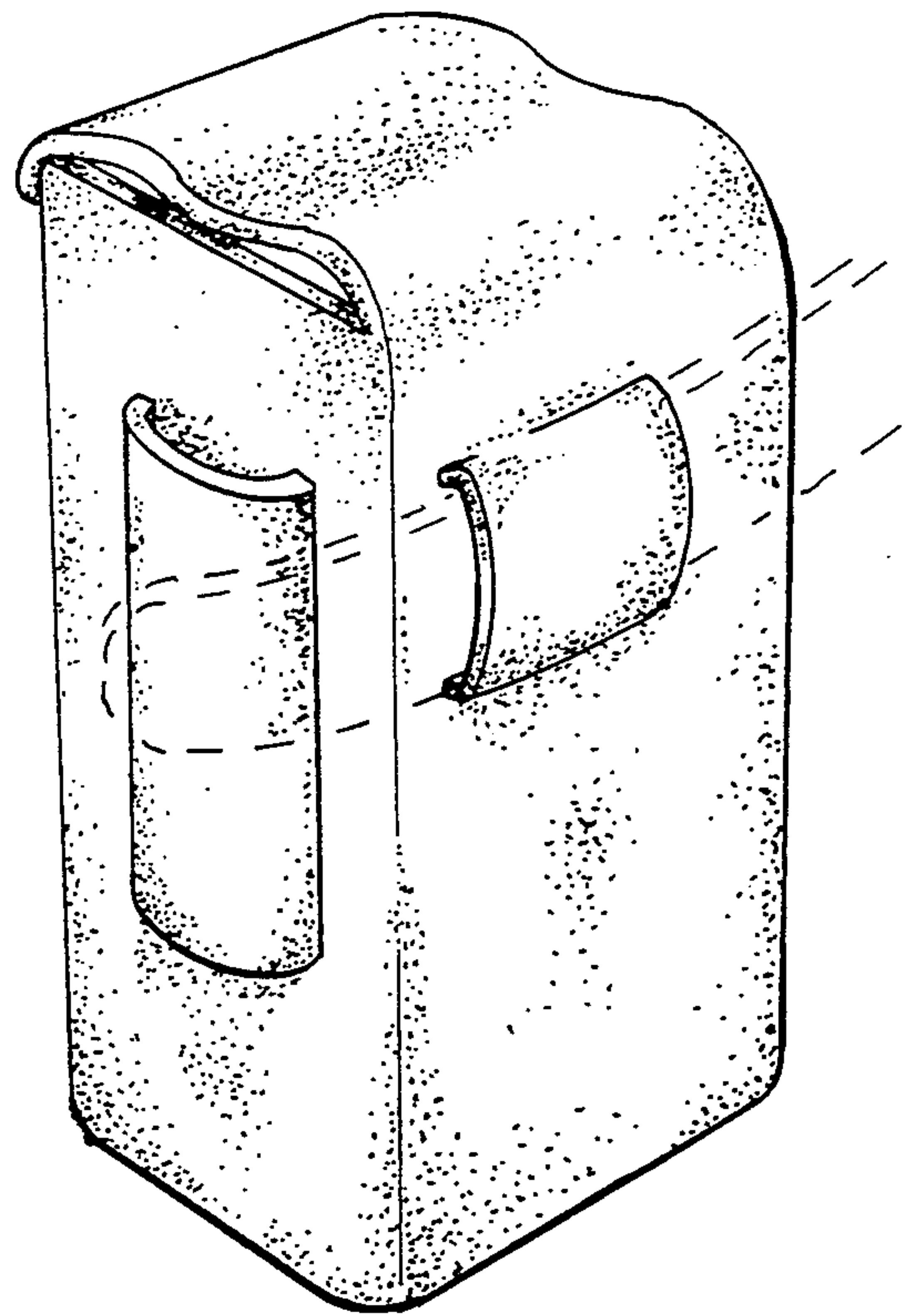
