The ornamental design for a storage cabinet, as shown and described.

DESCRIPTION

FIG. 1 is a front side perspective view of a storage cabinet showing my new design;

FIG. 2 is a front, left side perspective view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a front elevational view thereof;

FIG. 6 is a right side elevational view thereof;

FIG. 7 is a right side enlarged elevational view thereof;

FIG. 8 is a left side enlarged fragmentary view in respect to FIG. 1 thereof;

FIG. 9 is a top perspective view on an enlarged scale in respect to FIG. 1 thereof;

FIG. 10 is a top plan view of a second embodiment of FIG. 1 thereof;

FIG. 11 is a front left side elevational view of a second embodiment of FIG. 1 thereof; and,

FIG. 12 is a front right side elevational view of a second embodiment of FIG. 1 thereof.

FIGS. 4, 5, 6, 11 and 12 have been drawn on a reduced scale in respect to FIG. 1.

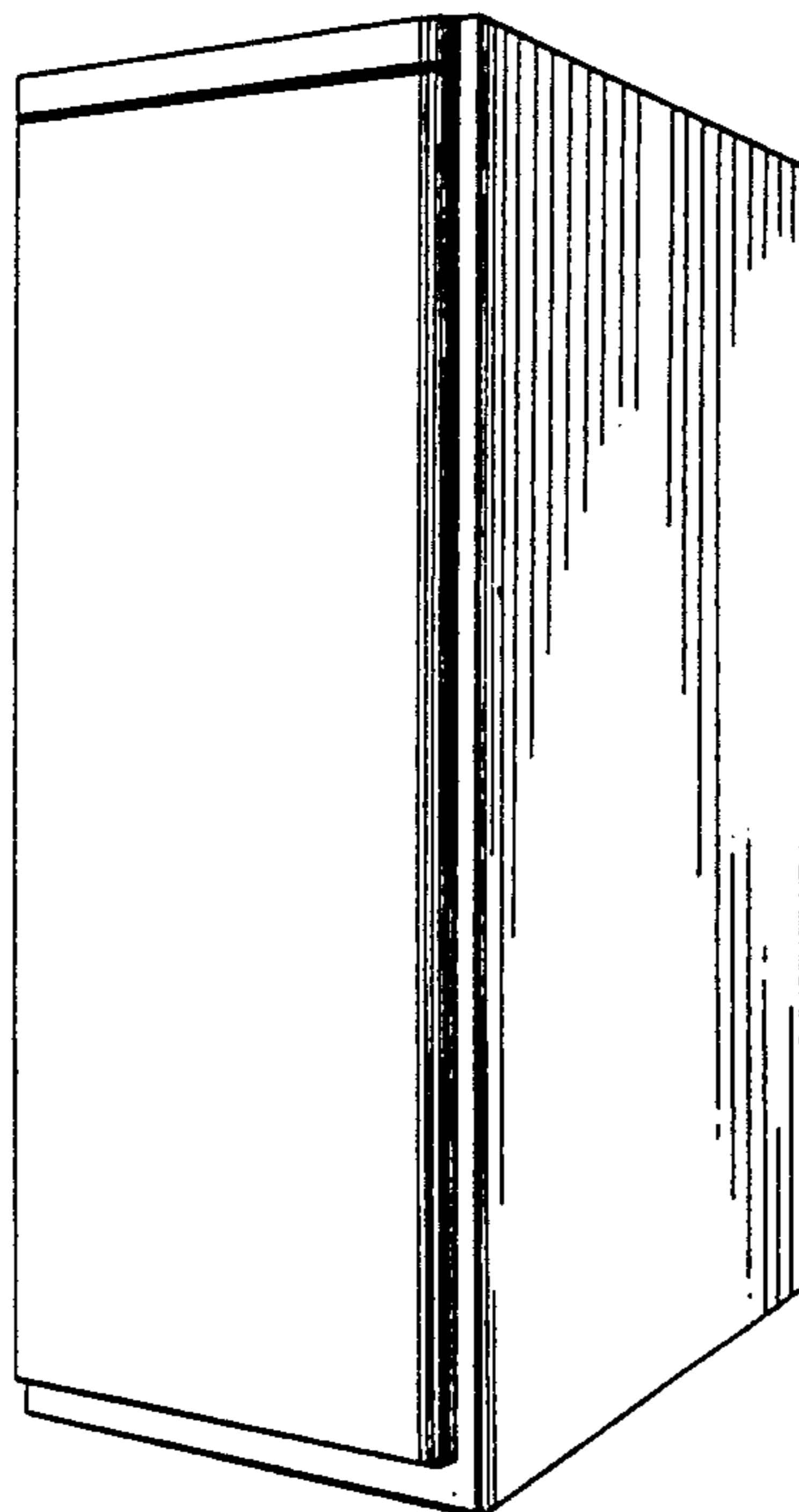

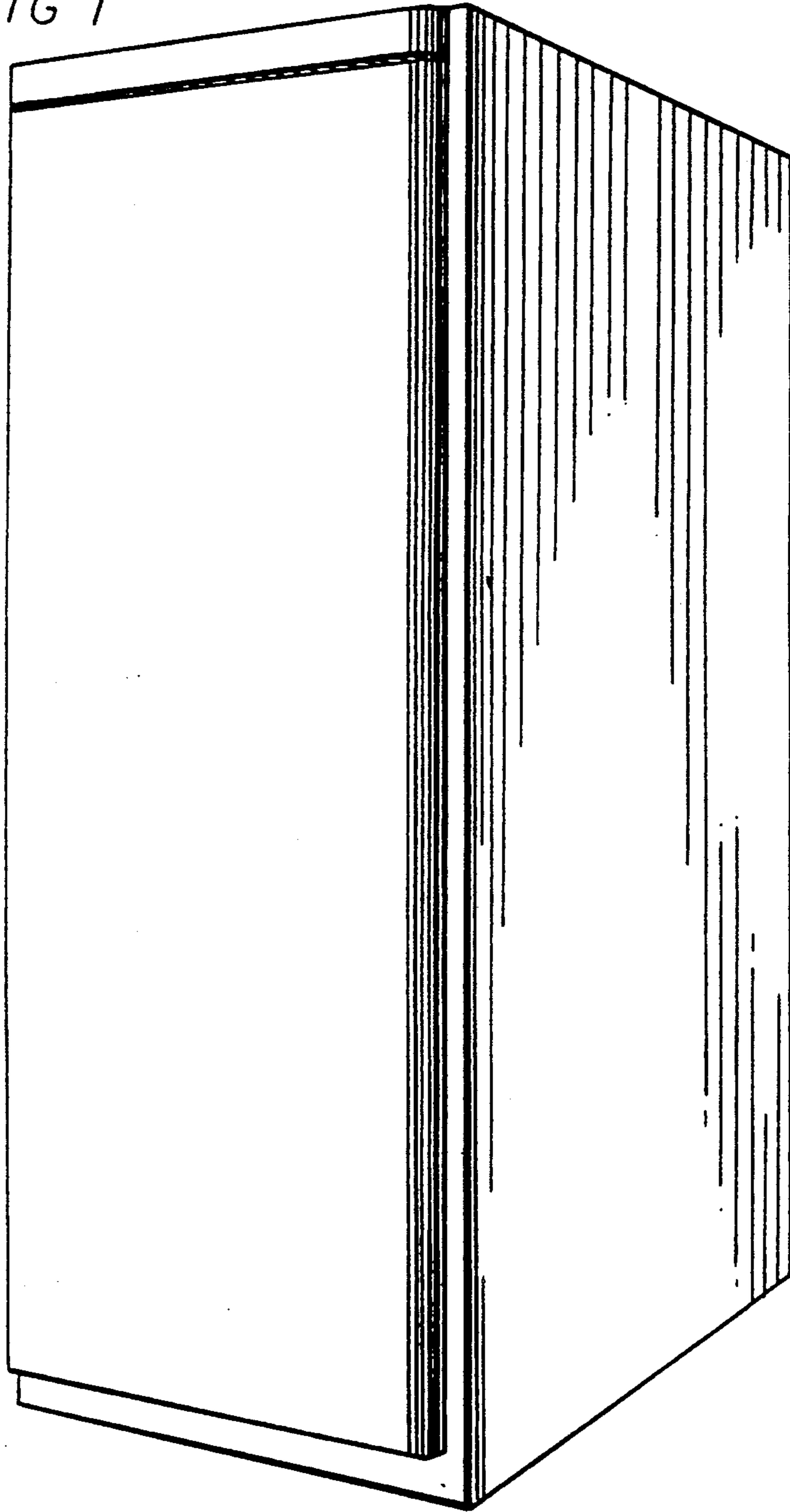
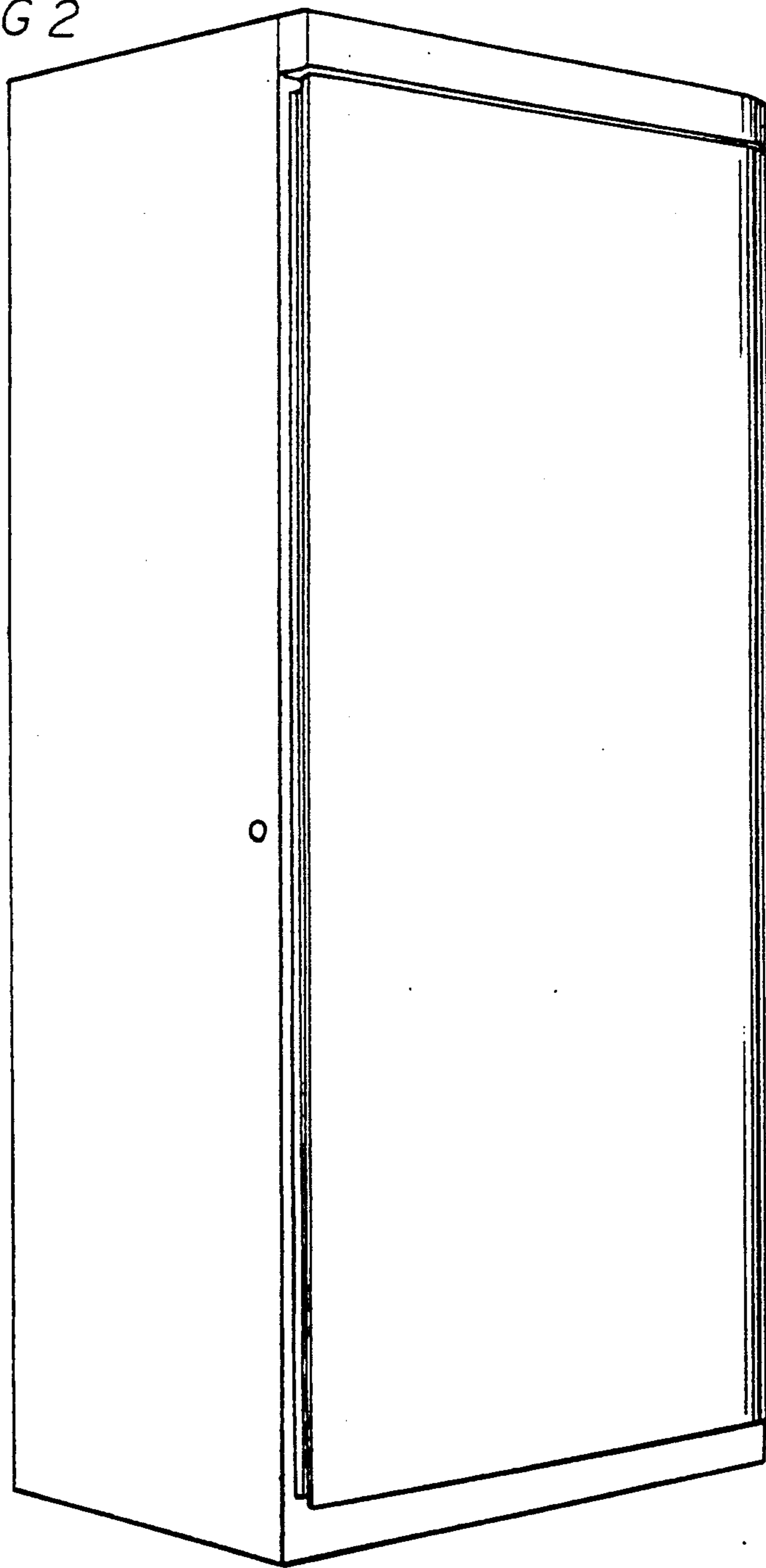

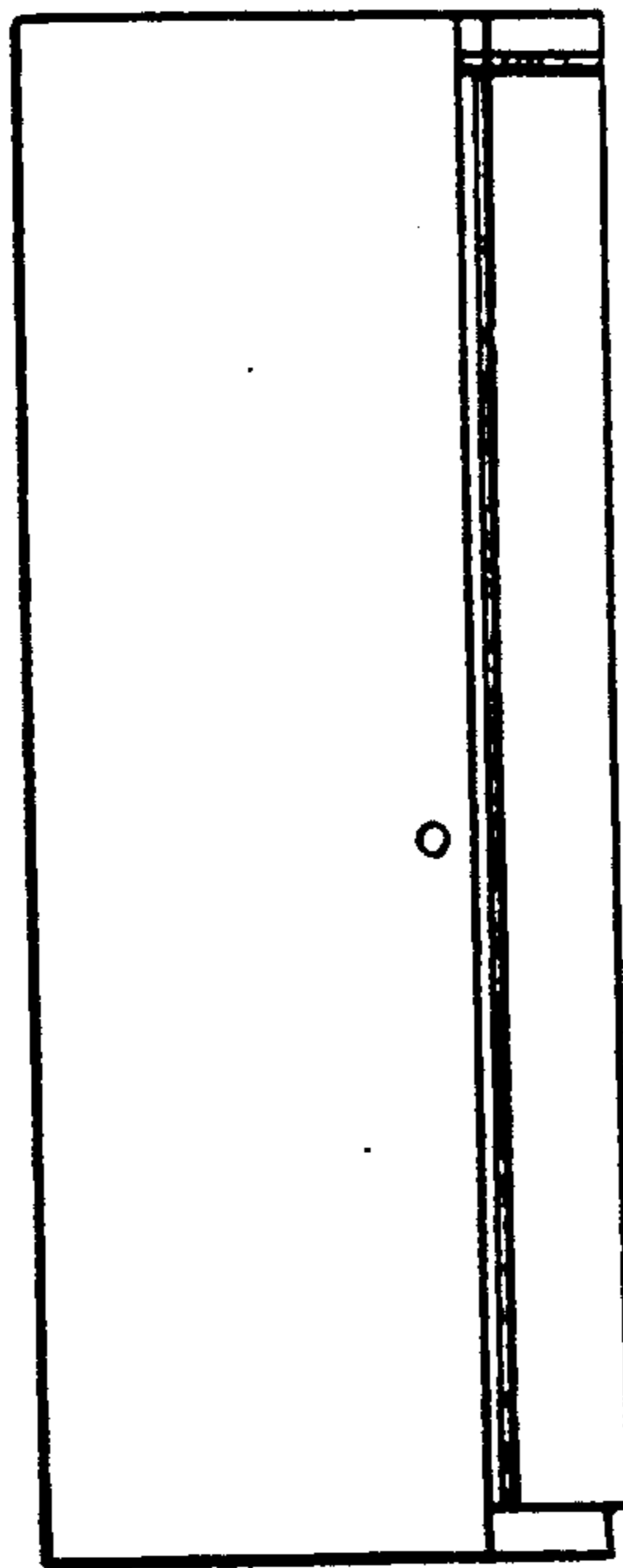
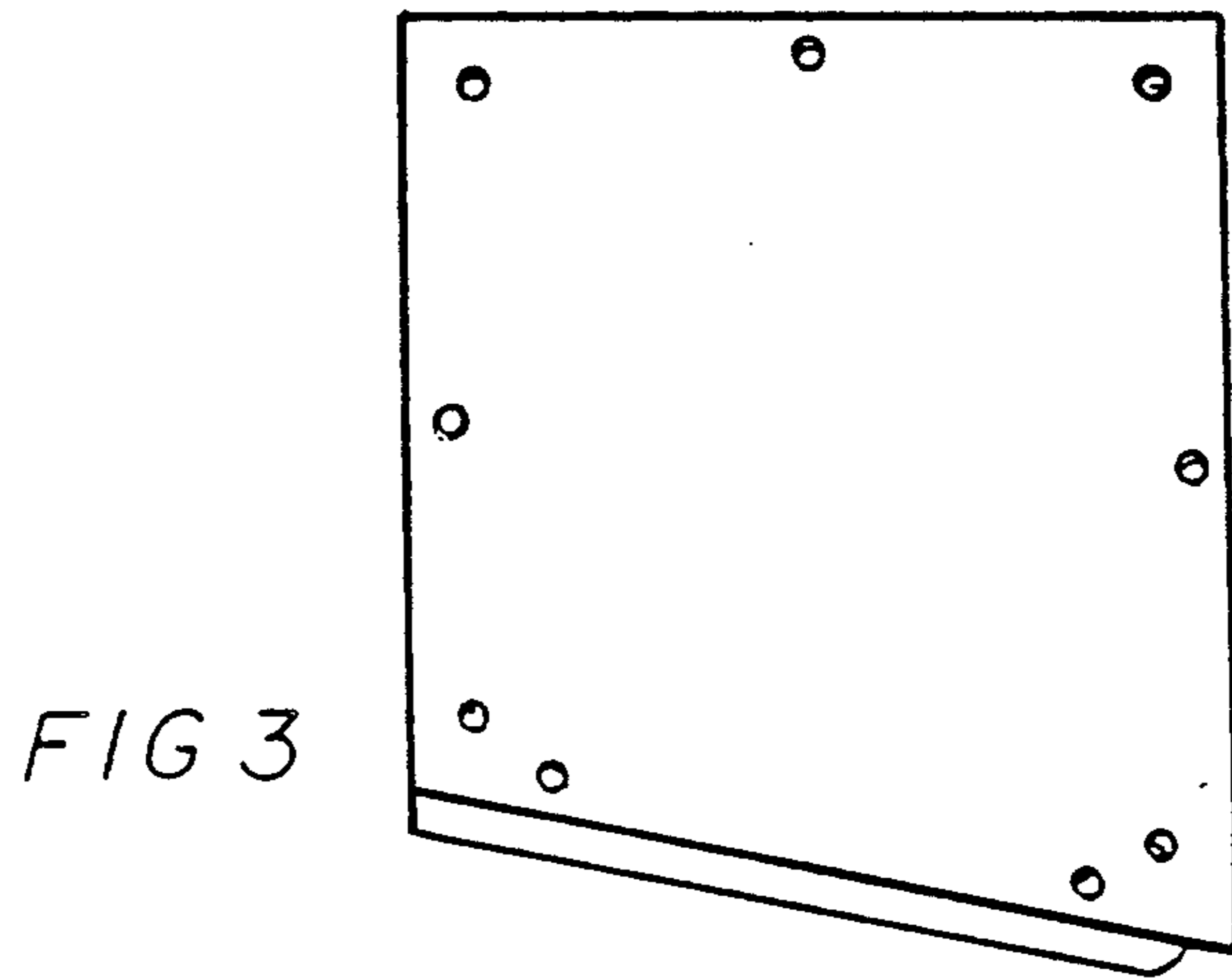

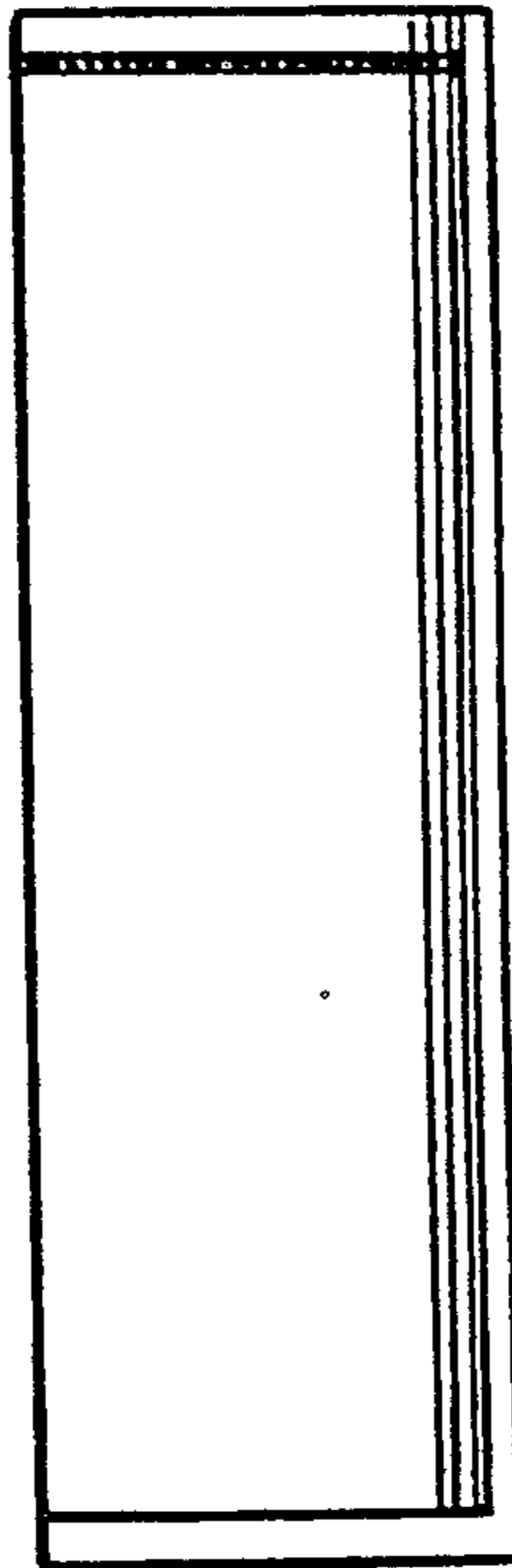

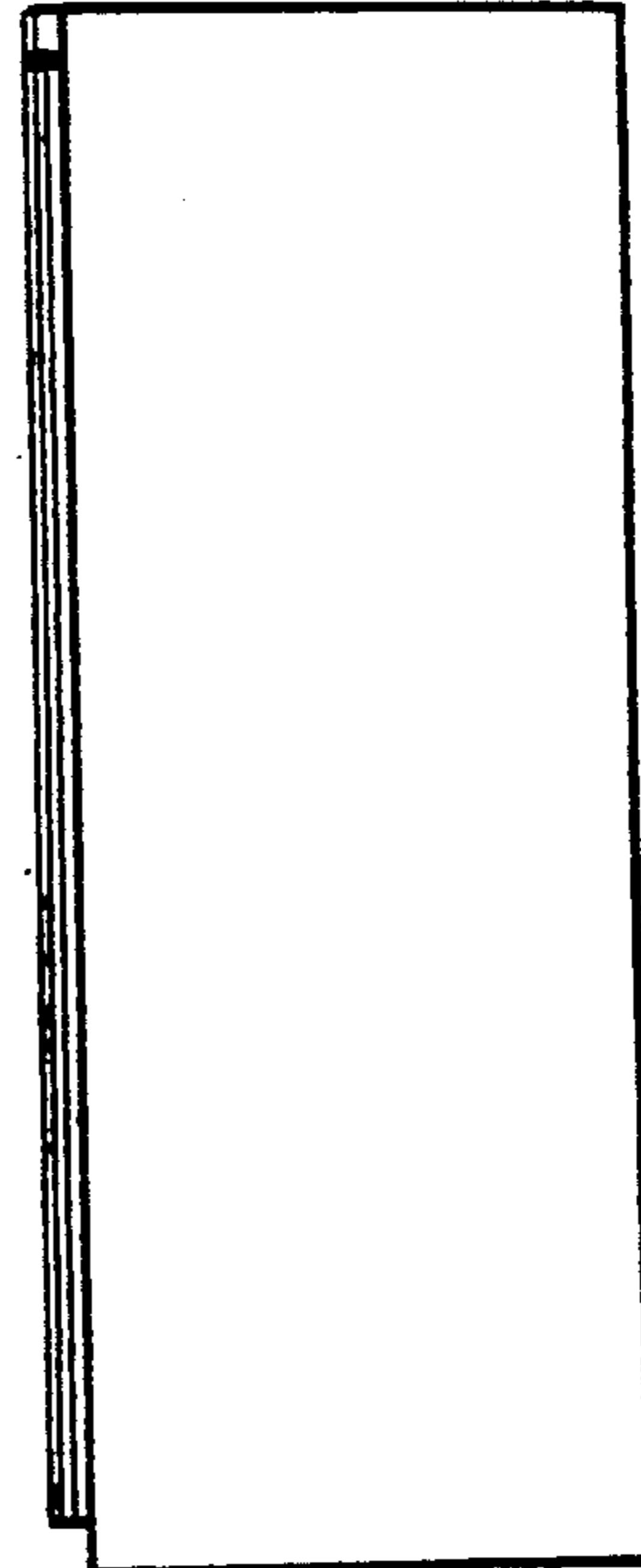

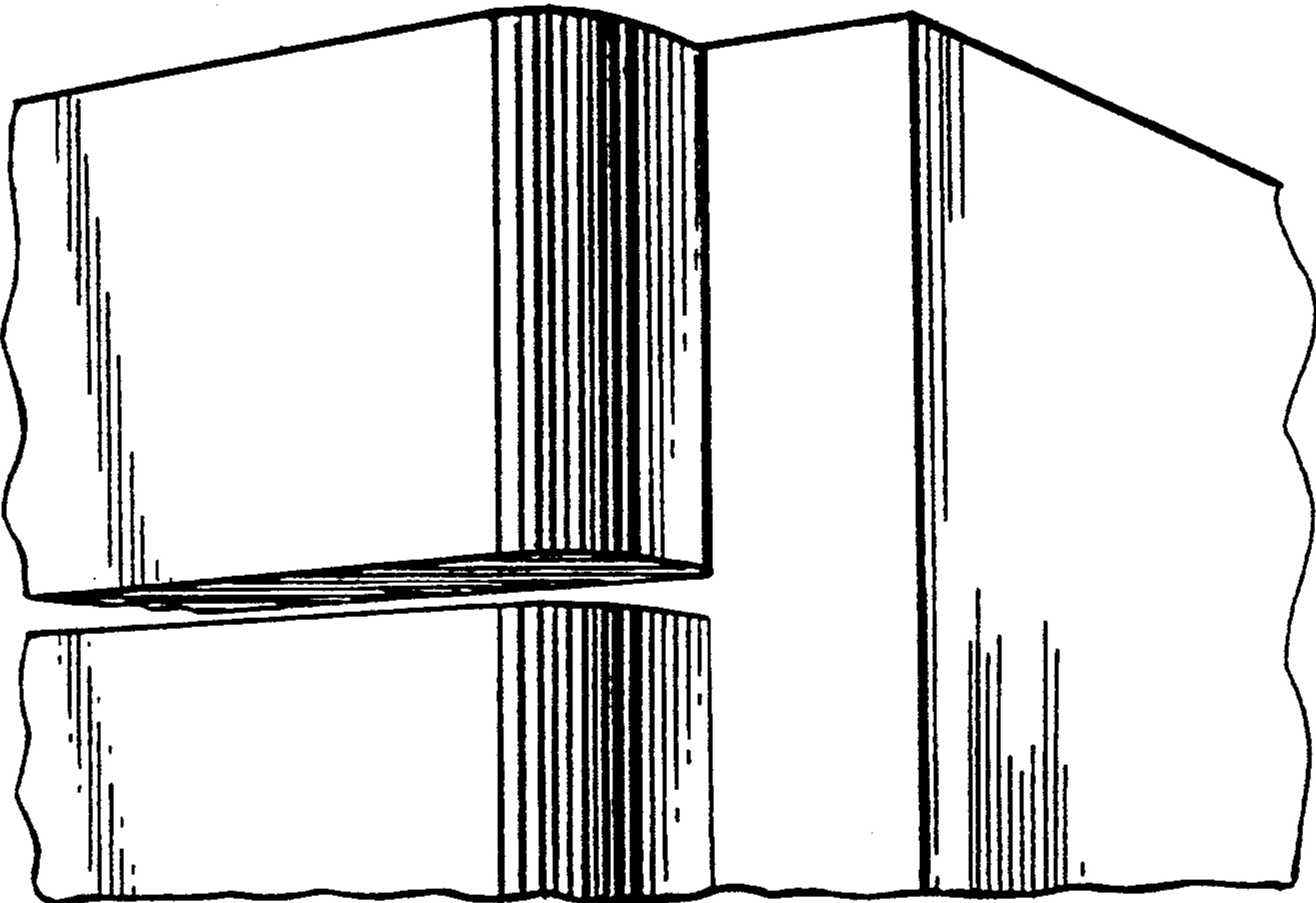
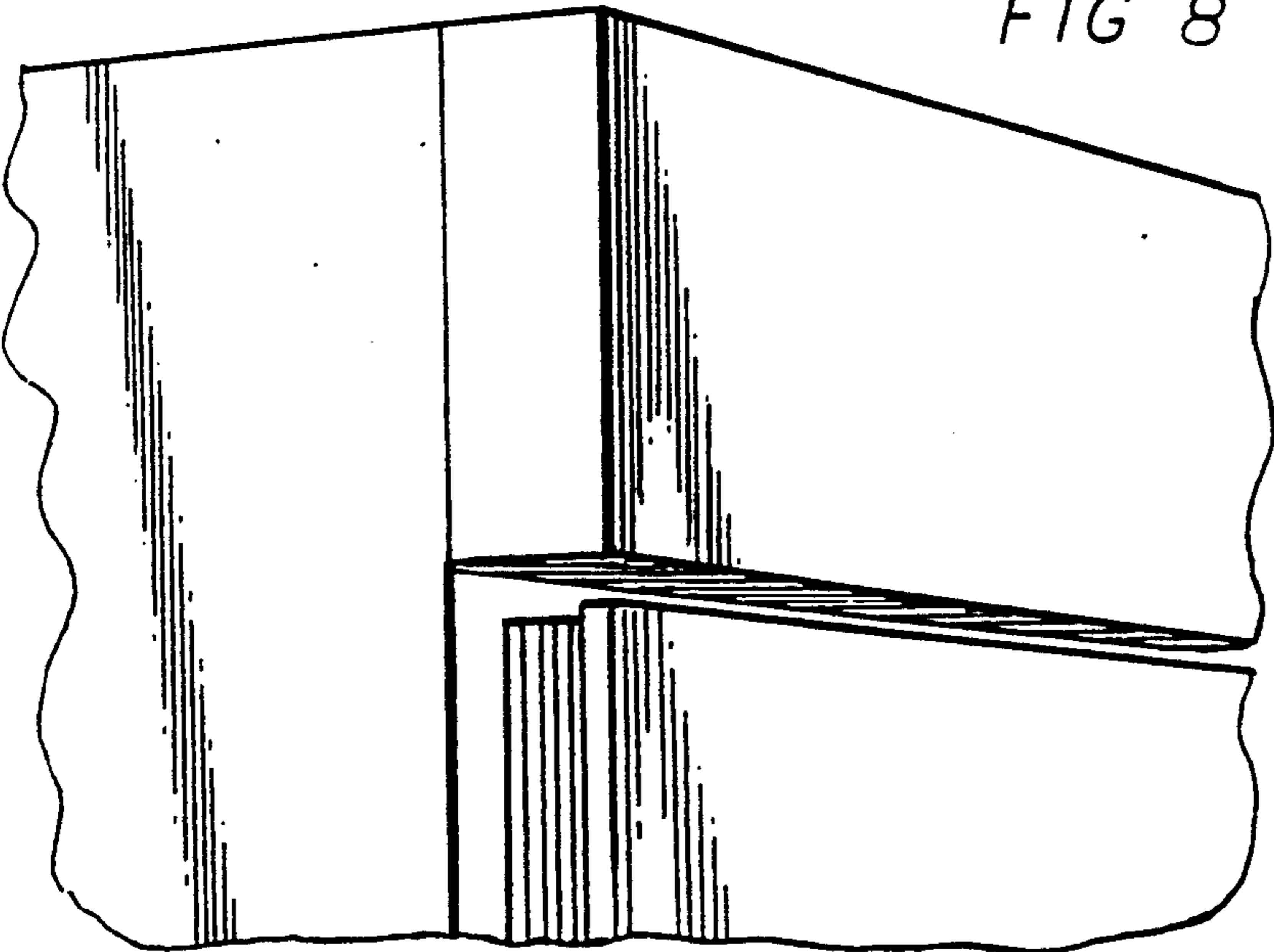

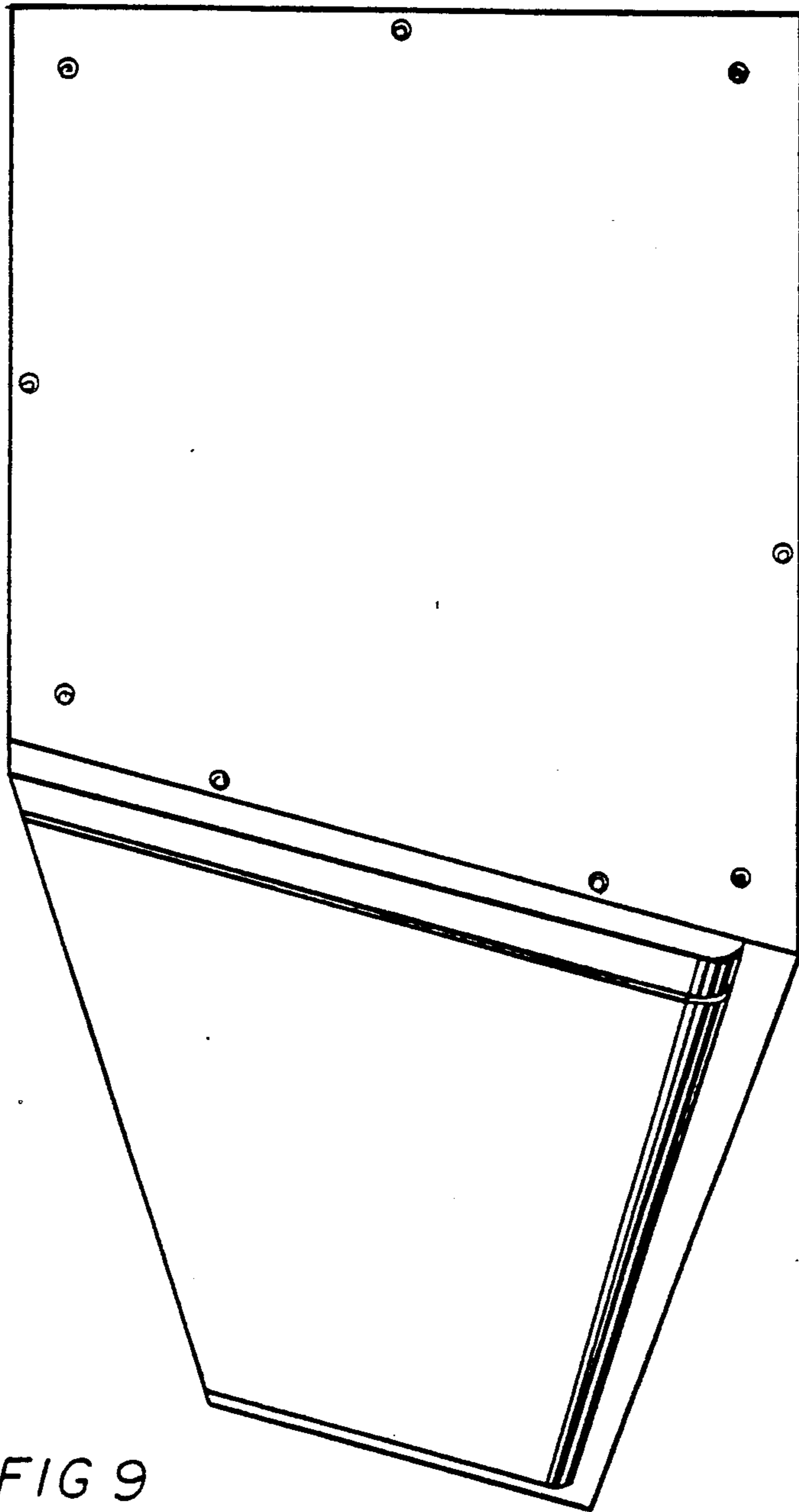

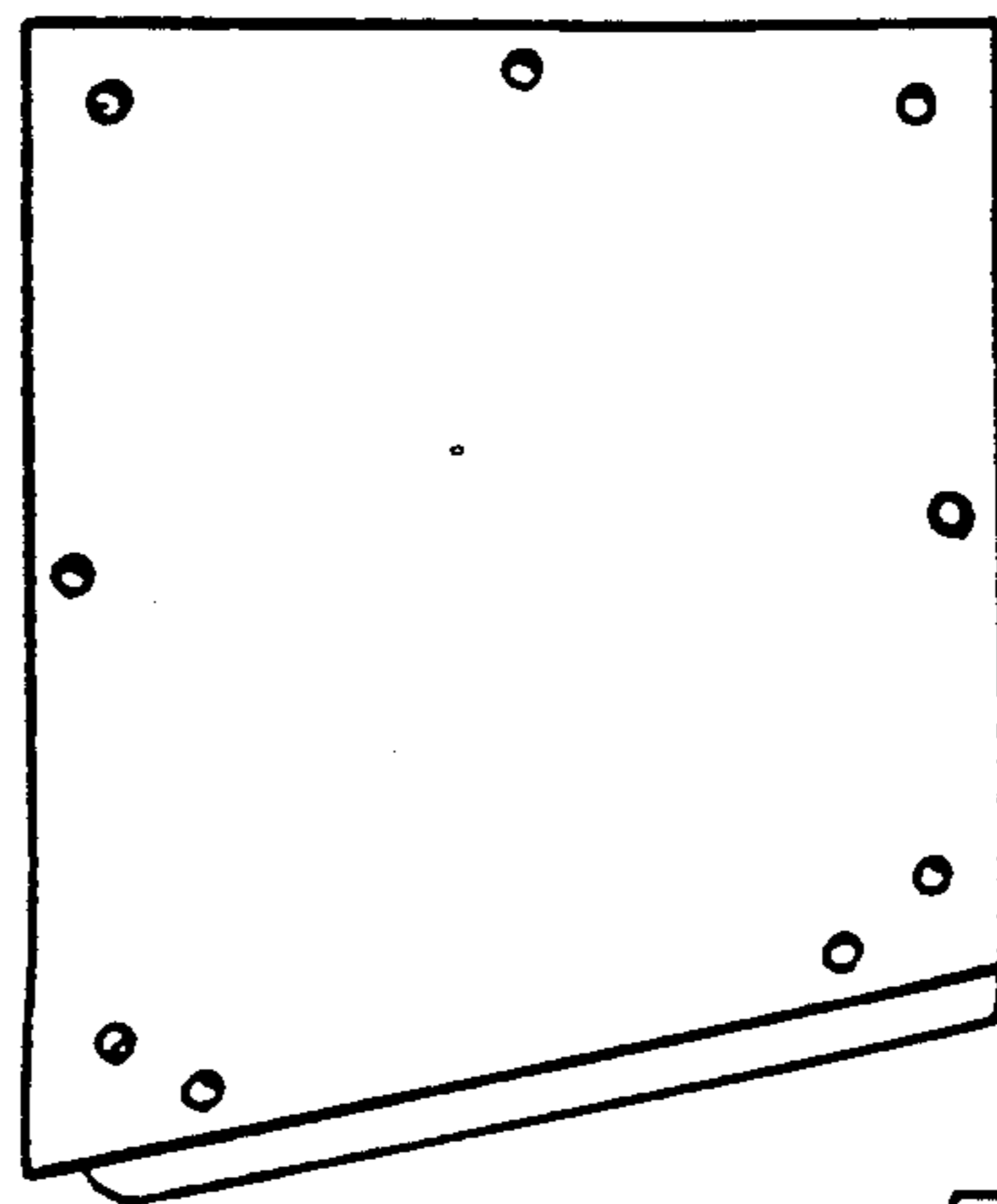

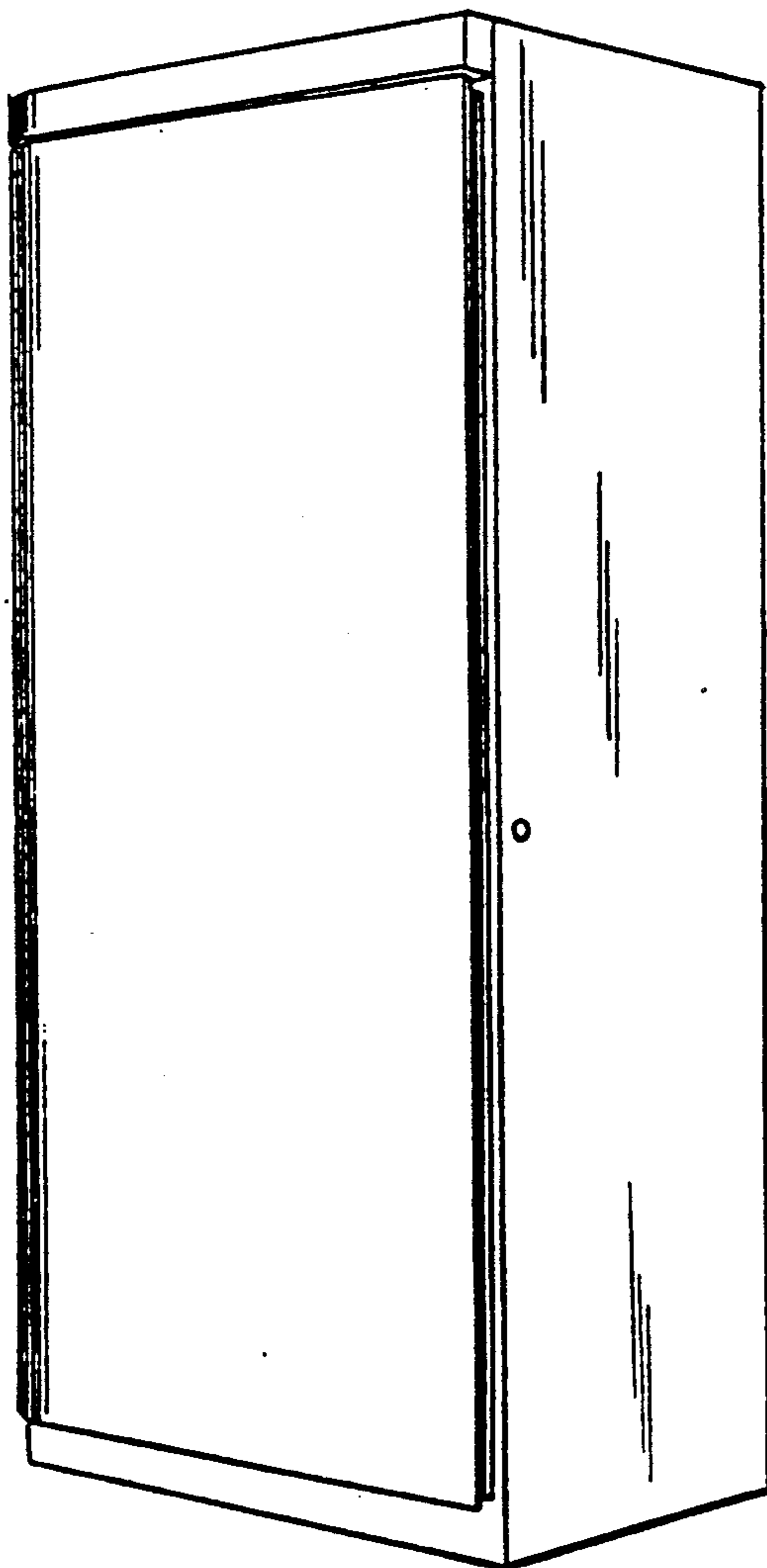

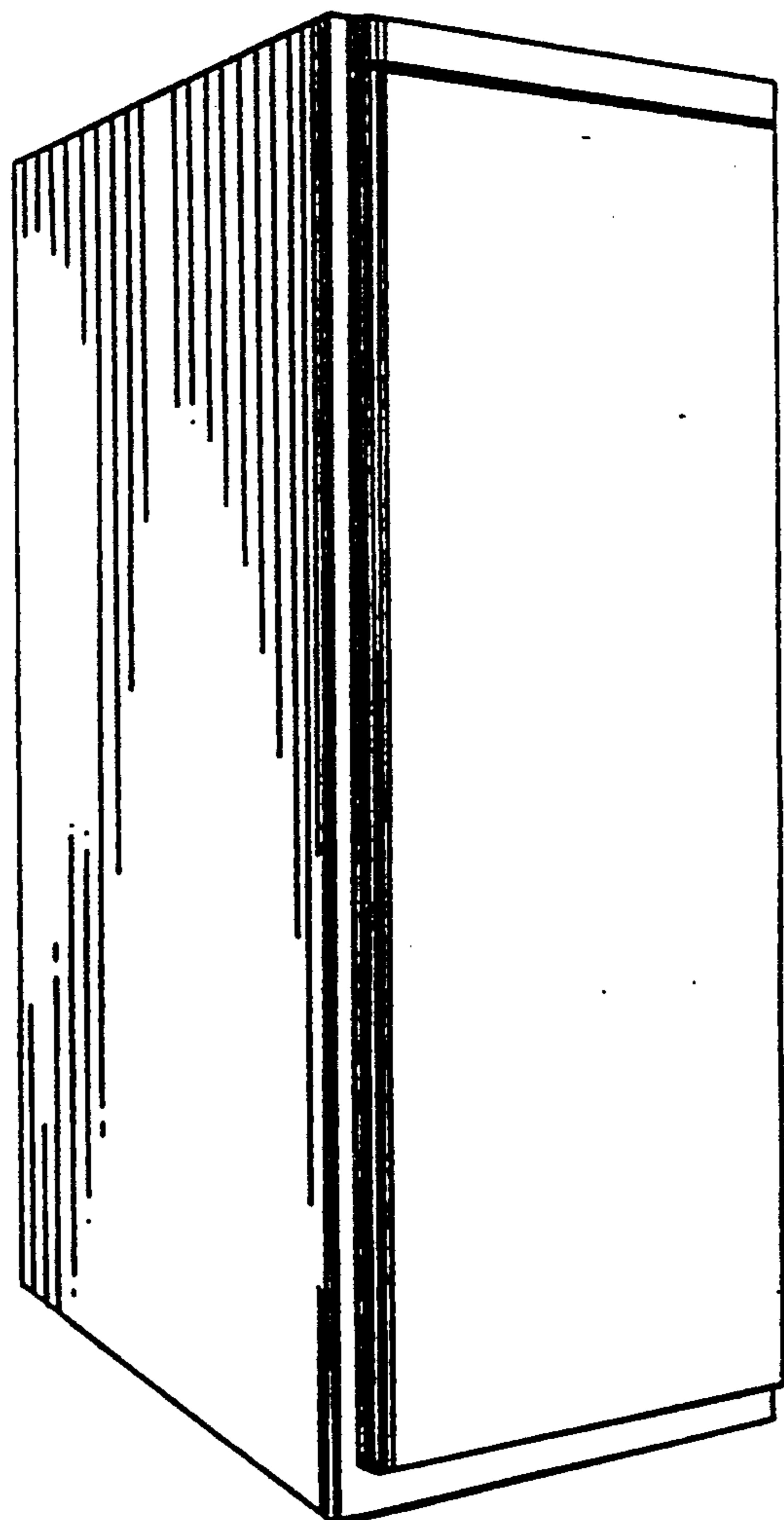
