[57] CLAIM

The ornamental design for a telephone handset housing or similar article, as shown and described.

DESCRIPTION

FIG. 1 is a left side, top and front perspective view of a telephone handset housing or similar article showing our new design; FIG. 2 is a bottom elevational view thereof; FIG. 3 is a right side elevational view thereof; and, FIG. 4 is a bottom plan view thereof. The broken line showing of an antenna in FIGS. 1-4 and push button in FIG. 1 is for illustrative purposes only and forms no part of the claimed design.

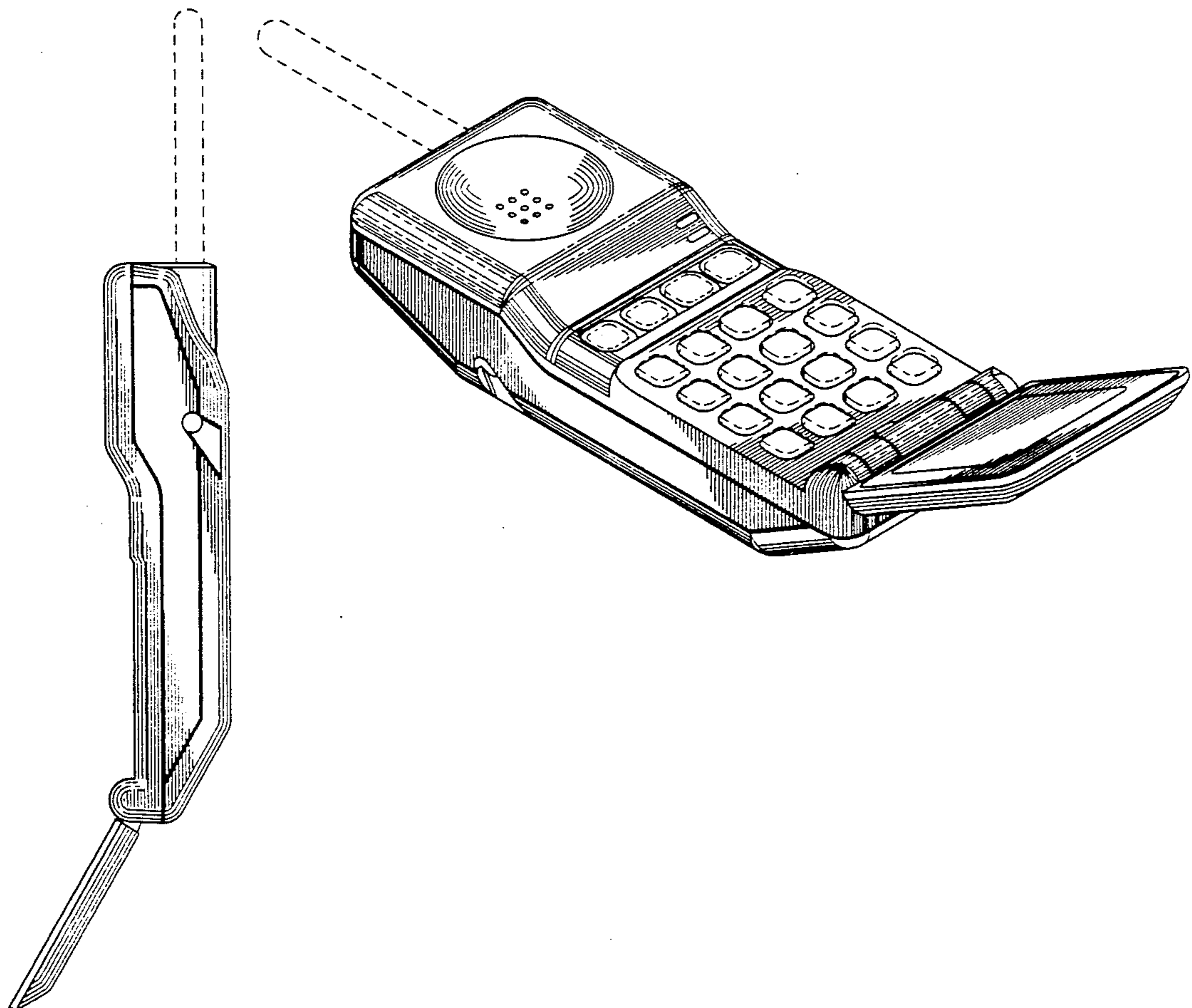
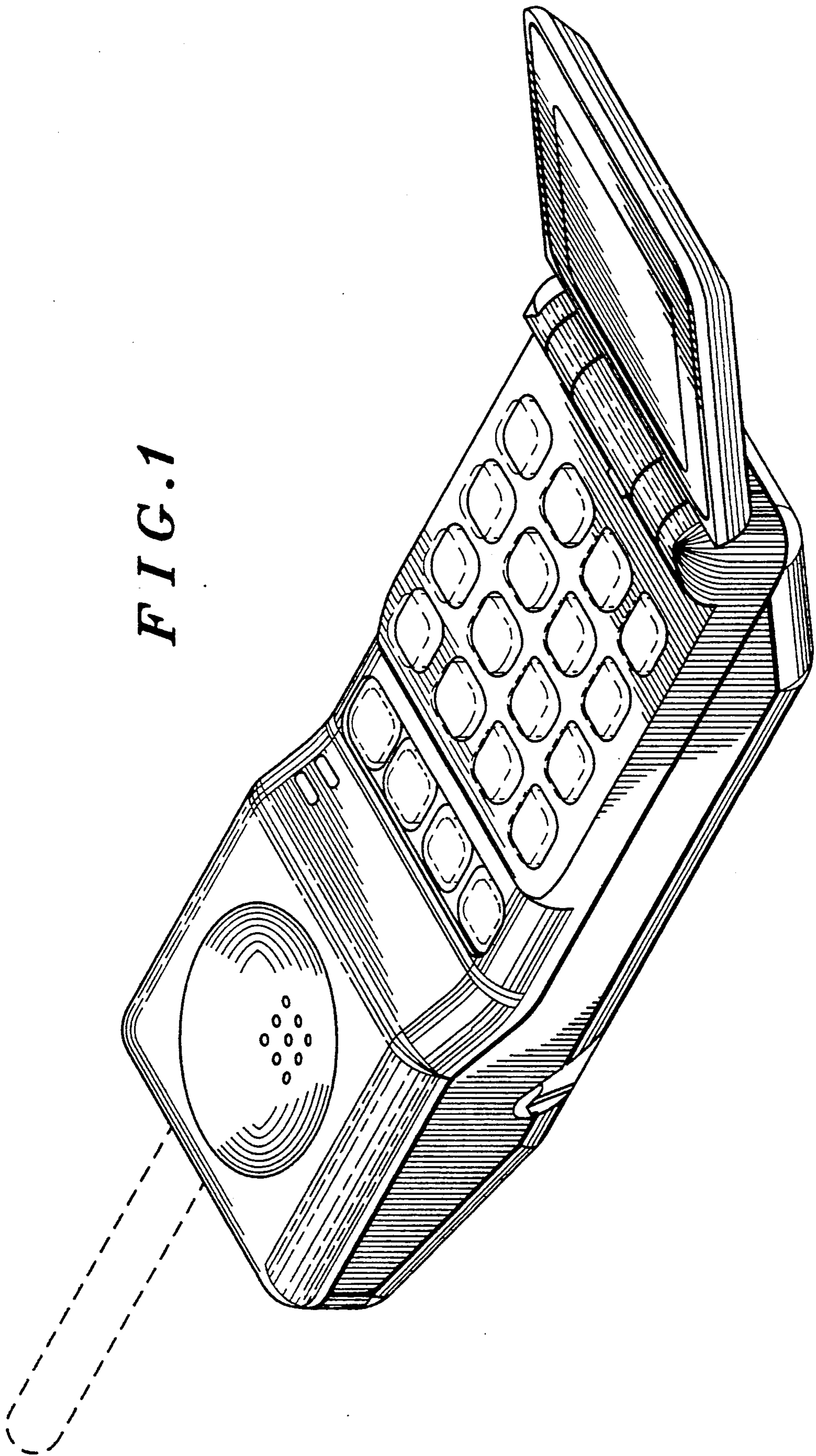

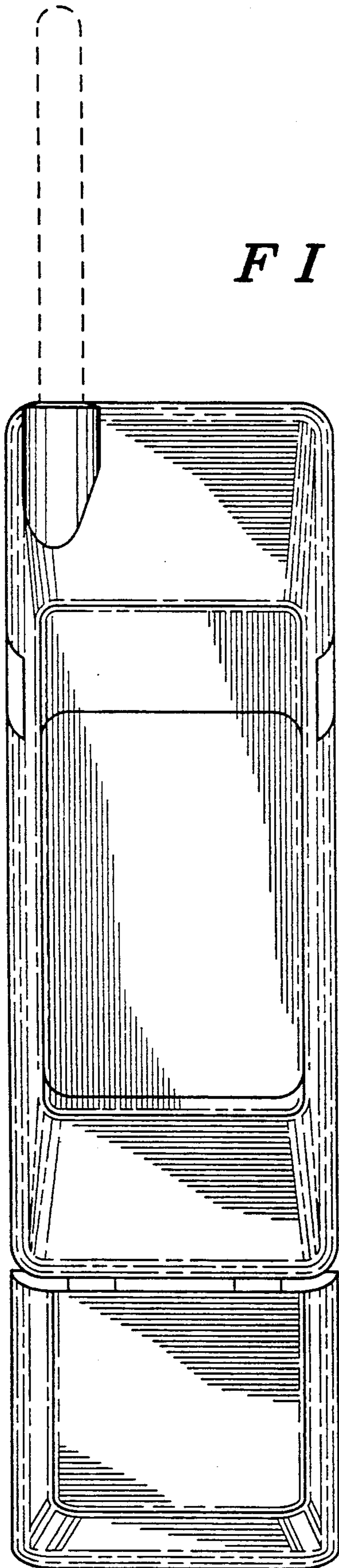
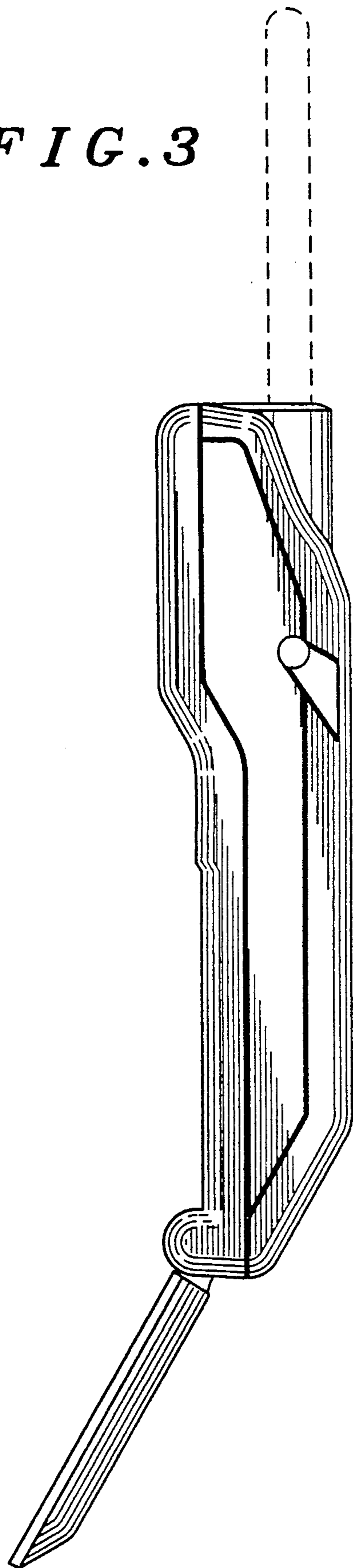

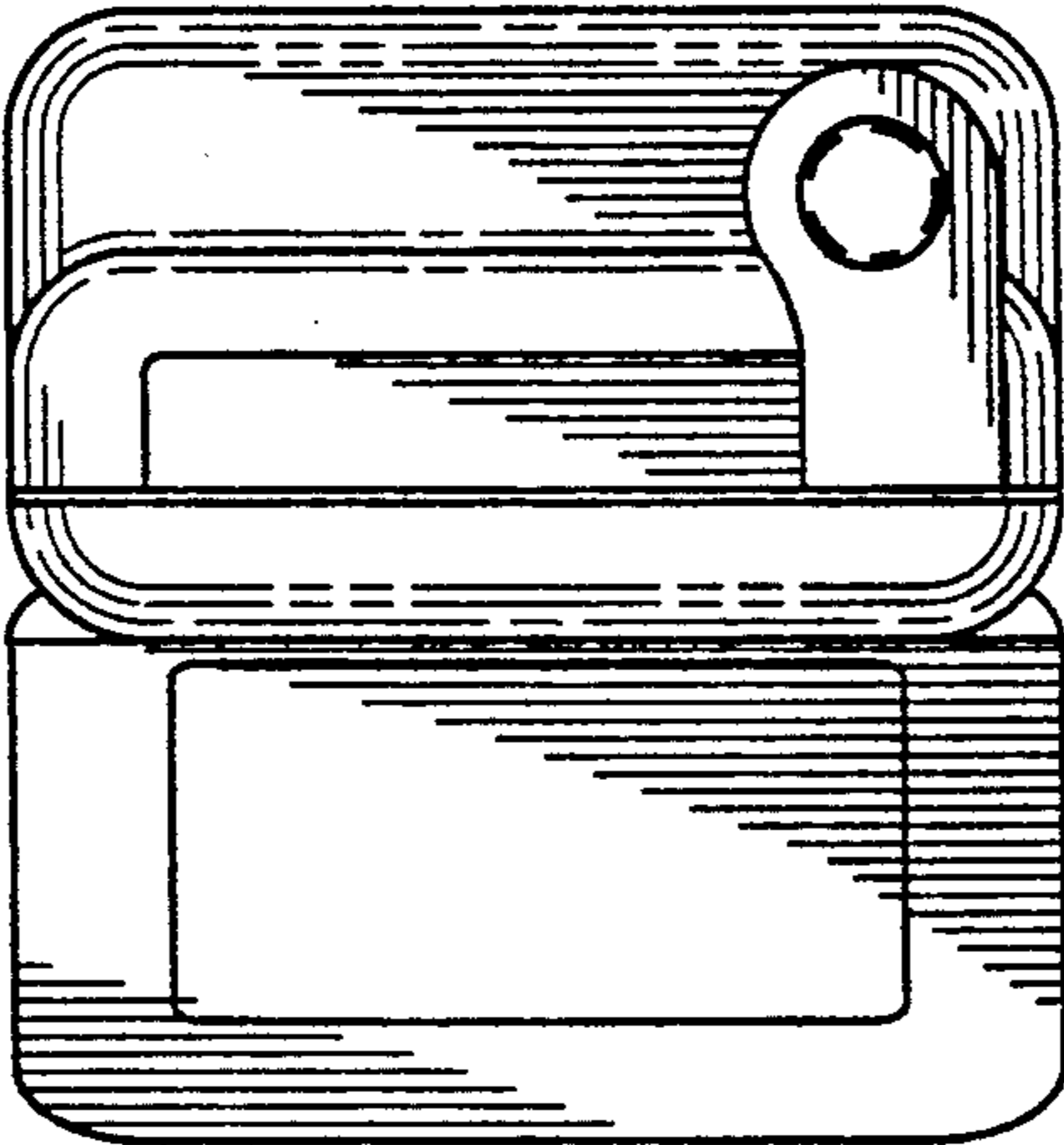
