The ornamental design for a toy construction piece, as shown and described.

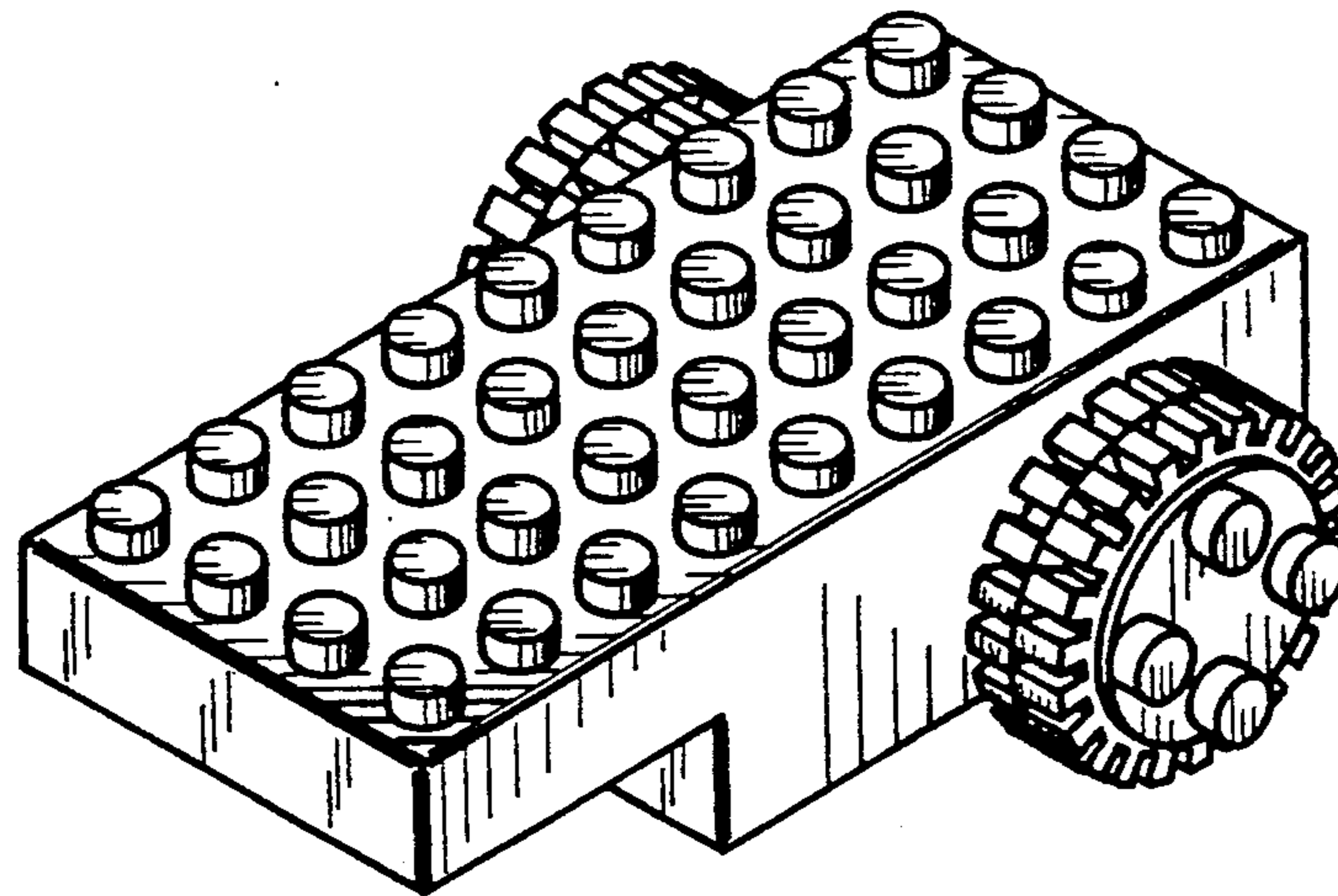
DESCRIPTION

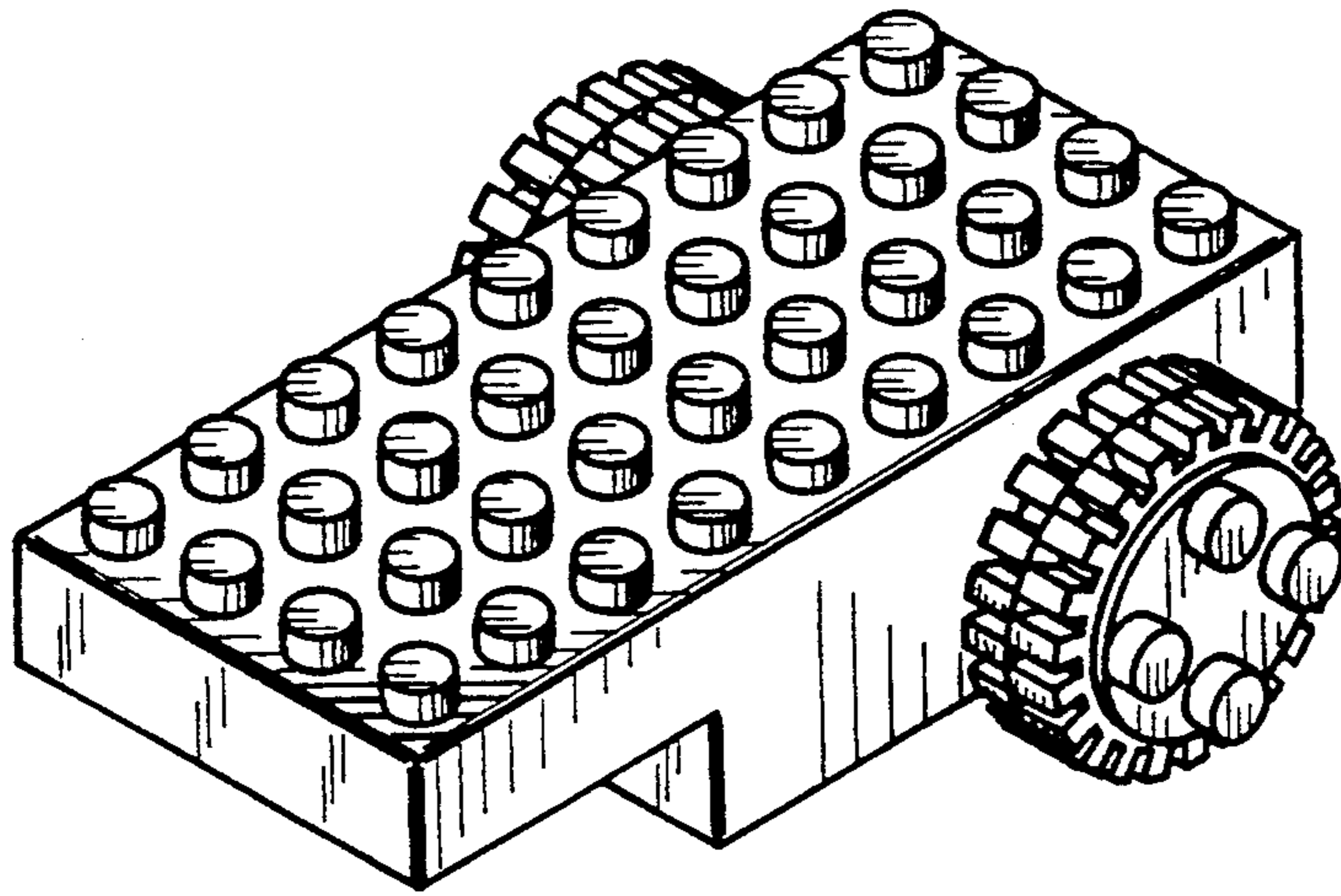

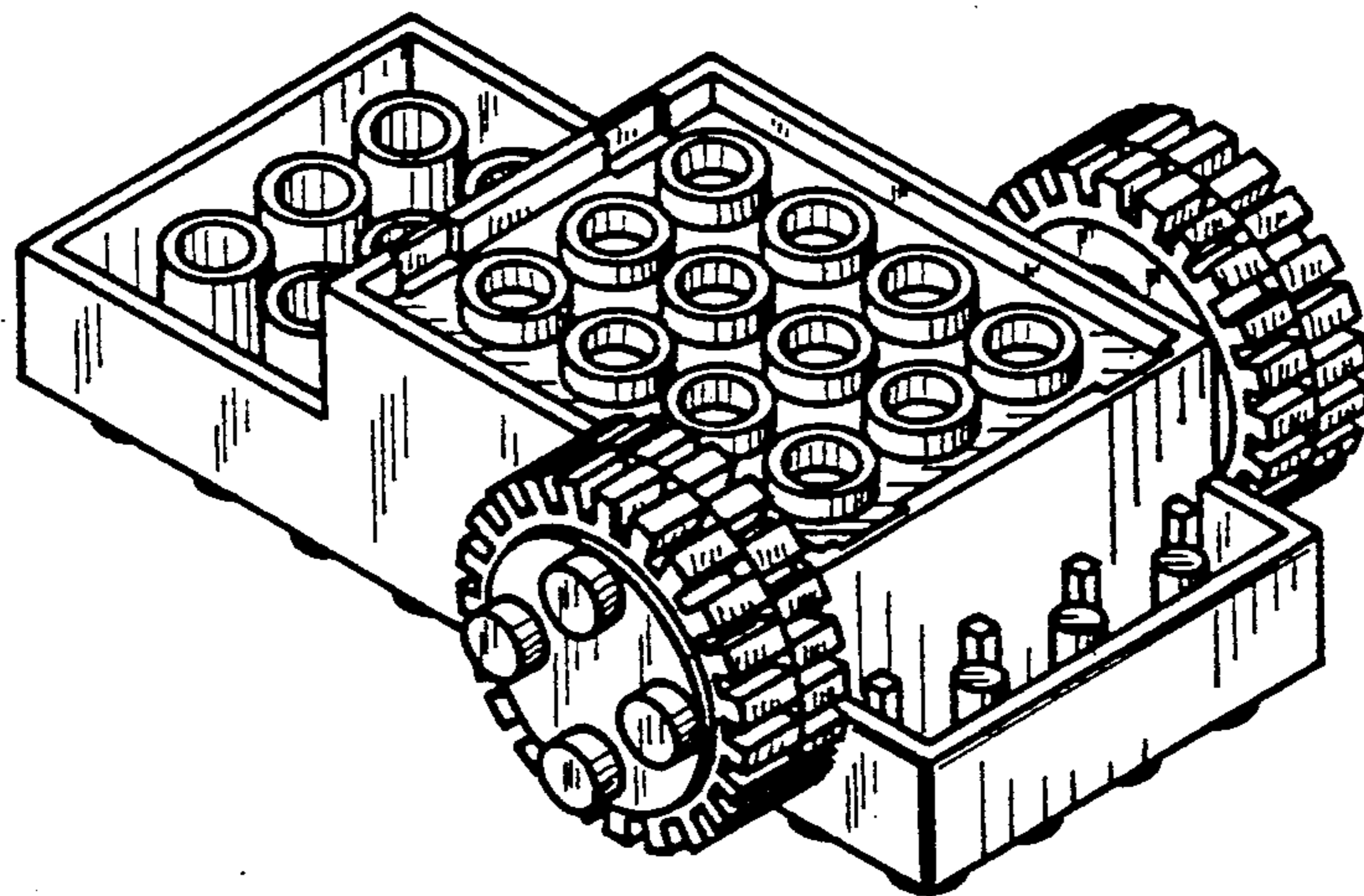

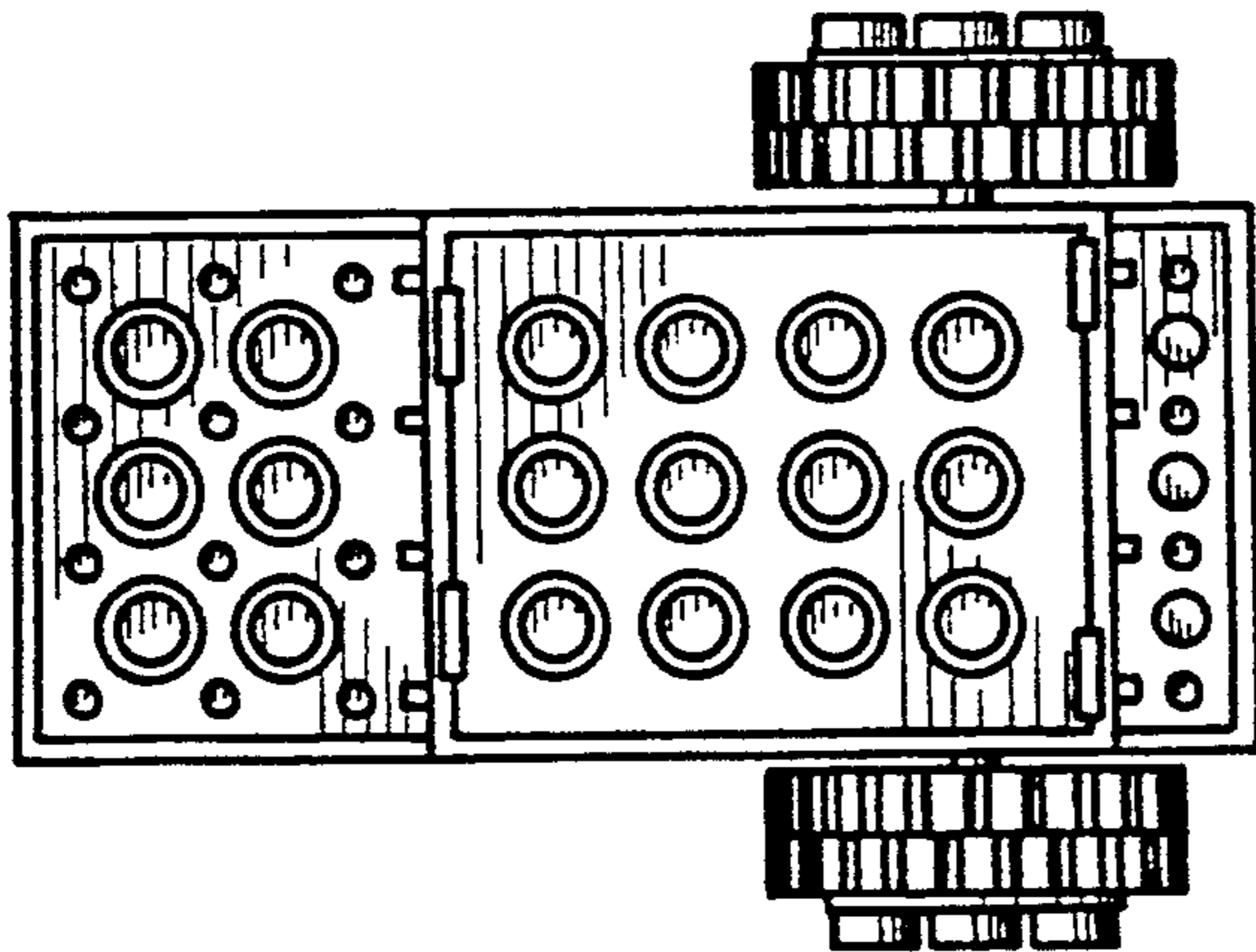

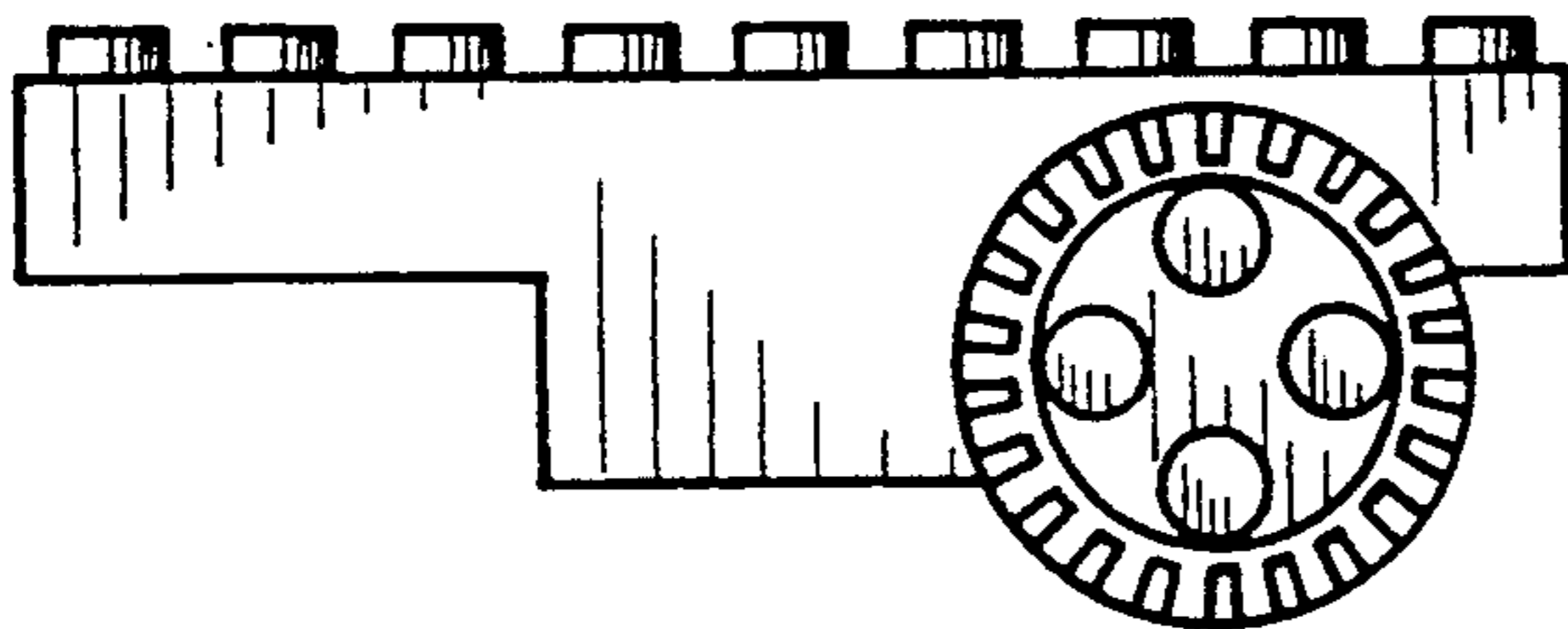

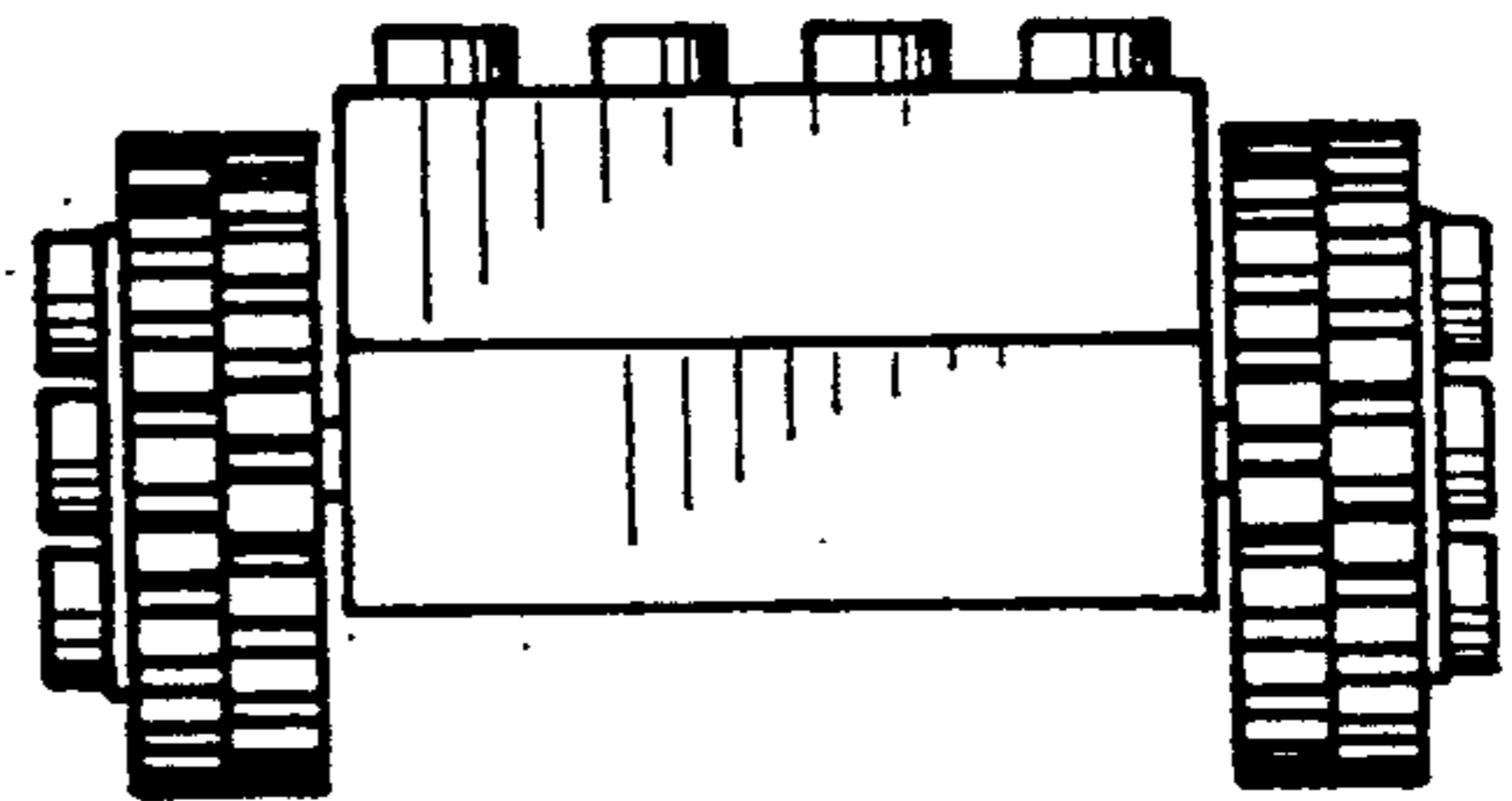

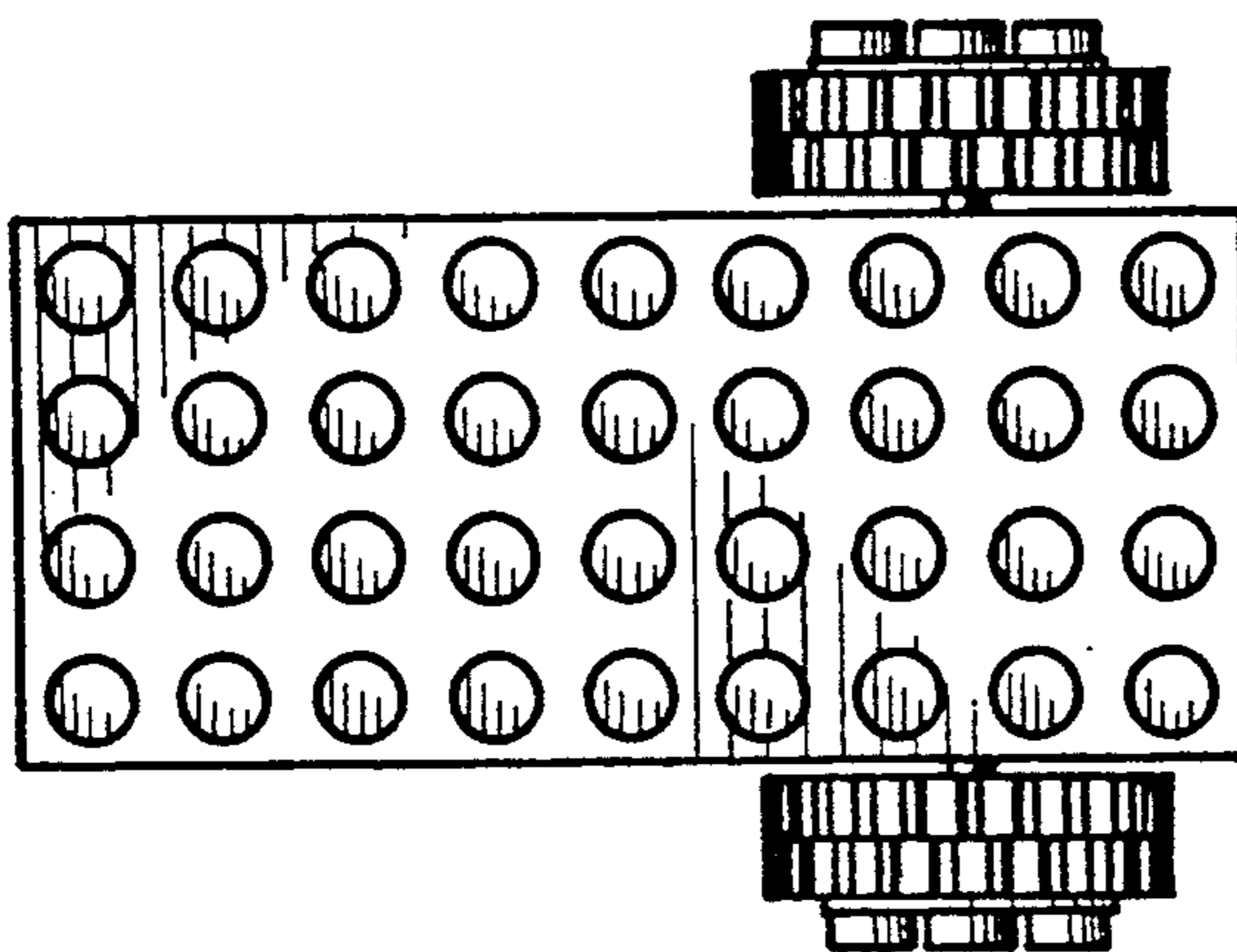

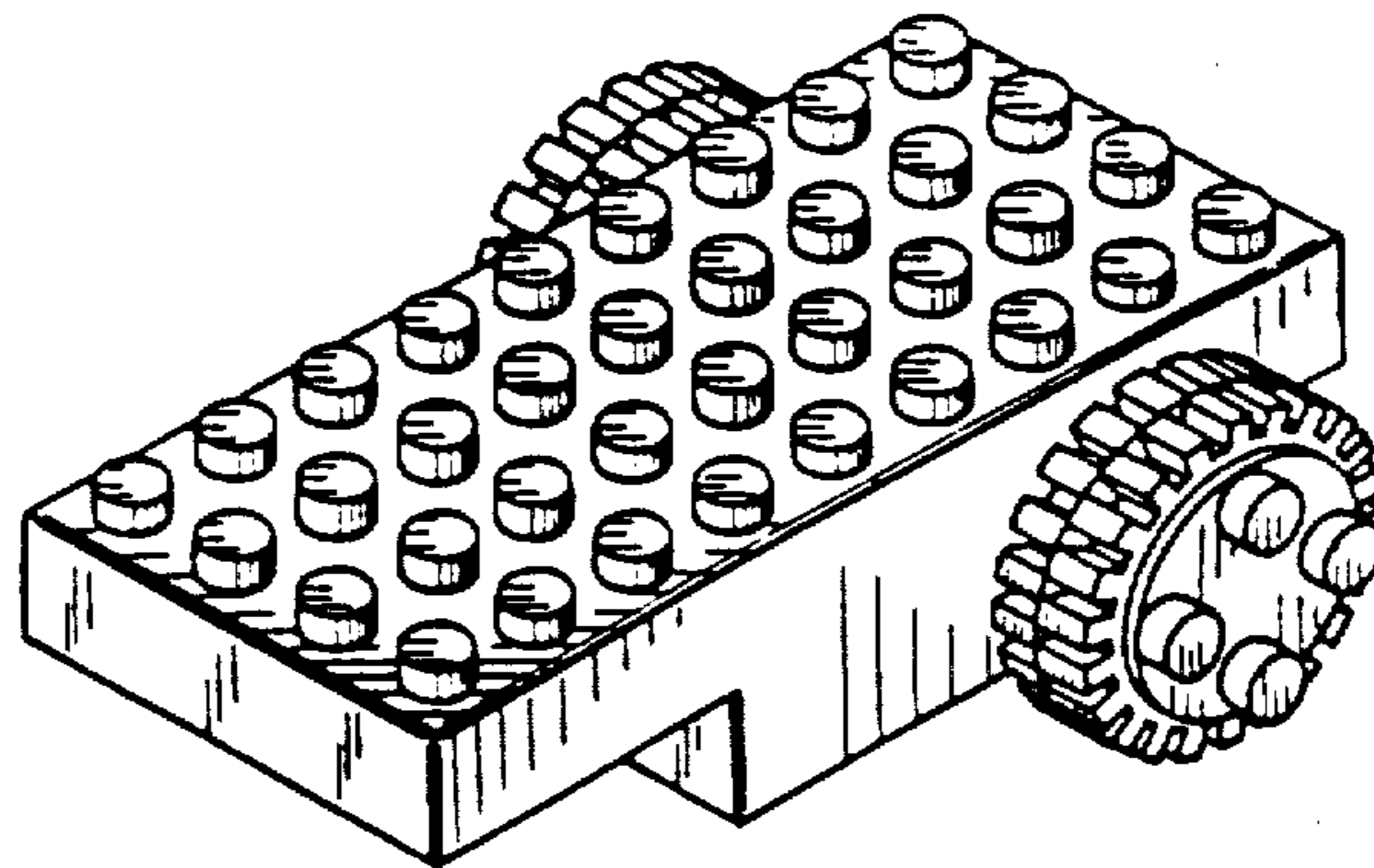

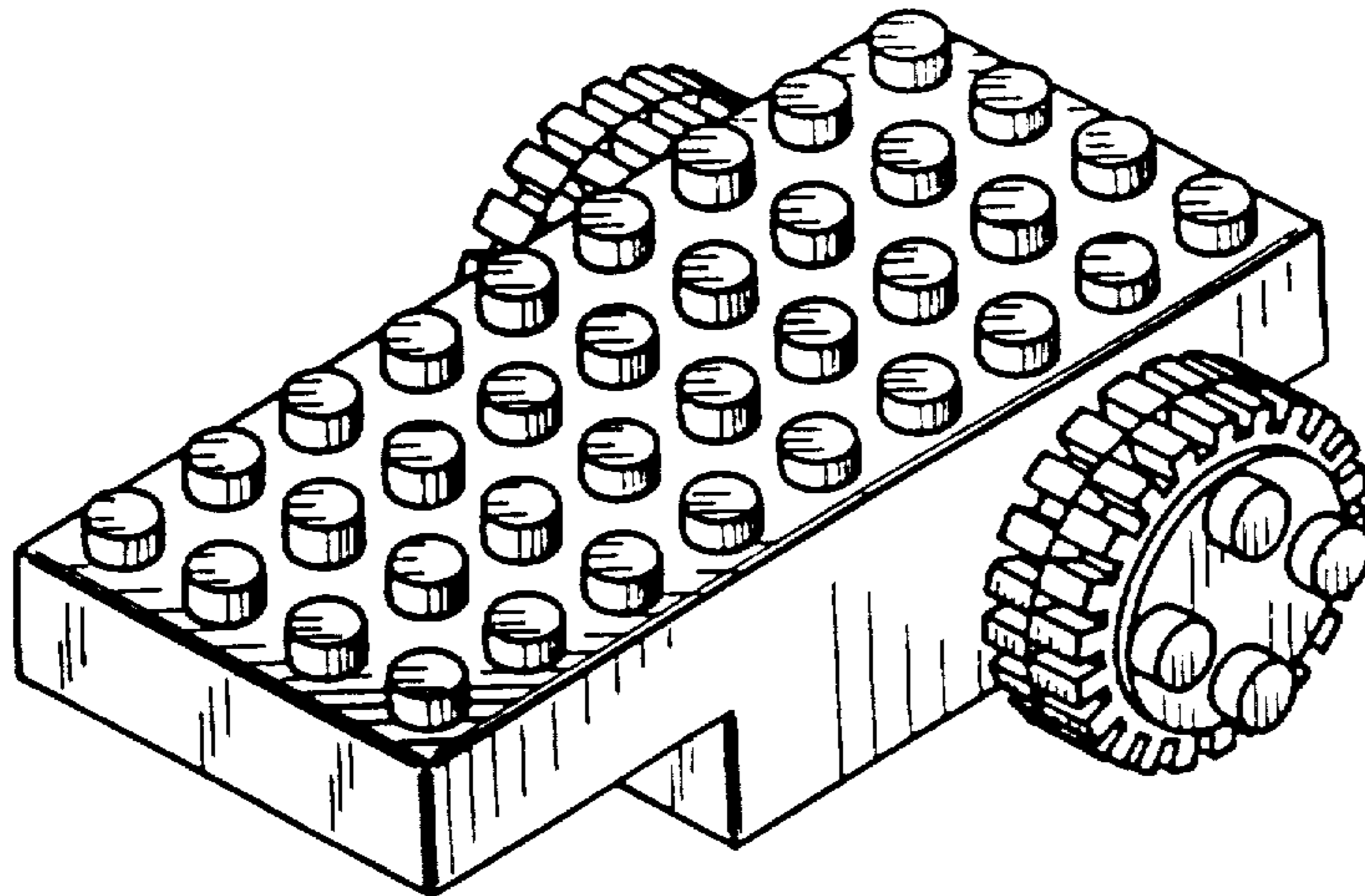
