 FIG. 34 is a bottom plan view of FIG. 31;

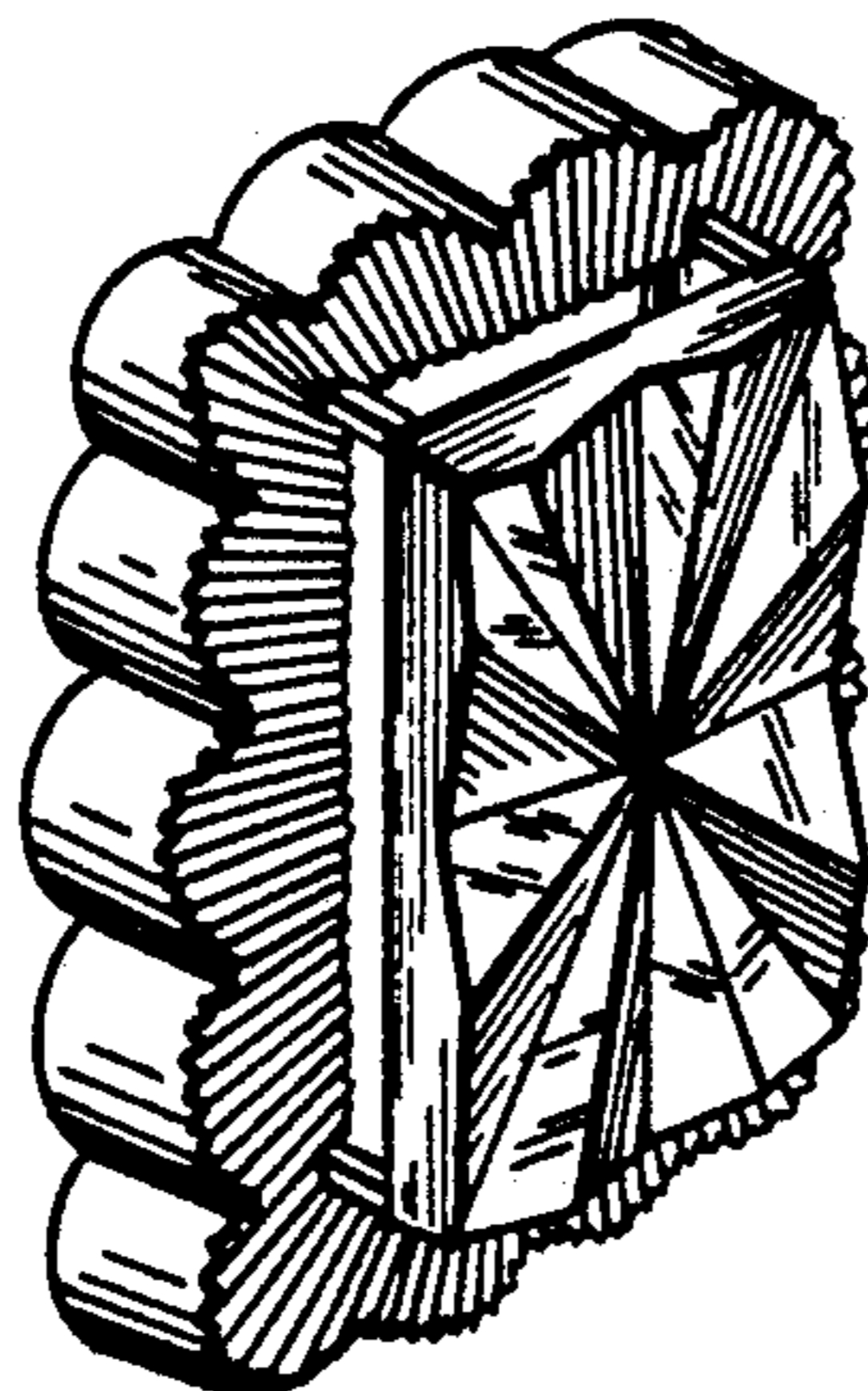


FIG. 35 is a top elevational view of FIG. 31;

FIG. 54 is a bottom elevatioanl view of FIG. 49.

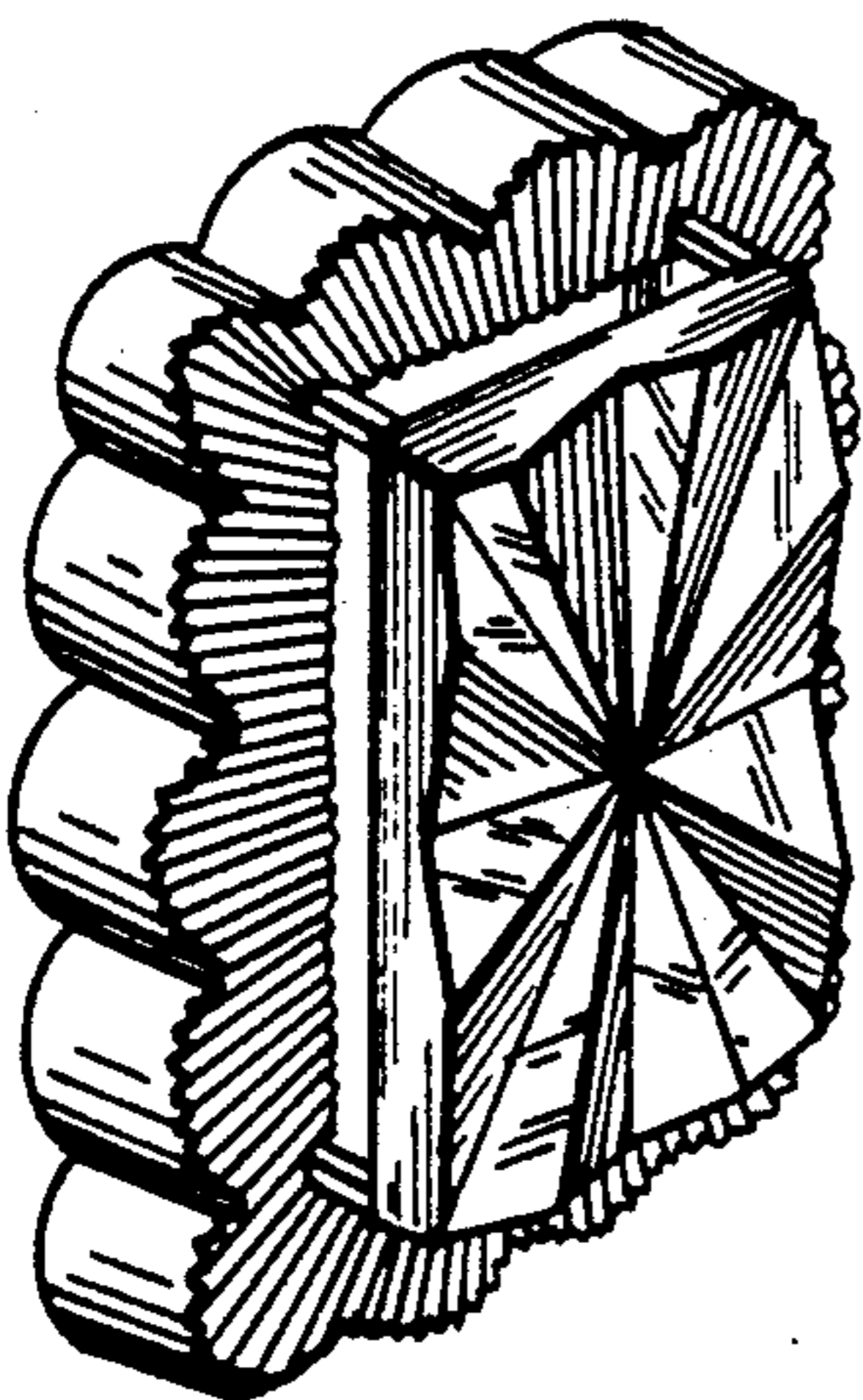

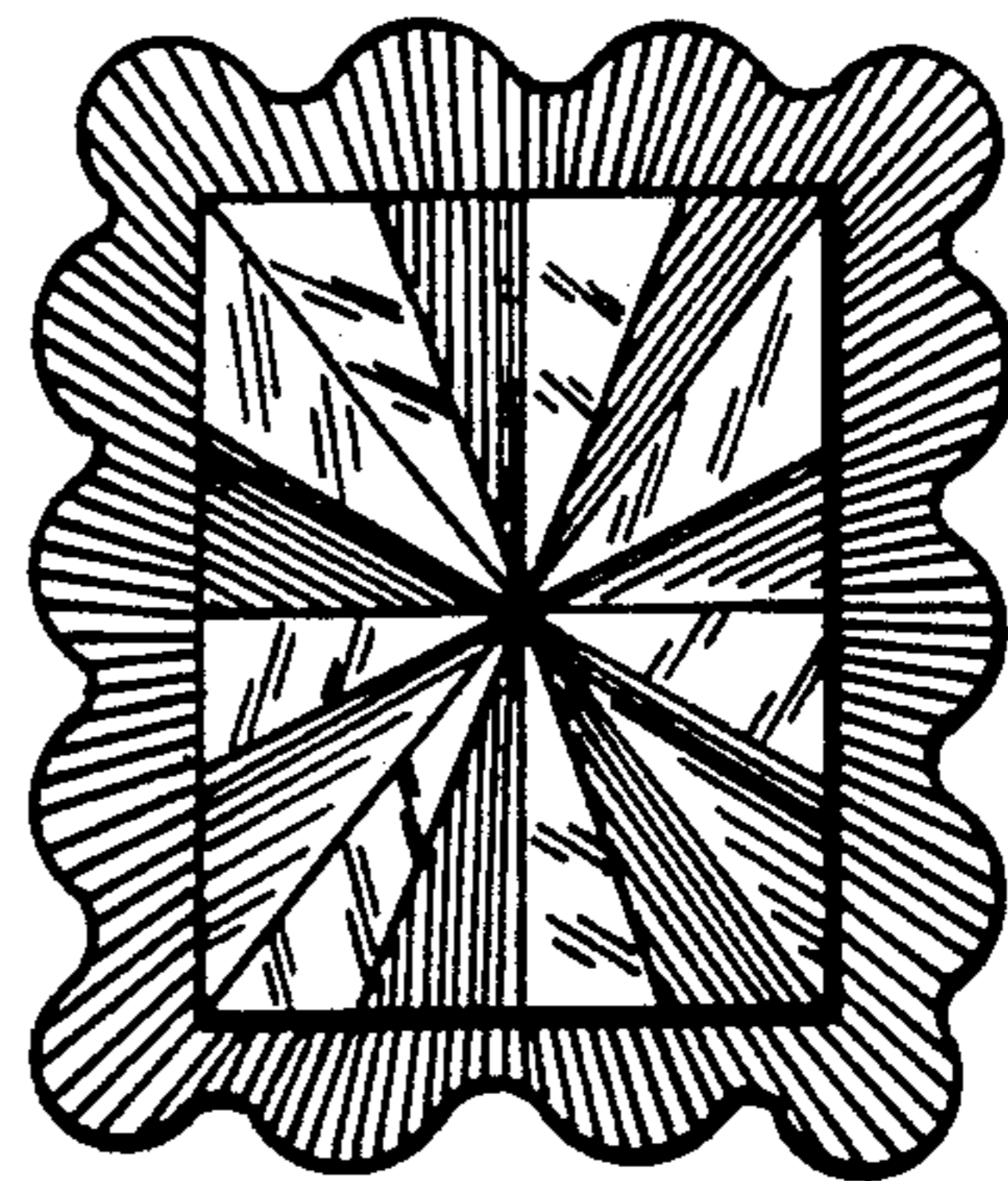

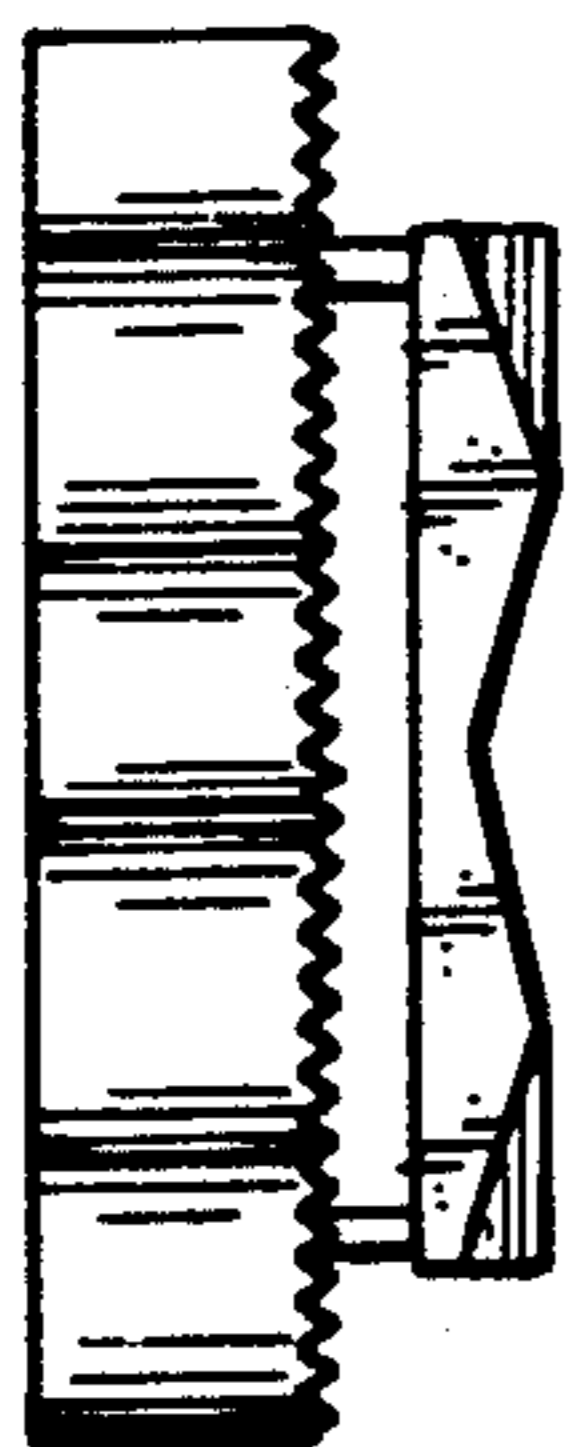

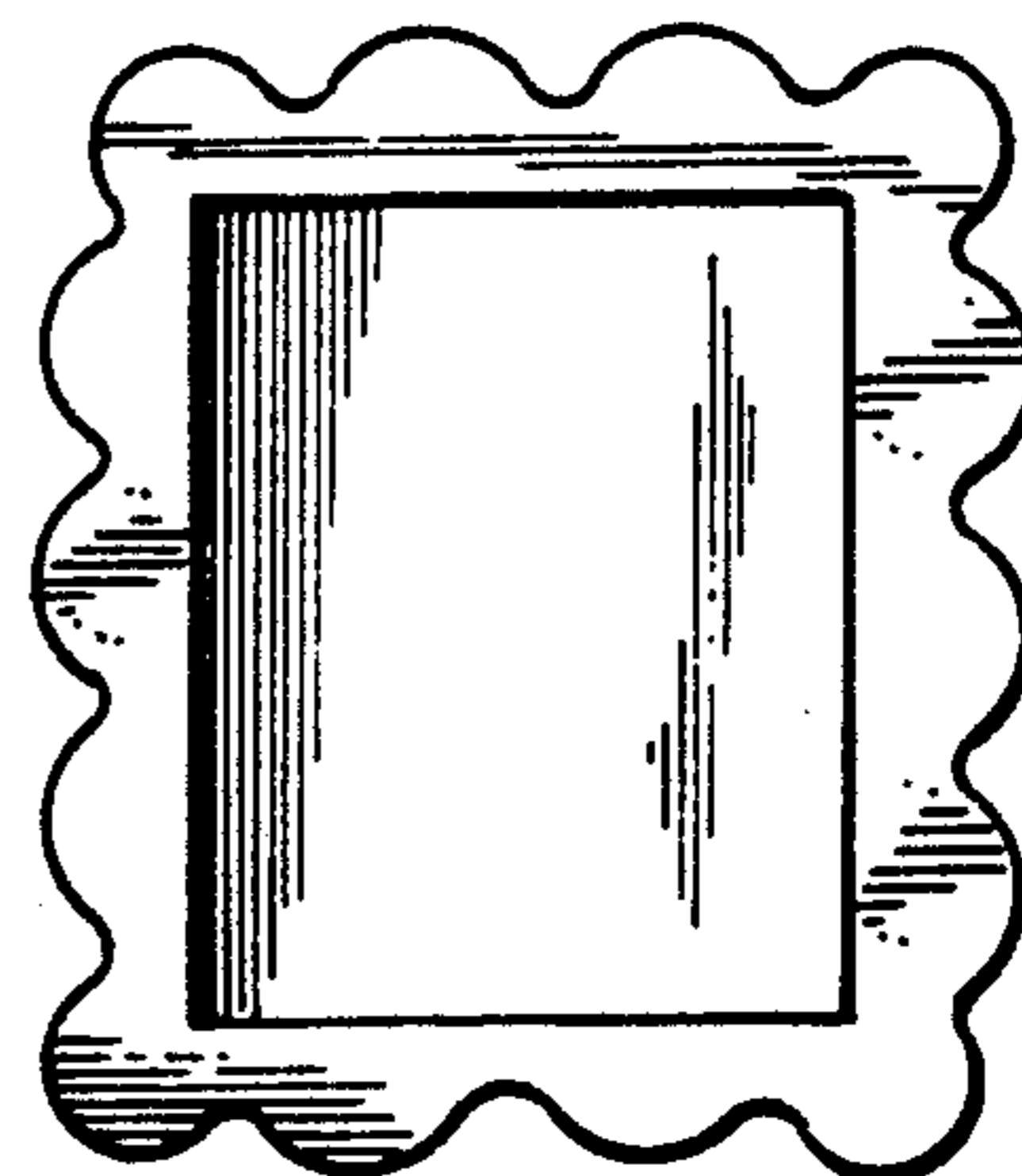

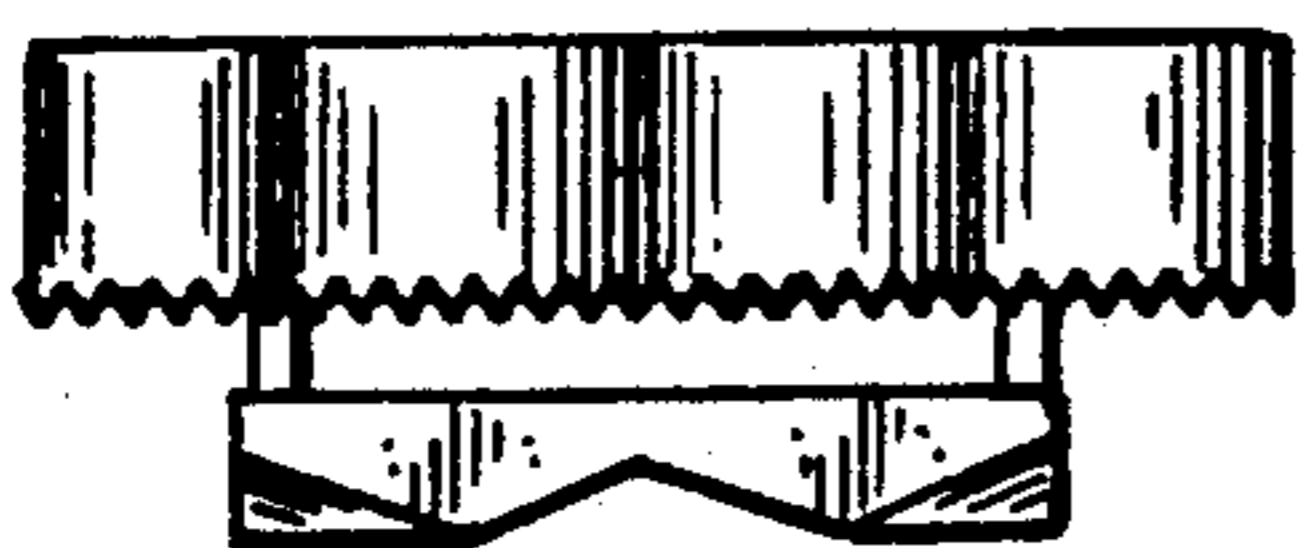

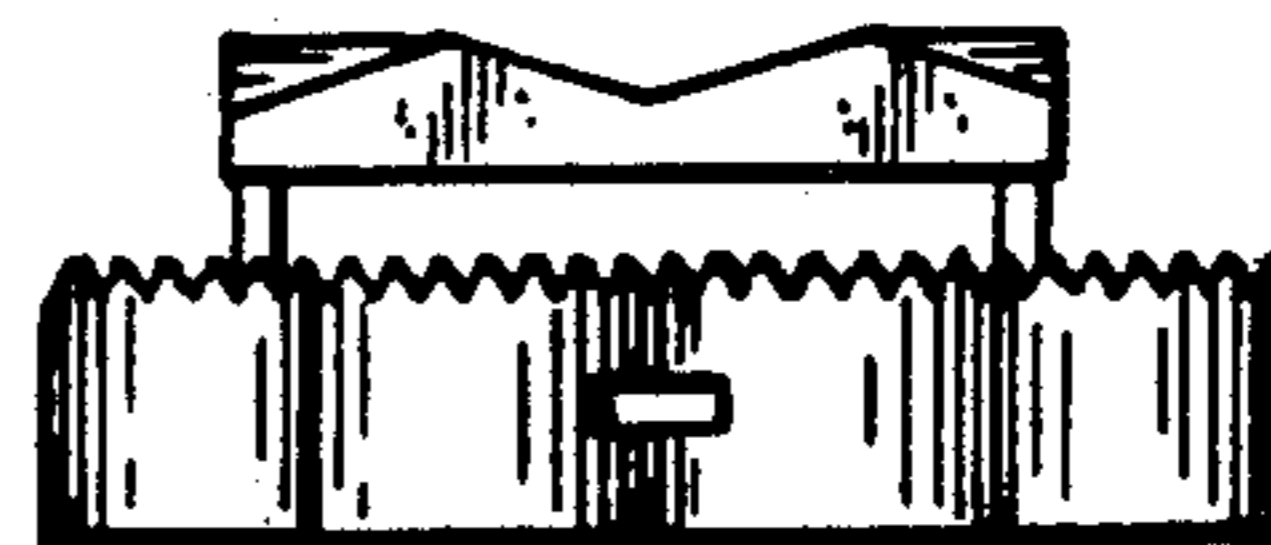

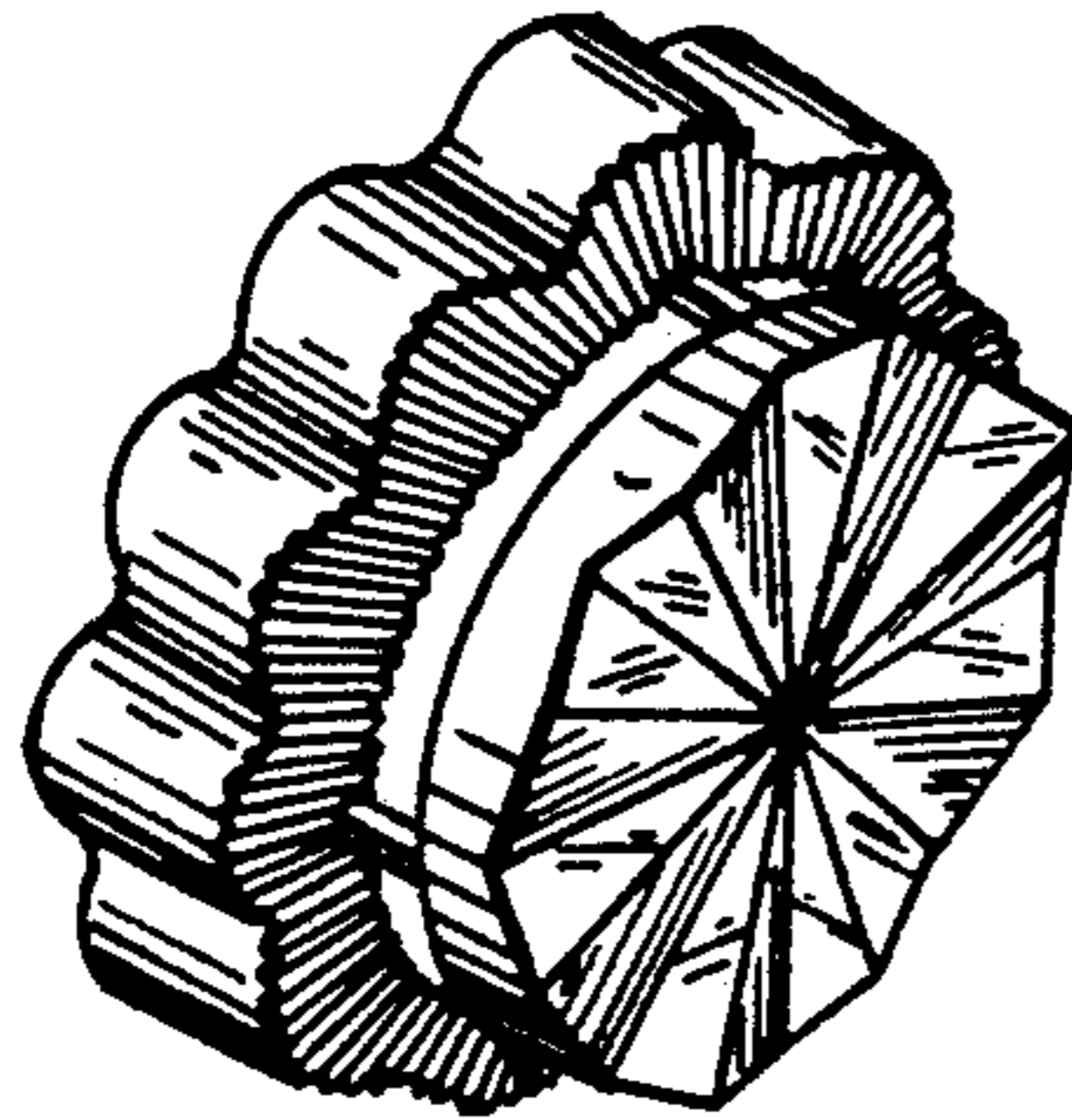

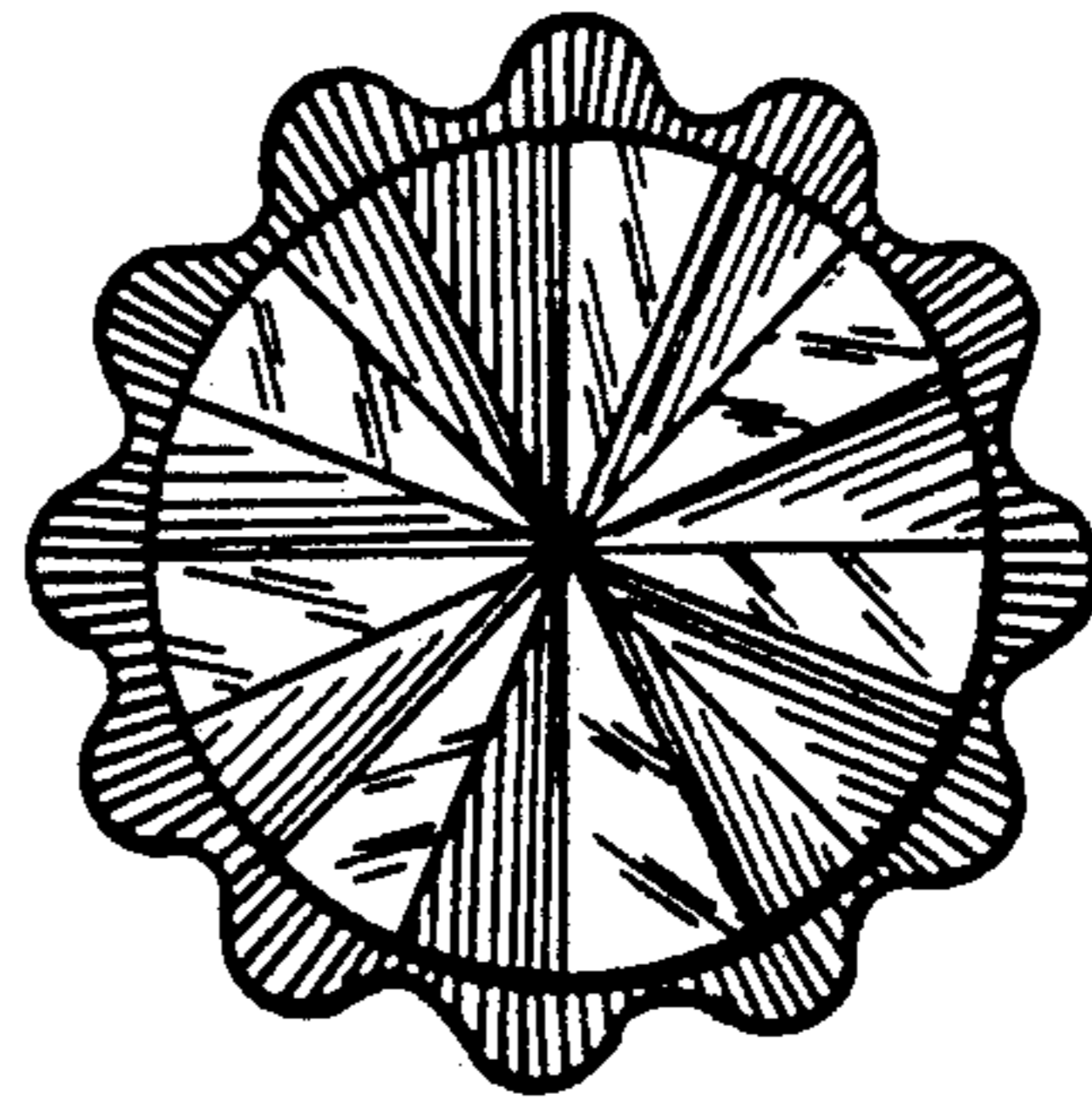

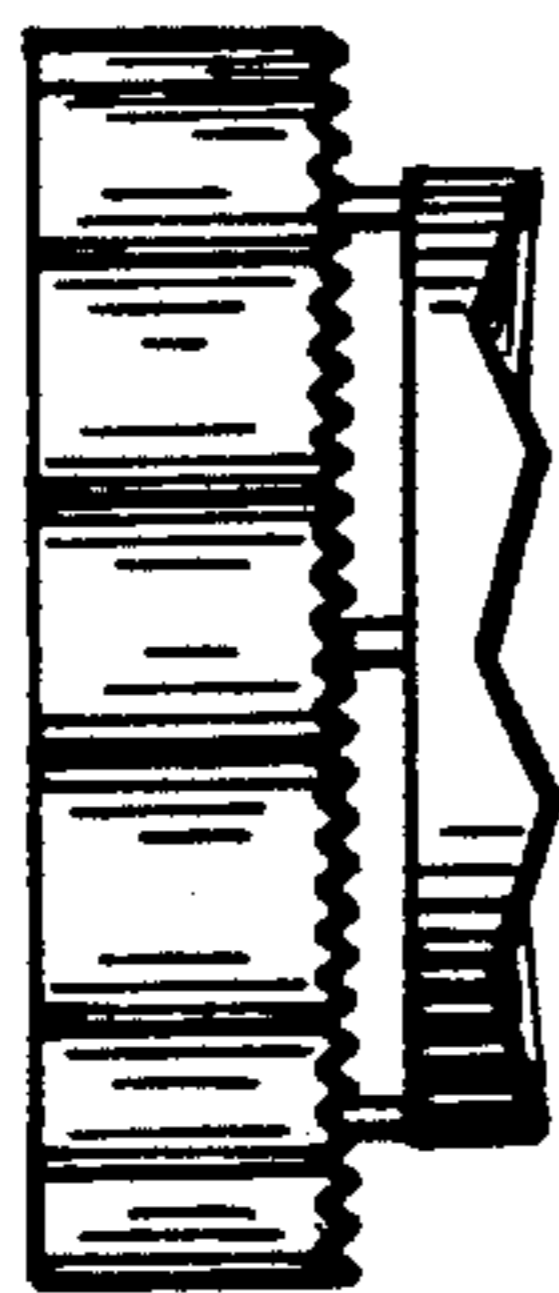

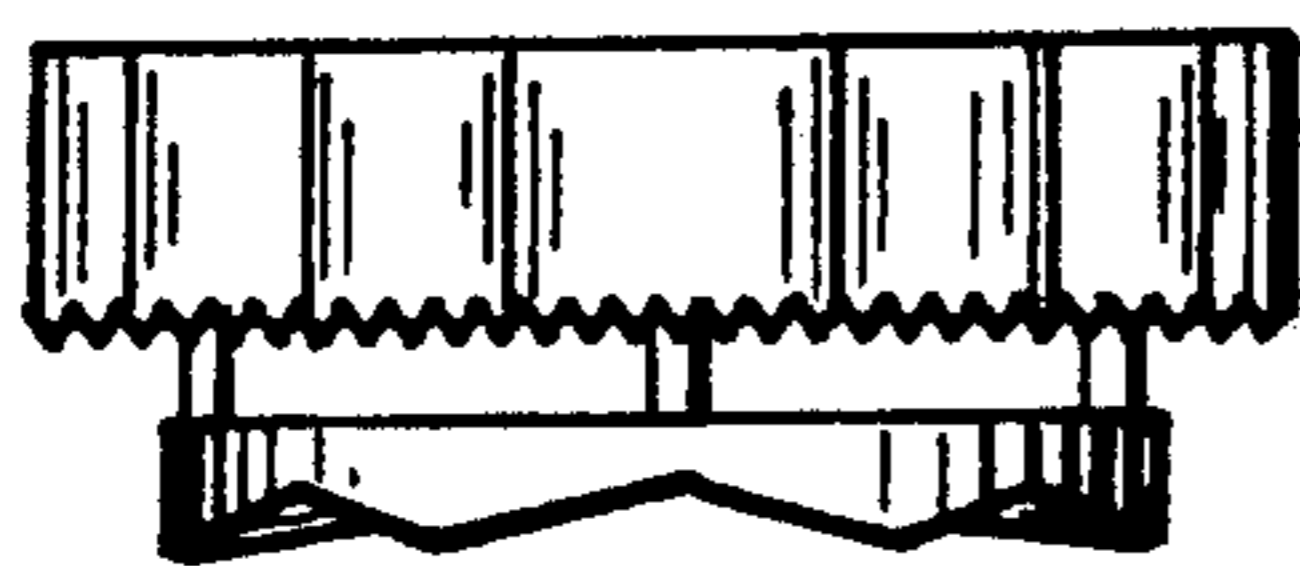
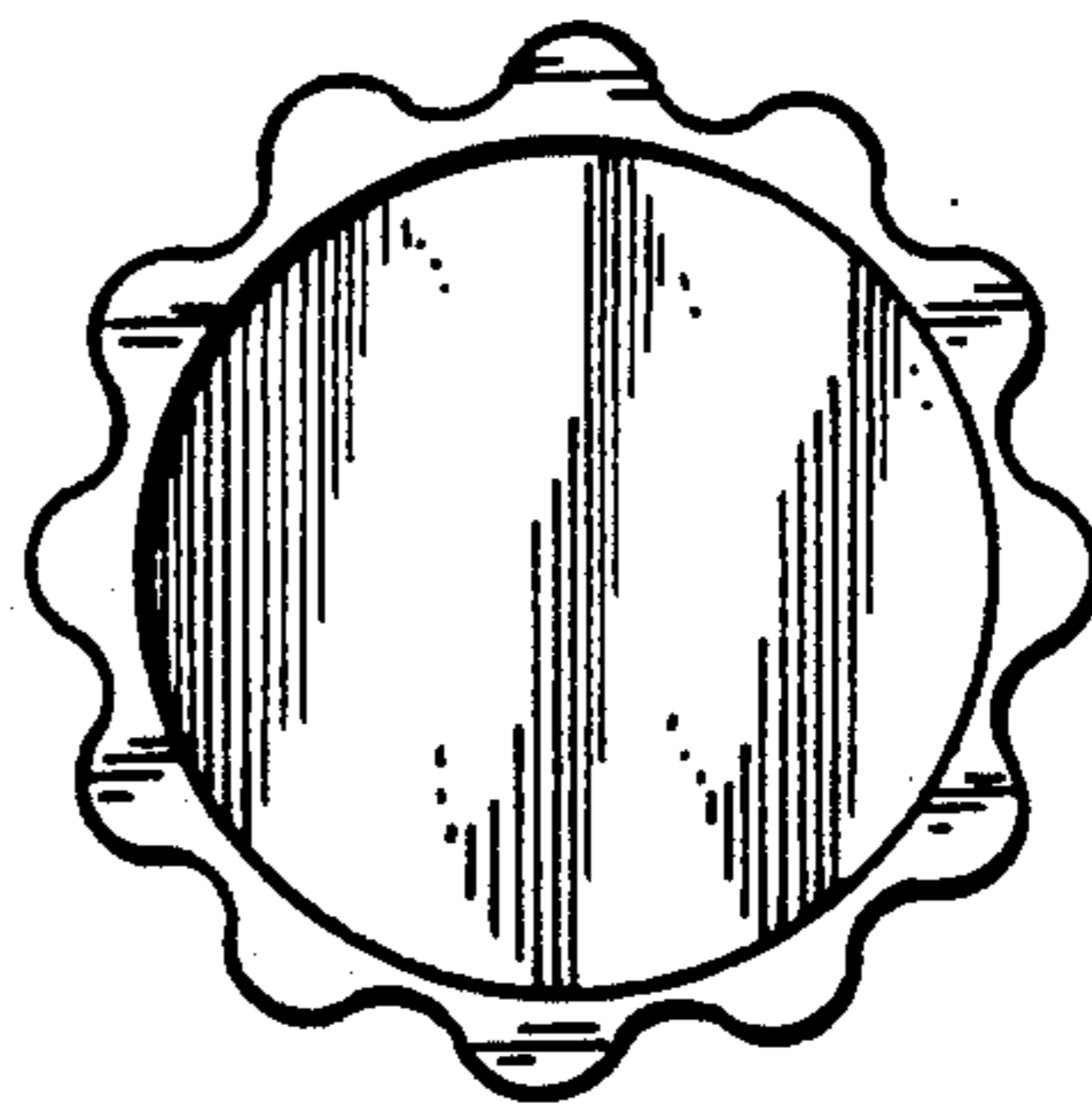

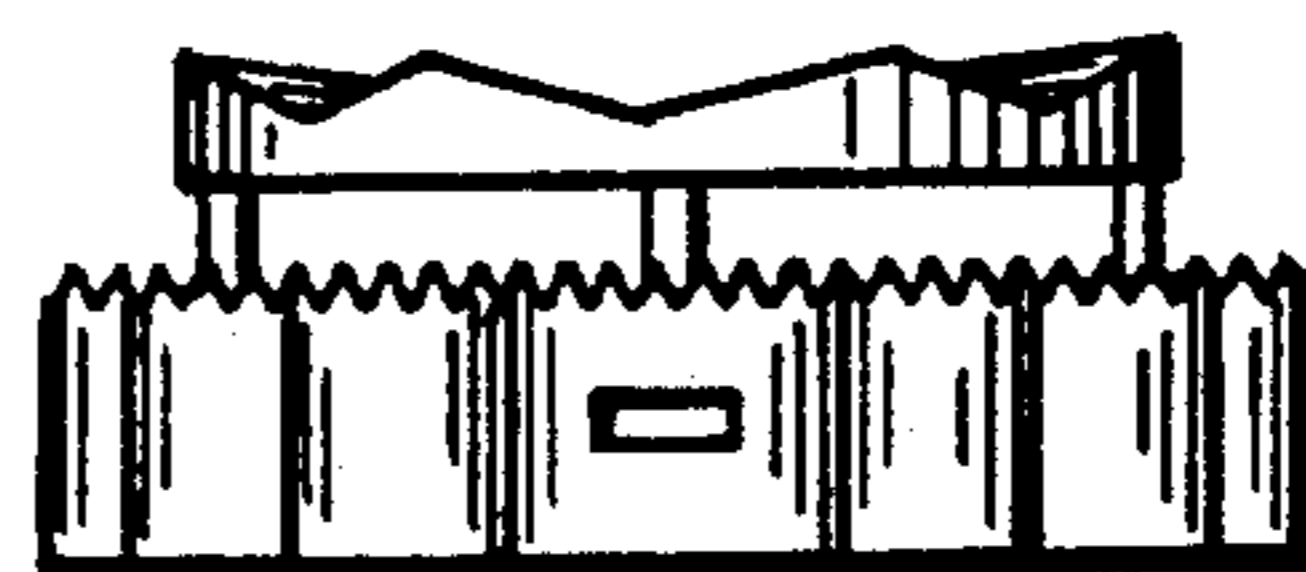

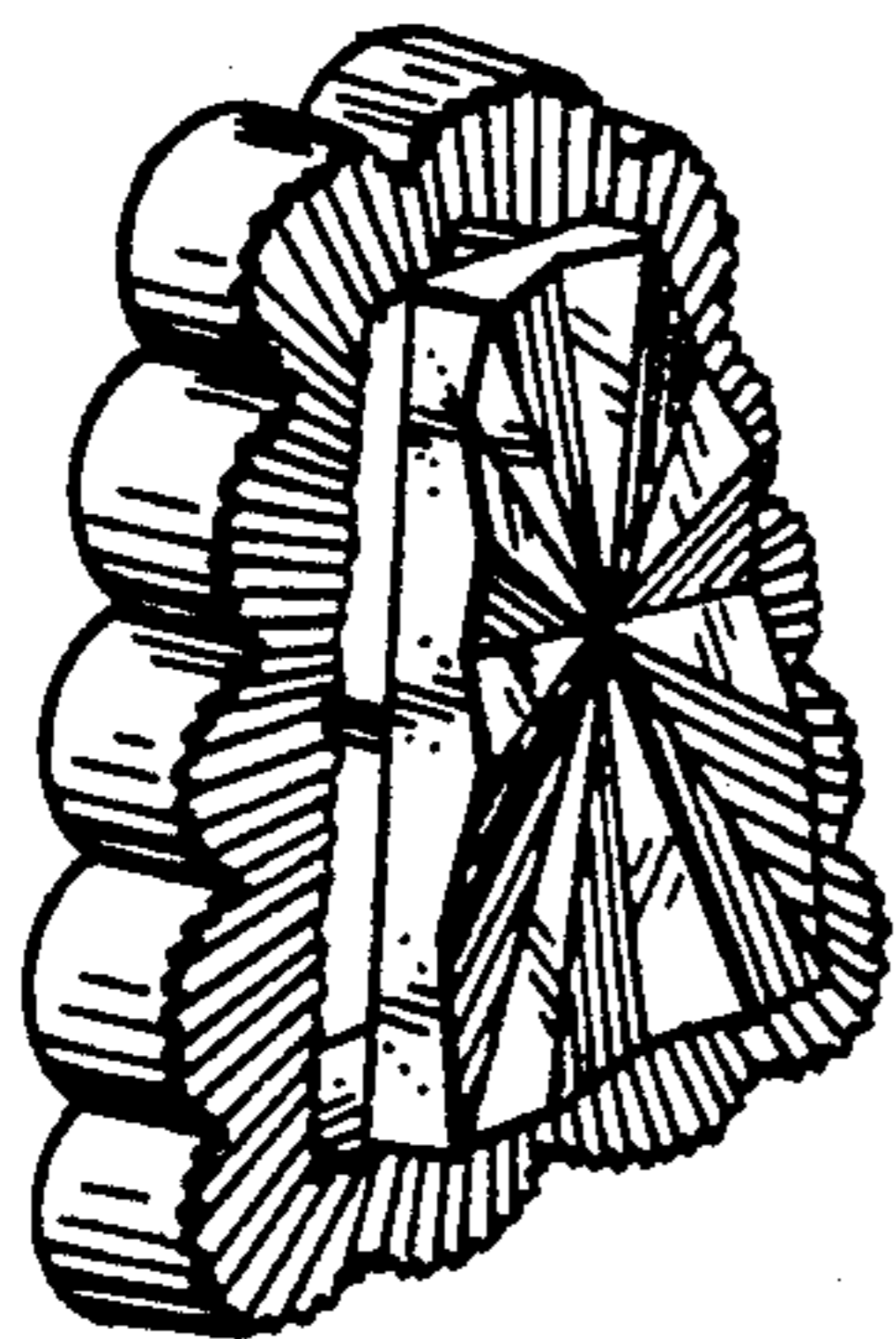

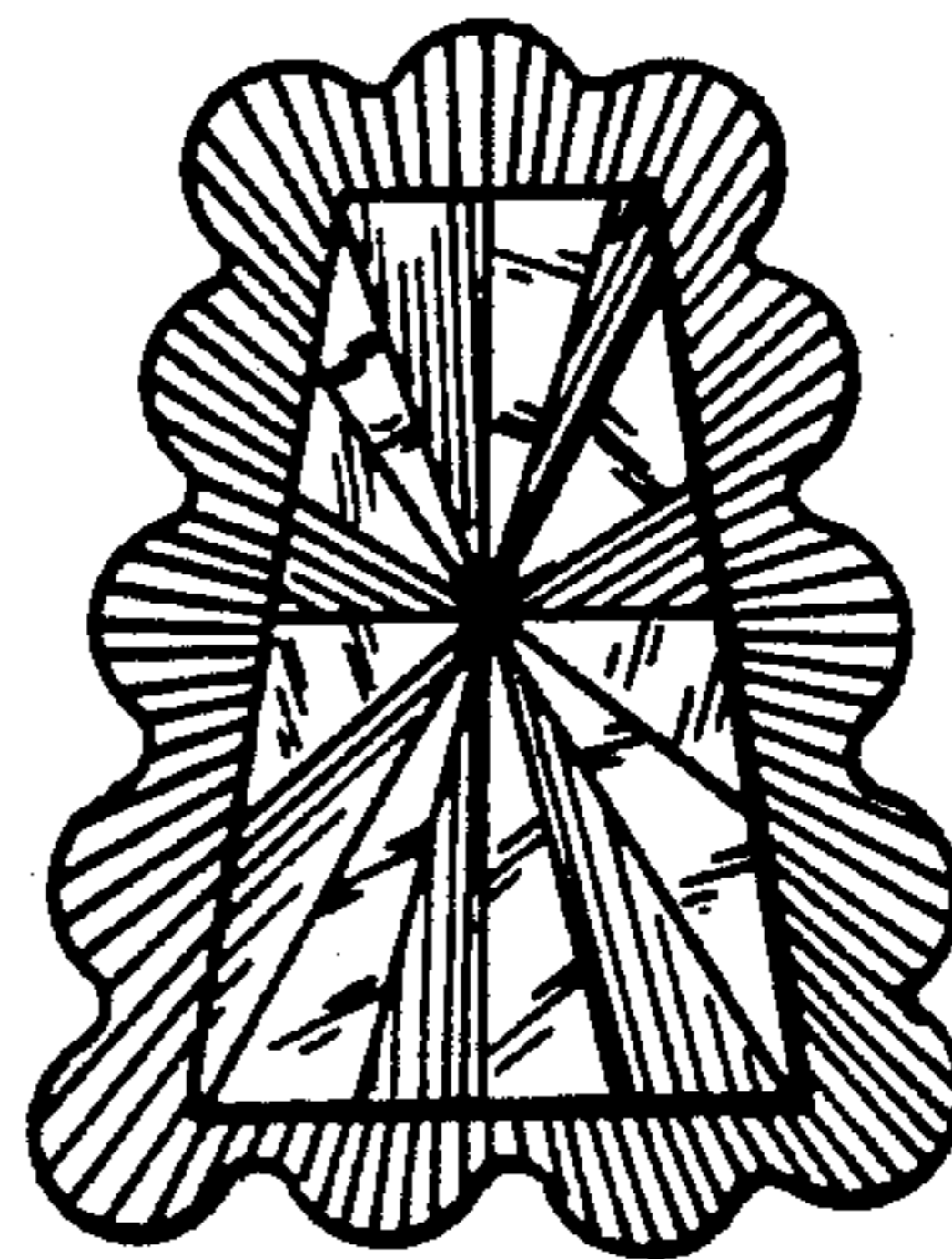

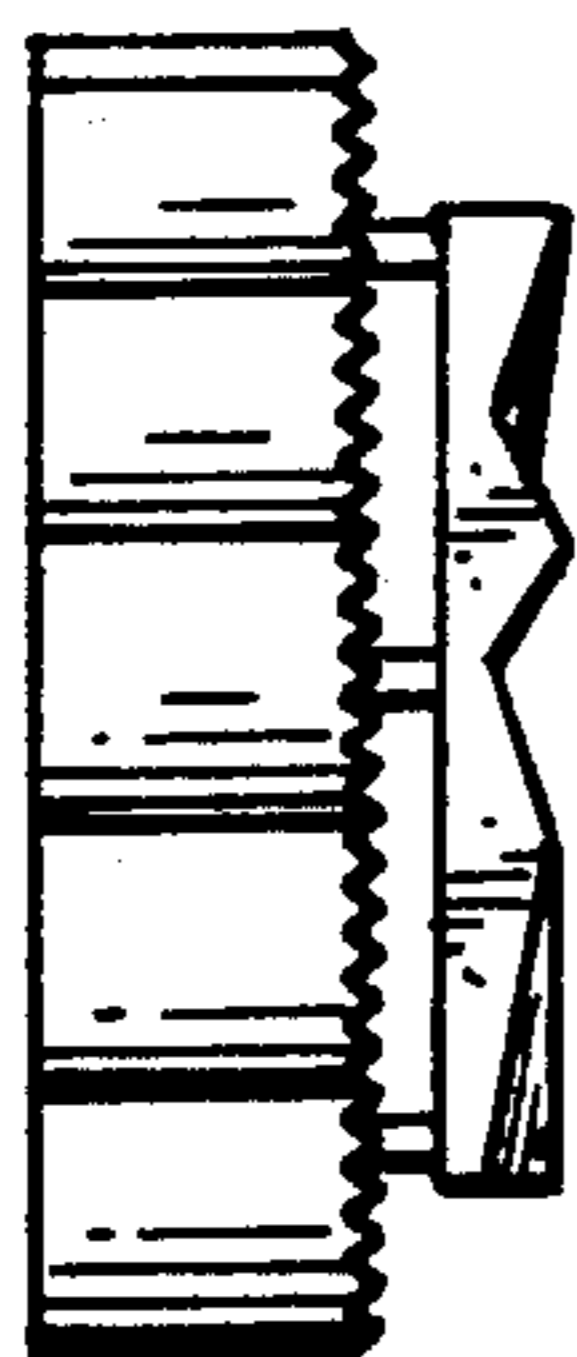

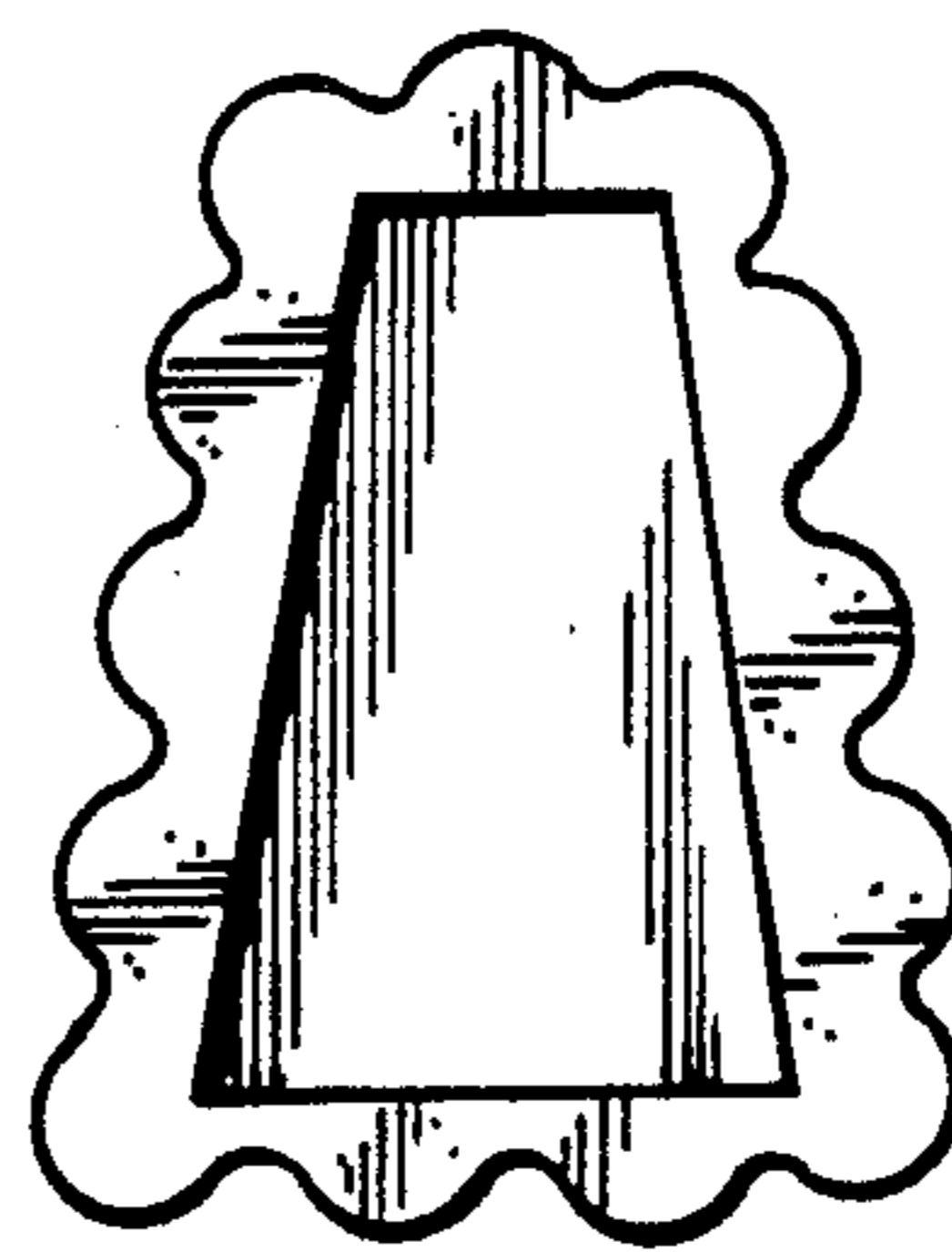

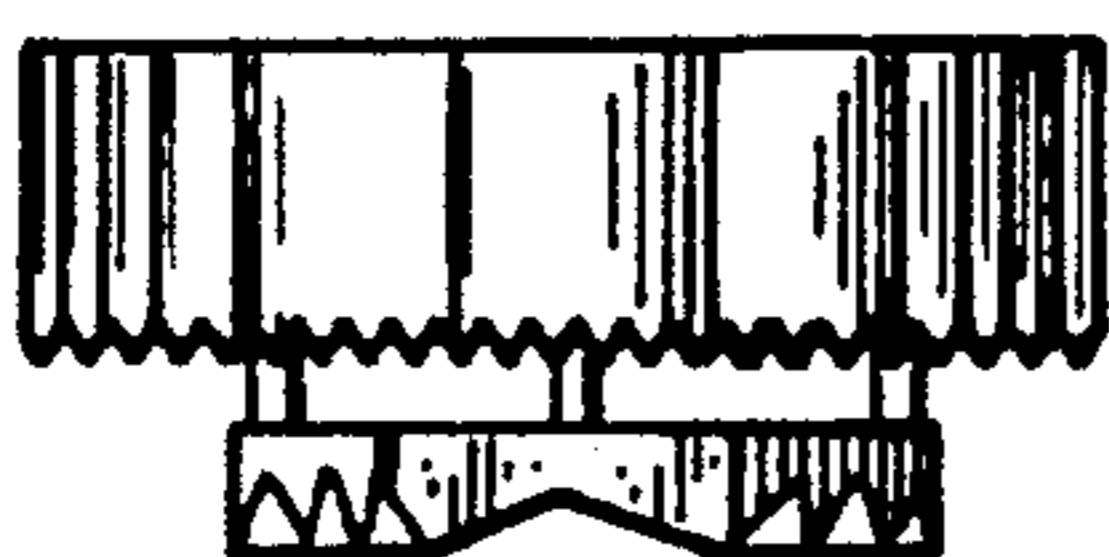

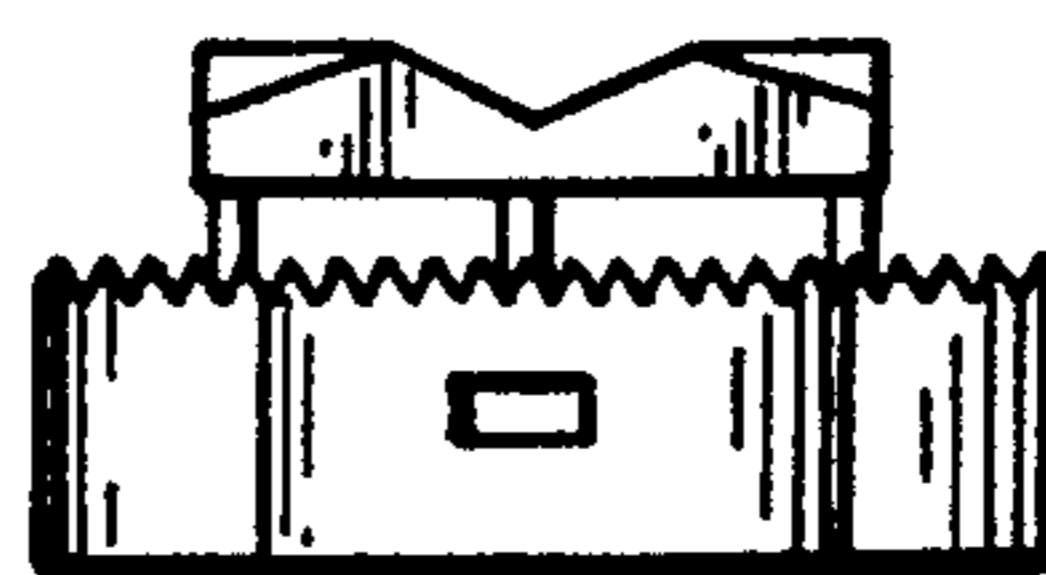

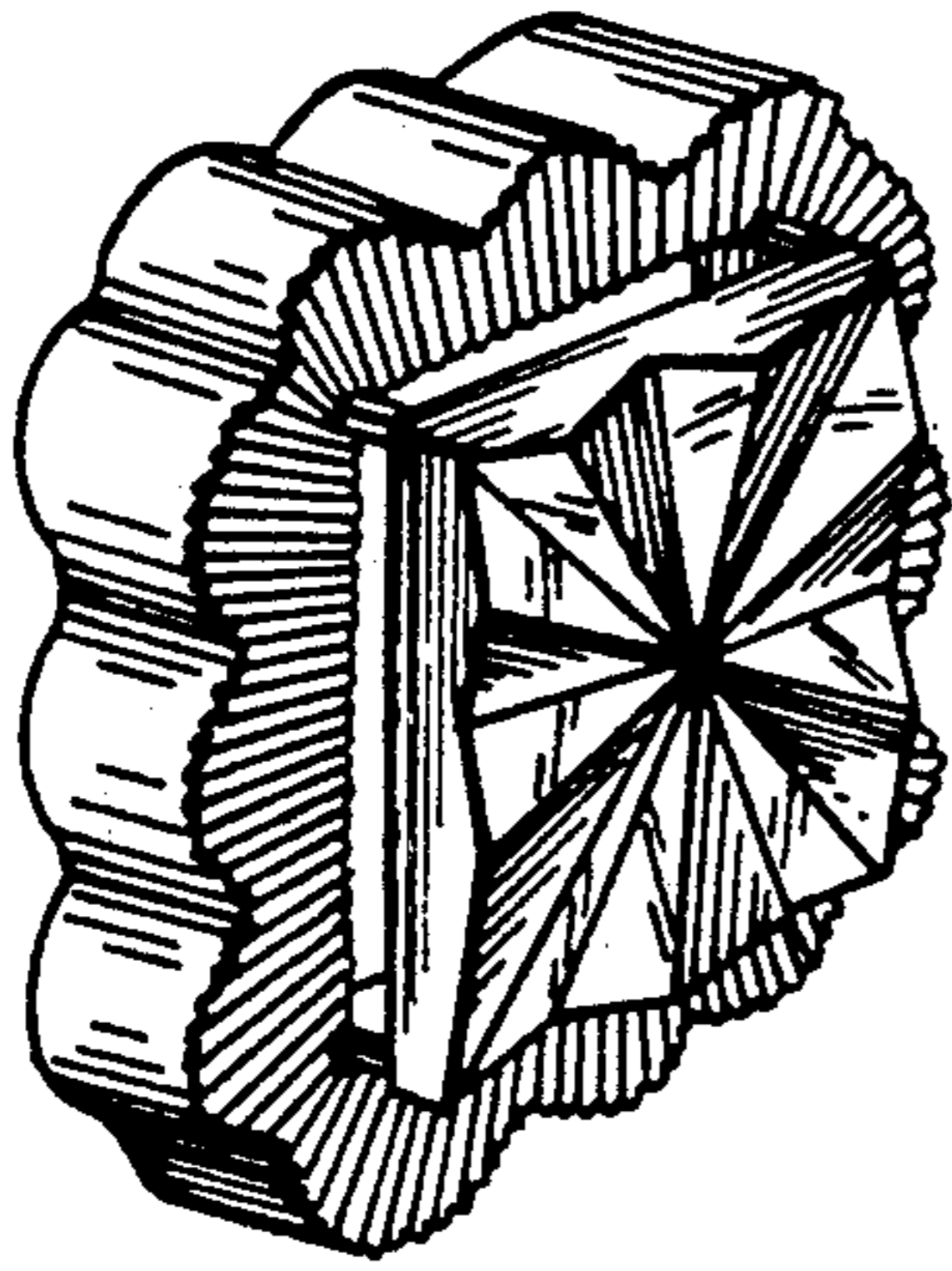

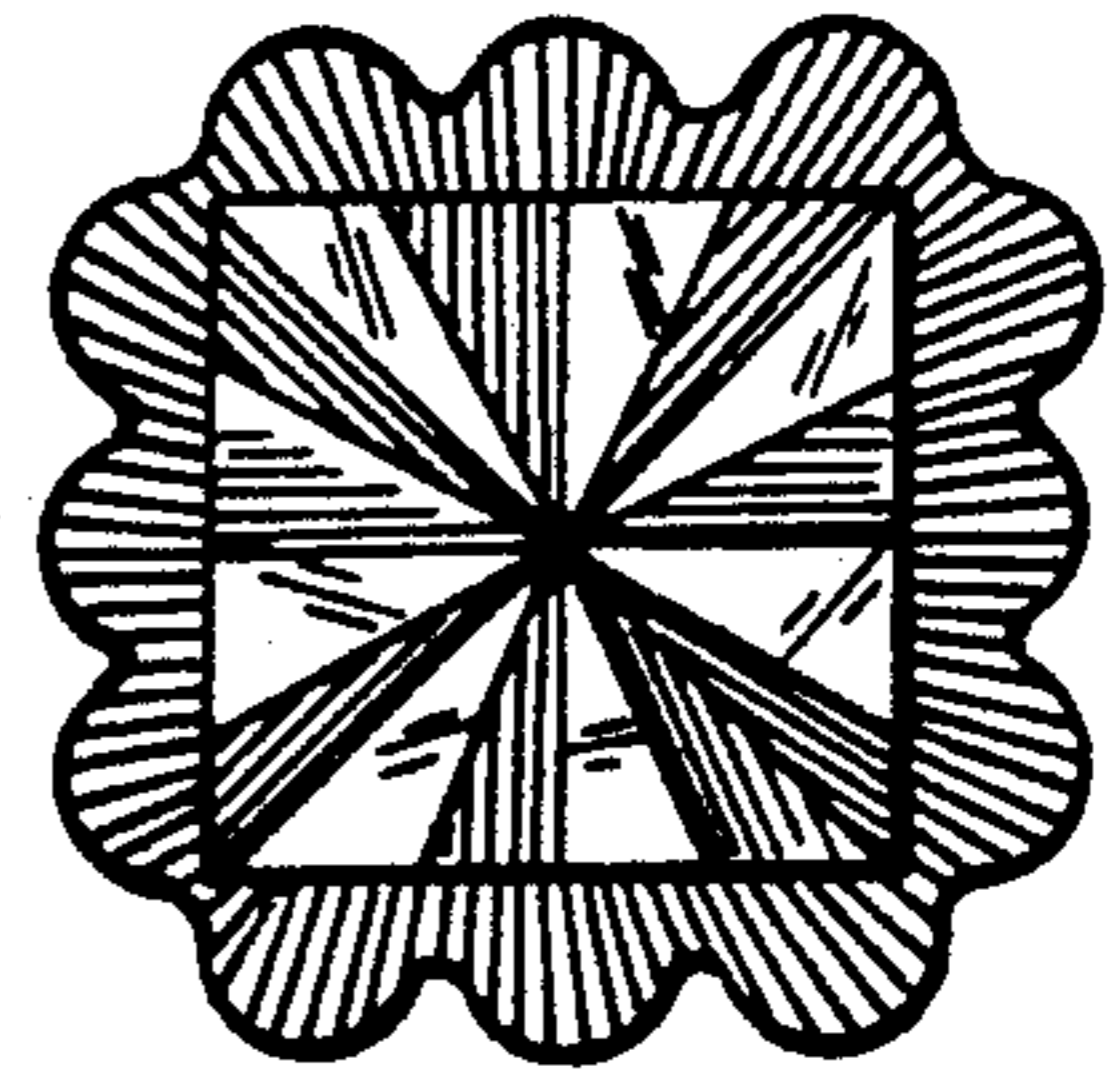

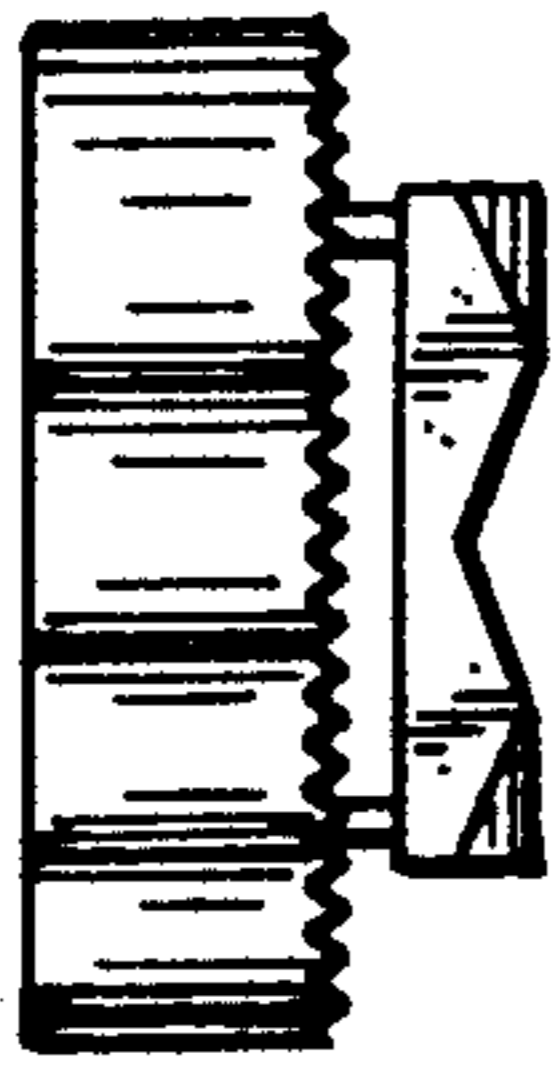

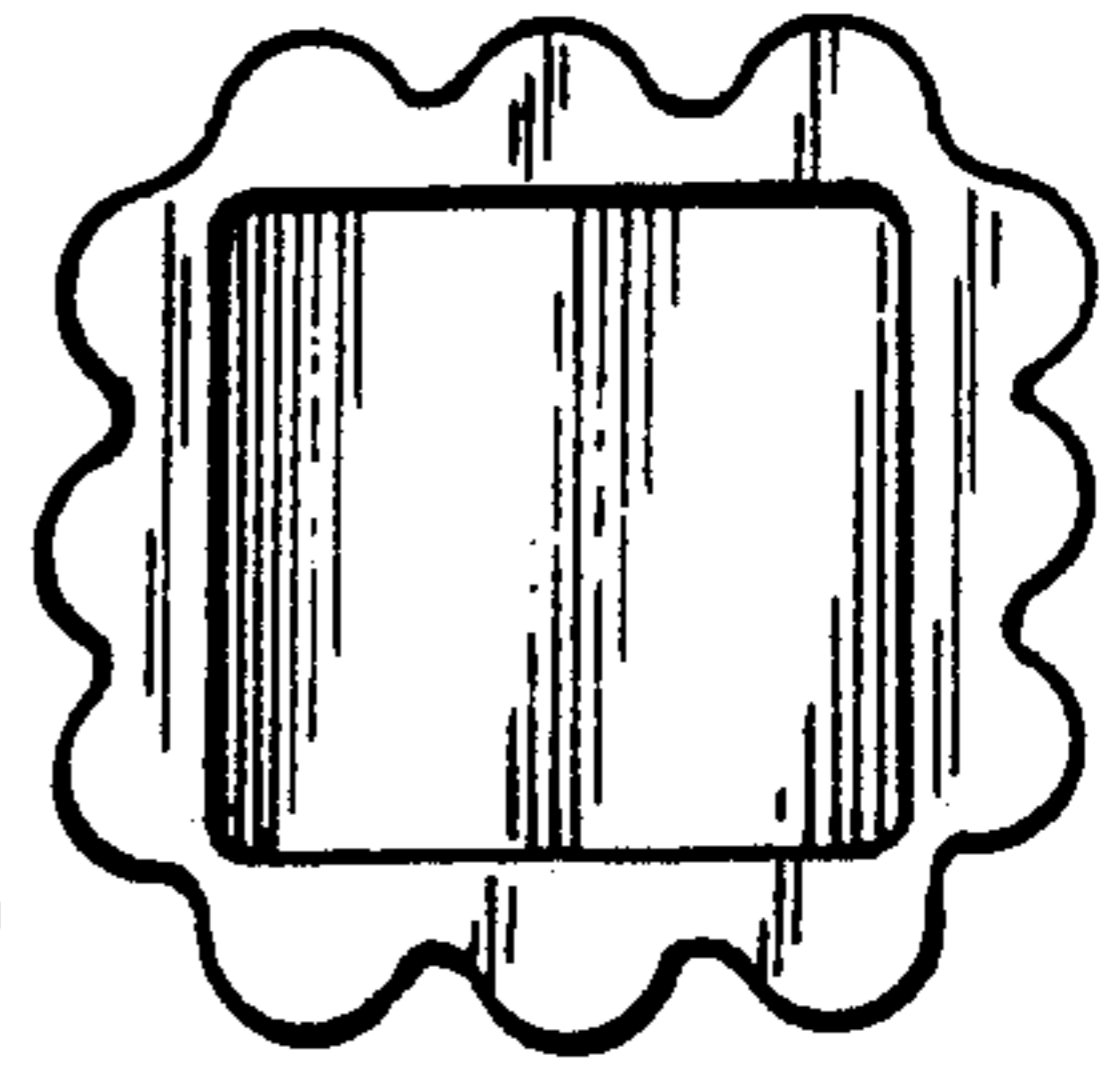

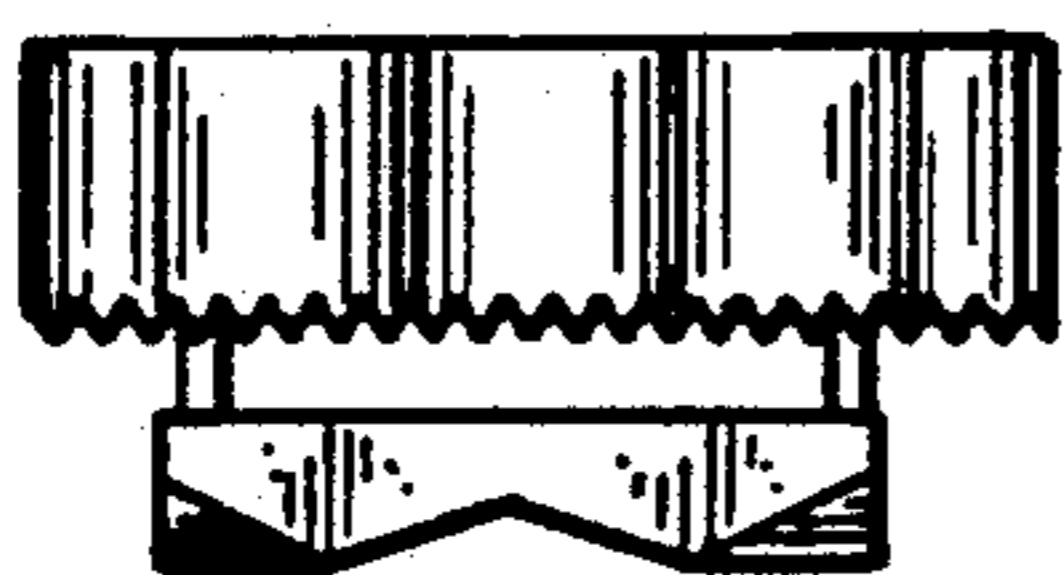

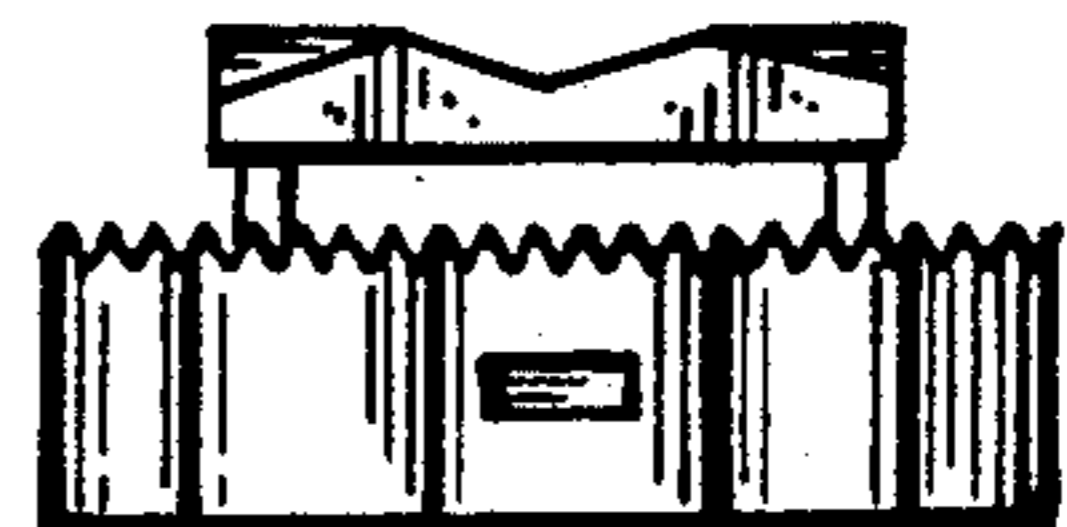

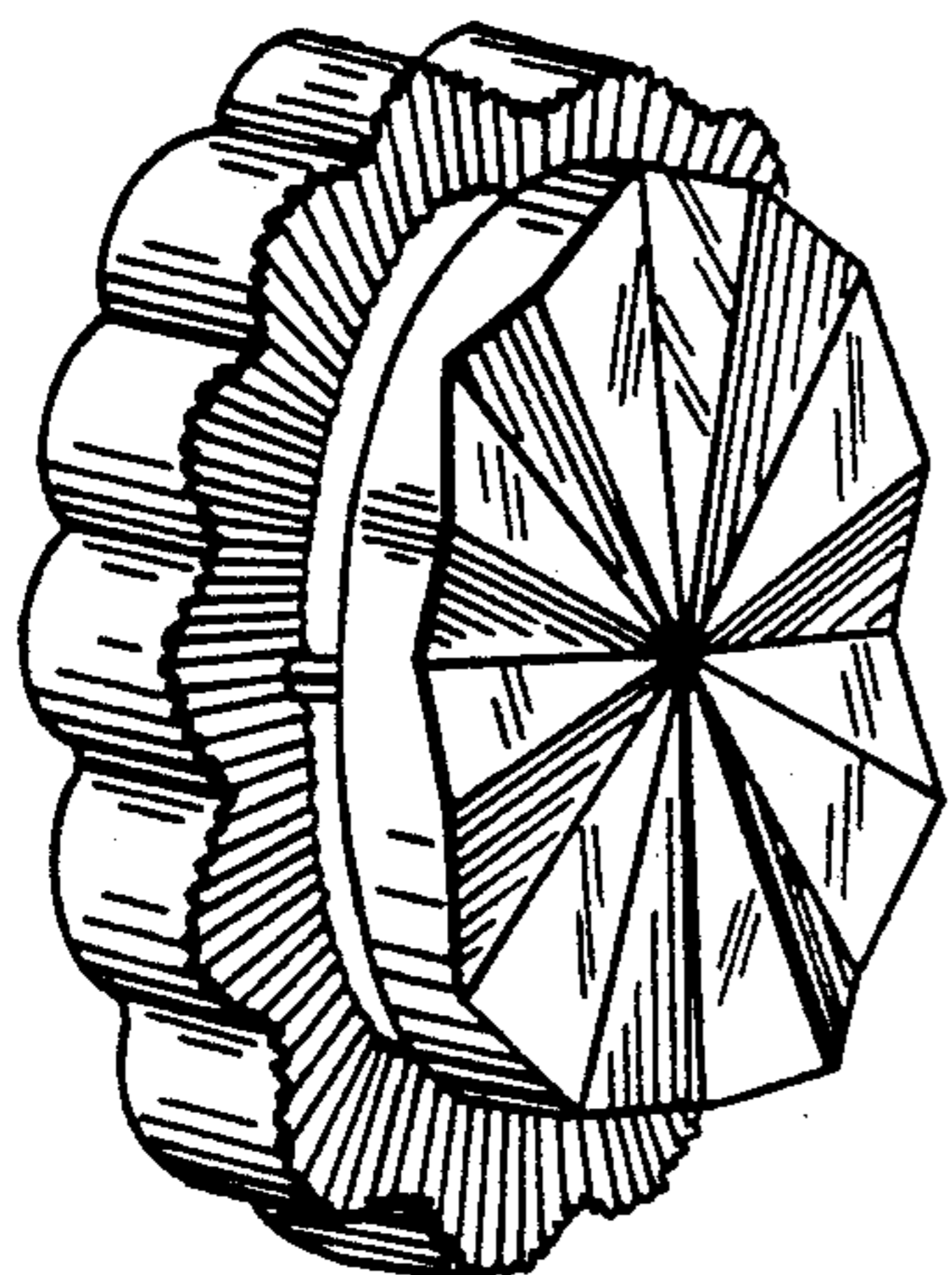

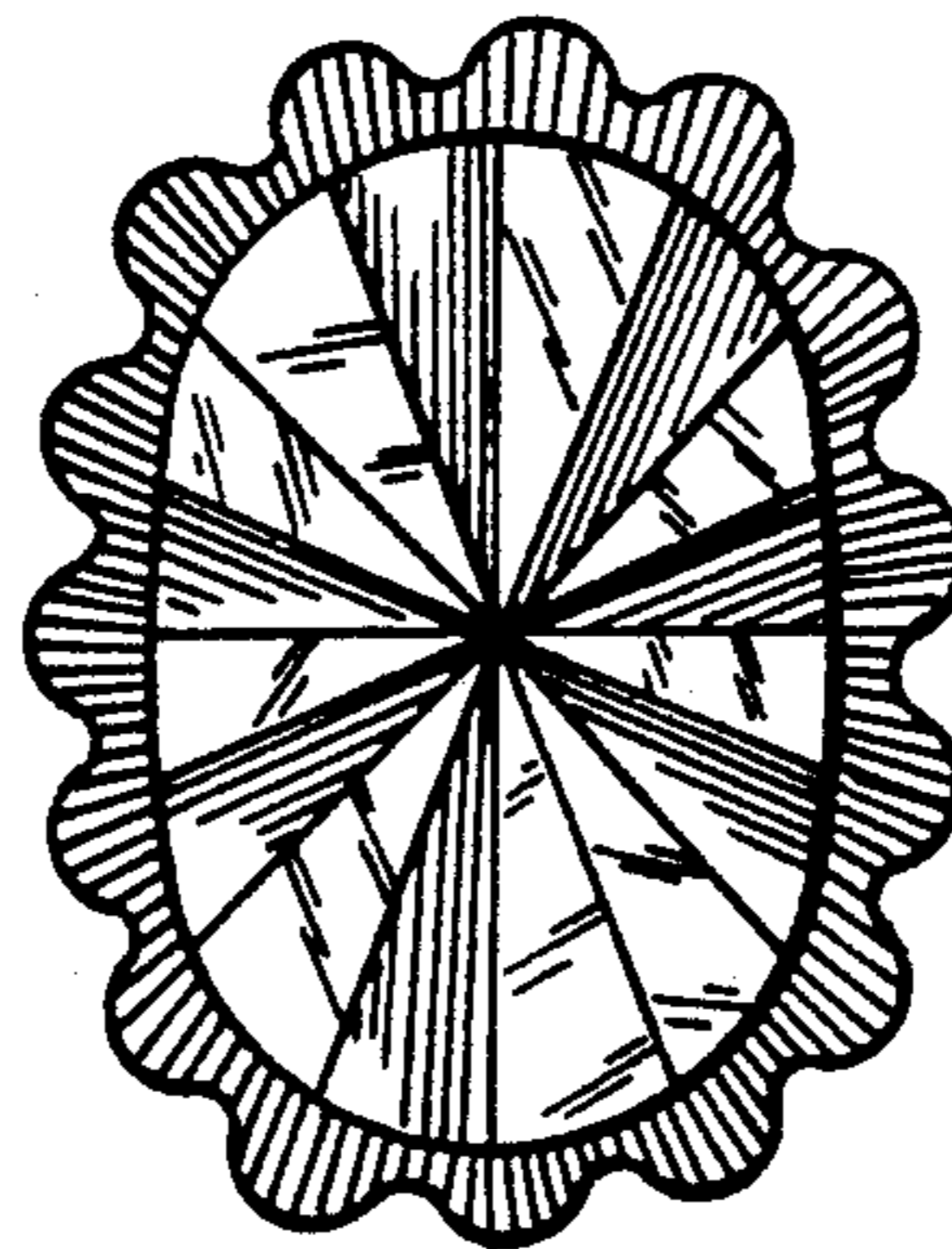

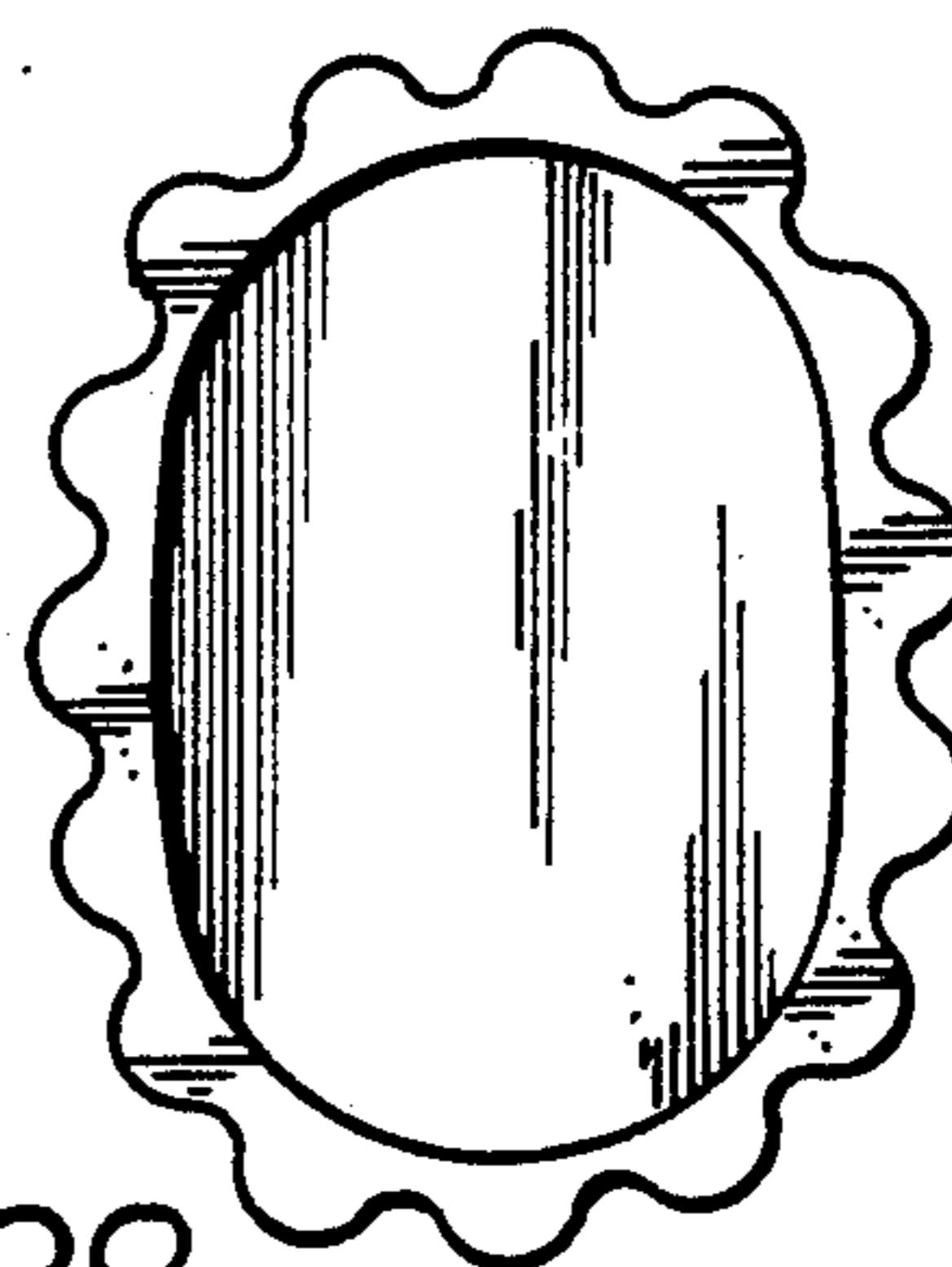
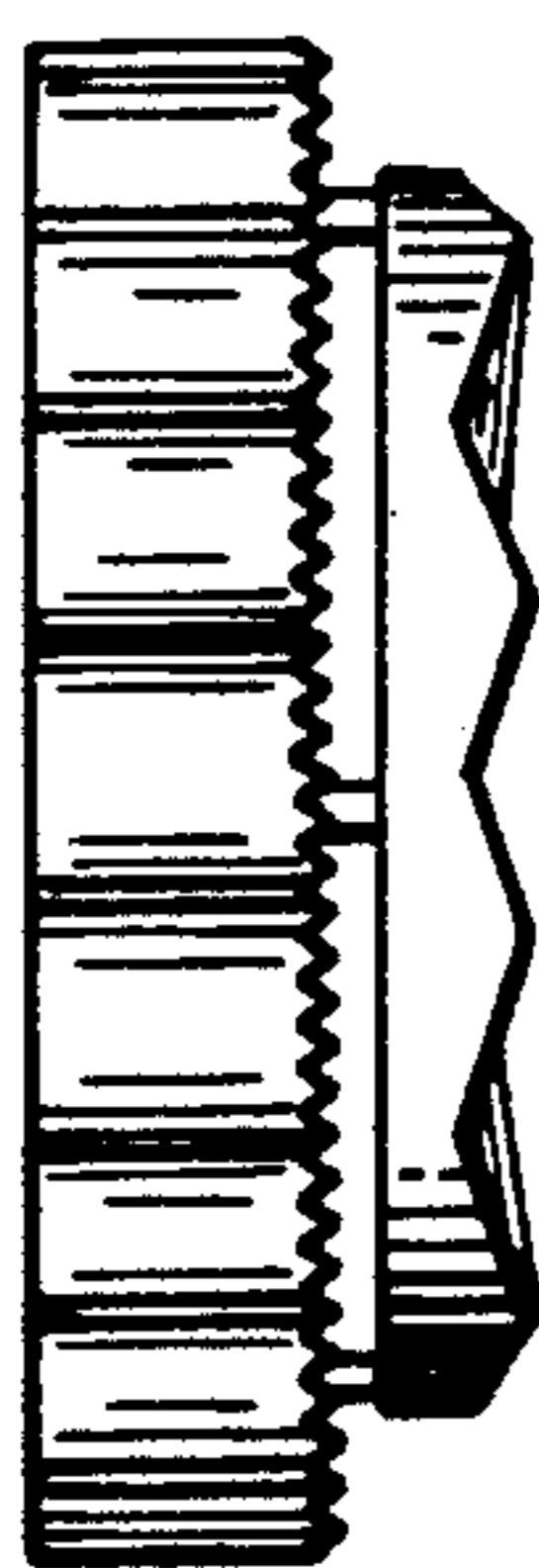

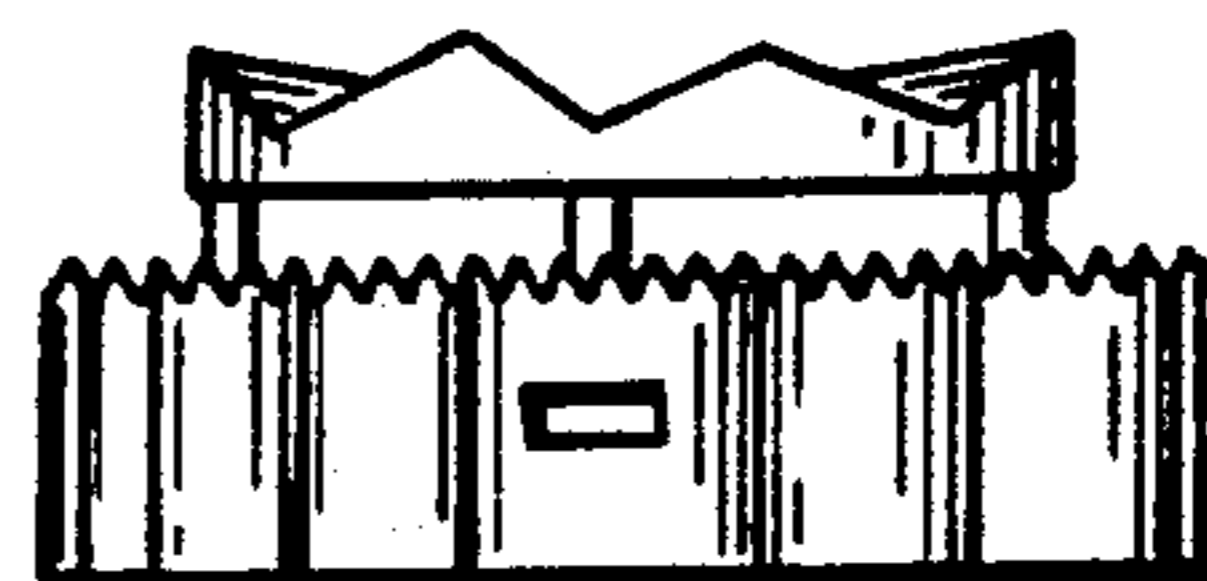
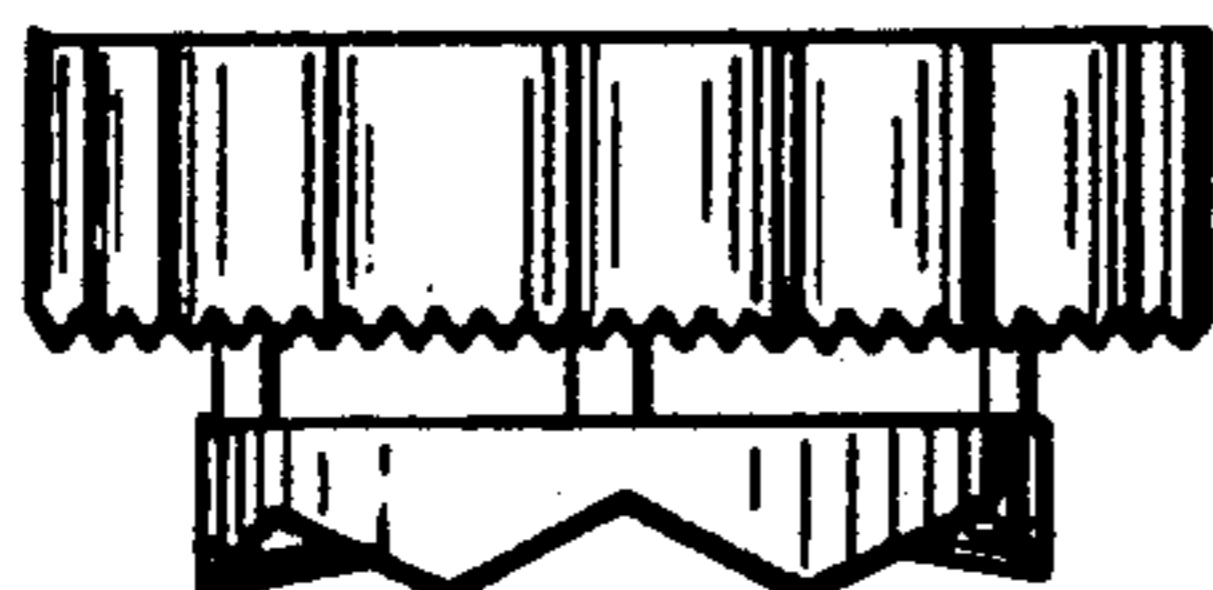

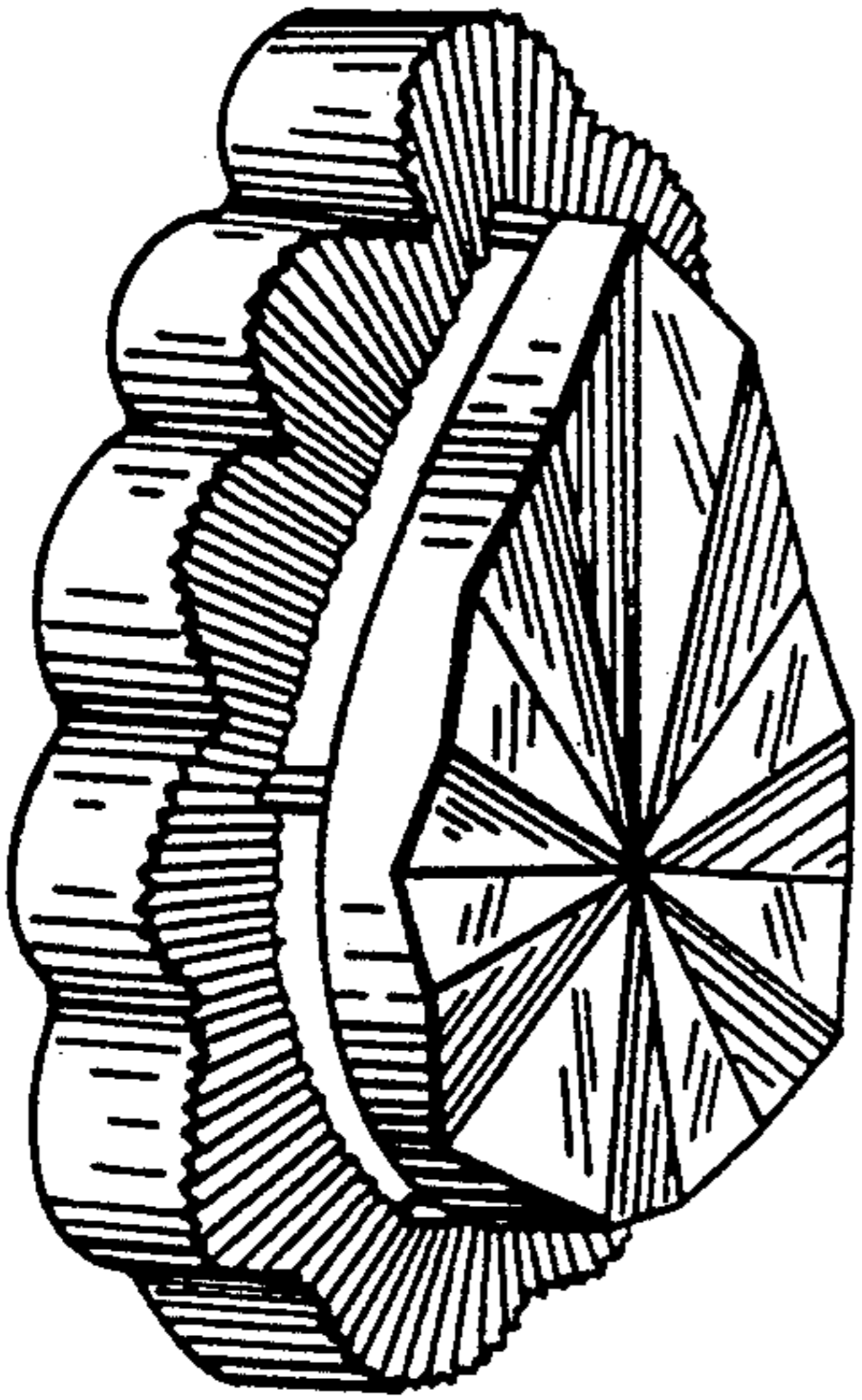

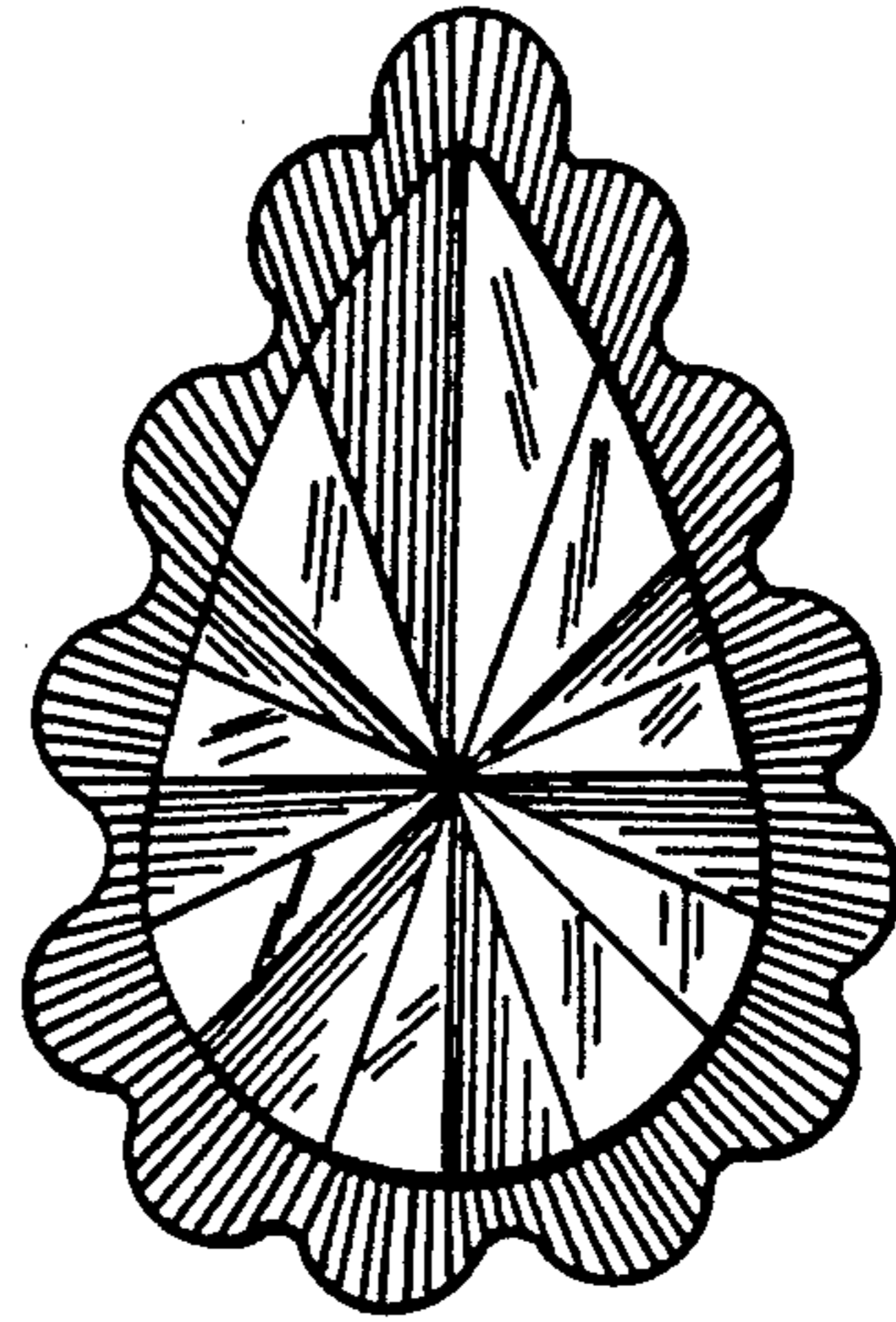

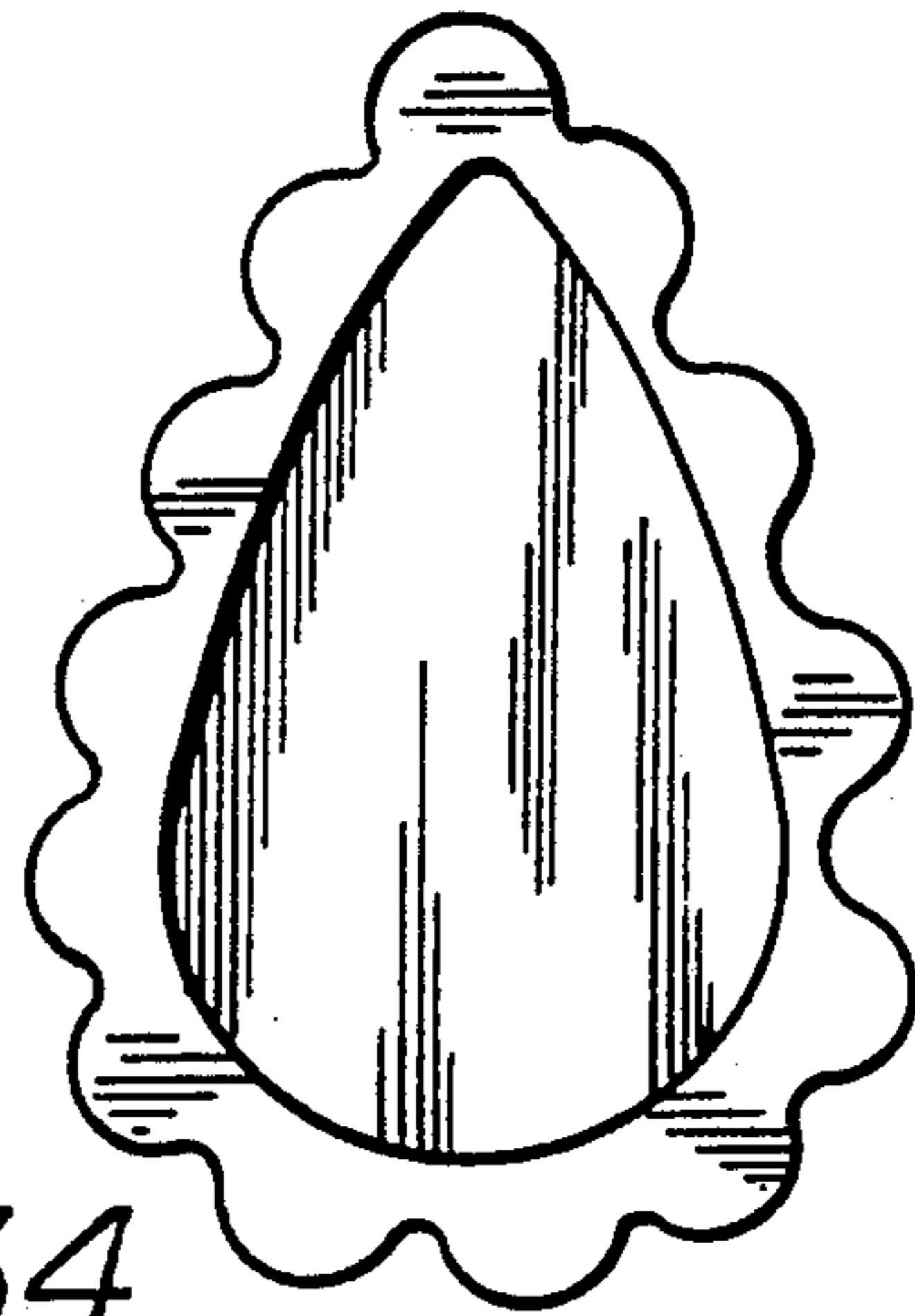
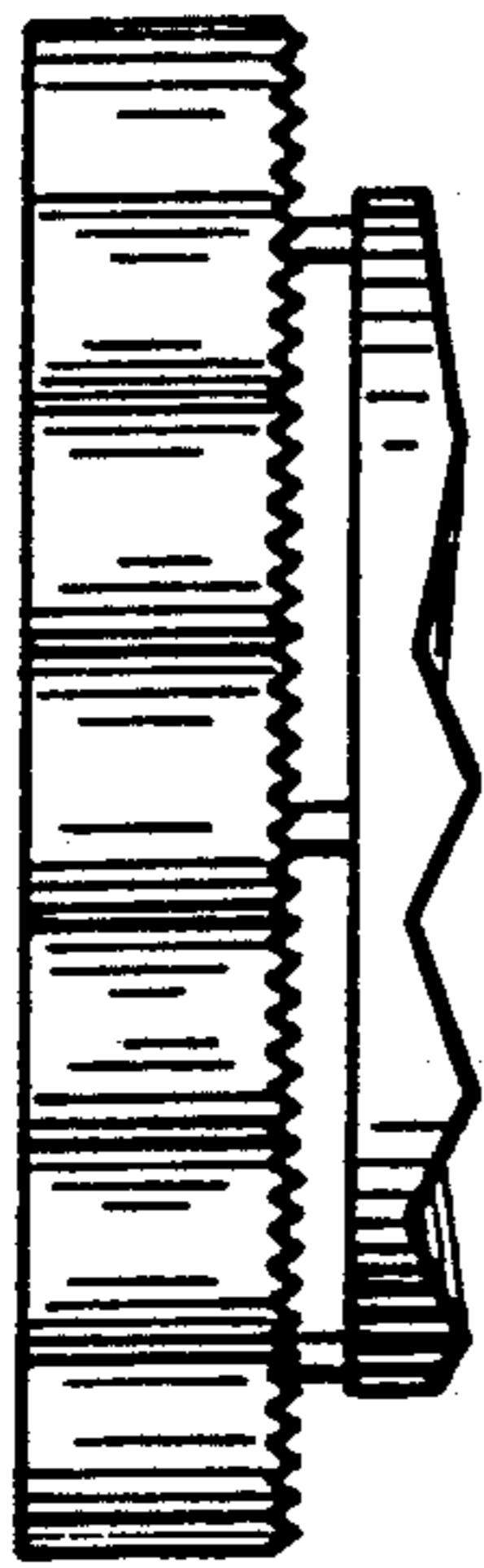

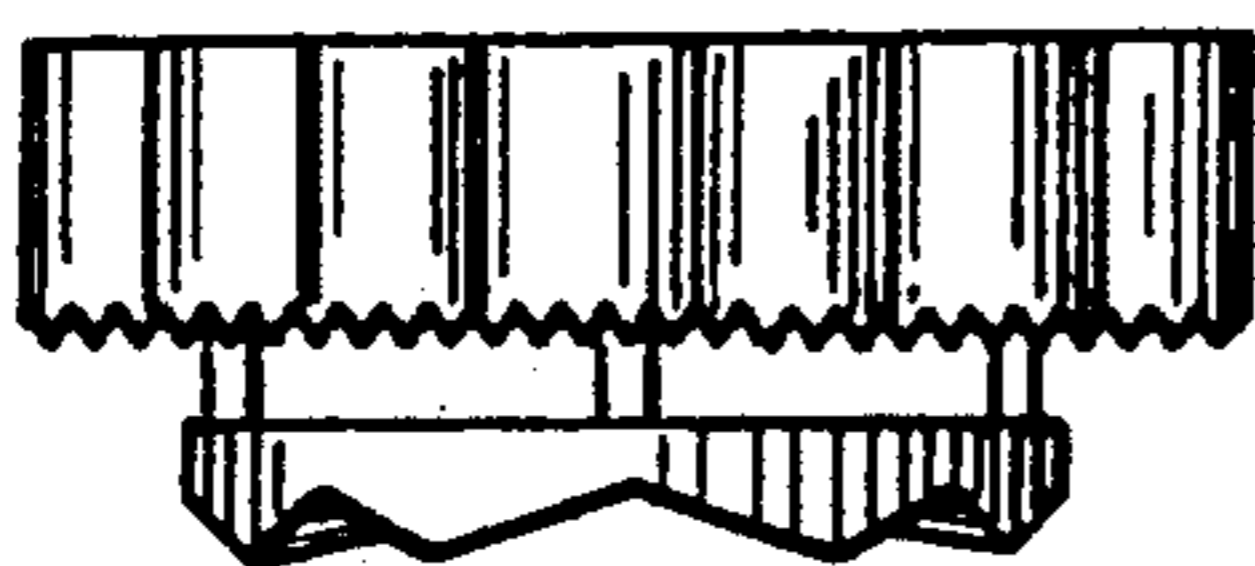

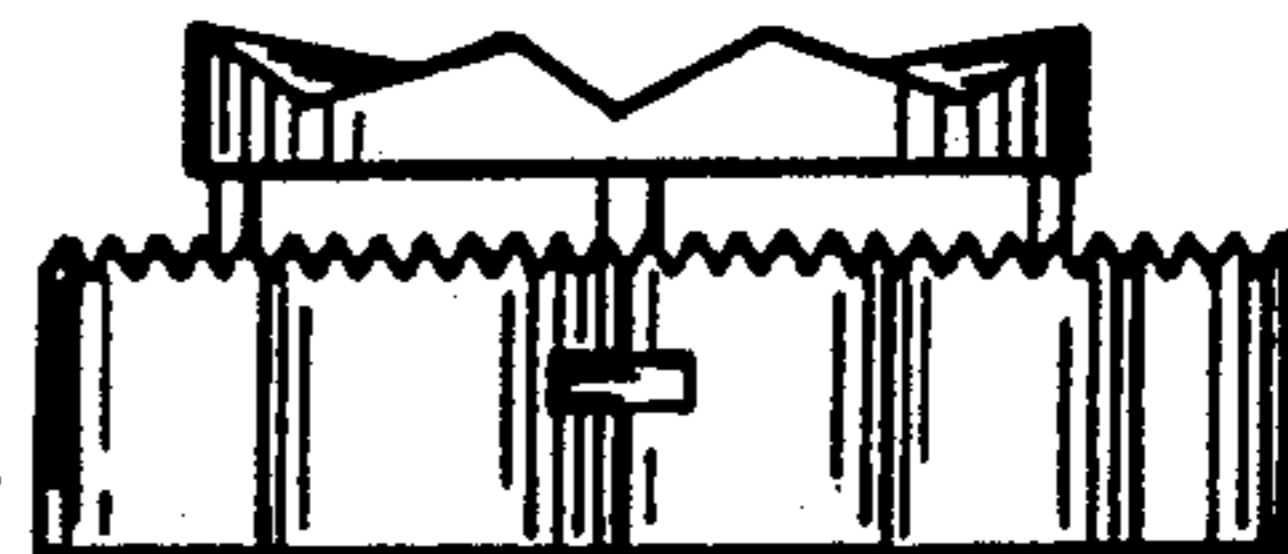

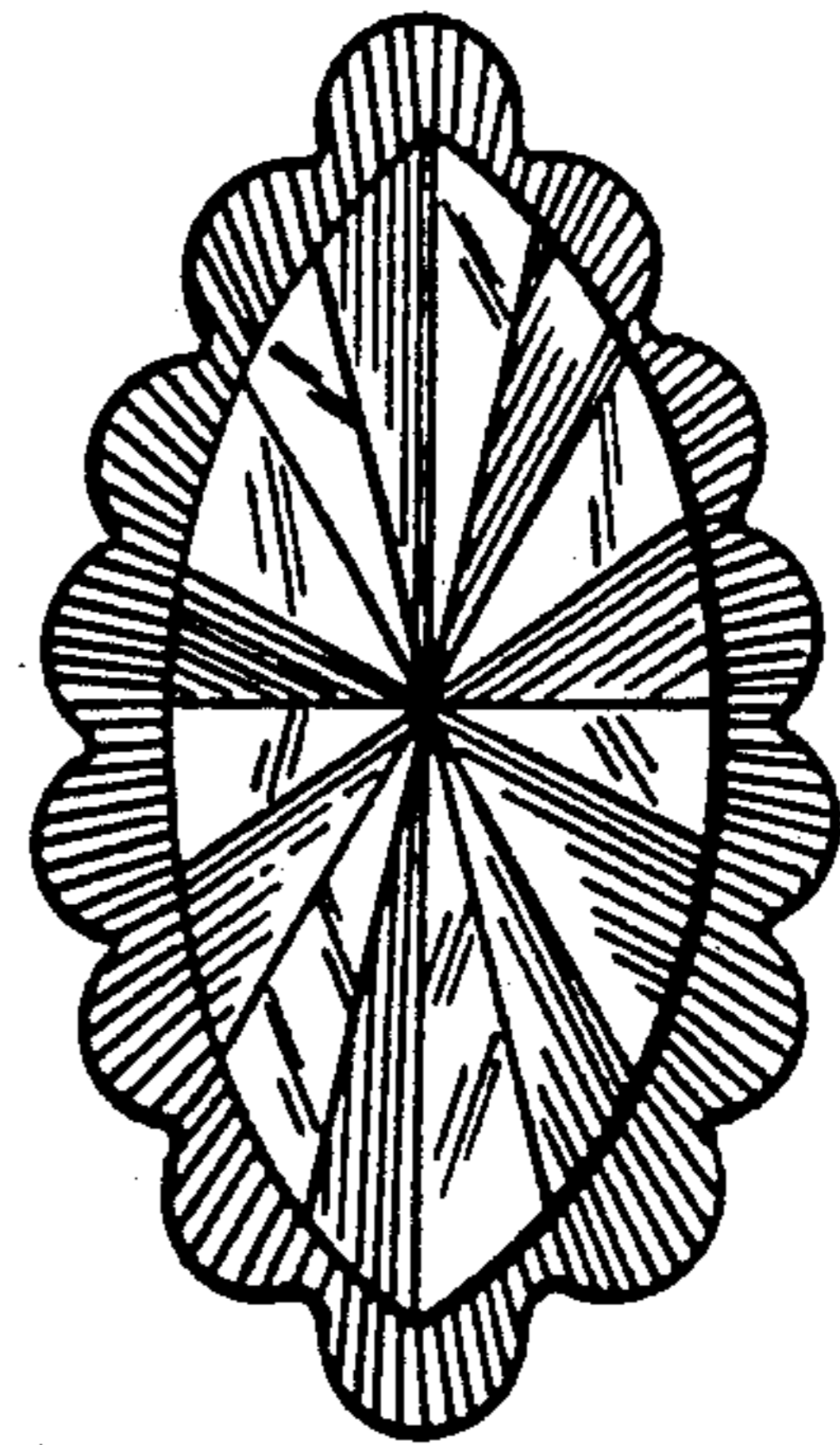
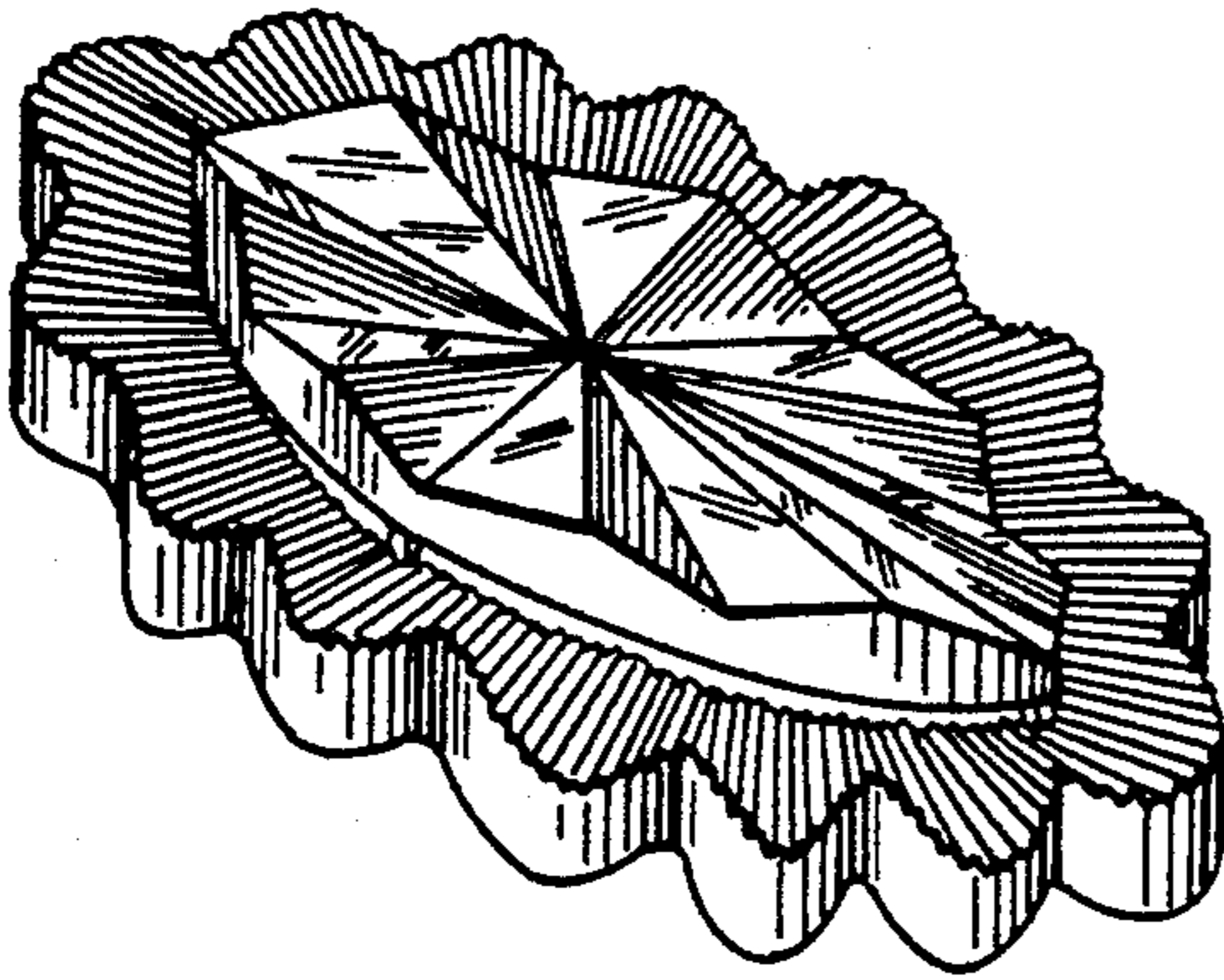

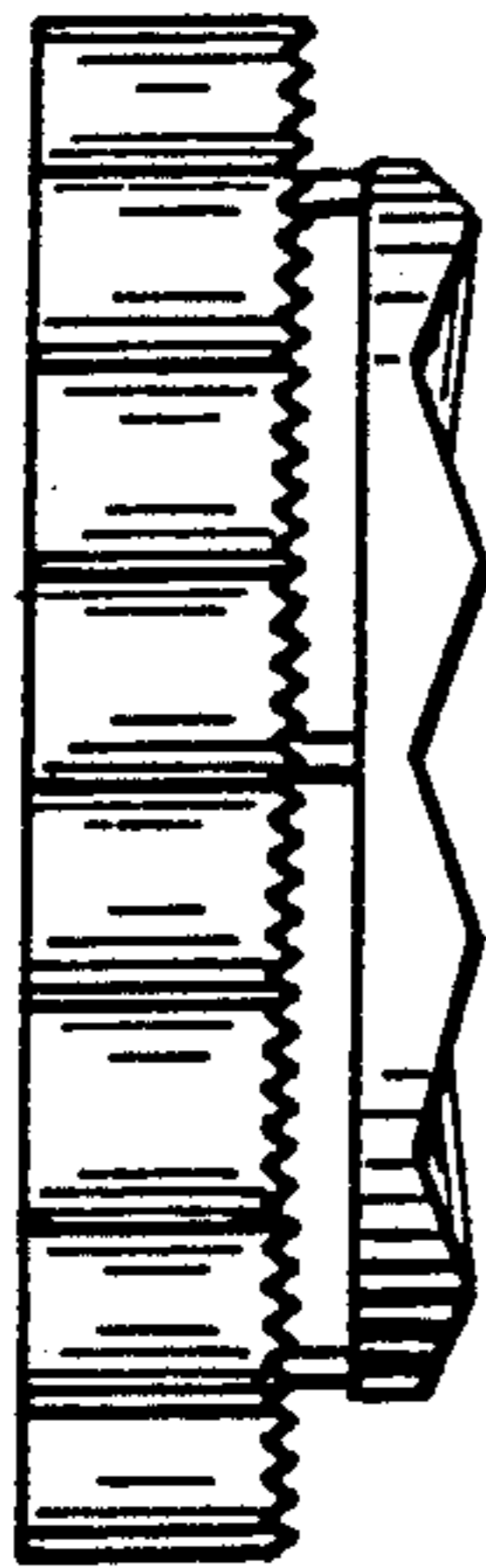

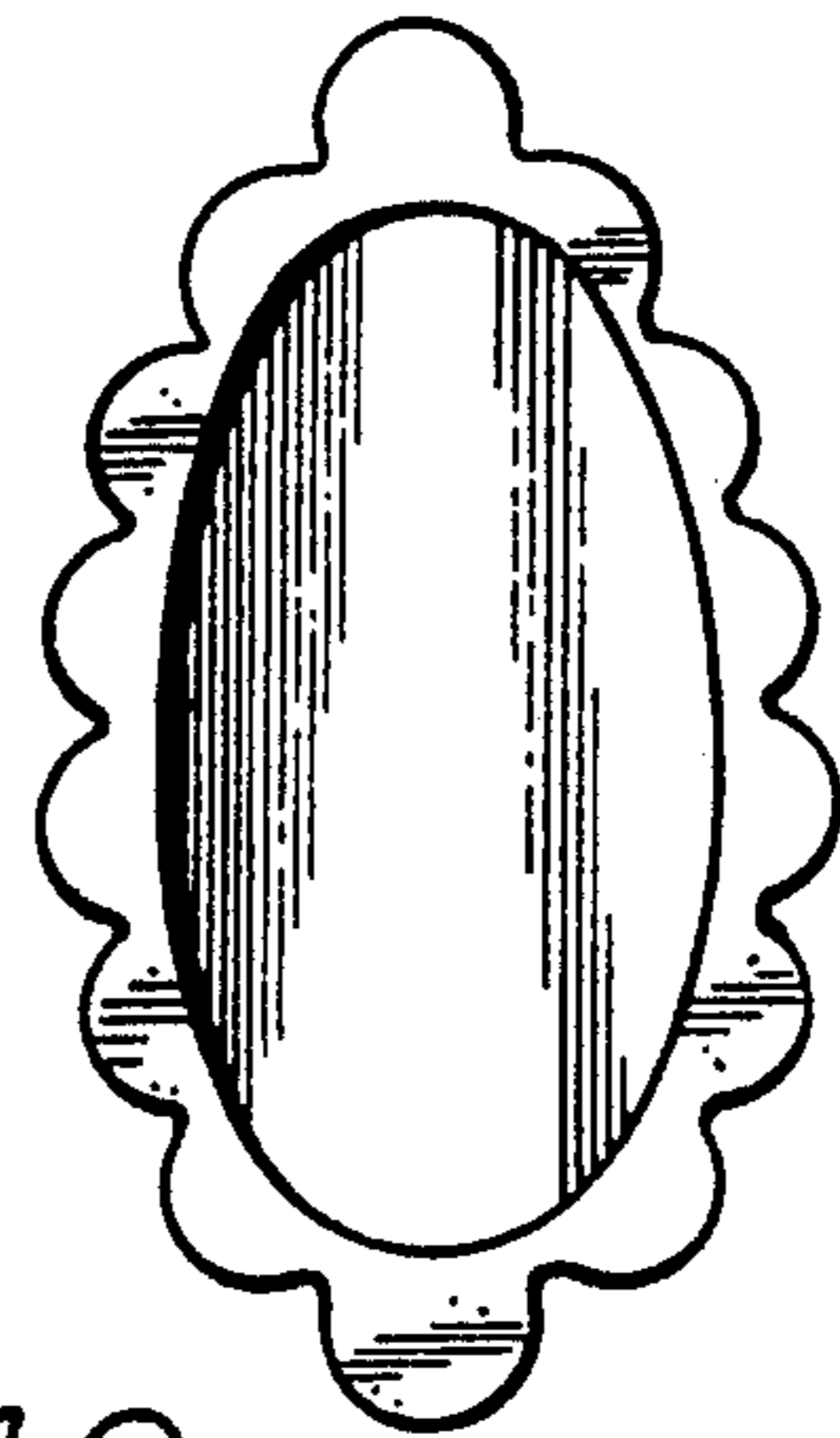

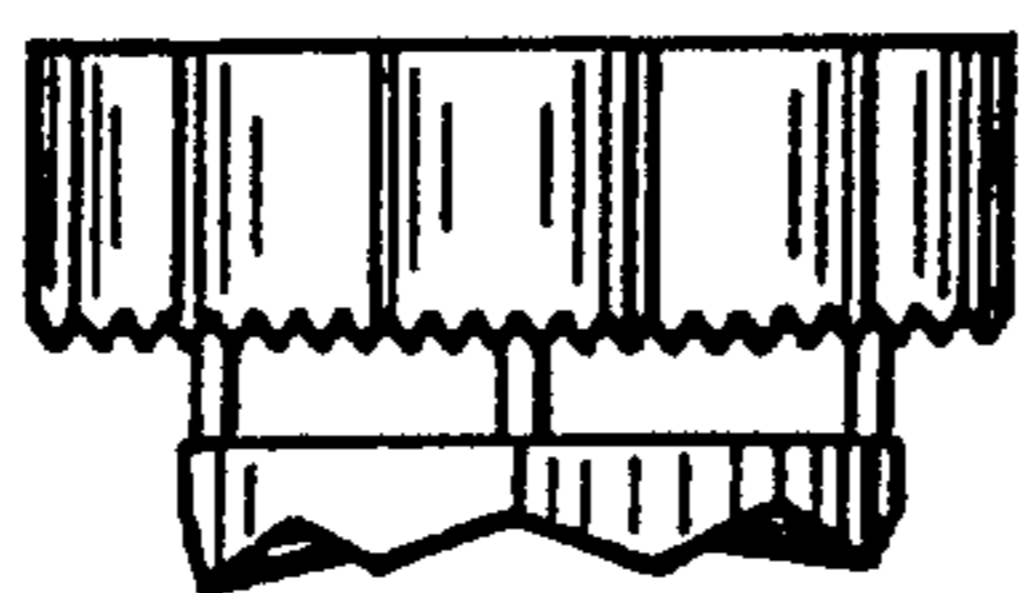

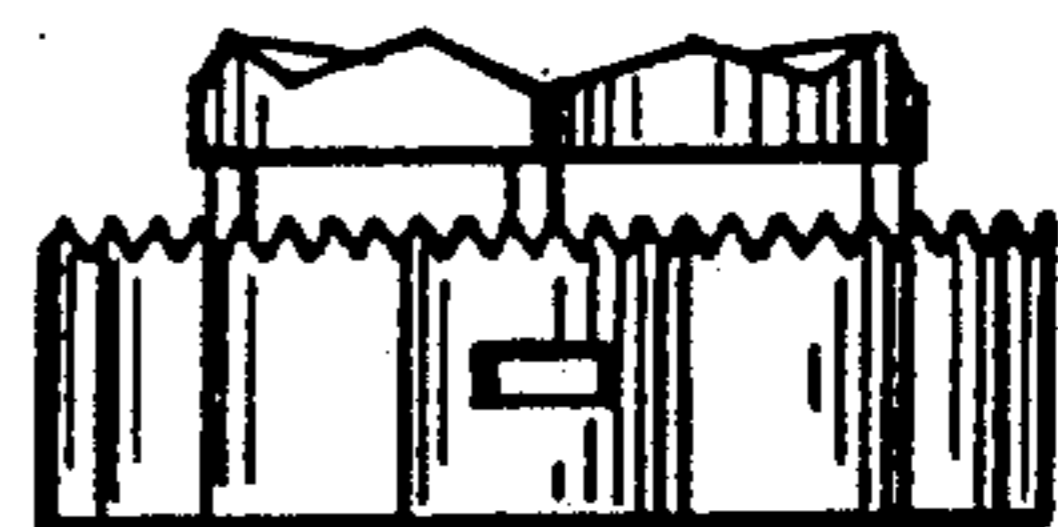

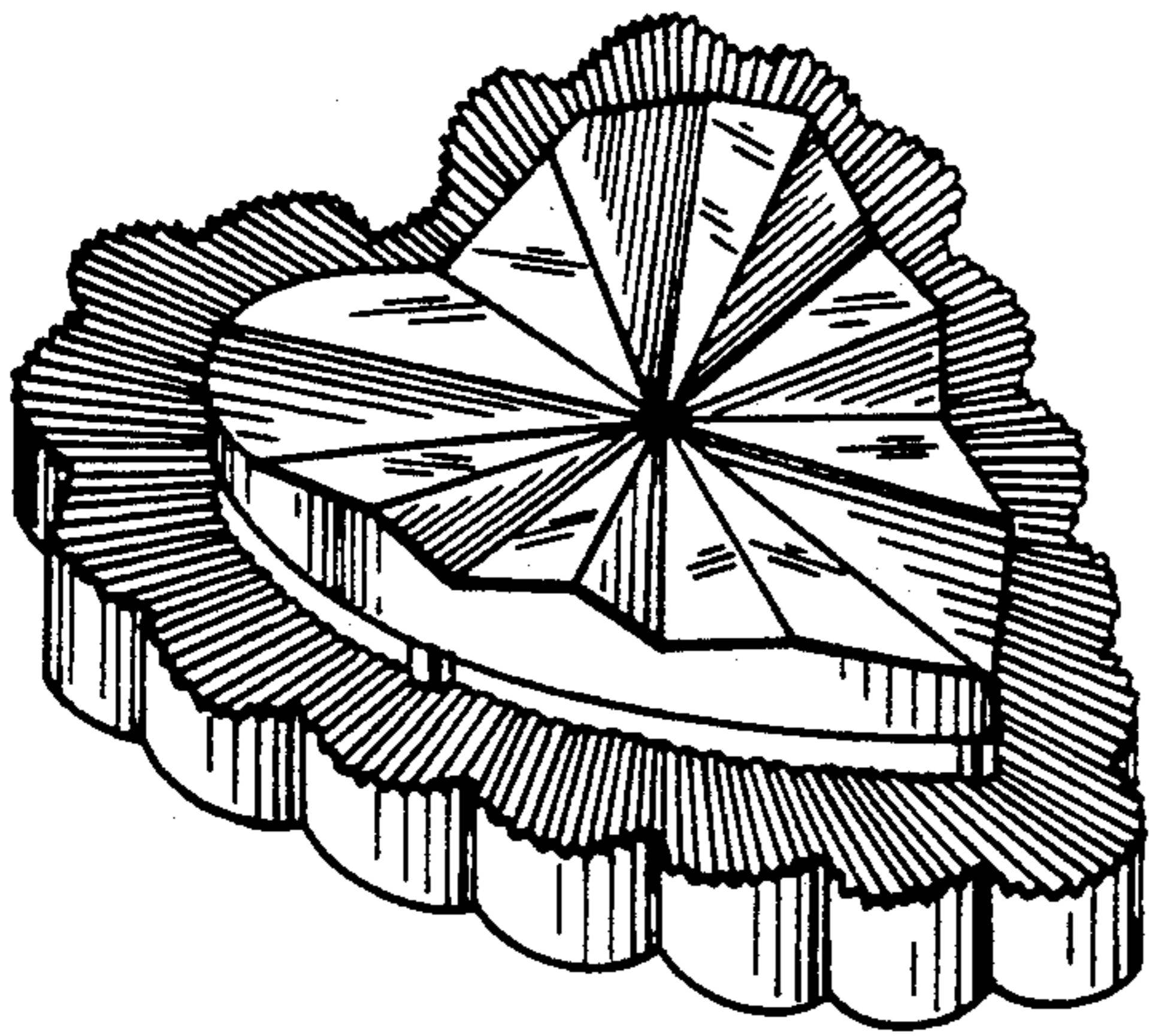

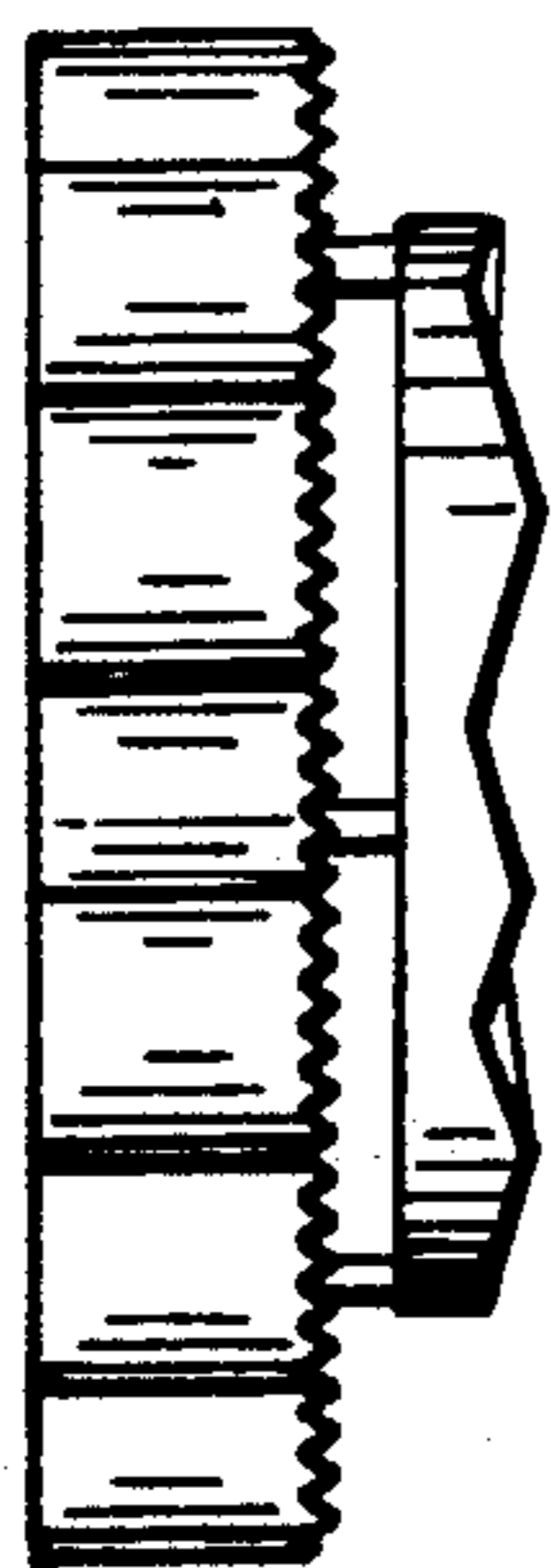
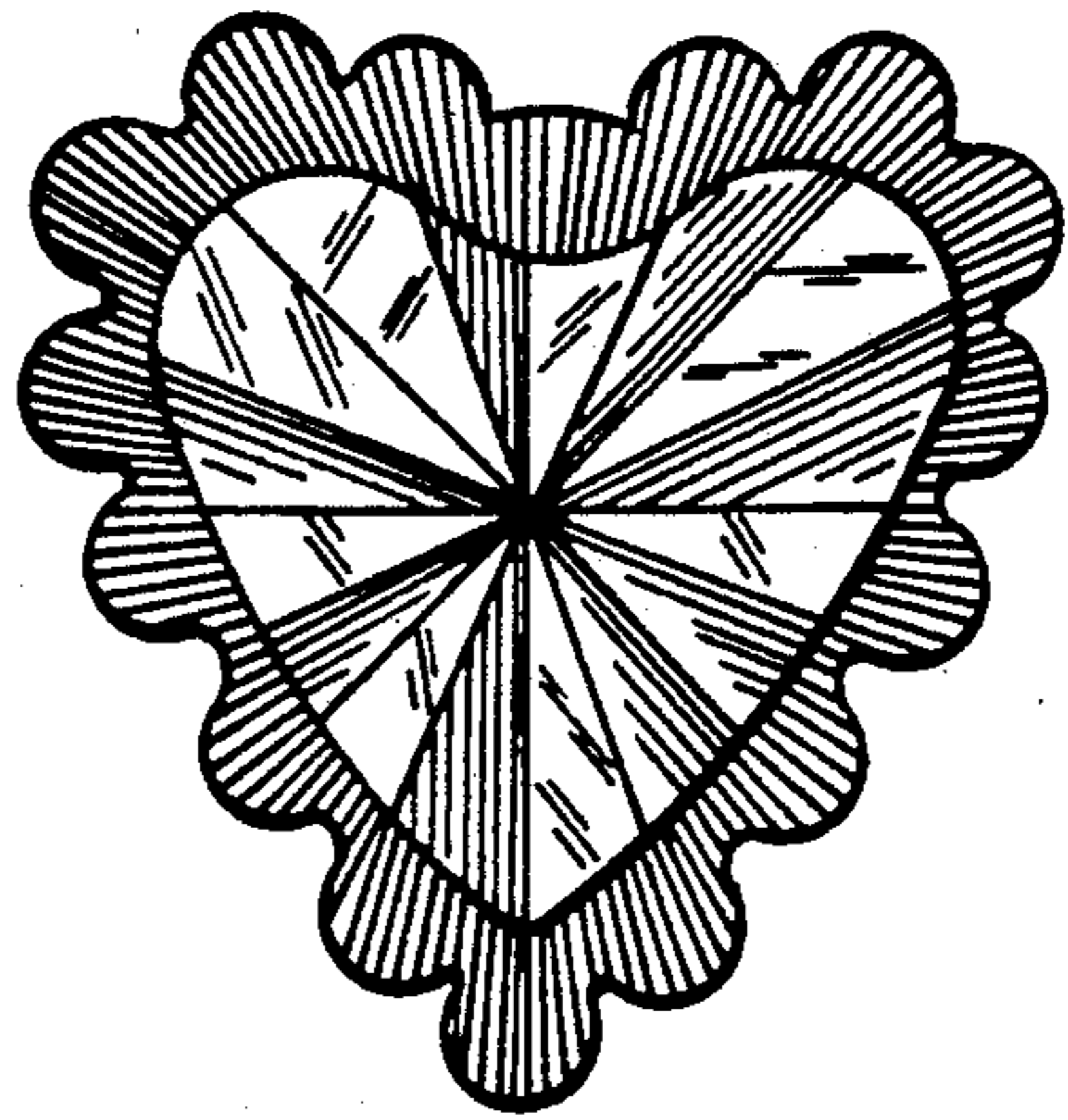

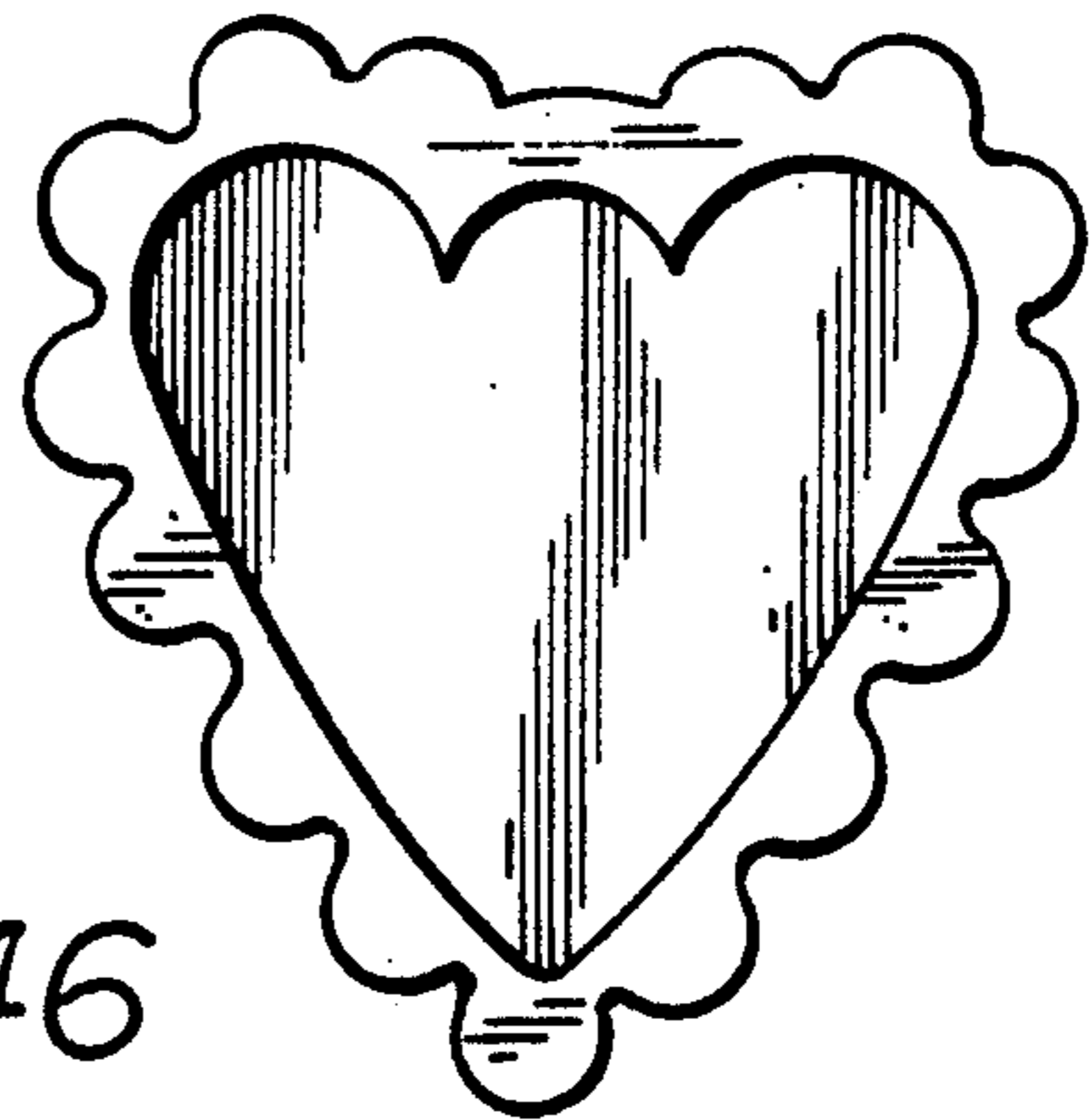

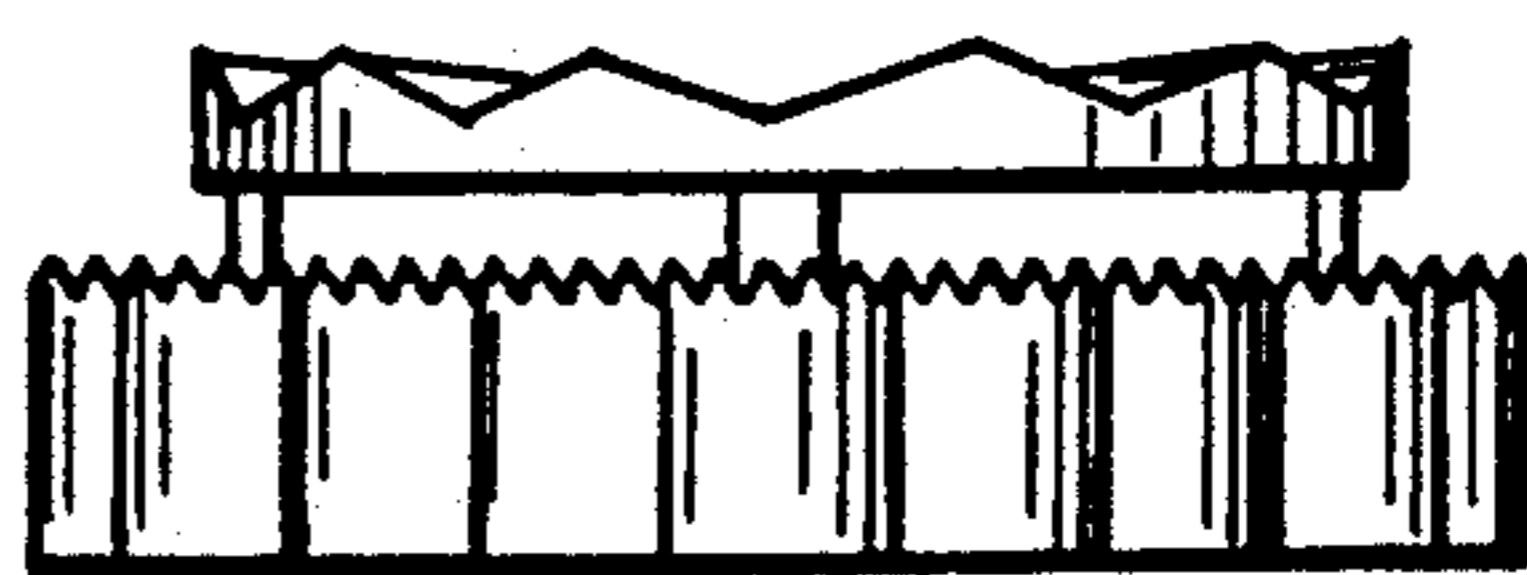
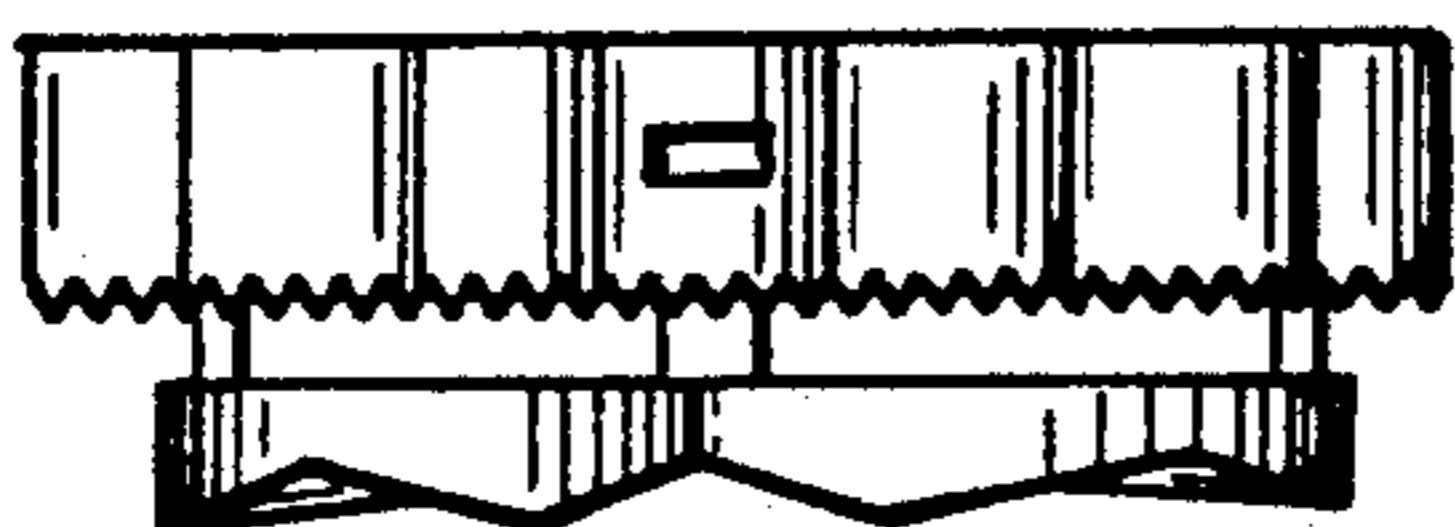

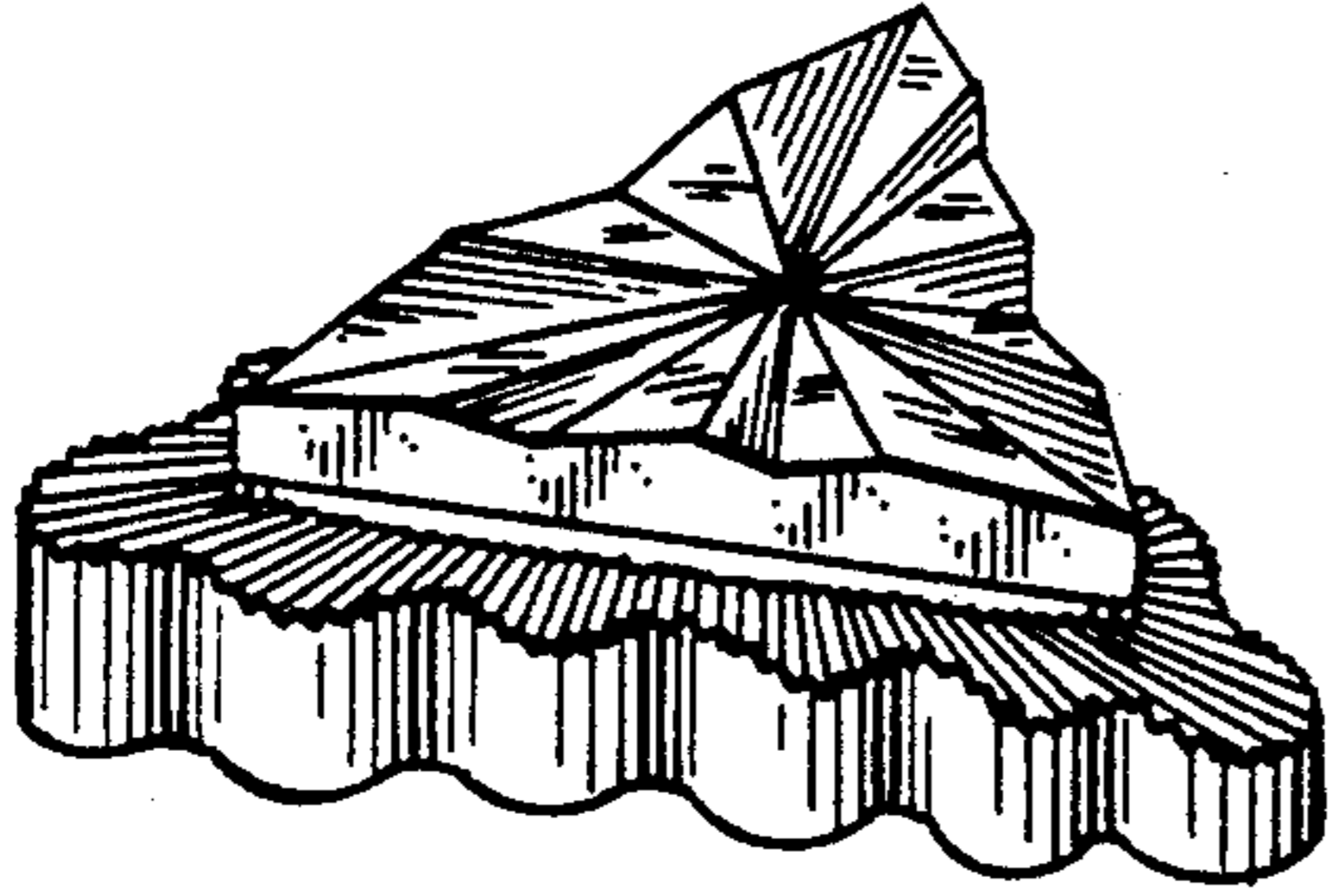

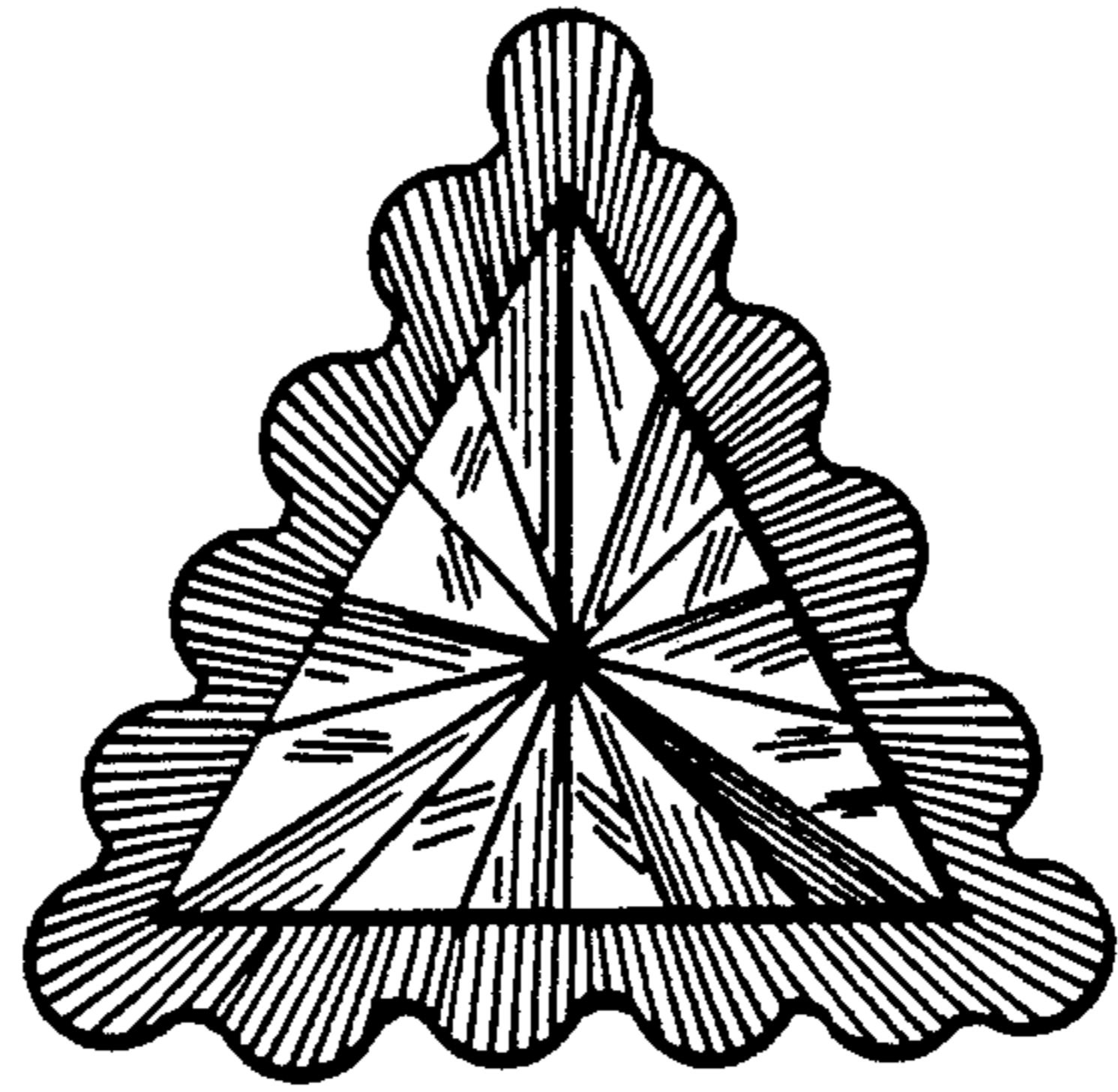

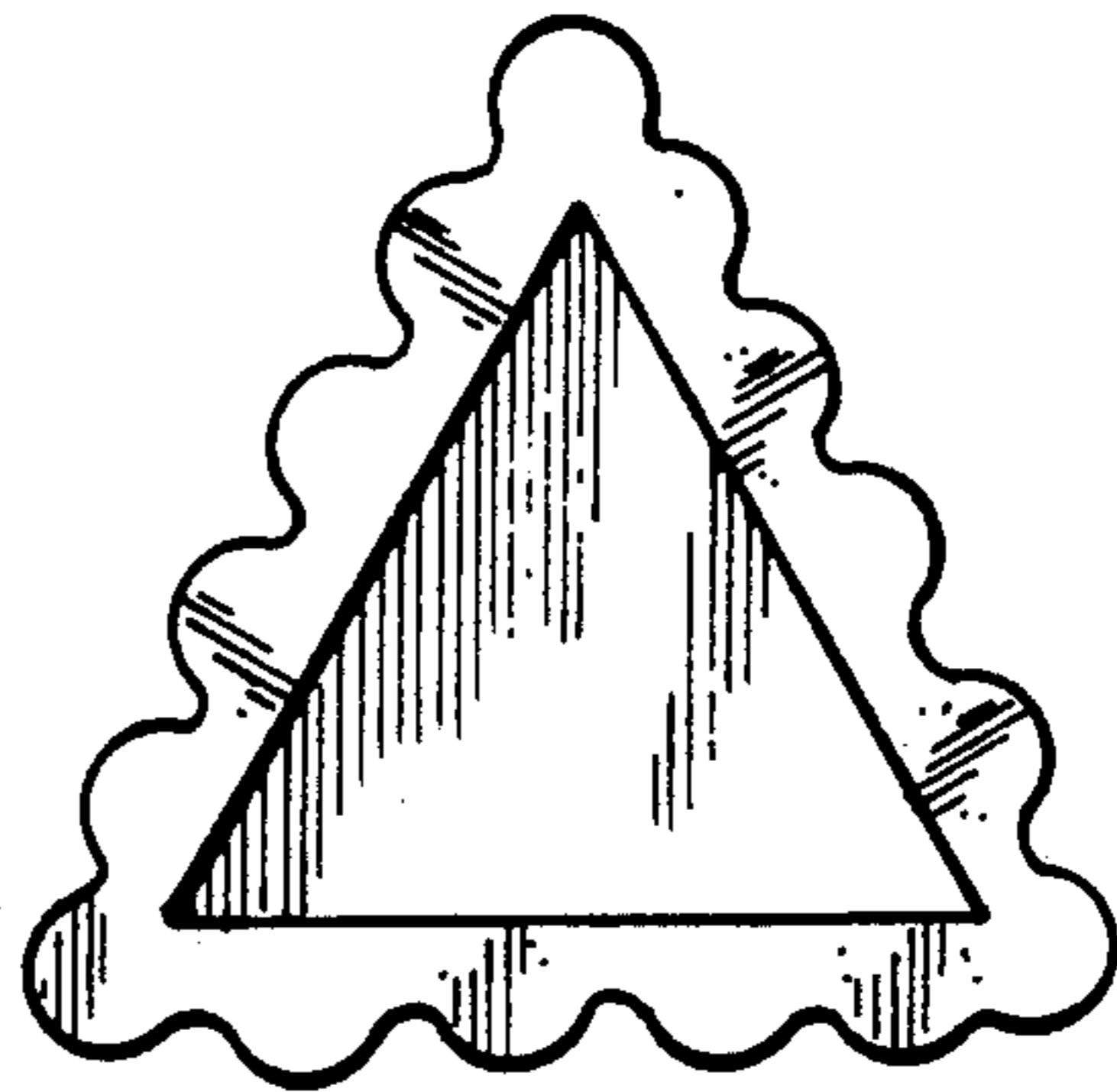

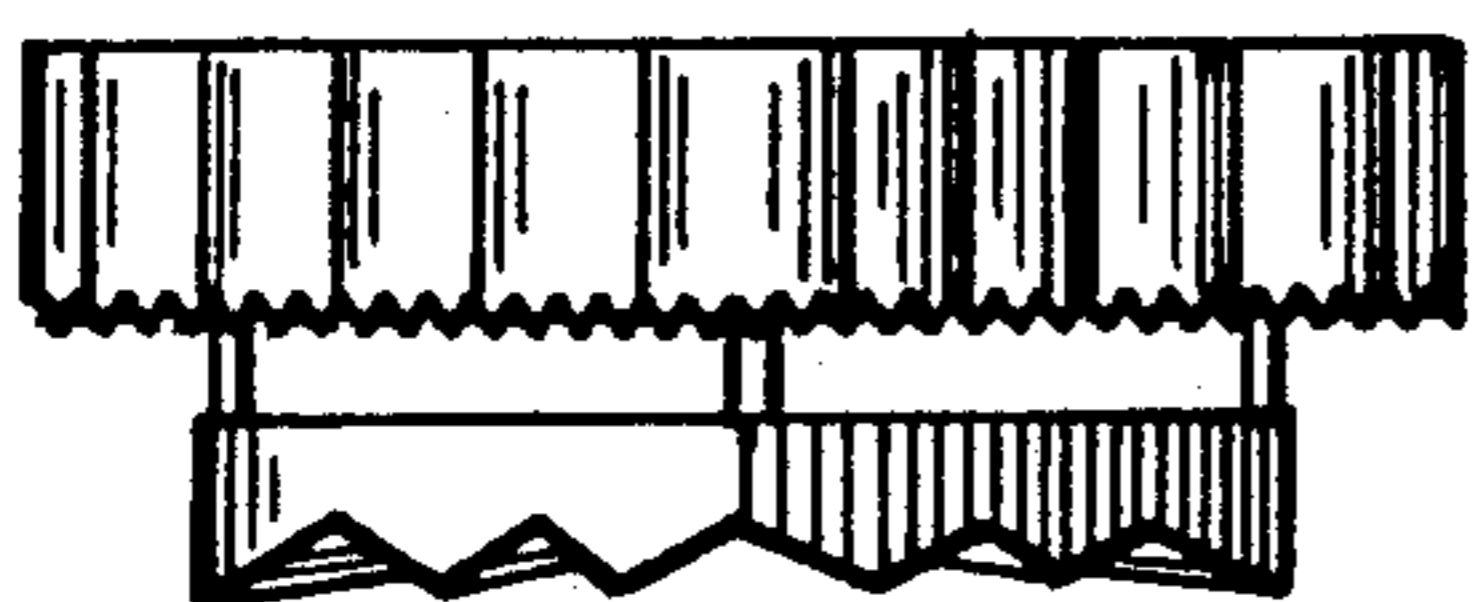
