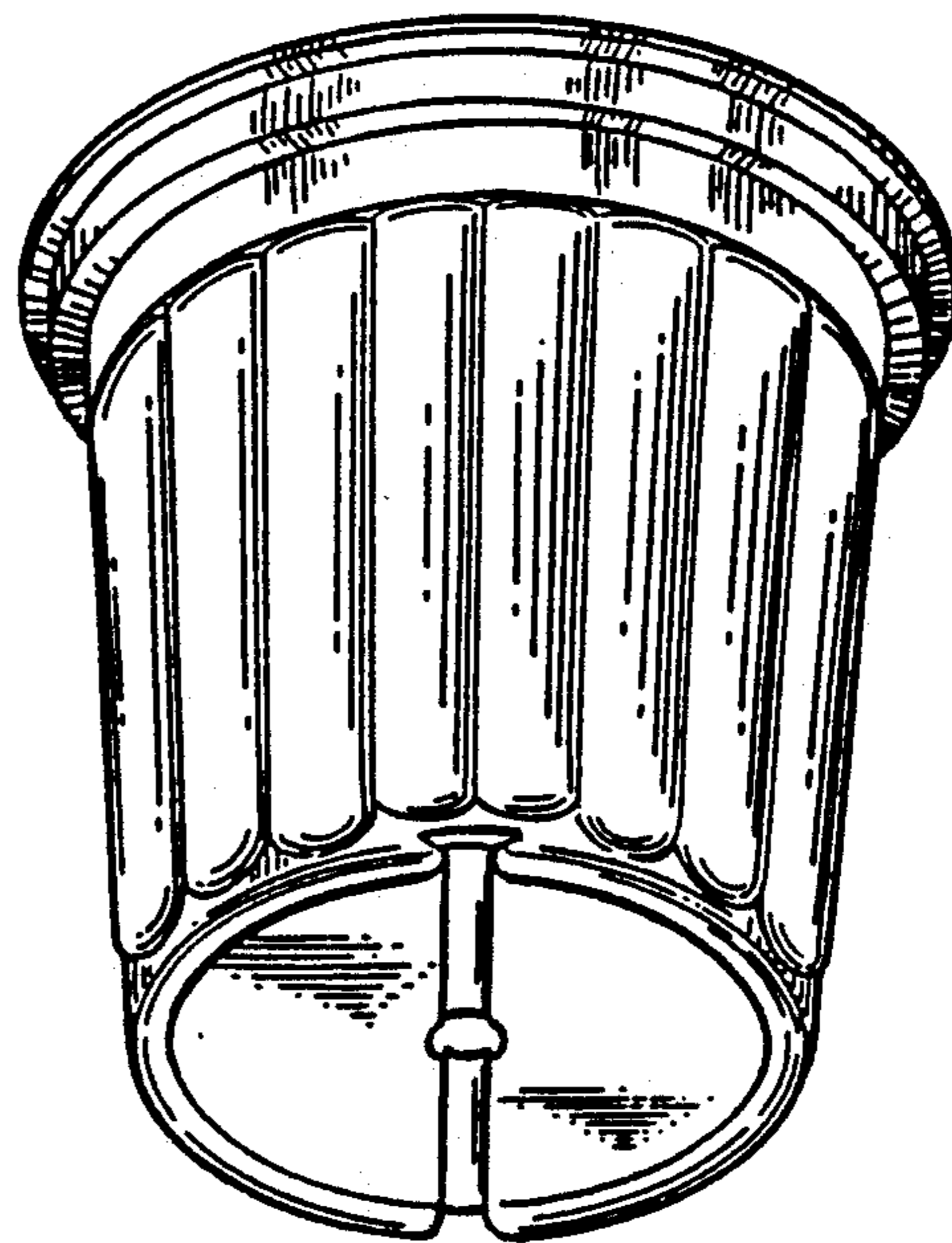
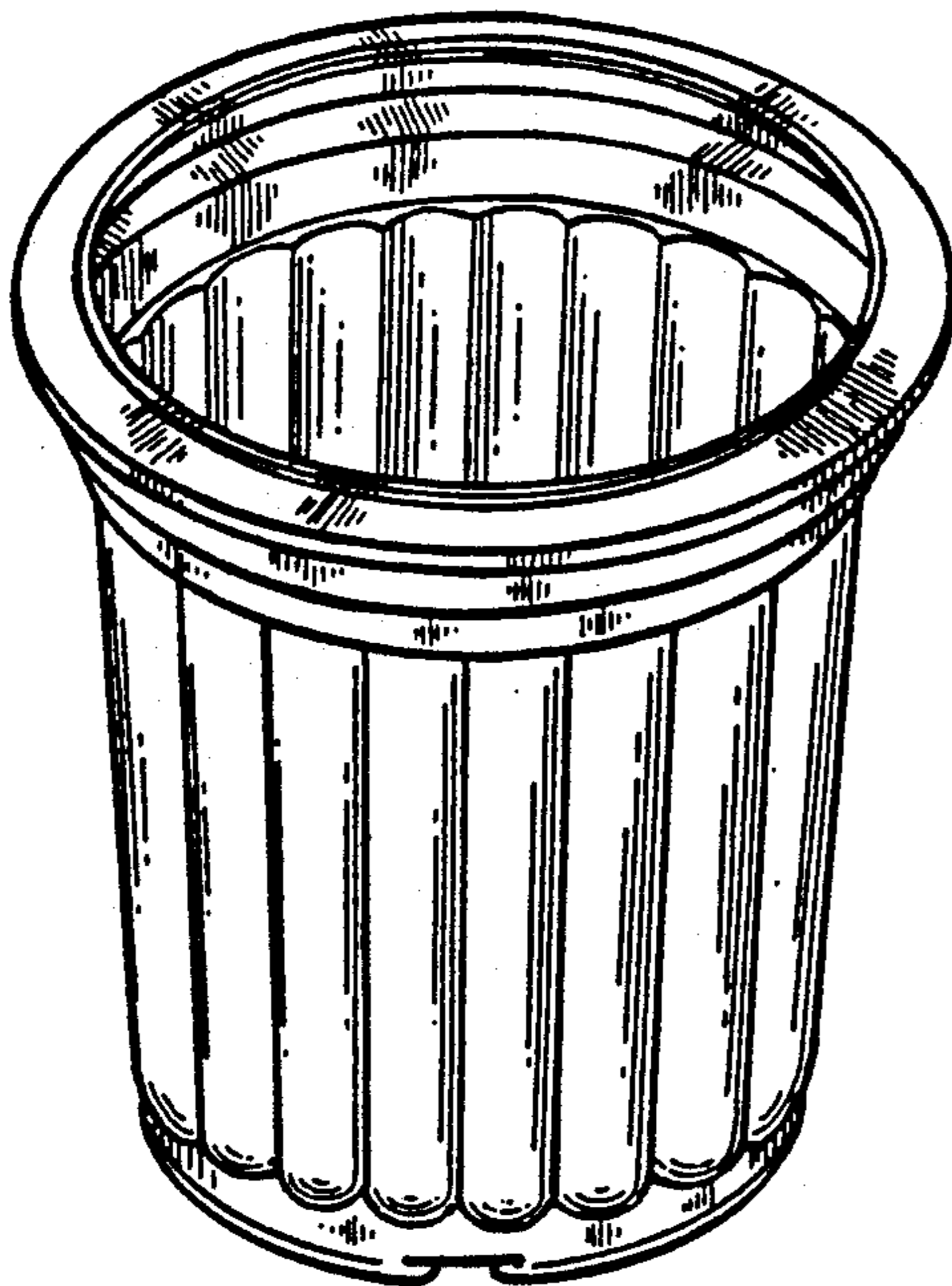

The ornamental design for plant container, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a plant container, showing my new design;
 FIG. 2 is a bottom perspective view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a side elevational view thereof;
 FIG. 5 is an enlarged fragmentary sectional view taken in the direction of the arrows on line 5—5 of FIG. 3;
 FIG. 6 is a top perspective view of a second embodiment of the design of FIG. 1;
 FIG. 7 is a bottom perspective view of FIG. 6;
 FIG. 8 is a top plan view of FIG. 6; and,
 FIG. 9 is a side elevational view of FIG. 6.



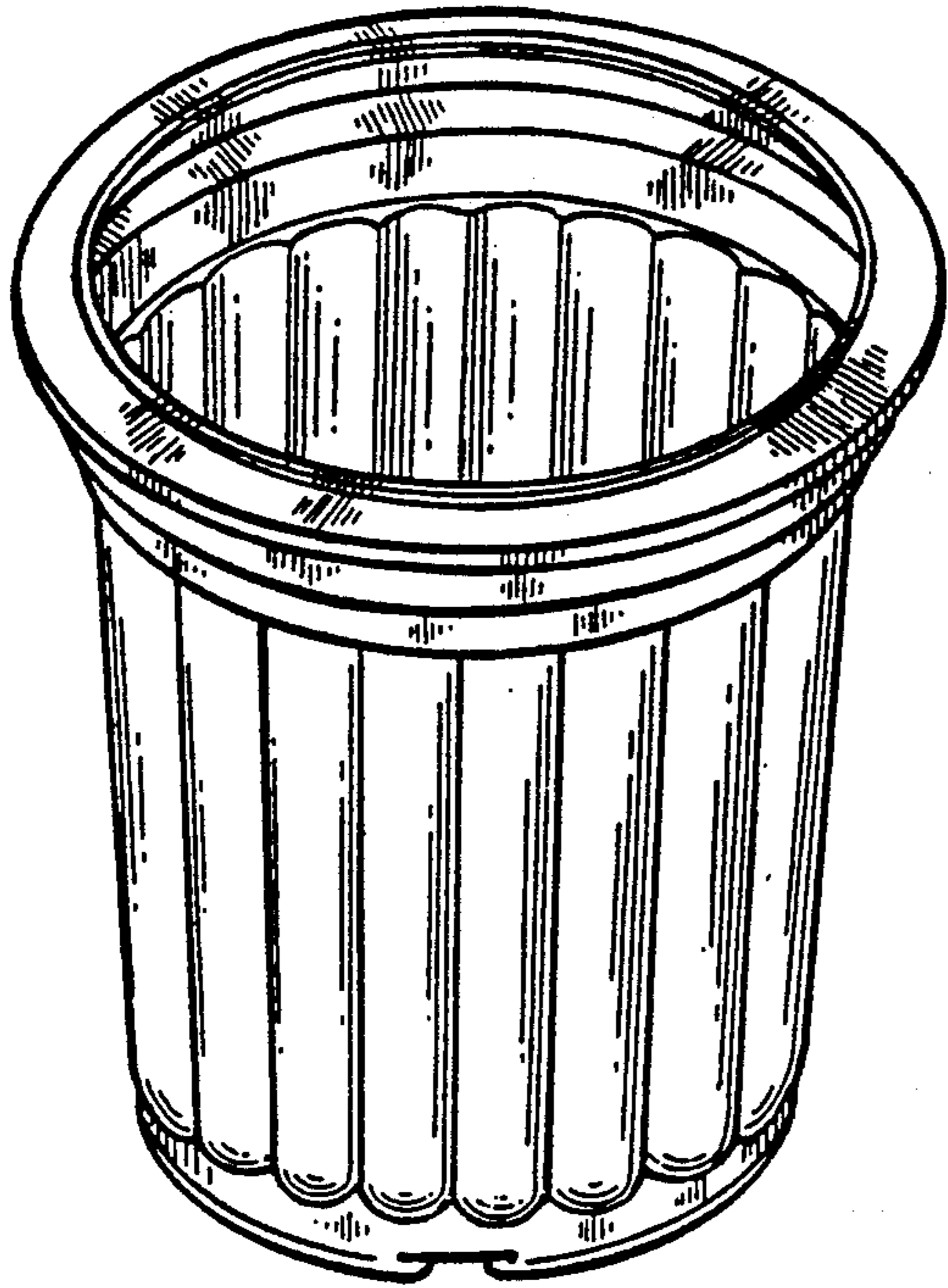

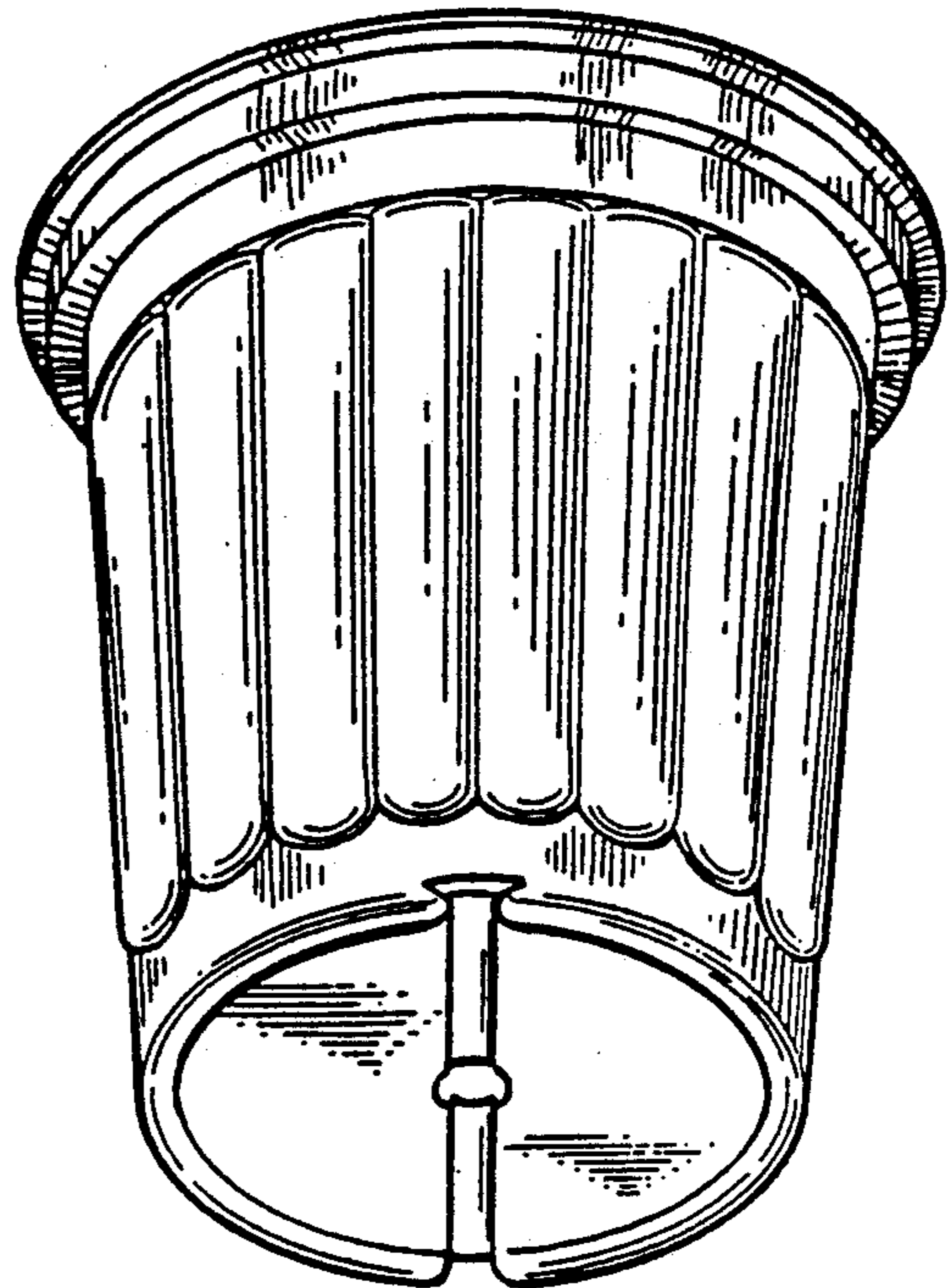

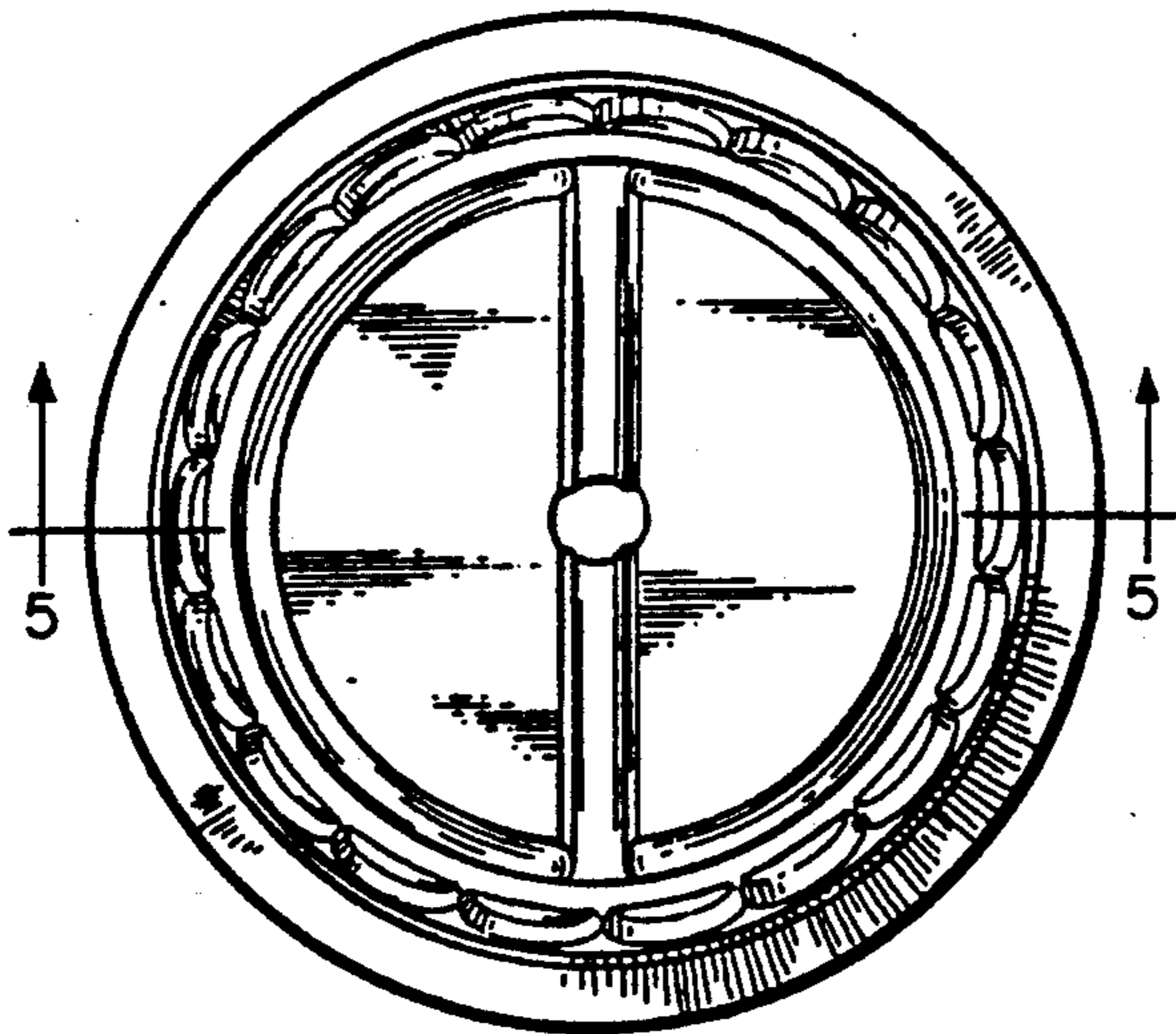

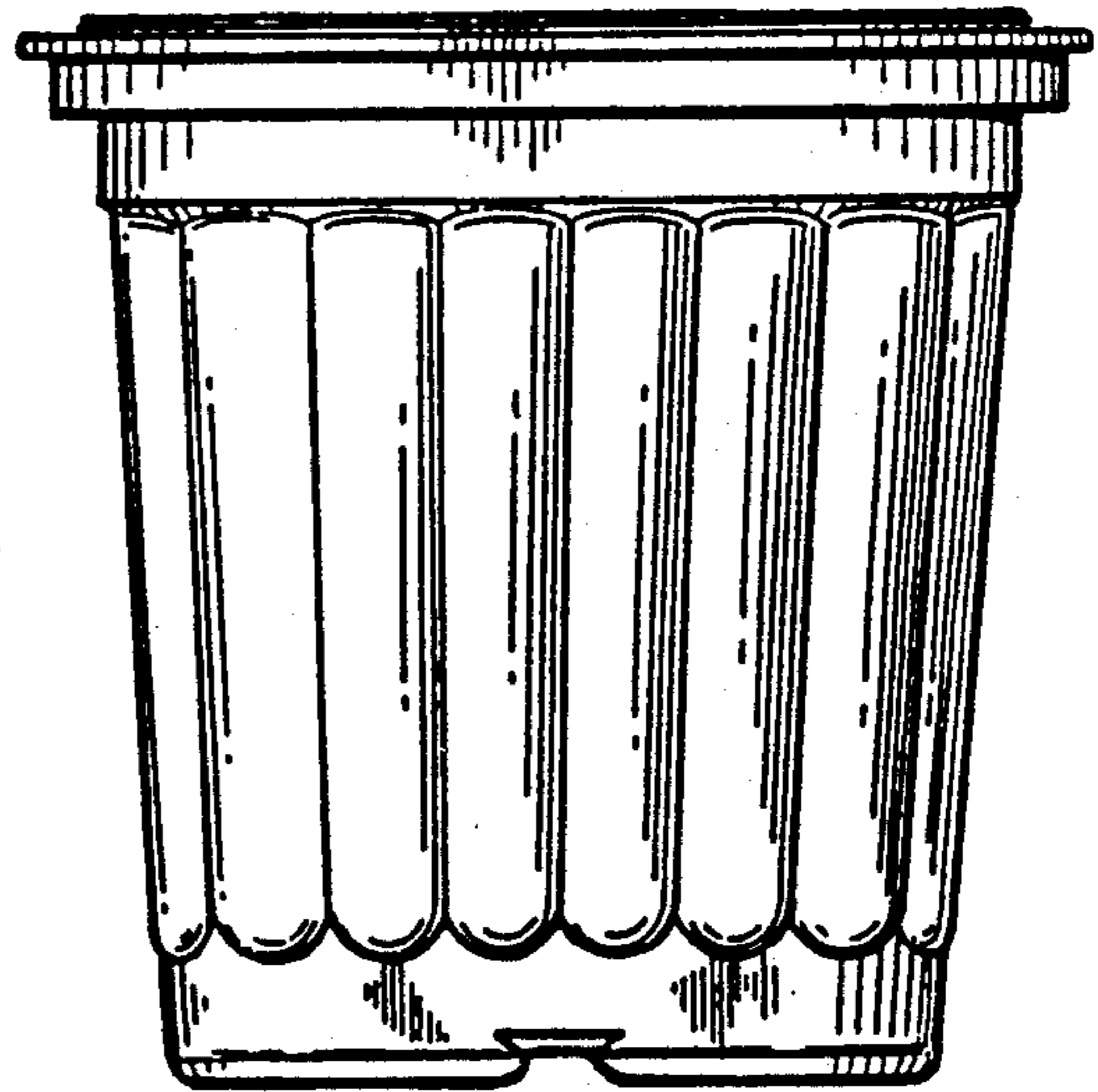

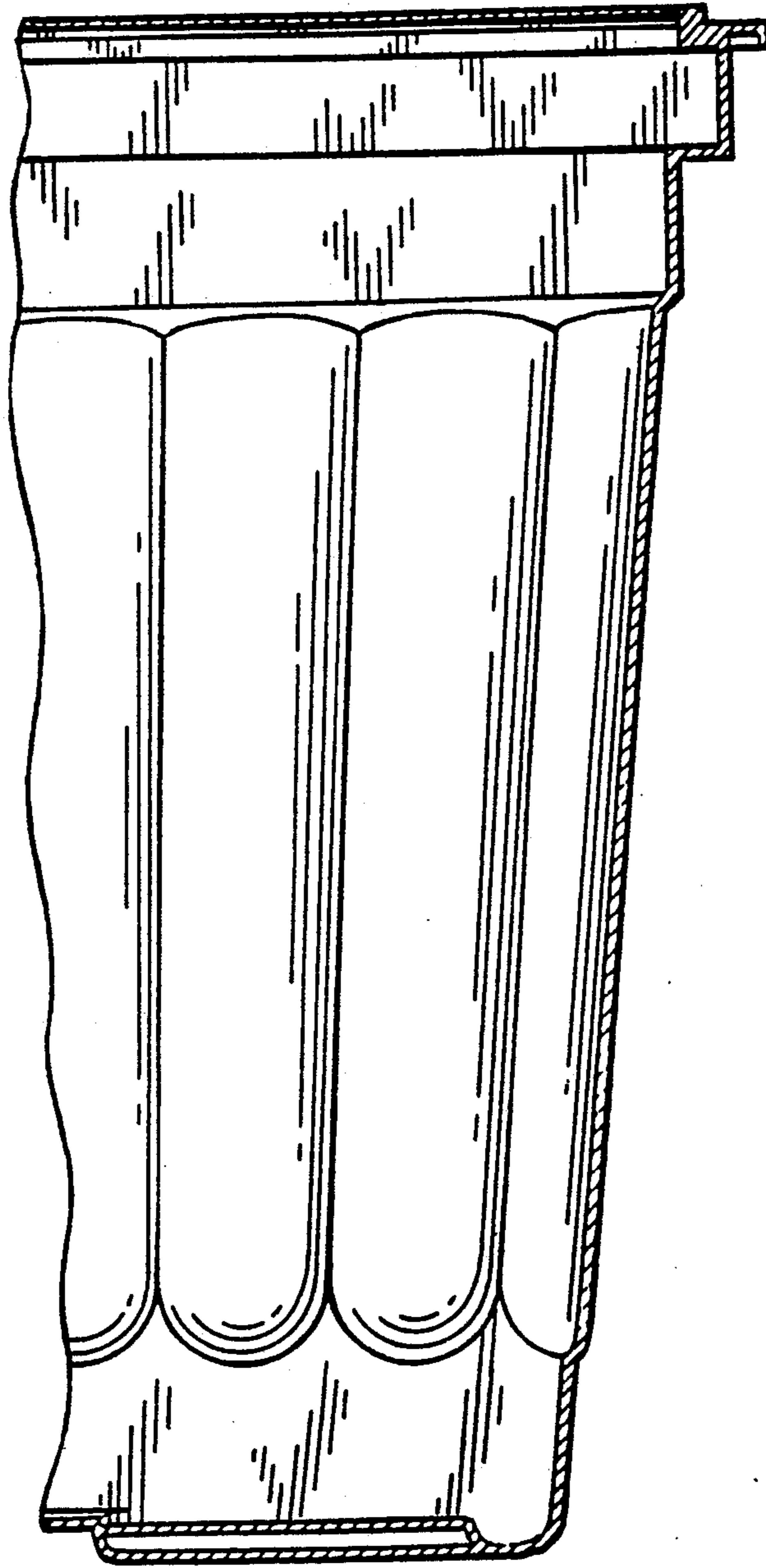

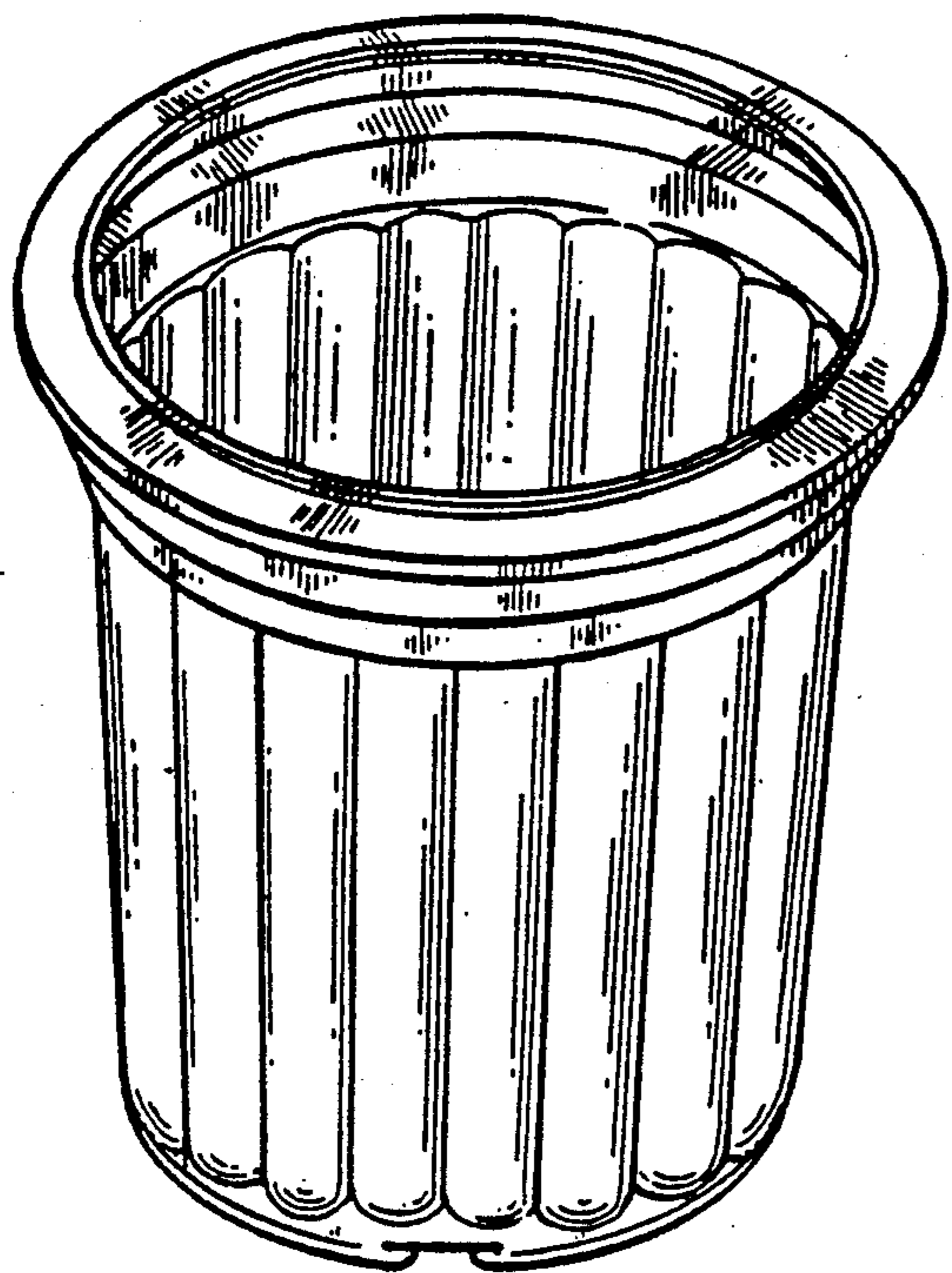

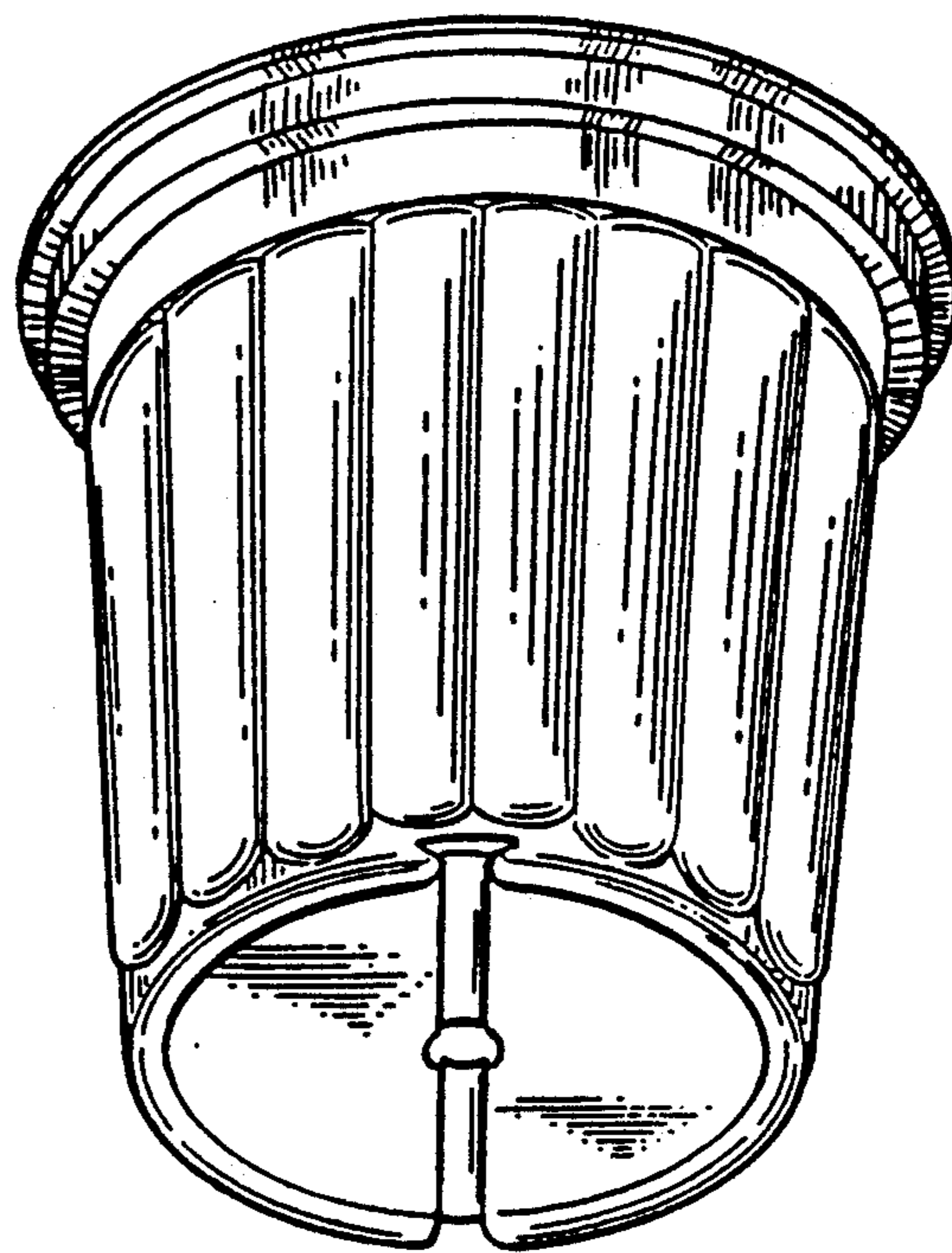

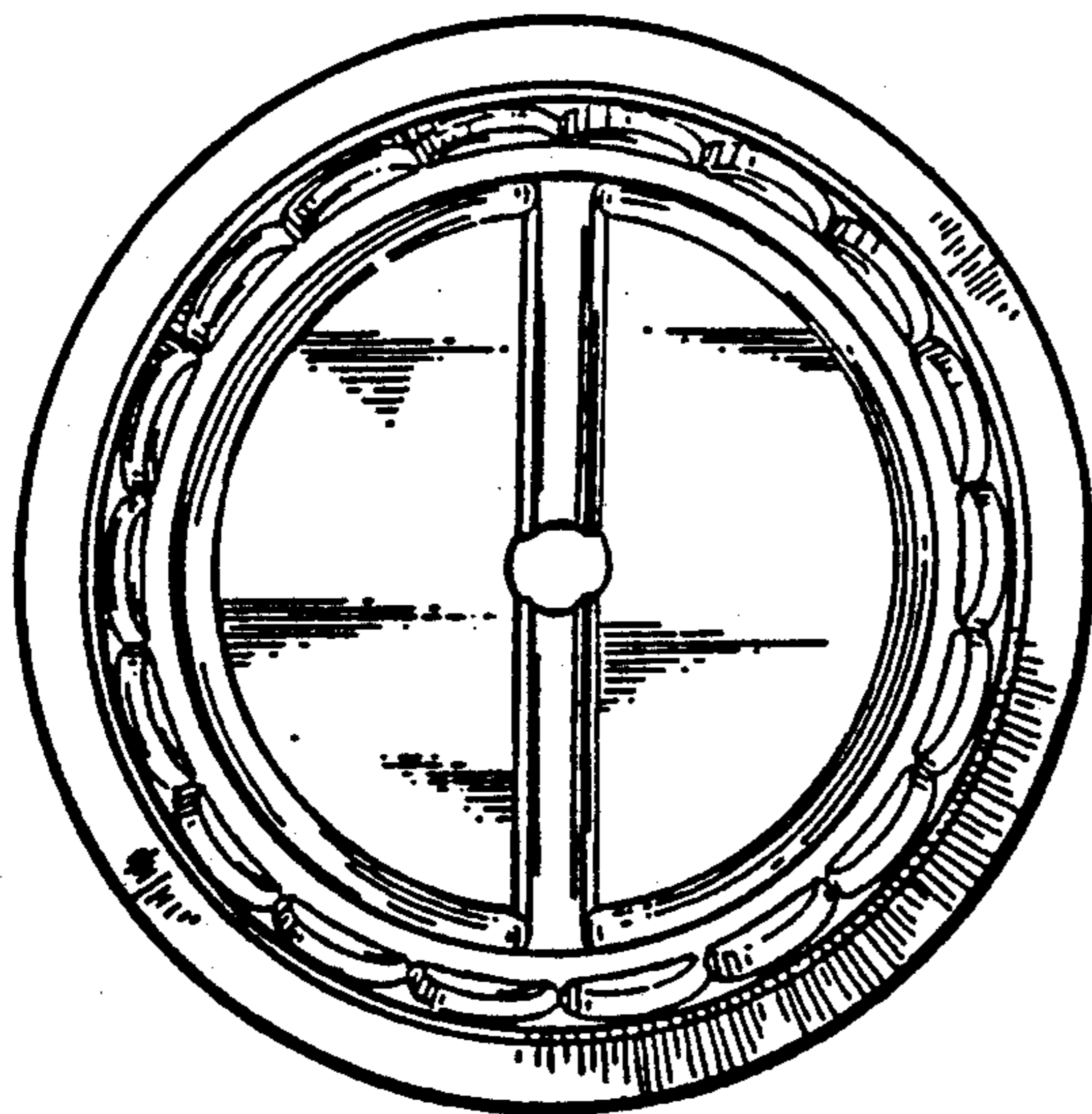

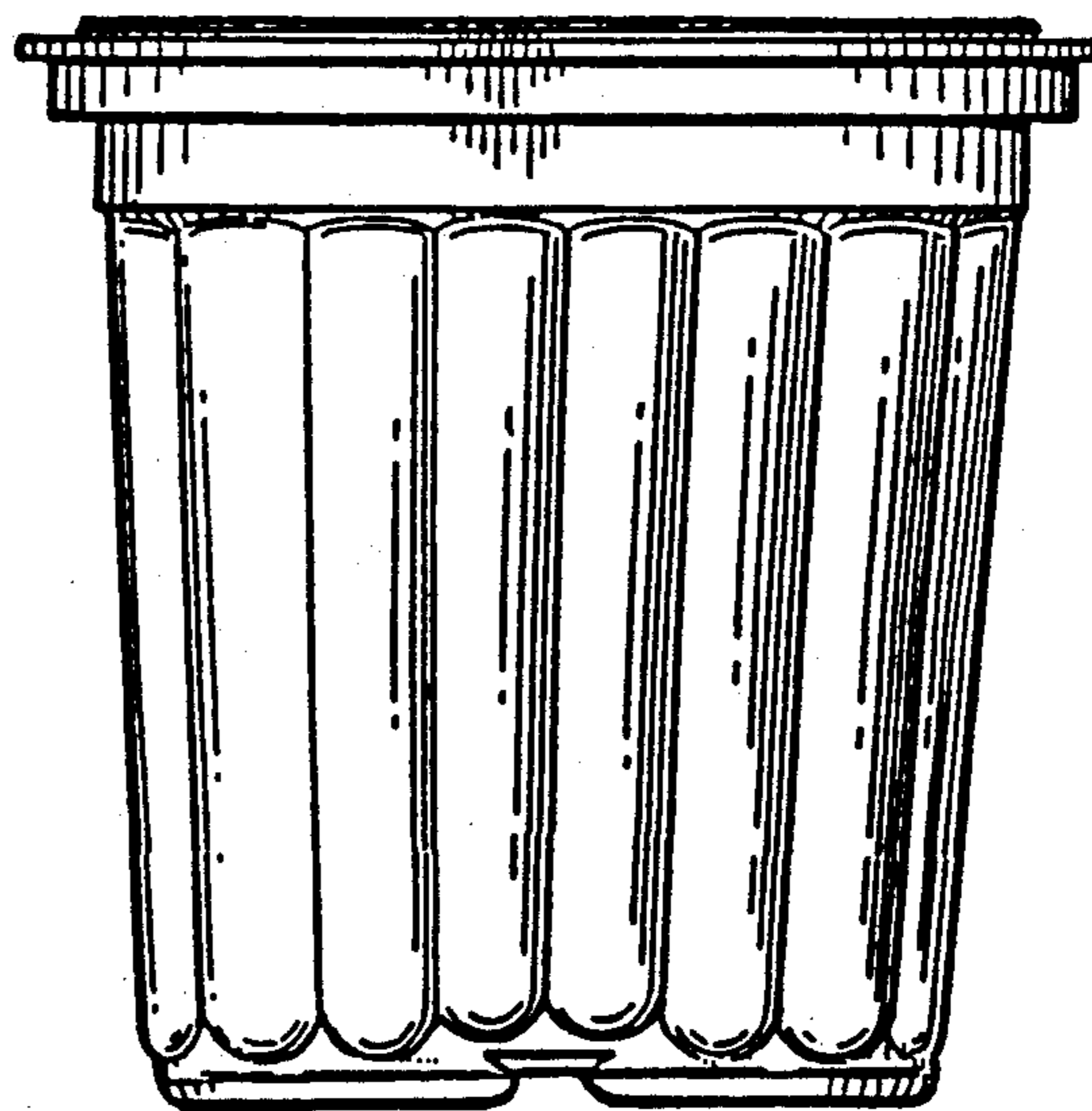
