[57] CLAIM

The ornamental design for a hand held controller for a video game machine, as shown and described.

DESCRIPTION

FIG. 44 is a rear elevational view of FIG. 39.

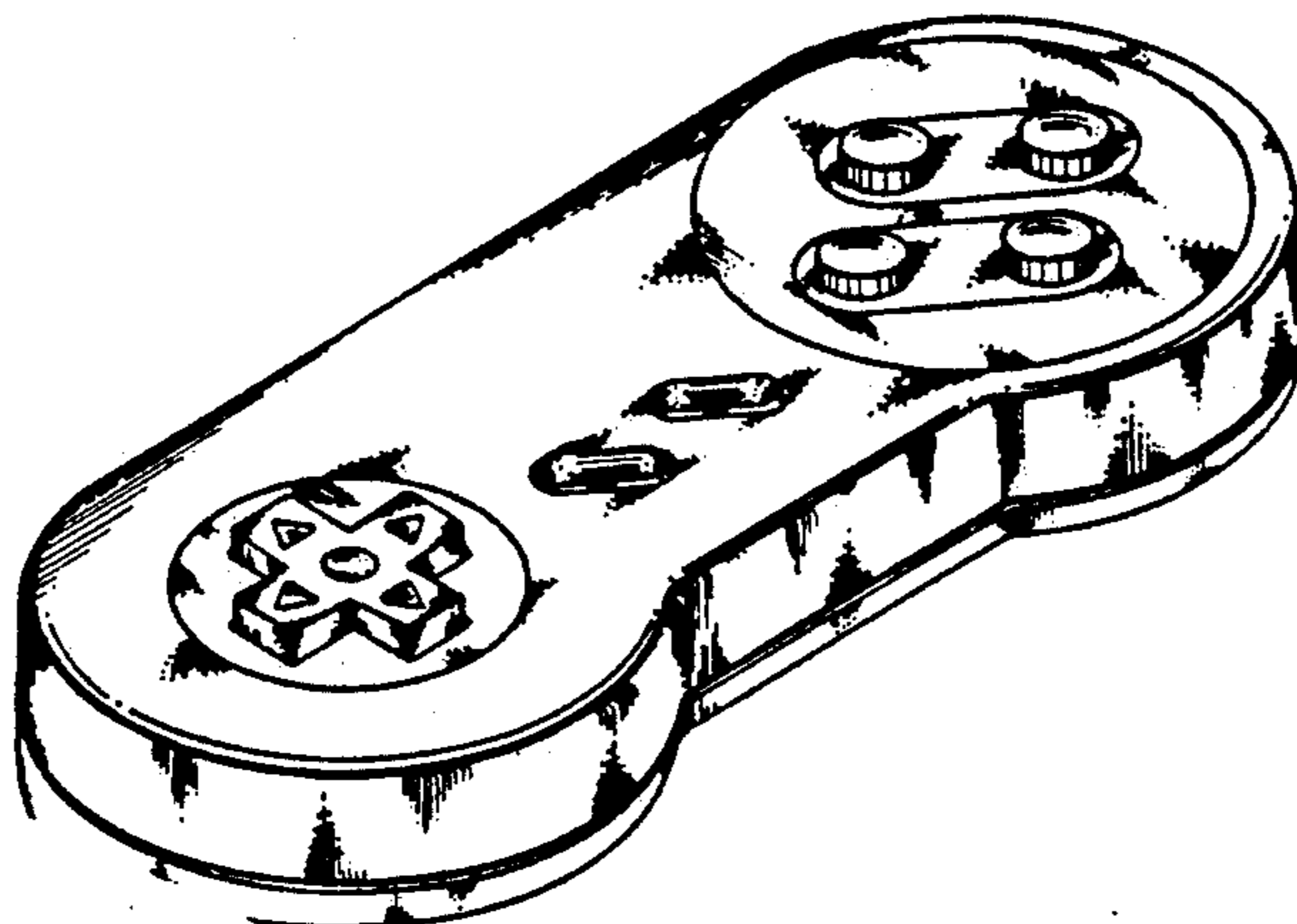

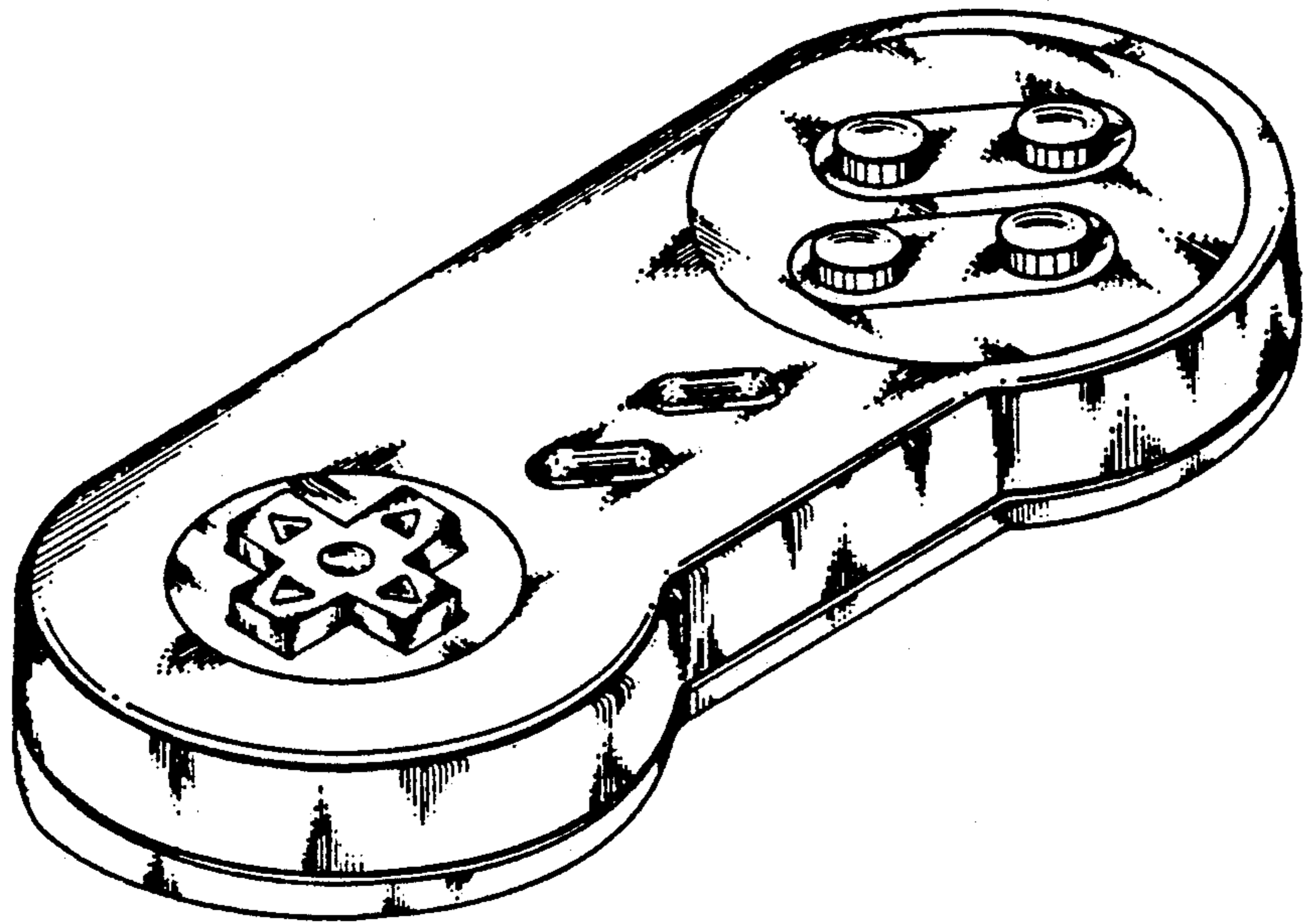

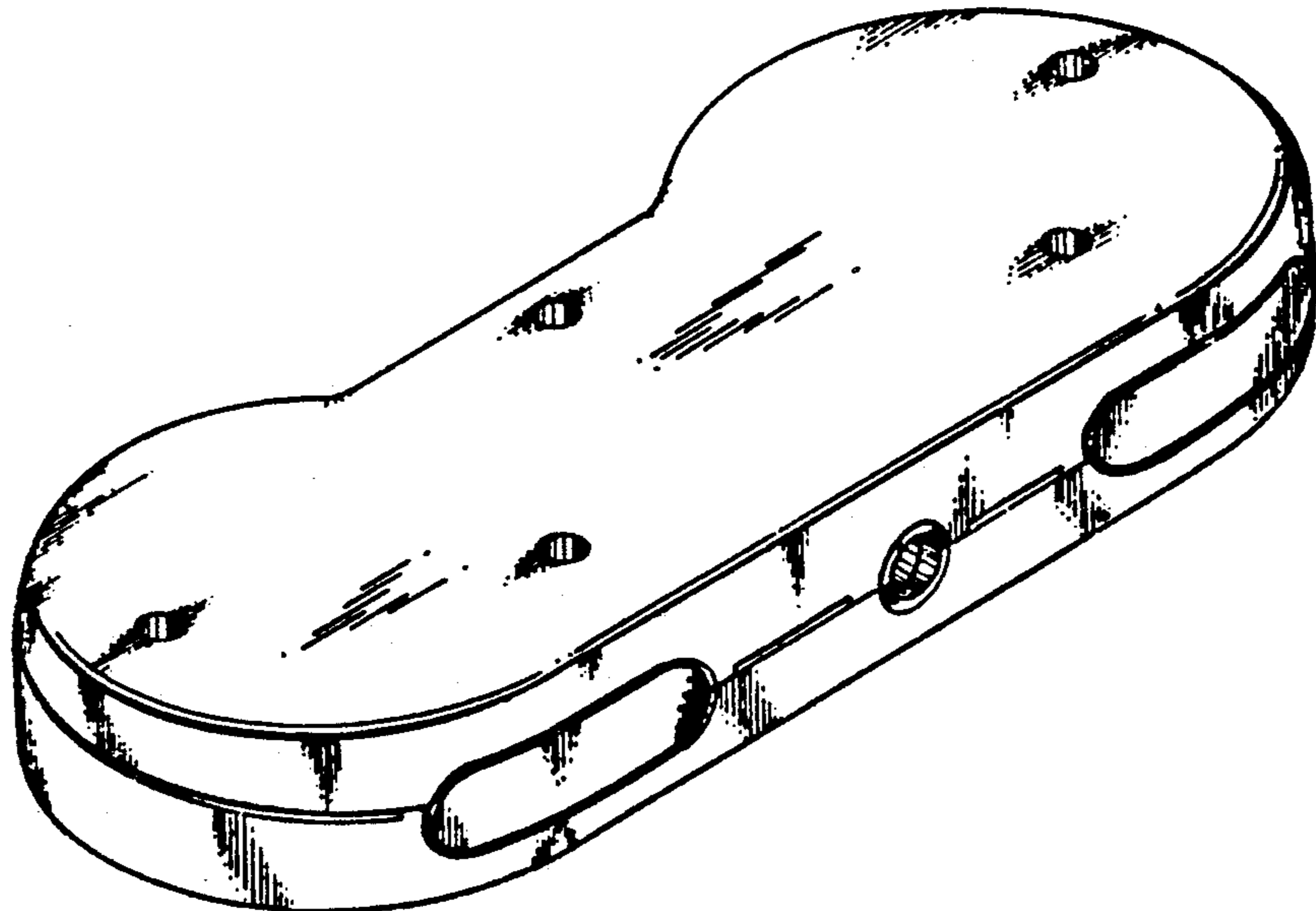

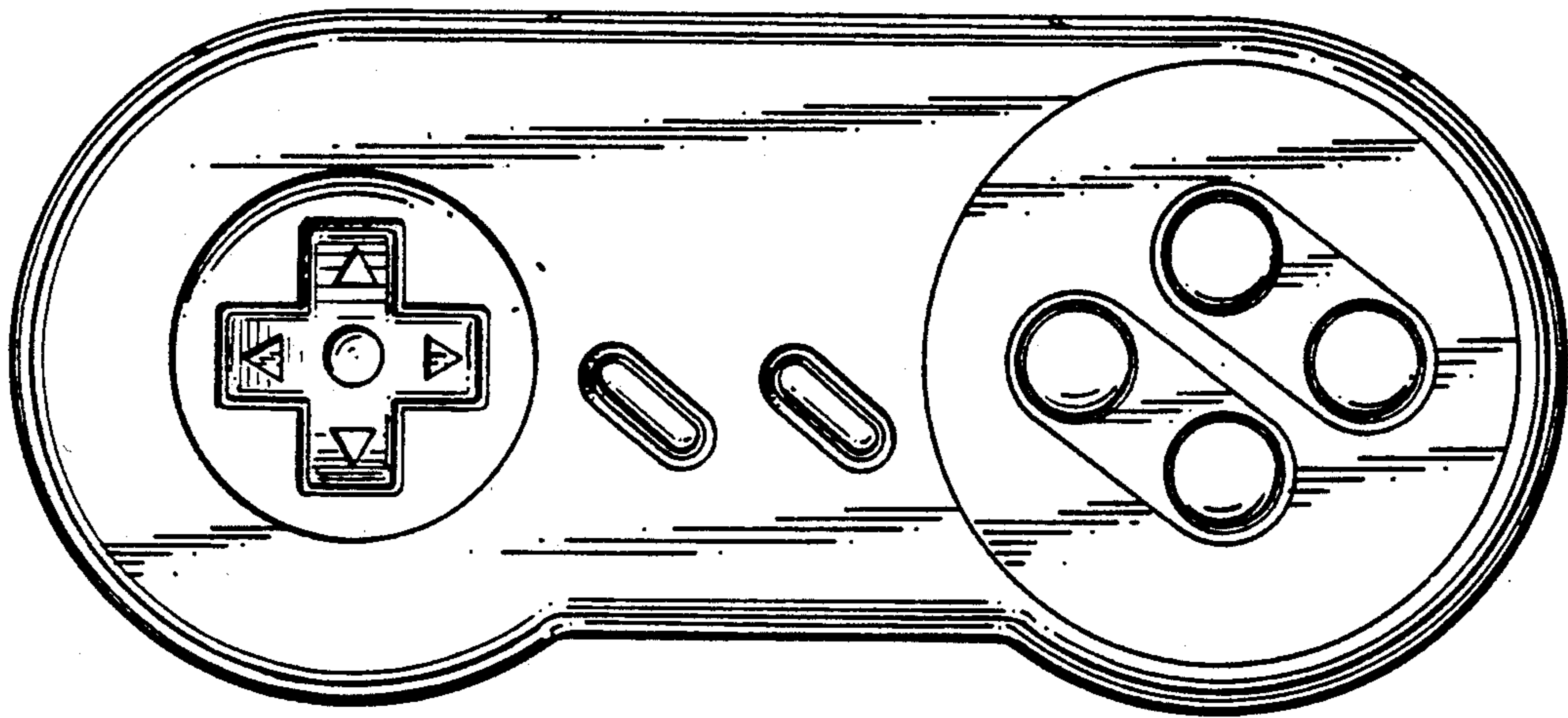

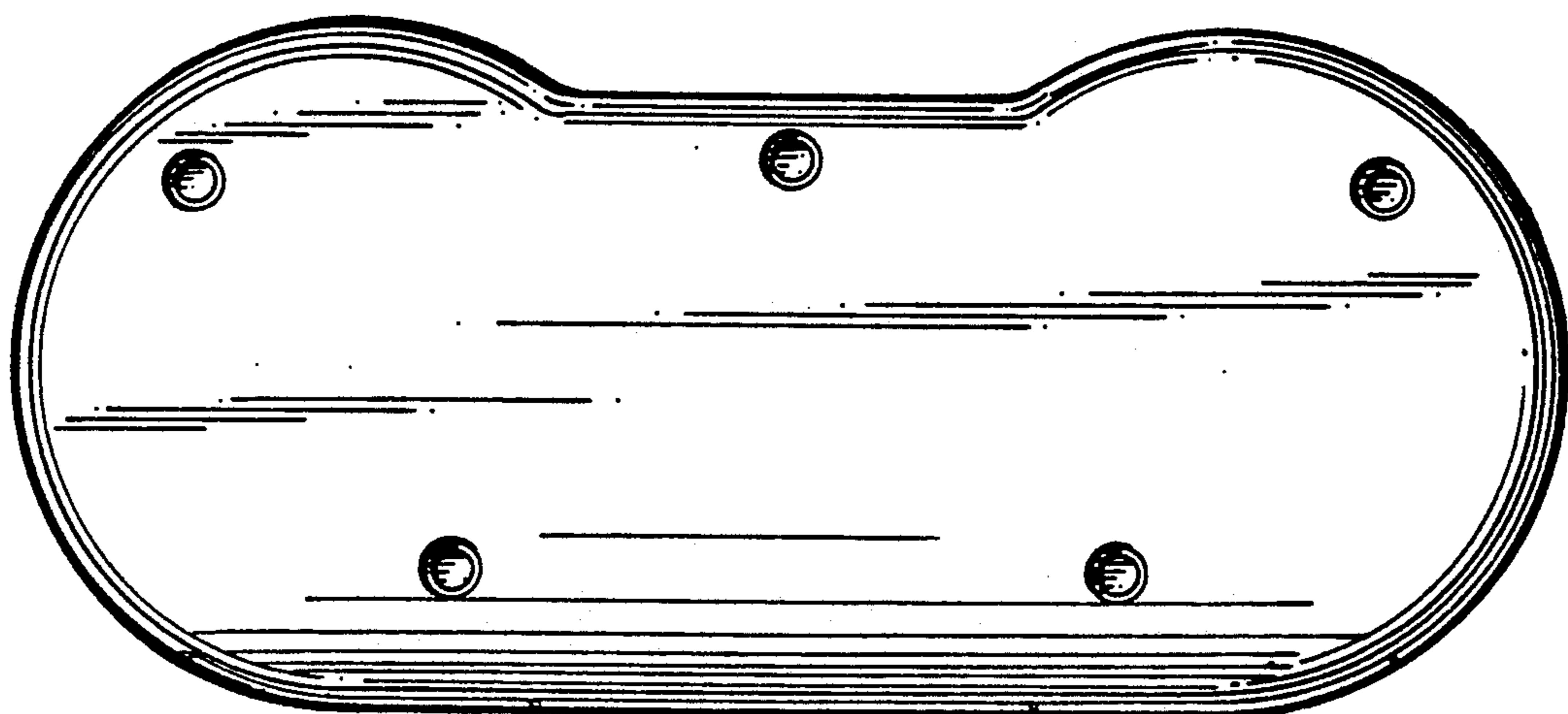

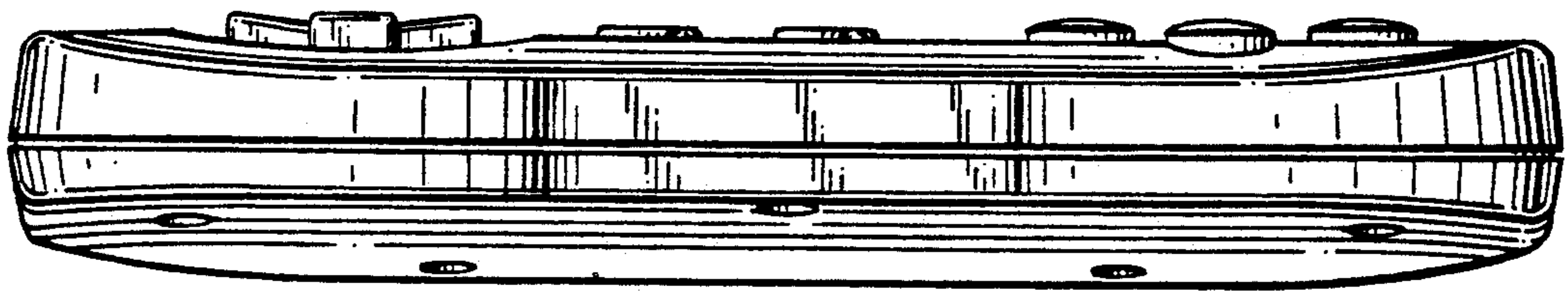

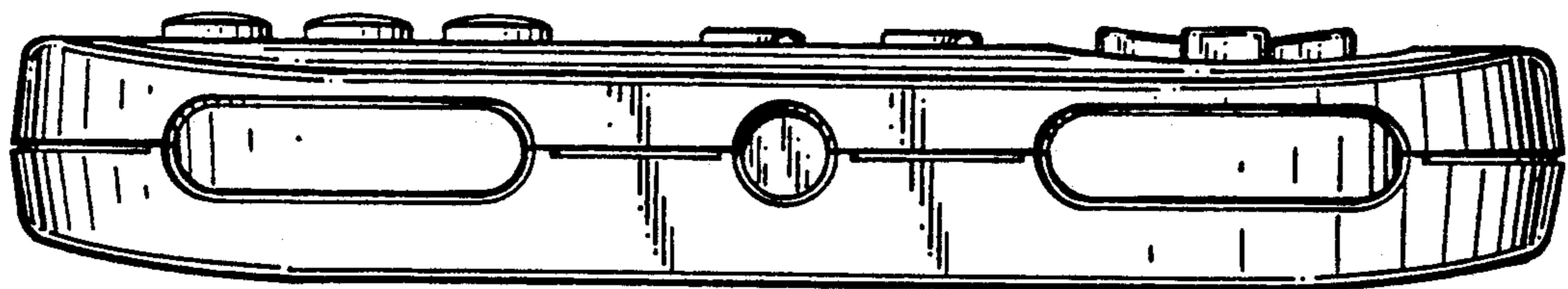

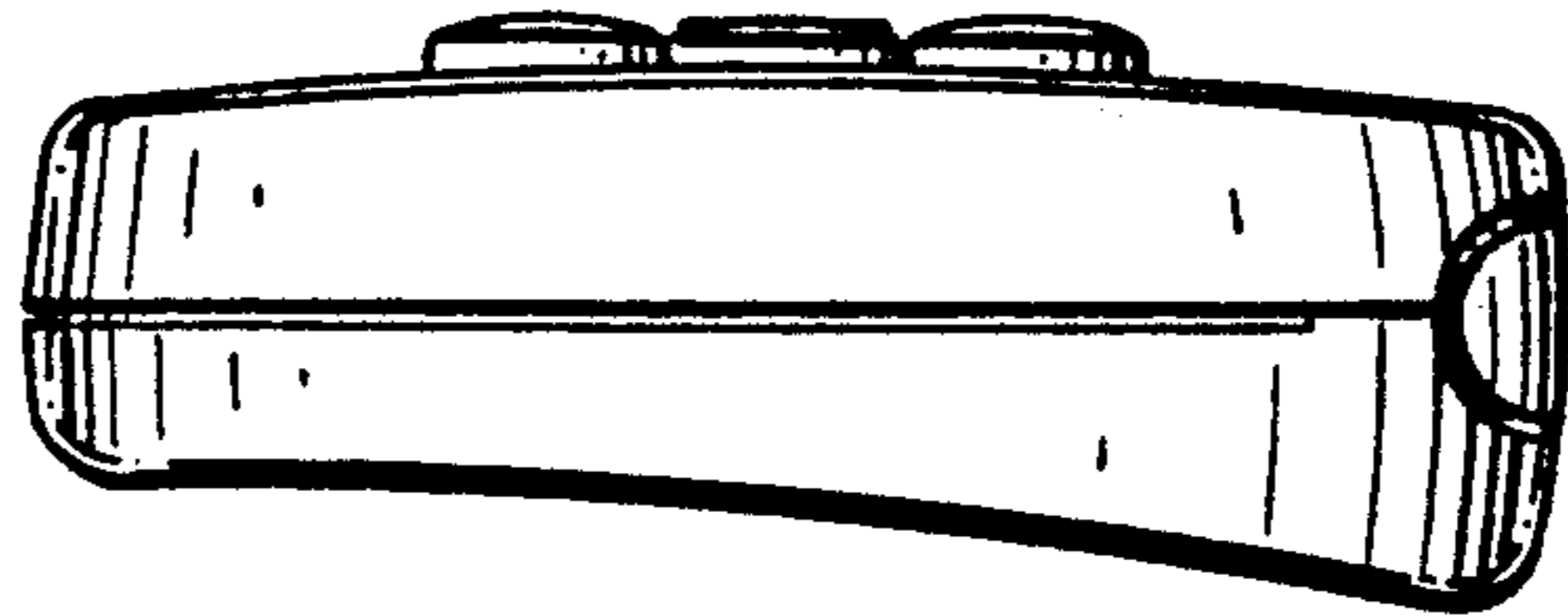

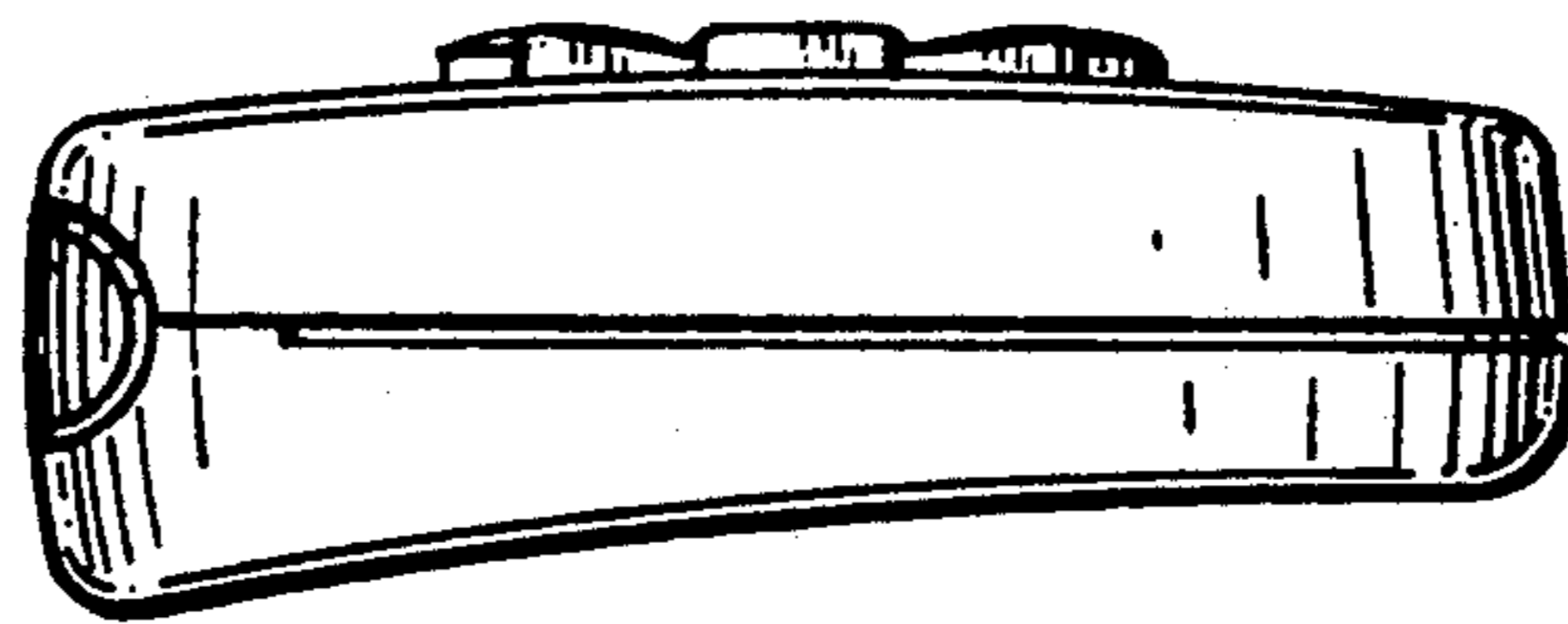

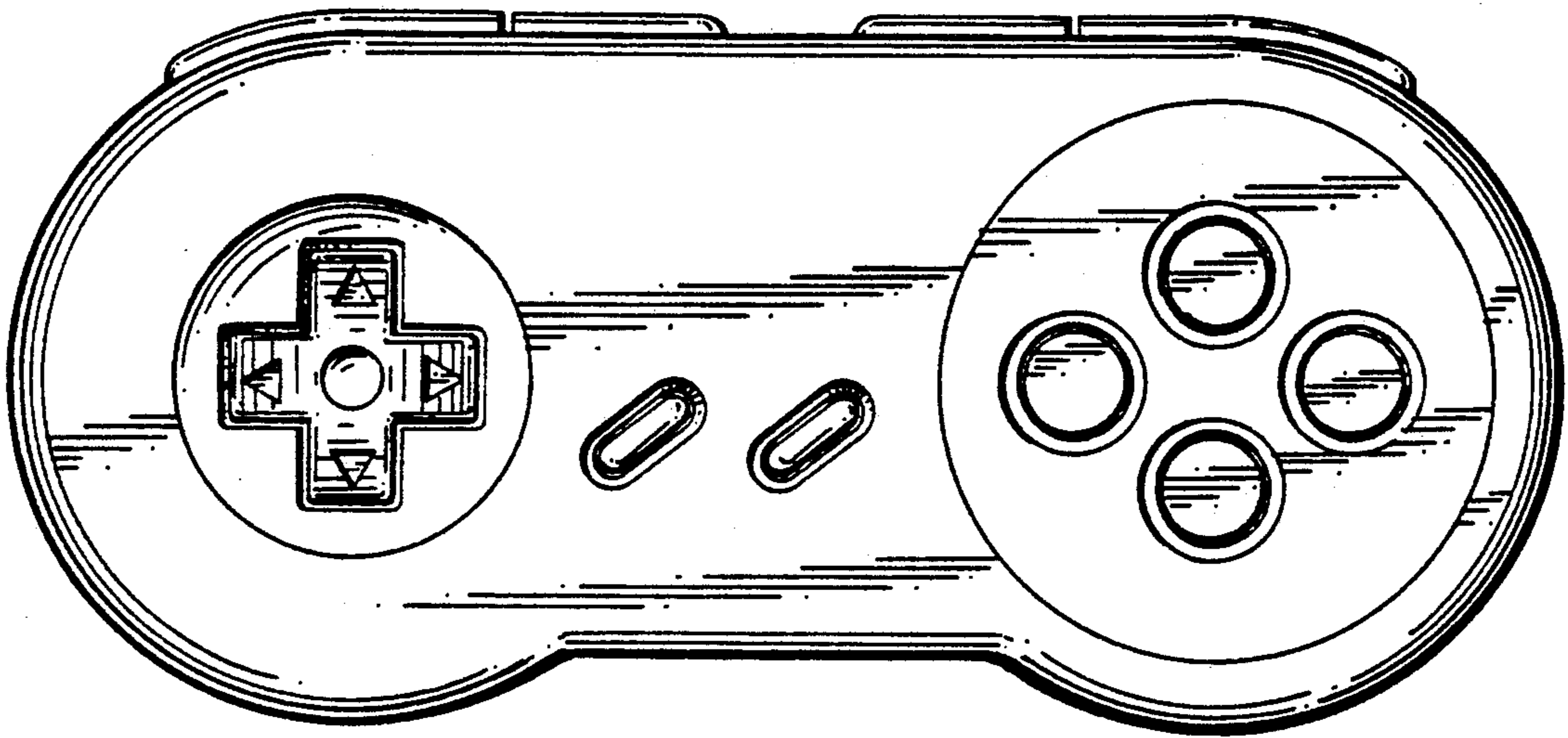

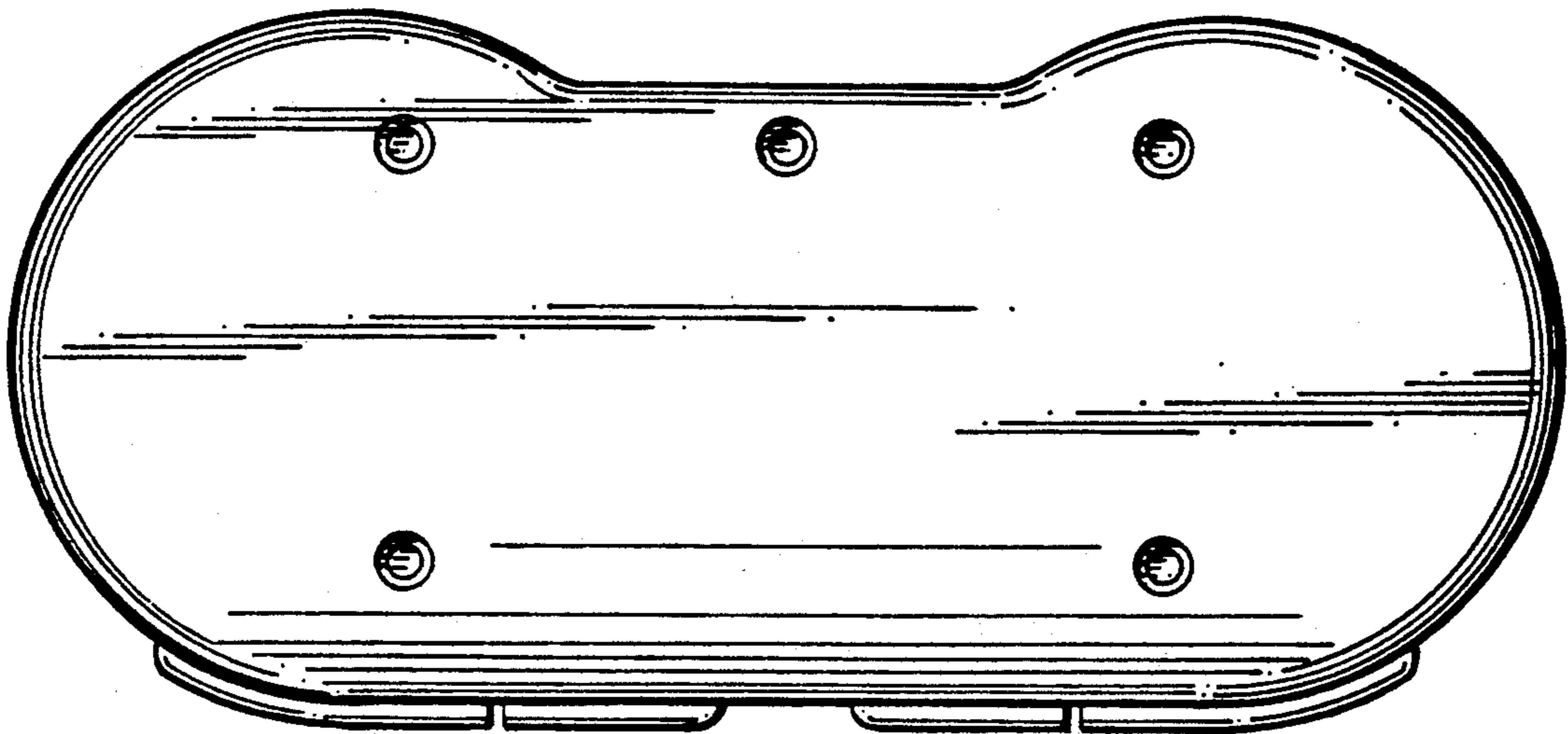

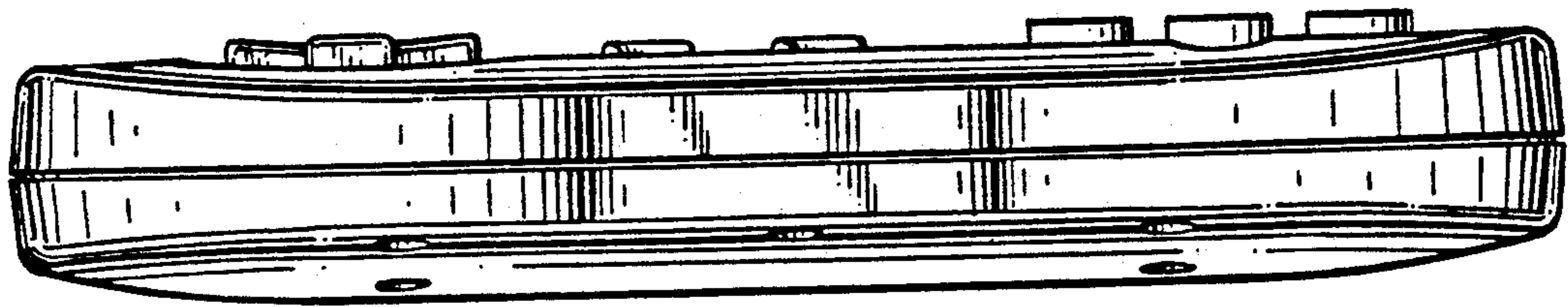

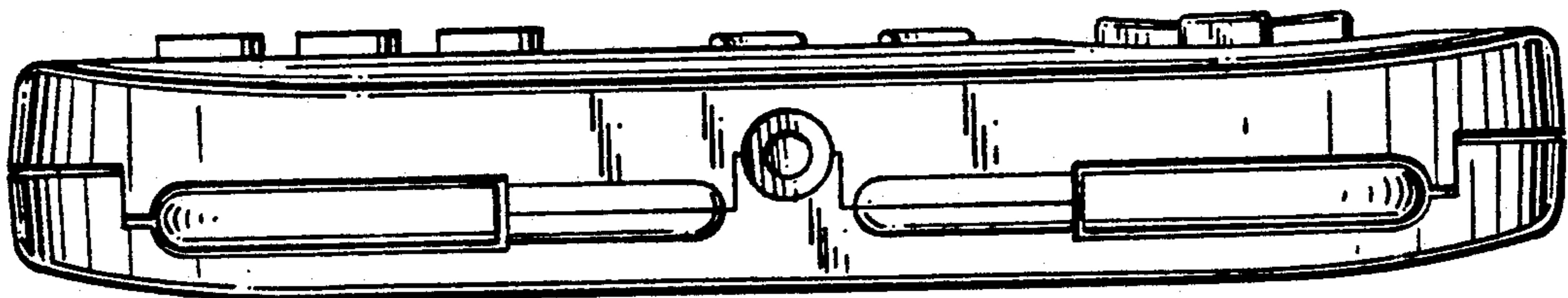

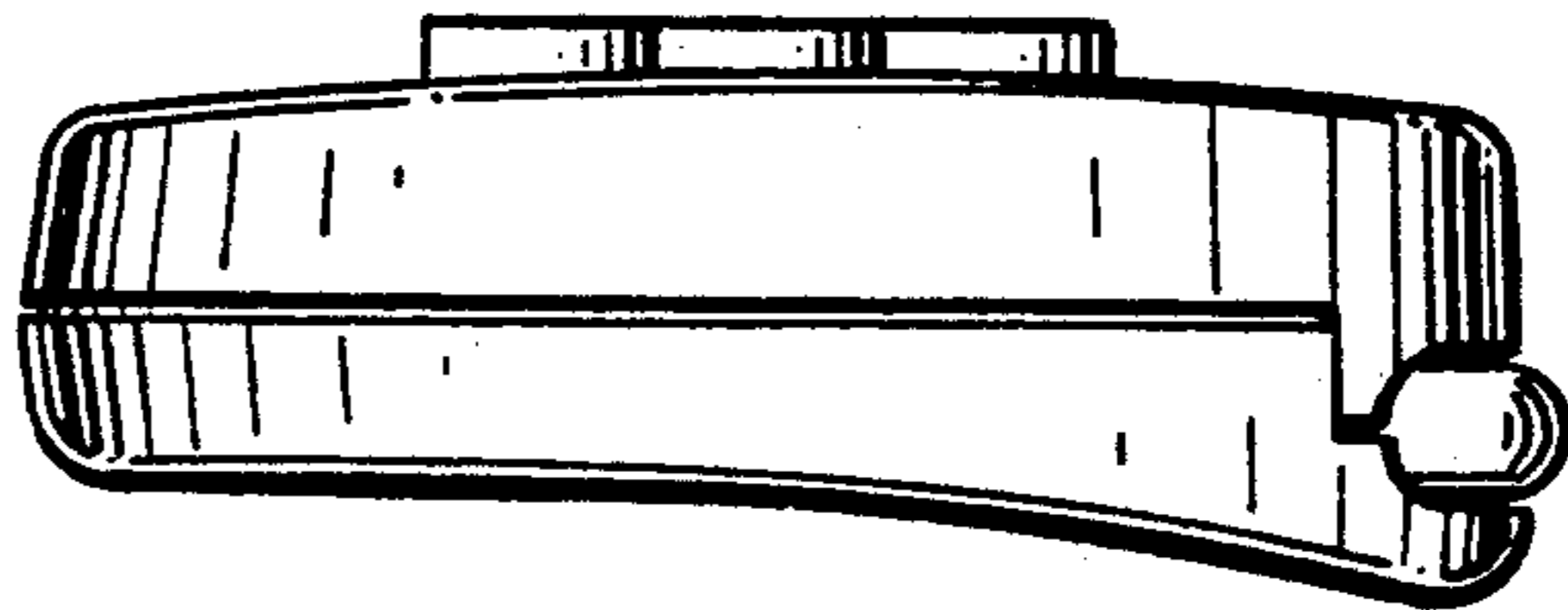

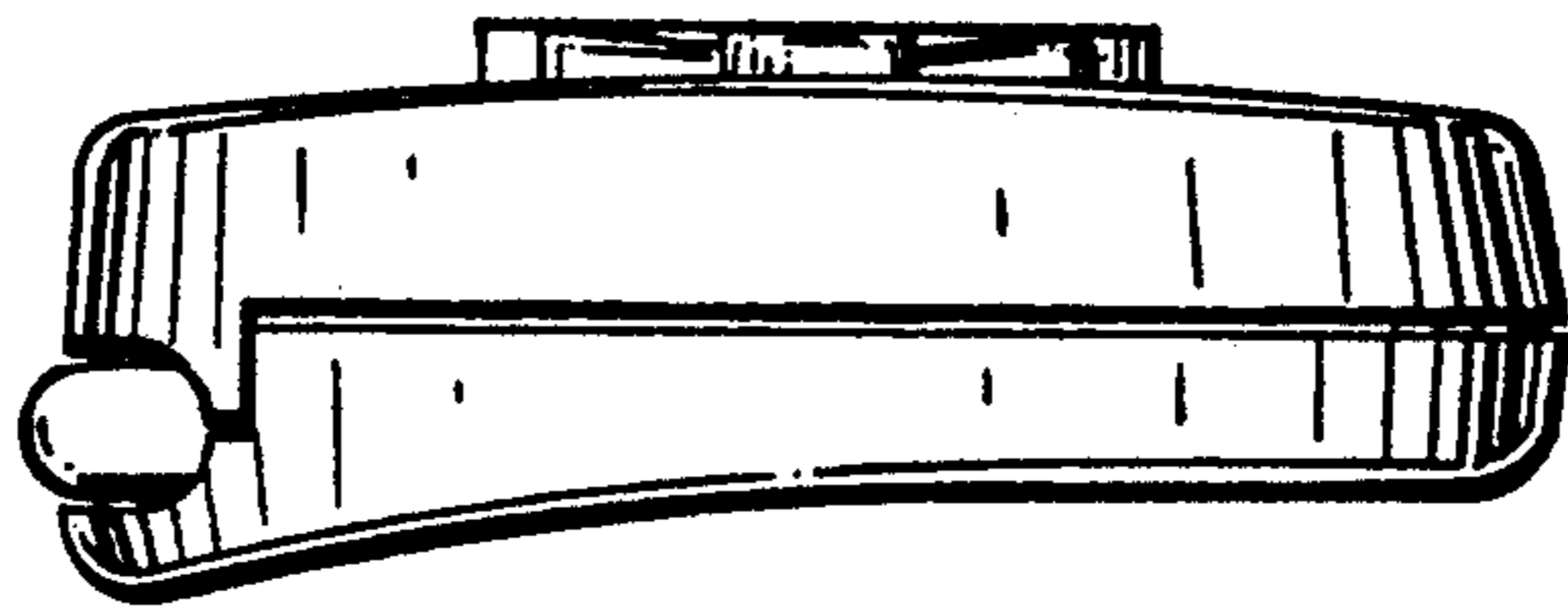

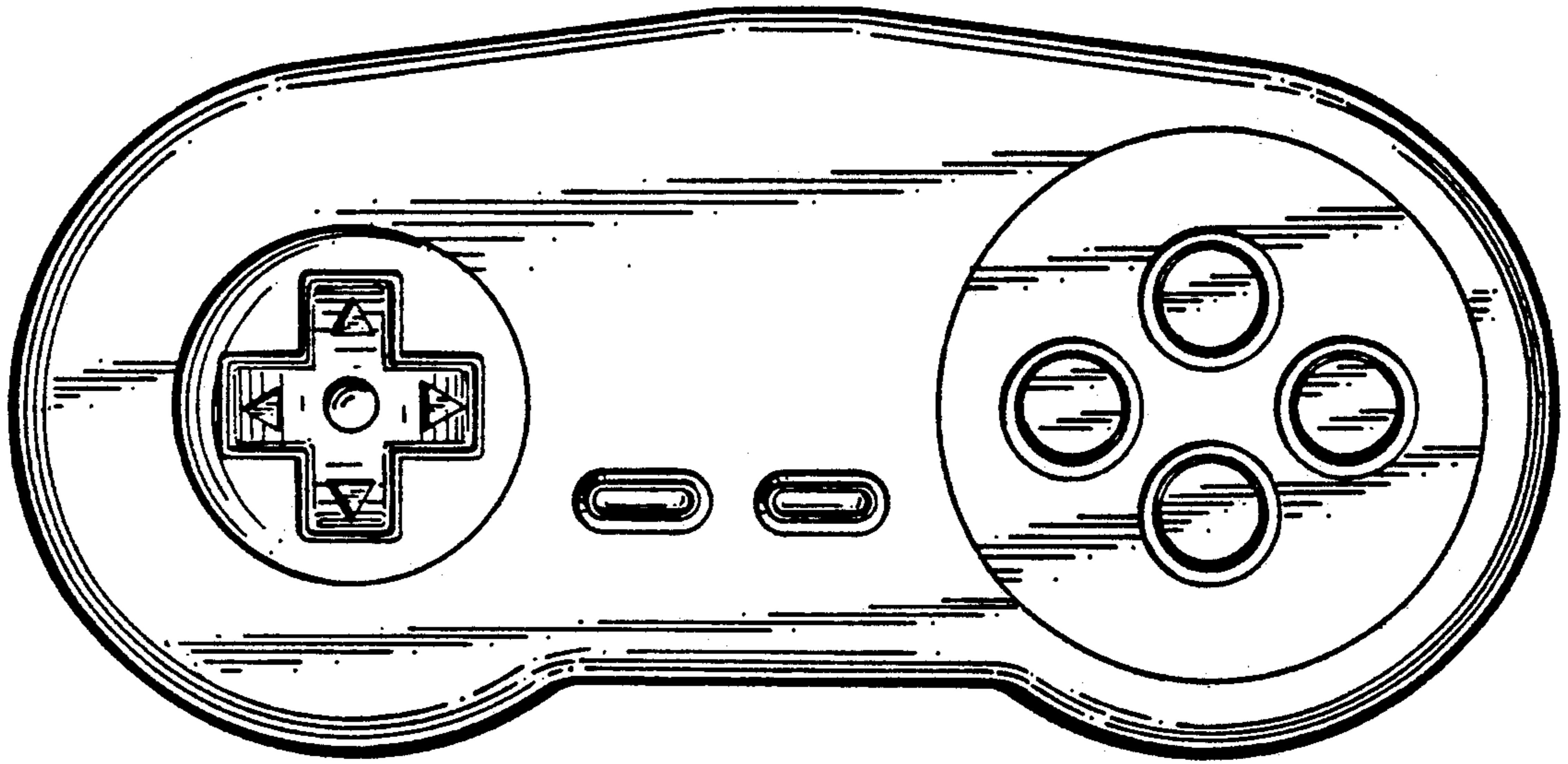

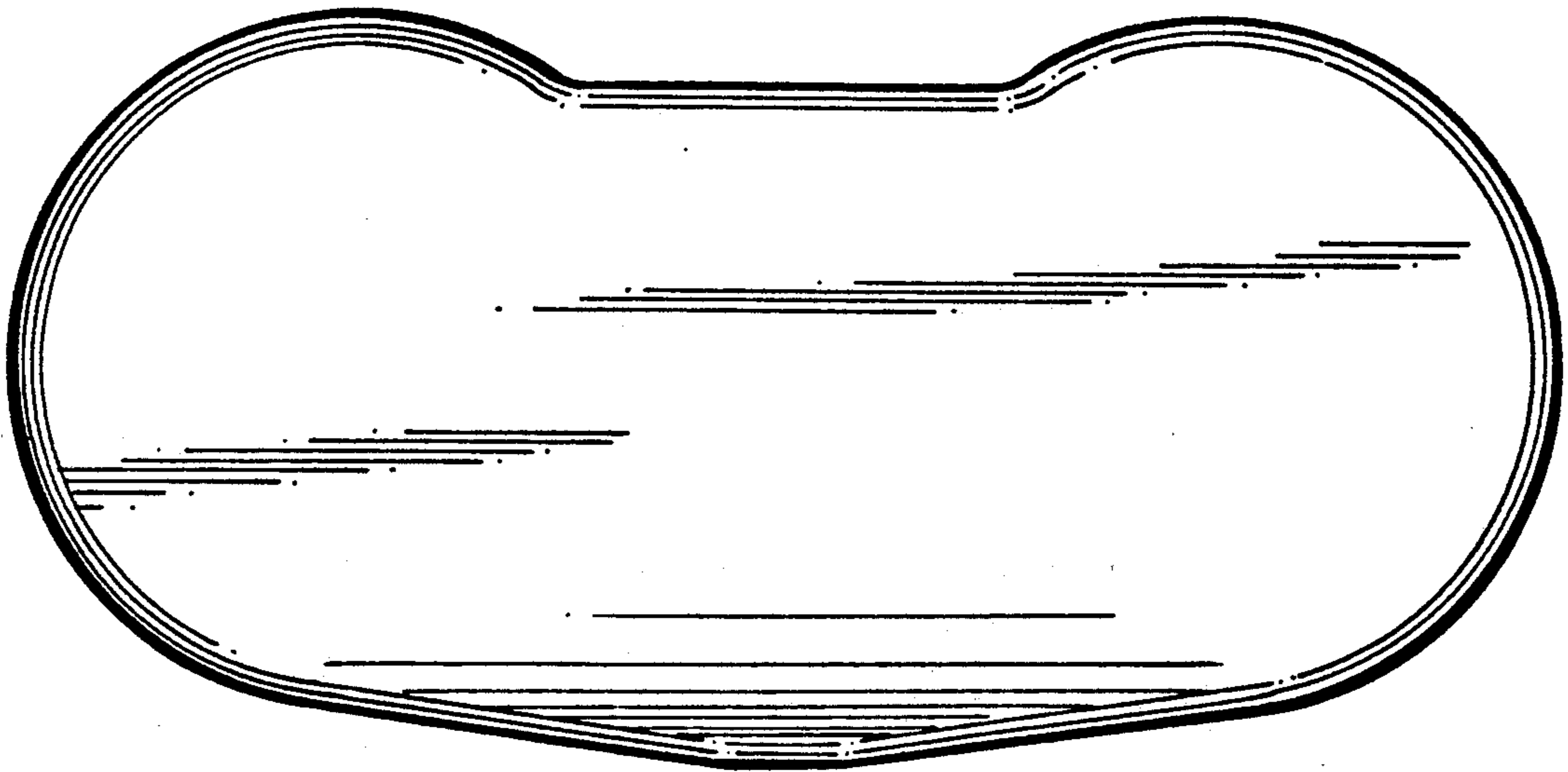

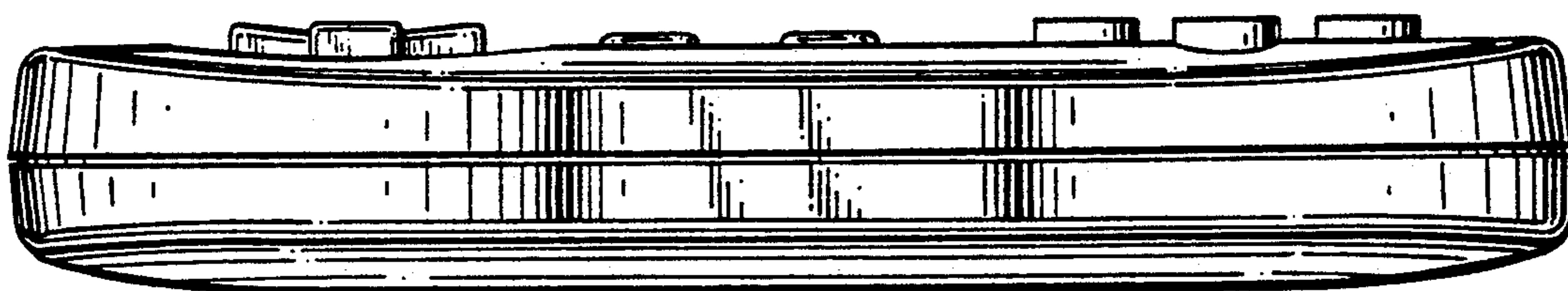

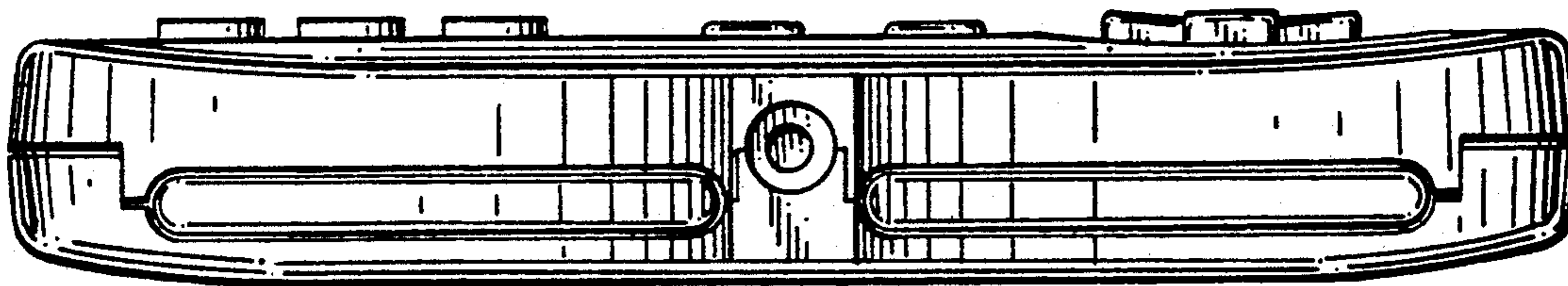

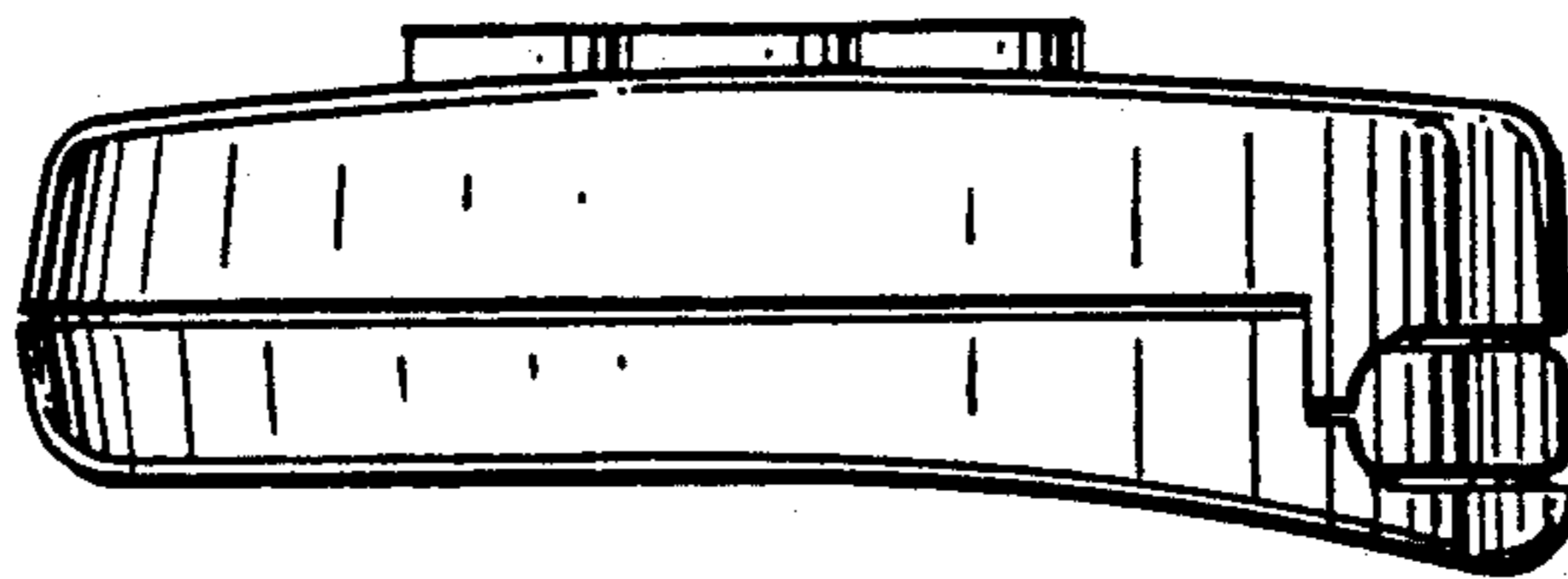

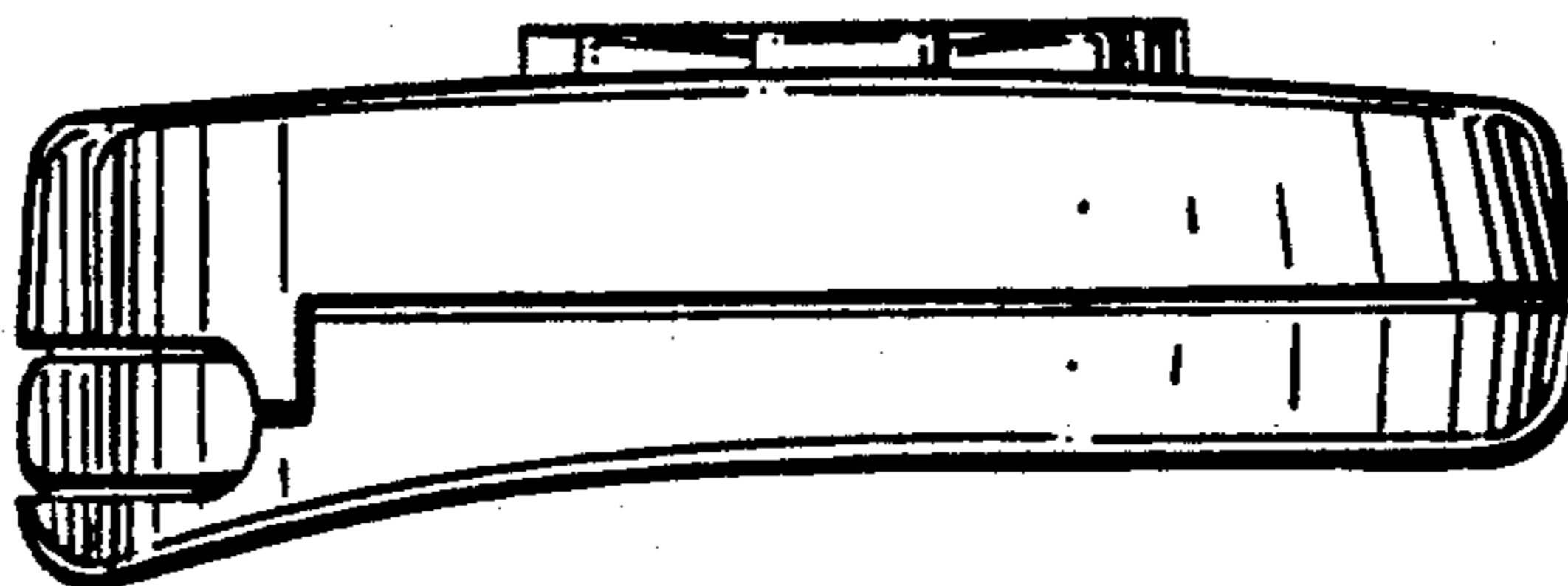

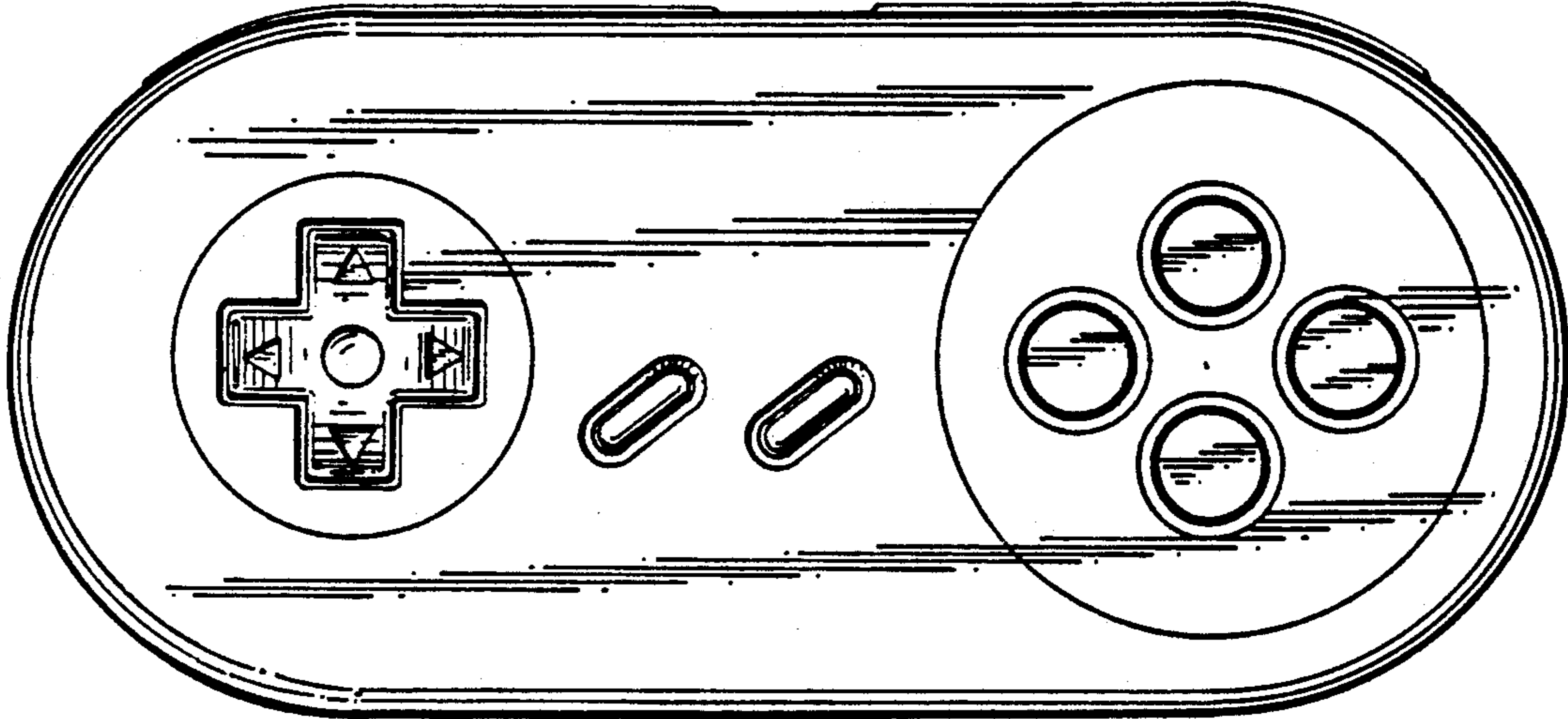

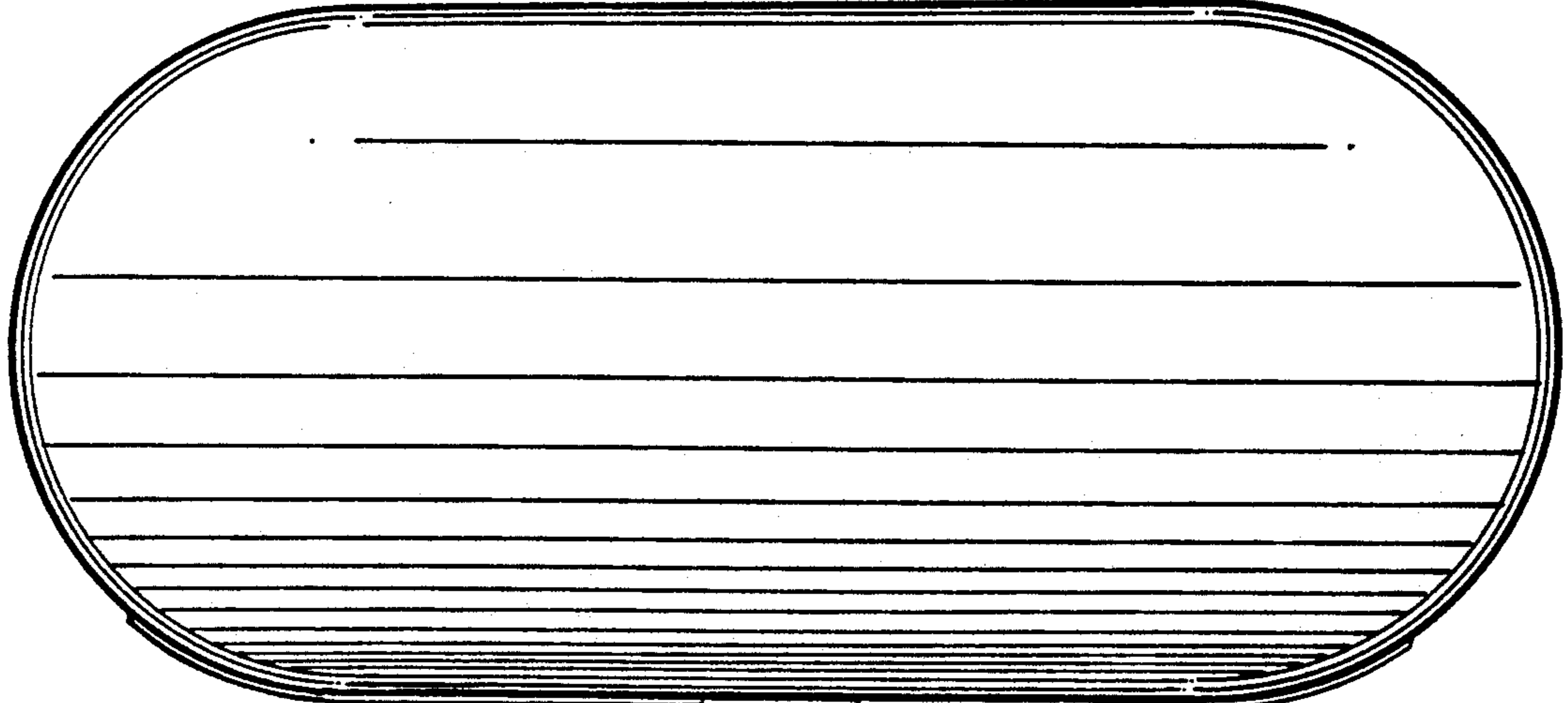

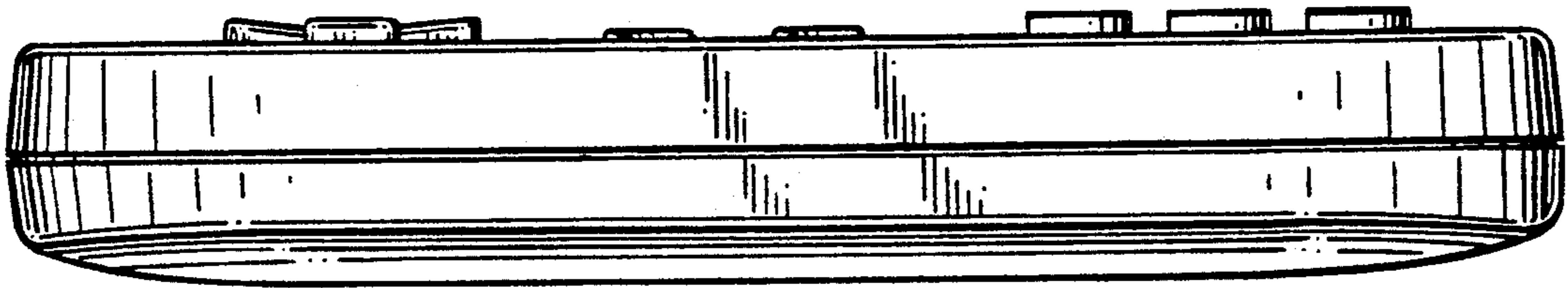

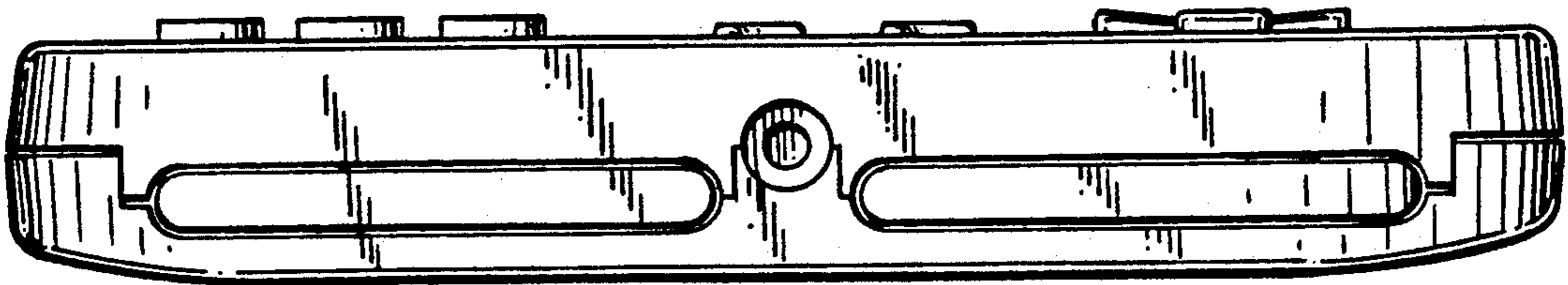

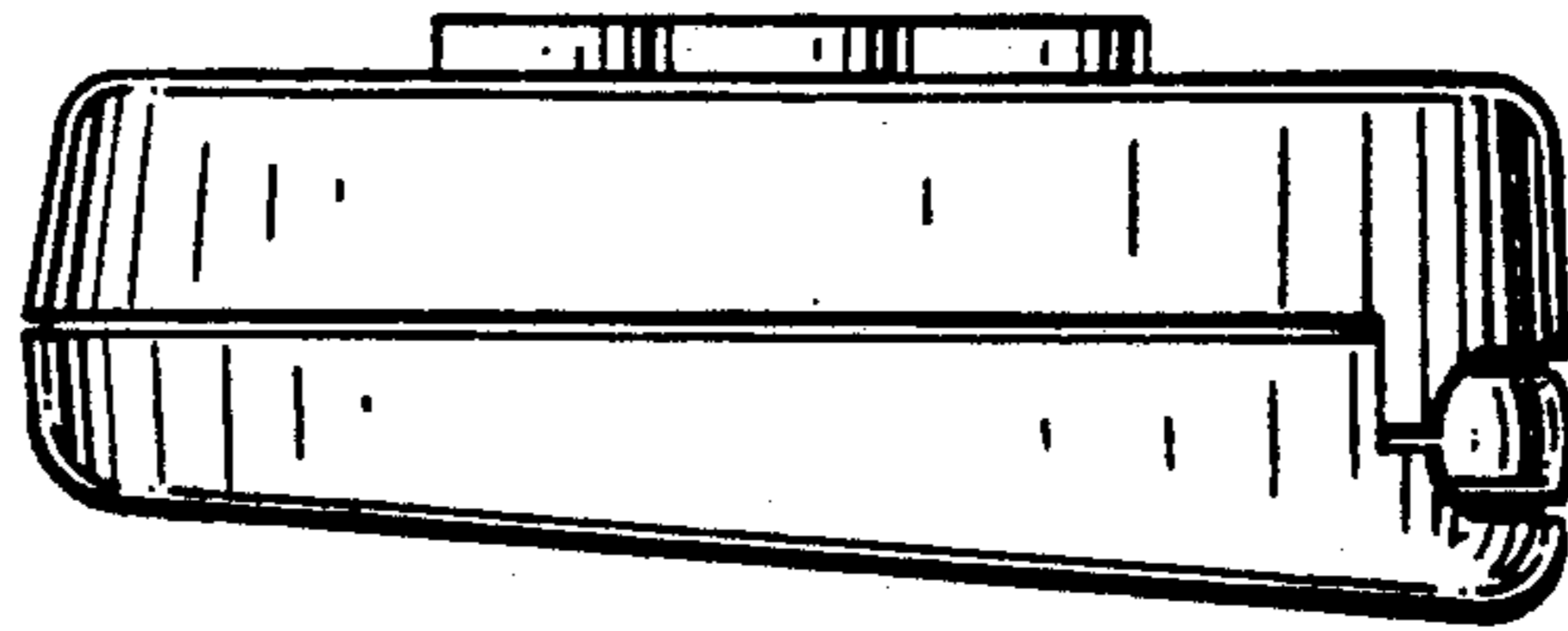

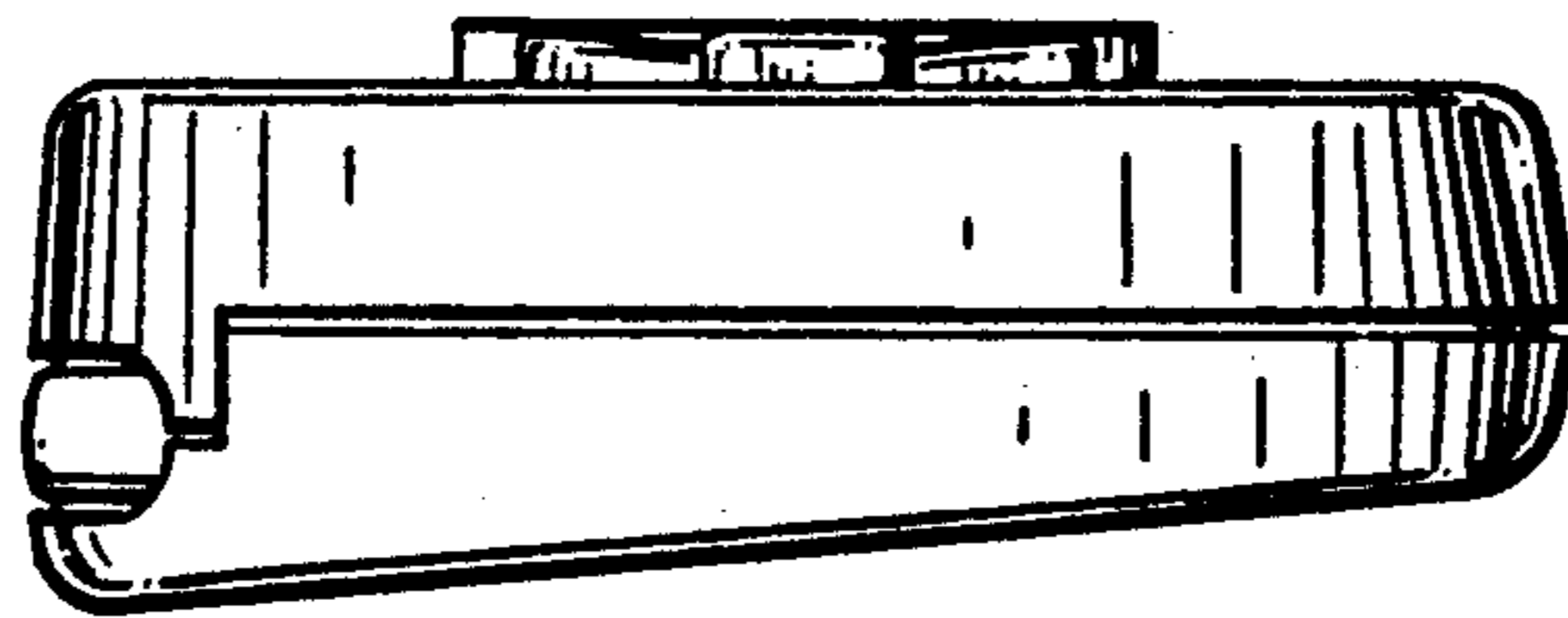

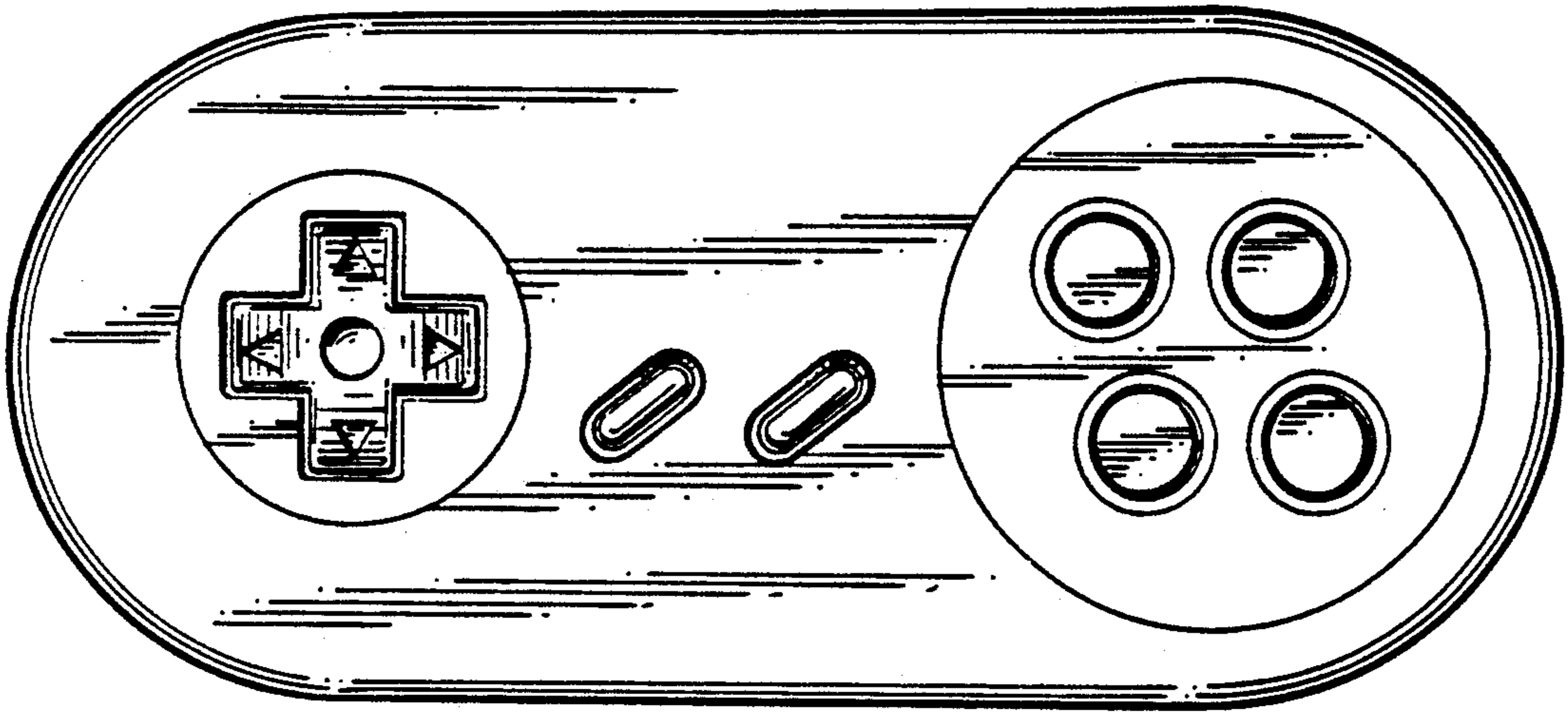

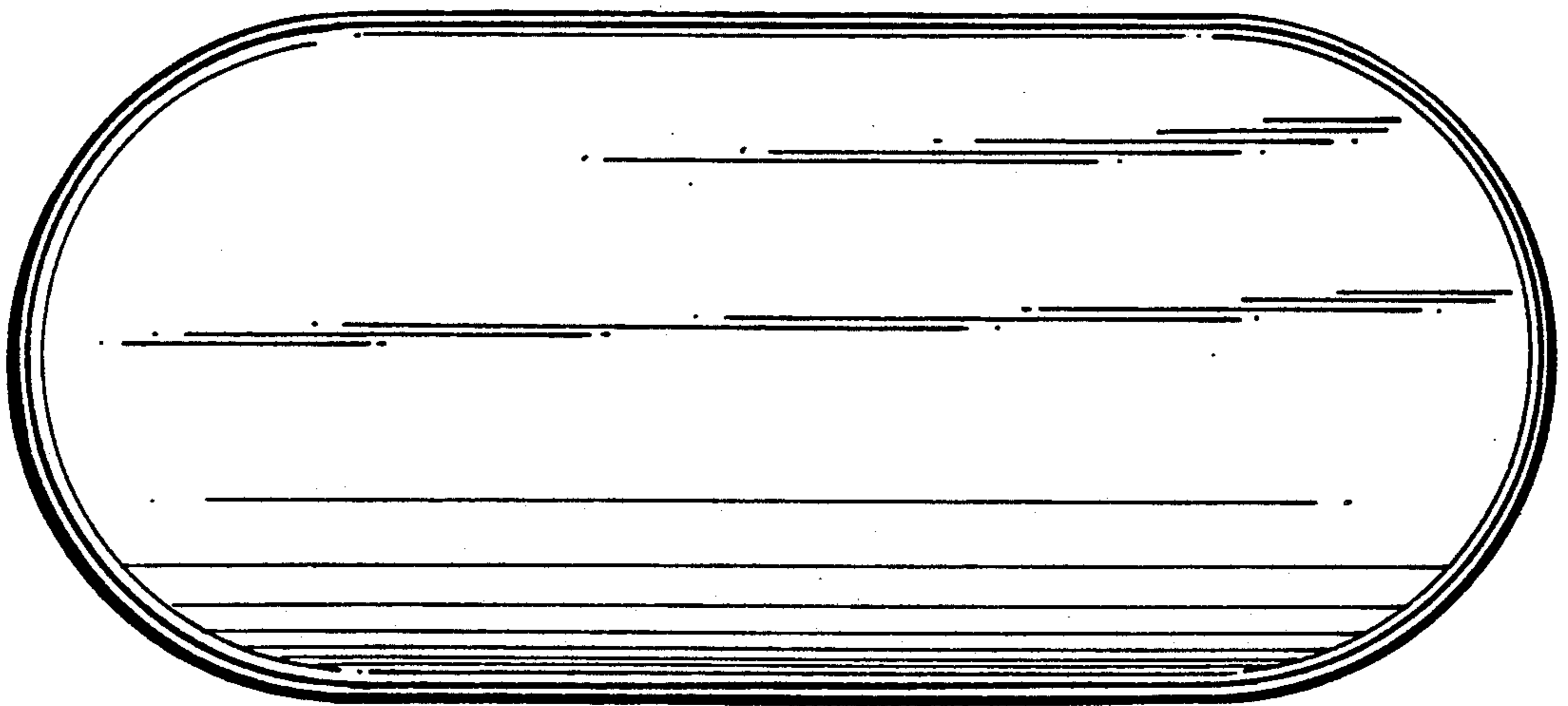

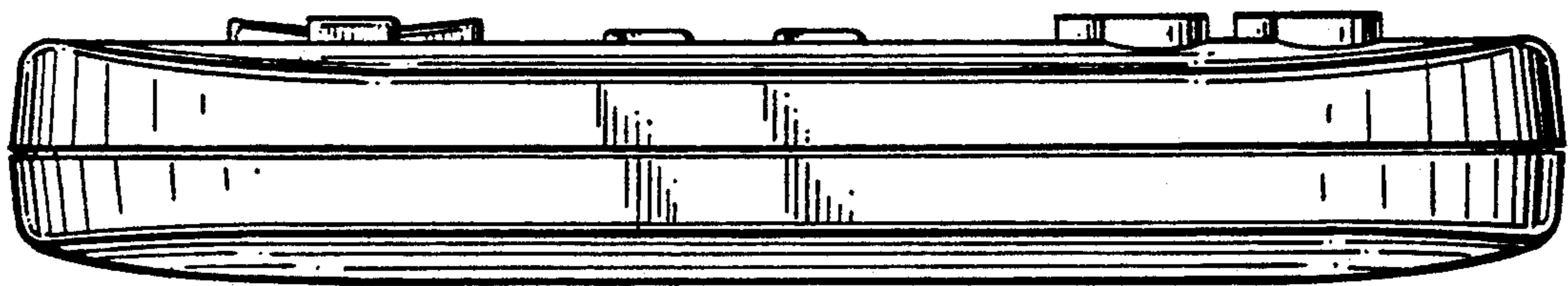

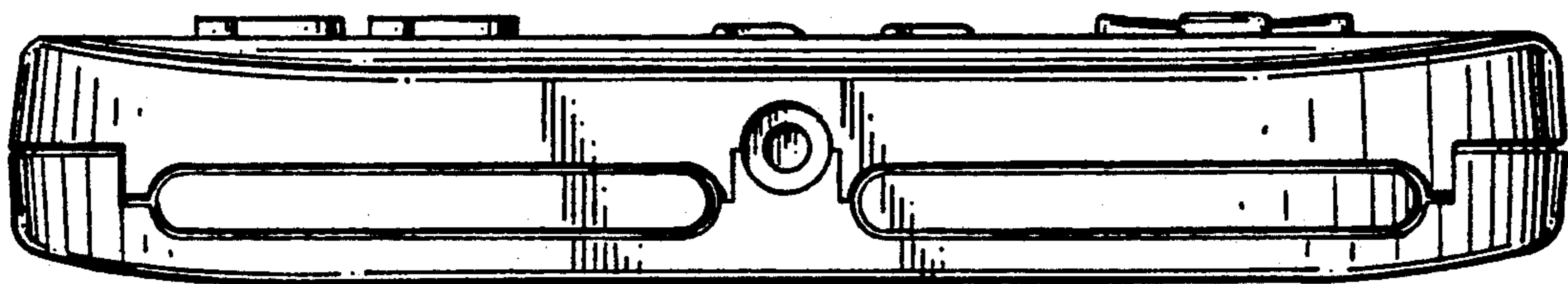

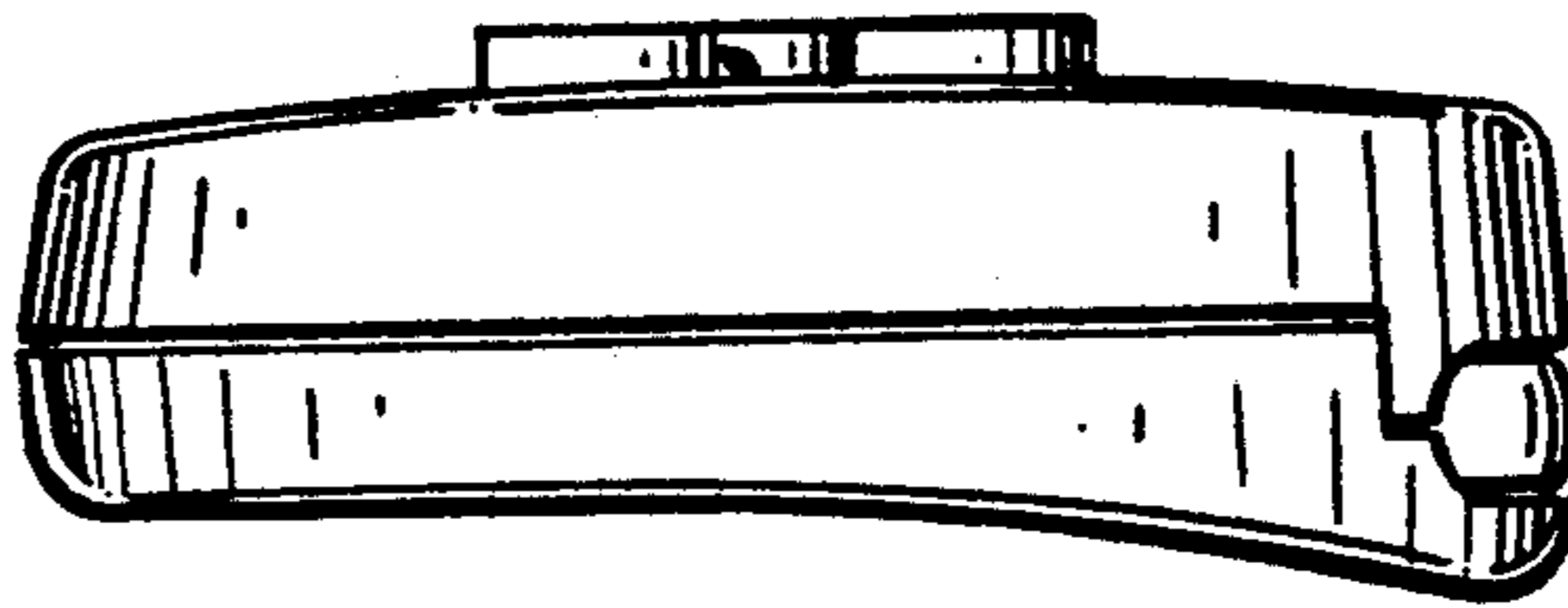

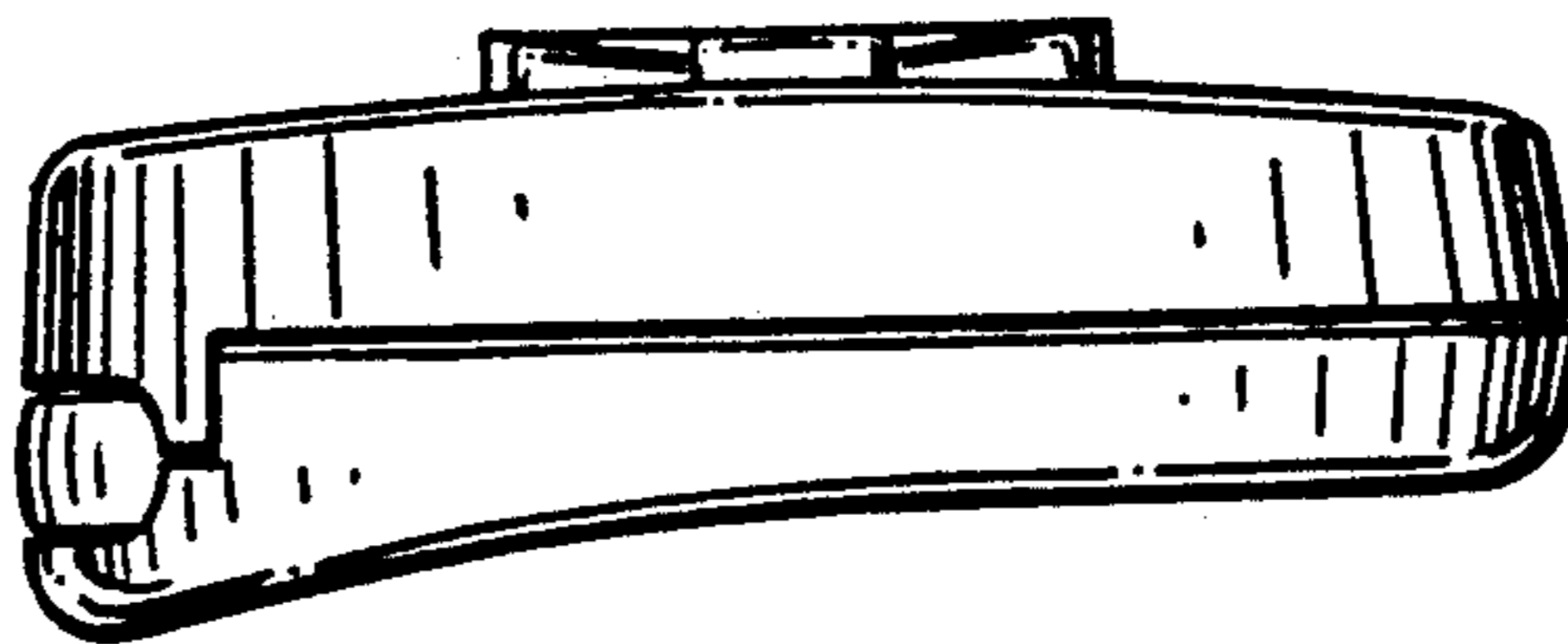

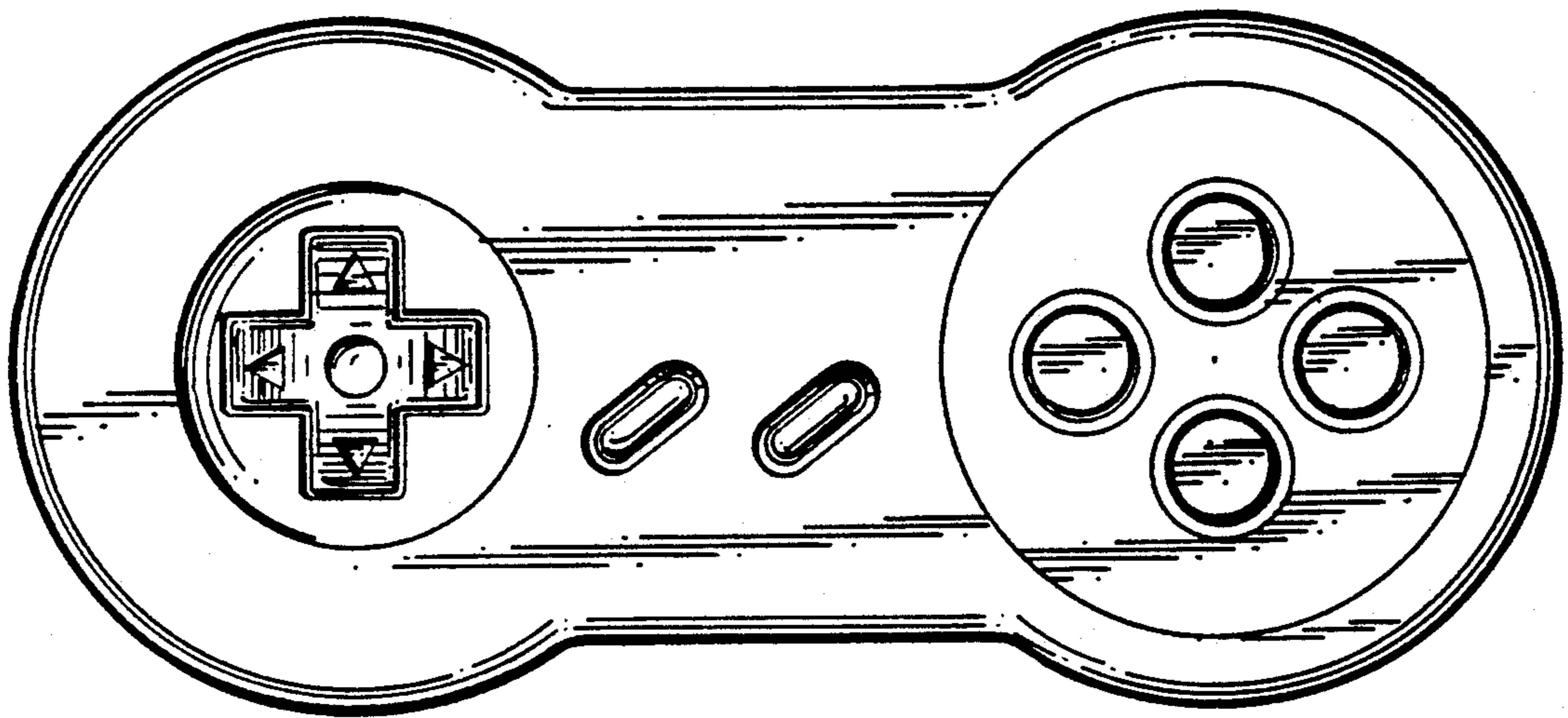

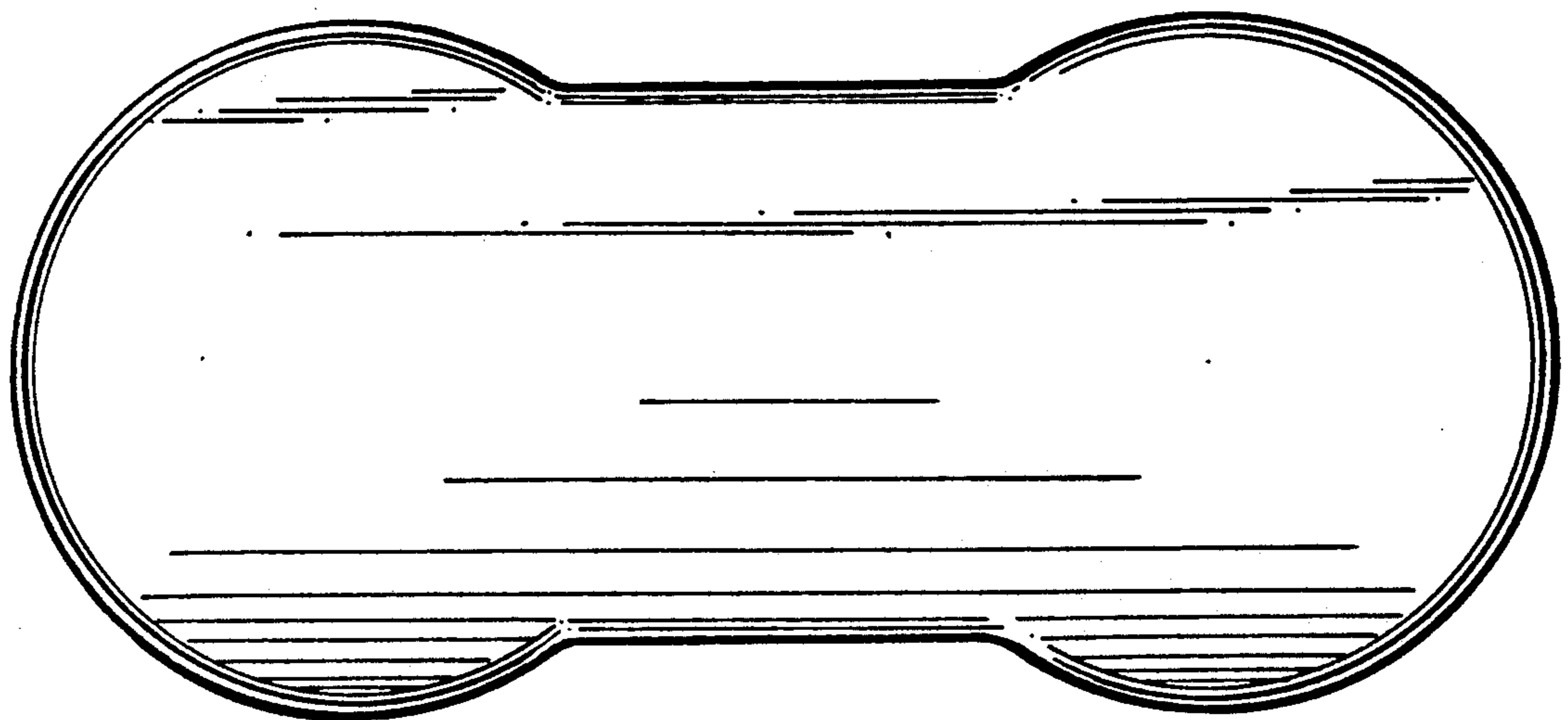

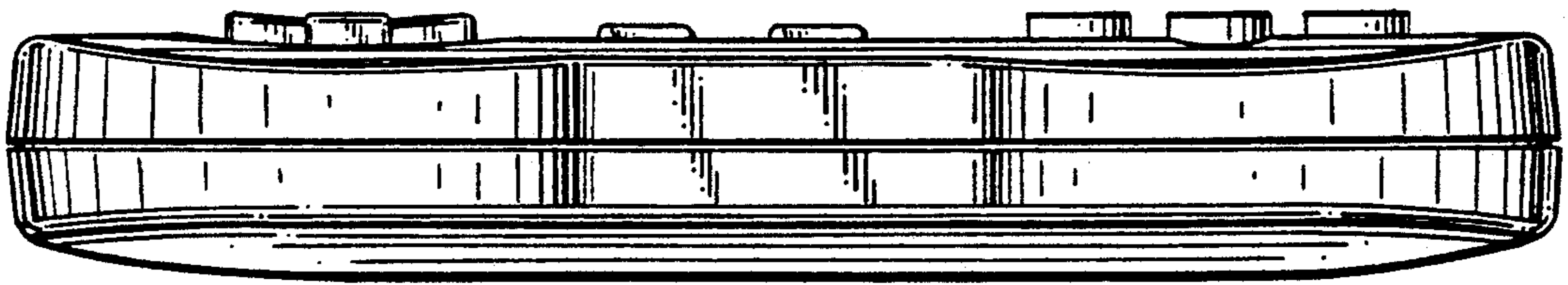

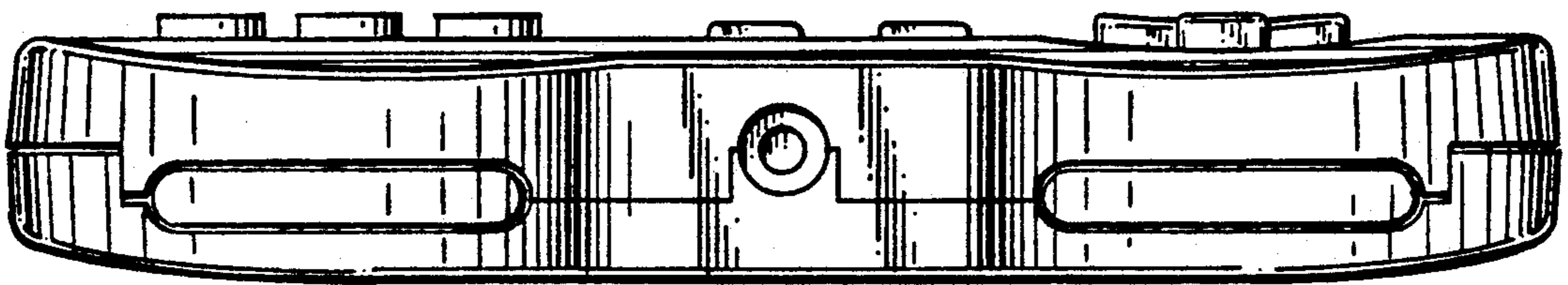

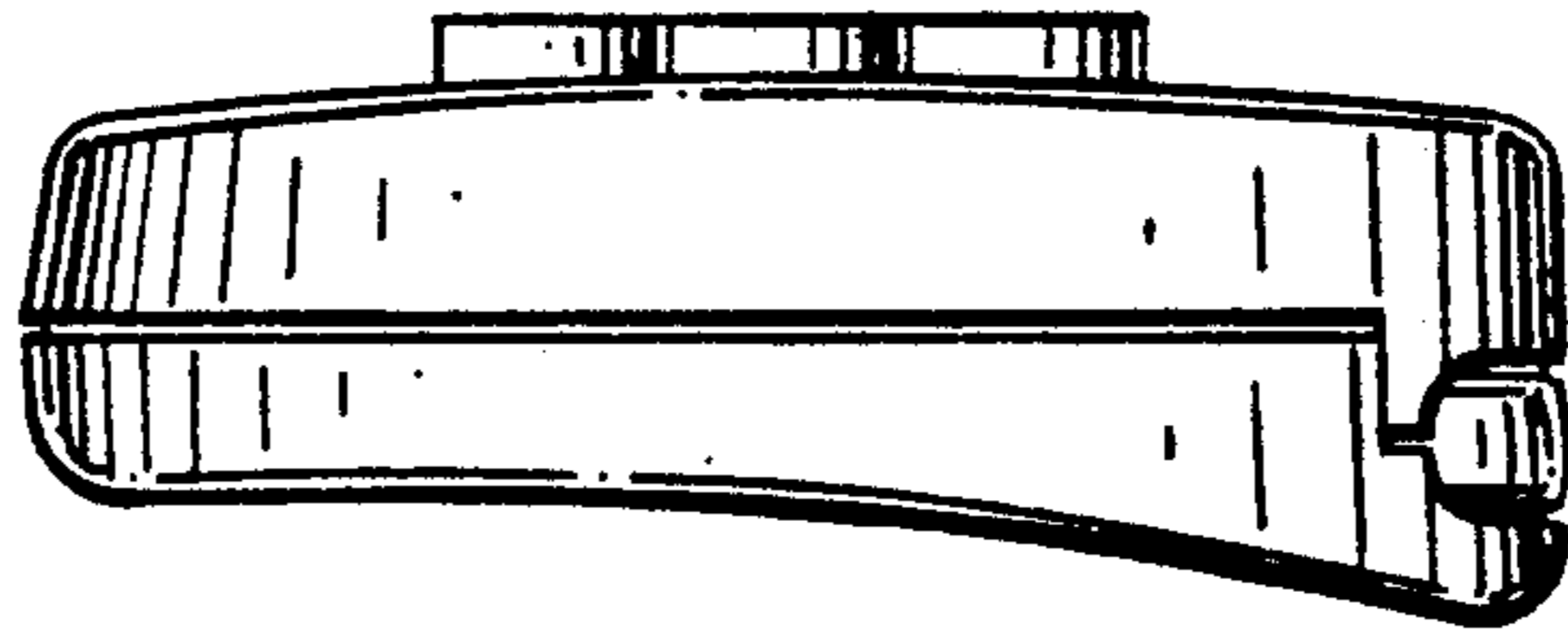

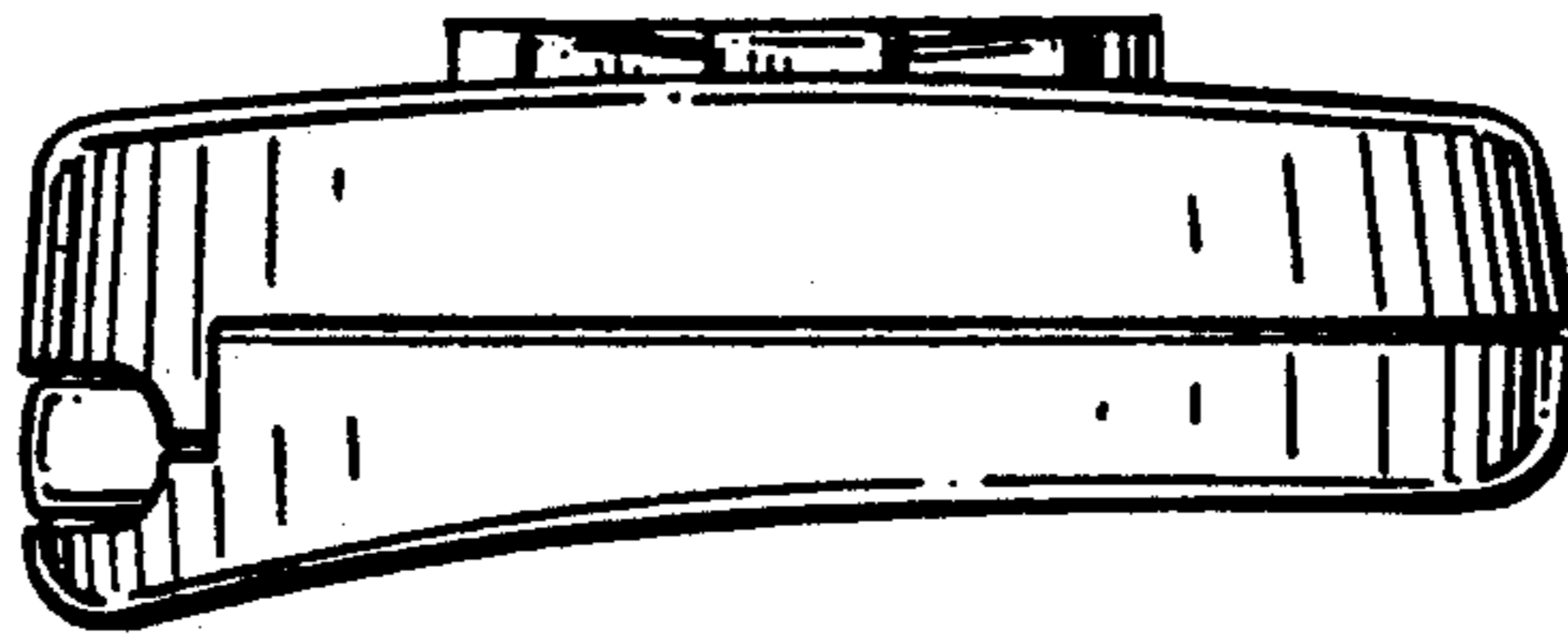

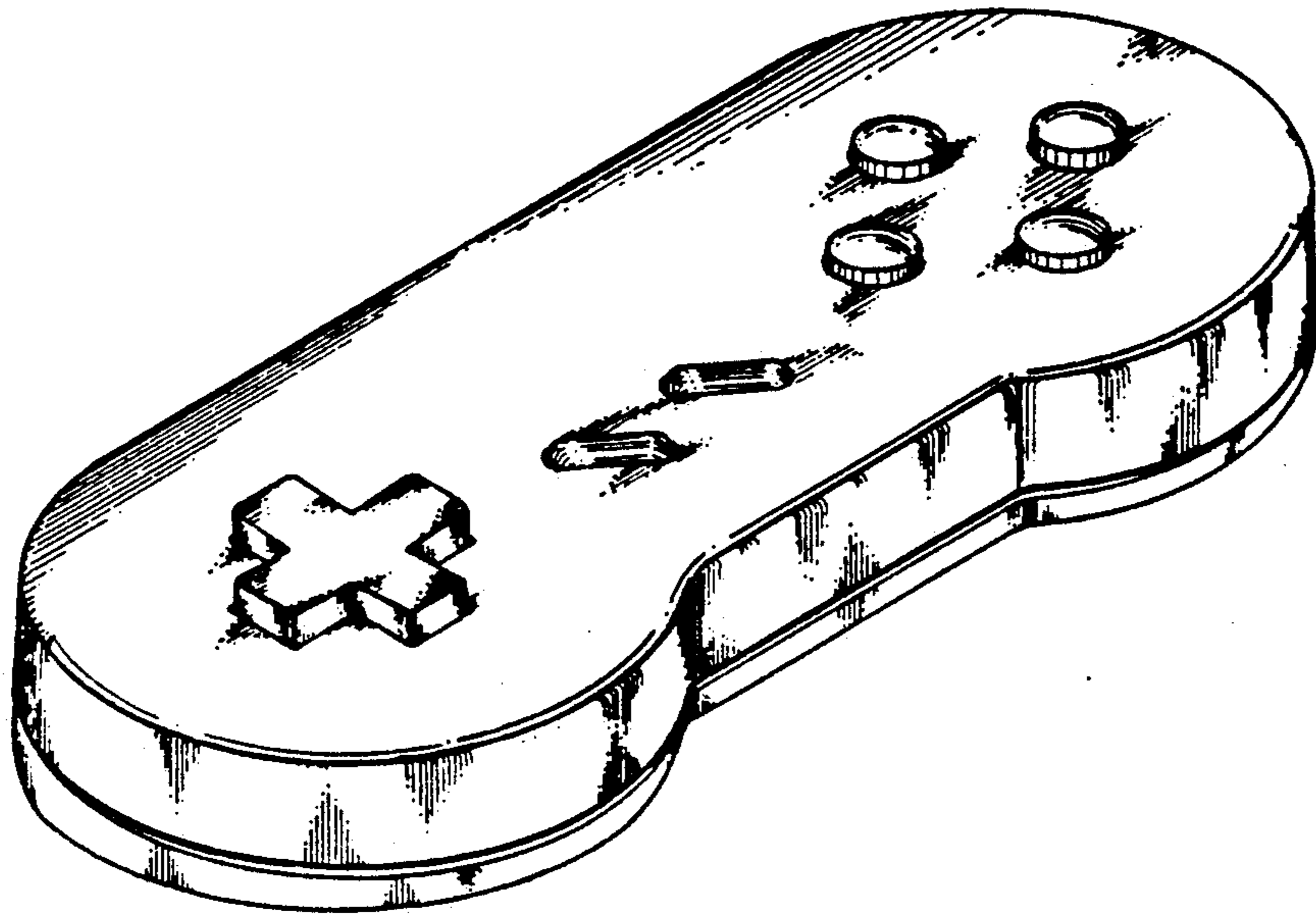

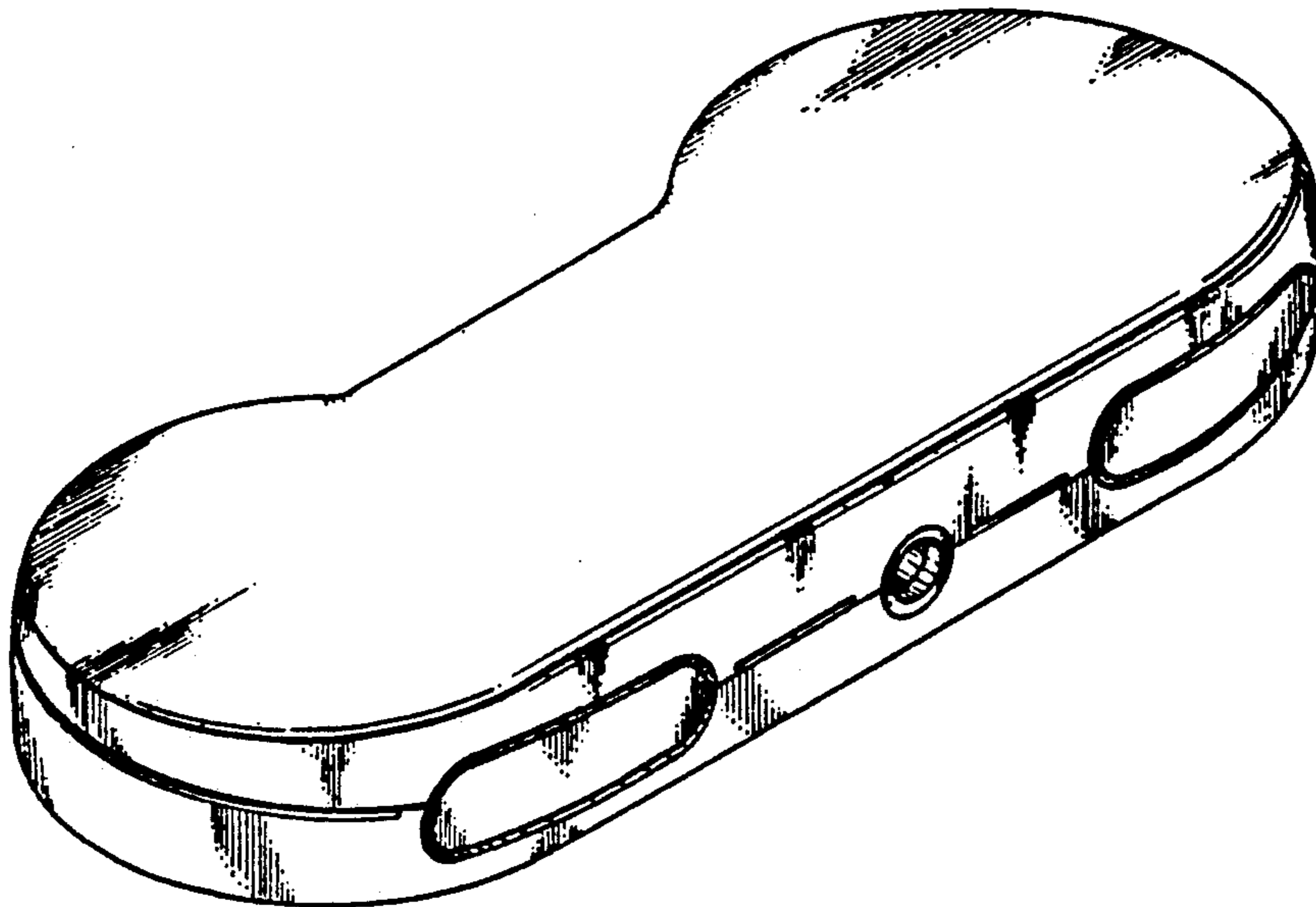

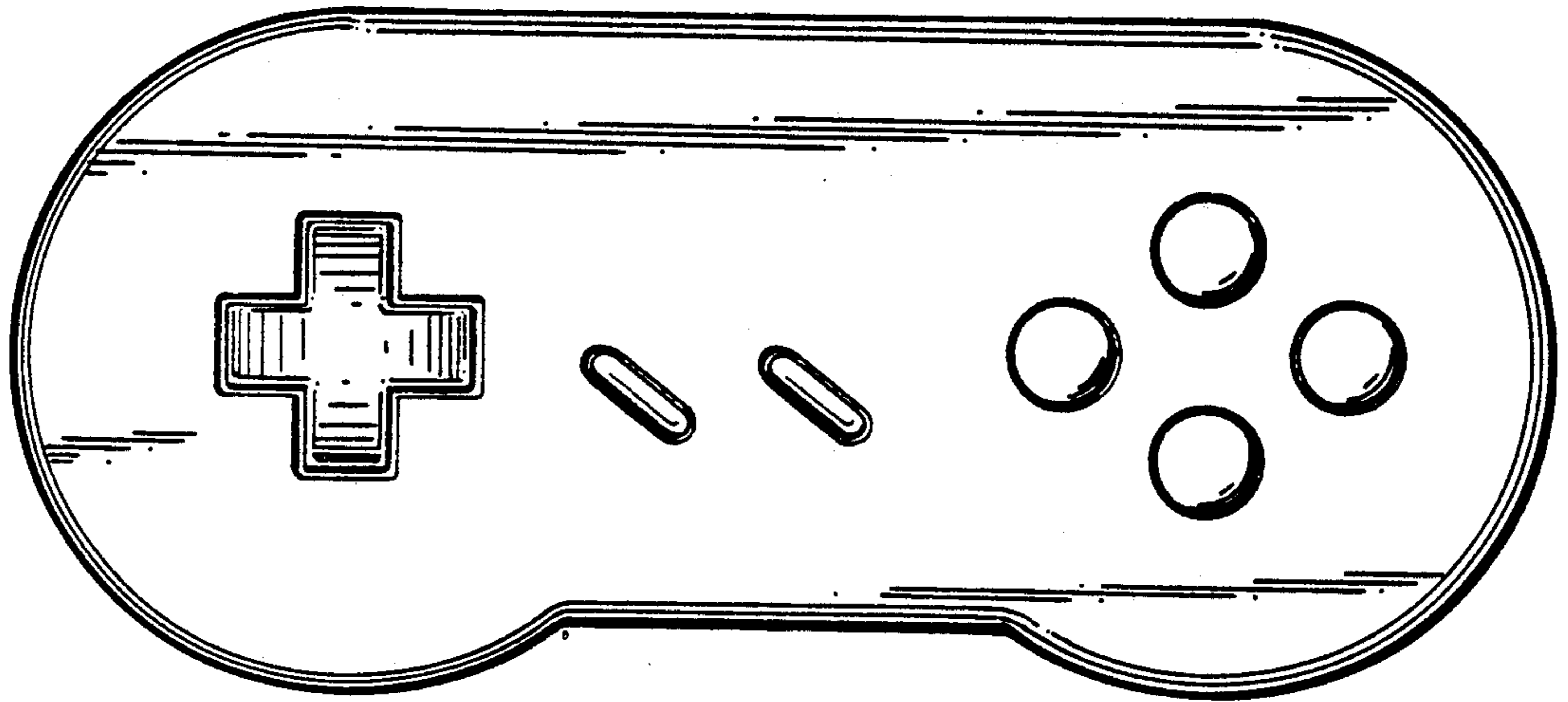

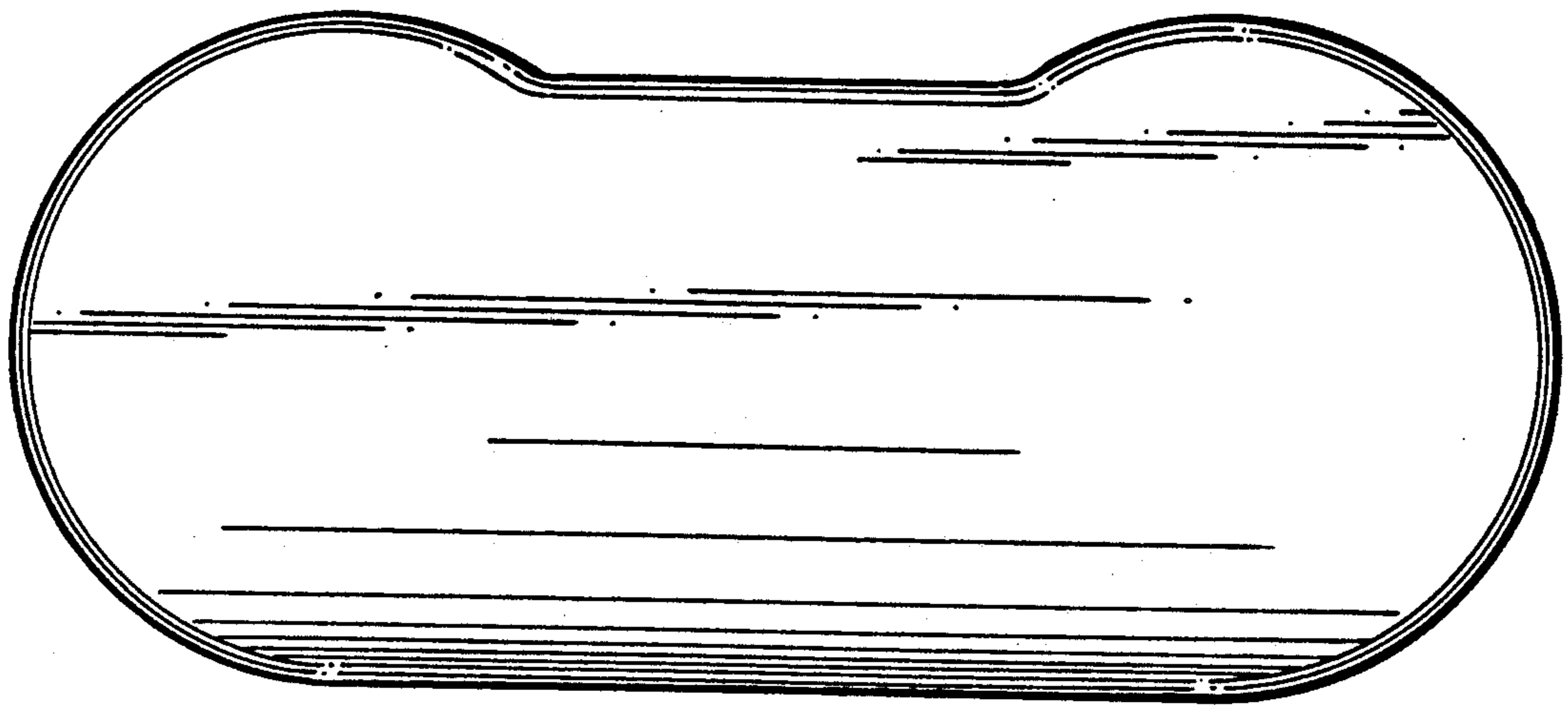

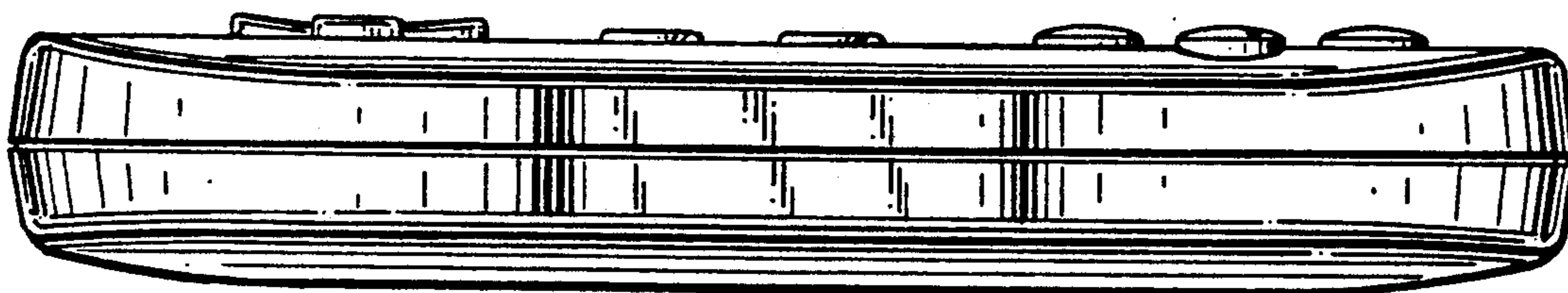
