[57] **CLAIM**

The ornamental design for a bidet, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view taken from the top and front of a bidet showing my new design;

FIG. 2 is another perspective view taken from the top and left side thereof;

Fig. 3 is a top plan view thereof;

FIG. 4 is a right side elevational view thereof, the left side being the mirror image of the right side shown;

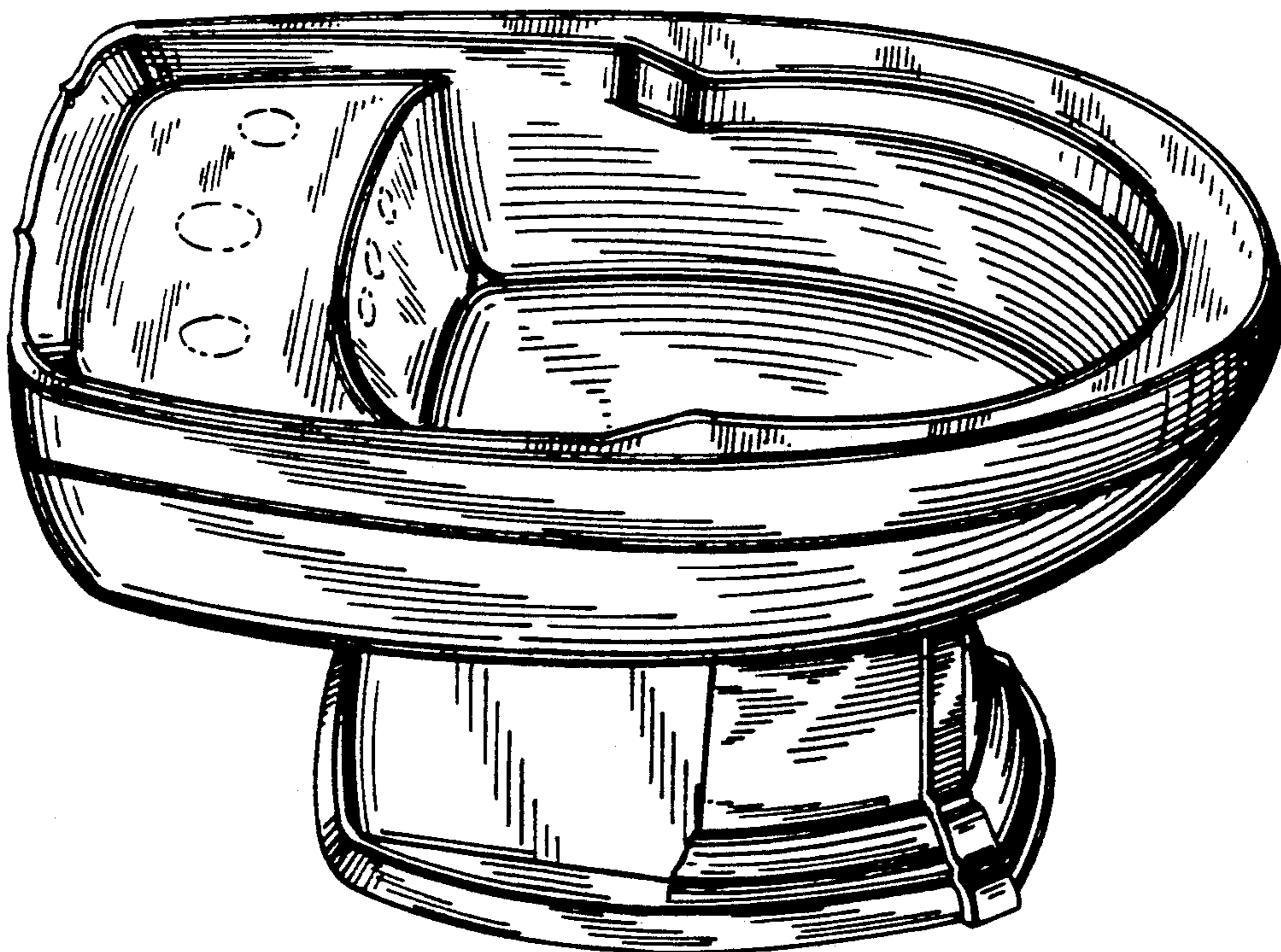
FIG. 5 is a front elevational view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a cross-sectional view taken on line 7—7 of FIG. 3; and,

FIG. 8 is a cross-sectional view taken on line 8—8 of FIG. 3.

The fragmentary broken line representations of holes in FIGS. 1-3 and 8 are for the purpose of illustration only and forms no part of the claimed design.



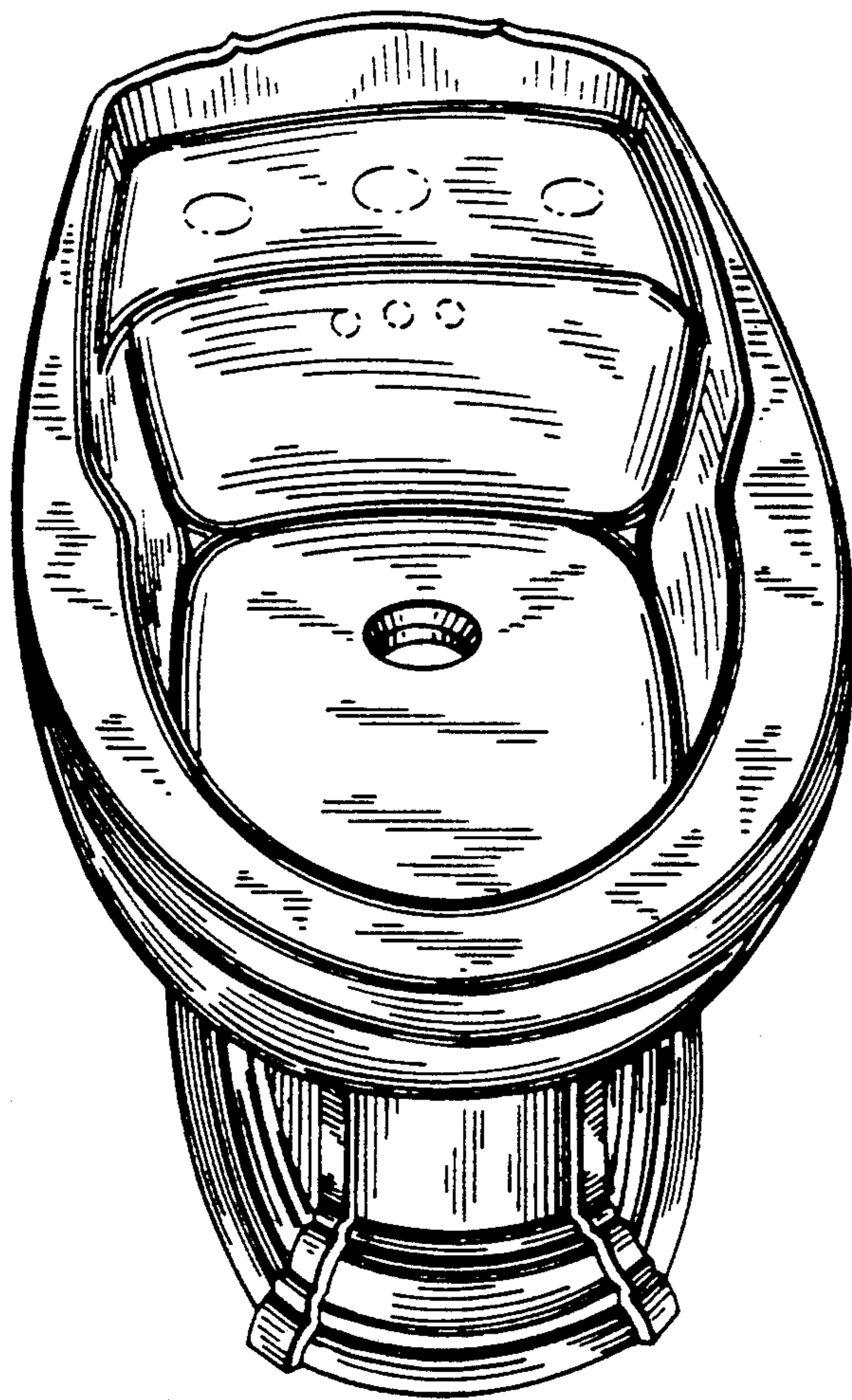

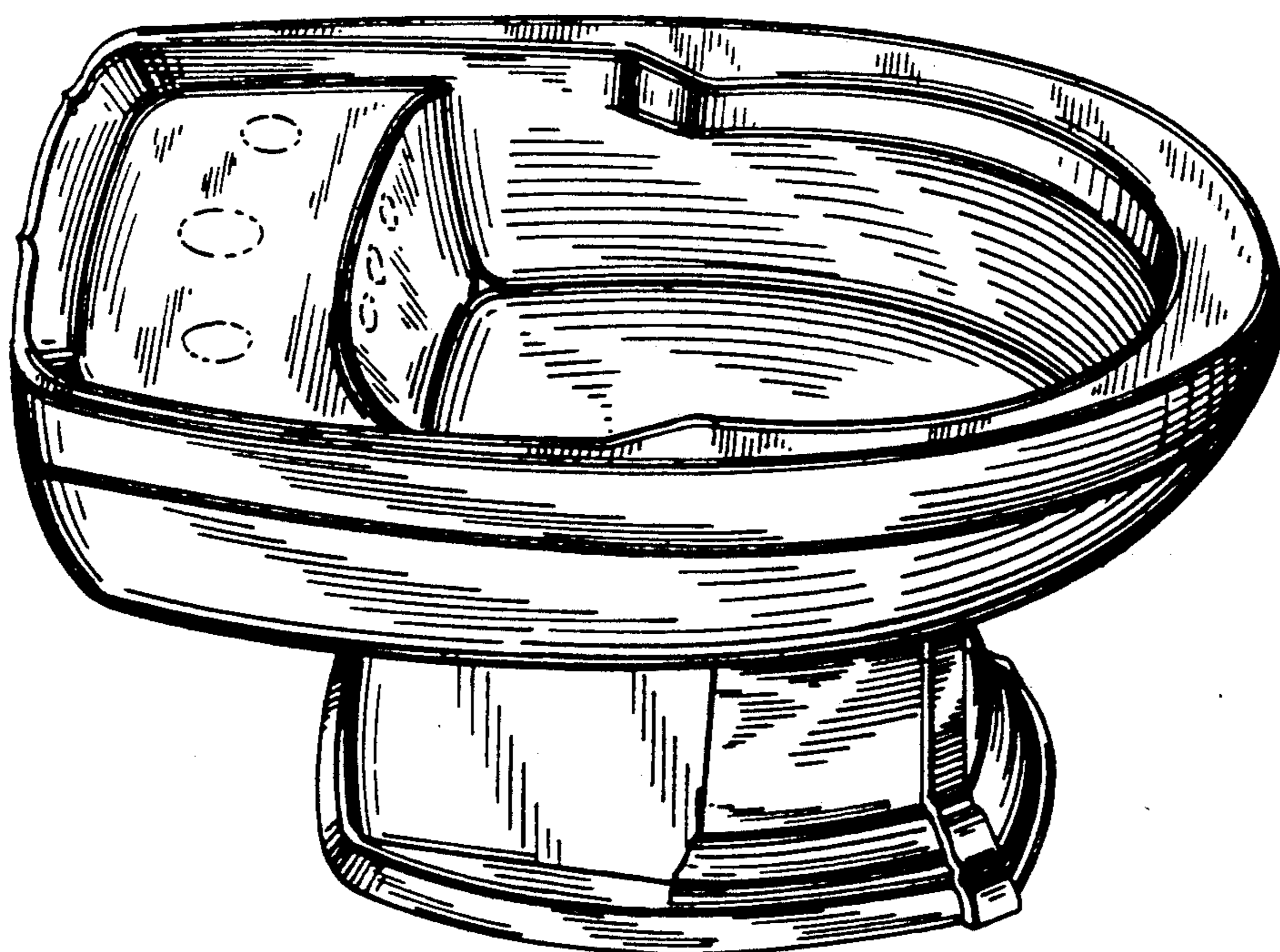

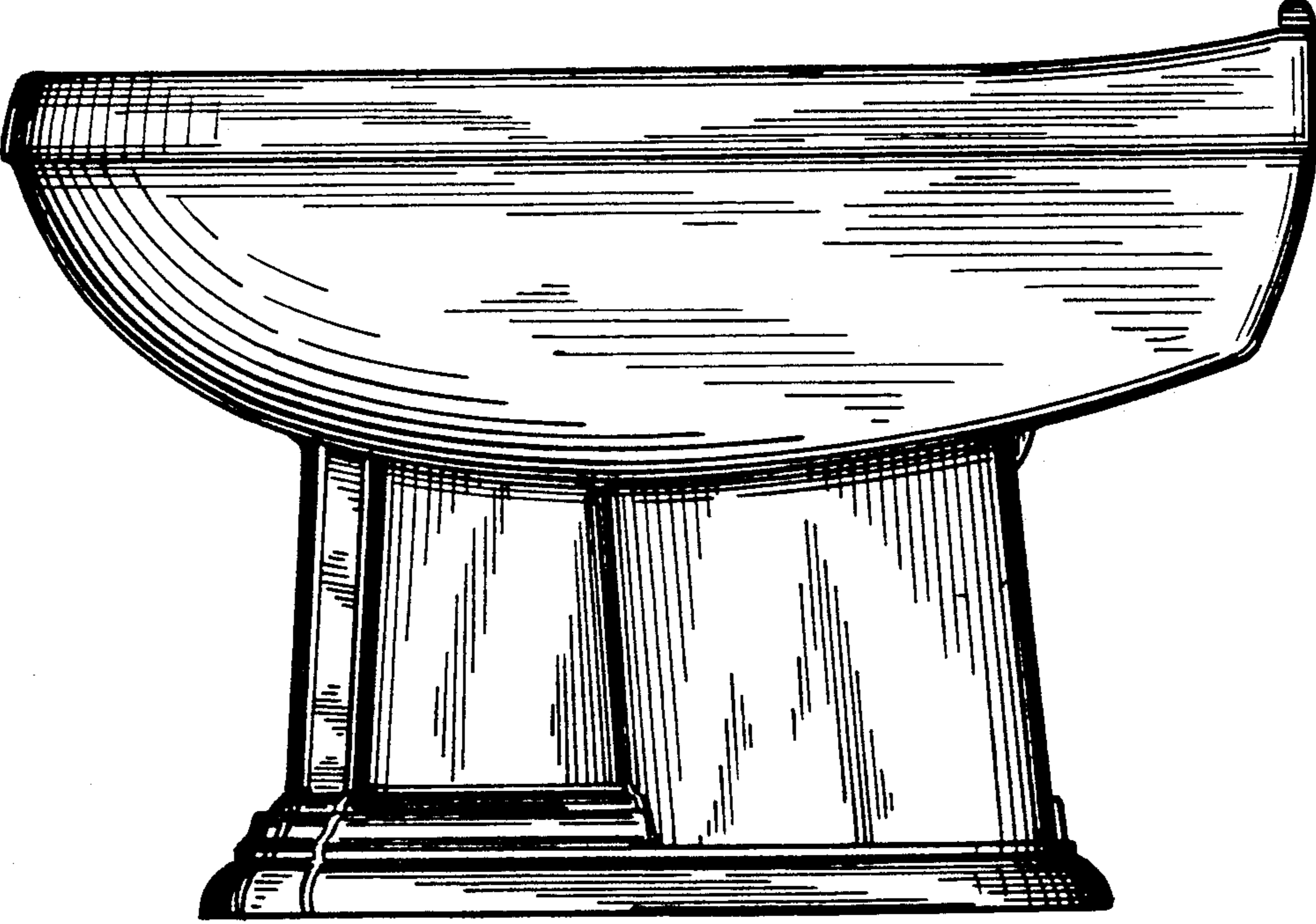
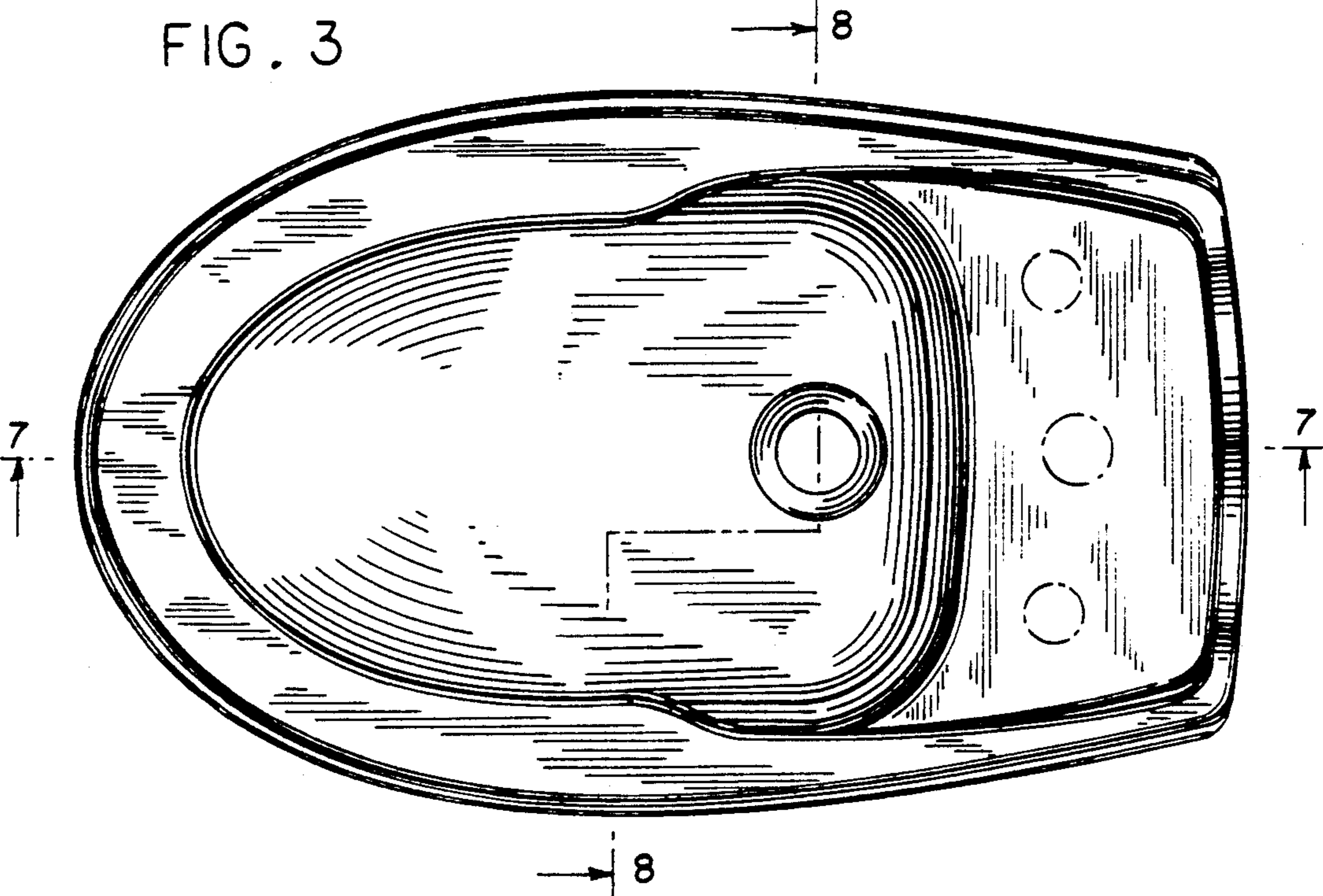

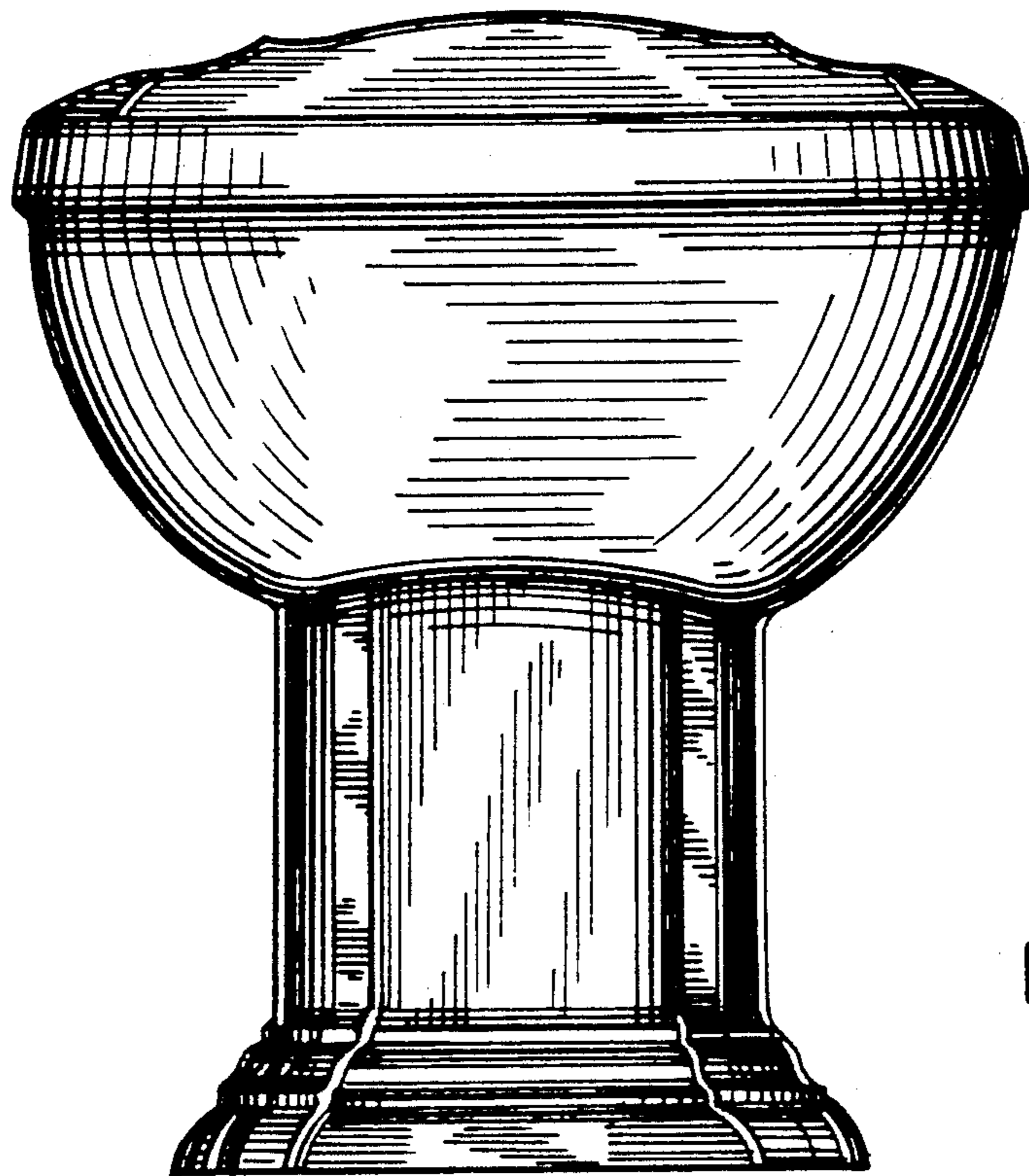

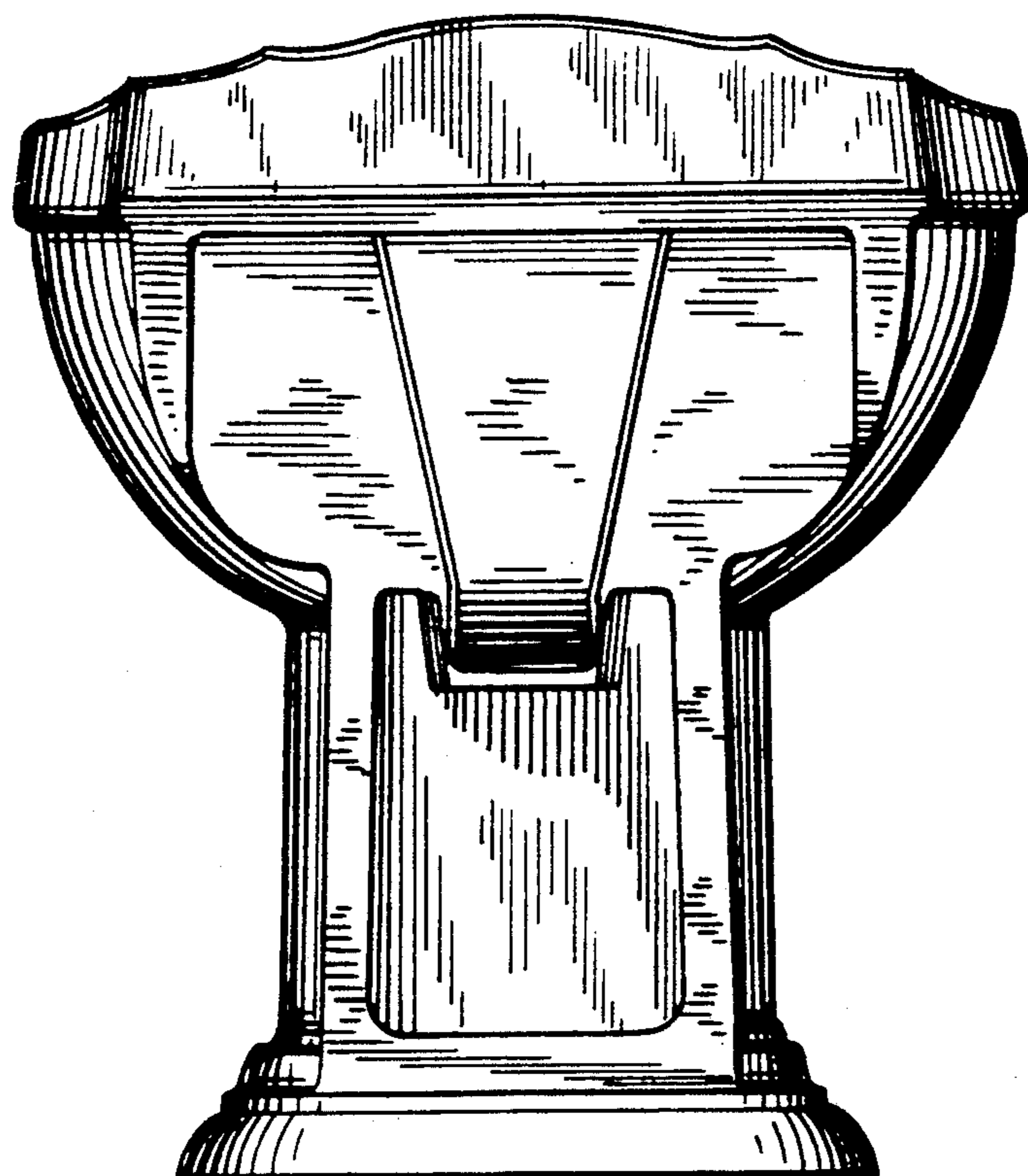

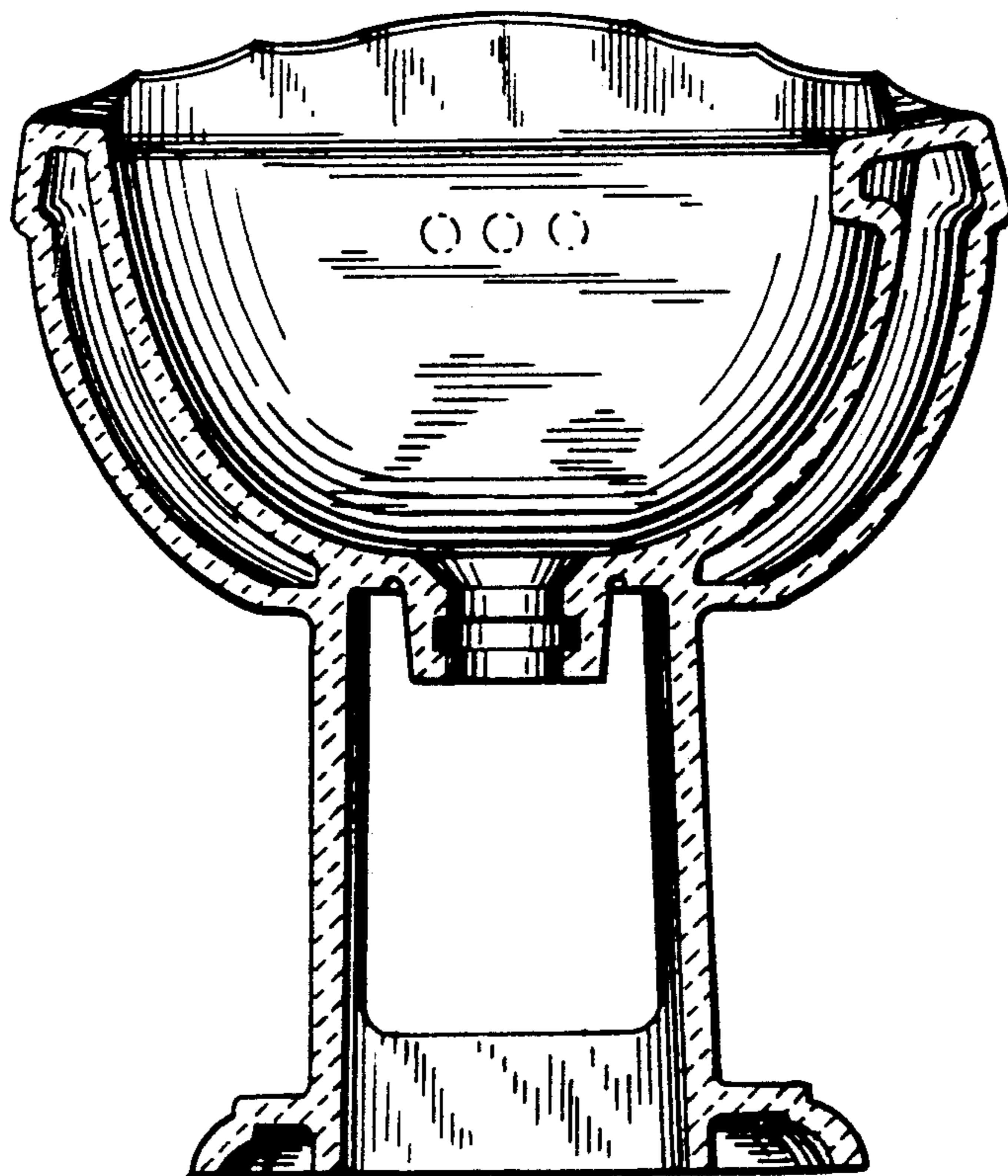
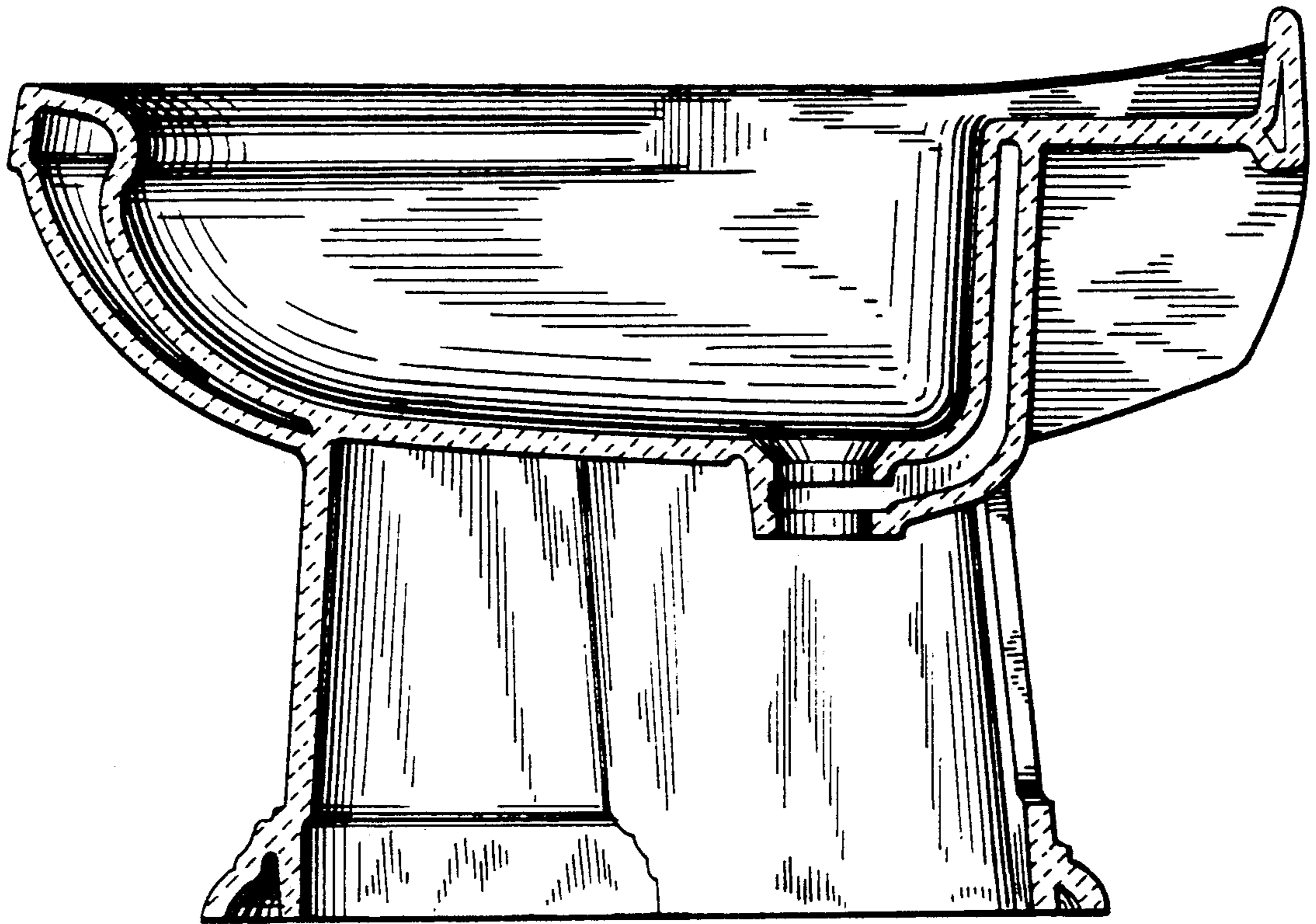
