### [57] CLAIM

The ornamental design for a forefoot element of a shoe upper, as shown and described.

### DESCRIPTION

FIG. 1 is a side elevational view of one side of a forefoot element of a shoe upper showing my new design;  
FIG. 2 is a side elevational view of the other side of the forefoot element of a shoe upper showing my new design;  
FIG. 3 is a top plan view of the forefoot element of the shoe upper showing my new design; and,  
FIG. 4 is a front elevational view of the forefoot element of the shoe upper showing my new design.  
The broken line showing of a shoe upper and sole is for illustrative purposes and forms no part of the claimed design.

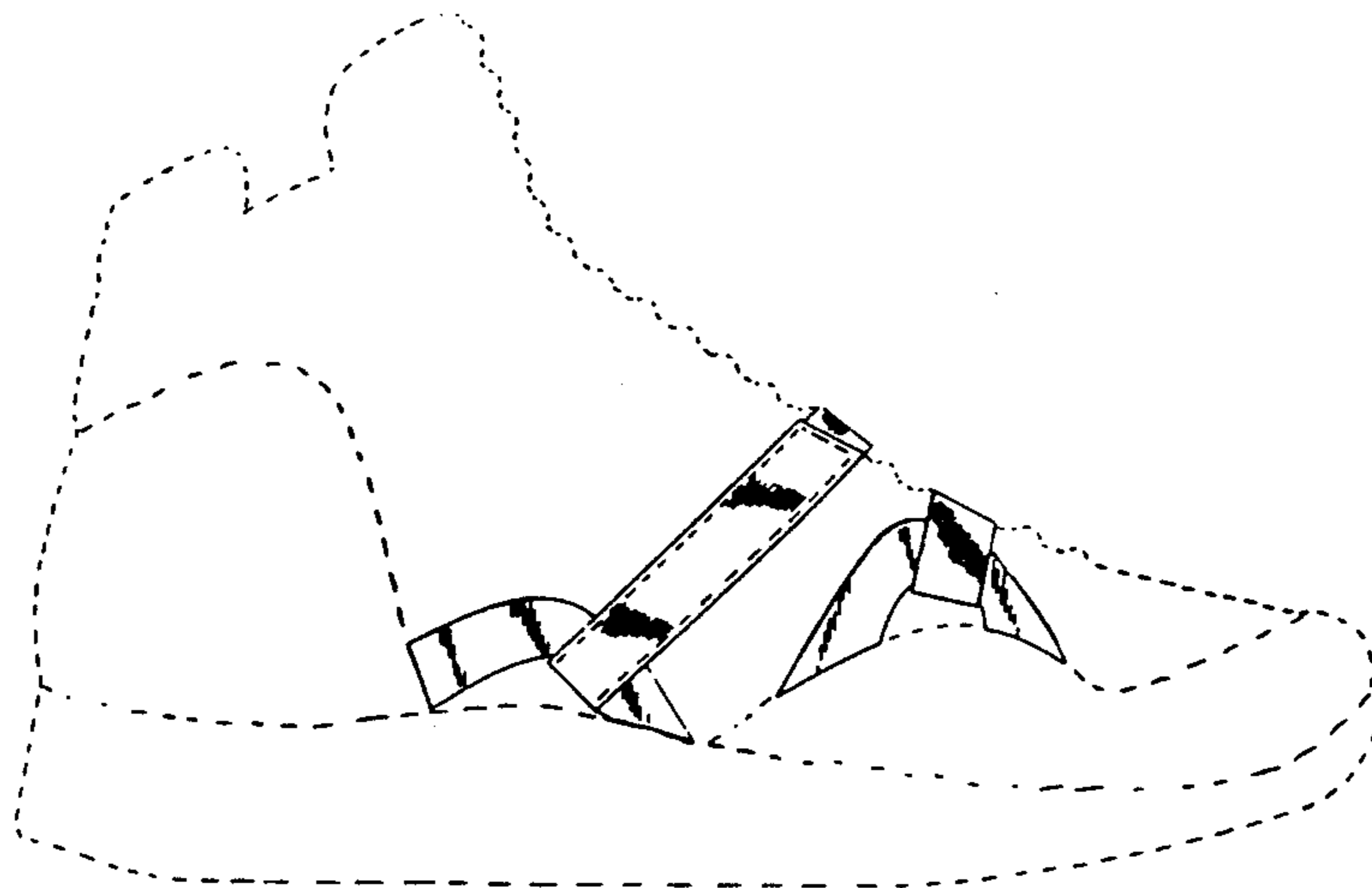
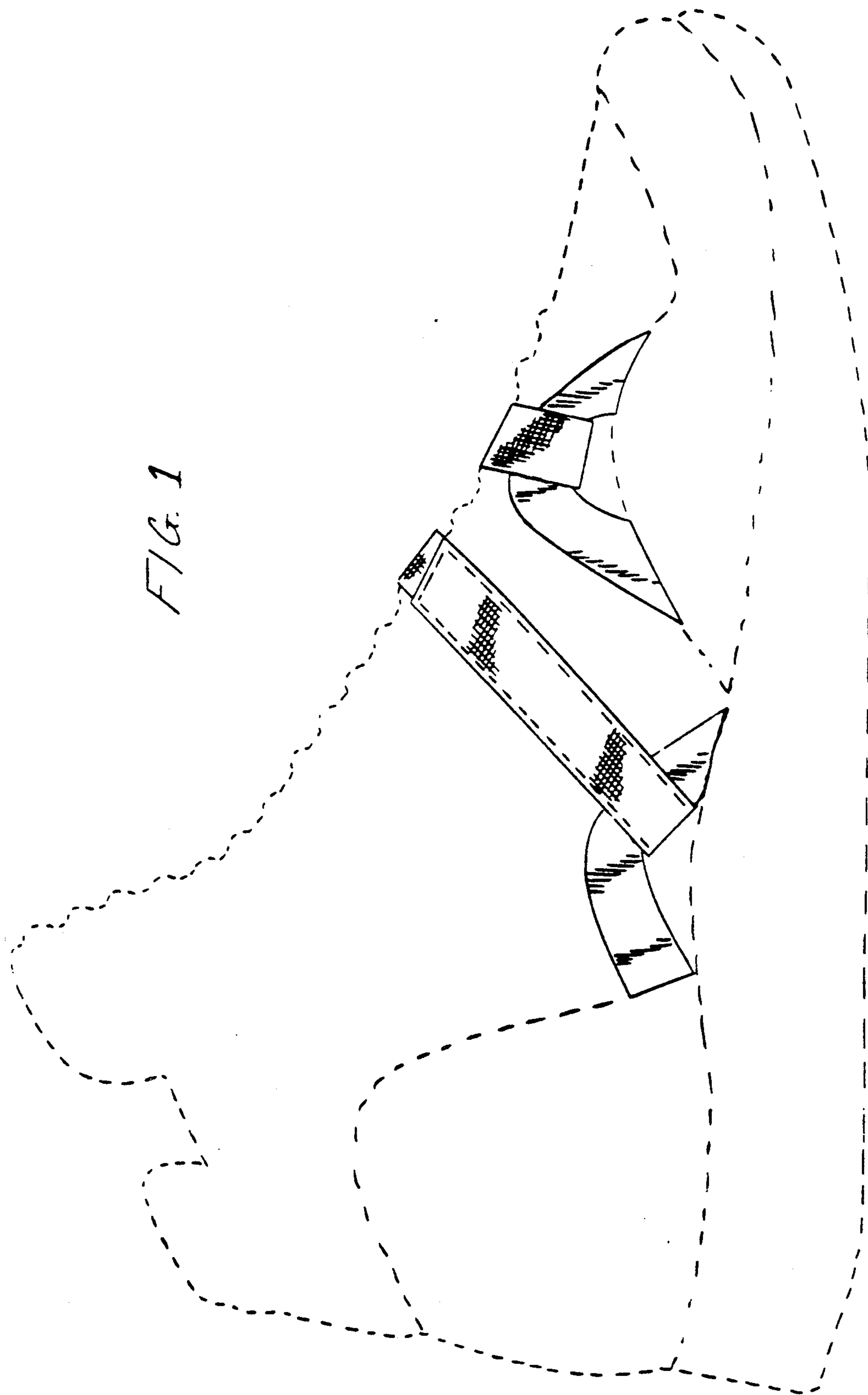

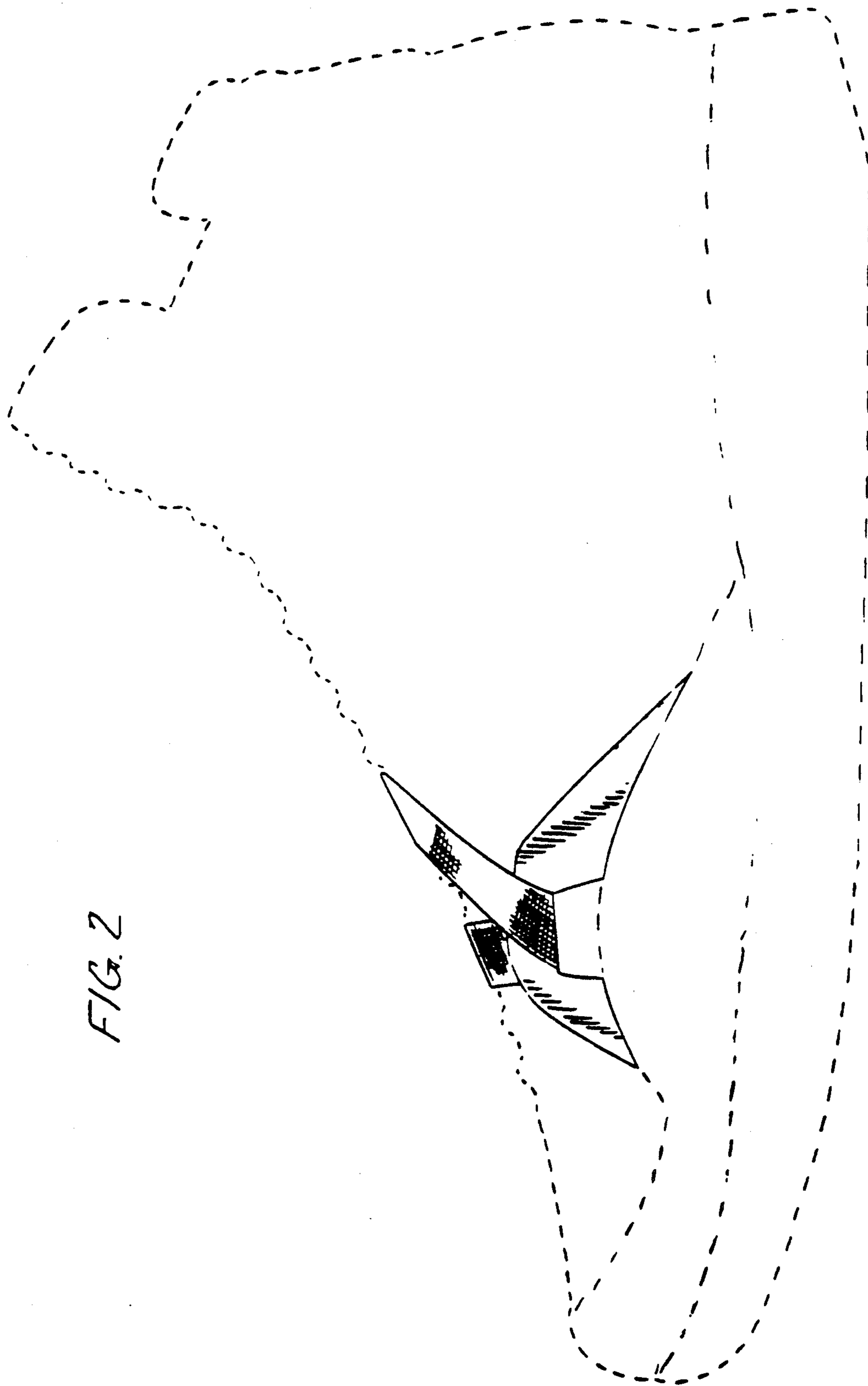

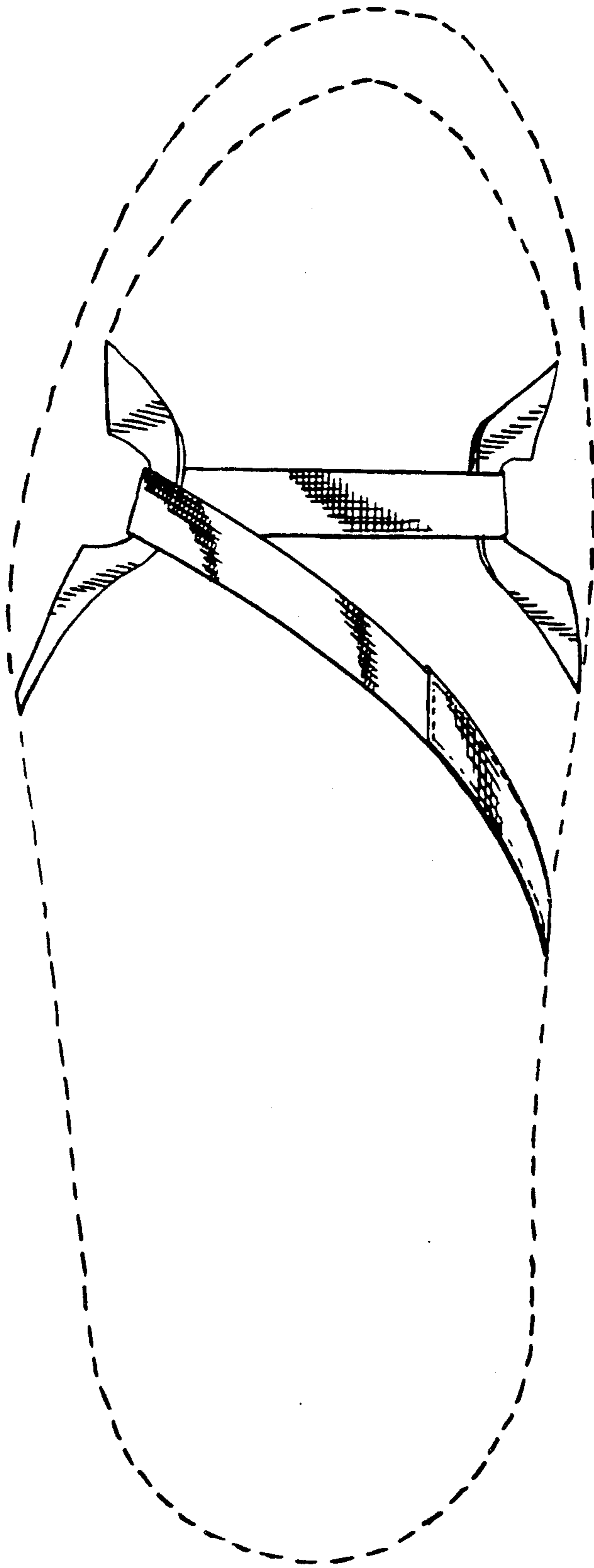
