The ornamental design for a disposable camera, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a disposable camera showing my new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a top plan view thereof;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is a left side elevational view thereof;
 FIG. 7 is a right side elevational view thereof; and,
 FIG. 8 is a top front view thereof, the target finder being in raised position.

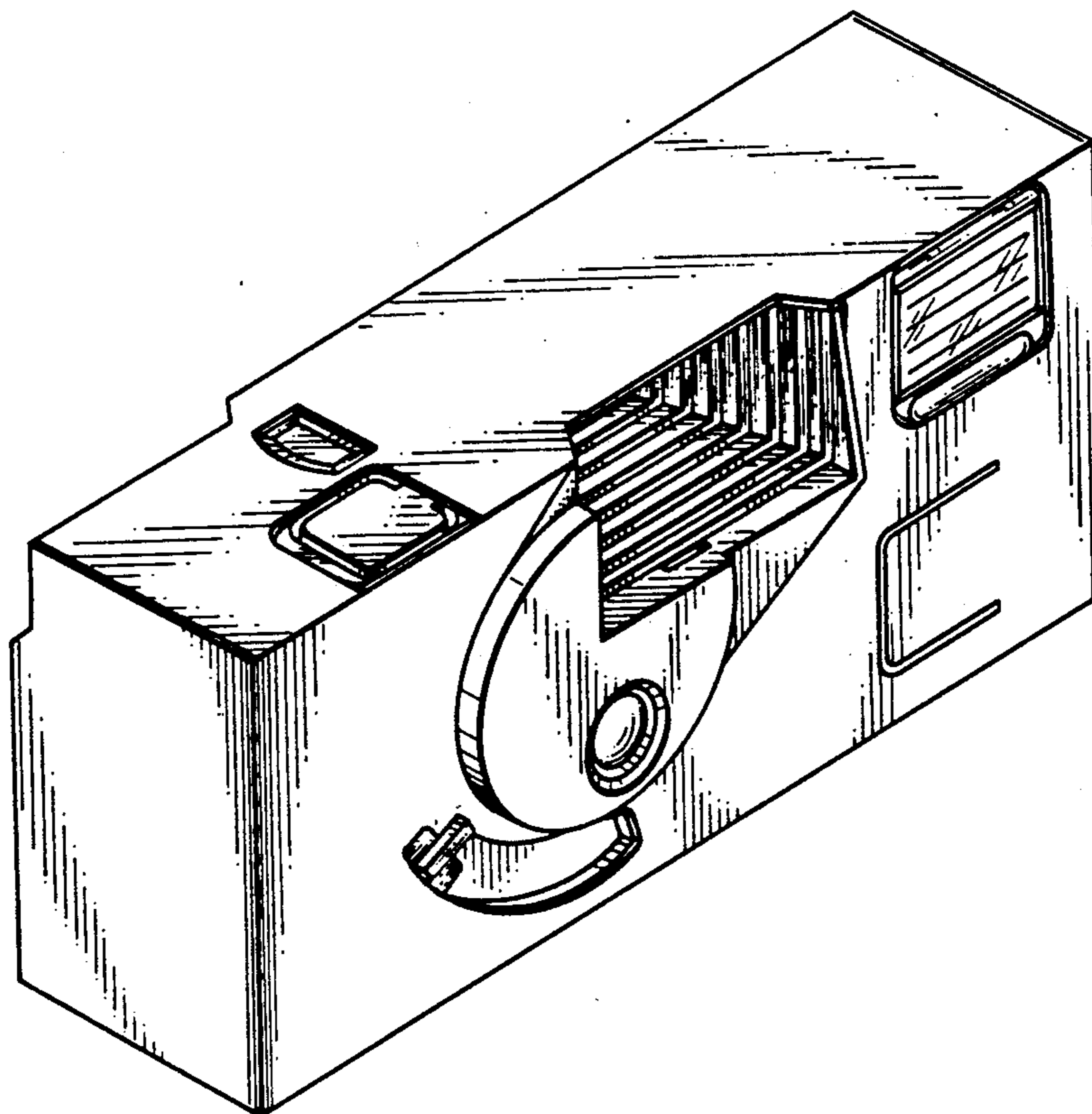

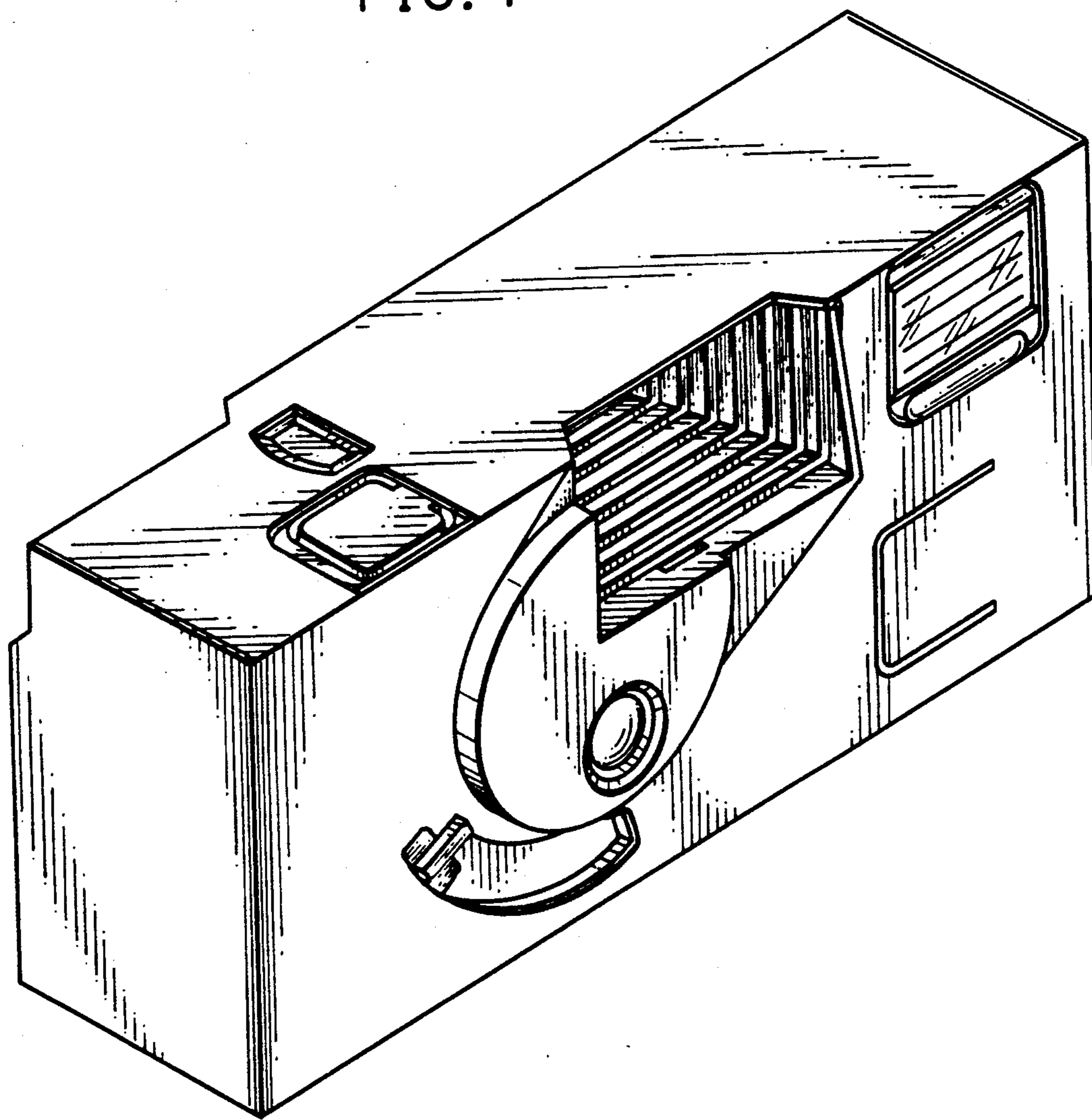

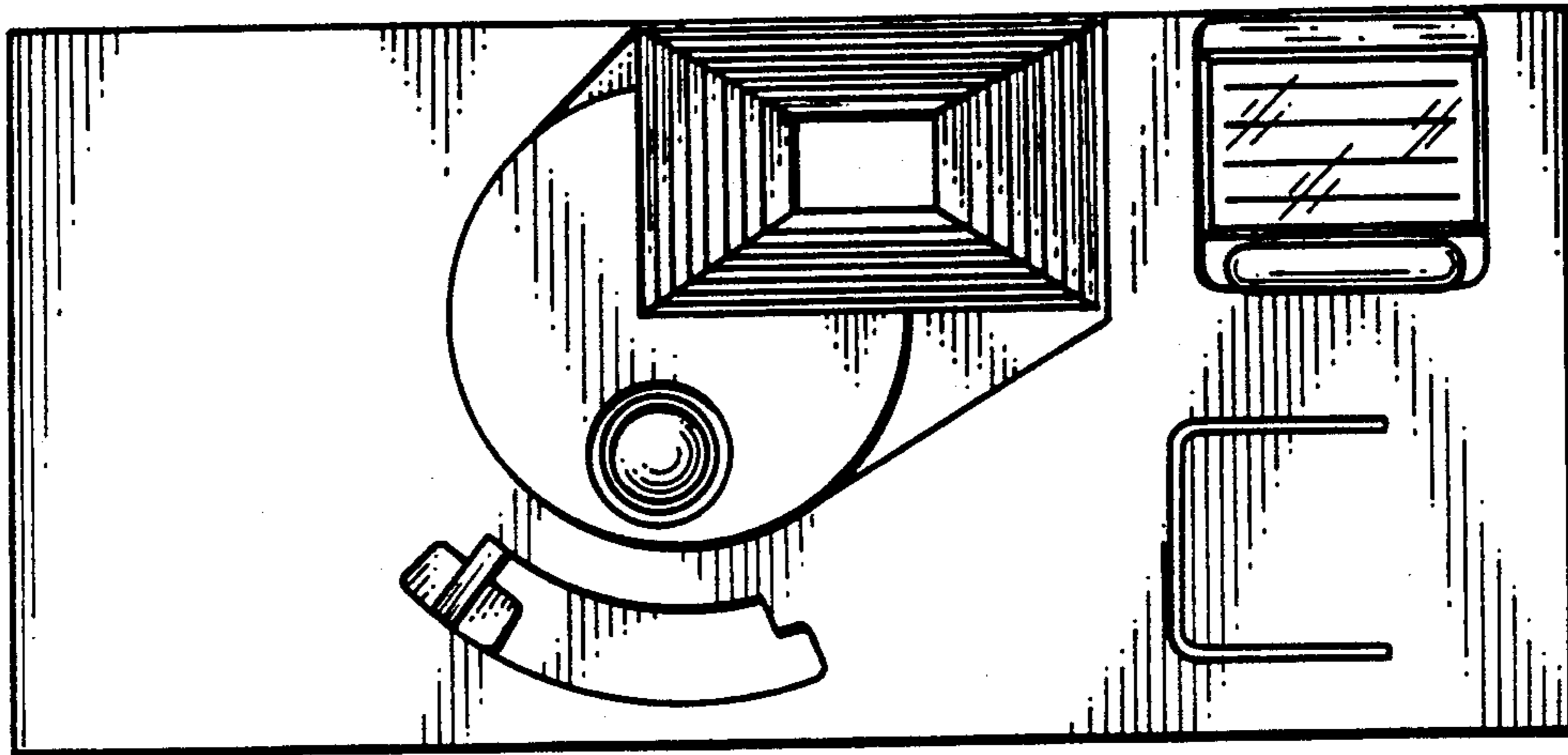

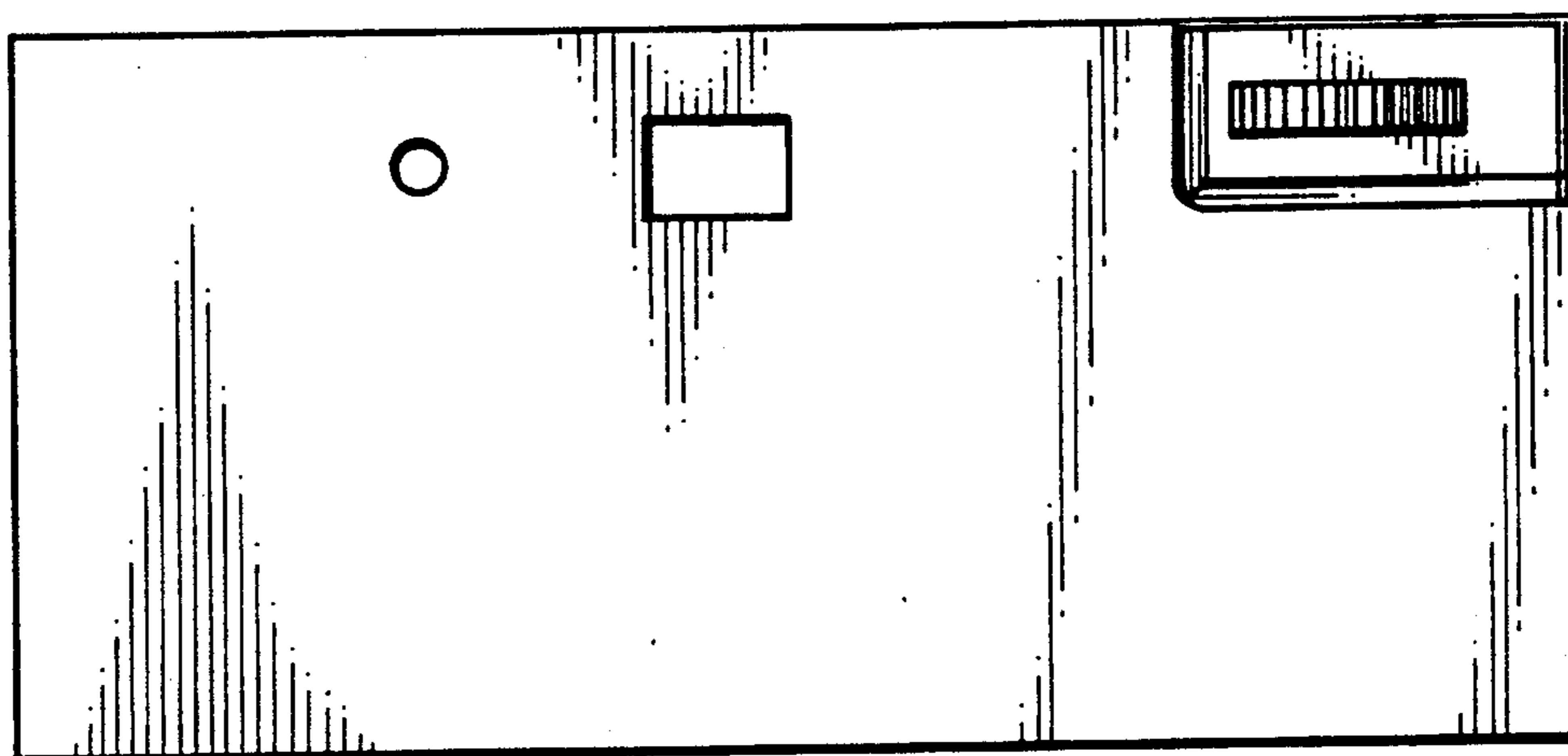

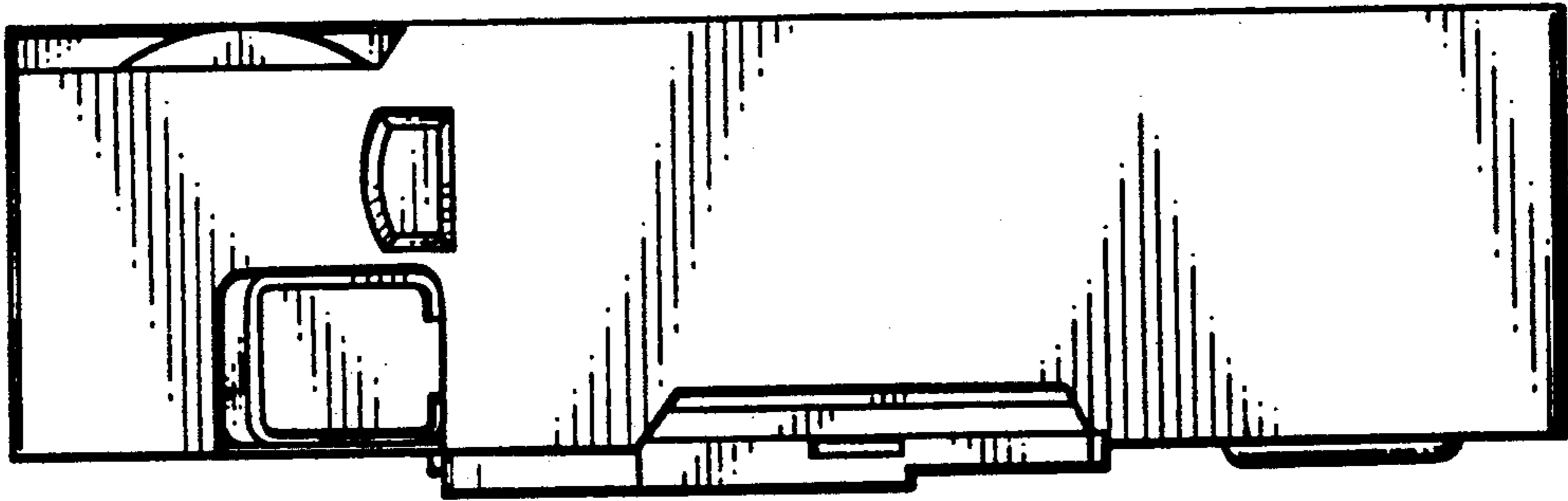

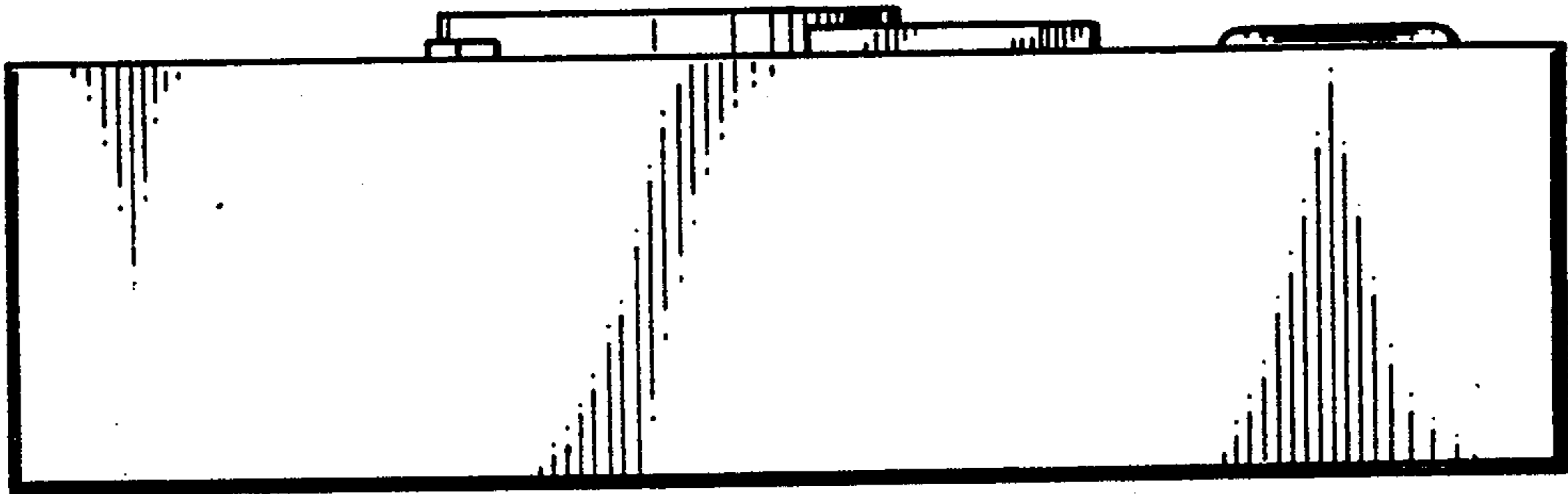

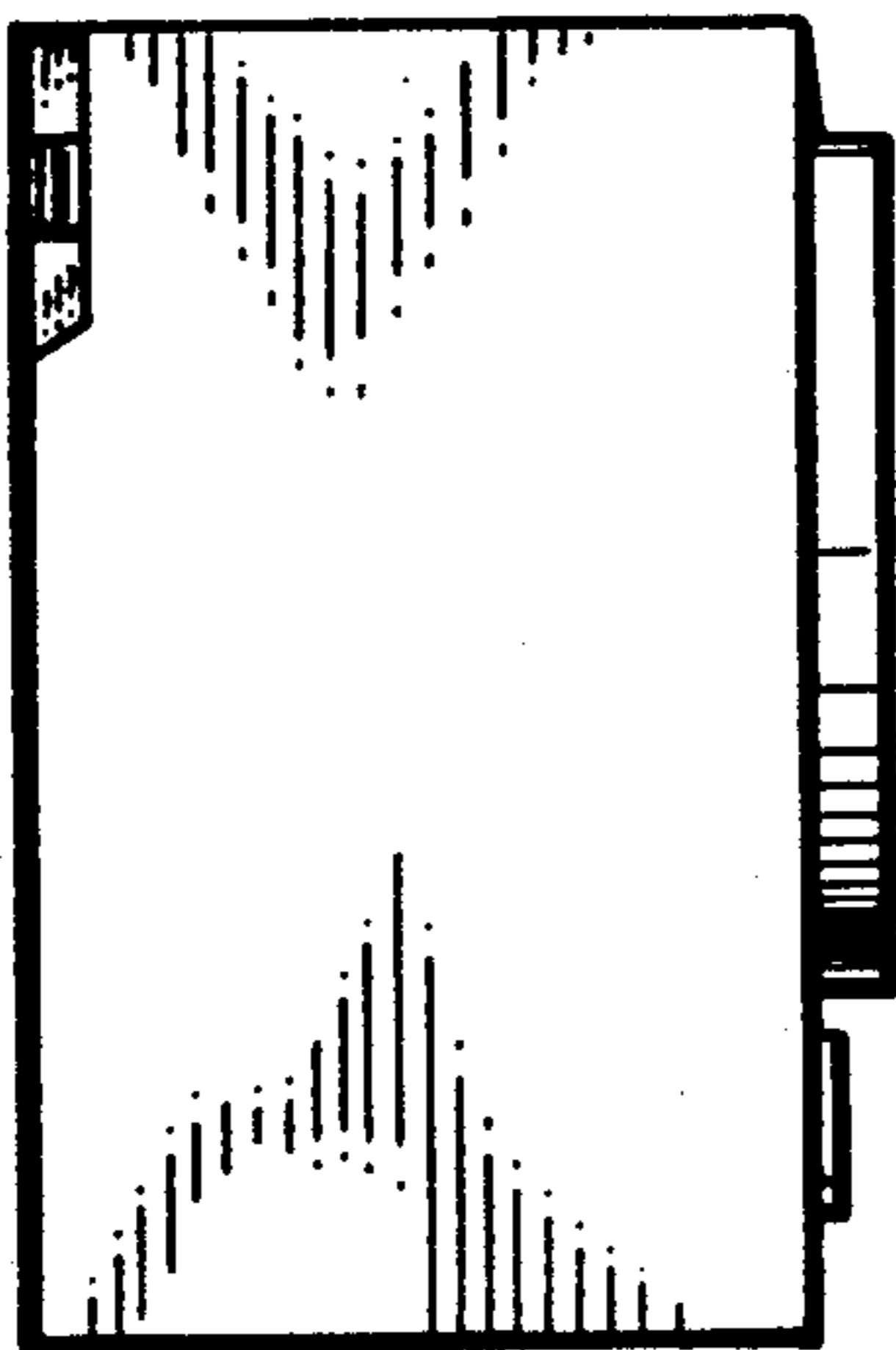

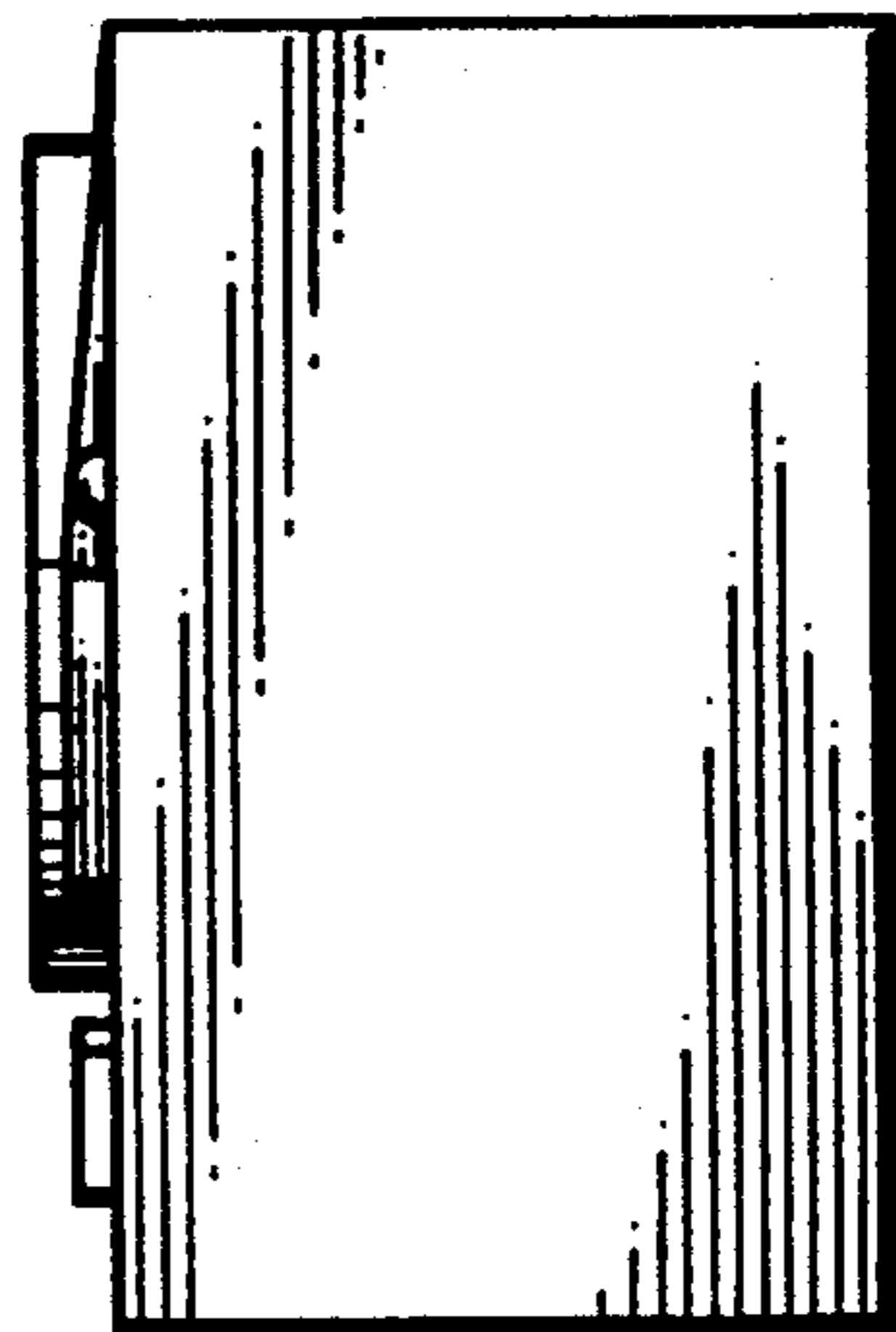
