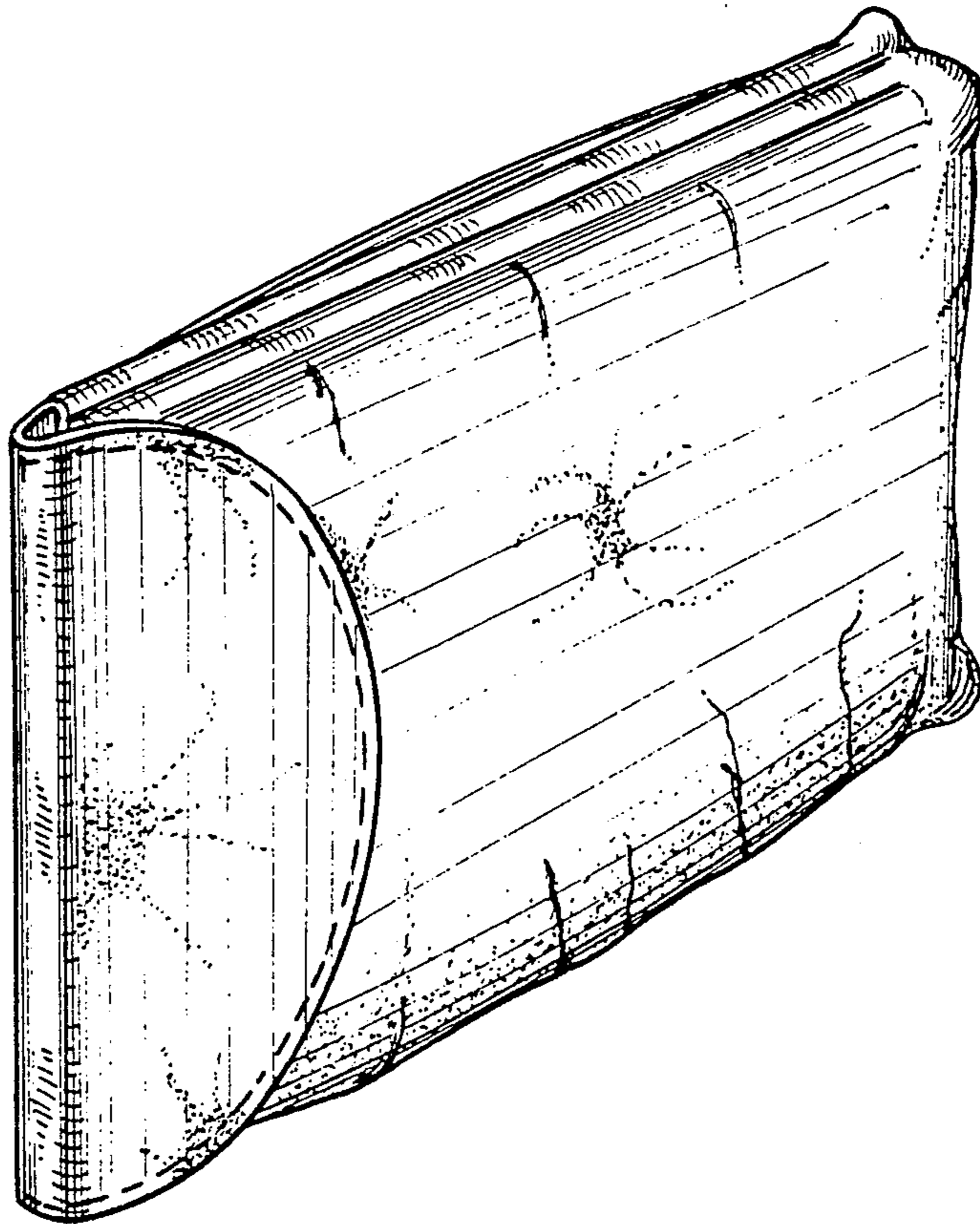

The ornamental design for a carrying case for firearms, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a carrying case for firearms showing my new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a bottom plan view thereof;
 FIG. 4 is a left-side elevational view thereof;
 FIG. 5 is a right-side elevational view thereof;
 FIG. 6 is a left-side elevational view thereof in open position;
 FIG. 7 is a front elevational view thereof;
 FIG. 8 is a front elevational view thereof in open position;
 FIG. 9 is a rear elevational view thereof; and,
 FIG. 10 is a rear elevational view thereof in use in open position.



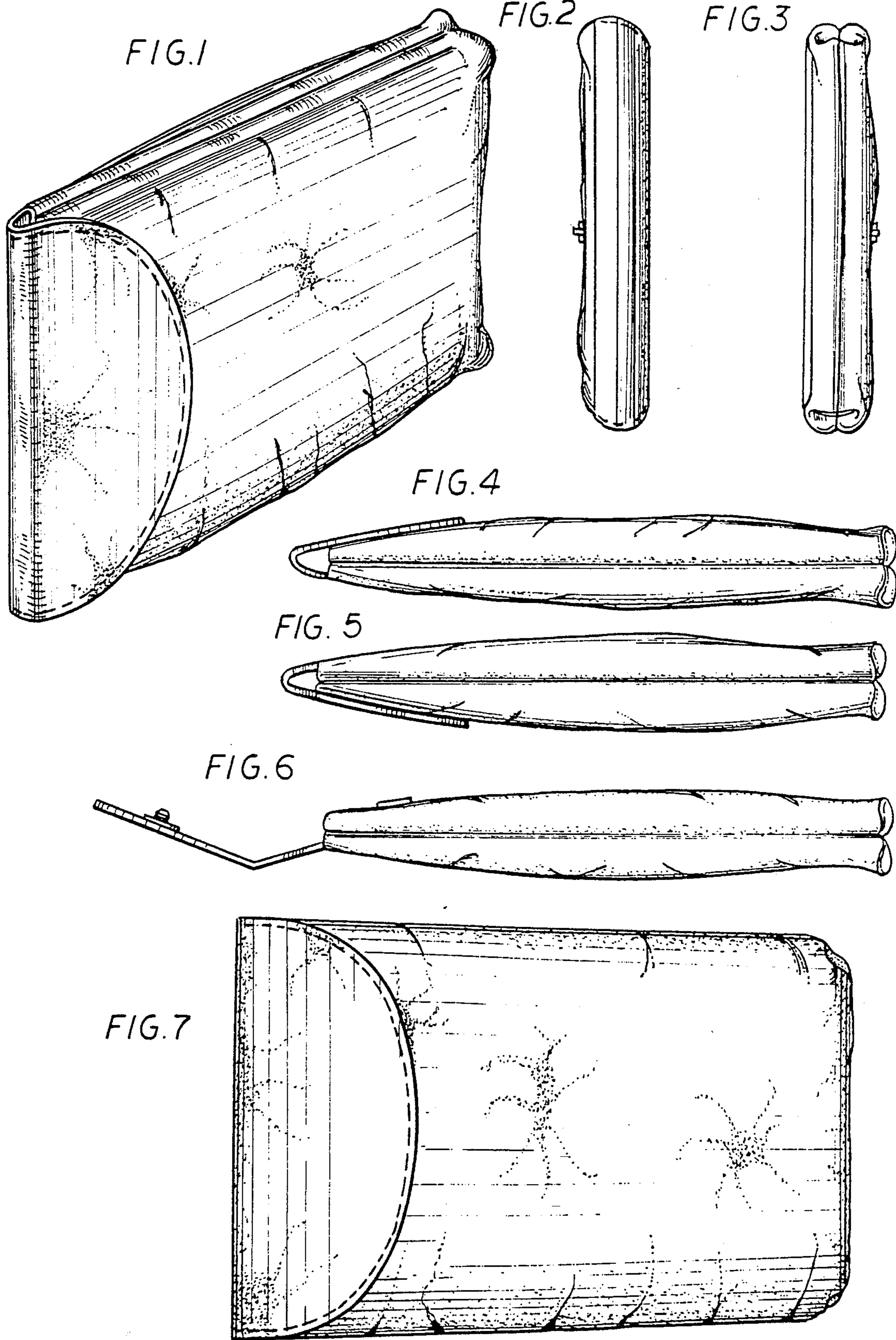

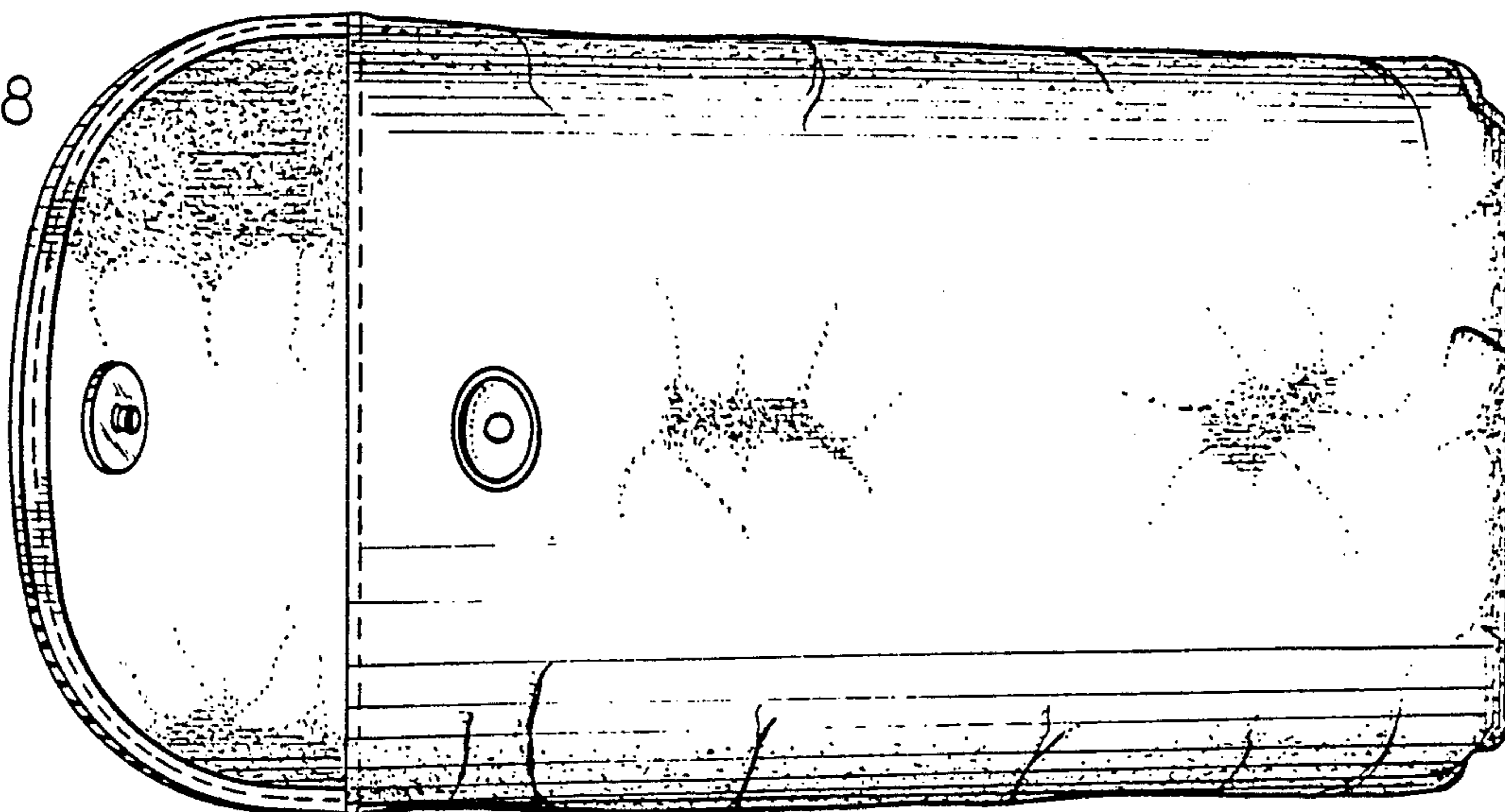

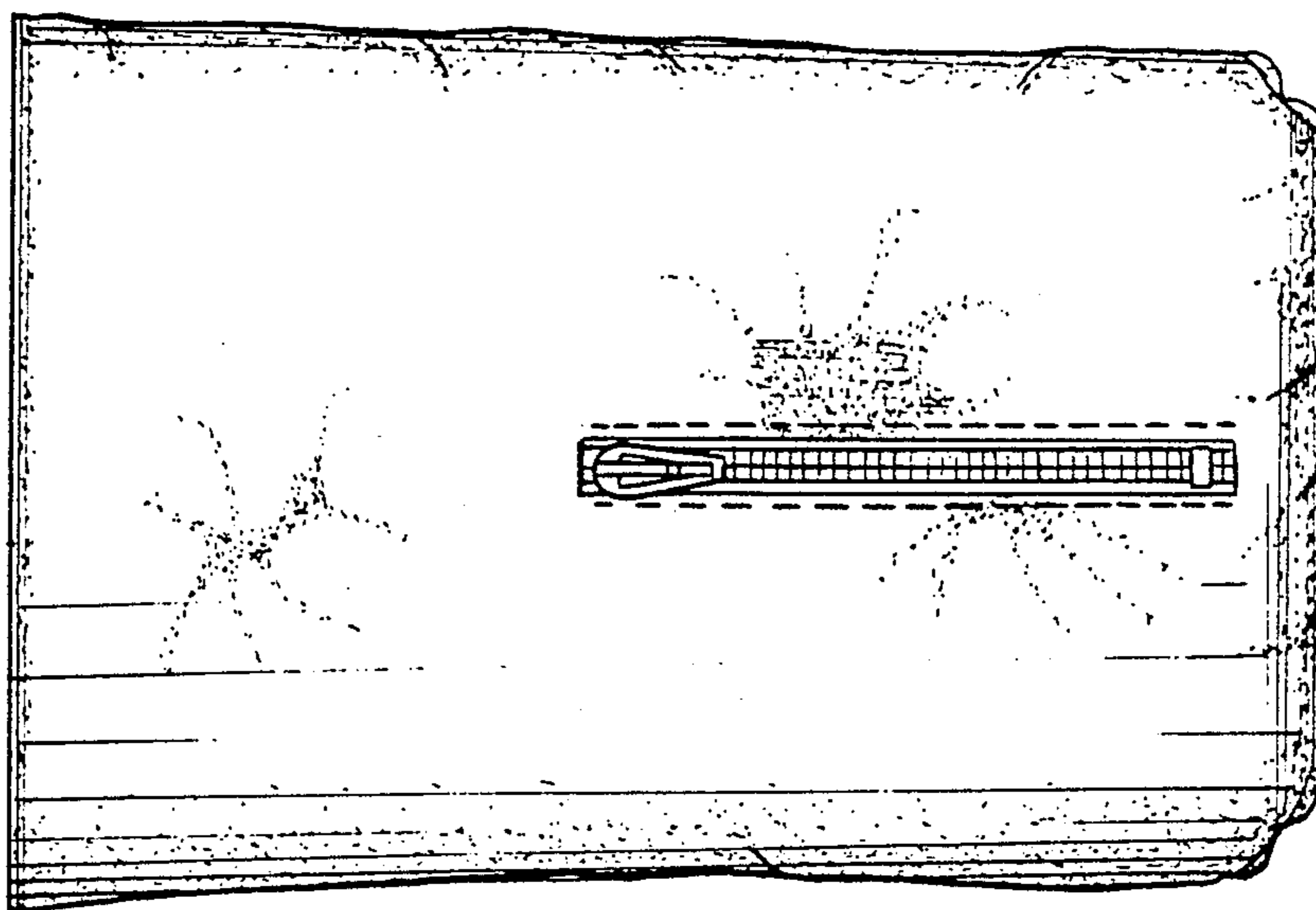
