[57] **CLAIM**

The ornamental design for a seat, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a seat, showing my new design;

FIG. 2 is a front elevational view;

FIG. 3 is a top plan view;

FIG. 4 is a rear elevational view;

FIG. 5 is a side elevational view, the opposite side being a mirror image thereof;

FIG. 6 is a bottom plan view;

FIG. 7 is a perspective view of a seat, showing an alternate embodiment of my new design;

FIG. 8 is a front elevational view of the alternate embodiment;

FIG. 9 is a top plan view of the alternate embodiment;

FIG. 10 is a rear elevational view of the alternate embodiment;

FIG. 11 is a right side elevational view of the alternate embodiment, the opposite side being a mirror image thereof; and,

FIG. 12 is a bottom plan view of the alternate embodiment.

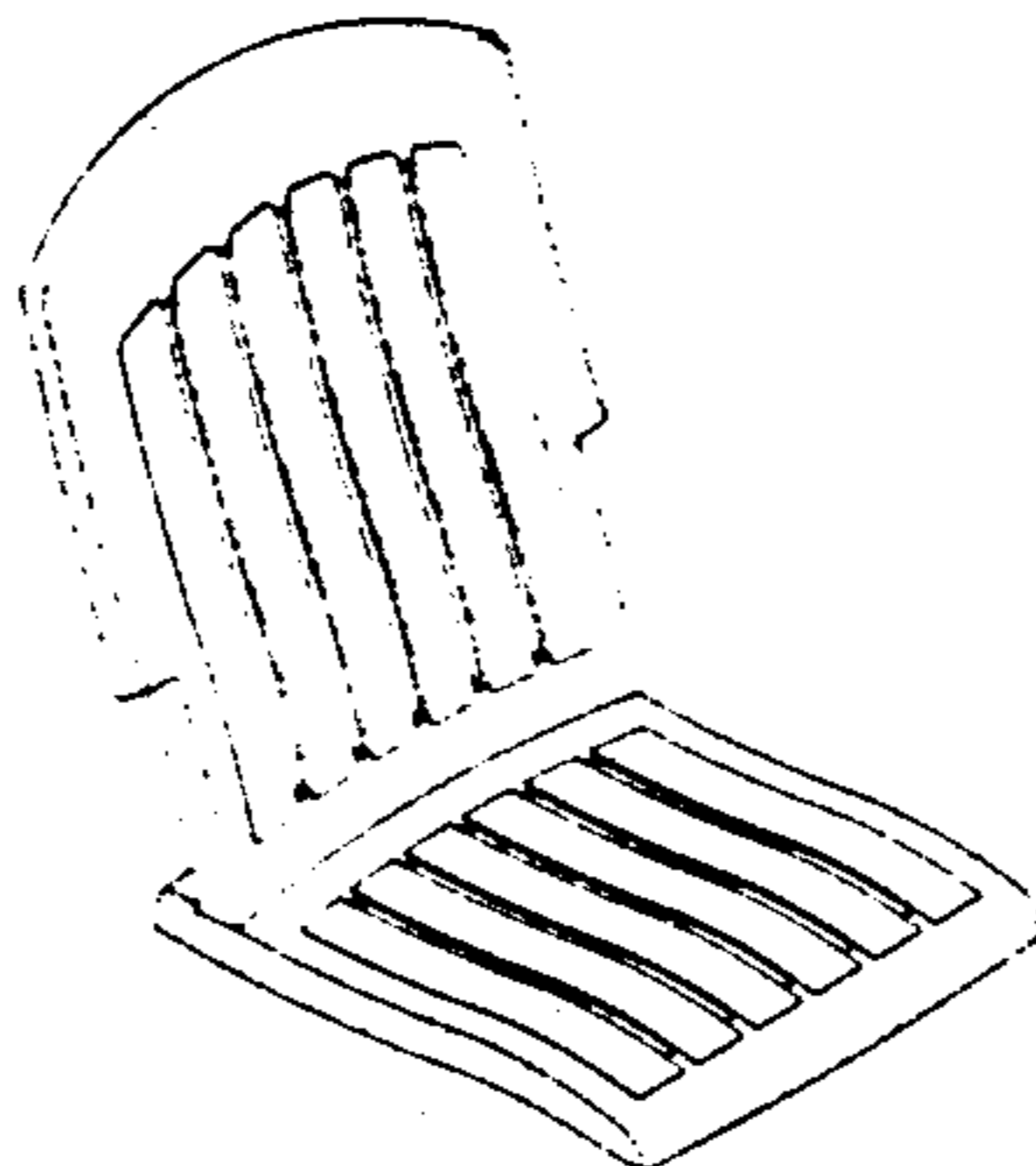
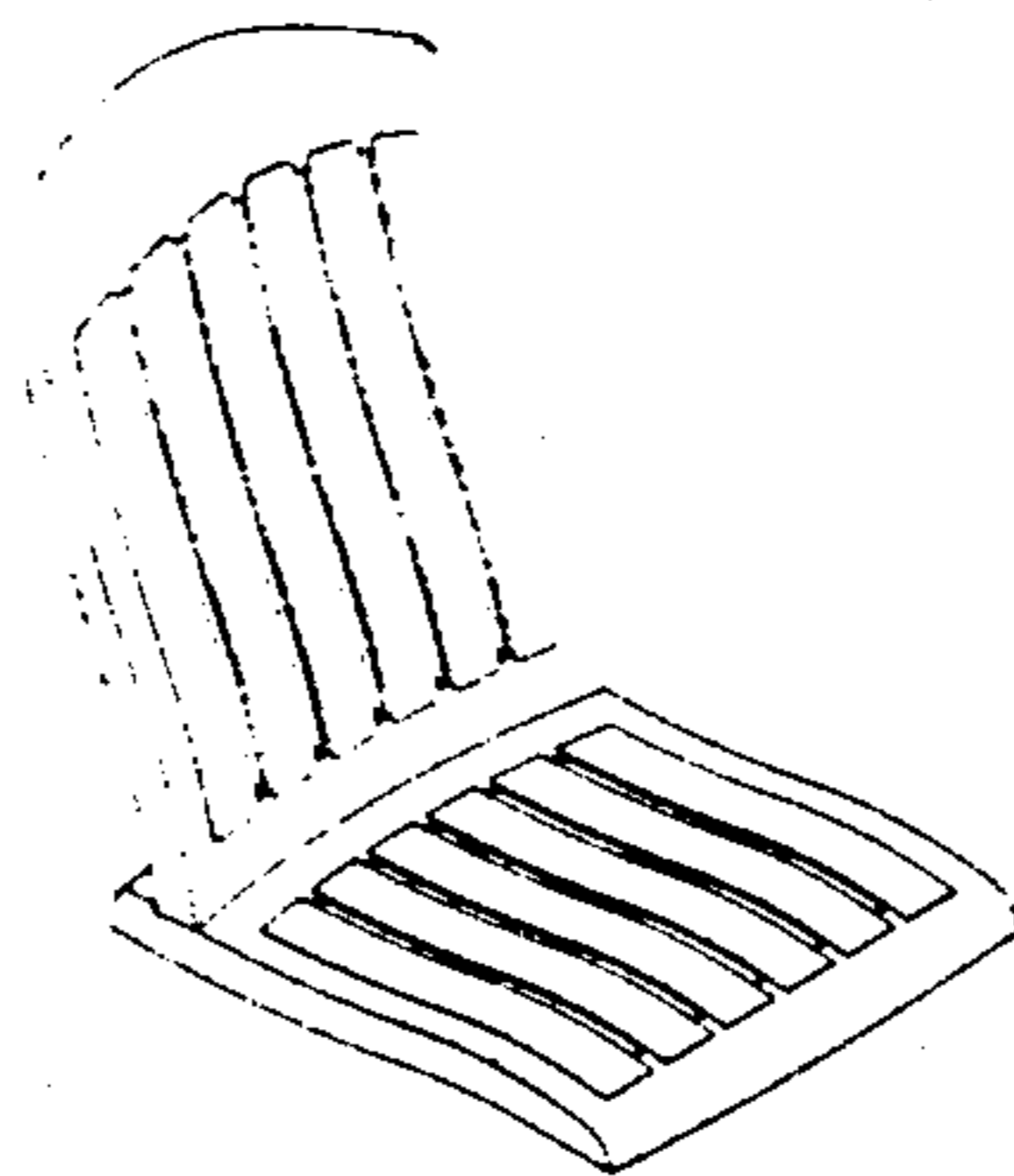

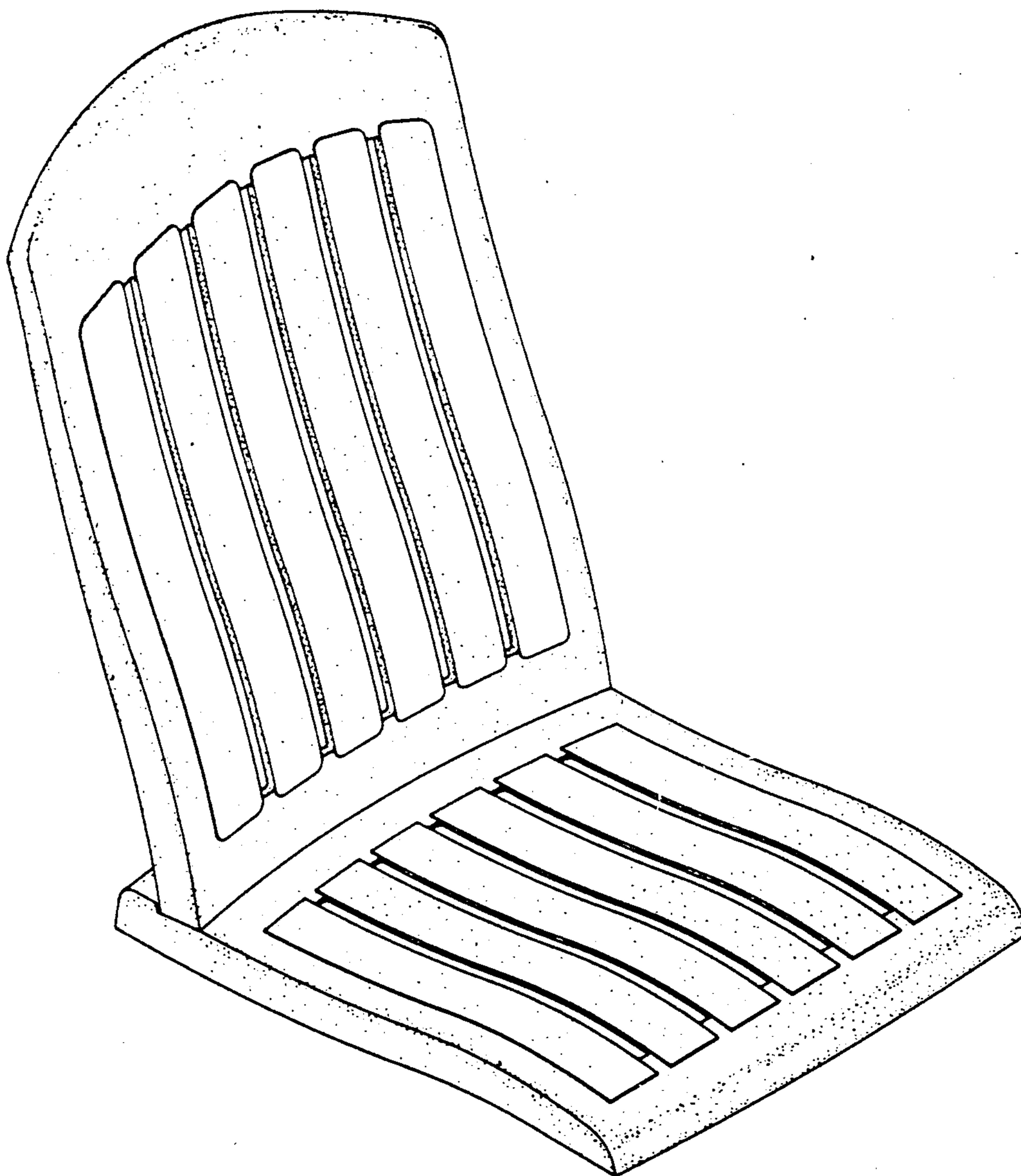

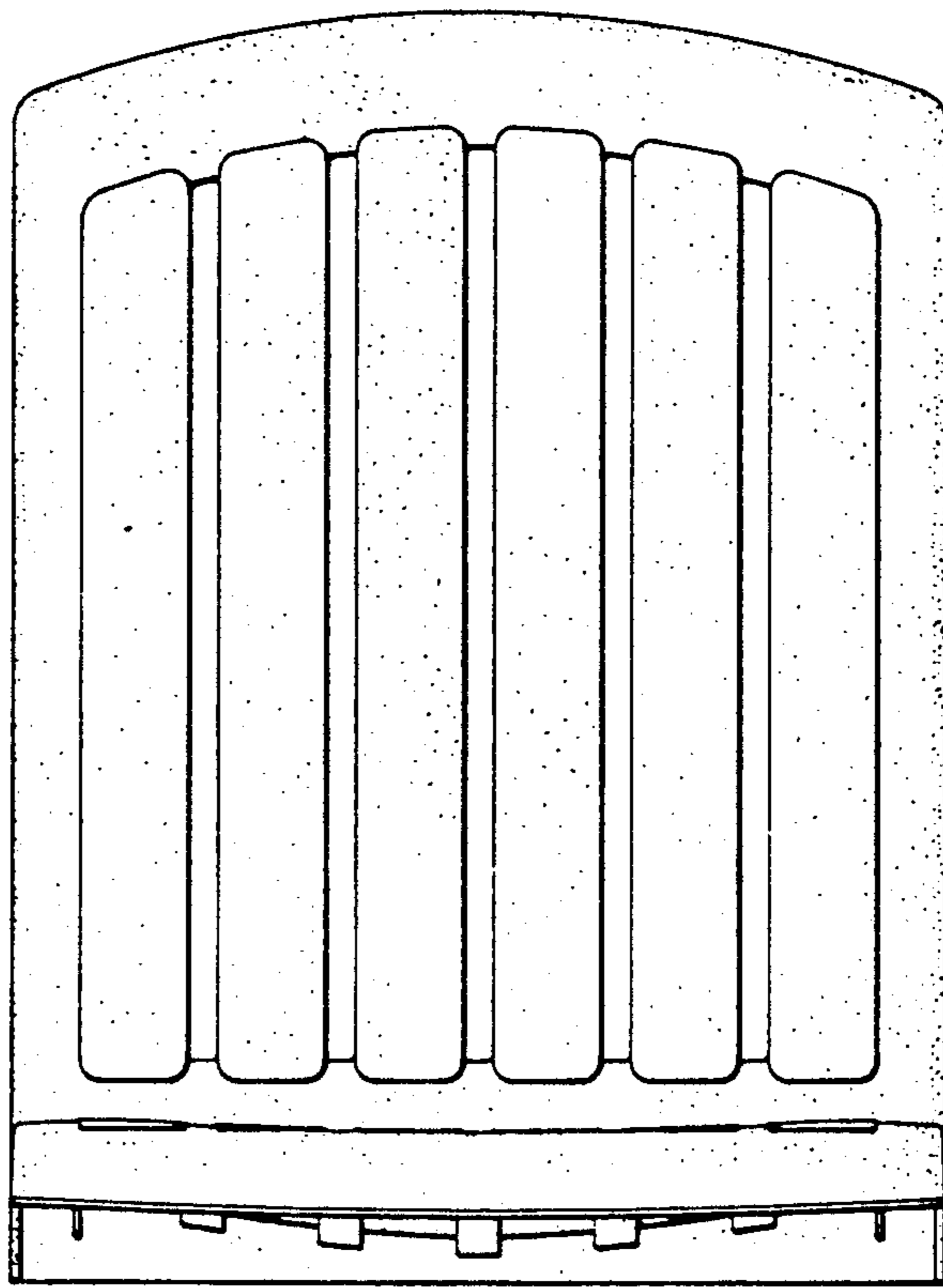

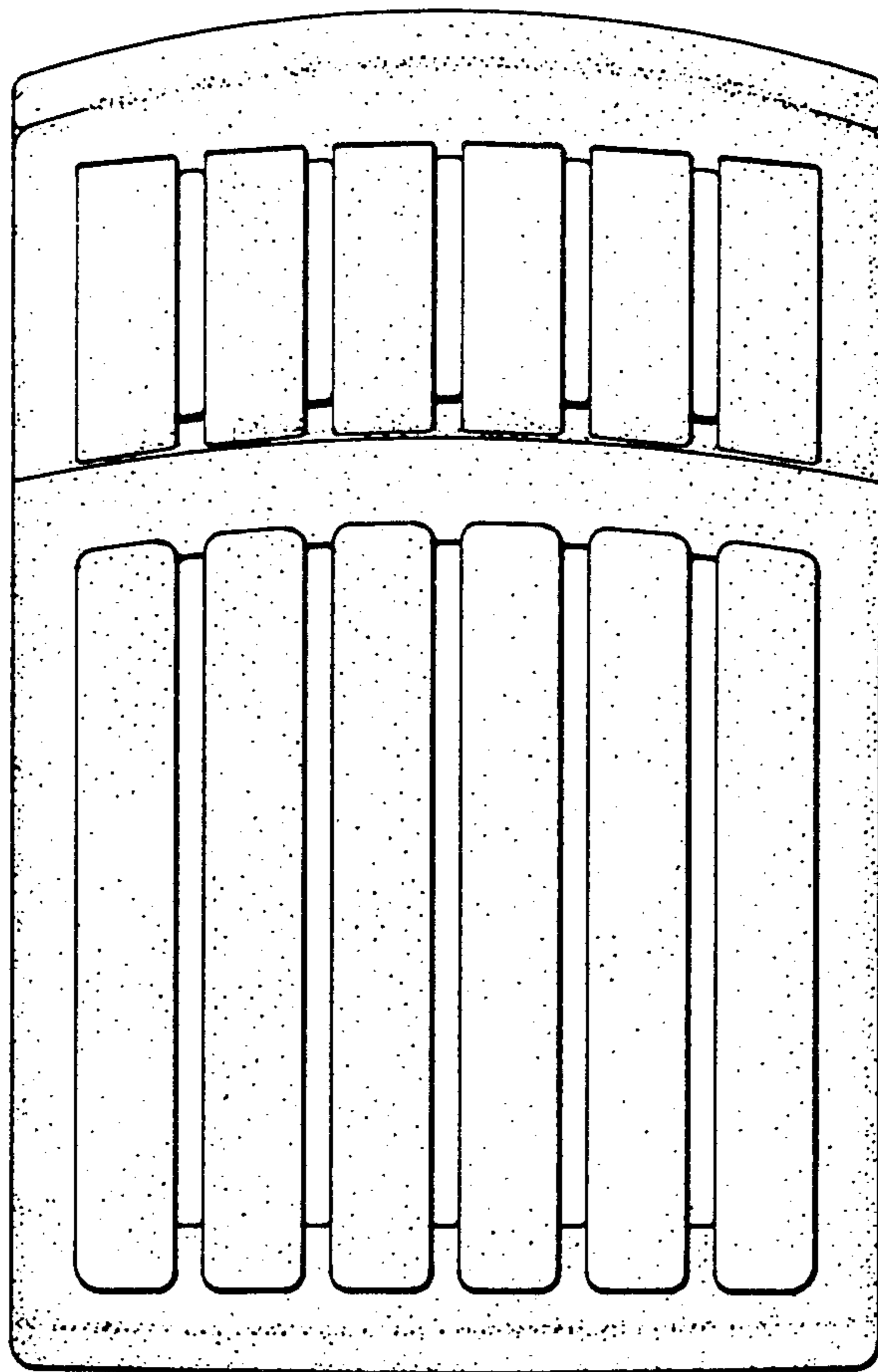

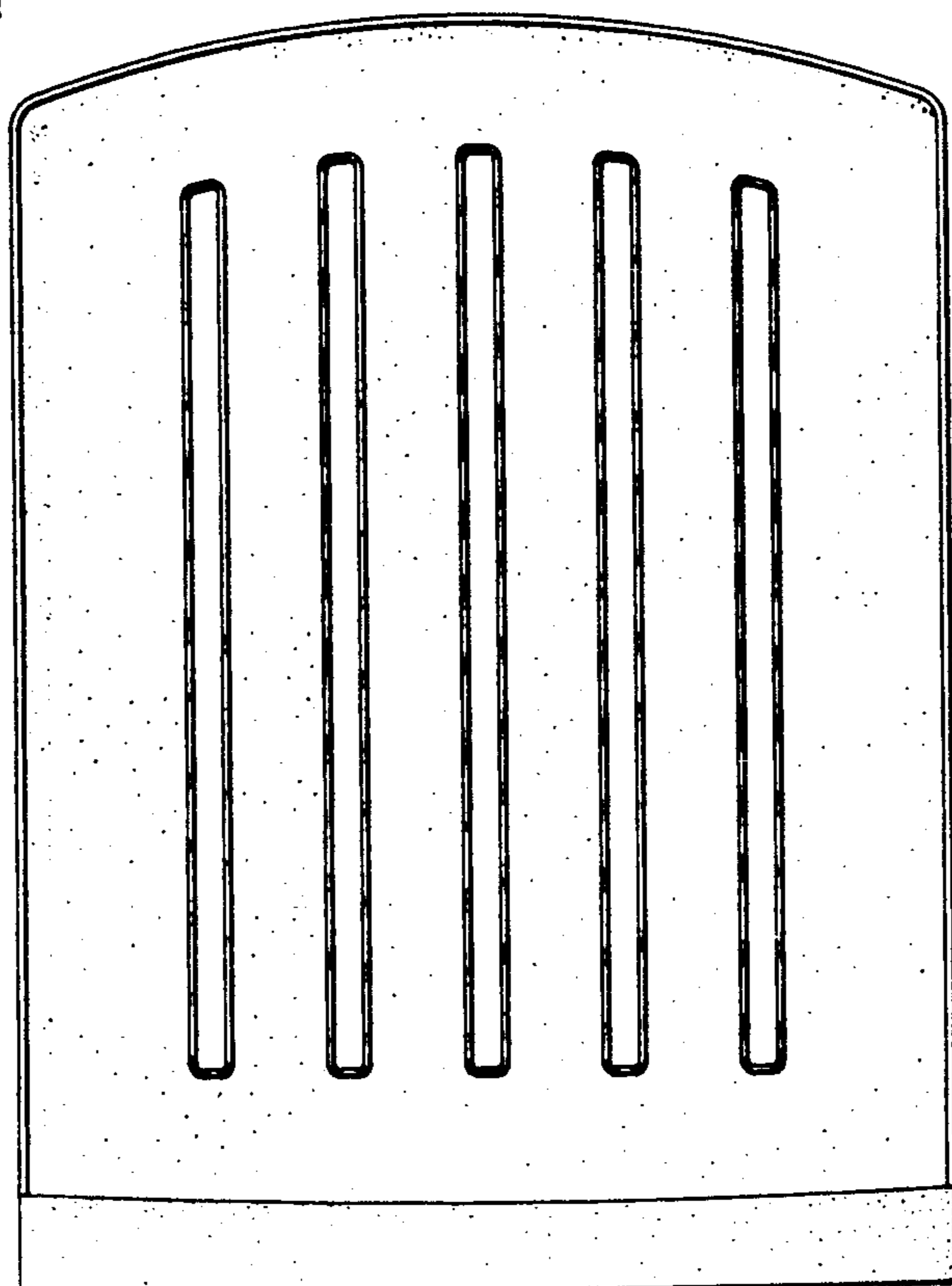

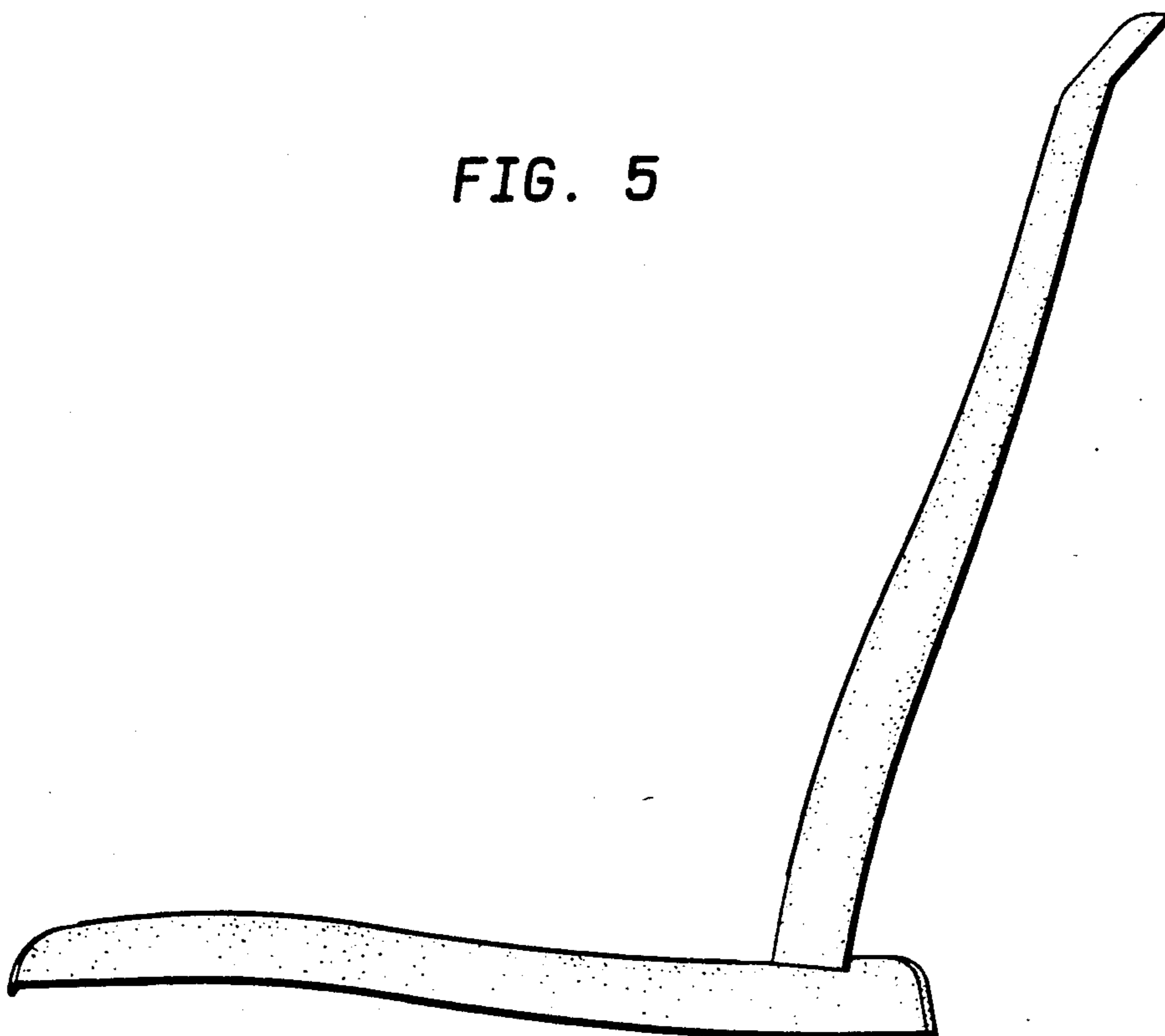

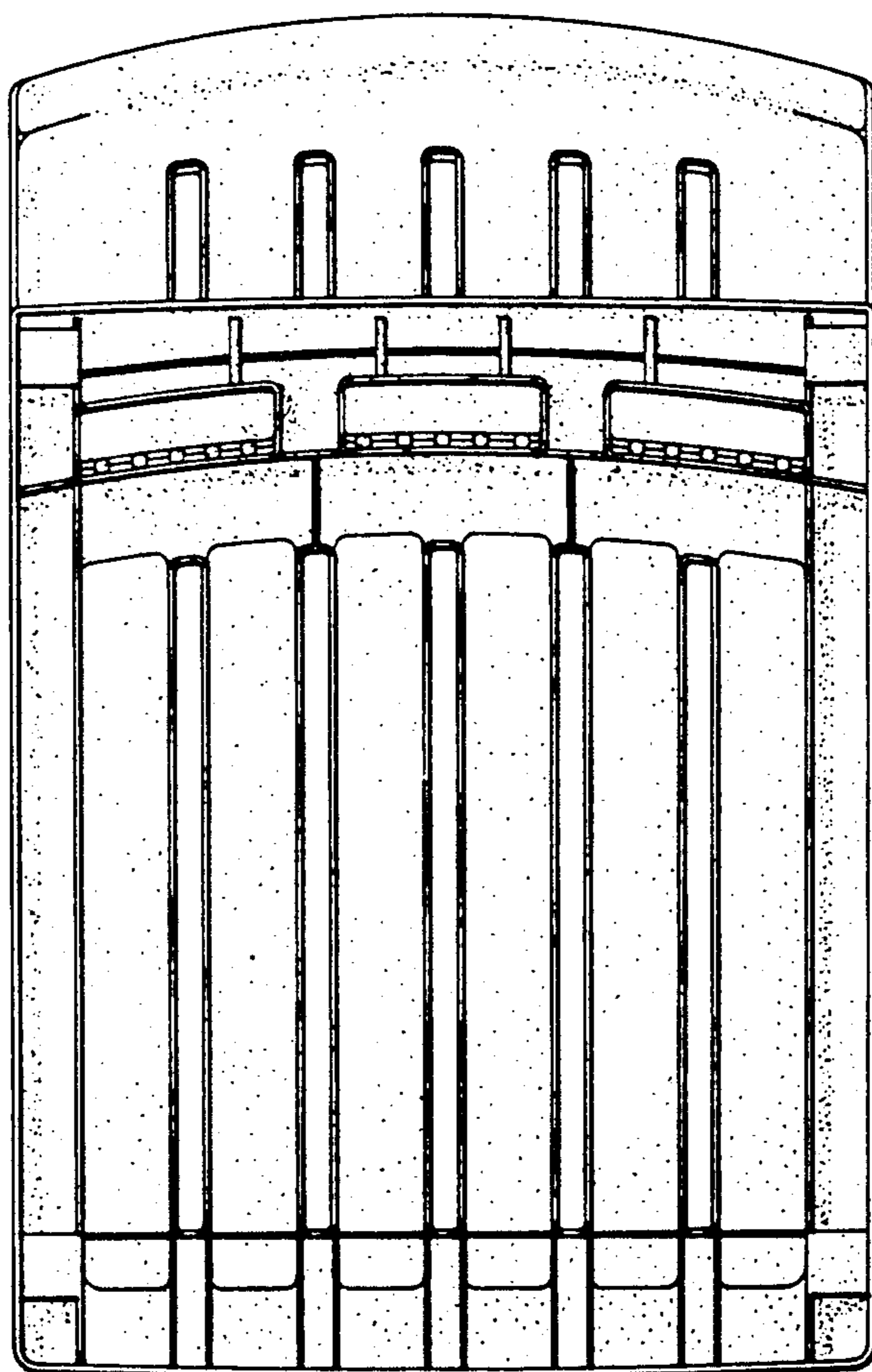

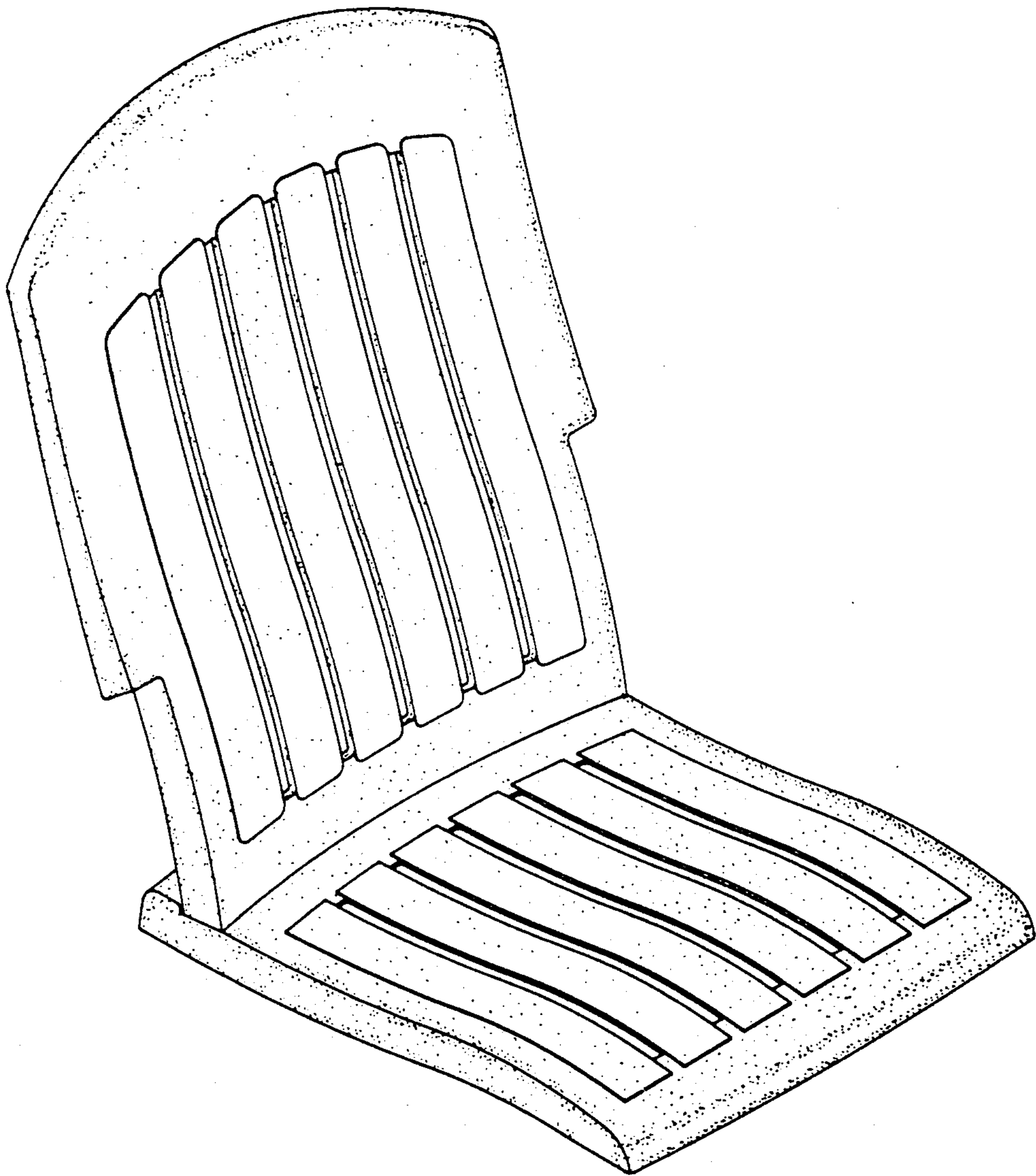

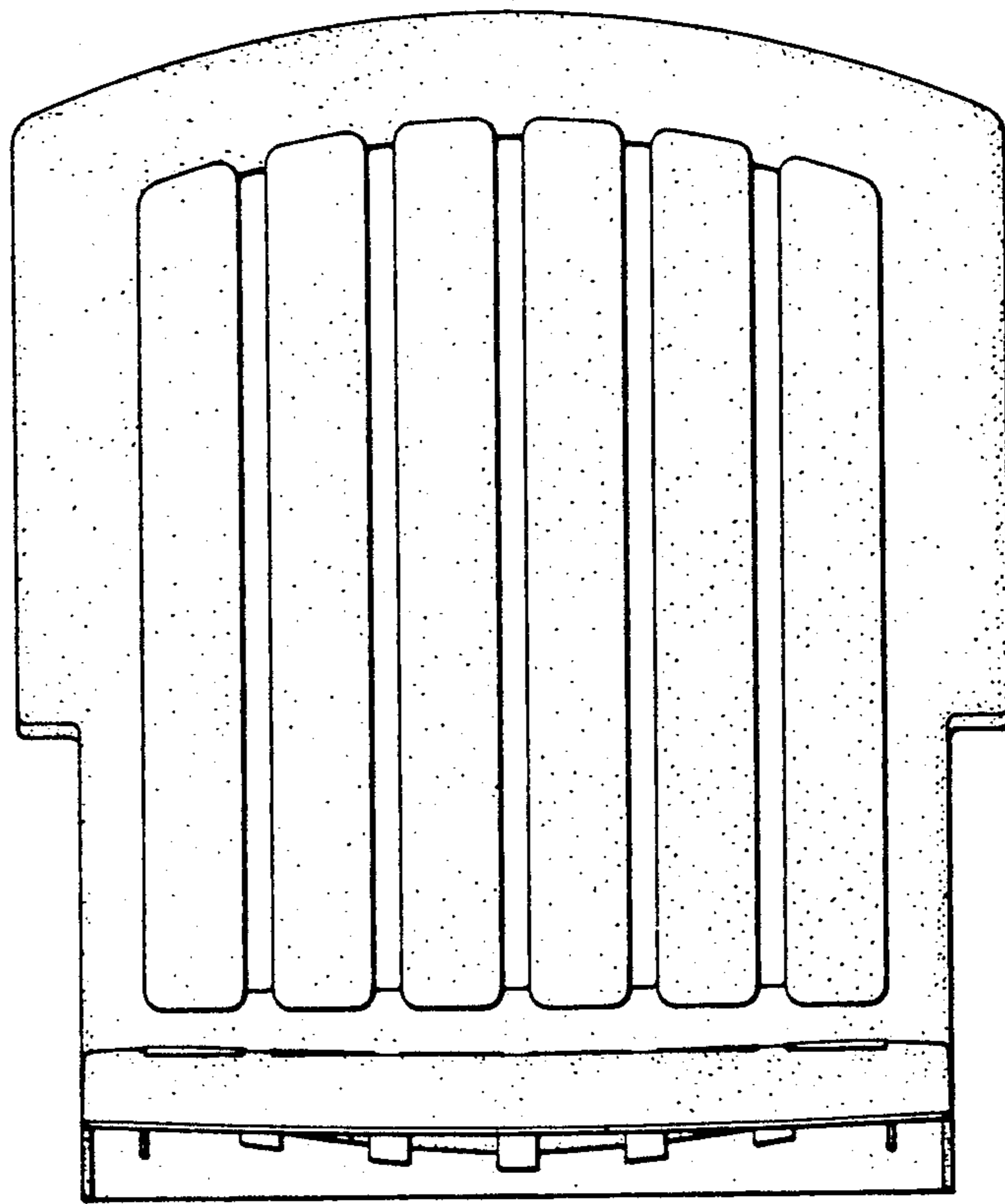

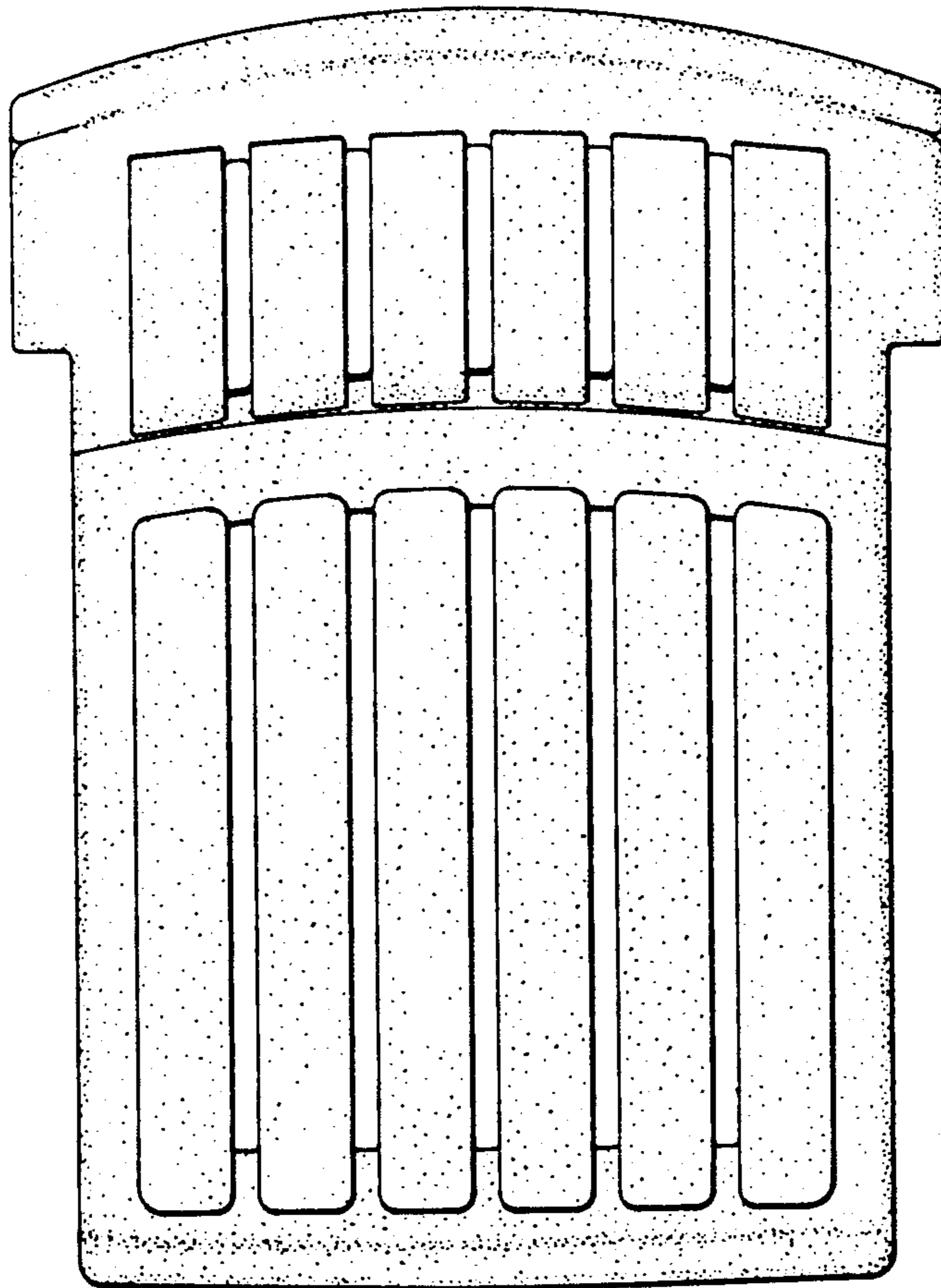

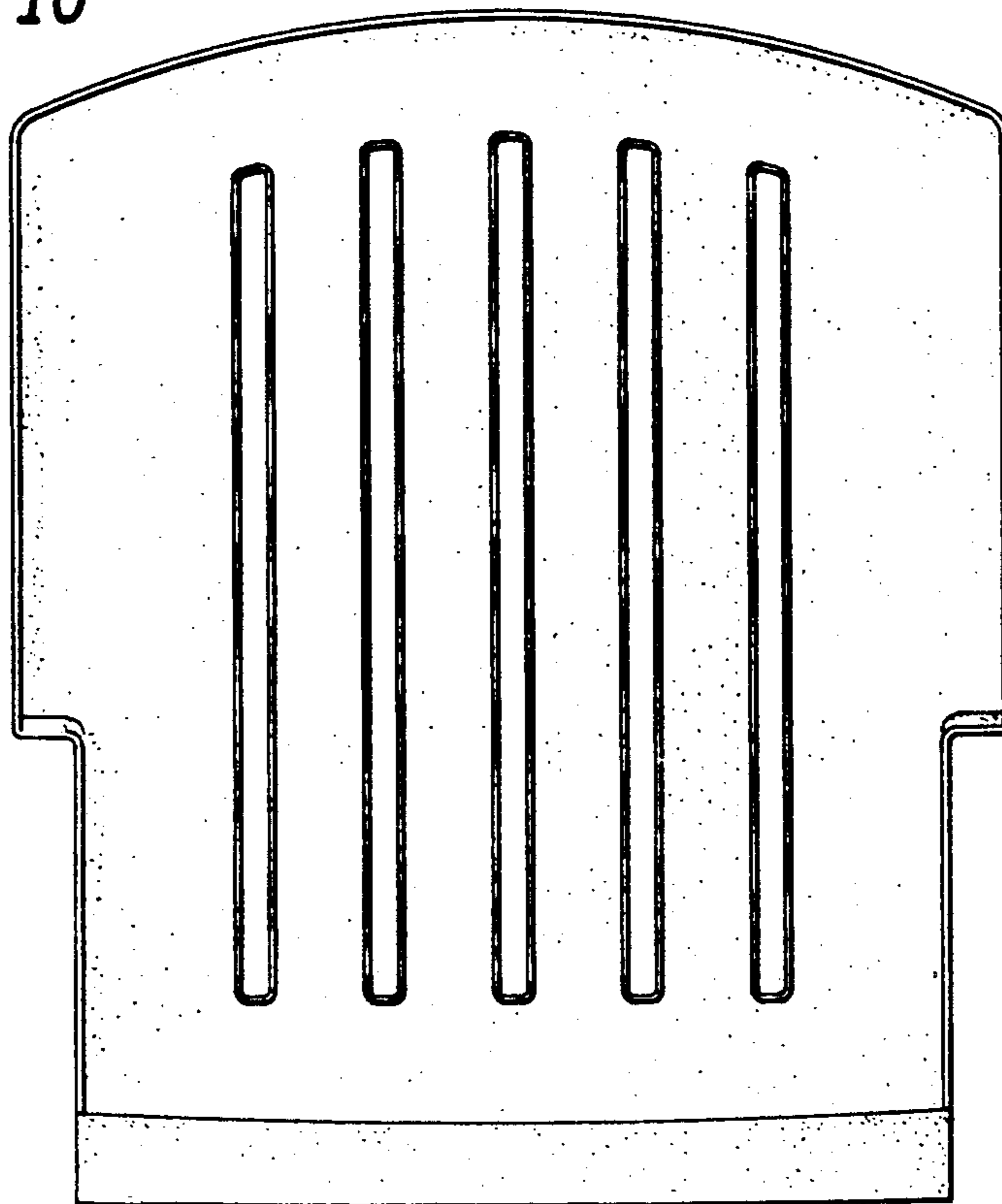

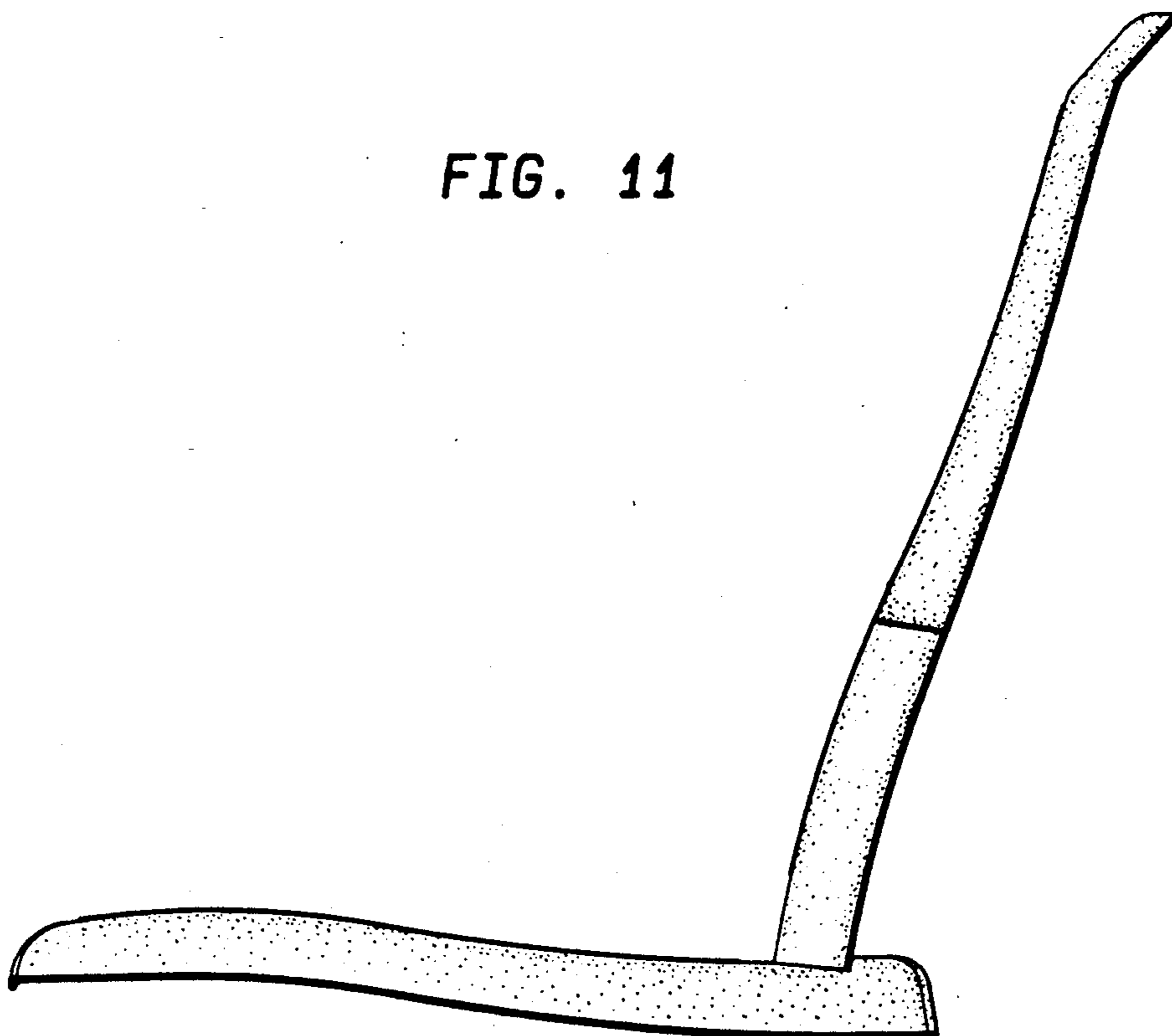
