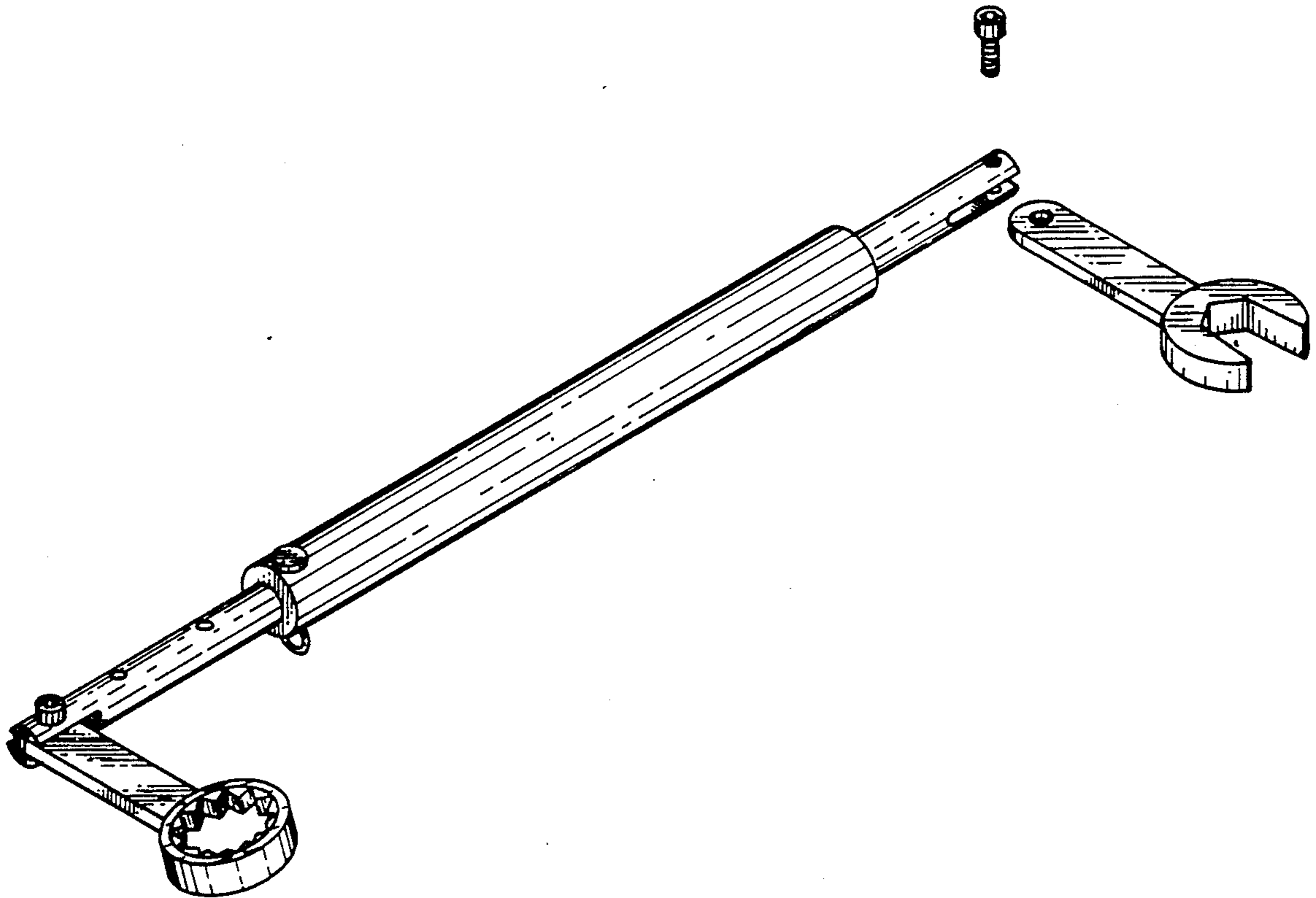

DESCRIPTION

FIG. 1 is a partially exploded perspective view of a wrench showing my new design;

 FIG. 15 is a left side elevational view of FIG. 9.



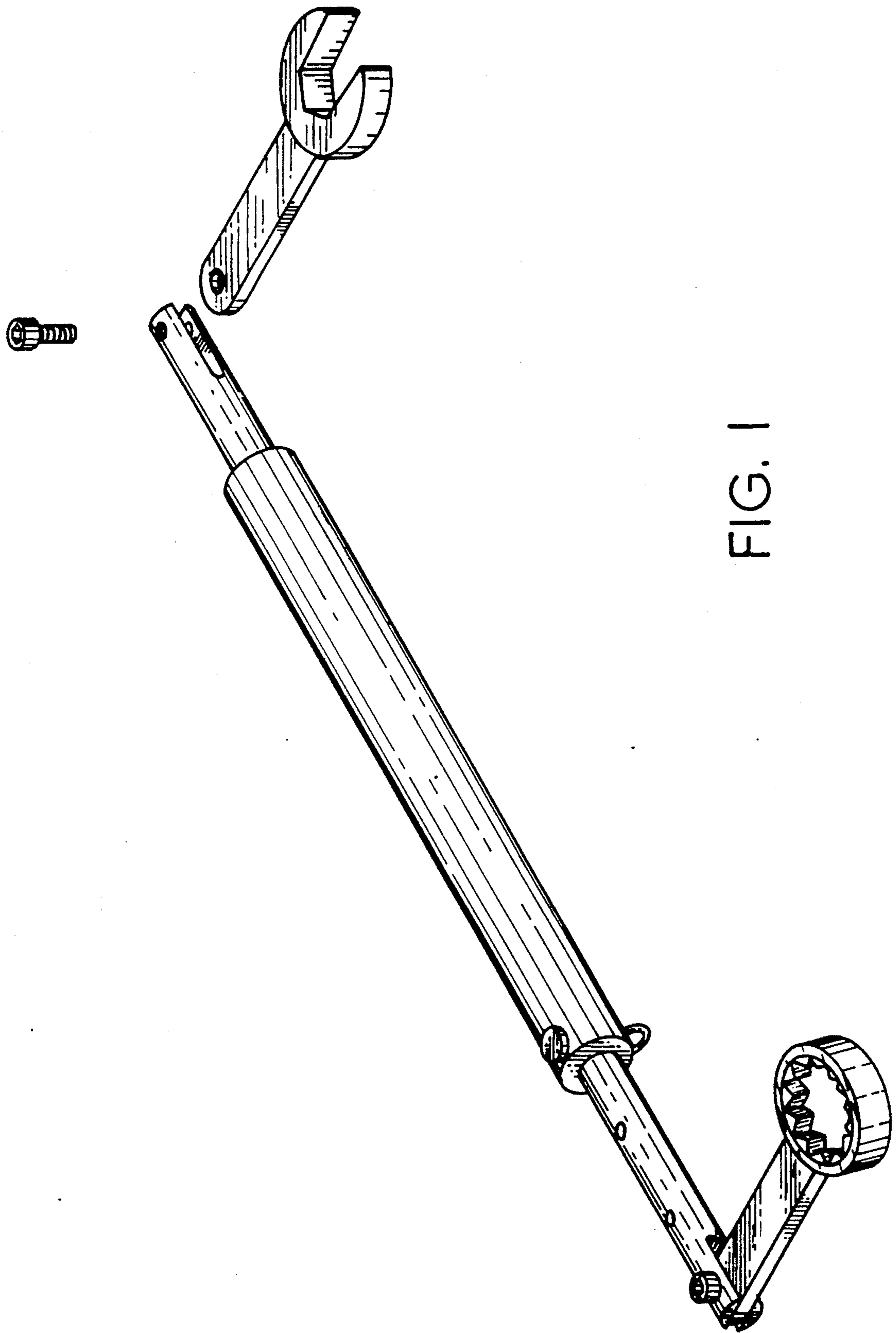

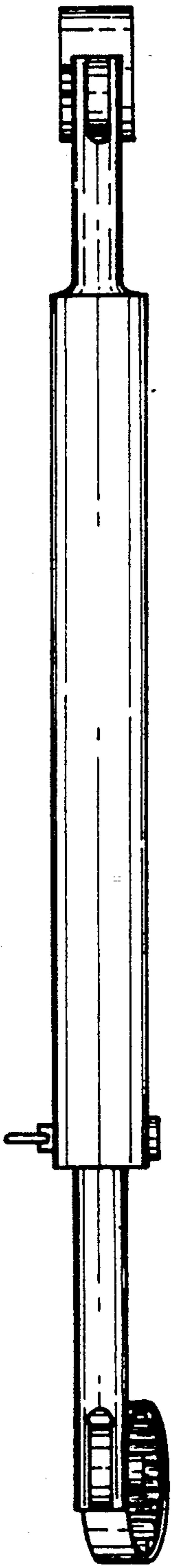

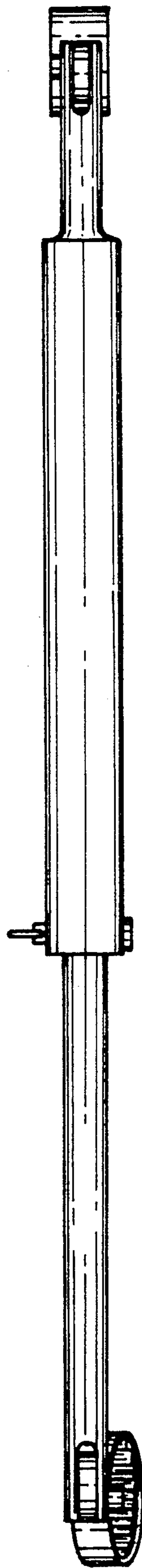
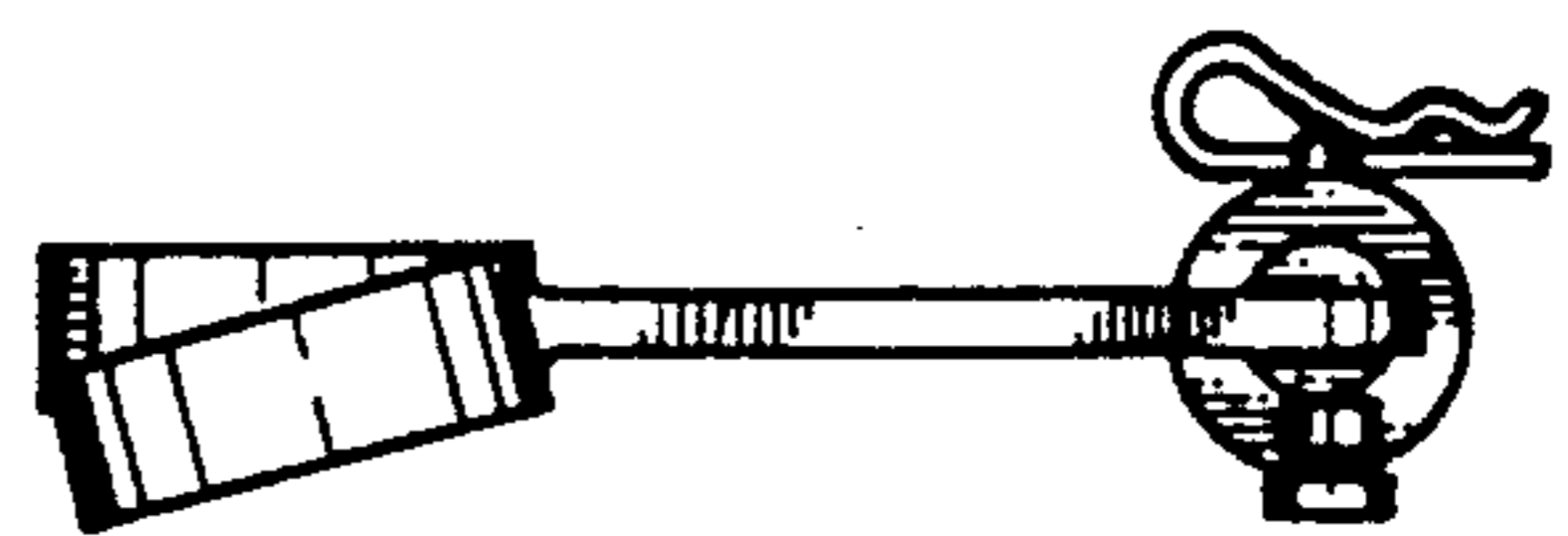
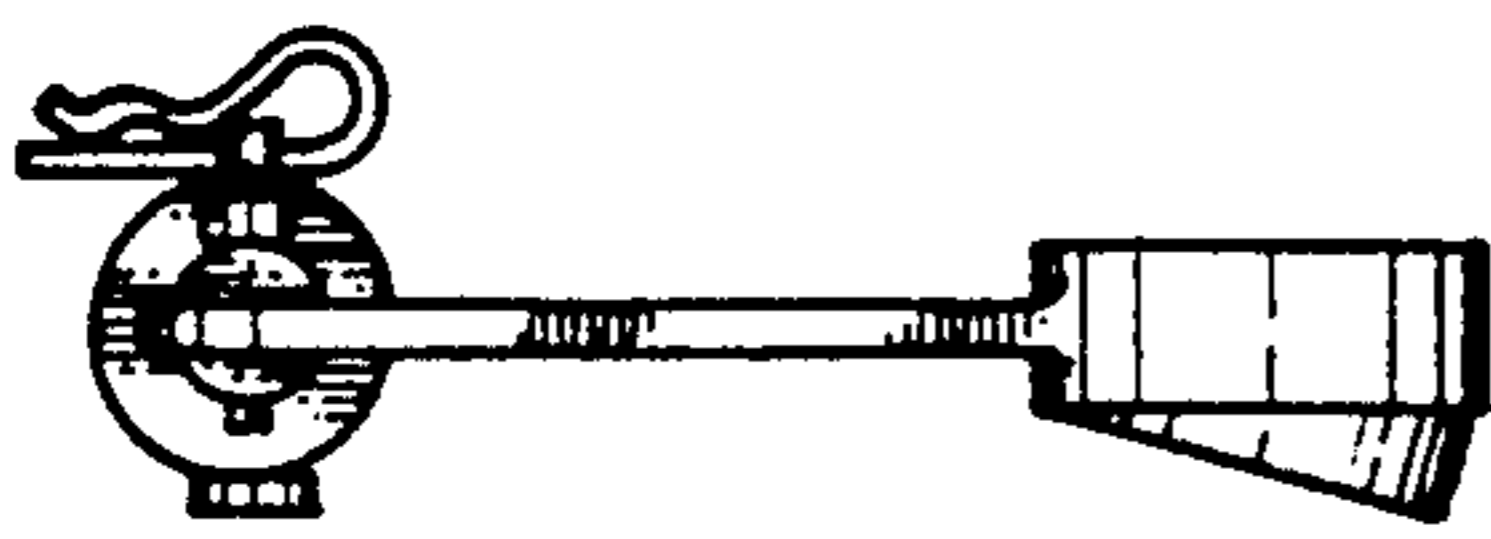
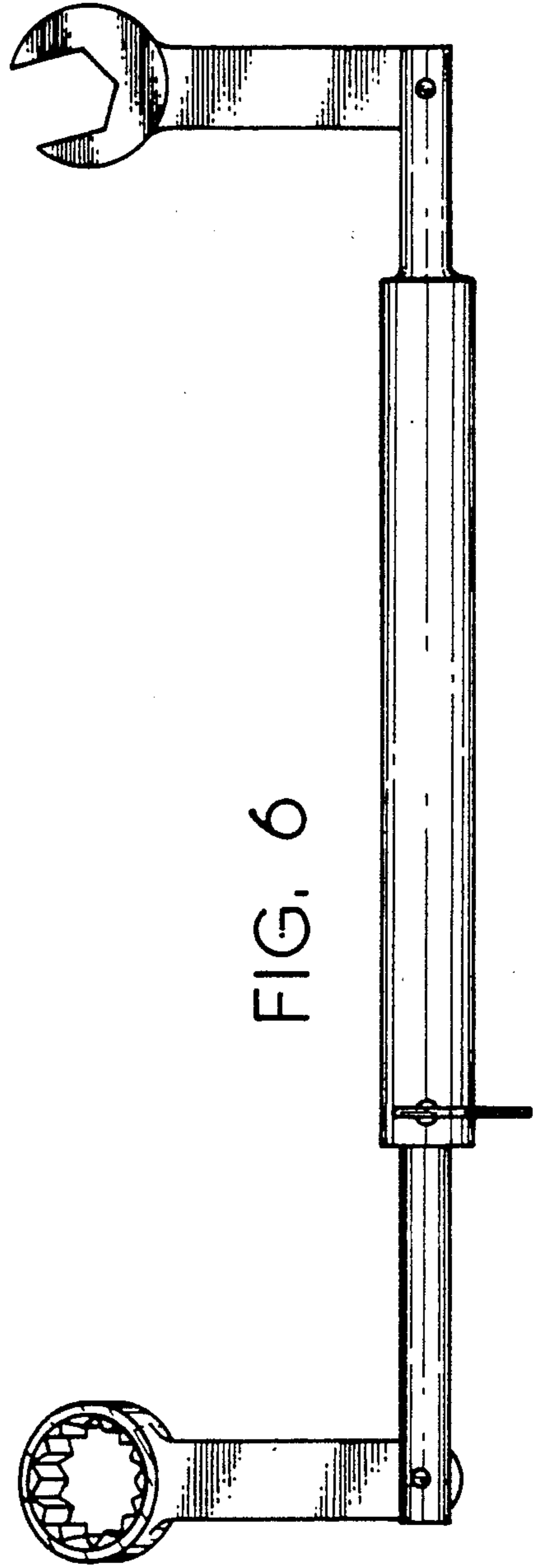
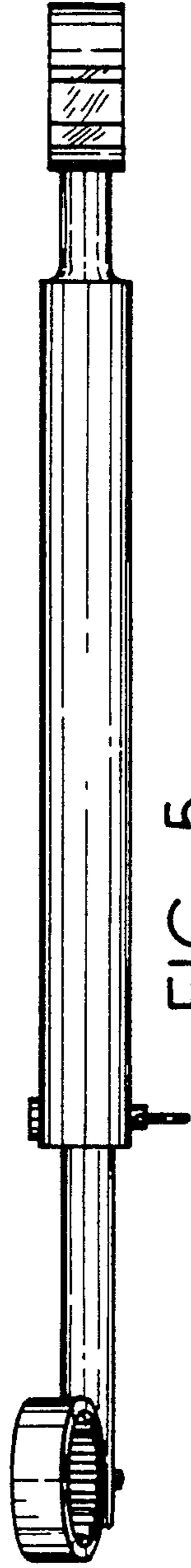
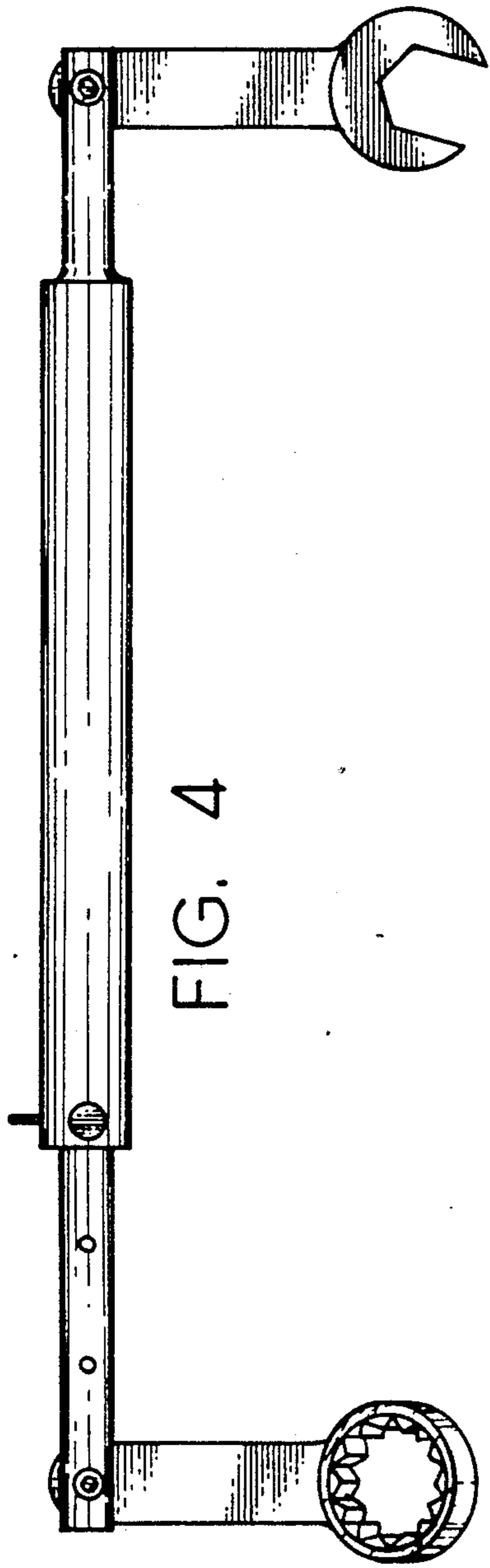

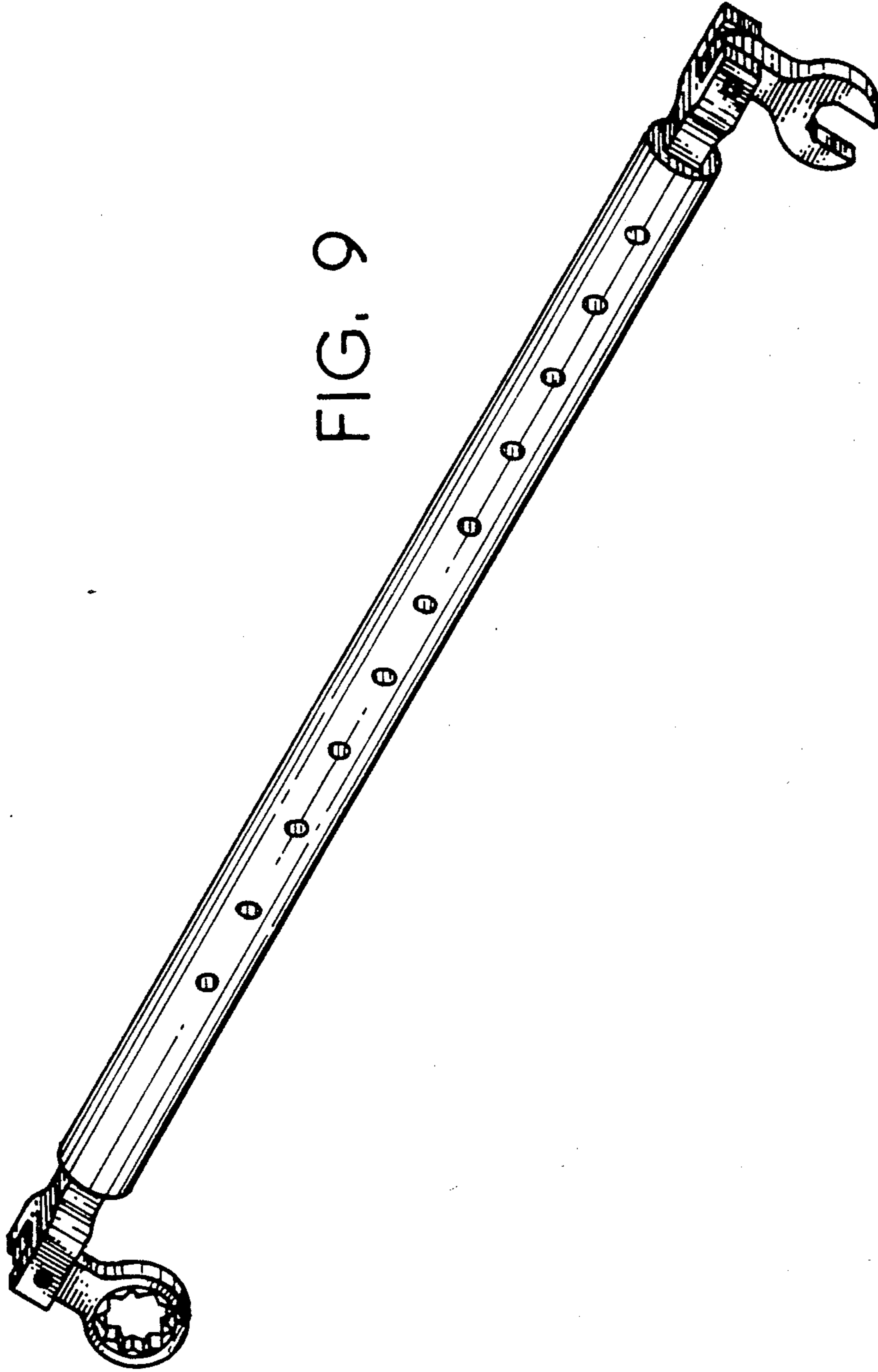

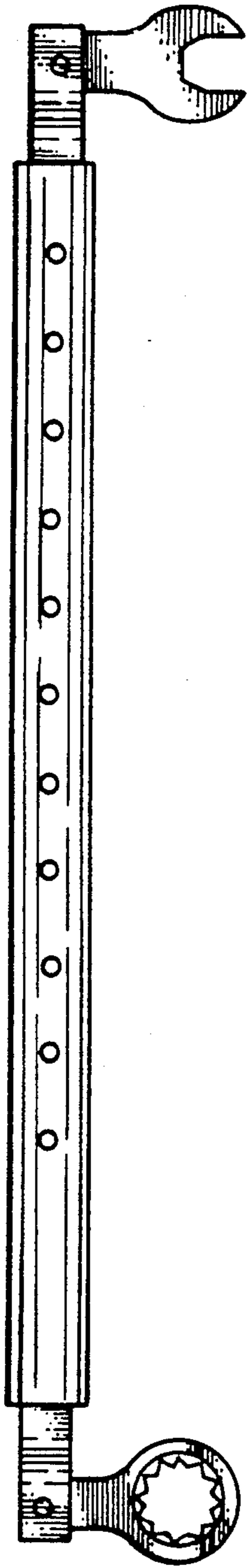

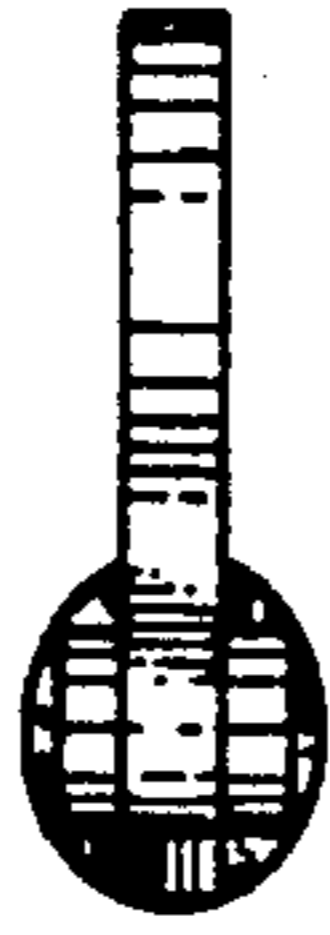

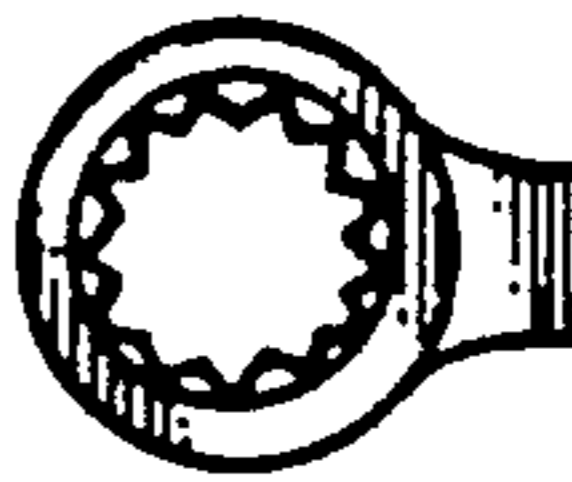

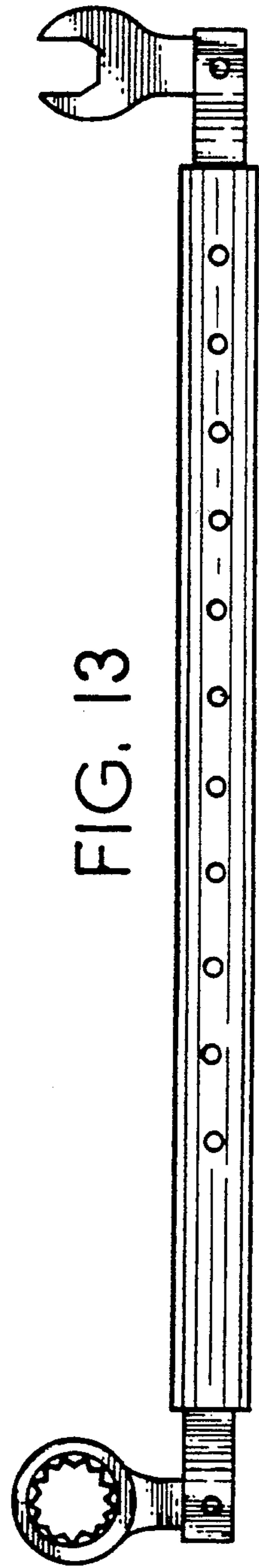
