[57] CLAIM

The ornamental design for an electrically powered three wheeled vehicle, as shown.

DESCRIPTION

FIG. 1 is a perspective view showing the front, right and top sides of an electrically powered three wheeled vehicle embodying the new design;

FIG. 2 is a left side elevational view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a top plan view thereof; and,

FIG. 6 is a bottom plan view thereof.

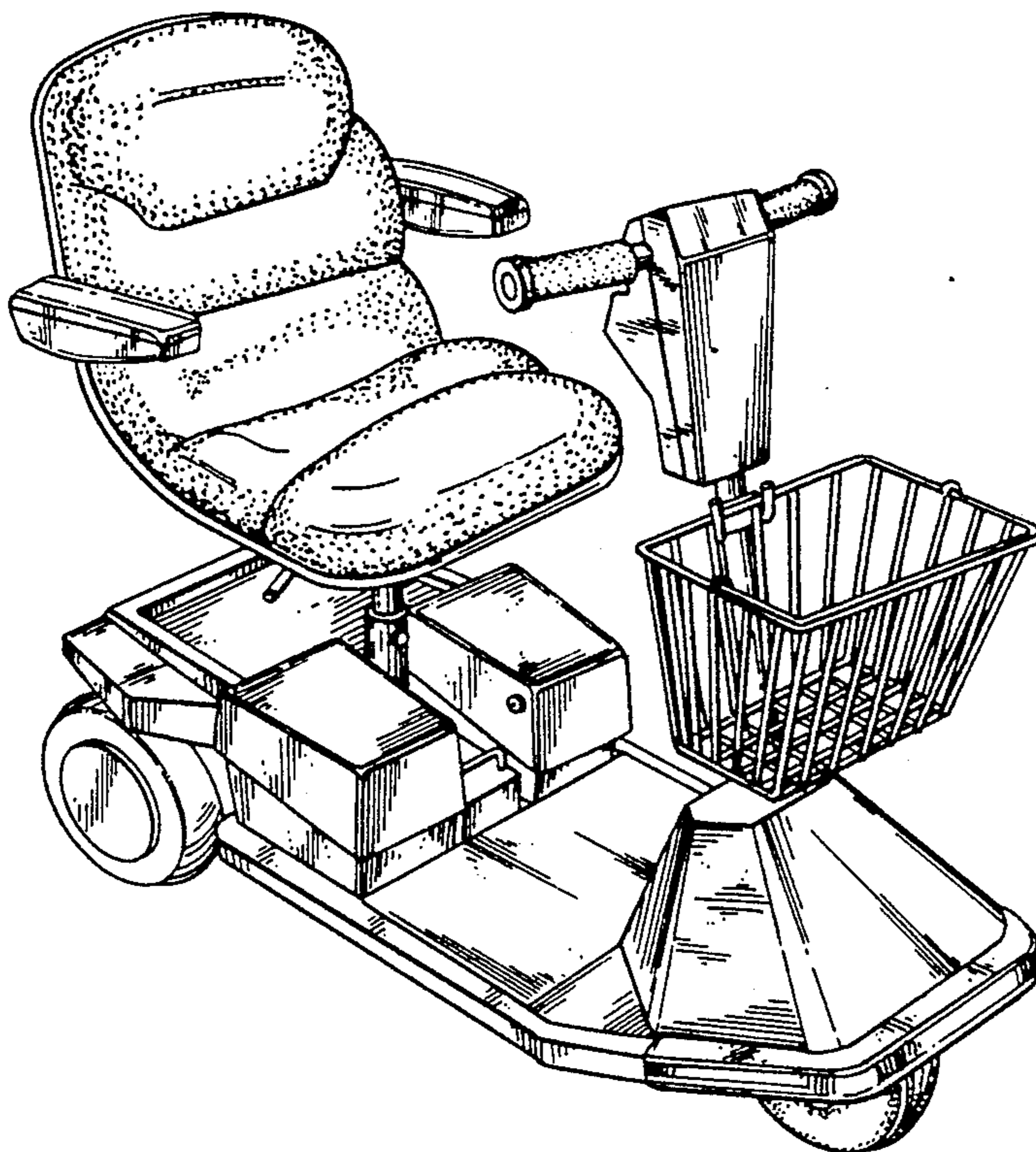

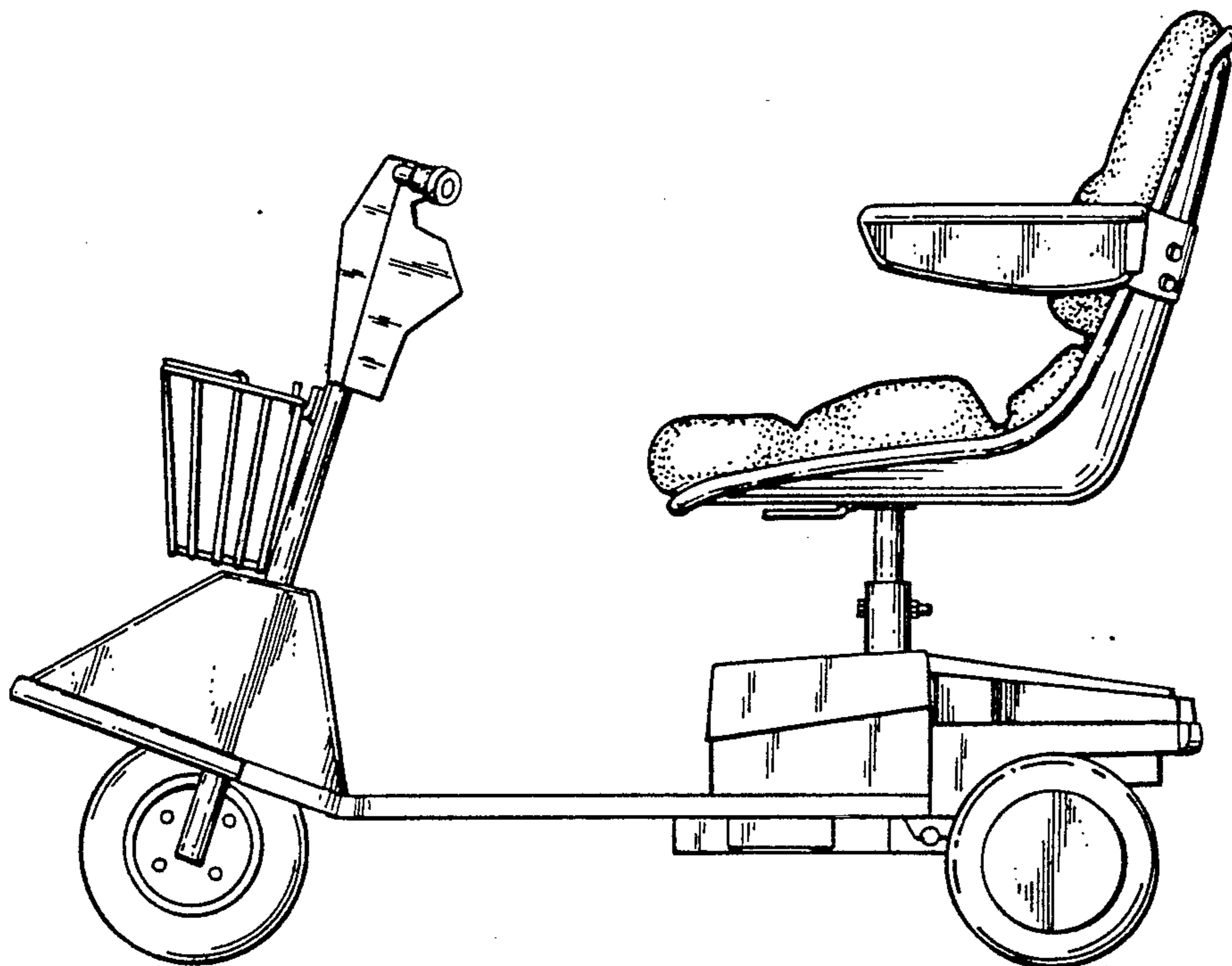
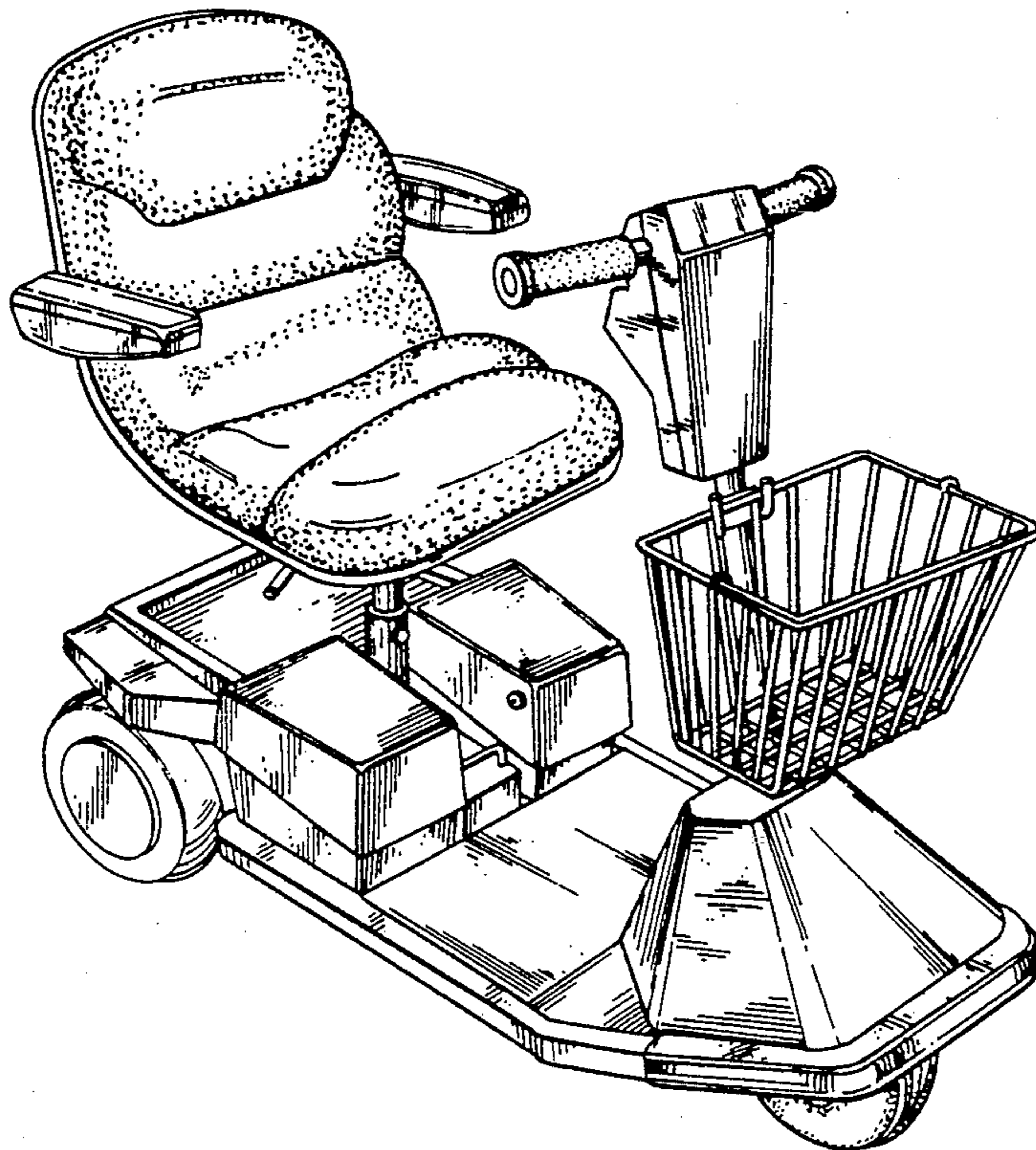

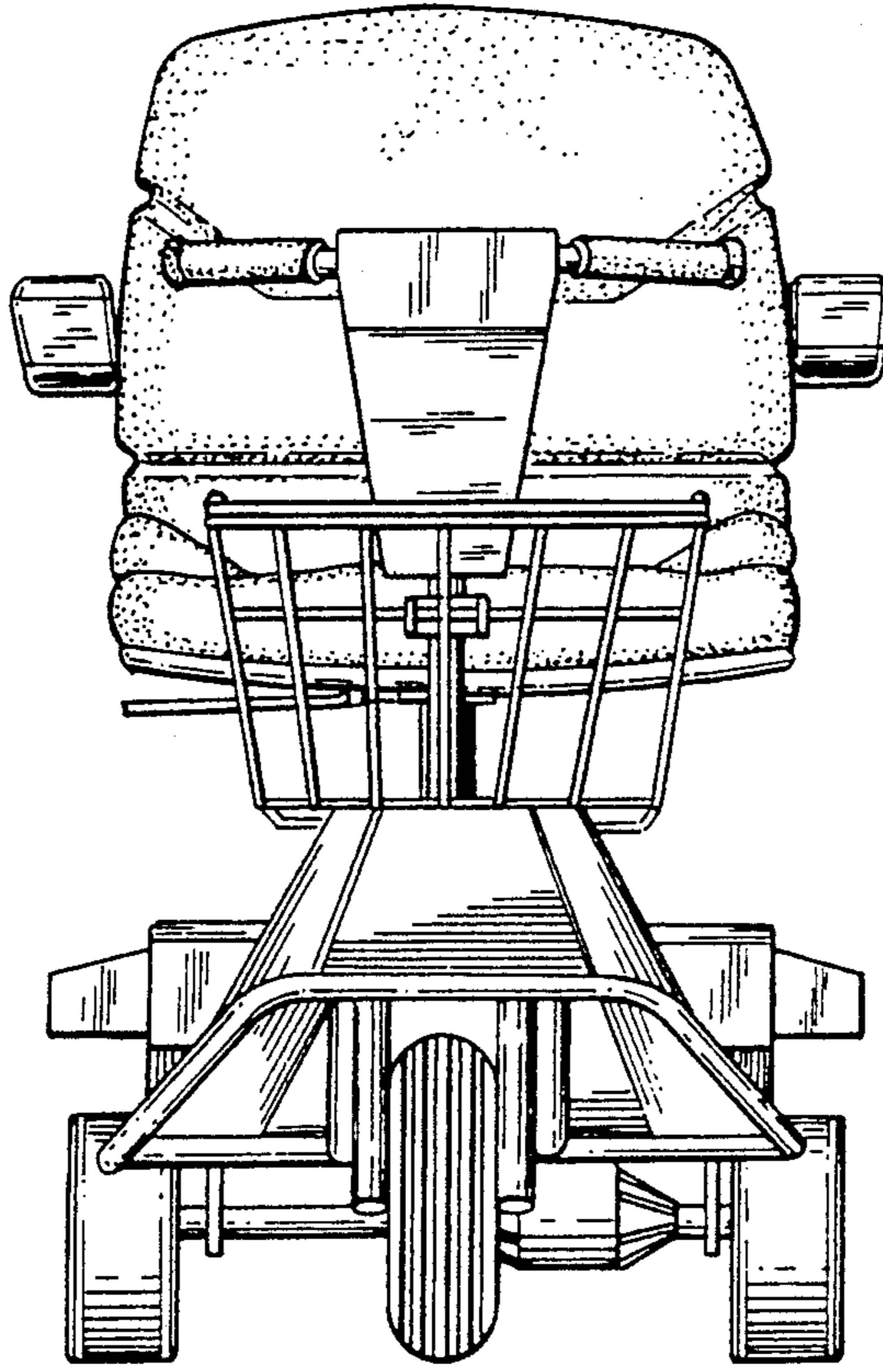
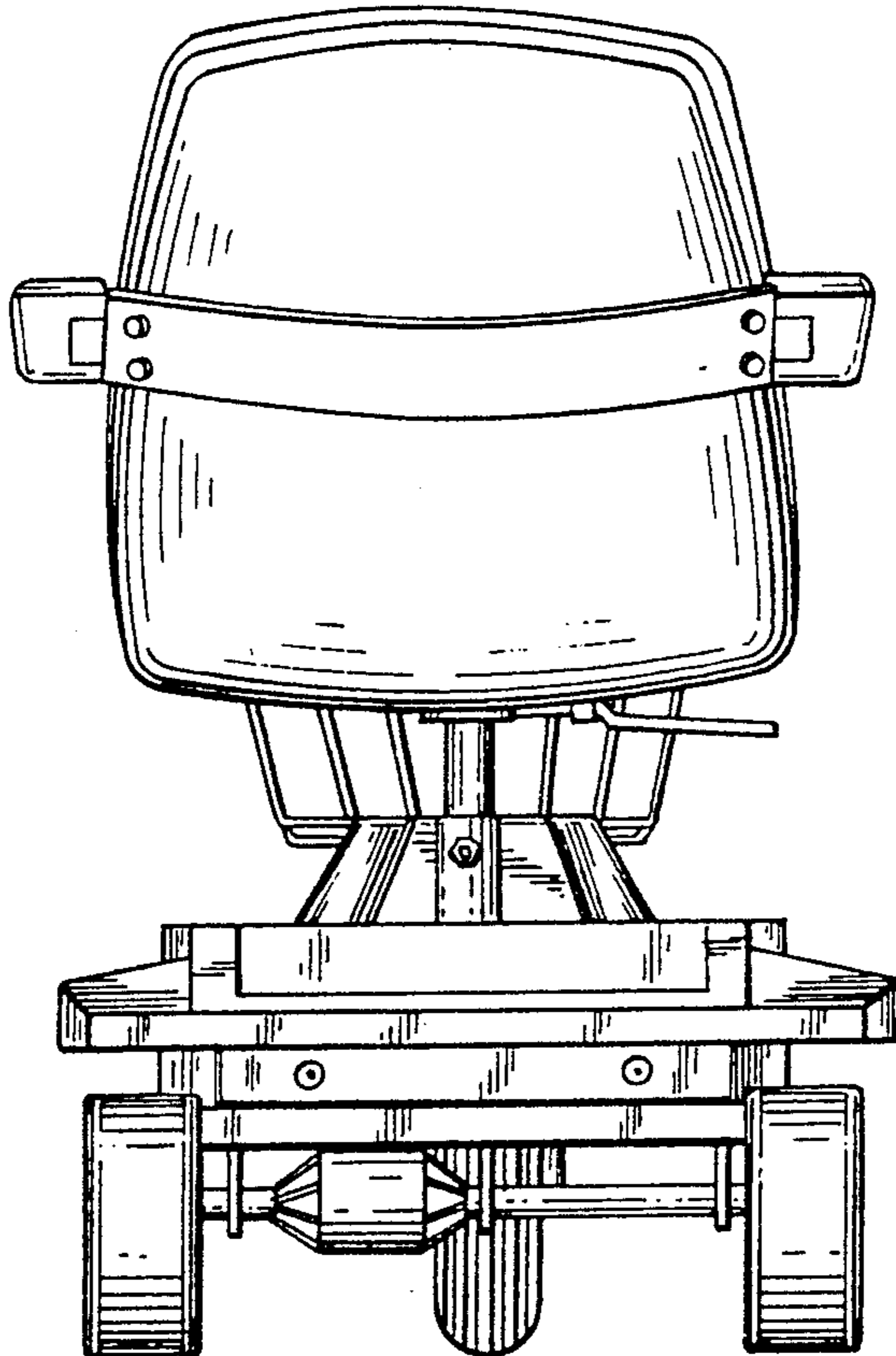

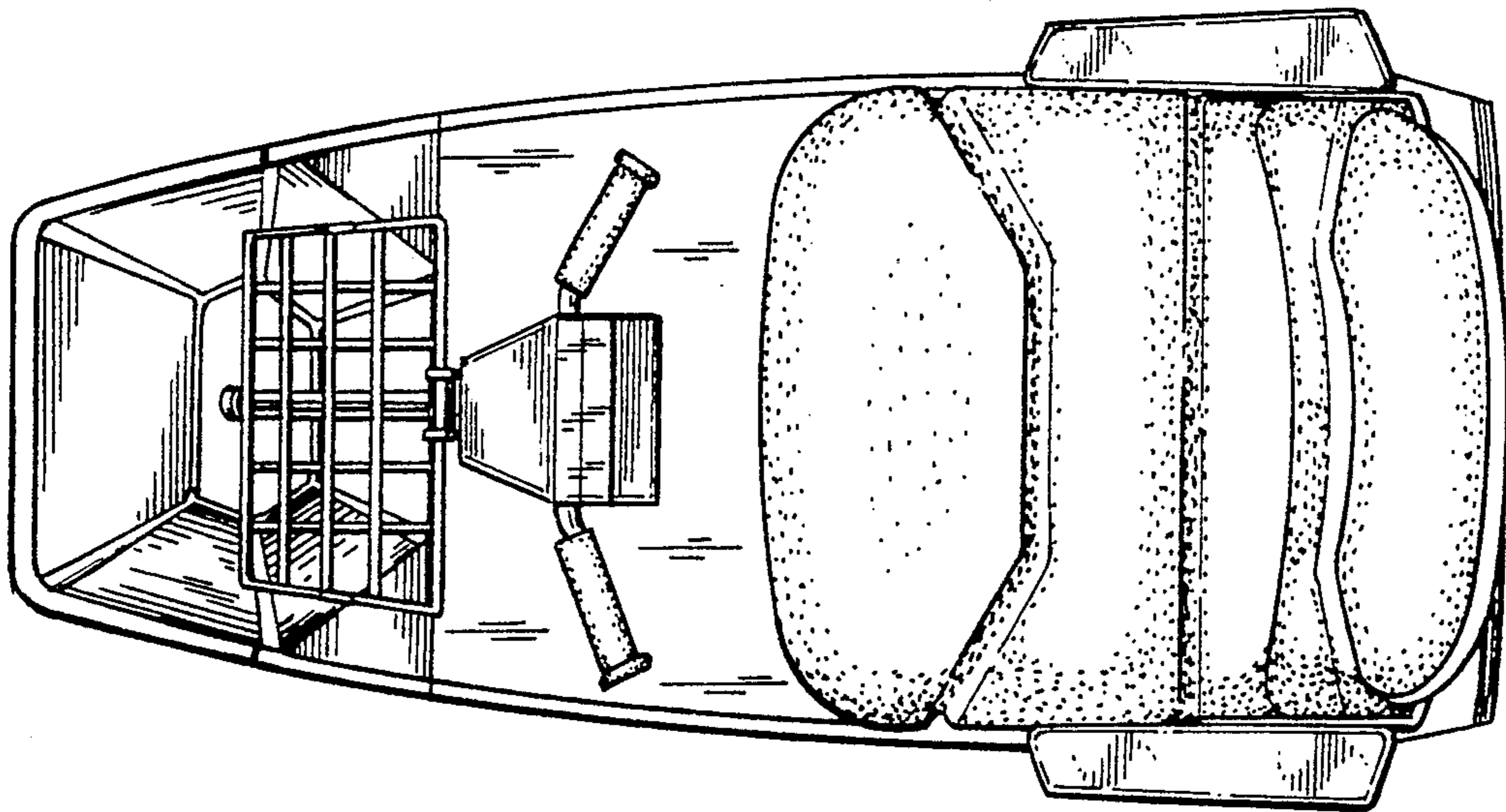

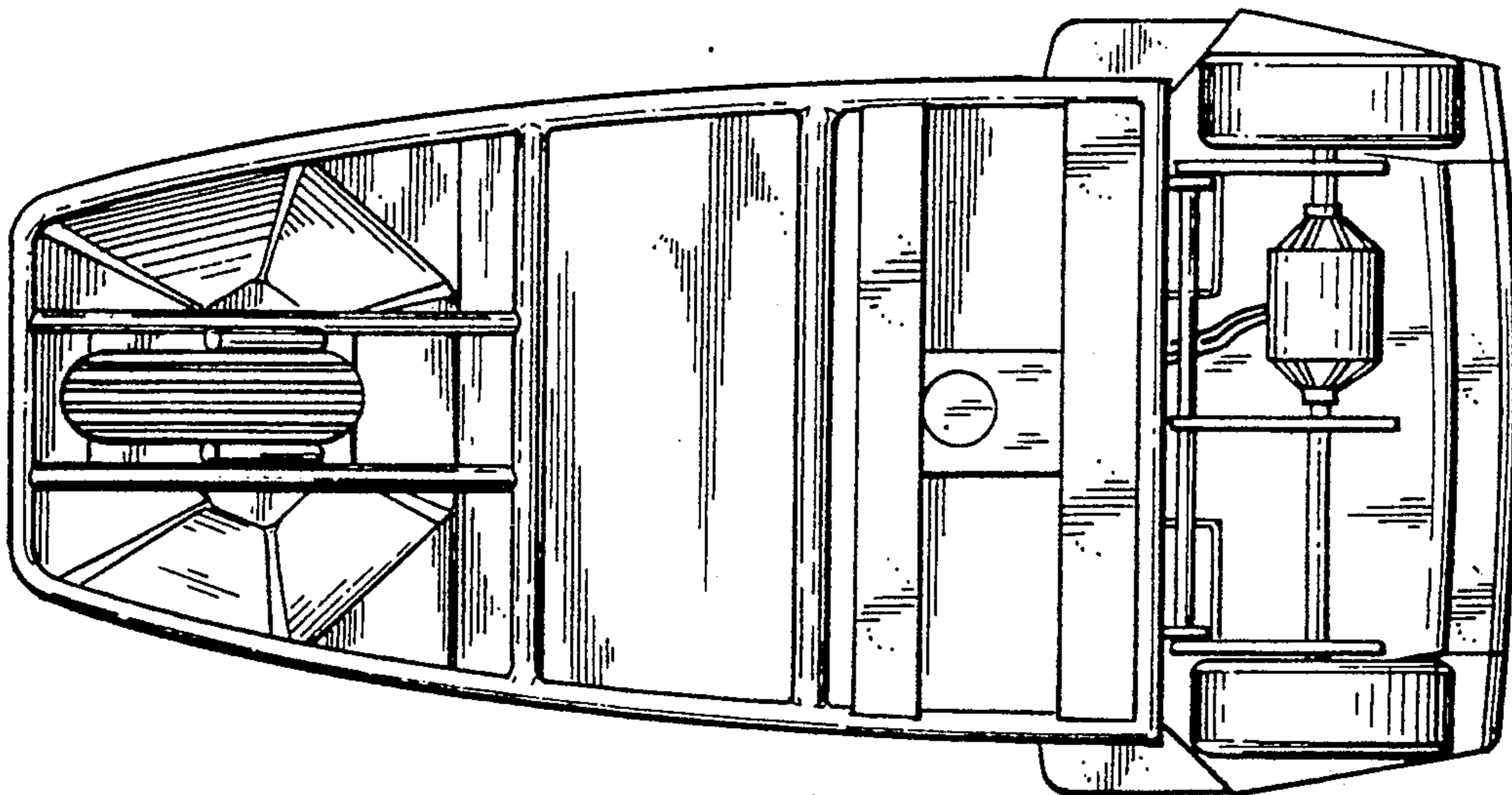
