[57] CLAIM

The ornamental design for an electrical connector housing, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of an electrical connector housing showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a left side elevational view thereof, the right side elevational view thereof being a mirror image; FIG. 5 is a rear elevational view thereof; FIG. 6 is a cross-sectional view thereof taken along line 6—6 of FIG. 2; FIG. 7 is a cross-sectional view thereof taken along line 7—7 of FIG. 2; FIG. 8 is a cross-sectional view thereof taken along line 8—8 of FIG. 2; FIG. 9 is a cross-sectional view thereof taken along line 9—9 of FIG. 2; FIG. 10 is a cross-sectional view thereof taken along line 10—10 of FIG. 4; and, FIG. 11 is a rear and upper left perspective view thereof shown on a reduced scale with two members separate from the housing. The broken line showing of the corresponding housing and related elements is included for the purpose of illustrating environmental elements only and forms no part of the claimed design.

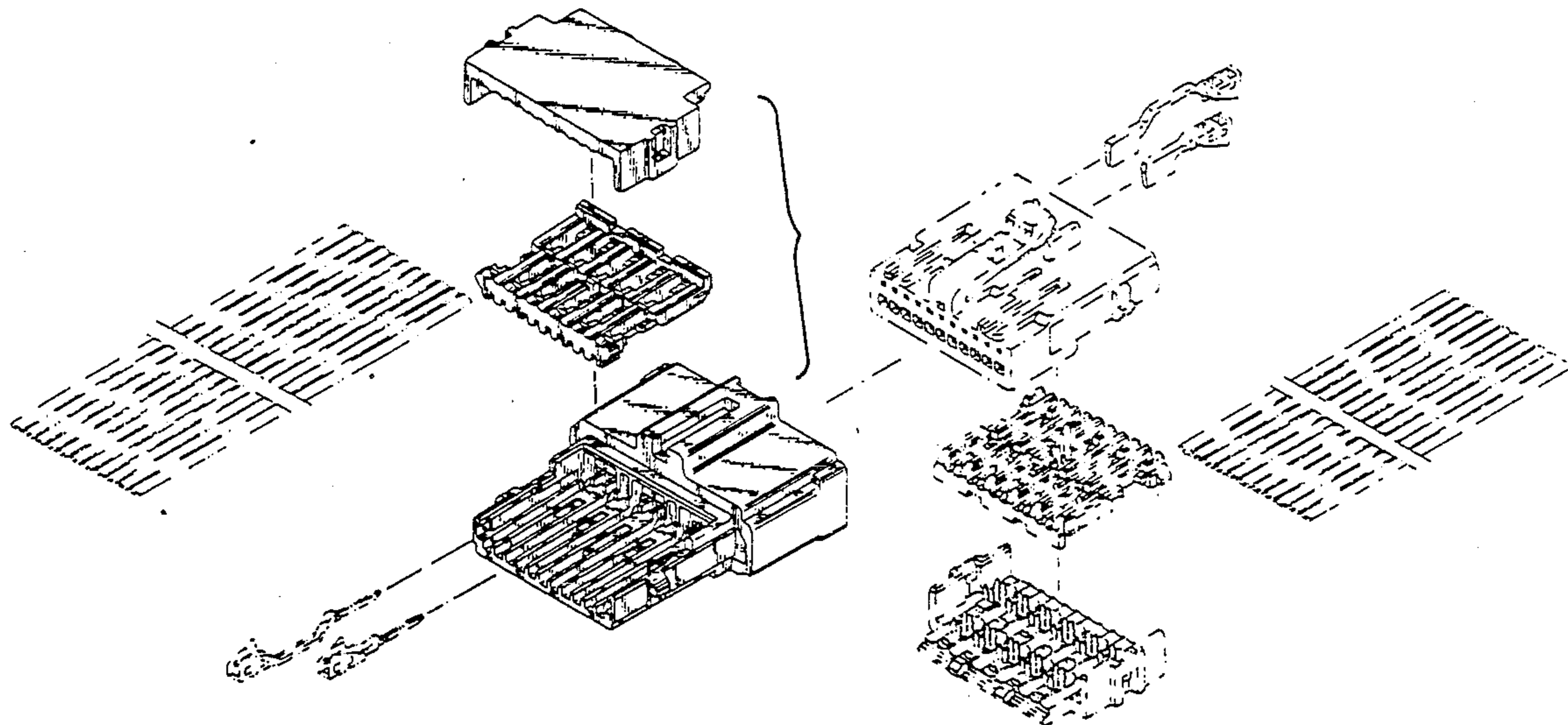

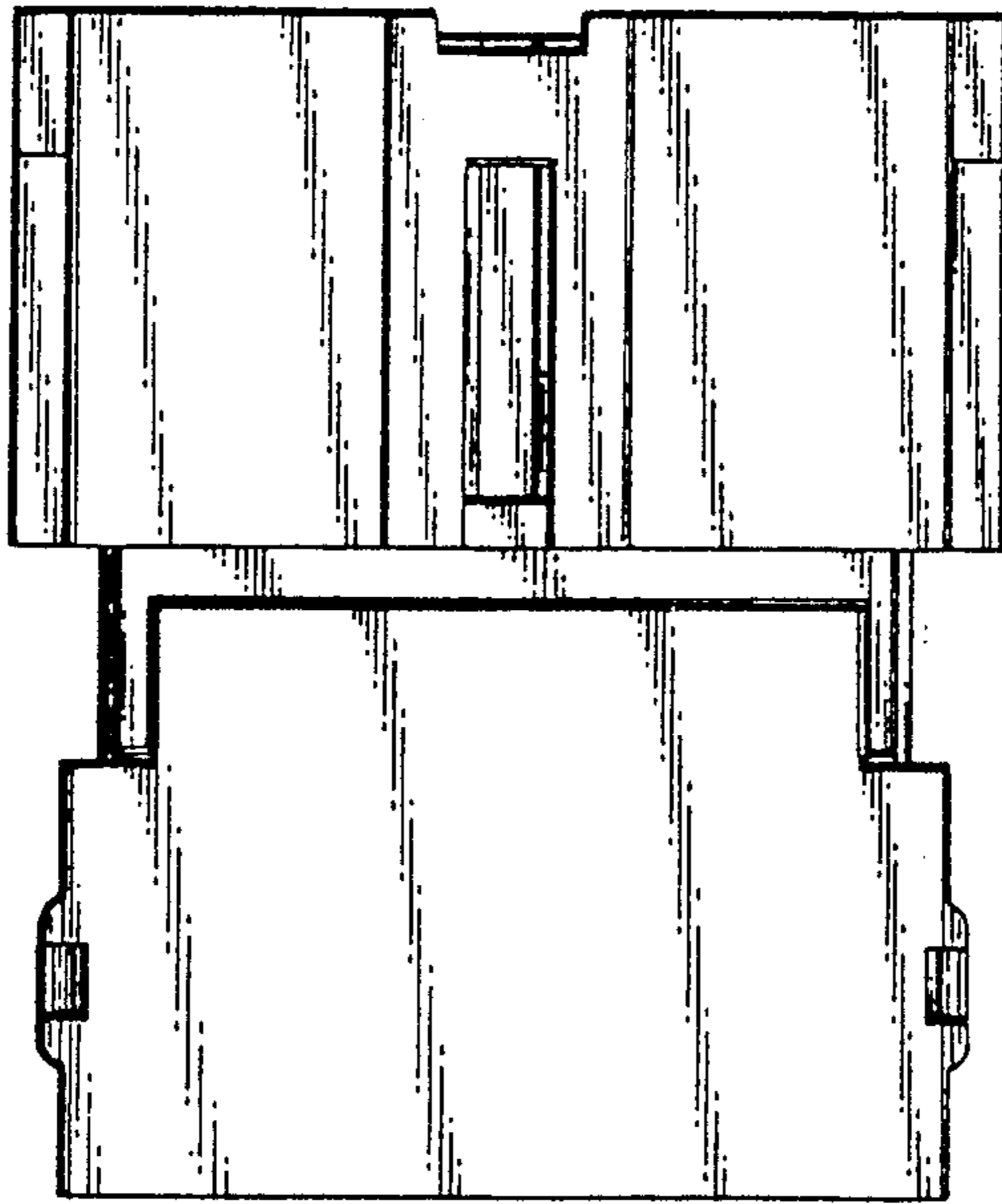

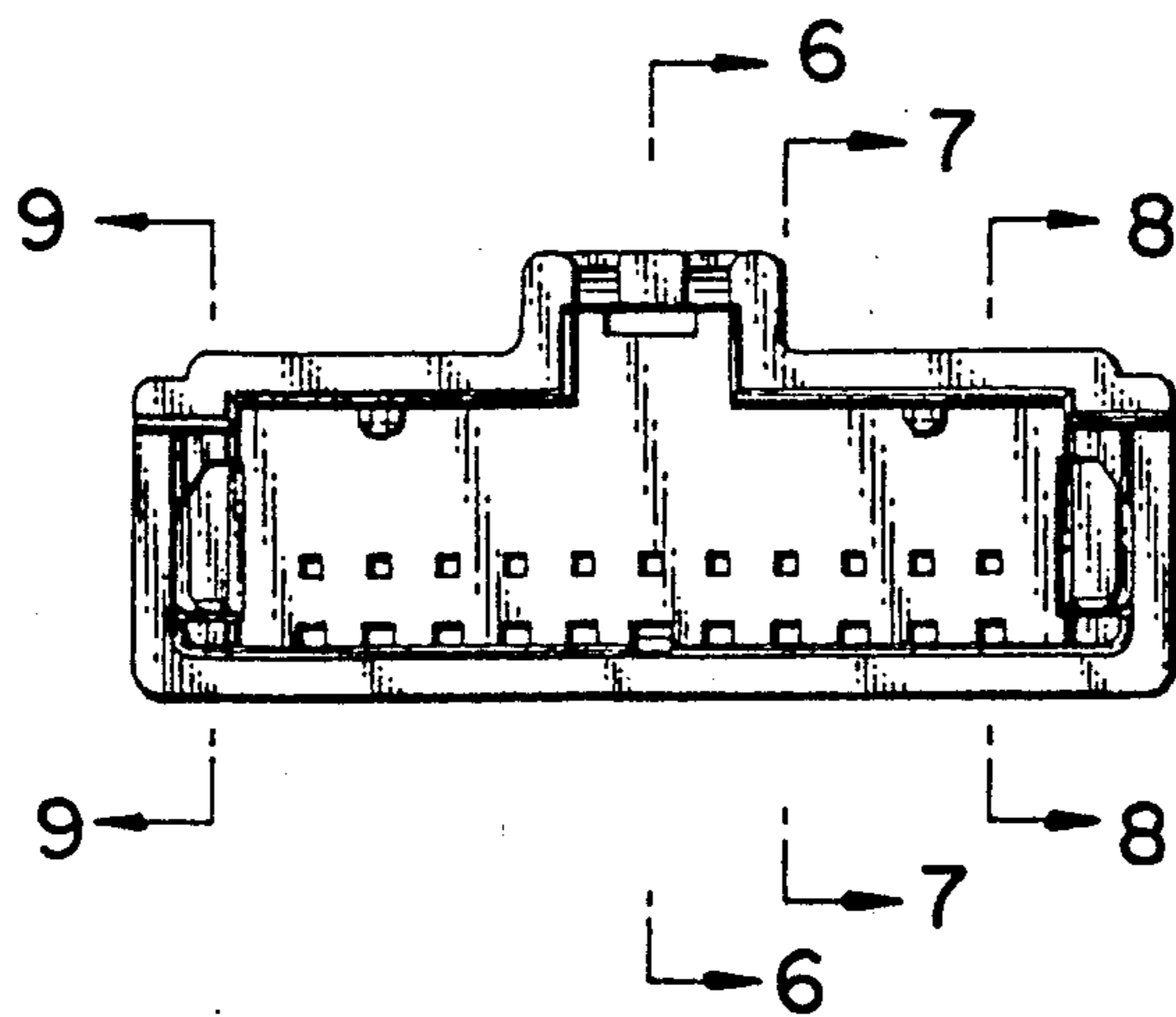

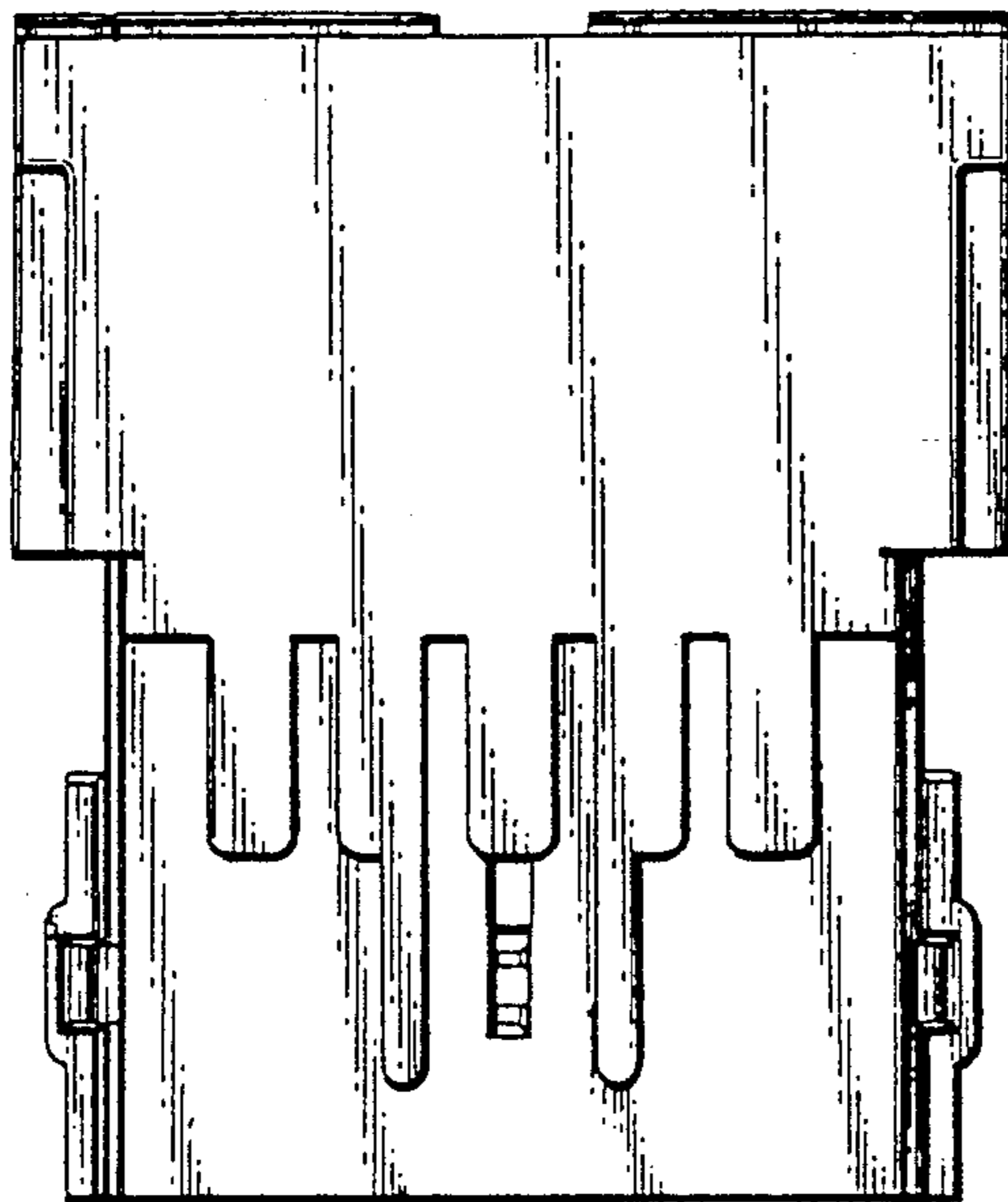

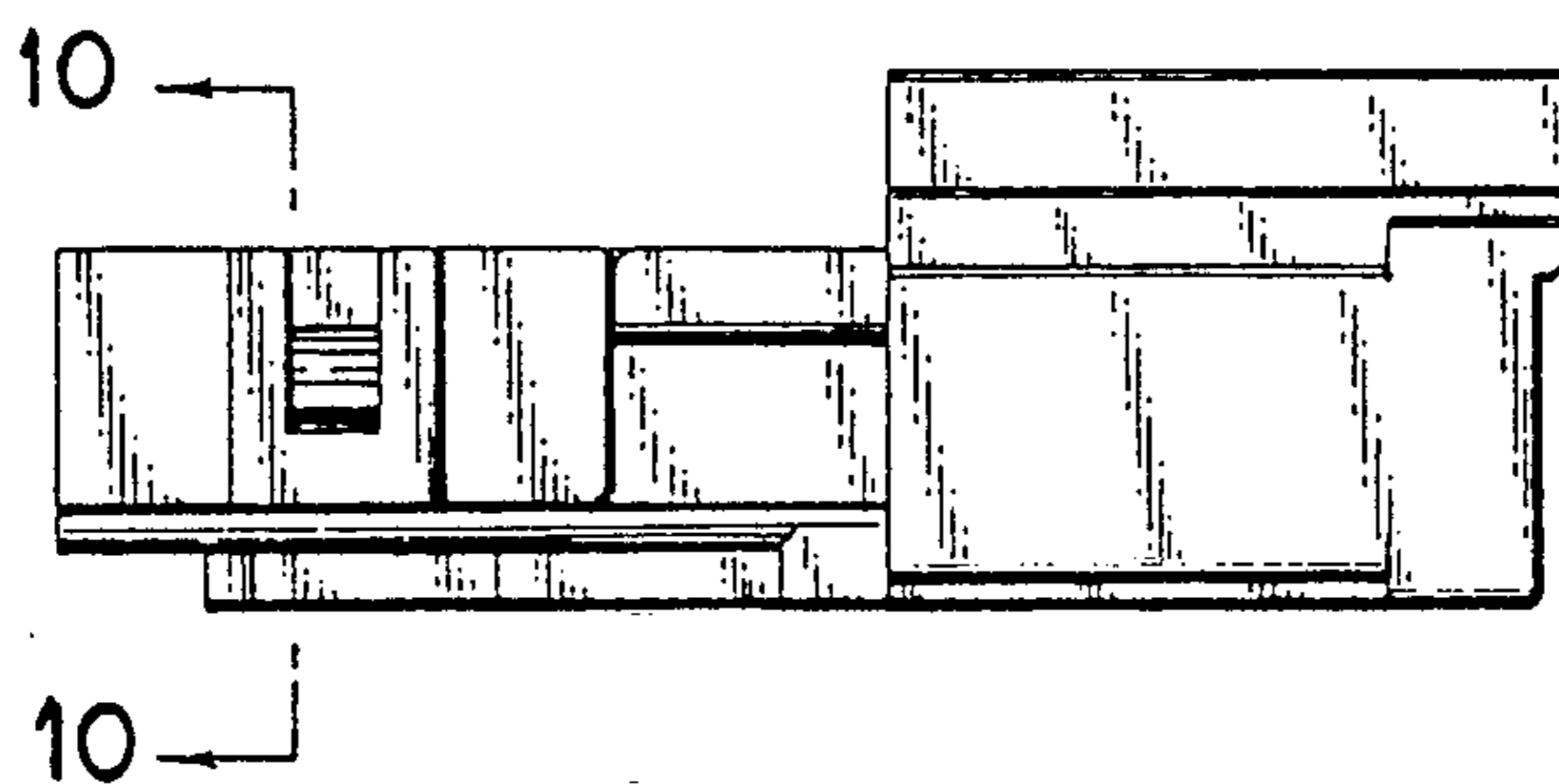

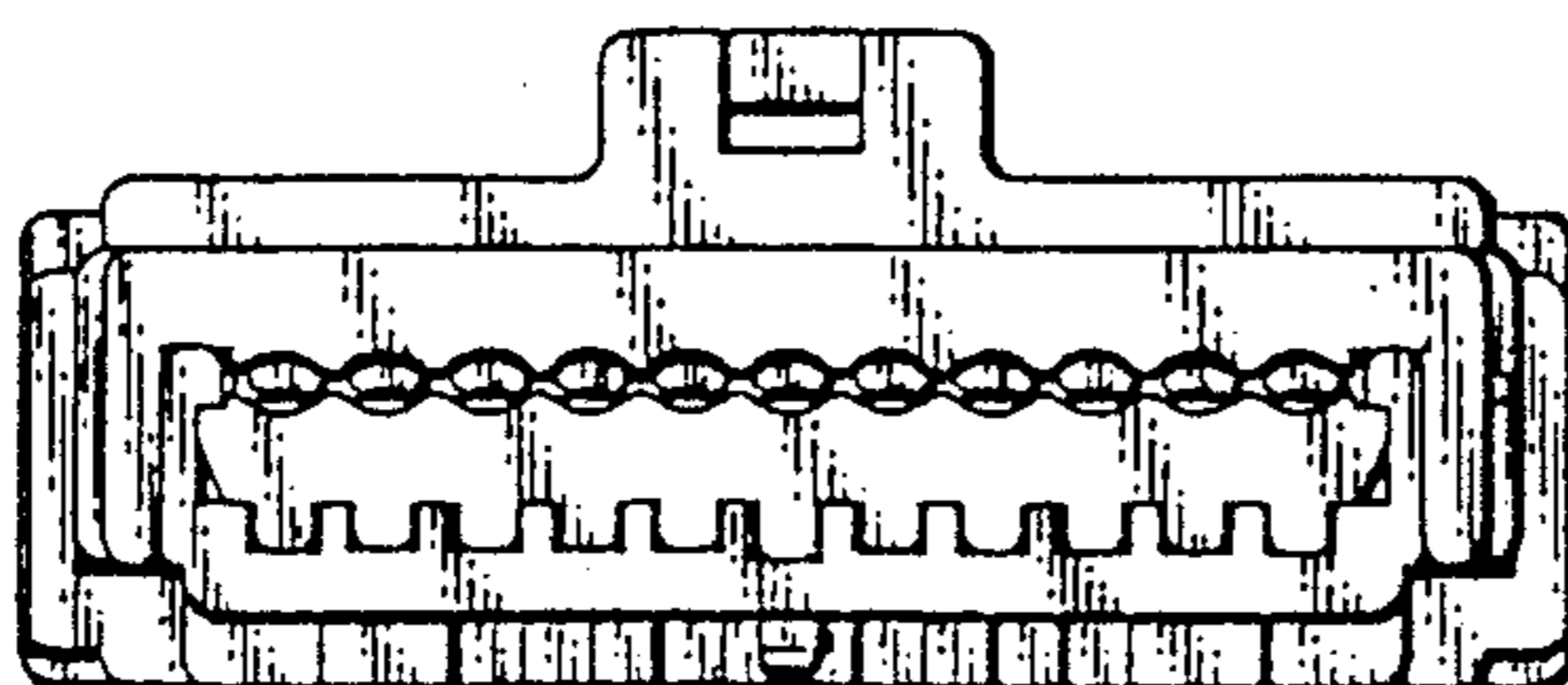

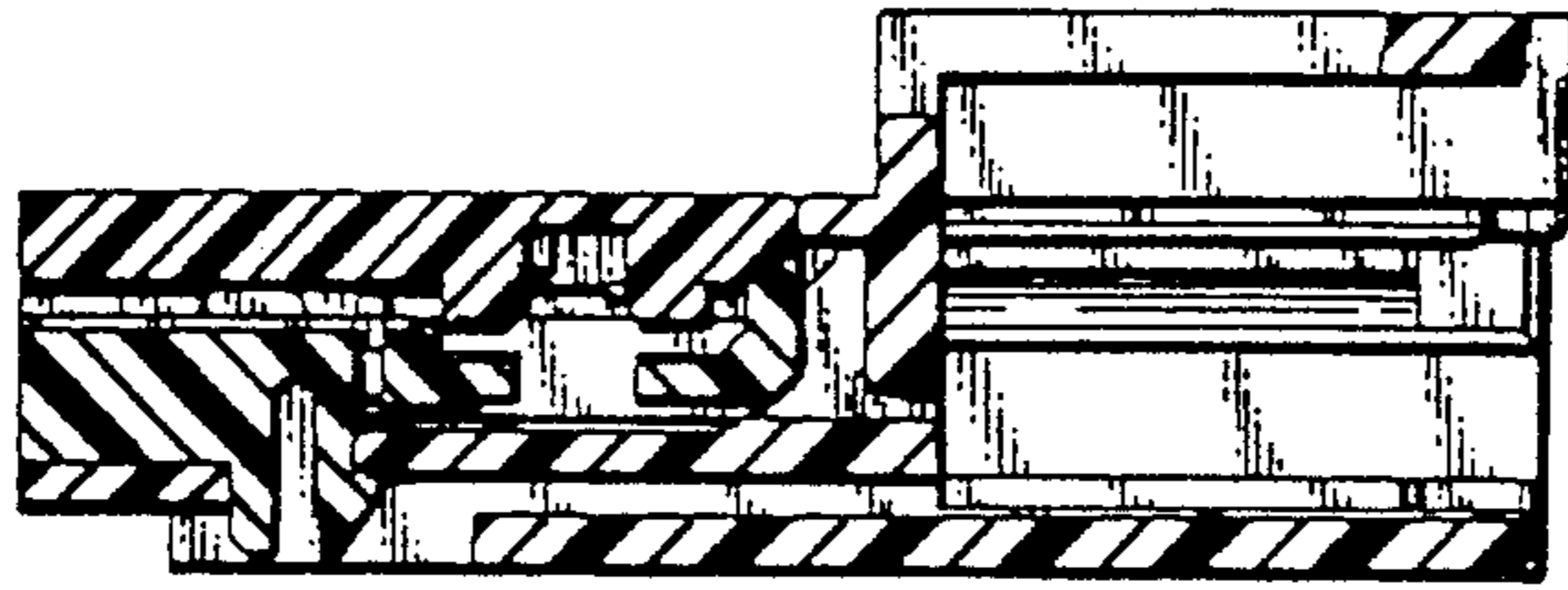

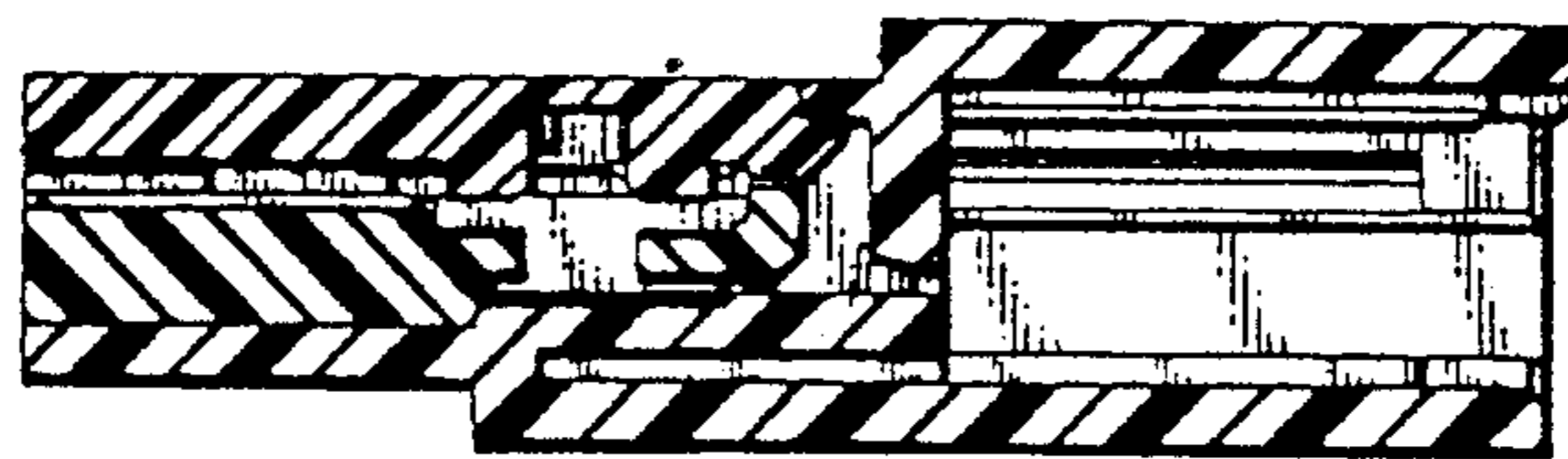

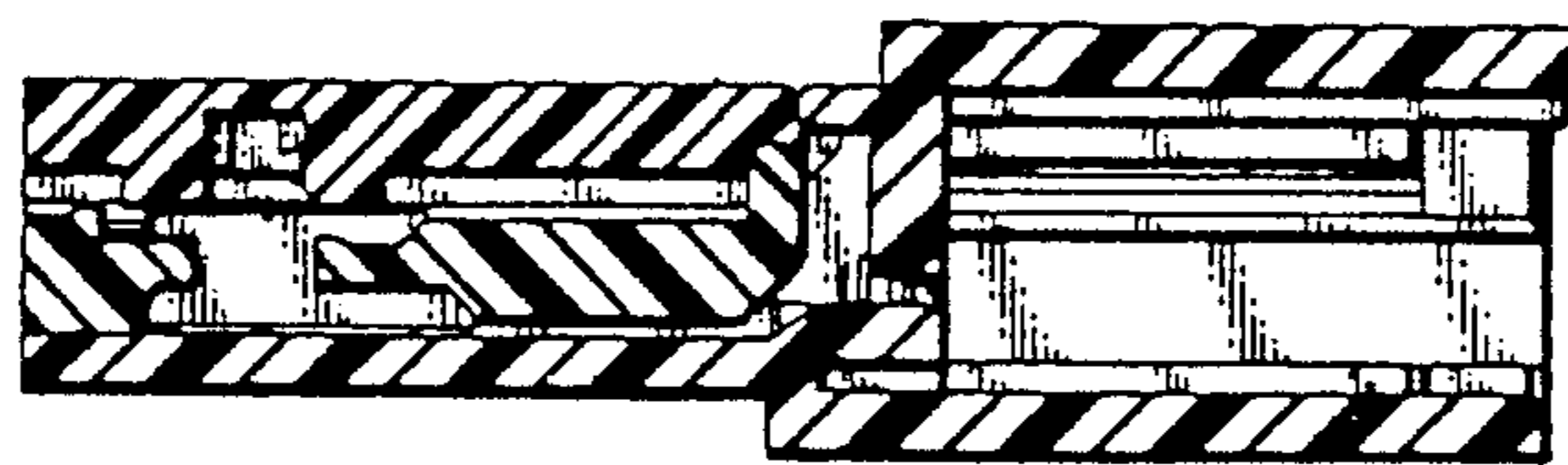

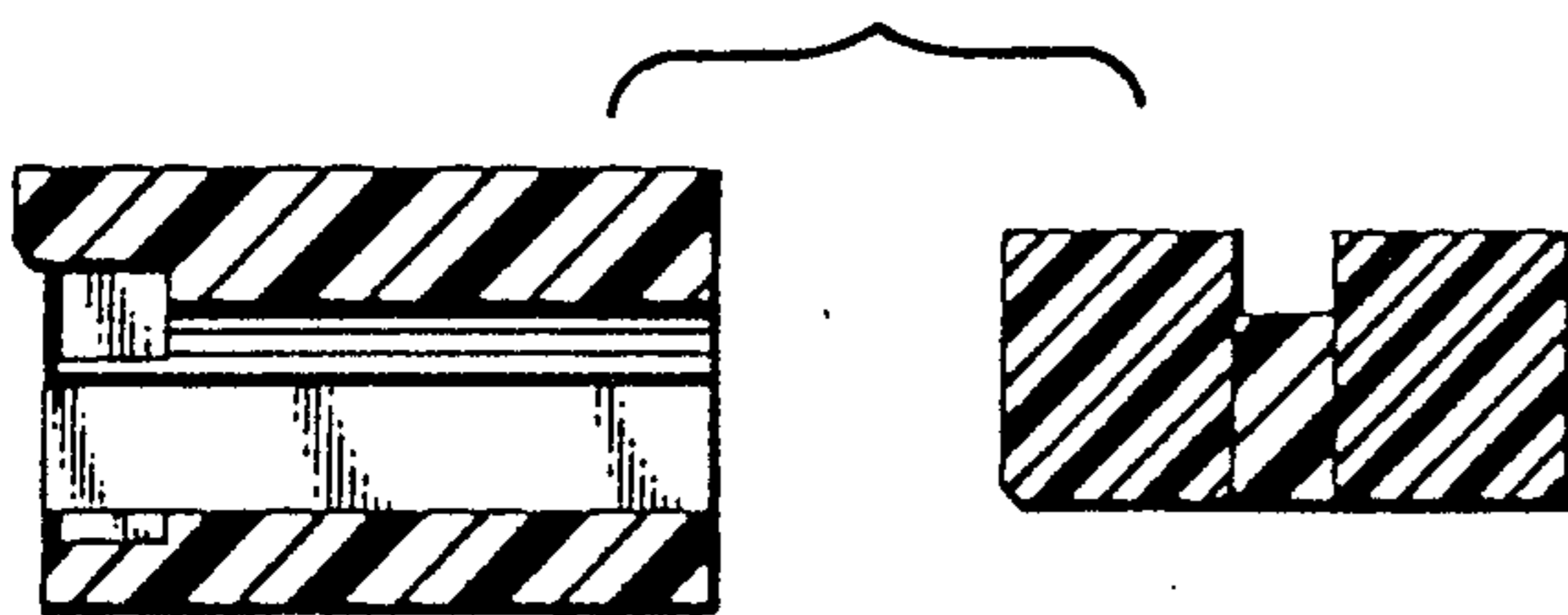

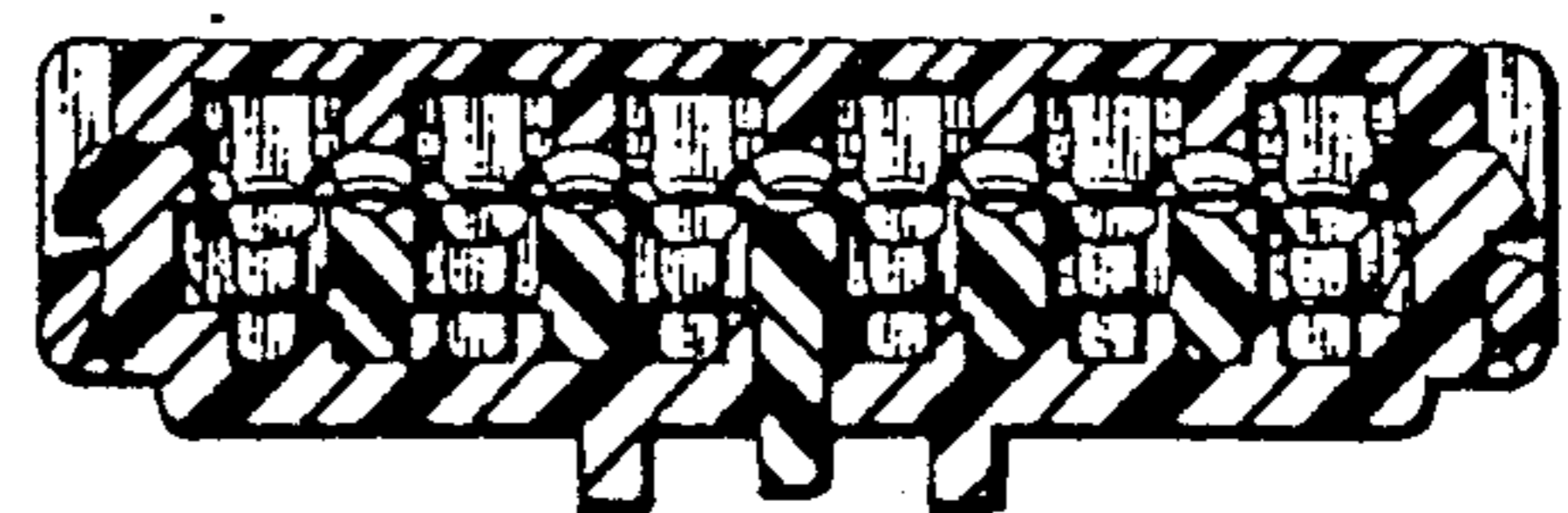
