 FIG. 32 is a rear elevational view of the king and pawn;

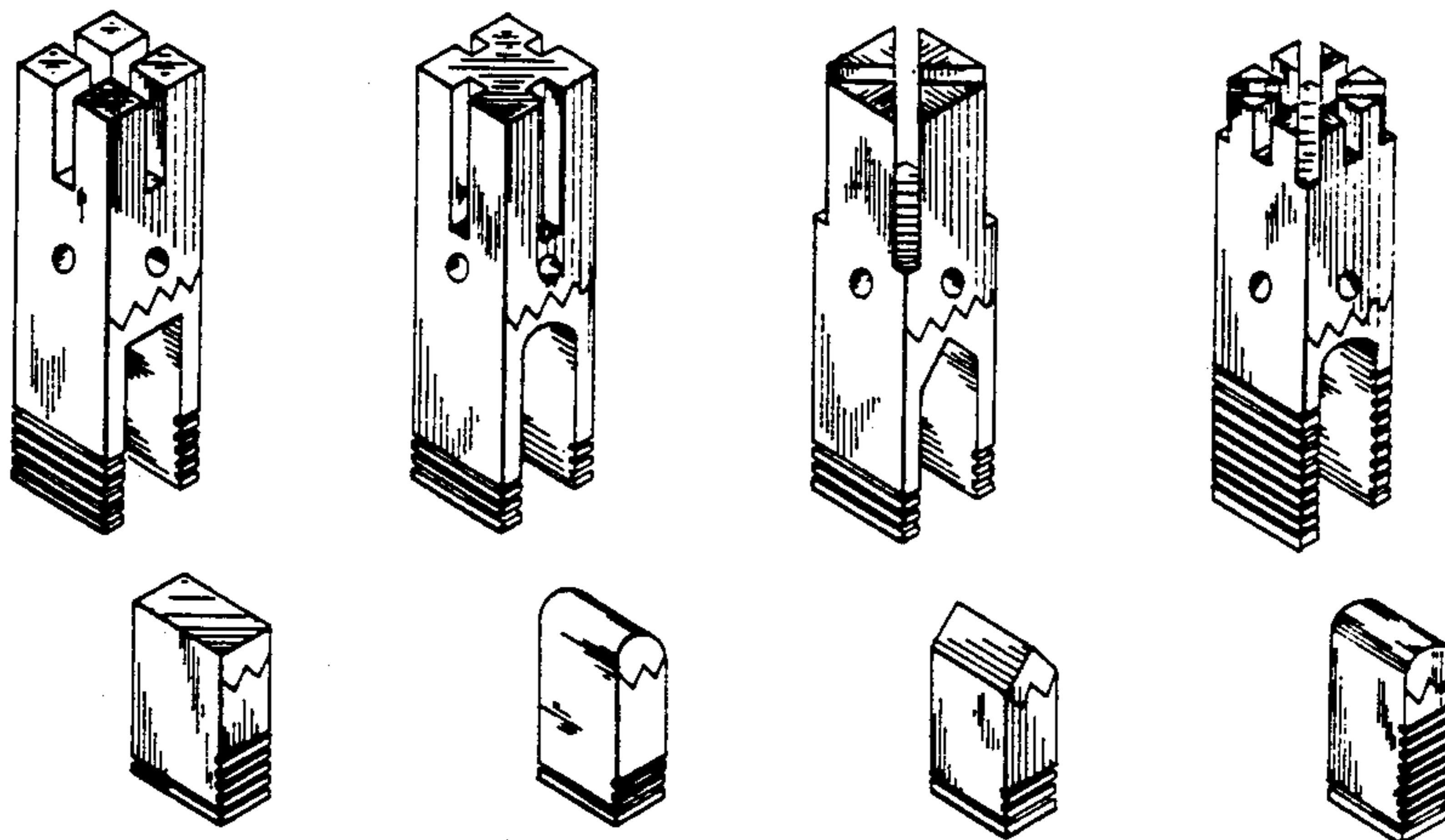


FIG. 33 is a front perspective view of the king's rook and pawn;

FIG. 40 is a rear perspective view of a king and pawn.

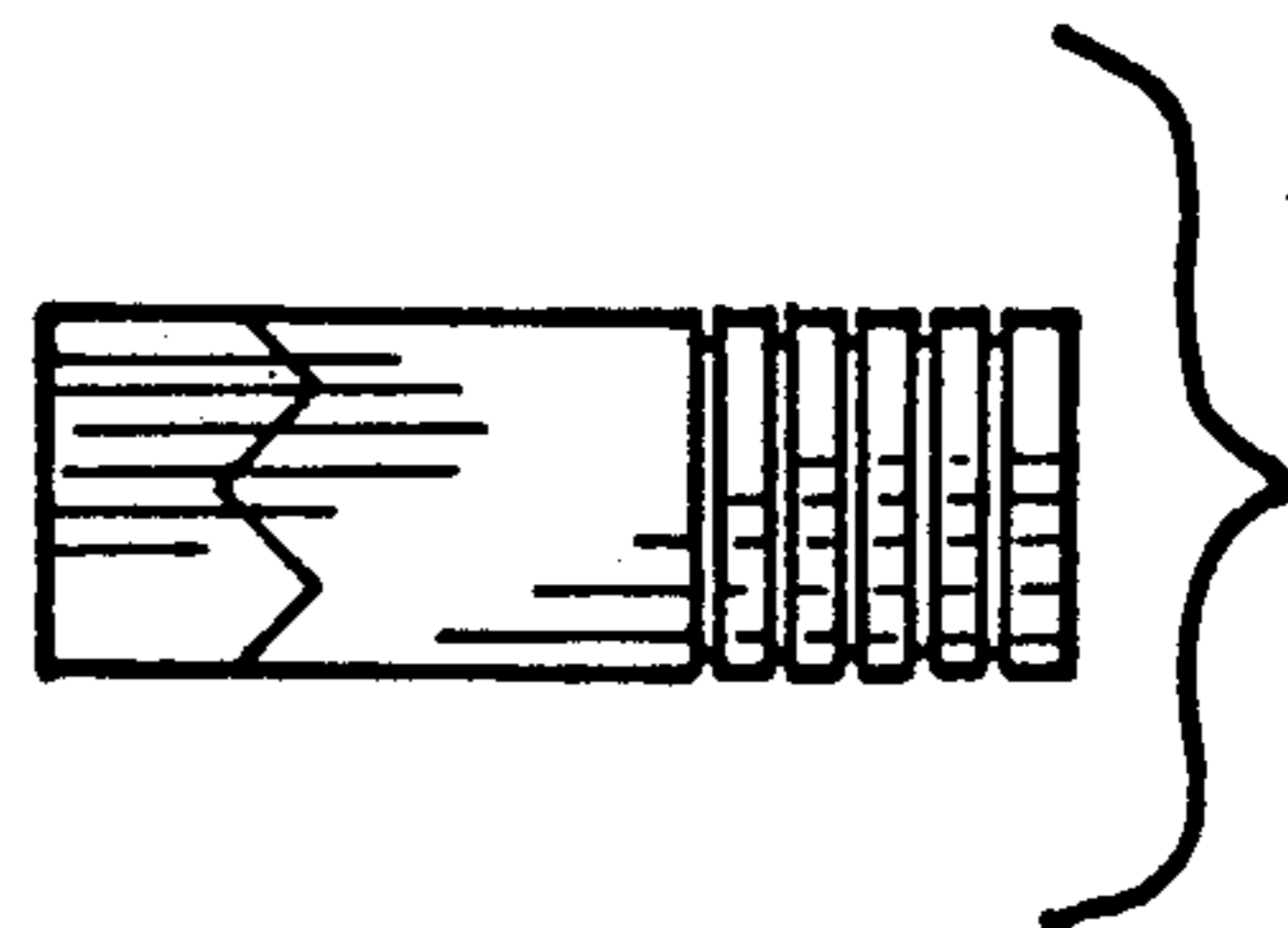
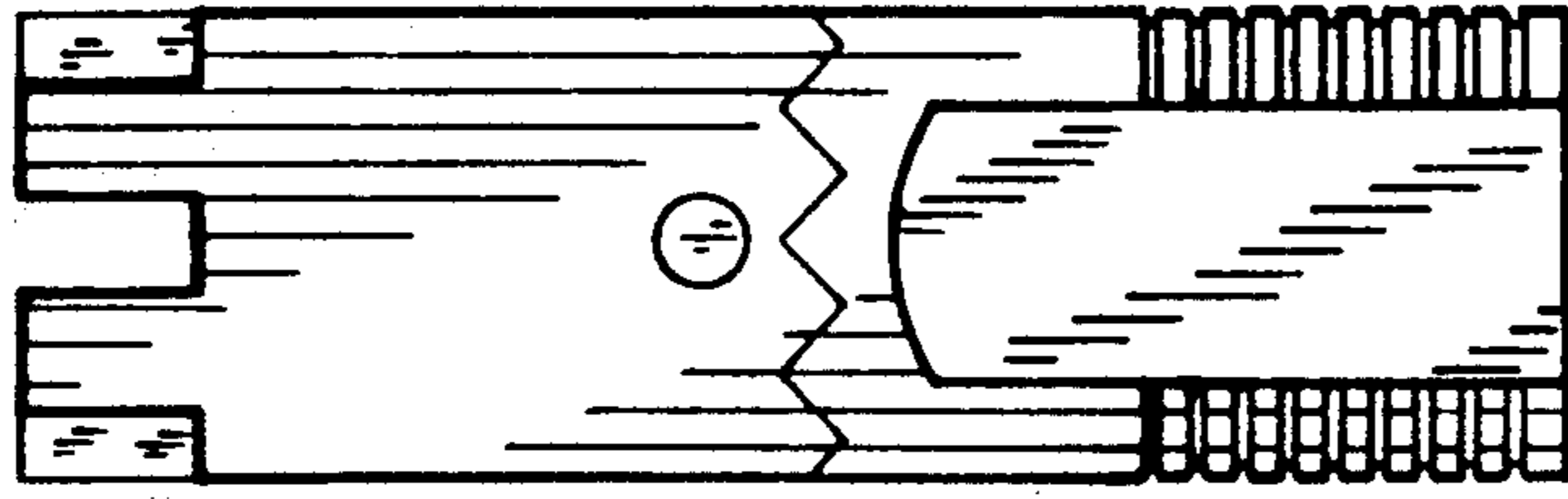

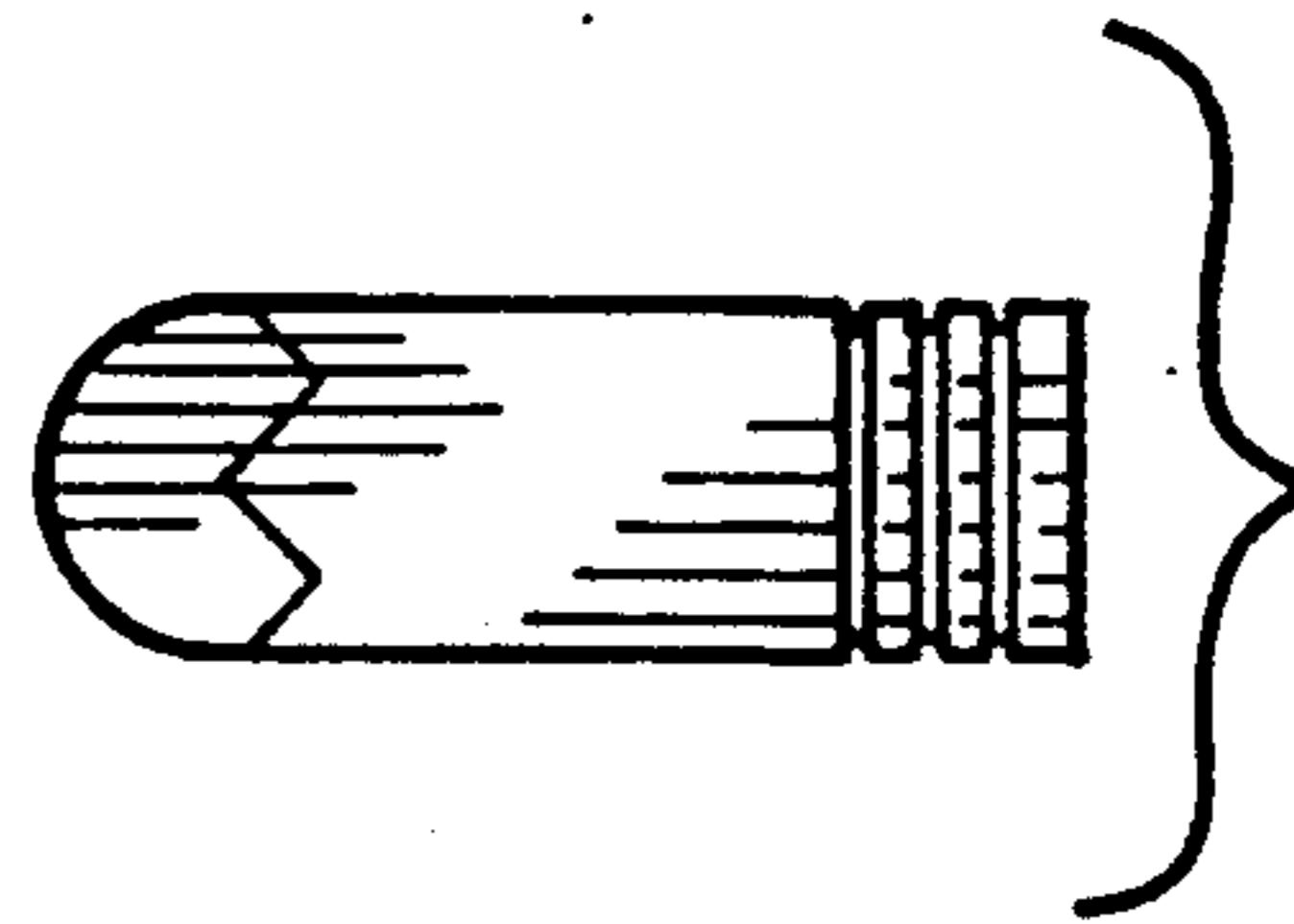
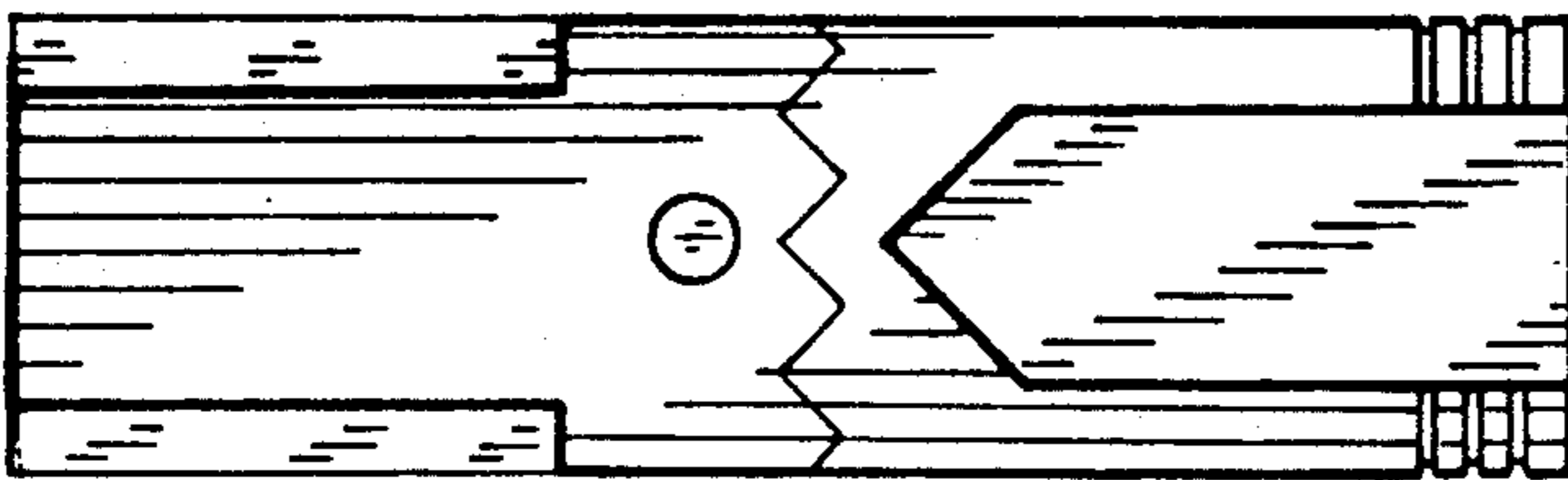

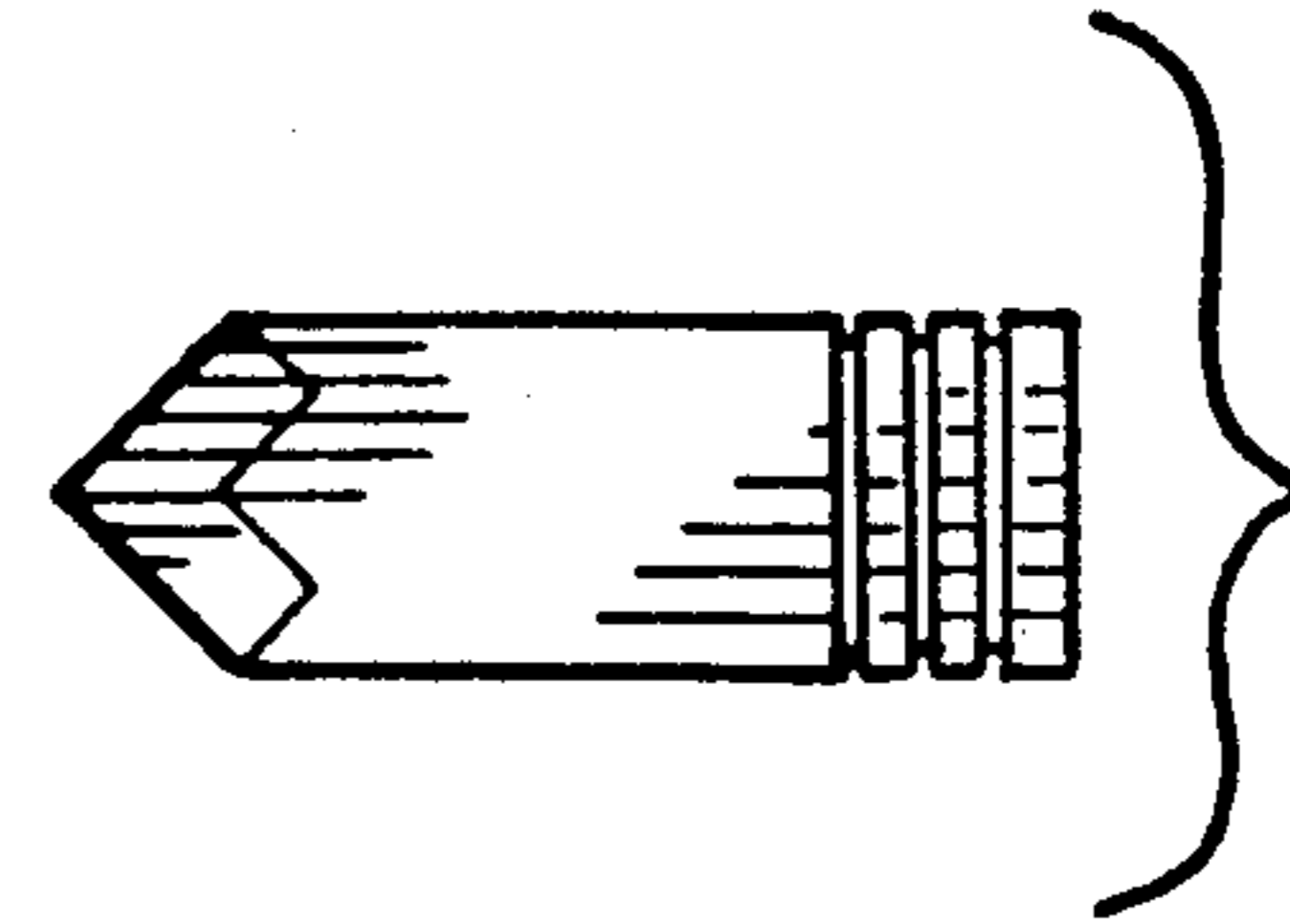
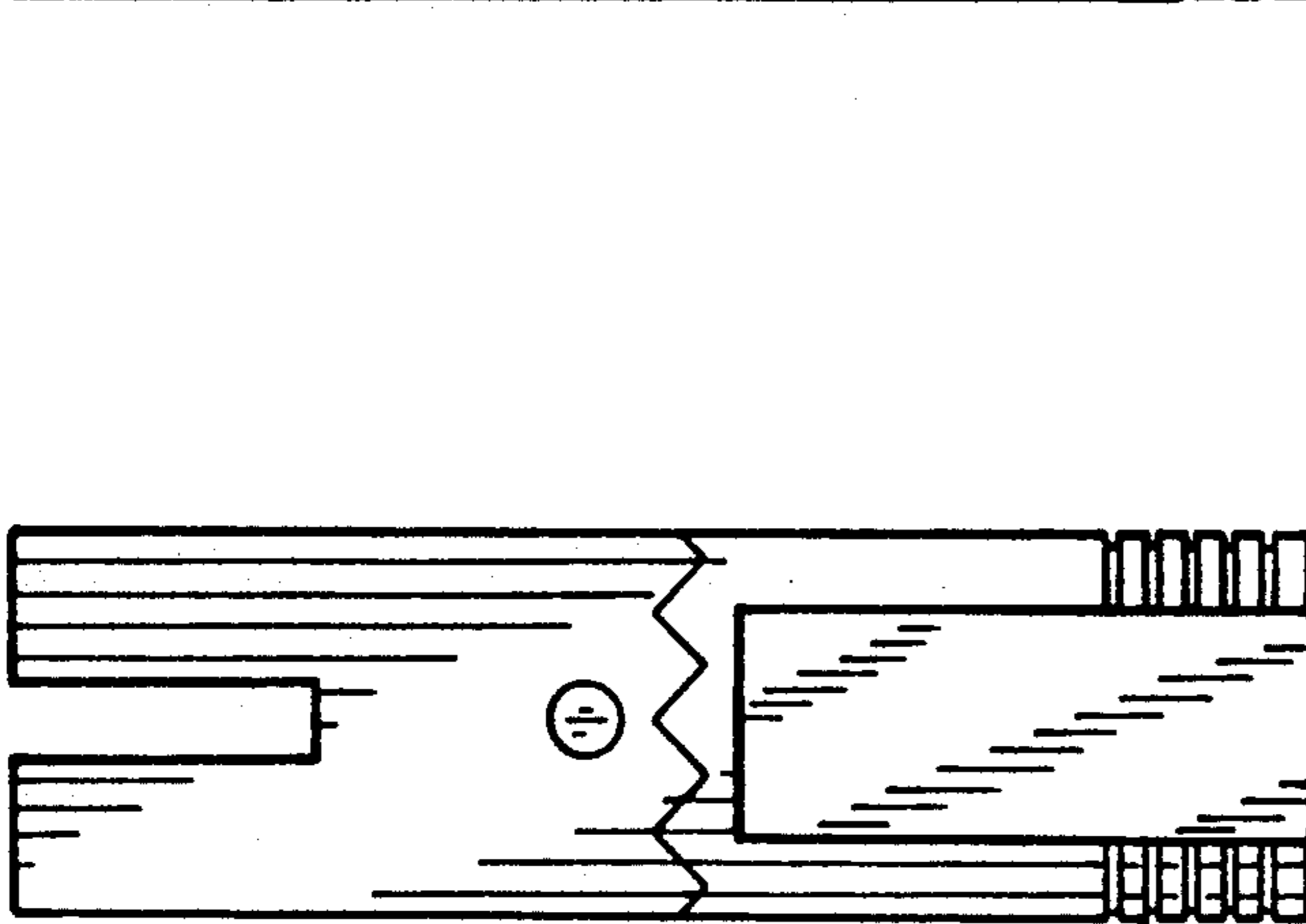

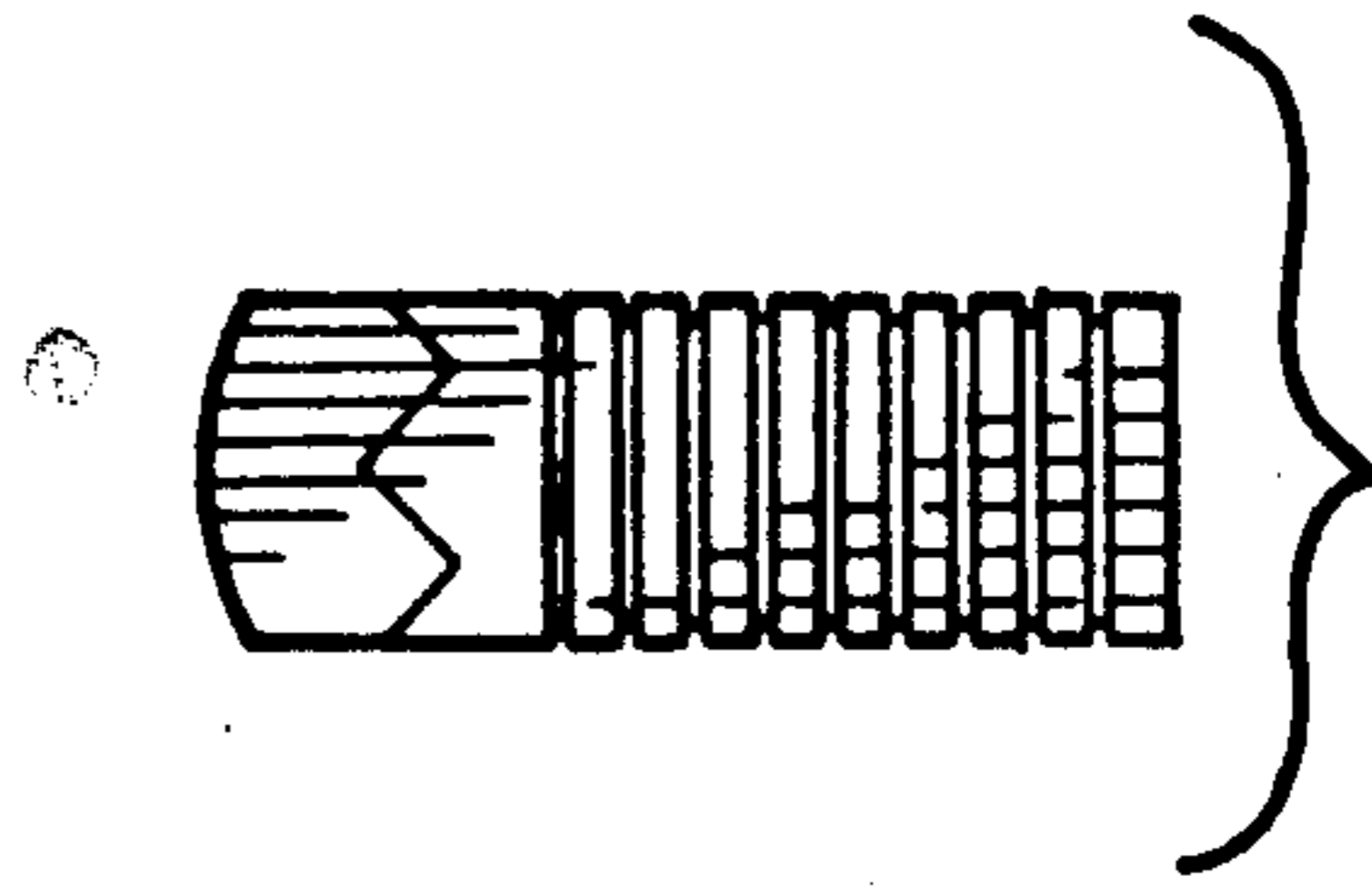
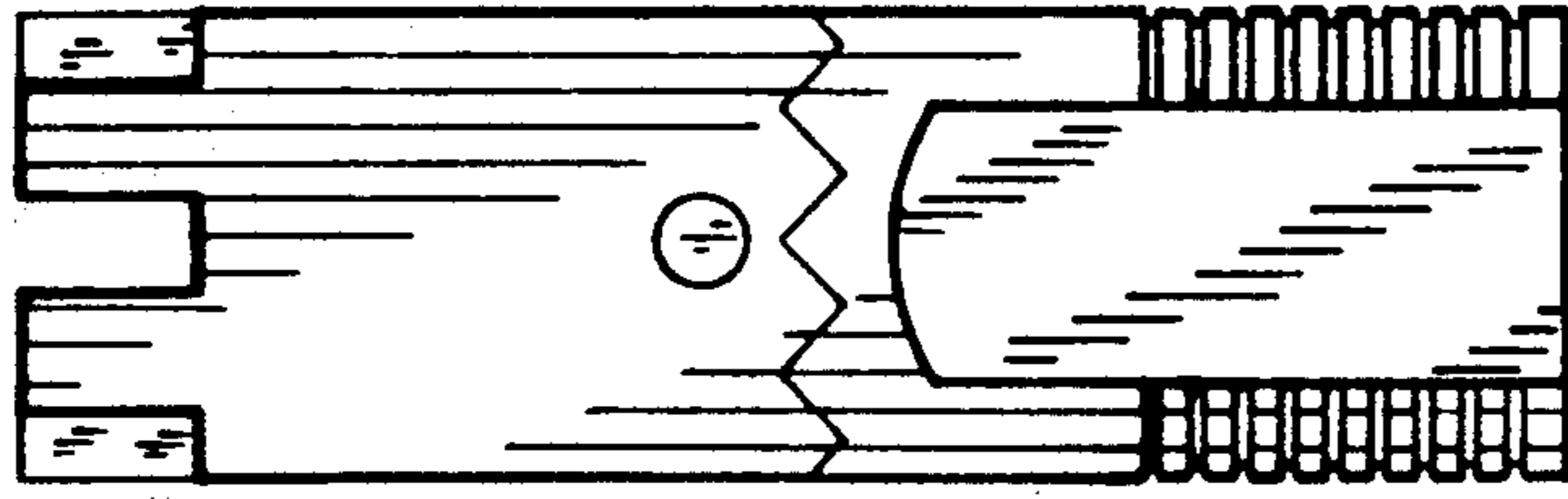

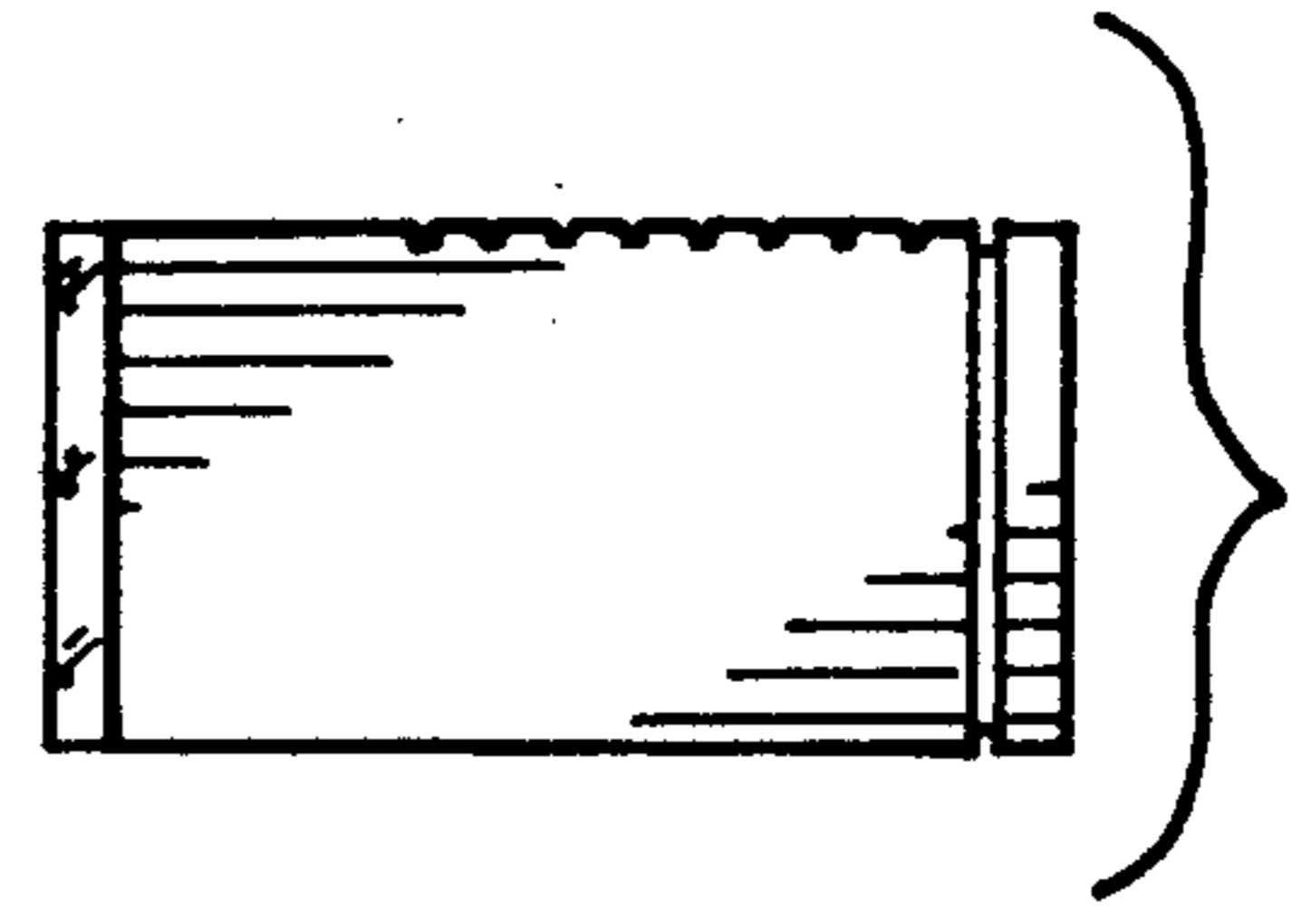
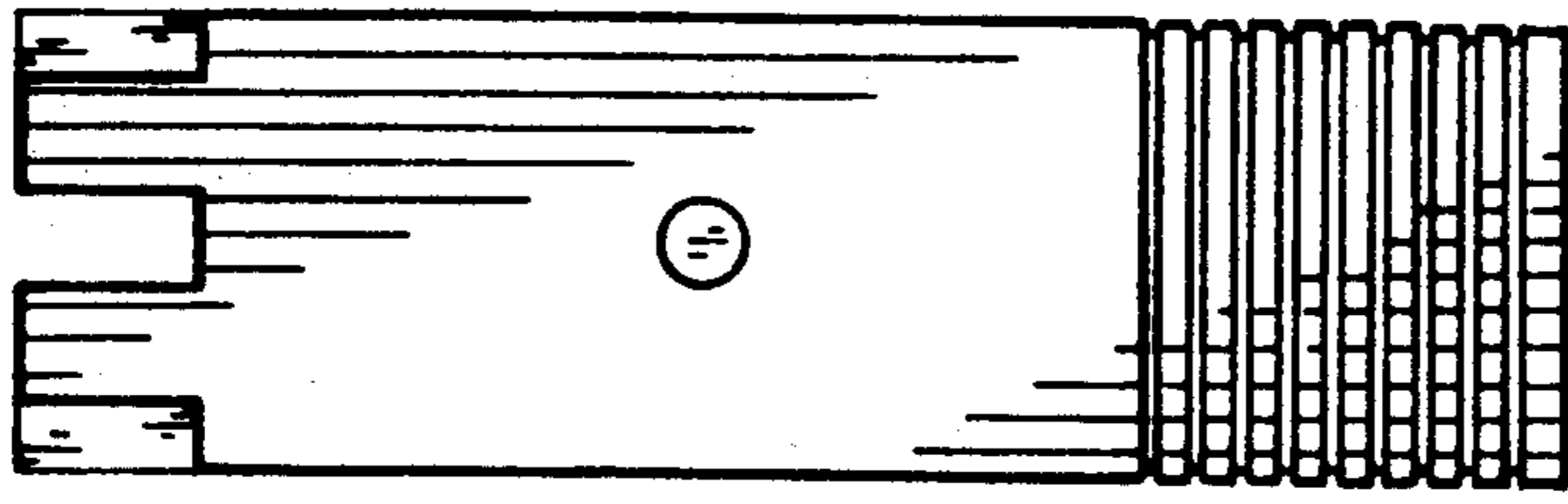

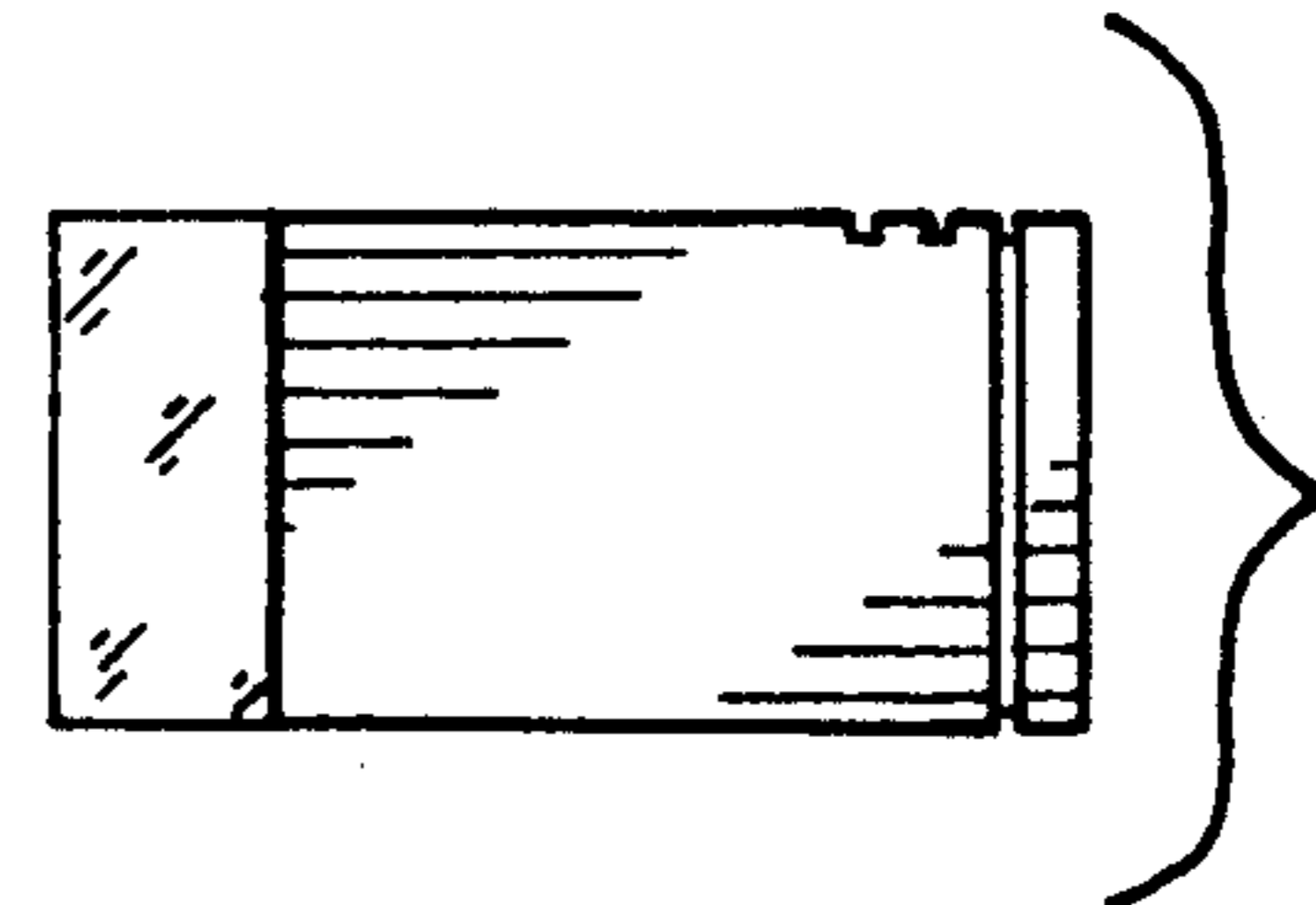
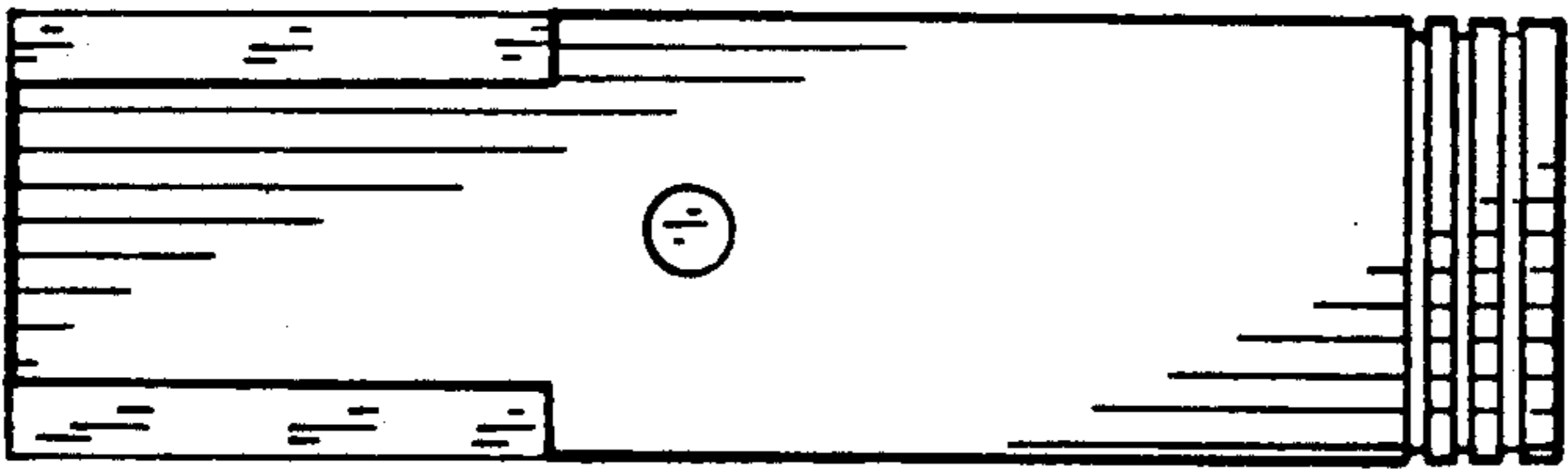

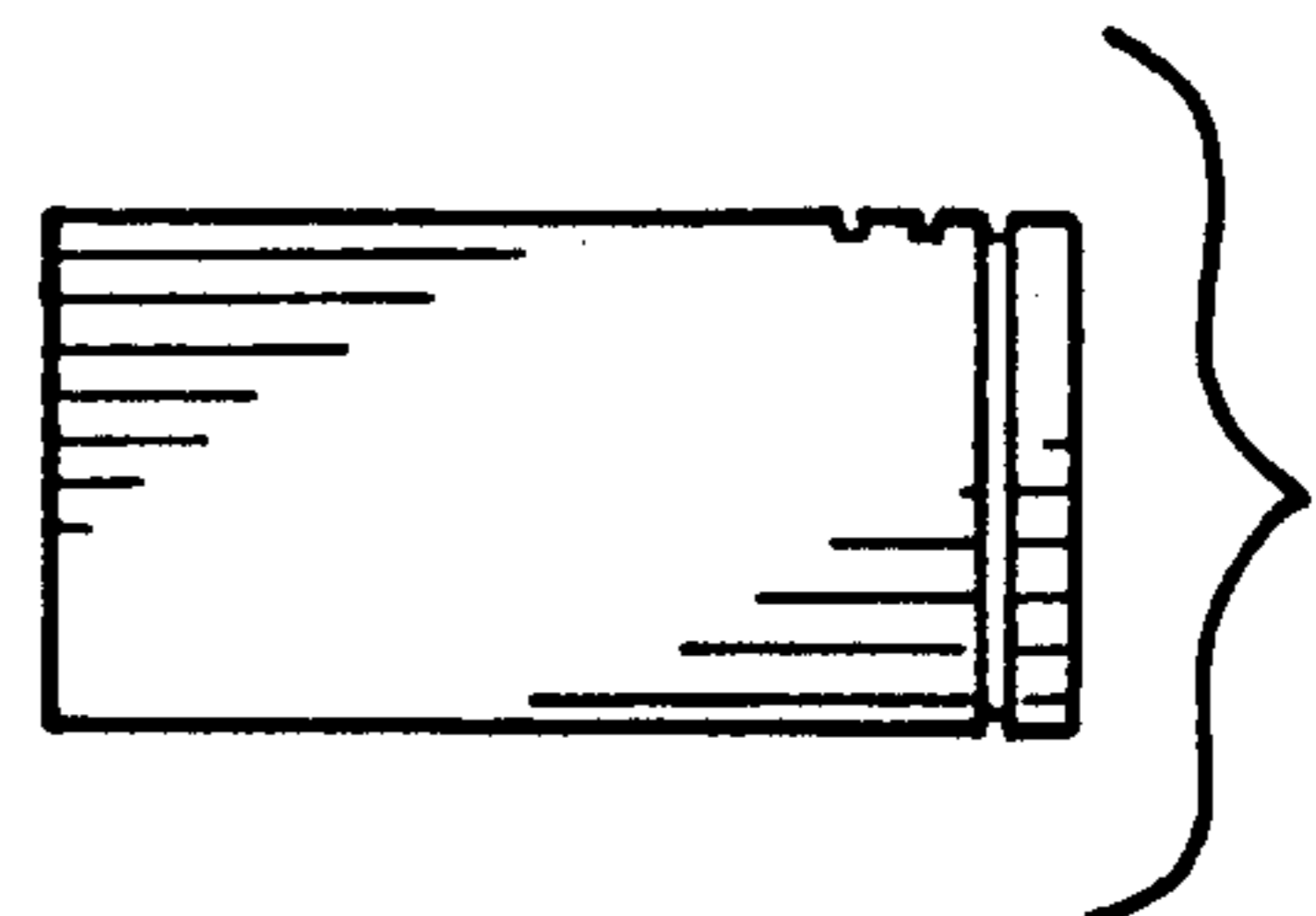
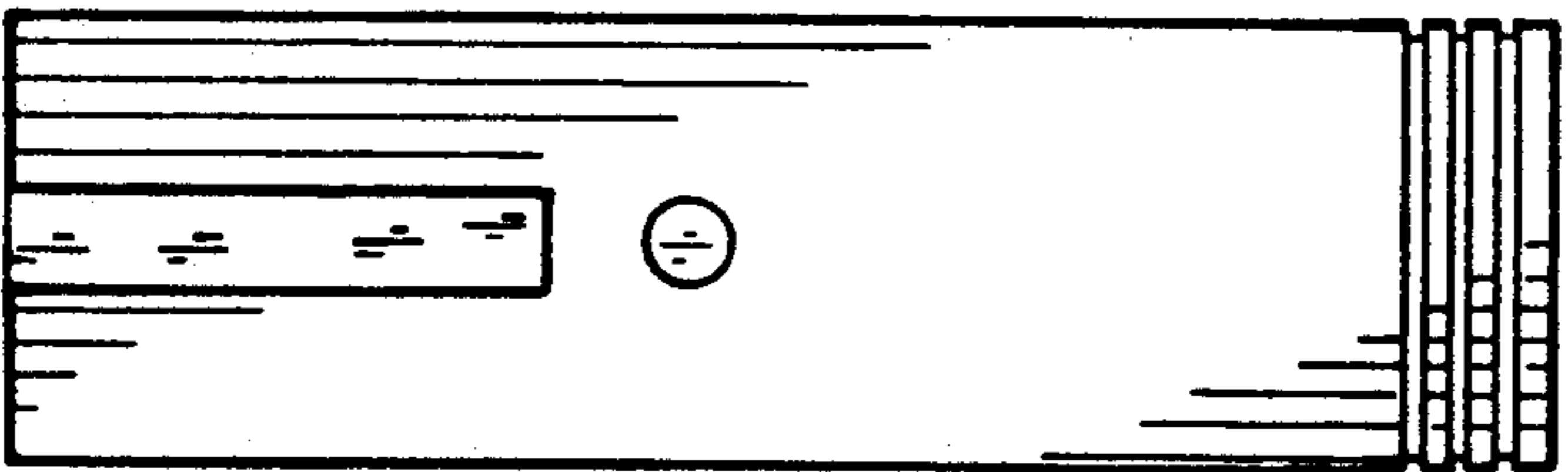

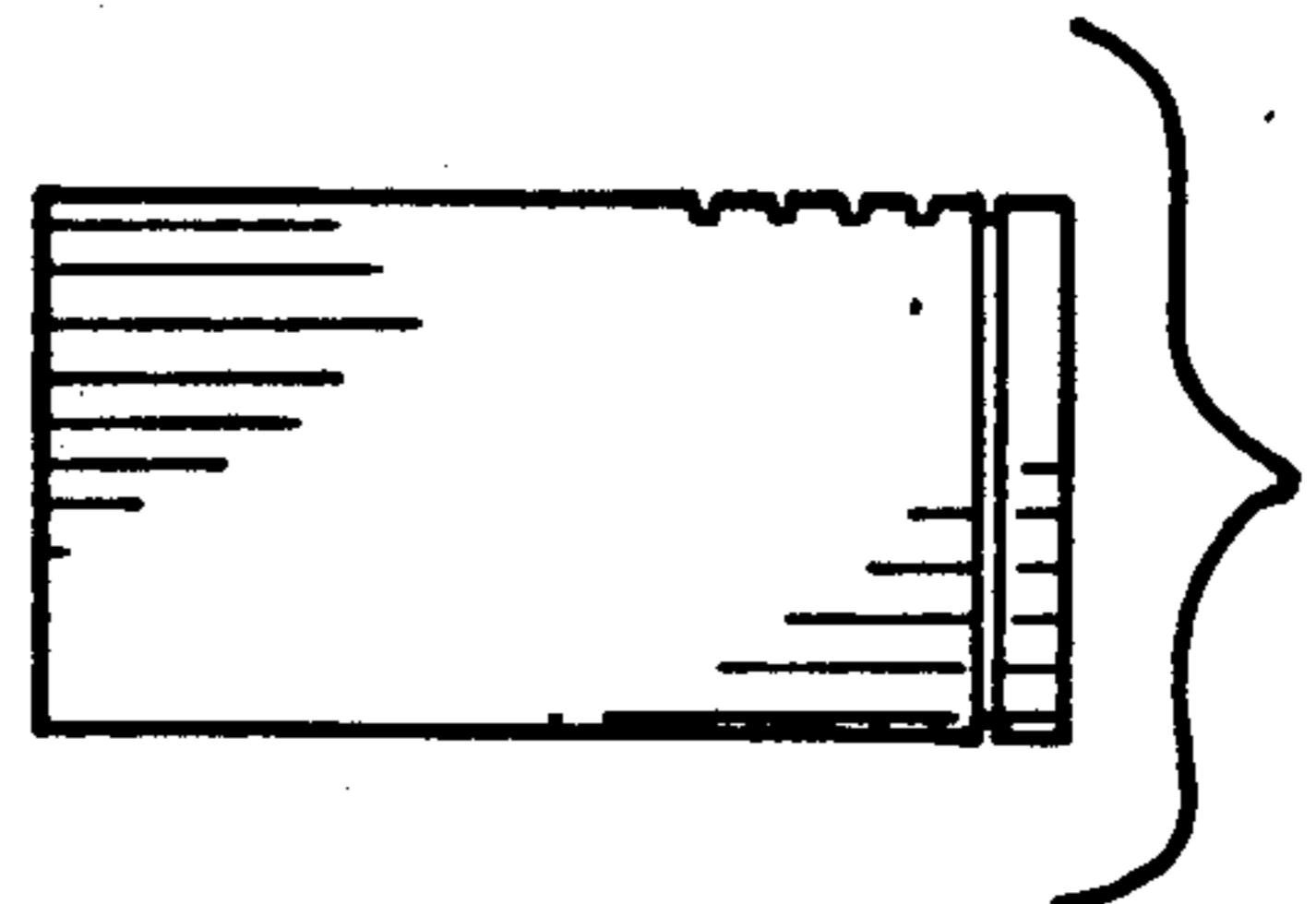
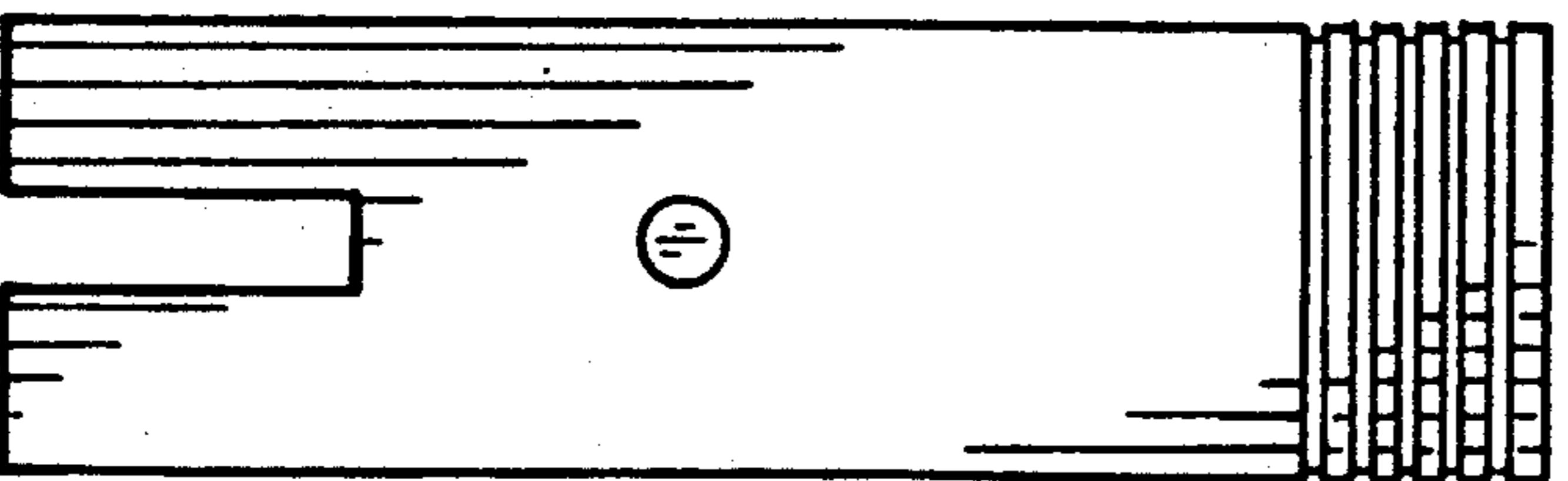

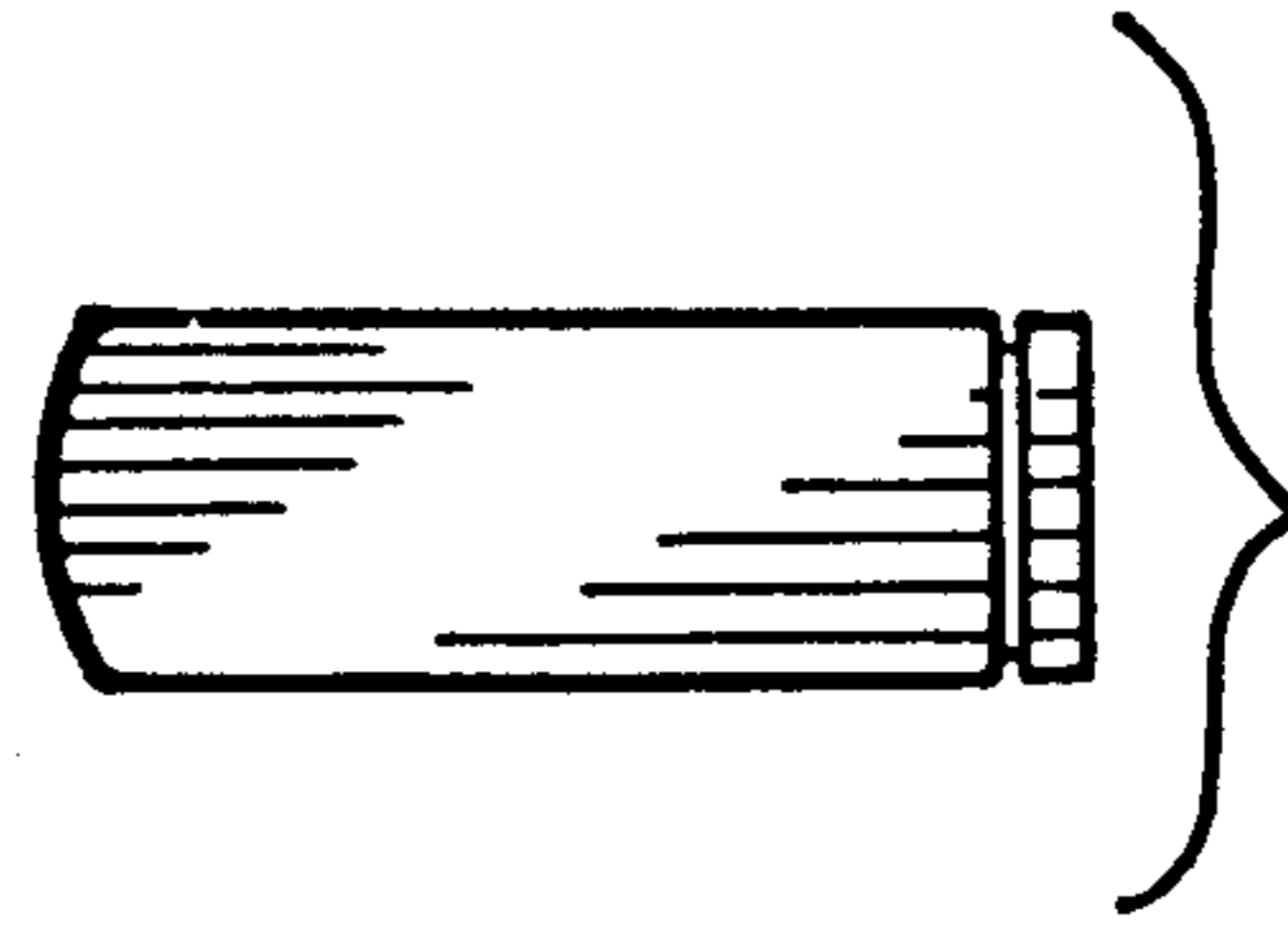
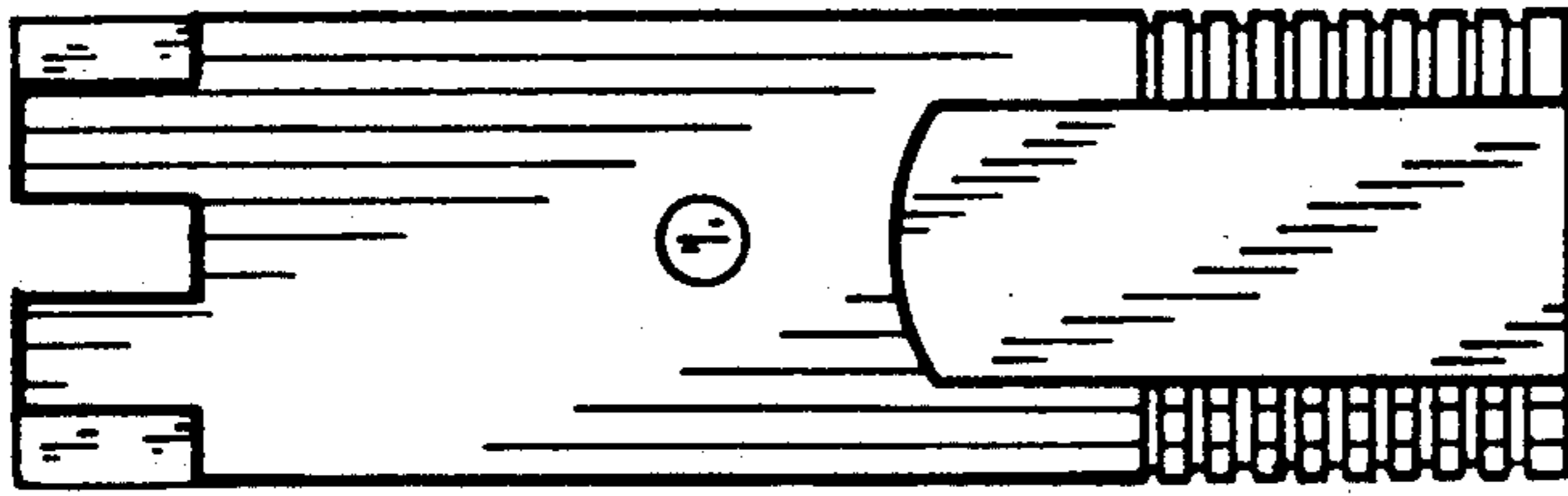

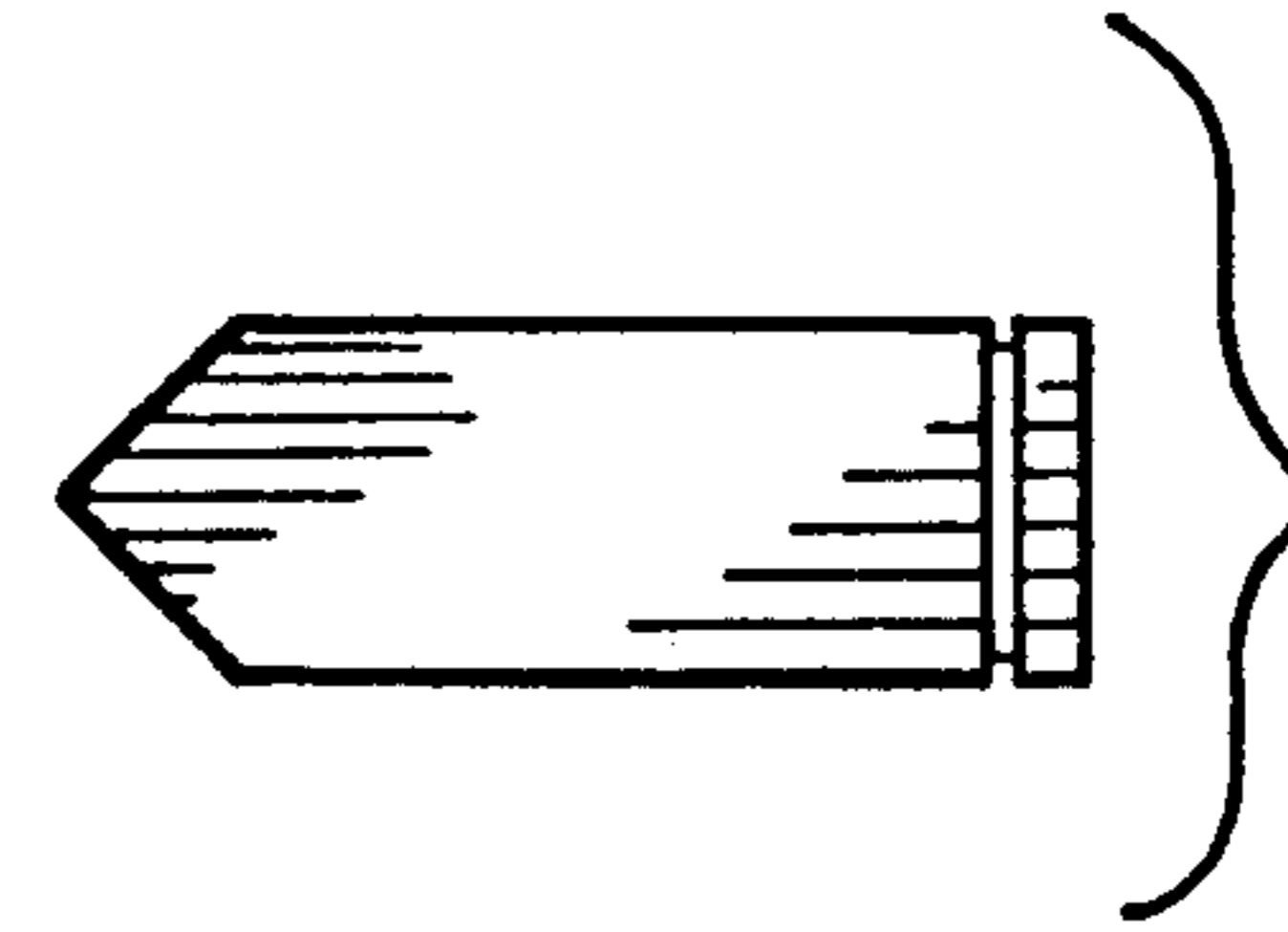
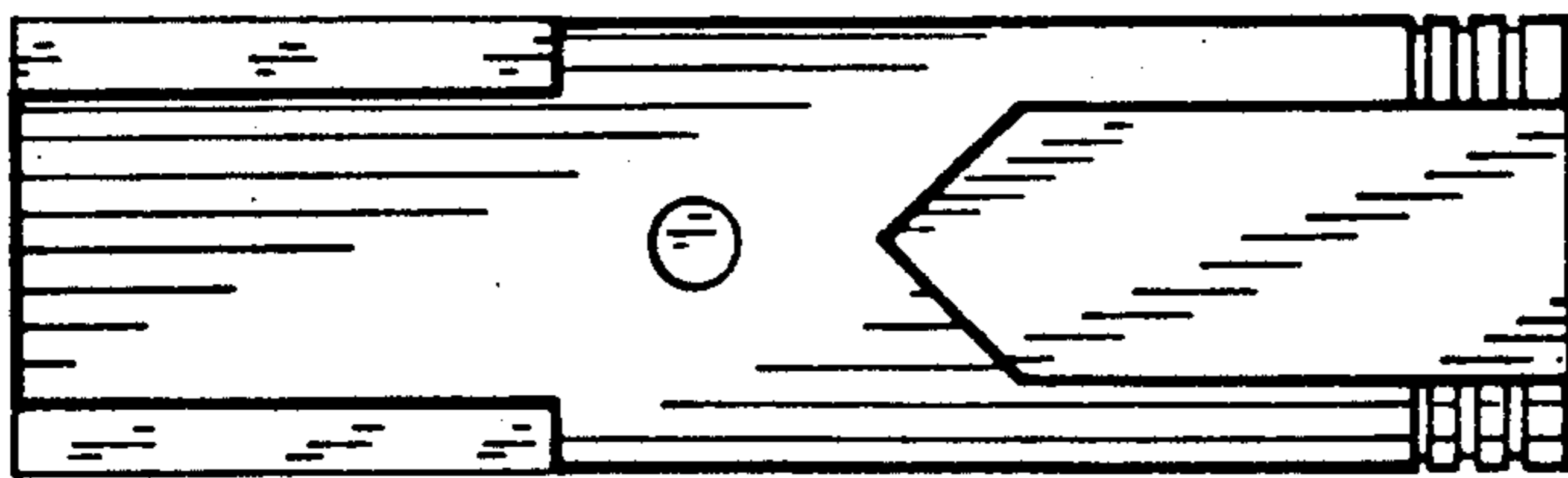

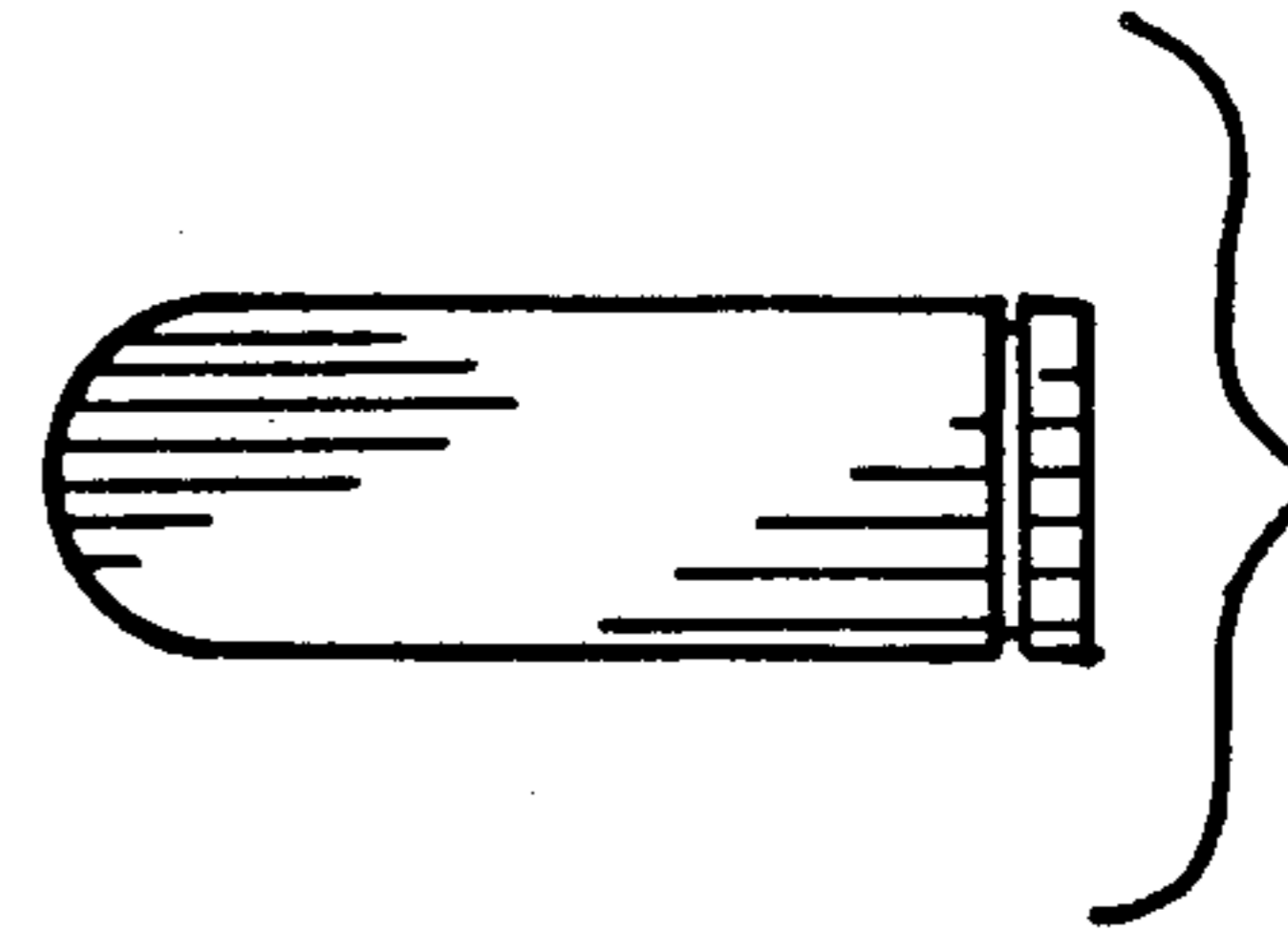
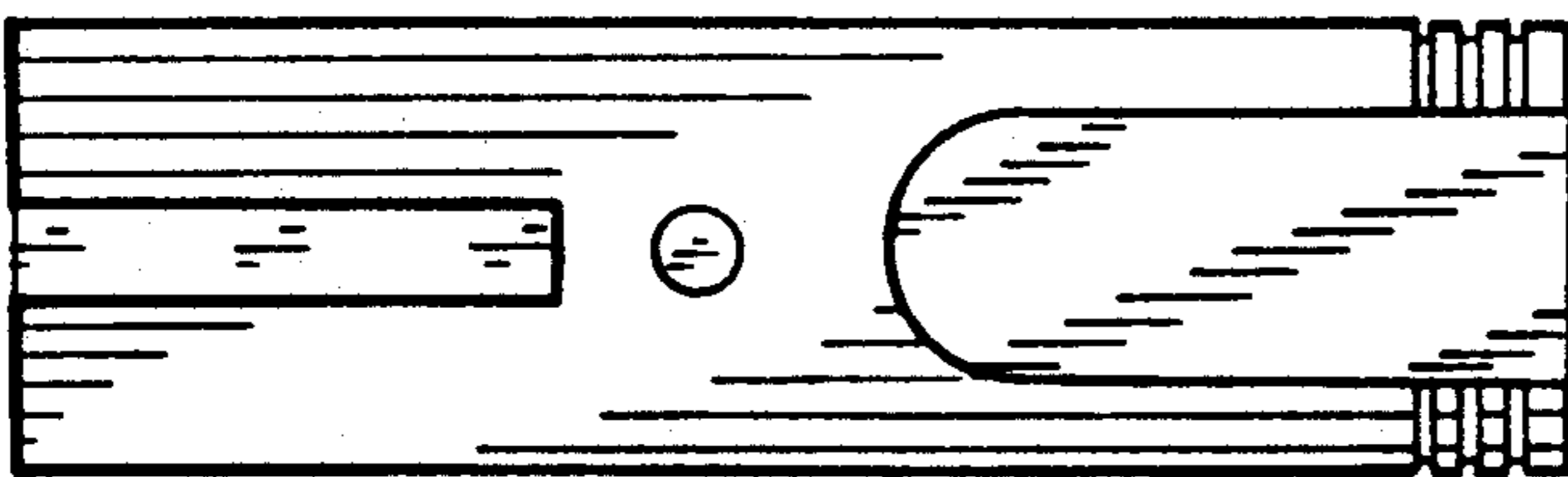

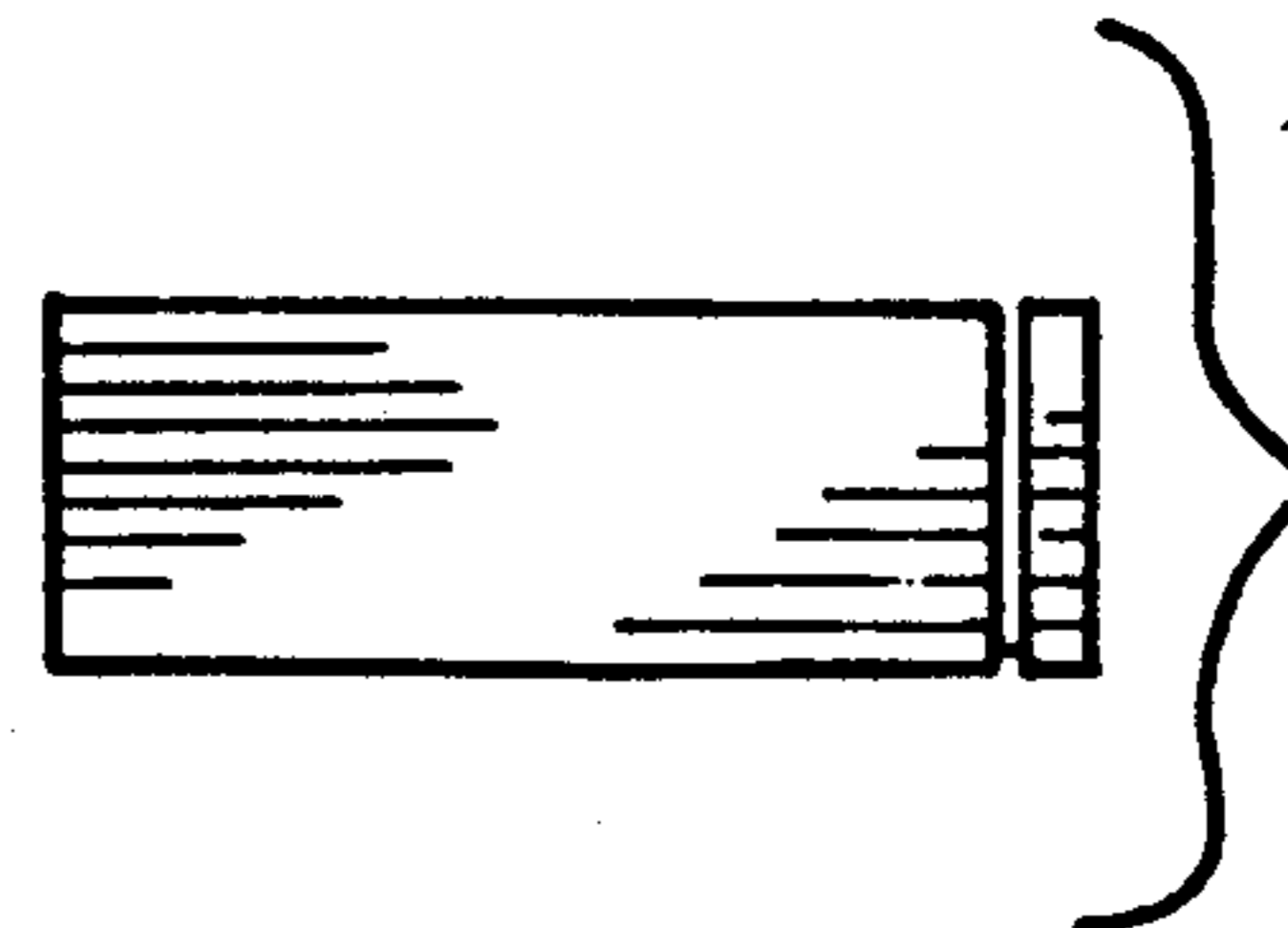
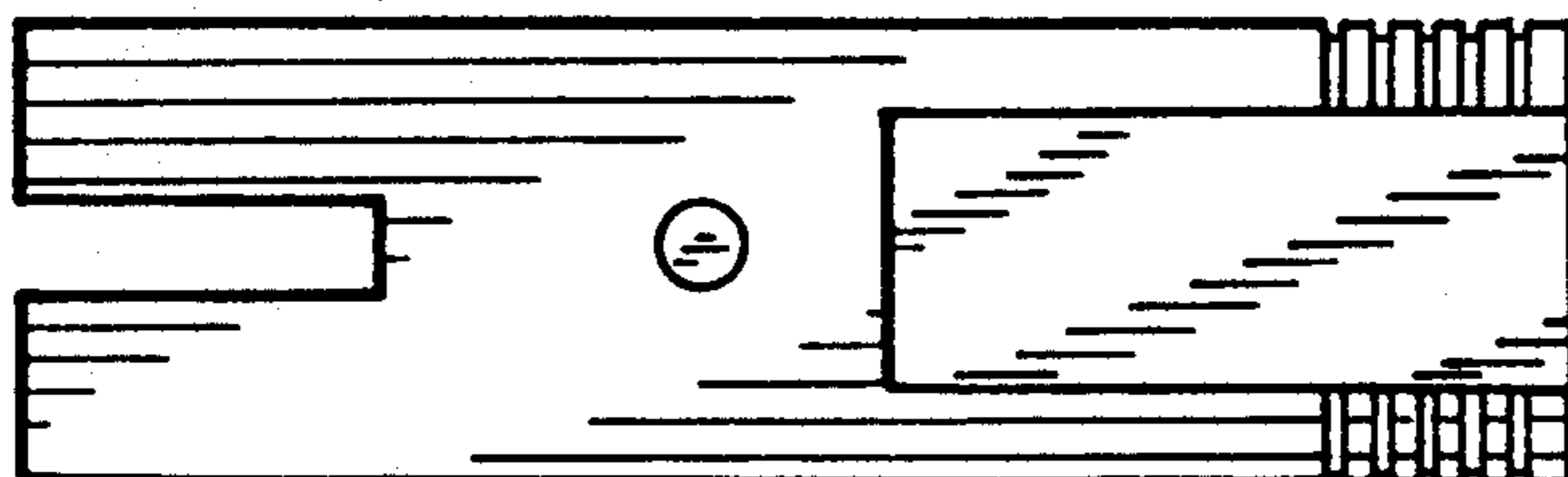

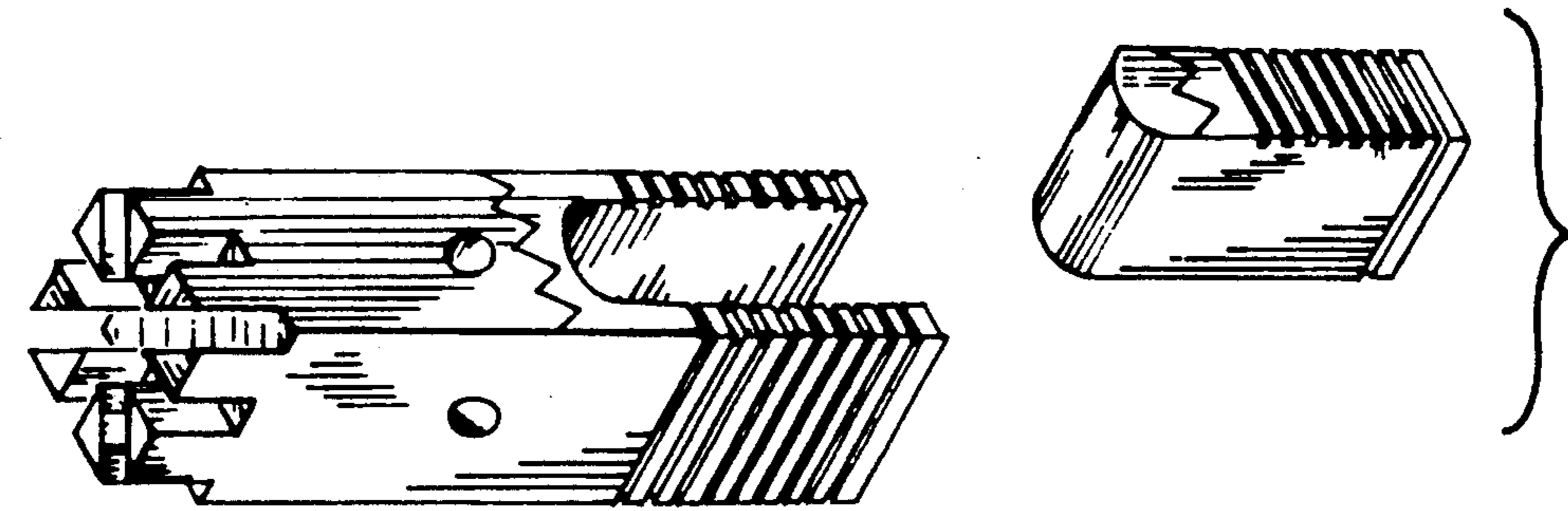

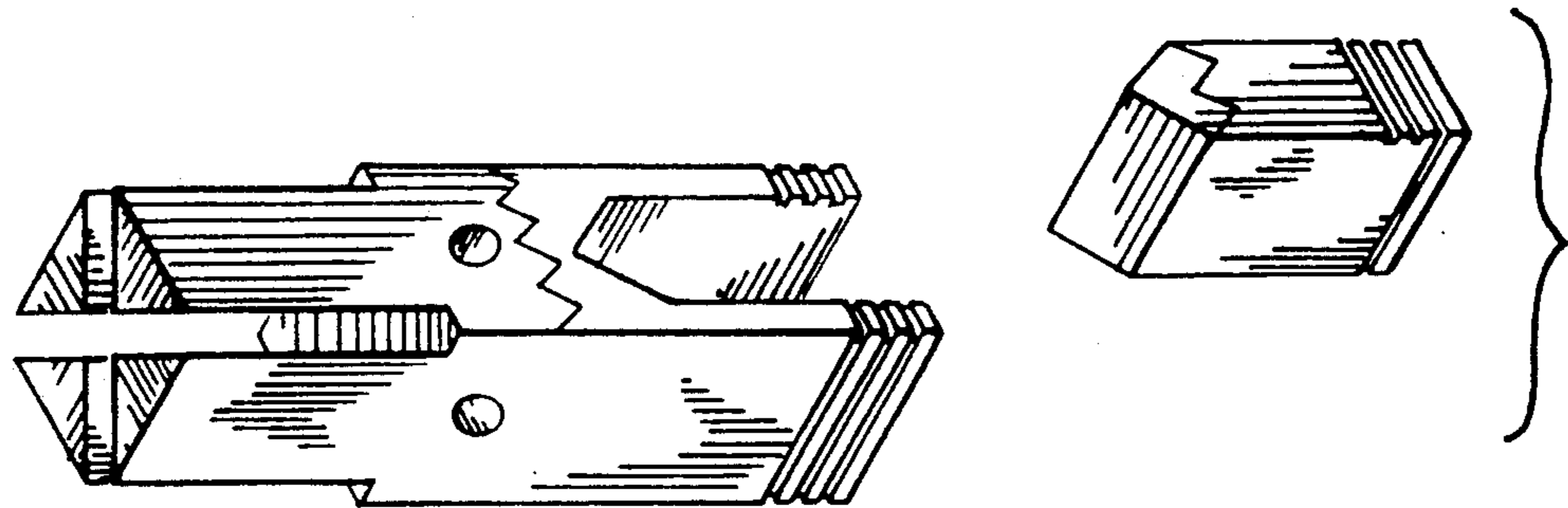

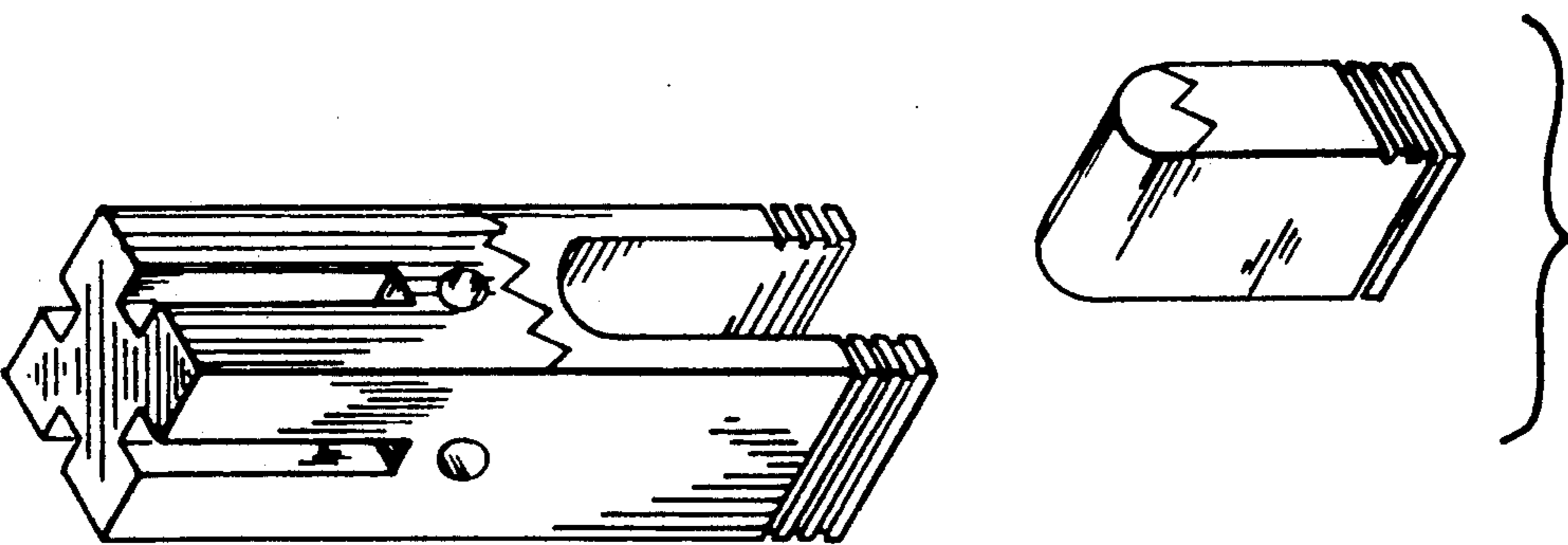

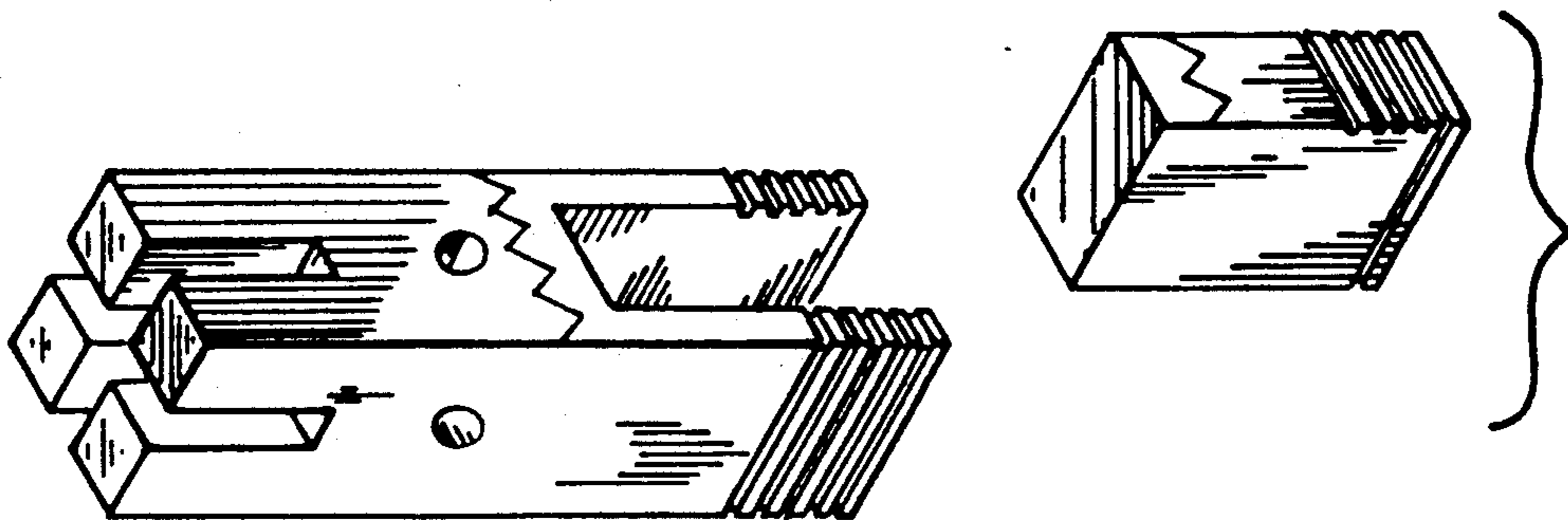

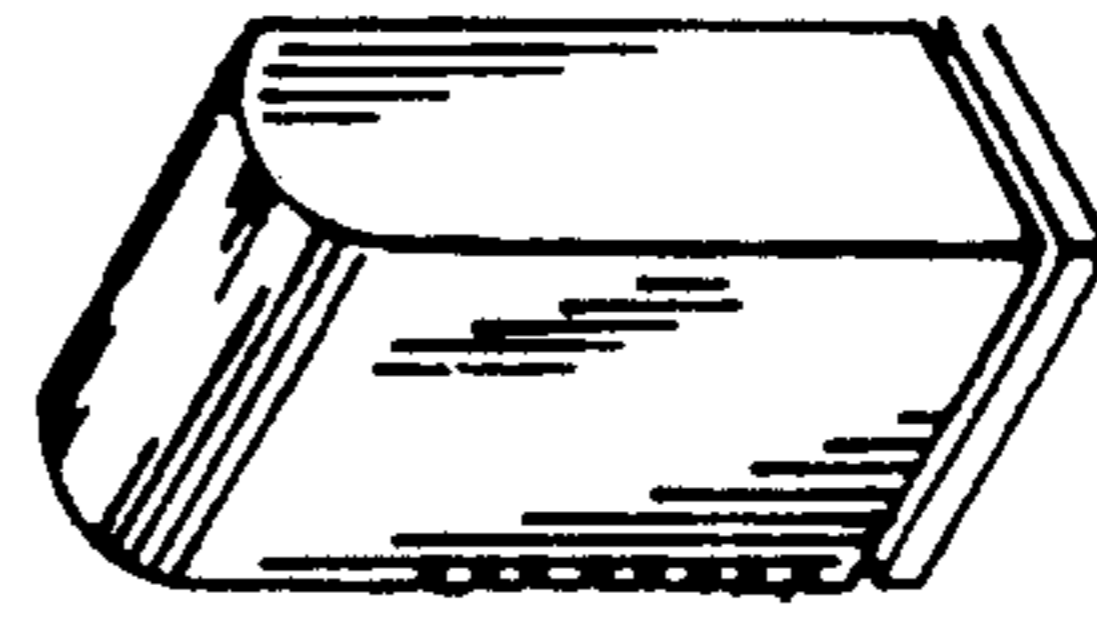
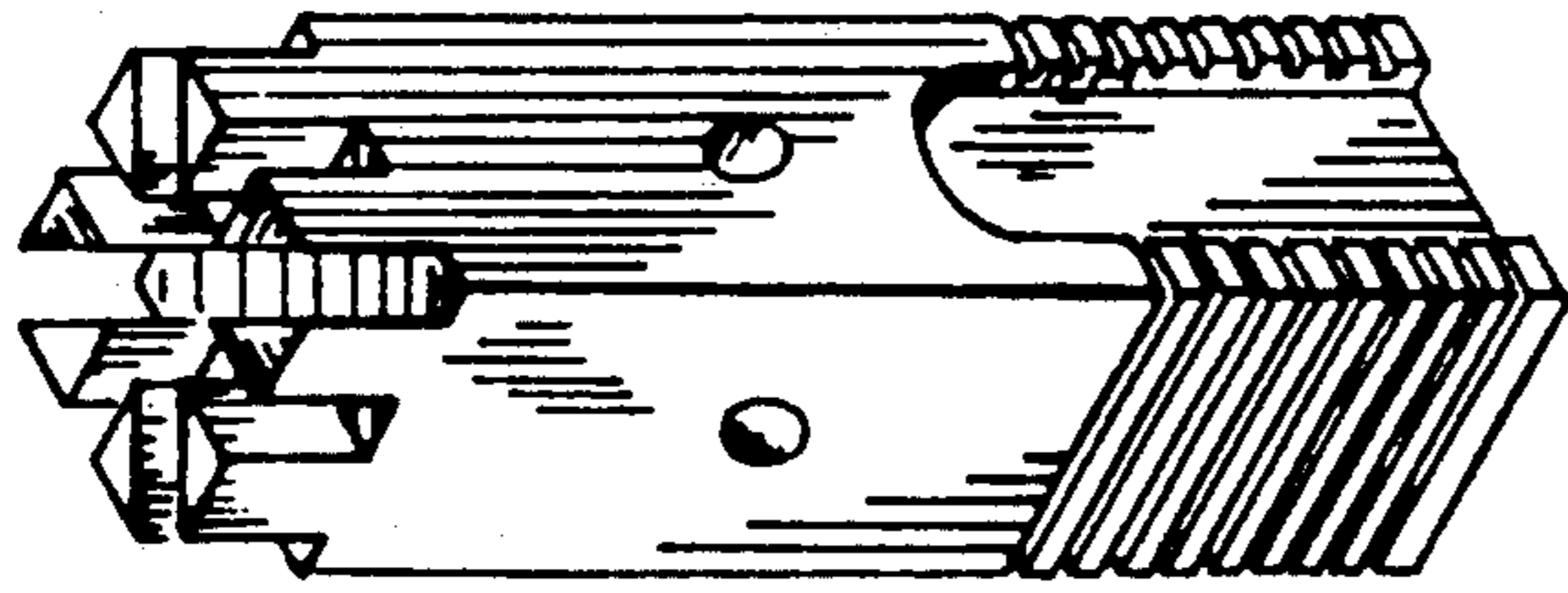

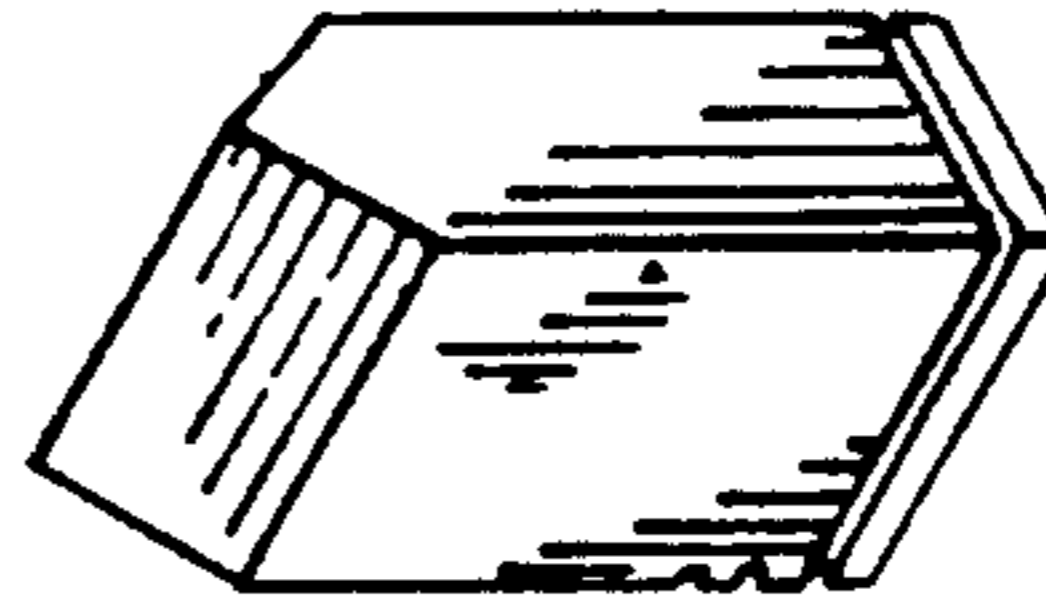
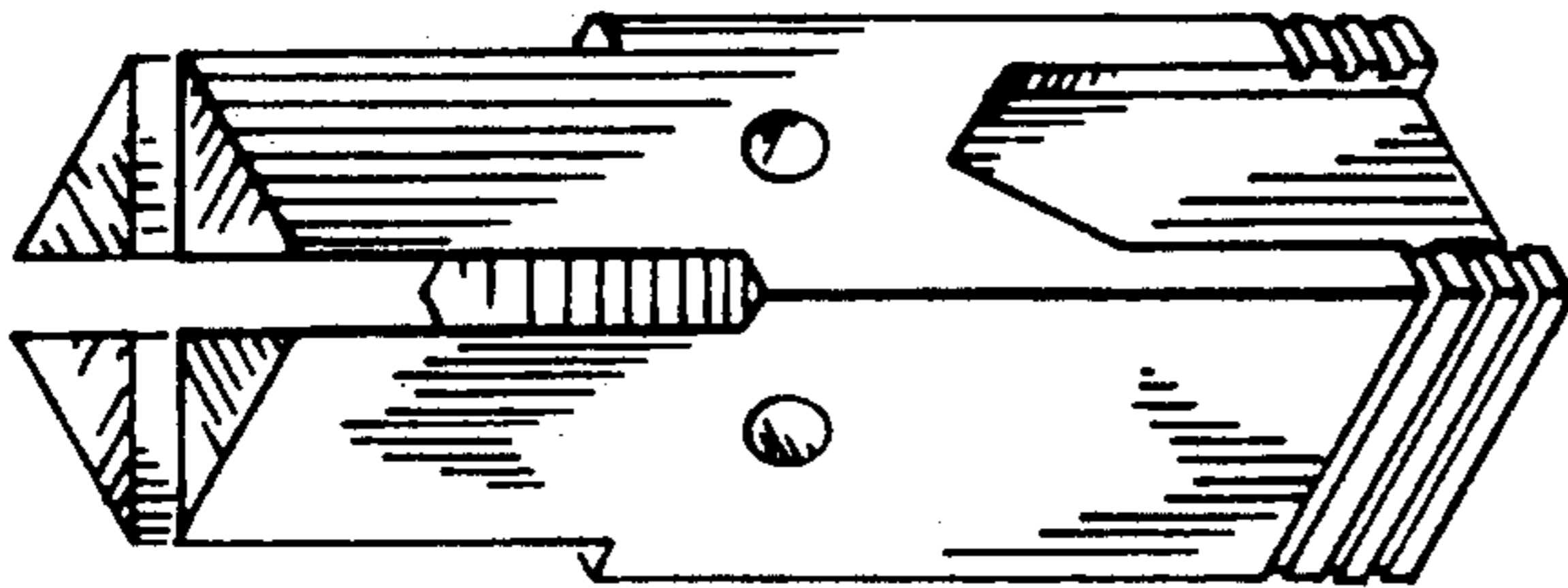

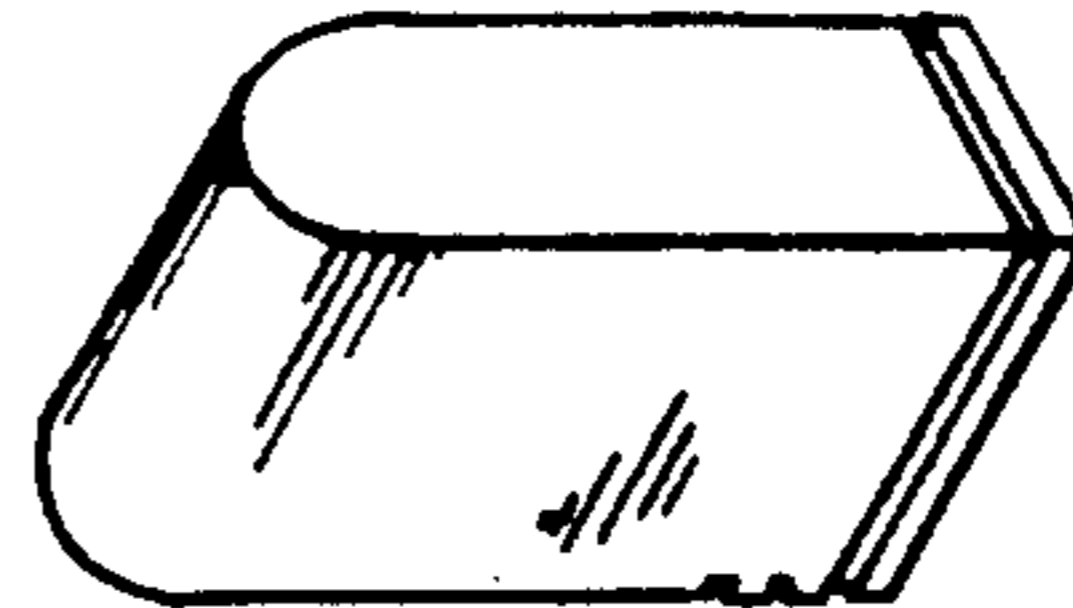
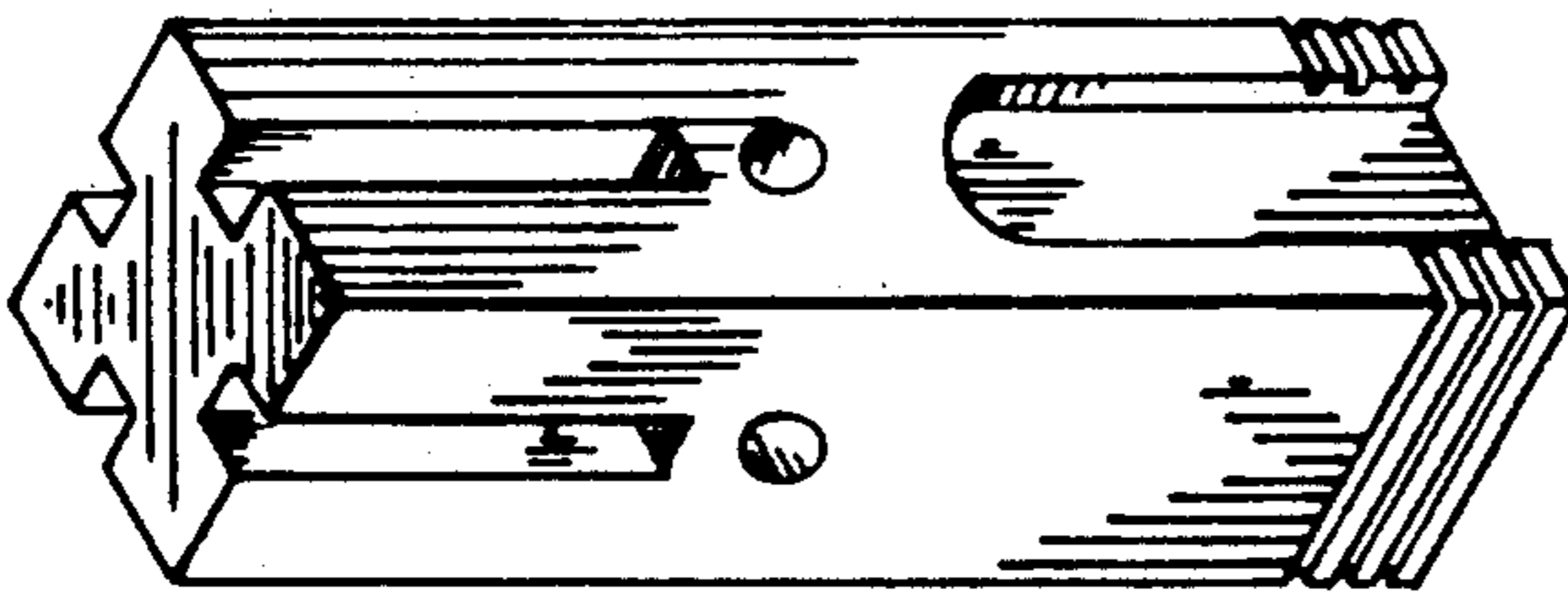

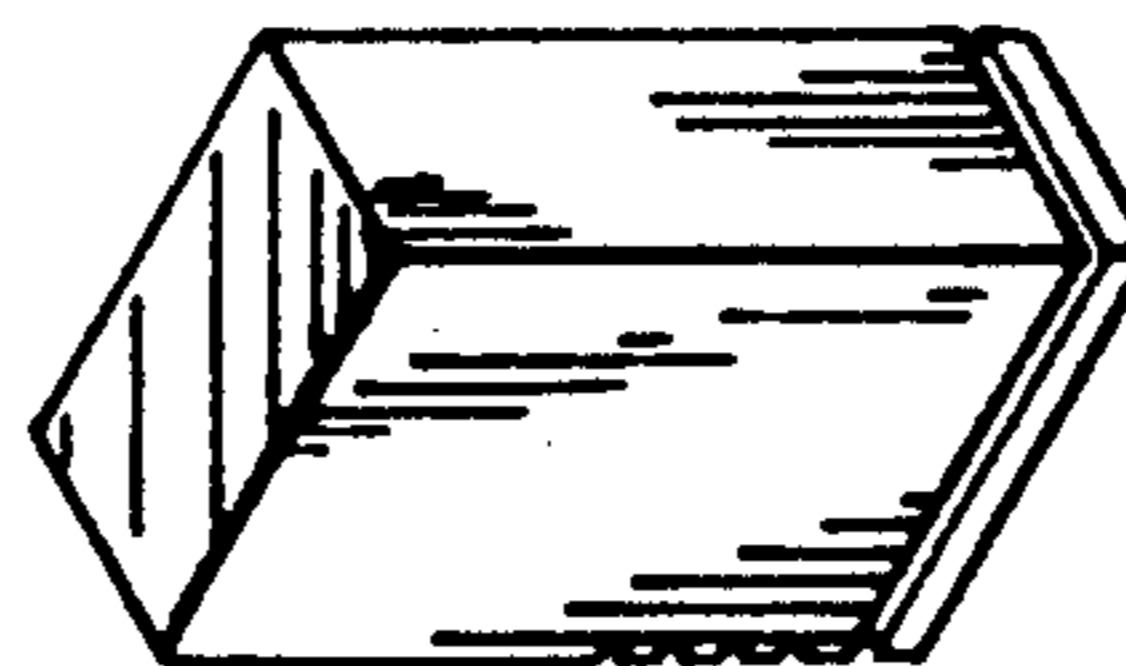
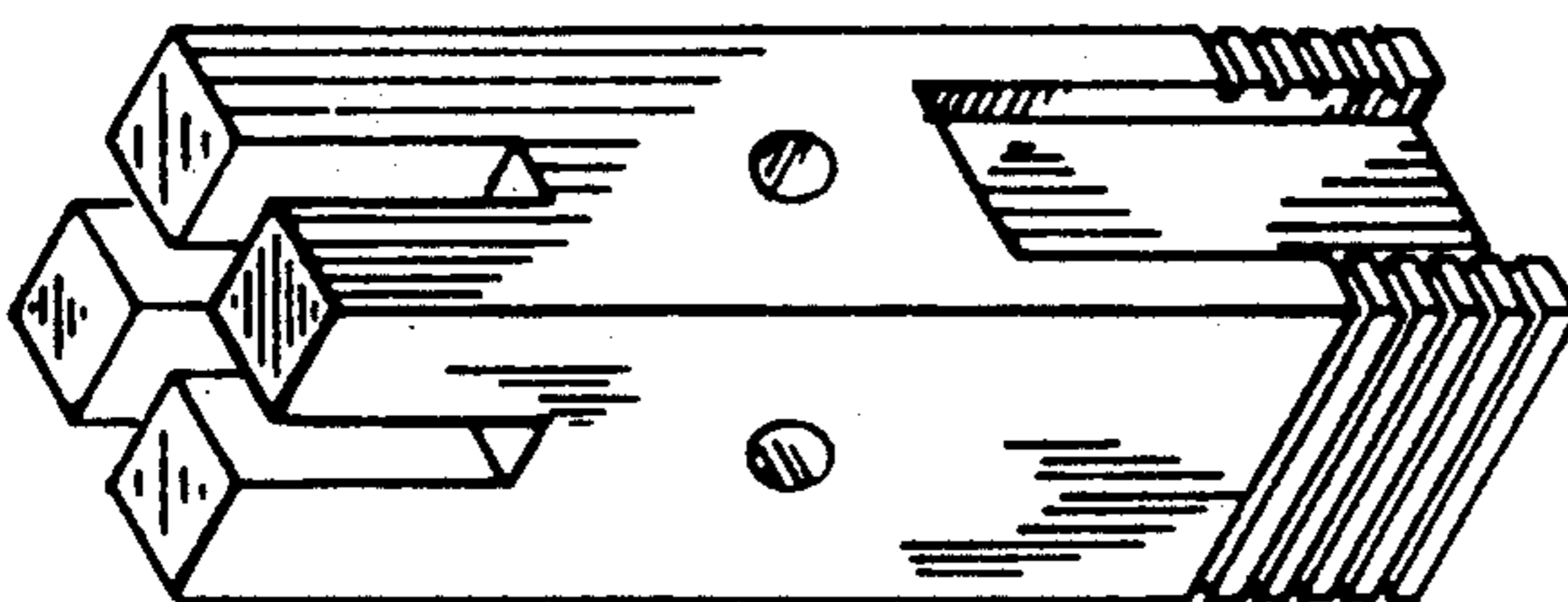

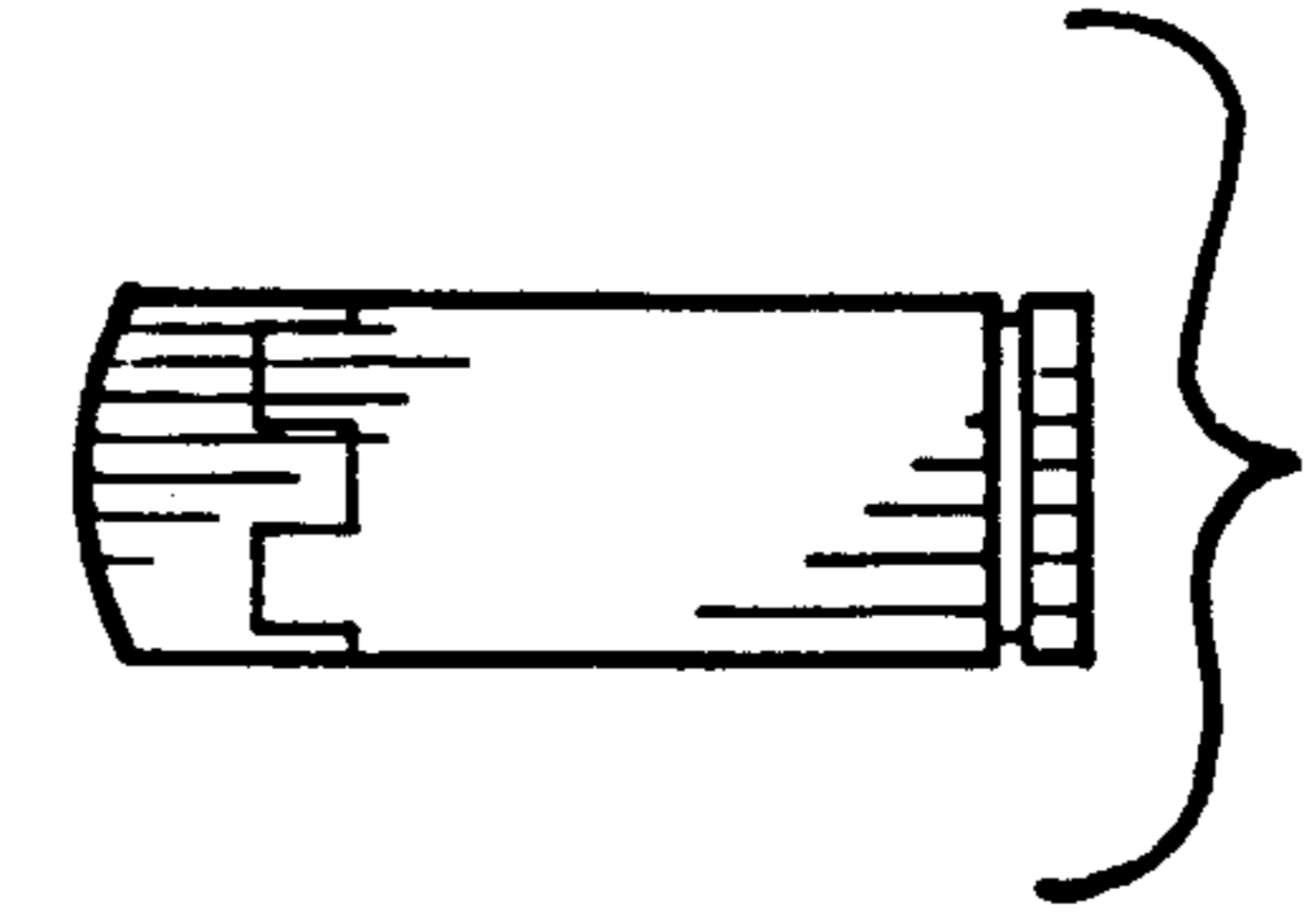
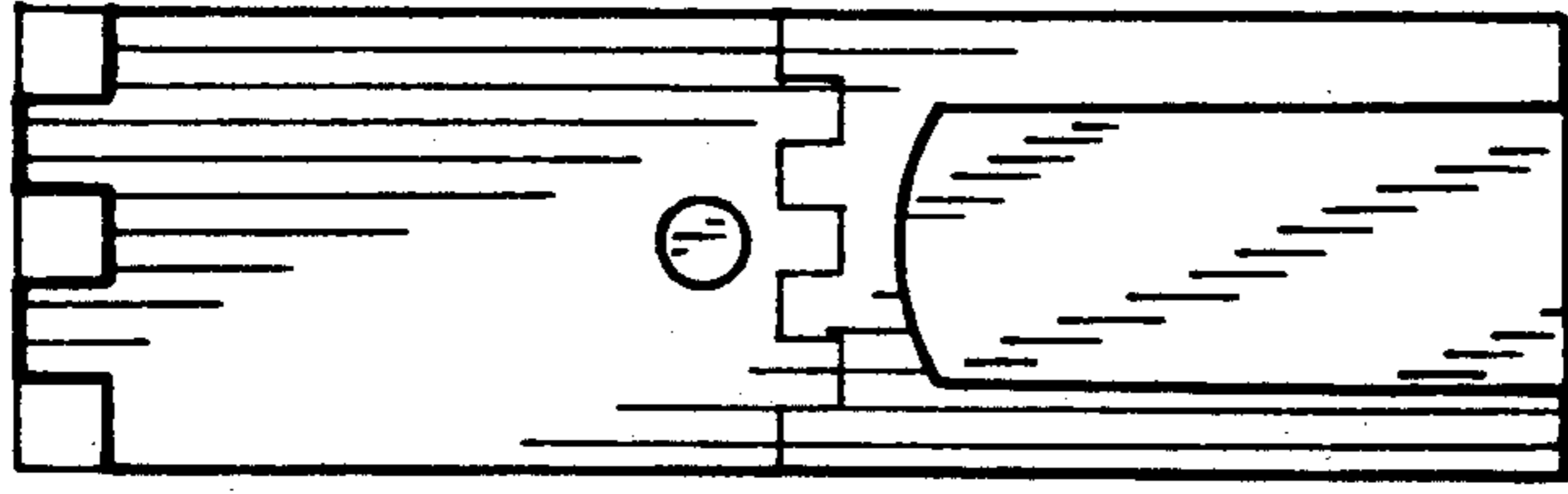

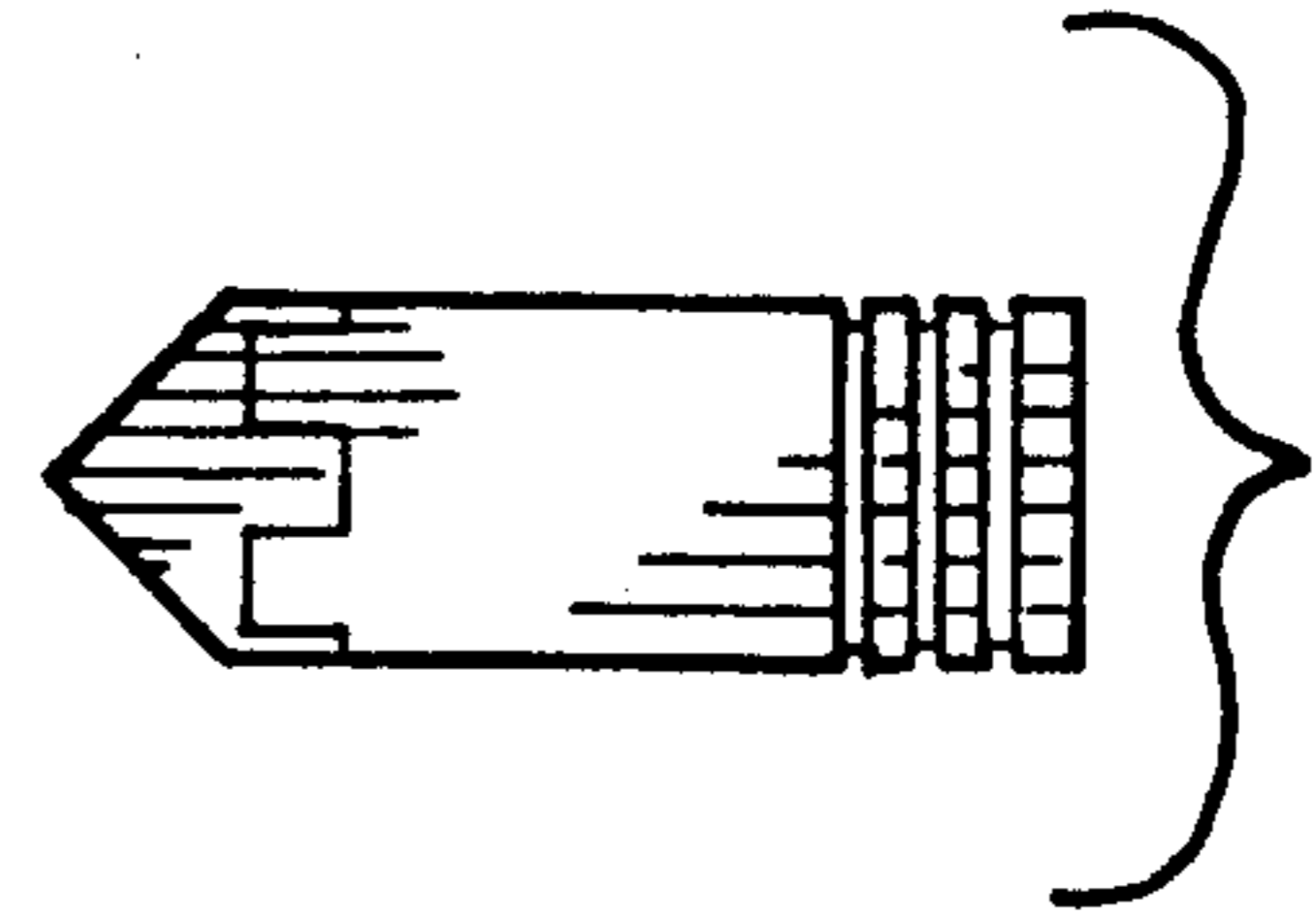
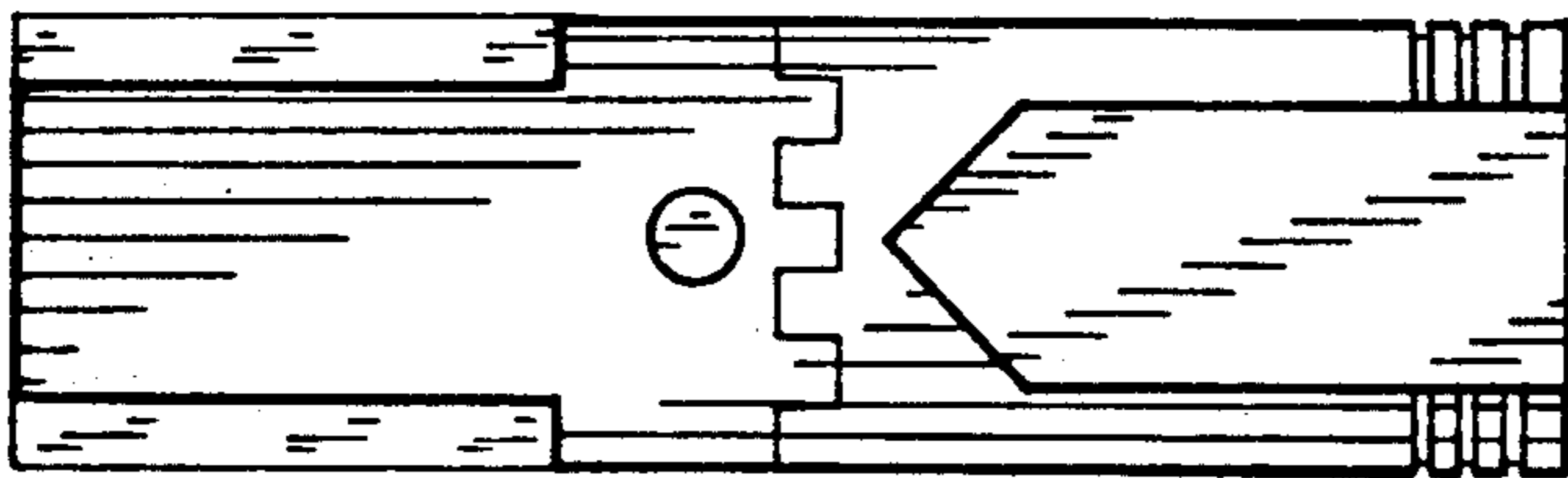

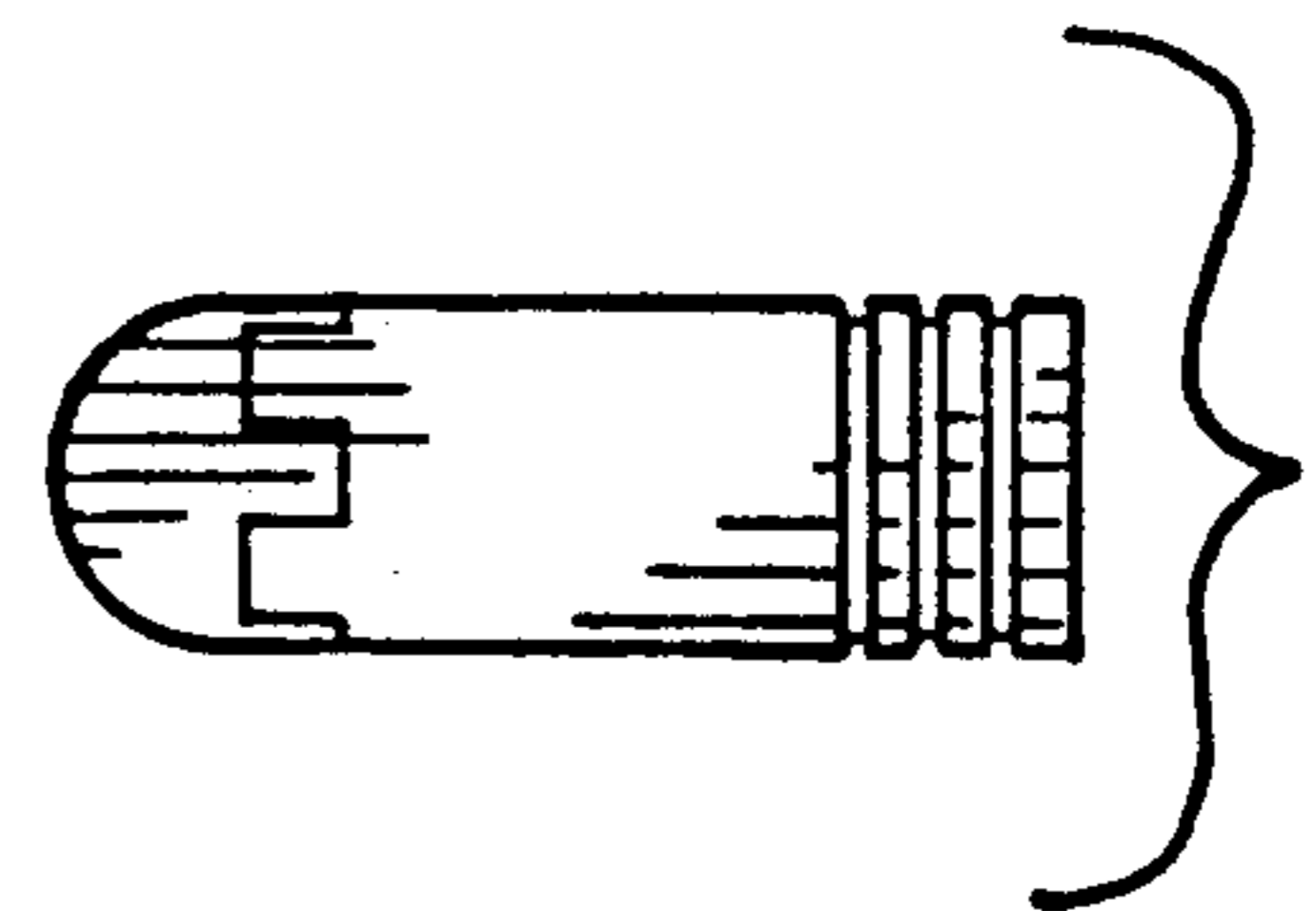
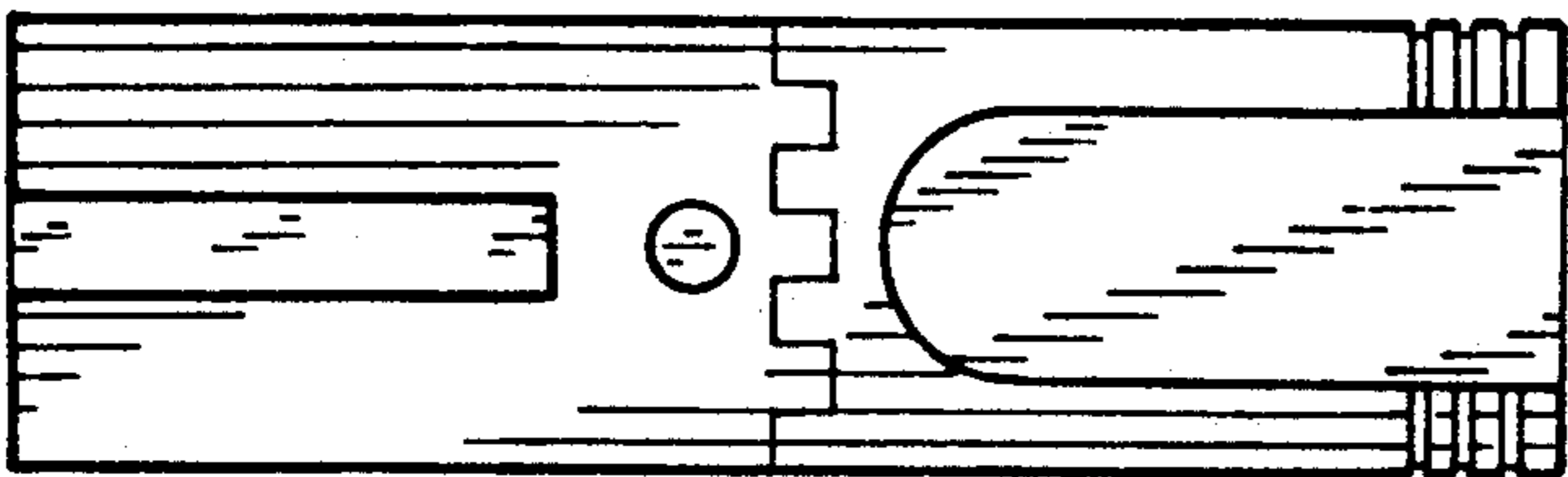

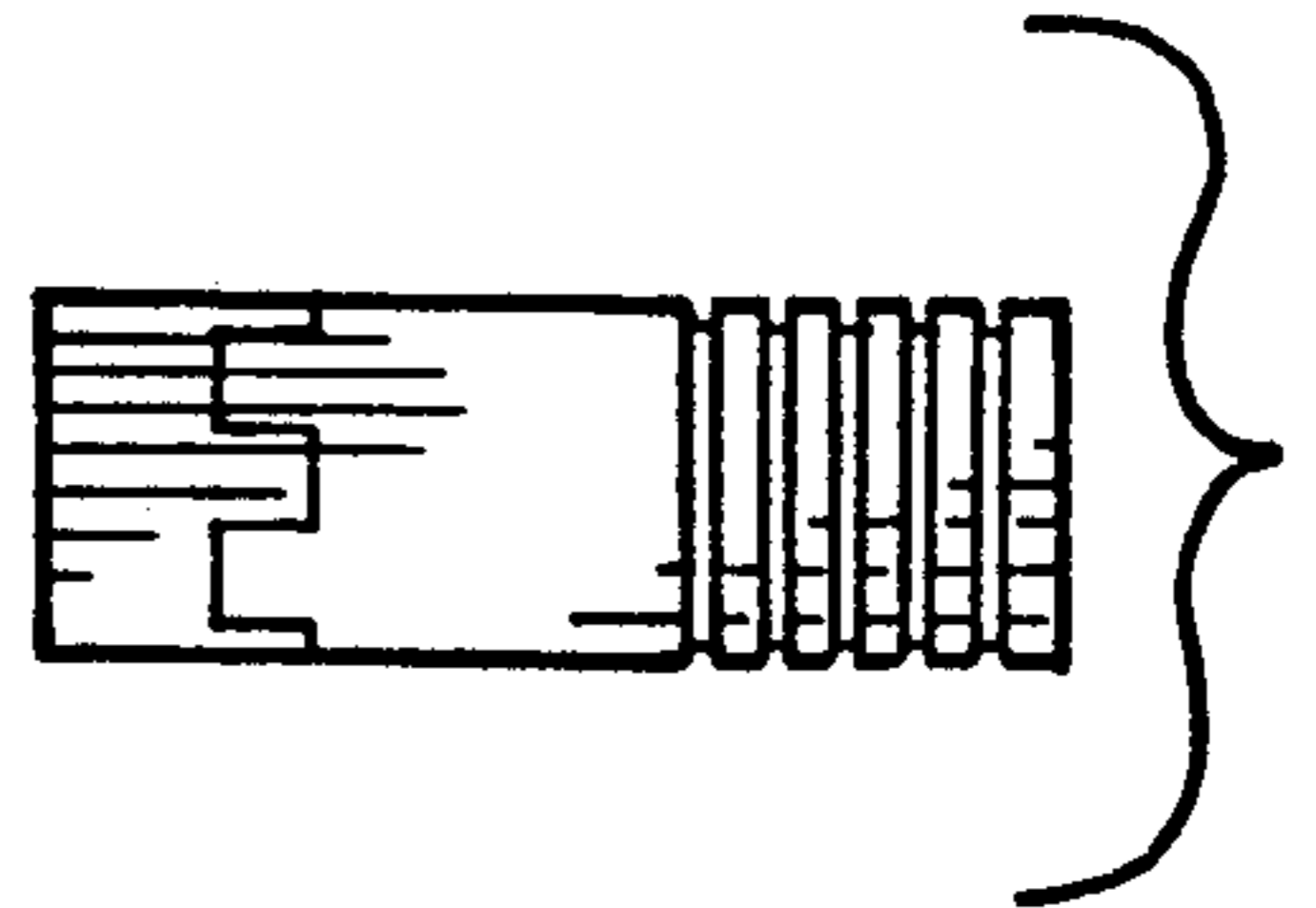
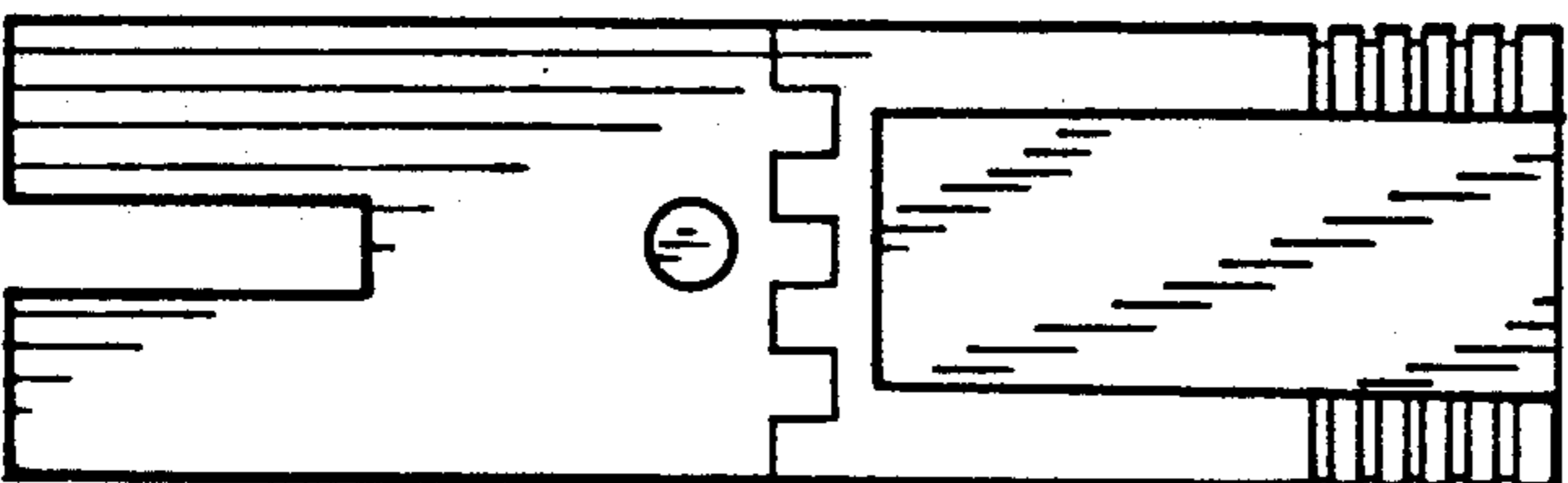

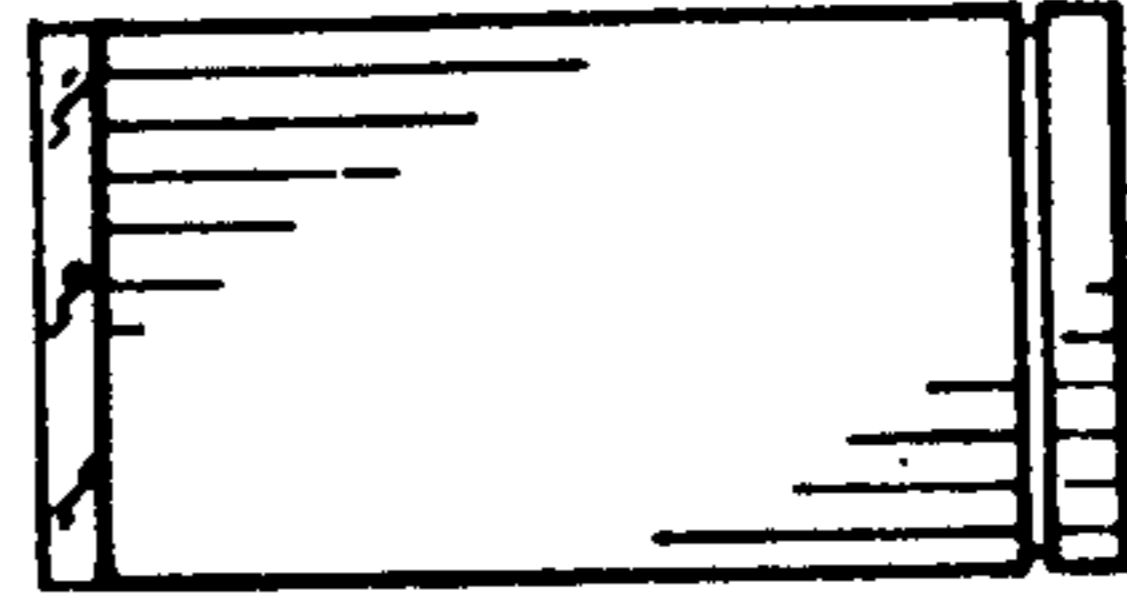
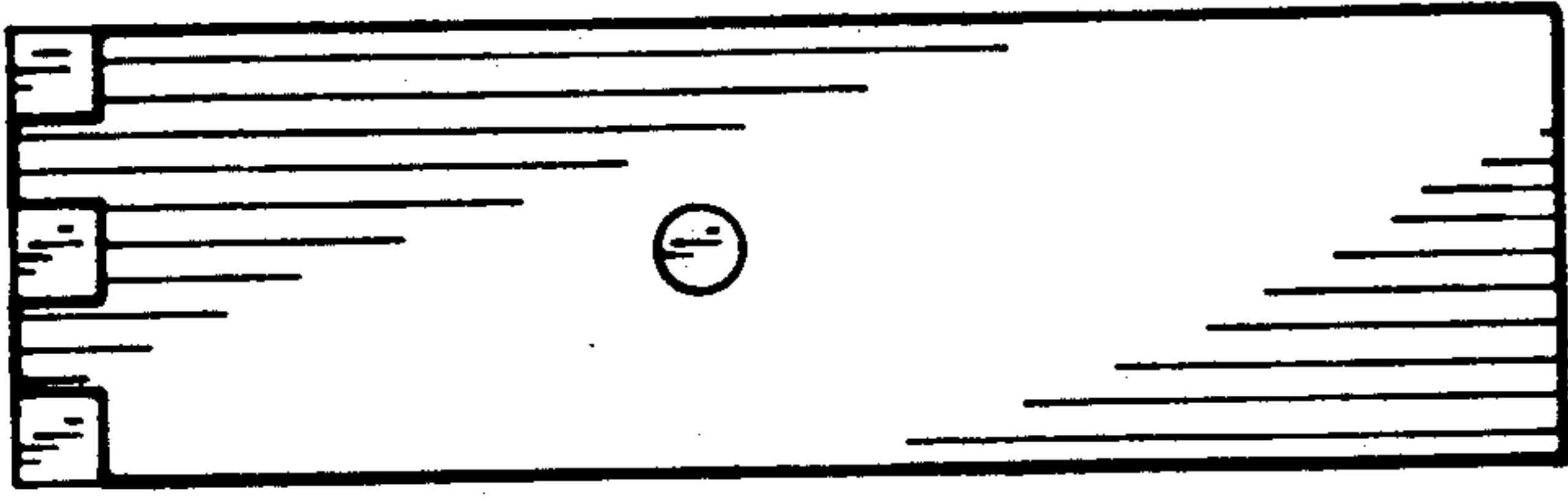

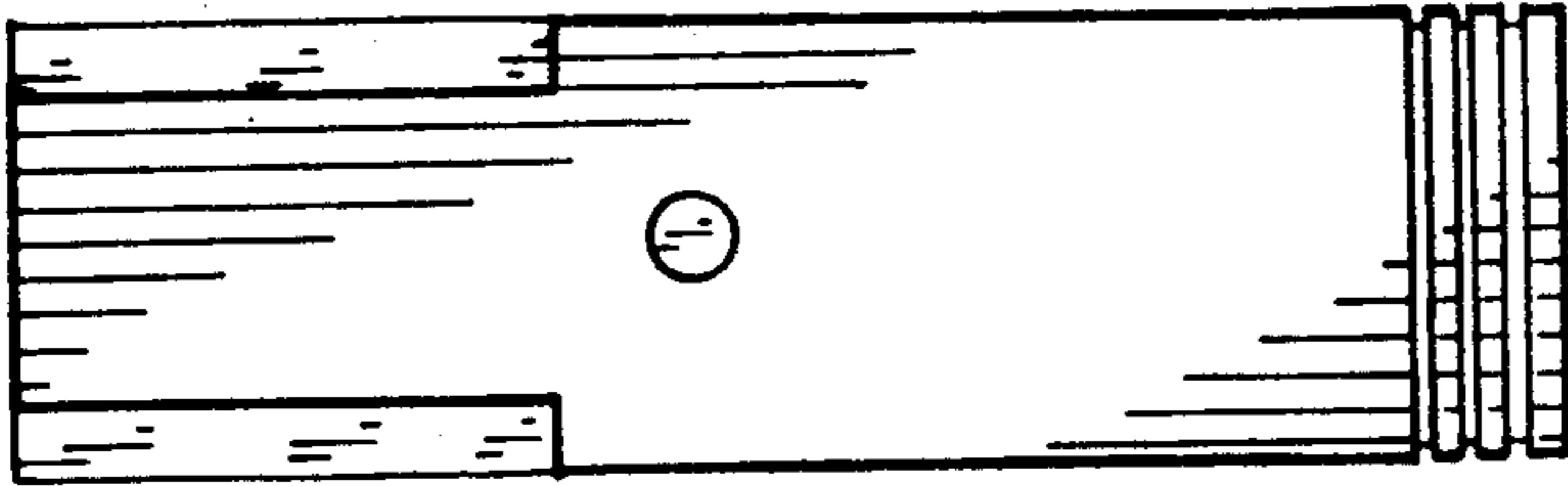

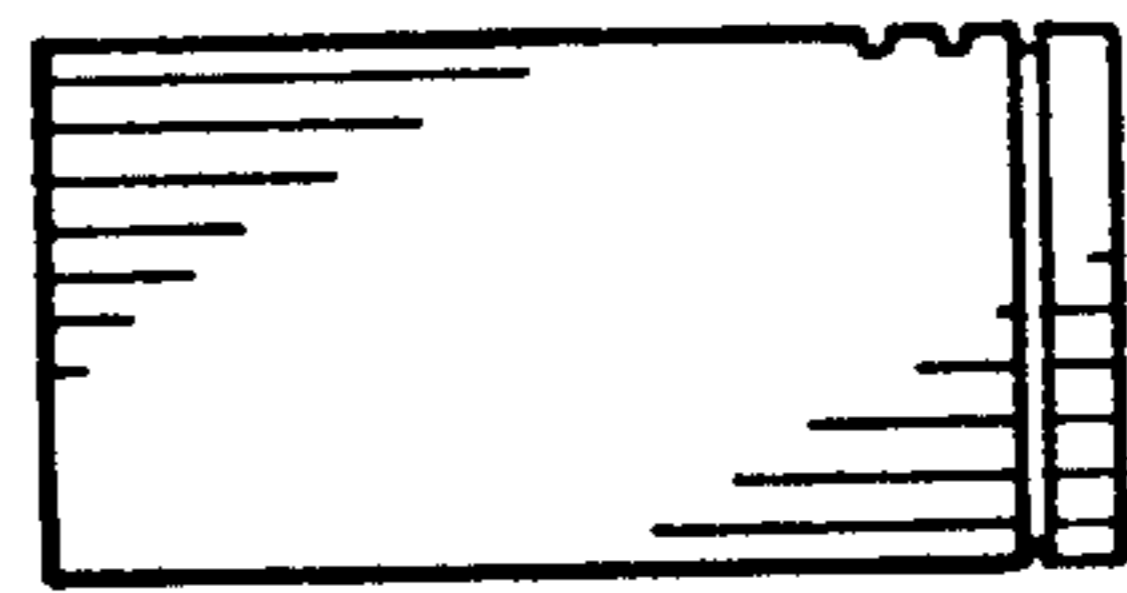
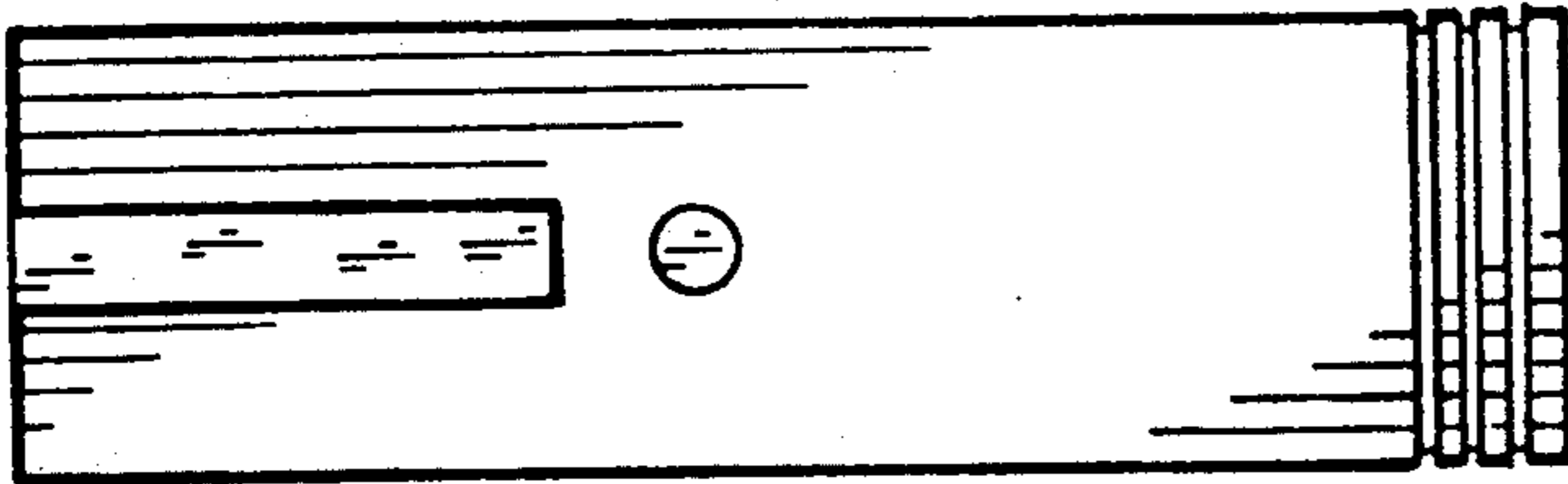

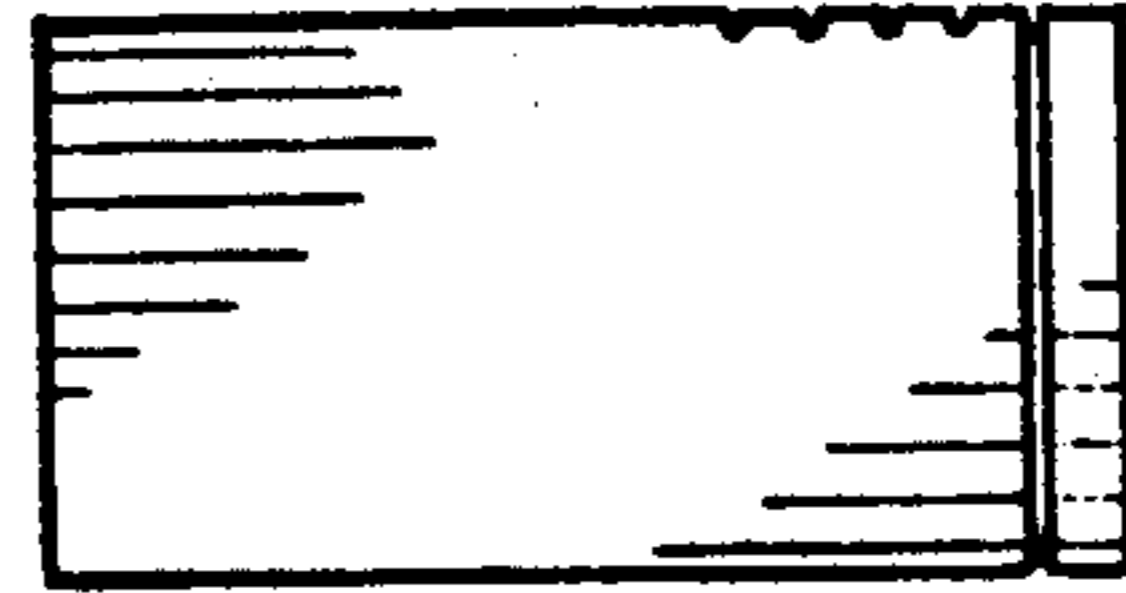
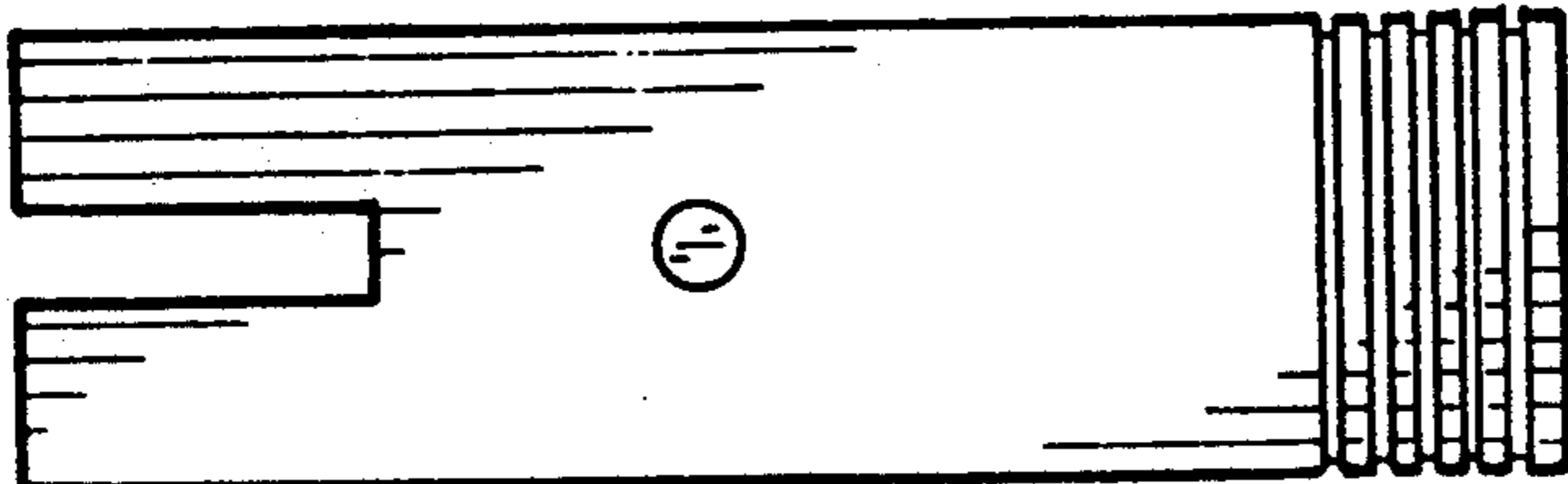

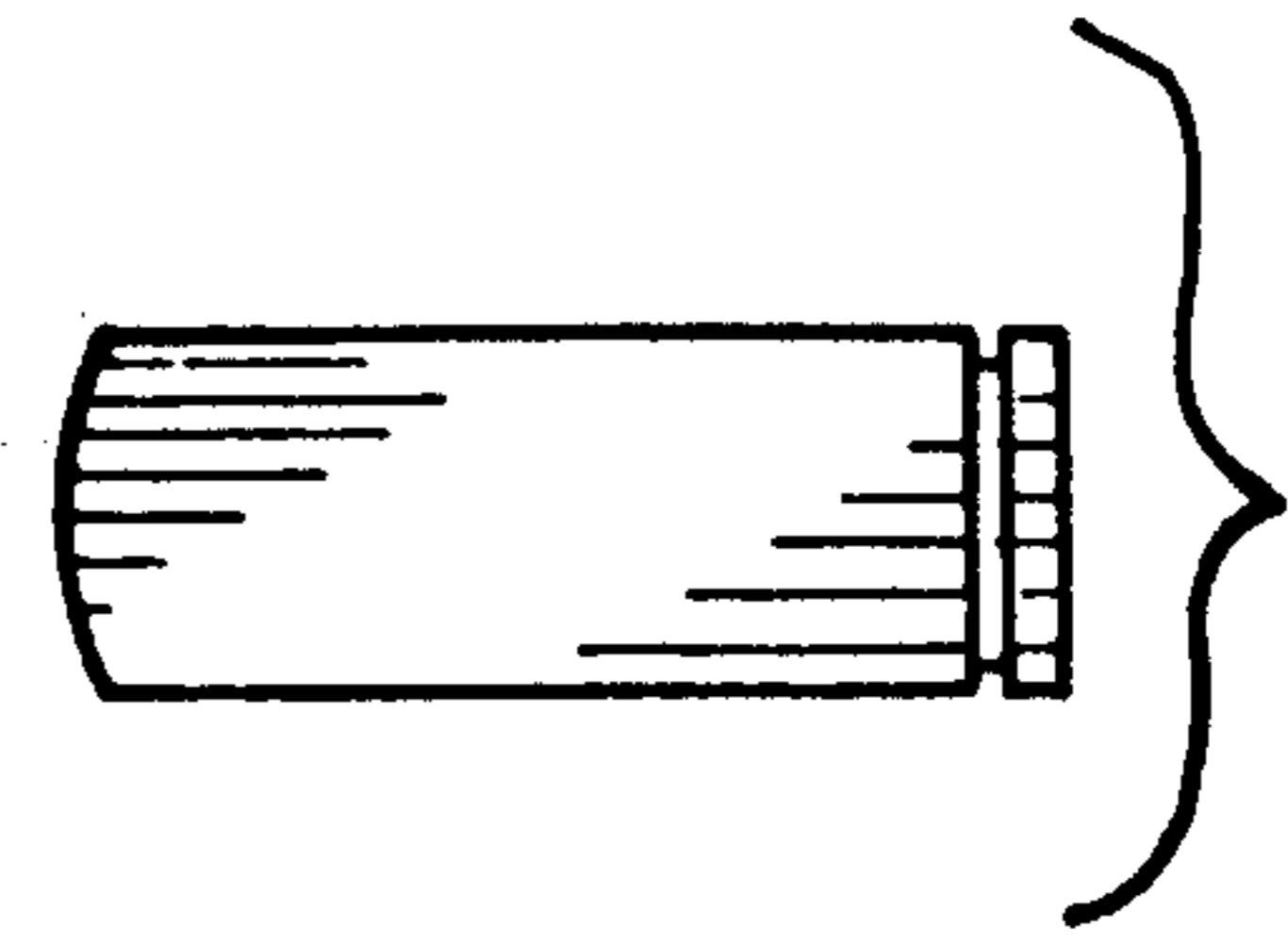
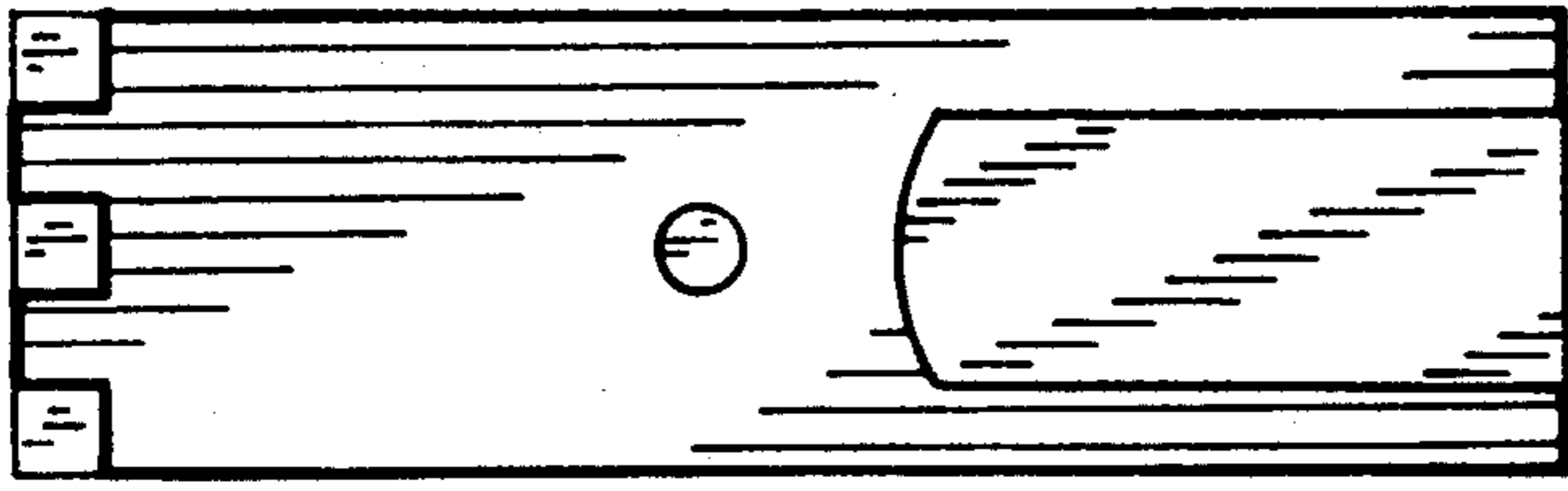

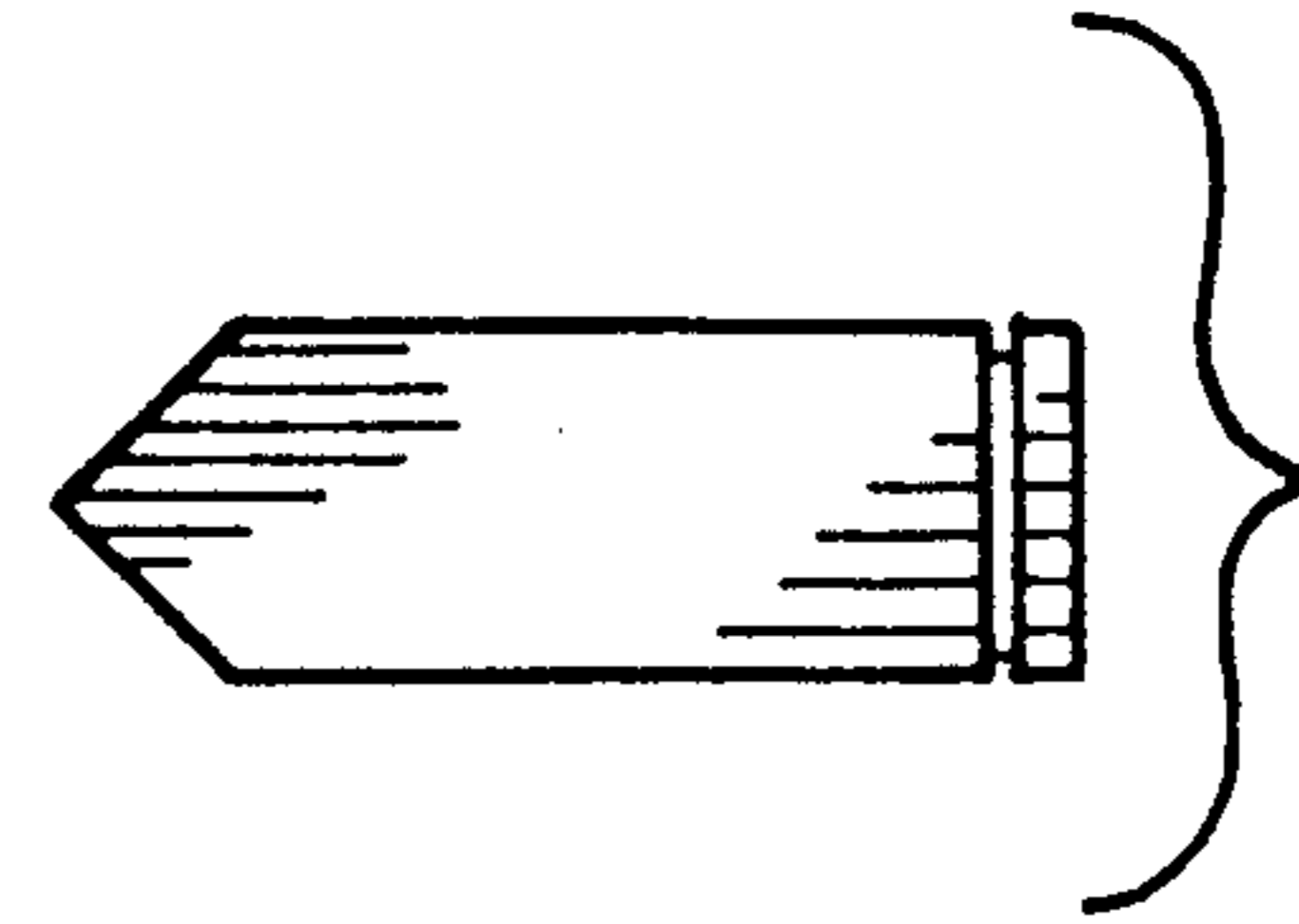
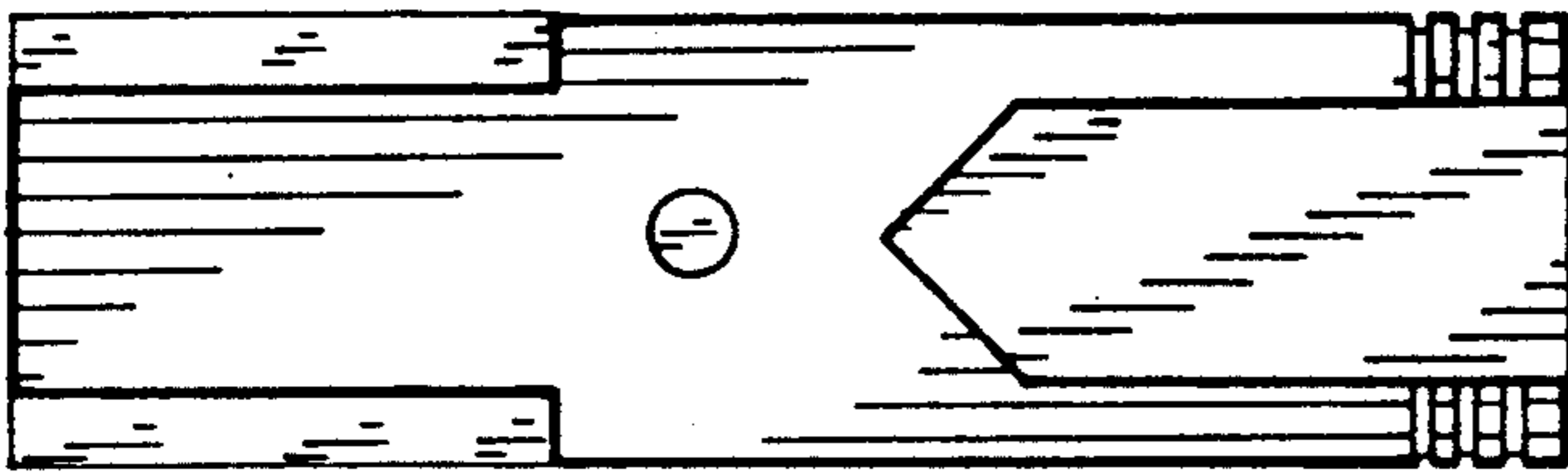

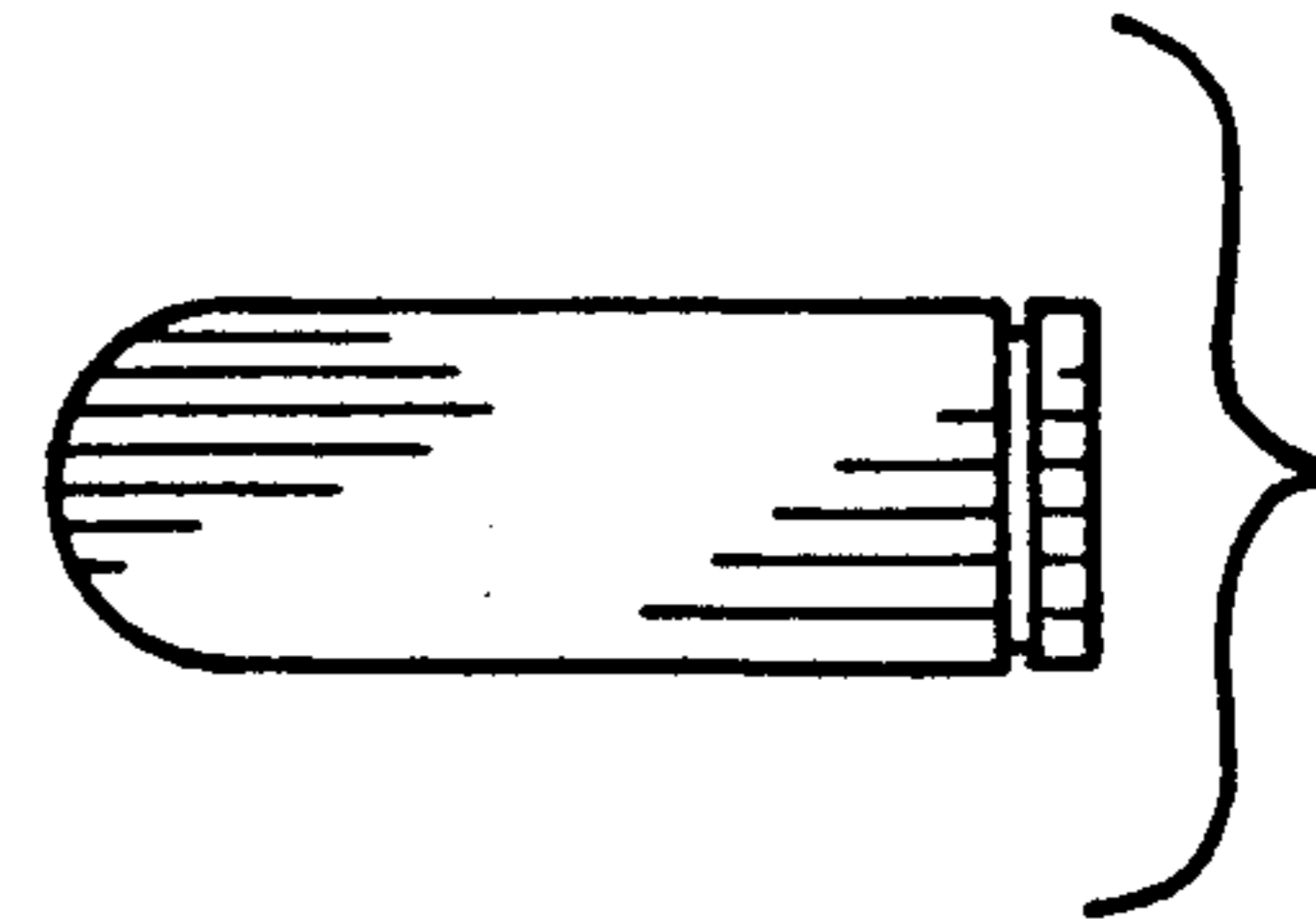
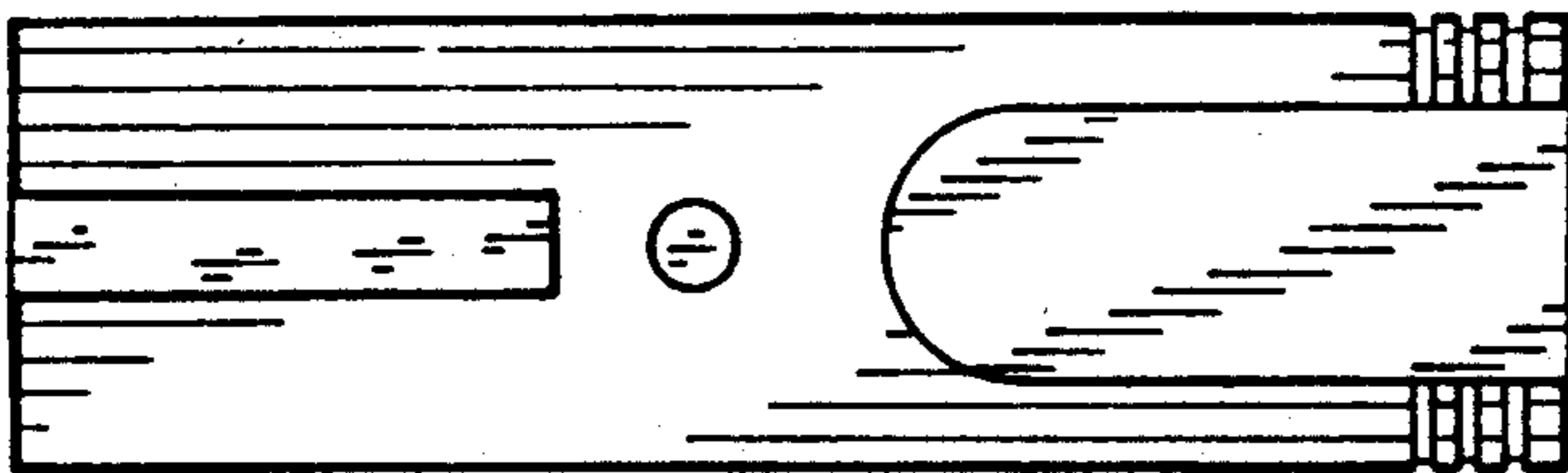

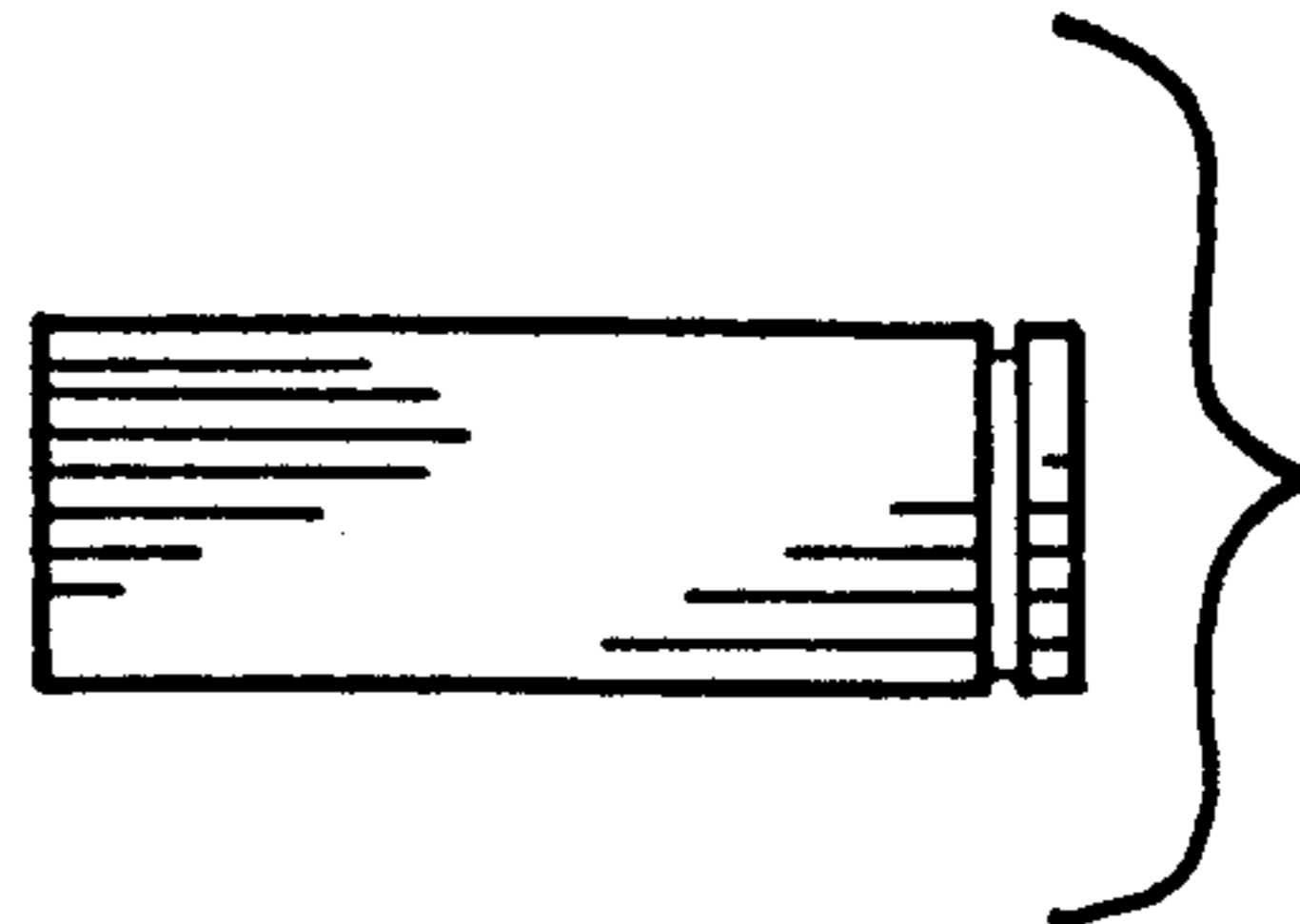
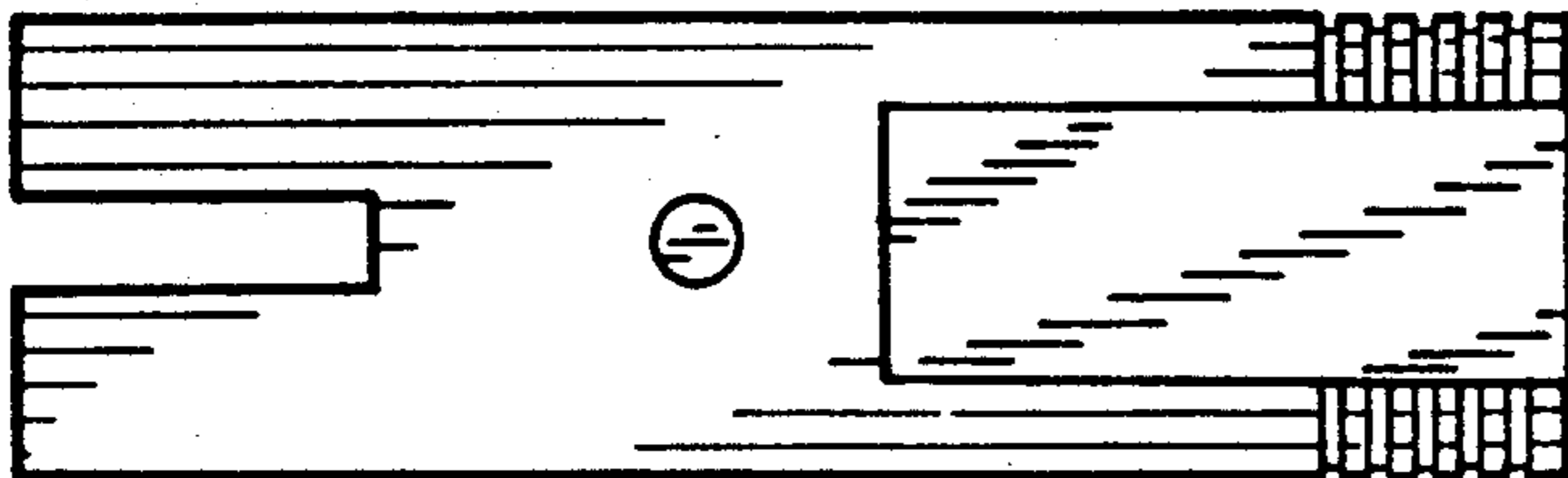

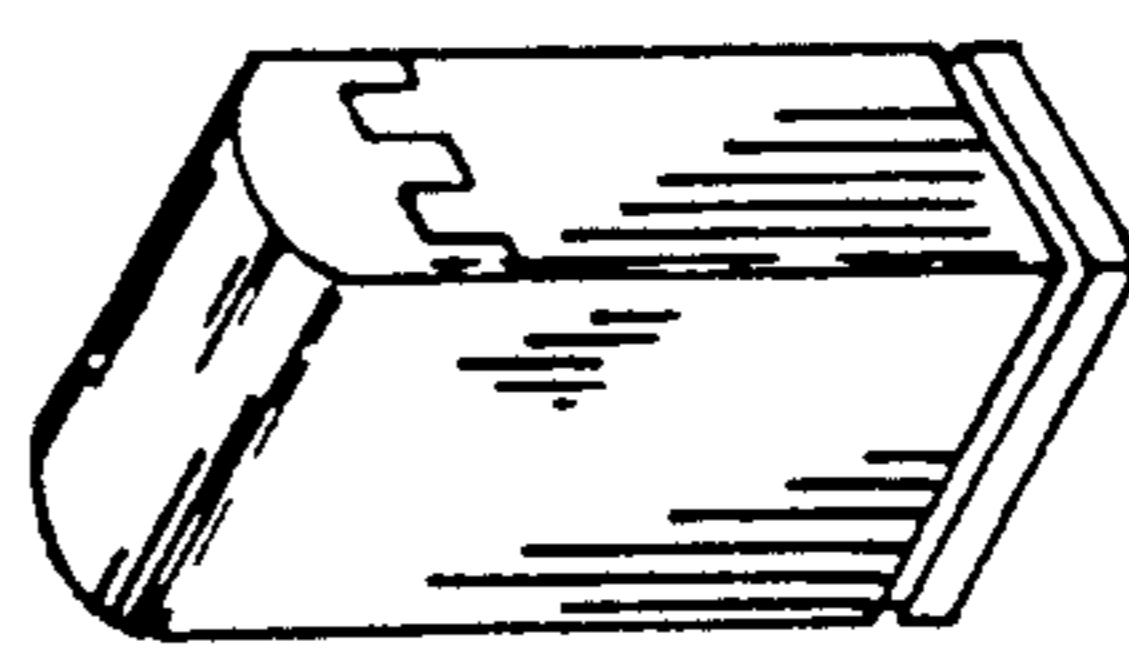
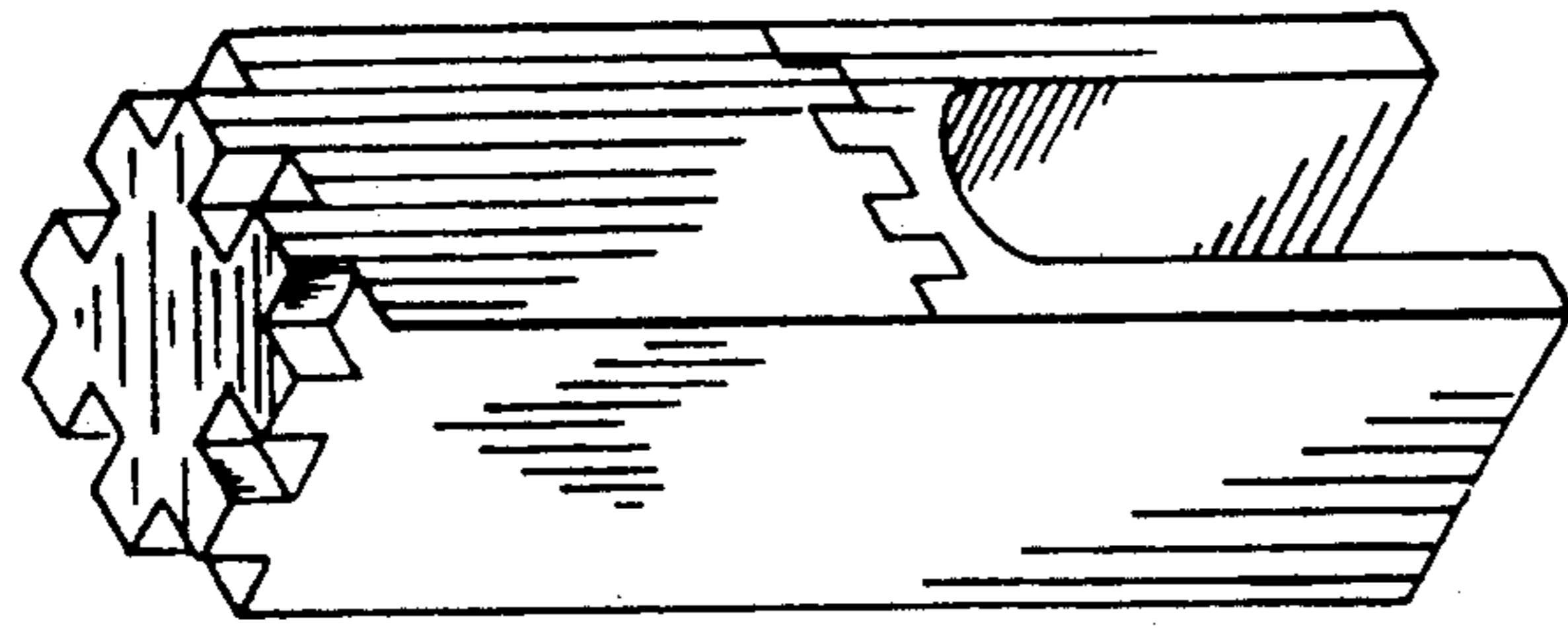

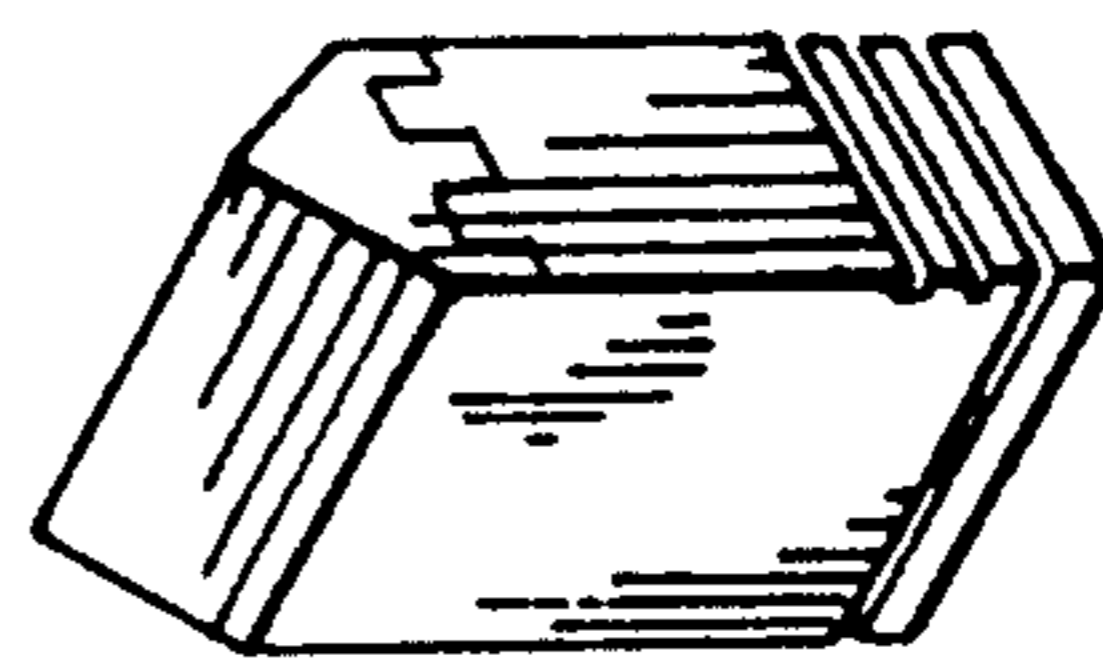
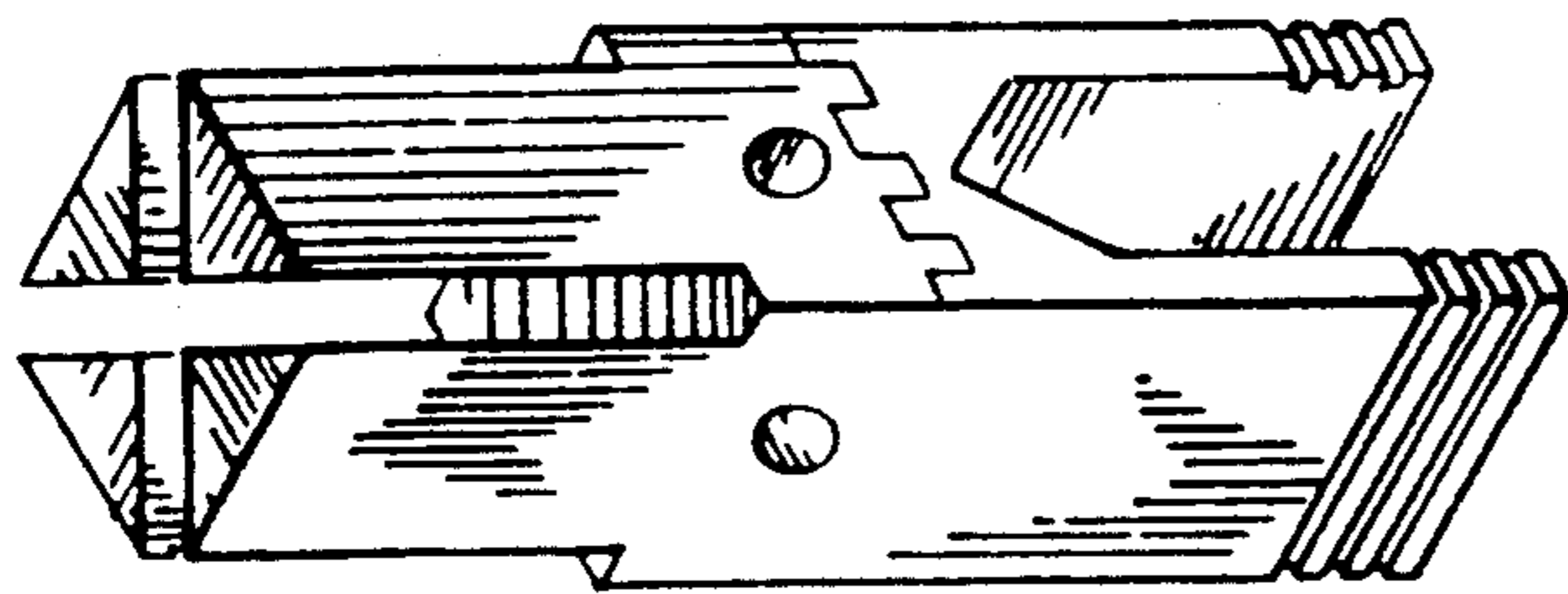

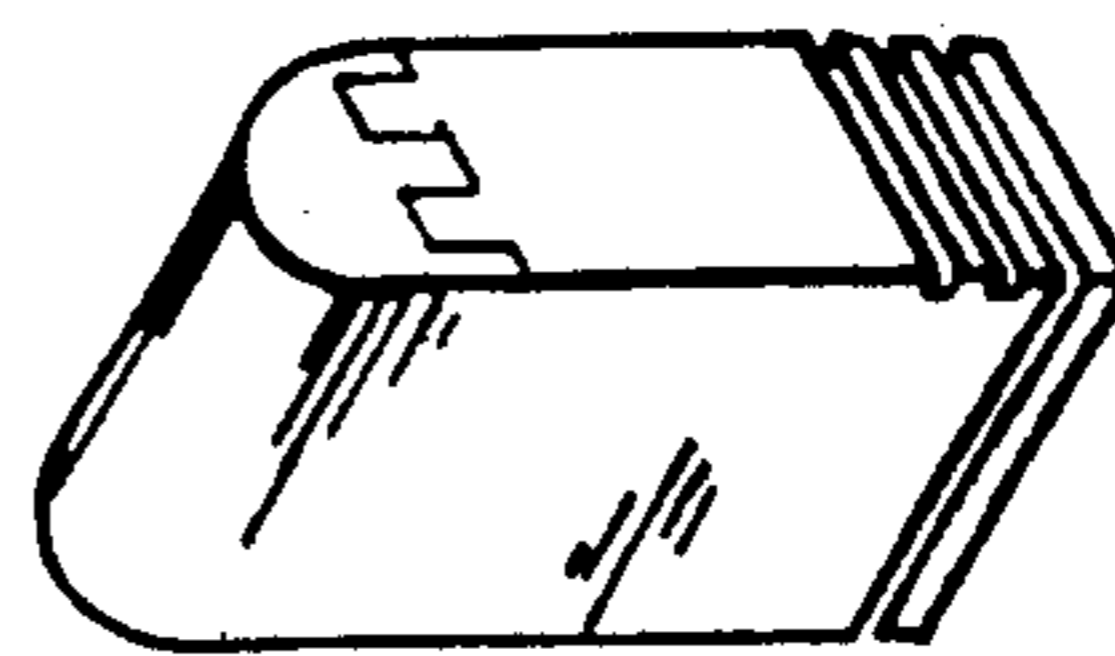
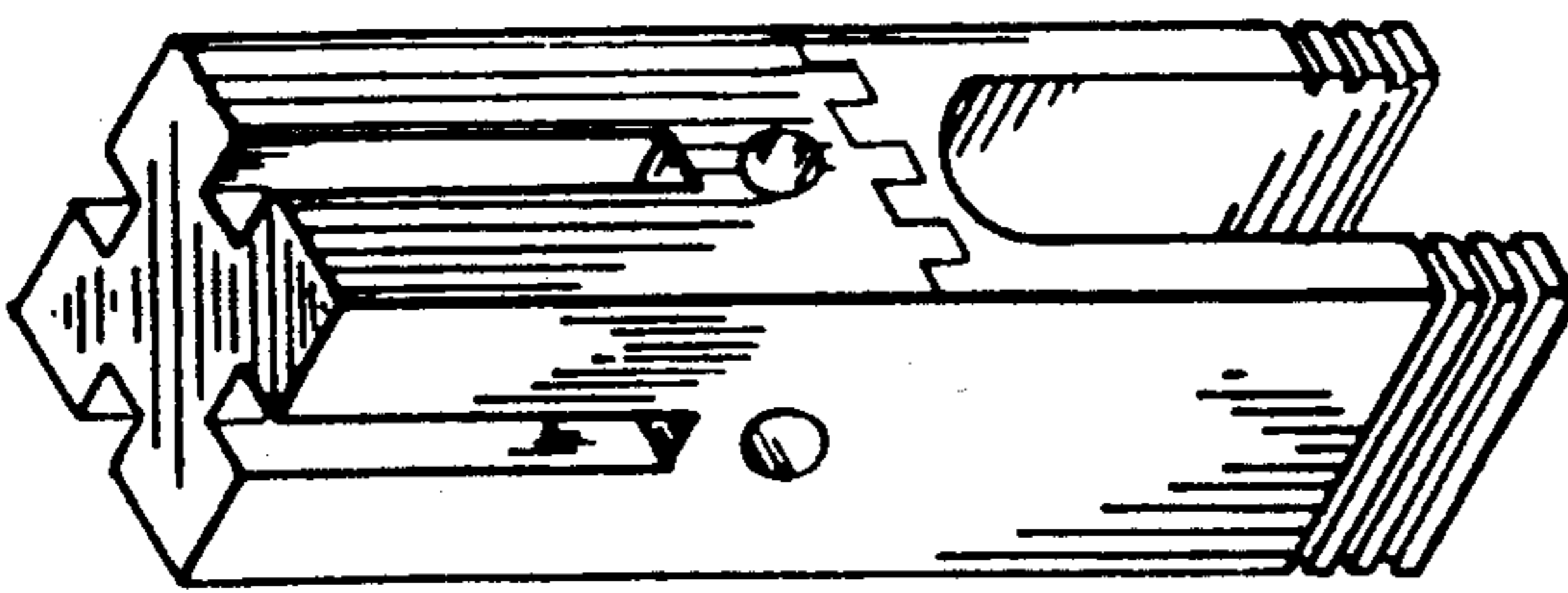

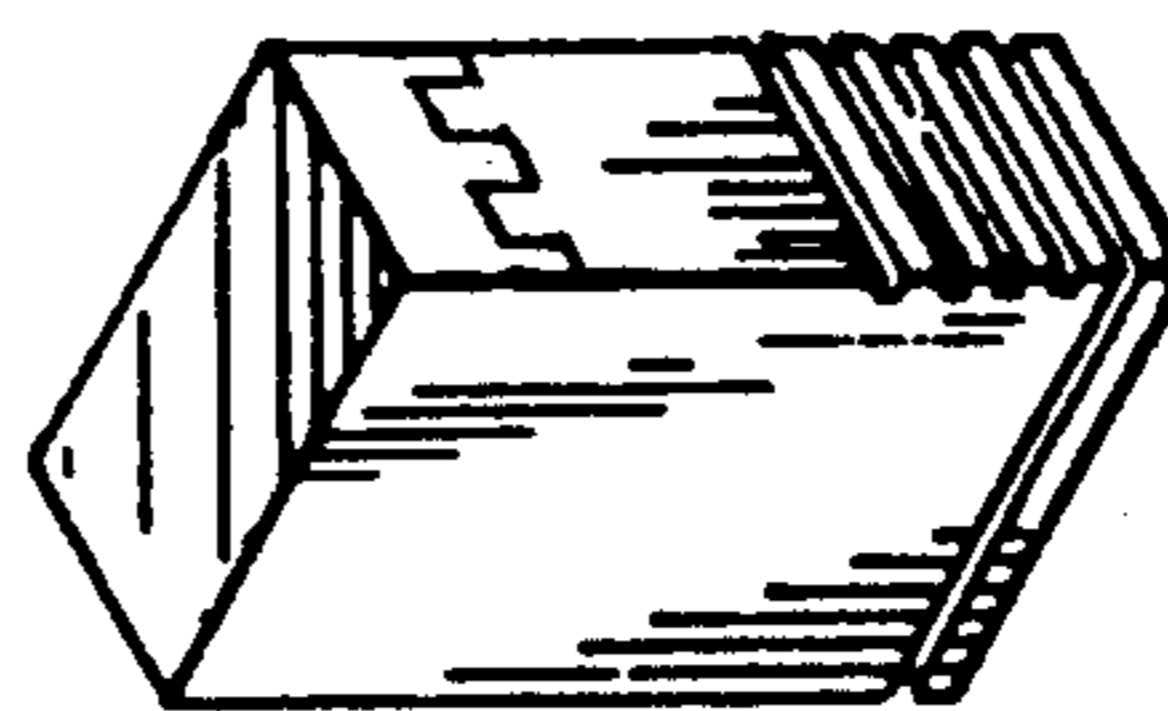
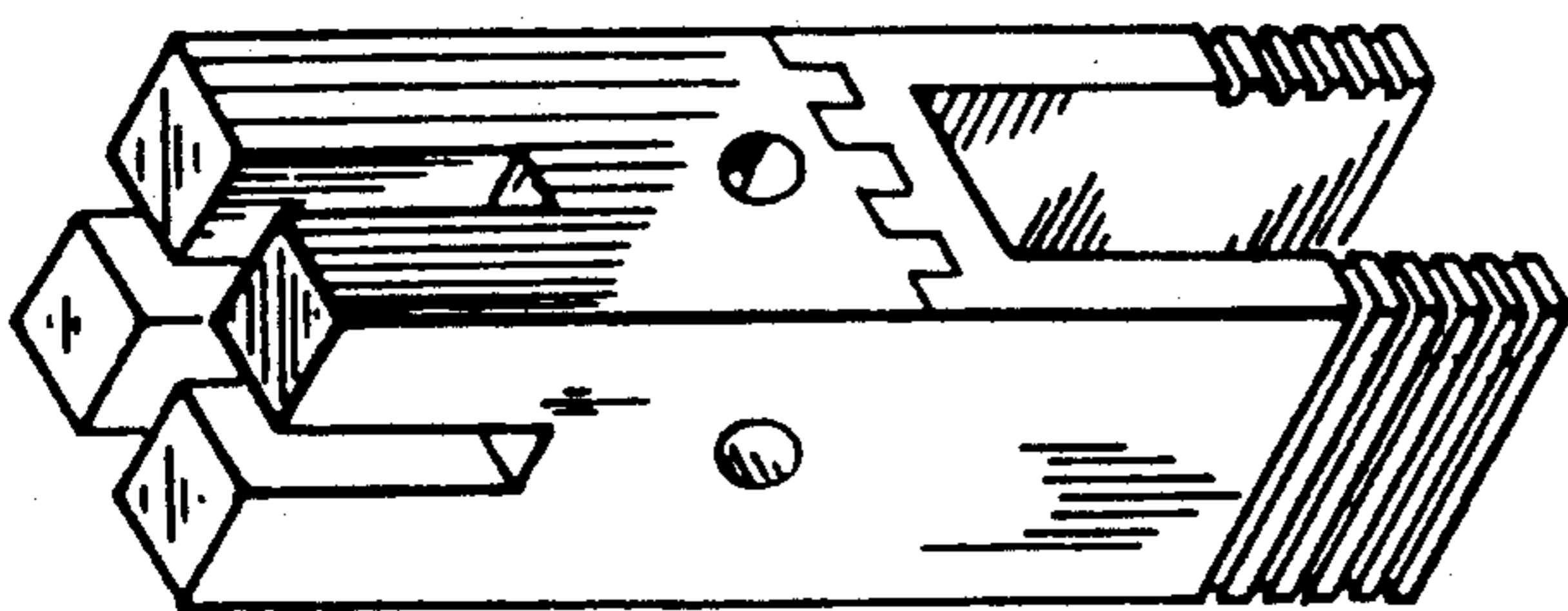

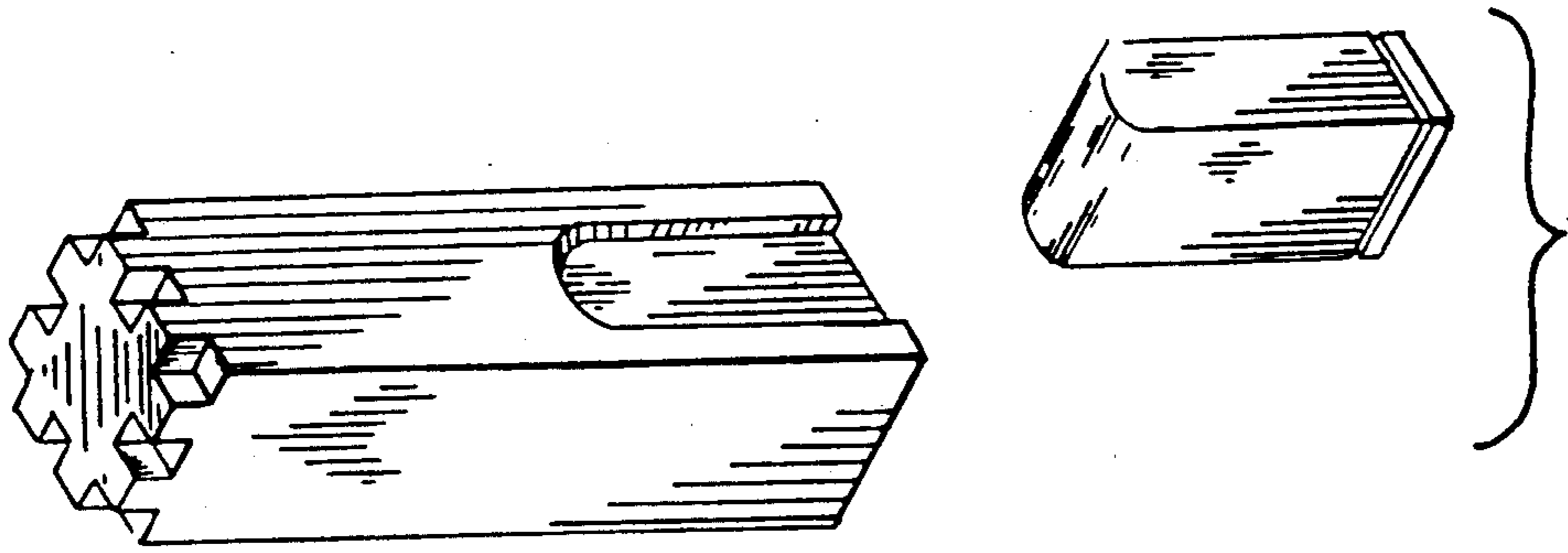

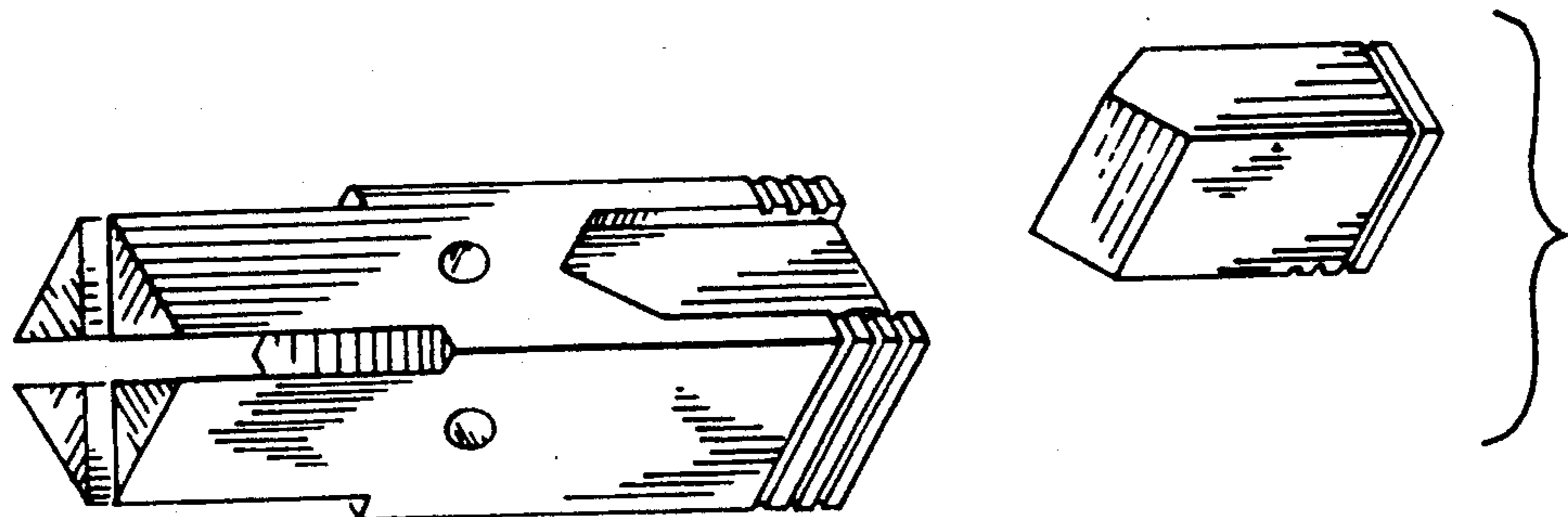

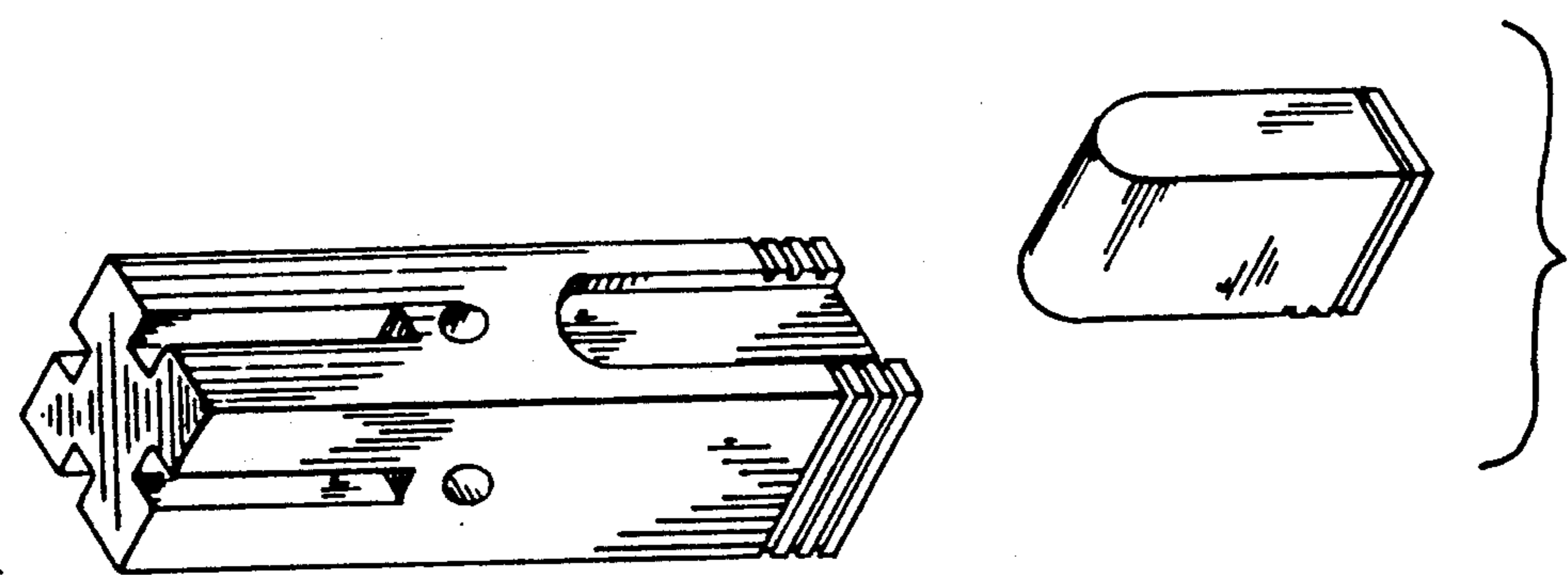

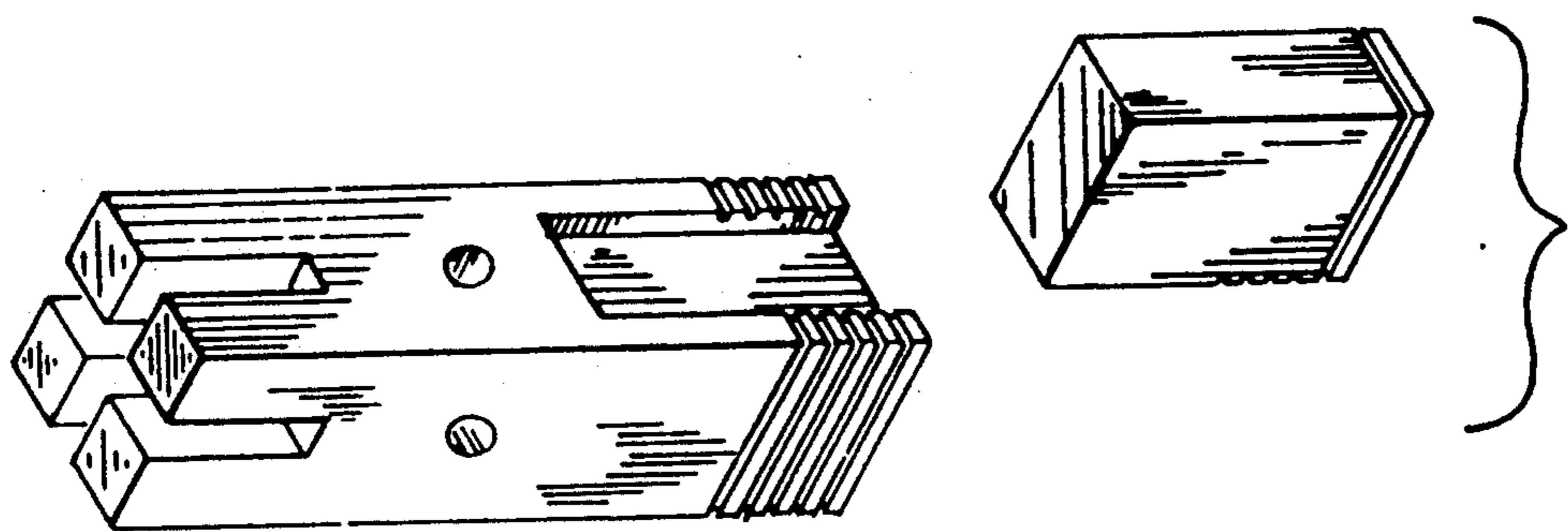
