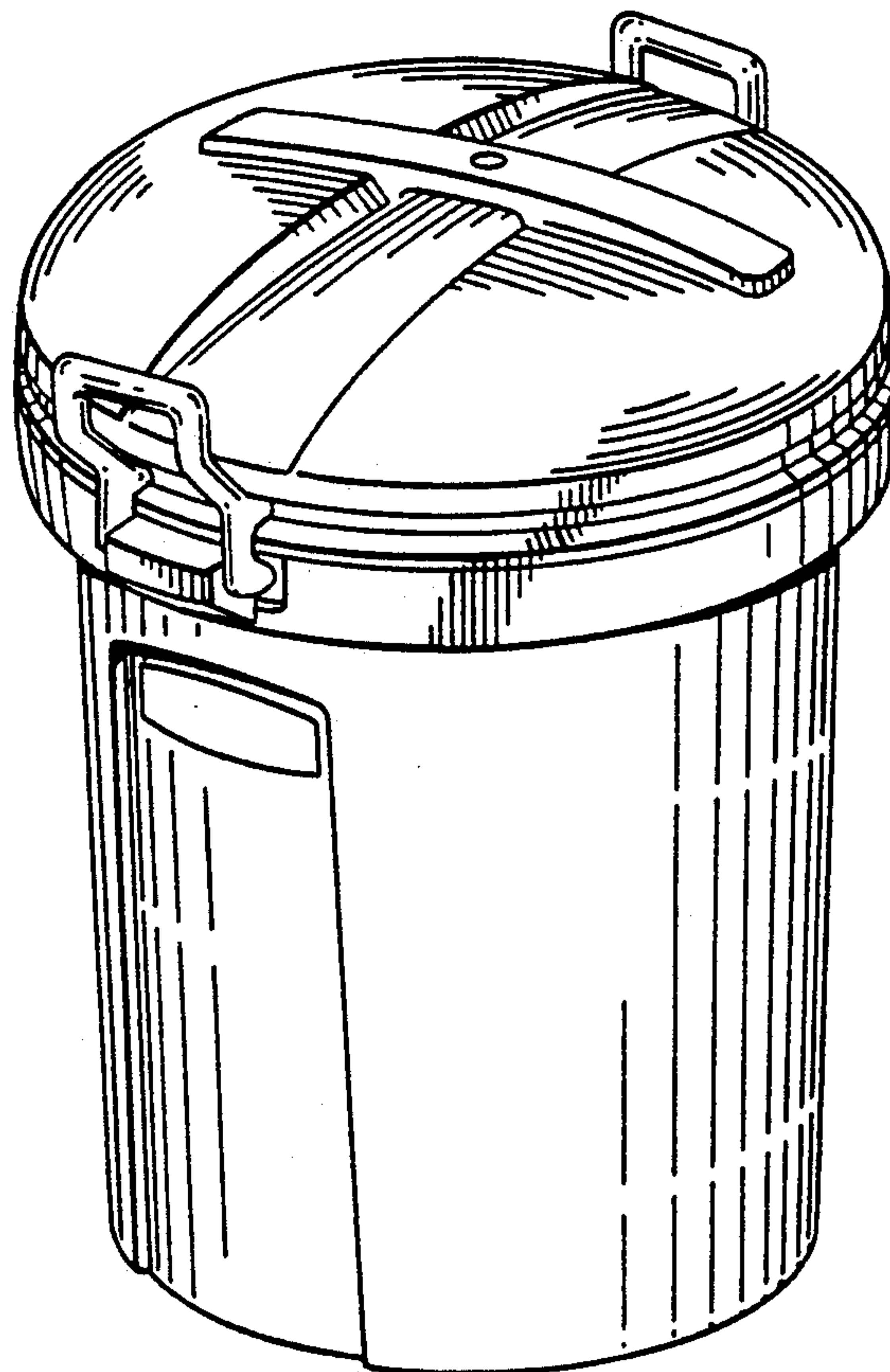

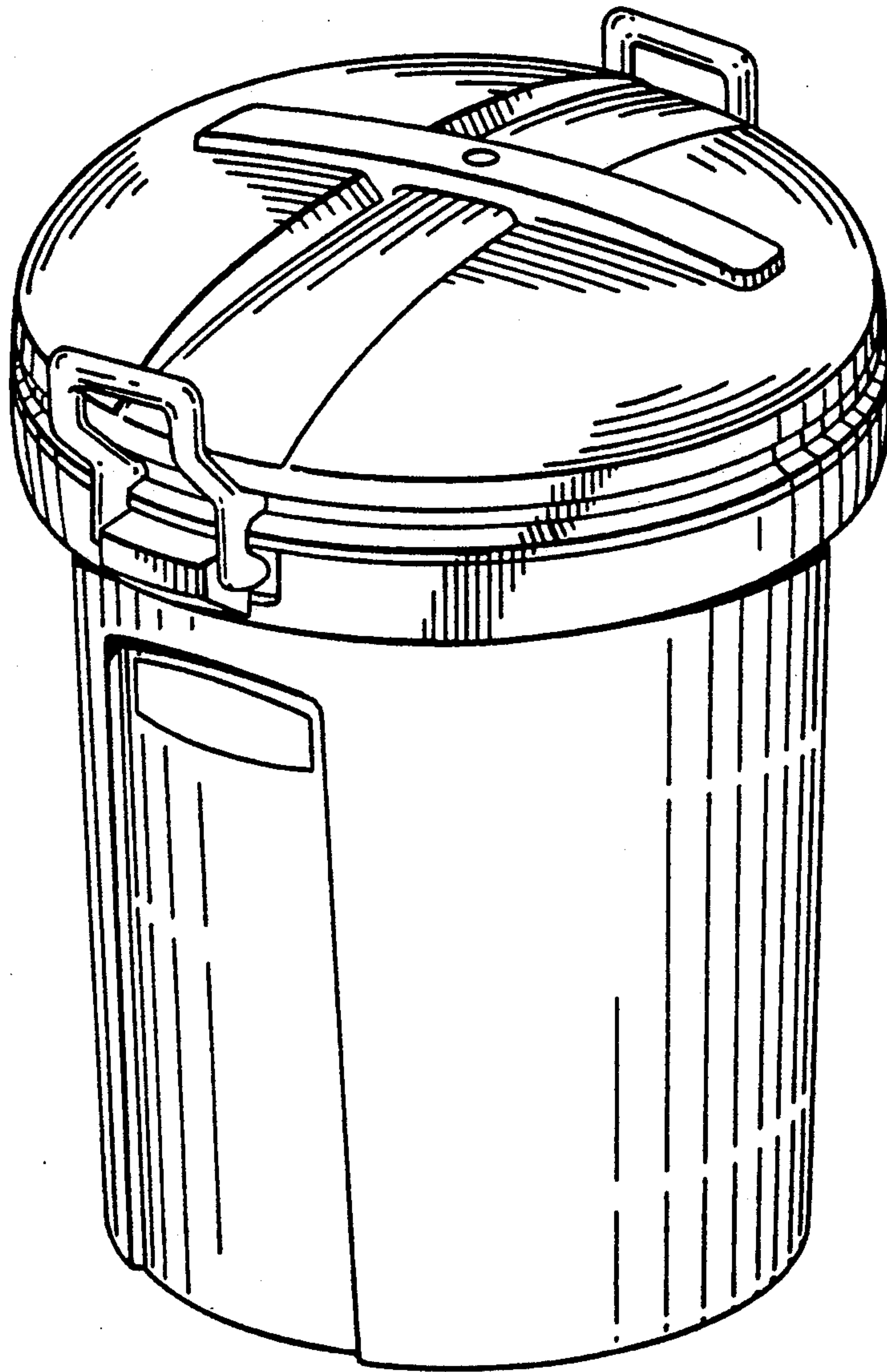
[57] **CLAIM**

The ornamental design for a refuse container, as shown and described.

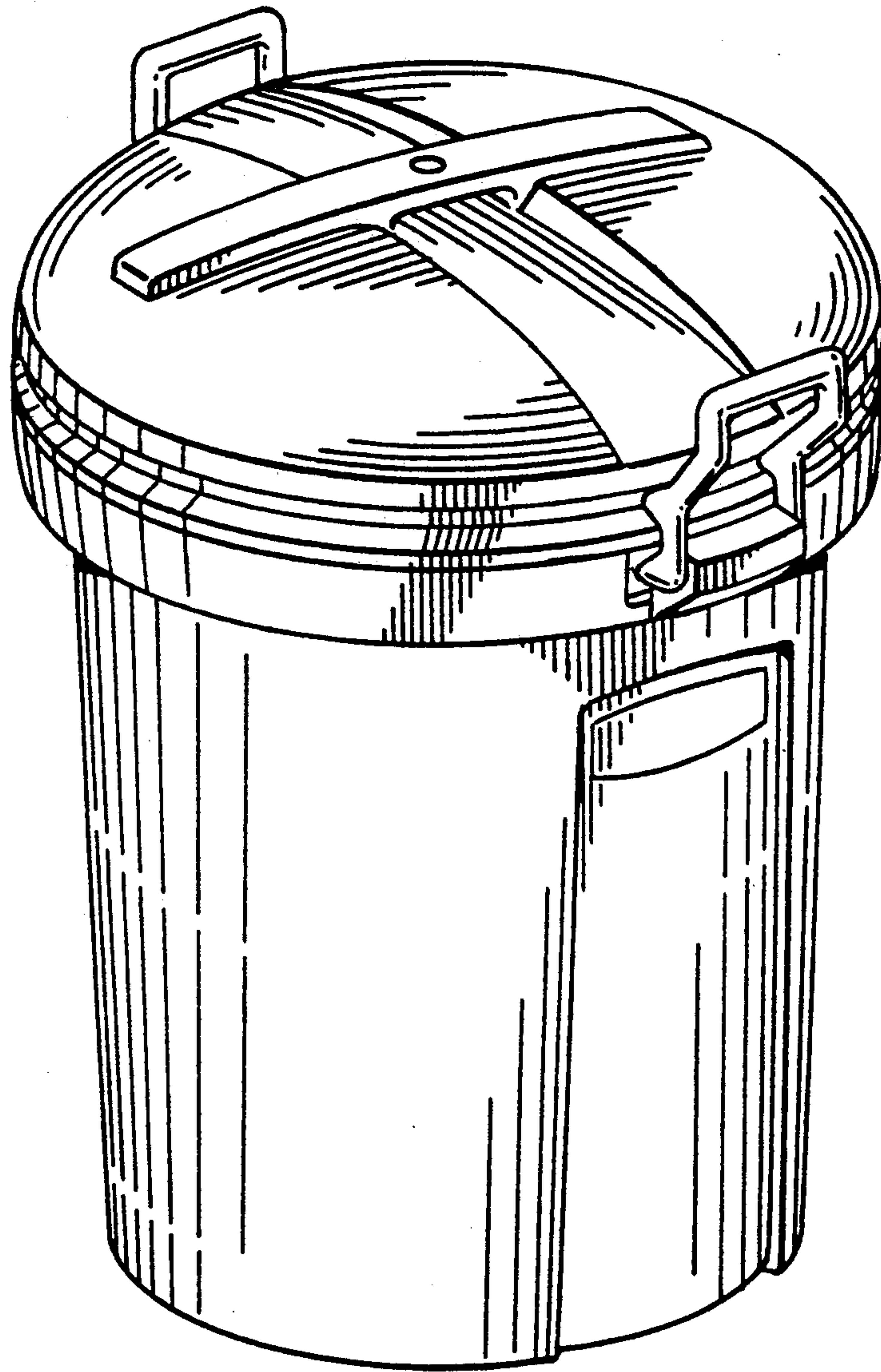
**DESCRIPTION**

FIG. 1 is a top, front and side perspective view of a refuse container showing our new design;  
 FIG. 2 is a top and rear perspective view thereof;  
 FIG. 3 is a front elevational view thereof, the rear elevational view being a mirror image of that shown;  
 FIG. 4 is a side elevational view thereof, the opposite side elevational view being a mirror image of that shown;  
 FIG. 5 is a top plan view thereof;  
 FIG. 6 is a bottom plan view thereof;  
 FIG. 7 is a top, front and side perspective view of a second embodiment of the refuse container;  
 FIG. 8 is a front elevational view of FIG. 7, the rear elevational view being a mirror image of that shown;  
 FIG. 9 is a top, front and side perspective view of a third embodiment of the refuse container; and,  
 FIG. 10 is a front elevational view of FIG. 9, the rear elevational view being a mirror image of that shown.  
 The undisclosed bottom of FIGS. 1, 7 and 9 is flat and unornamented.

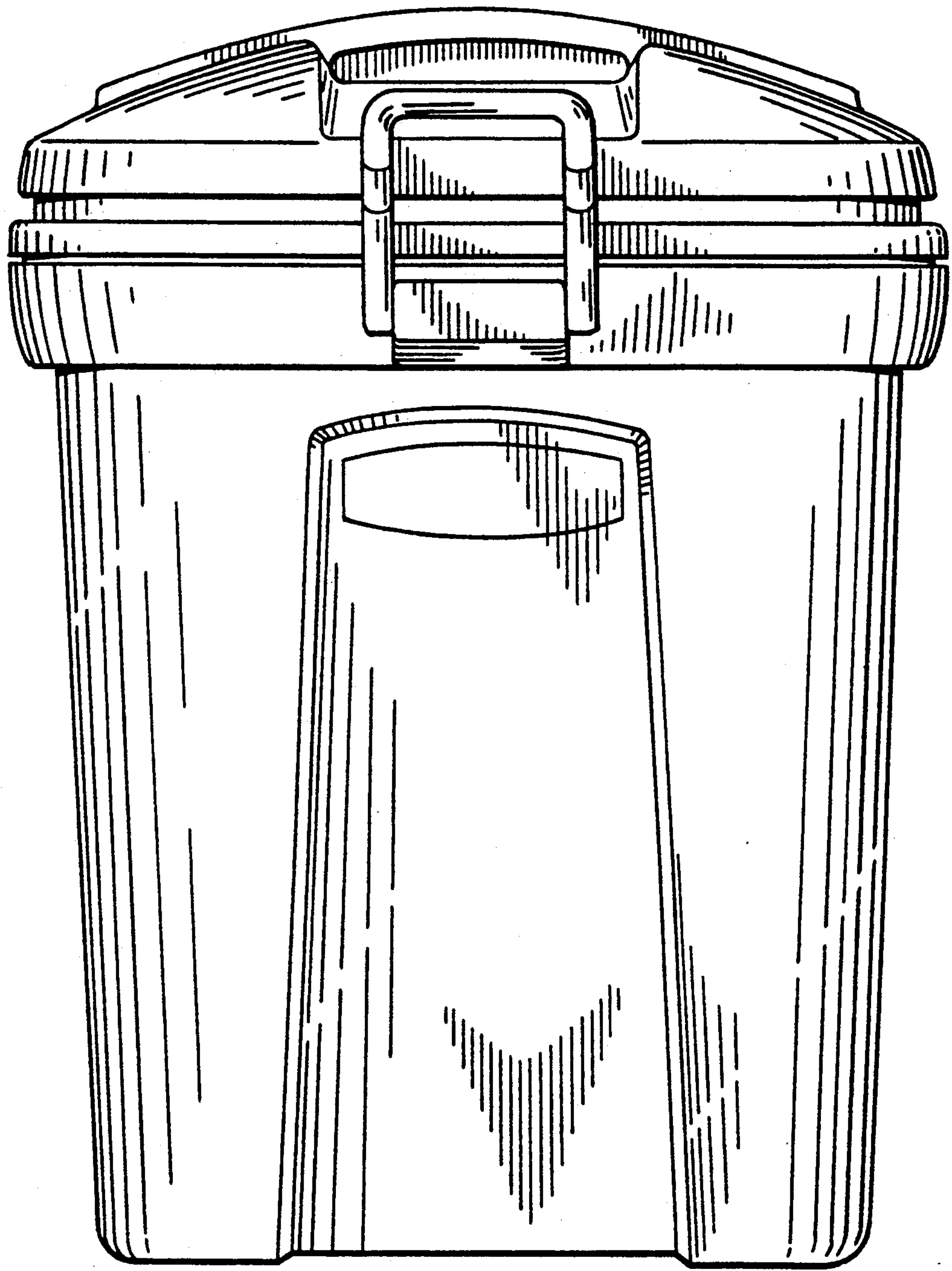

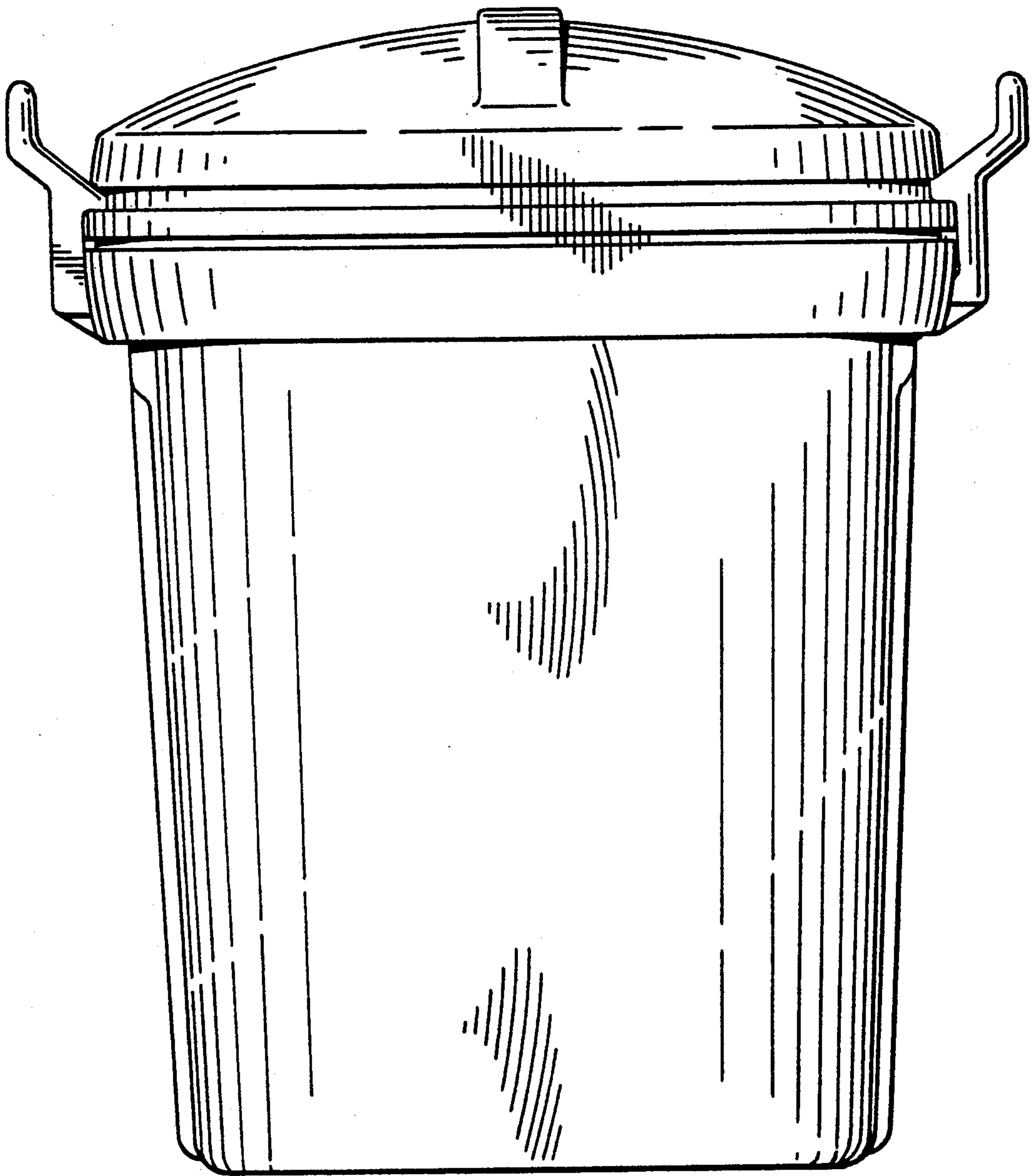
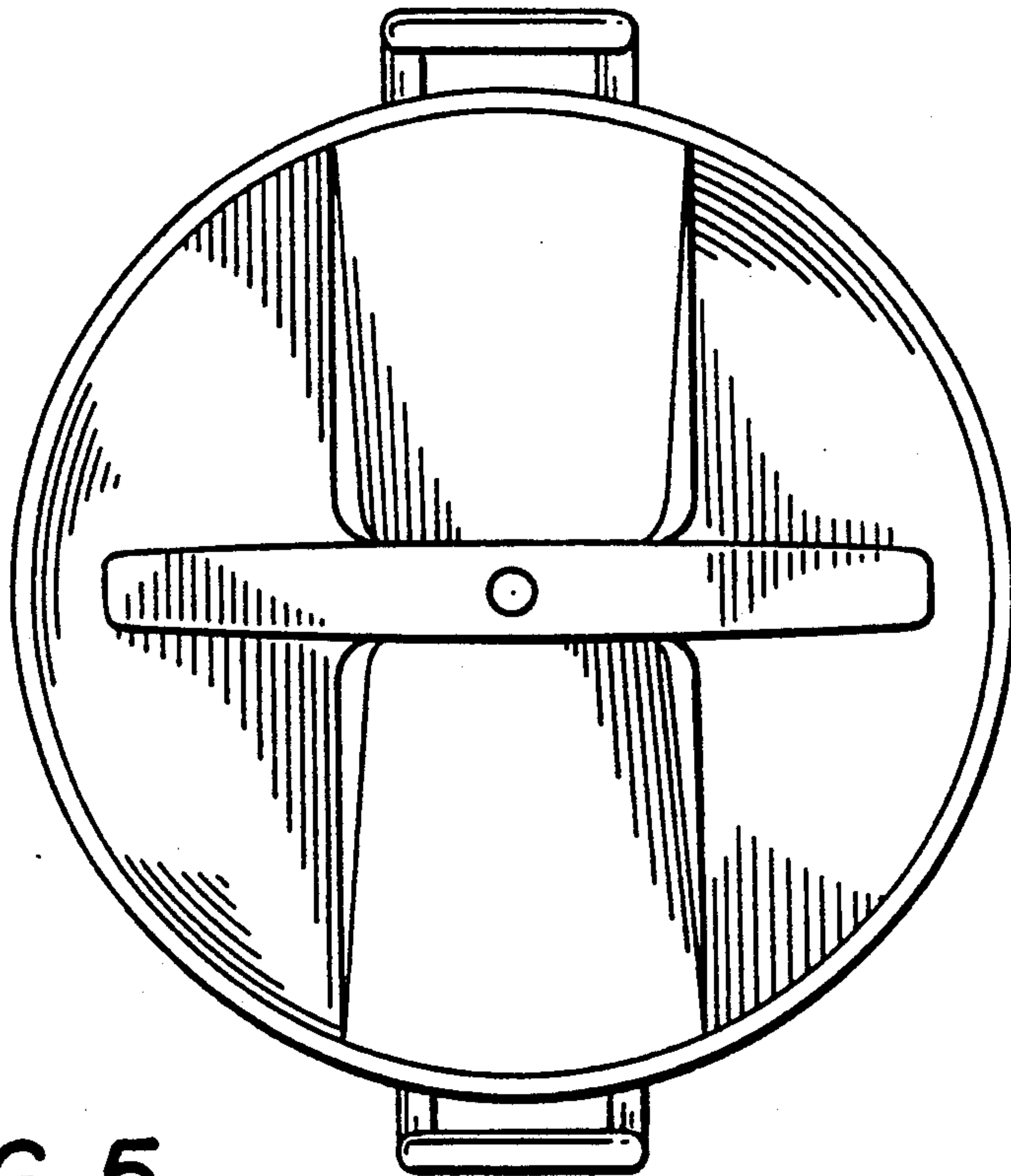
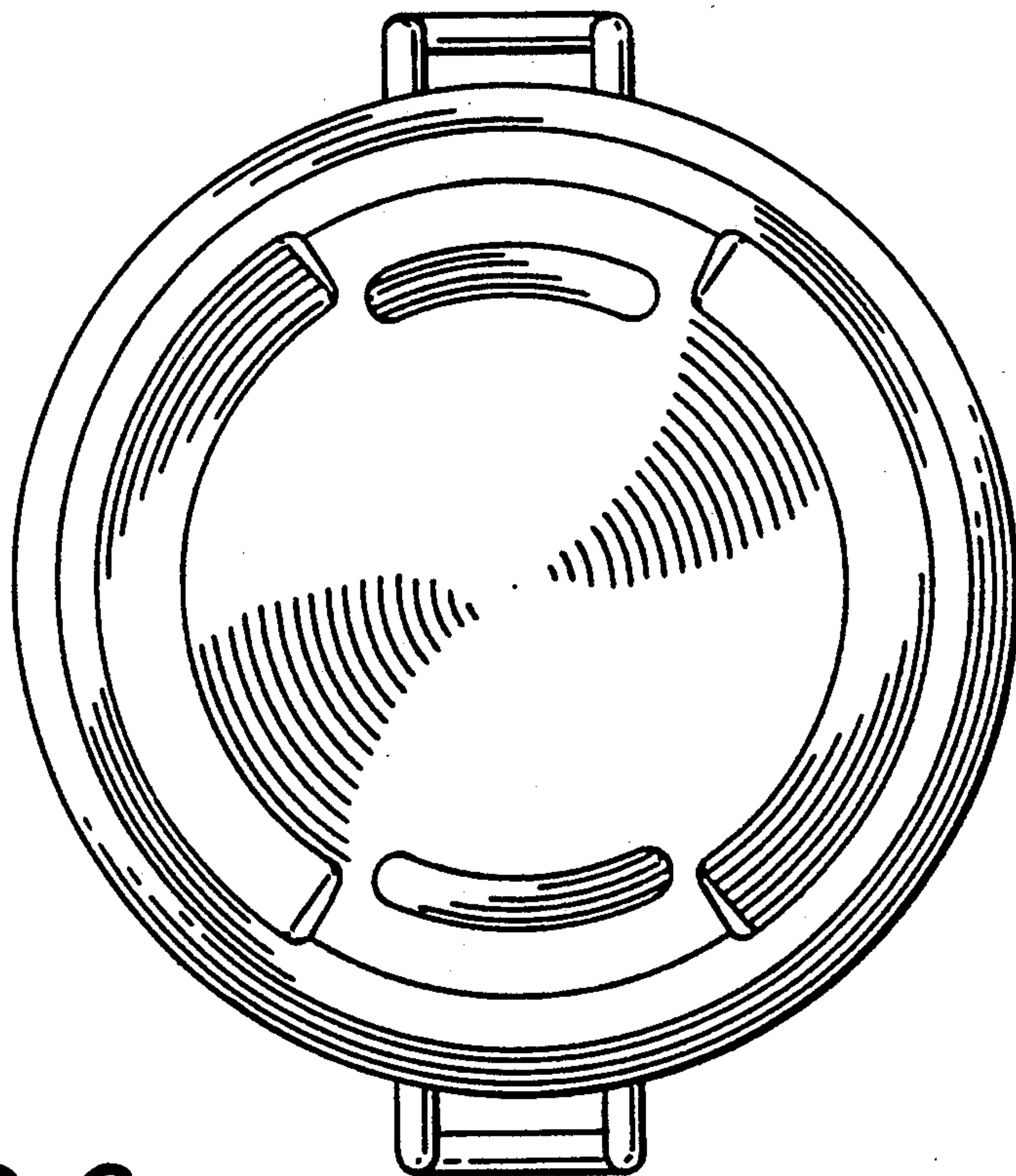


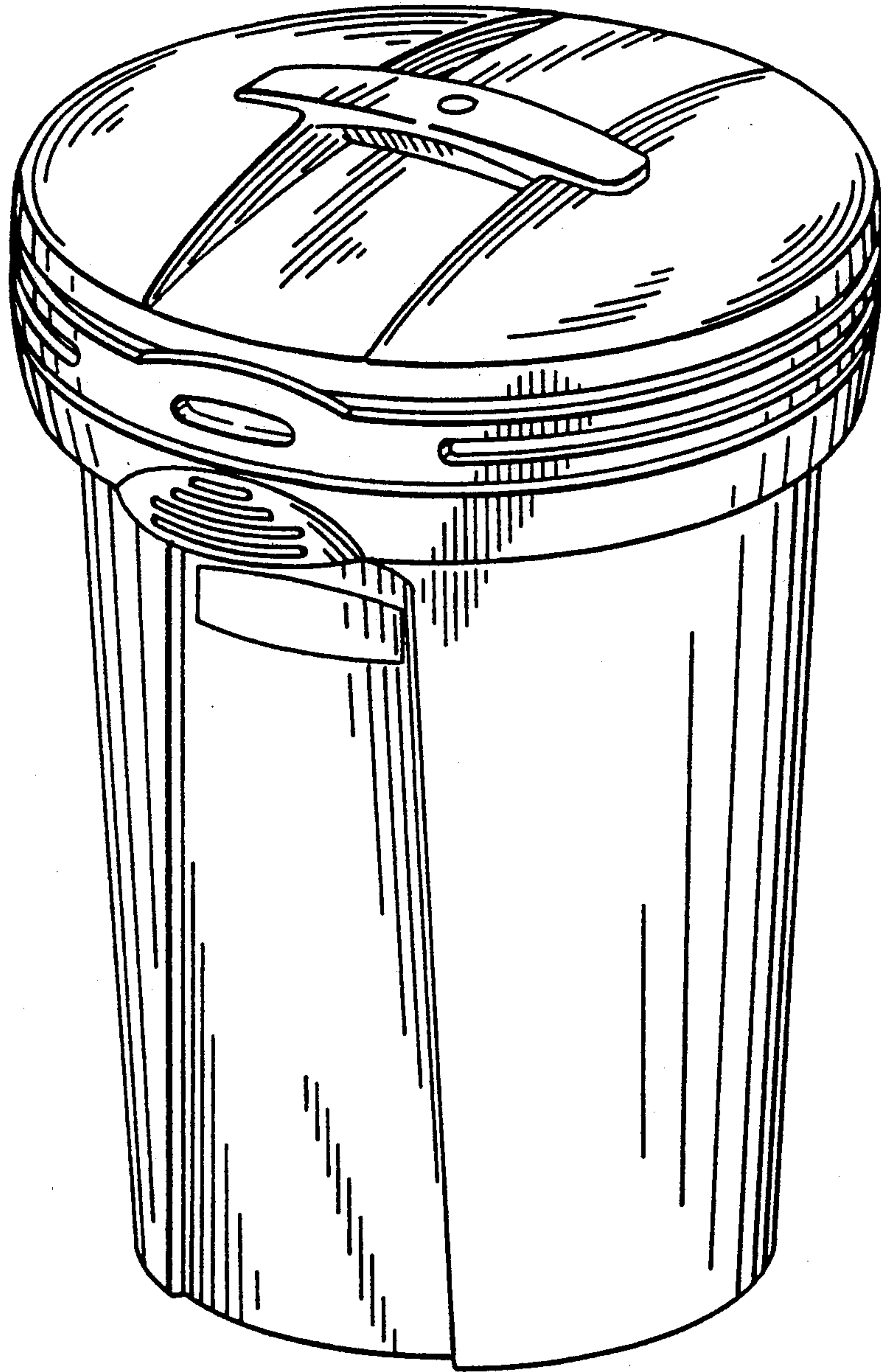

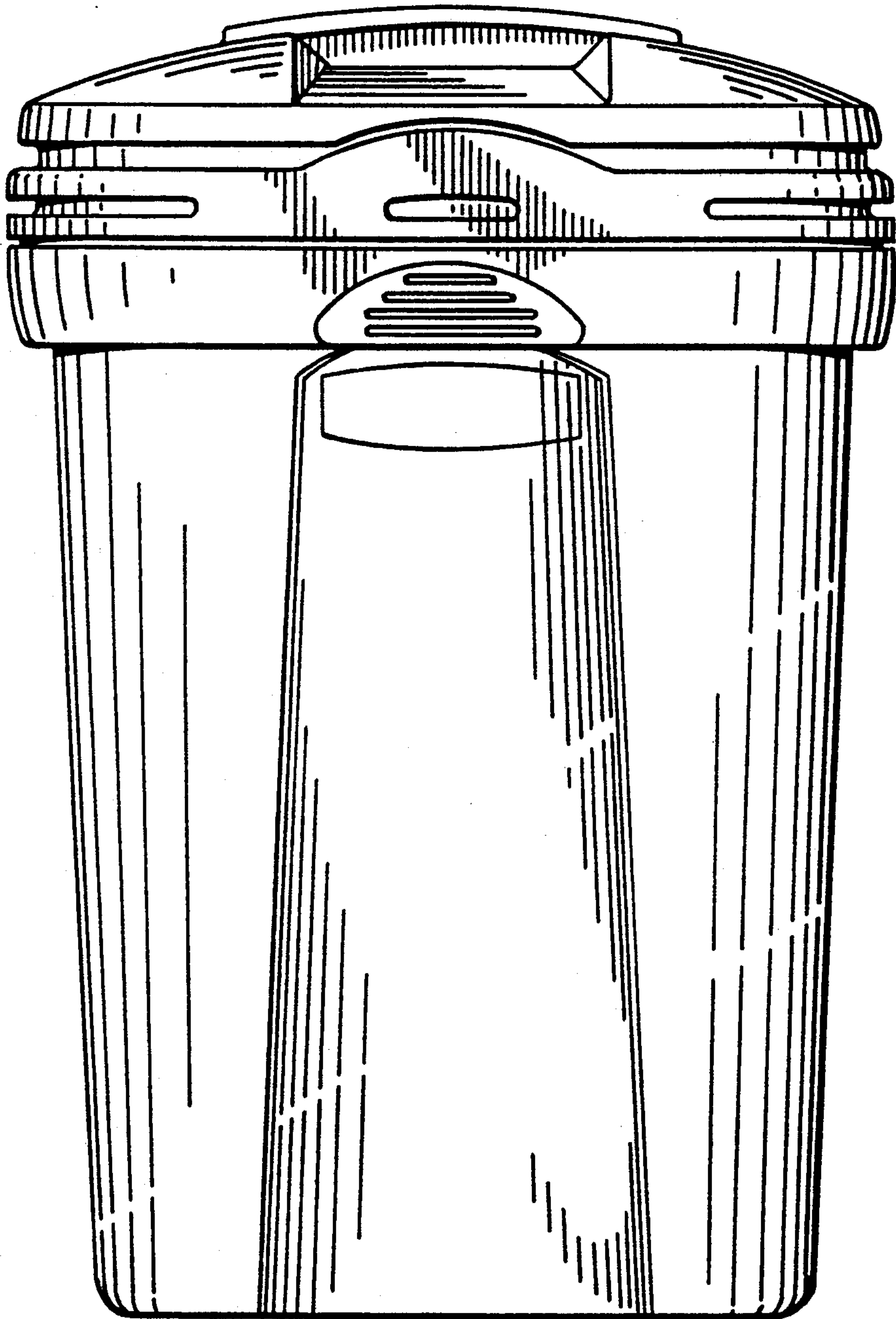

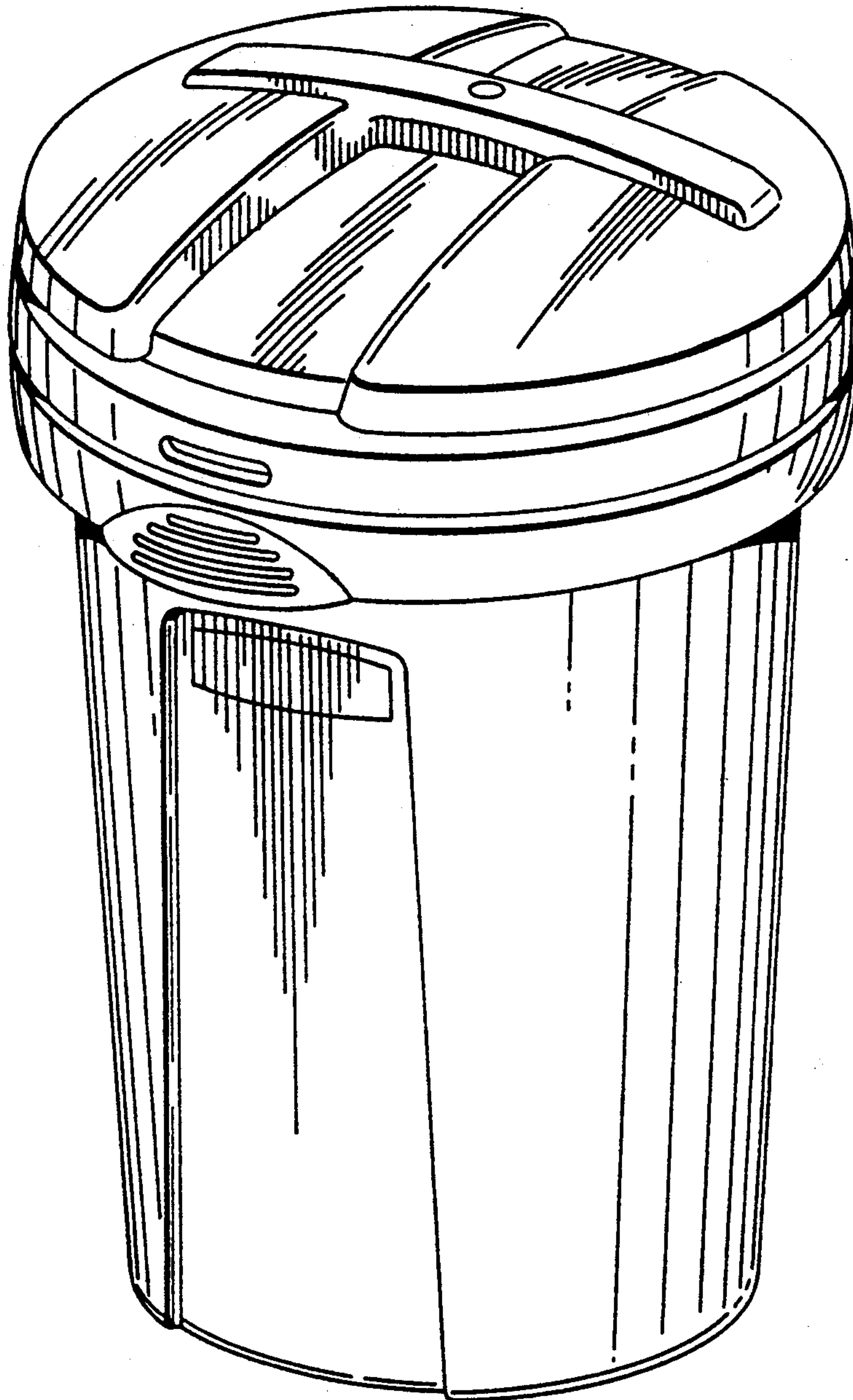

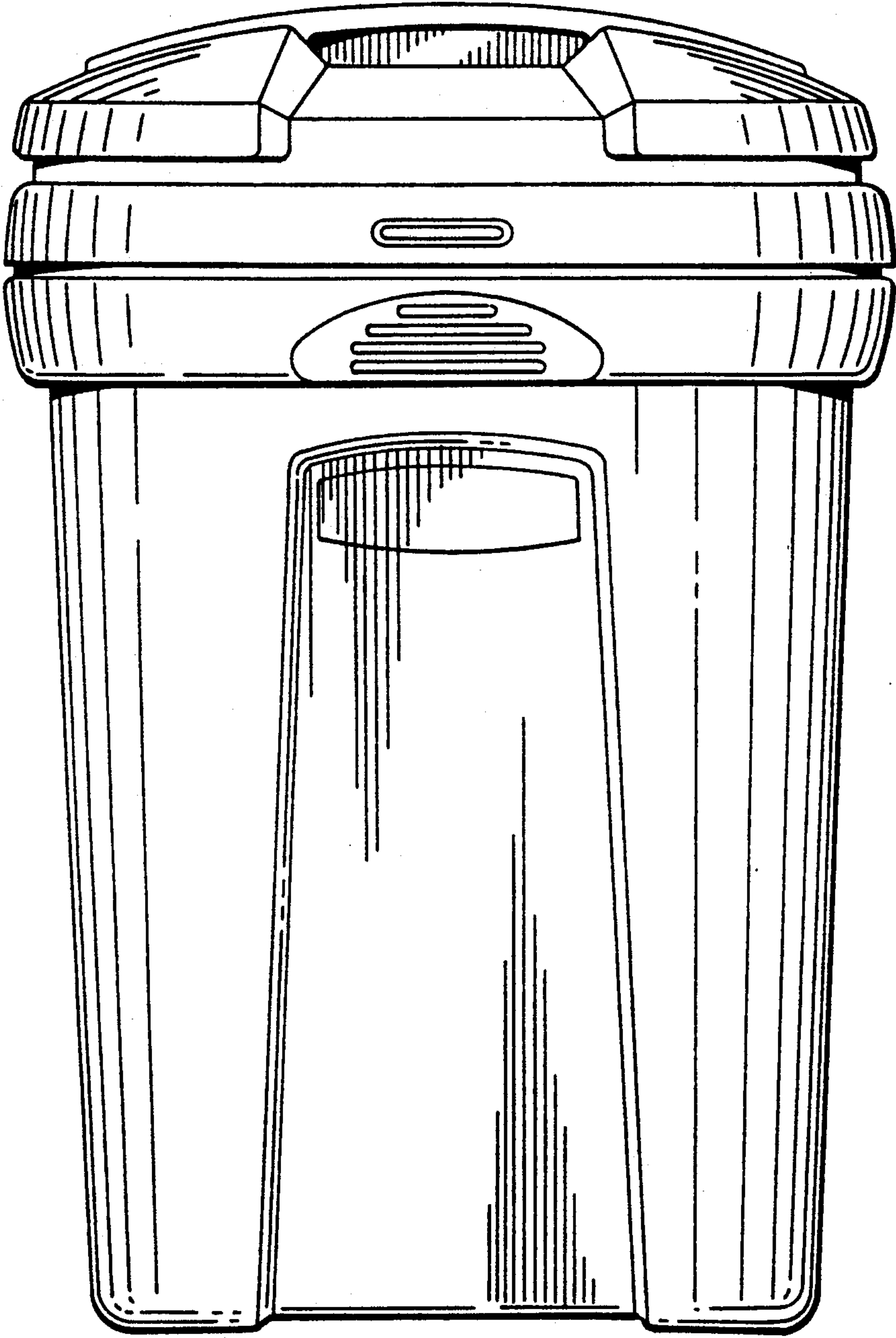
