The ornamental design for holder for wet cleaning accessories, as shown and described.

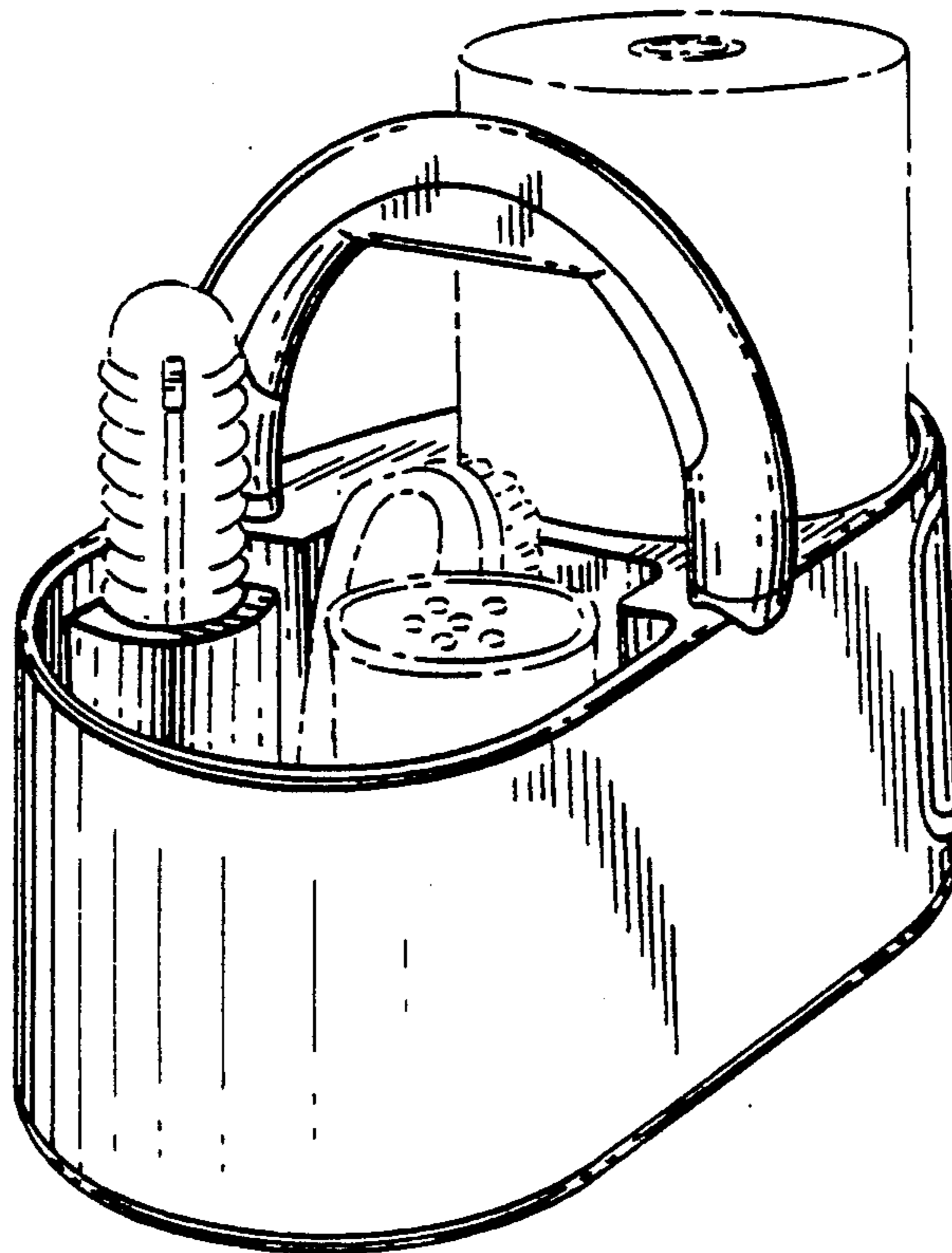
### DESCRIPTION

FIG. 1 is a perspective view of a holder for wet cleaning accessories showing our new design; FIG. 2 is a rear elevation thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a left side elevation thereof; the right side elevation being a mirror image thereof; FIG. 5 is a front elevation thereof; and, FIG. 6 is a bottom plan view thereof. 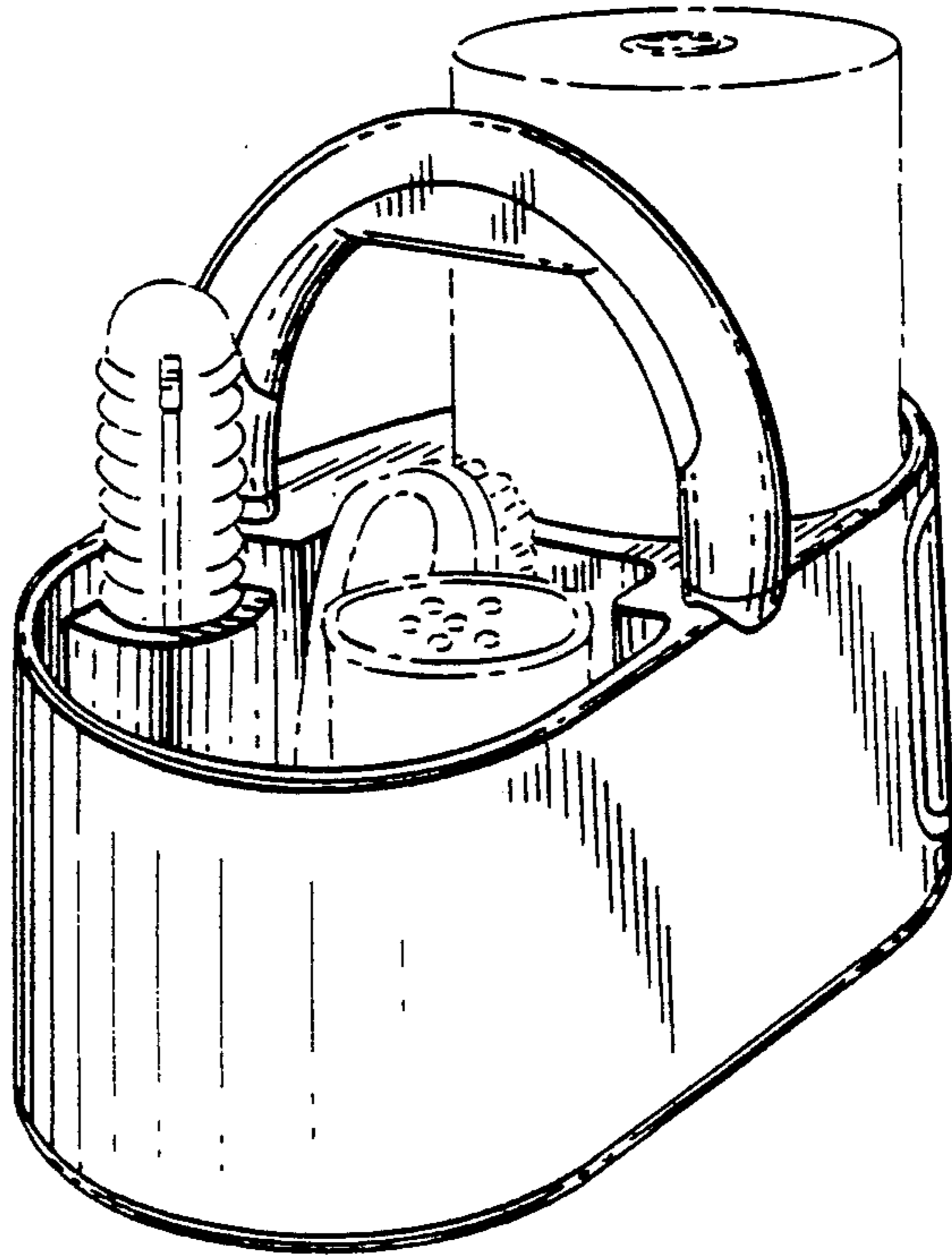

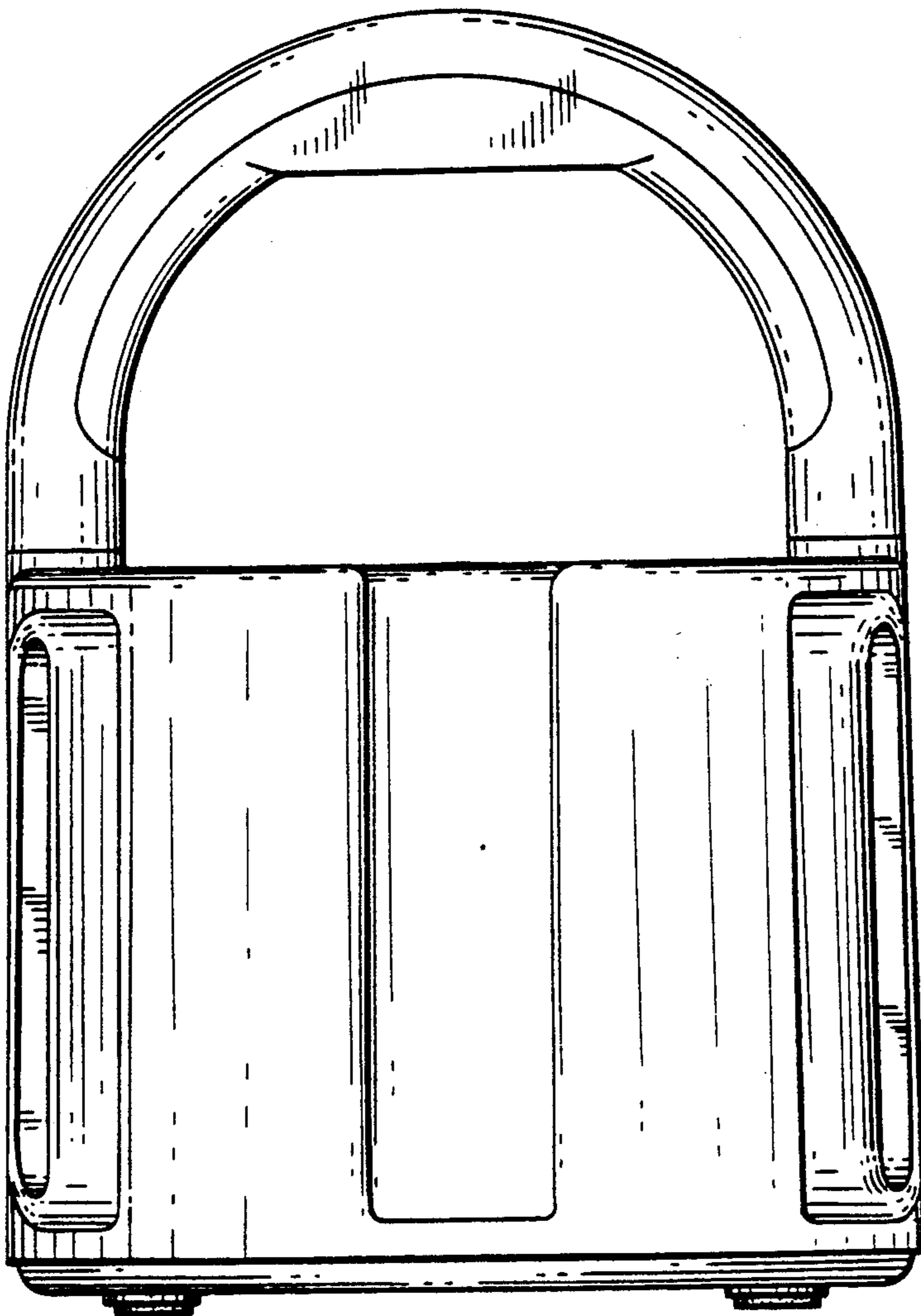

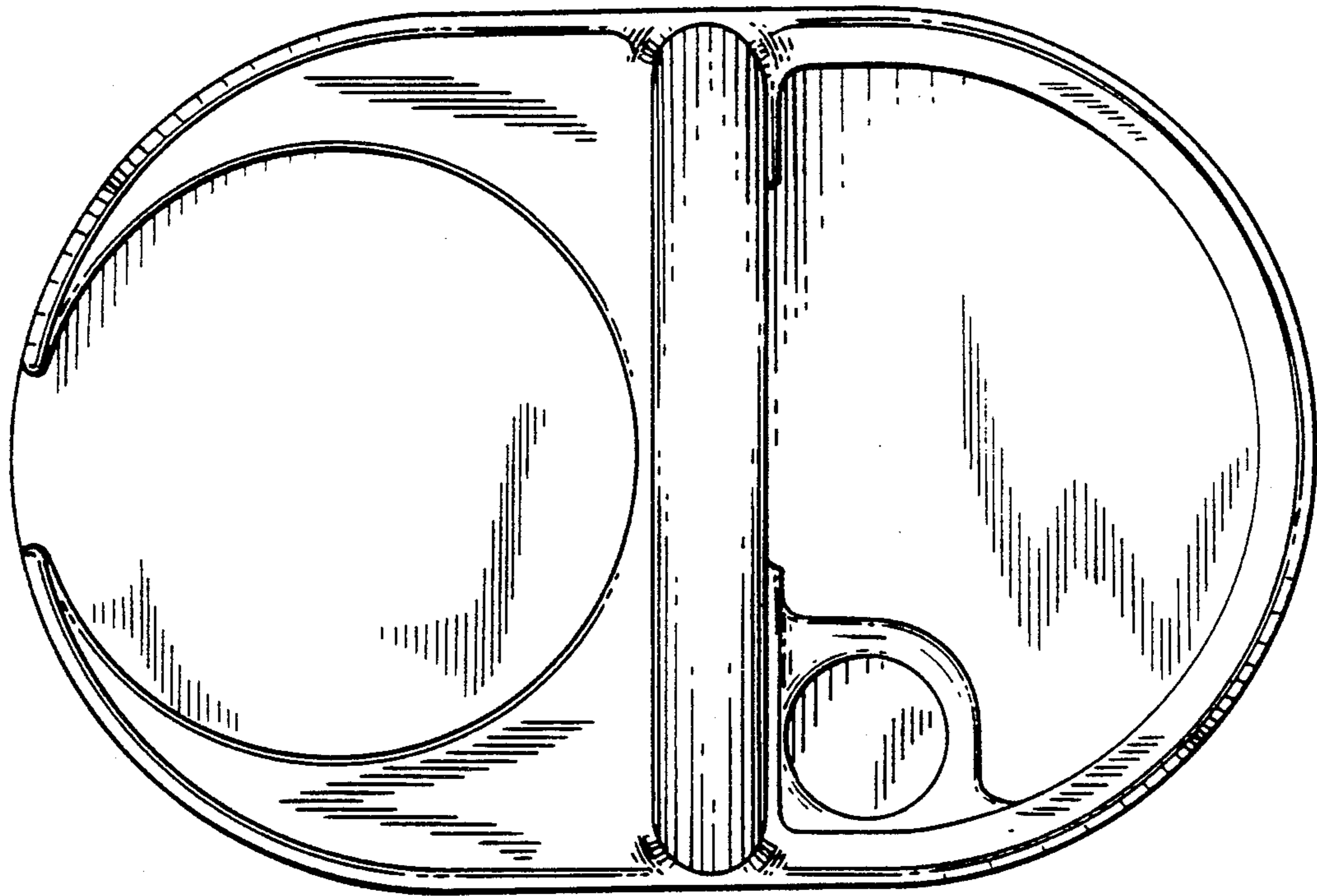

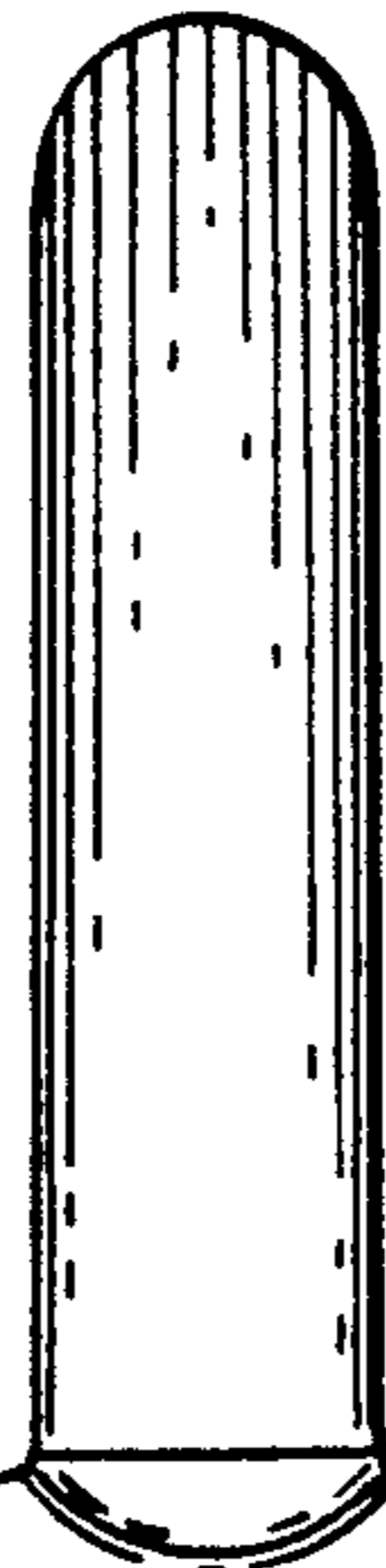

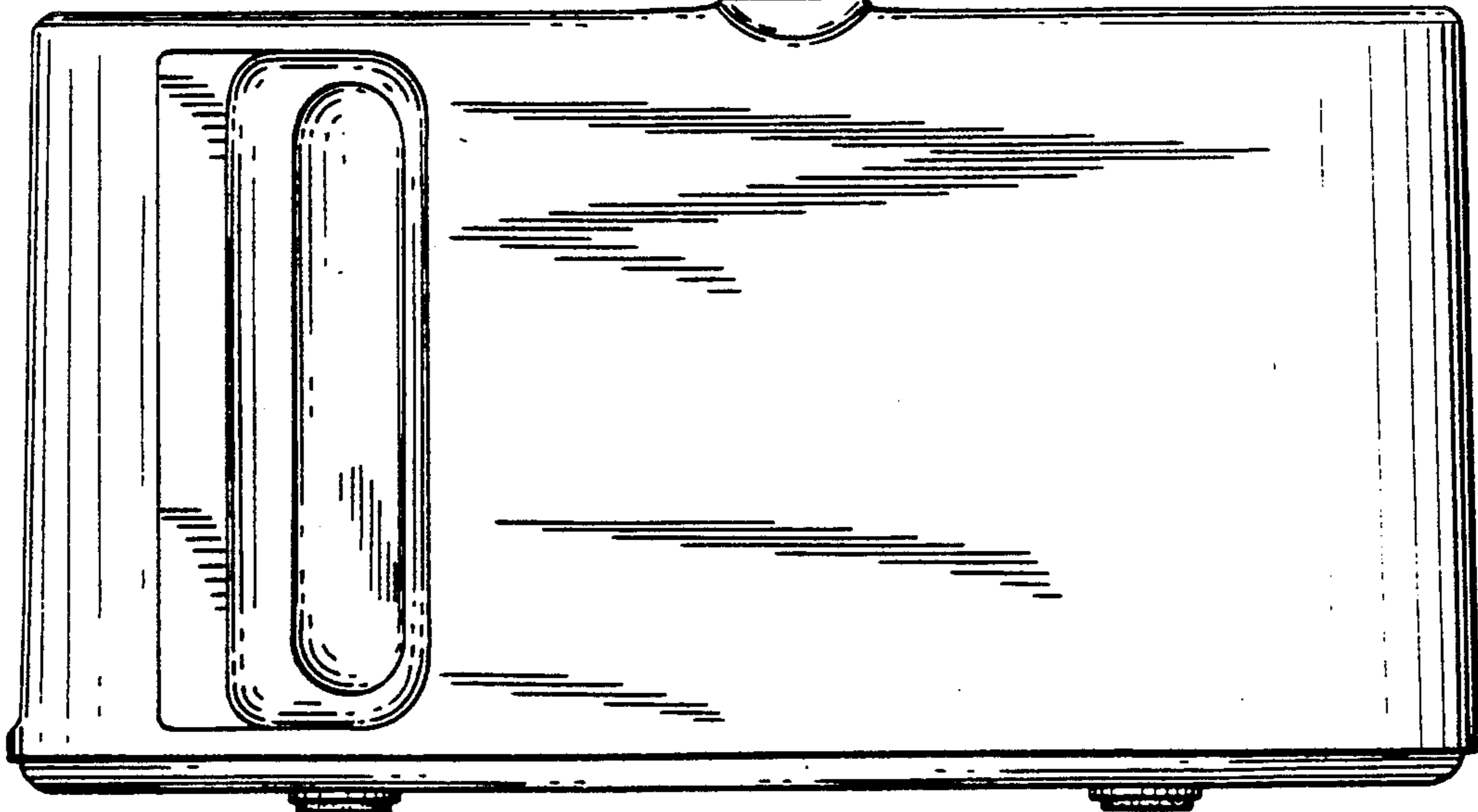




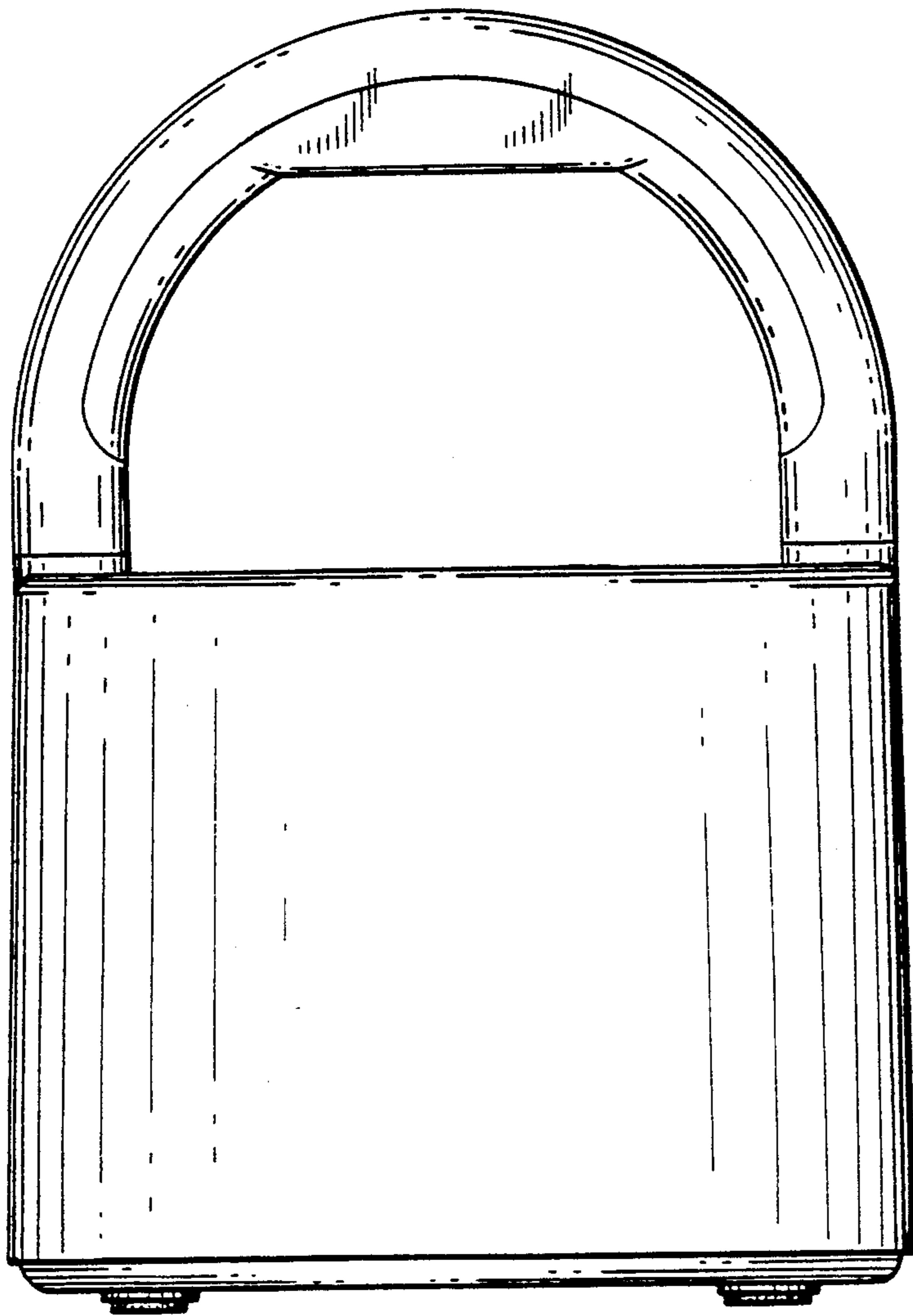

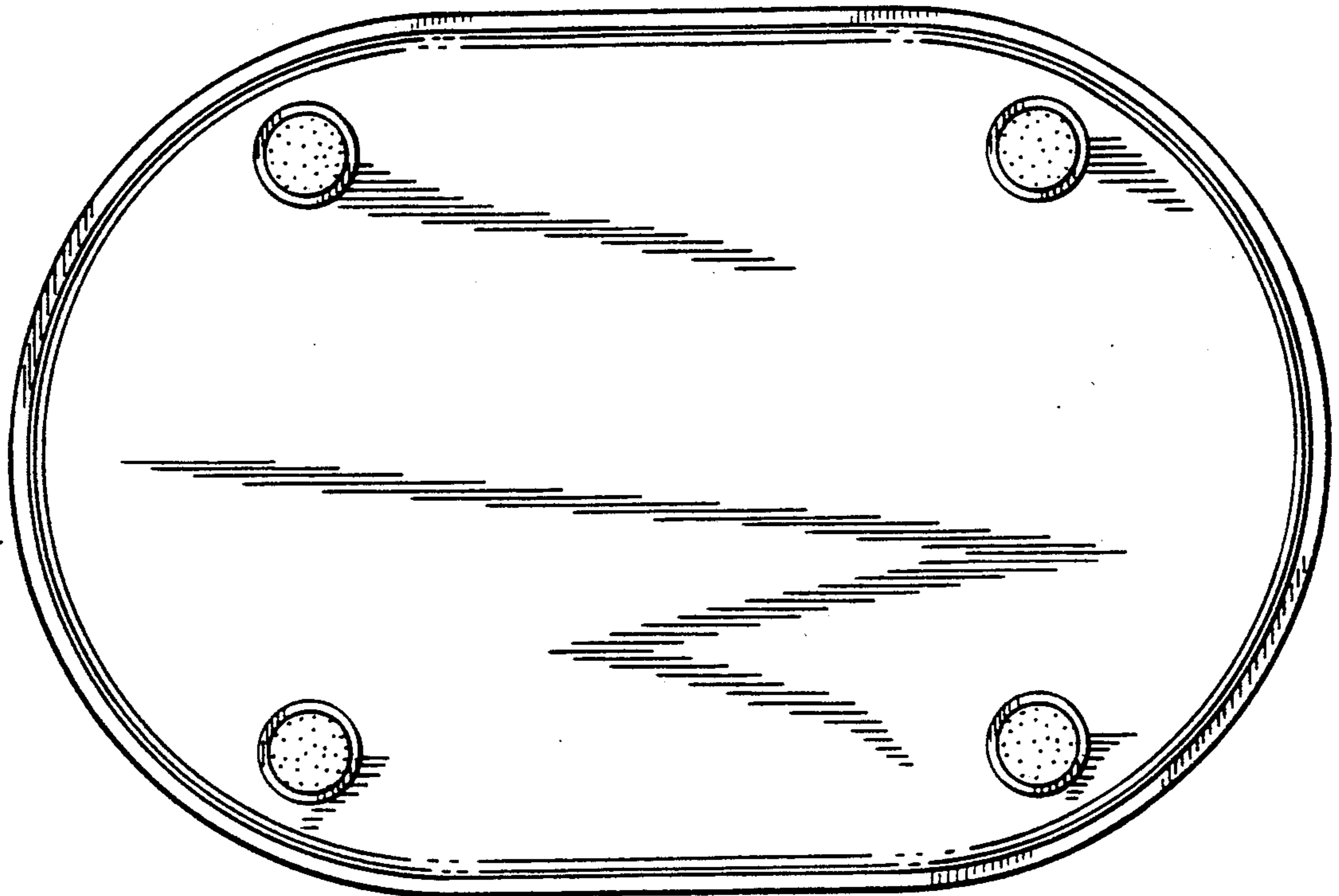
