


[57] **CLAIM**

The ornamental design for a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevational view of a shoe upper showing my new design;
 FIG. 2 is a left side elevational view thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a rear elevational view thereof; and,
 FIG. 5 is a top plan view thereof.
 The broken line showing the remaining portion of the shoe bottom in FIGS. 1-4 forms no part of the claimed design.










