[57] CLAIM

The ornamental design for an automotive telephone control unit, as shown and described.

DESCRIPTION

FIGS. 1 and 2 are respectively front and rear elevational views of an automotive telephone control unit showing my new design;

FIGS. 3 and 4 are respectively top and bottom plan views thereof;

FIGS. 5 and 6 are respectively left and right side elevational views thereof;

FIG. 7 is a front and right side perspective view showing the control unit in electrified status;

FIGS. 8 and 9 are respectively sectional views taken on the lines VII—VIII and IV—IV in FIG. 3; and,

FIG. 10 is a bracket associated view thereof, with the top peripheral frame spaced apart from the main body to show how the assembled control unit fits upon the vehicle sun visor.

The broken line showing of numerals, words, letters, abbreviated words, and symbols in FIG. 7 is for illustrative purposes only and forms no part of the claimed design.

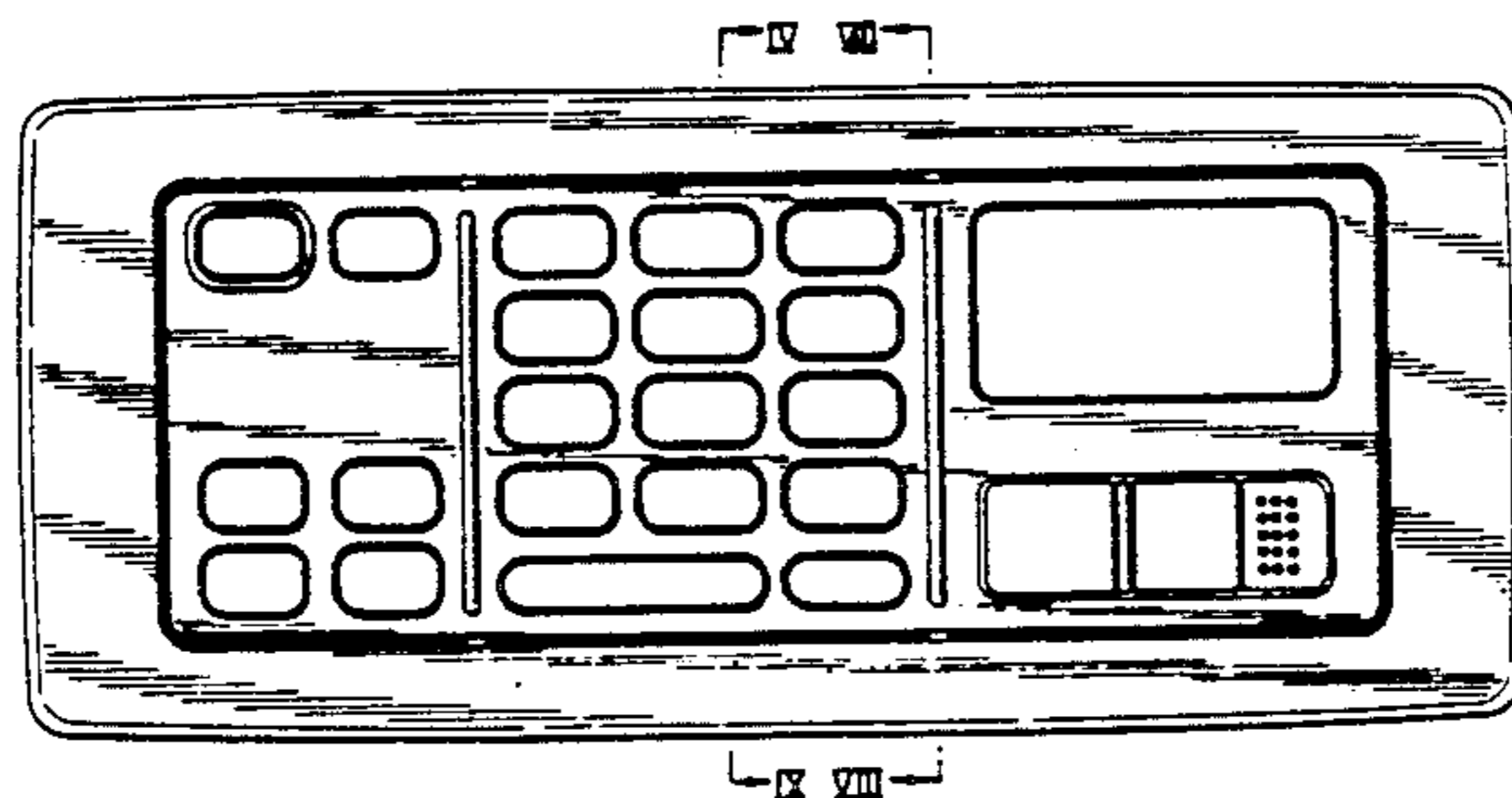
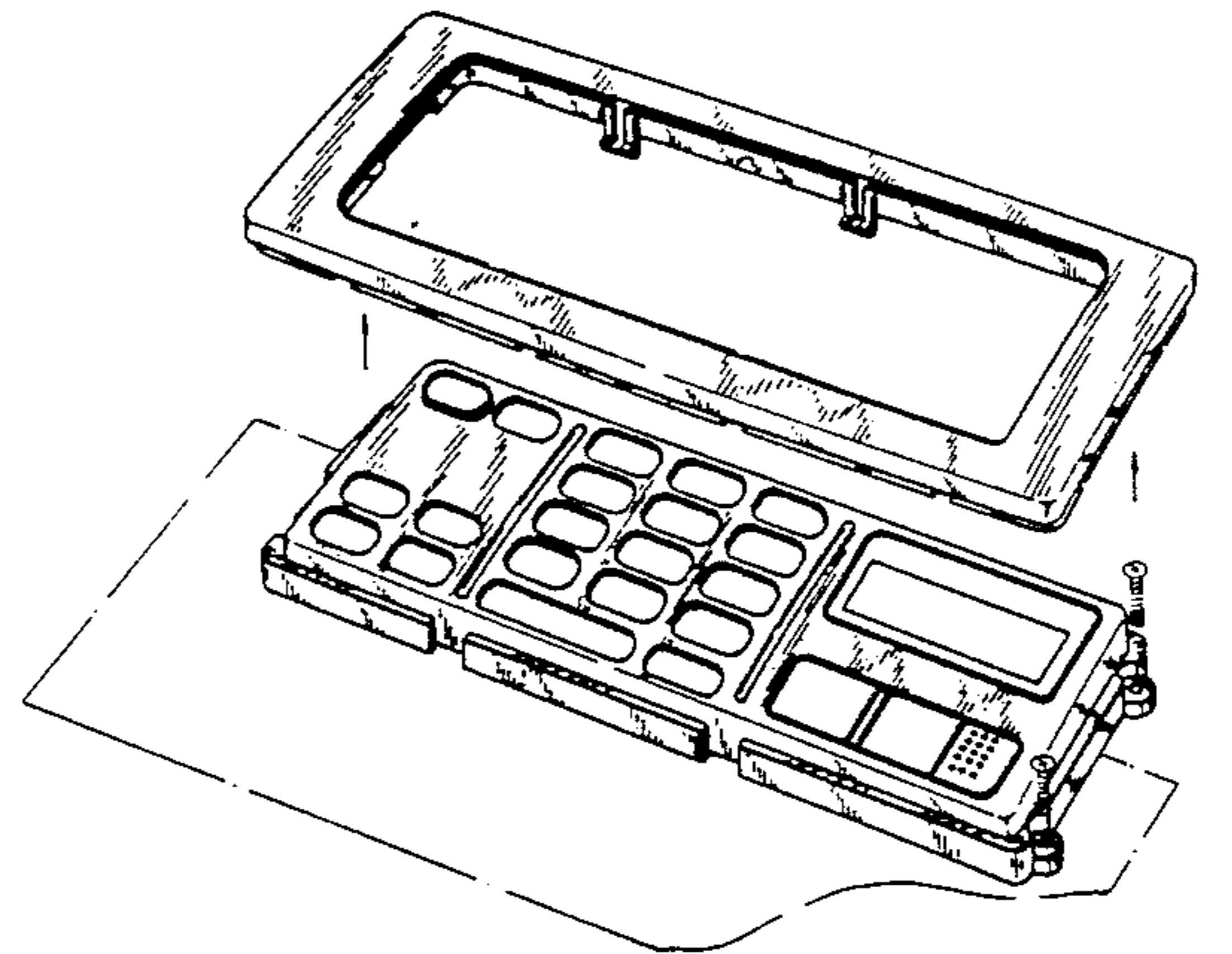

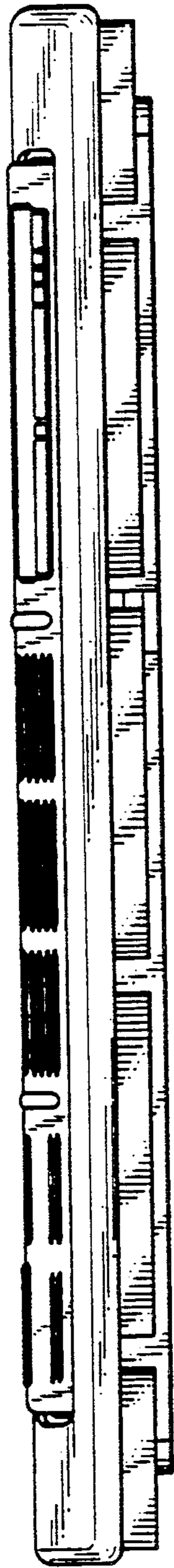

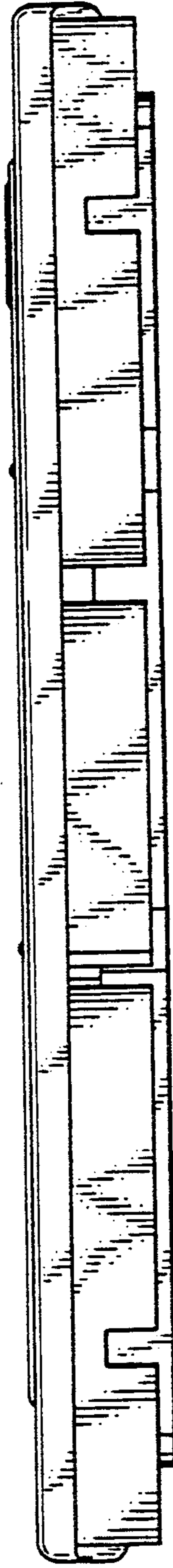

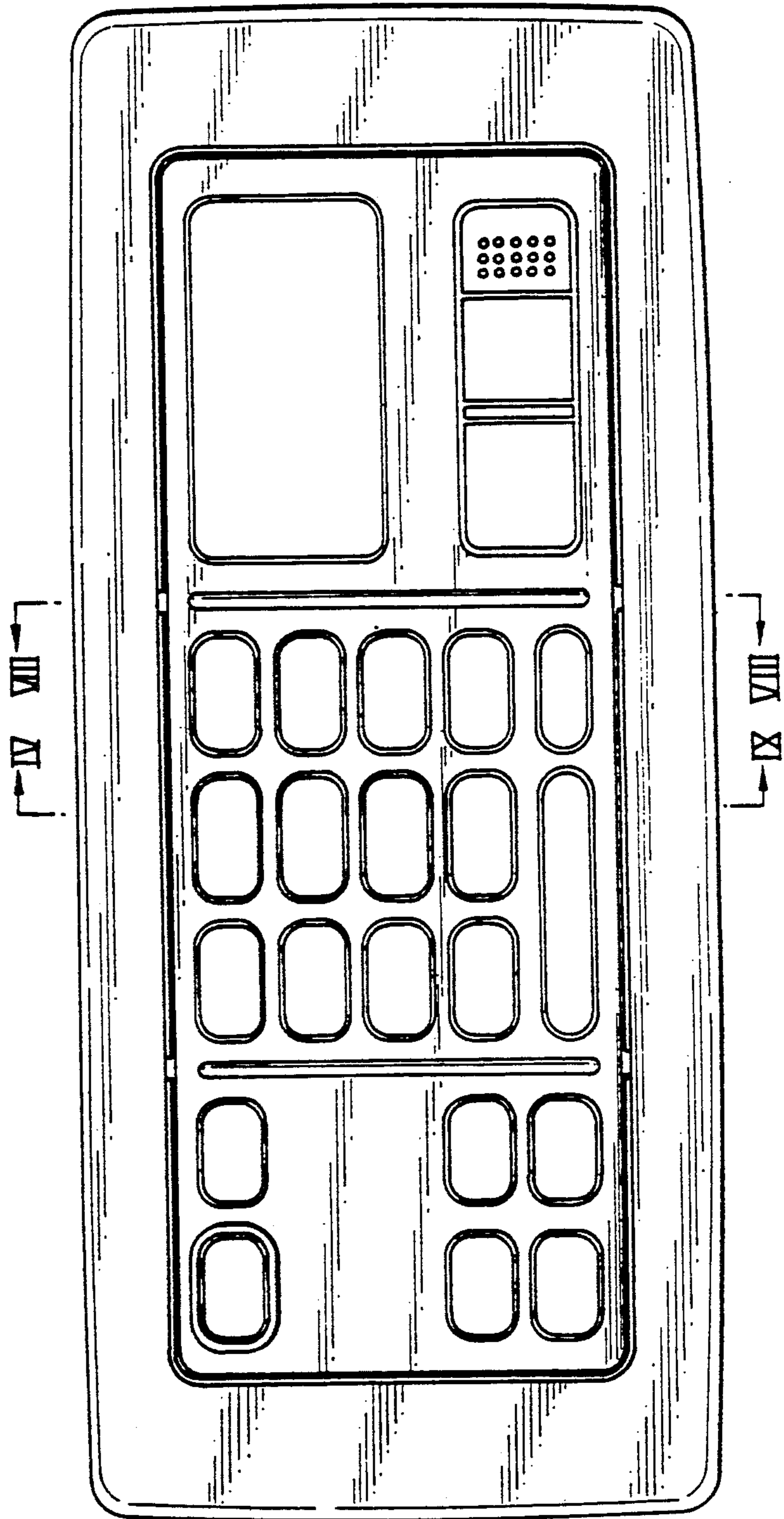

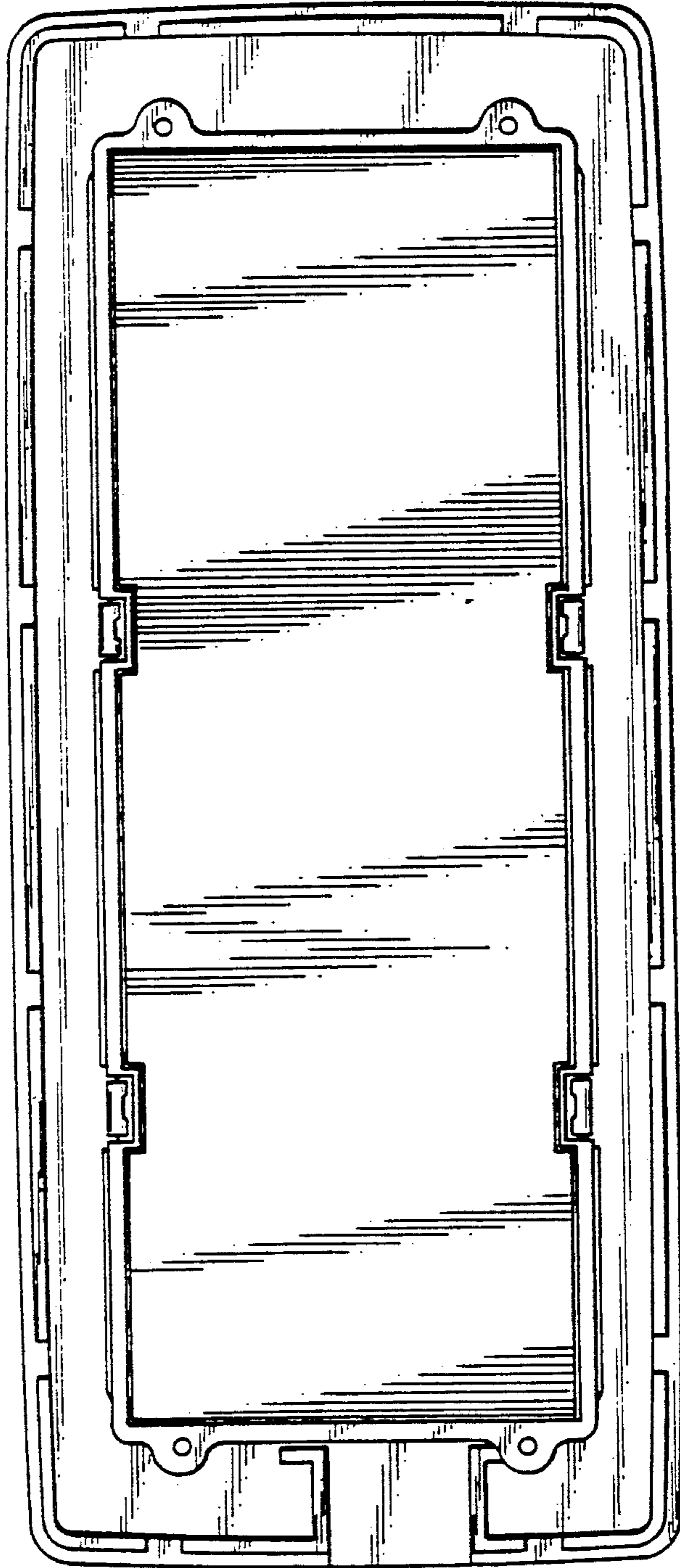

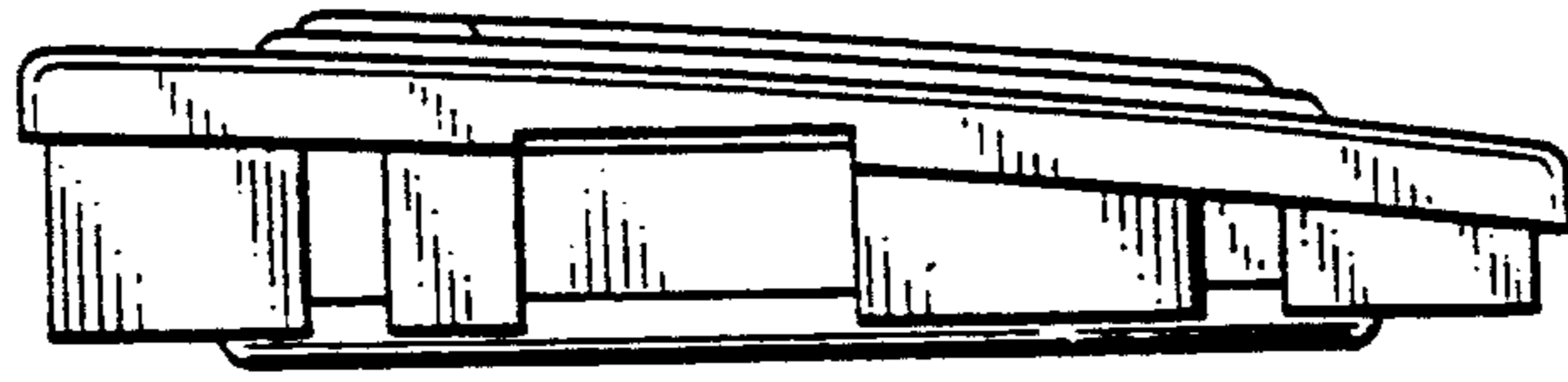

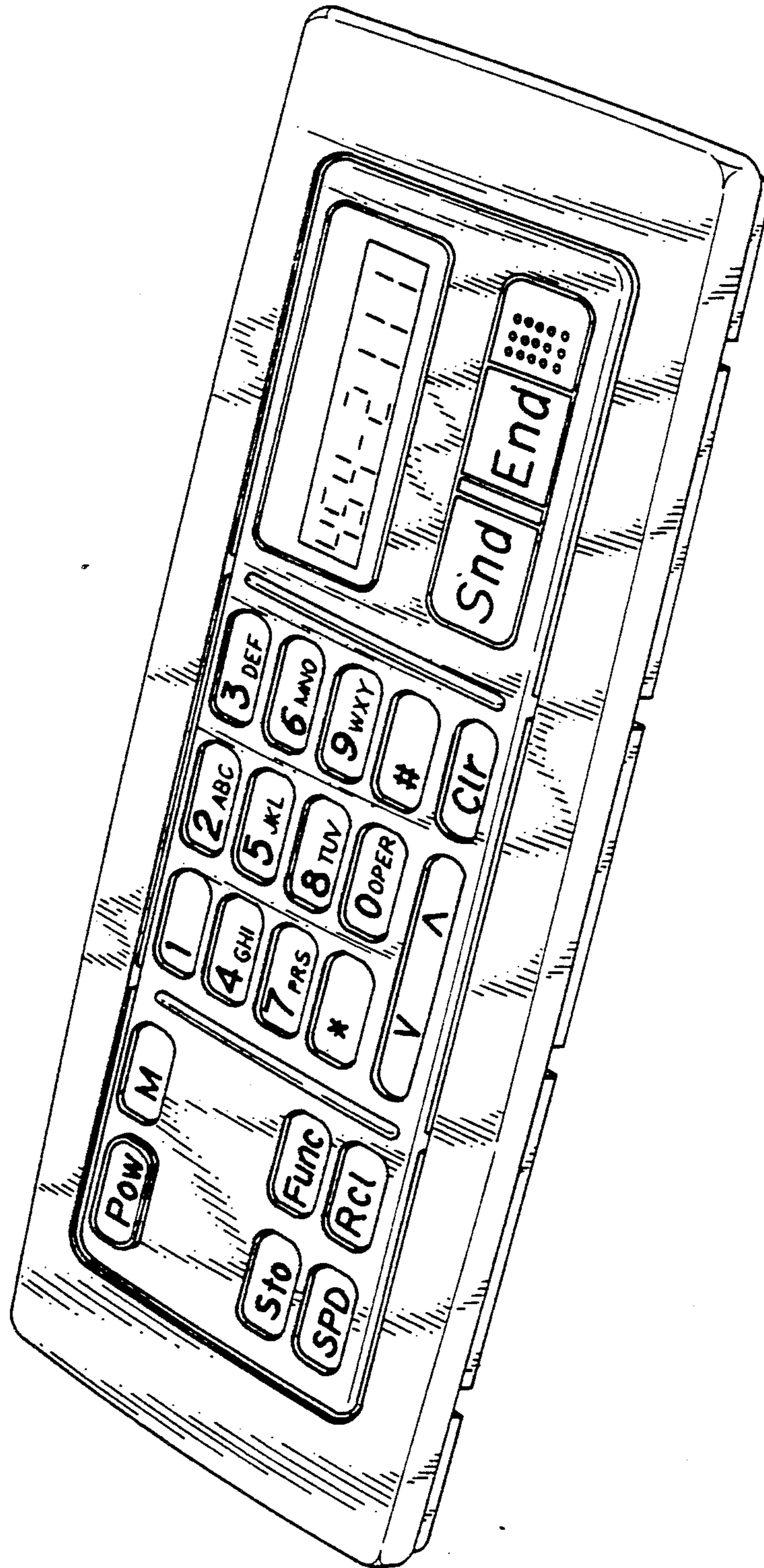

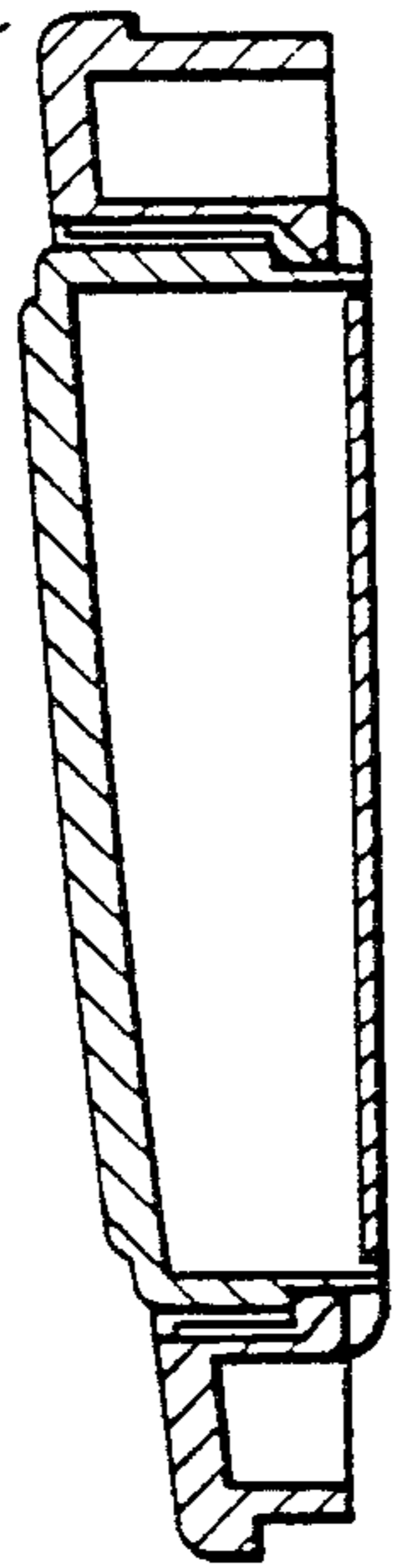
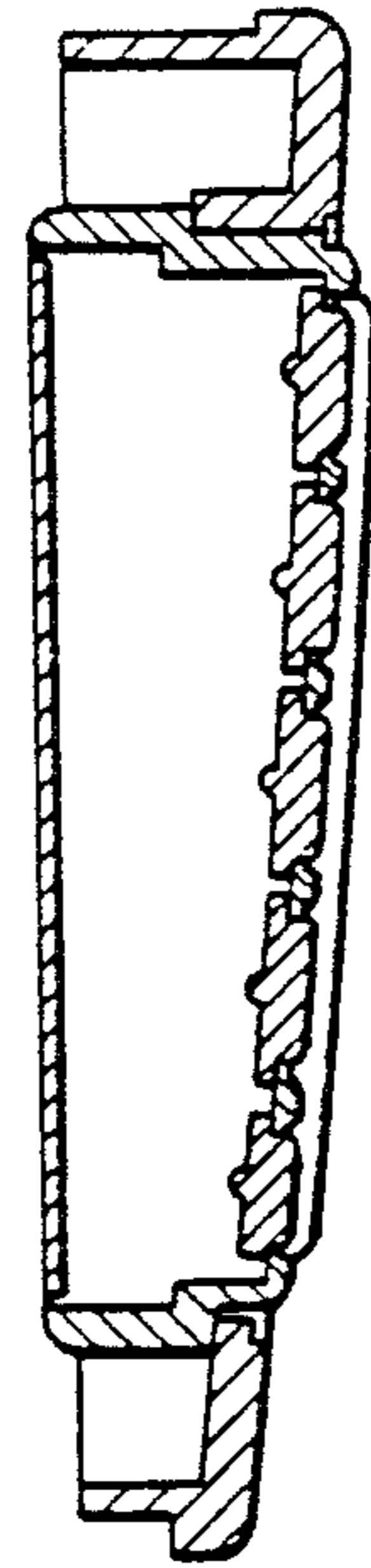

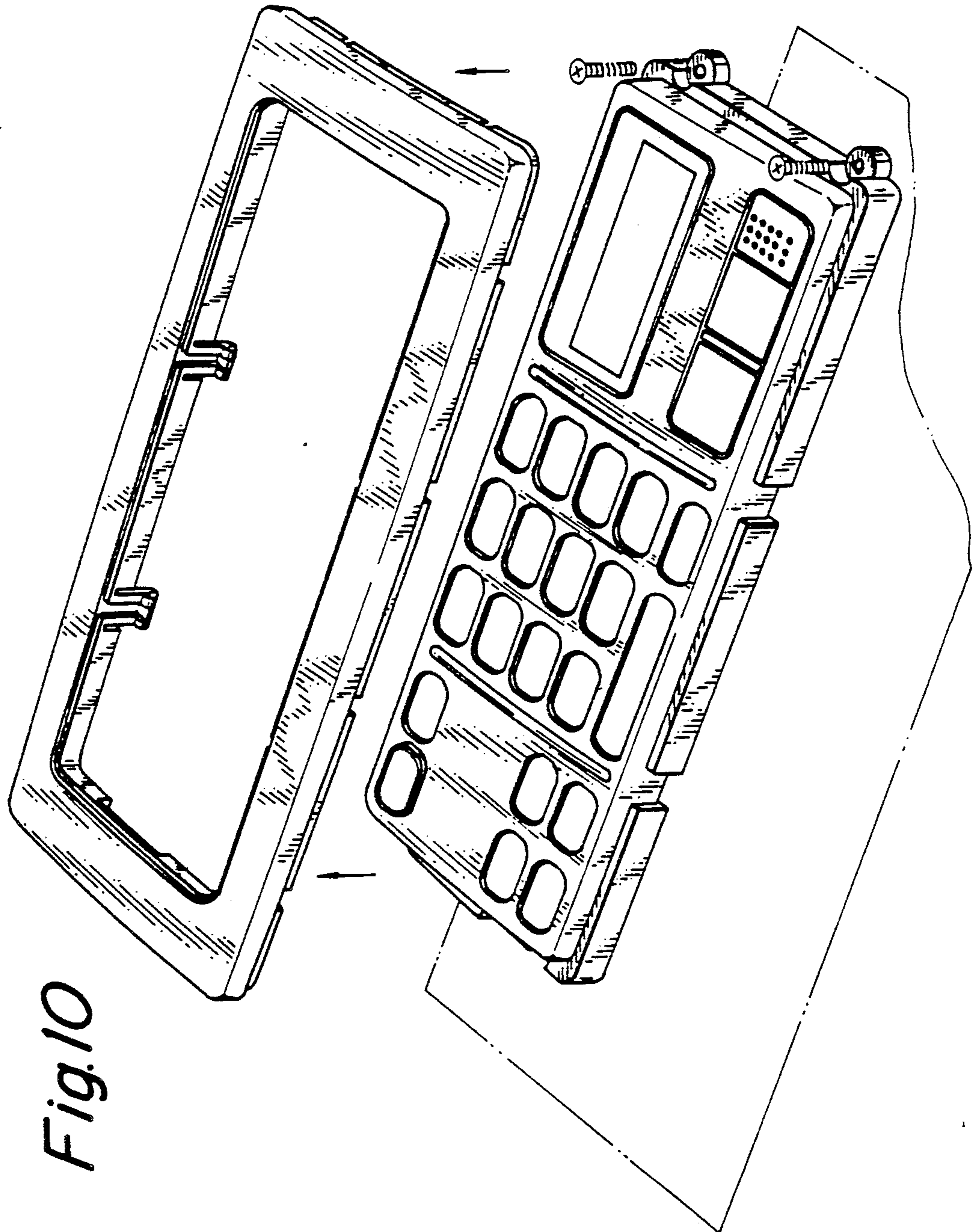
