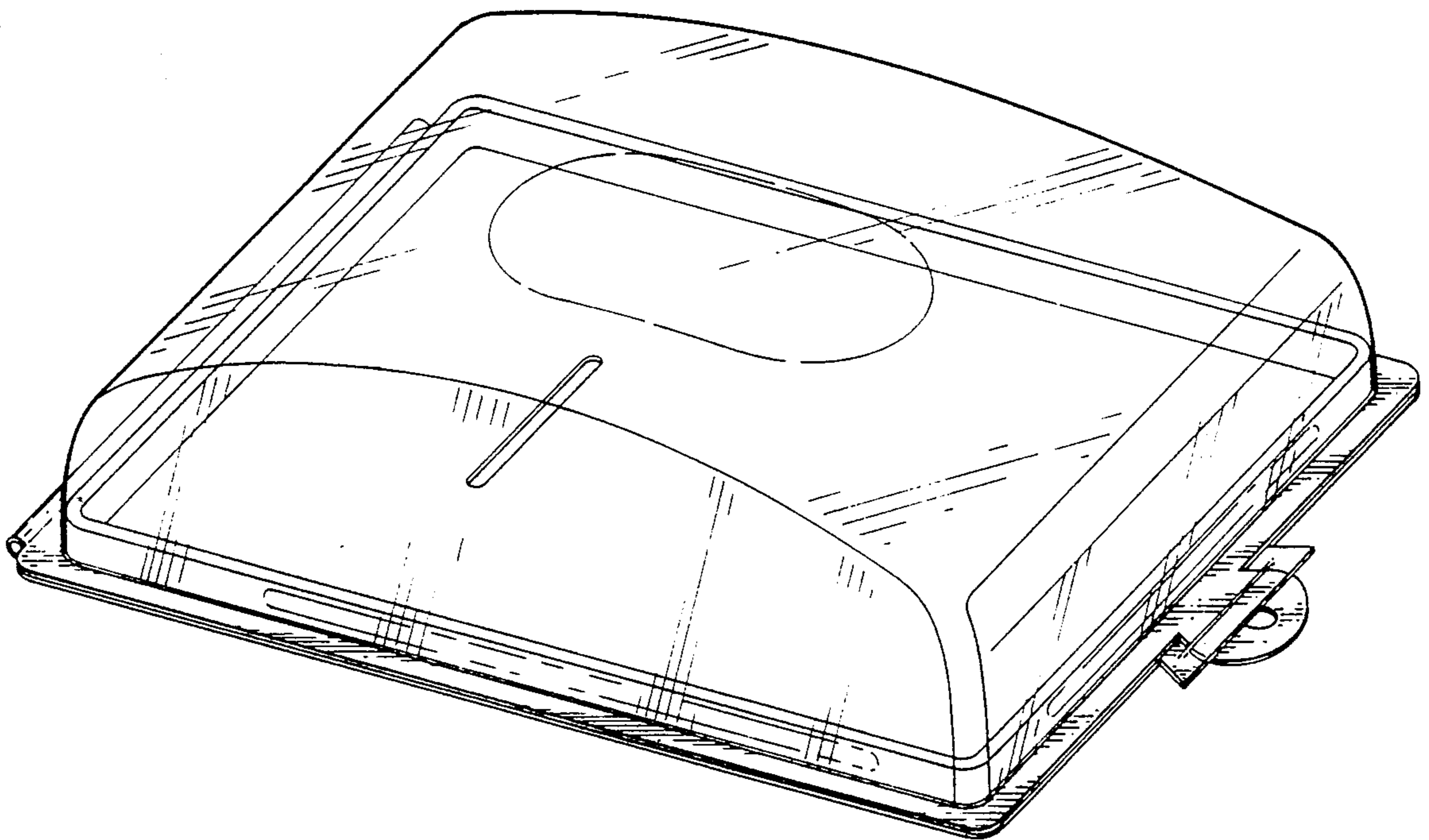

[57] CLAIM

The ornamental design for a rubber band dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a rubber band dispenser showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a right side elevation thereof; the left side elevation being a mirror image thereof;
FIG. 5 is a bottom plan view thereof; and,
FIG. 6 is a top plan view thereof.
The oval-shaped dash lines represent a dispenser opening.



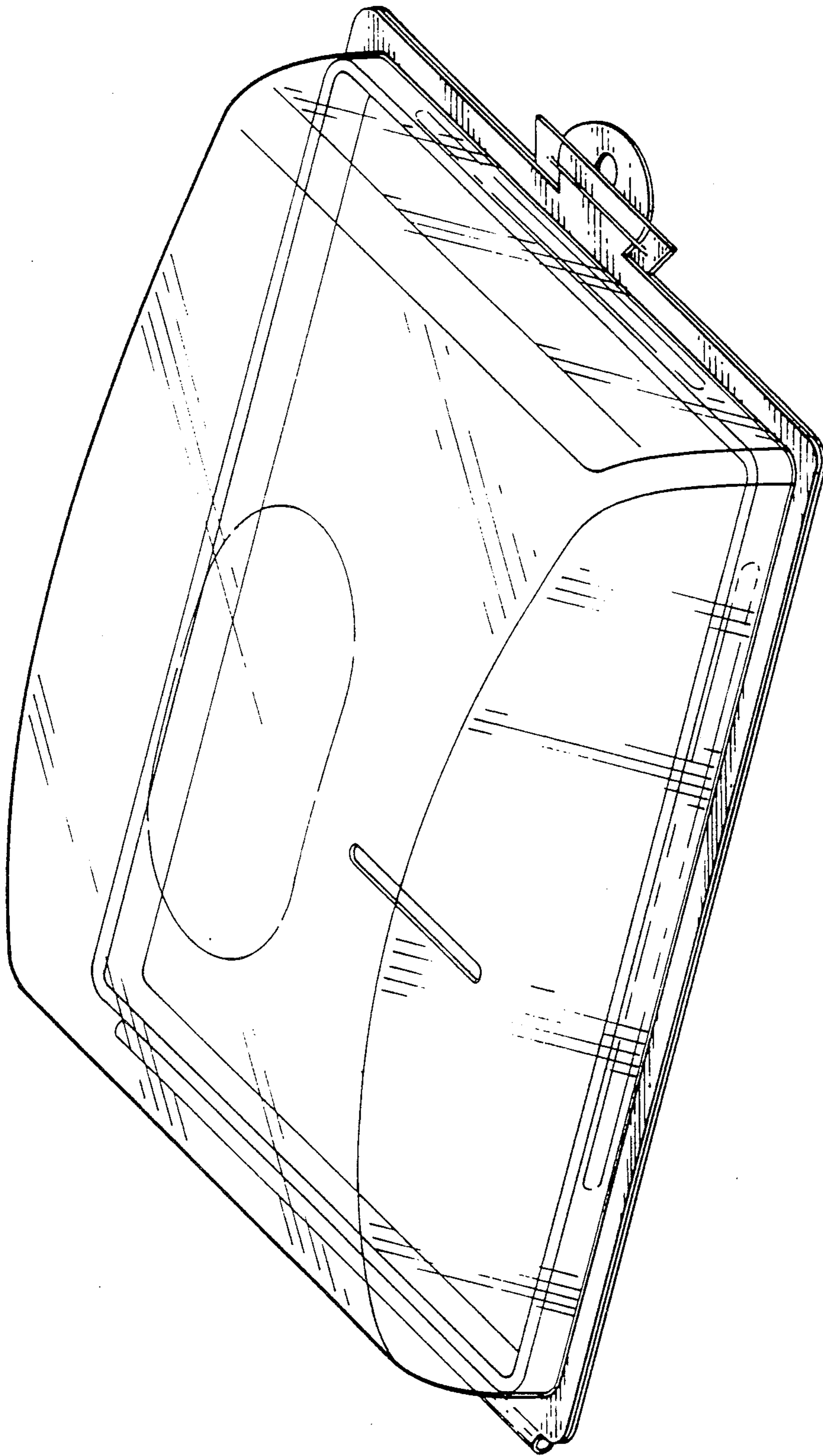

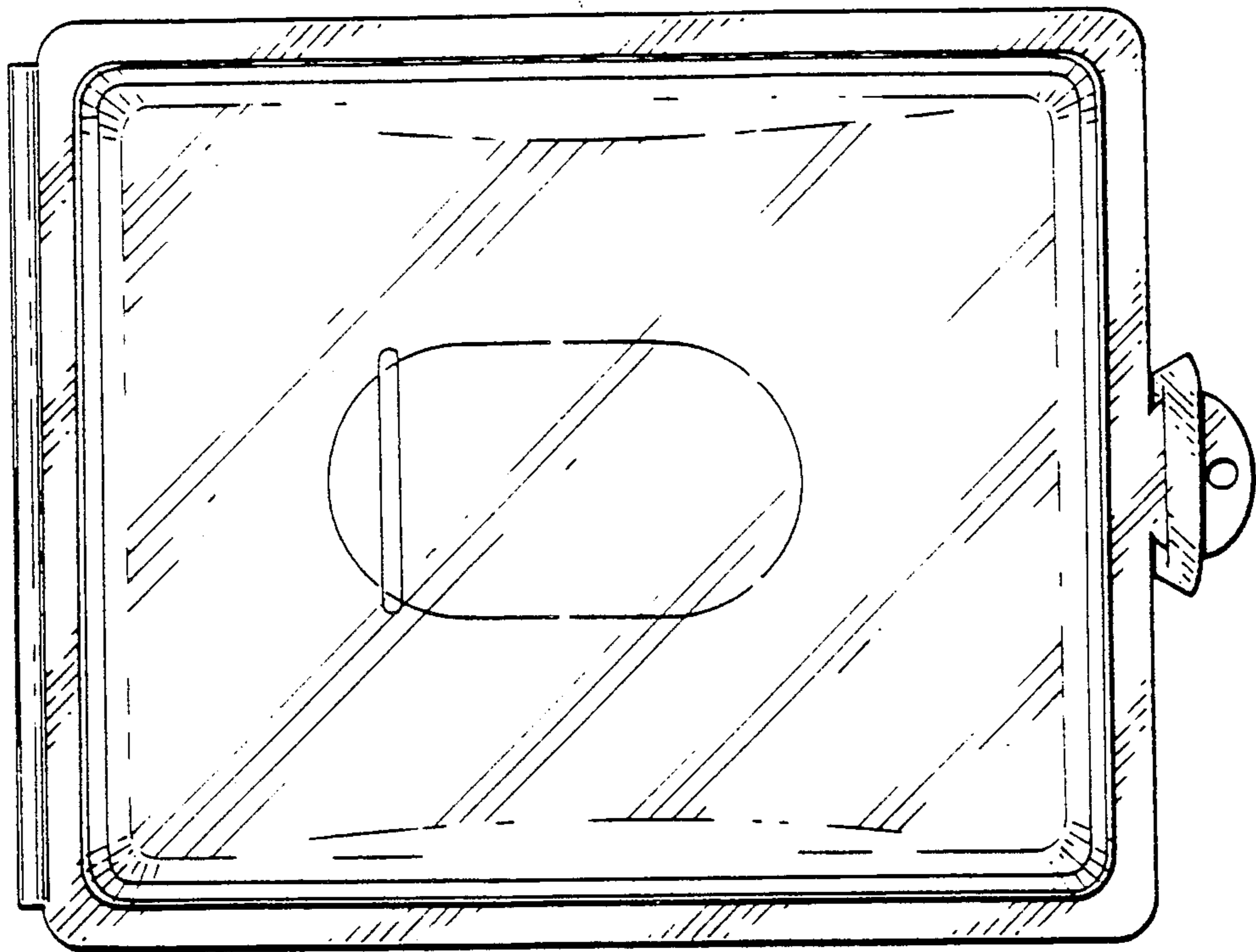

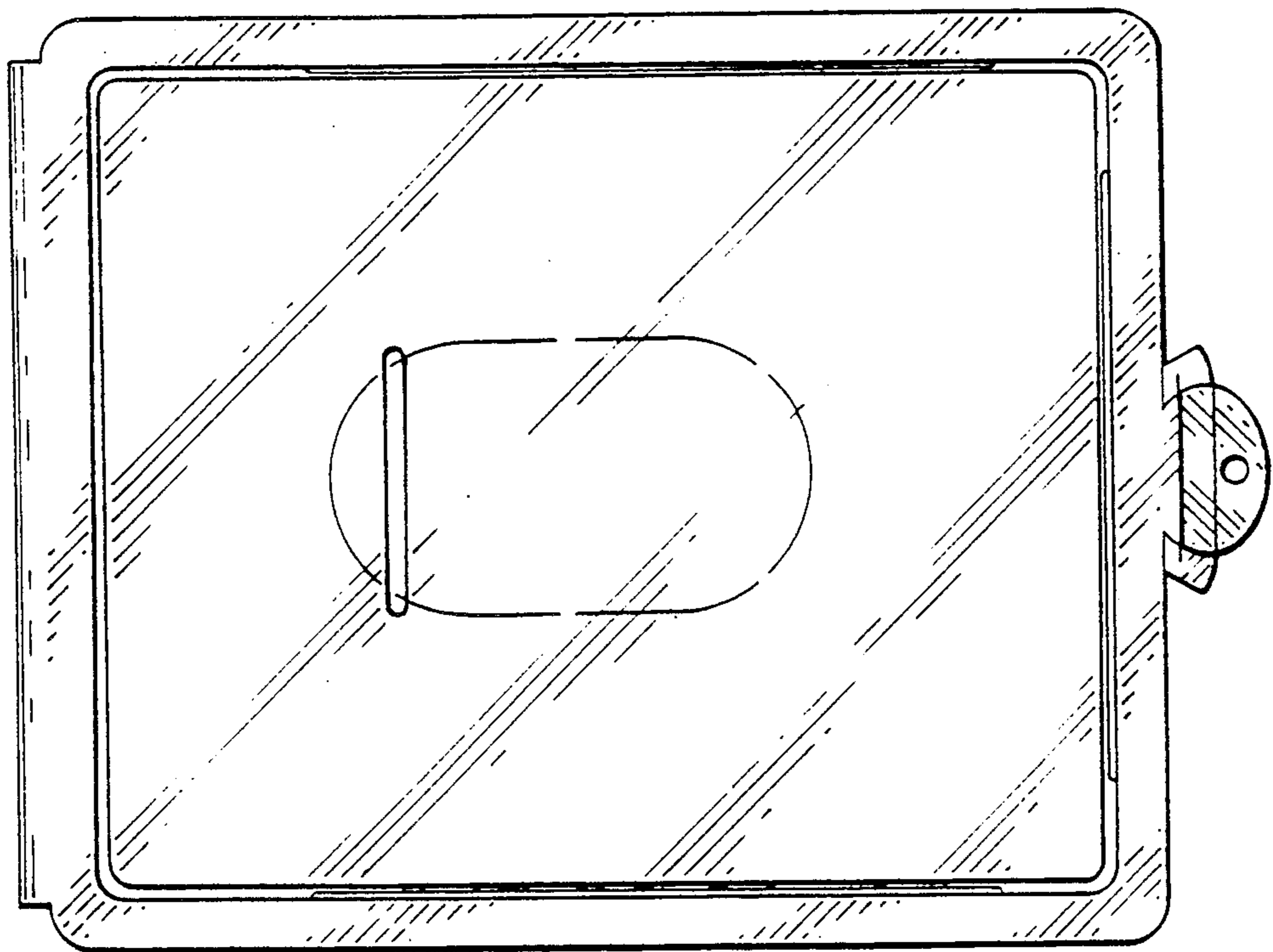

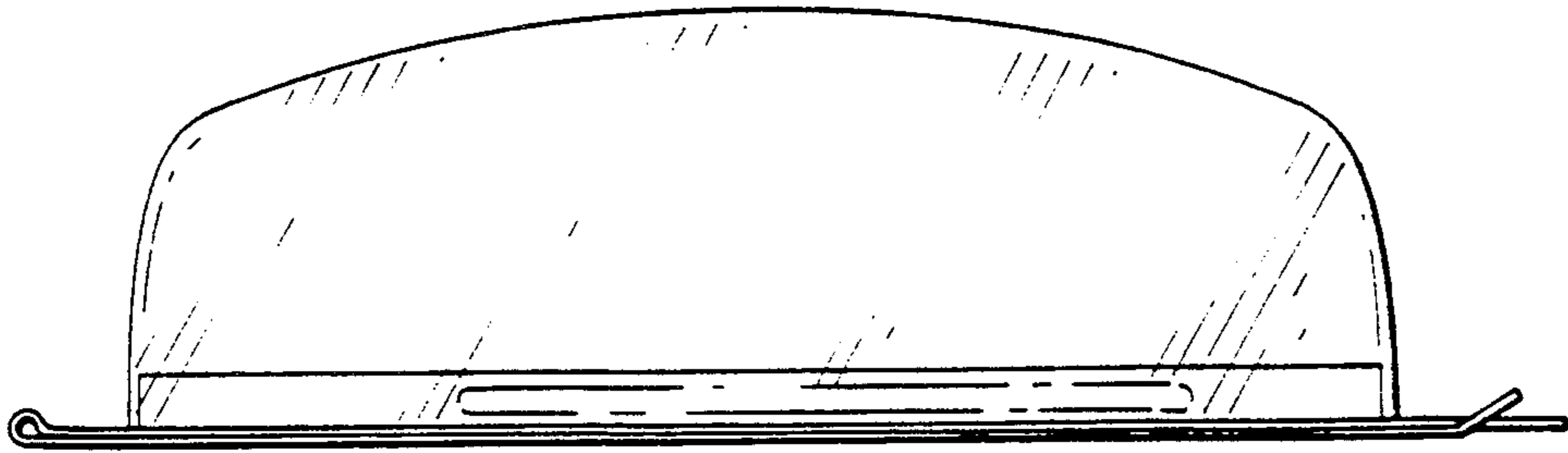

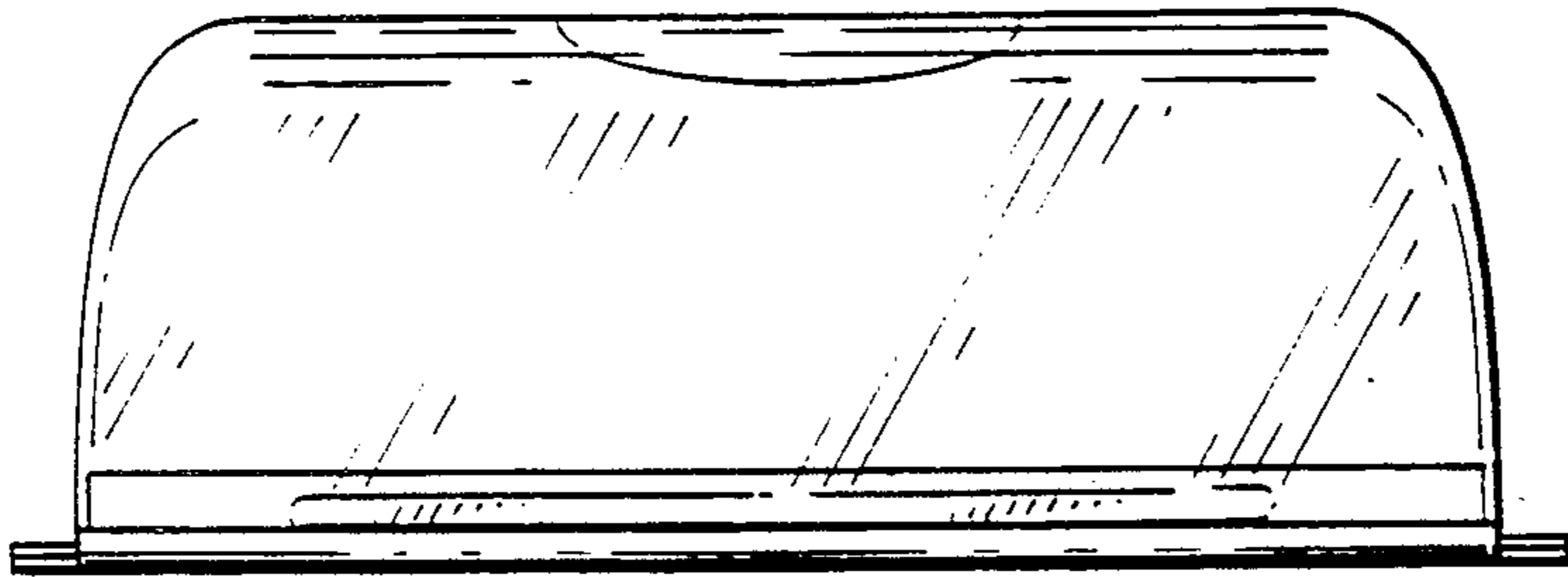

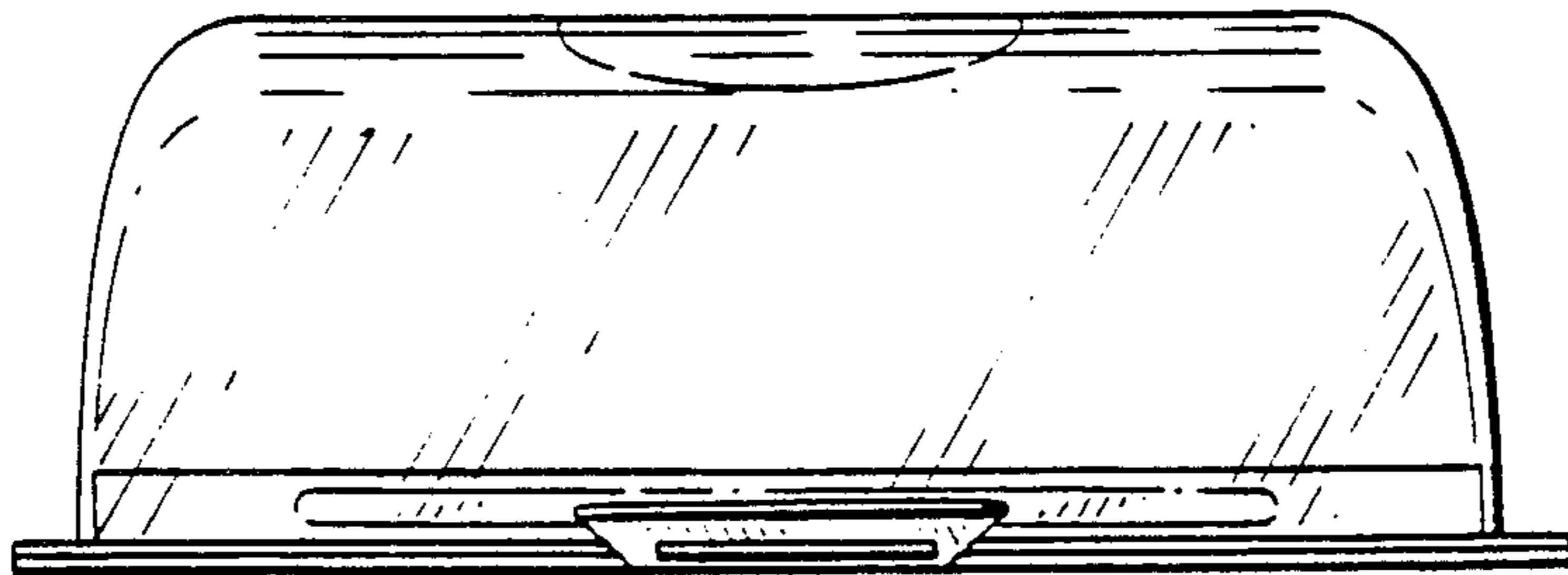
