DESCRIPTION

FIG. 1 is a top, front, right perspective view of an interior compartment for a video game case showing my new design;

FIG. 2 is a top plan view thereof;

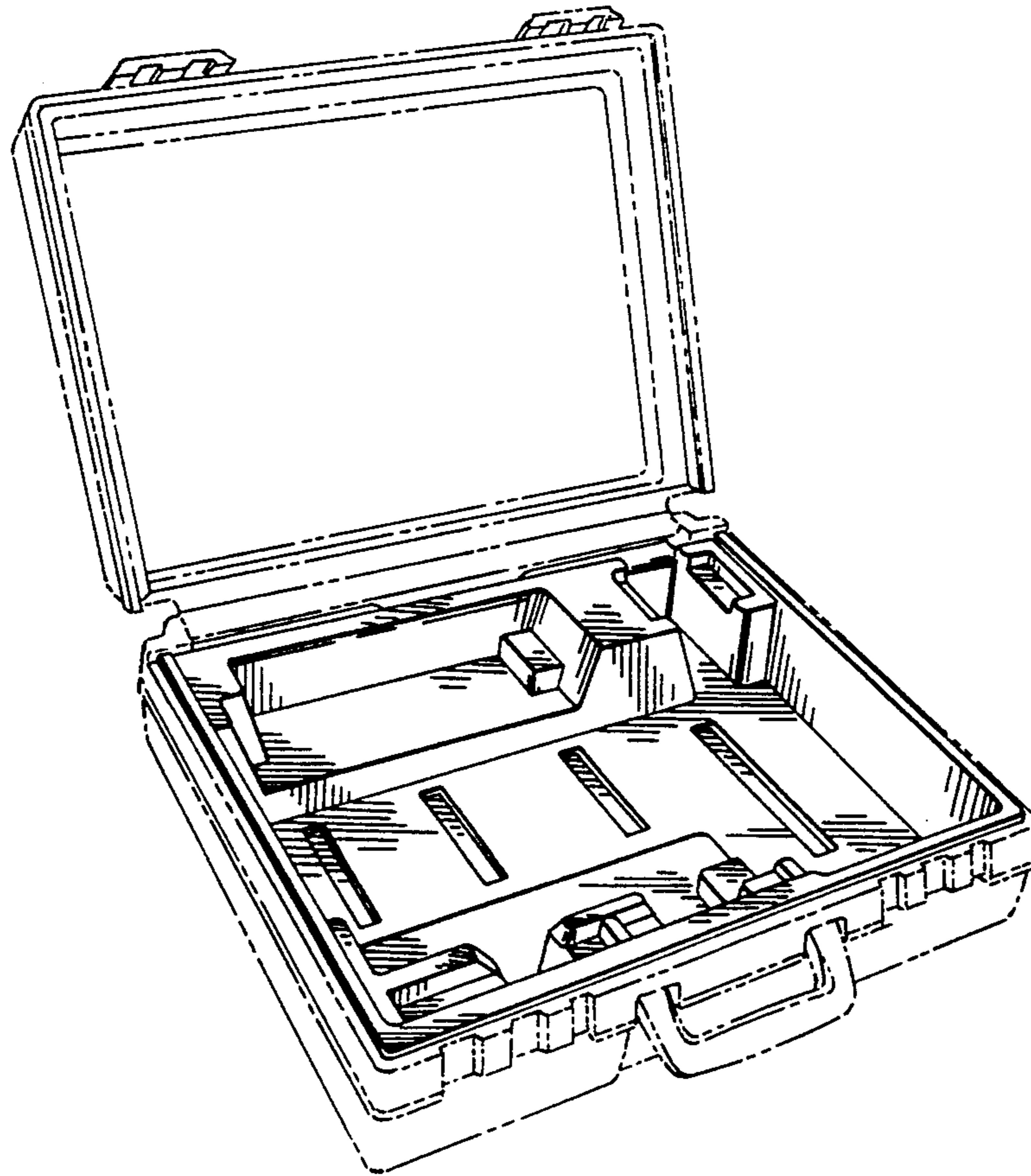
FIG. 3 is a sectional view taken along lines 3—3 of FIG. 2;

FIG. 7 is a sectional view taken along line 7—7 of FIG. 2.



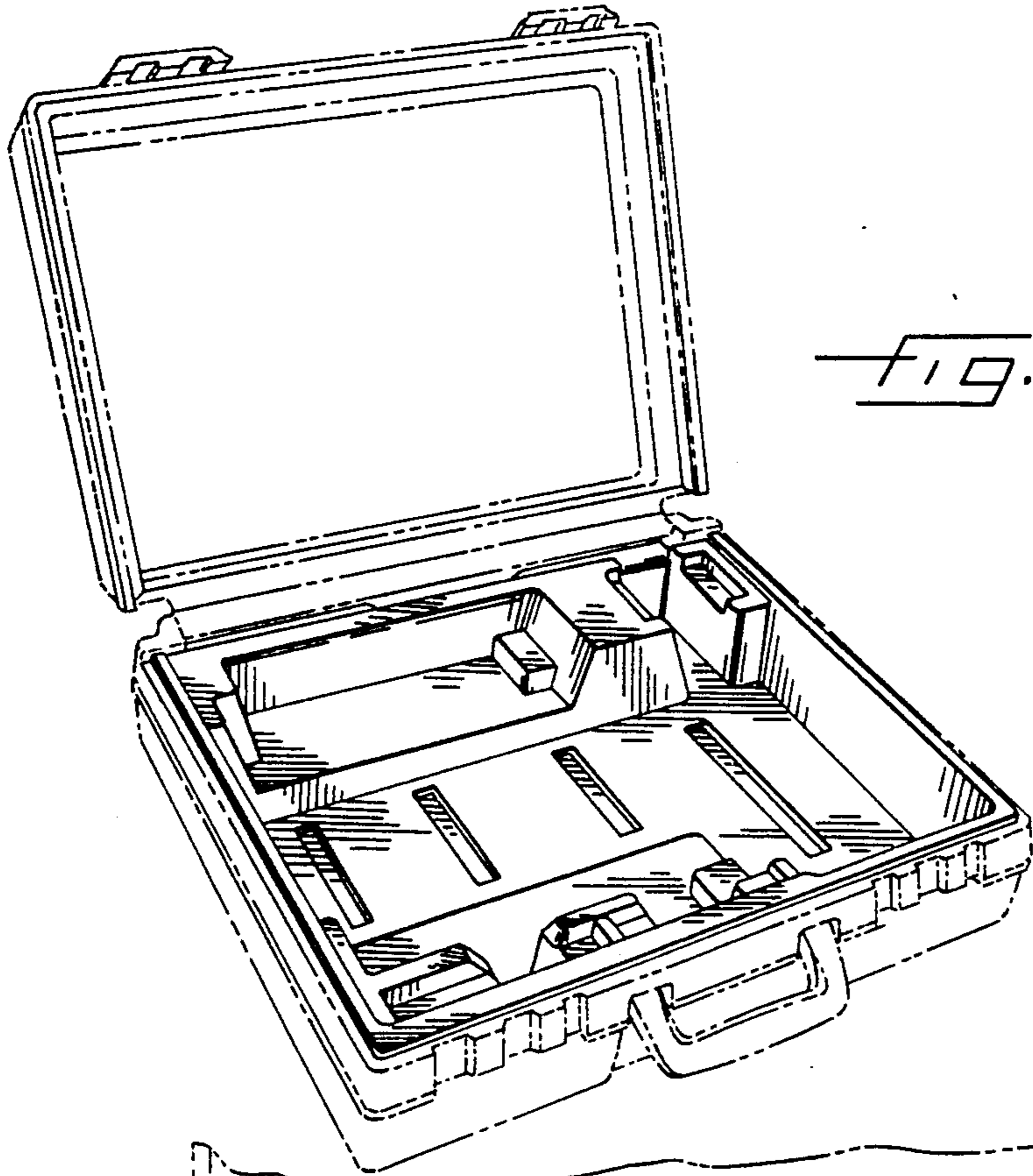

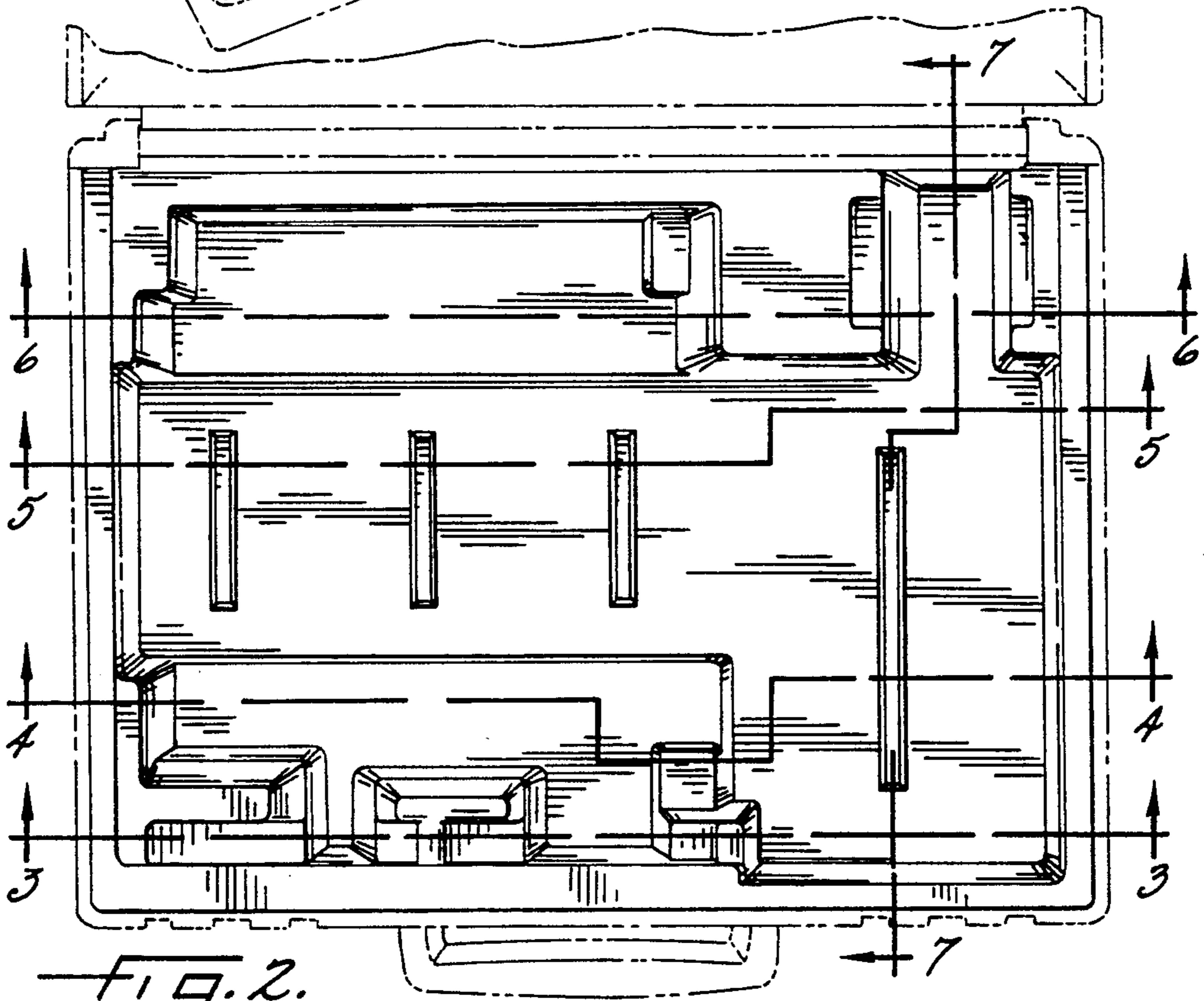

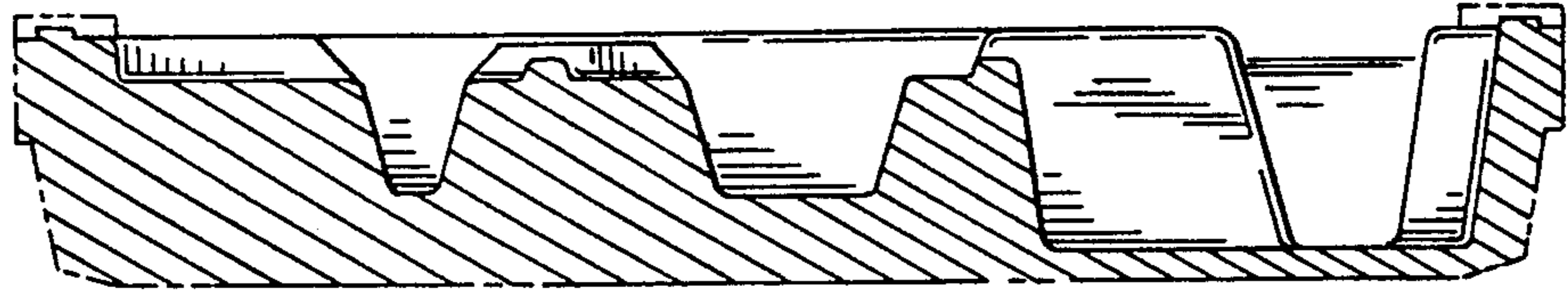

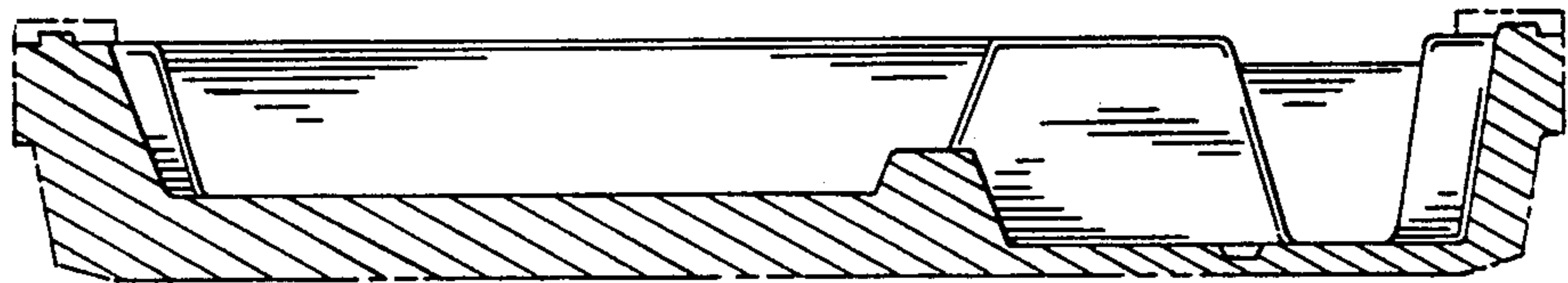

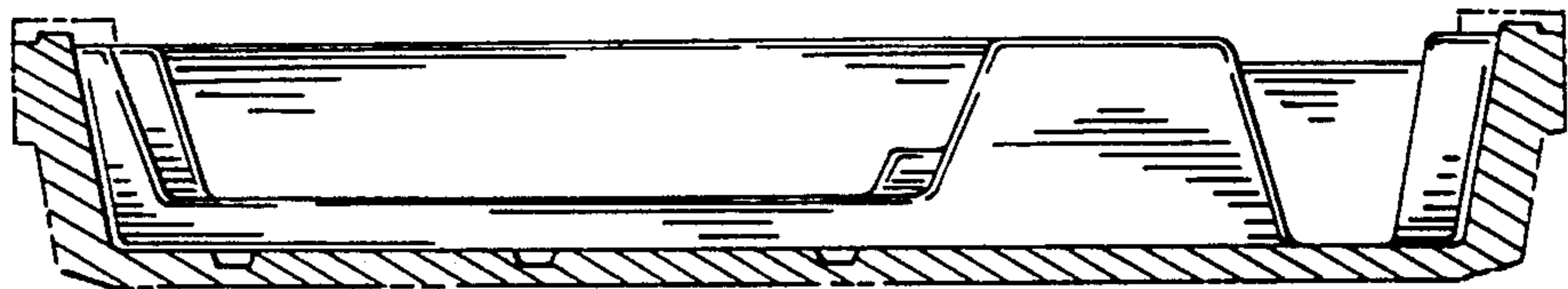

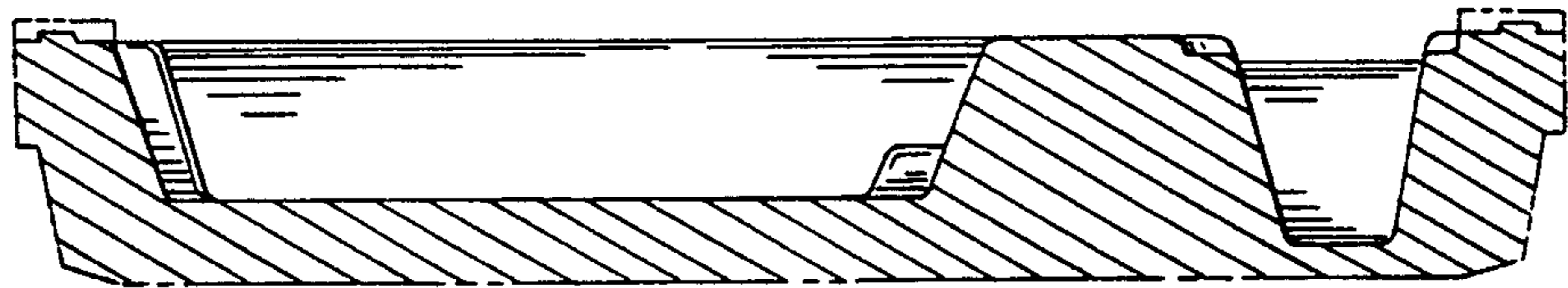

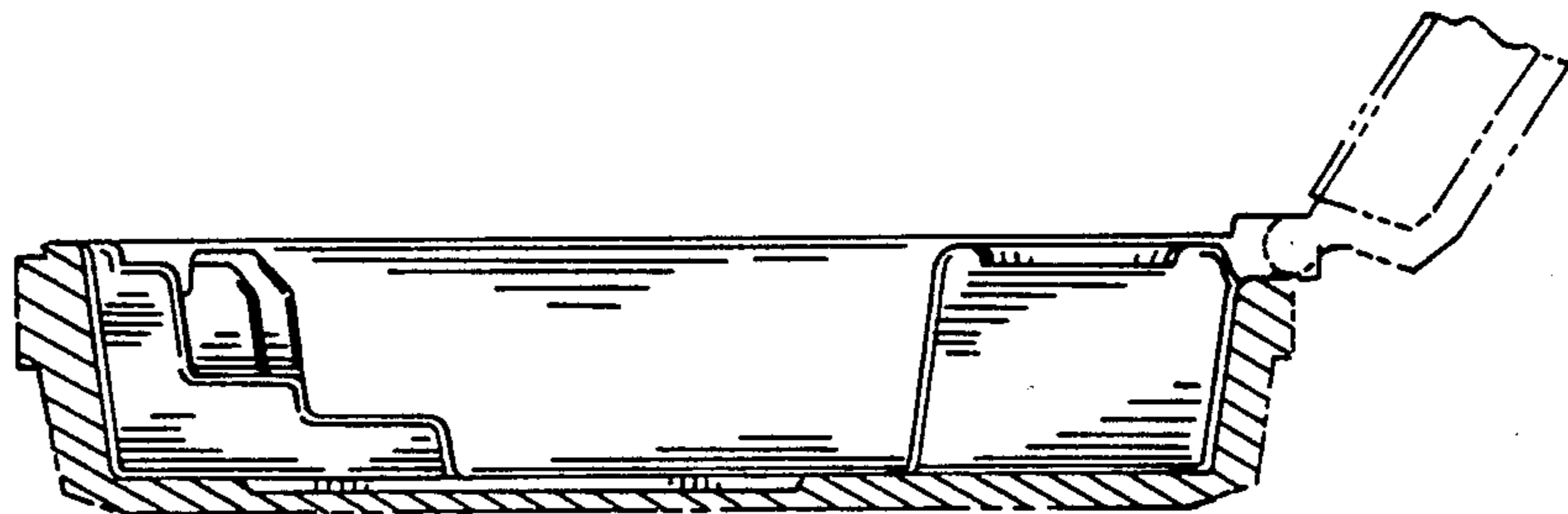
