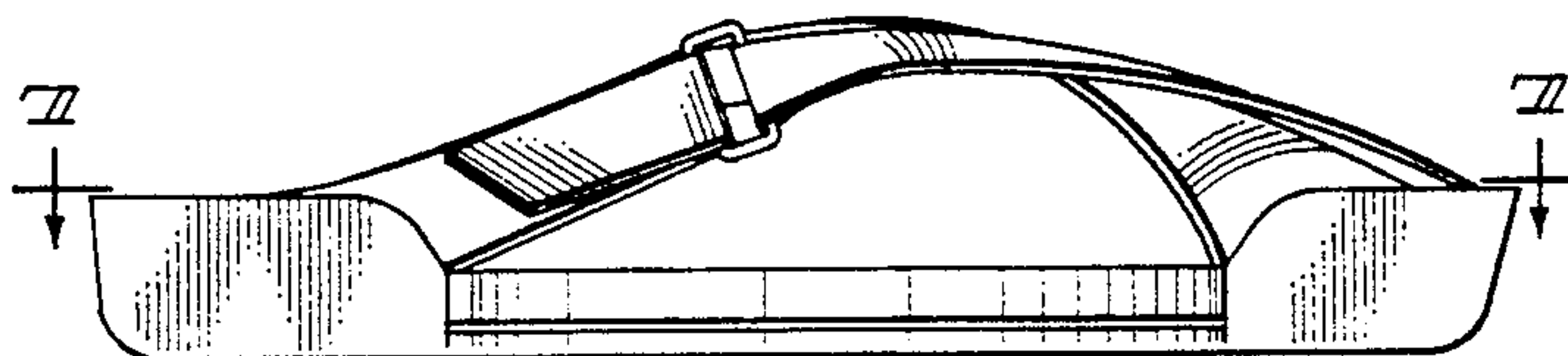
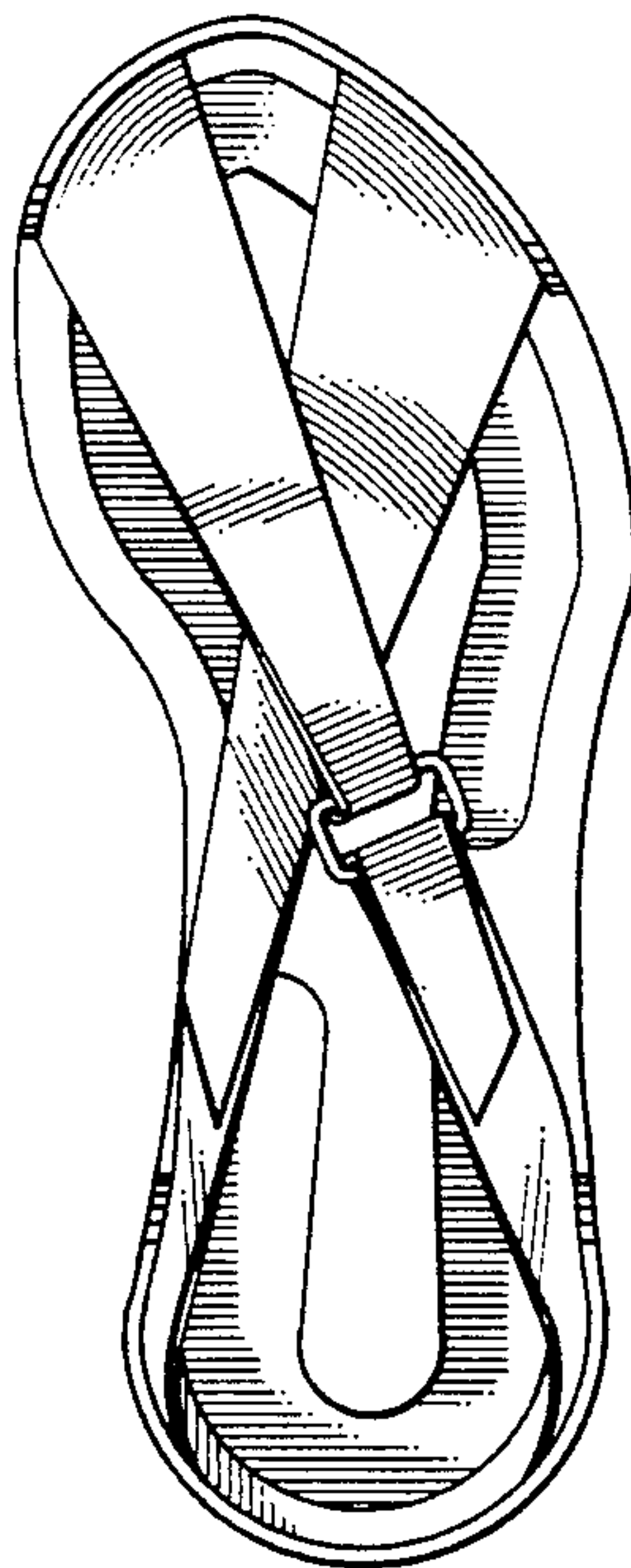

[57] **CLAIM**

The ornamental design for a removable sole for spiked shoes, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a removable sole for spiked shoes showing a first preferred form of my new design; FIG. 2 is a bottom plan view thereof; FIG. 3 is a toe end view thereof; FIG. 4 is a heel end view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a right side view thereof; FIG. 7 is a sectional view thereof taken along line 7—7 in FIG. 6; FIG. 8 is a top plan view of a removable sole for spiked shoes showing an alternate form of my new design; and, FIG. 9 is a sectioned top plan view of the alternate form thereof.



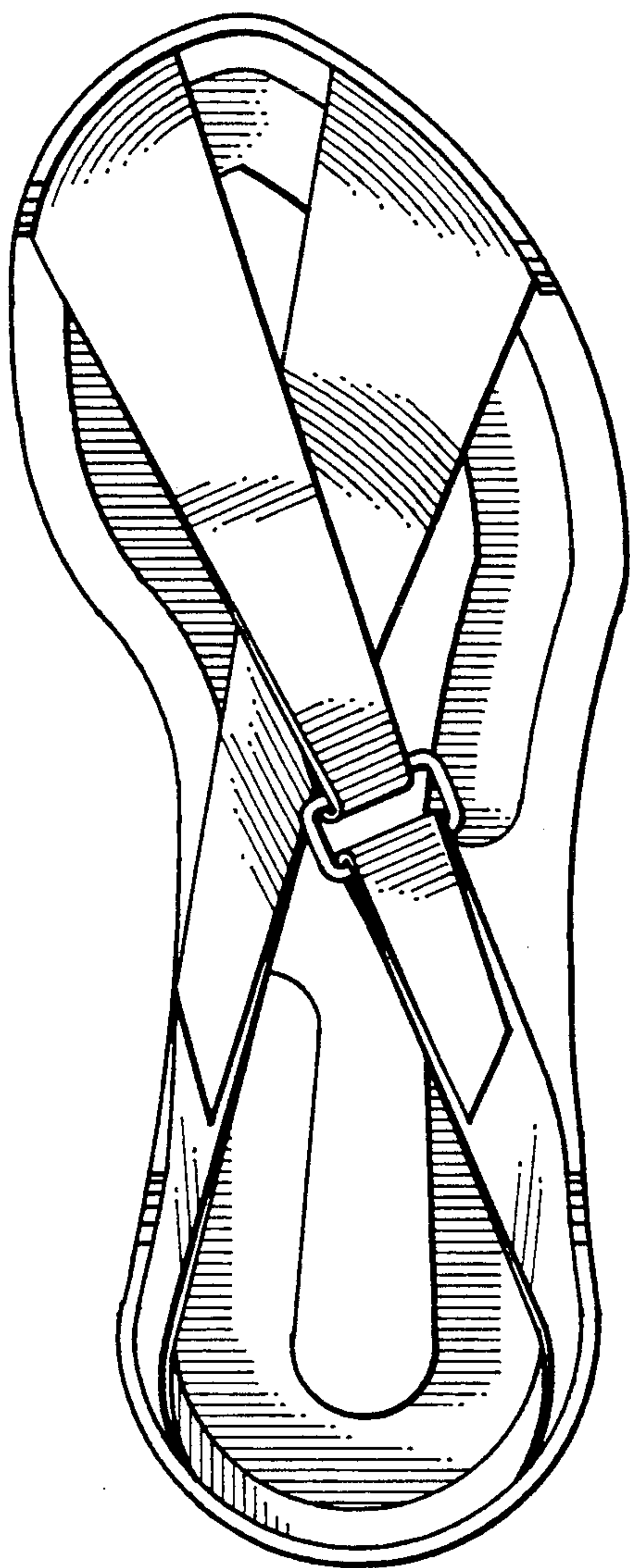
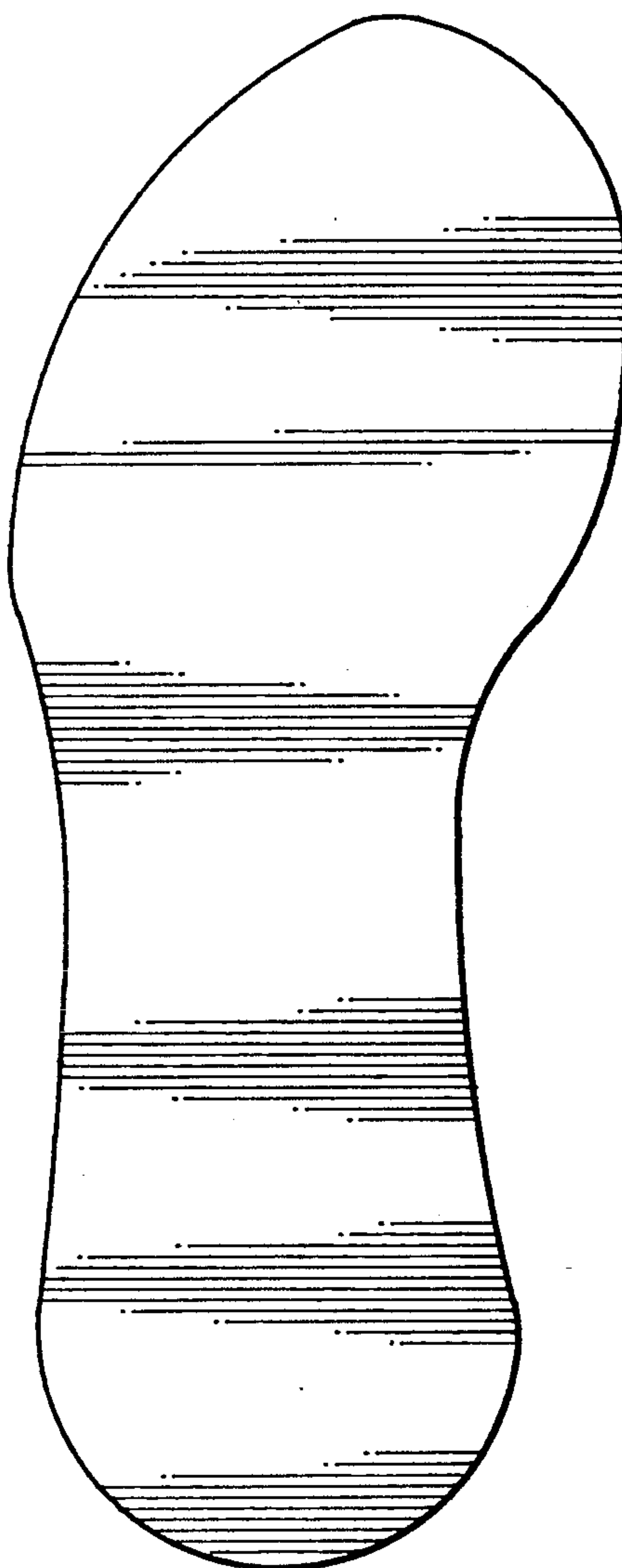

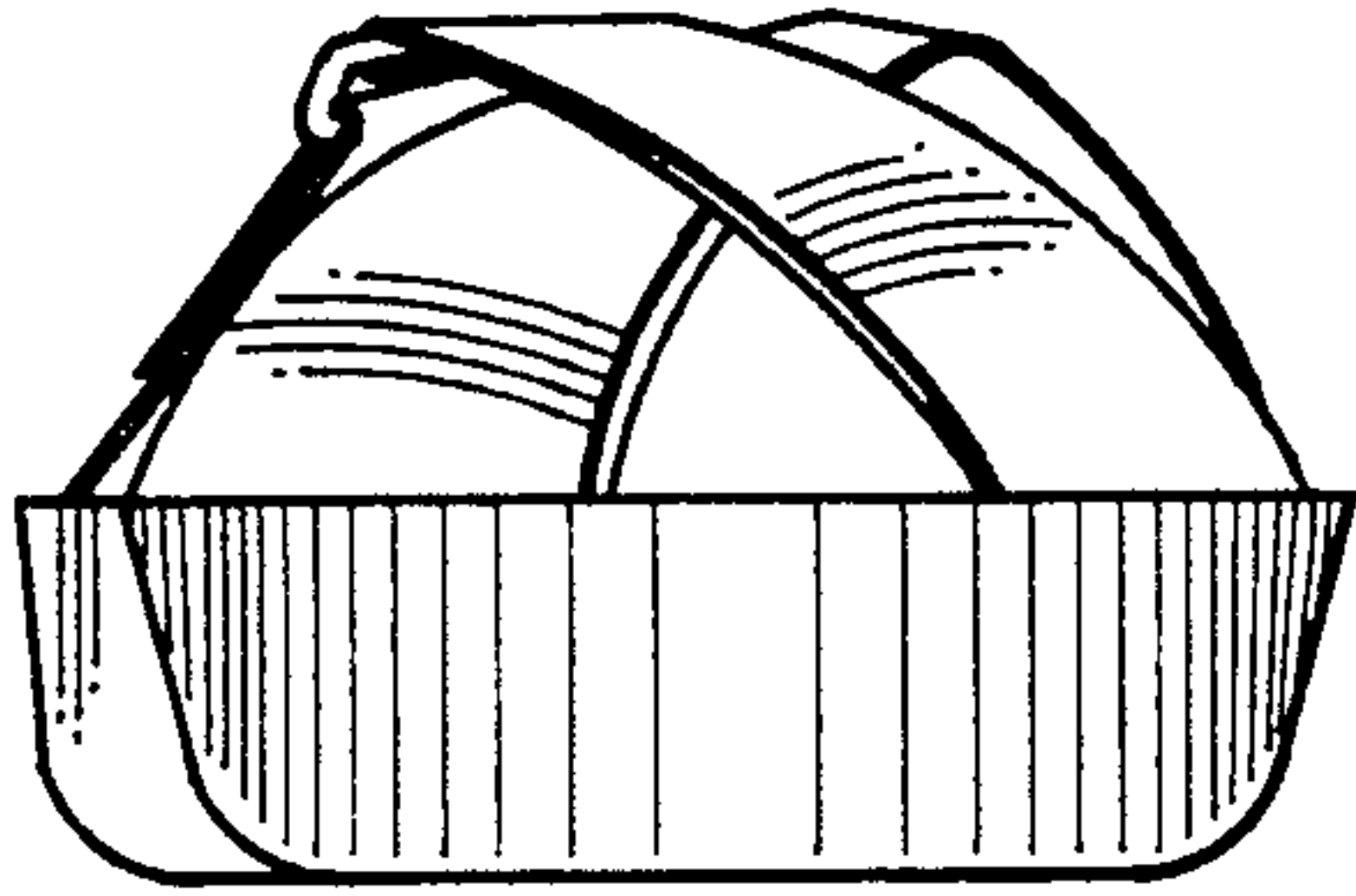

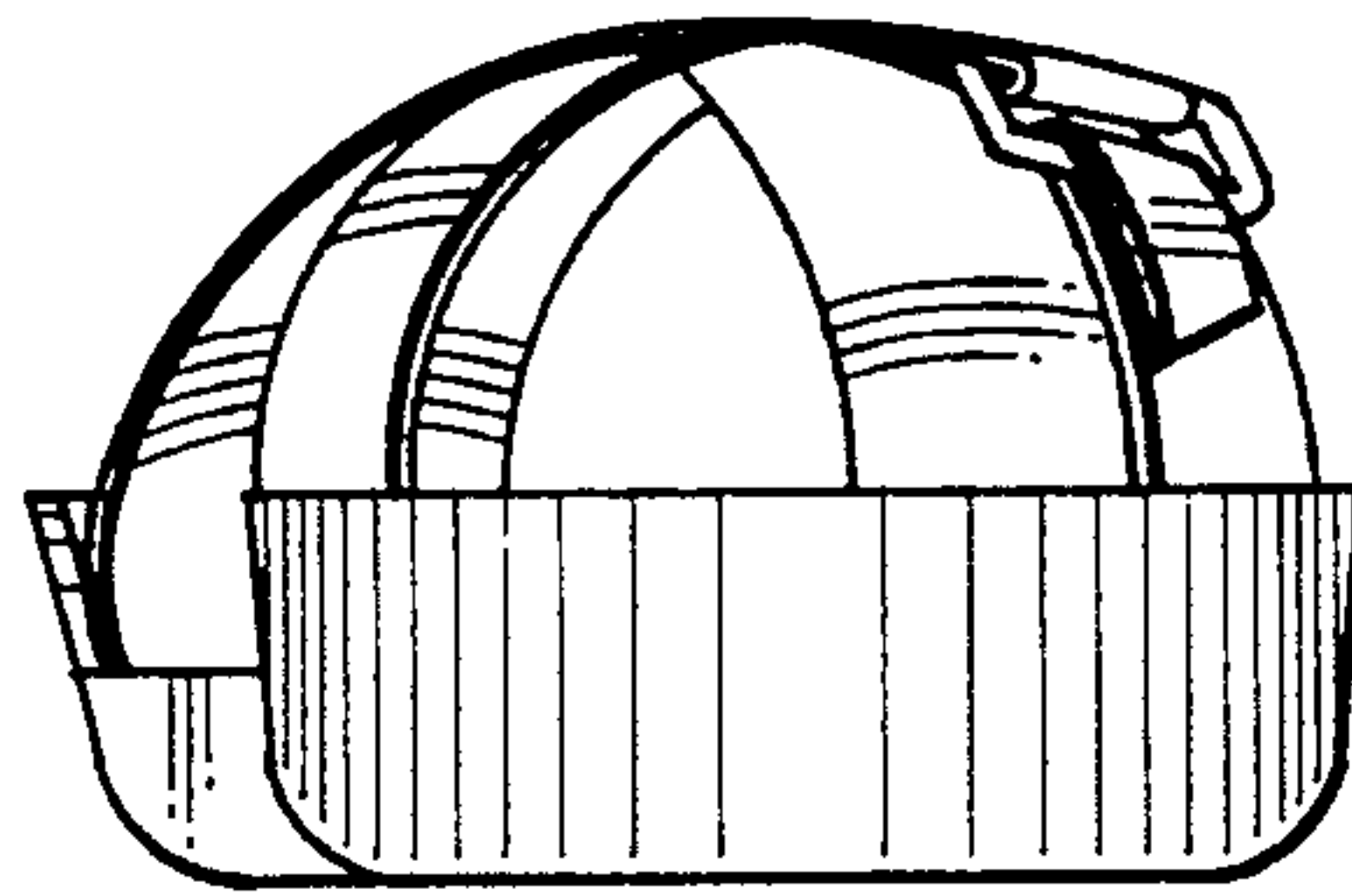

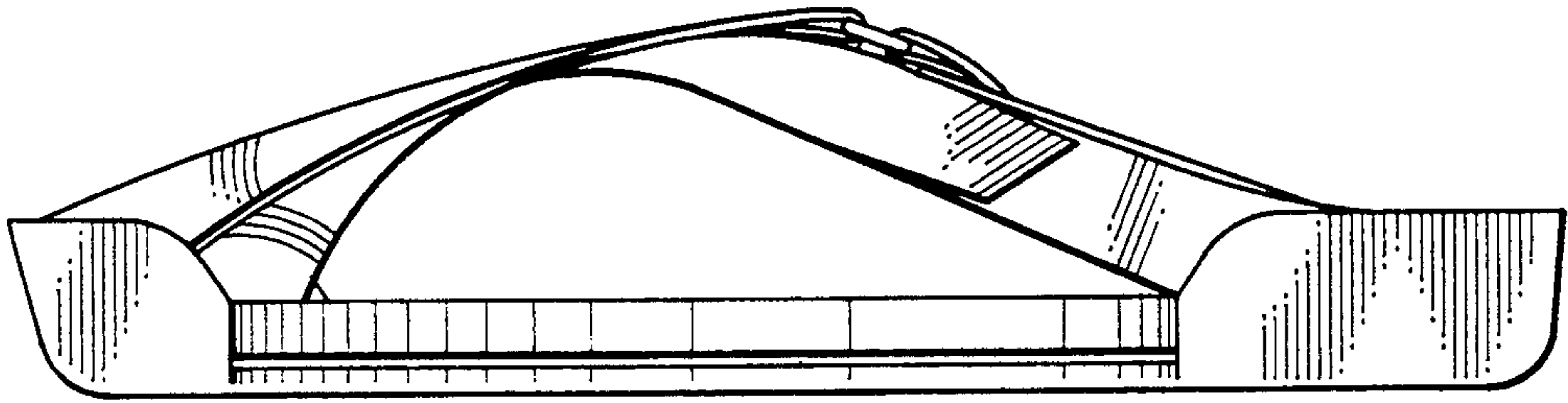

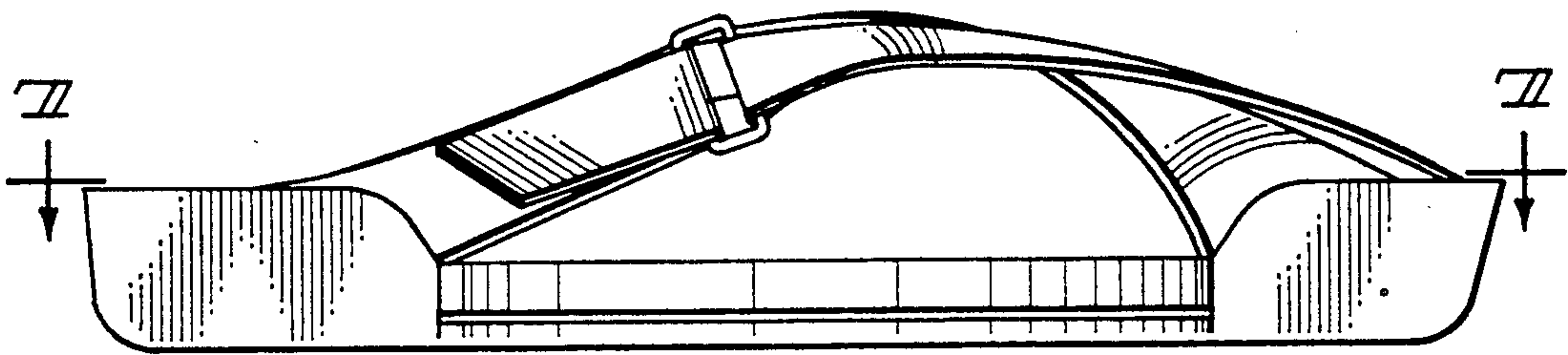

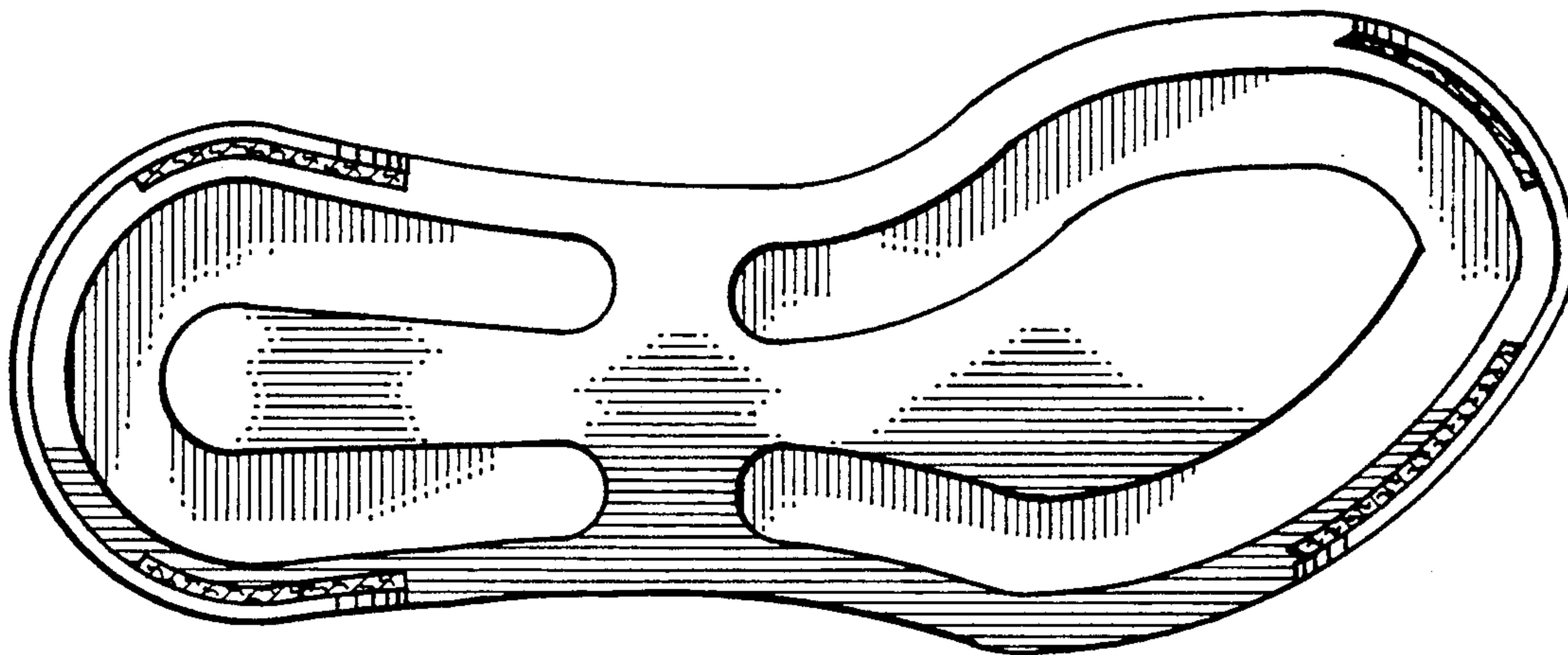

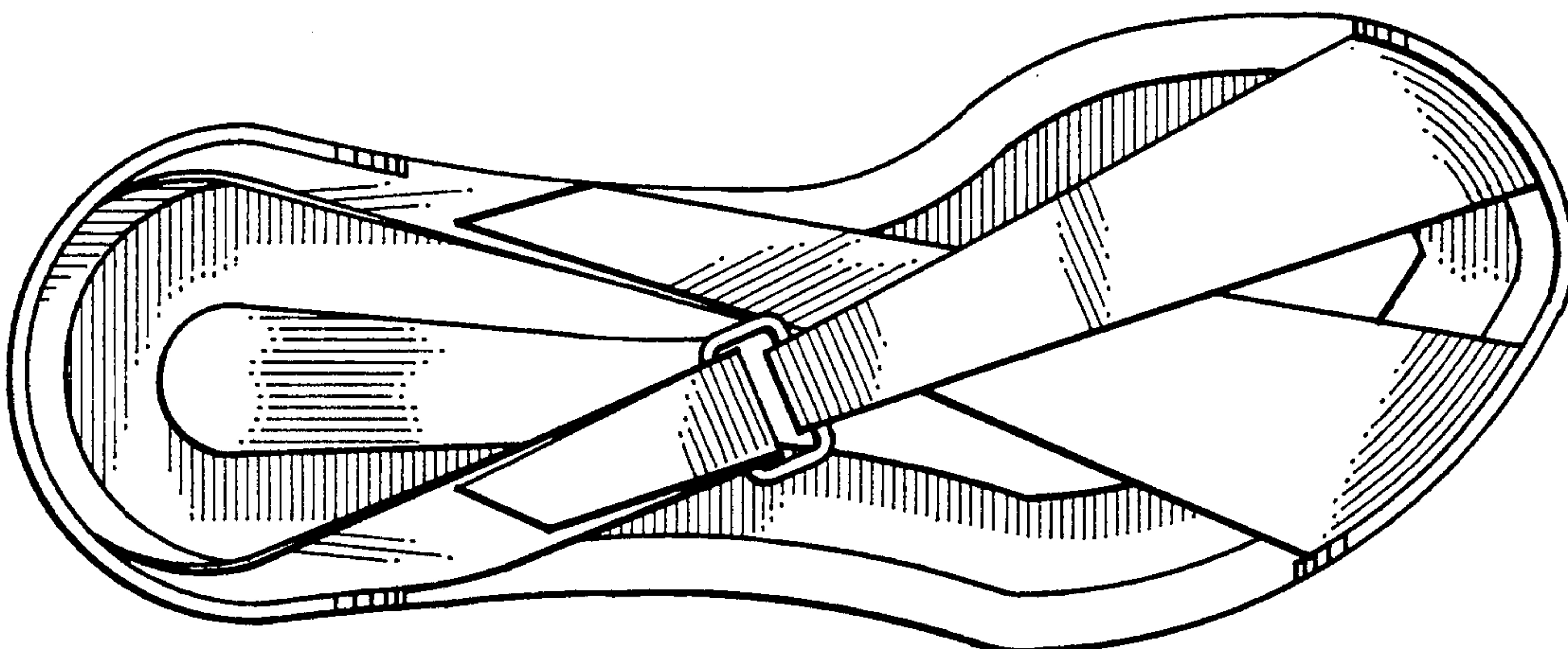

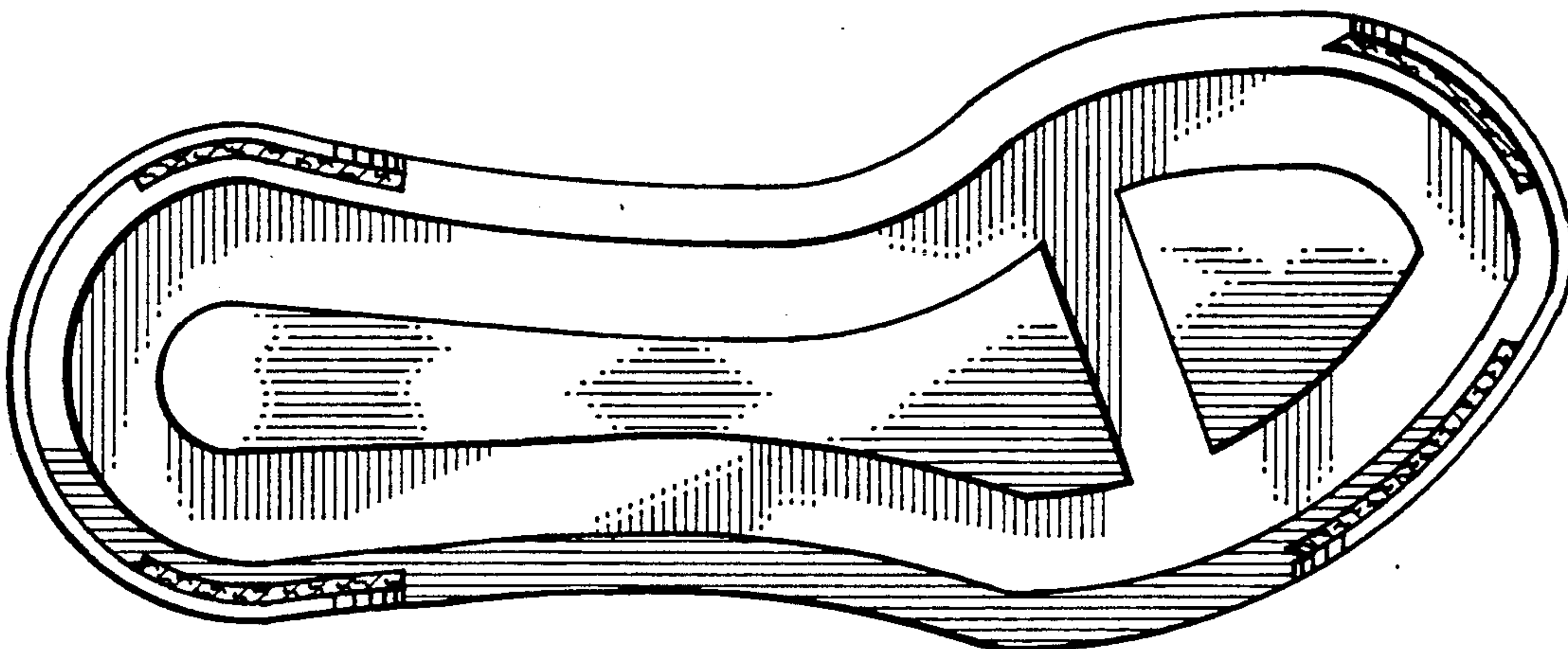
