The ornamental design for a wristwatch, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a wristwatch showing my new design;

FIG. 2 is a right side elevational view;

FIG. 3 is a rear elevational view;

FIG. 4 is a left side elevational view;

FIG. 5 is a top plan view;

FIG. 6 is a bottom plan view; and,

FIG. 7 is a bottom plan and front perspective view thereof, drawn on an enlarged scale.

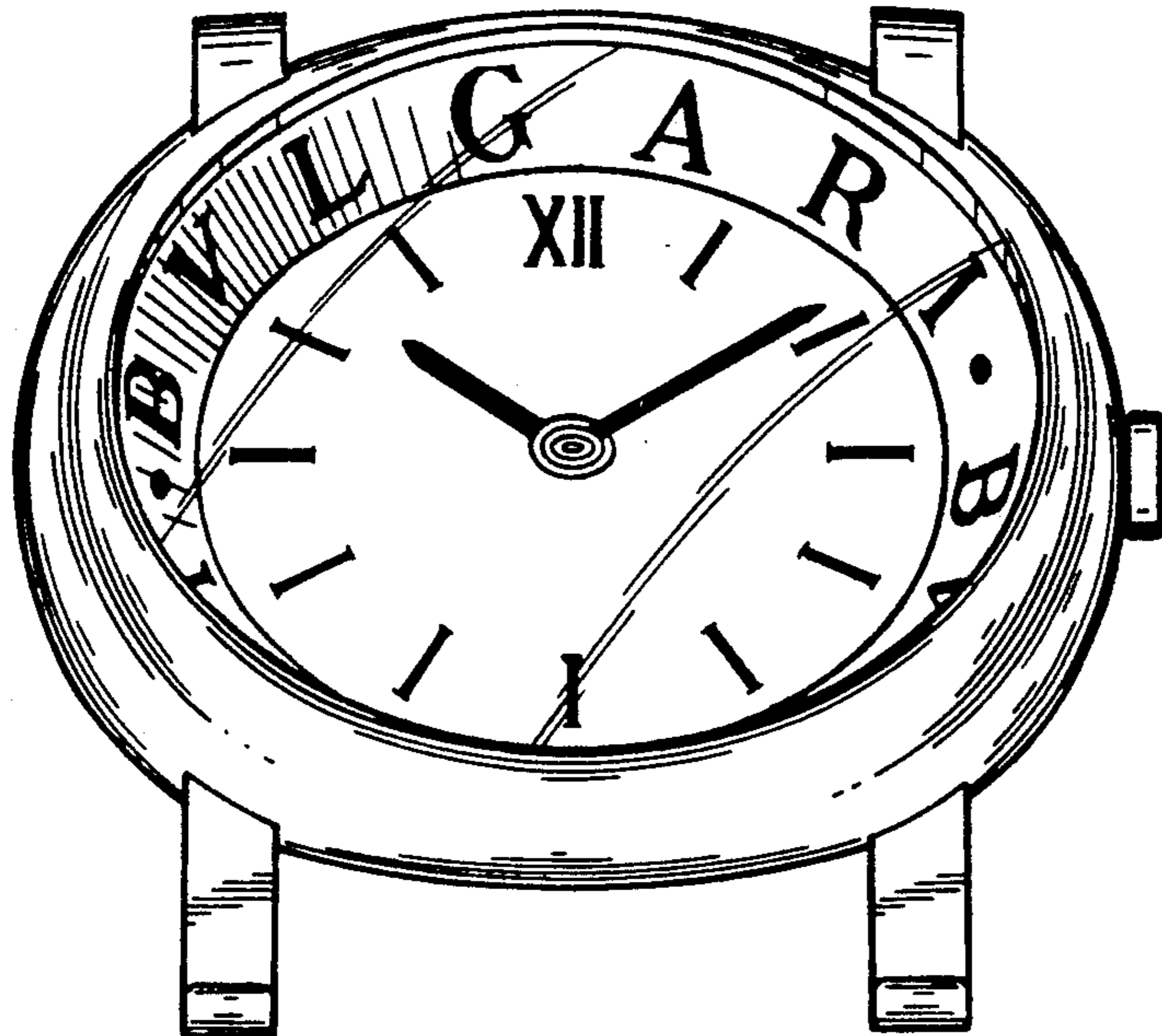

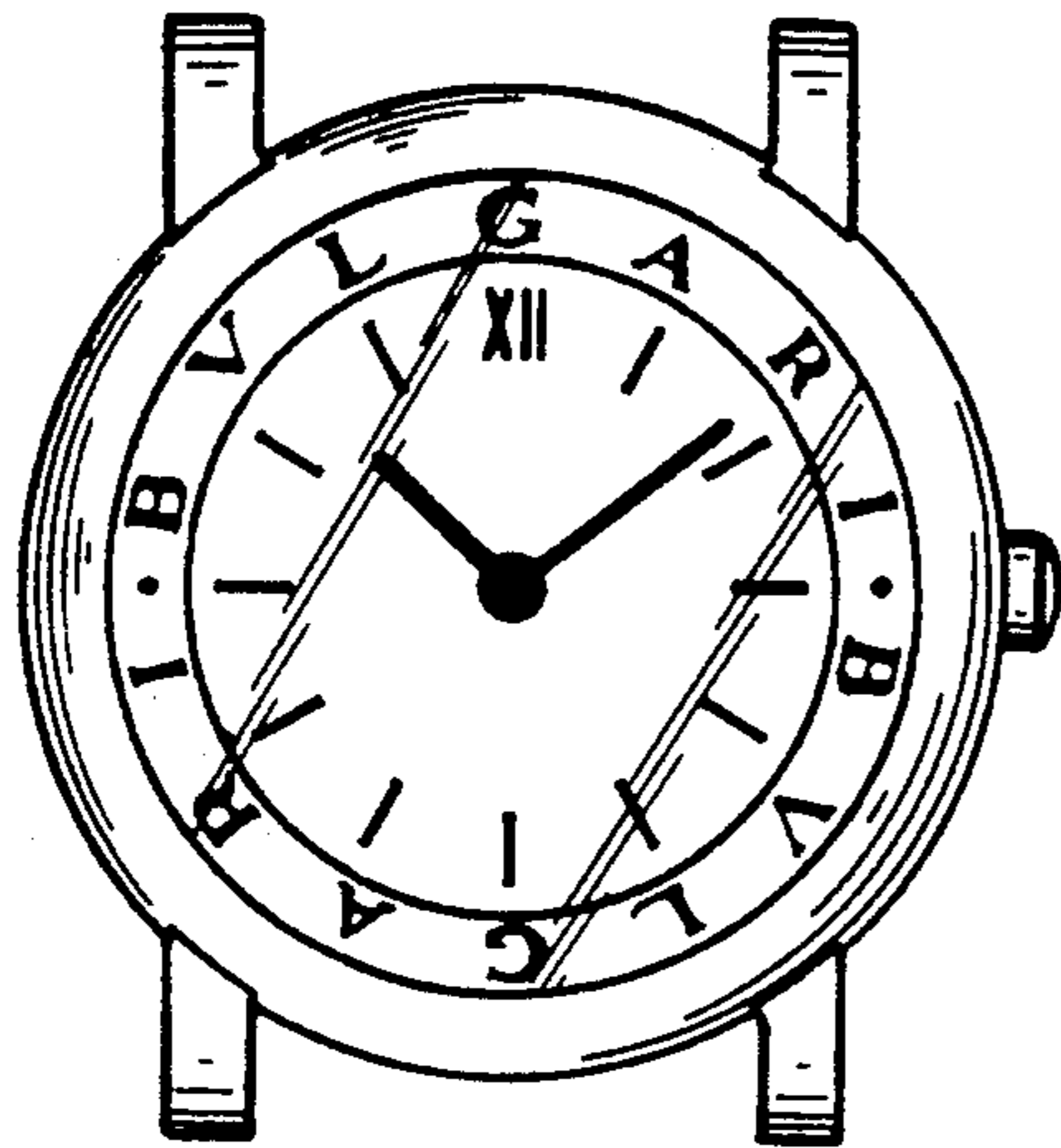

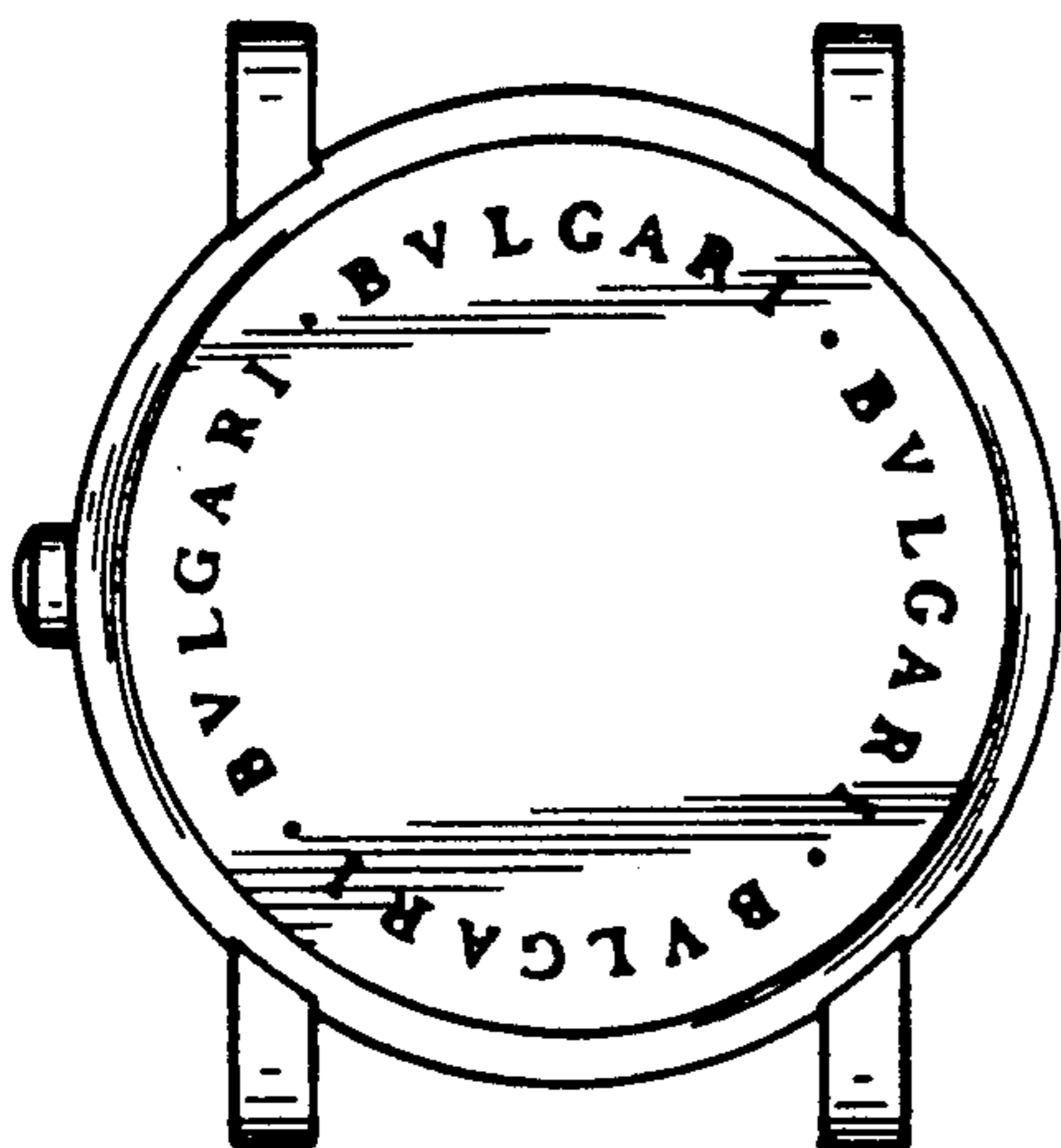

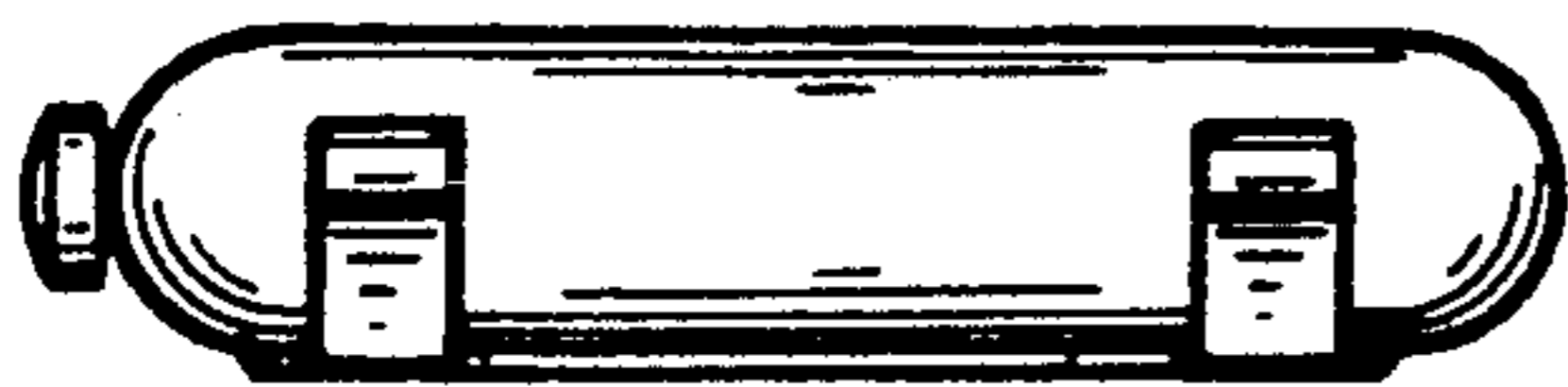

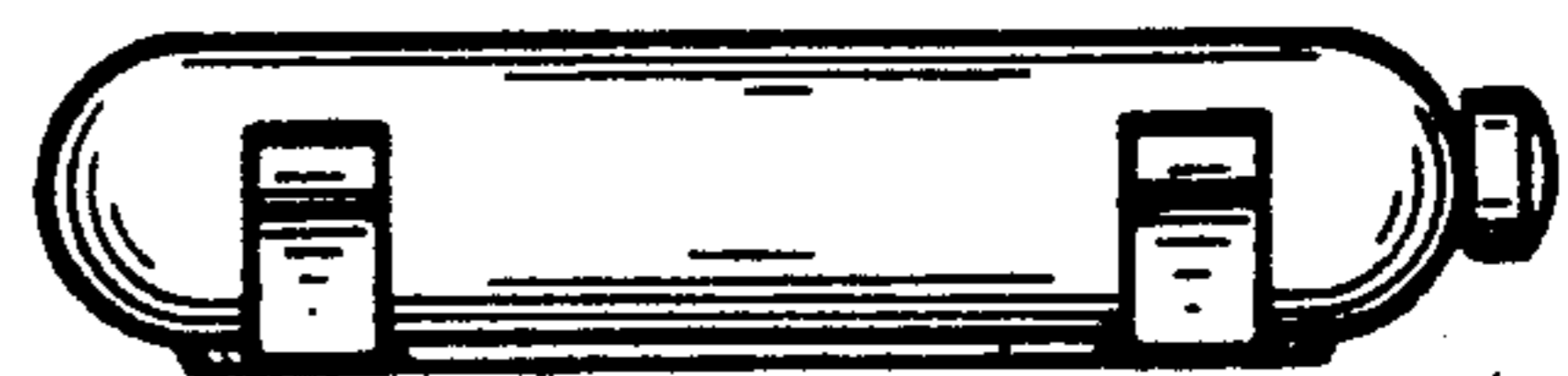
