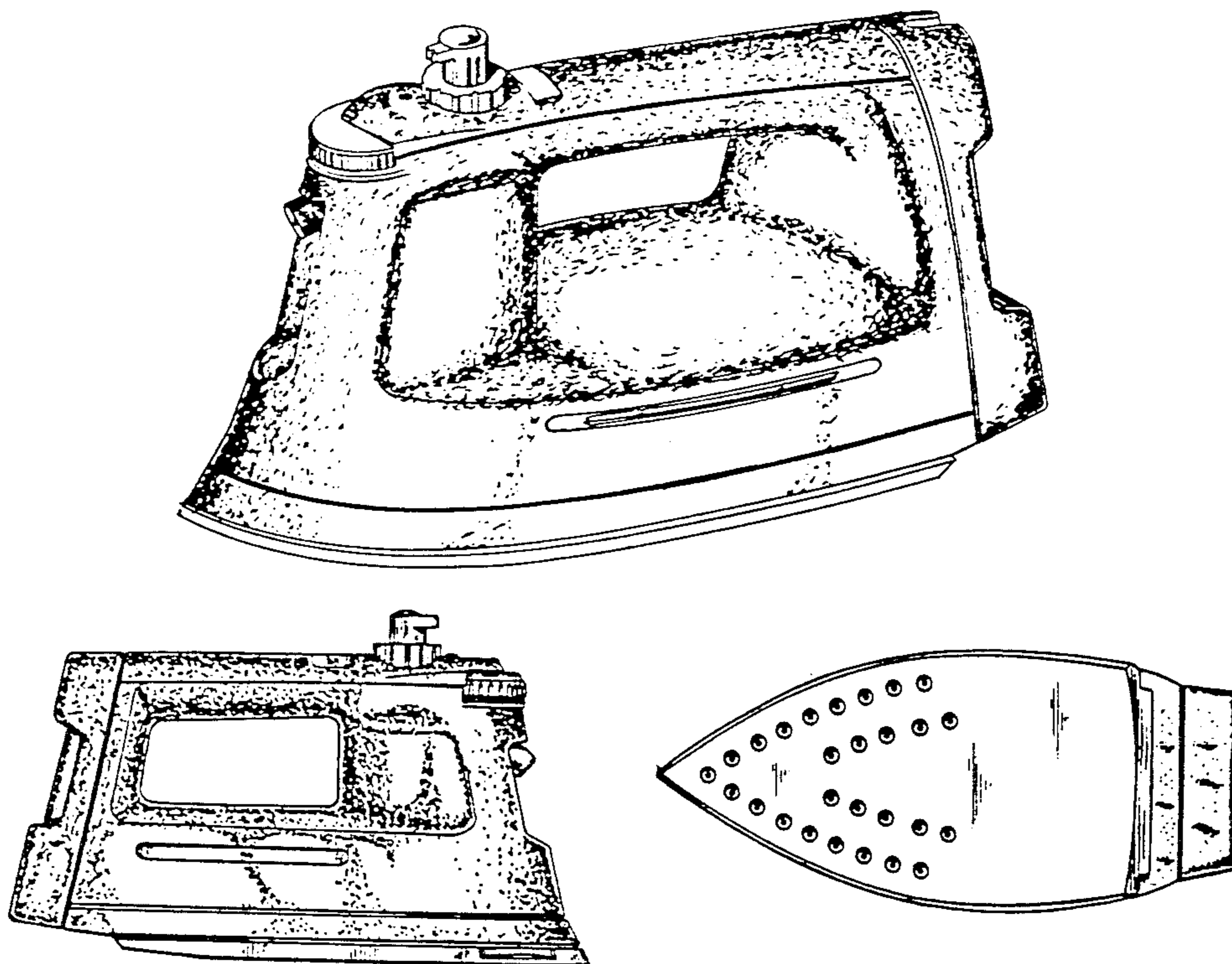

[57] CLAIM

The ornamental design for an electric iron, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view, taken from the right side, of an electric iron, showing my new design; FIG. 2 is a left side elevational view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a rear elevational view thereof; and, FIG. 7 is a front elevational view thereof.



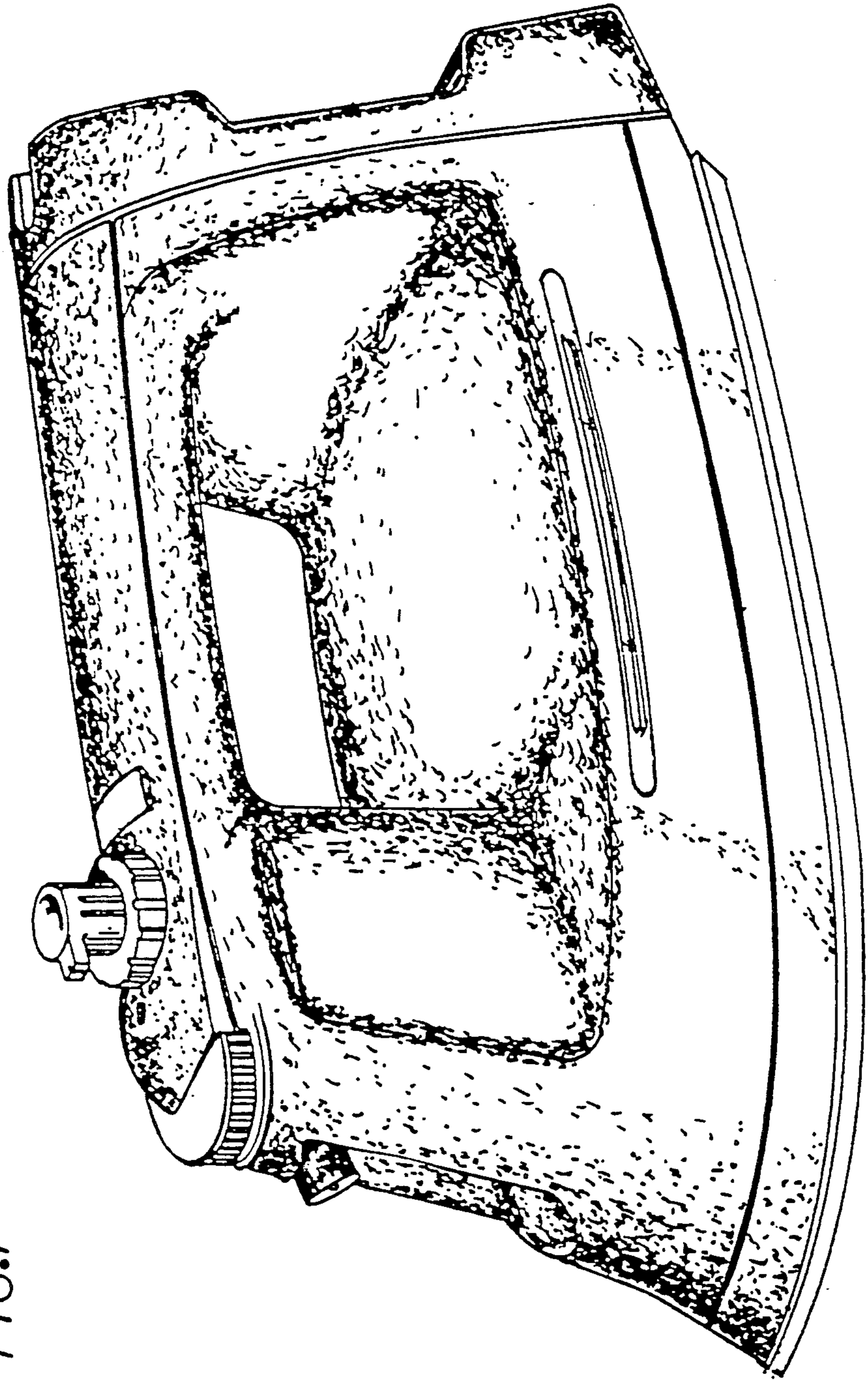

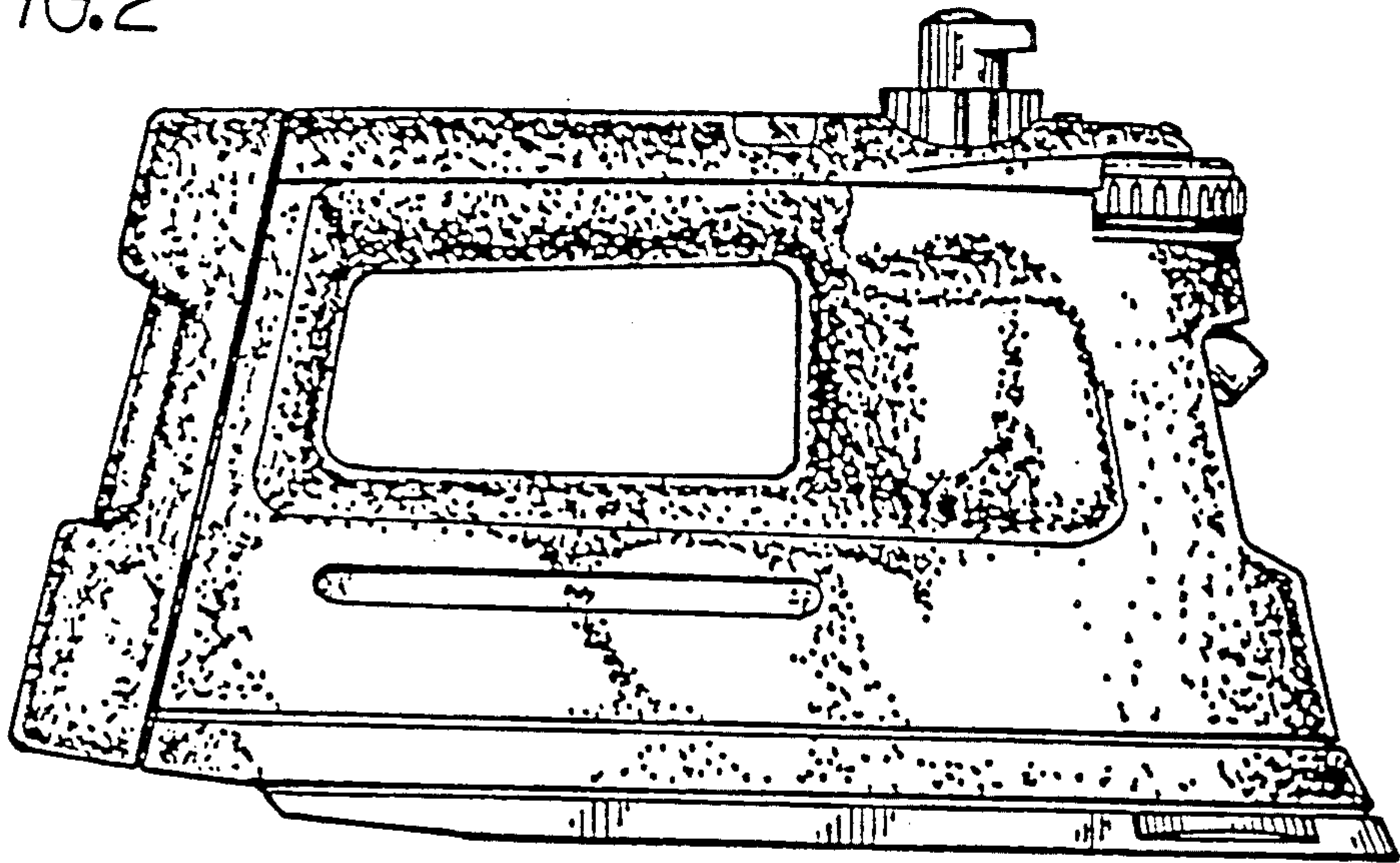

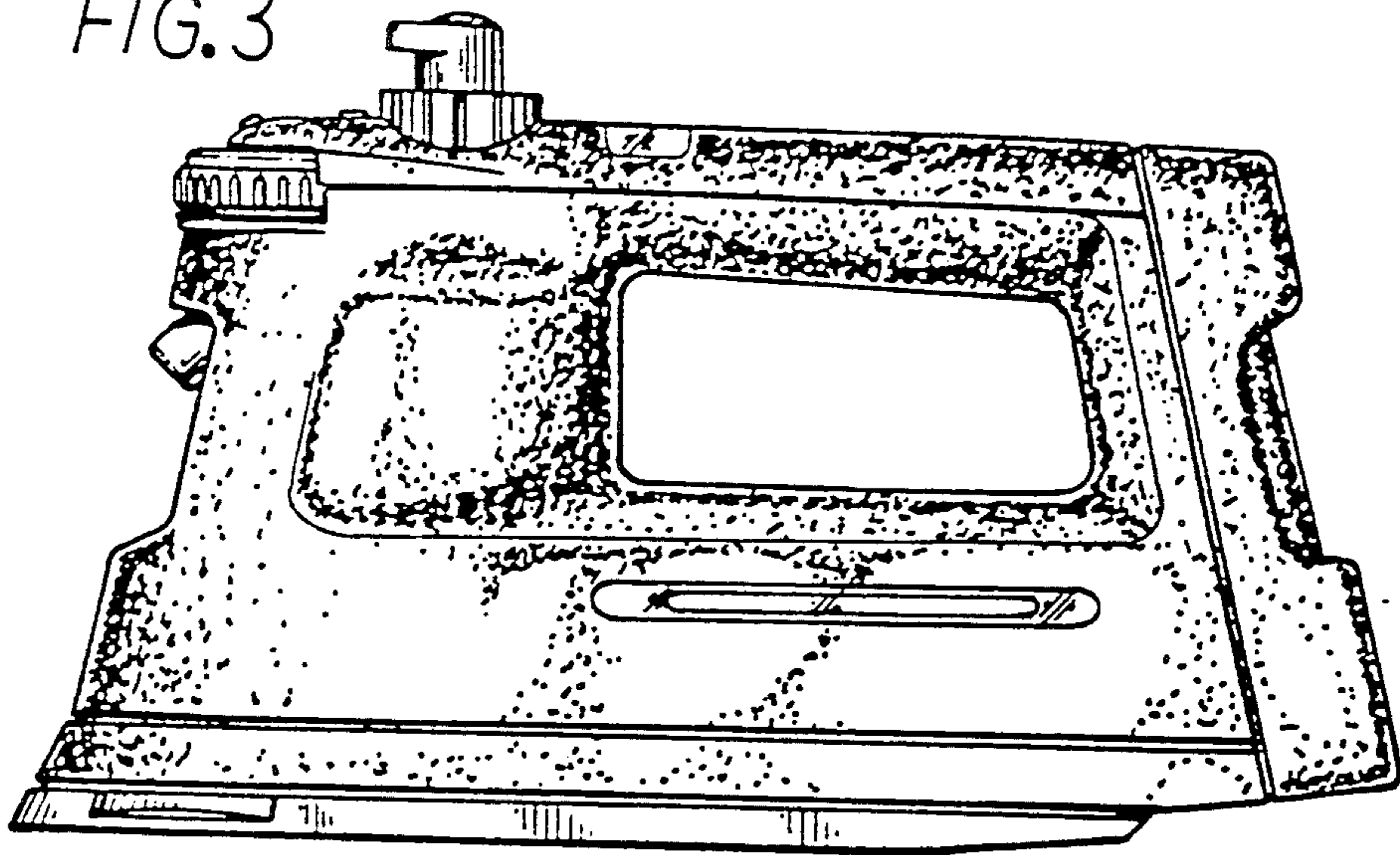

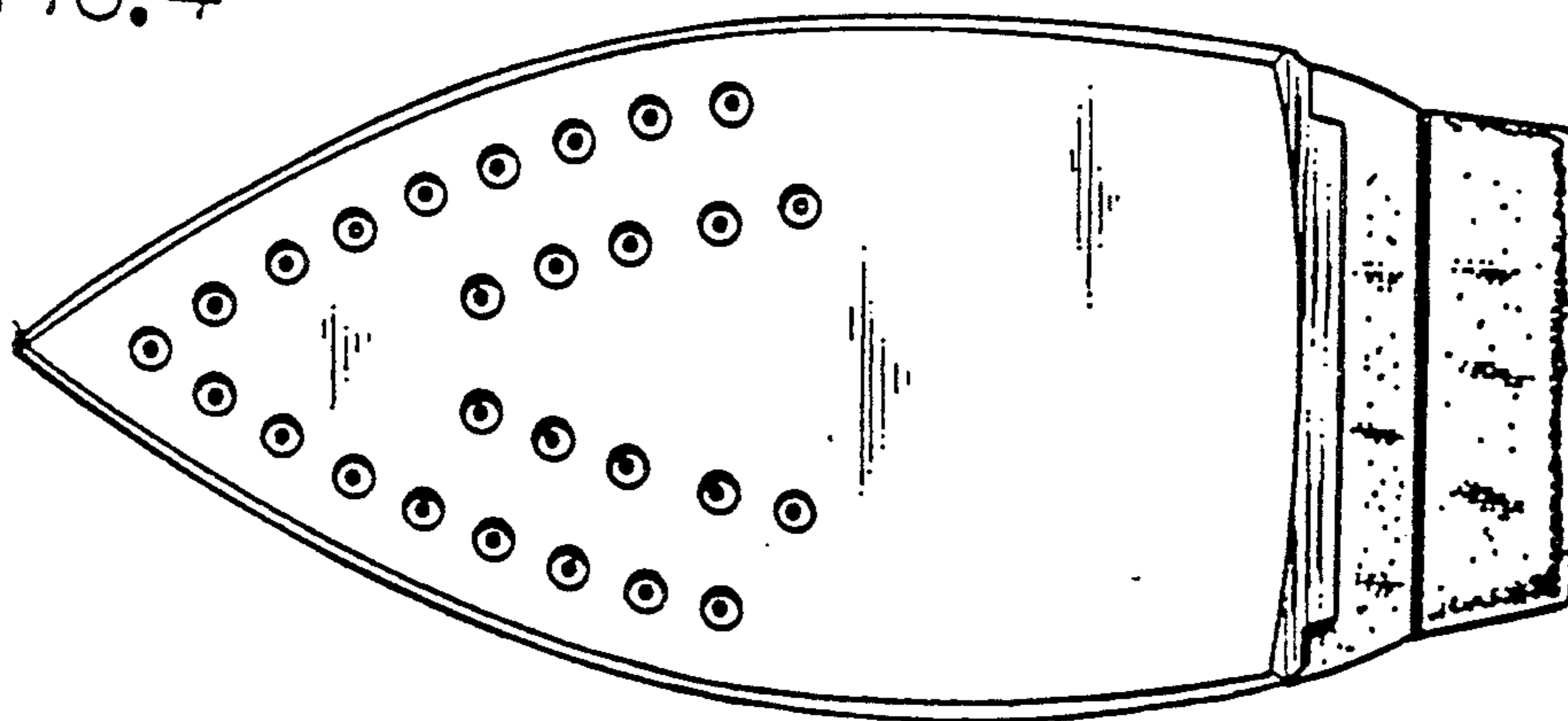

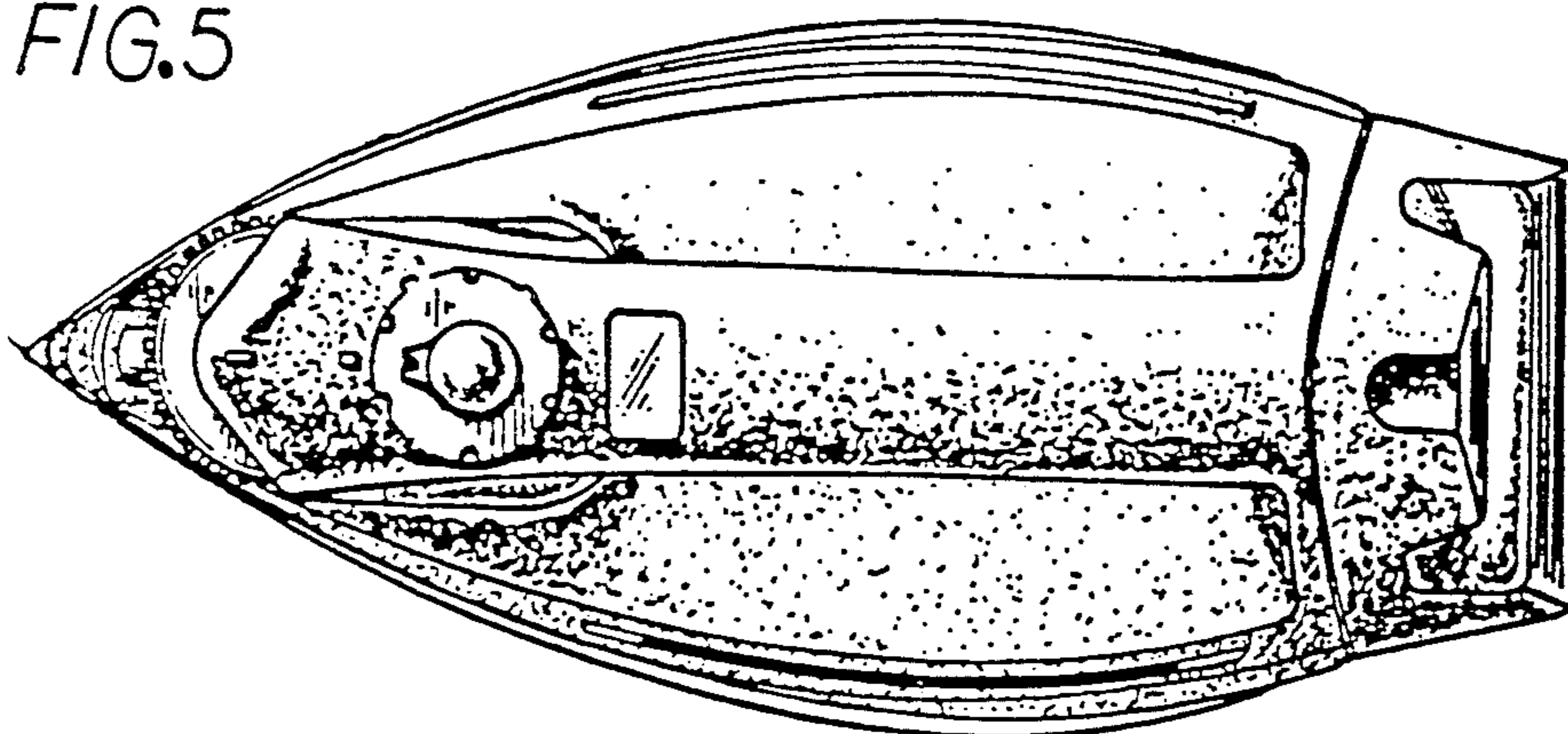

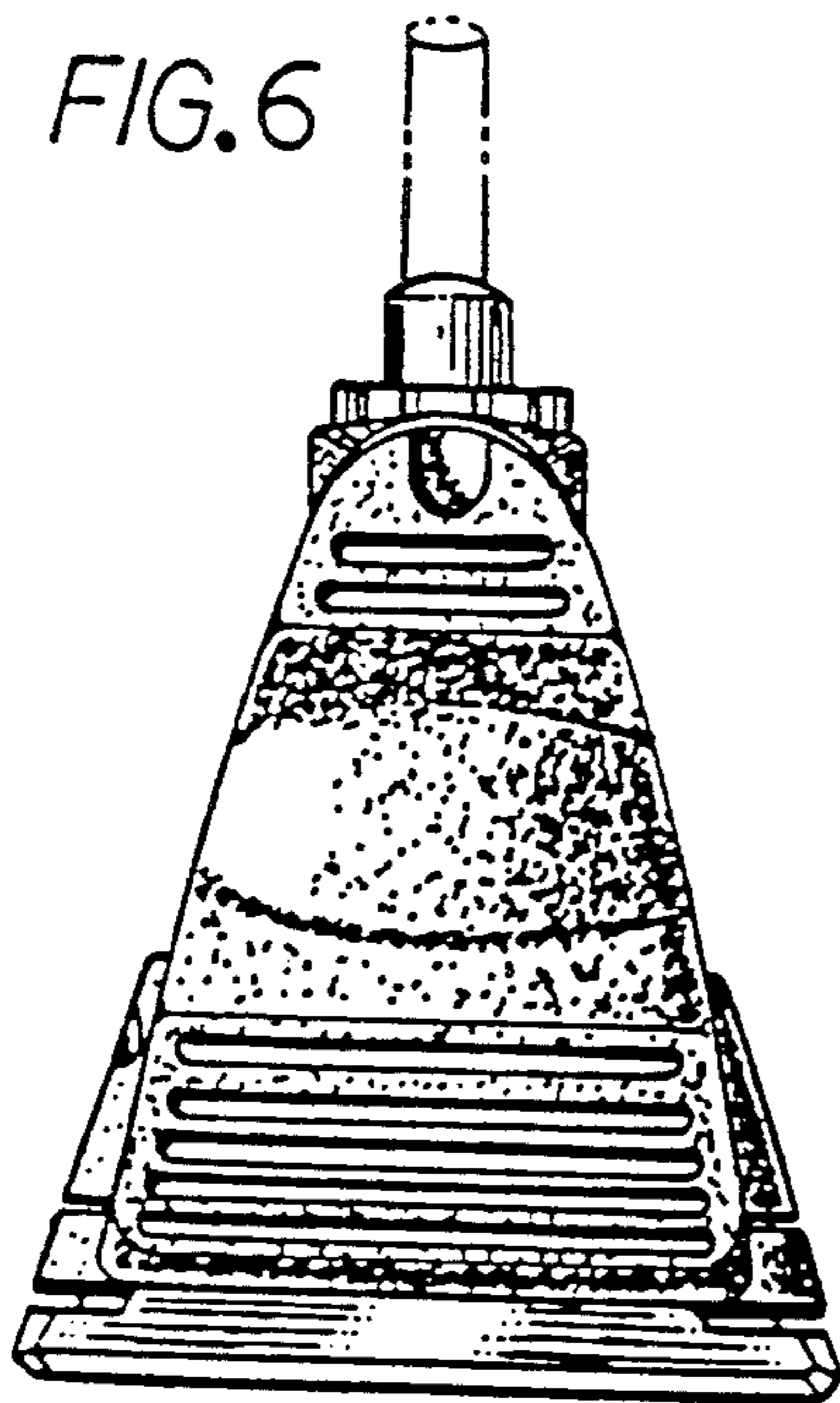
