The ornamental design for a paper tray, as shown and described.

### DESCRIPTION

FIG. 1 is a top, left front perspective view of a paper tray showing our new design;

FIG. 2 is a right side elevational view, the left side being a mirror image thereof;

FIG. 3 is a top plan view;

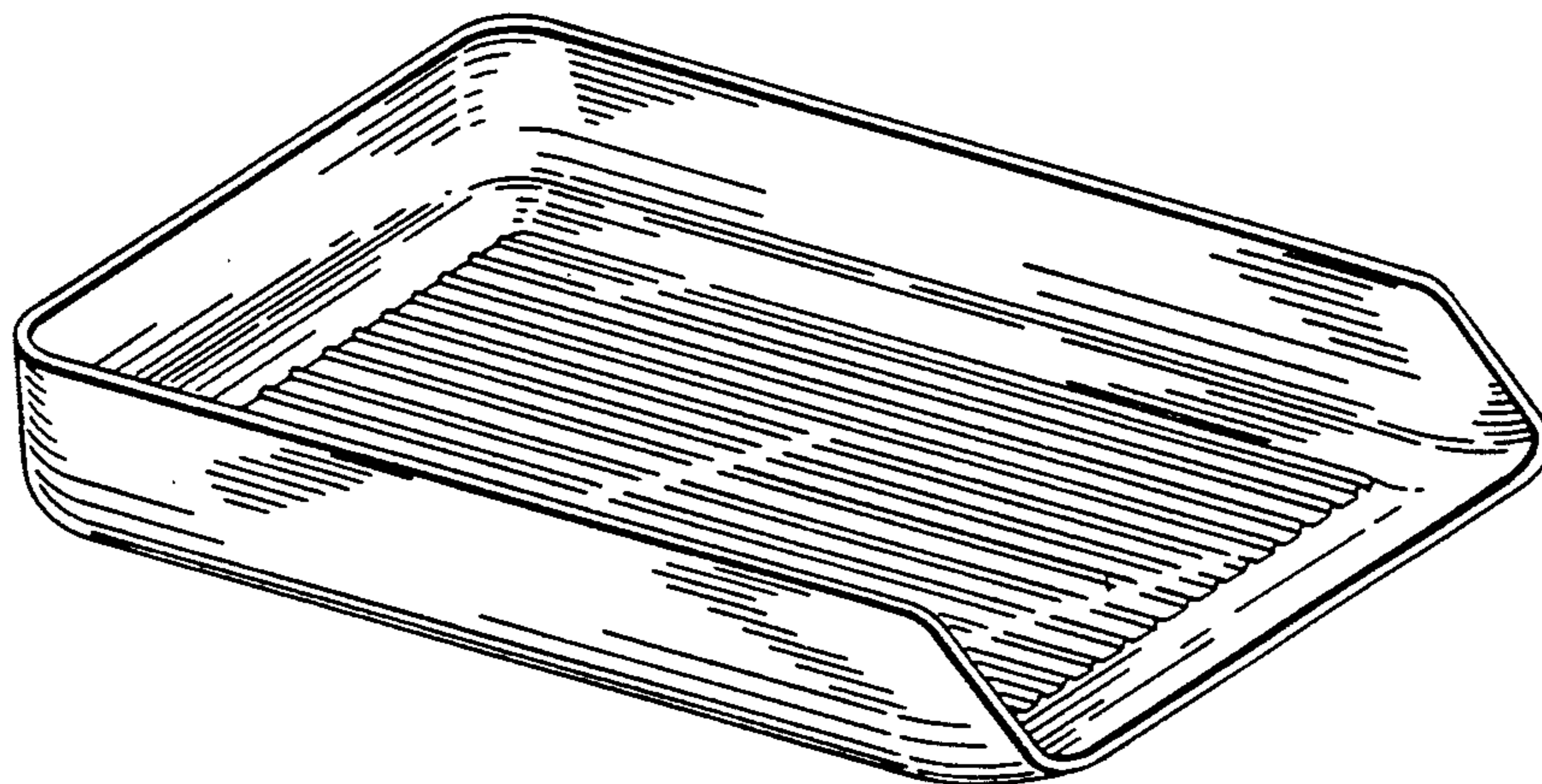
FIG. 4 is a front elevational view;

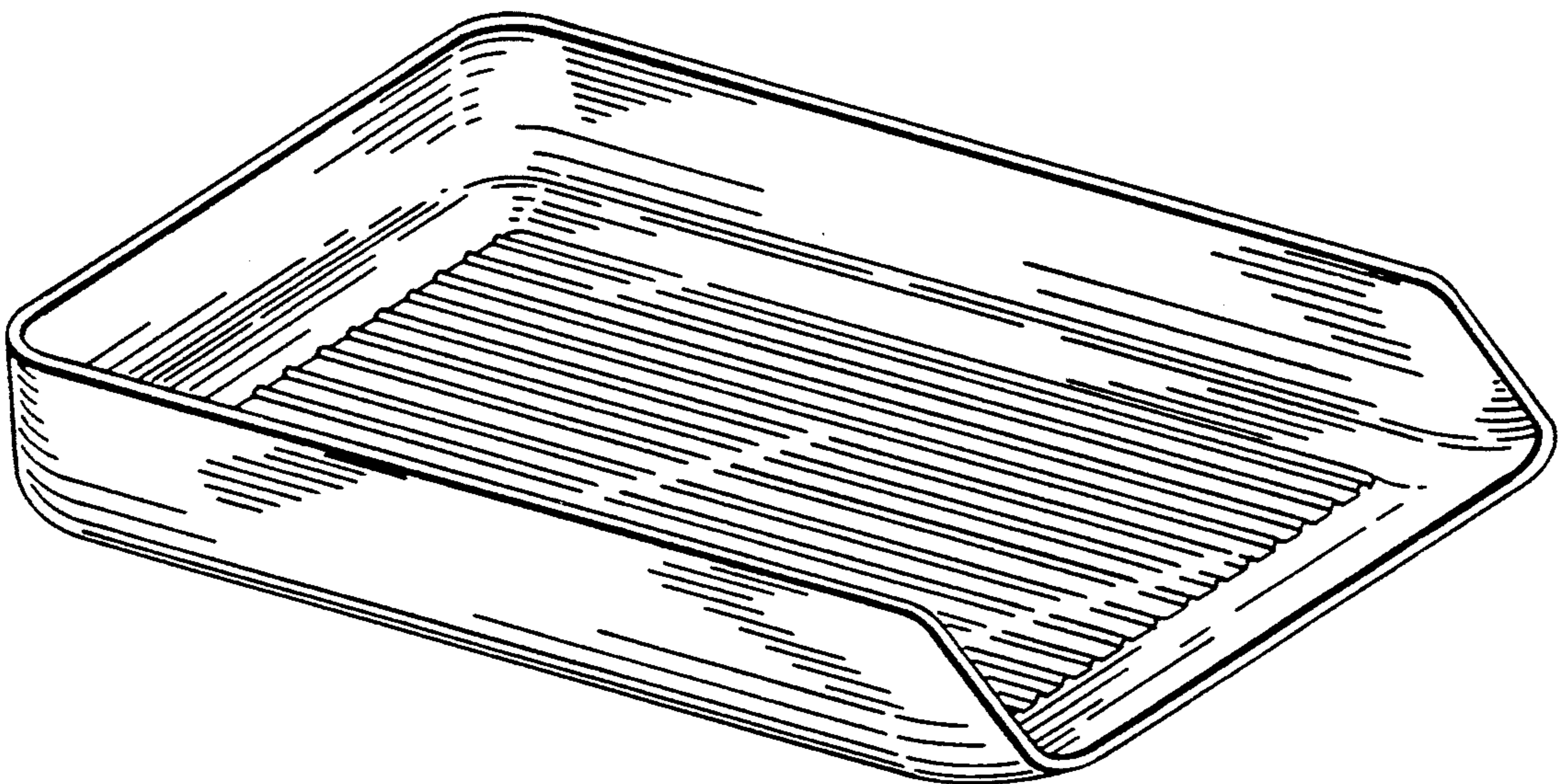
FIG. 5 is a bottom plan view;

FIG. 6 is a rear elevational view; and,

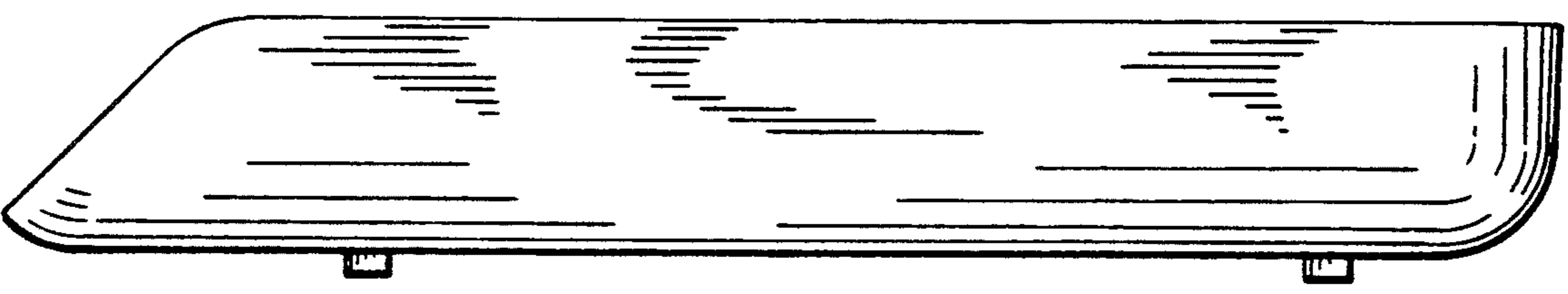
FIG. 7 is a top, left front perspective view of a second embodiment of our new design.

FIGS. 1 and 7 have been drawn to a reduced scale with respect to FIGS. 2 through 6.

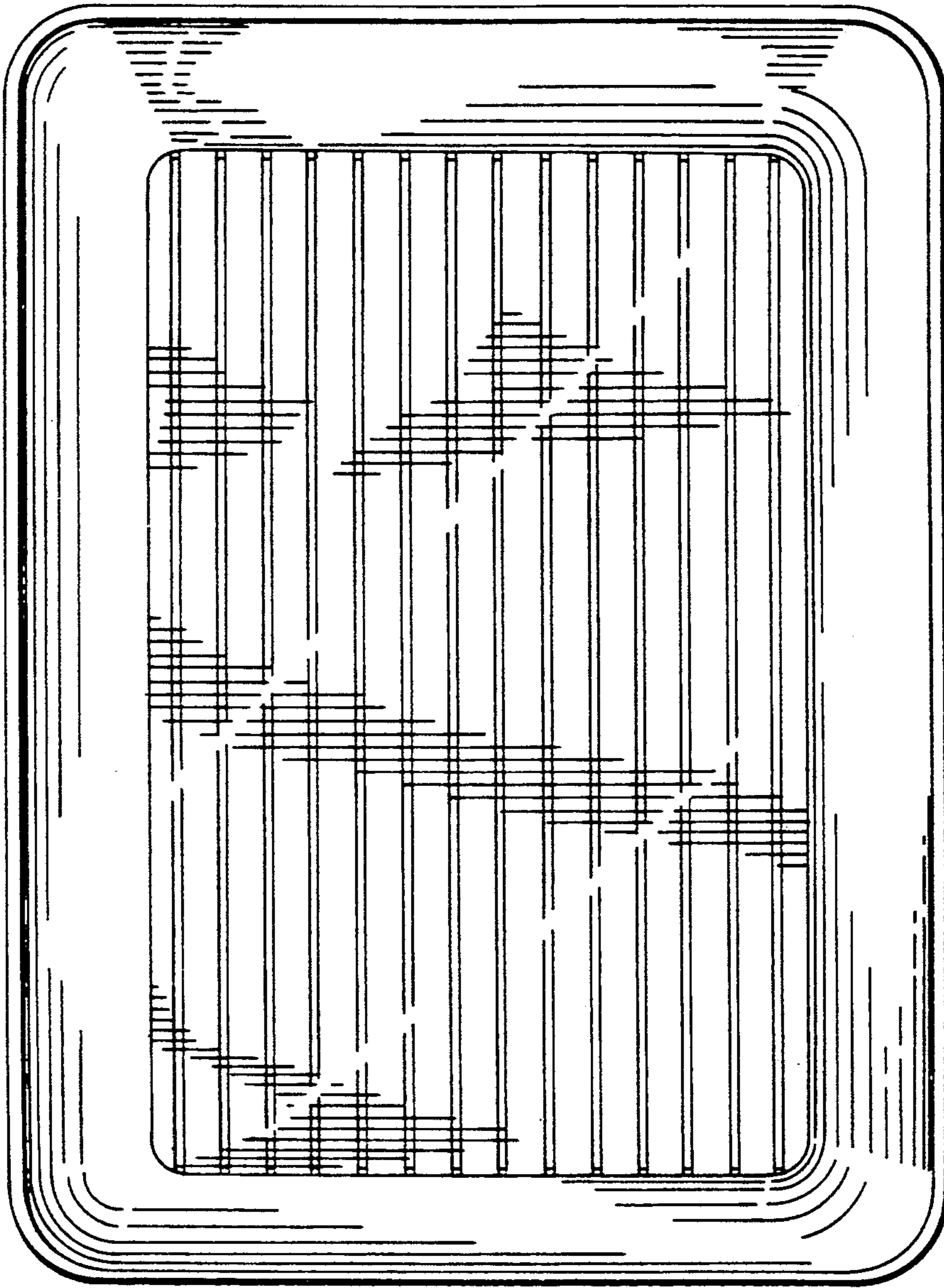




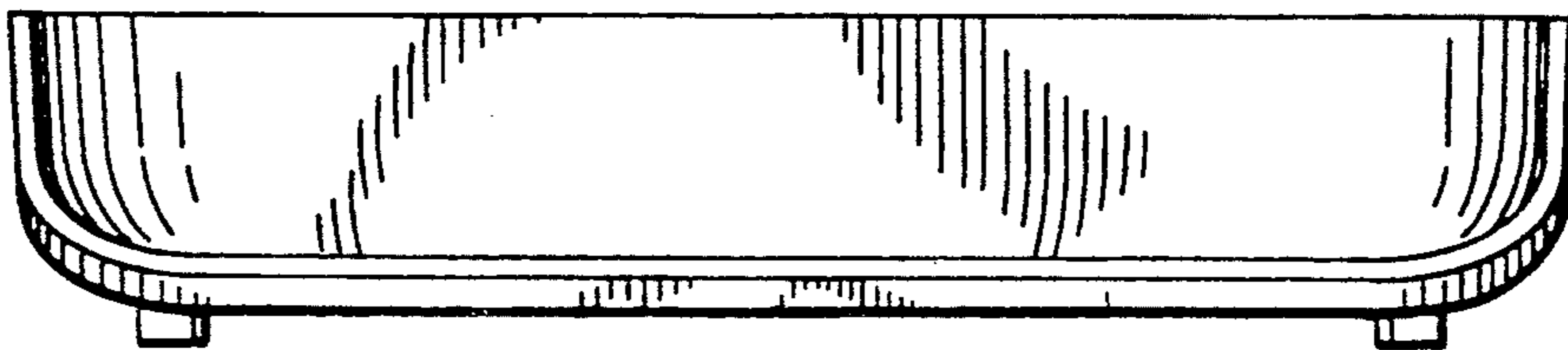

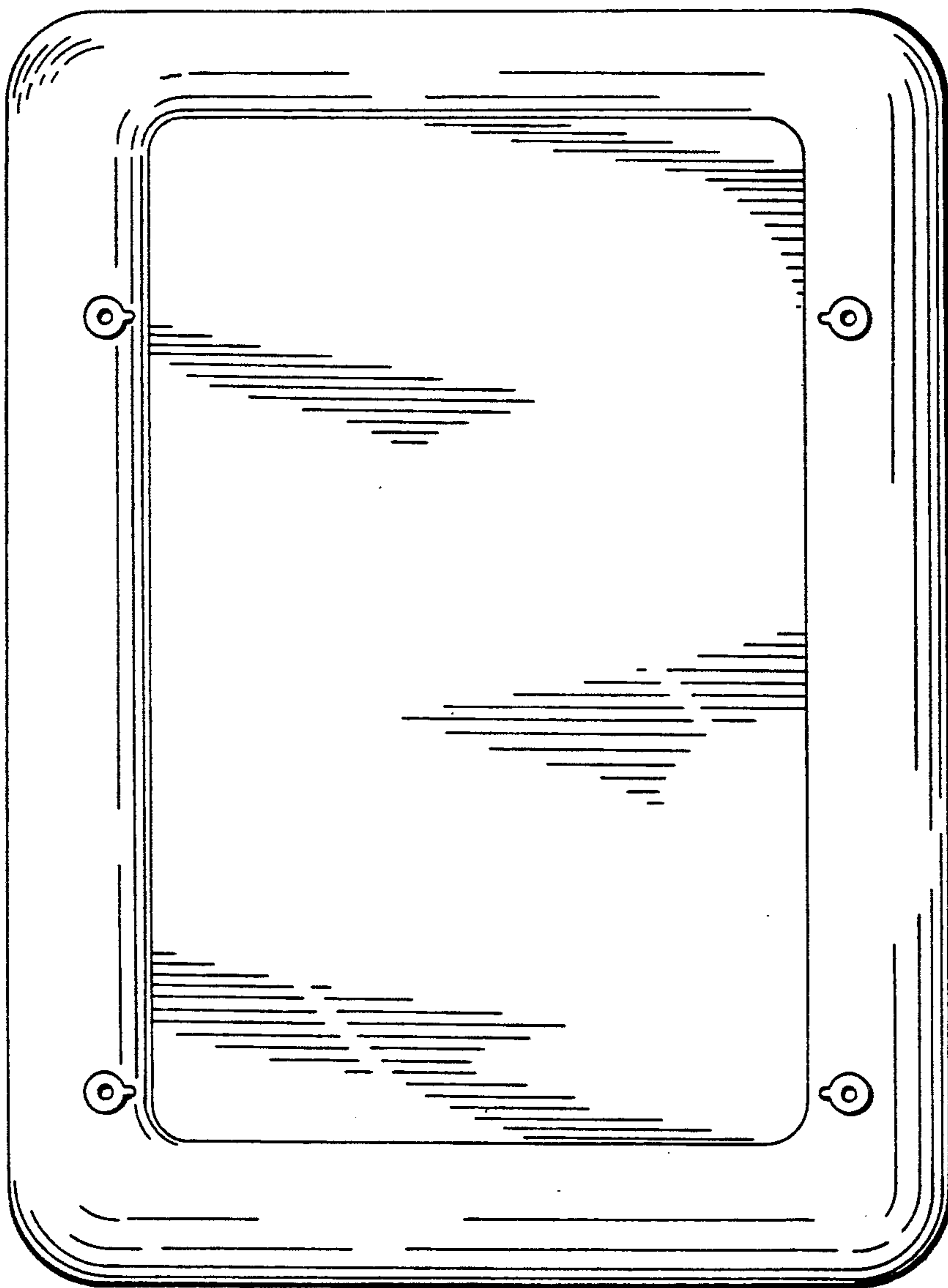

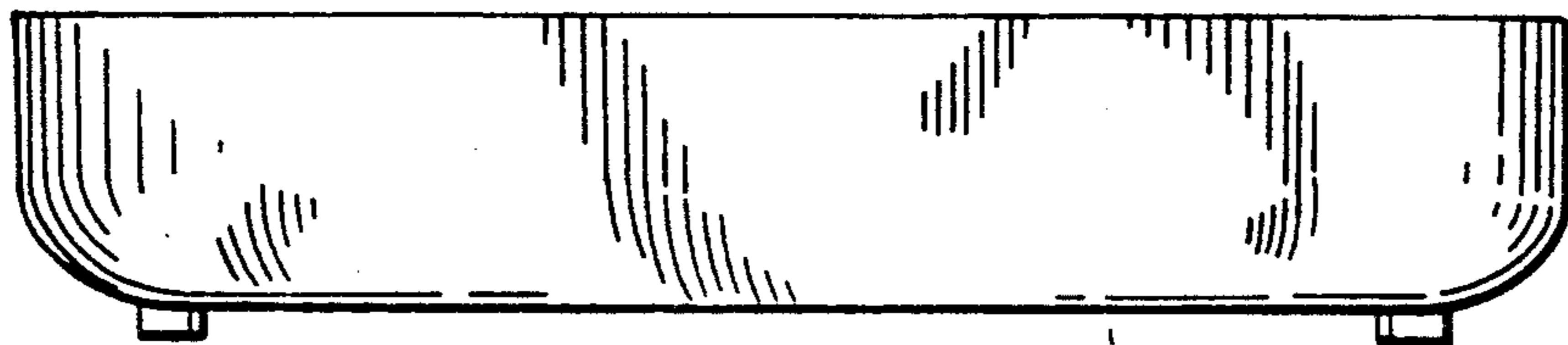

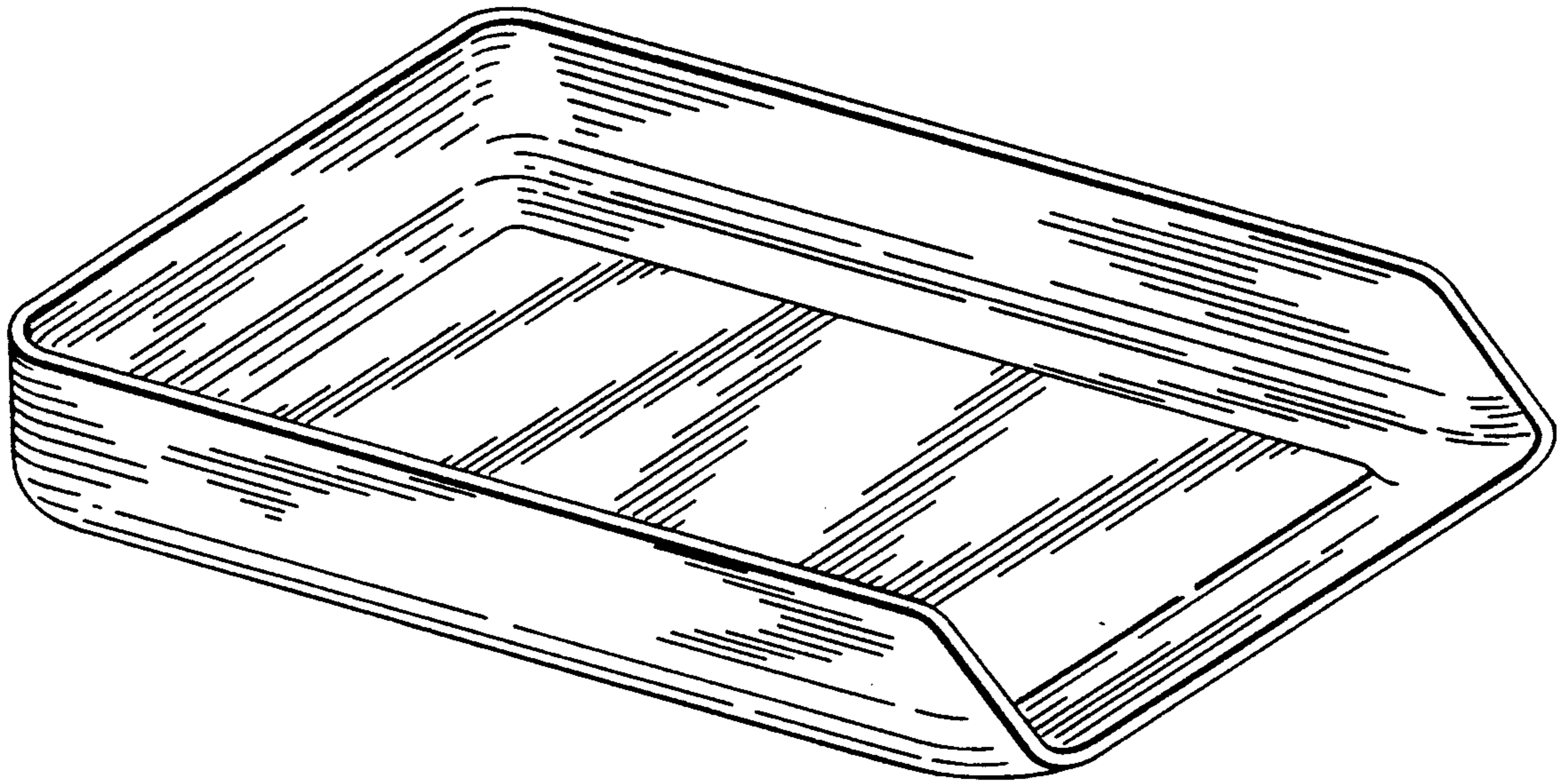
