The ornamental design for a chair, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a chair showing my new design;
FIG. 2 is a front elevational view;
FIG. 3 is a right side elevational view;
FIG. 4 is a left side elevational view;
FIG. 5 is a rear elevational view;
FIG. 6 is a top plan view;
FIG. 7 is a bottom plan view;
FIG. 8 is a front perspective view of a chair showing a second embodiment of my new design;

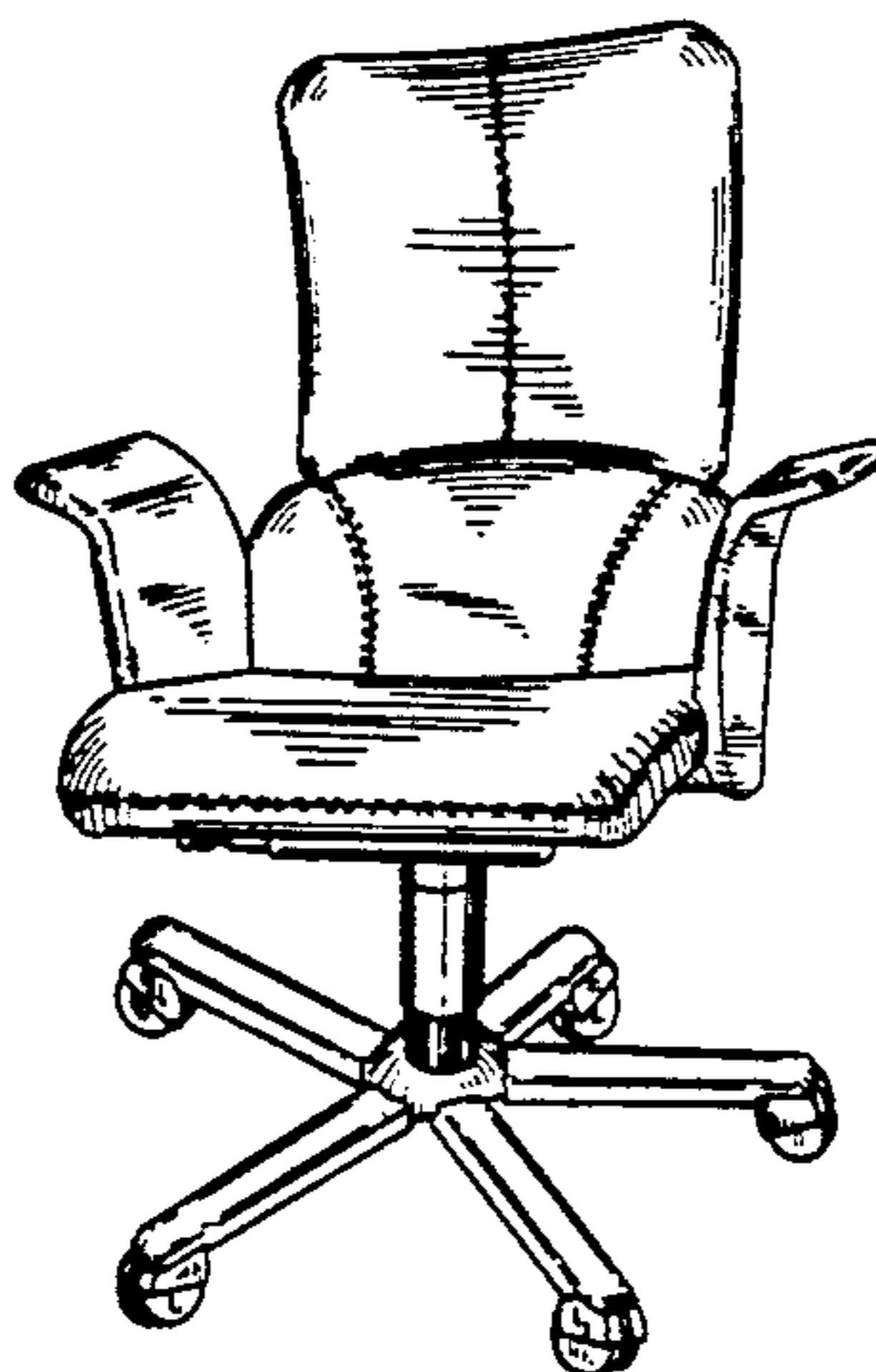


FIG. 9 is a front elevational view of FIG. 8;

The broken lines showing in FIGS. 1-6 and 8-13 represent stitching.

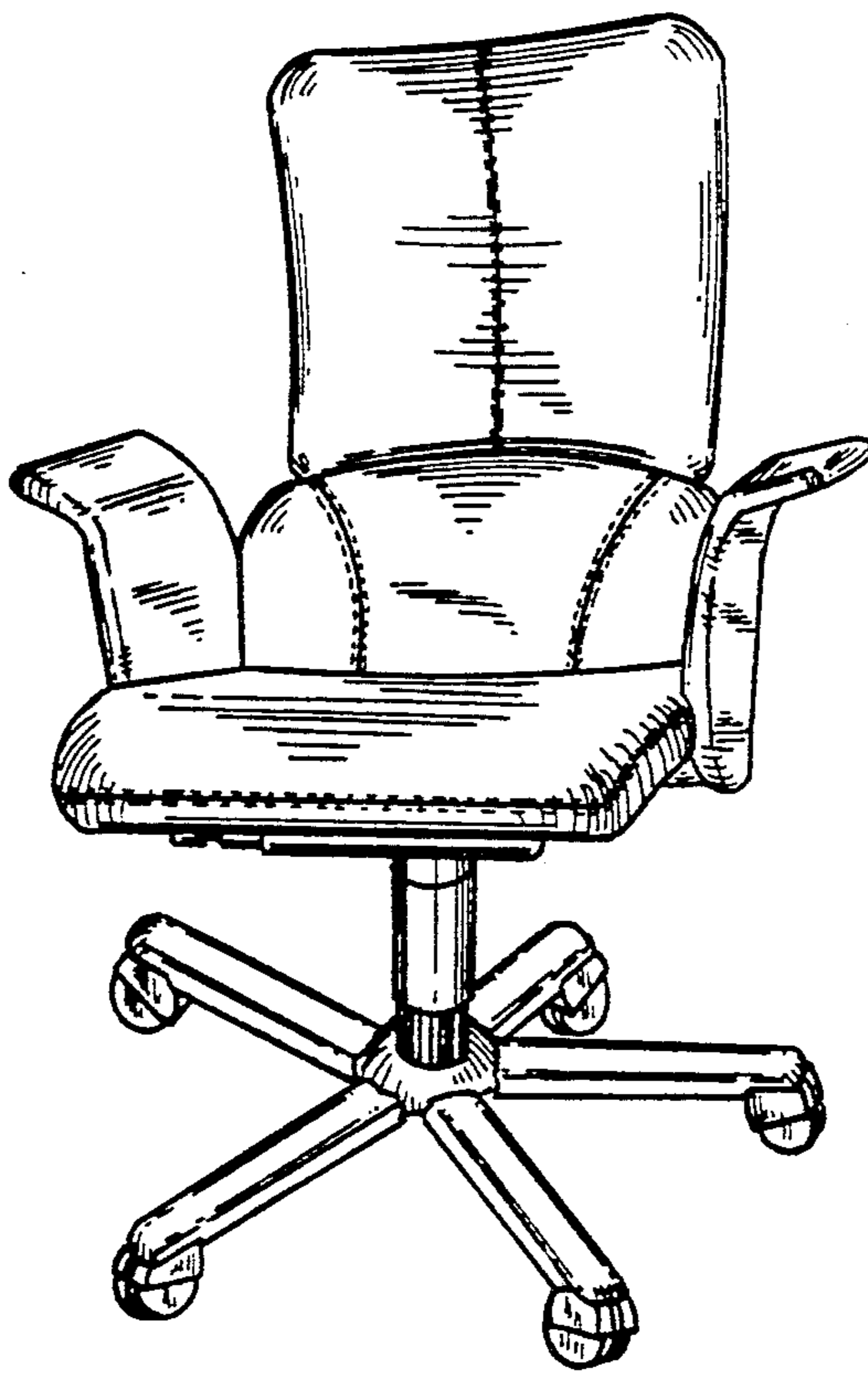

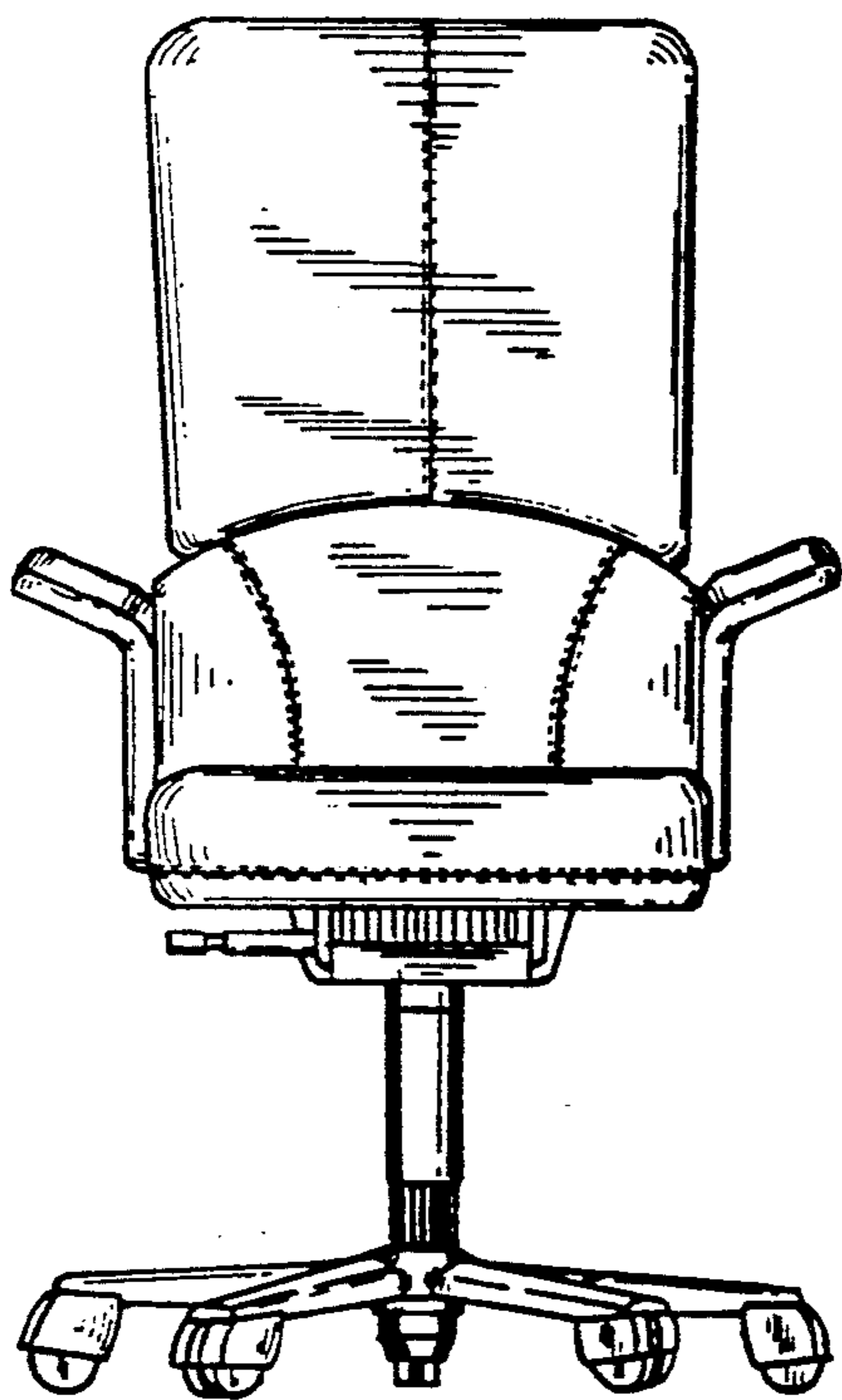

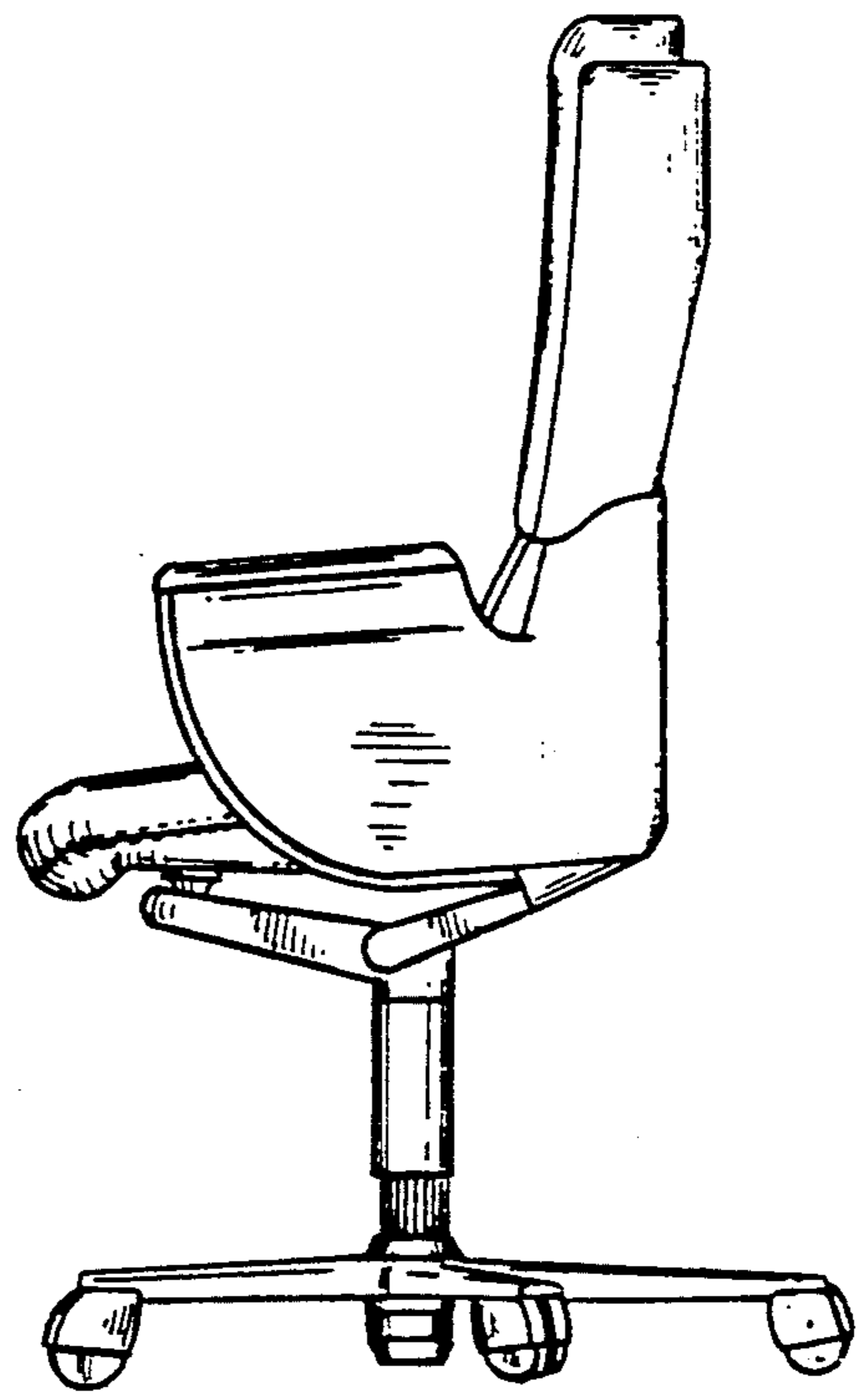

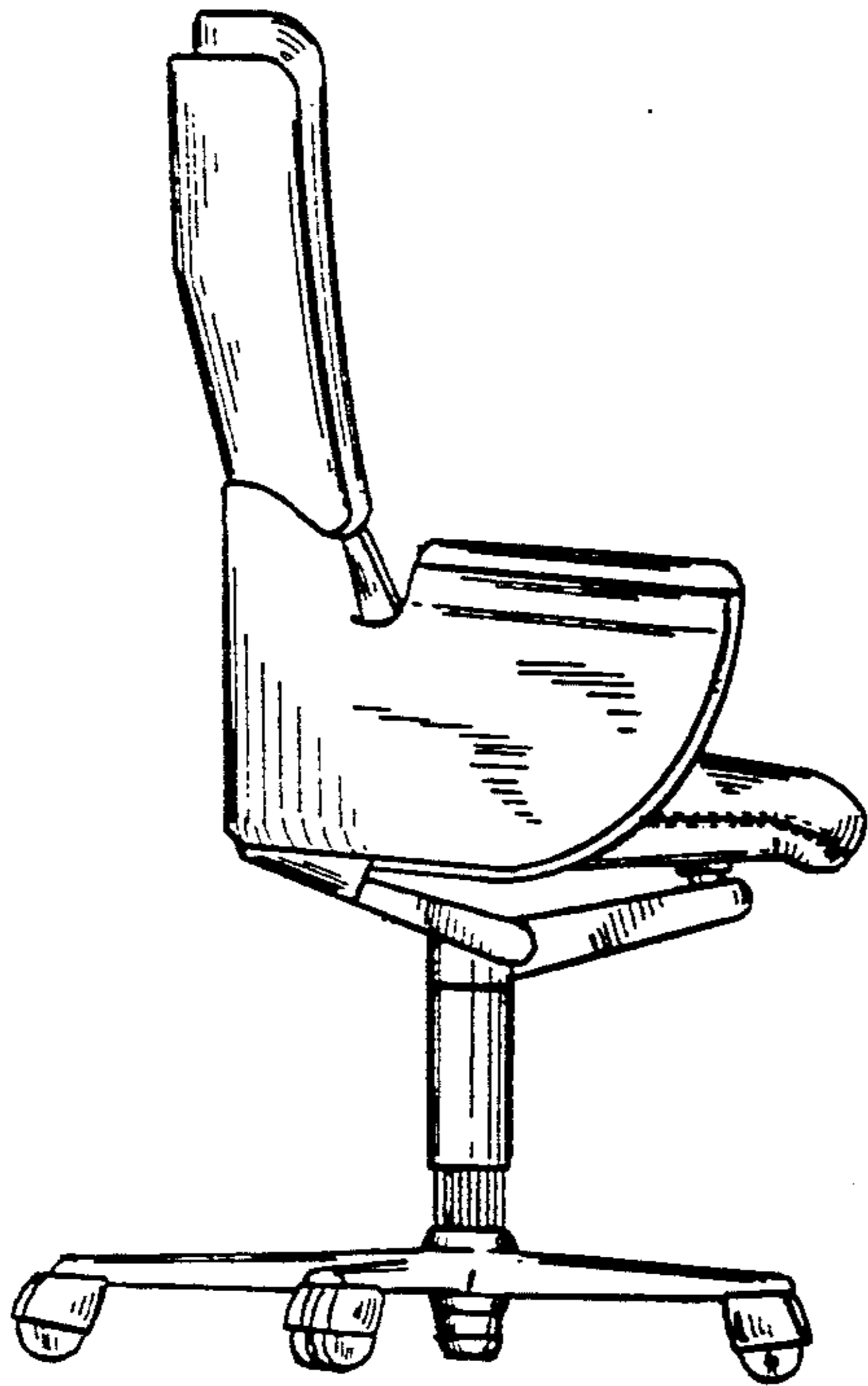

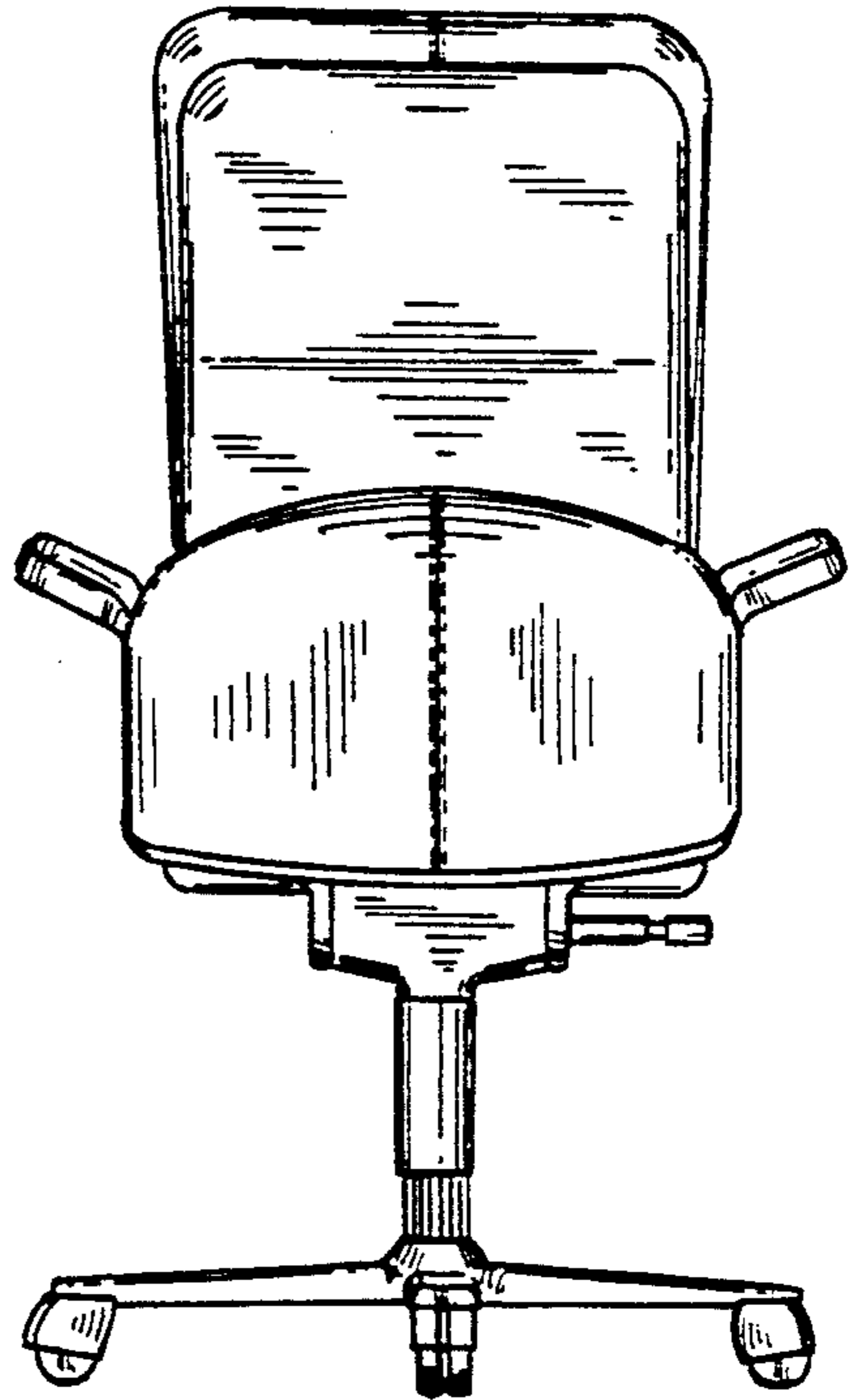

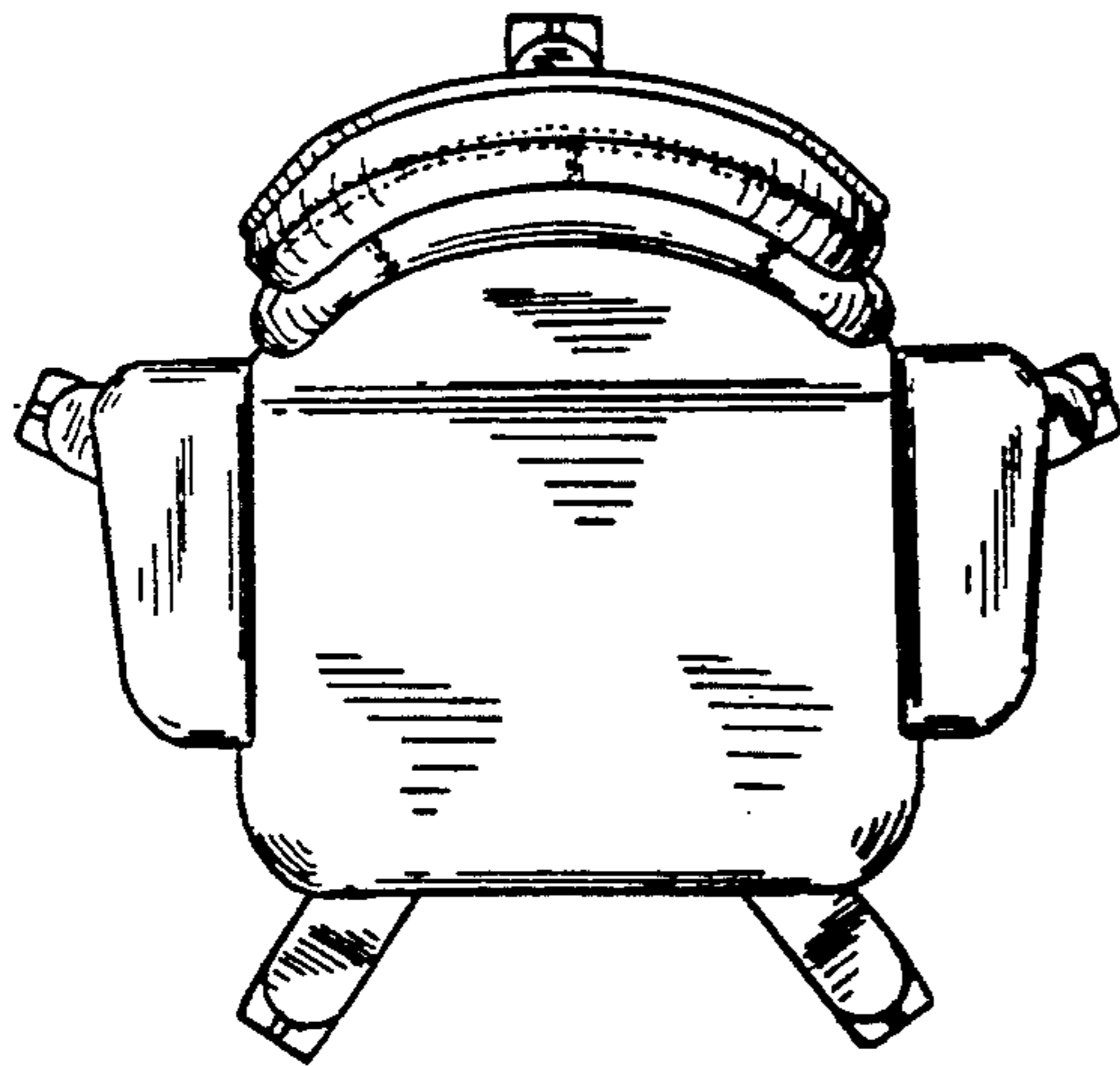

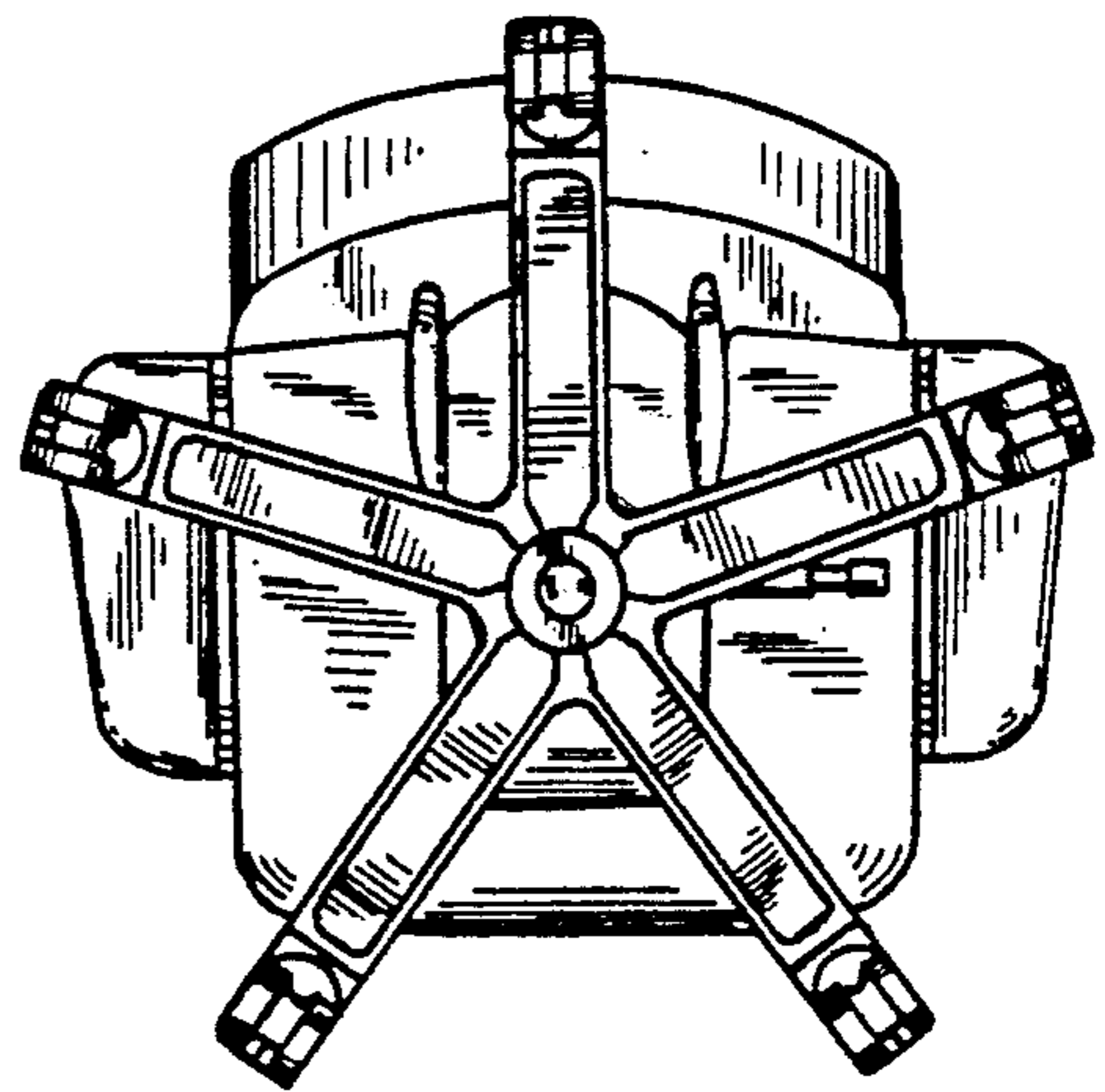

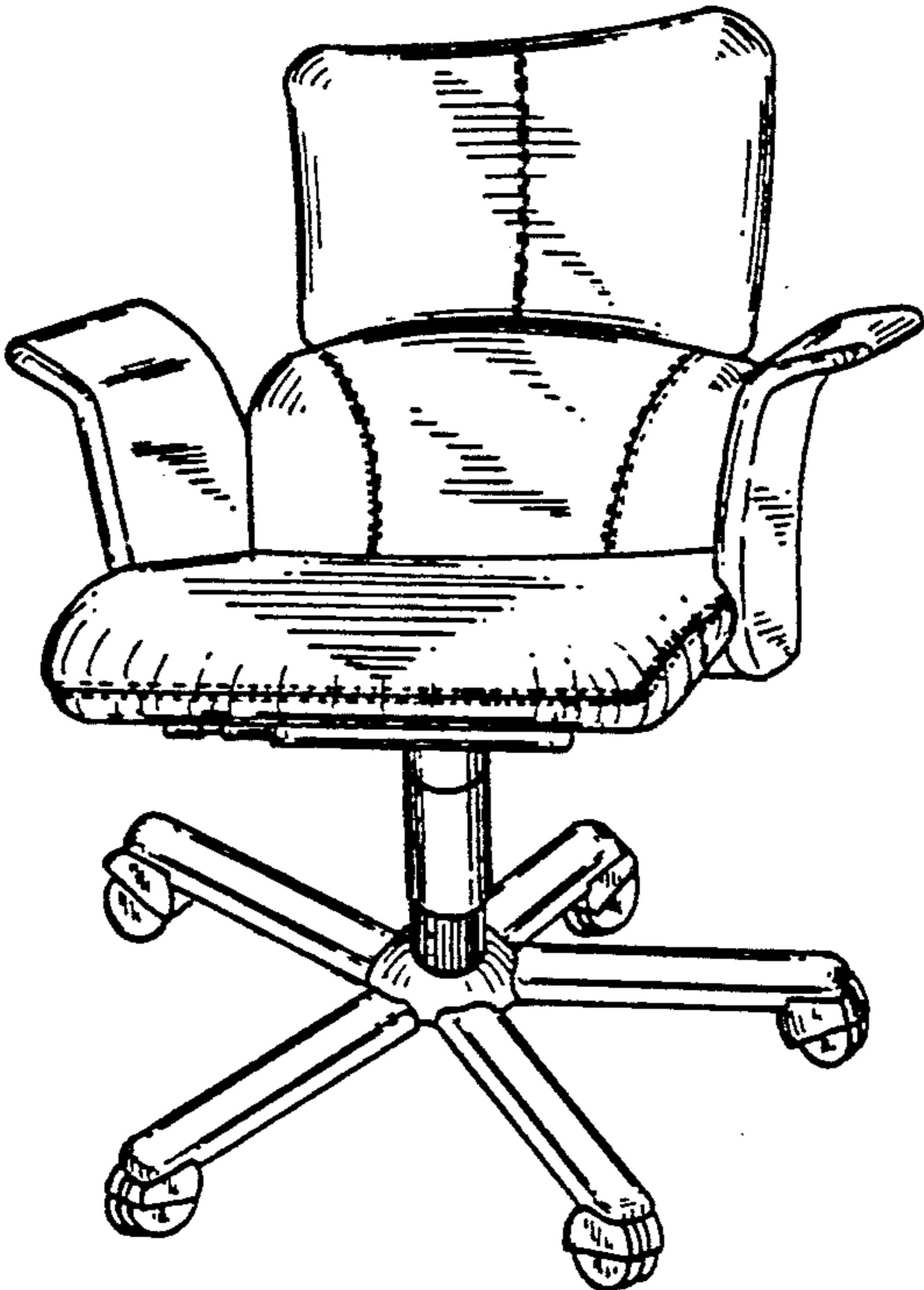

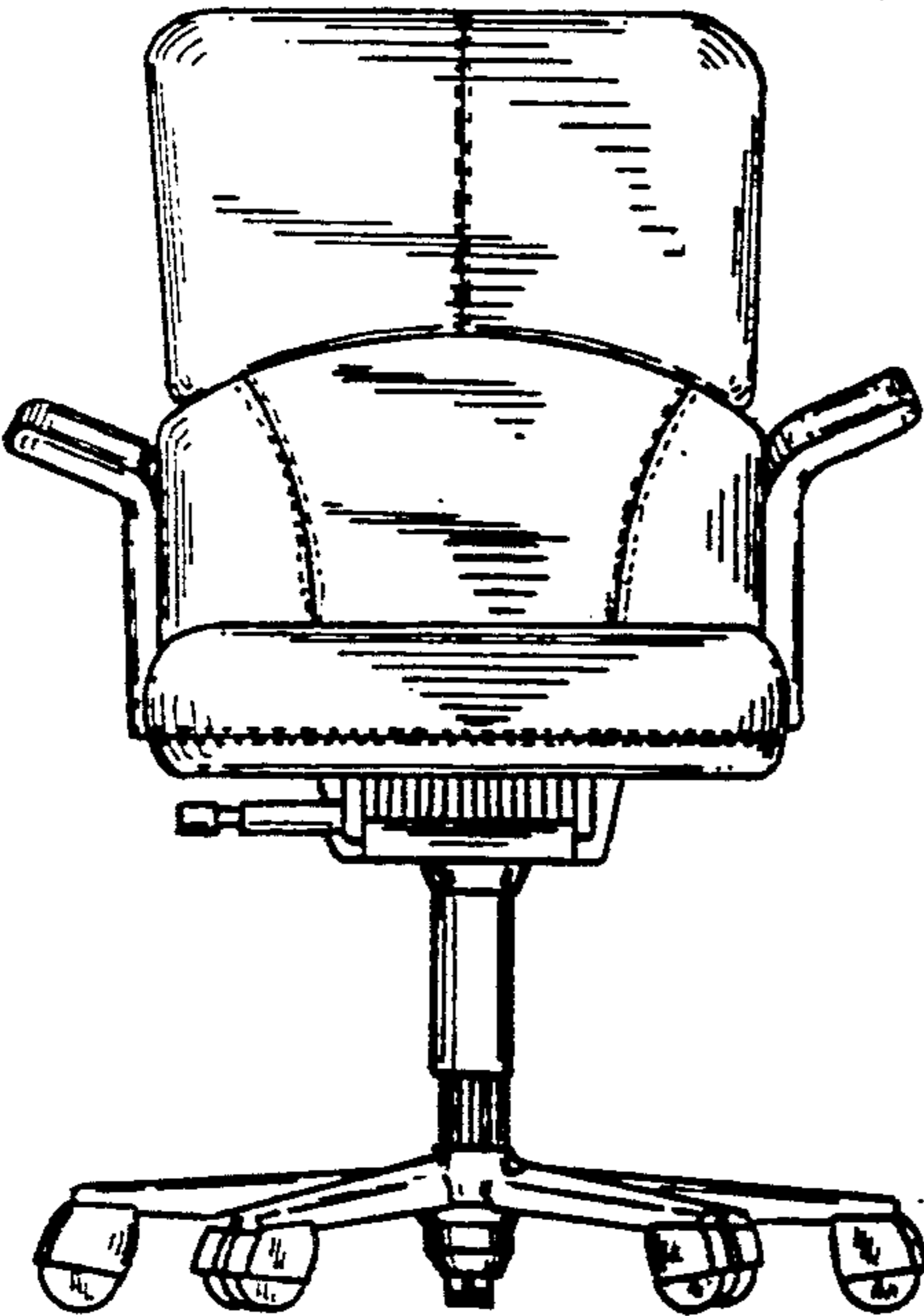

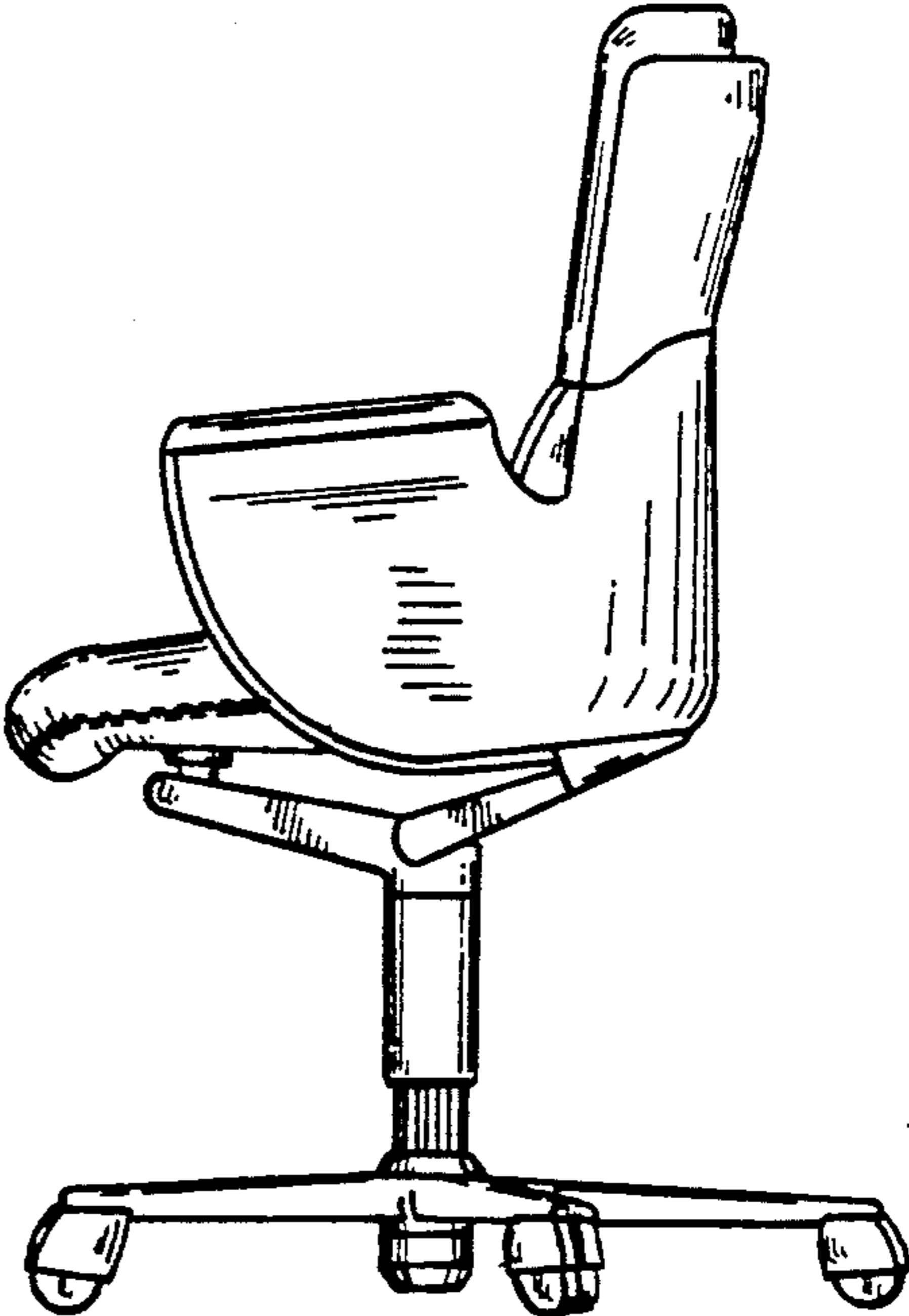

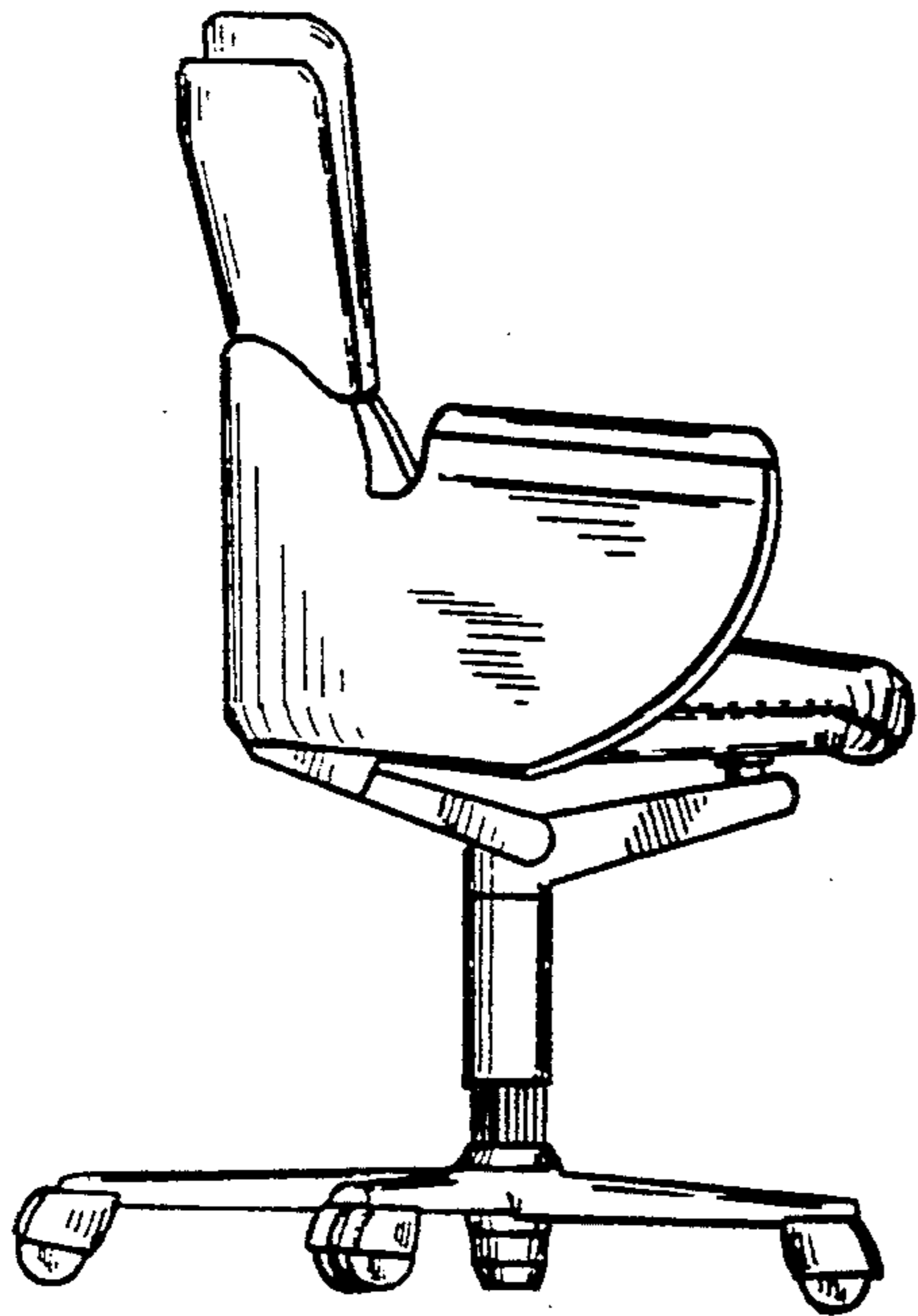

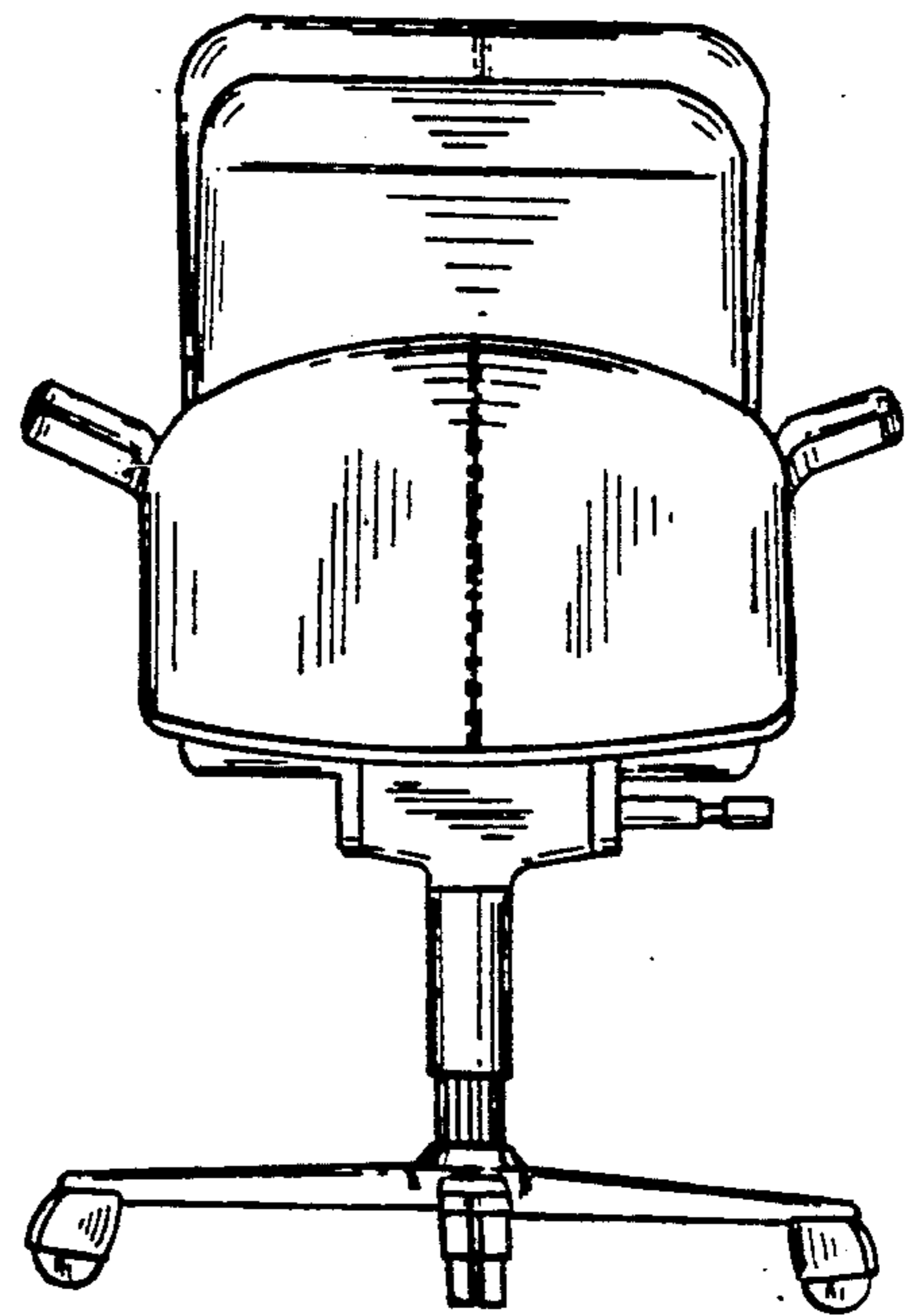

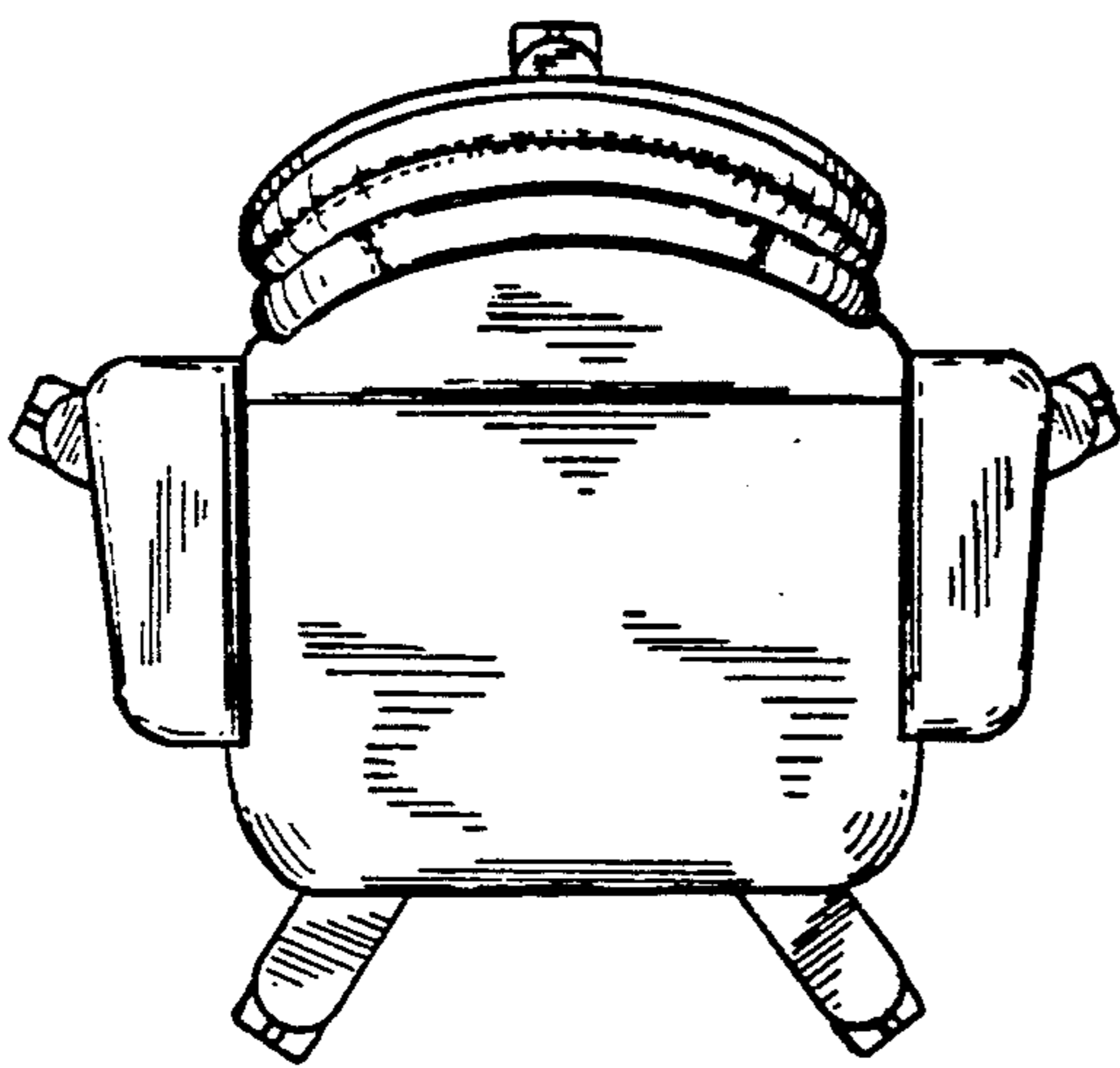

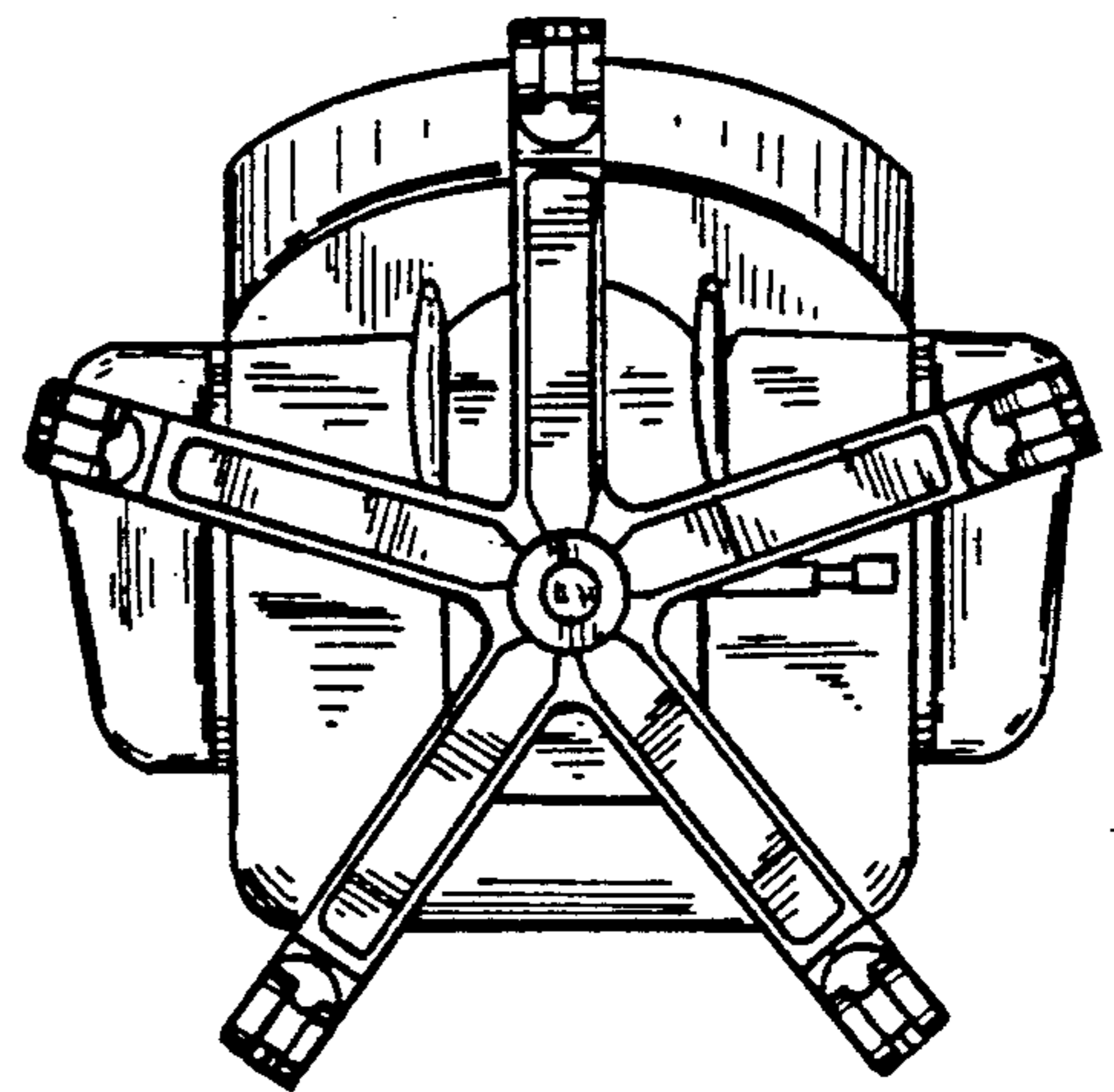
