[57] CLAIM

The ornamental design for a clip-hanger for suspending articles from walls, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a clip hanger for suspending articles from walls; showing the first embodiment of our new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a right side elevational view thereof, the side opposite being a mirror image;
 FIG. 5 is a rear elevational view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is top plan view of a second embodiment thereof;
 FIG. 8 is a front elevational view thereof;
 FIG. 9 is a right side elevational view thereof, the side opposite being a mirror image;
 FIG. 10 is a rear elevational view thereof;

 FIG. 13 is a front elevational view thereof;

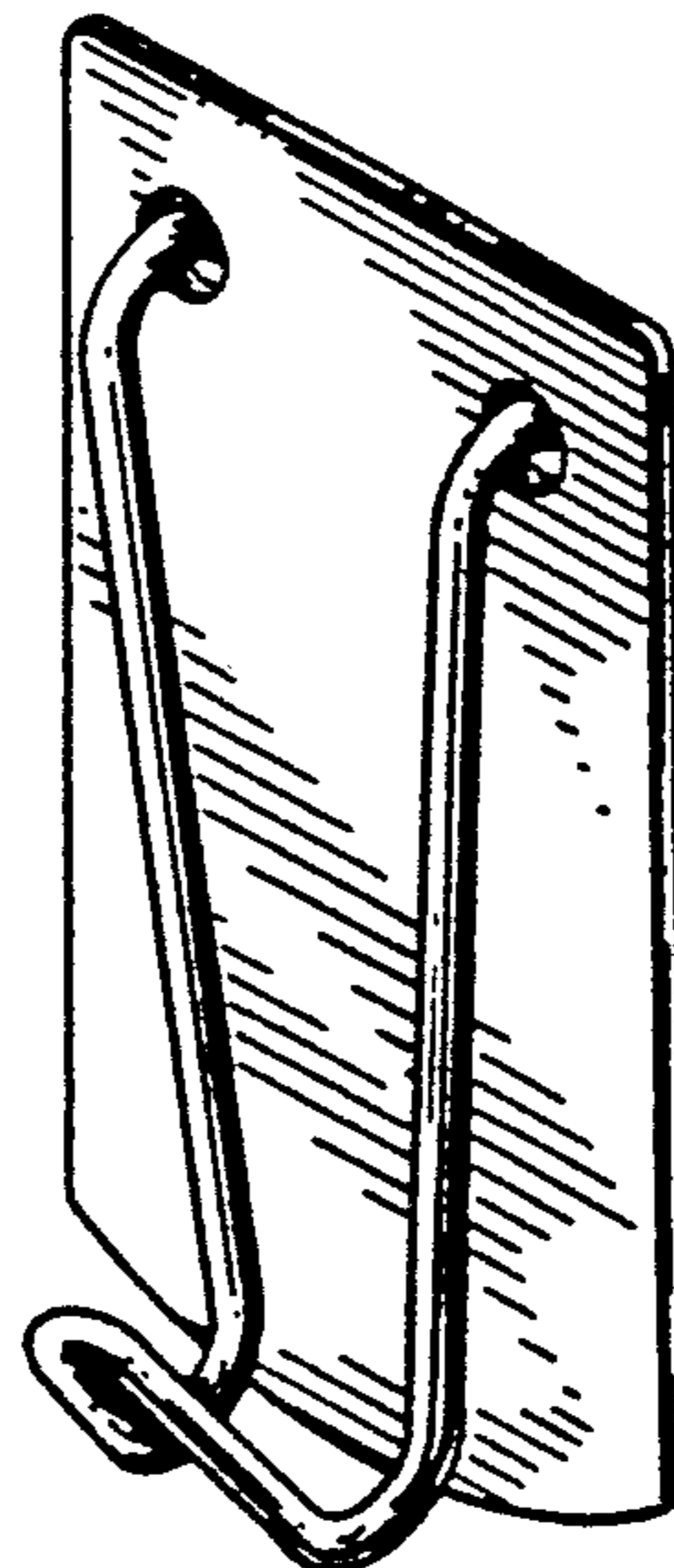

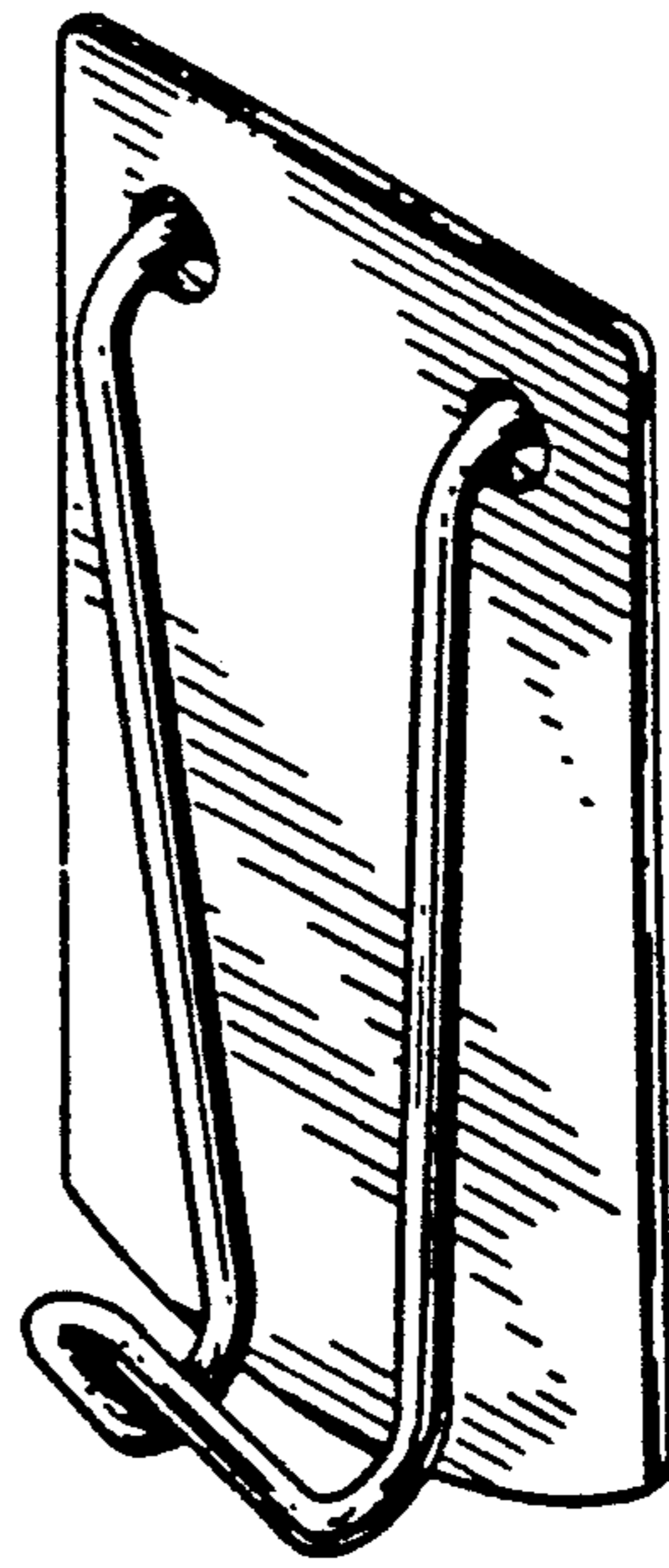

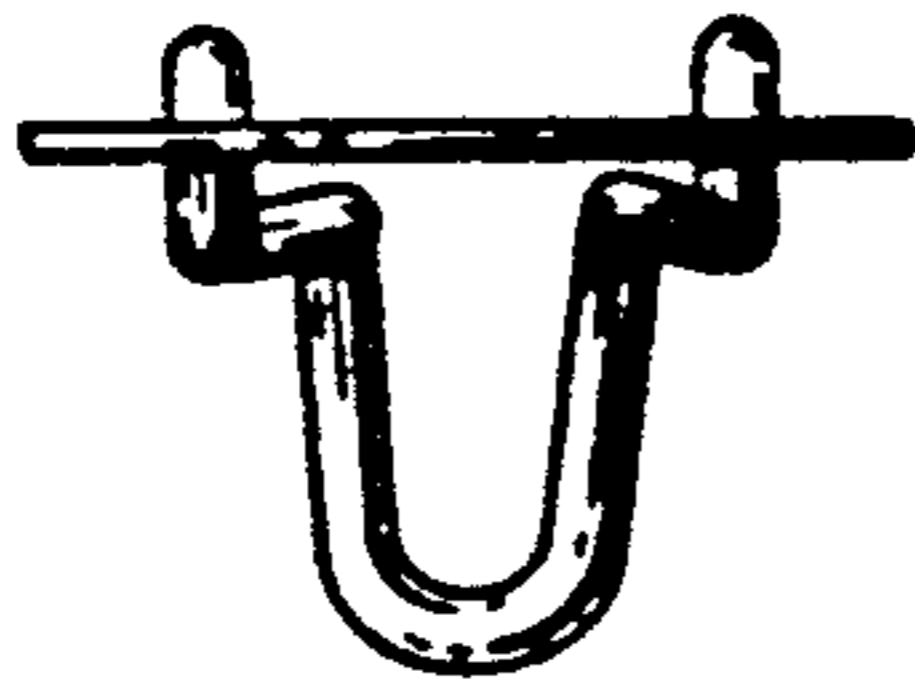

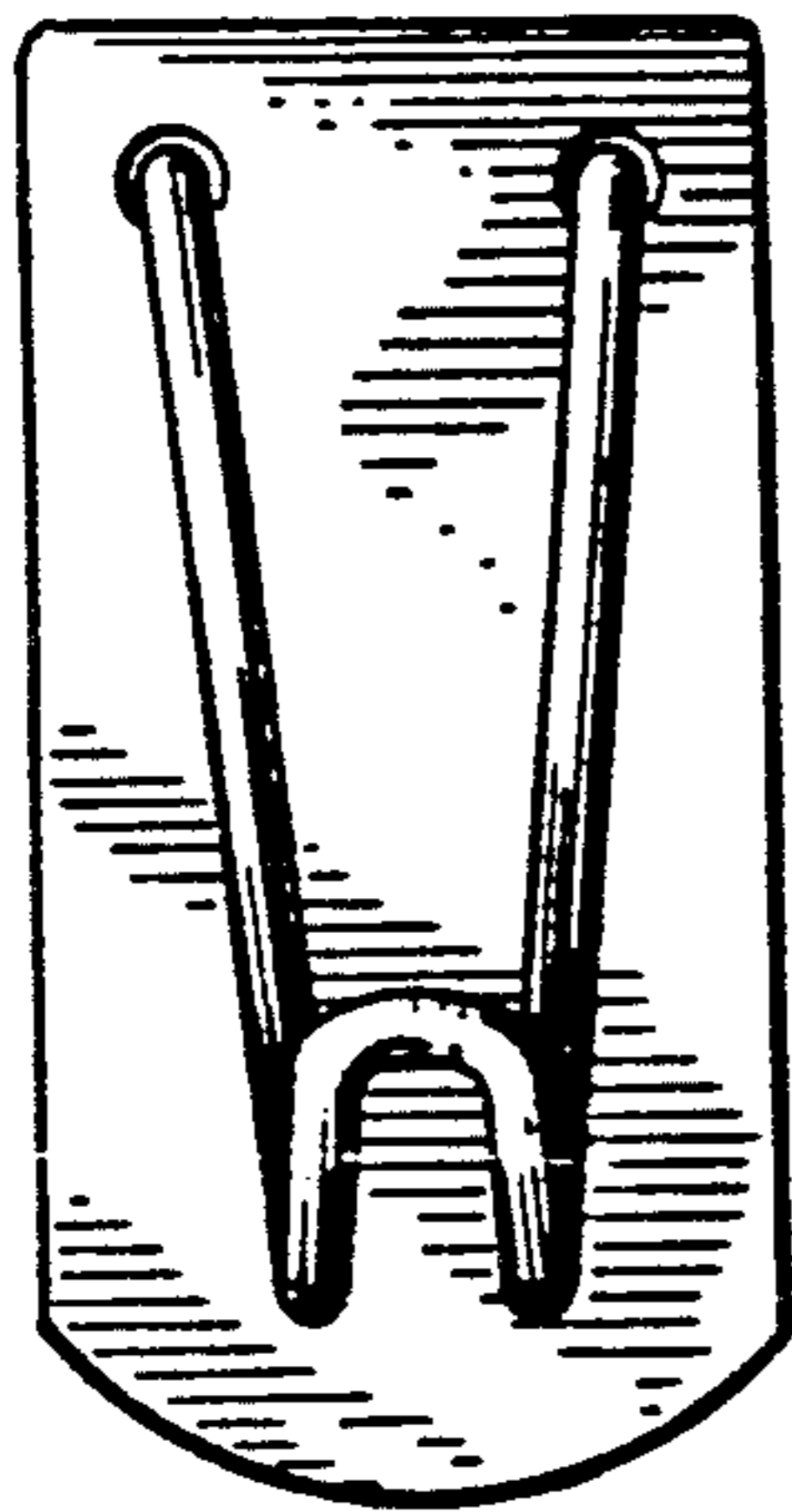

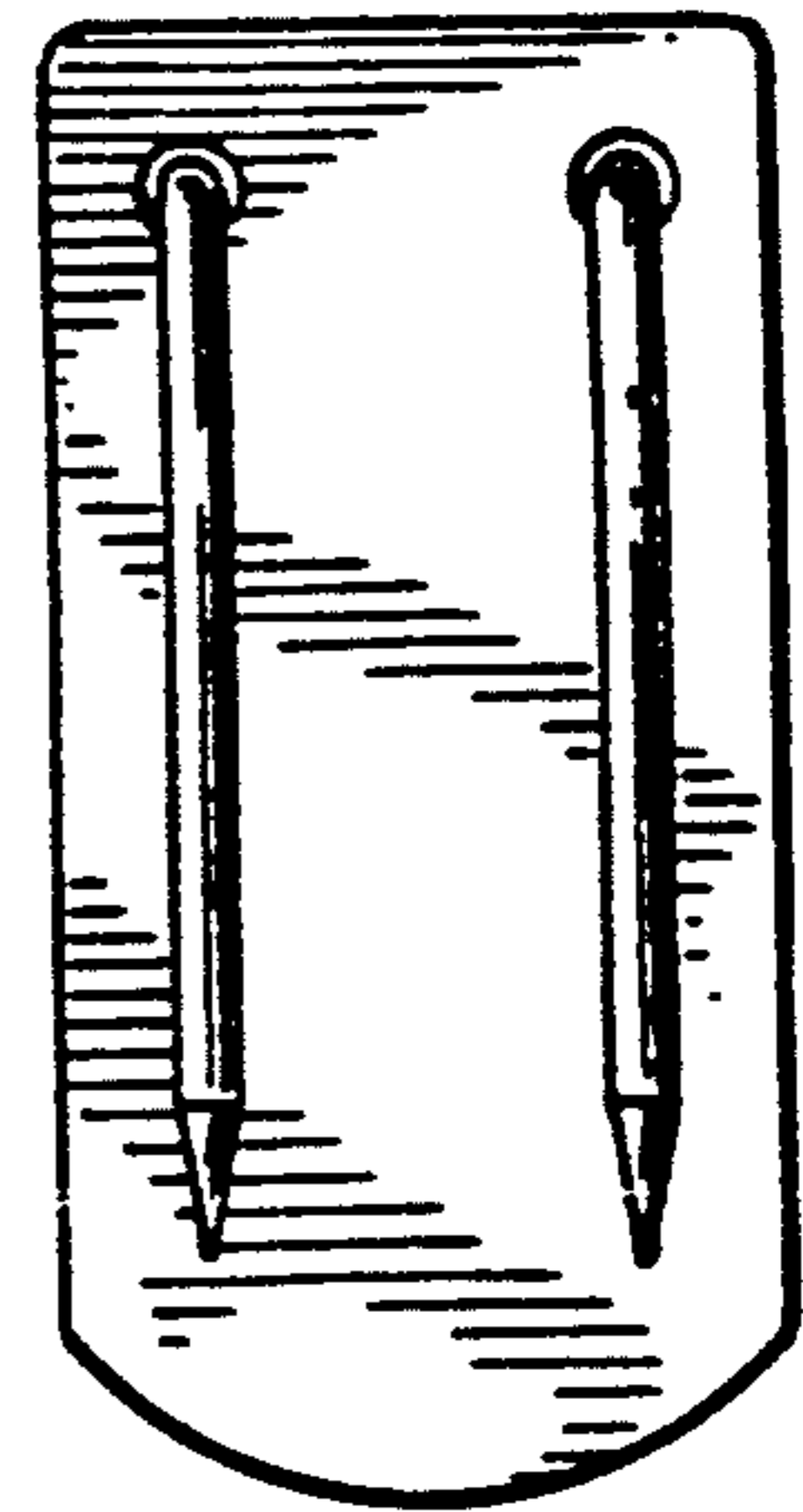

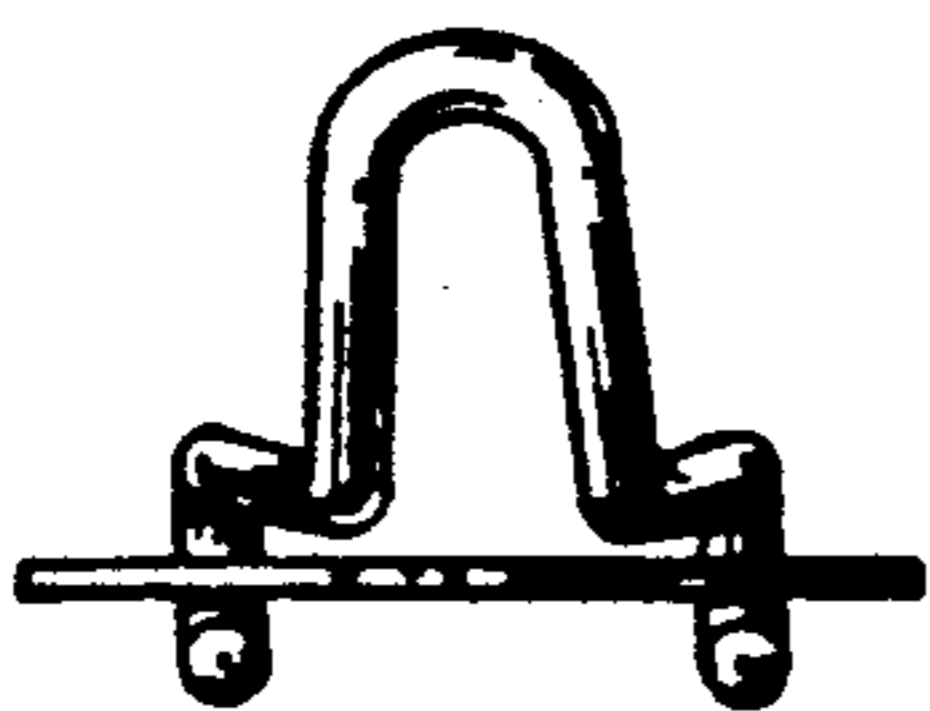

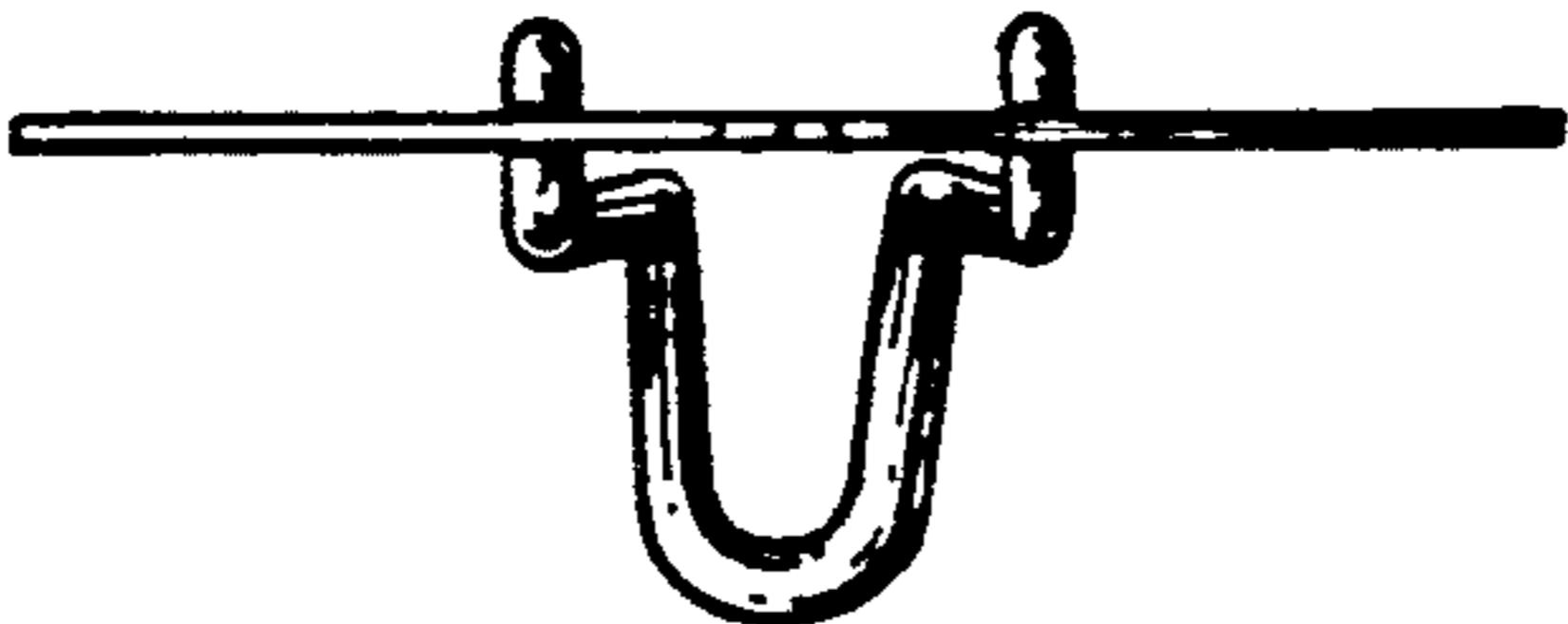

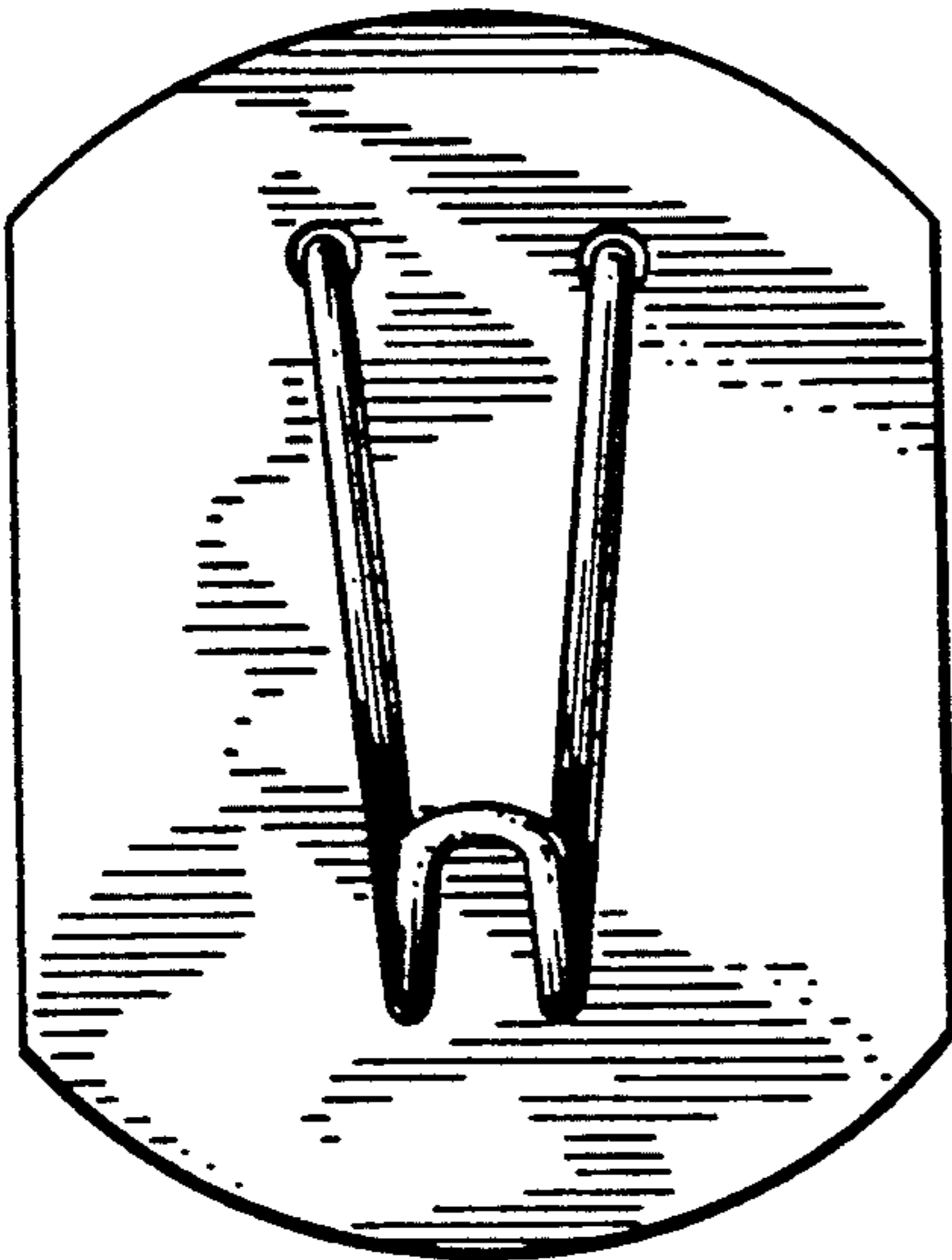

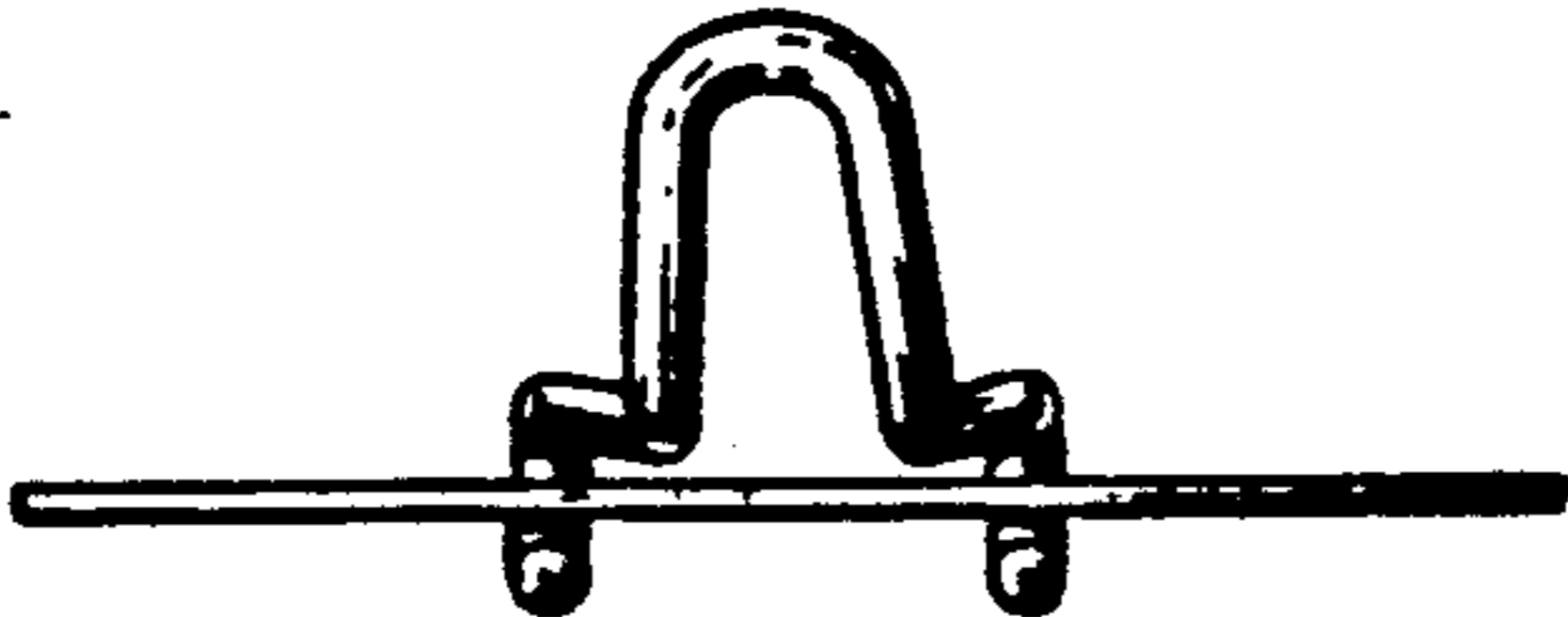

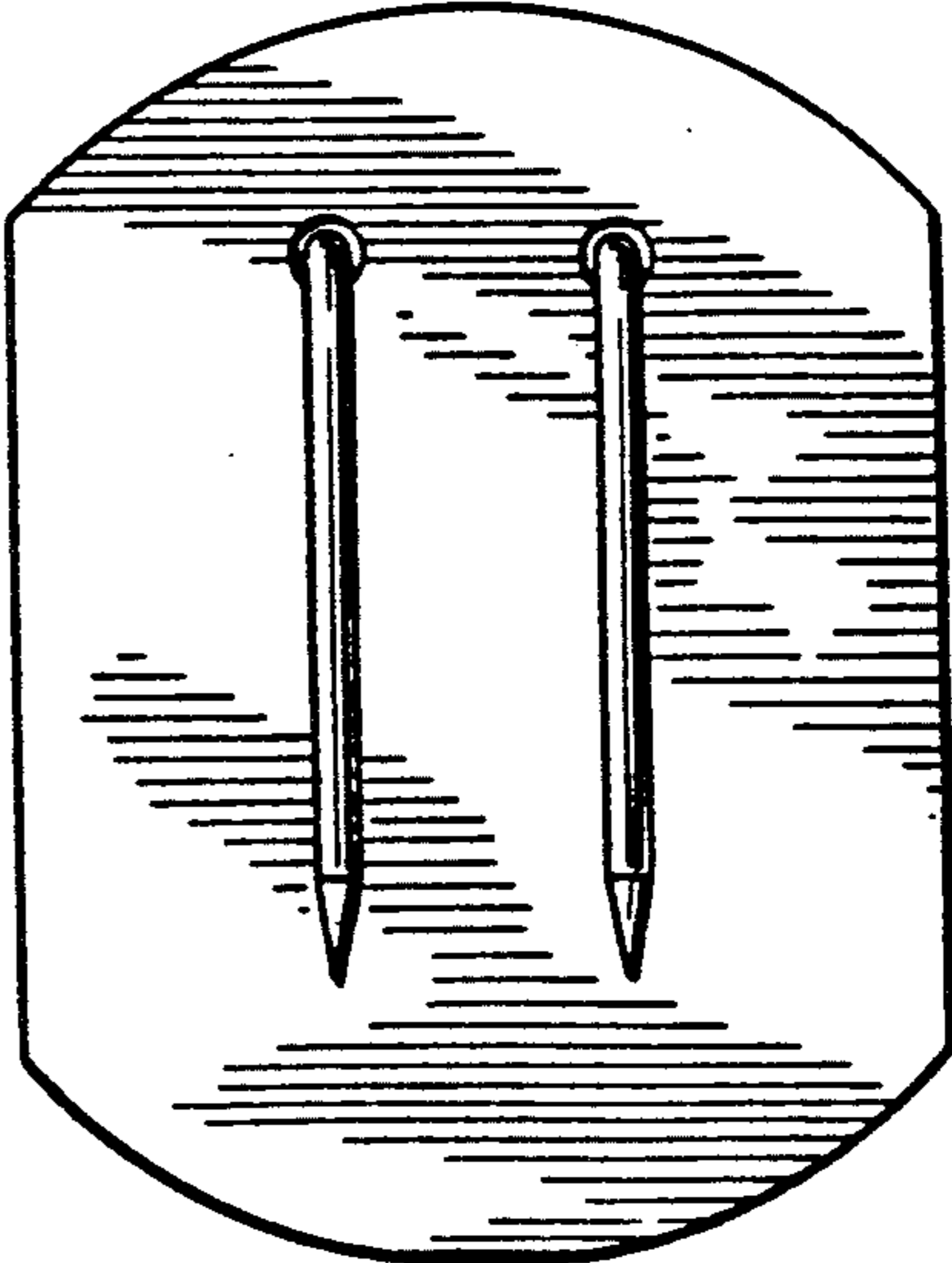

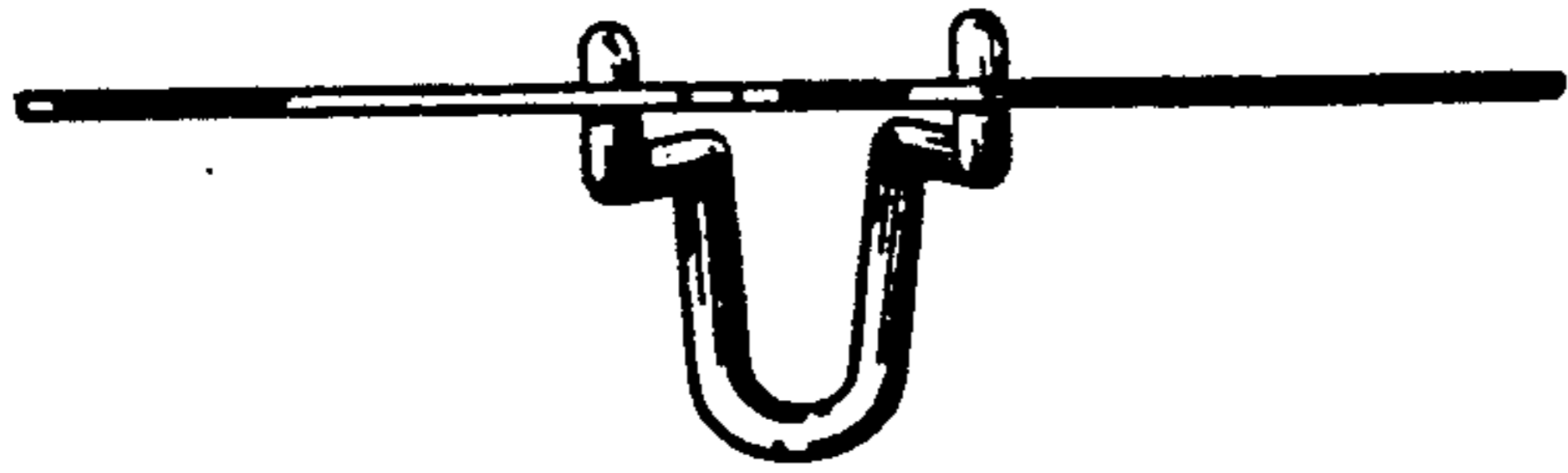

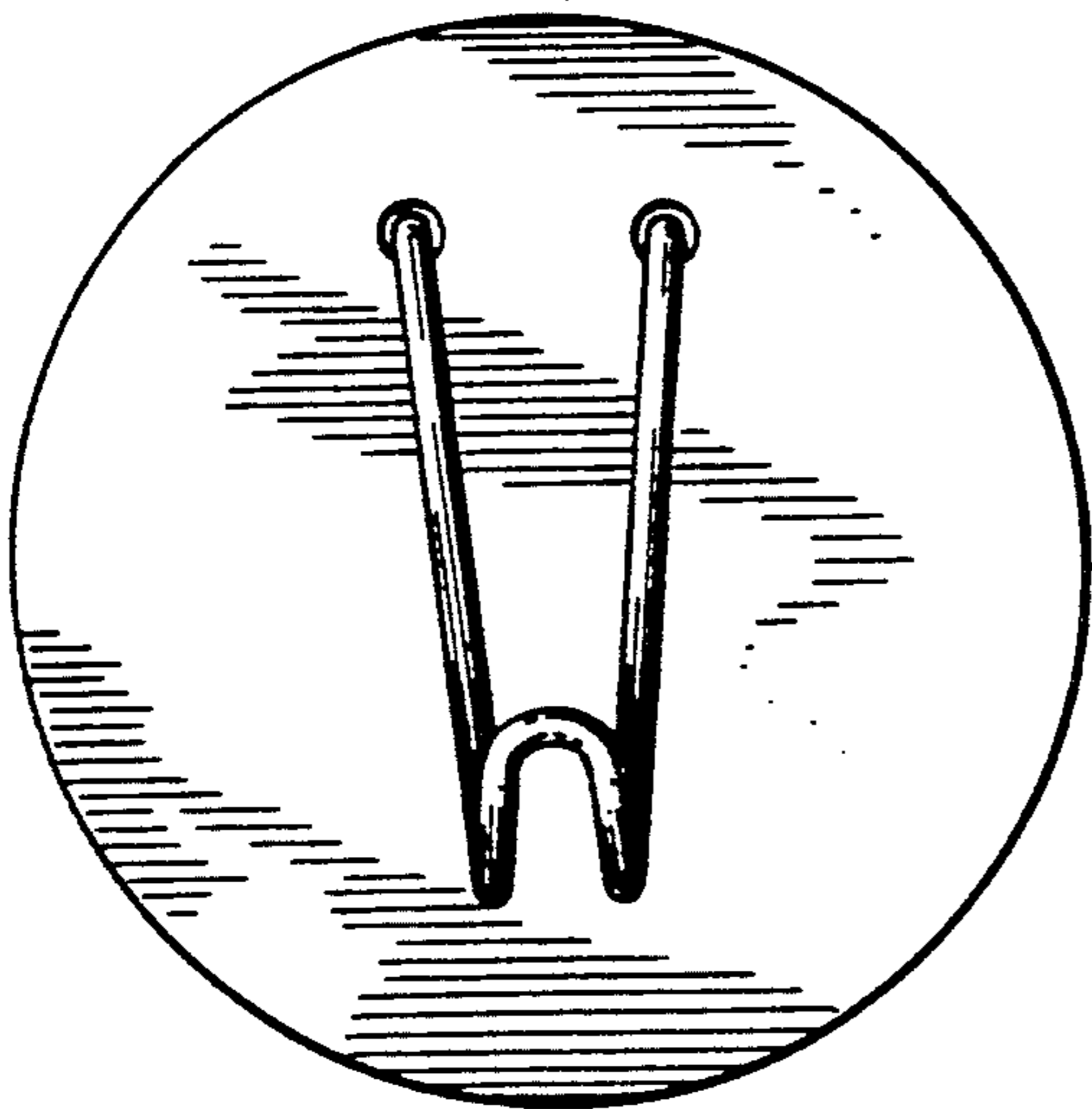

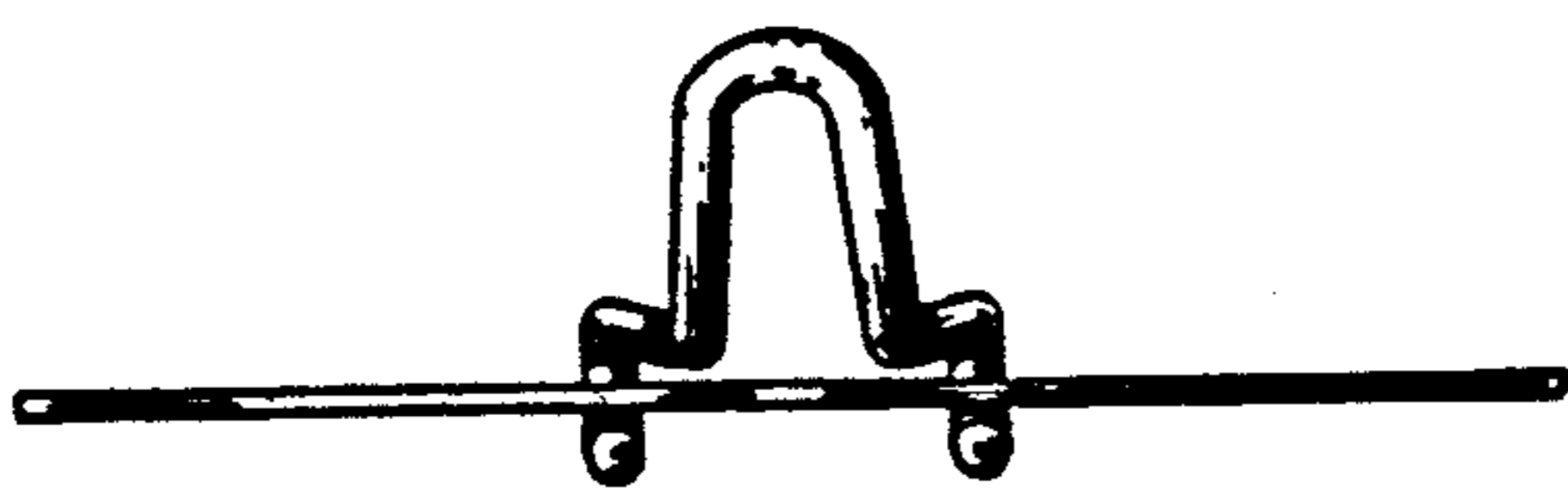

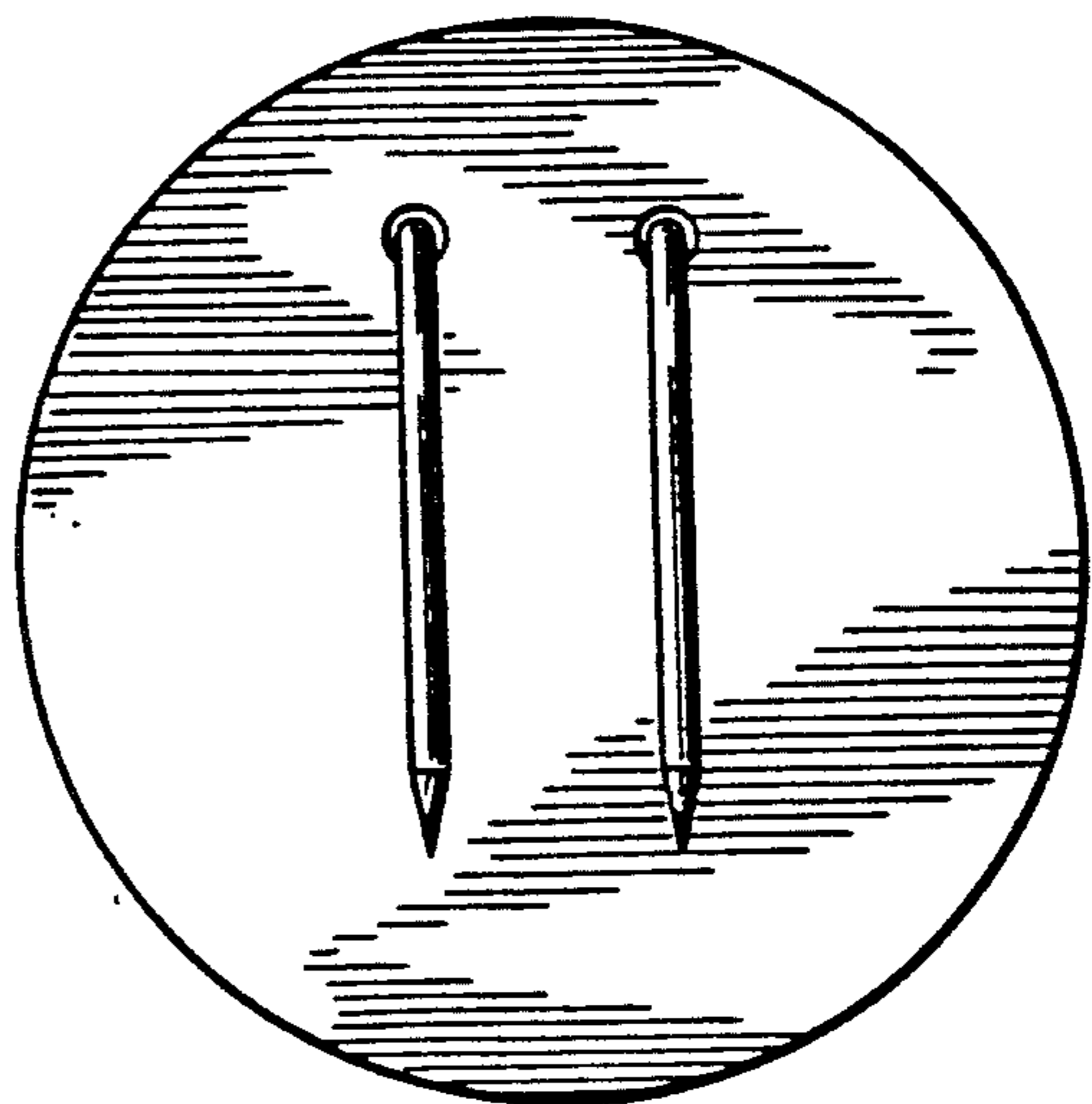
