## [57] CLAIM

The ornamental design for a frame for a traffic barricade, as shown and described.

## DESCRIPTION

FIG. 1 is a reduced perspective view of a frame for a traffic barricade showing our new design with the broken lines shown for illustrative purposes only and forming no part of the claimed design;

FIG. 2 is a left side elevational view thereof, with the opposite side being a mirror image;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a front elevational view of a second embodiment thereof;

FIG. 8 is a left side elevational view thereof; with the opposite side being a mirror image;

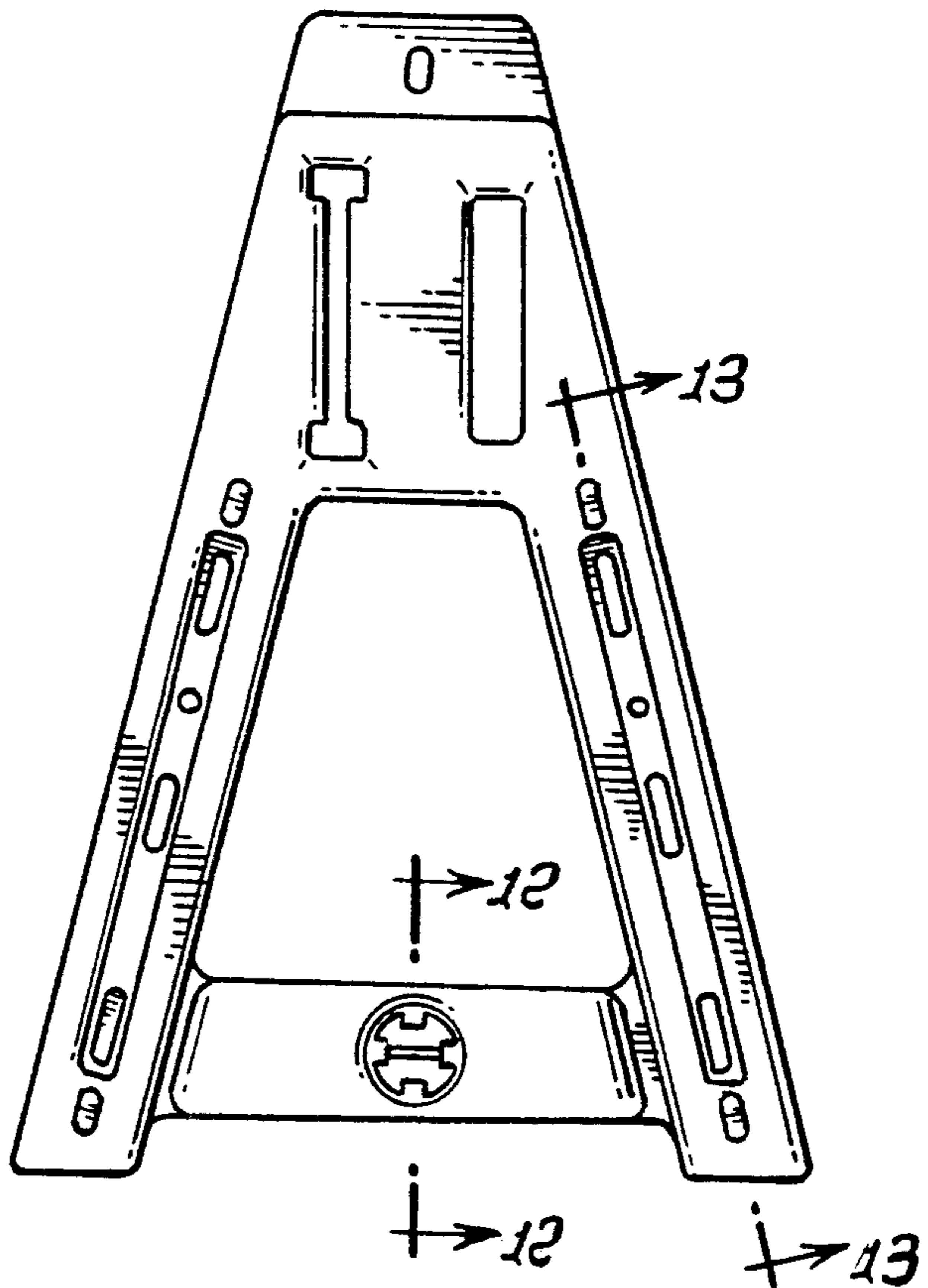
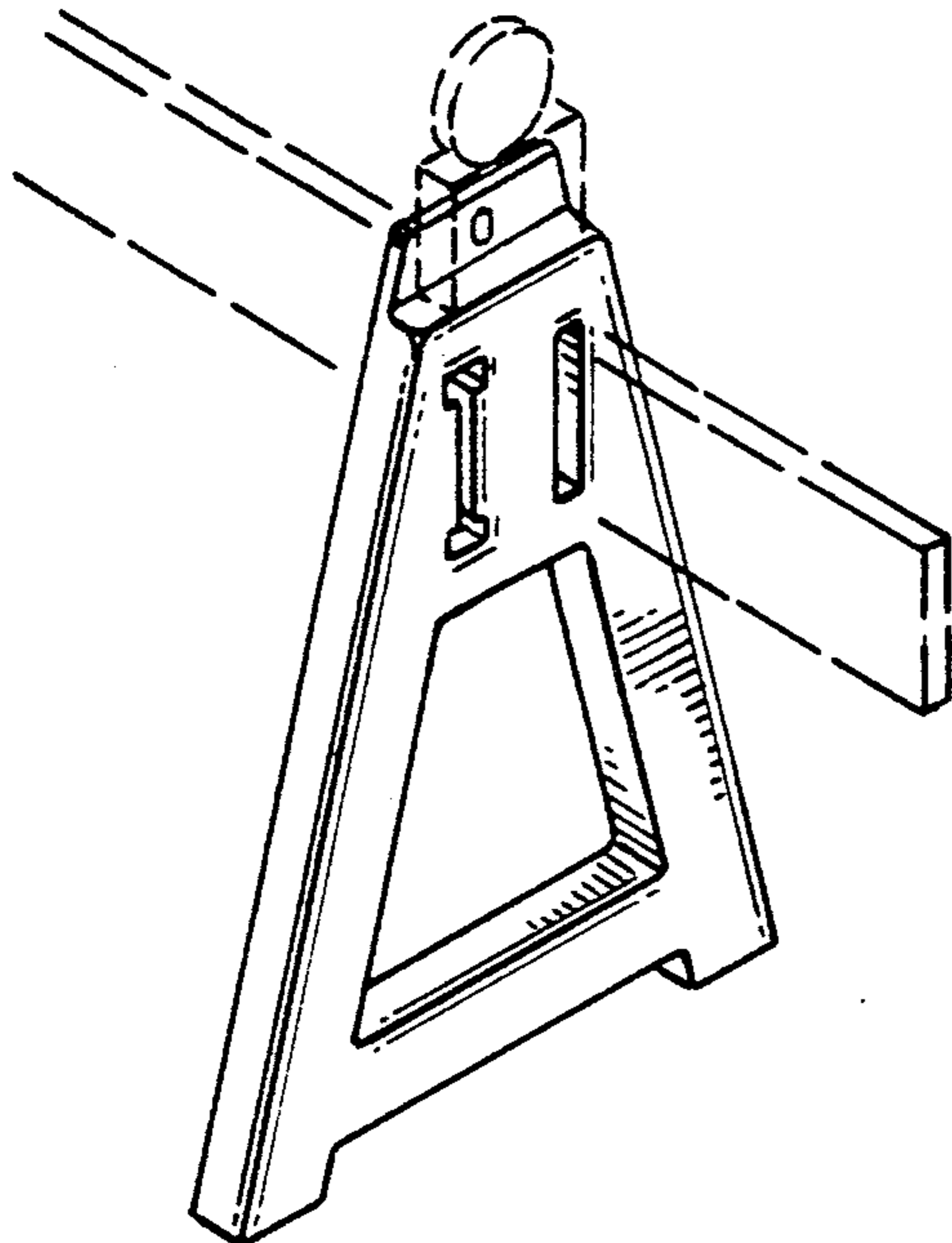
FIG. 9 is a top plan view thereof;

FIG. 10 is a bottom plan view thereof;

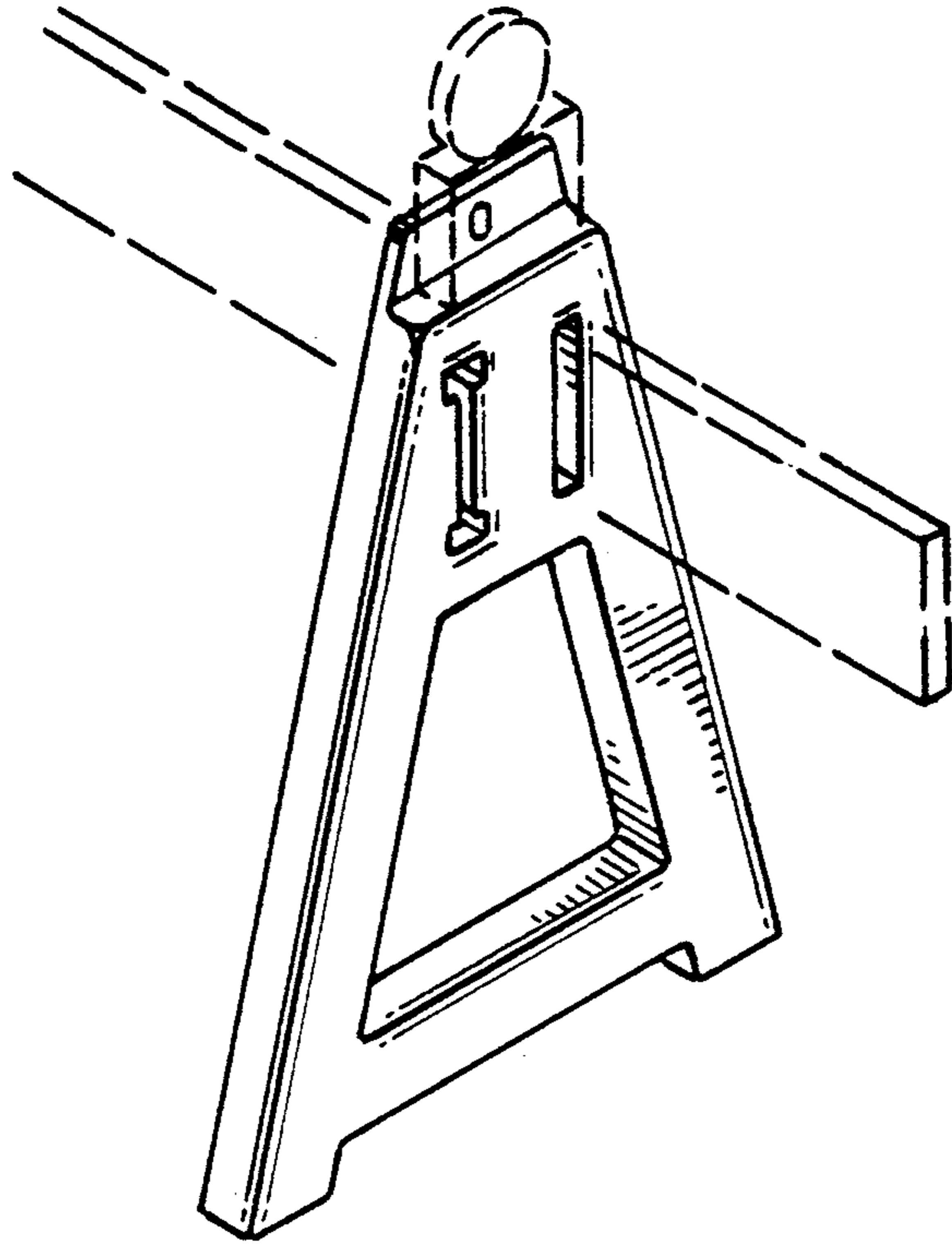
FIG. 11 is a rear elevational view thereof;

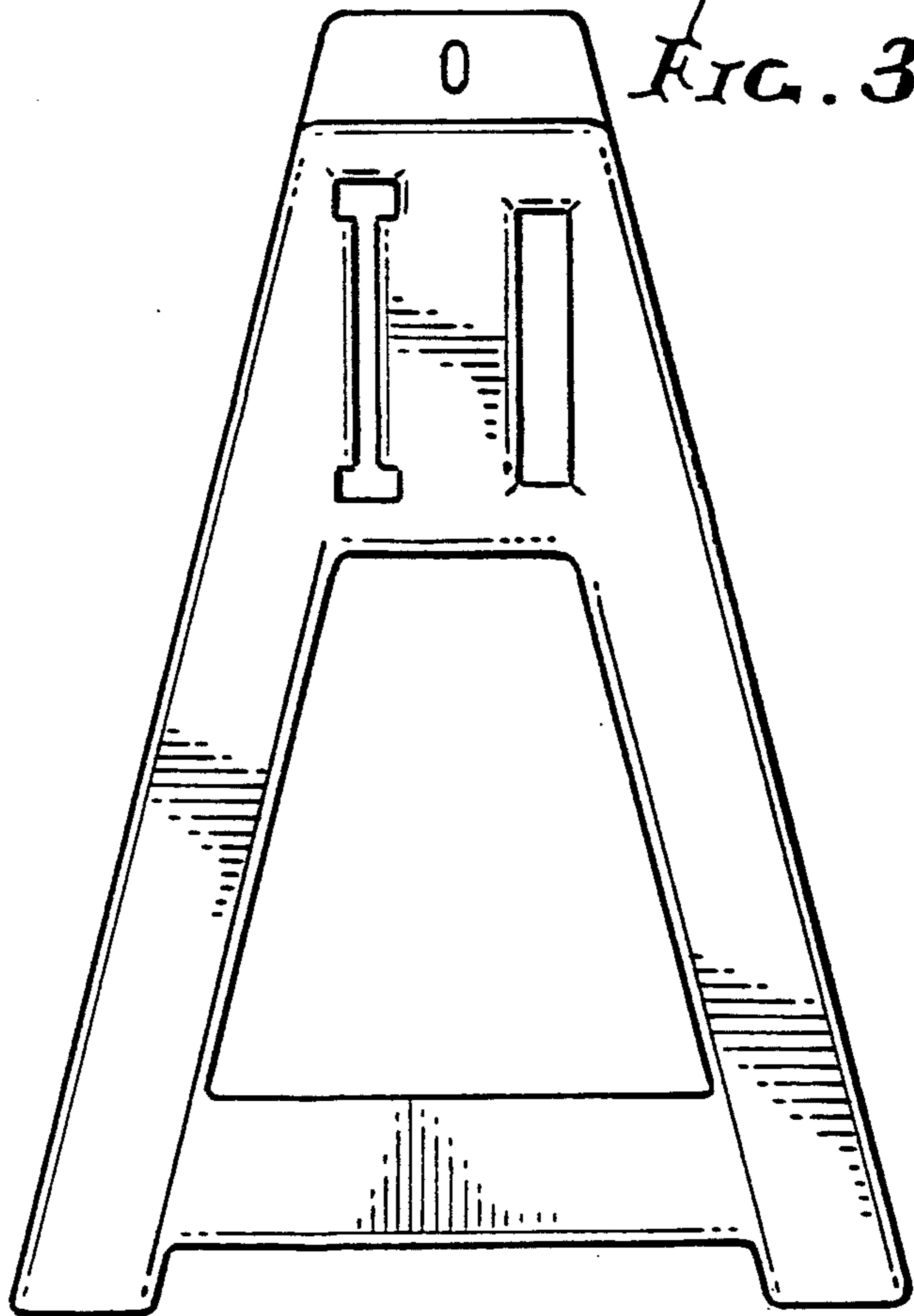

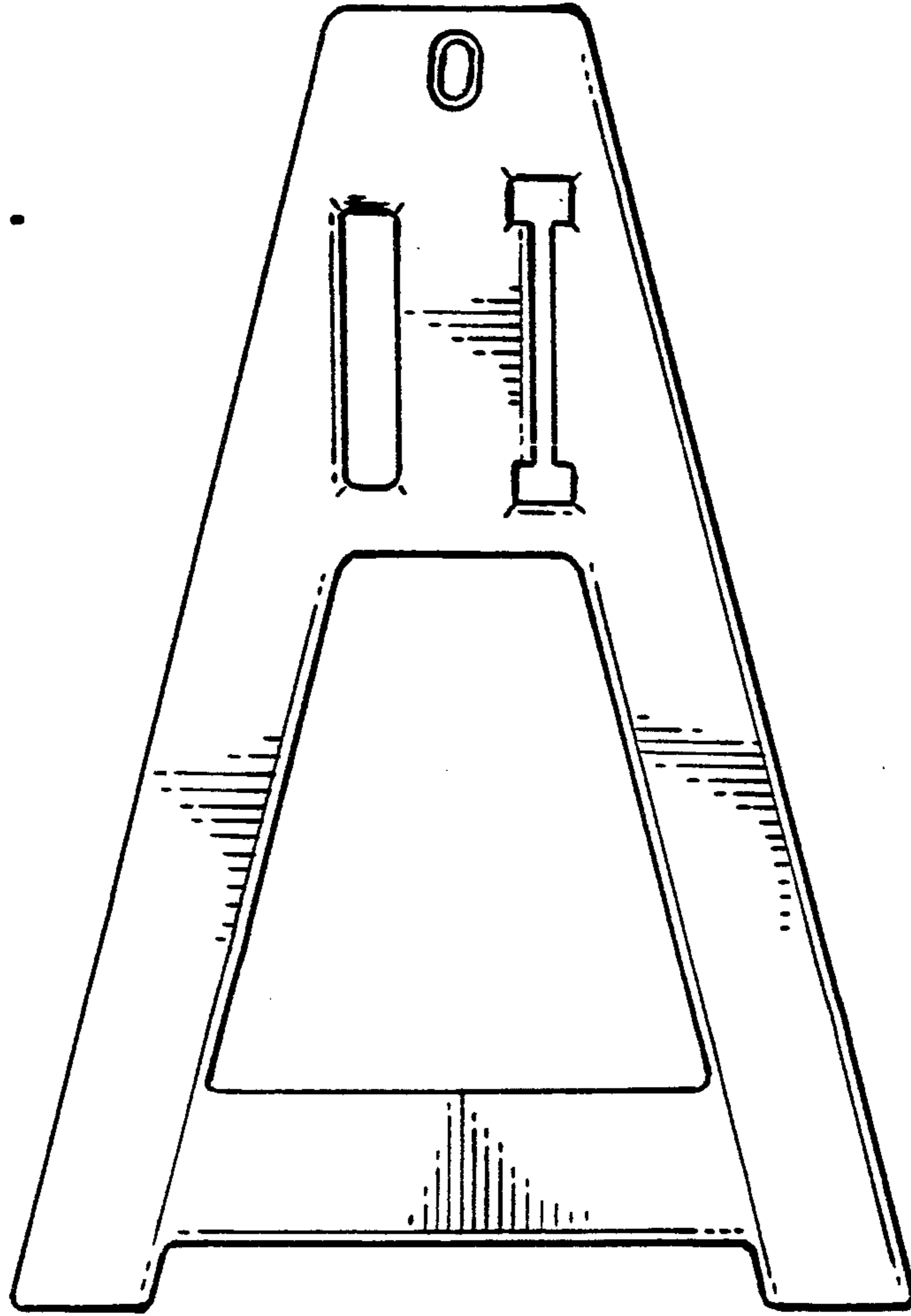

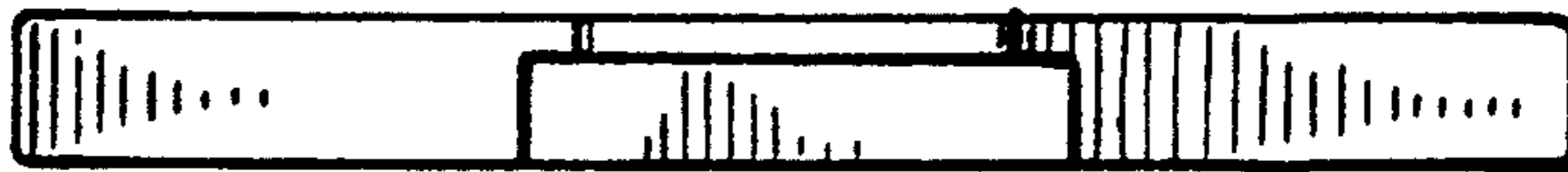

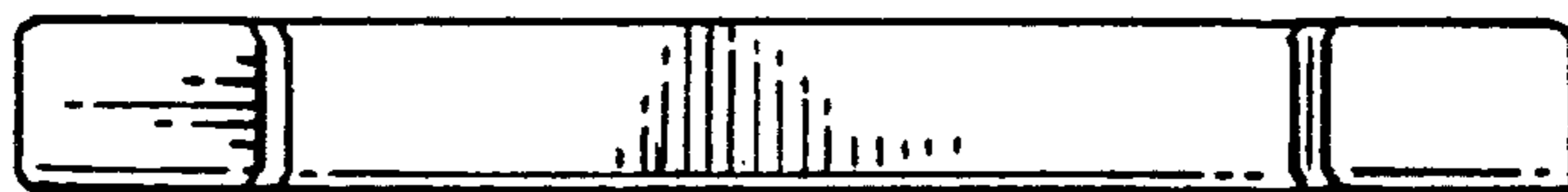

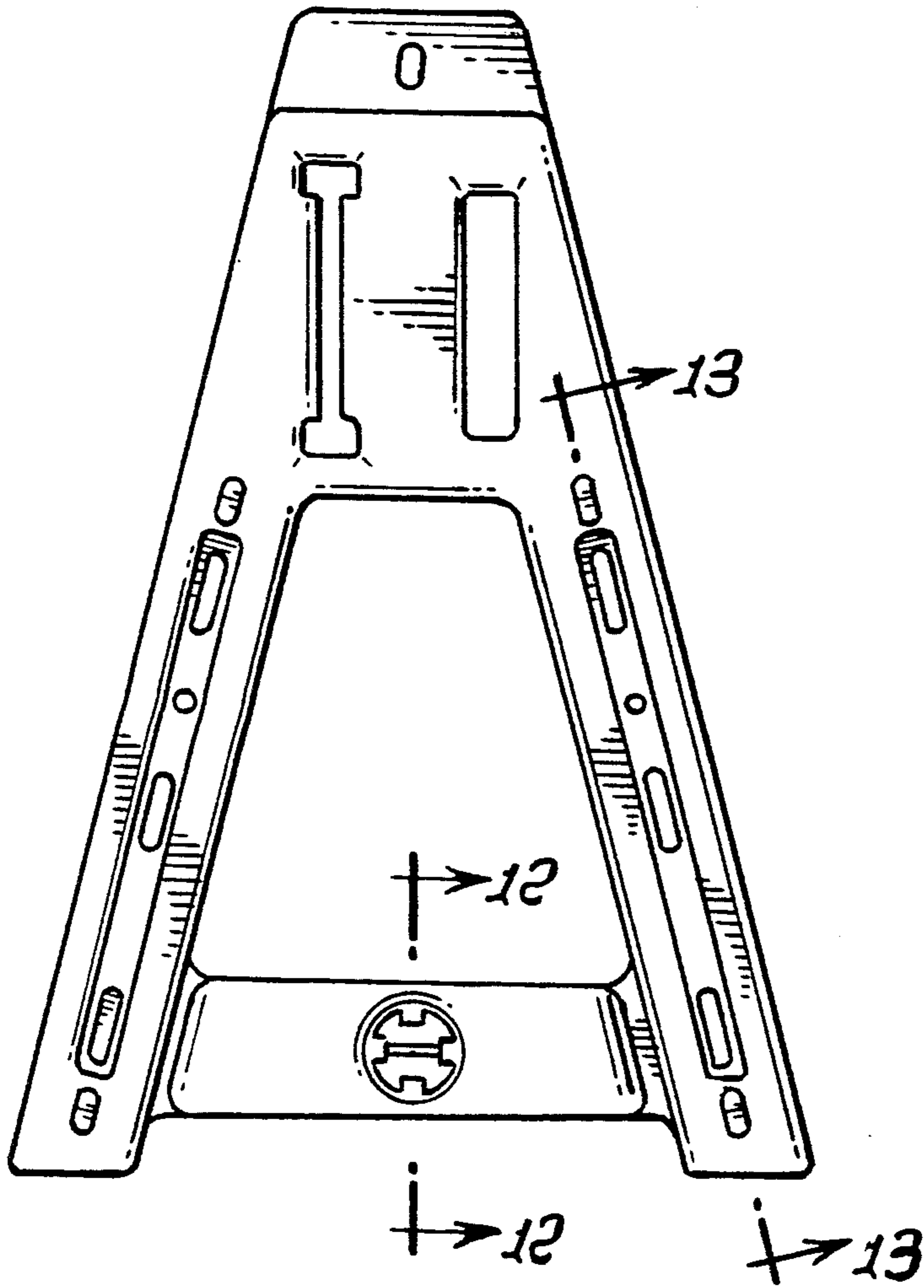

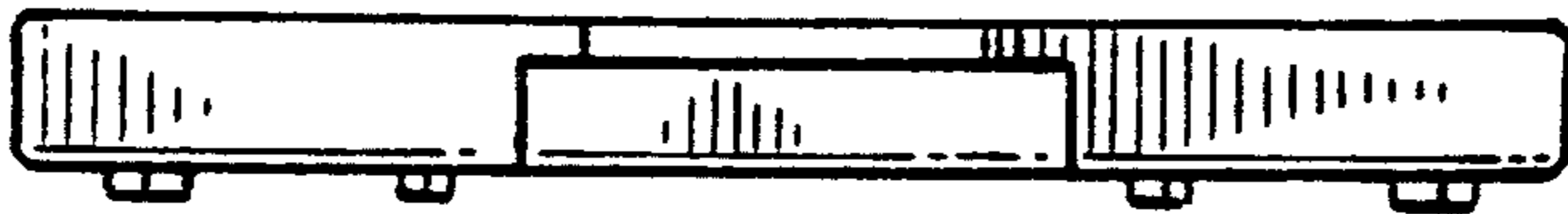

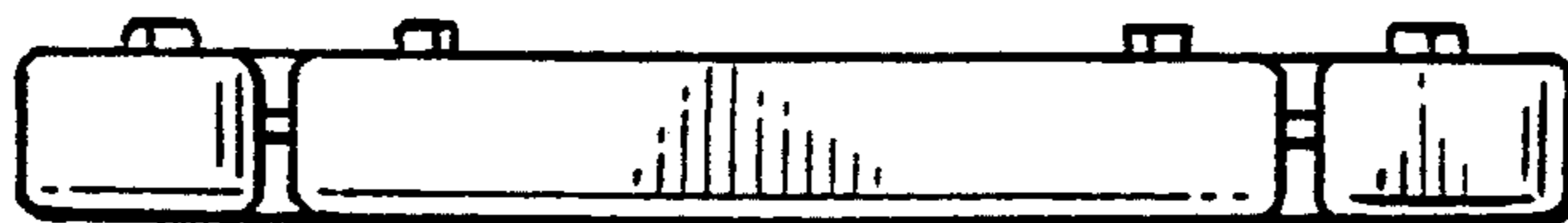

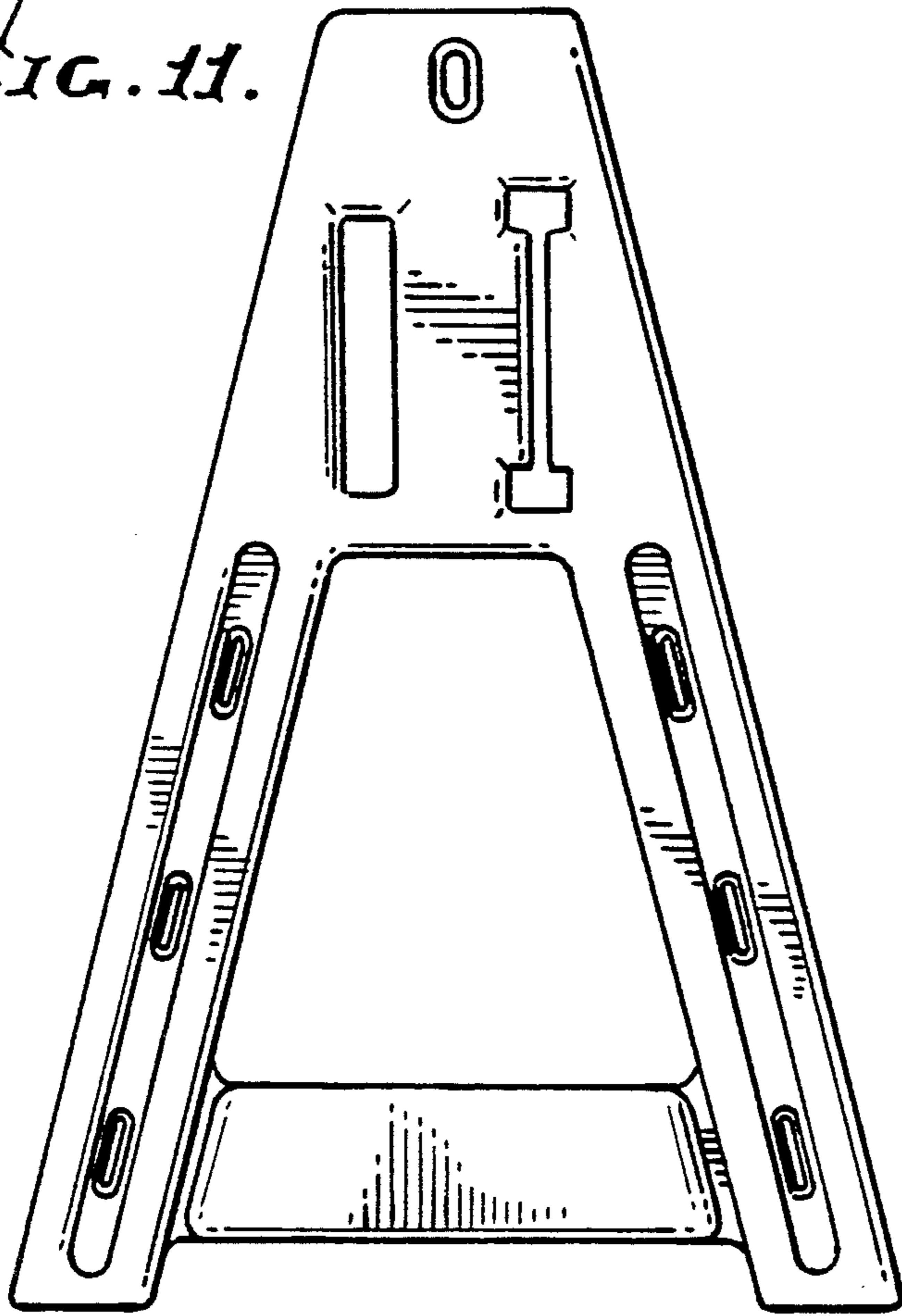

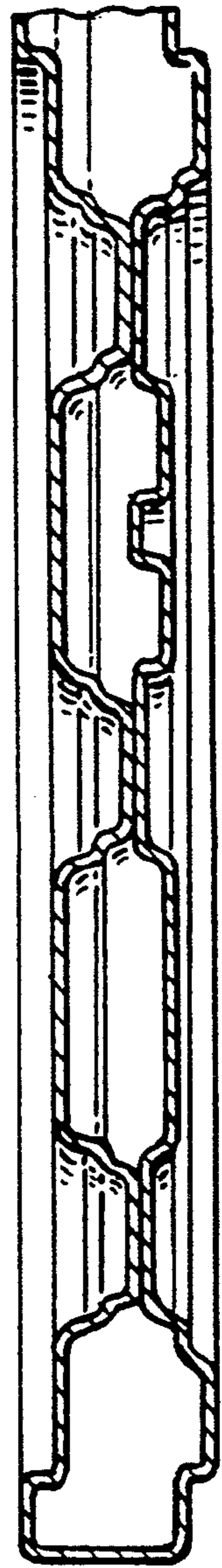
