The ornamental design for a combined flashlight and pen, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a combined flashlight and pen showing my new design;

FIG. 6 is a top, right front perspective view thereof.

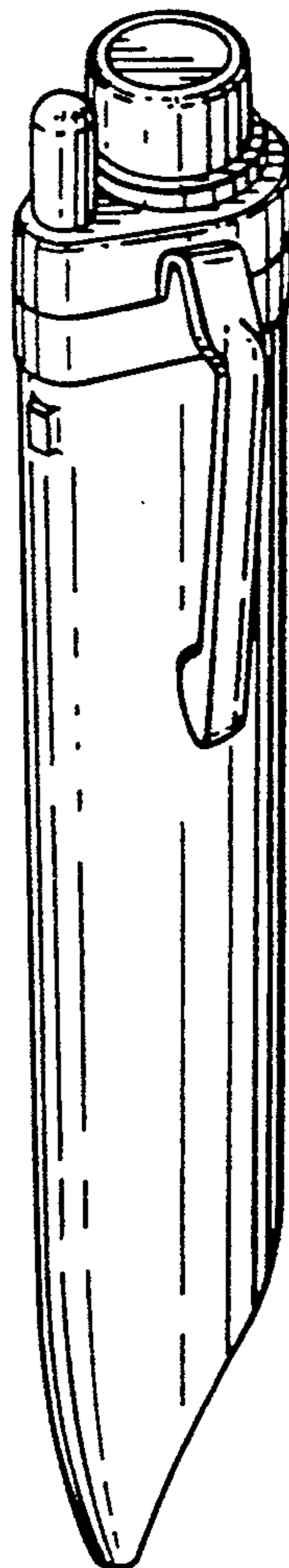

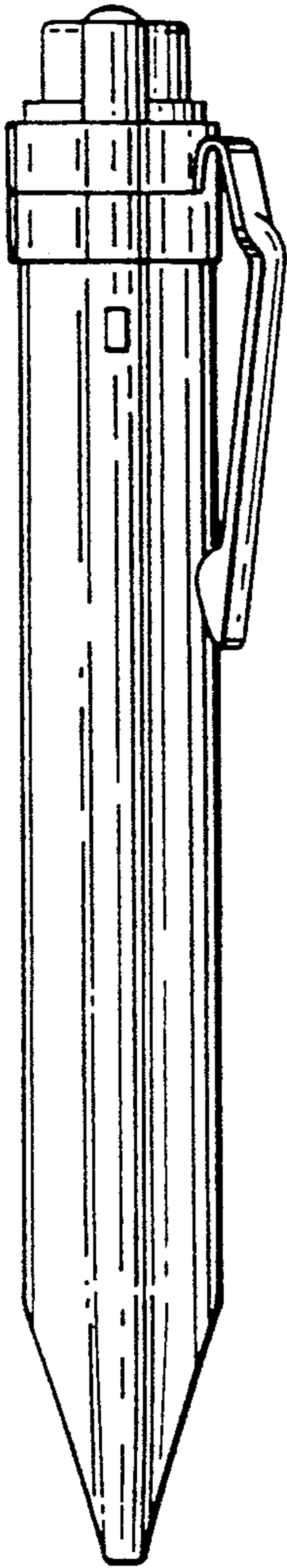

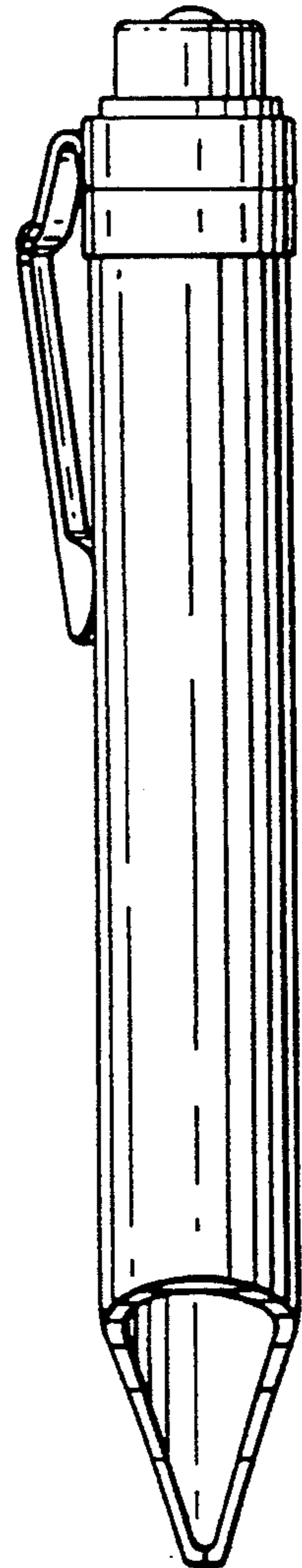

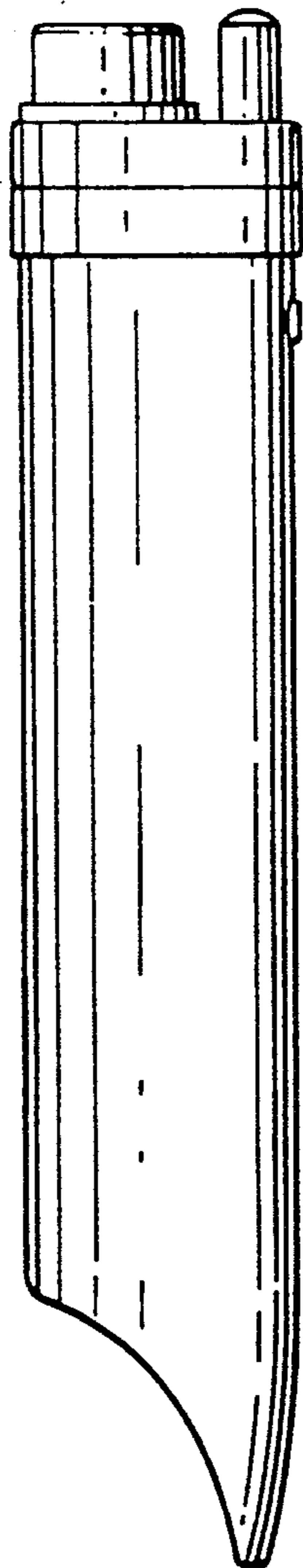

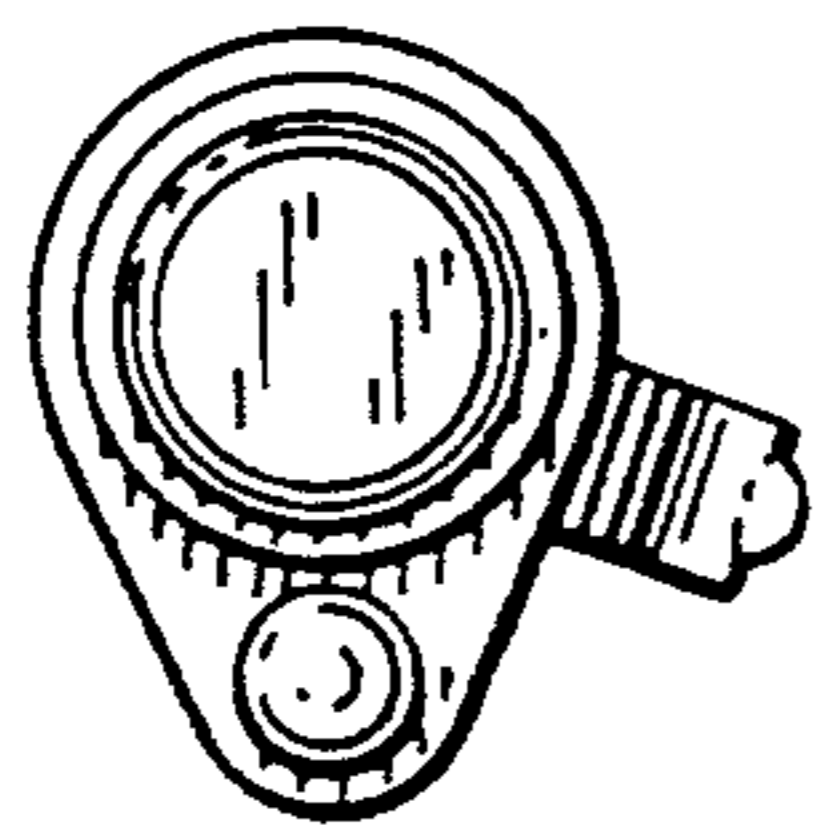

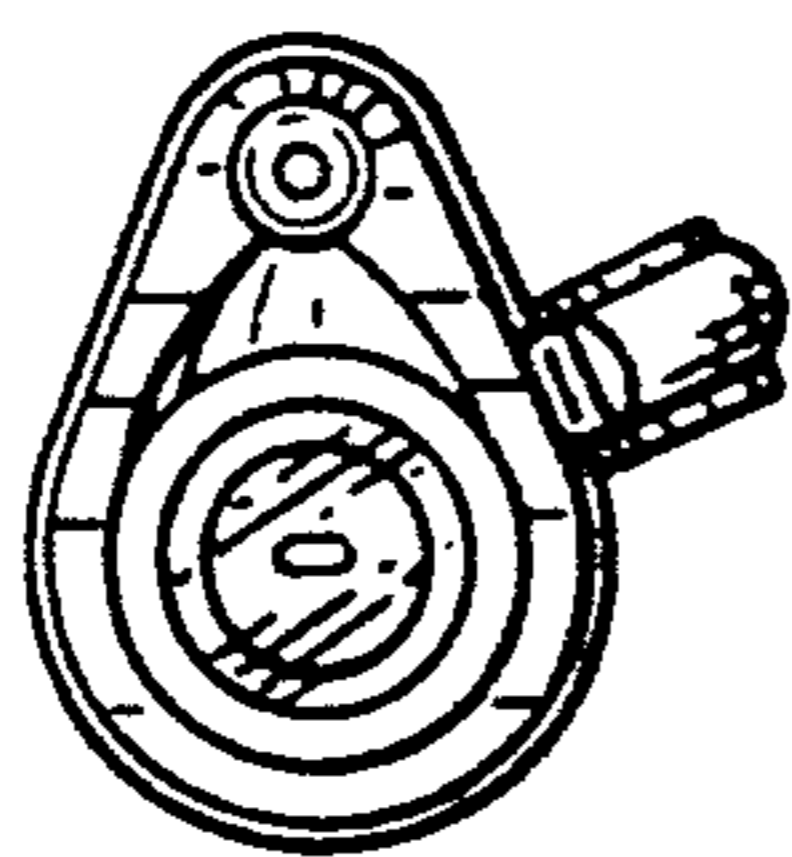
