The ornamental design for a tweezers or similar article, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of tweezers or a similar article showing my new design;

FIG. 21 is a right side elevational view thereof.

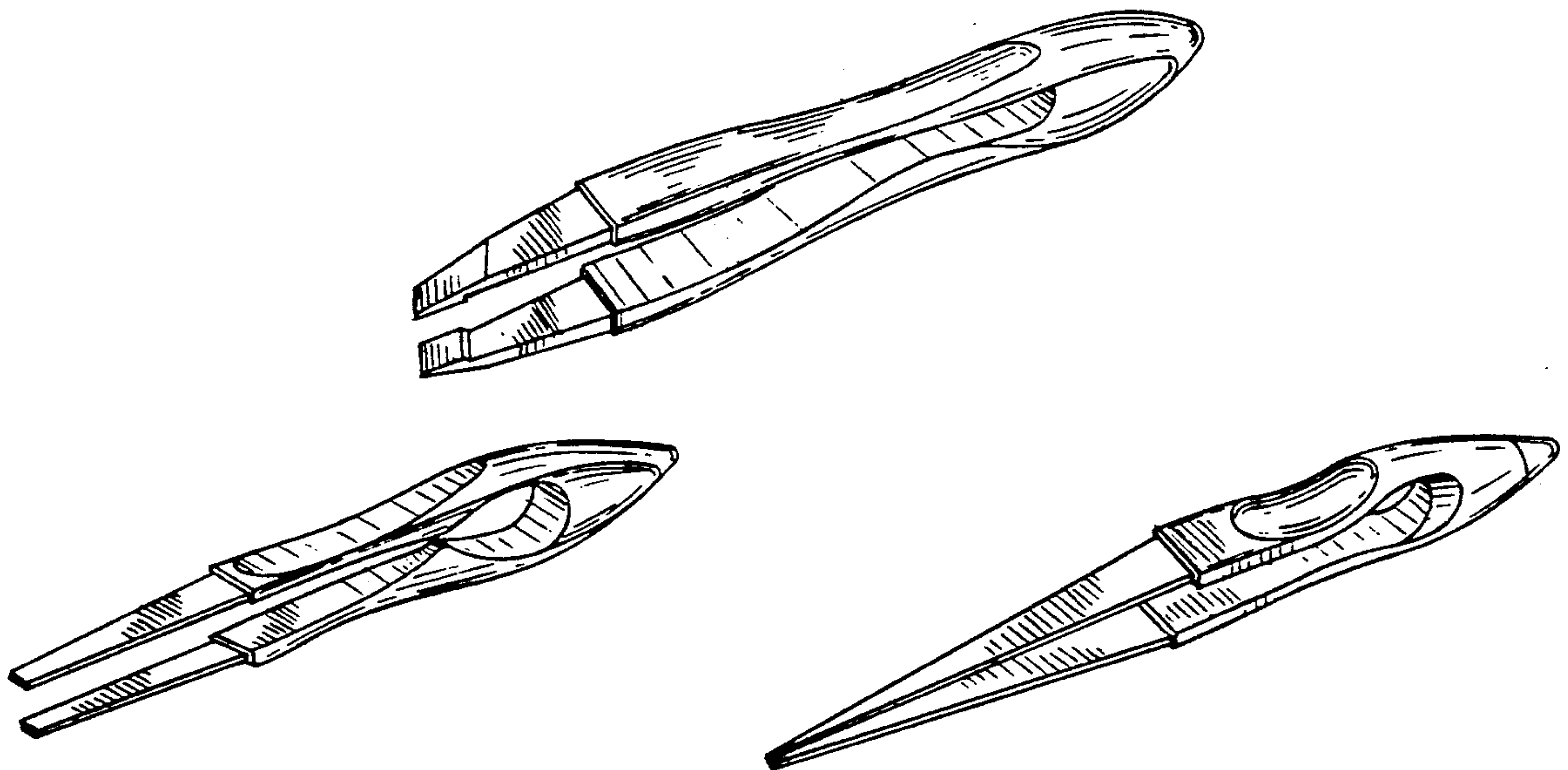

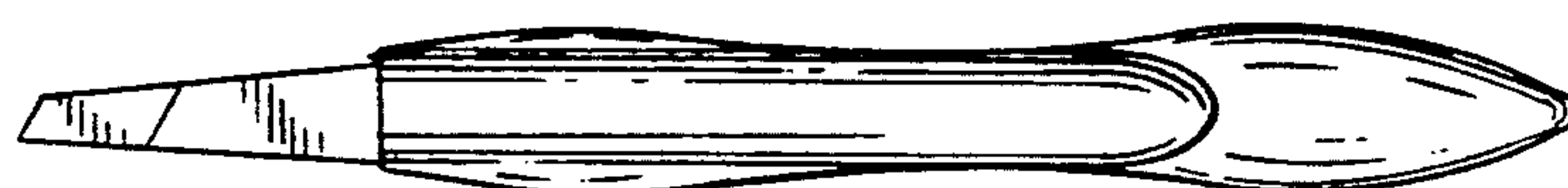
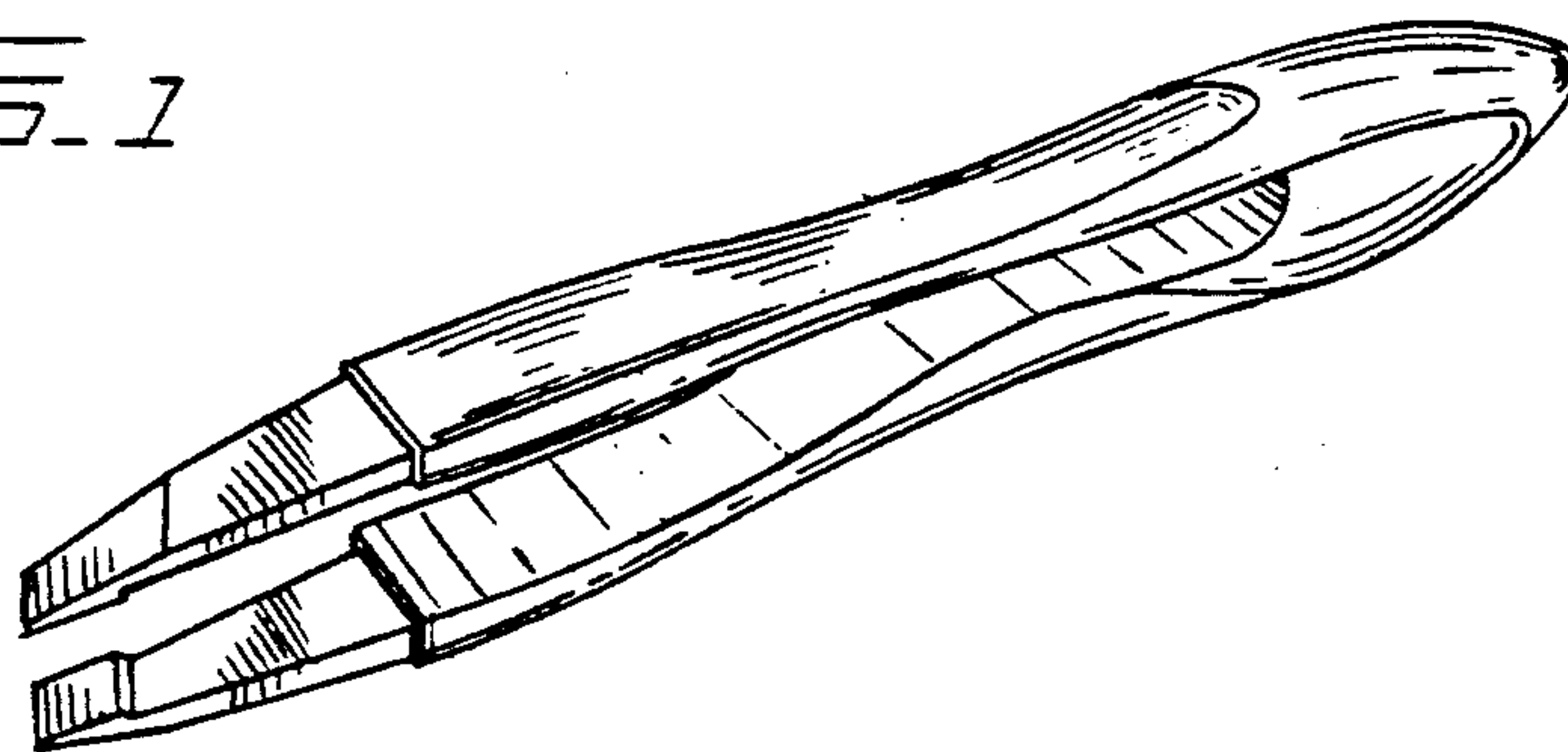

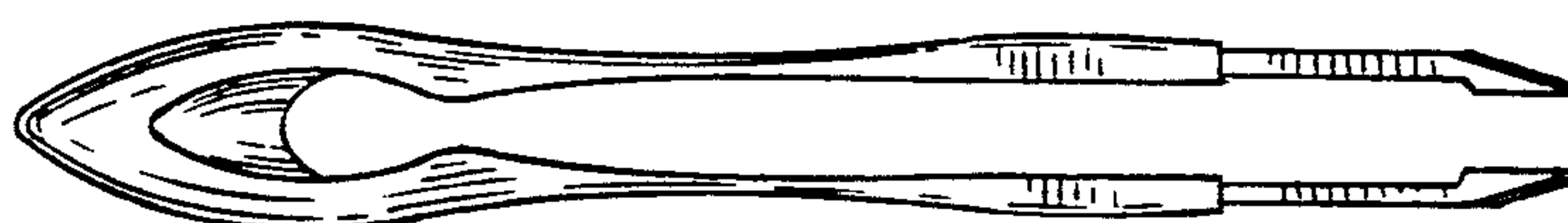

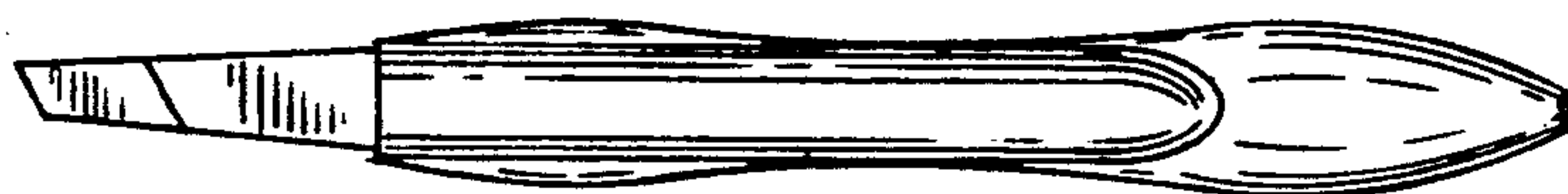

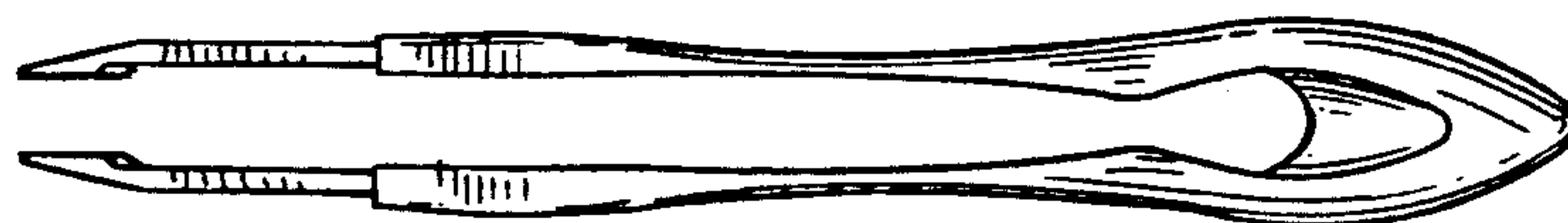

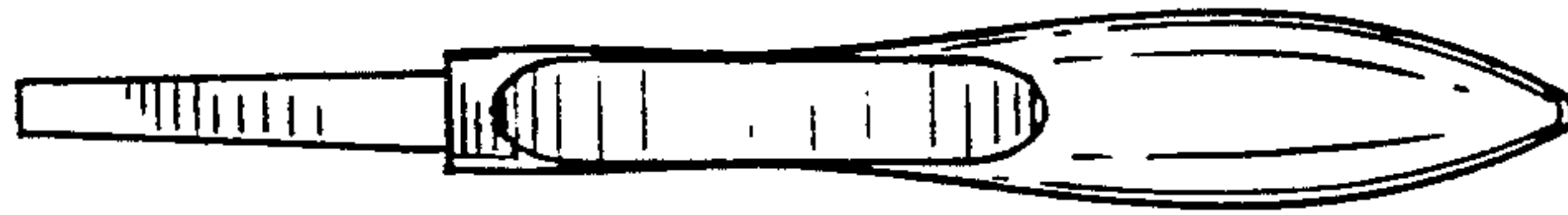
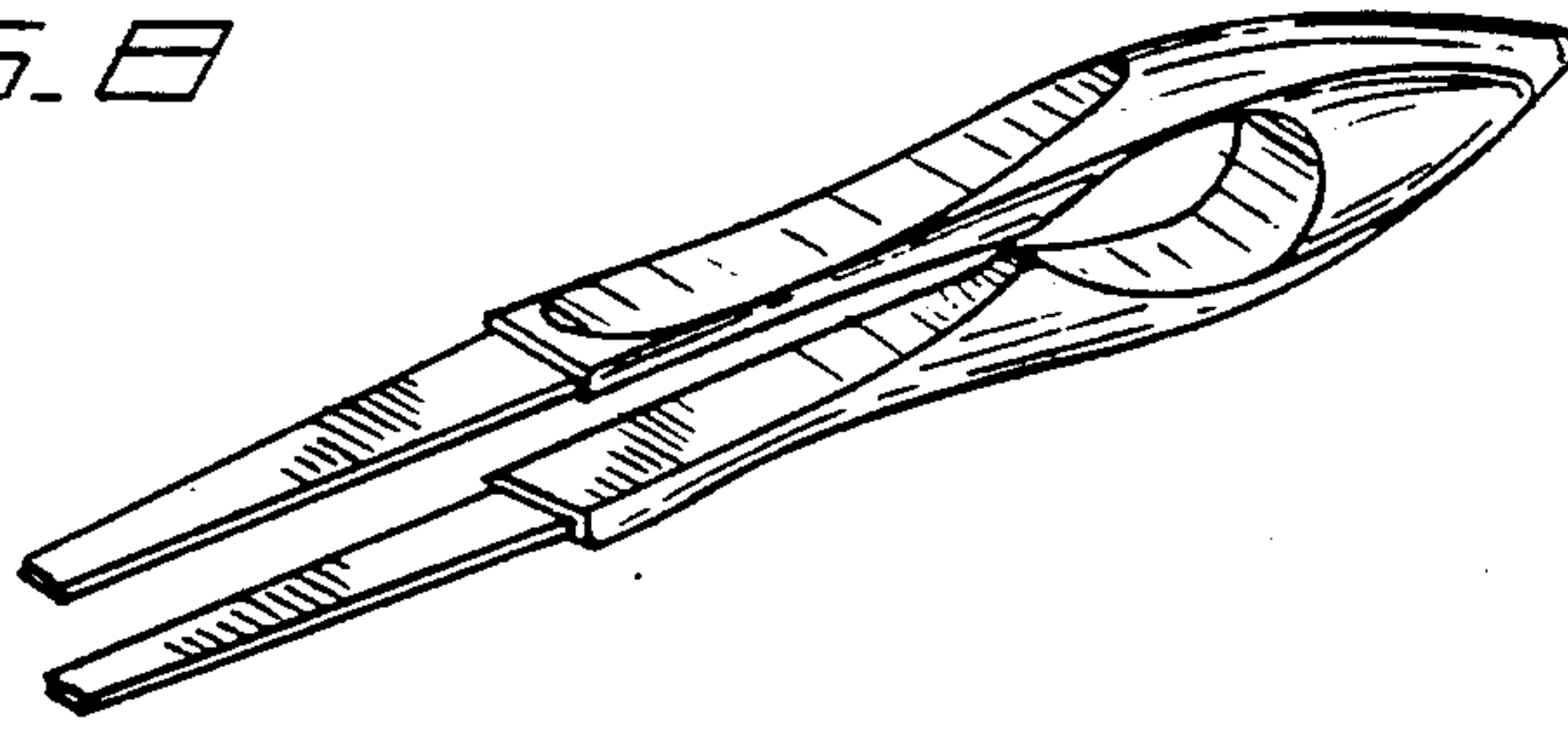

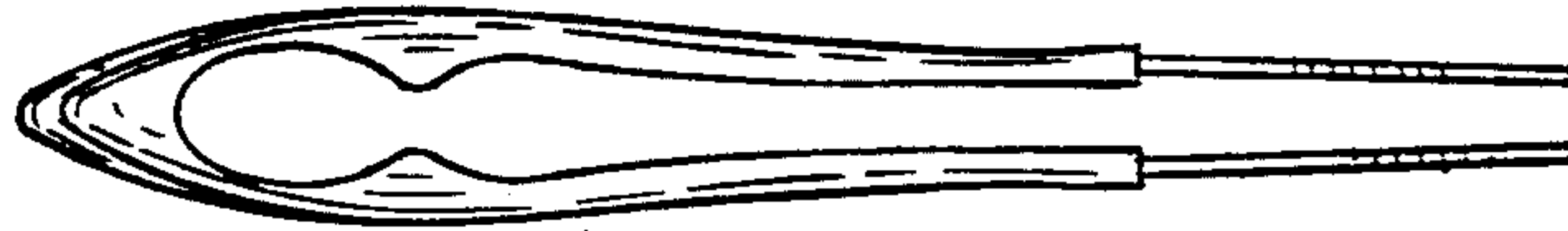

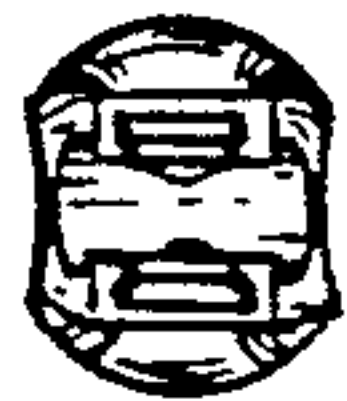

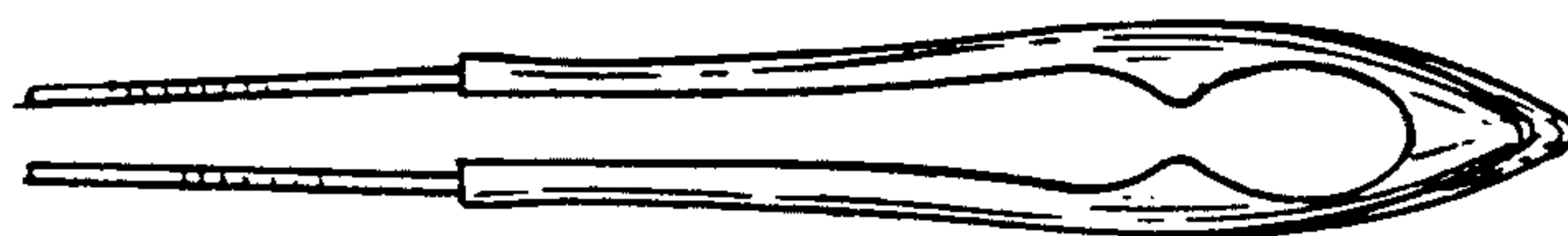

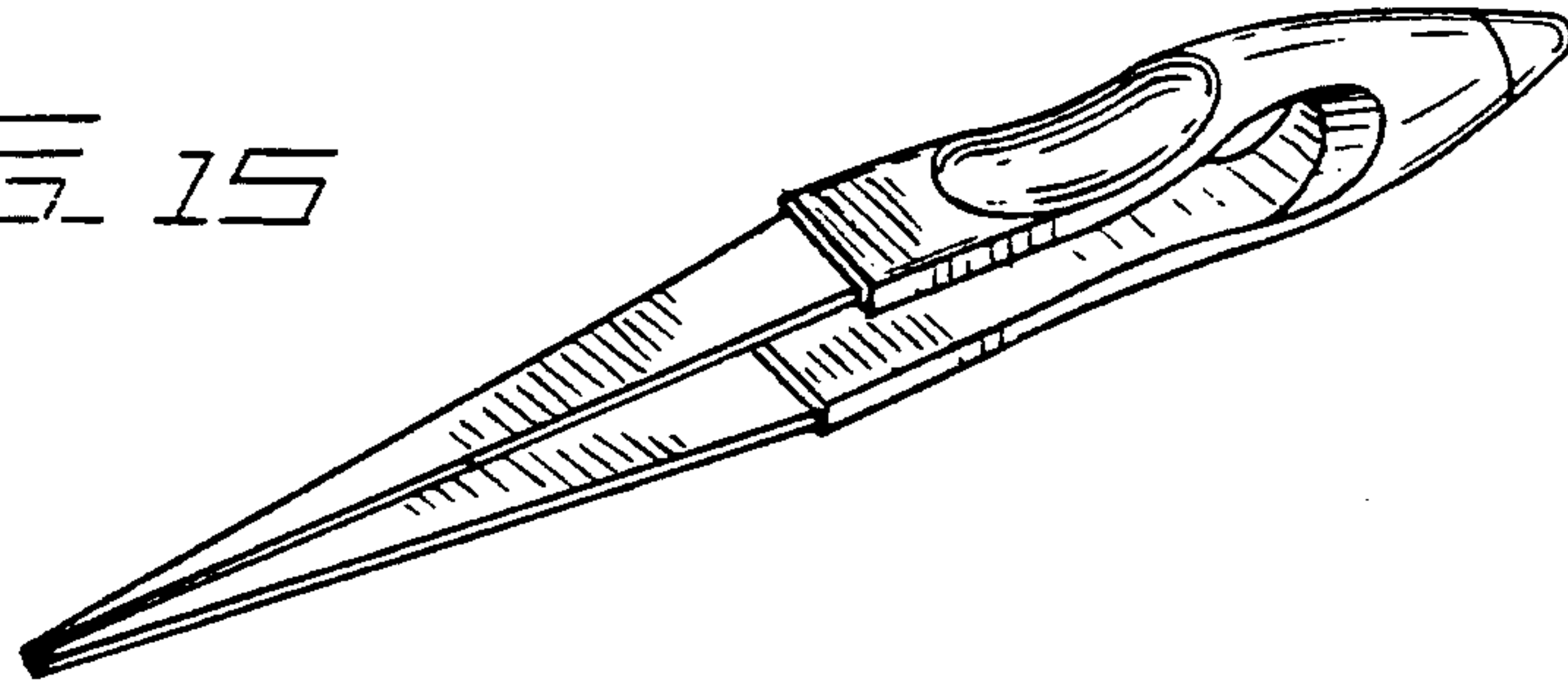

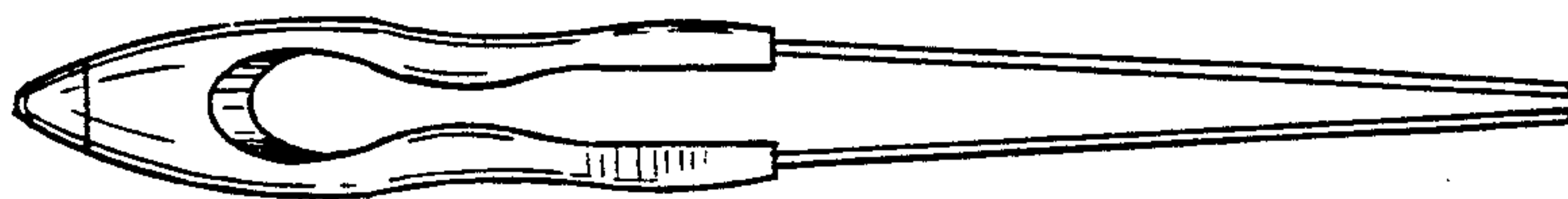

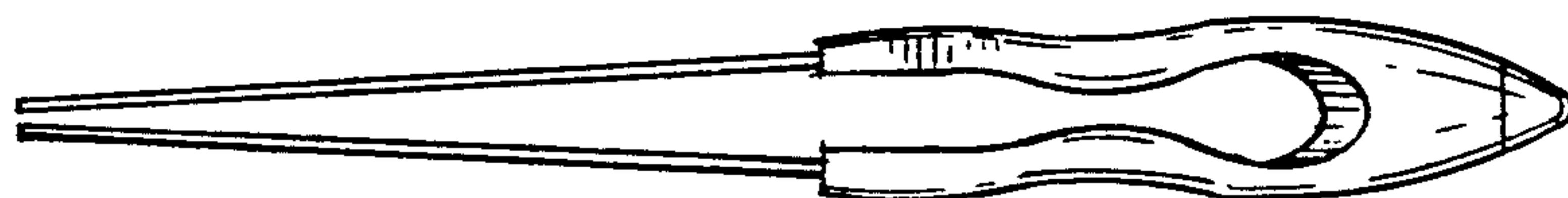
