[57] **CLAIM**

The ornamental design for combined storage bins and cart therefor, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a combined storage

bins and cart therefor showing our new design, with the lid of one storage bin being opened and the bin being elevated from the bottom of the cart;

FIG. 2 is a front elevational view of one of the storage bins;

FIG. 3 is a rear elevational view of FIG. 2;

FIG. 4 is a side elevational view of FIG. 2, the opposite side view being a mirror image of that shown;

FIG. 5 is a top plan view of FIG. 2;

FIG. 6 is a bottom plan view of FIG. 2;

FIG. 7 is a front elevational view of the cart;

FIG. 8 is a rear elevational view of FIG. 7;

FIG. 9 is a side elevational view of FIG. 7, the opposite side view being a mirror image of that shown;

FIG. 10 is a top plan view of FIG. 9;

FIG. 11 is a bottom plan view of FIG. 9;

FIG. 12 is a front elevational view of a second embodiment view of a second embodiment of the cart;

FIG. 13 is a rear elevational view of FIG. 12;

FIG. 14 is a side elevational view of FIG. 12, the opposite side view being a mirror image of that shown;

FIG. 15 is a top plan view of FIG. 12;

FIG. 16 is a front elevational view of a third embodiment of the cart;

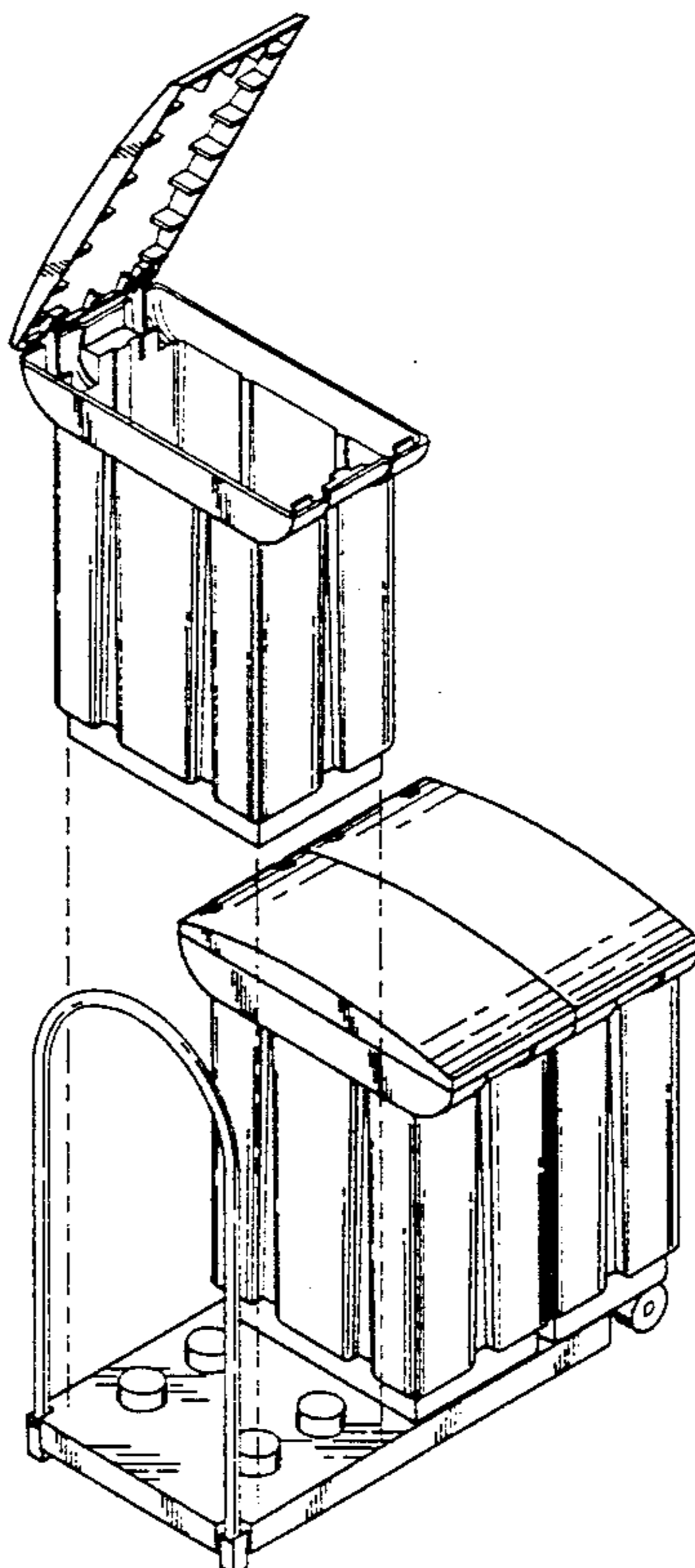
FIG. 17 is a rear elevational view of FIG. 16;

FIG. 18 is a side elevational view of FIG. 16; the opposite side view being a mirror image of that shown;

FIG. 19 is a top plan view of FIG. 16; and,

The undisclosed bottom of the second and third embodiment being the same as the first embodiment shown in FIG. 11.



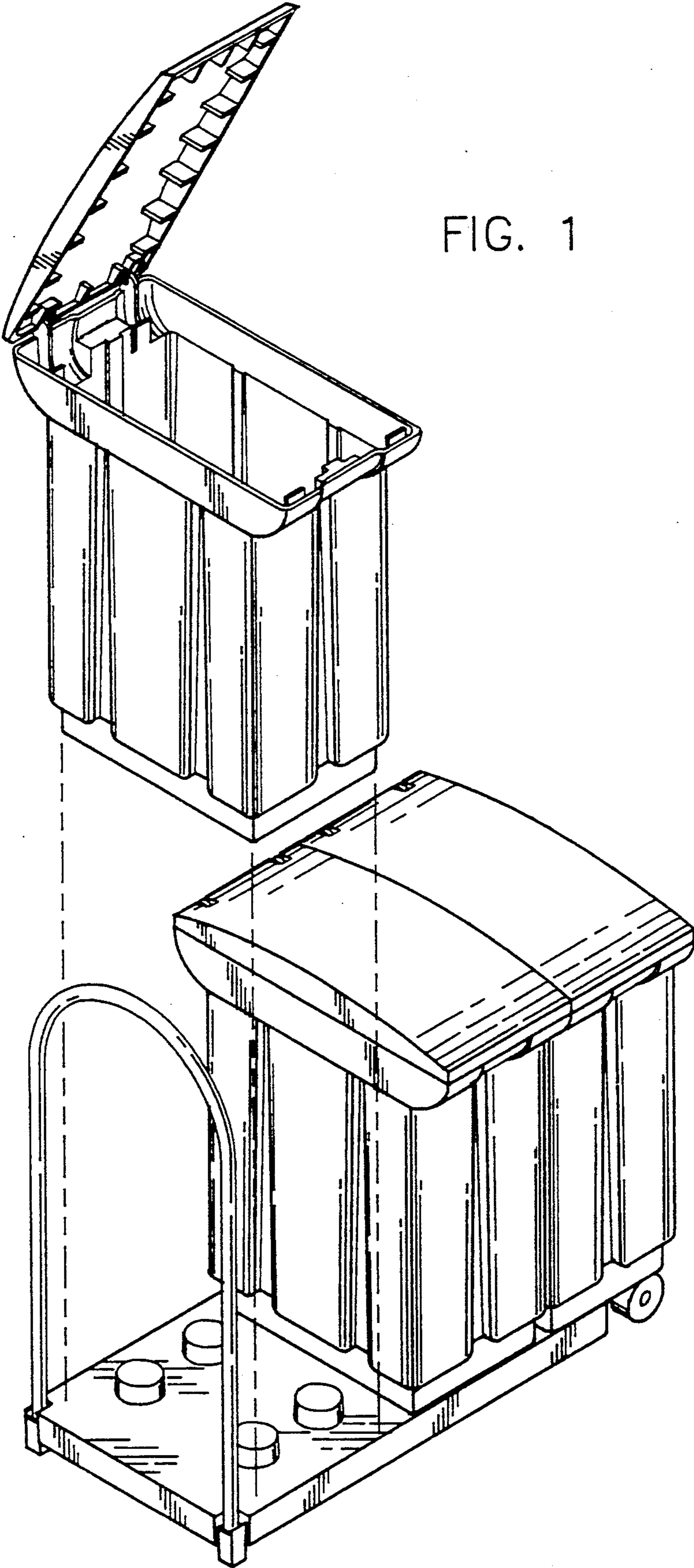

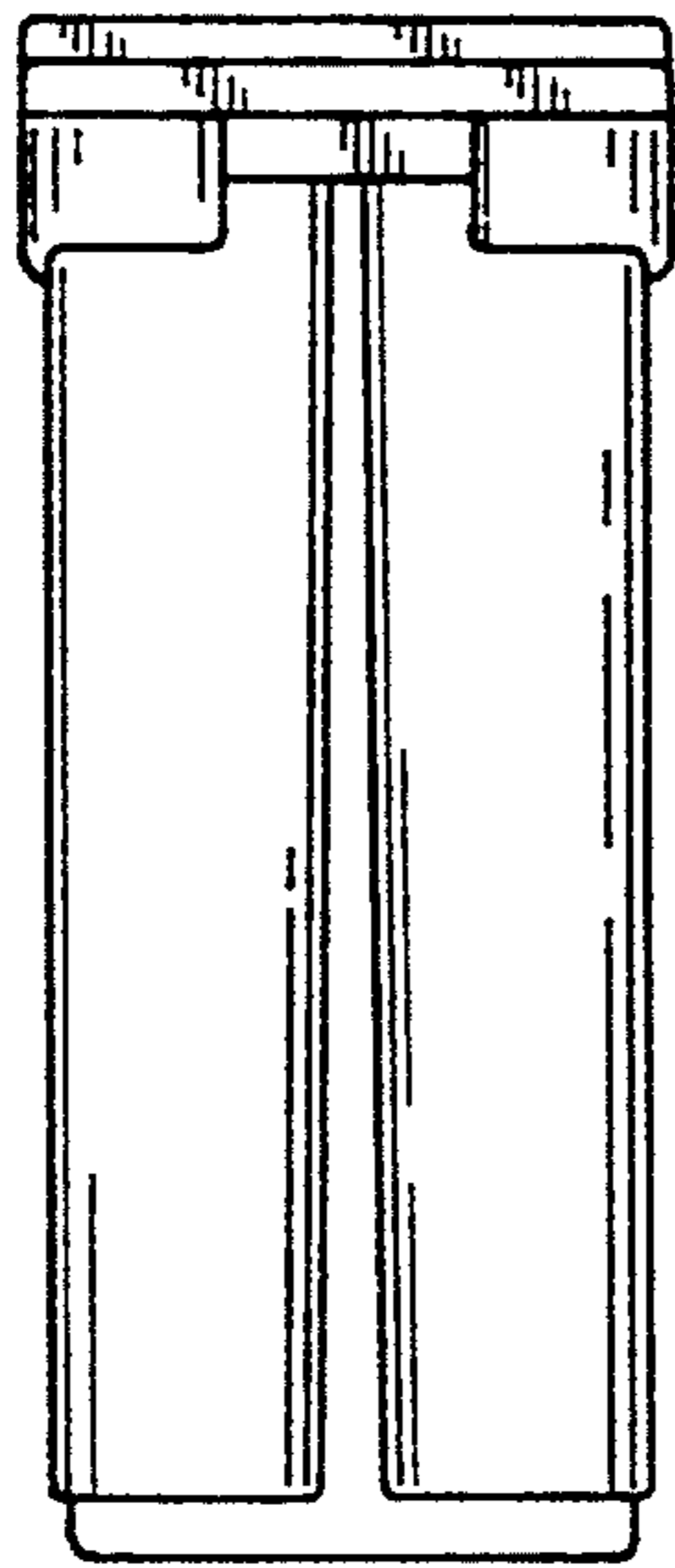

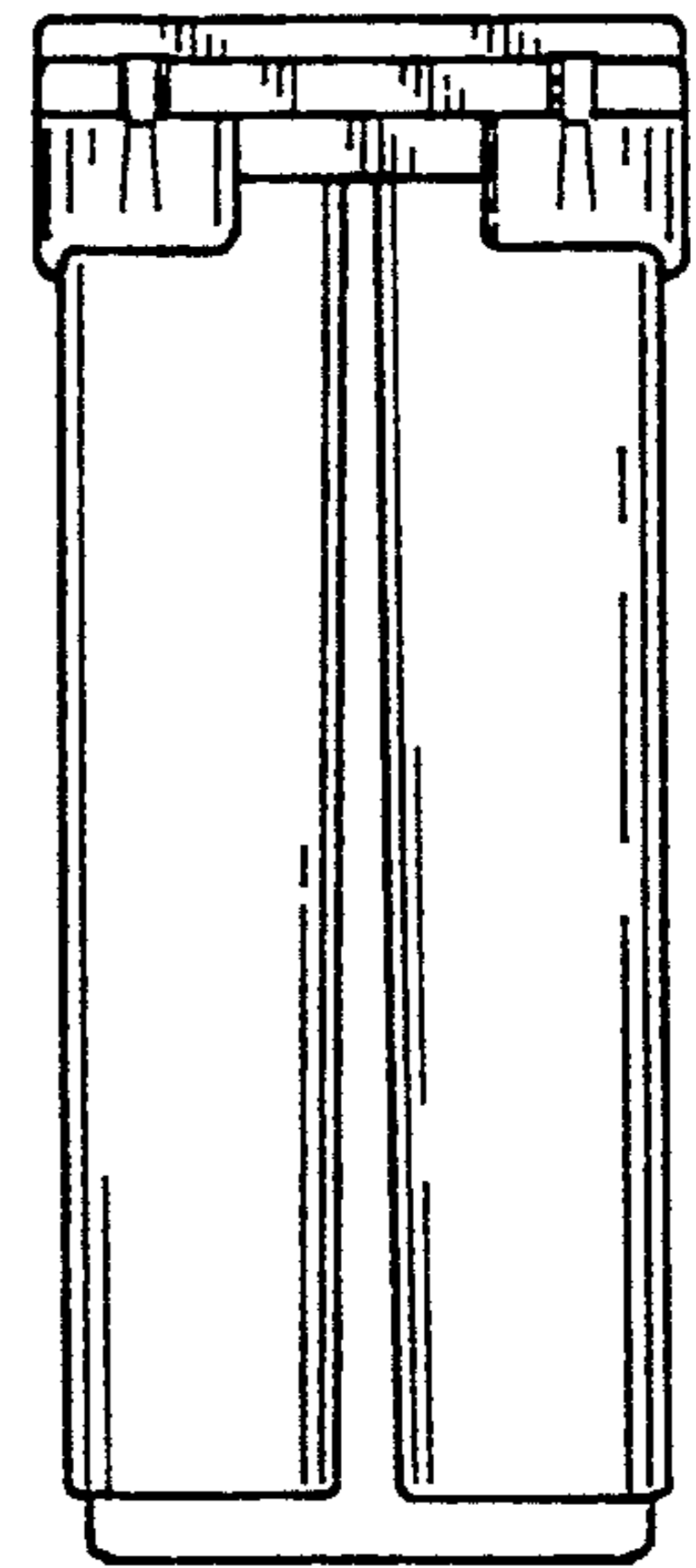

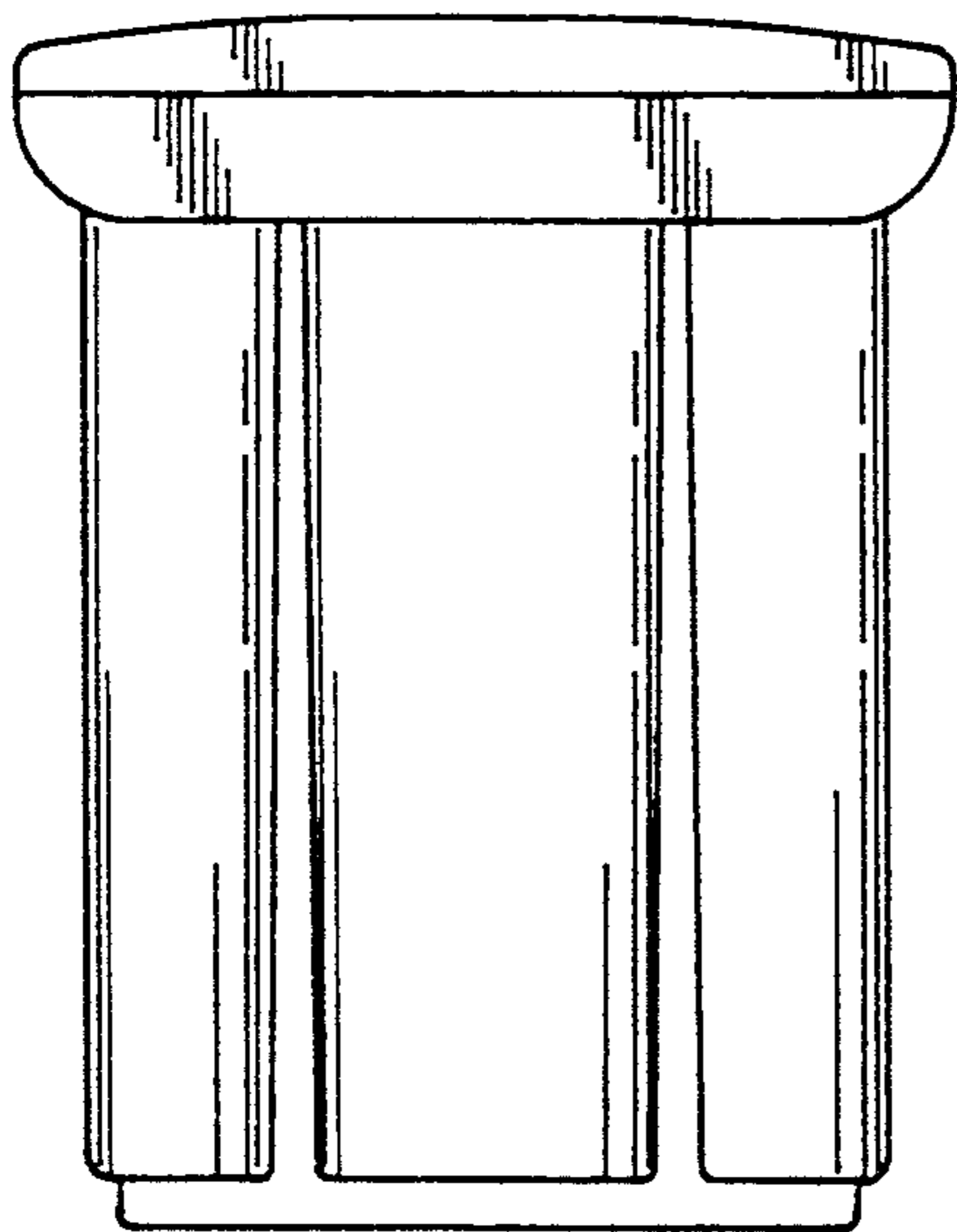

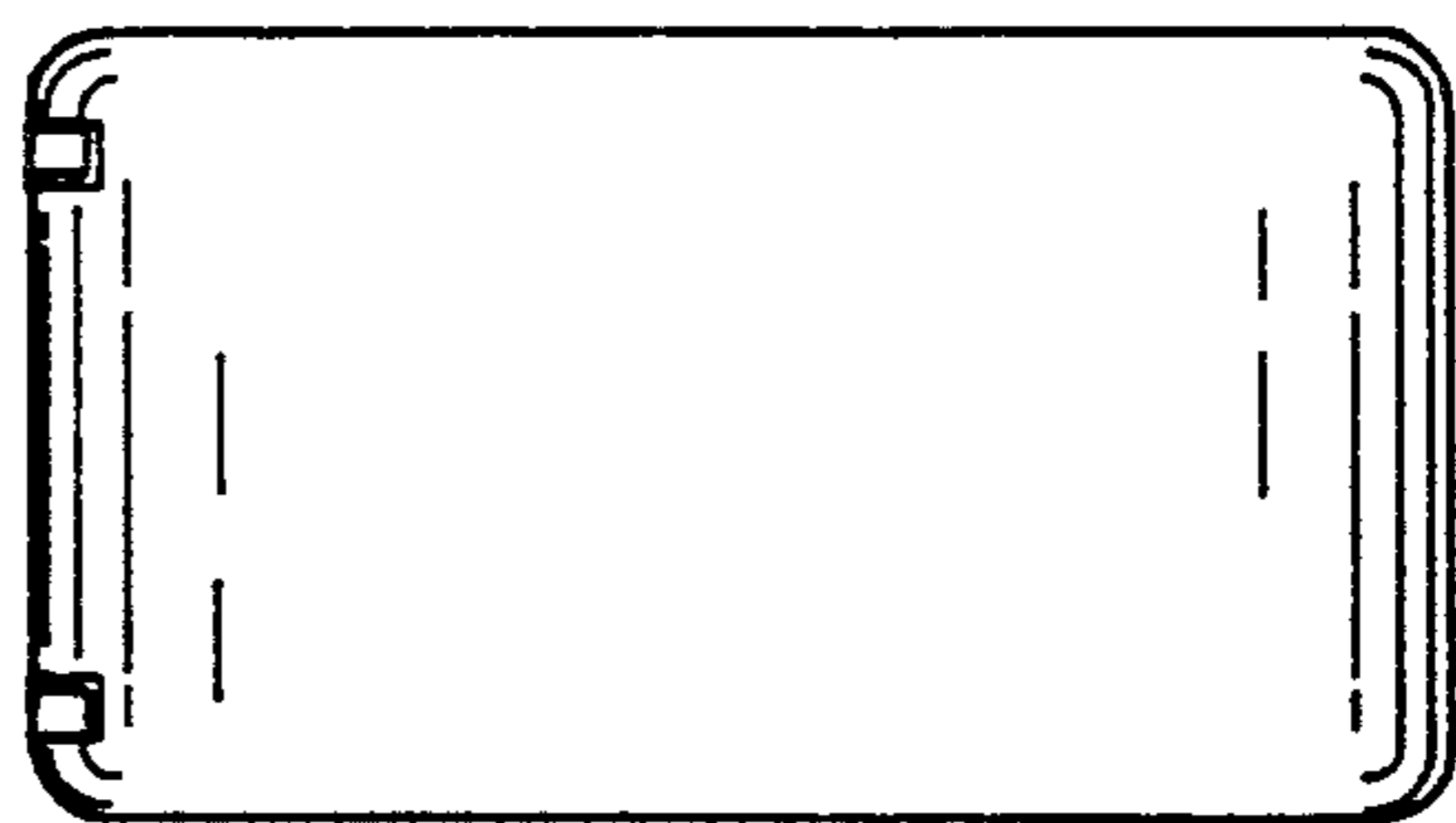

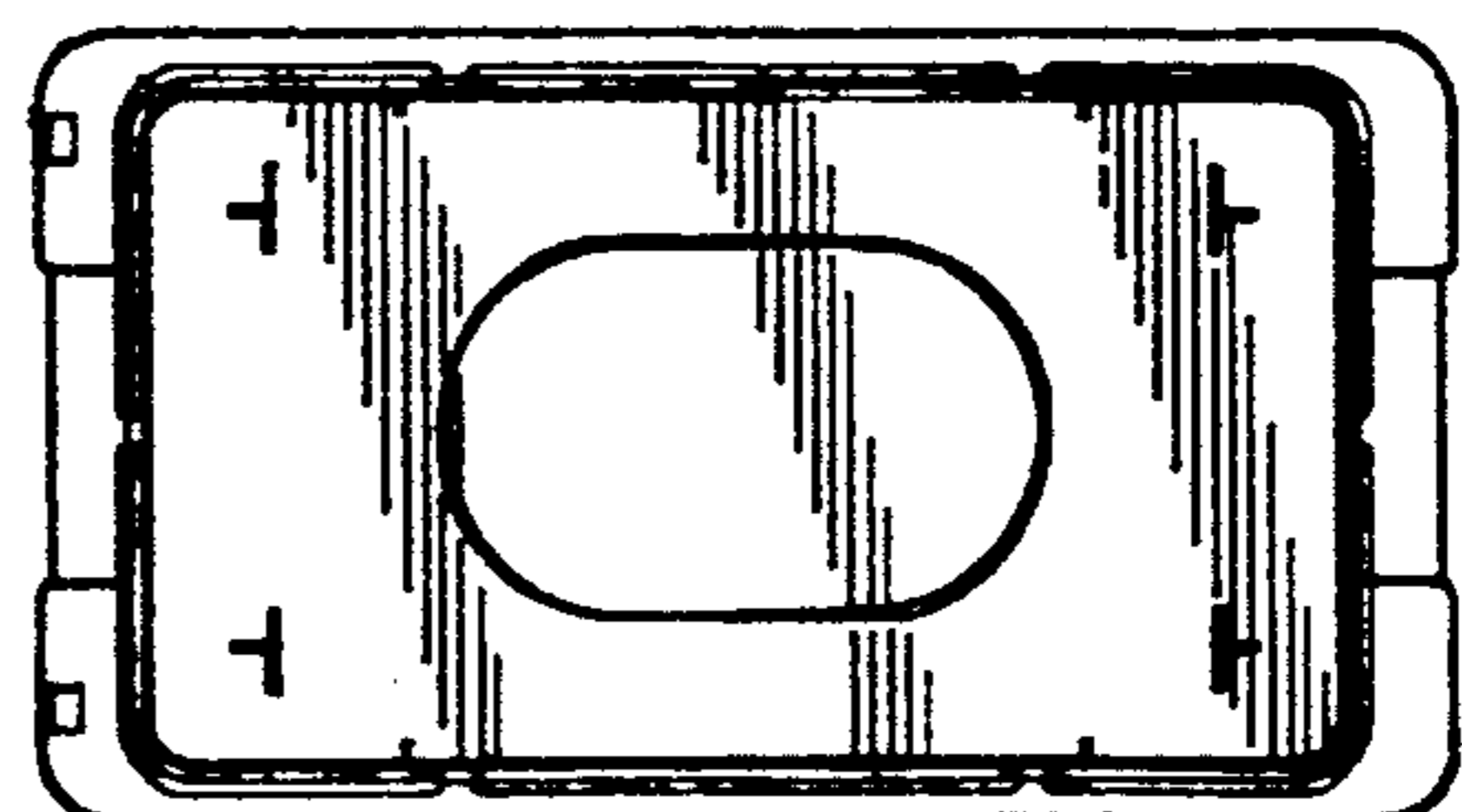

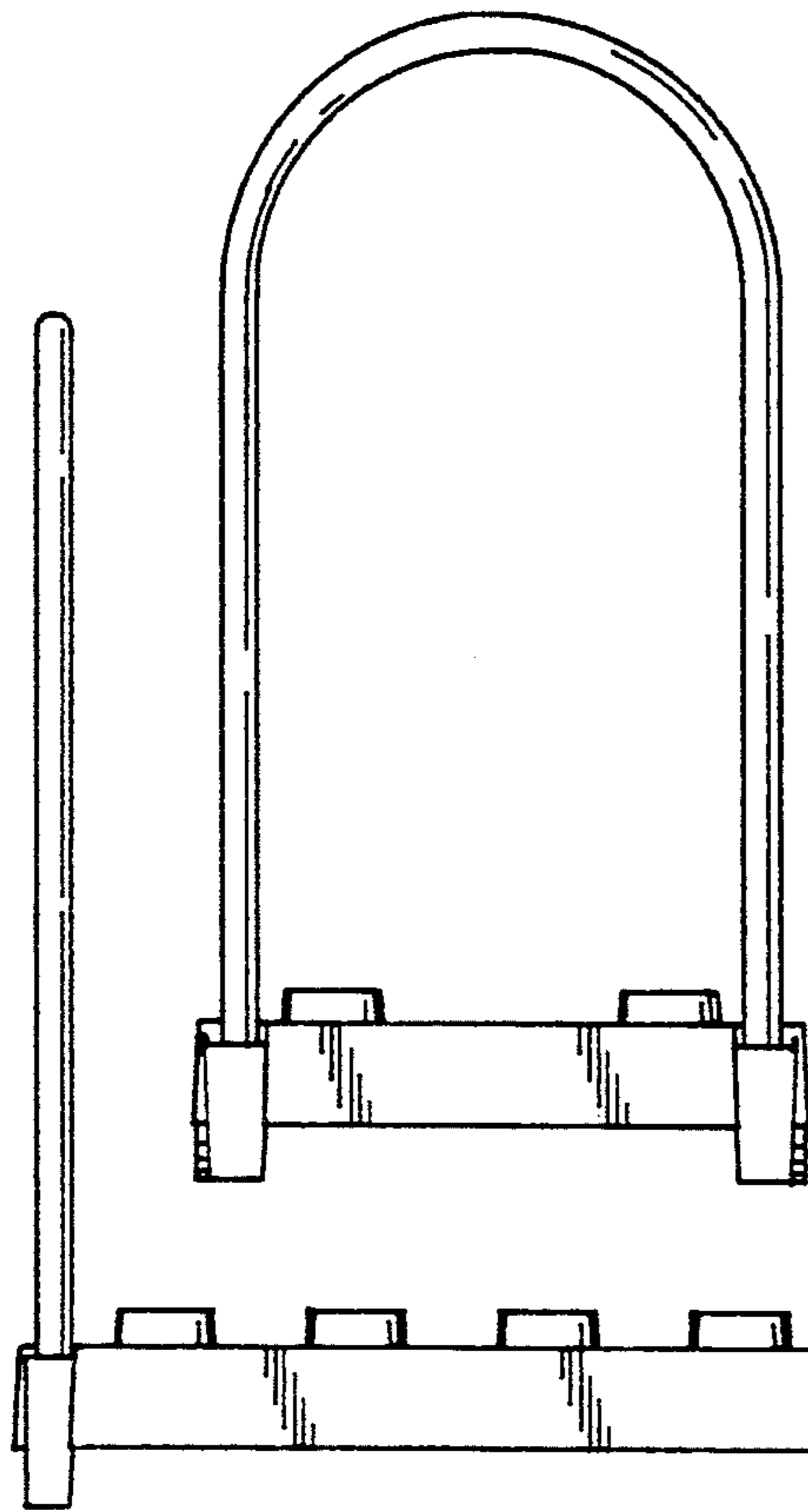

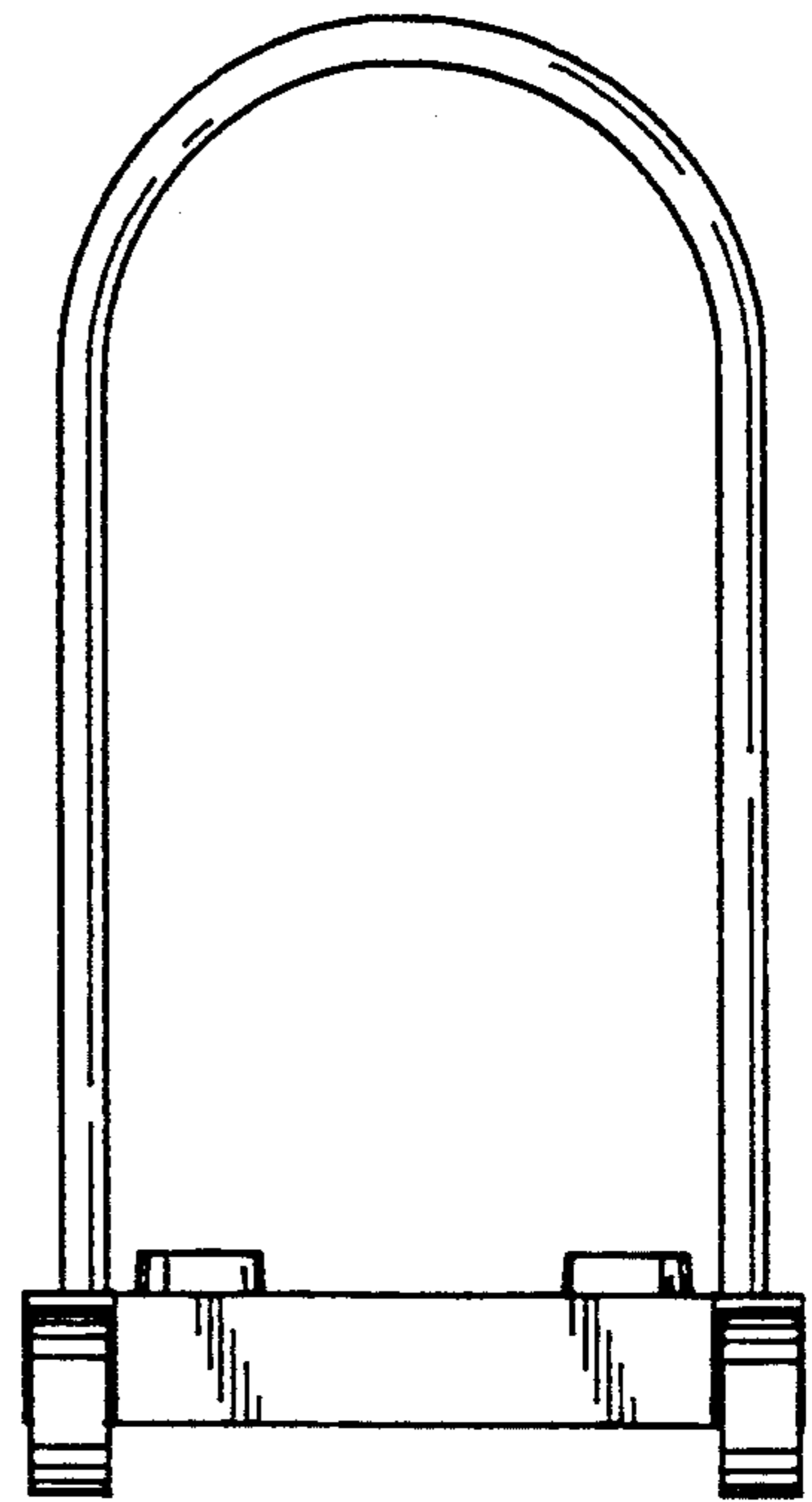

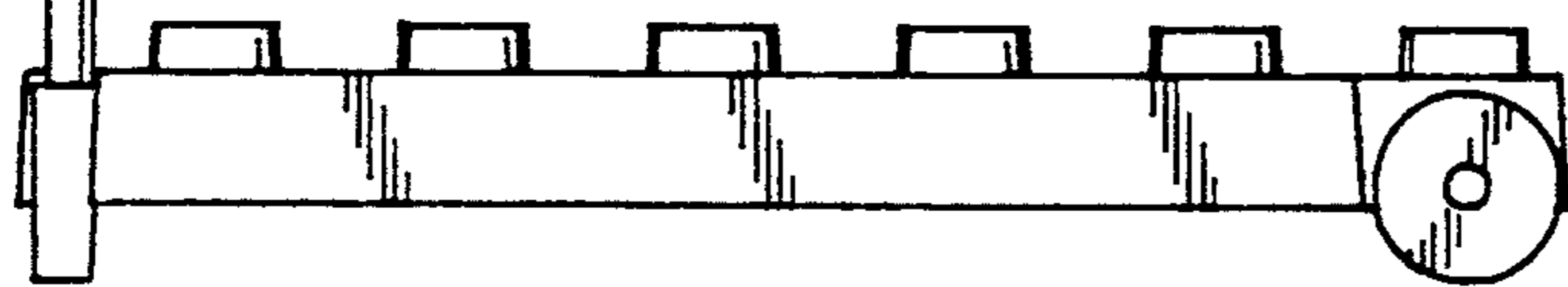

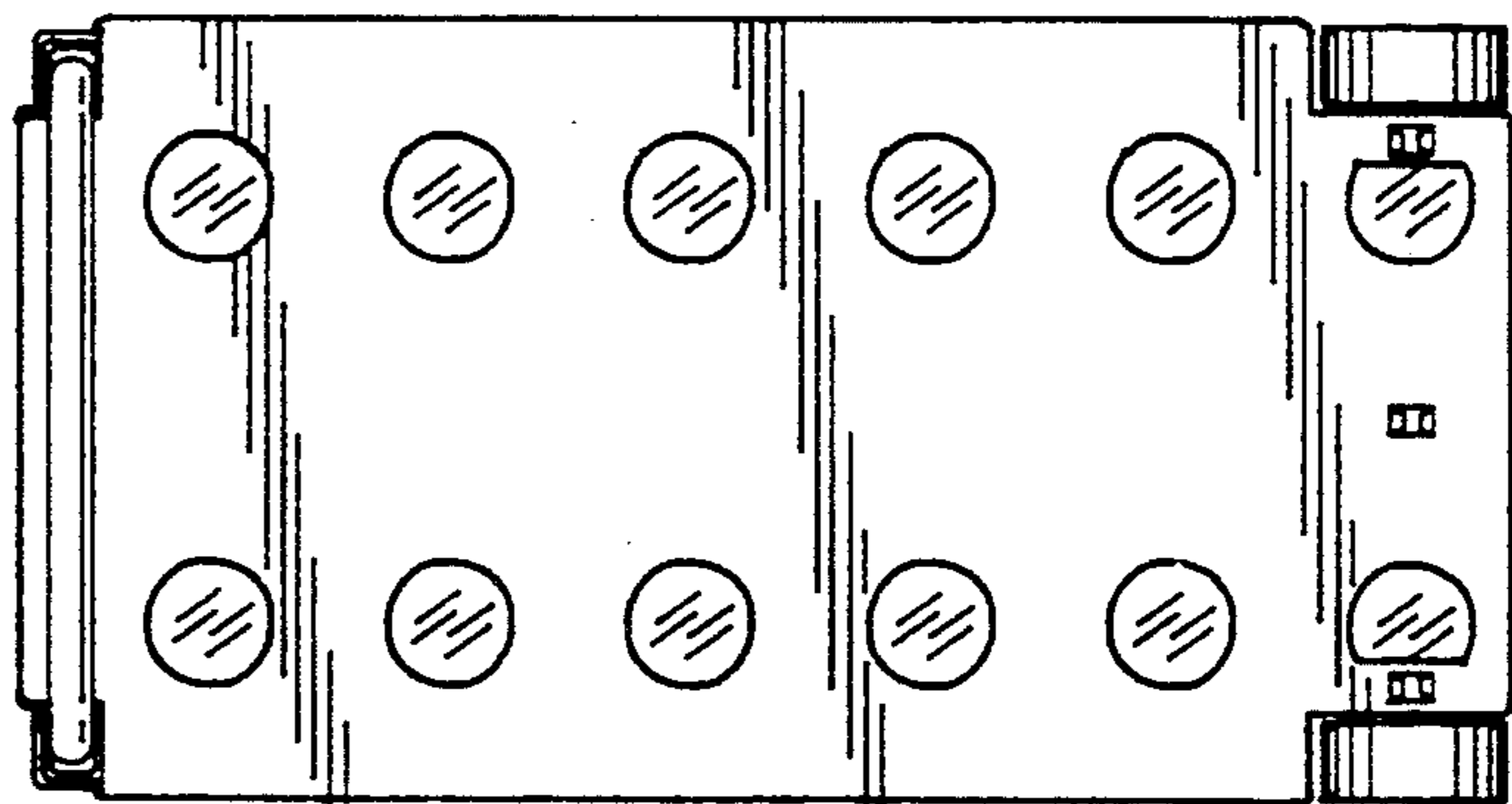

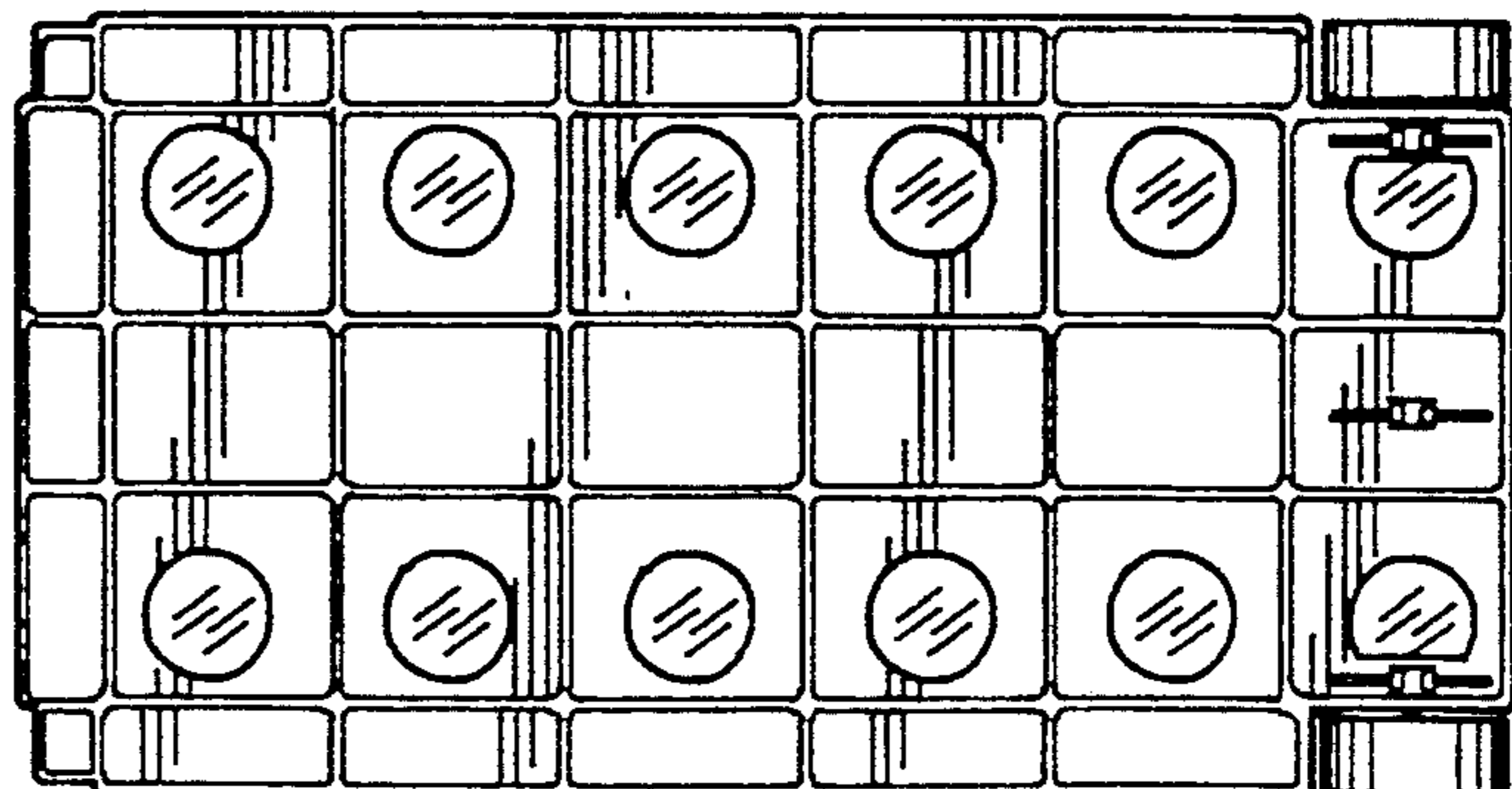

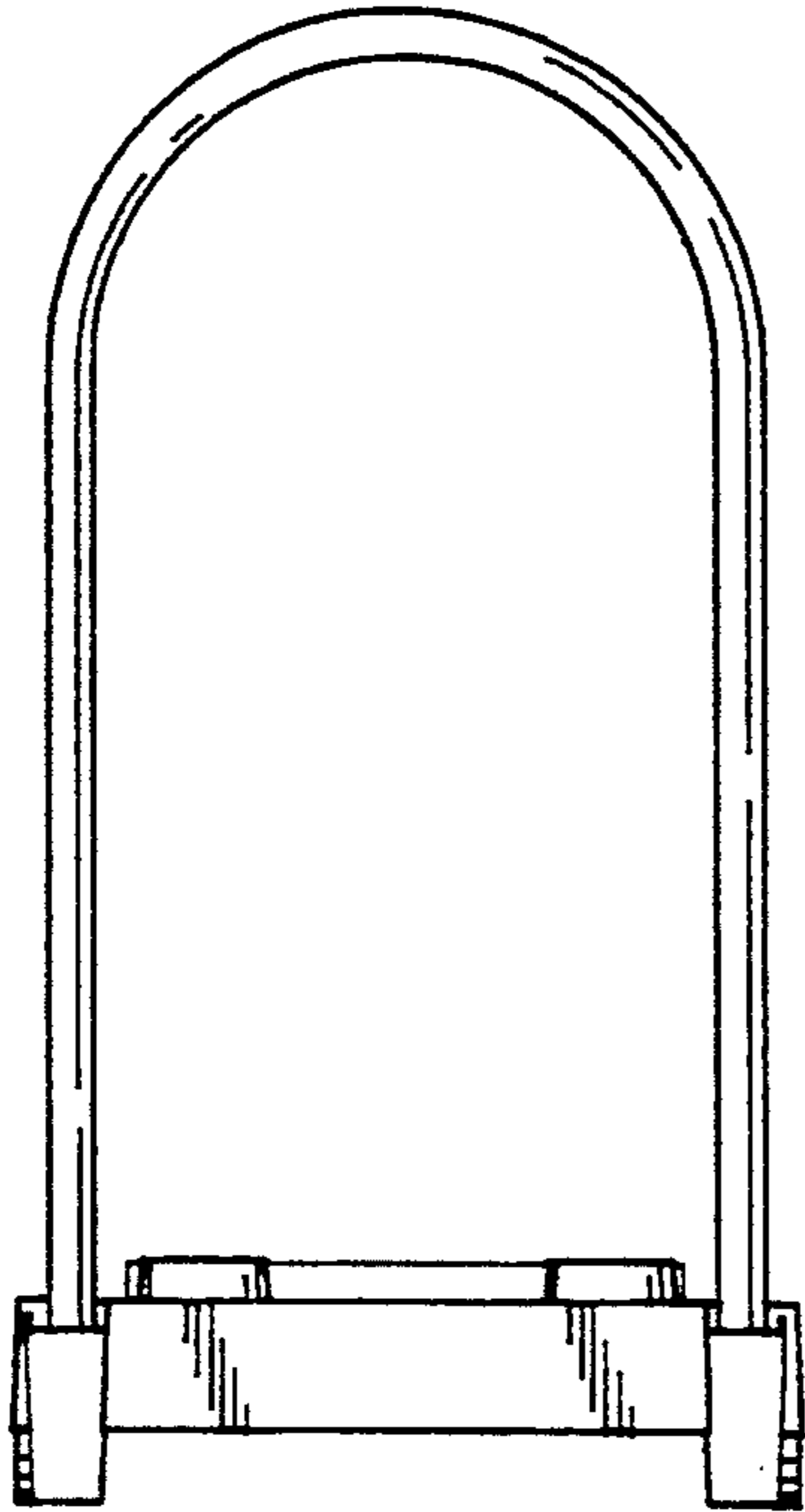

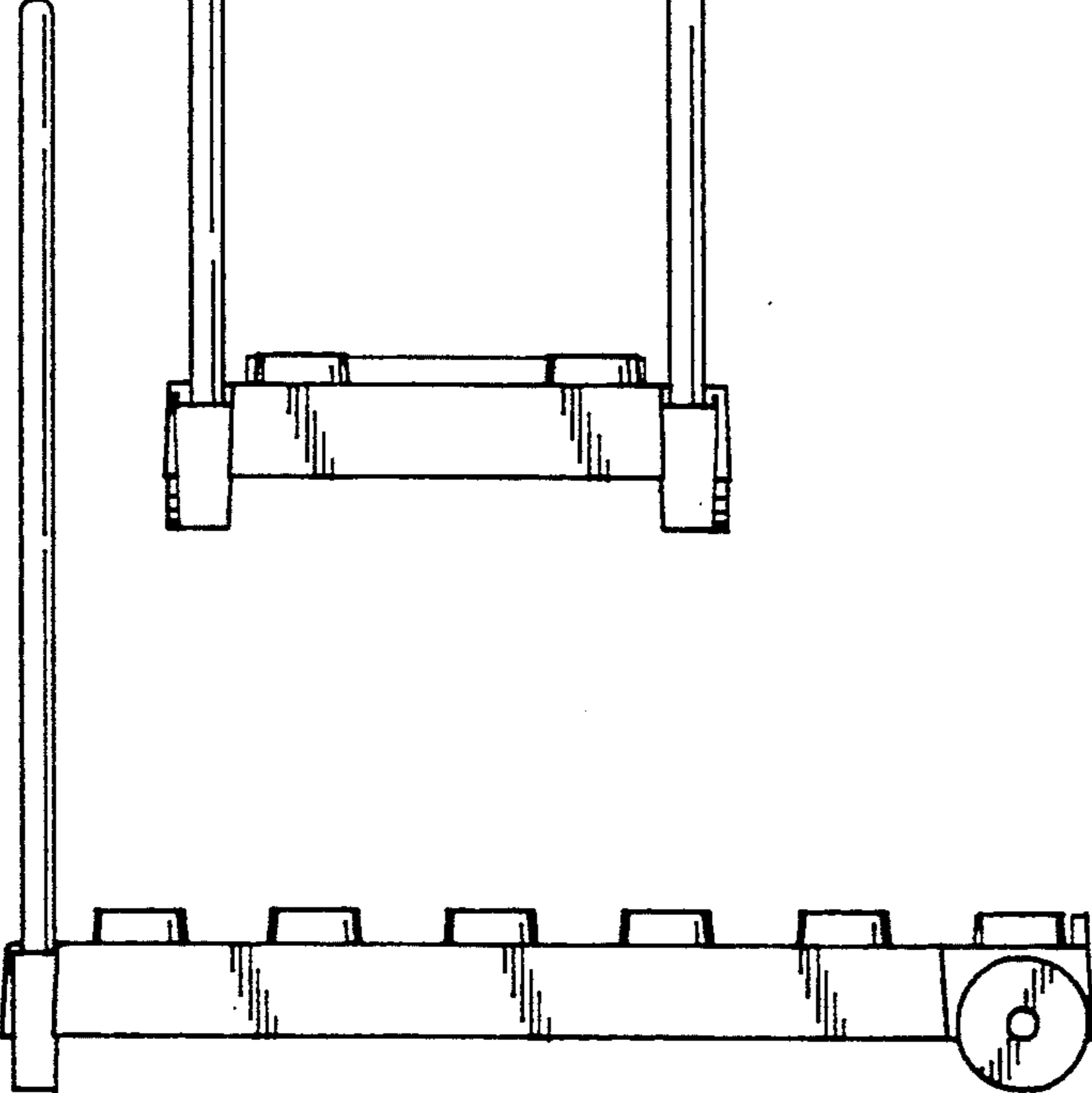
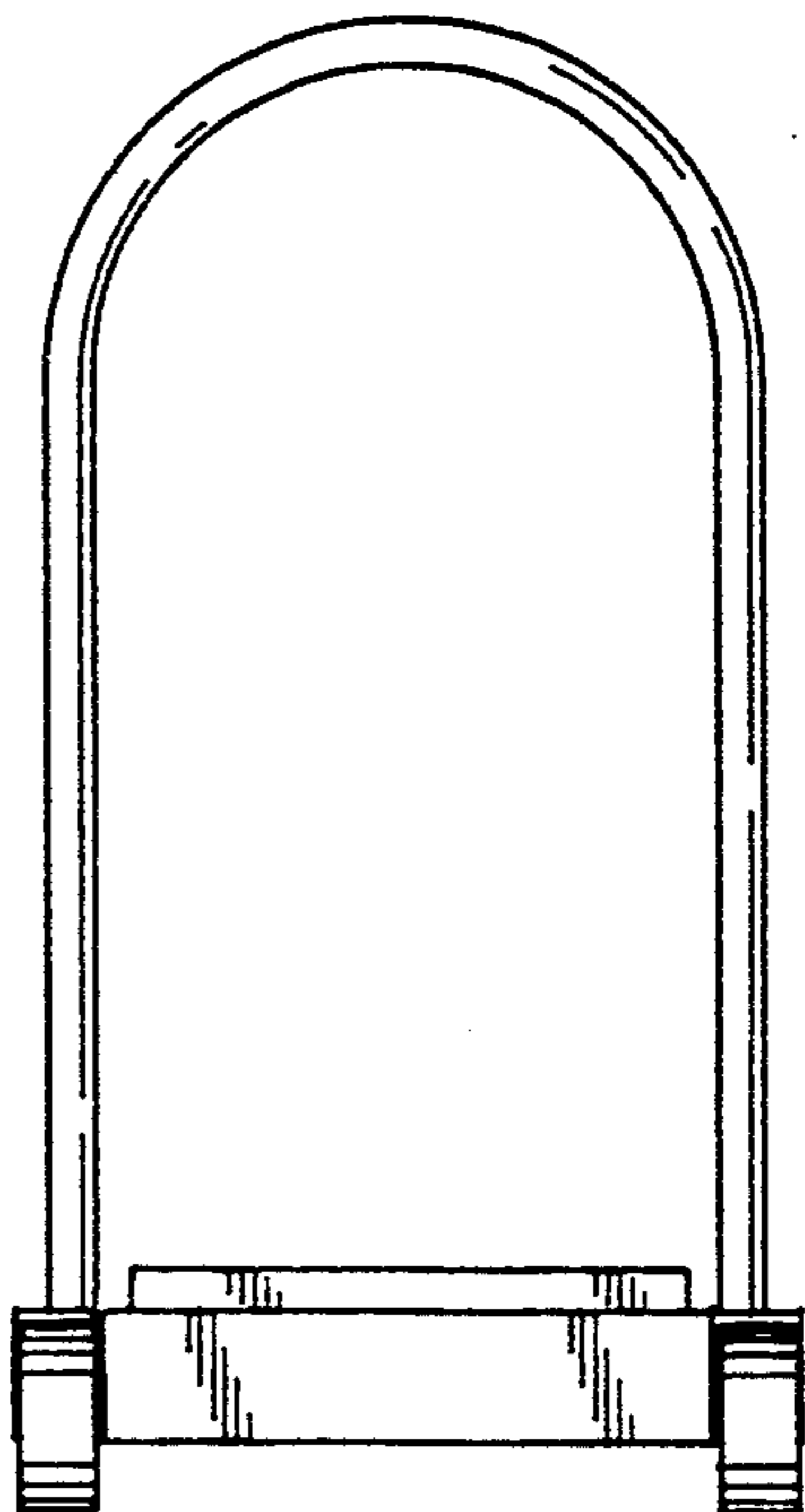

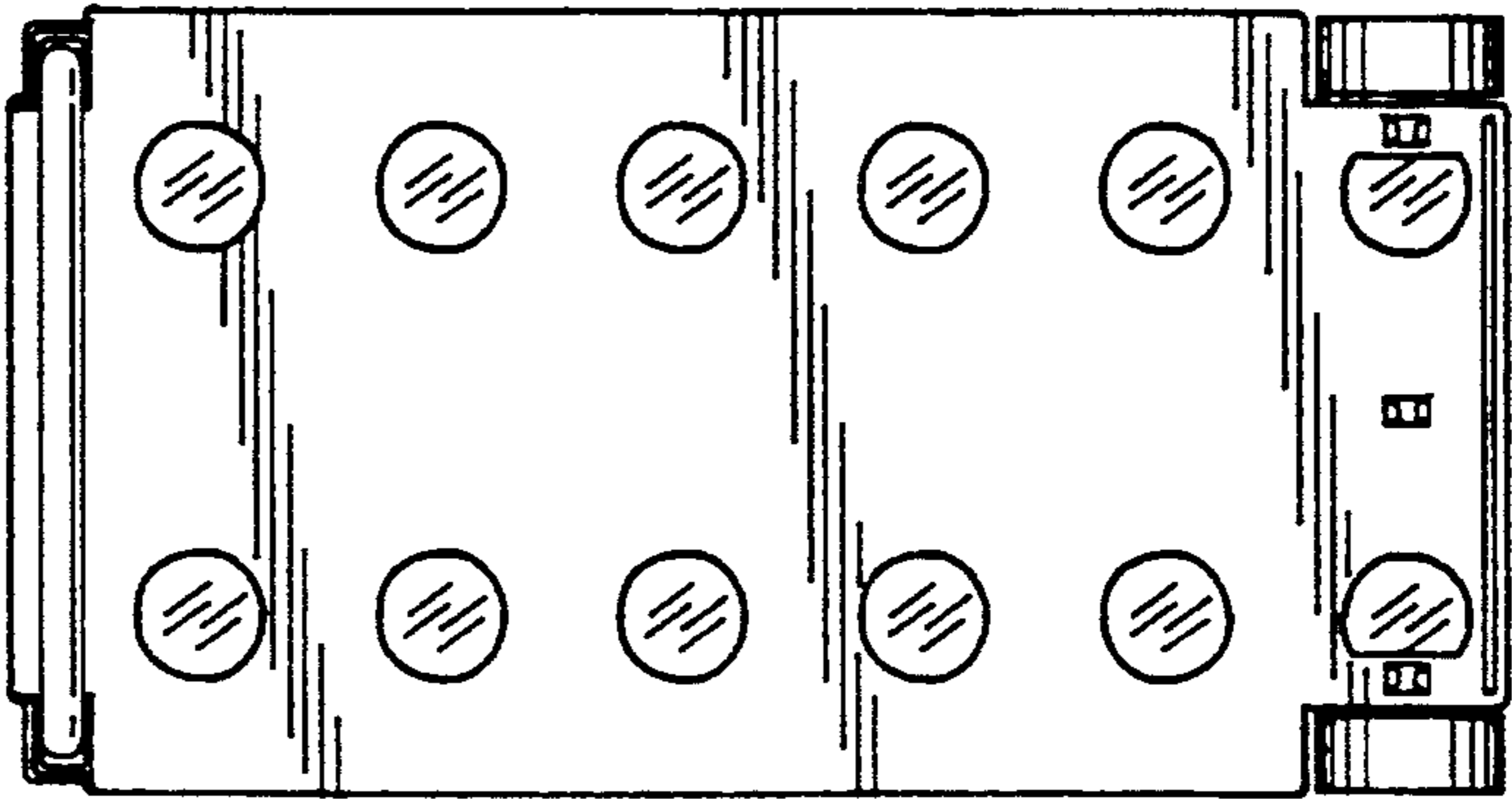

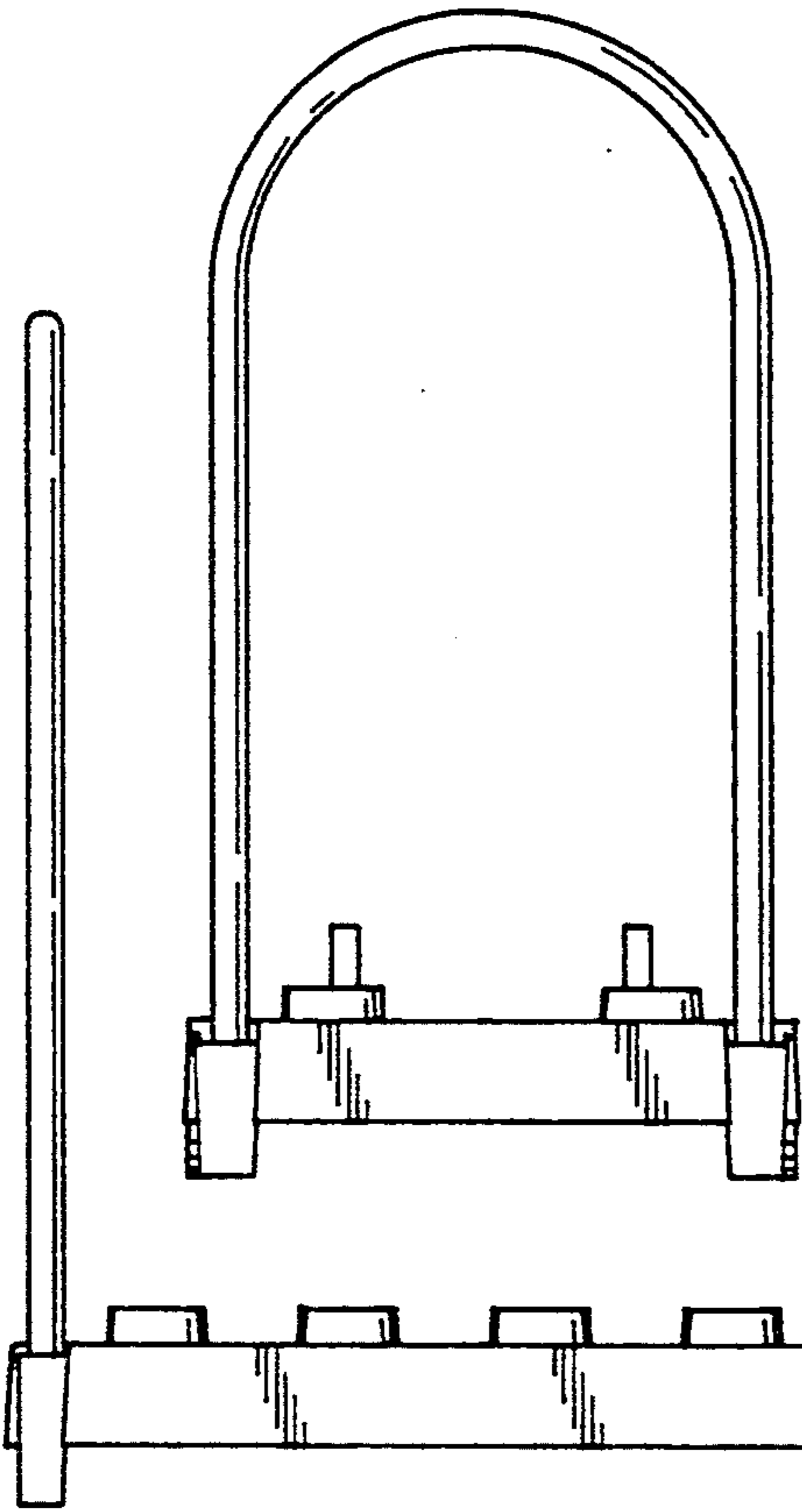

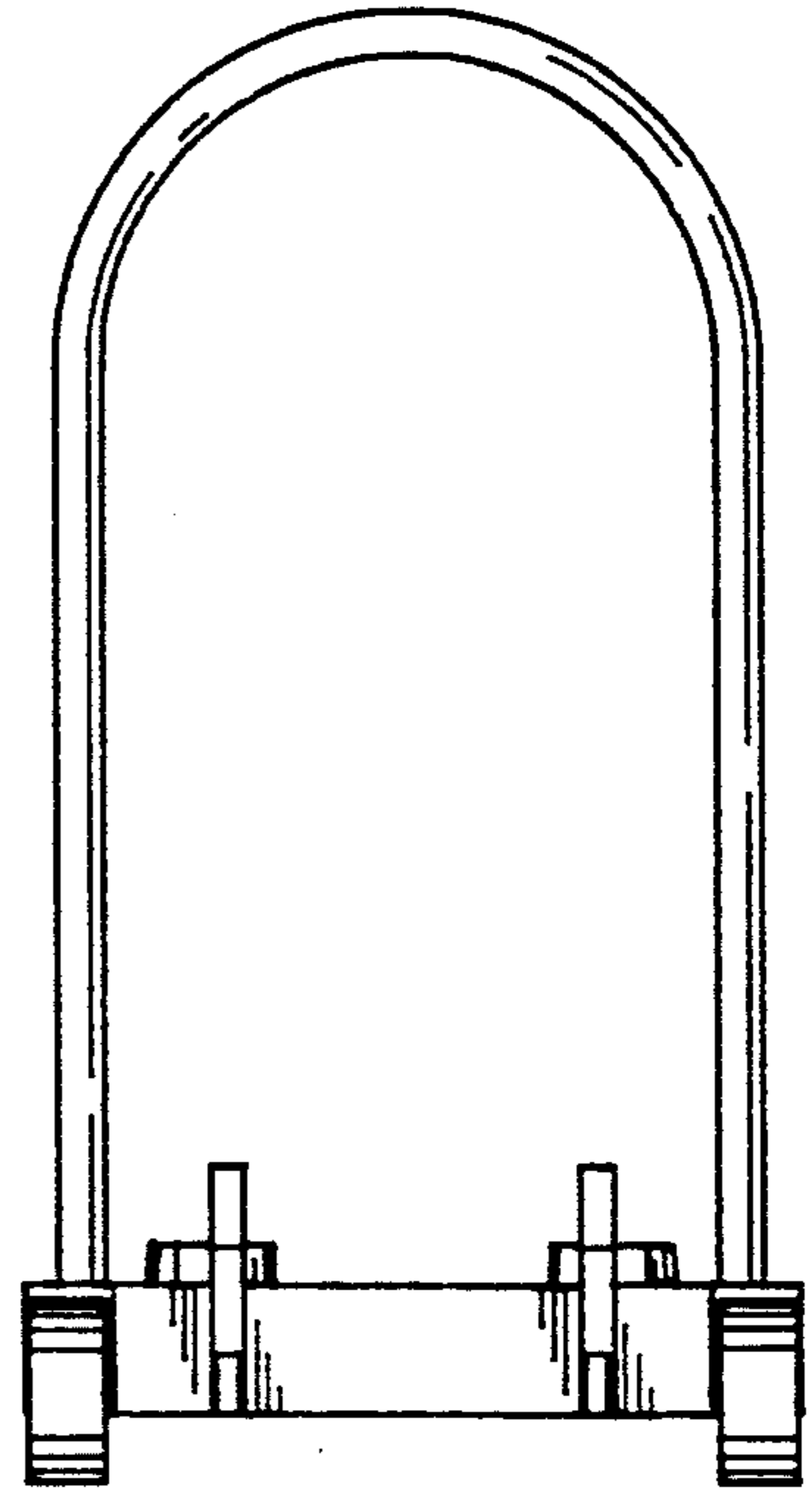

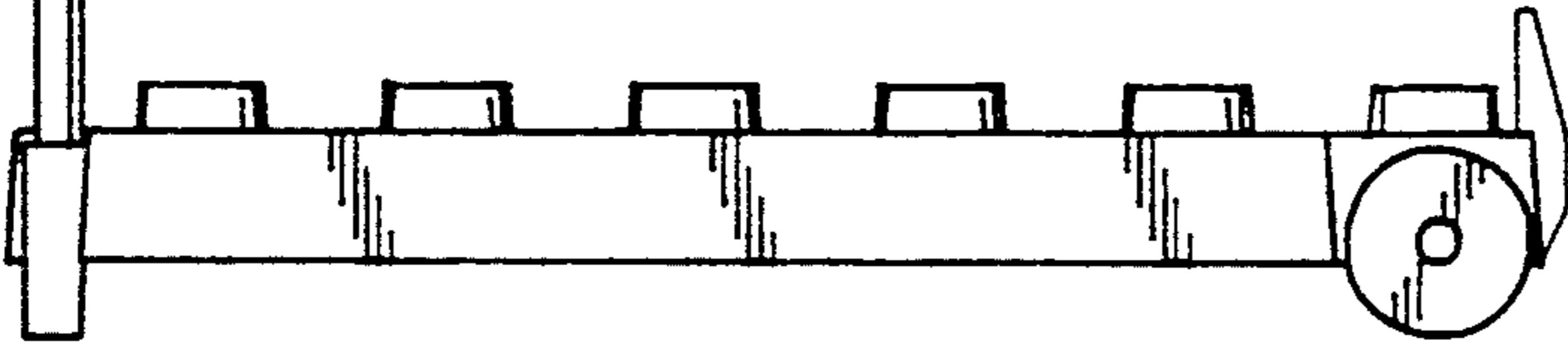

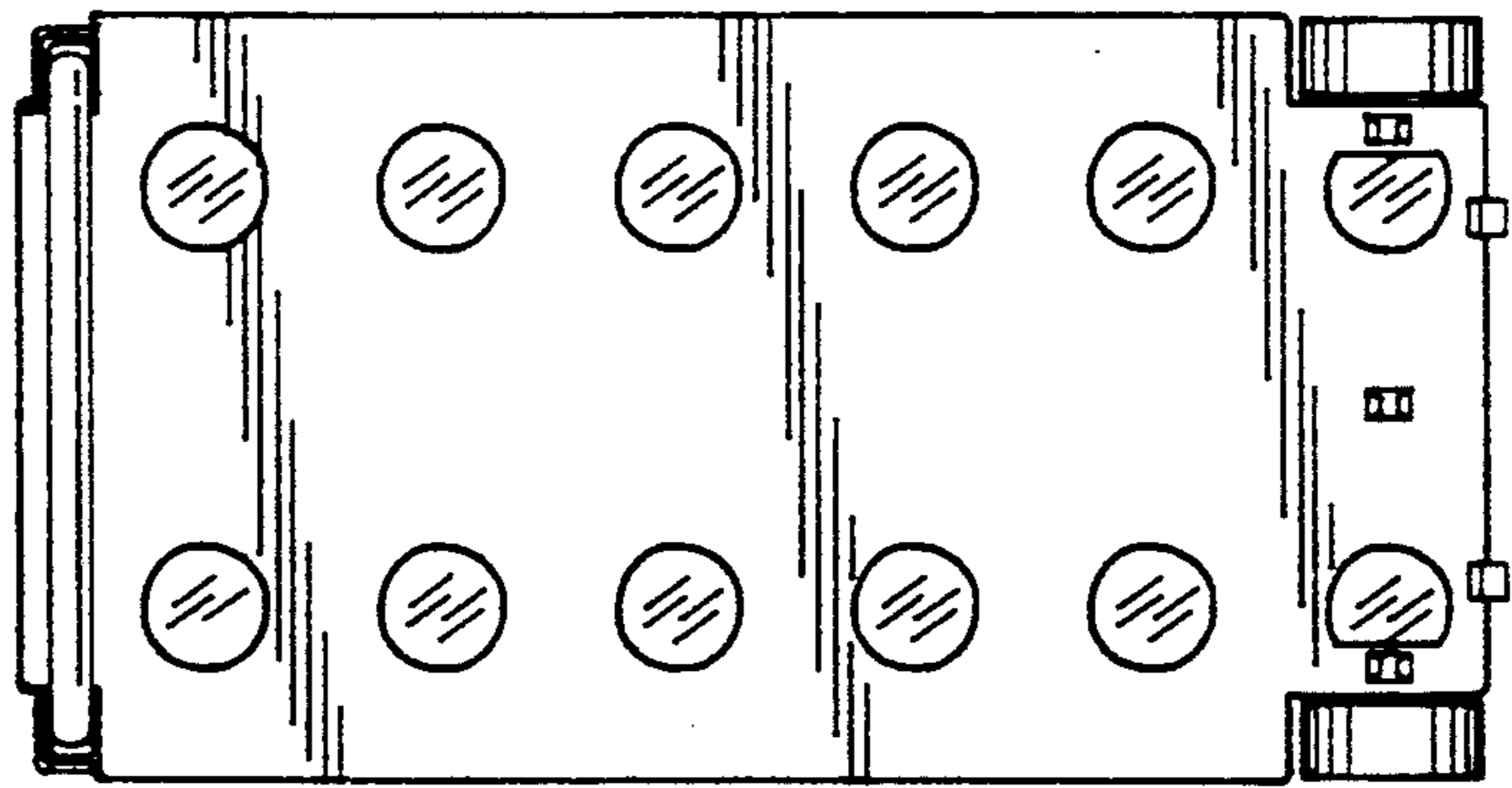
