The ornamental design for a box for collection and storage of confidential documents, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a box for collection and storage of confidential documents showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 7 is a left side elevational view thereof.

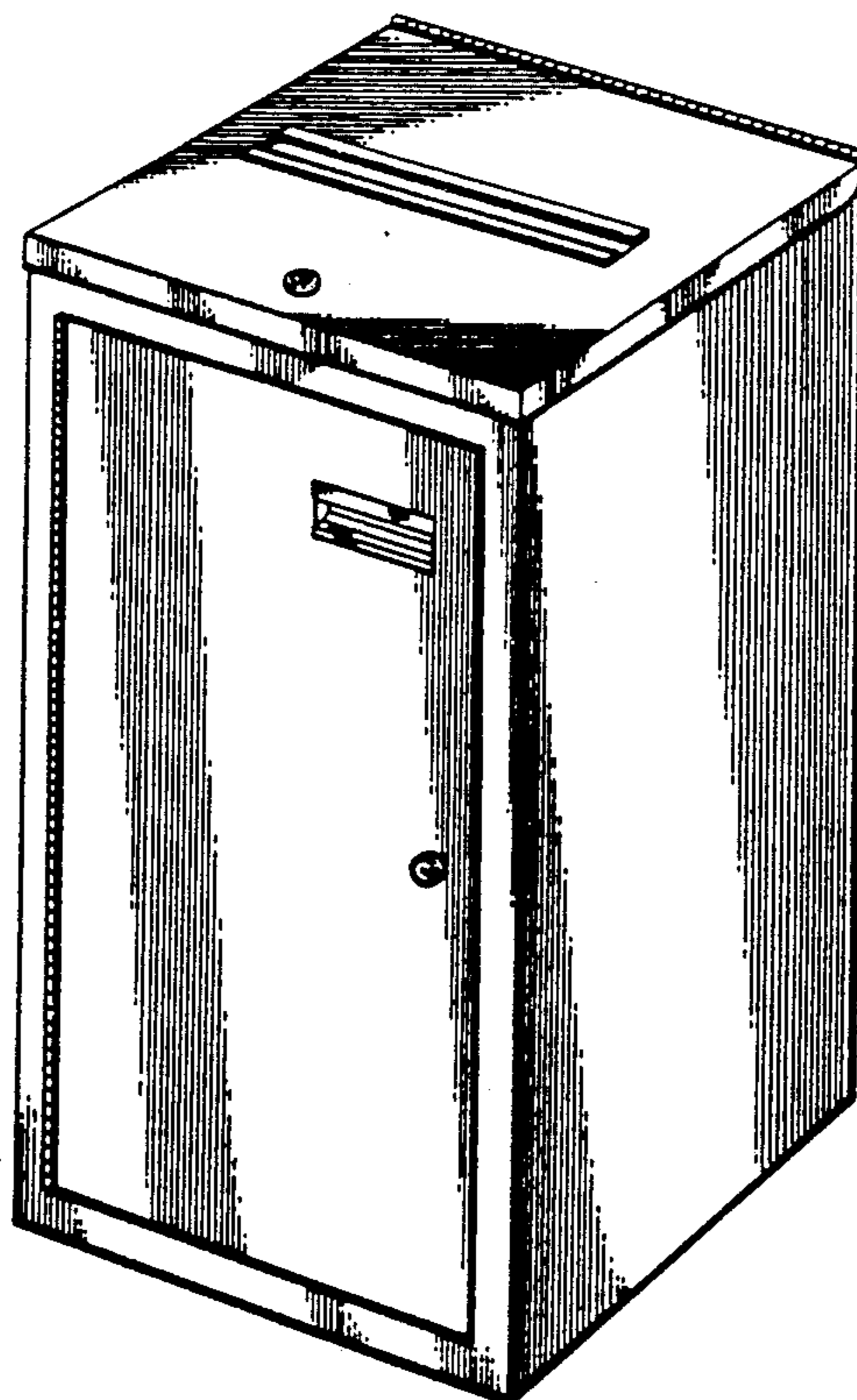

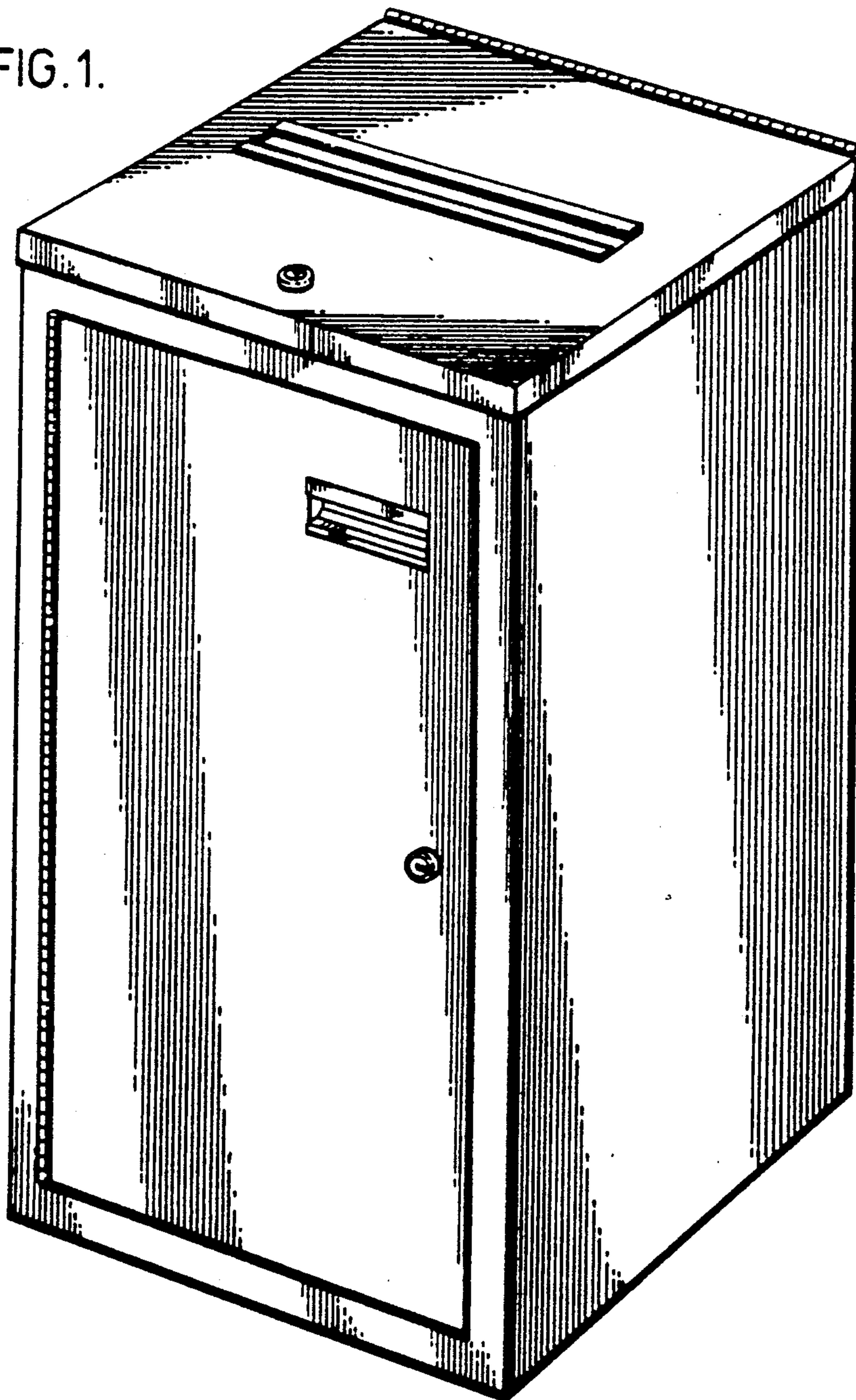

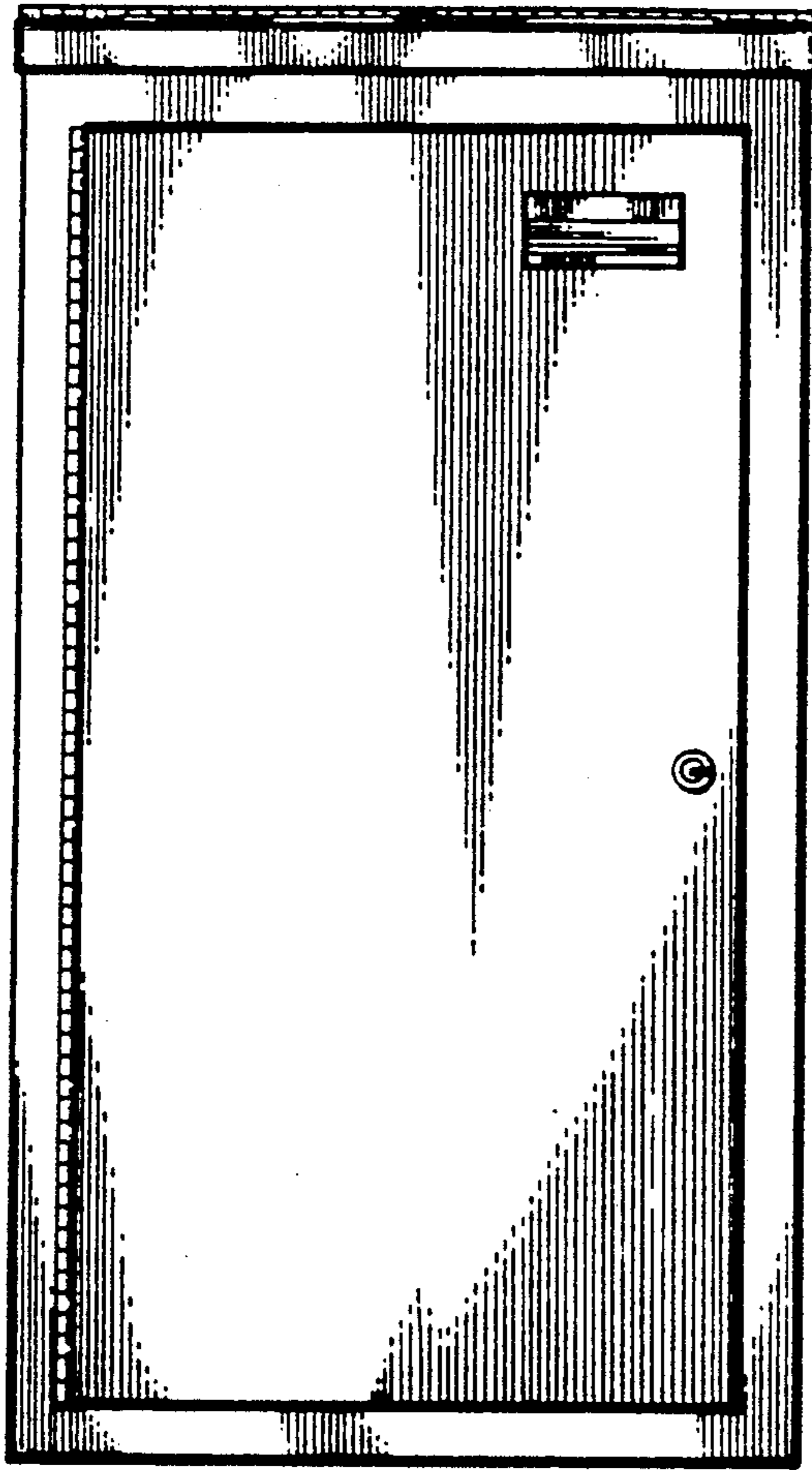

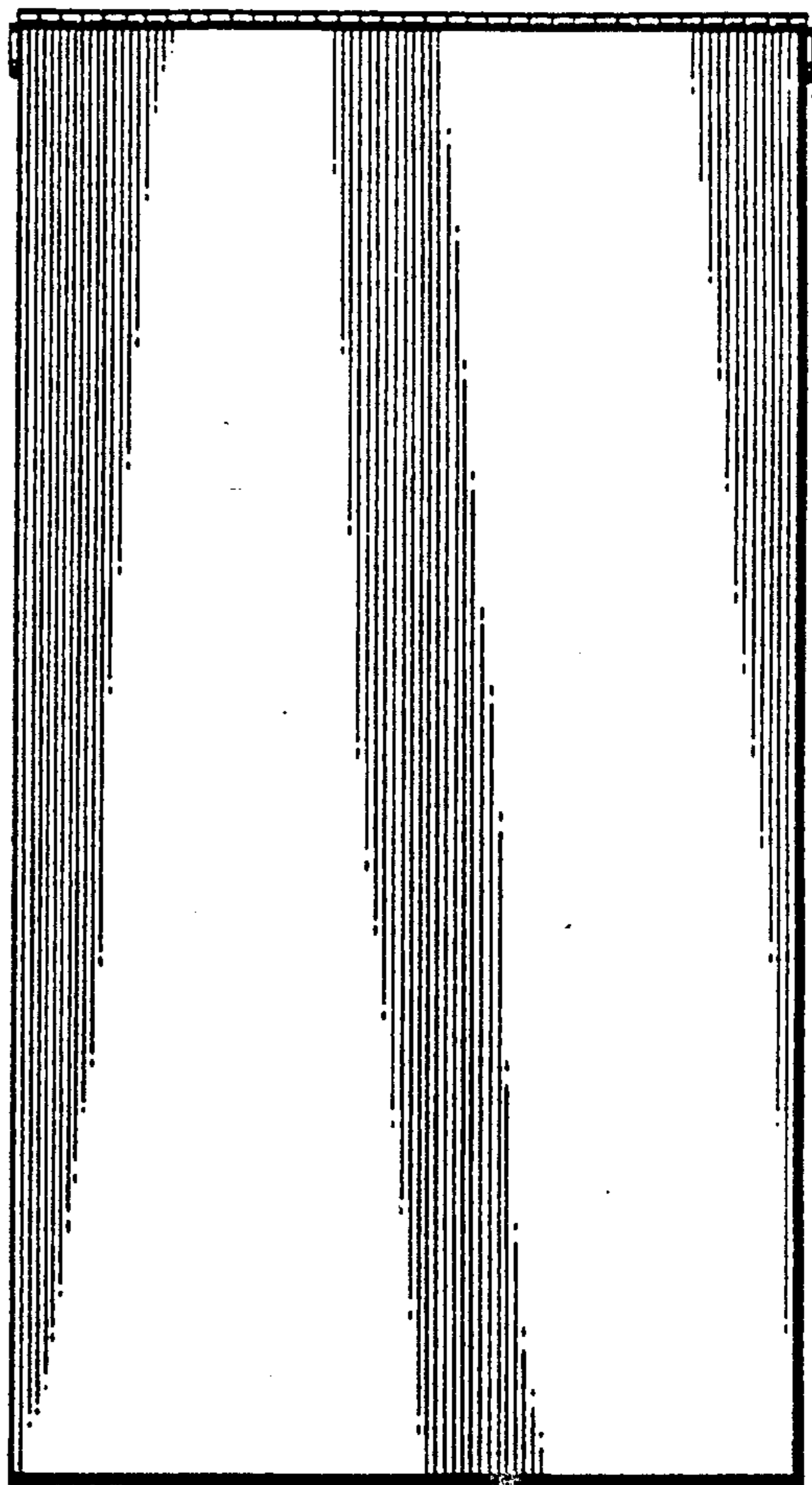

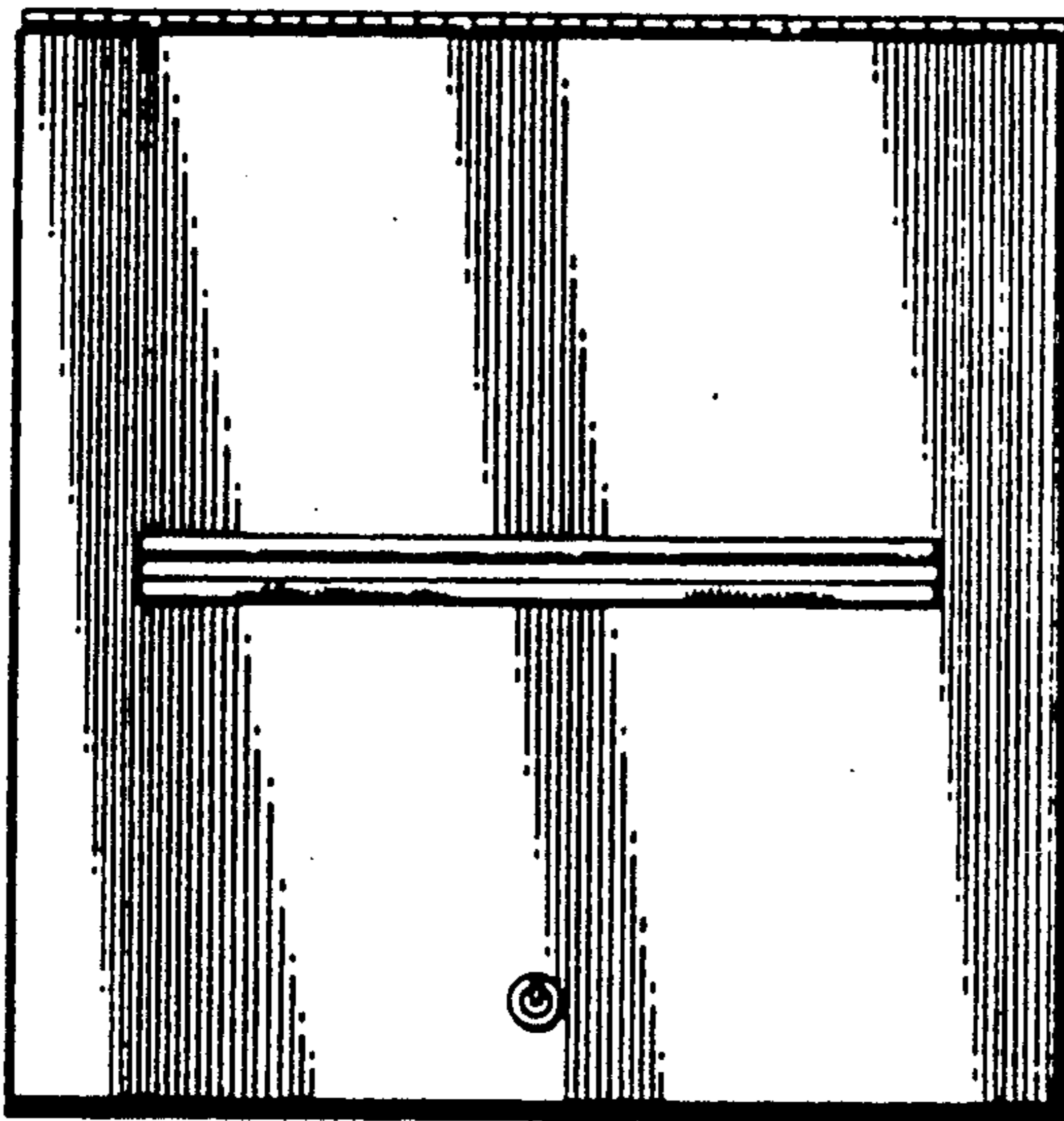

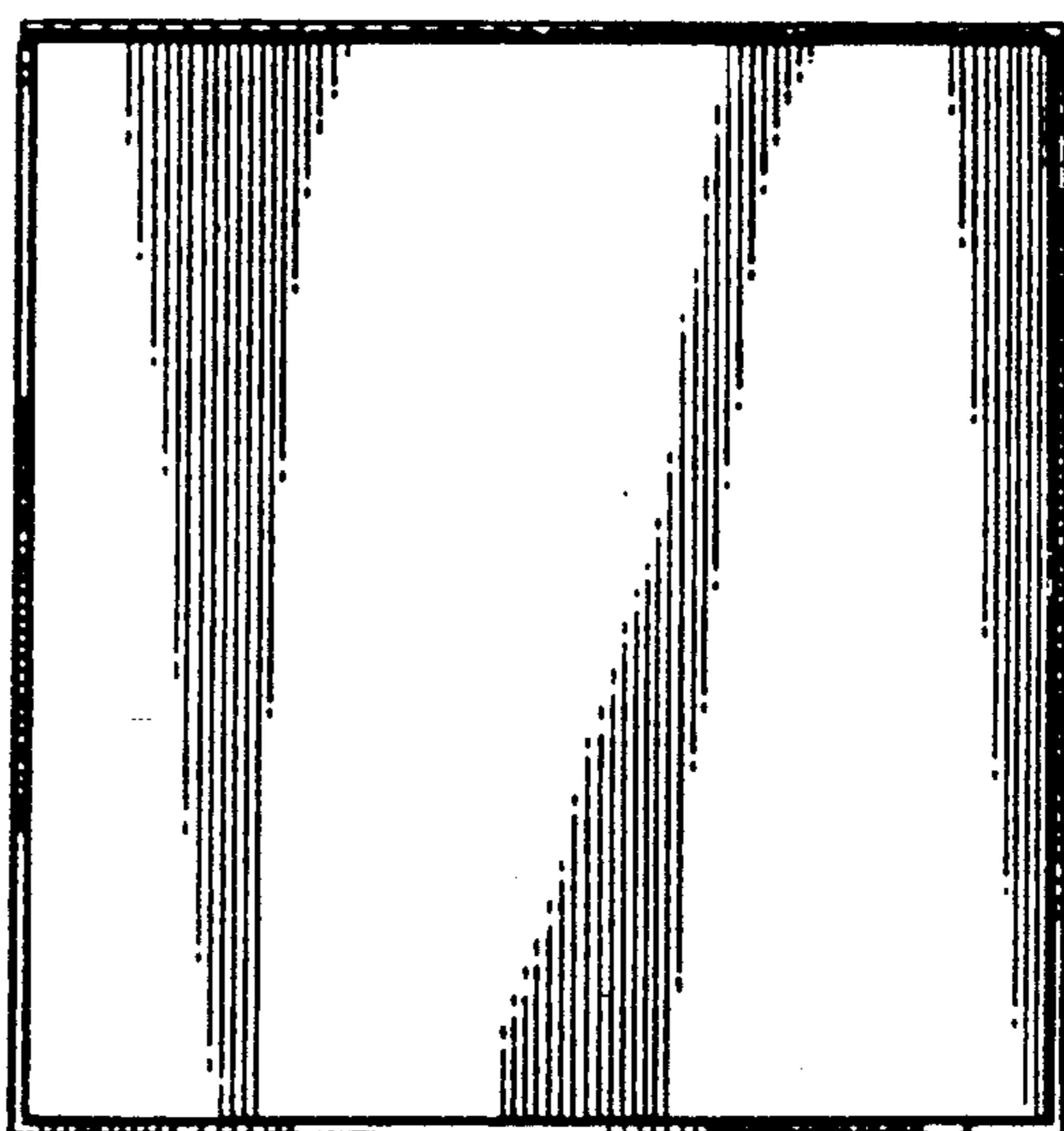

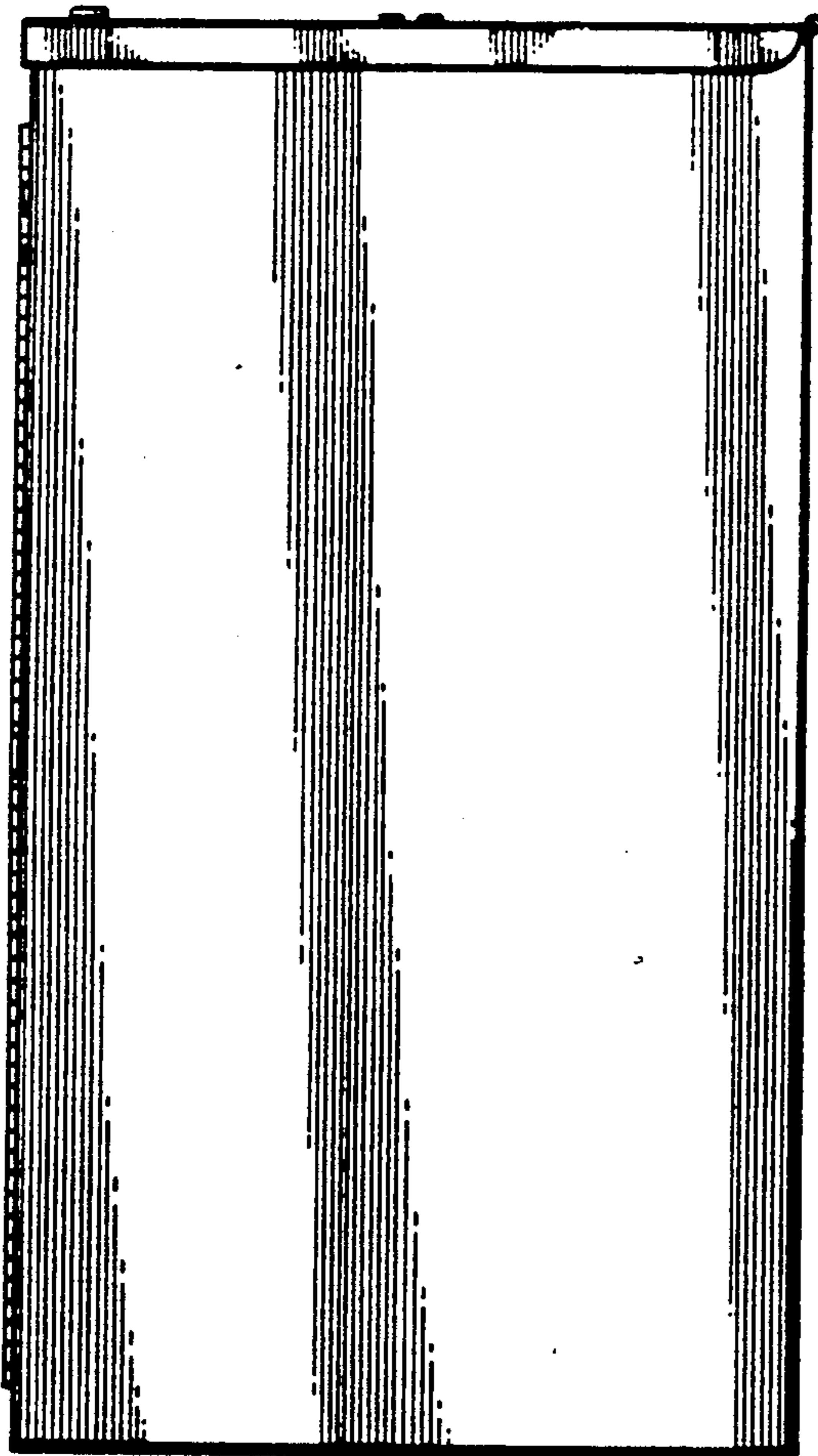
