The ornamental design for basket, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a basket showing our new design;

FIG. 2 is a left side perspective view thereof; the right side perspective view being a mirror image thereof;

FIG. 3 is a front perspective view thereof; the rear perspective view being a mirror image thereof;

FIG. 4 is a top perspective view thereof;

FIG. 5 is a perspective view of a second embodiment of FIG. 1.

FIG. 6 is a right side perspective view of FIG. 5; the left side perspective view being a mirror image thereof;

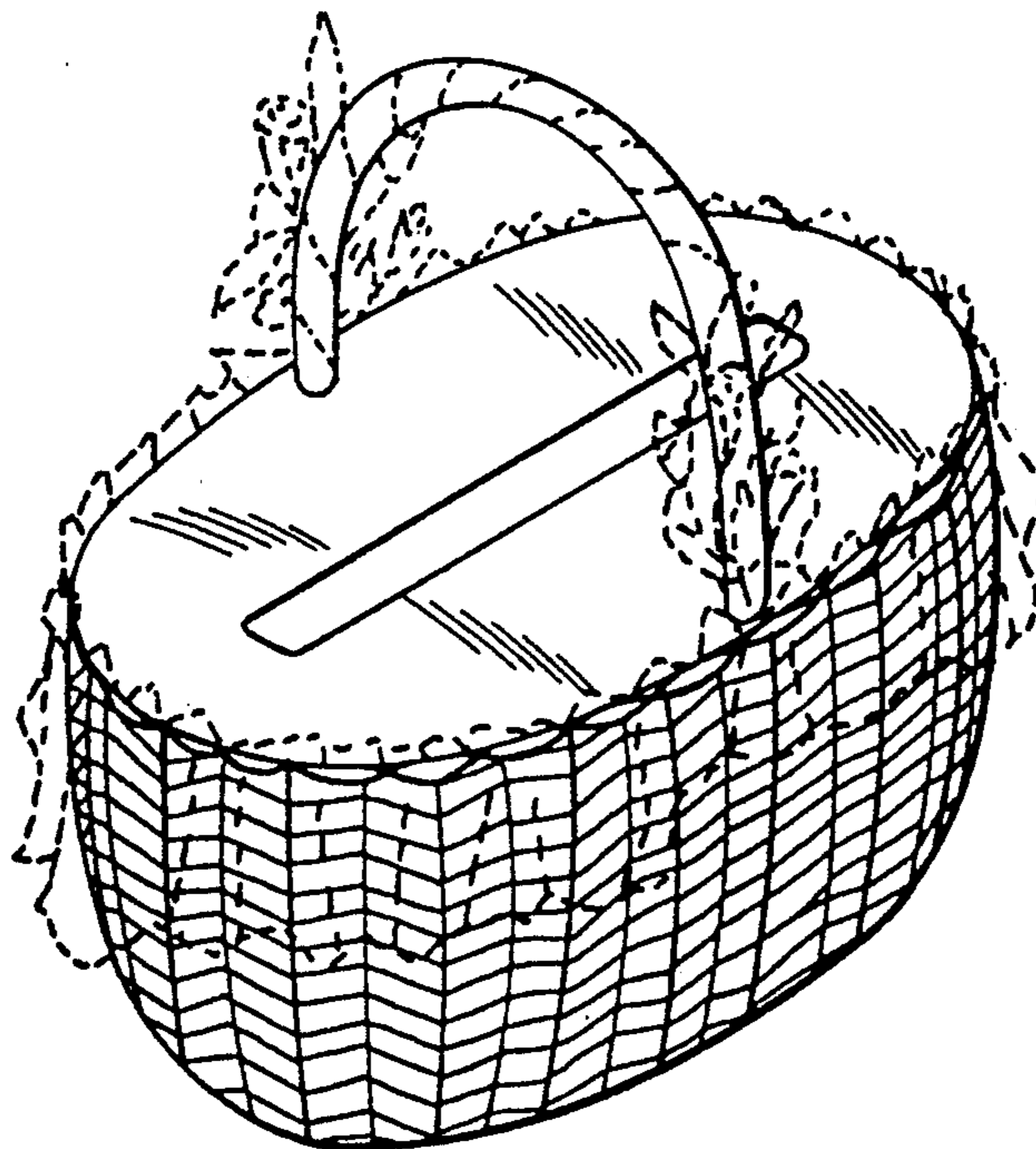
FIG. 7 is a front perspective view of FIG. 5; the rear perspective view being a mirror image thereof;

FIG. 8 is a top perspective view of FIG. 5; and,

FIG. 9 is a bottom perspective view of FIG. 5.

The broken line showing ribbons, bows and flowers is for illustrative purposes only and forms no part of the claim.

The undisclosed bottom portion is similar to FIG. 9, with the exception that it follows the general configuration of the basket, as best illustrated in FIG. 1.



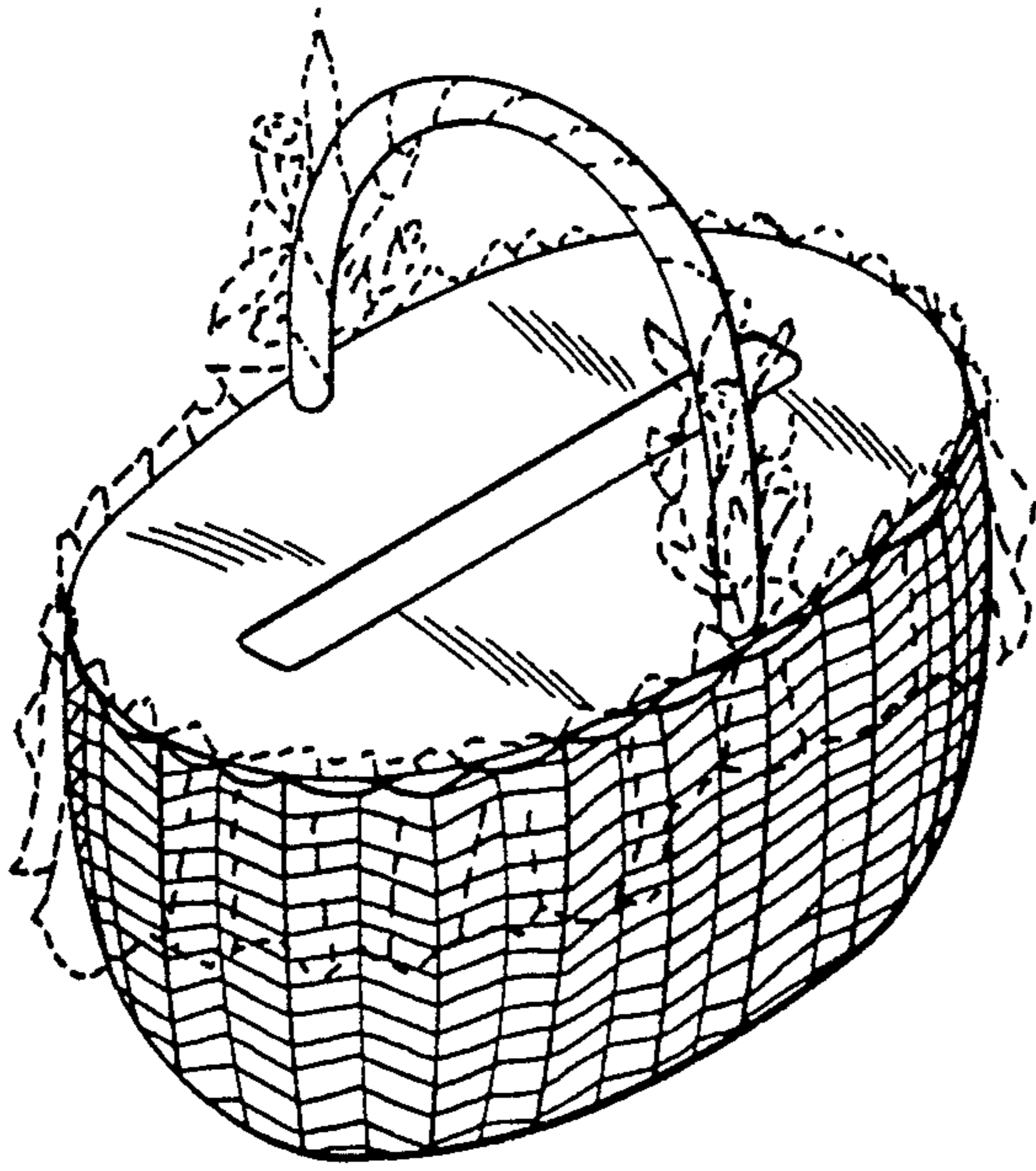

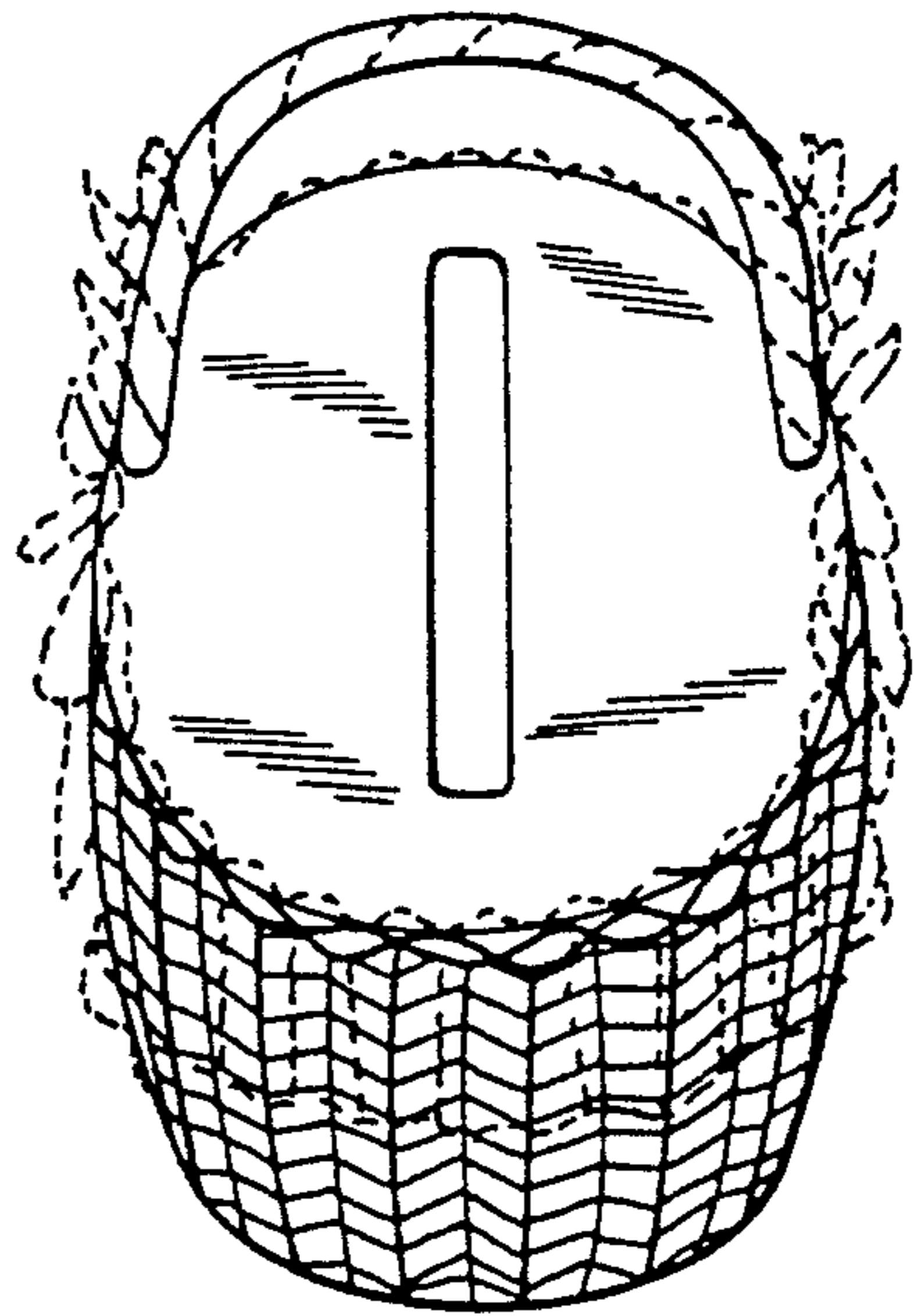

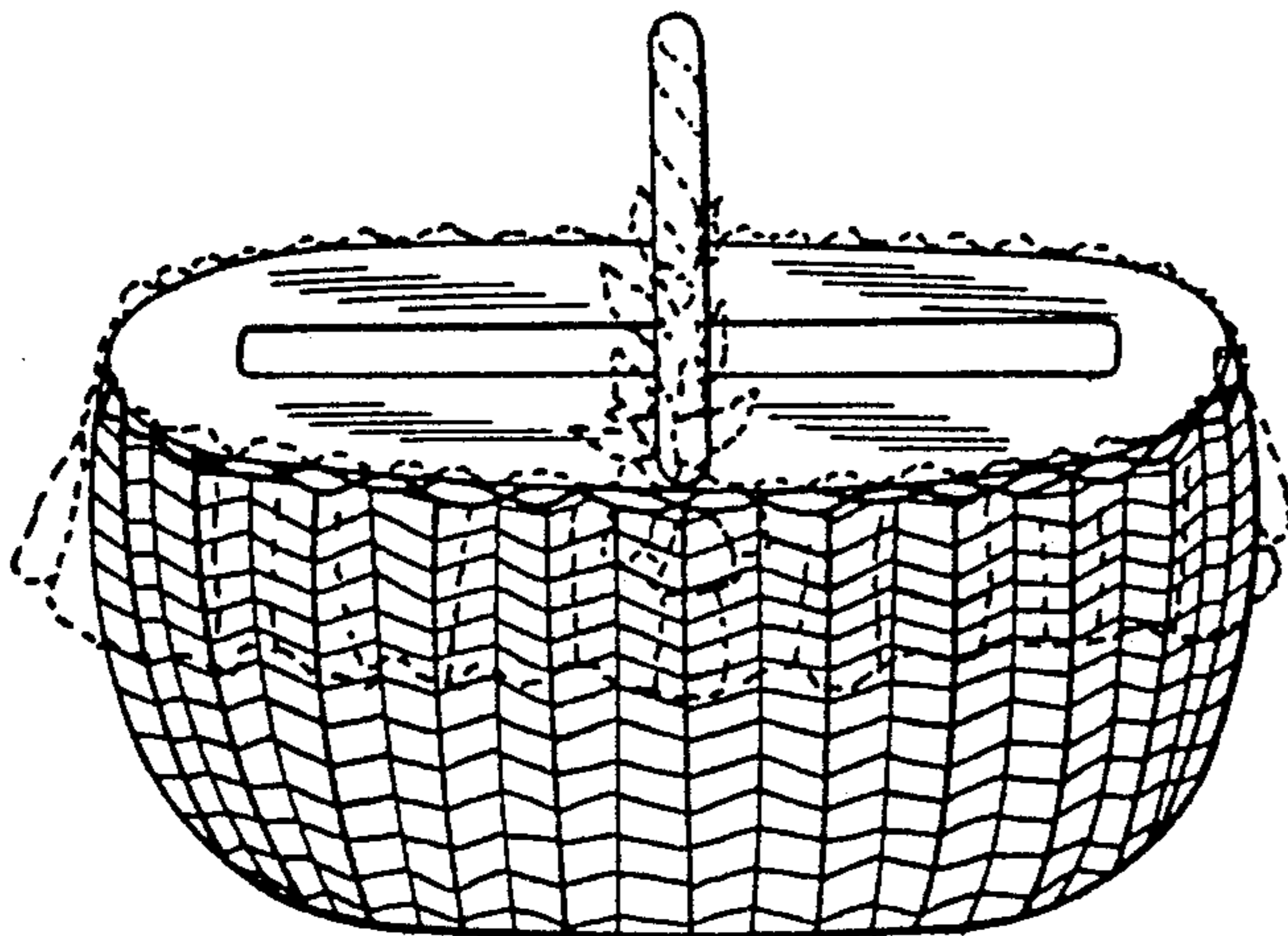

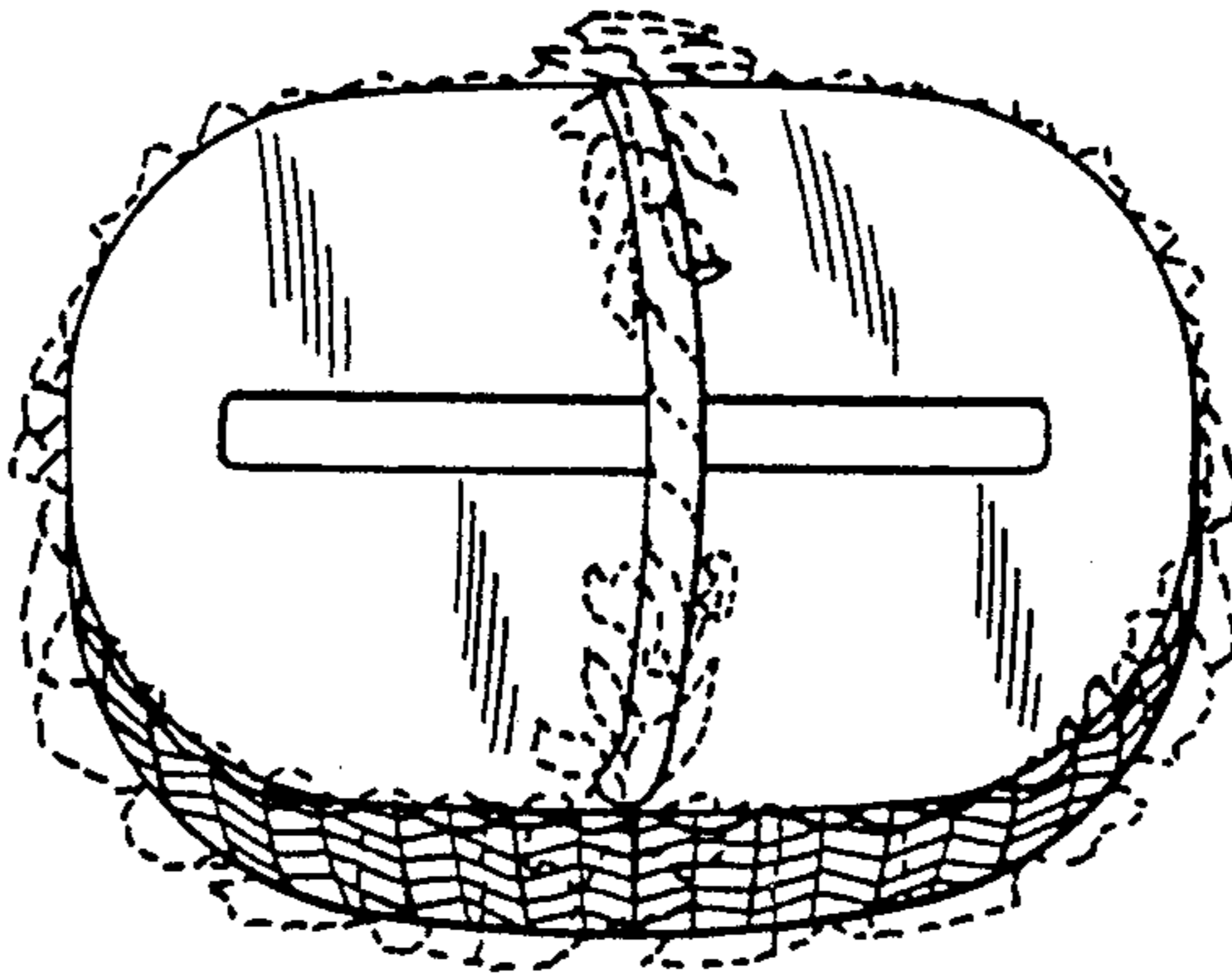

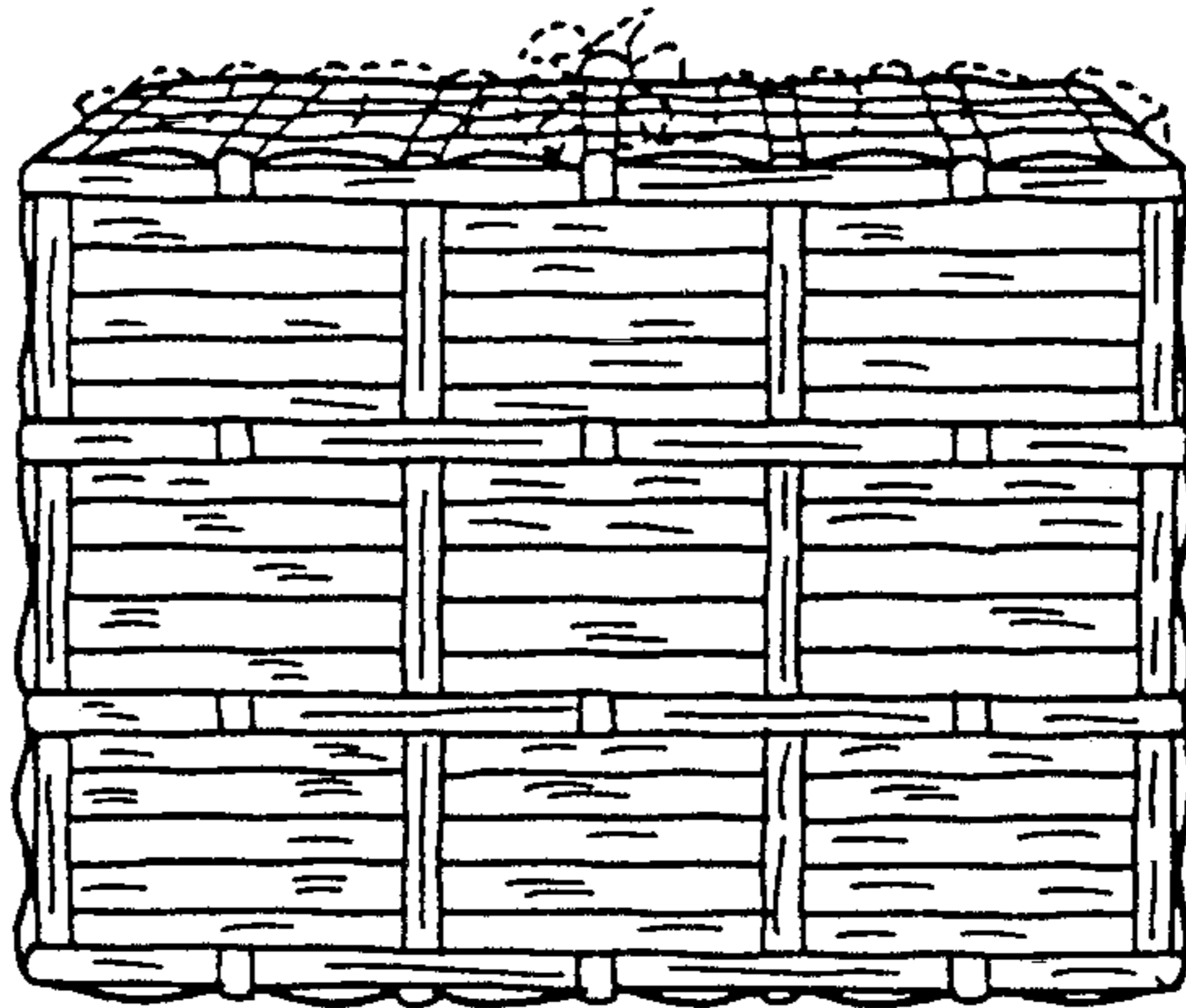
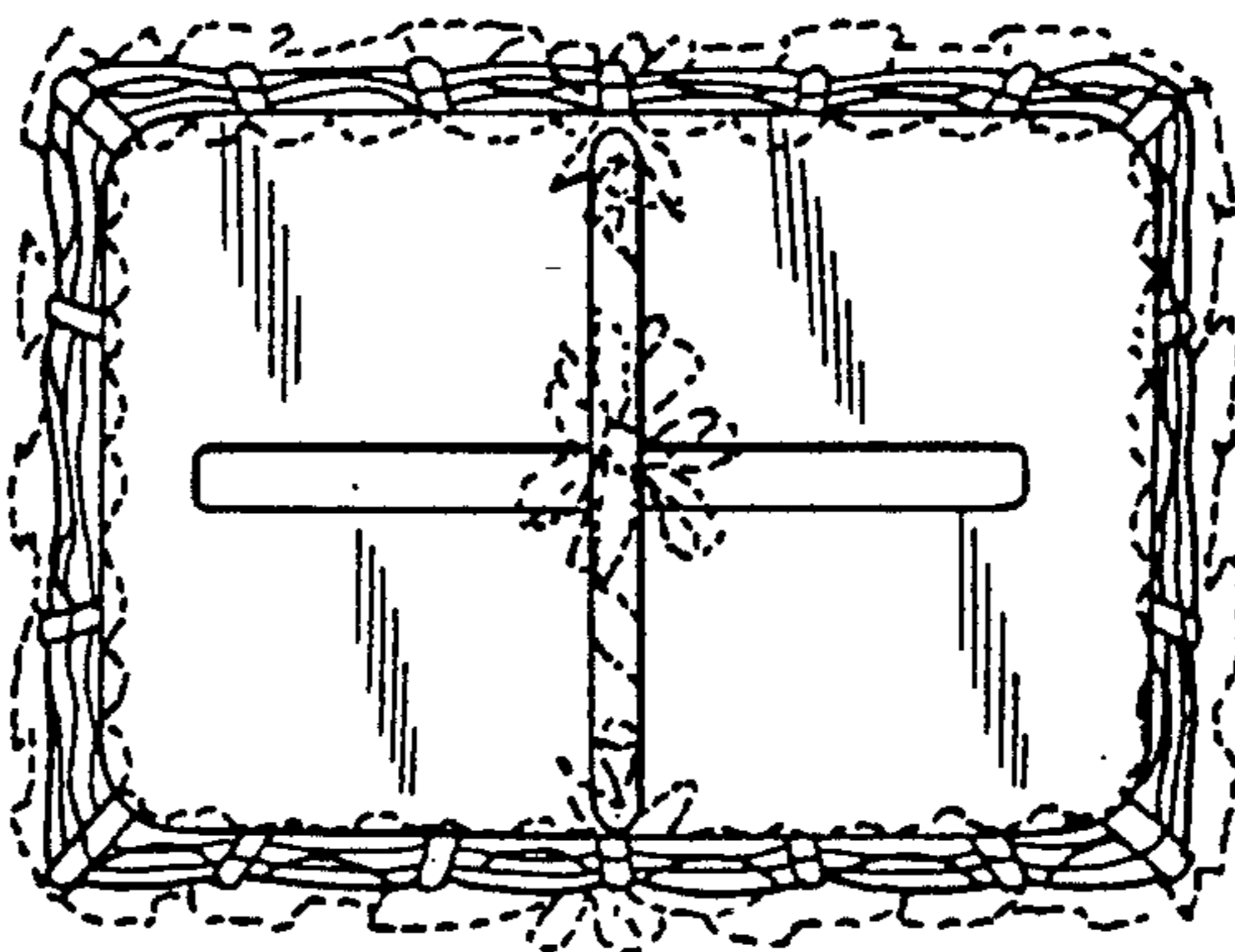

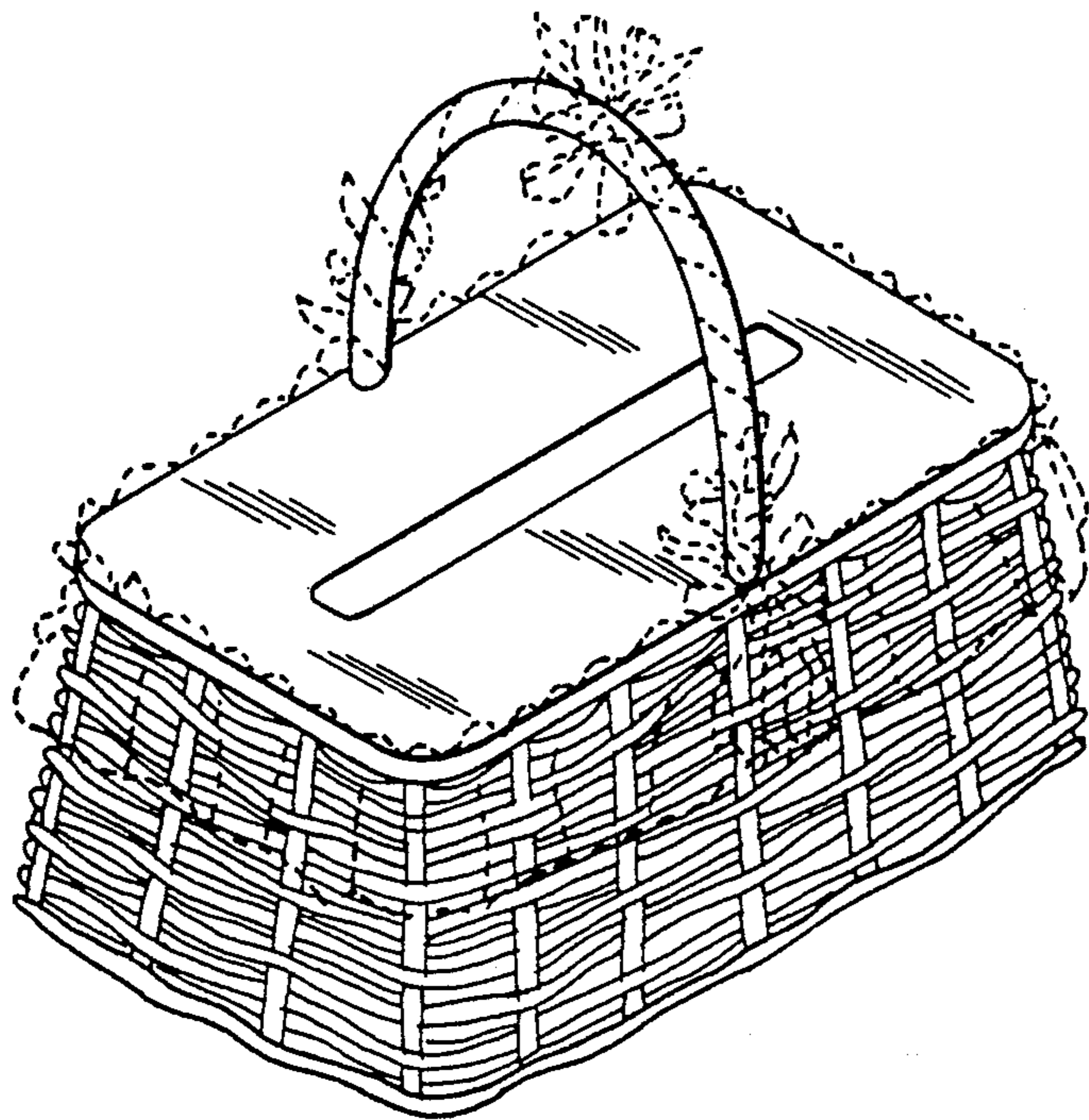

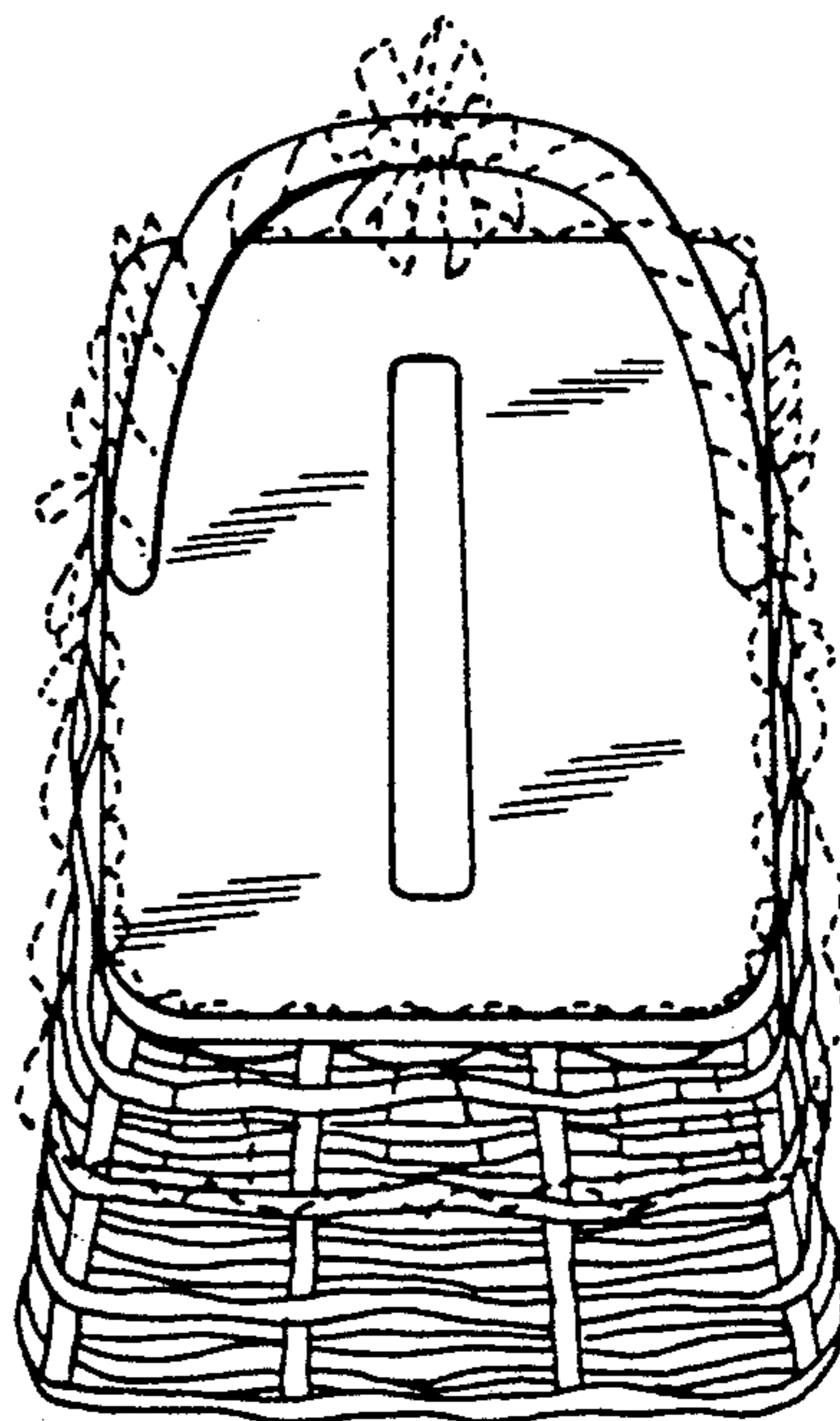

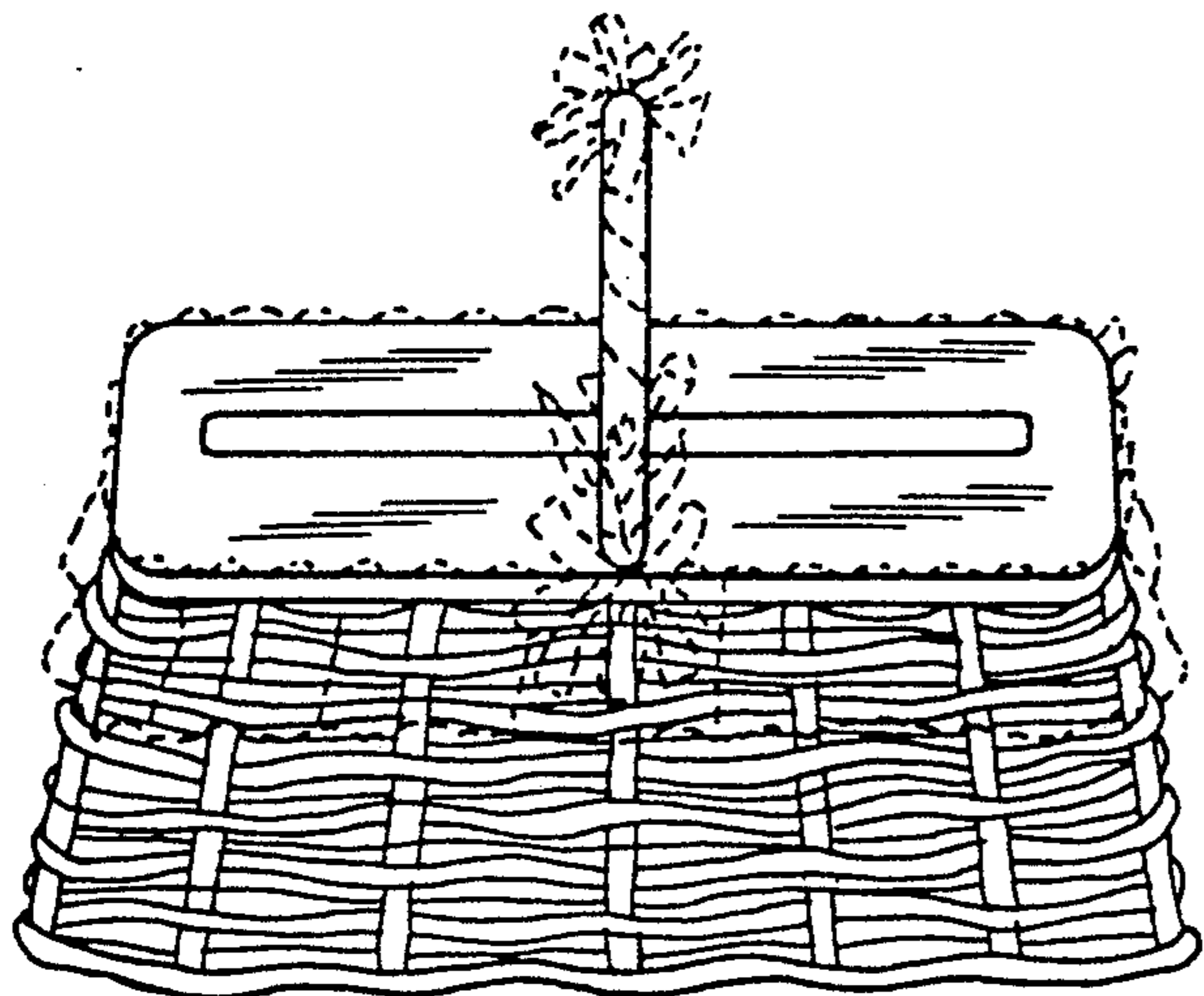
