FIG. 1 is a front elevational view of a combined divot repair tool and writing instrument showing my new design;

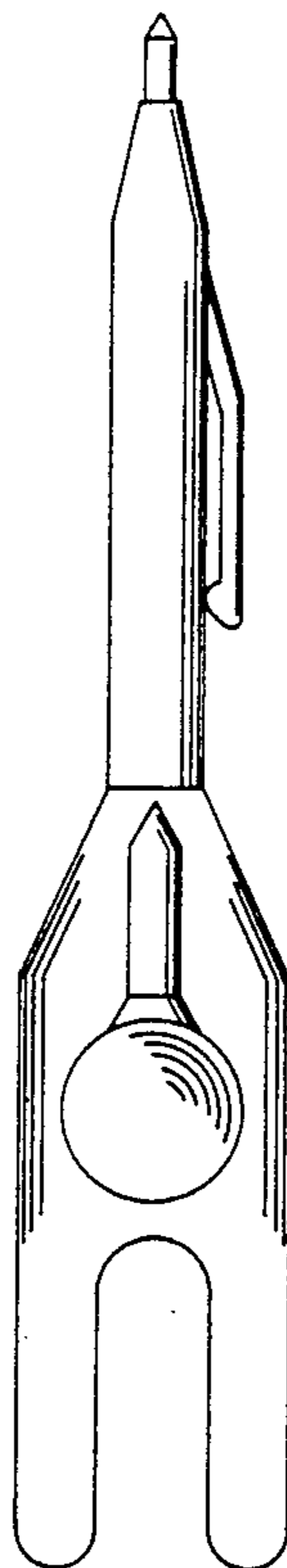
FIG. 2 is a right side elevational view;

FIG. 6 is a bottom plan view thereof.



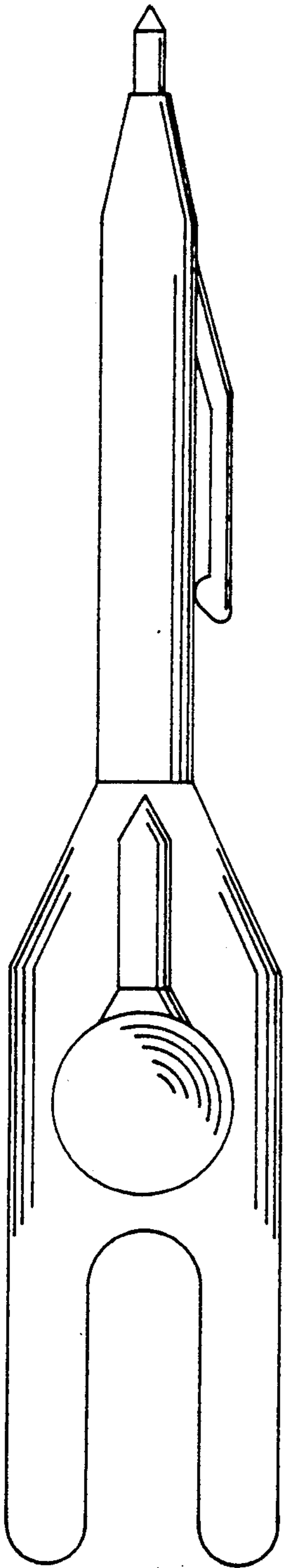

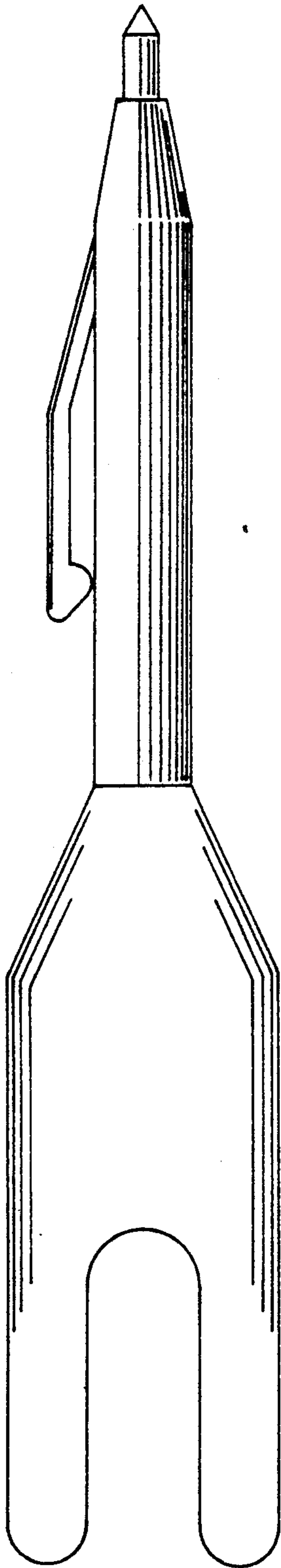

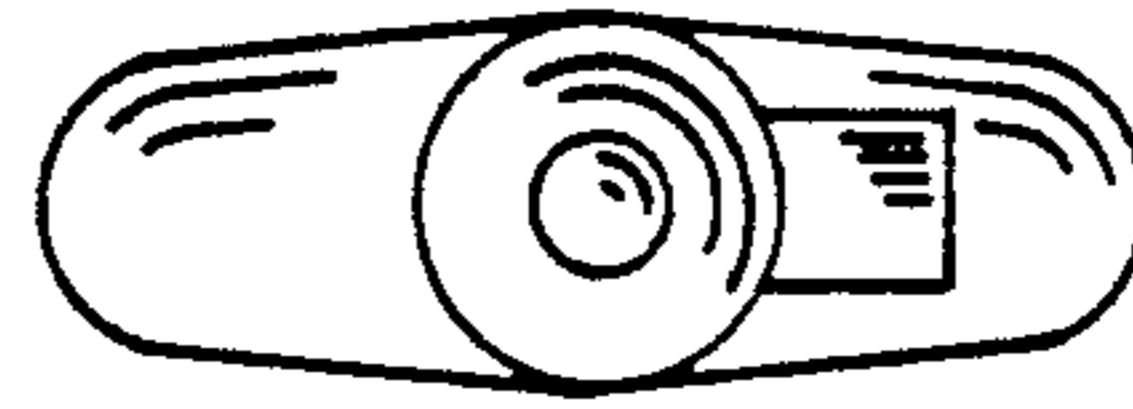
