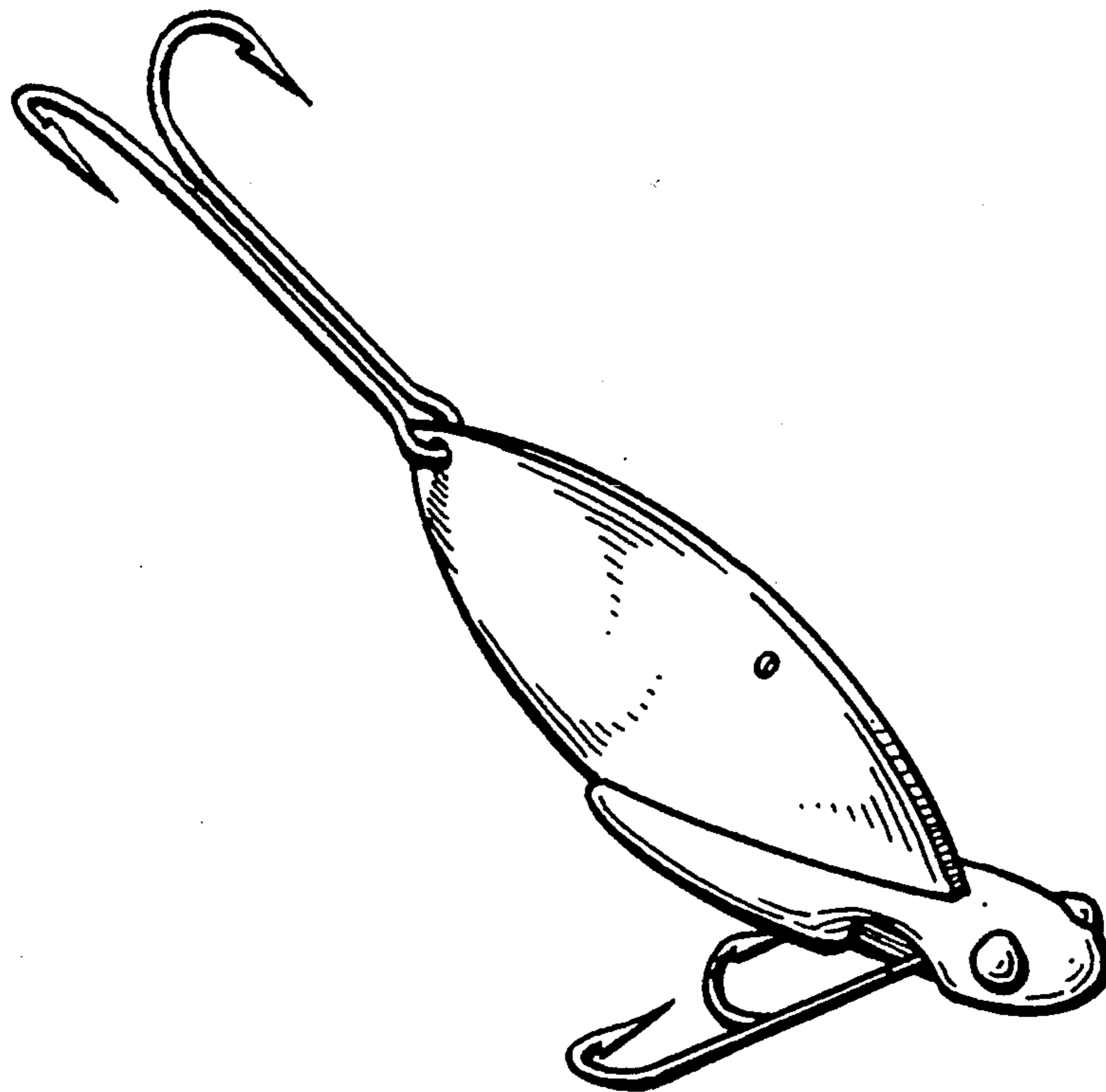
The ornamental design for a fishing lure, as shown and described.

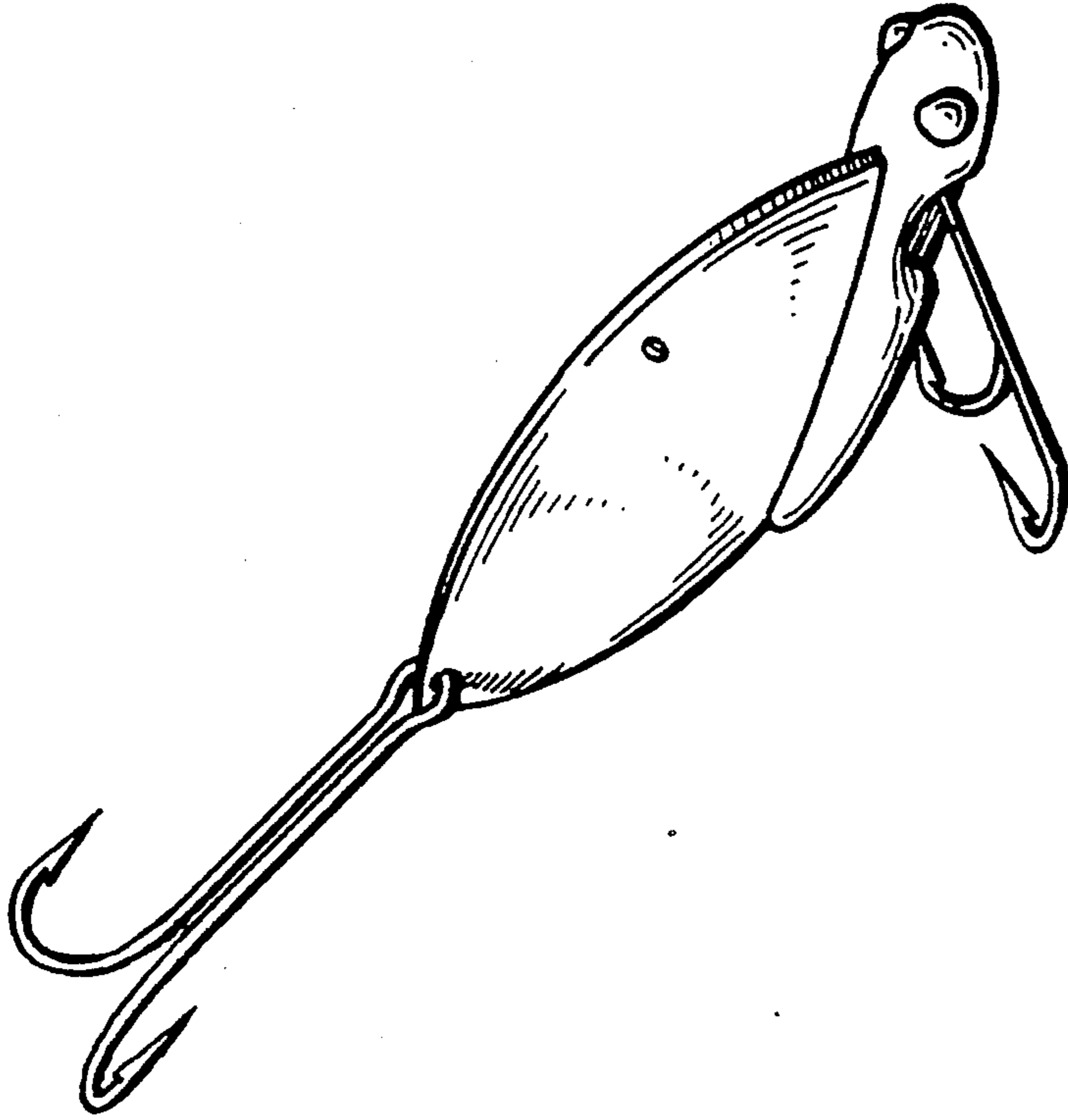

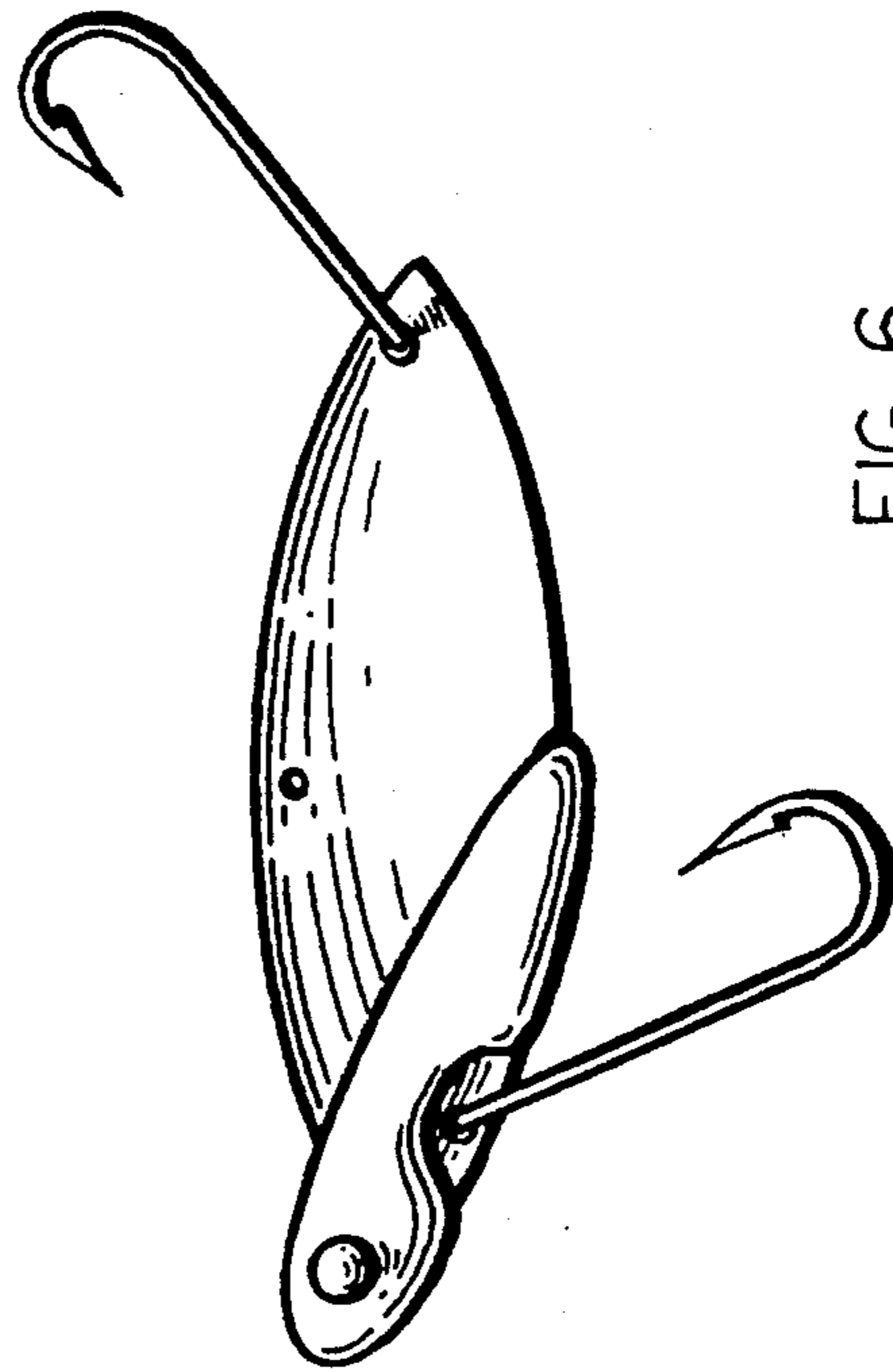

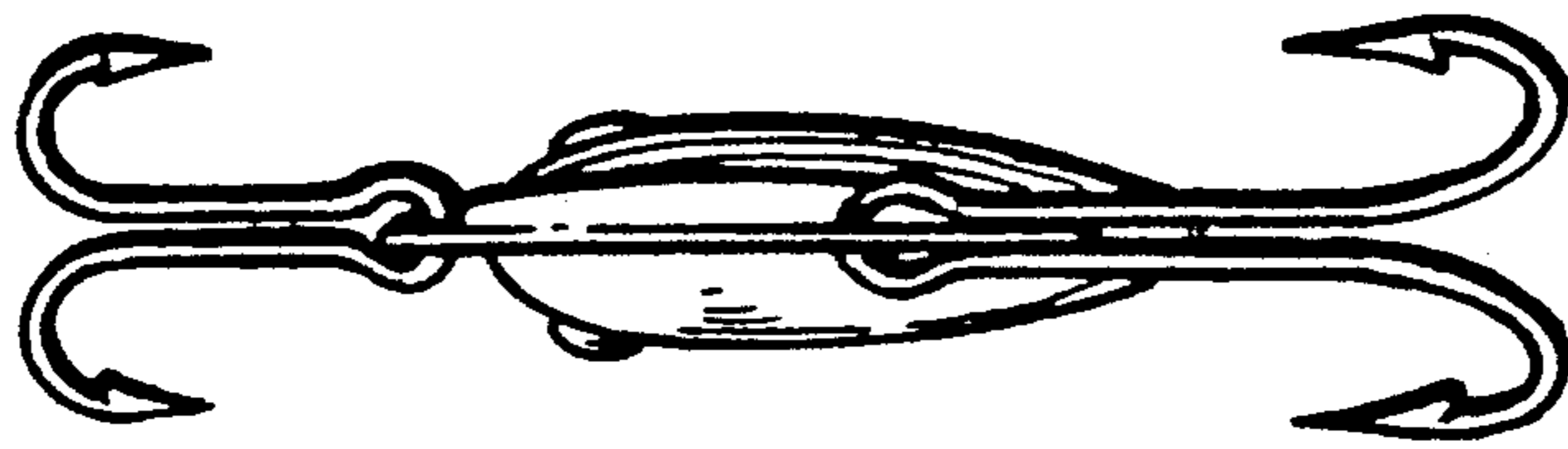

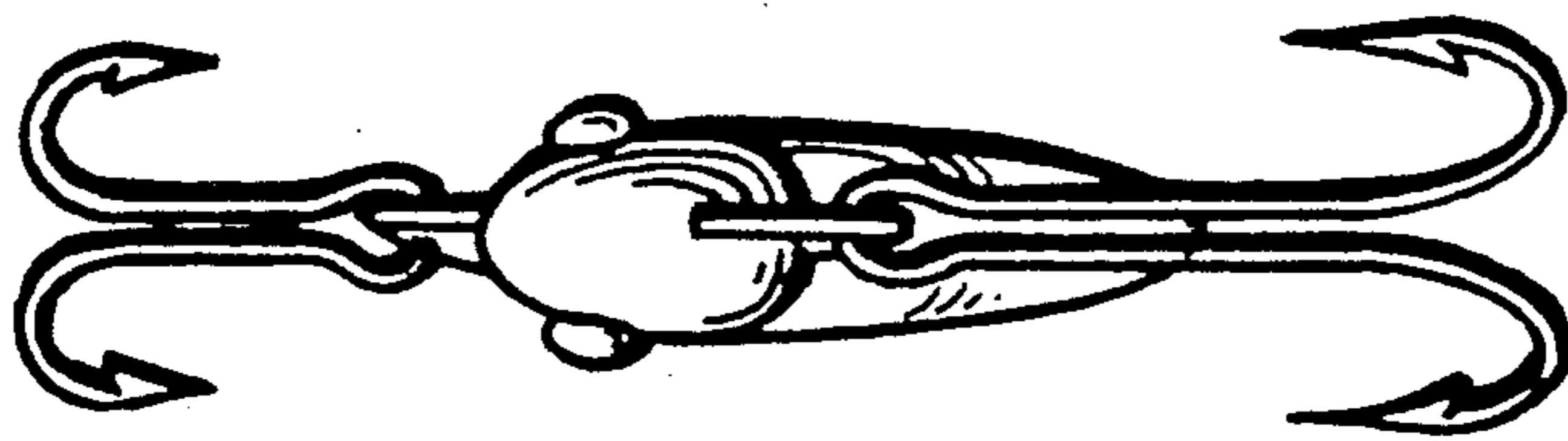

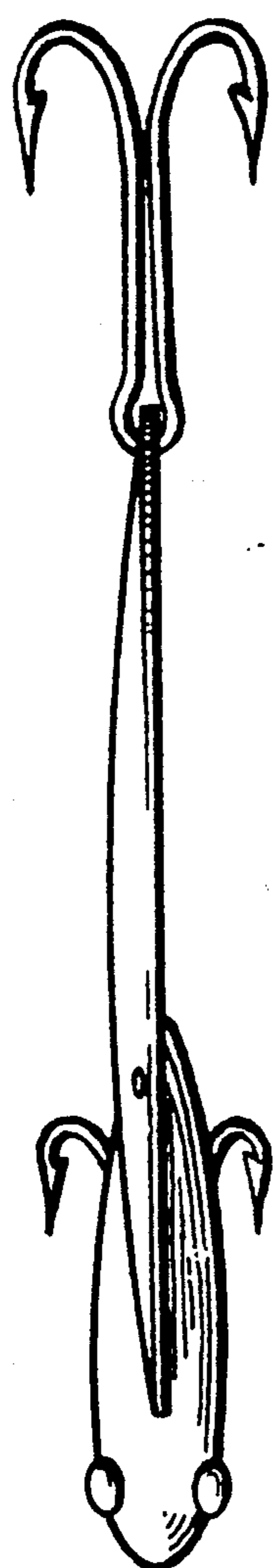

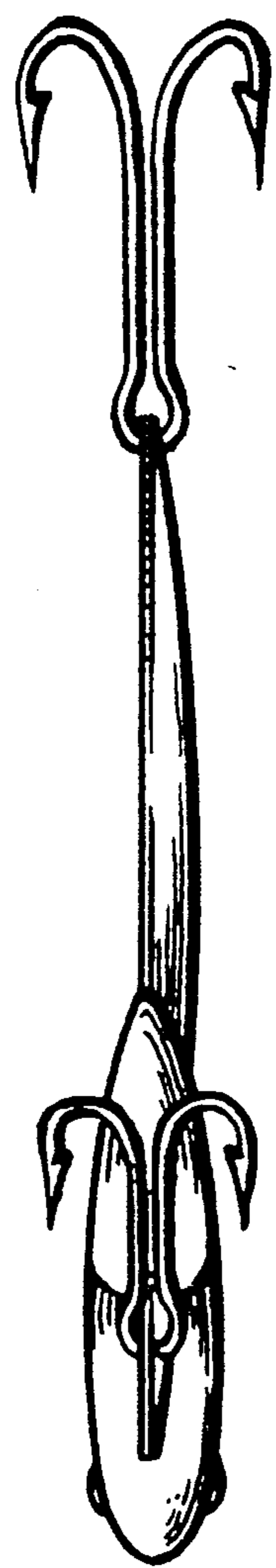

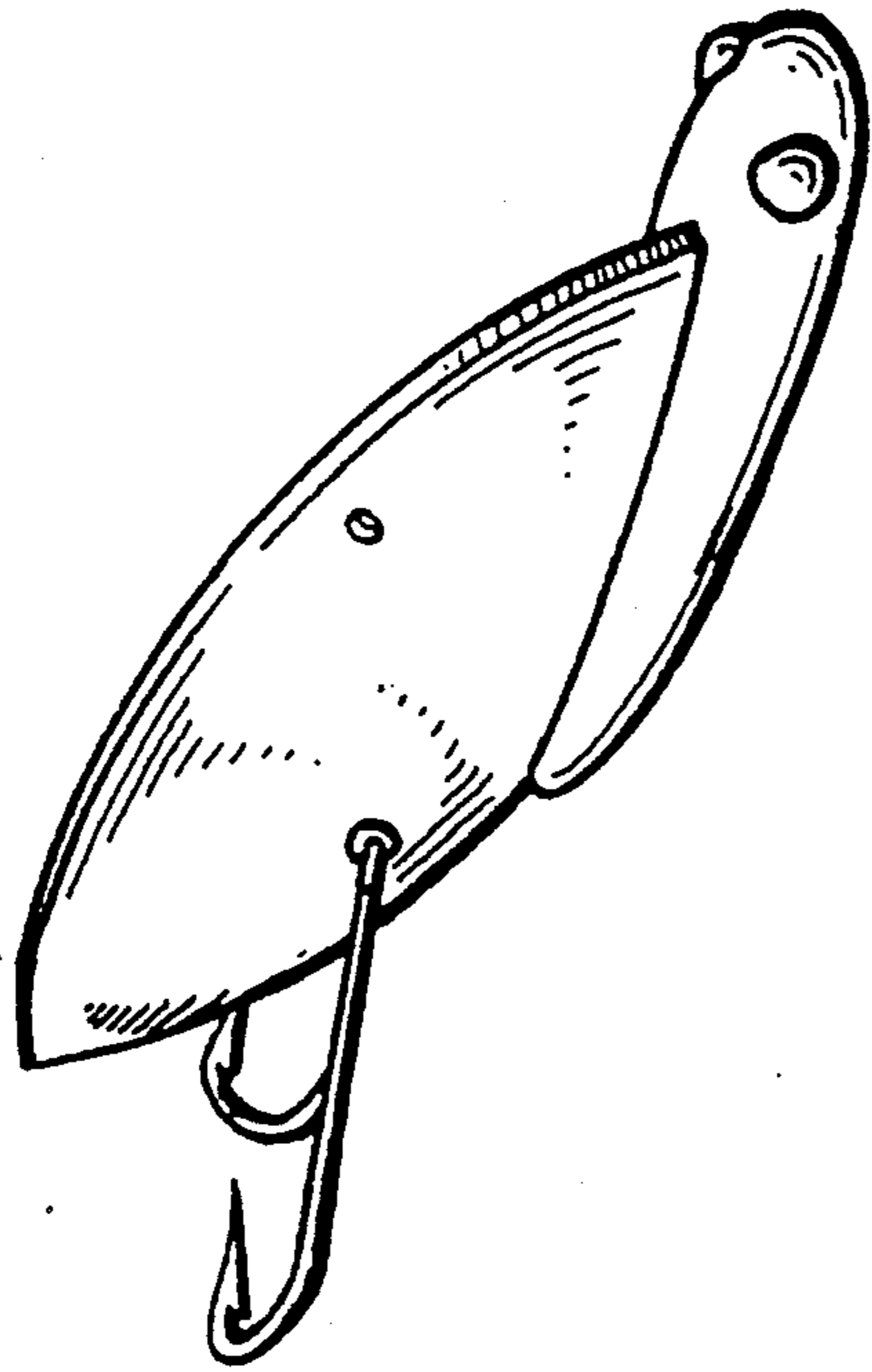

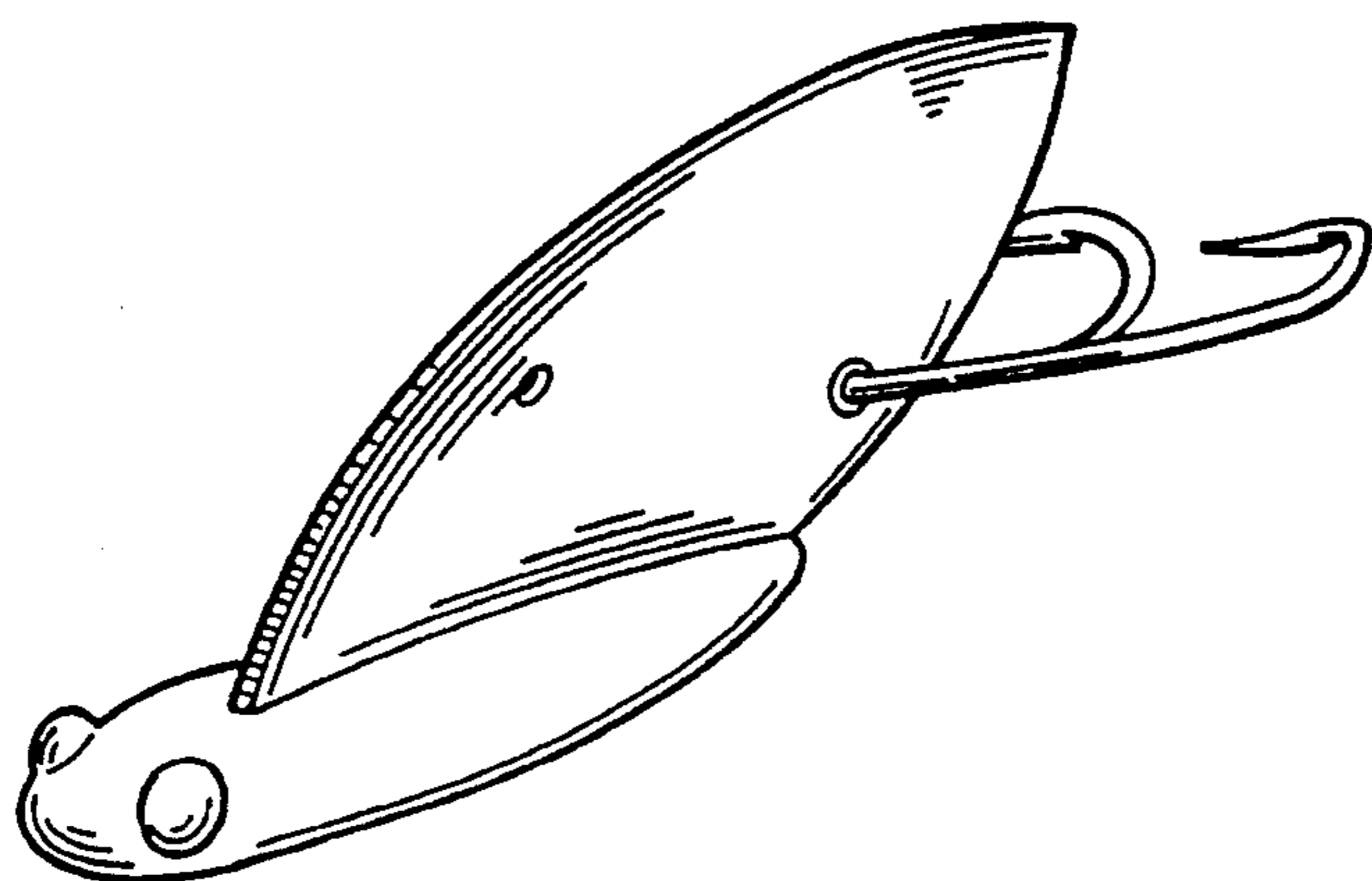
