DESCRIPTION

FIG. 1 is a top perspective view of a stackable container for bottles showing our new design; FIG. 2 is a bottom perspective view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a front elevation thereof; the rear elevation being a mirror image thereof; FIG. 6 is a left side elevation thereof; the right side elevation being a mirror image thereof; and, FIG. 7 is a fragmentary sectional elevation thereof; taken along line 7—7 of FIG. 3.

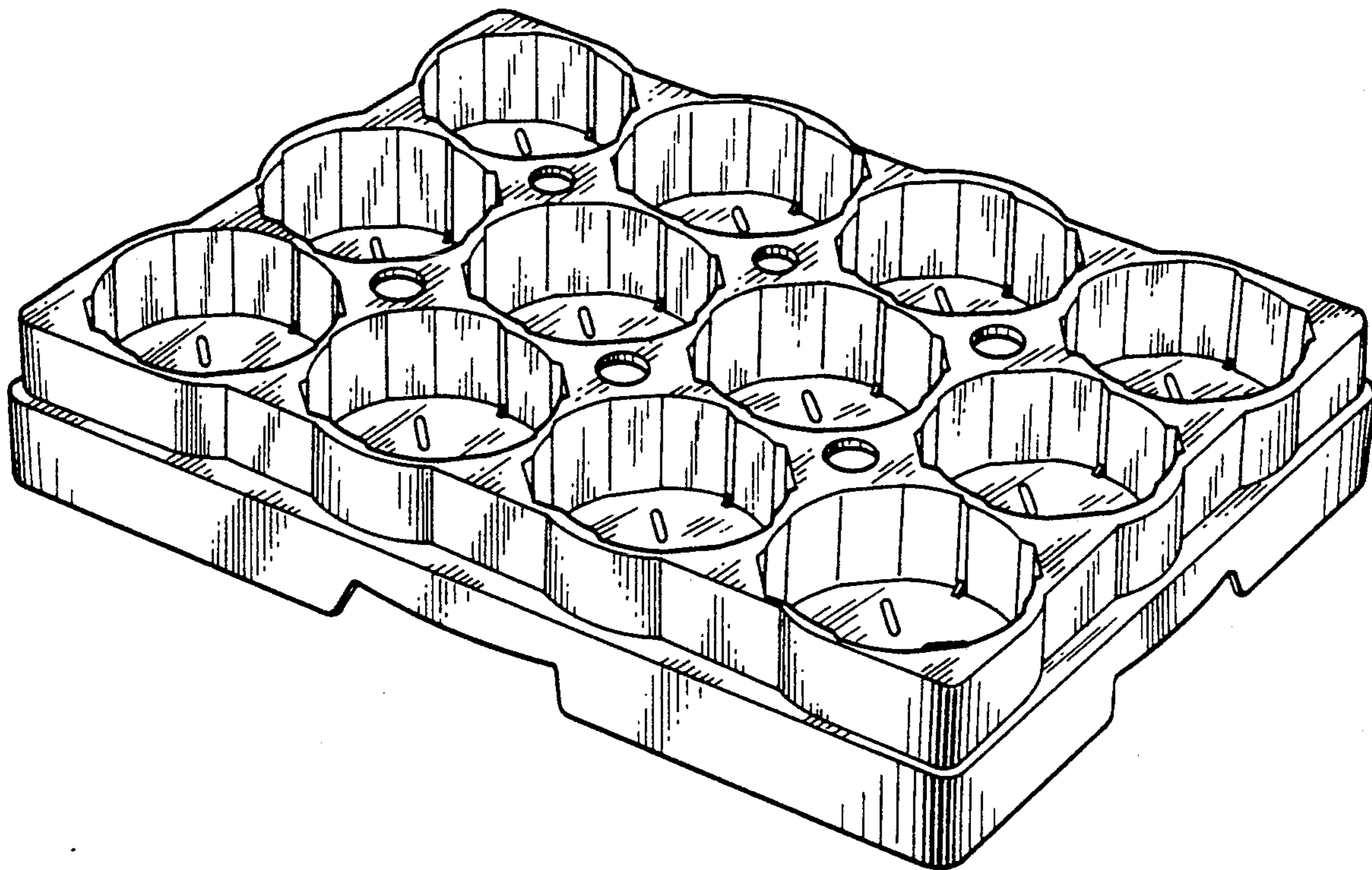

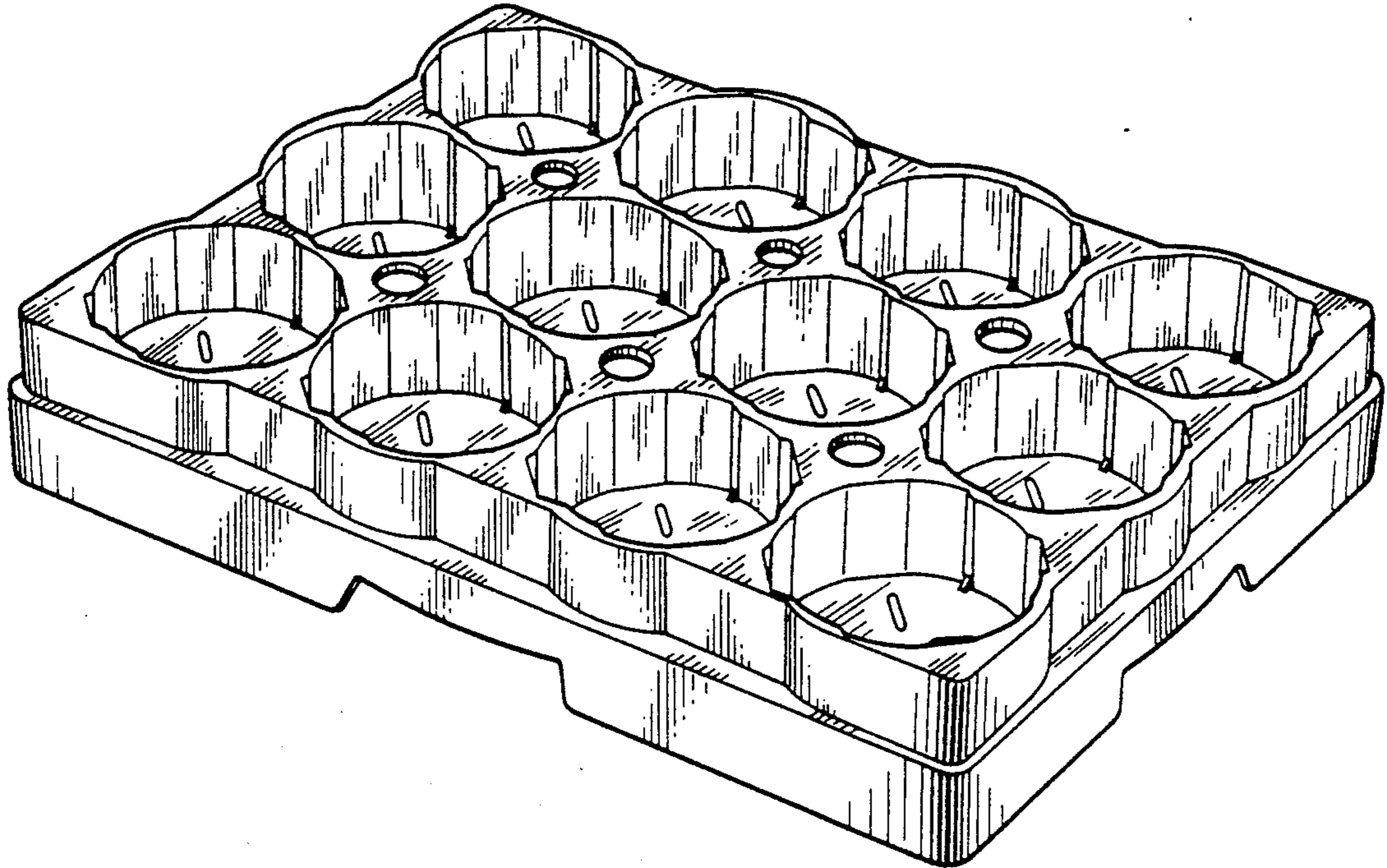

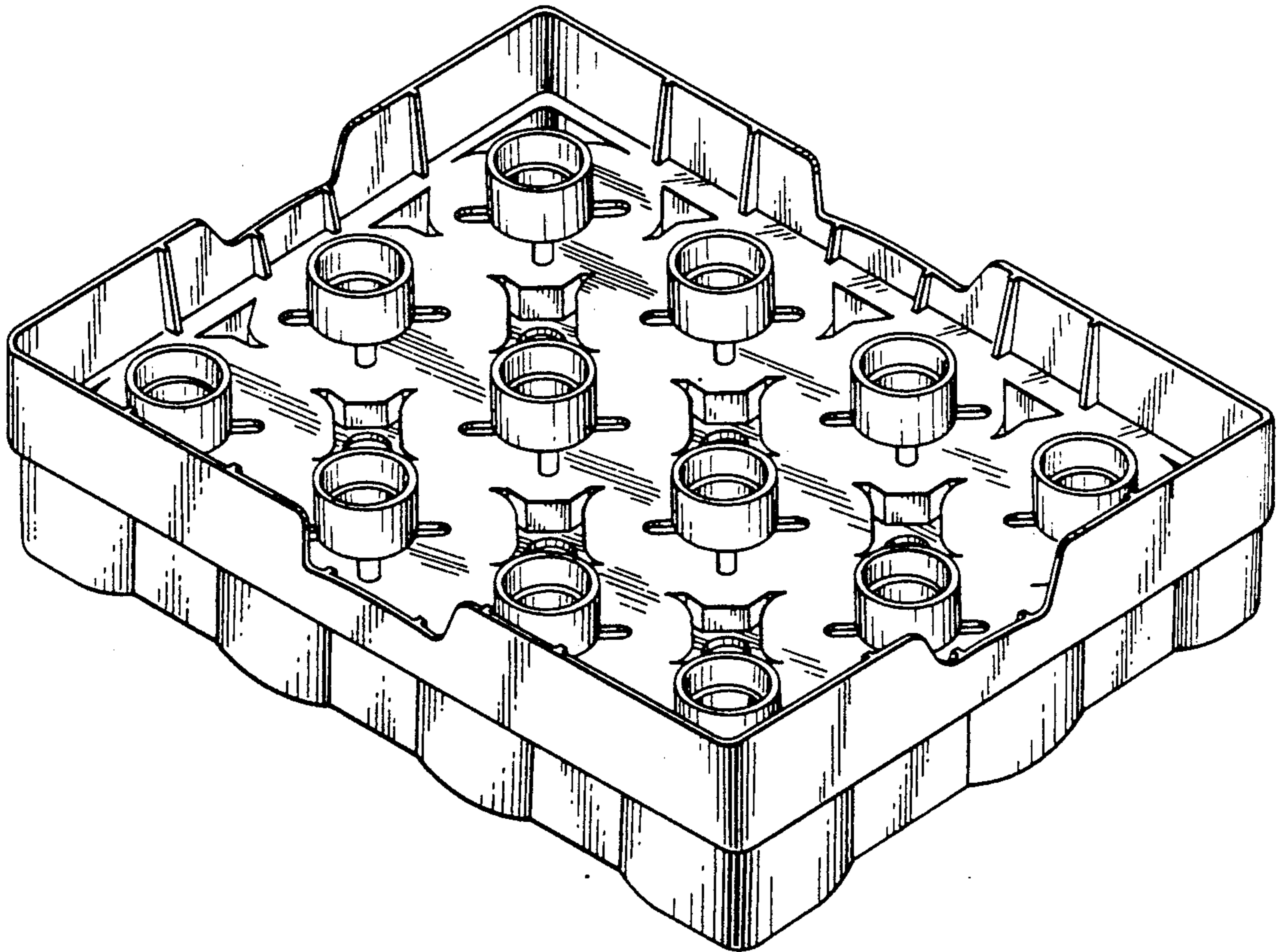

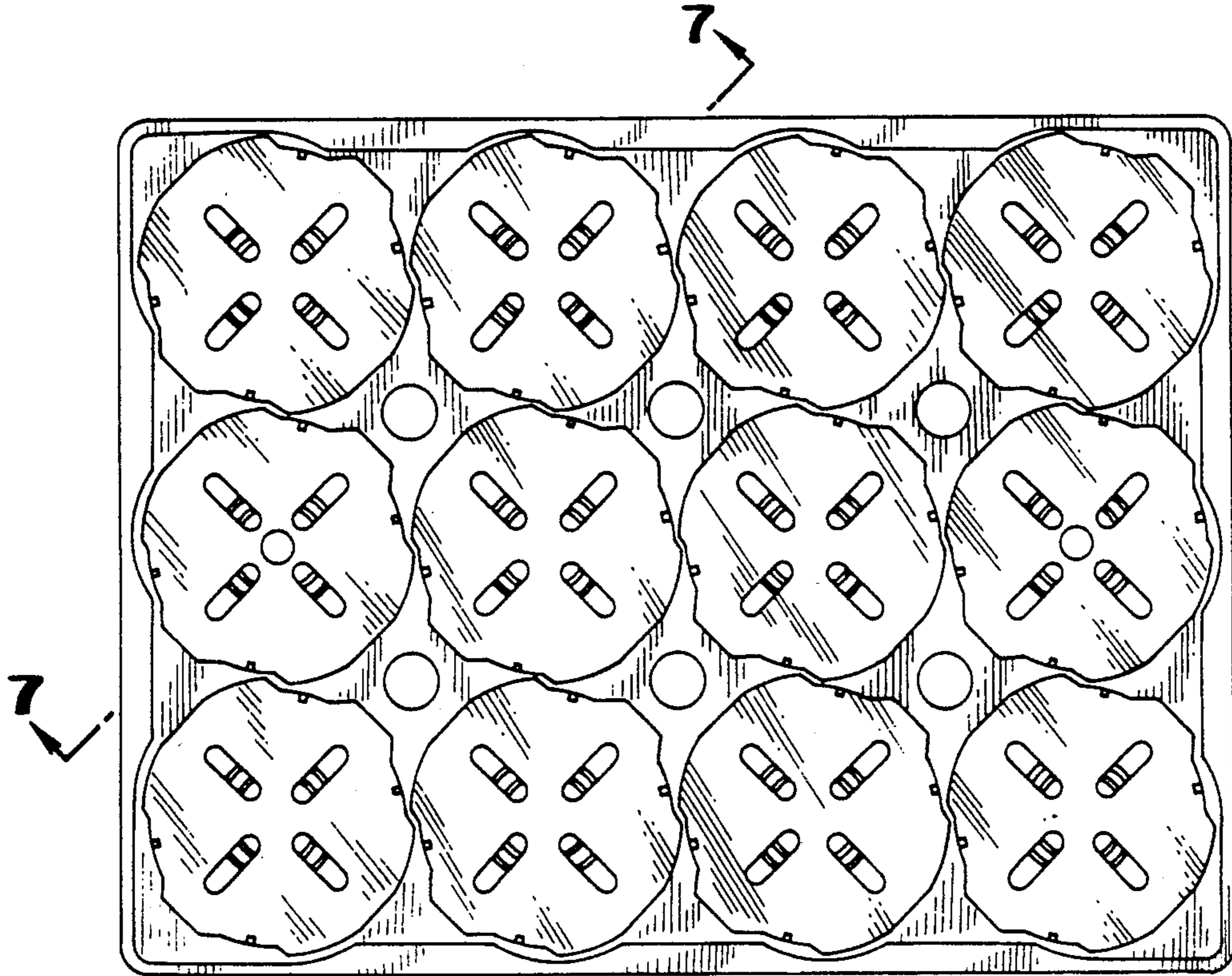

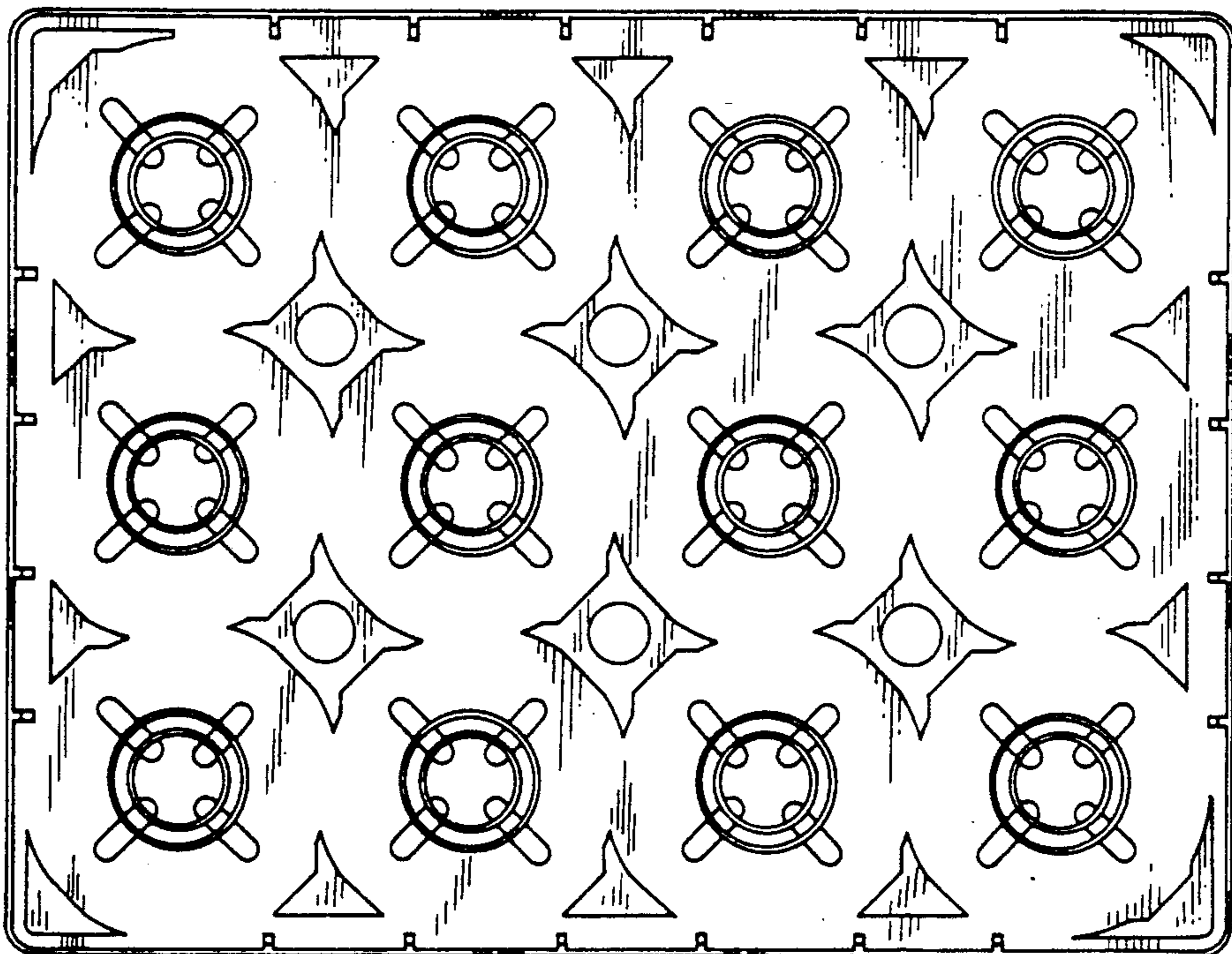

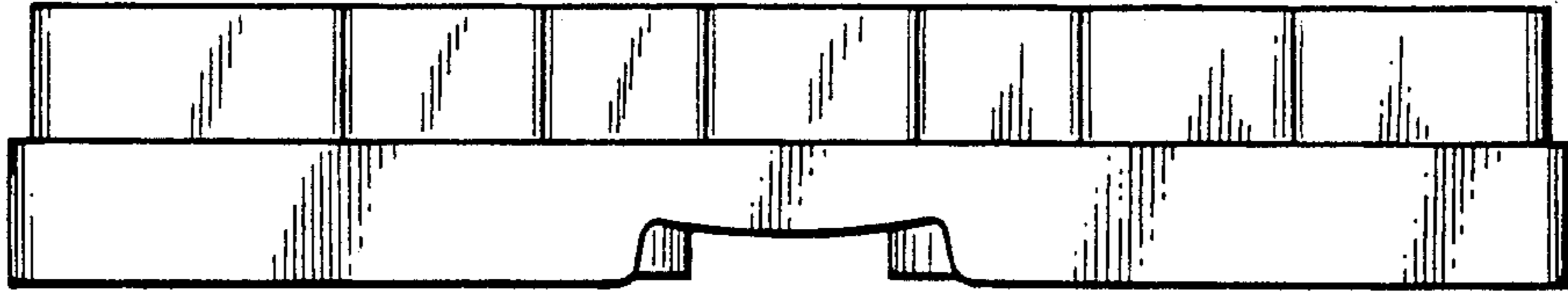

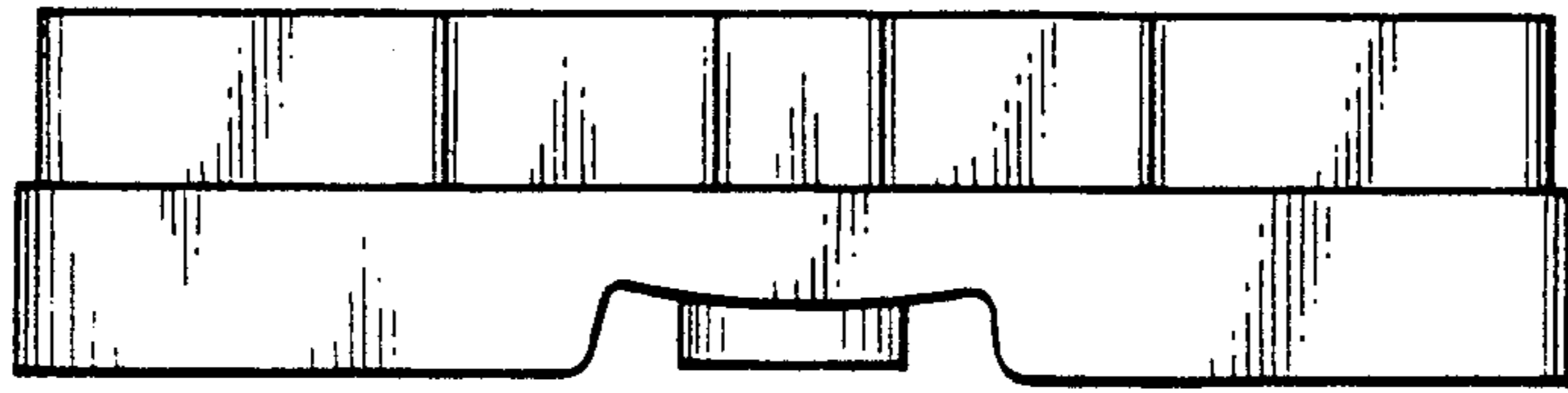
