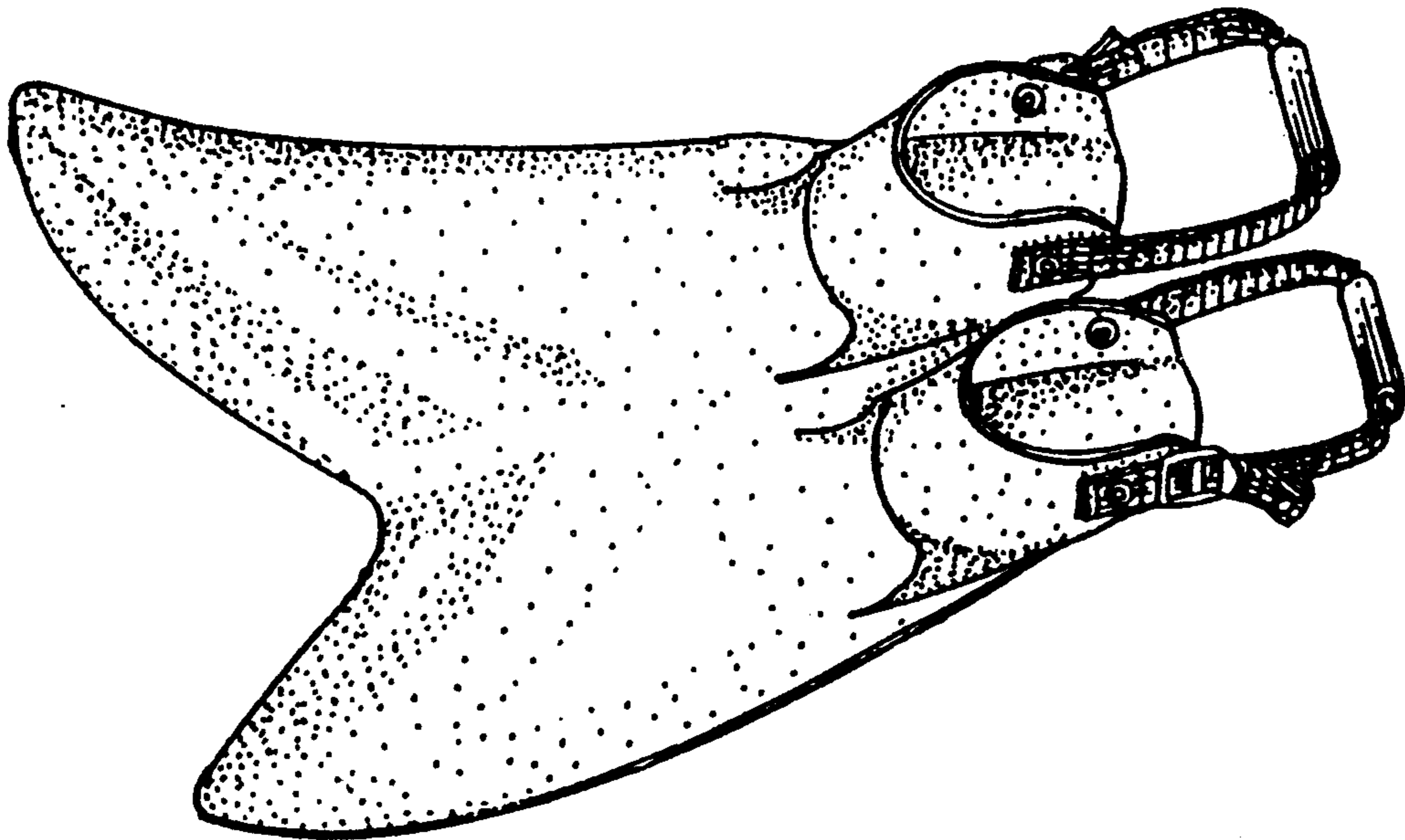
[57] **CLAIM**

The ornamental design for a unitary swim fin, as shown and described.

**DESCRIPTION**

FIG. 32 is a cross sectional view taken along line 32—32 of FIG. 26.



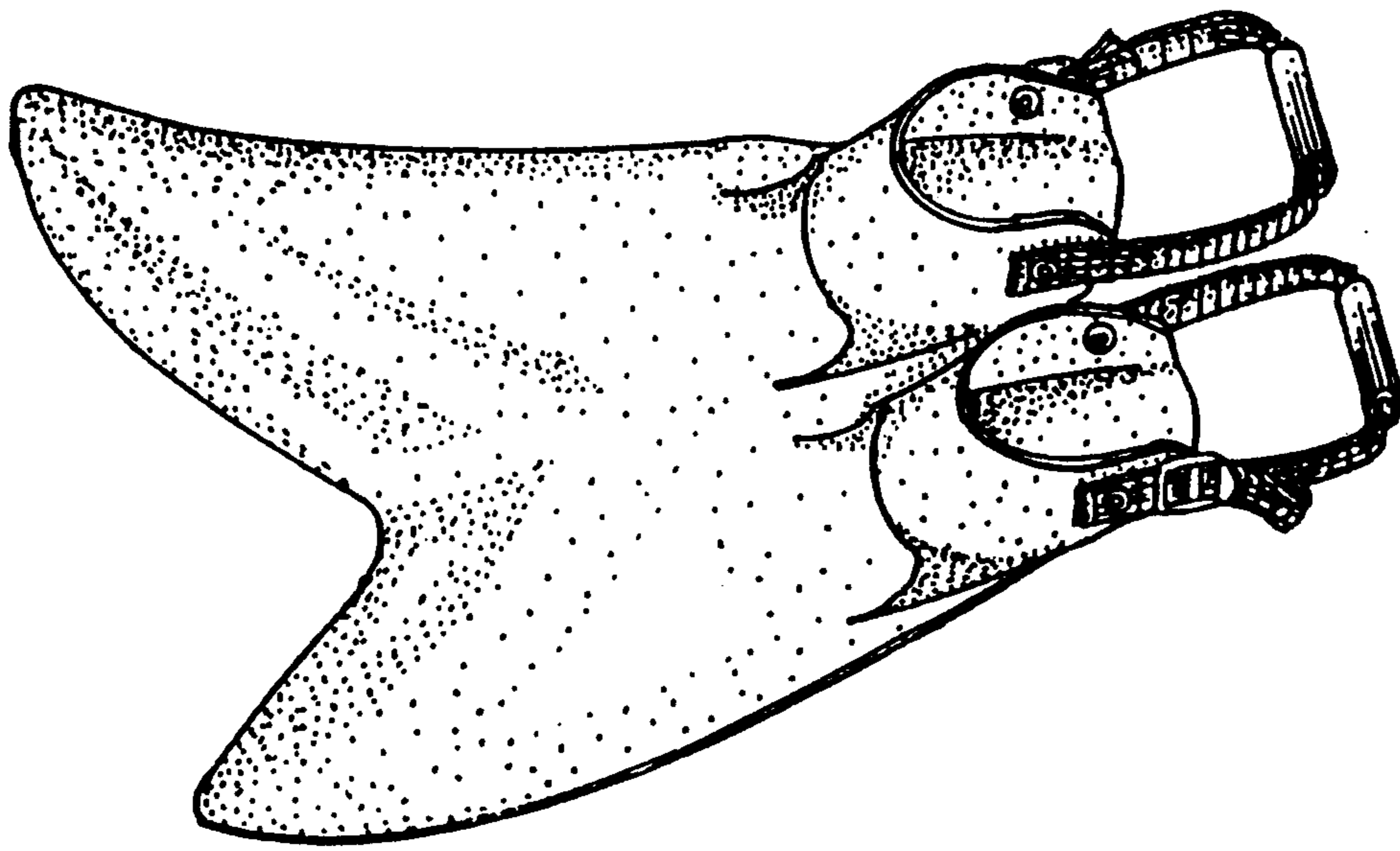

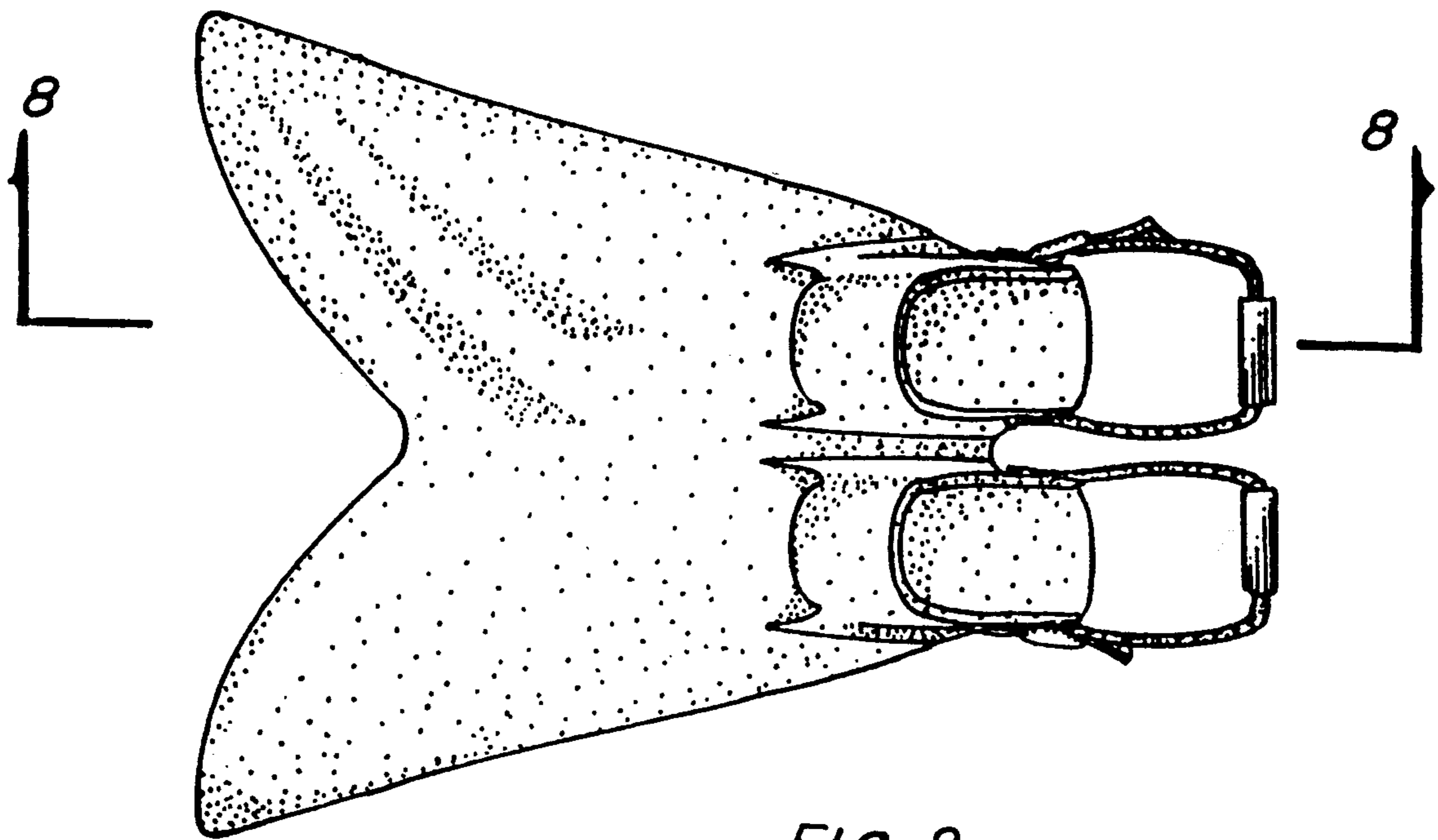

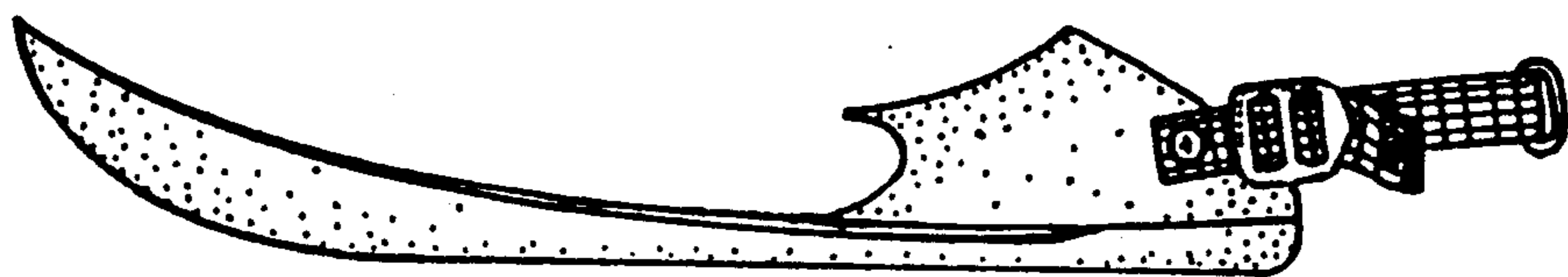

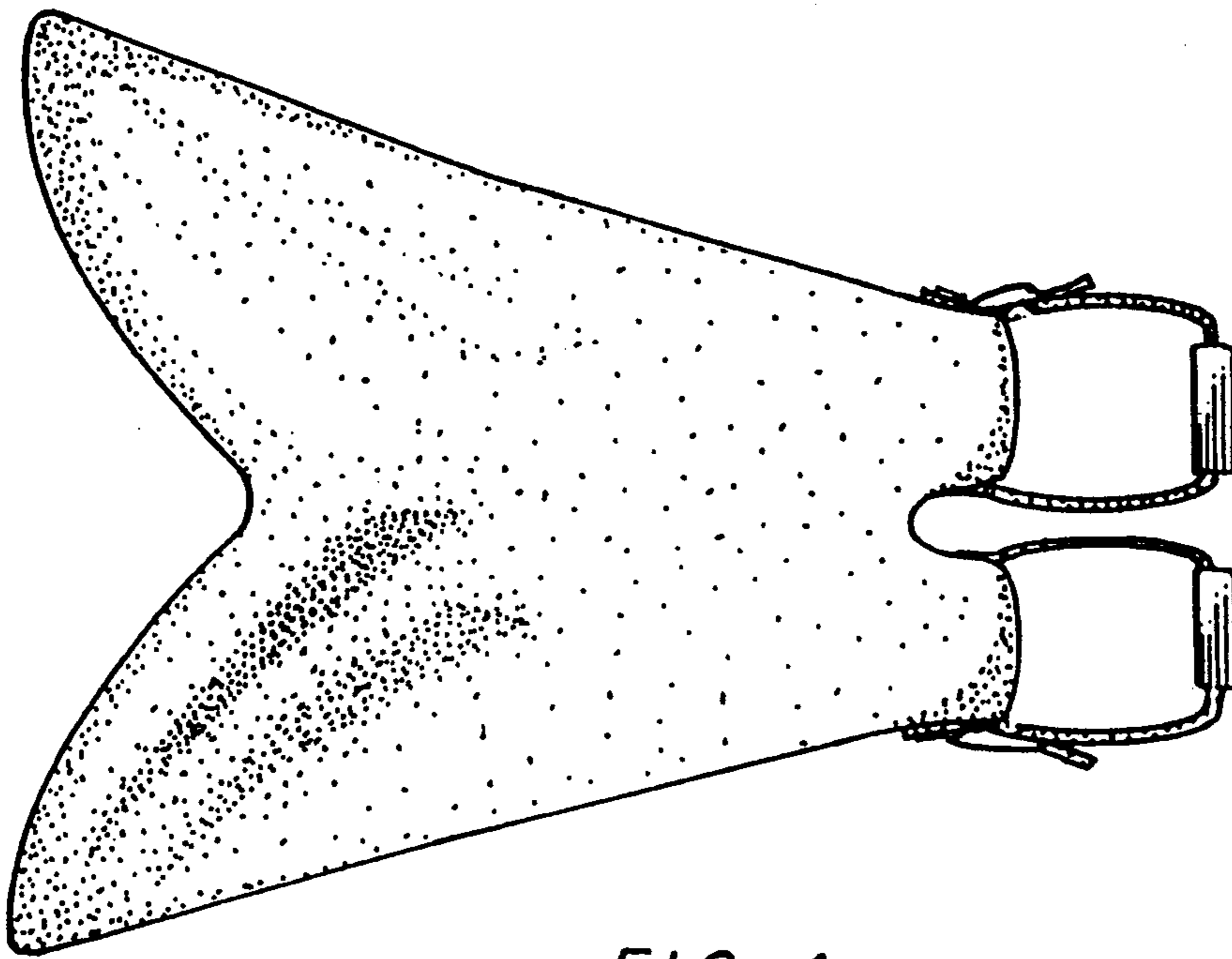

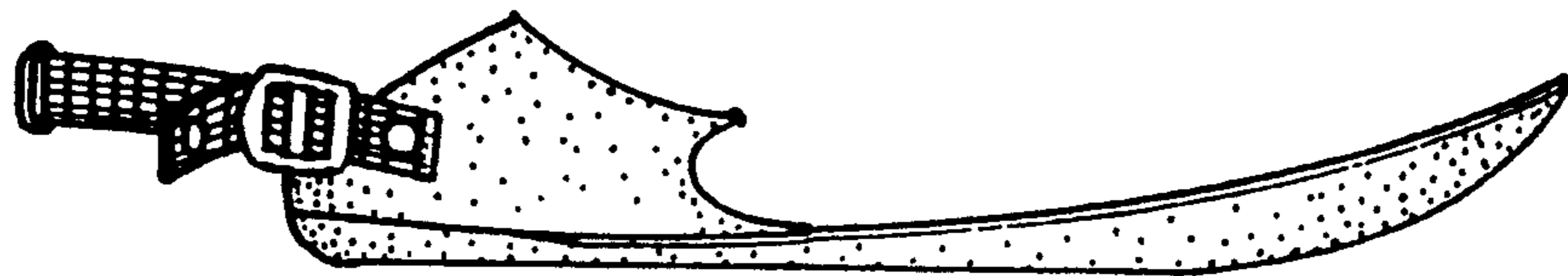

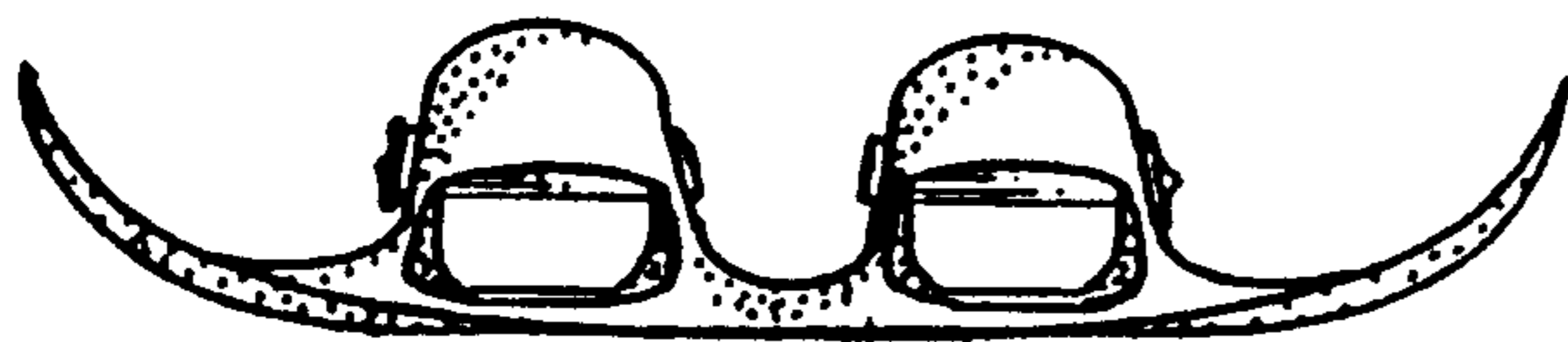

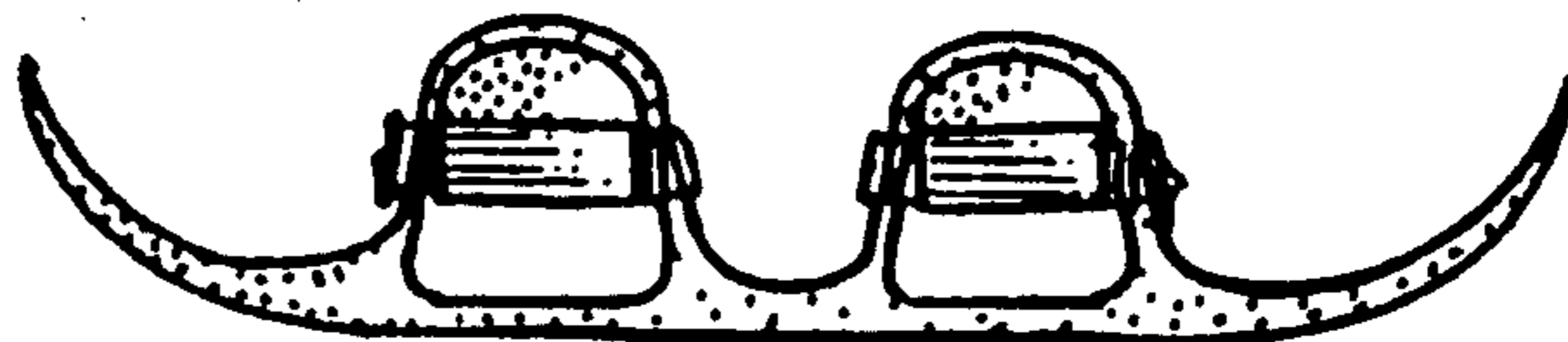

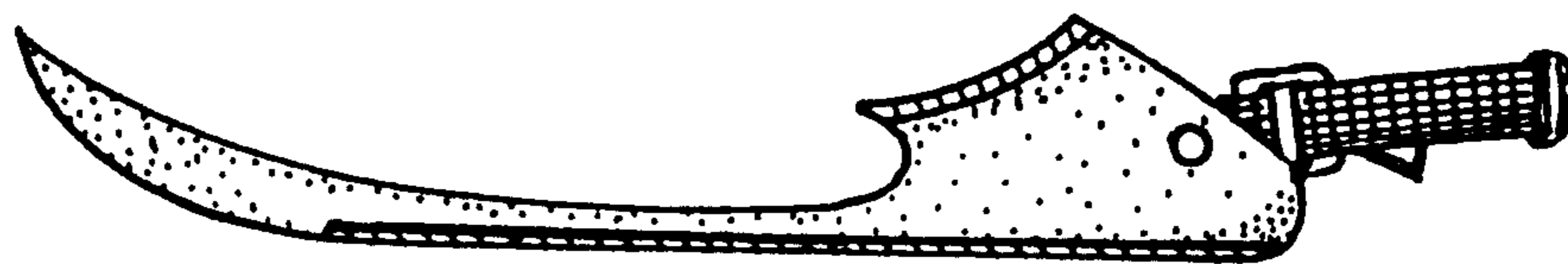

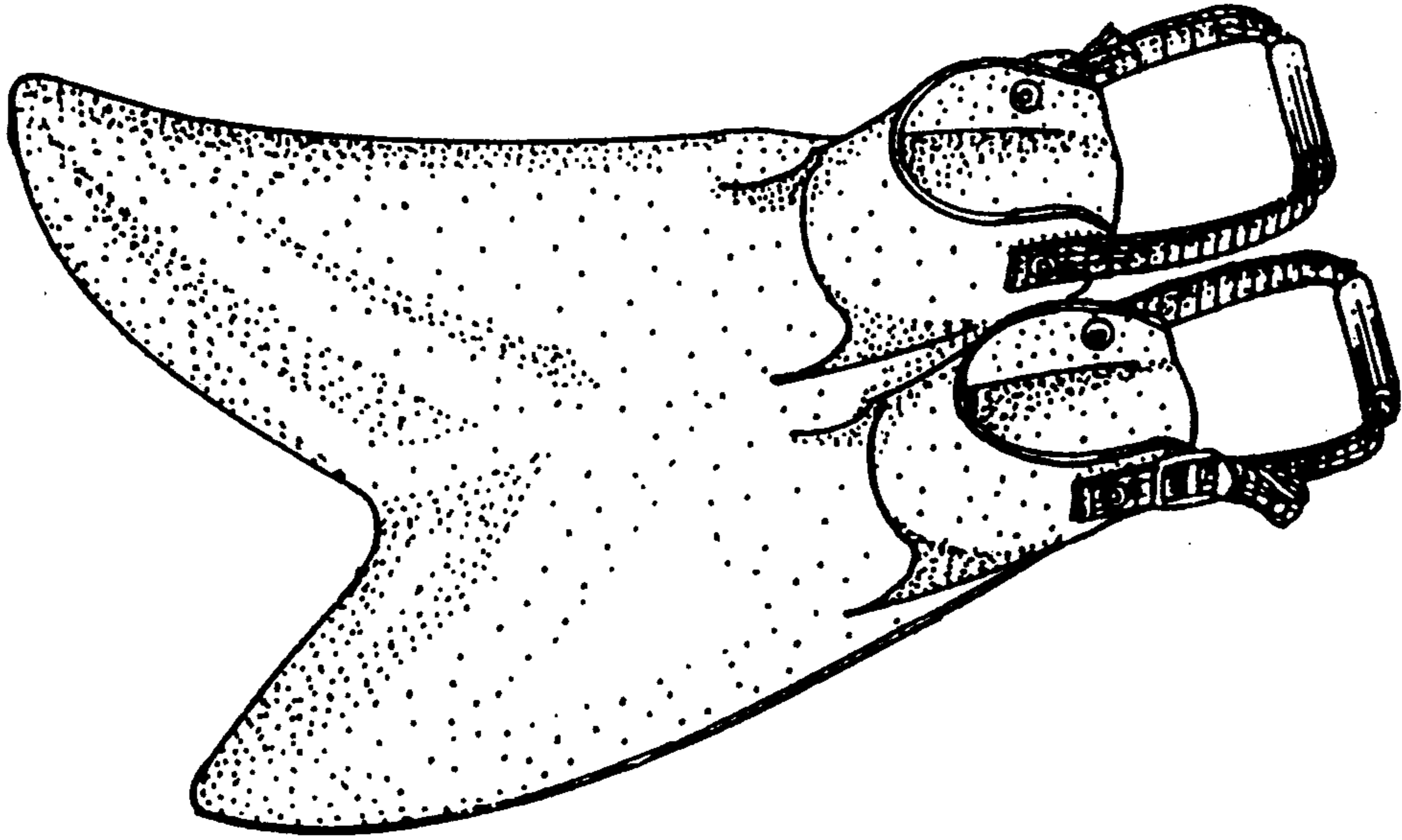

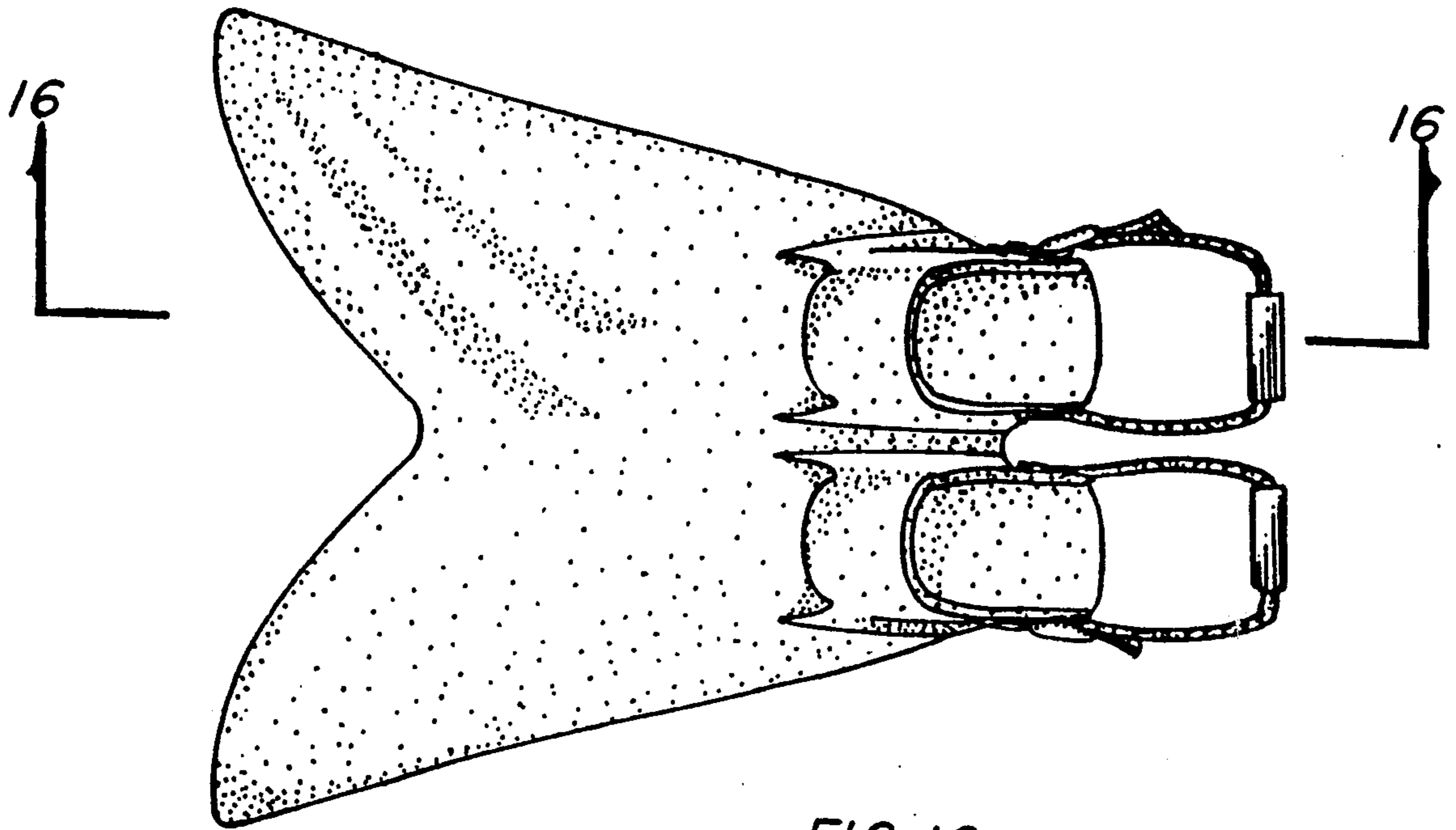

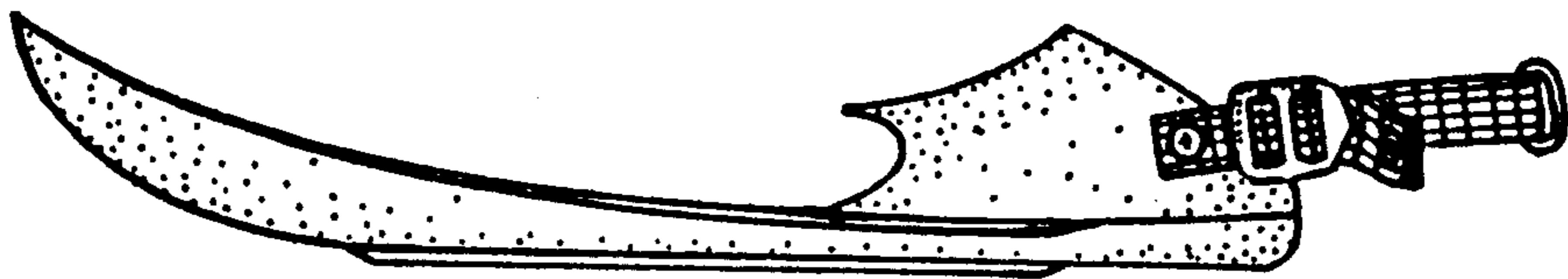

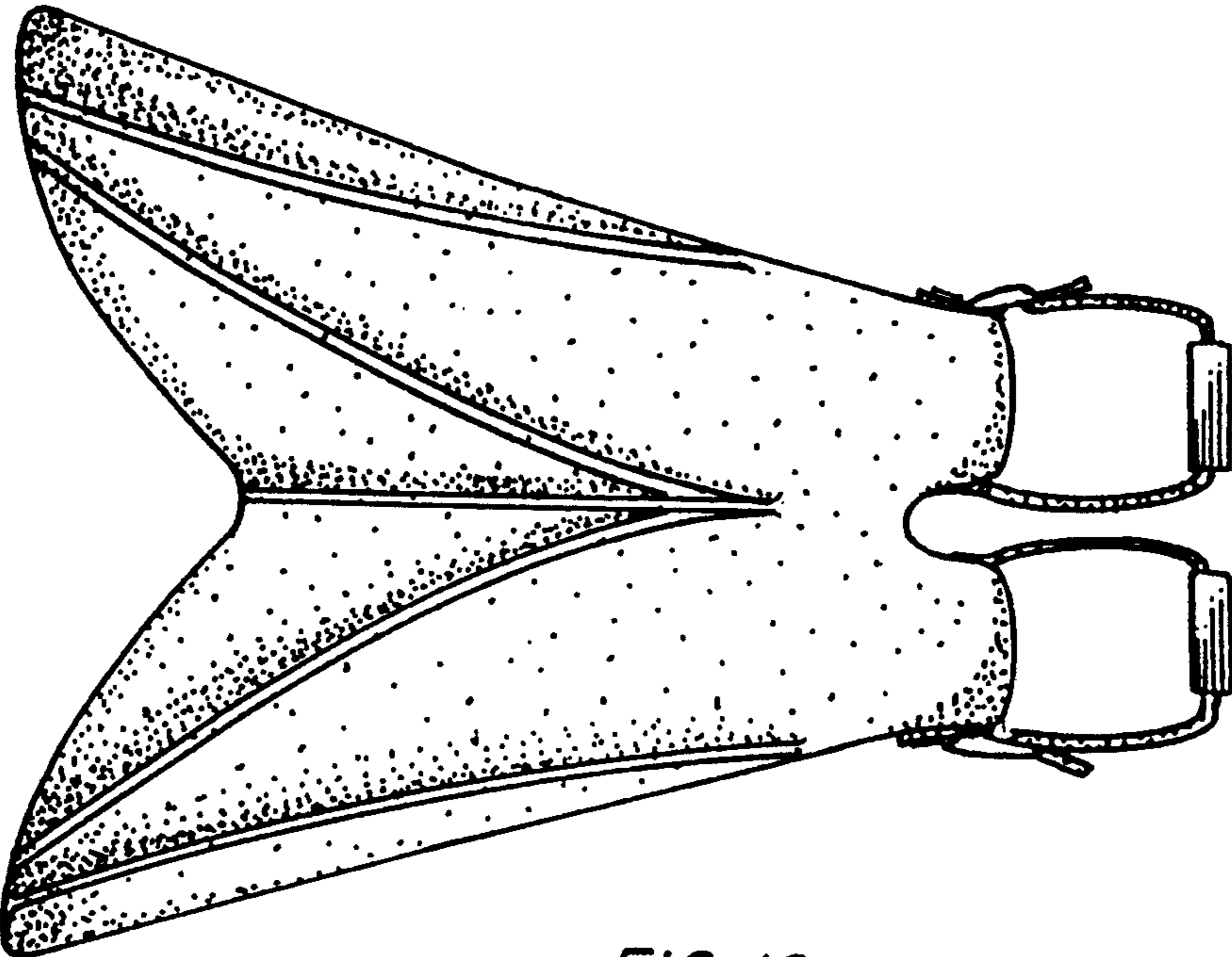

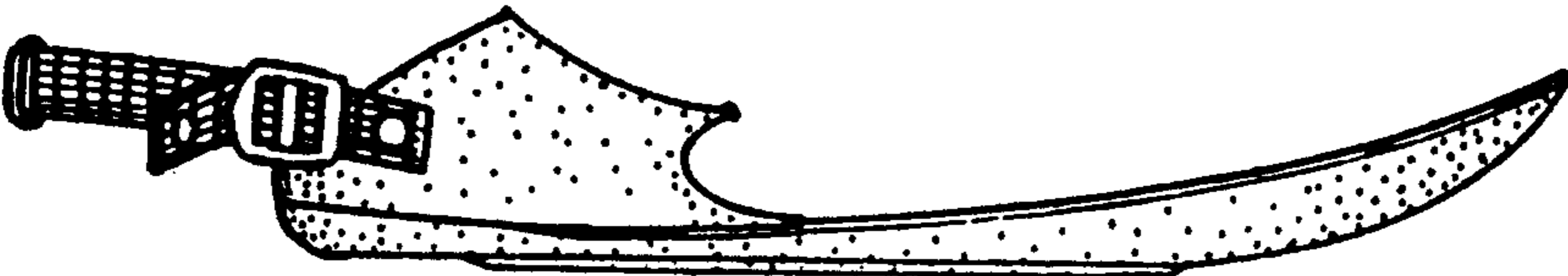

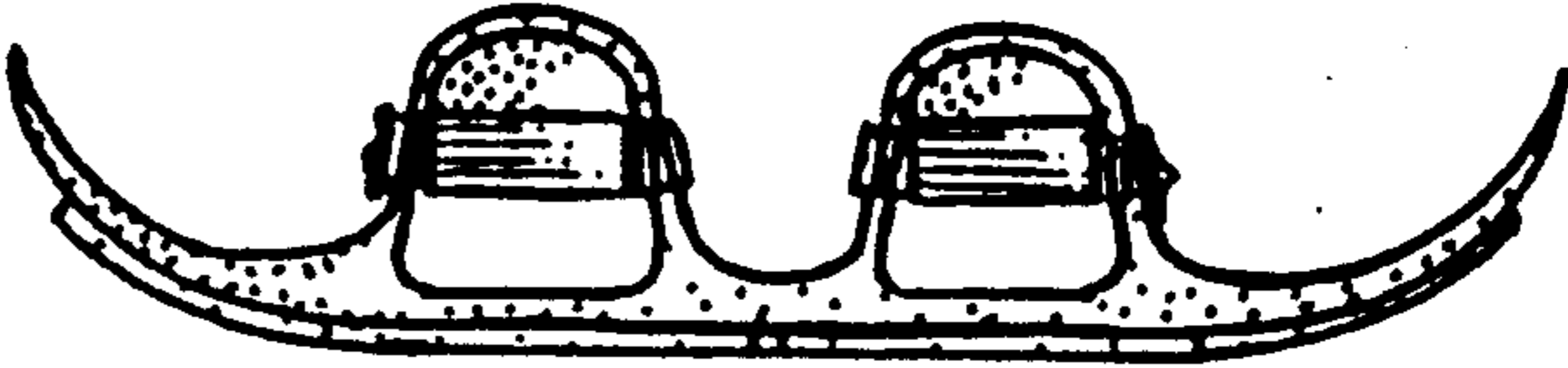

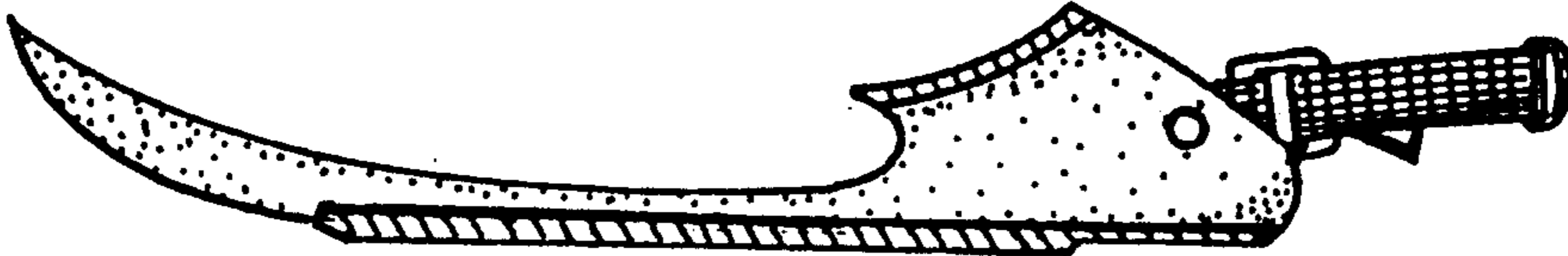

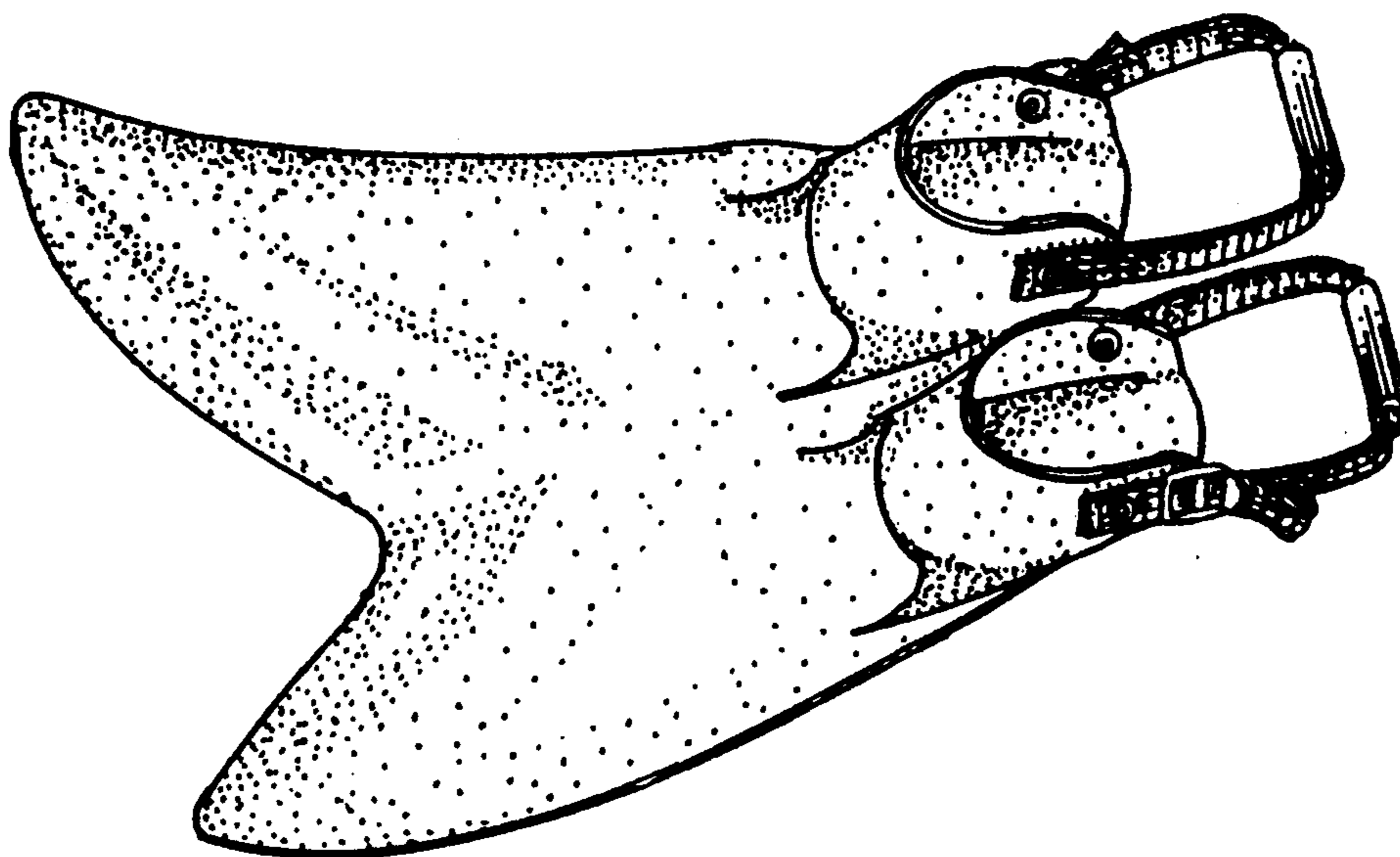

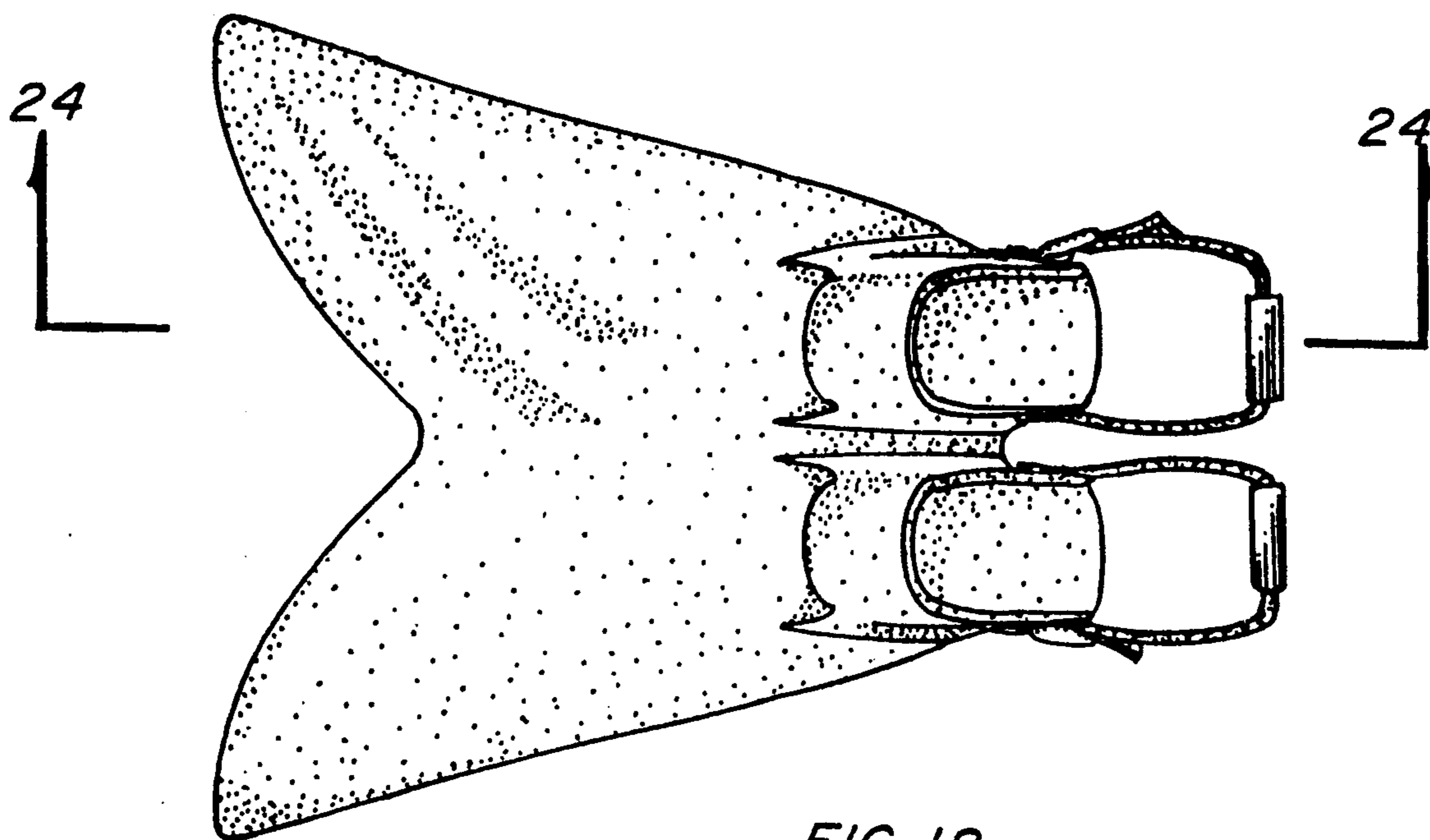

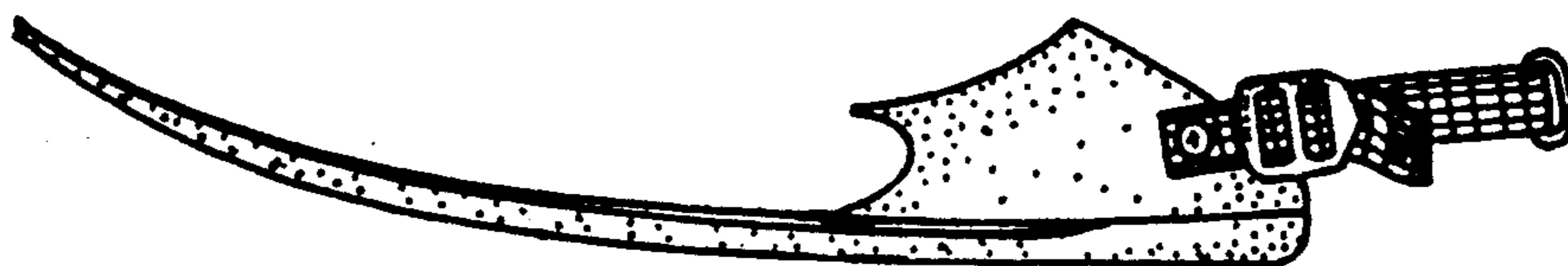

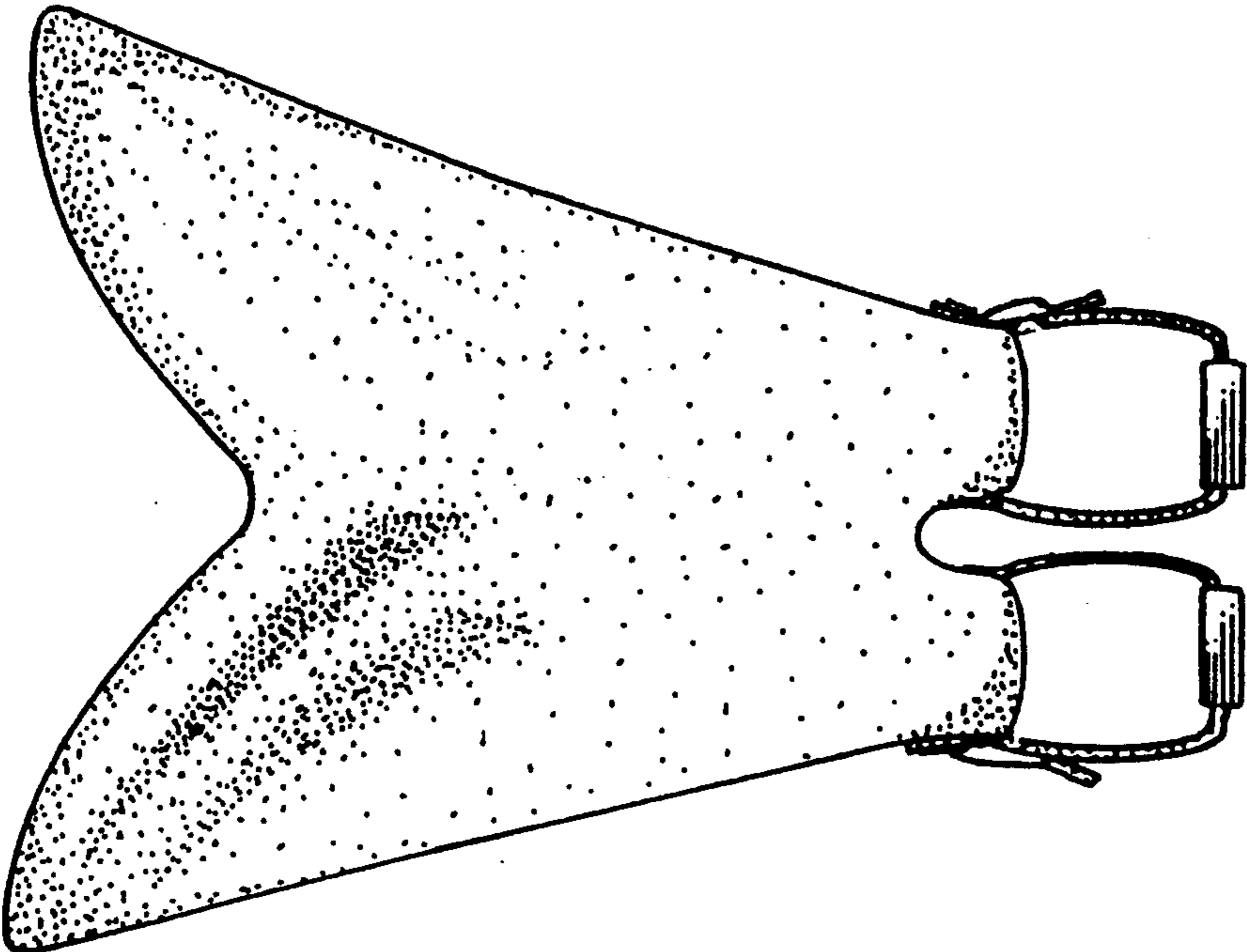

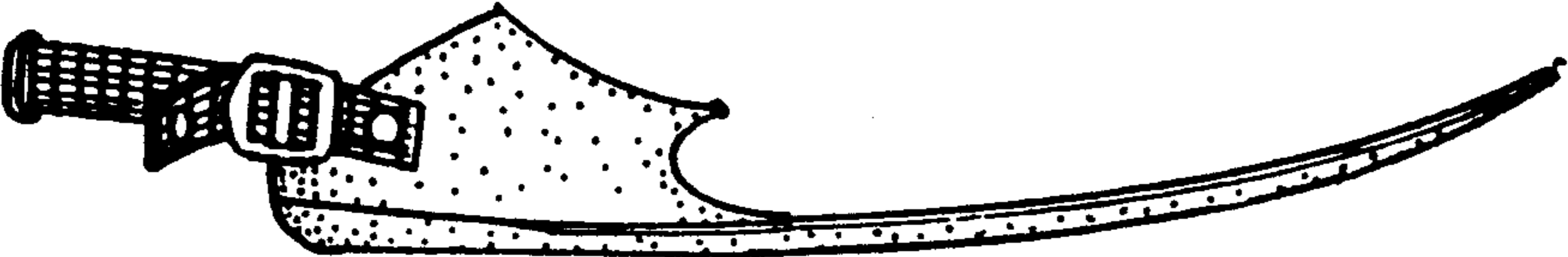

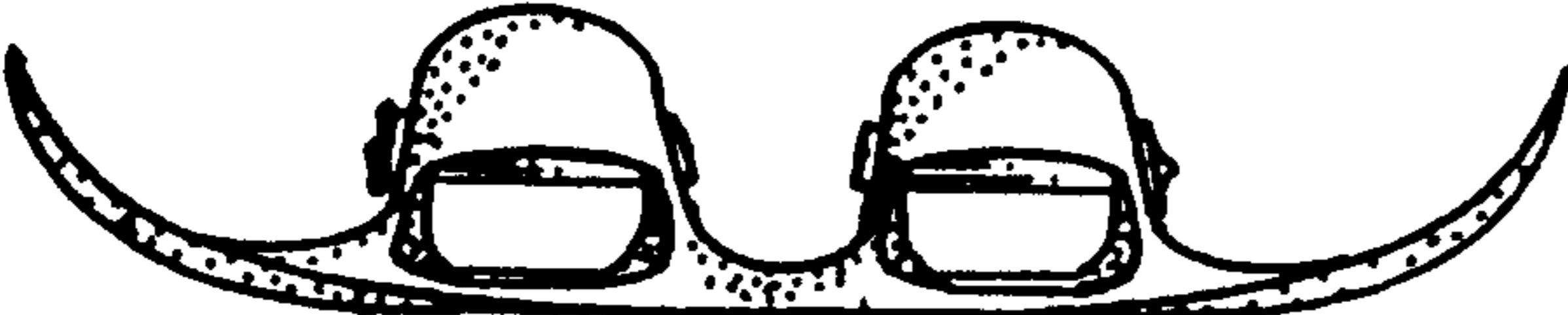

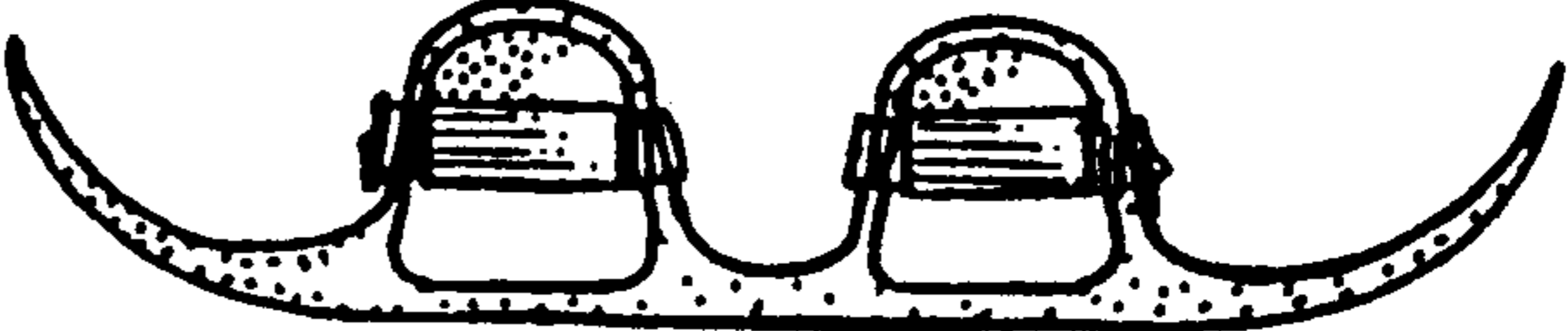

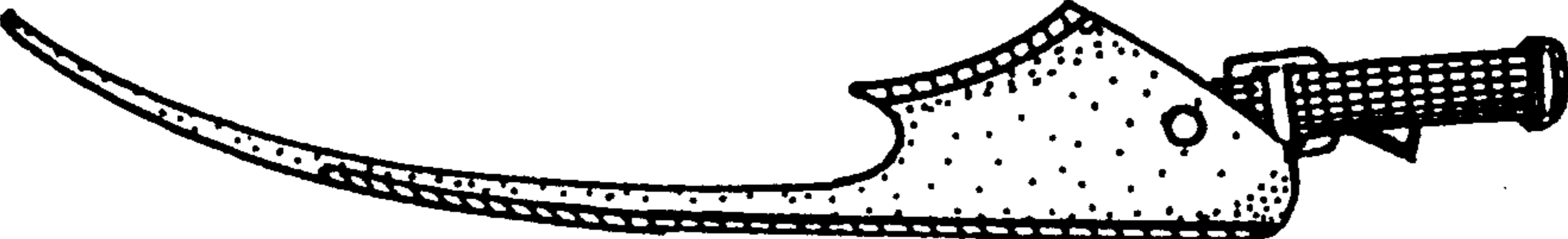

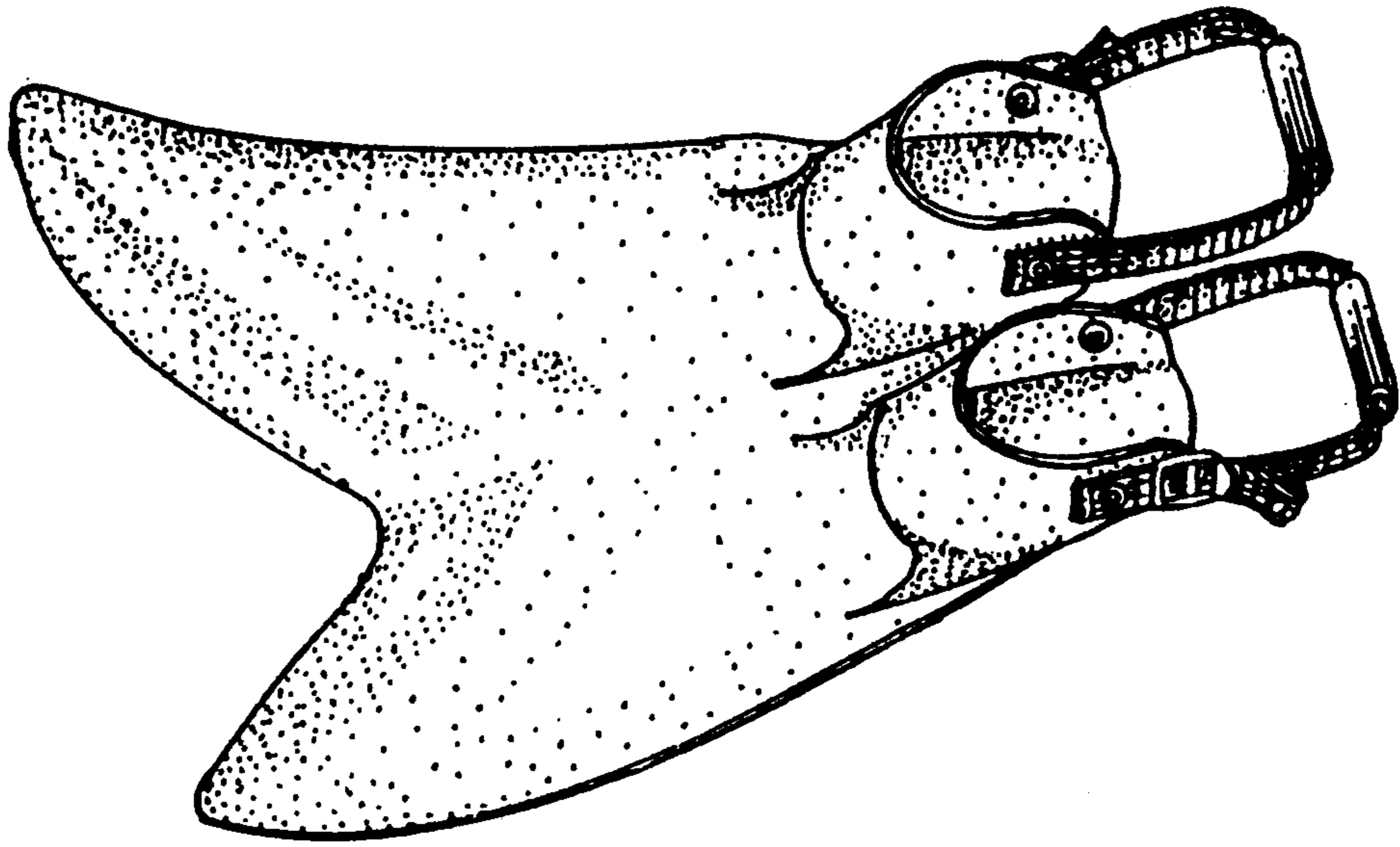

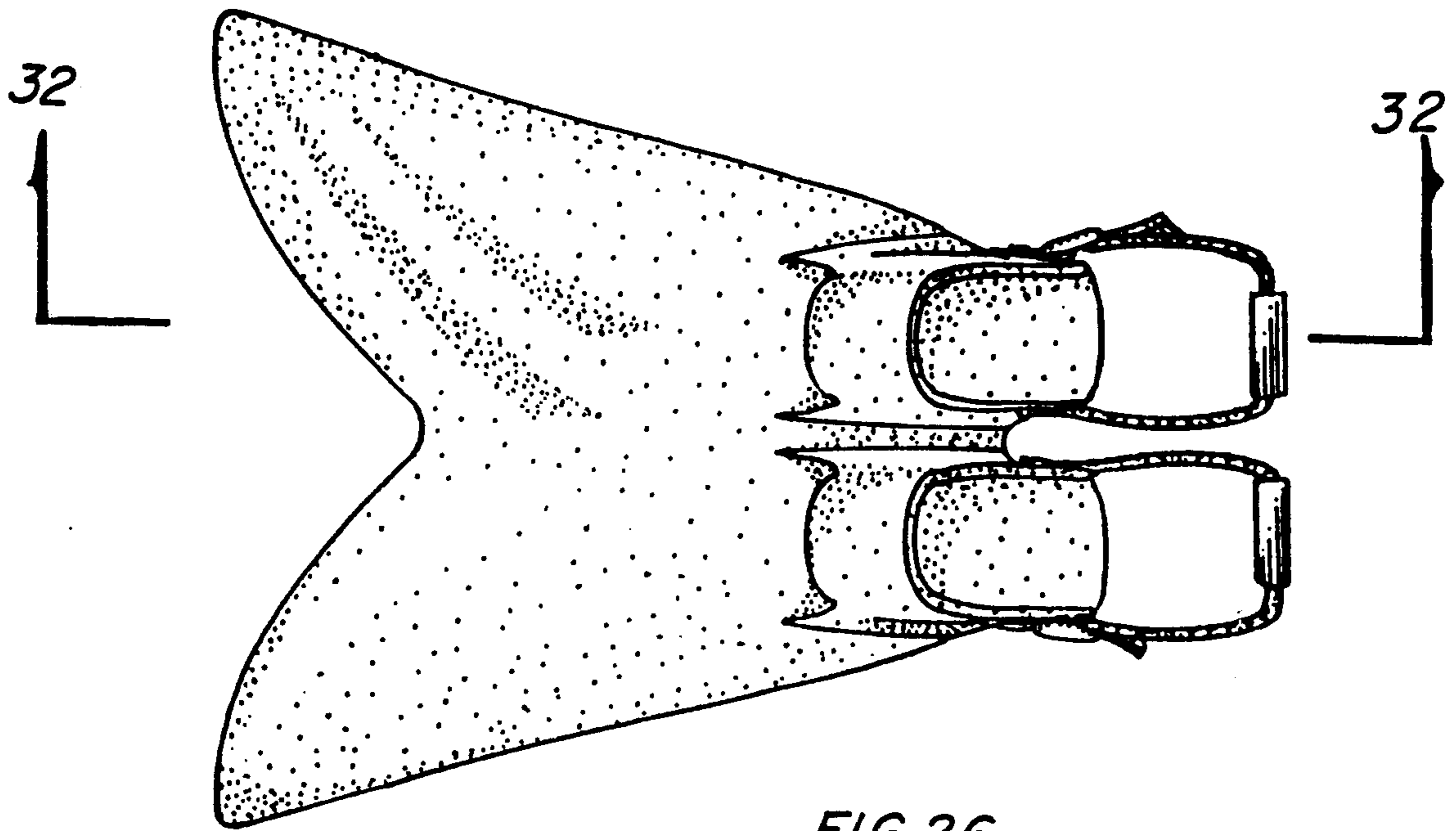

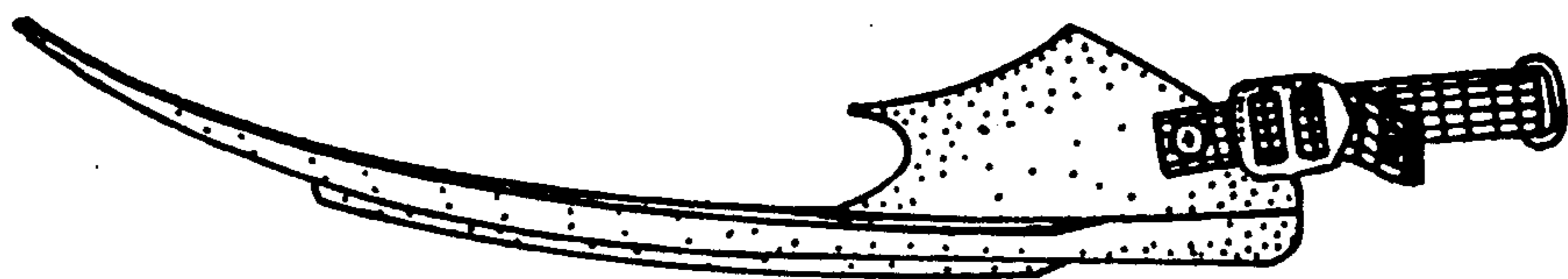

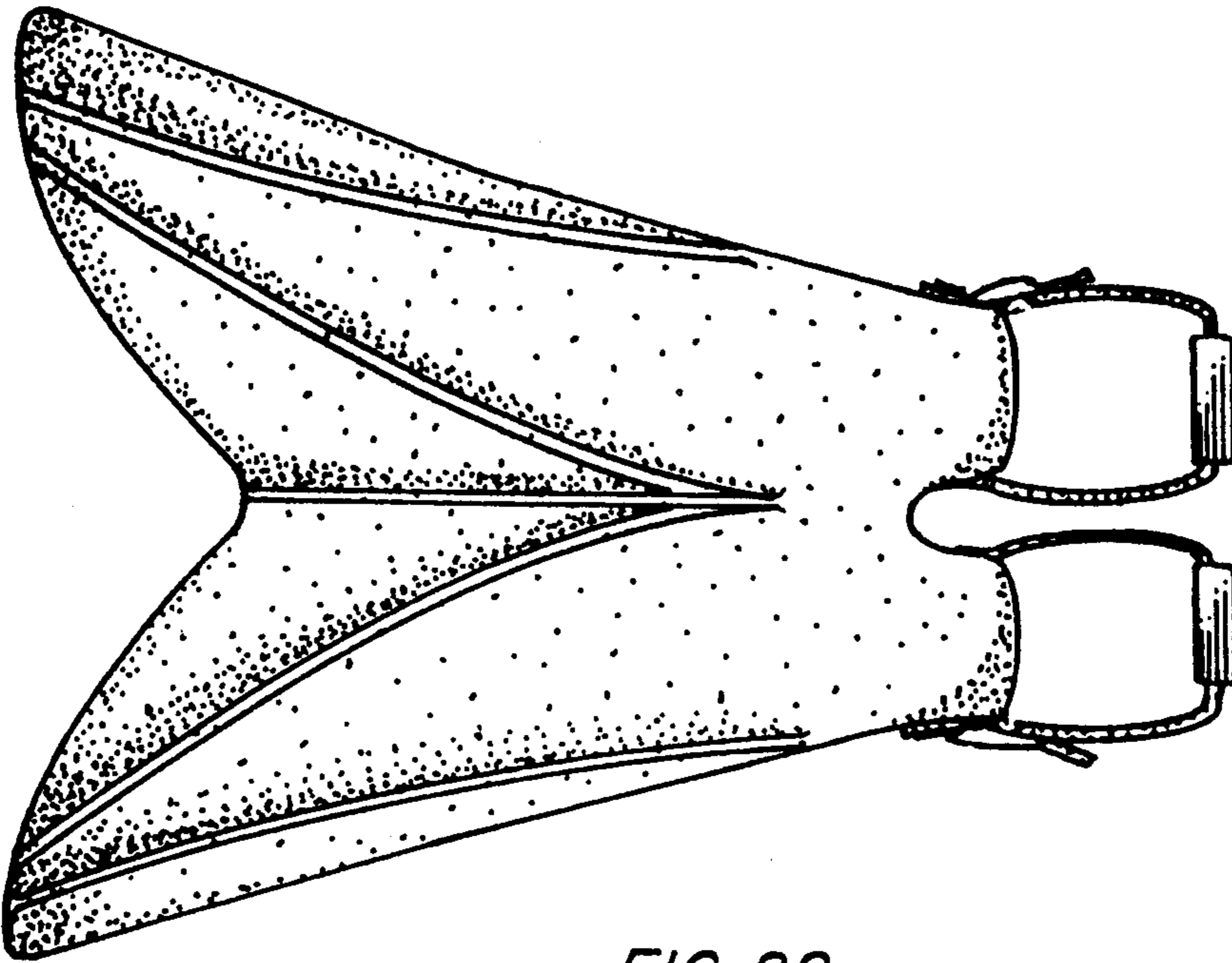

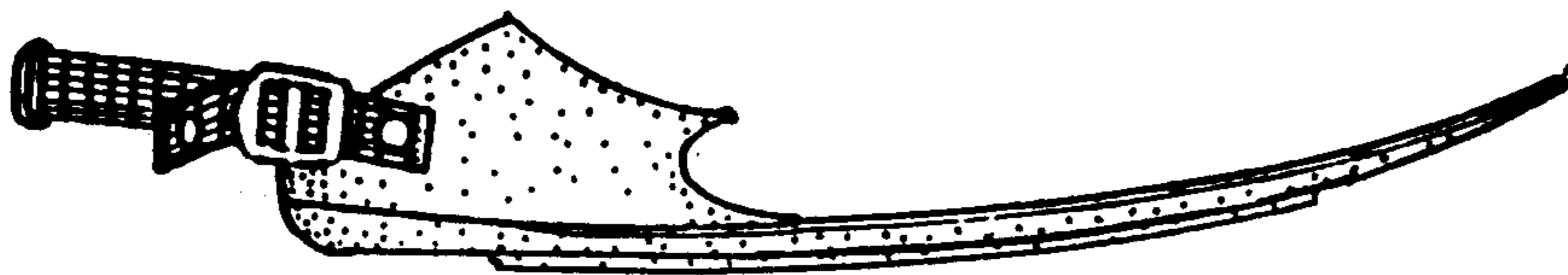

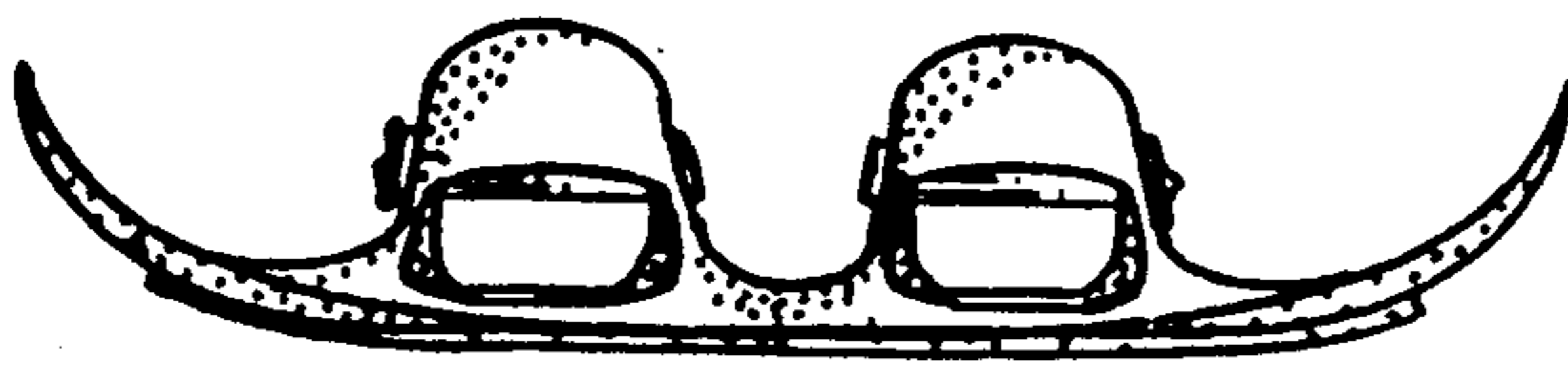

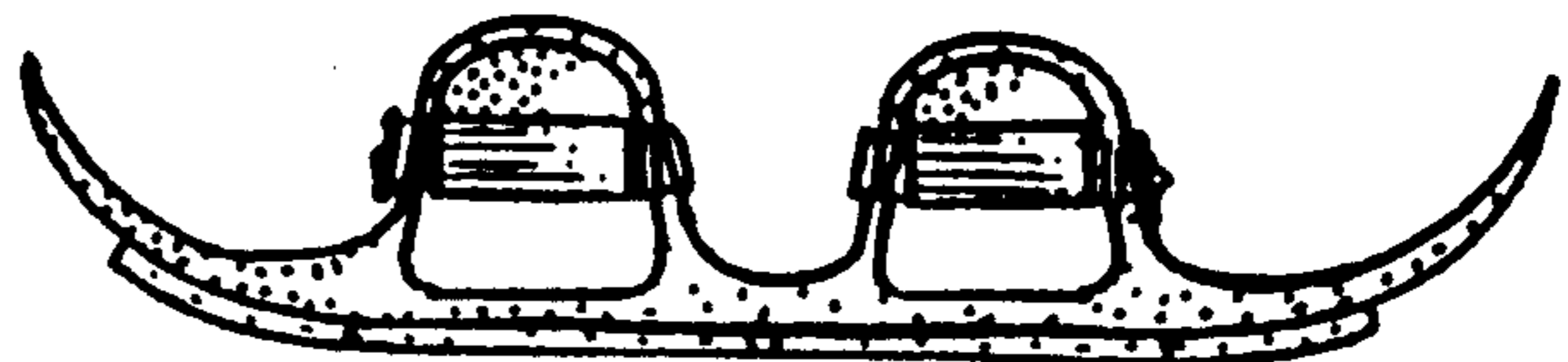

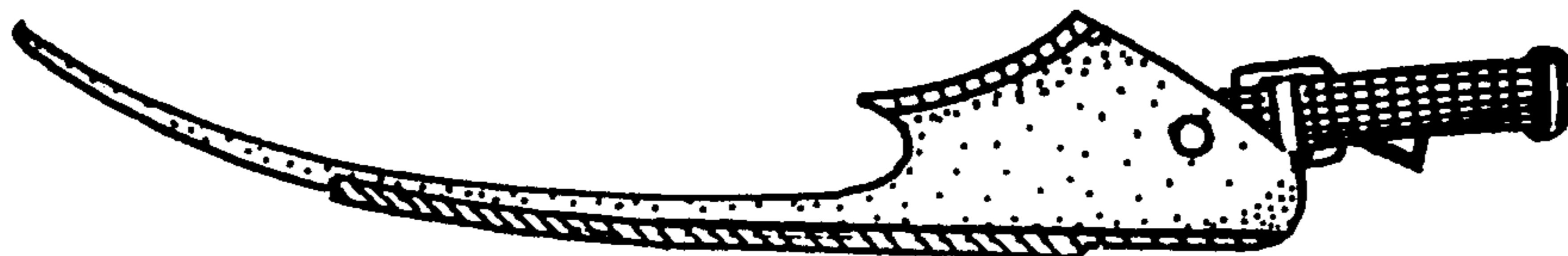
