**DESCRIPTION**

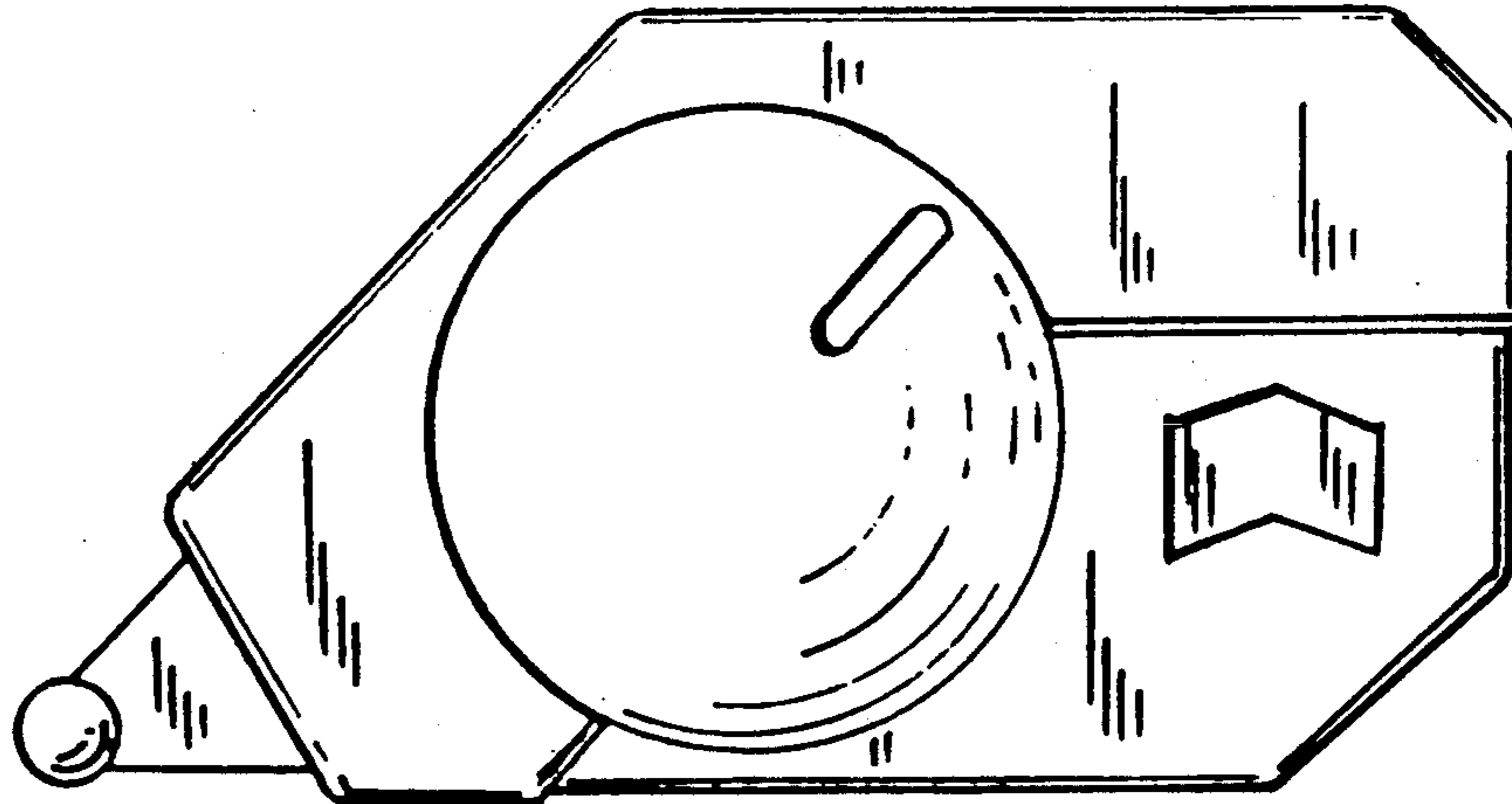
FIG. 1 is a front elevational view of a combined dispenser and applicator for adhesive strip material showing my new design;

FIG. 5 is a bottom plan view thereof.



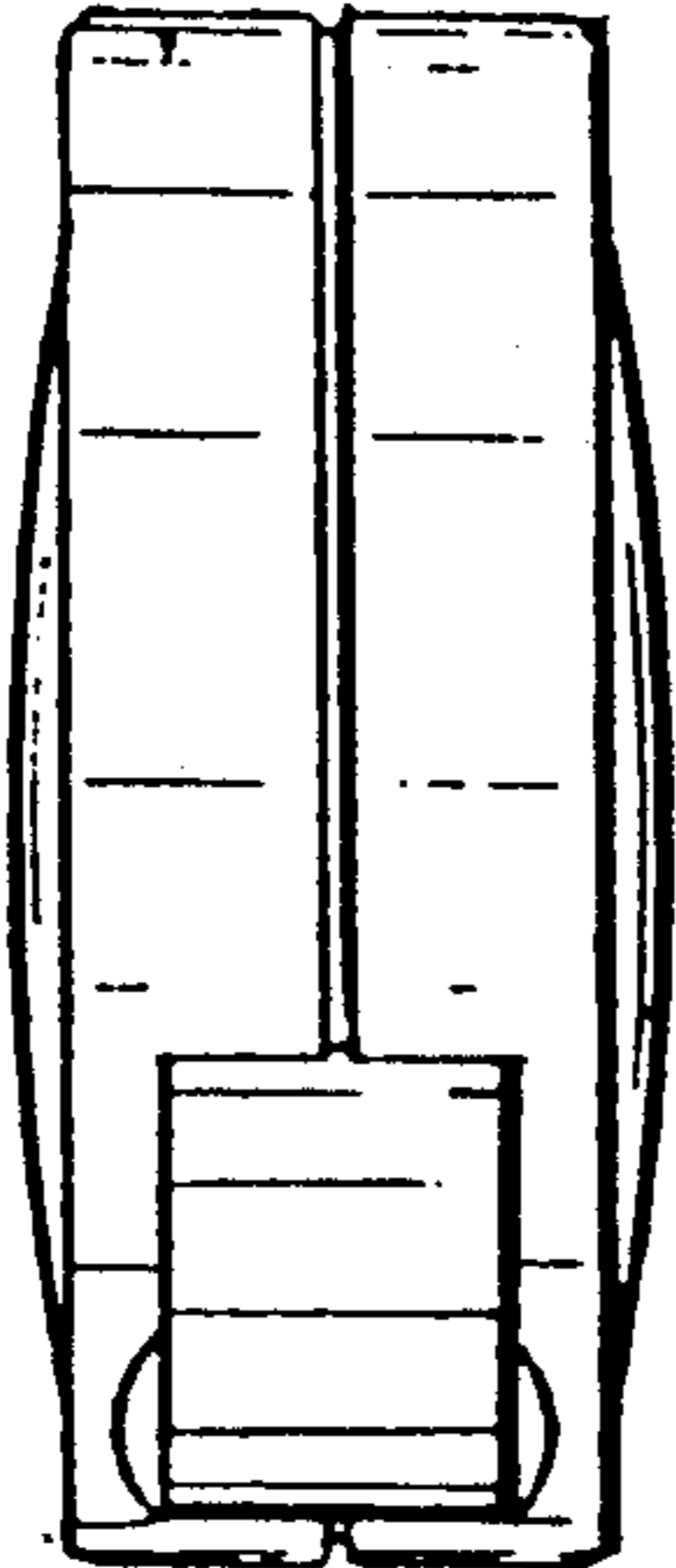

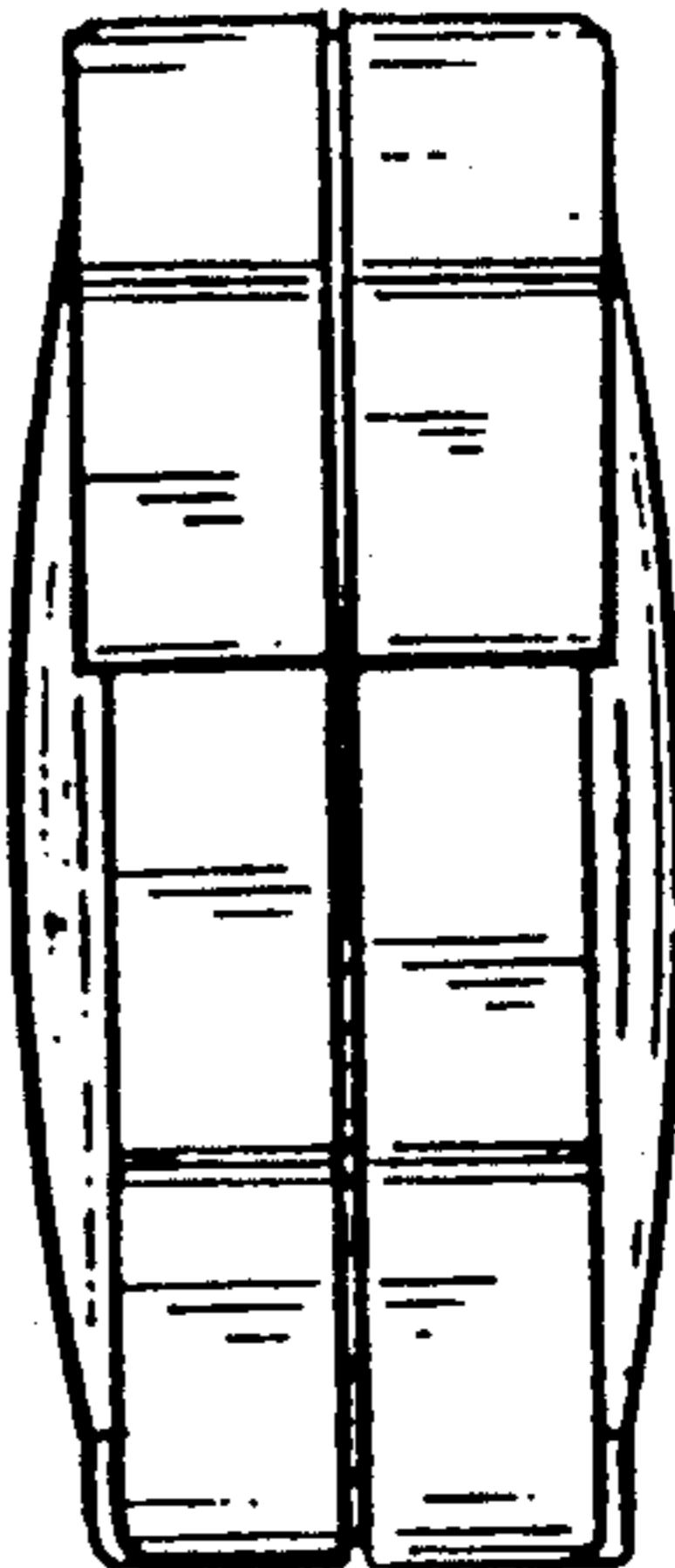

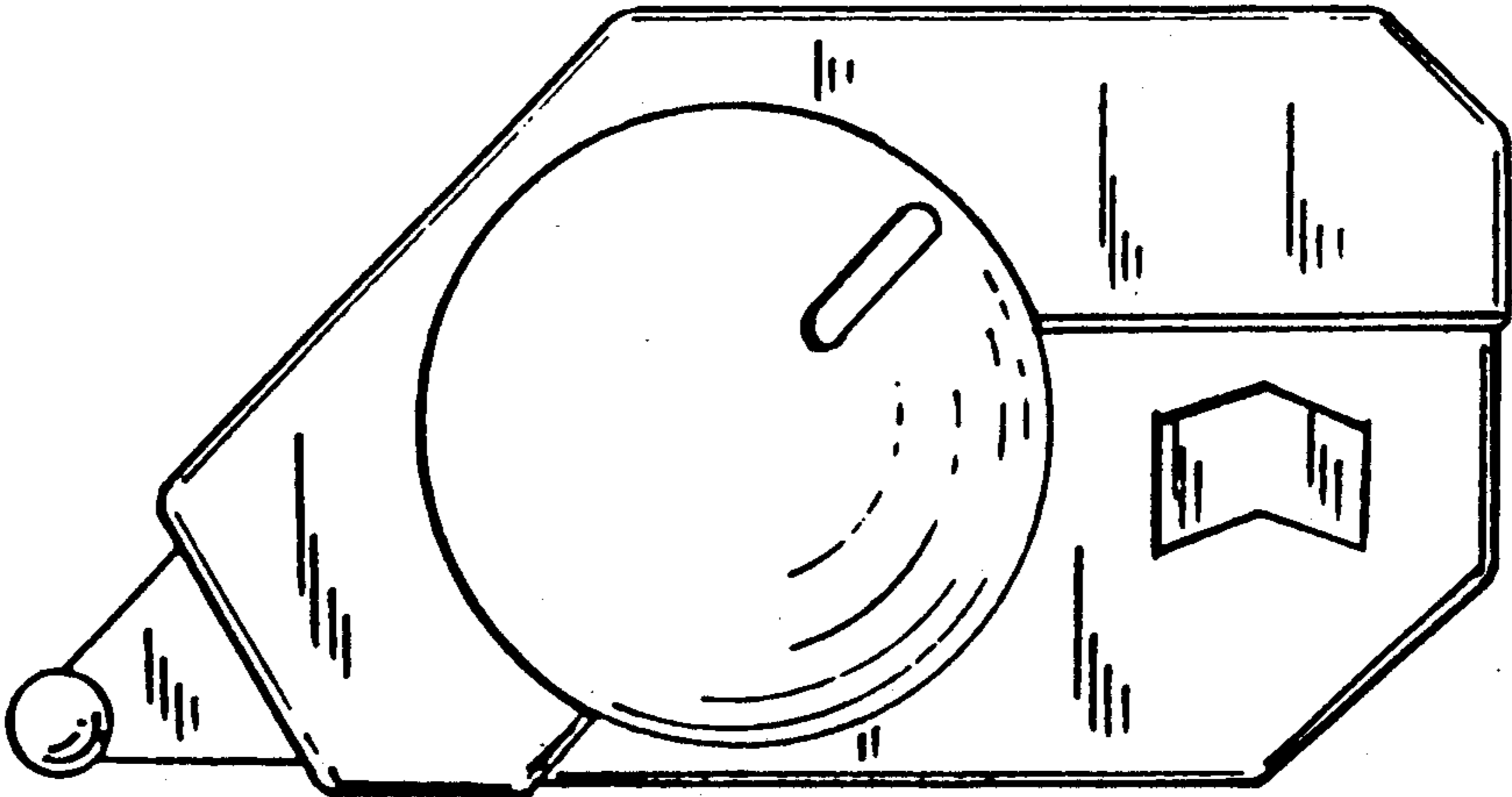

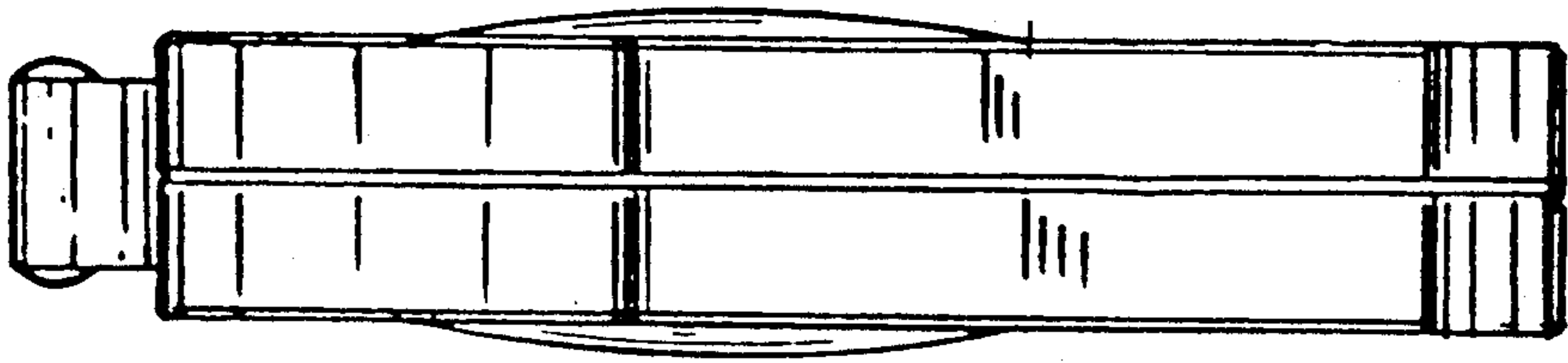

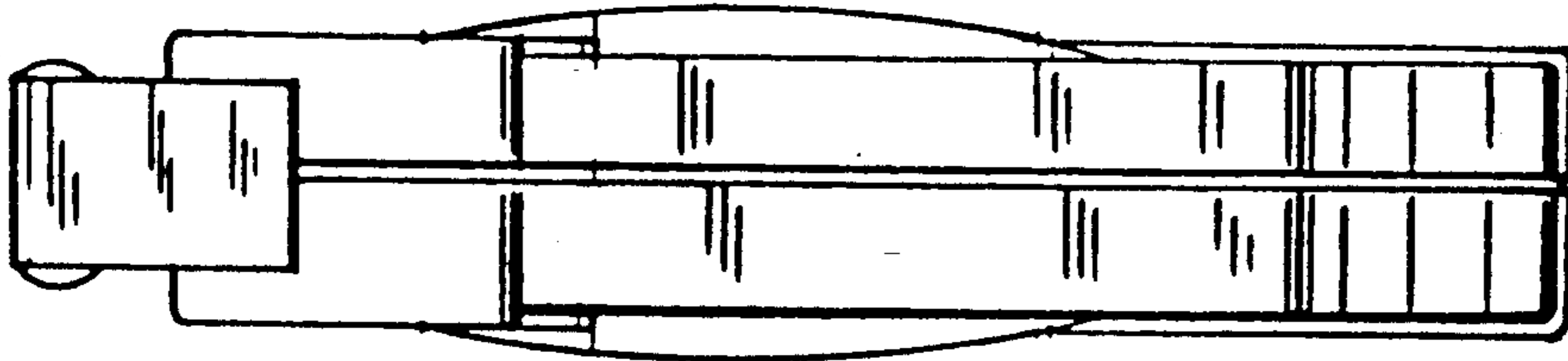
