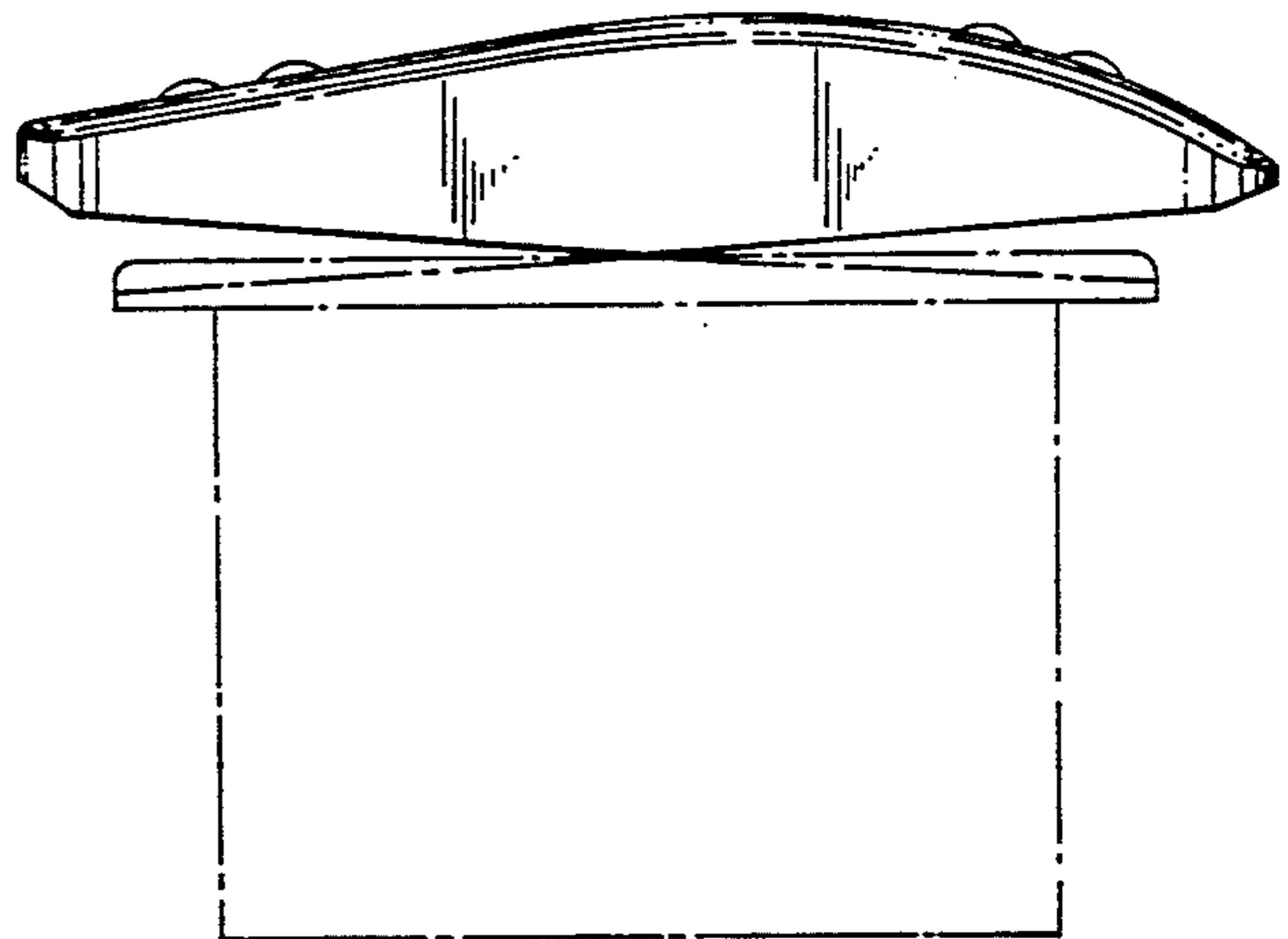
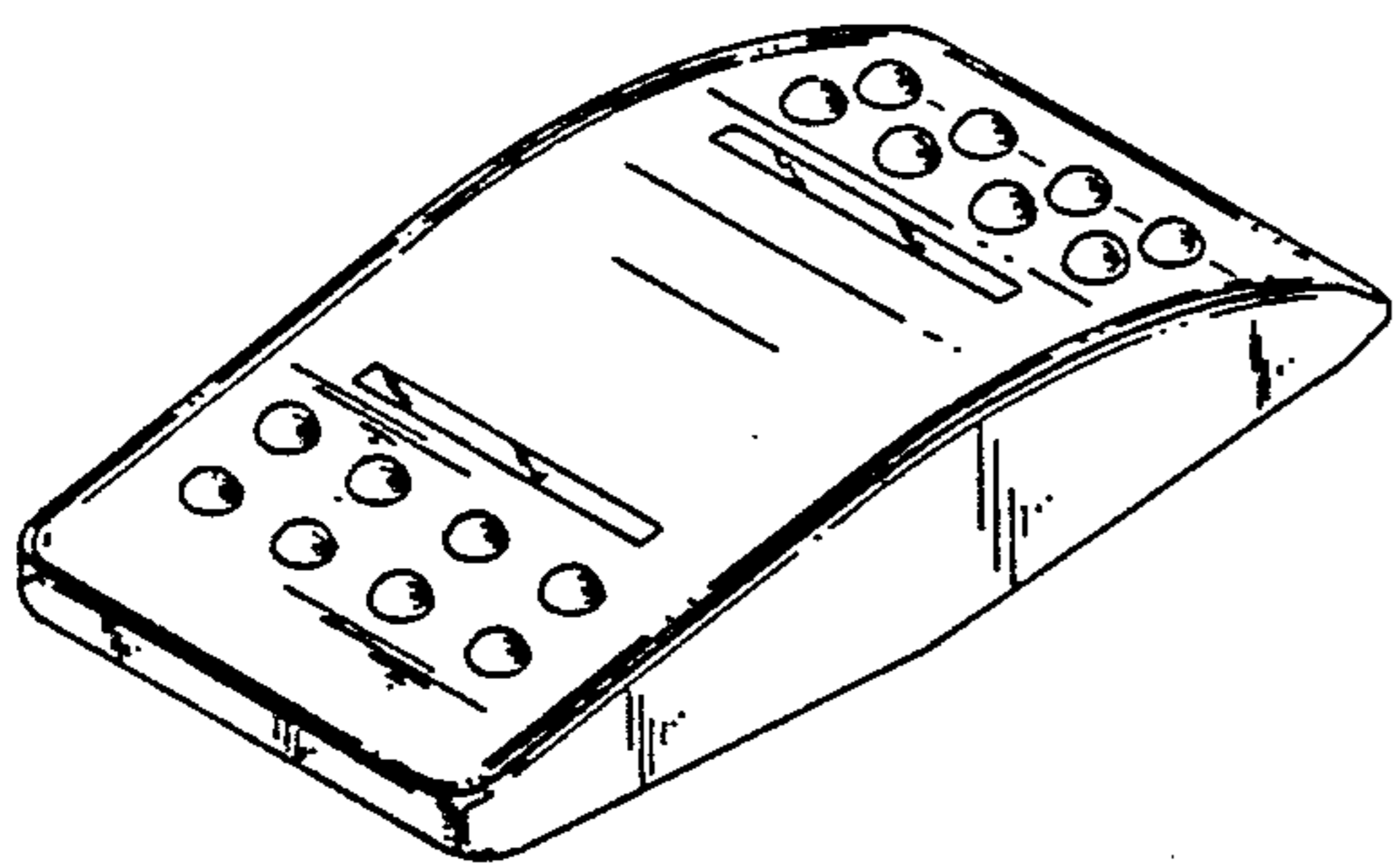

[57] **CLAIM**

The ornamental design for a rocker switch actuator, as shown and described.

DESCRIPTION

FIG. 1 is a front upper right perspective view of a rocker switch actuator showing our new design; FIG. 2 is a top plan view of a rocker switch actuator showing our new design on an enlarged scale. The broken line showing the switch housing being included for the purpose of illustrating environmental background only and forming no part of the claimed design; FIG. 3 is a front end elevational view thereof; FIG. 4 is a right side elevational view thereof, the left side elevational view being a mirror image thereof; FIG. 5 is a right hand elevational view thereof; FIG. 6 is a top plan view of a rocker switch actuator showing a second embodiment of our claimed design; FIG. 7 is a top plan view of a rocker switch actuator showing a third embodiment of our claimed design; FIG. 8 is a top plan view of a rocker switch actuator showing a fourth embodiment of our claimed design; FIG. 9 is a front upper right perspective view of the embodiment illustrated in FIG. 6 shown on a reduced scale; FIG. 10 is a front upper right perspective view of the embodiment illustrated in FIG. 7 shown on a reduced scale; and, FIG. 11 is a front upper right perspective view of the embodiment illustrated in FIG. 8 shown on a reduced scale.



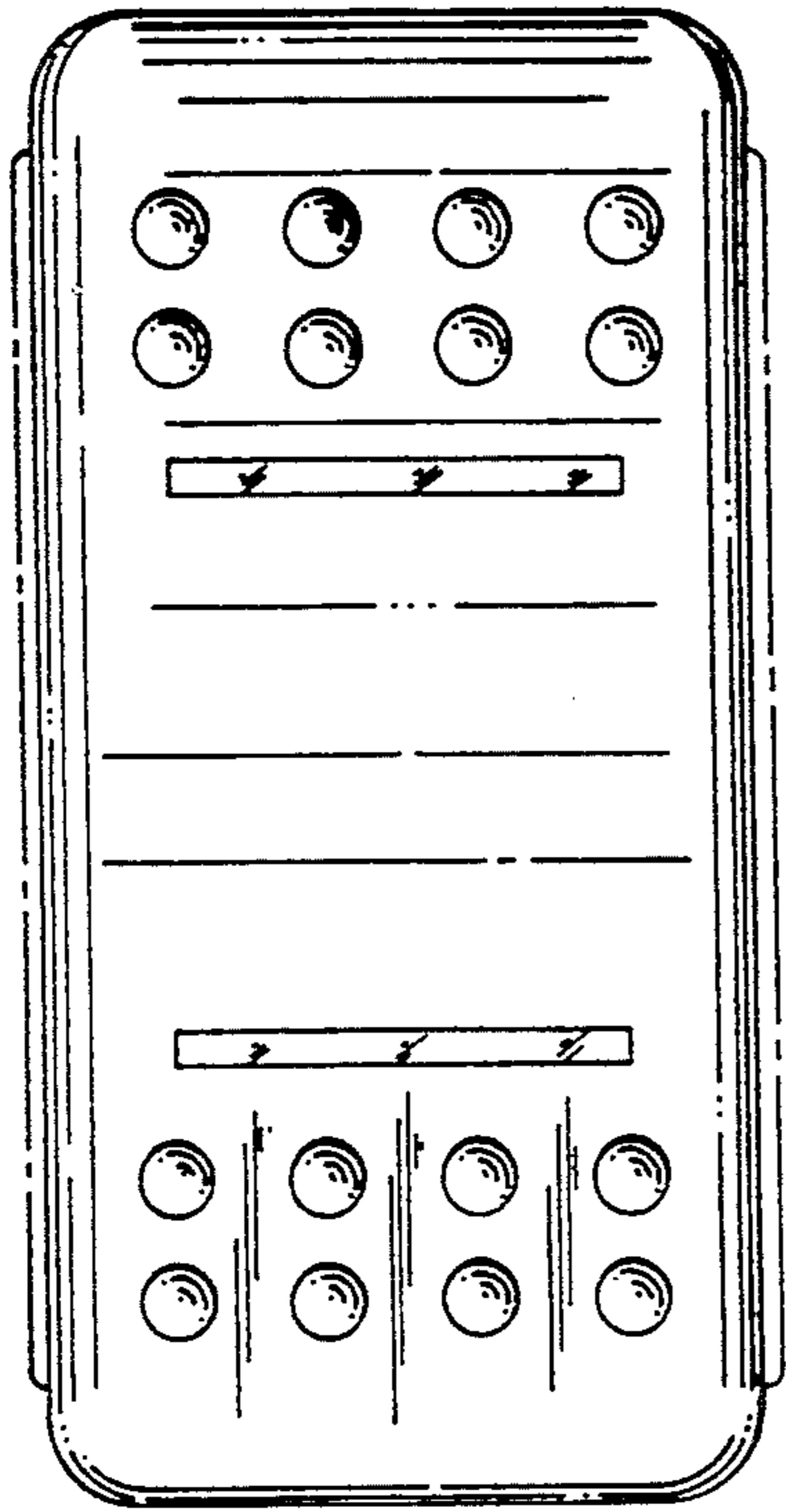

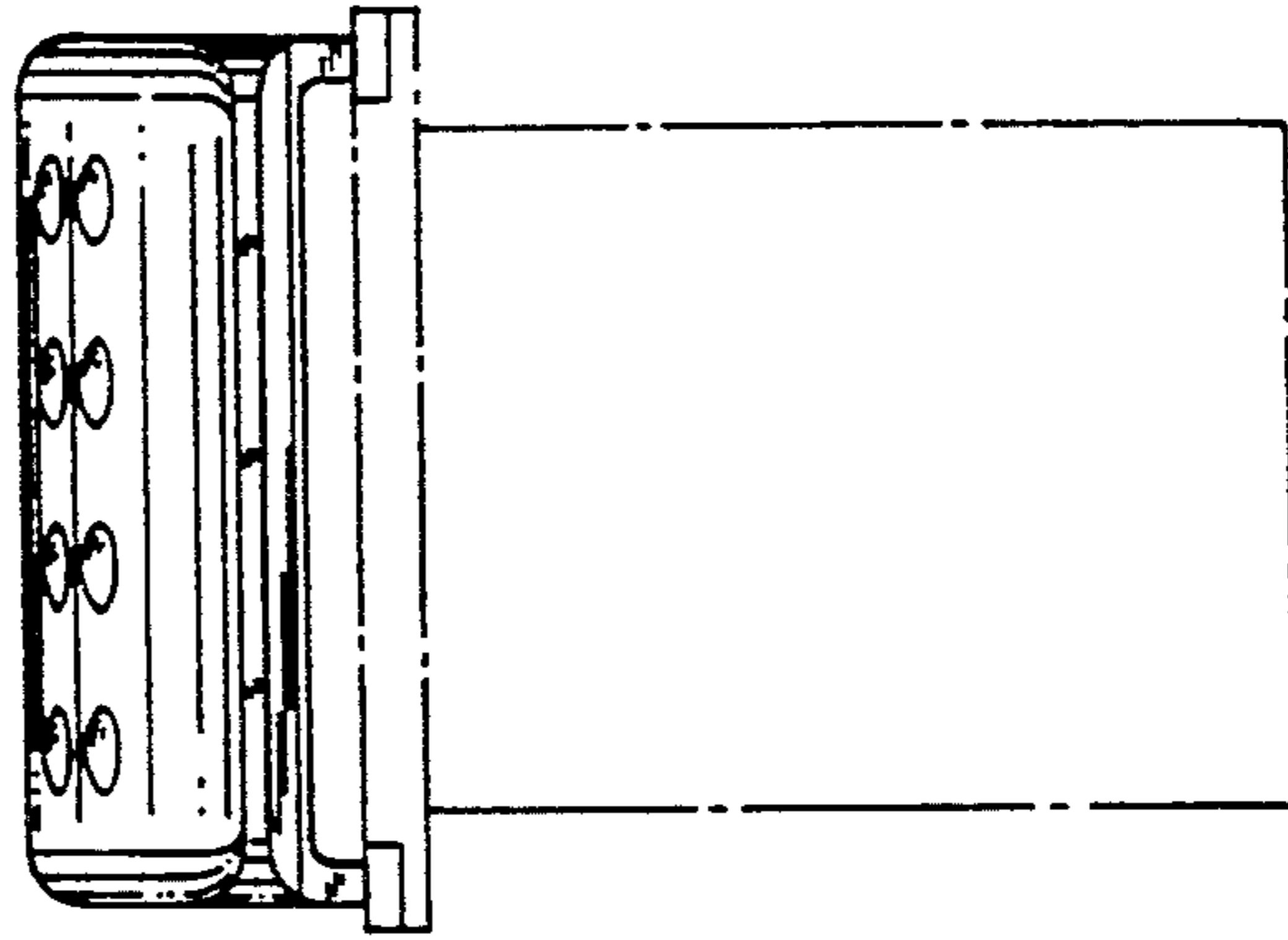

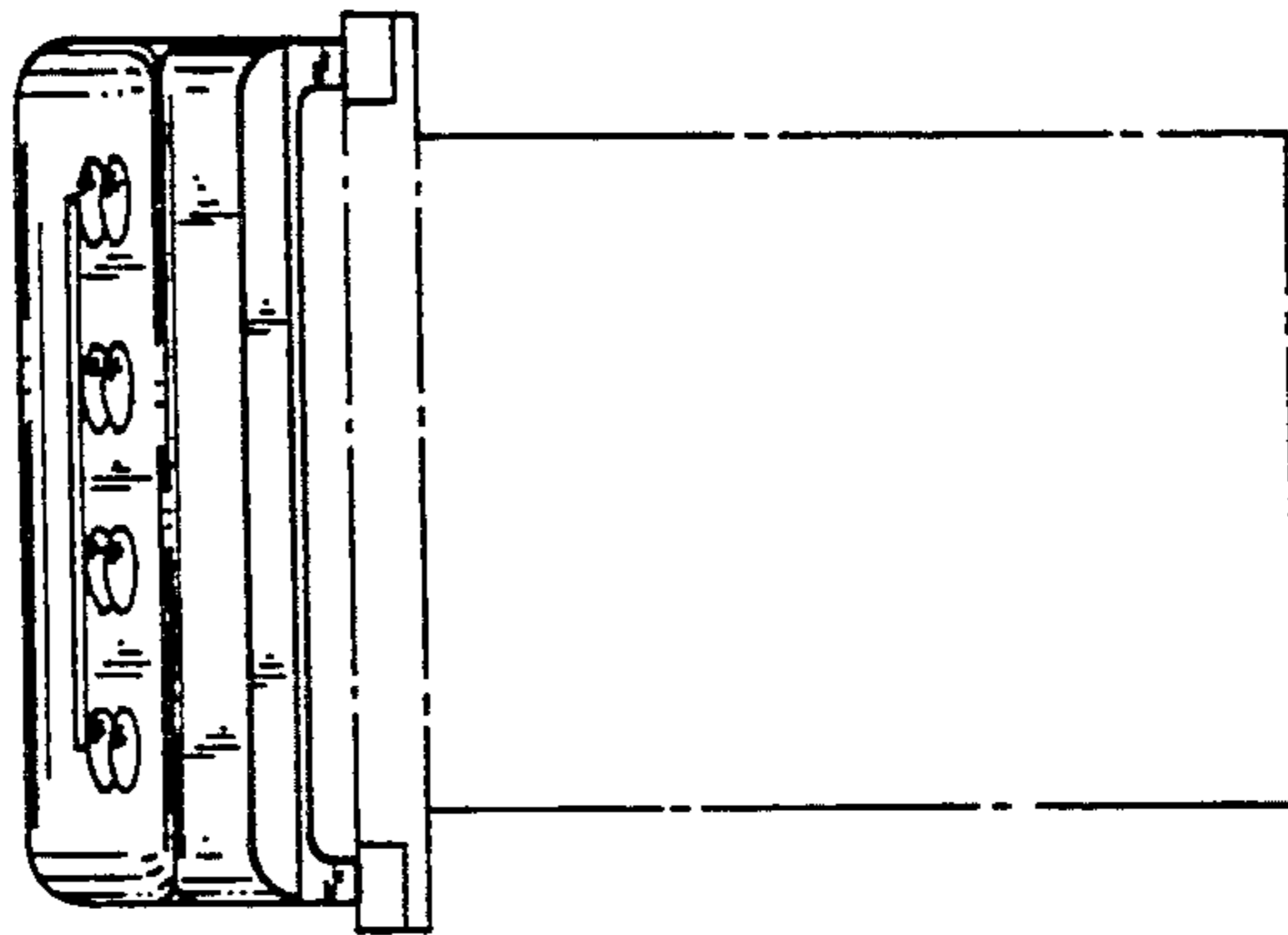

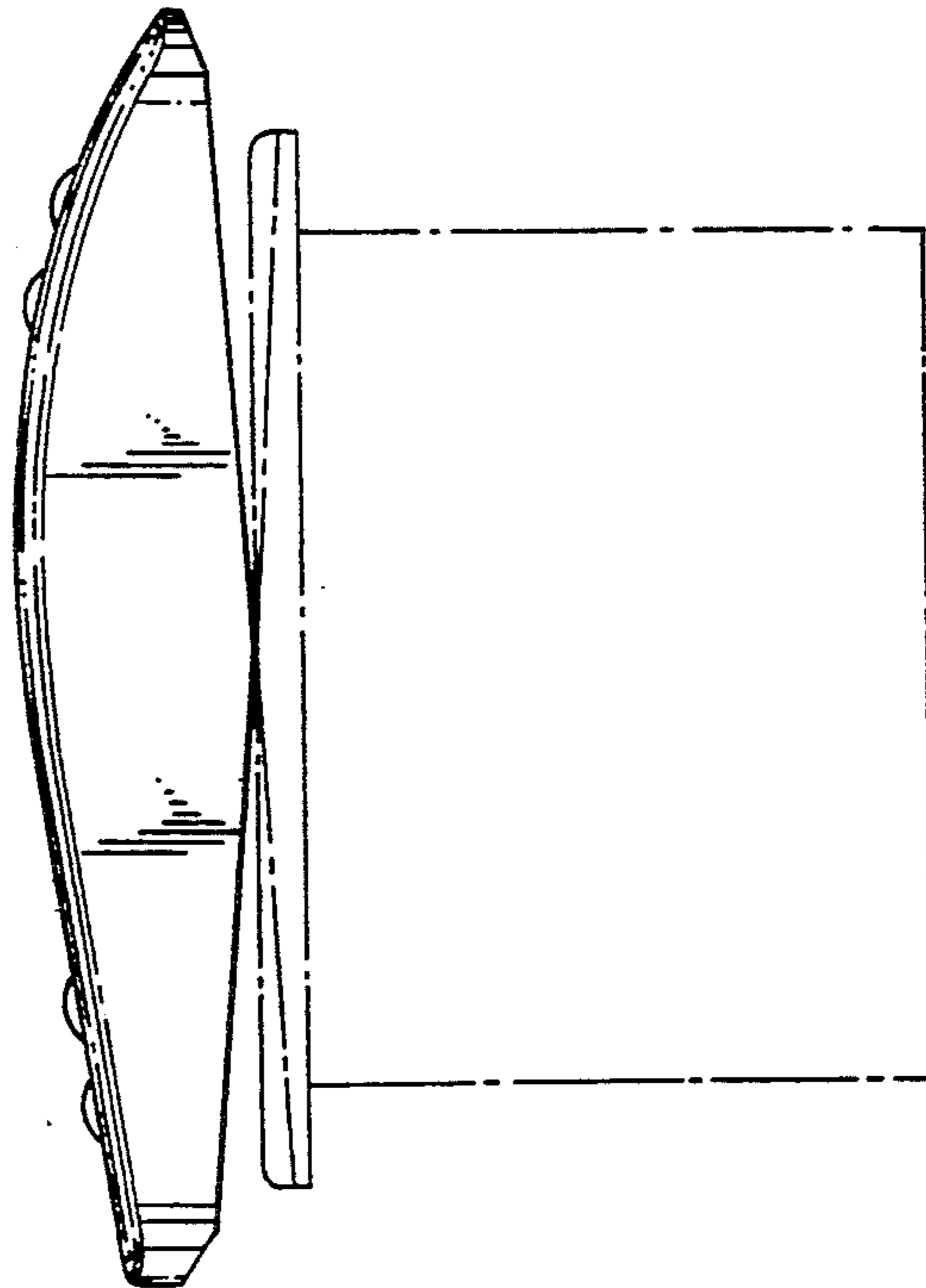

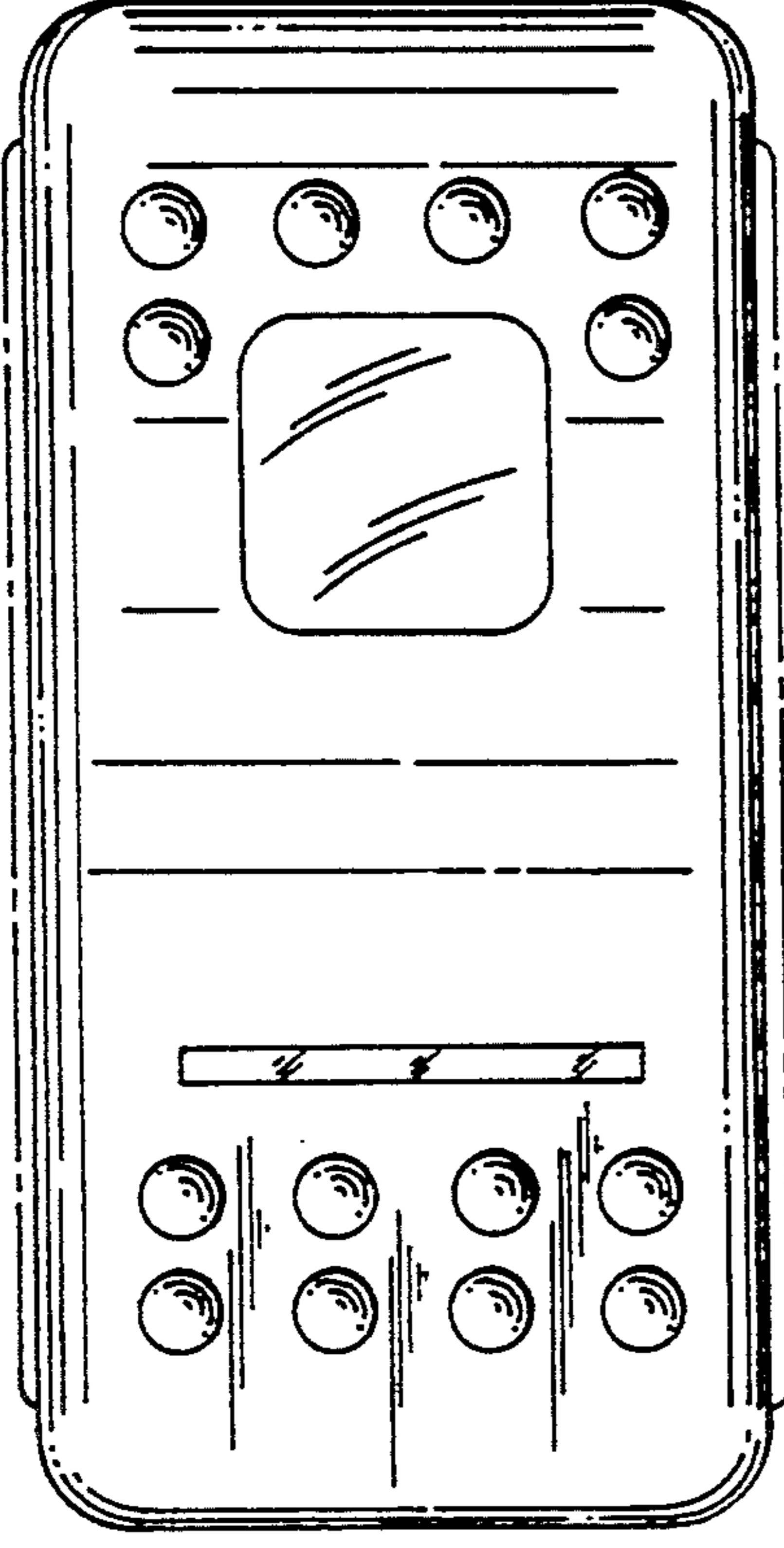

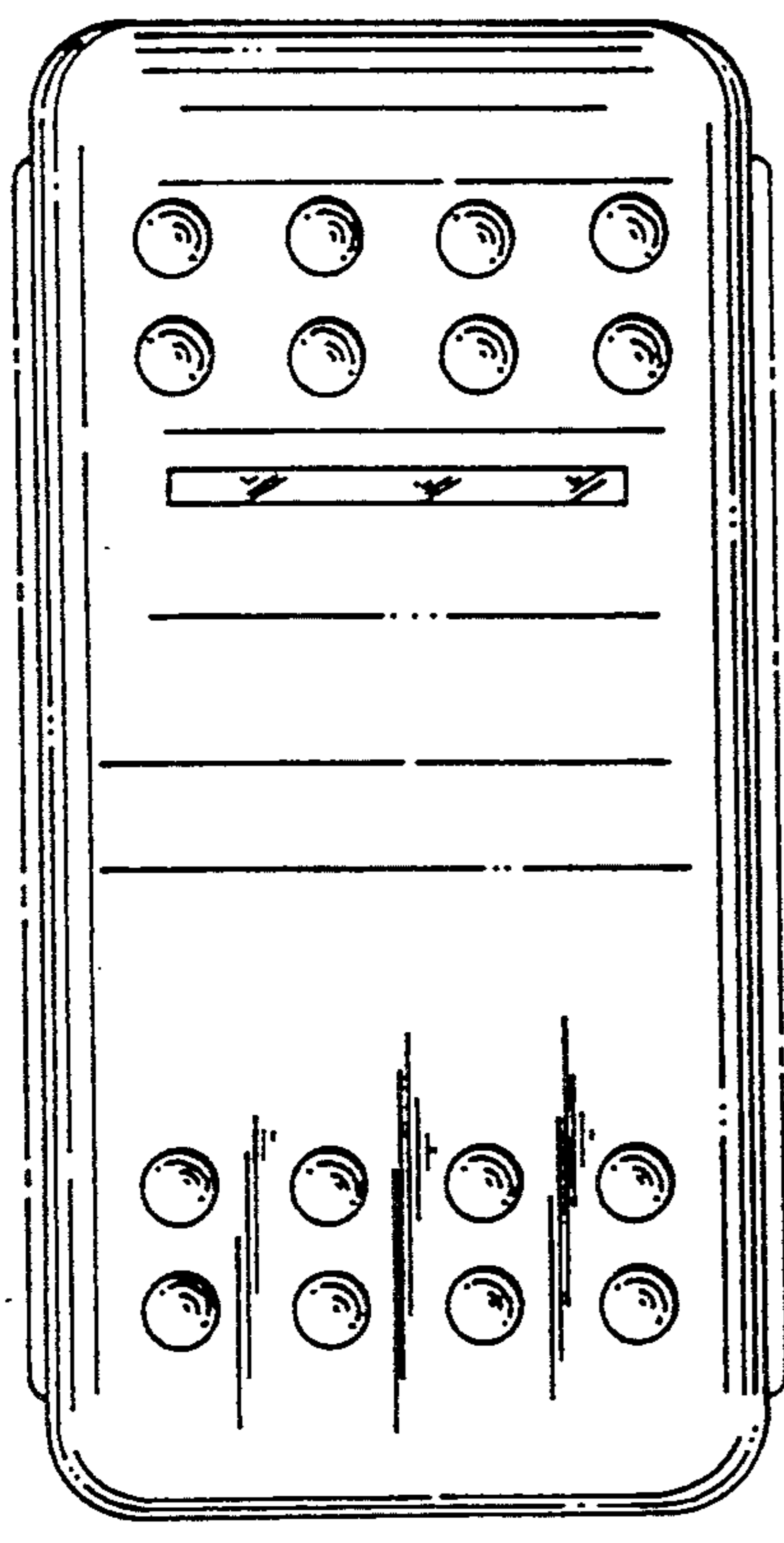

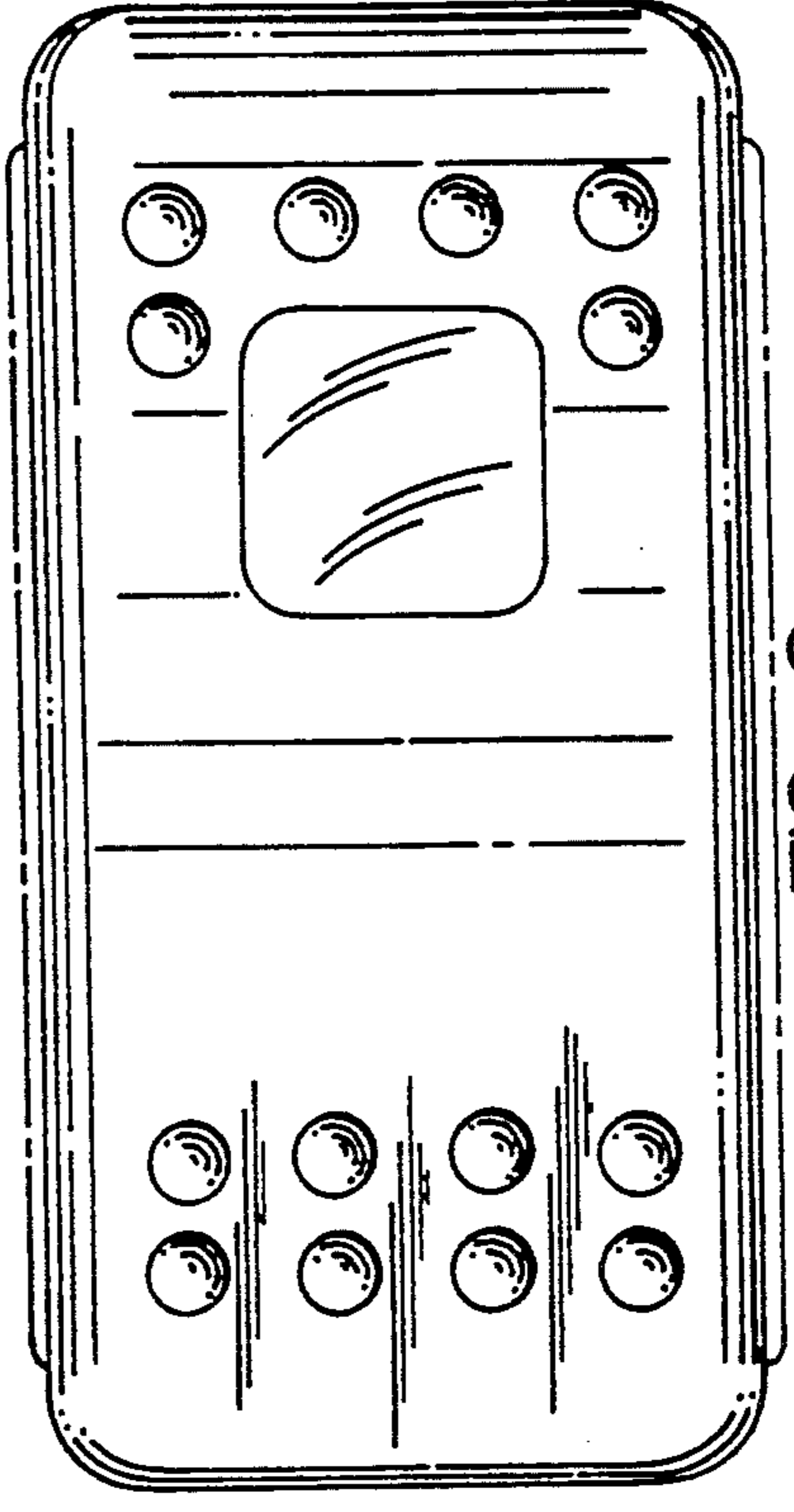

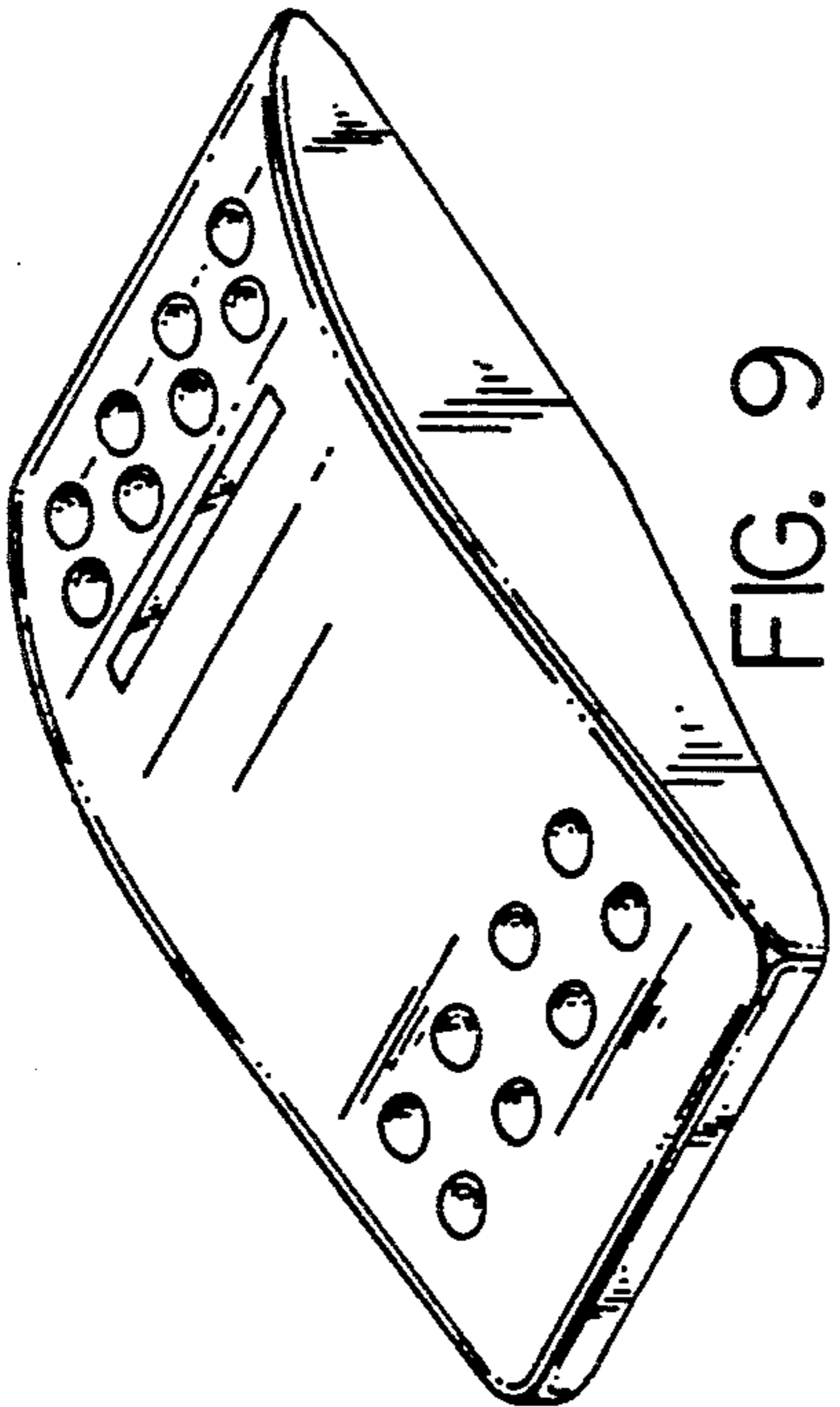

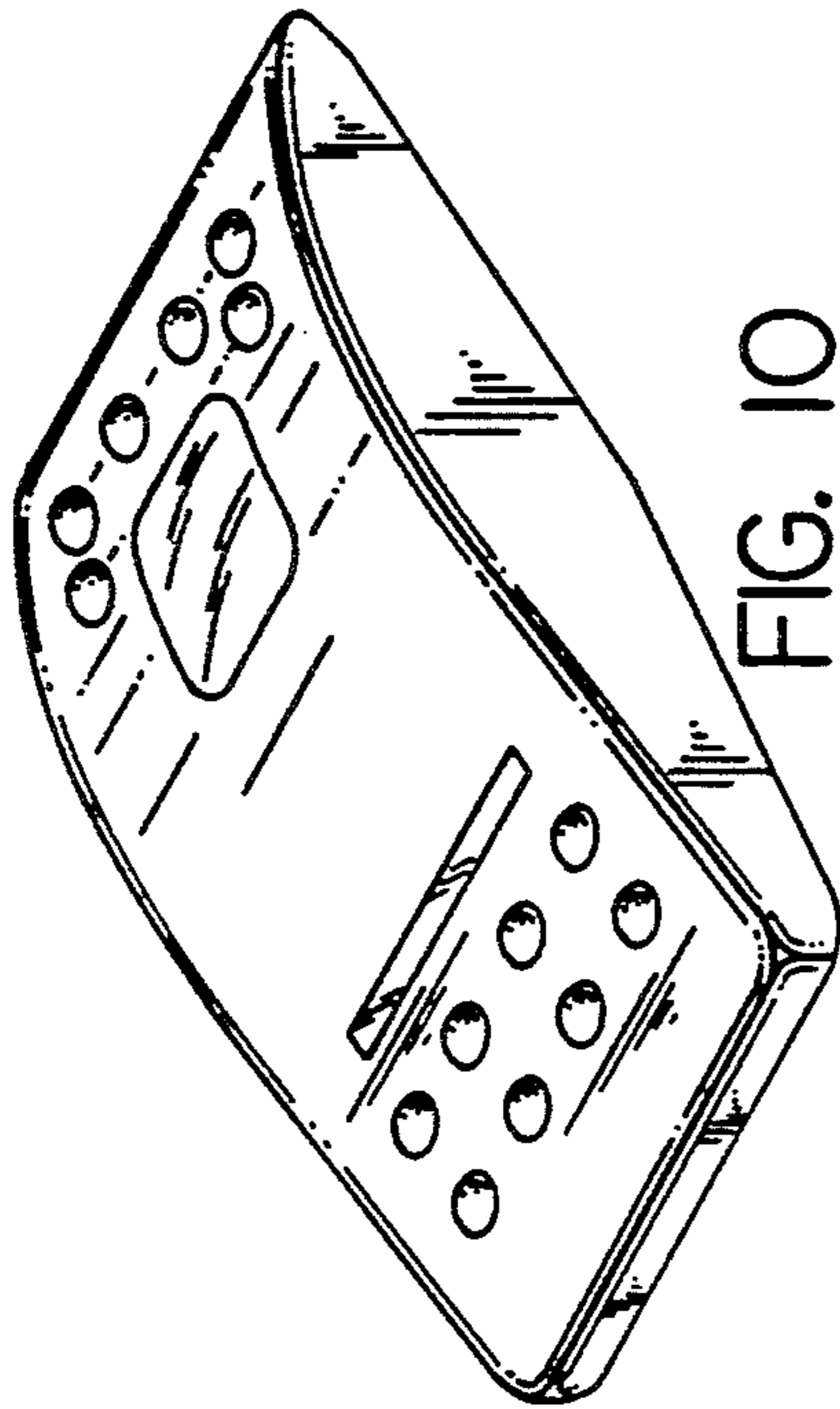

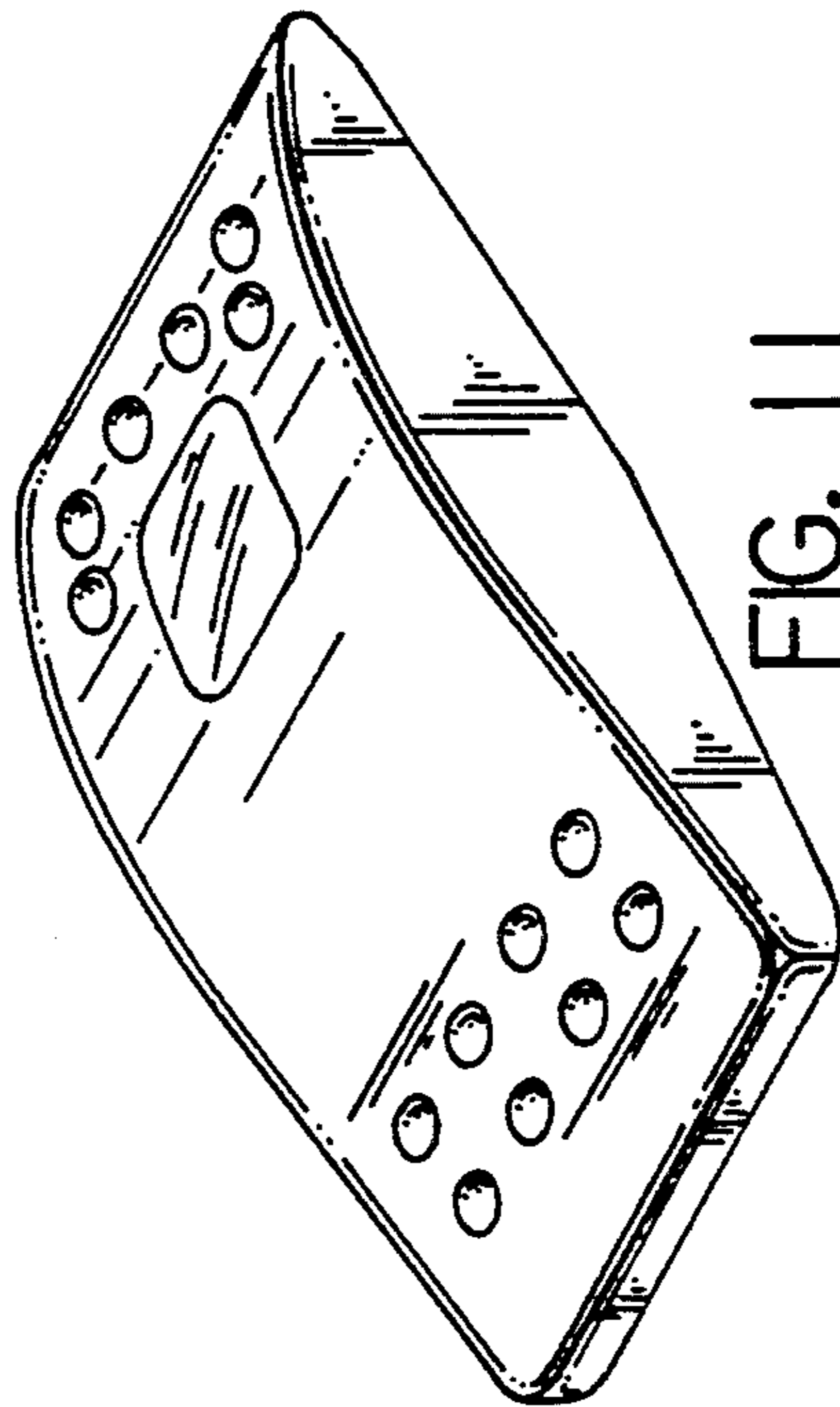
