[57] CLAIM

The ornamental design for a convertible scooter/wagon, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of a convertible scooter/wagon in the wagon condition showing my new design, the side opposite being a mirror image;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a bottom plan view thereof;
 FIG. 4 is a front elevational view thereof;
 FIG. 5 is a rear elevational view thereof;
 FIG. 6 is a side elevational view thereof in its scooter condition;
 FIG. 7 is a top plan view thereof in the scooter condition;
 FIG. 8 is a front elevational view thereof in the scooter condition; and,
 FIG. 9 is an enlarged cross-sectional view taken through FIG. 7 along the line 9—9.

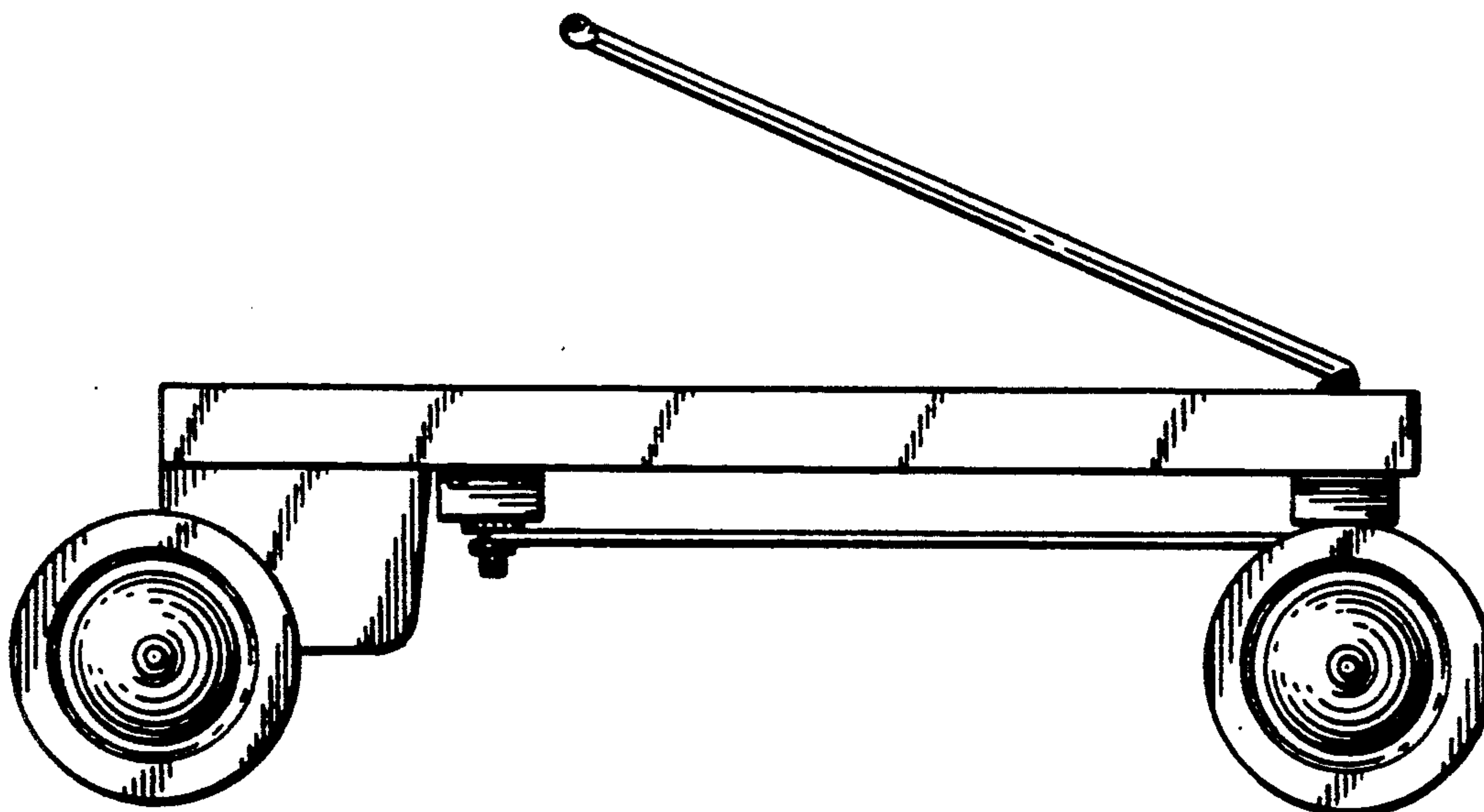

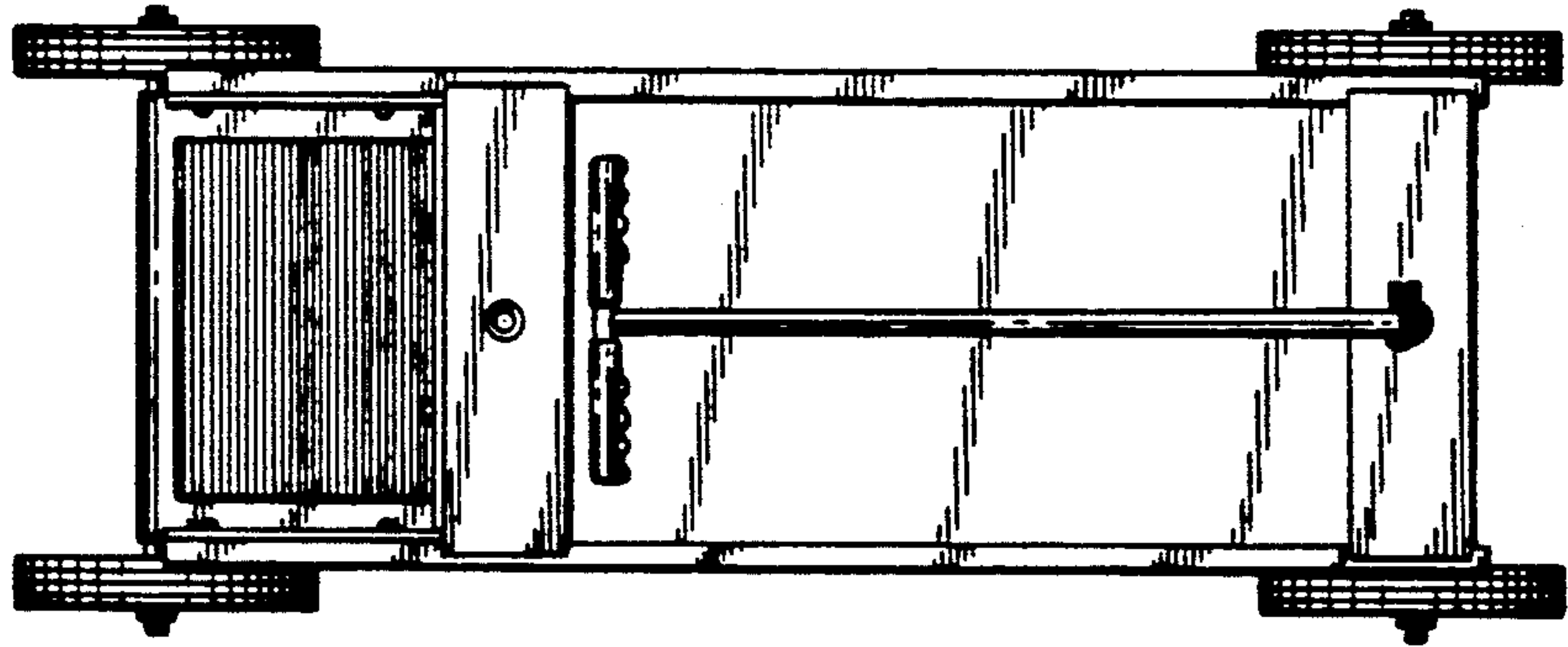

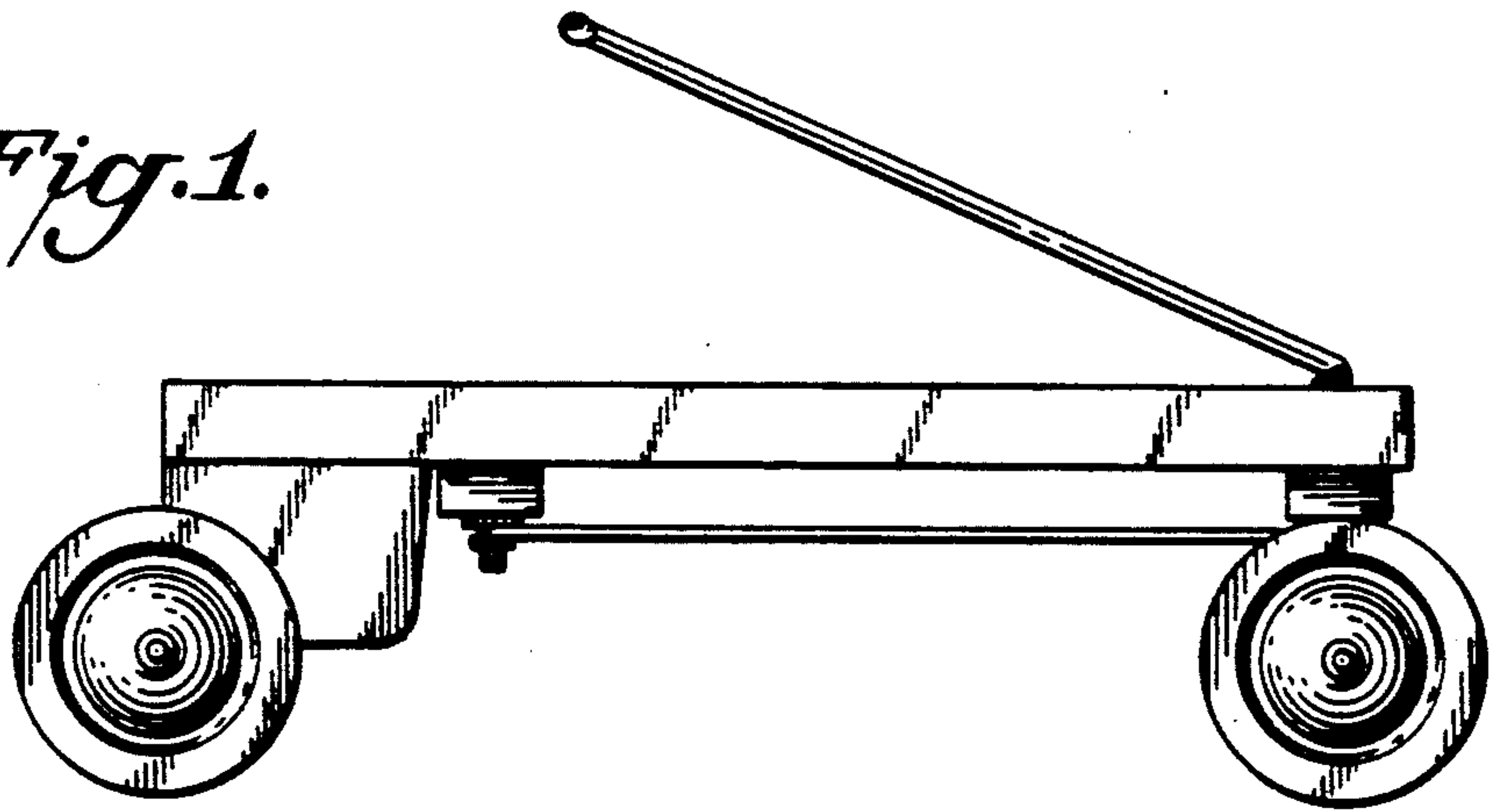

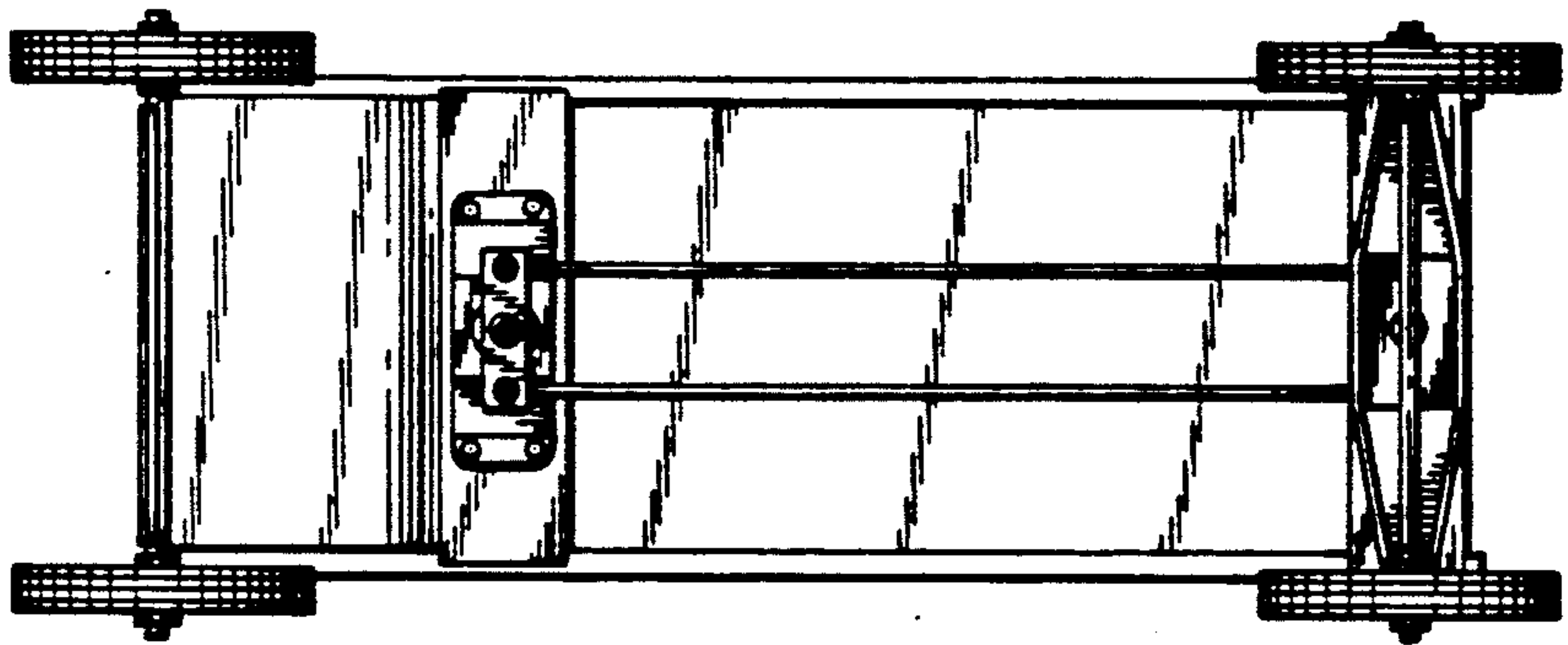

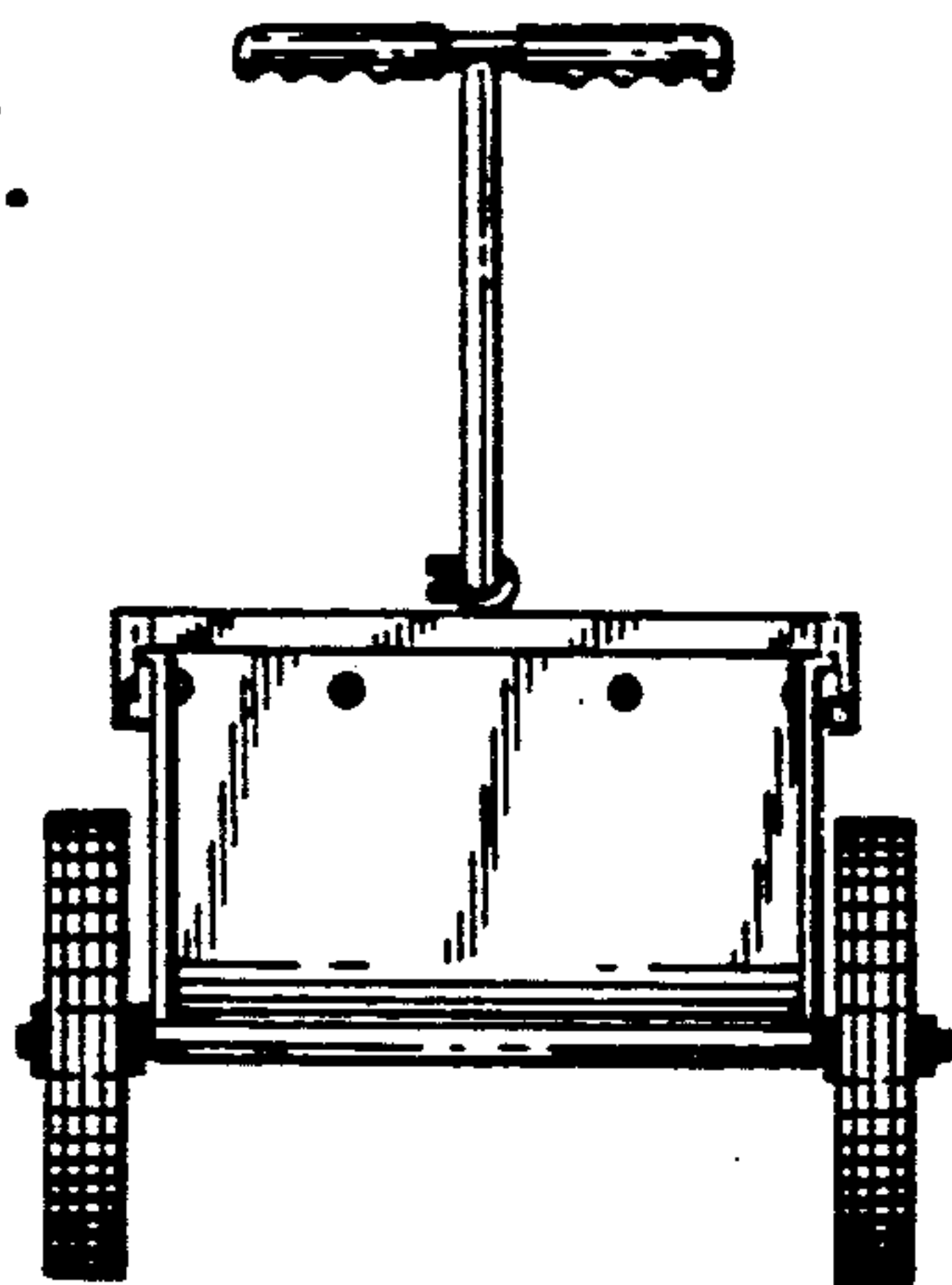

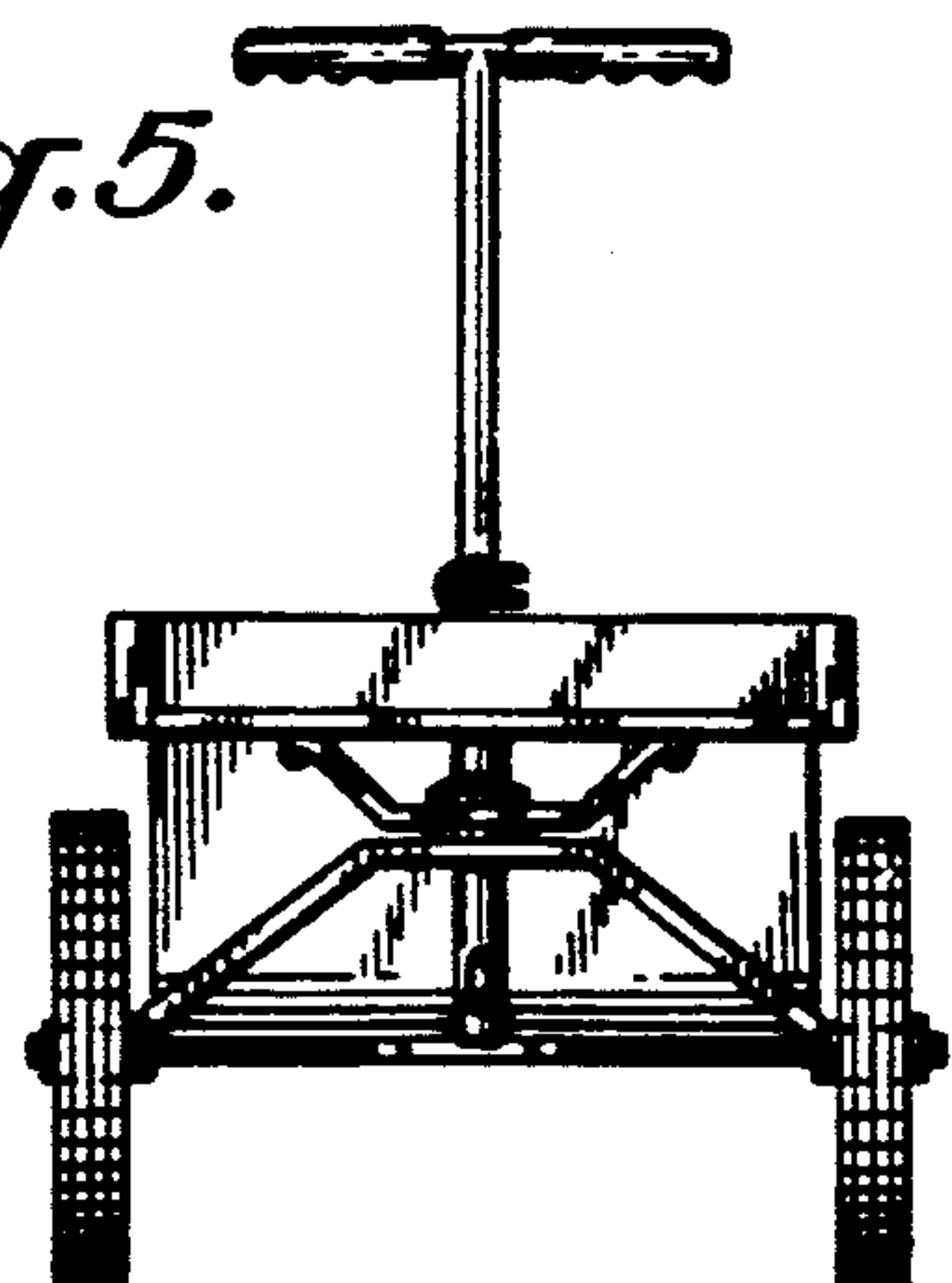

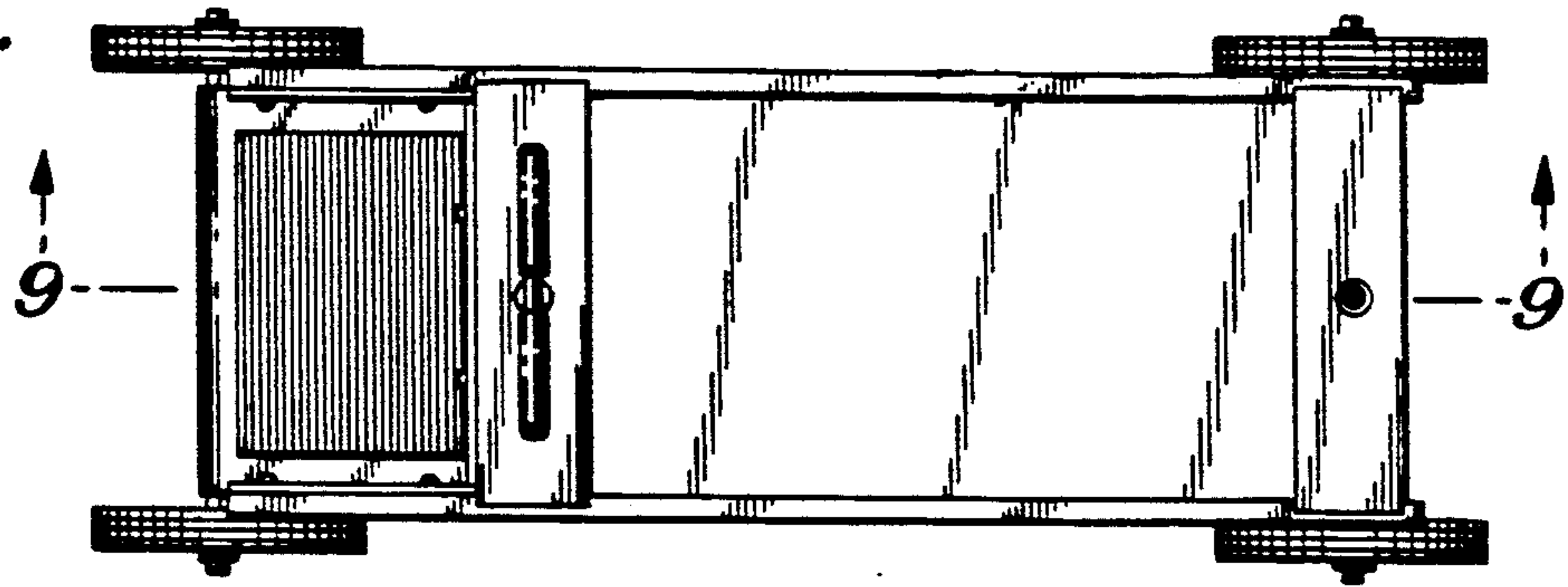

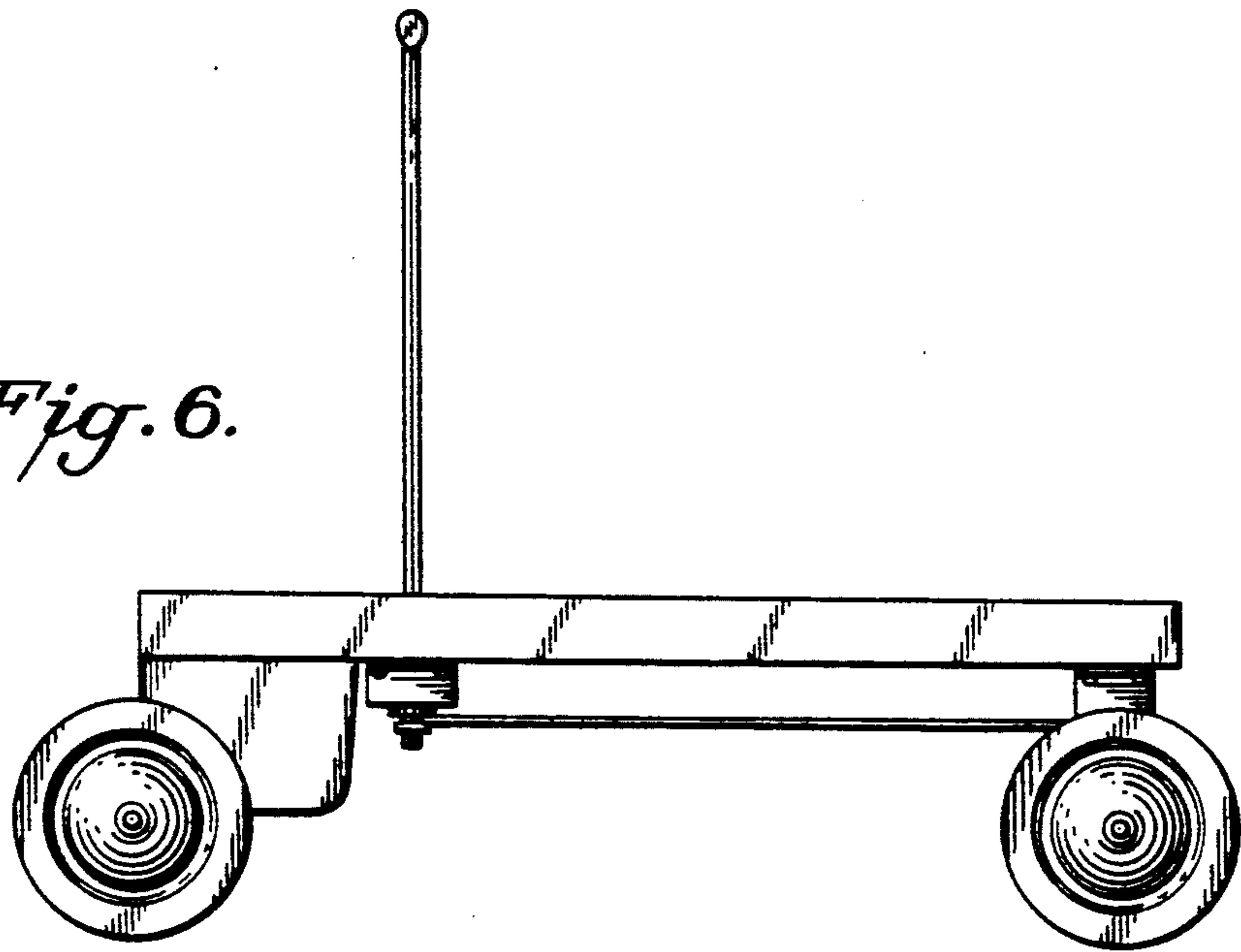

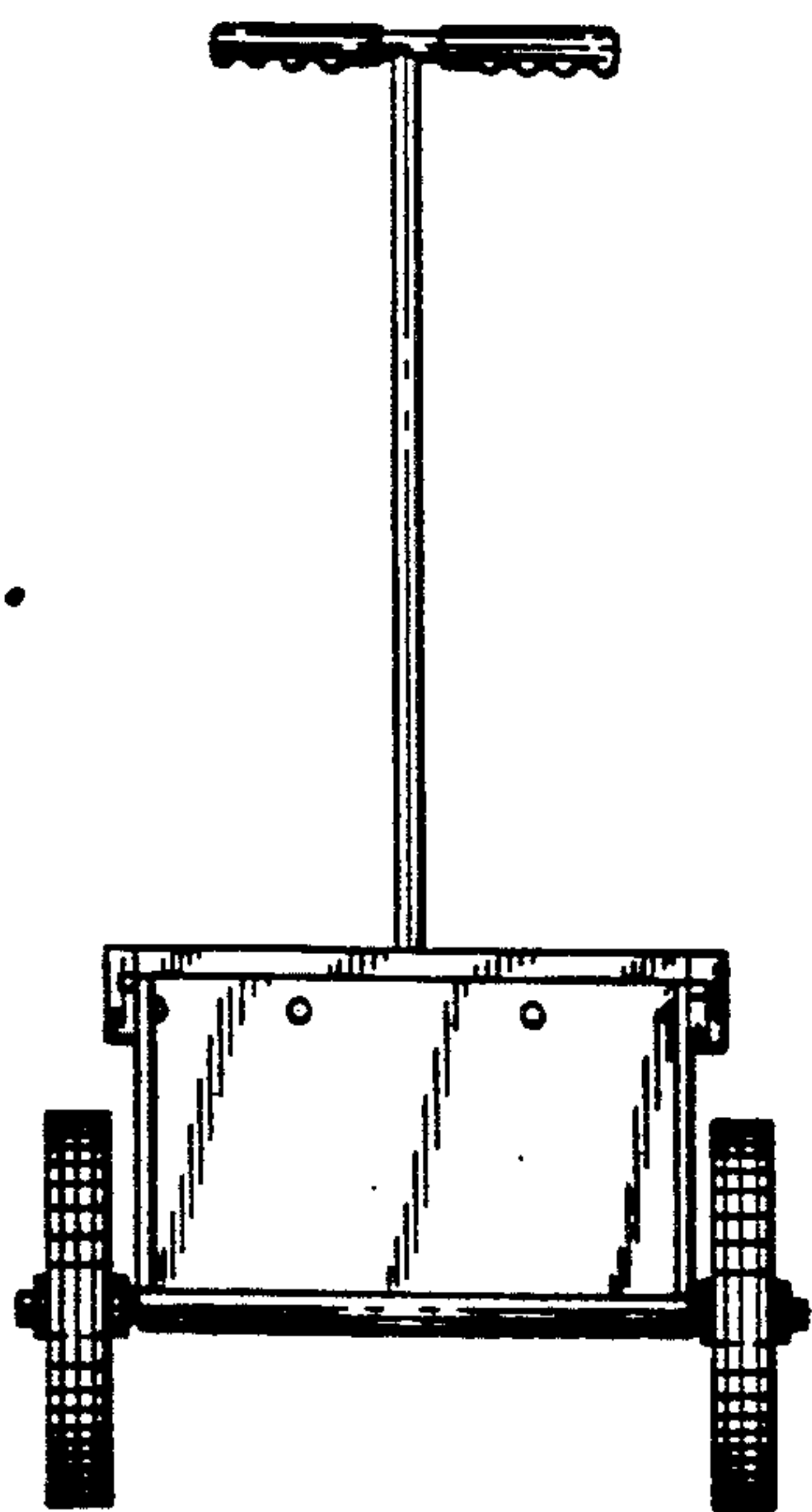
