[57] **CLAIM**

The ornamental design for a single-lens reflex camera body with self-contained strobe, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a single-lens reflex camera body with self-contained strobe showing my new design;  
FIG. 2 is a rear elevational view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a left side elevational view thereof;  
FIG. 6 is a right side elevational view thereof; and,  
FIG. 7 is a perspective view thereof.

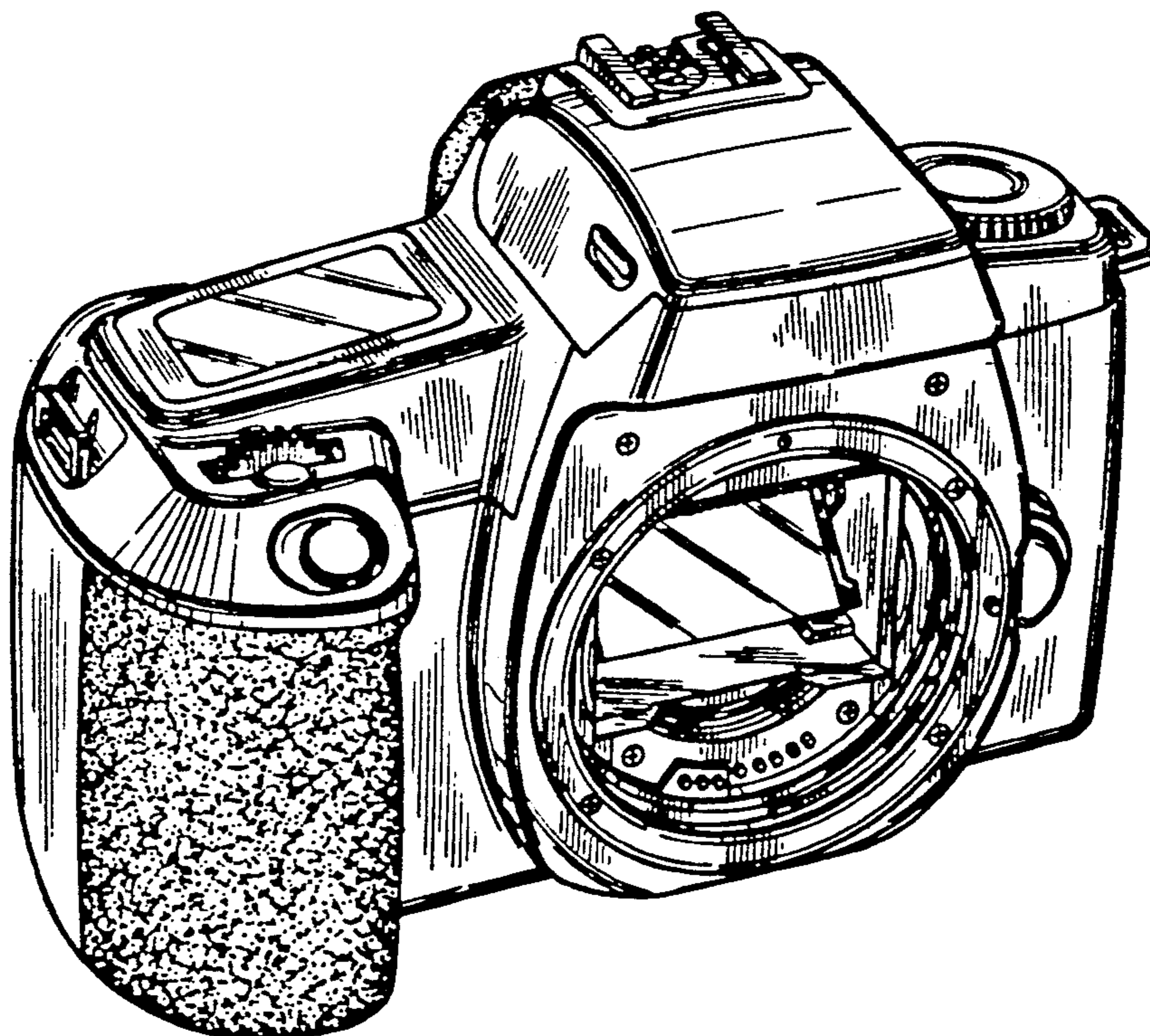

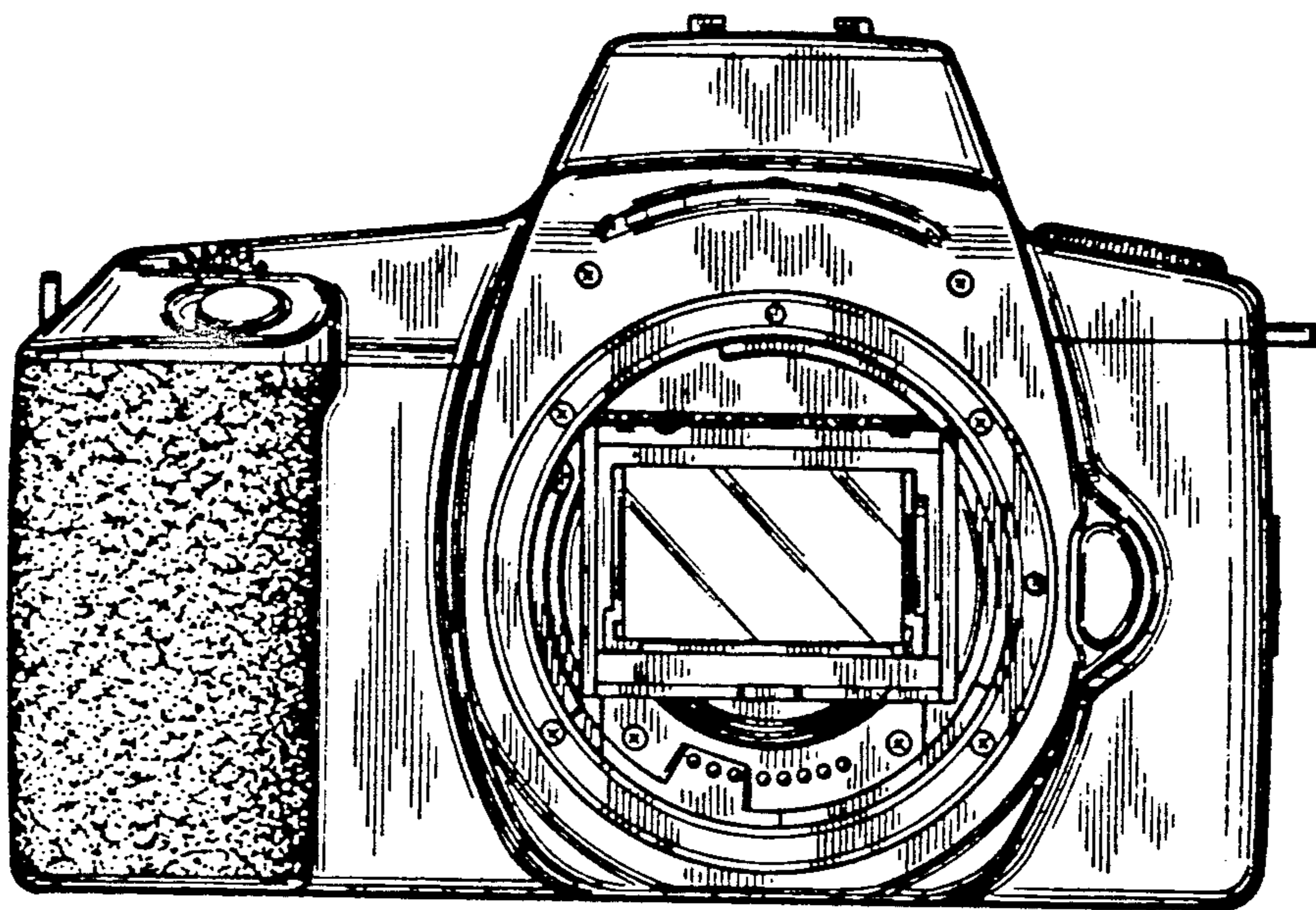

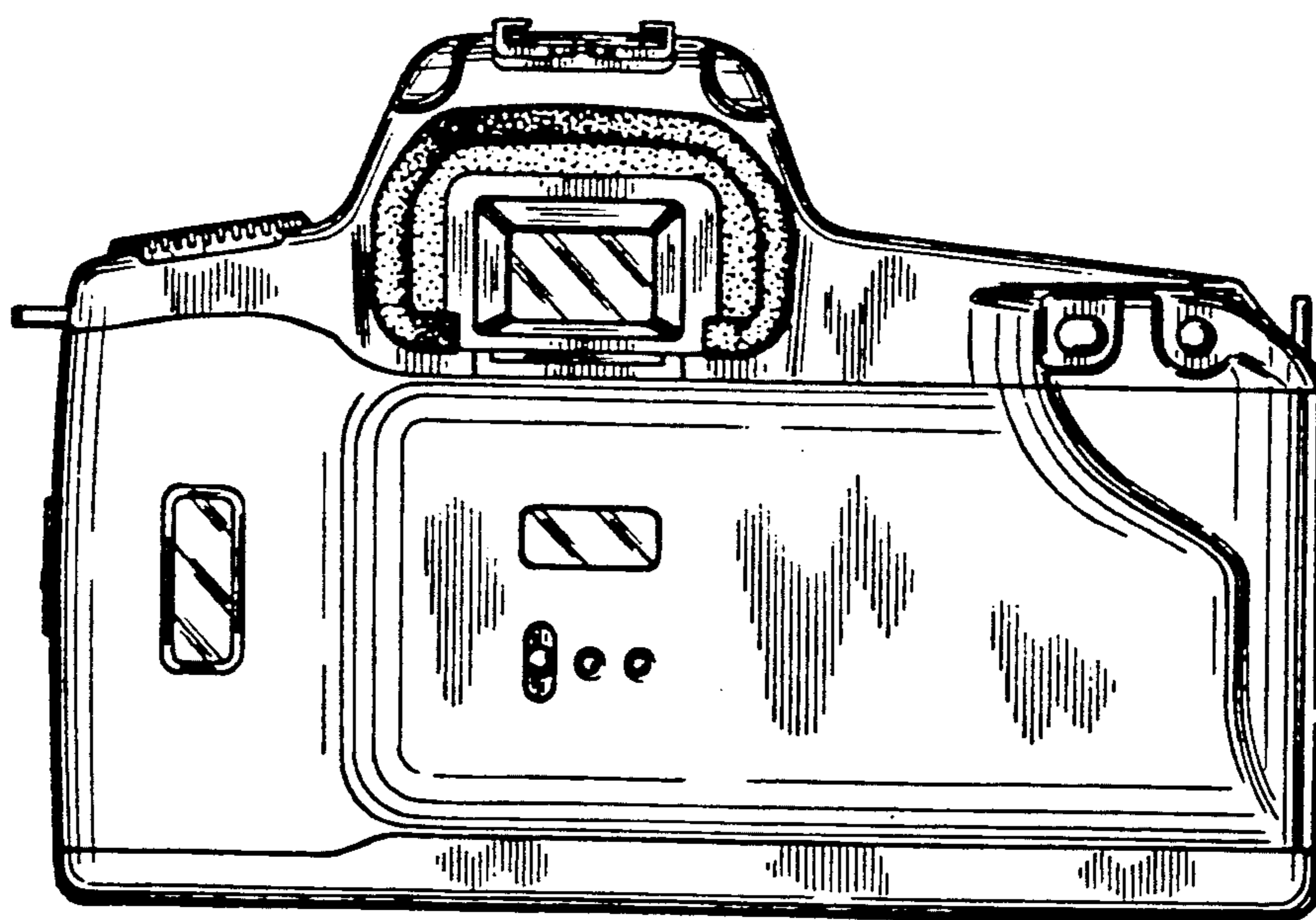

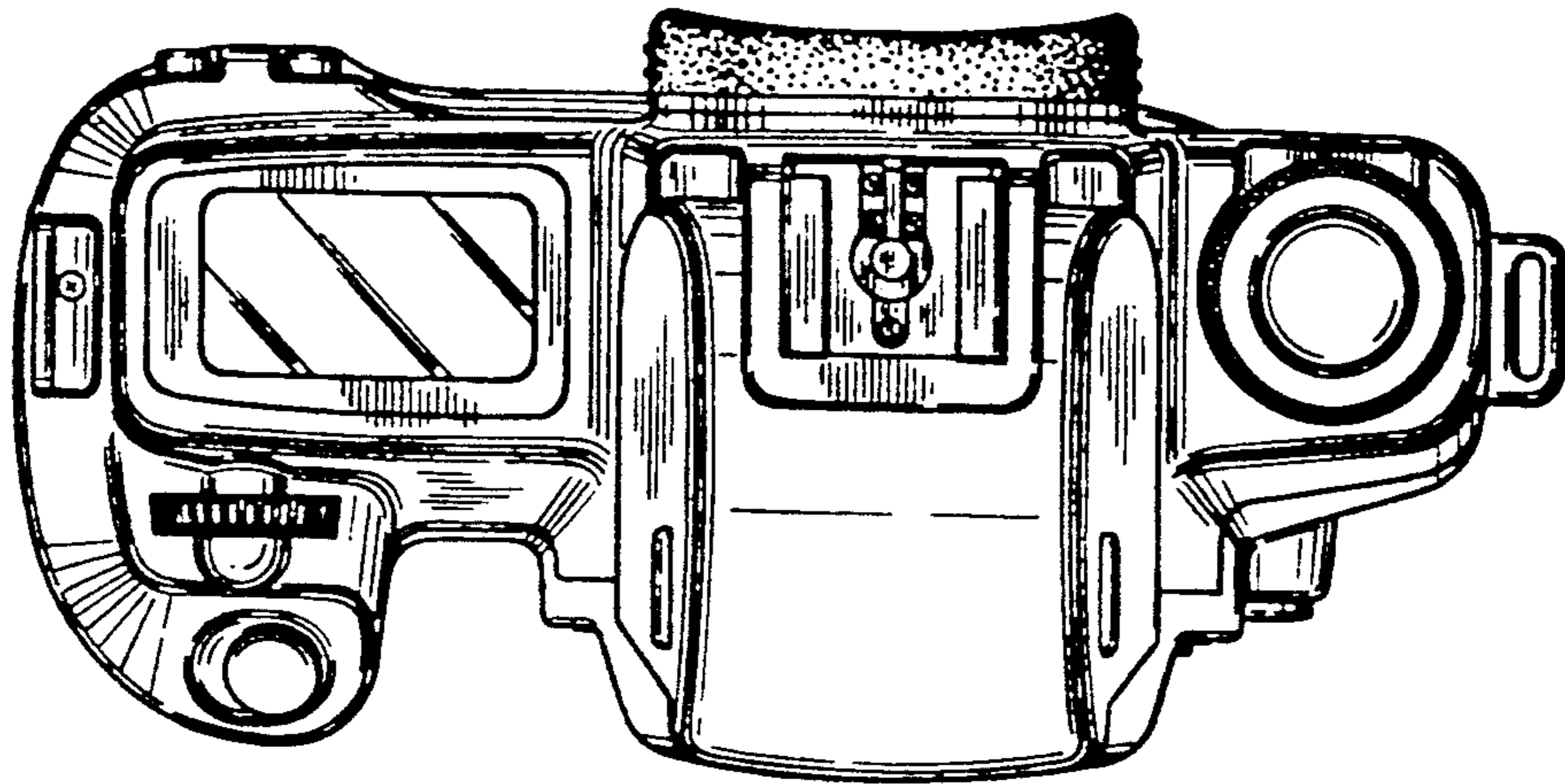

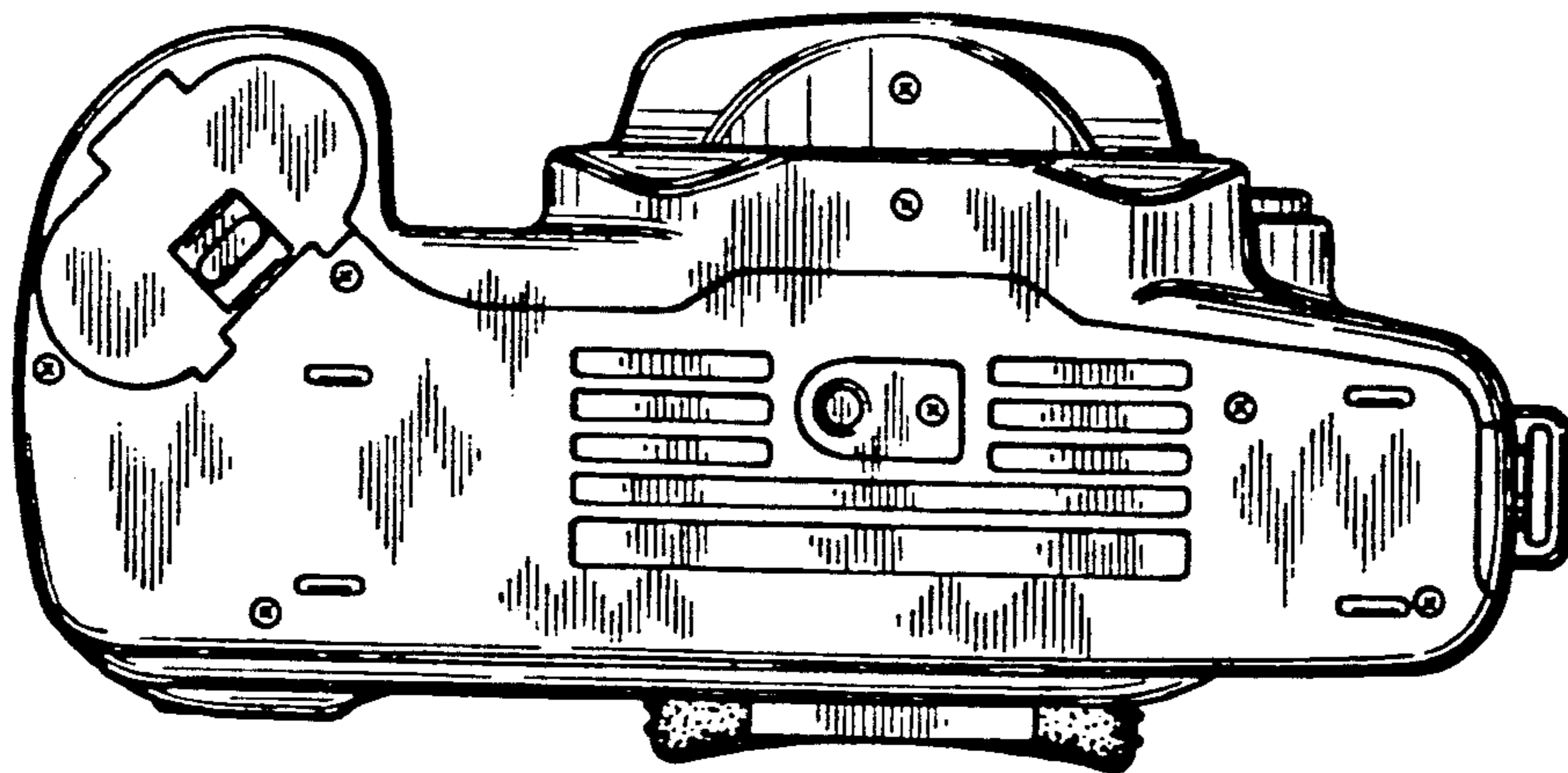

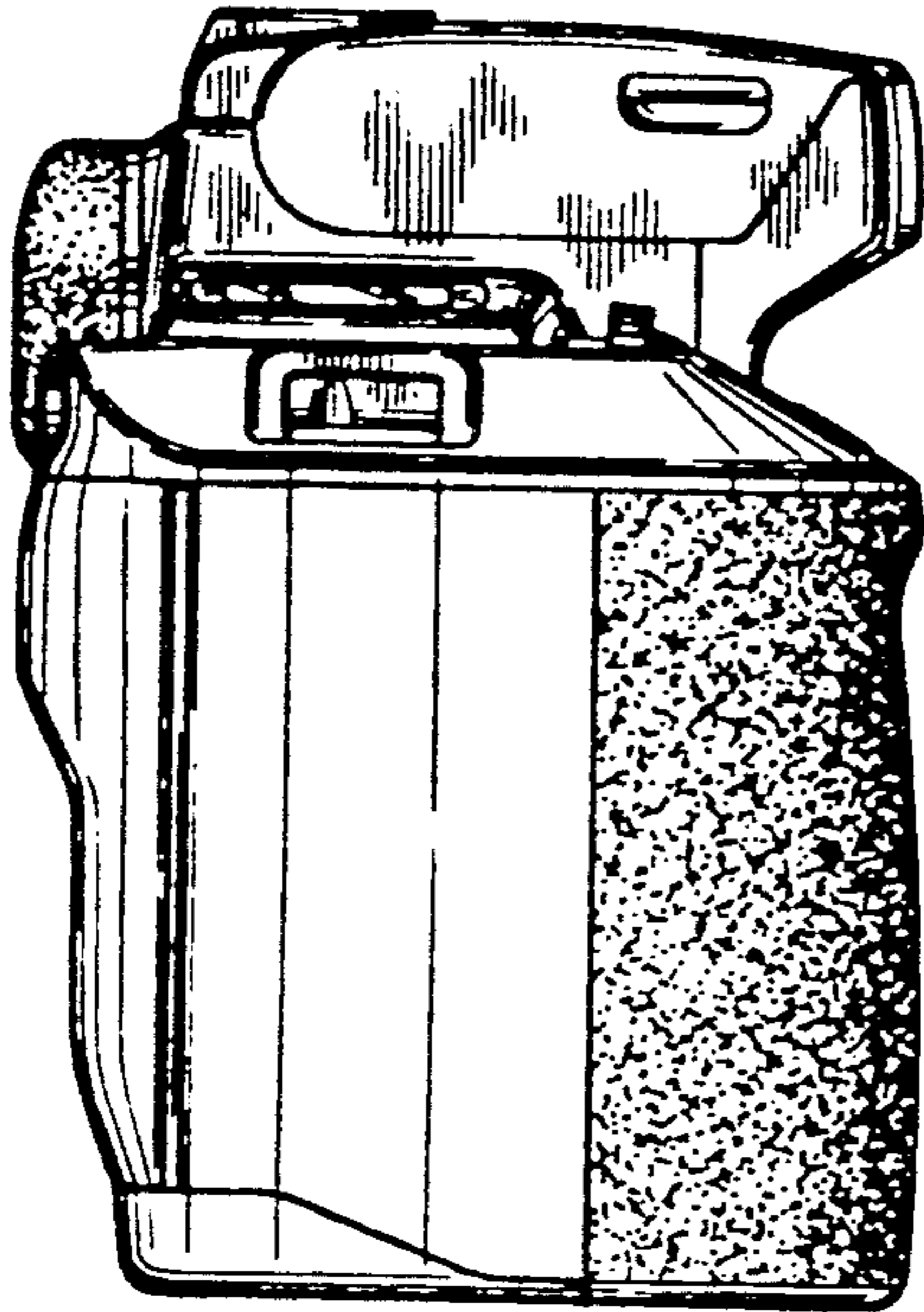

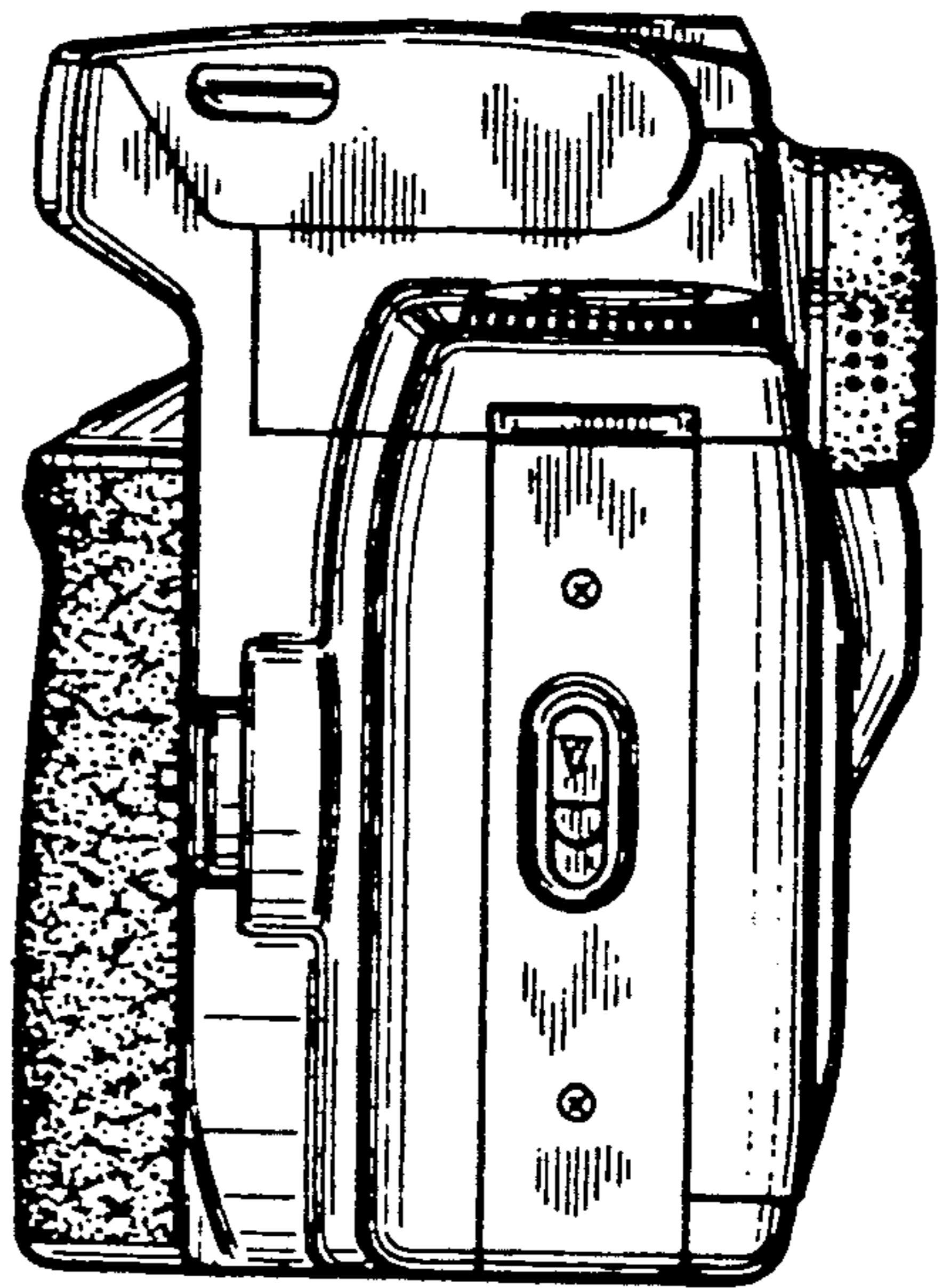
