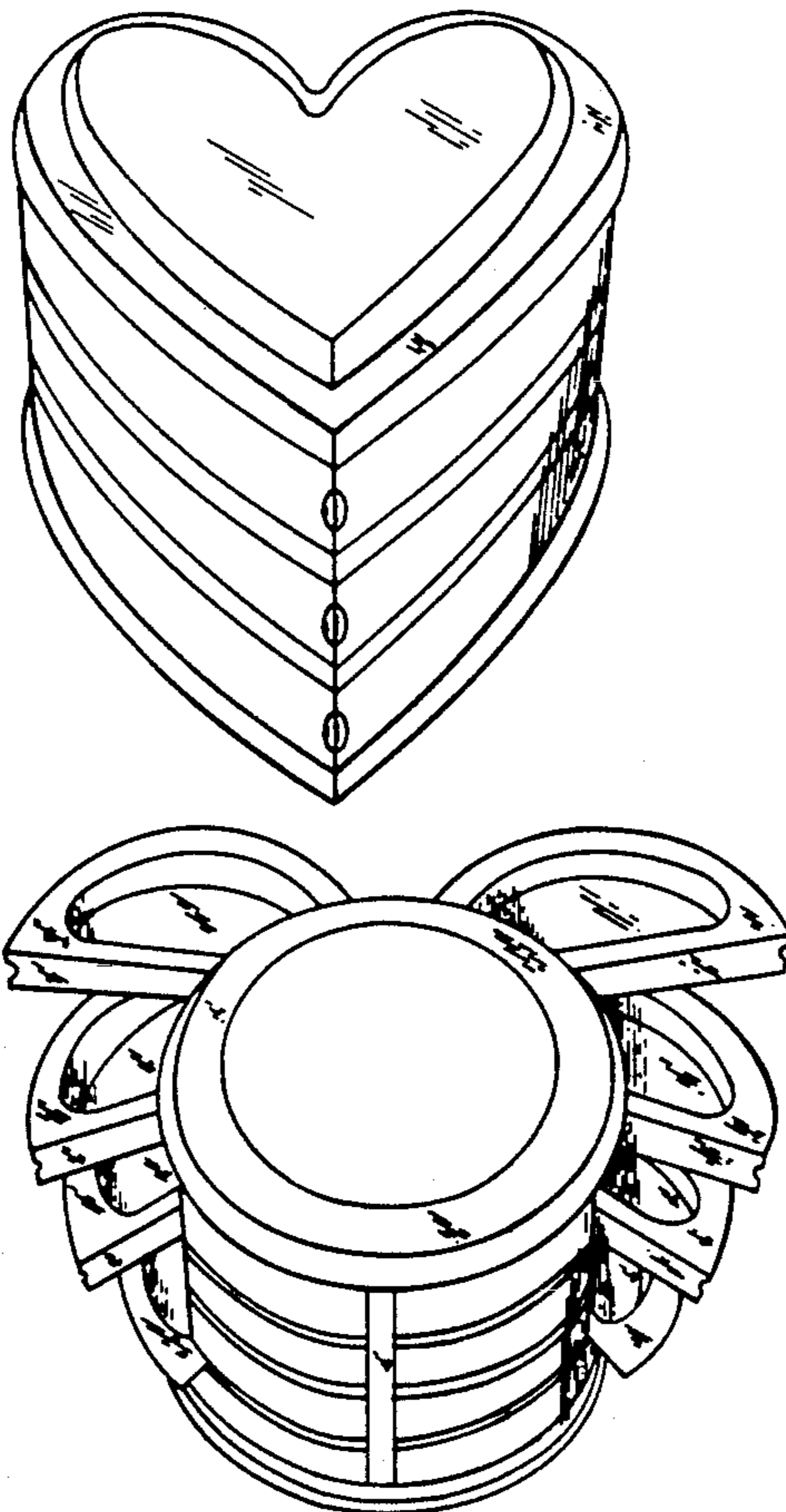

 The bottom of both embodiments are plain and unornamented.



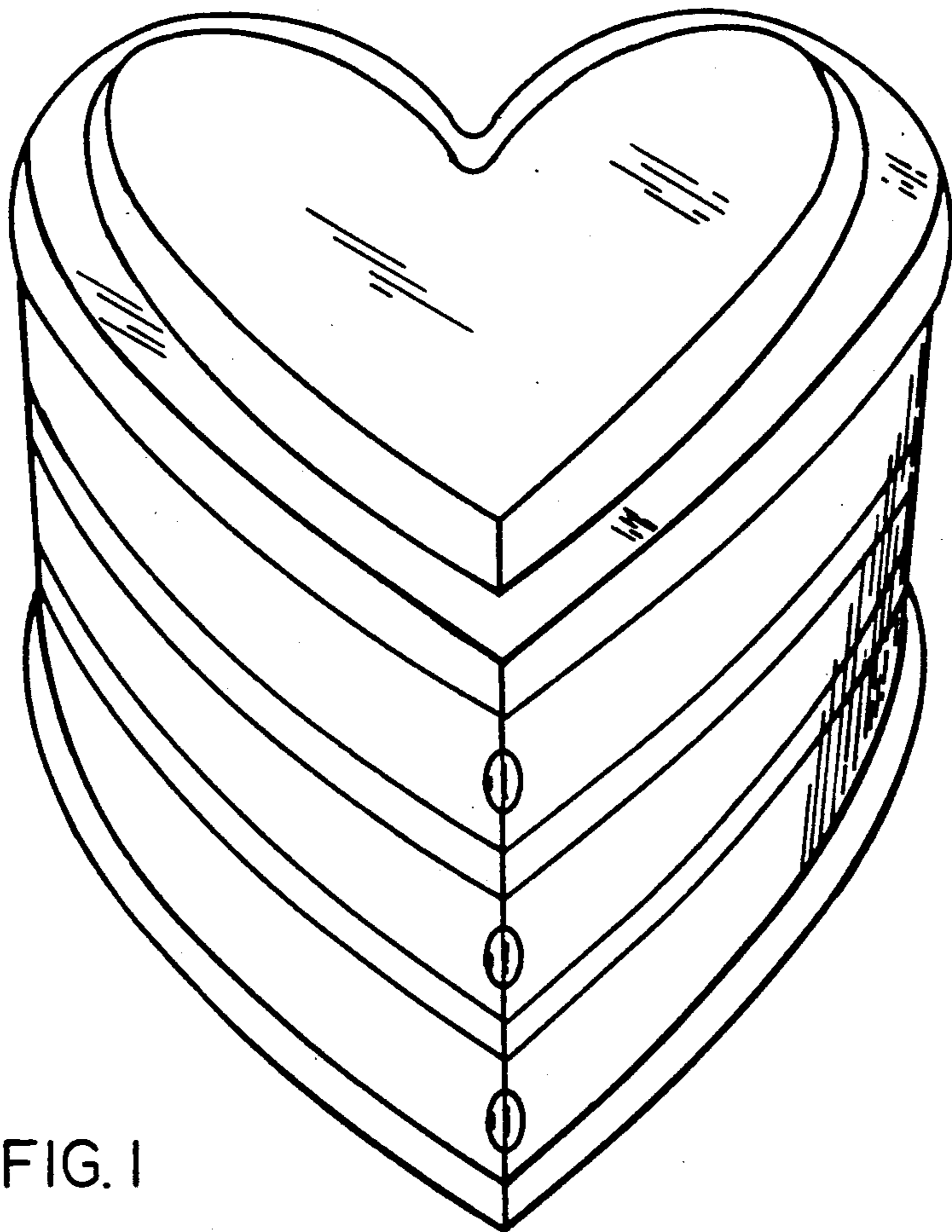

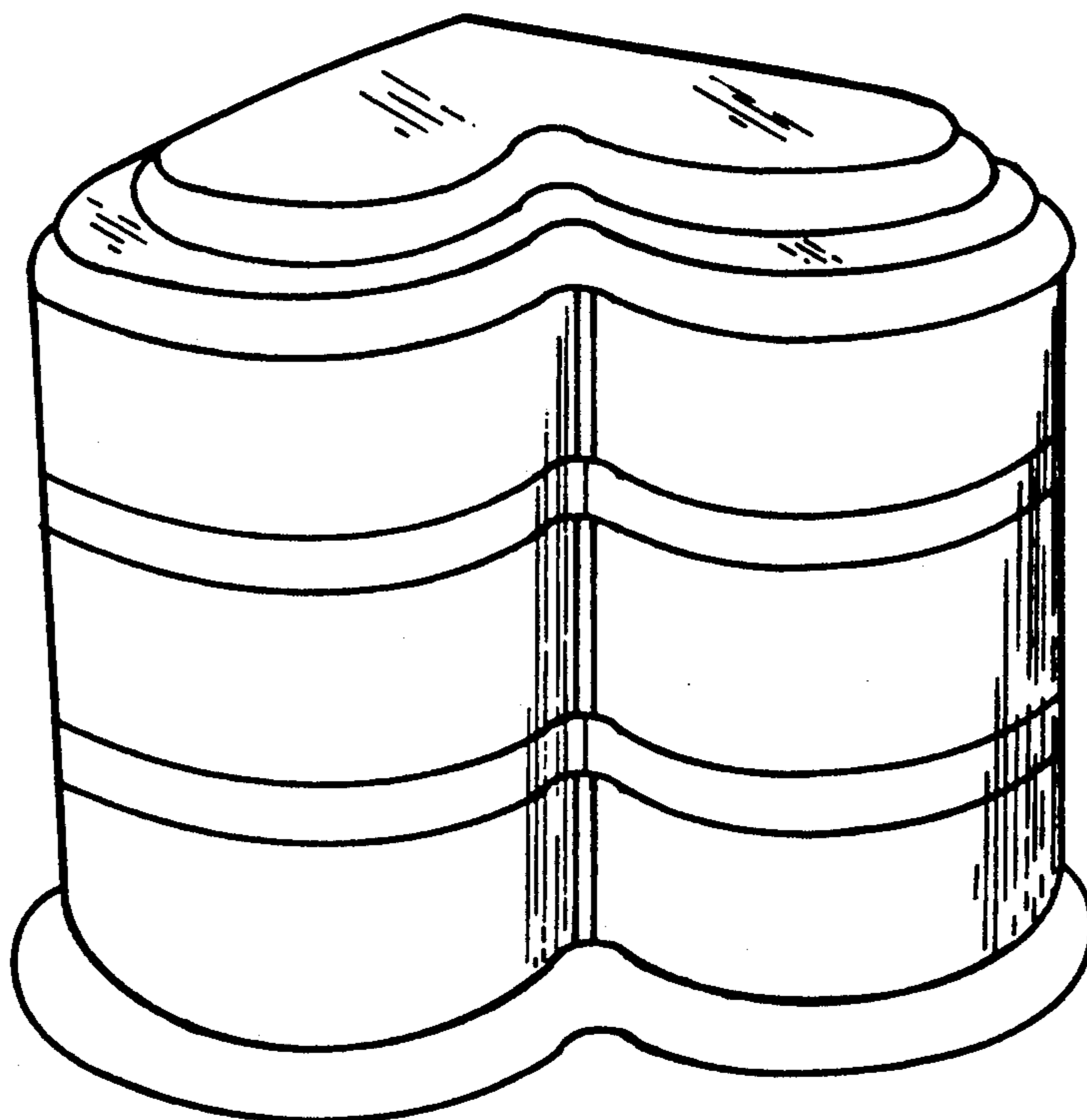

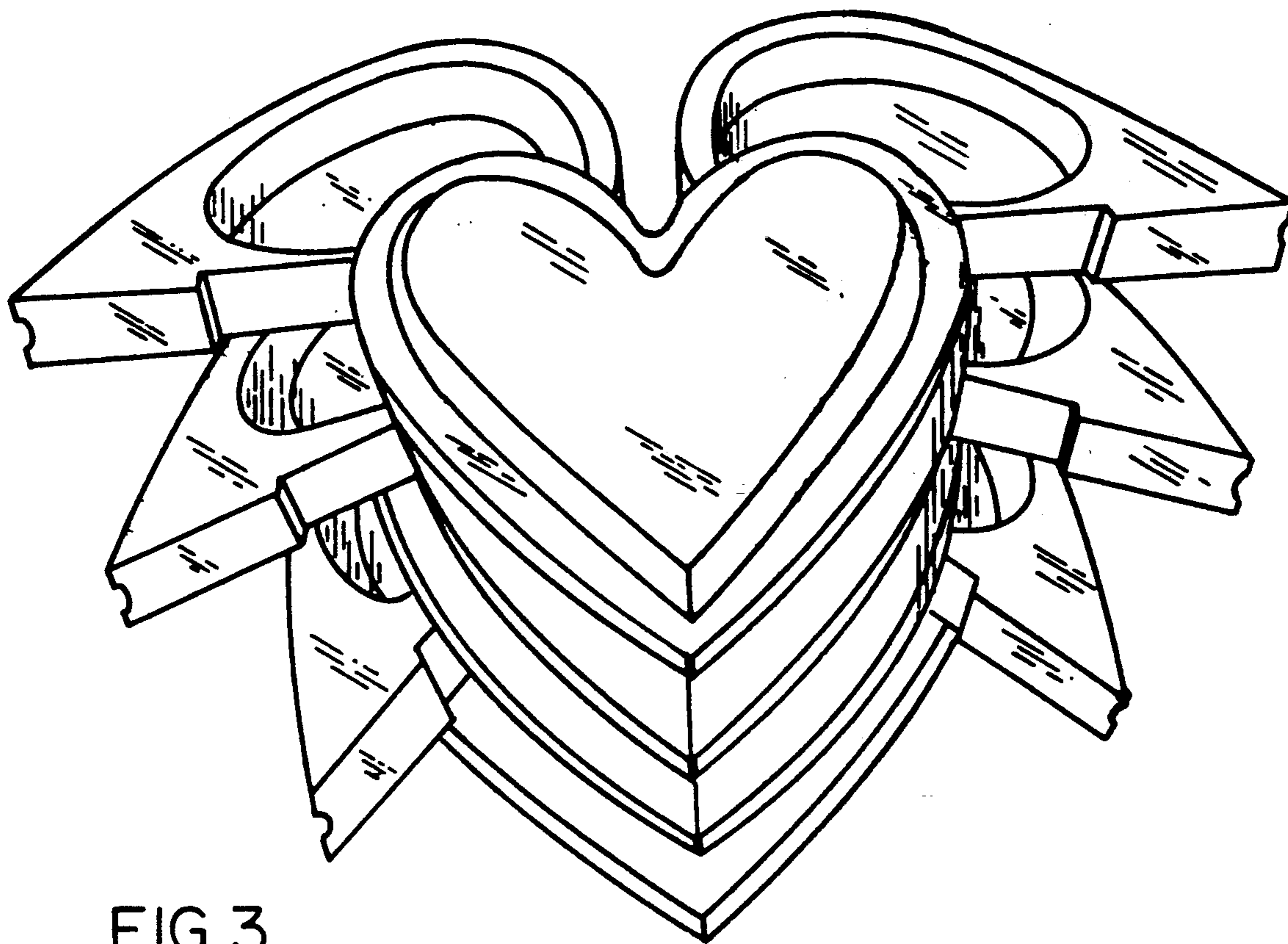

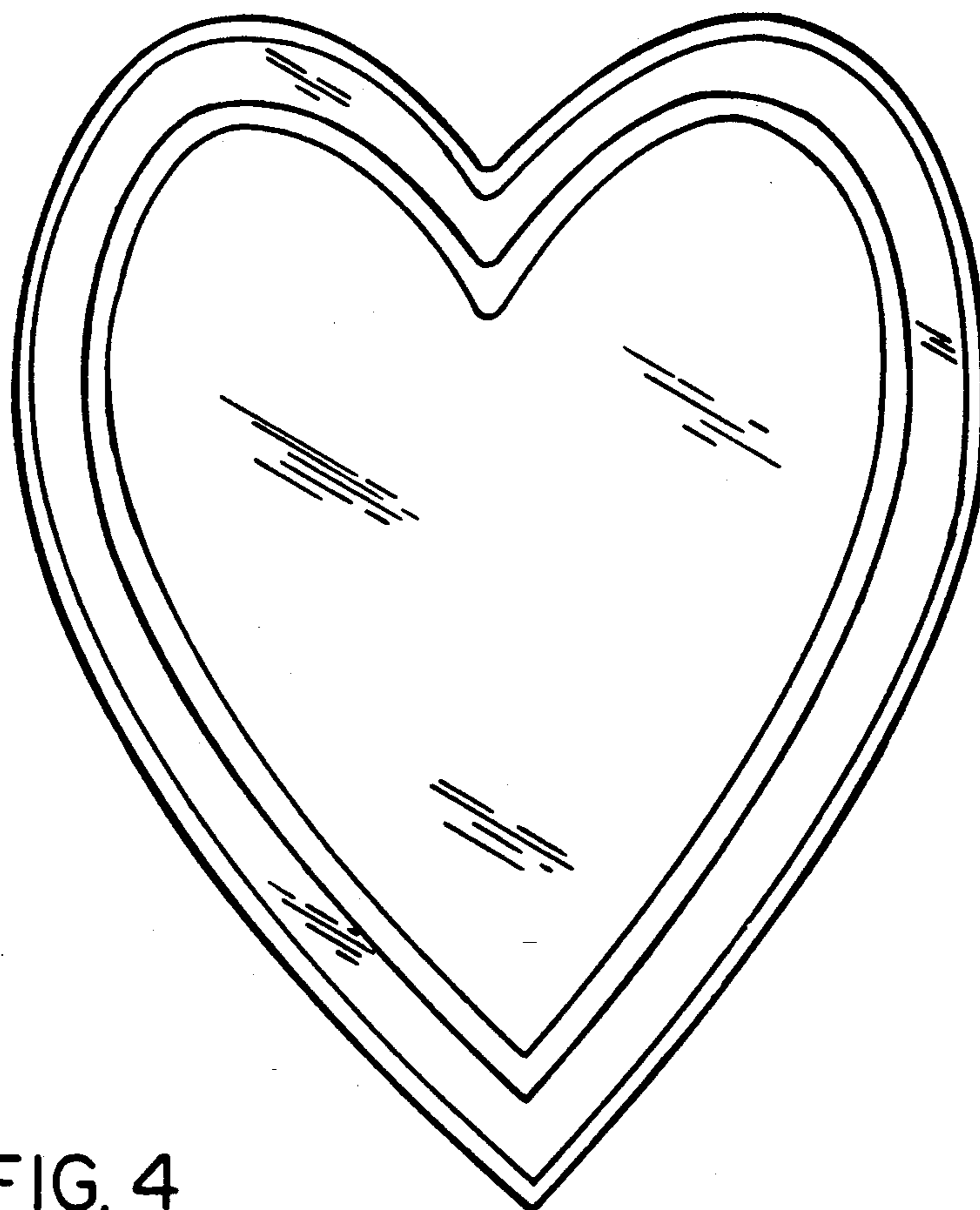

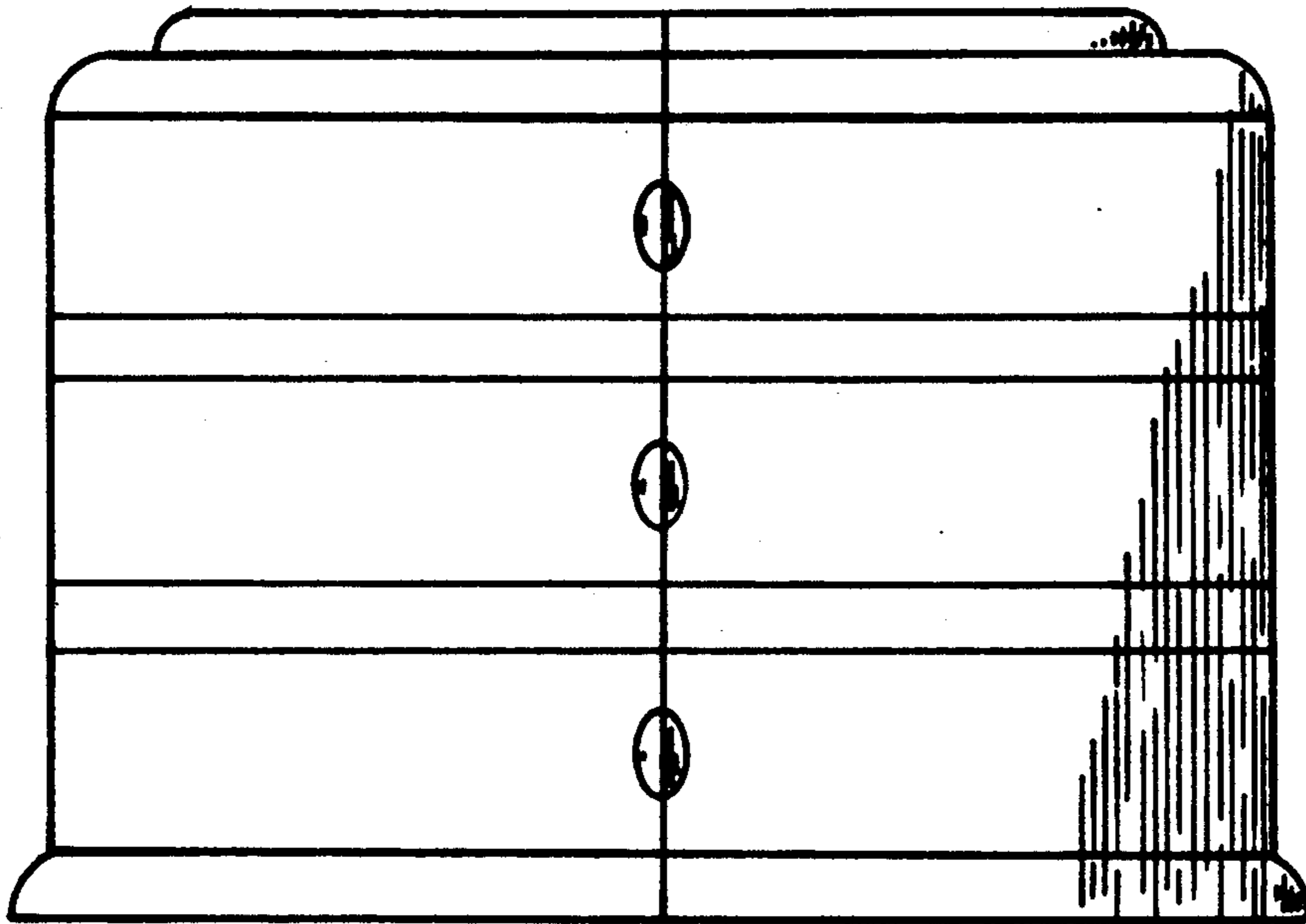

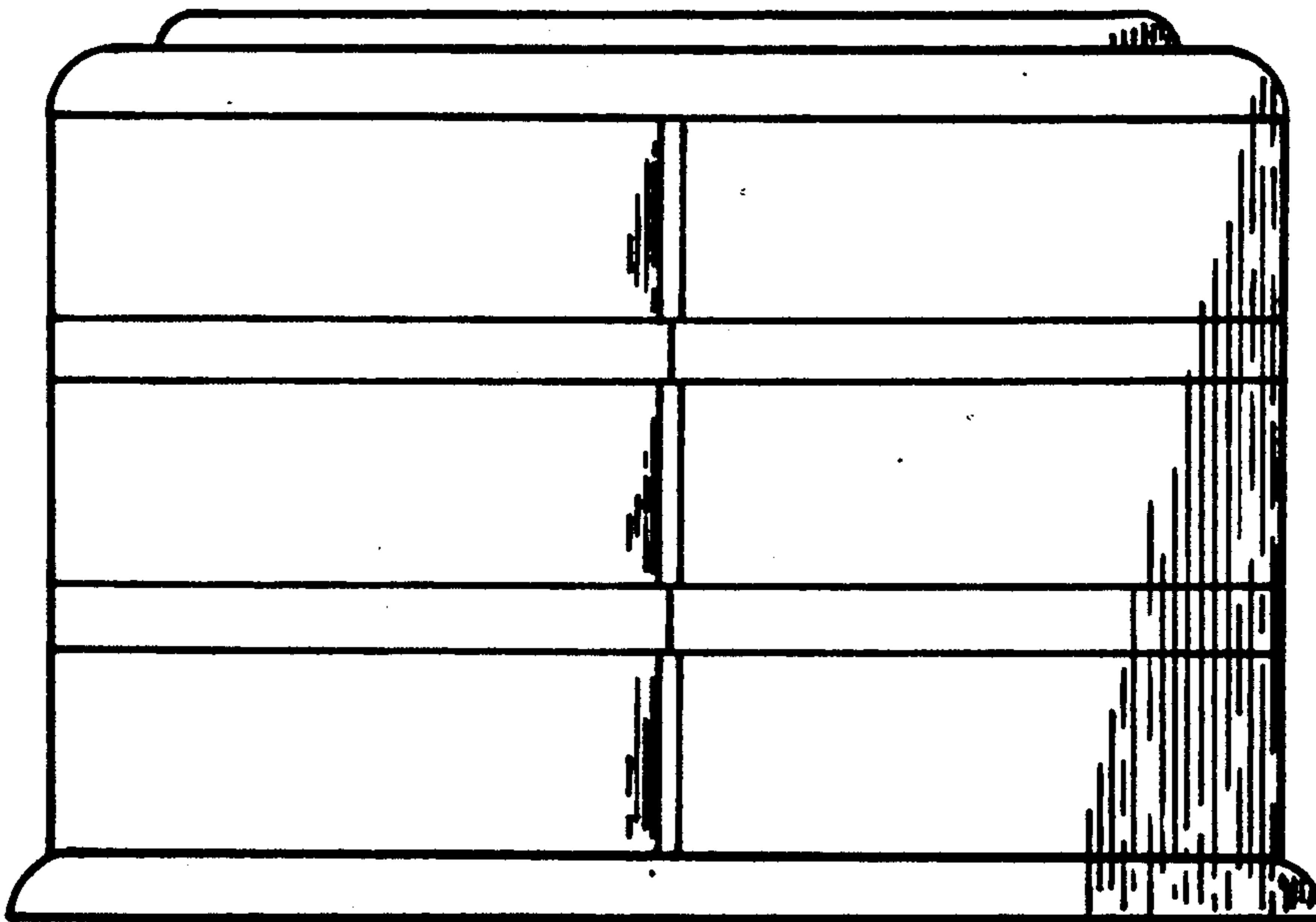

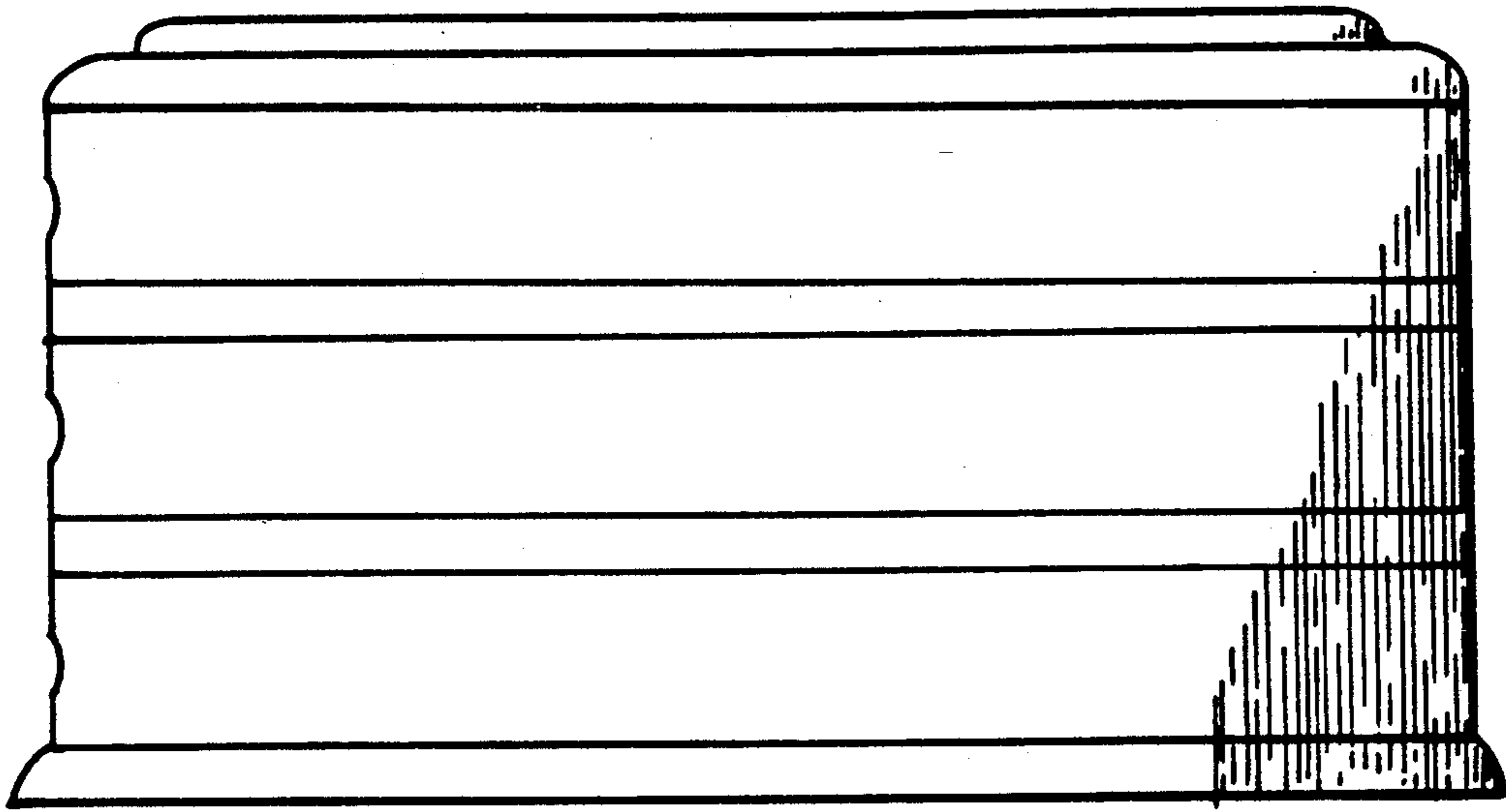

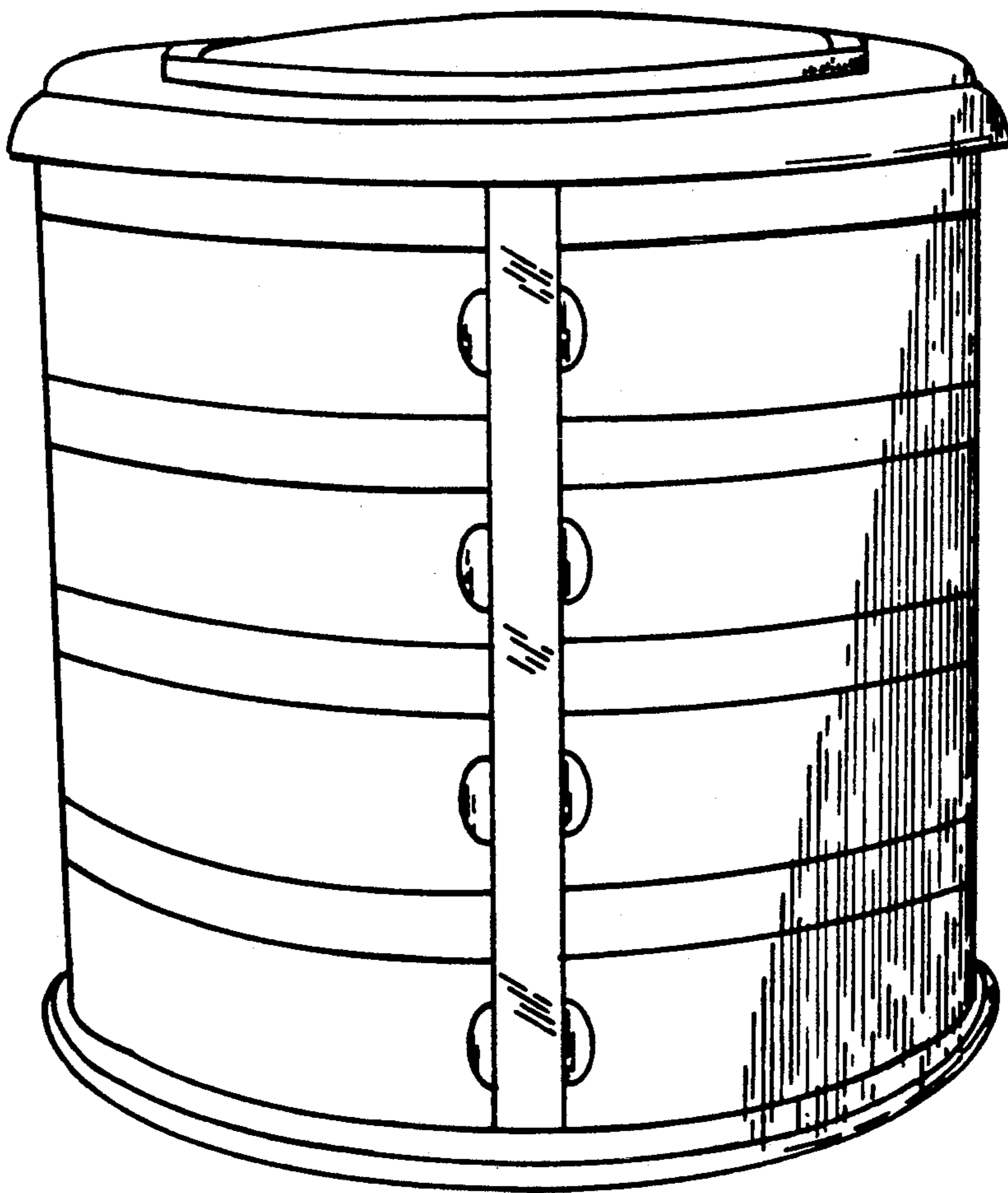

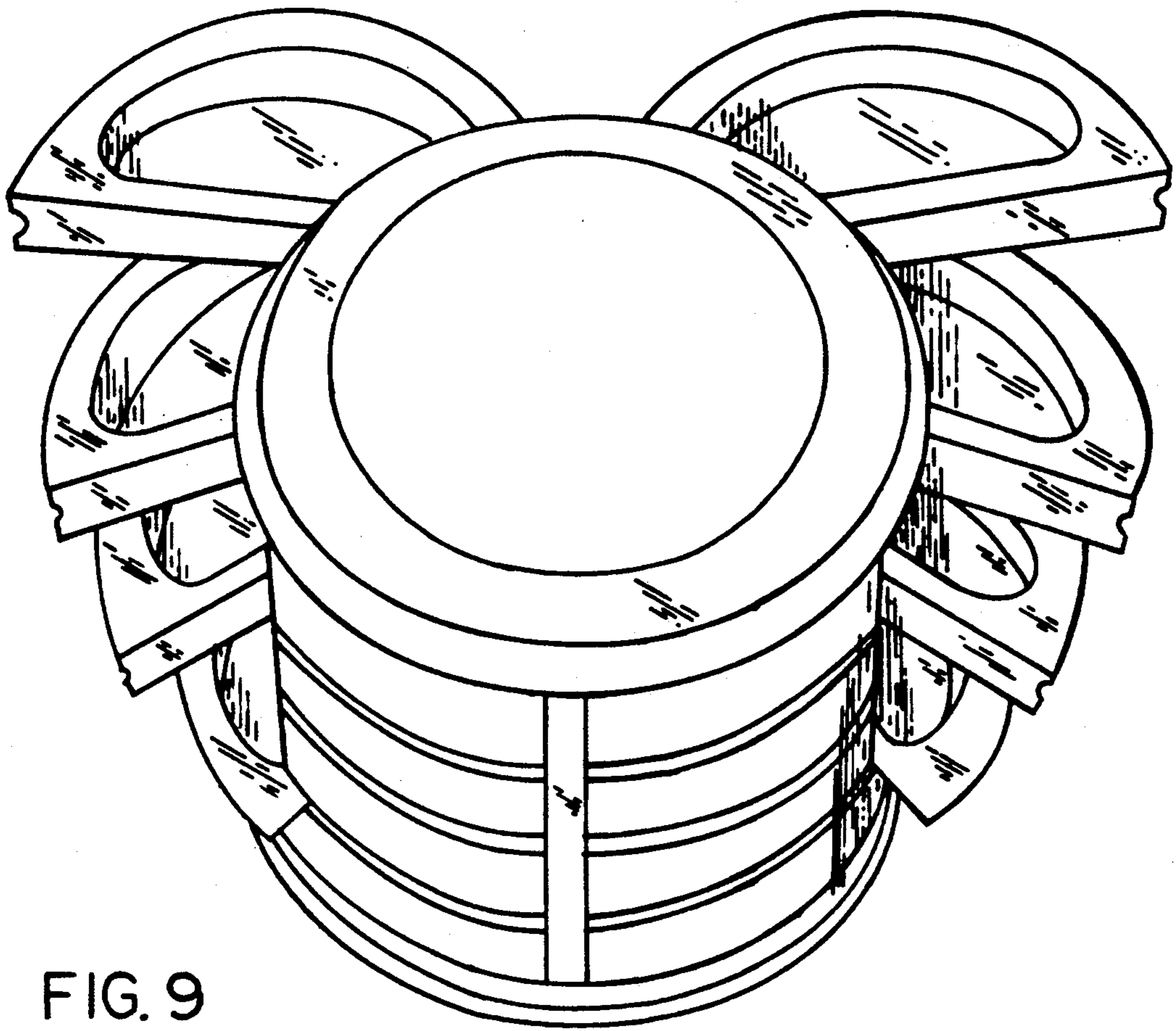

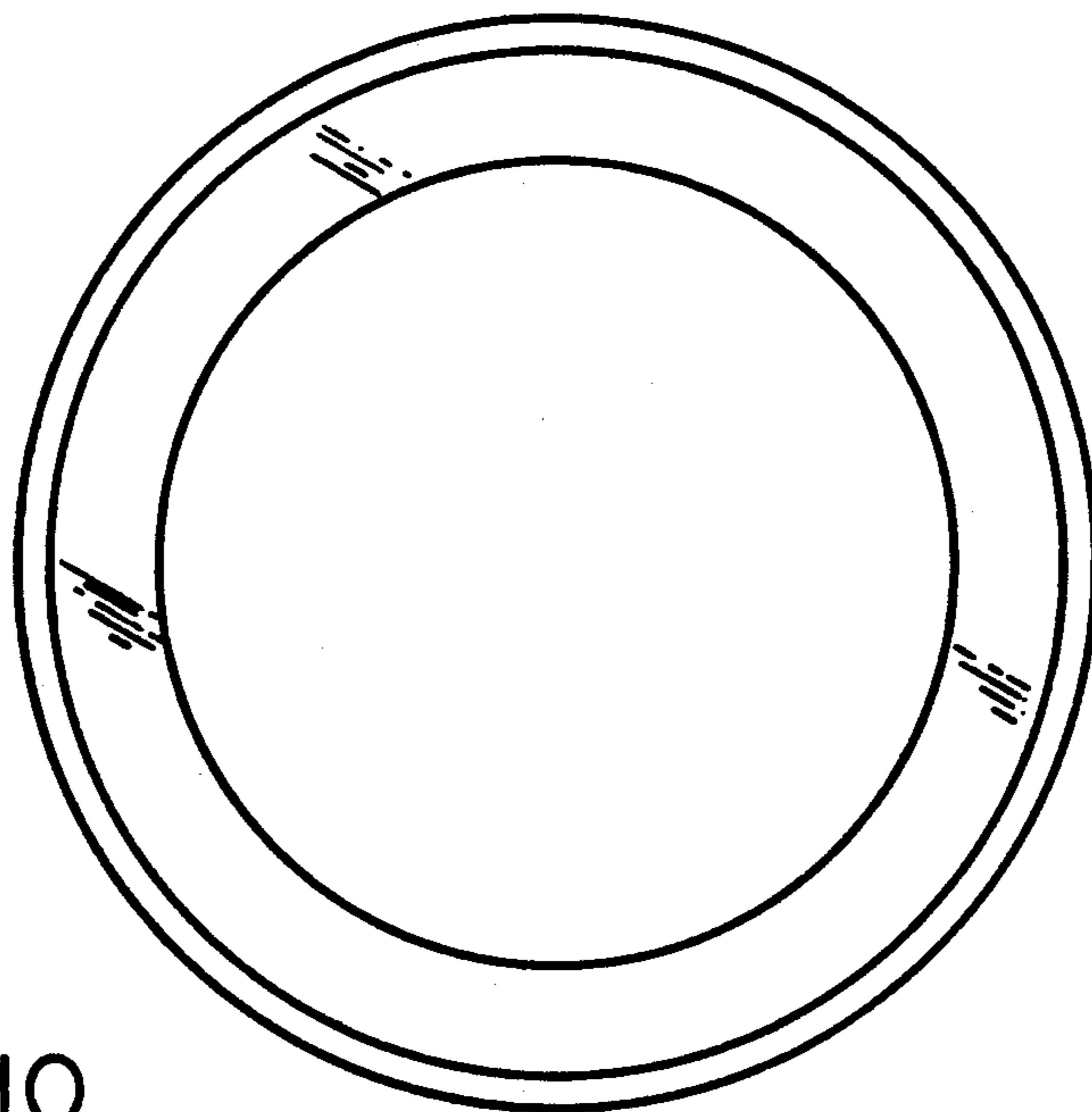

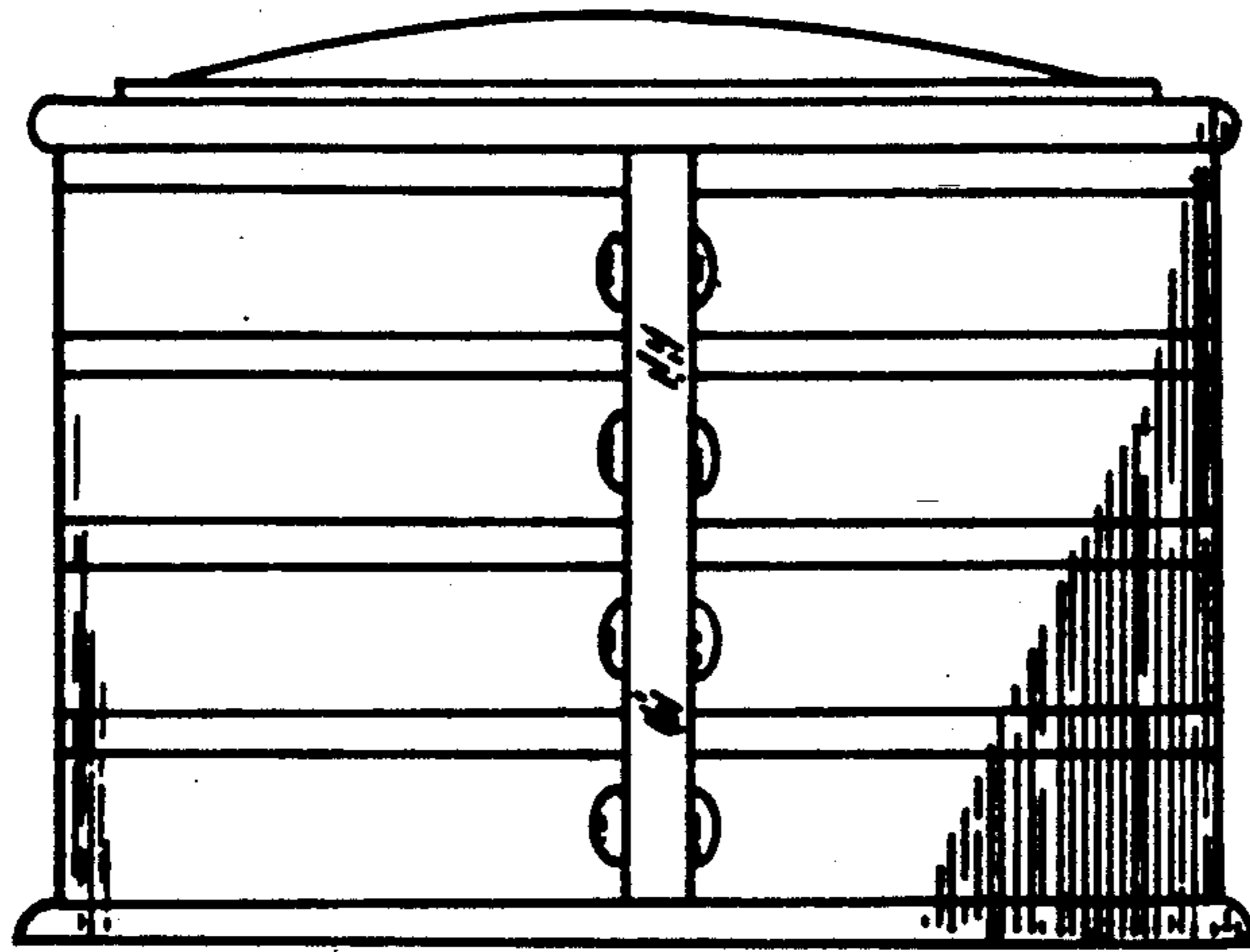

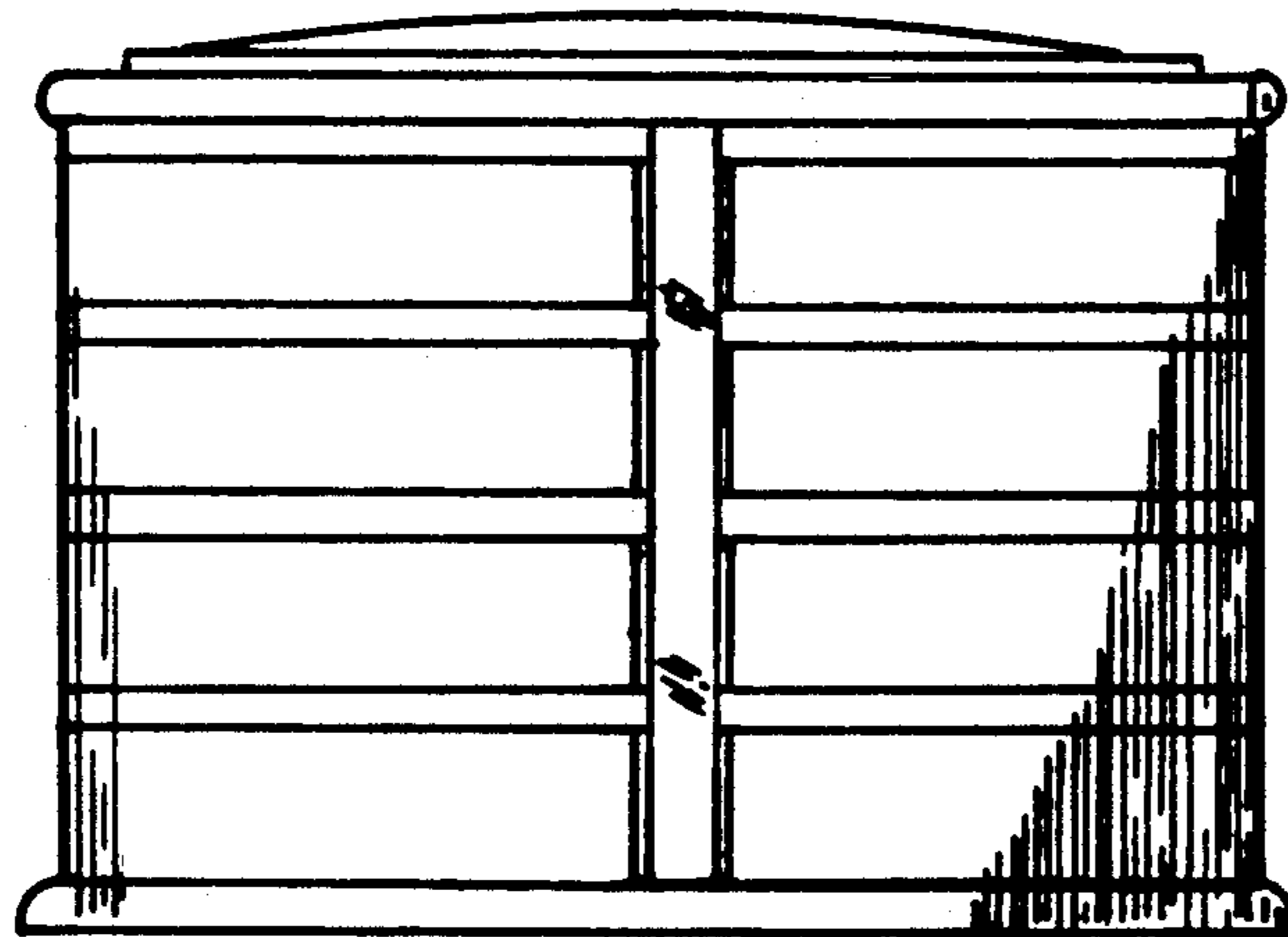

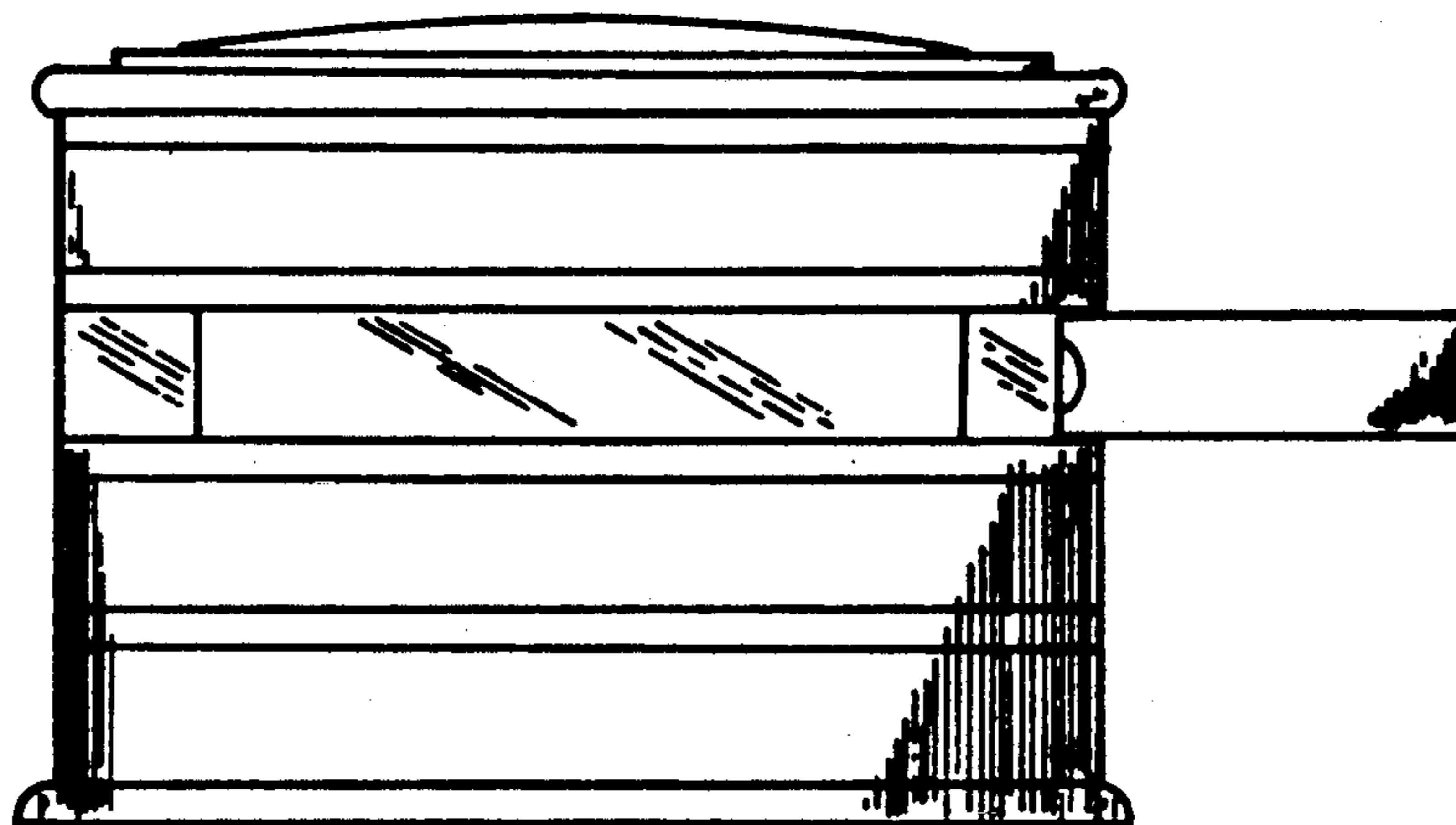

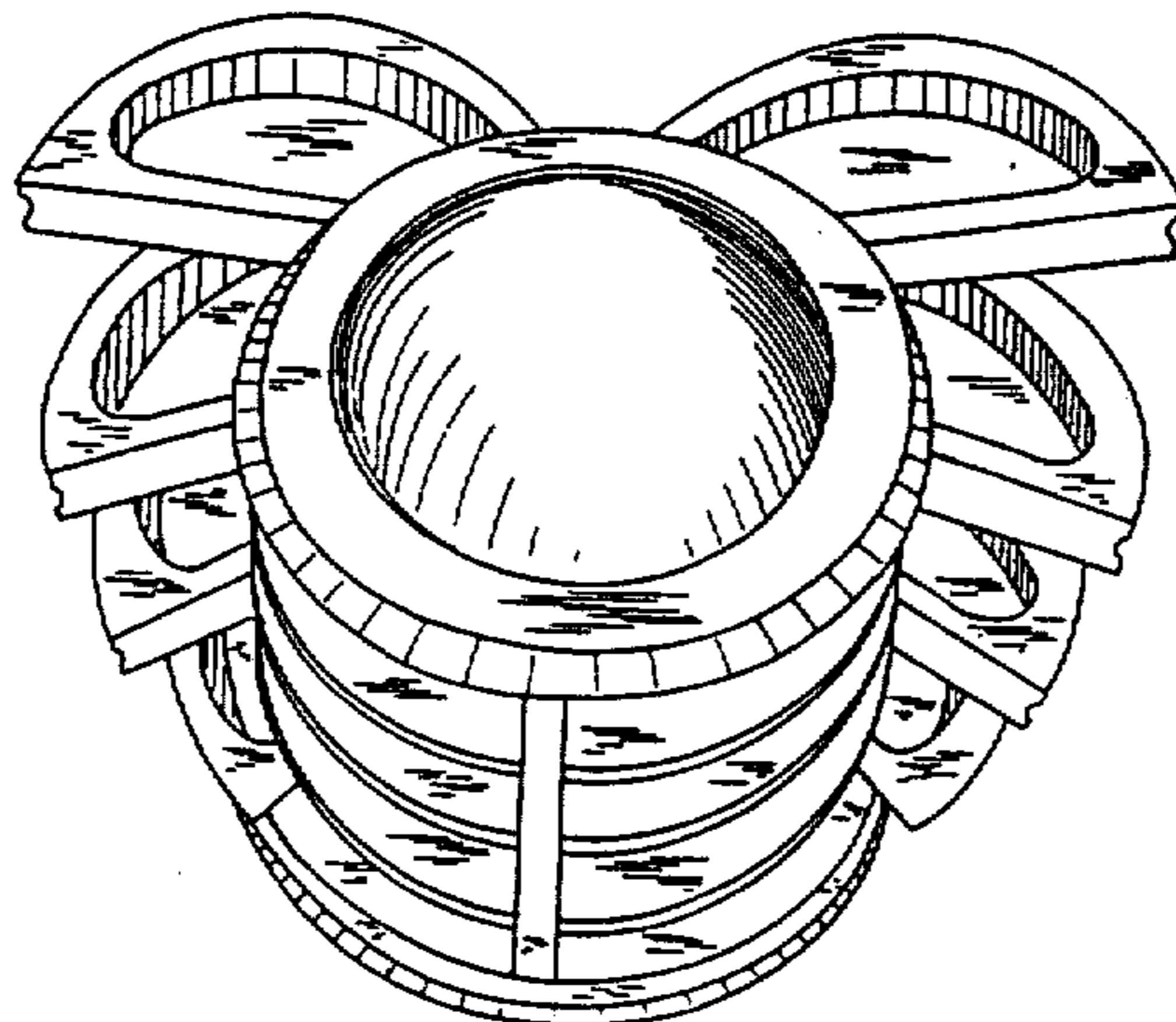
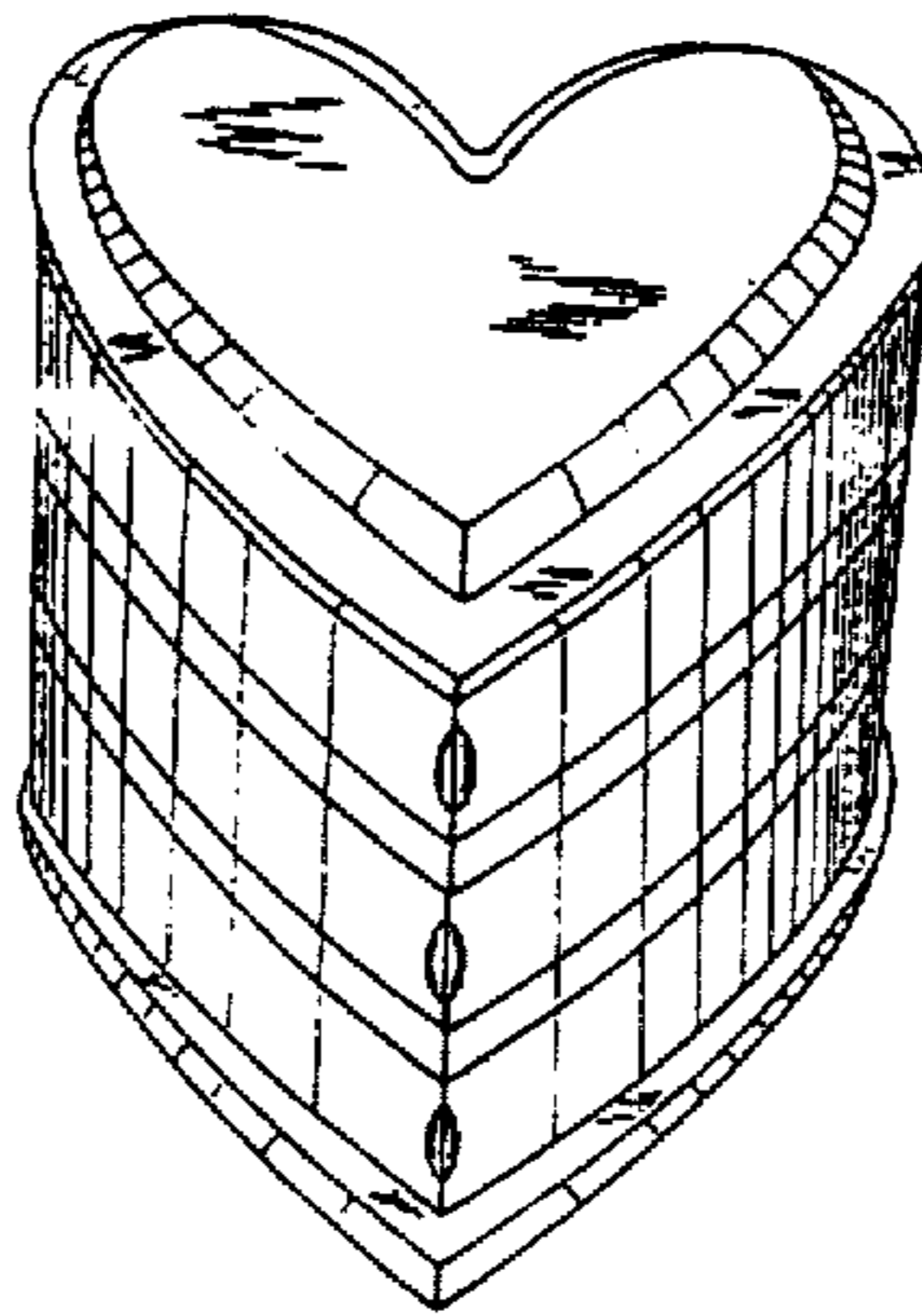

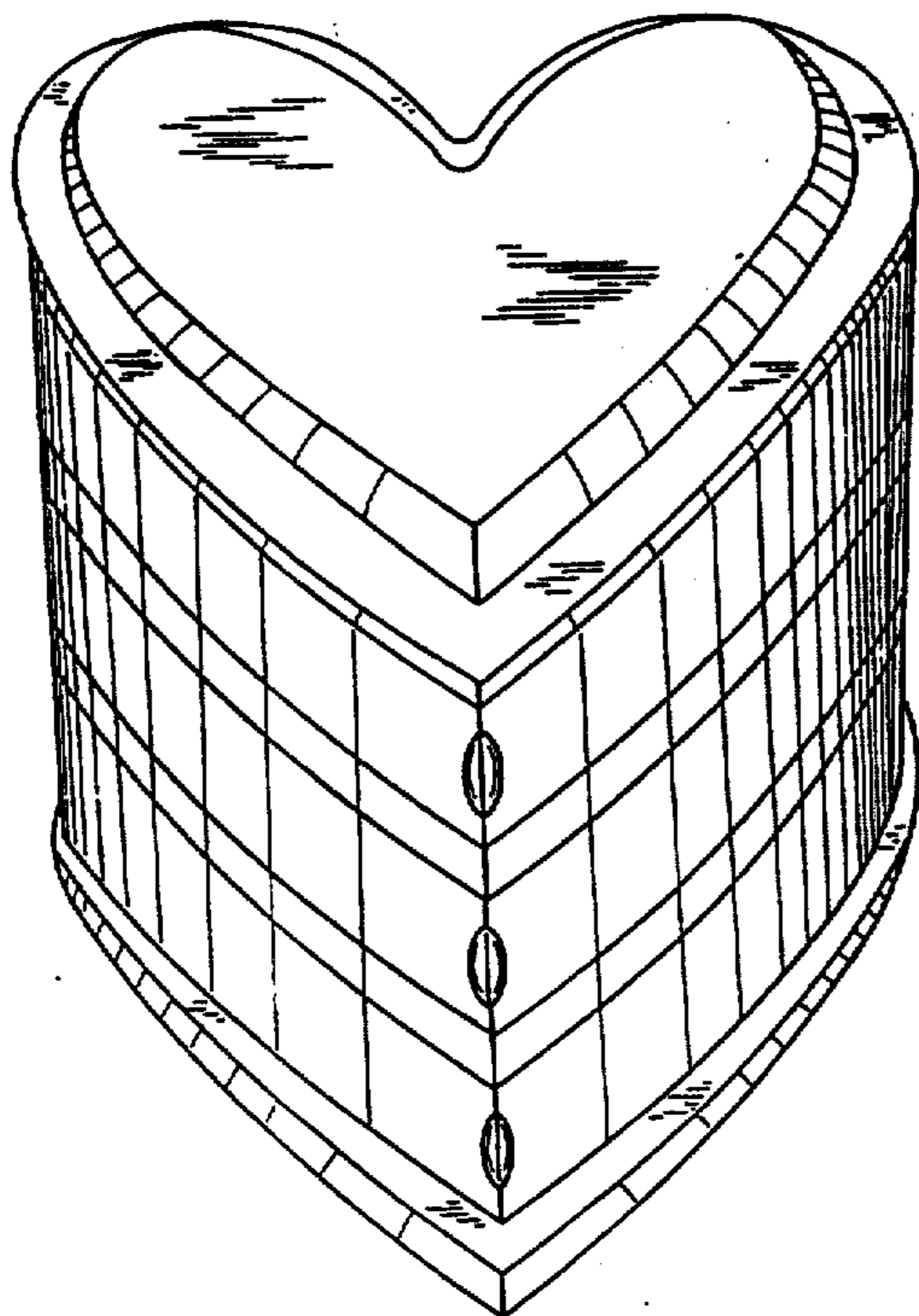

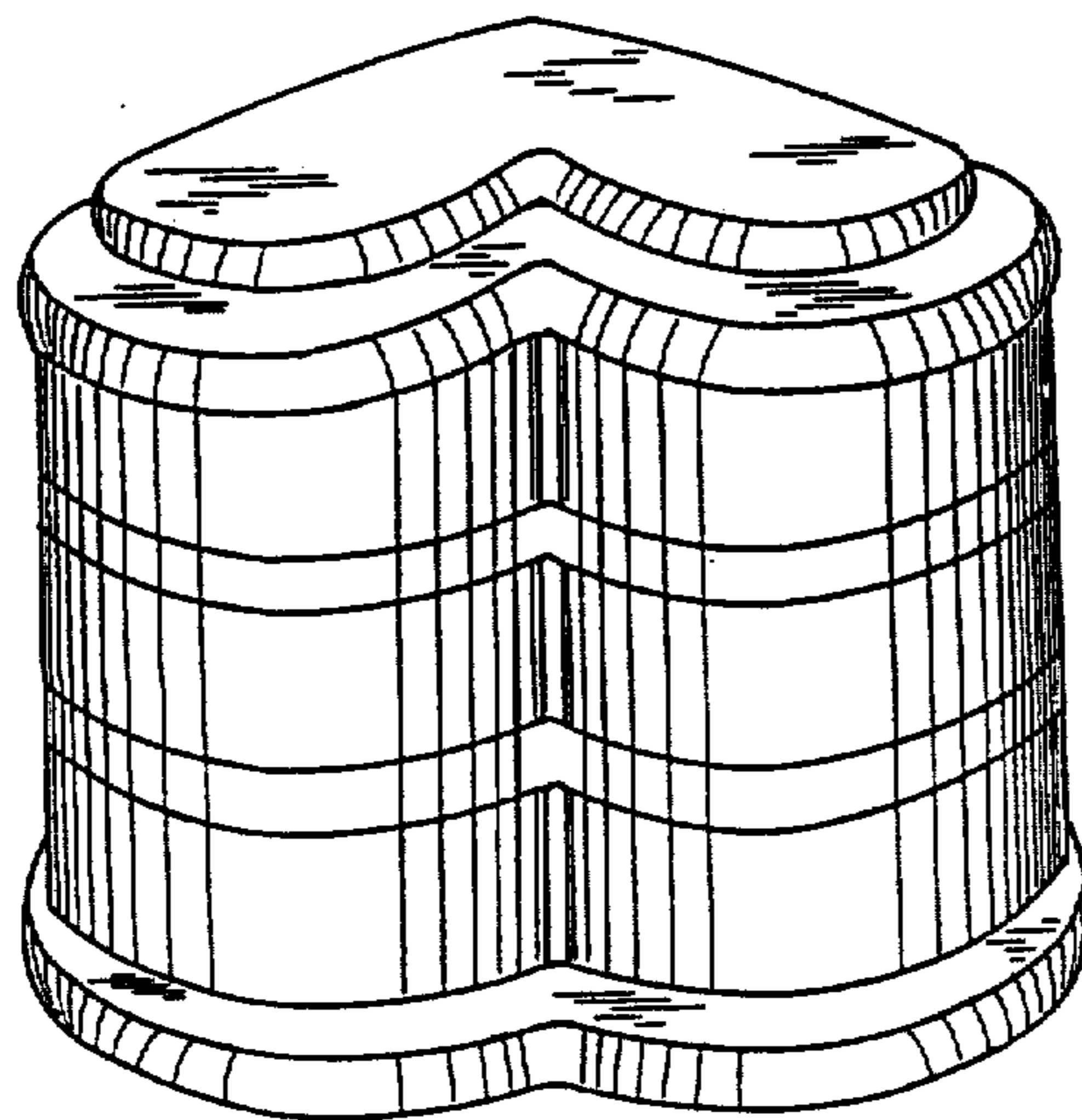

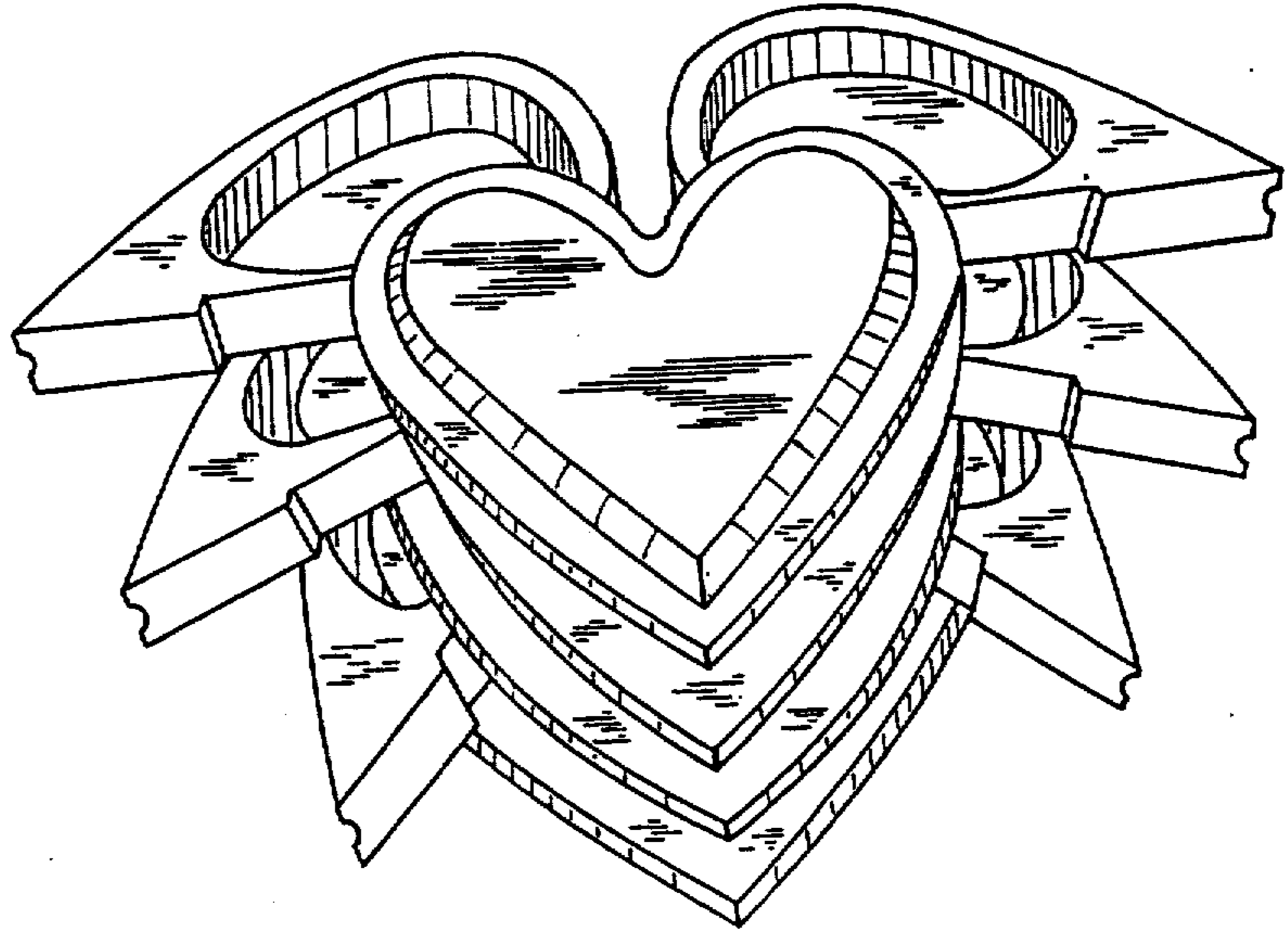

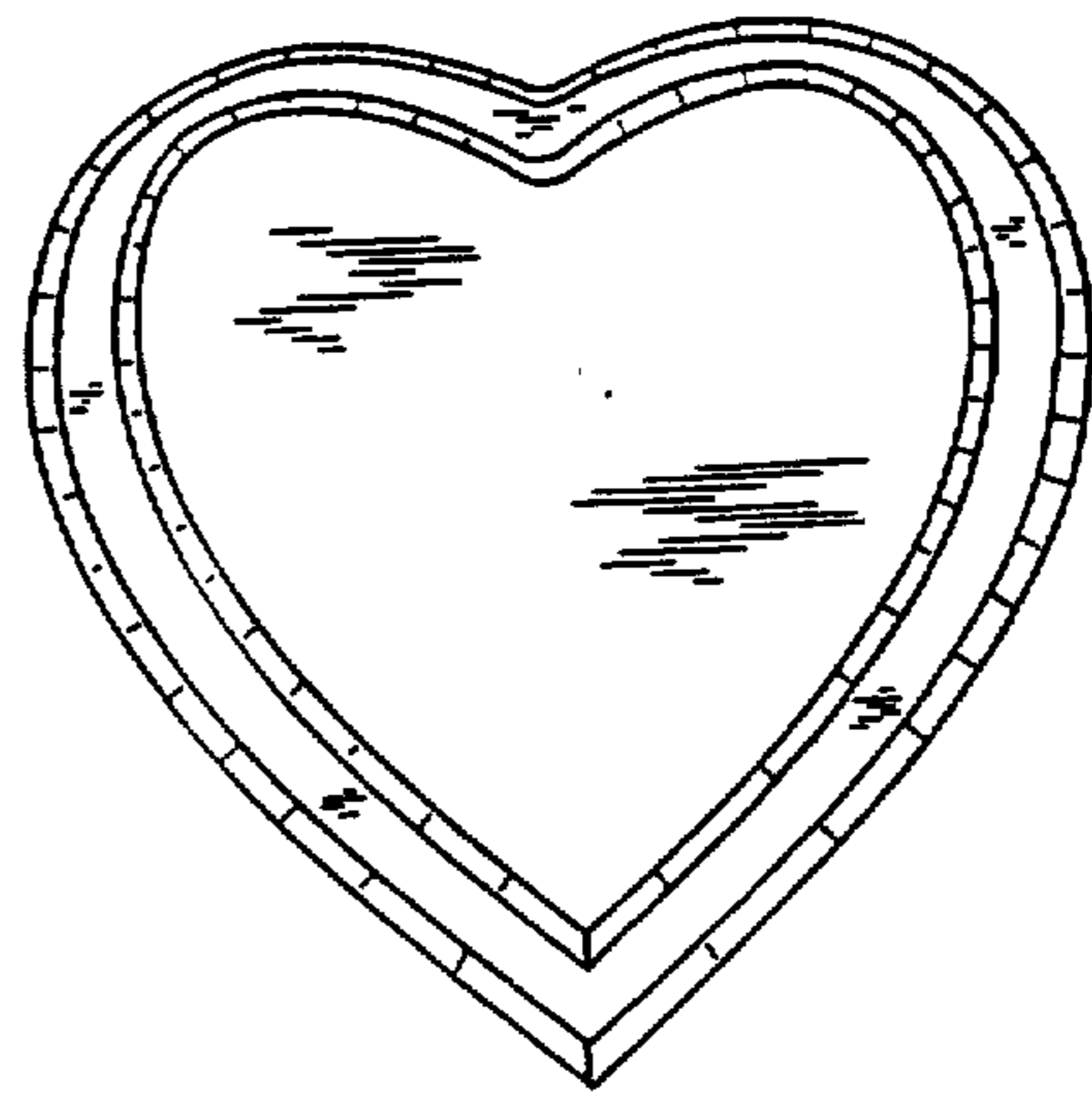

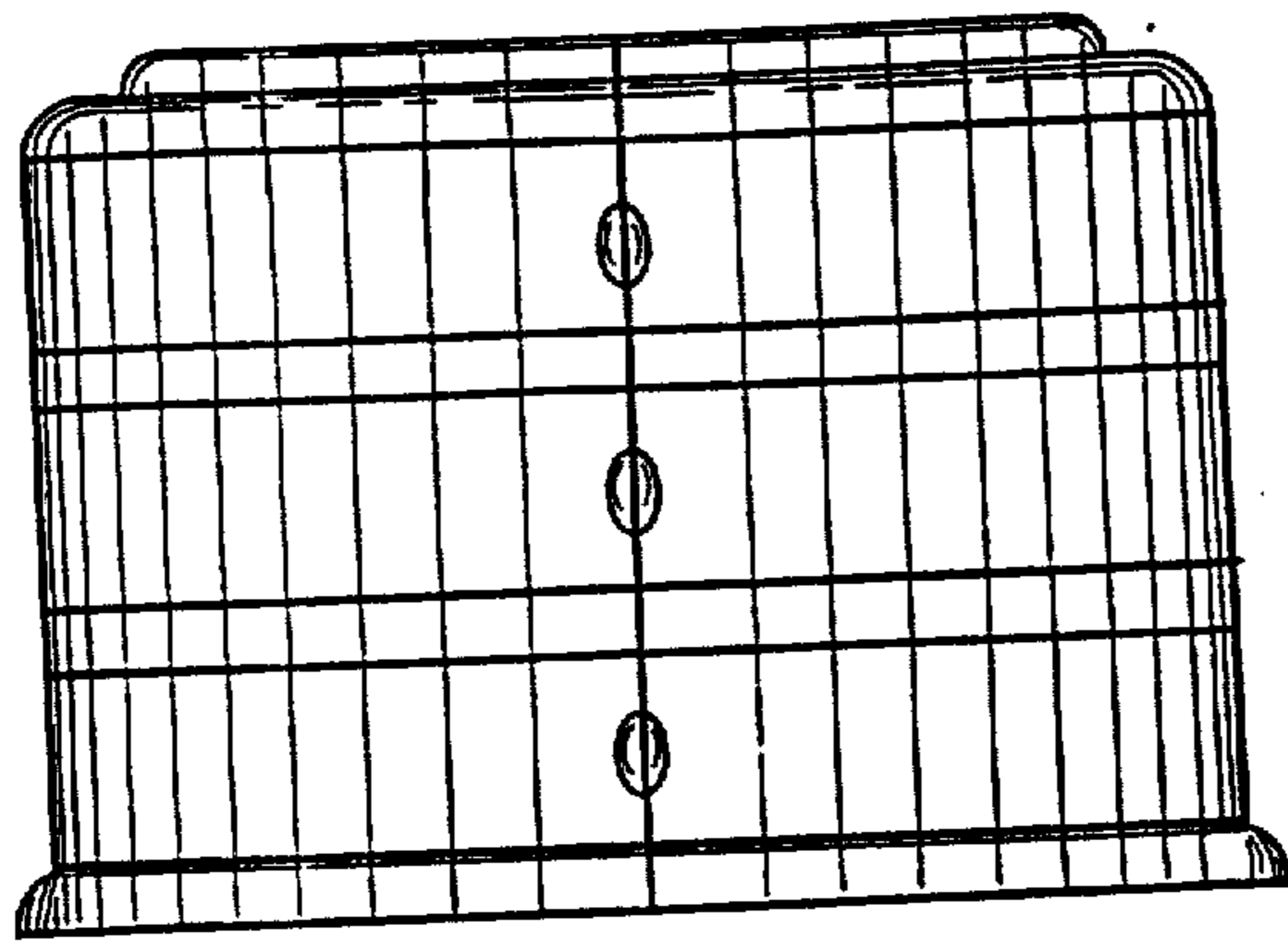

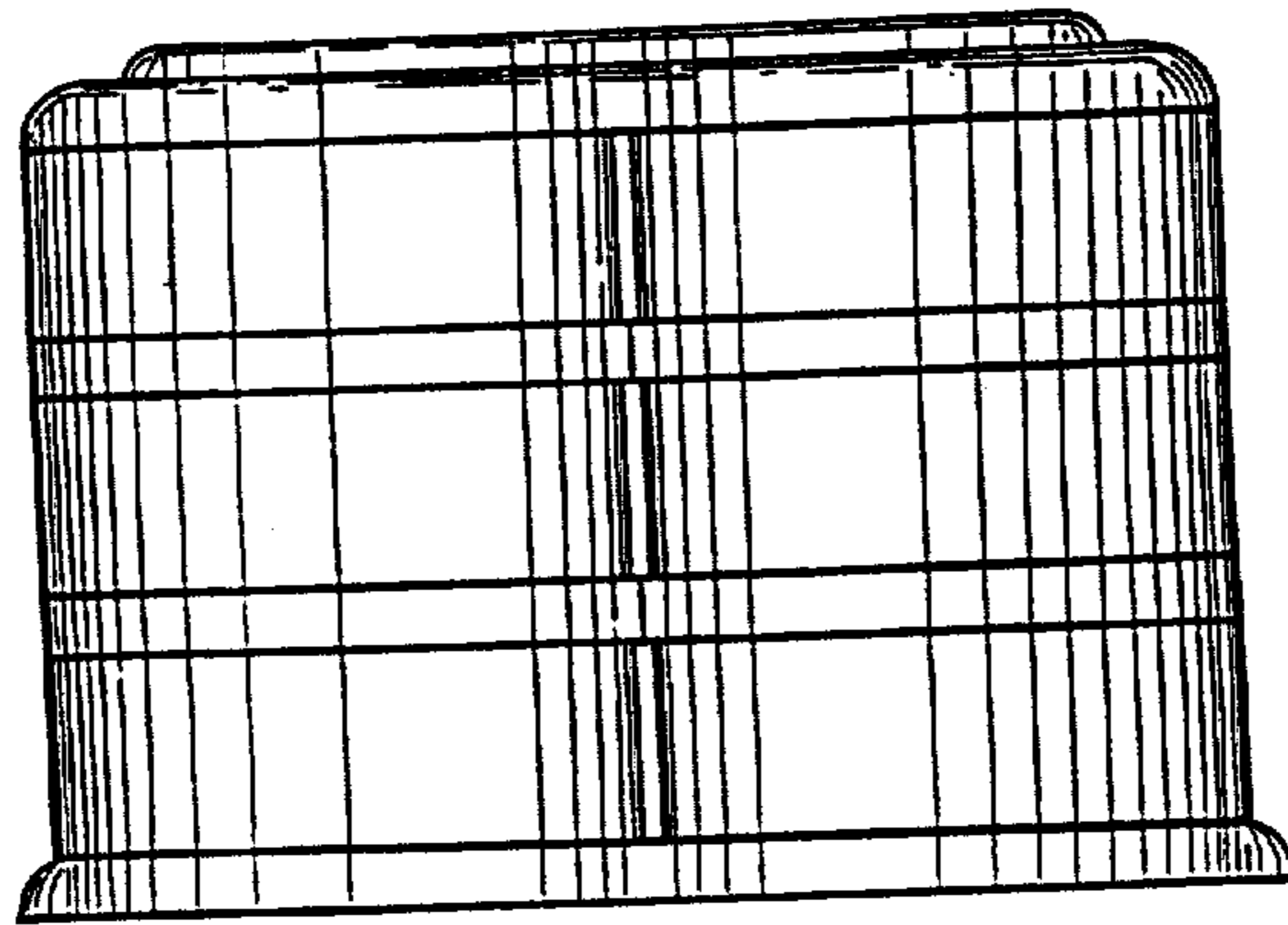

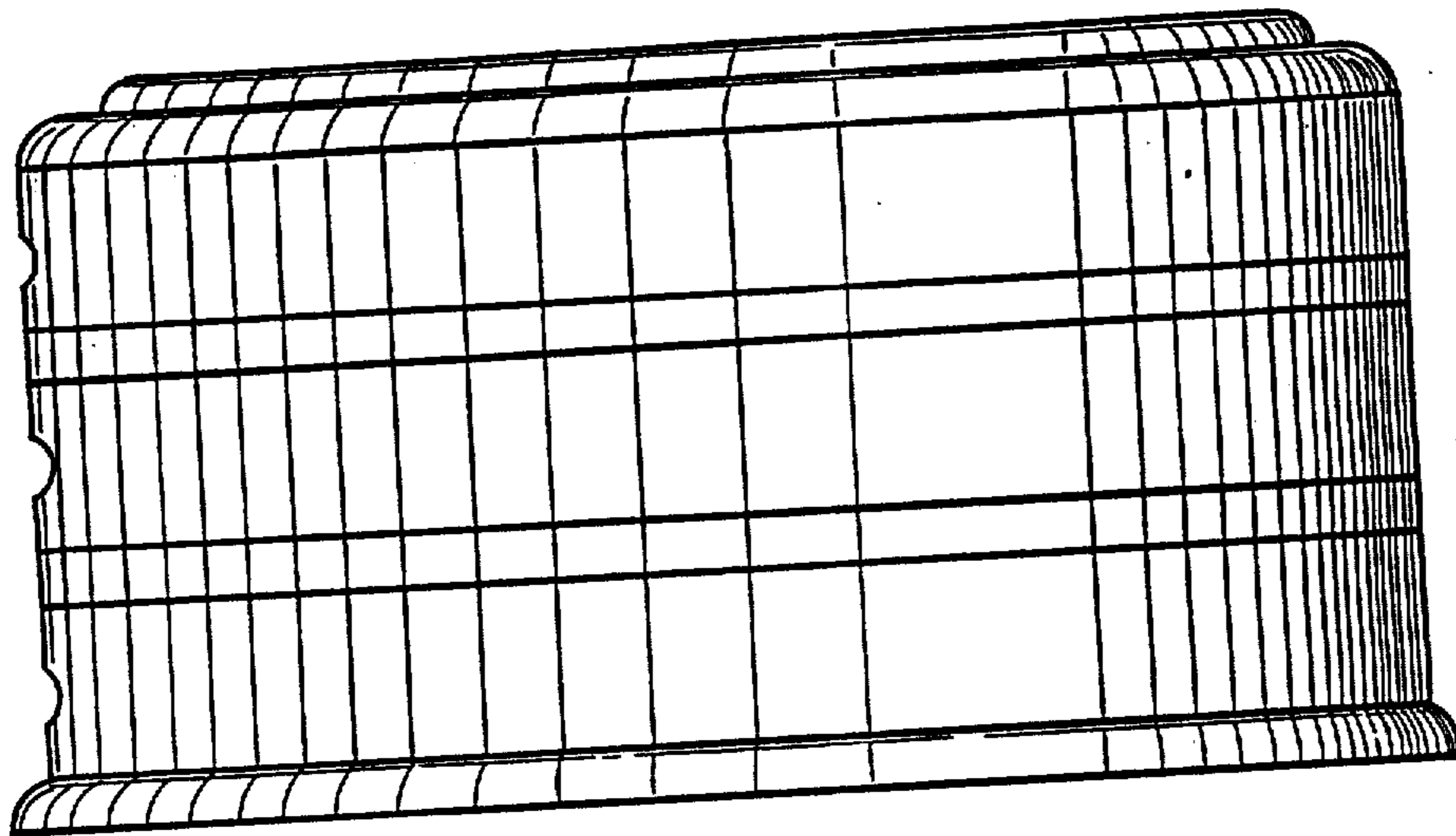

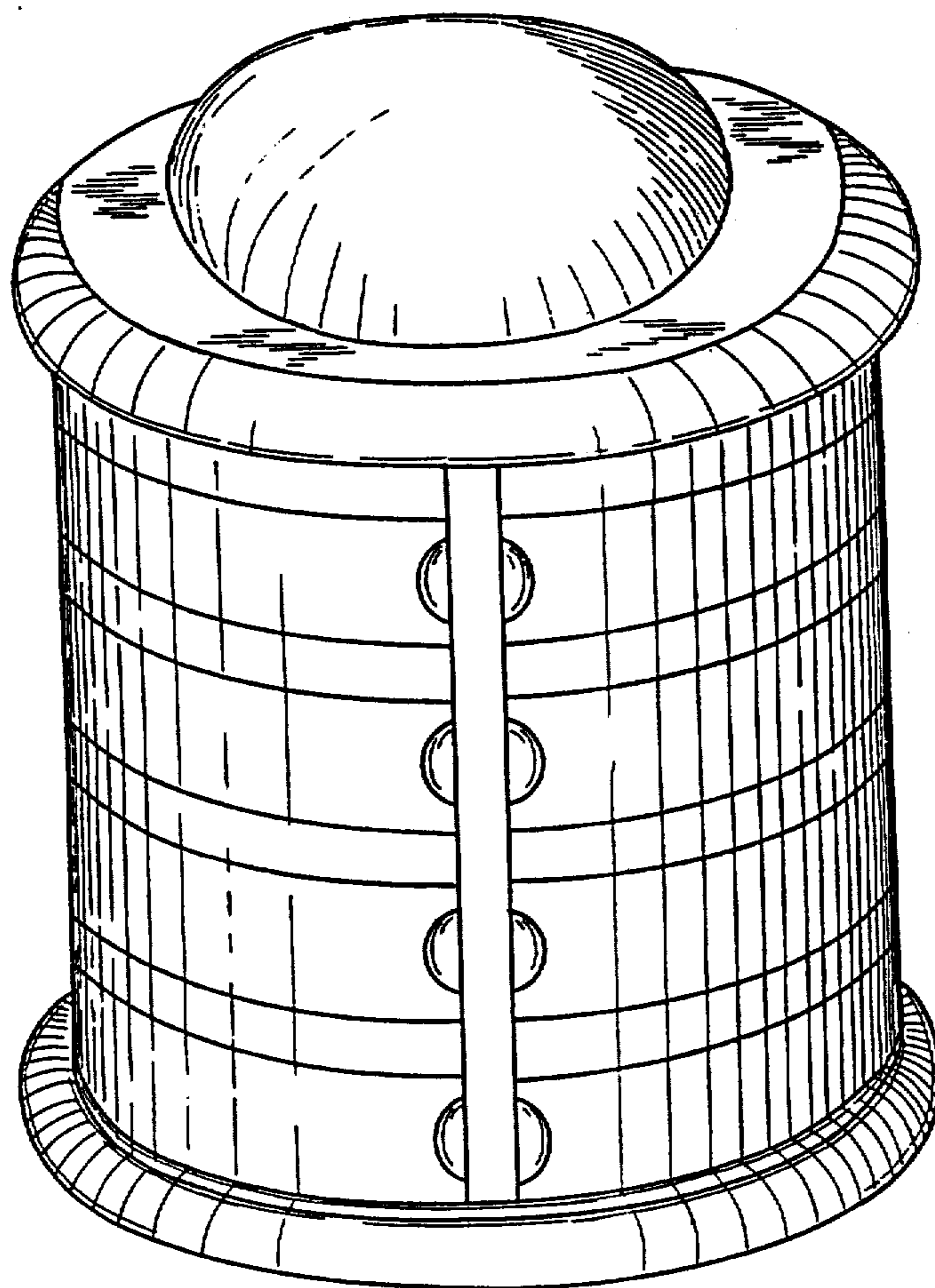

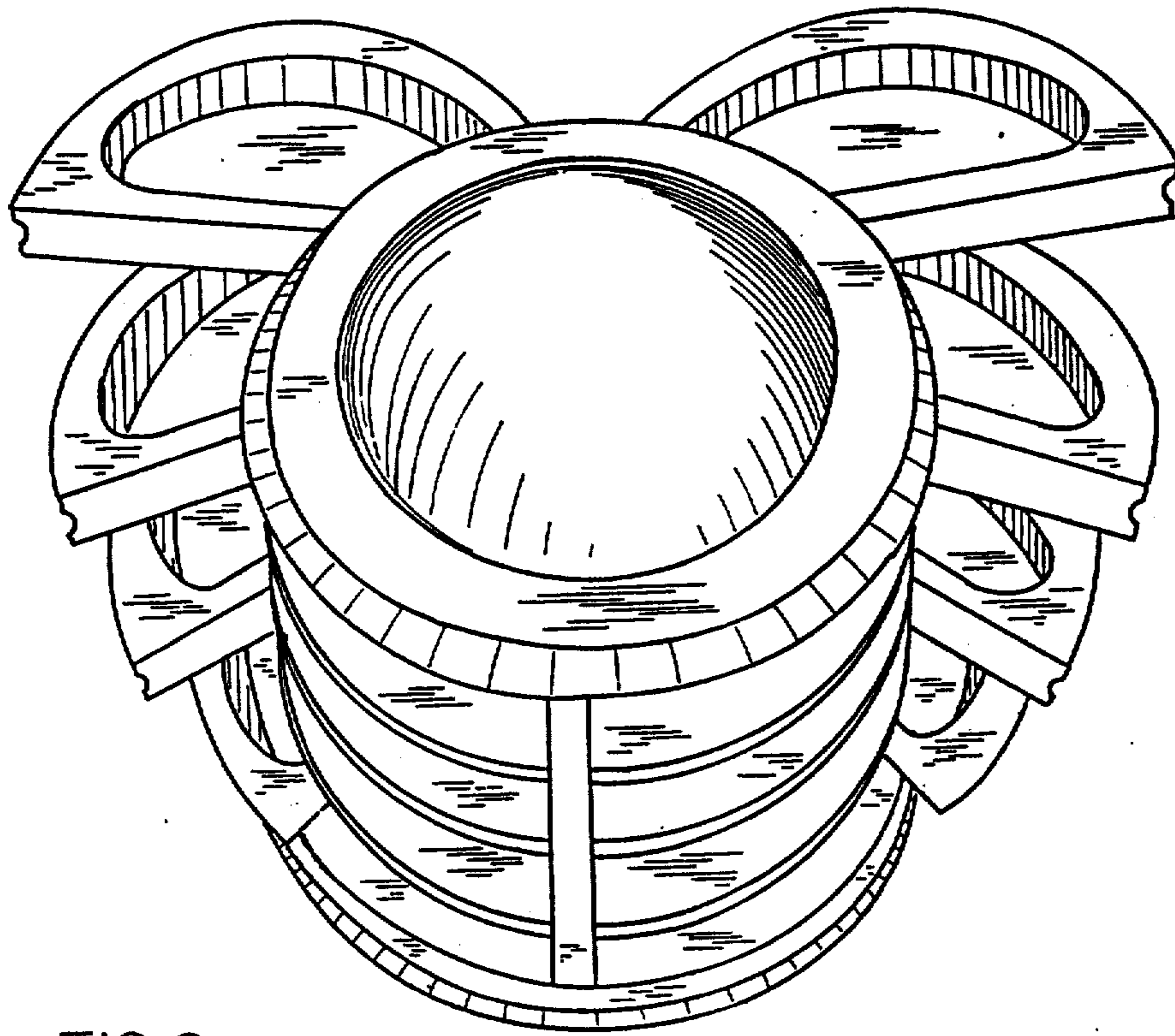

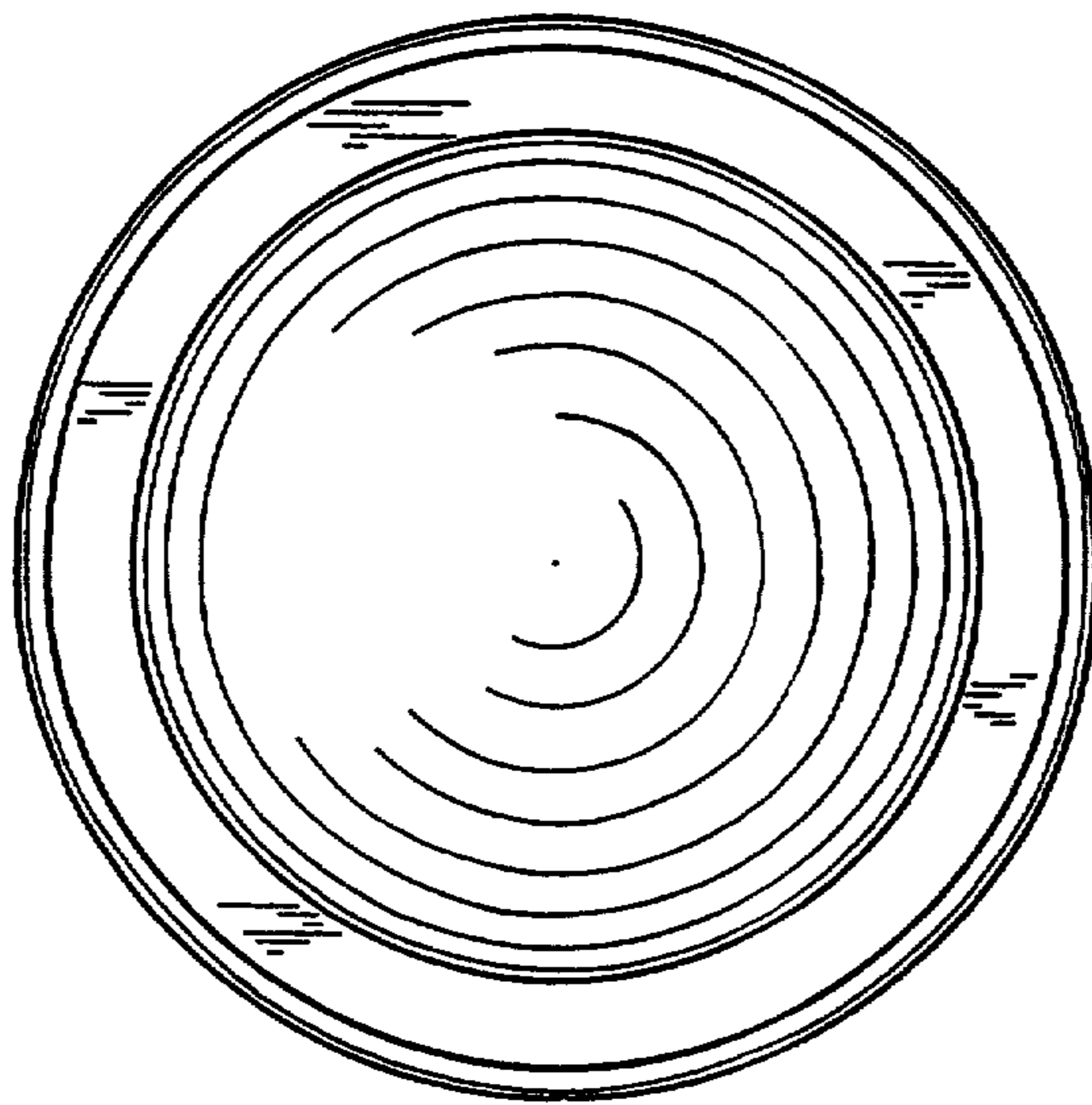

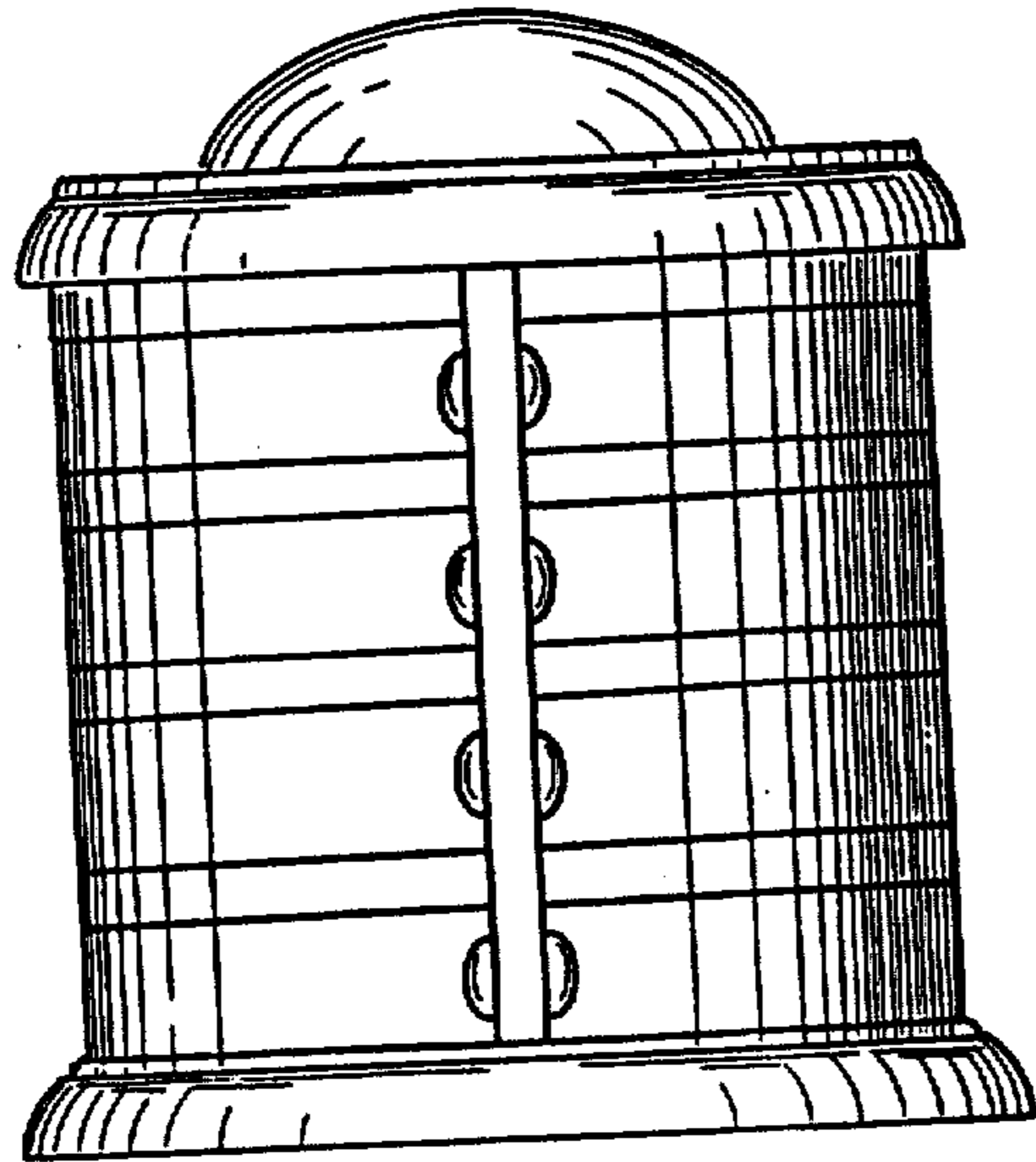

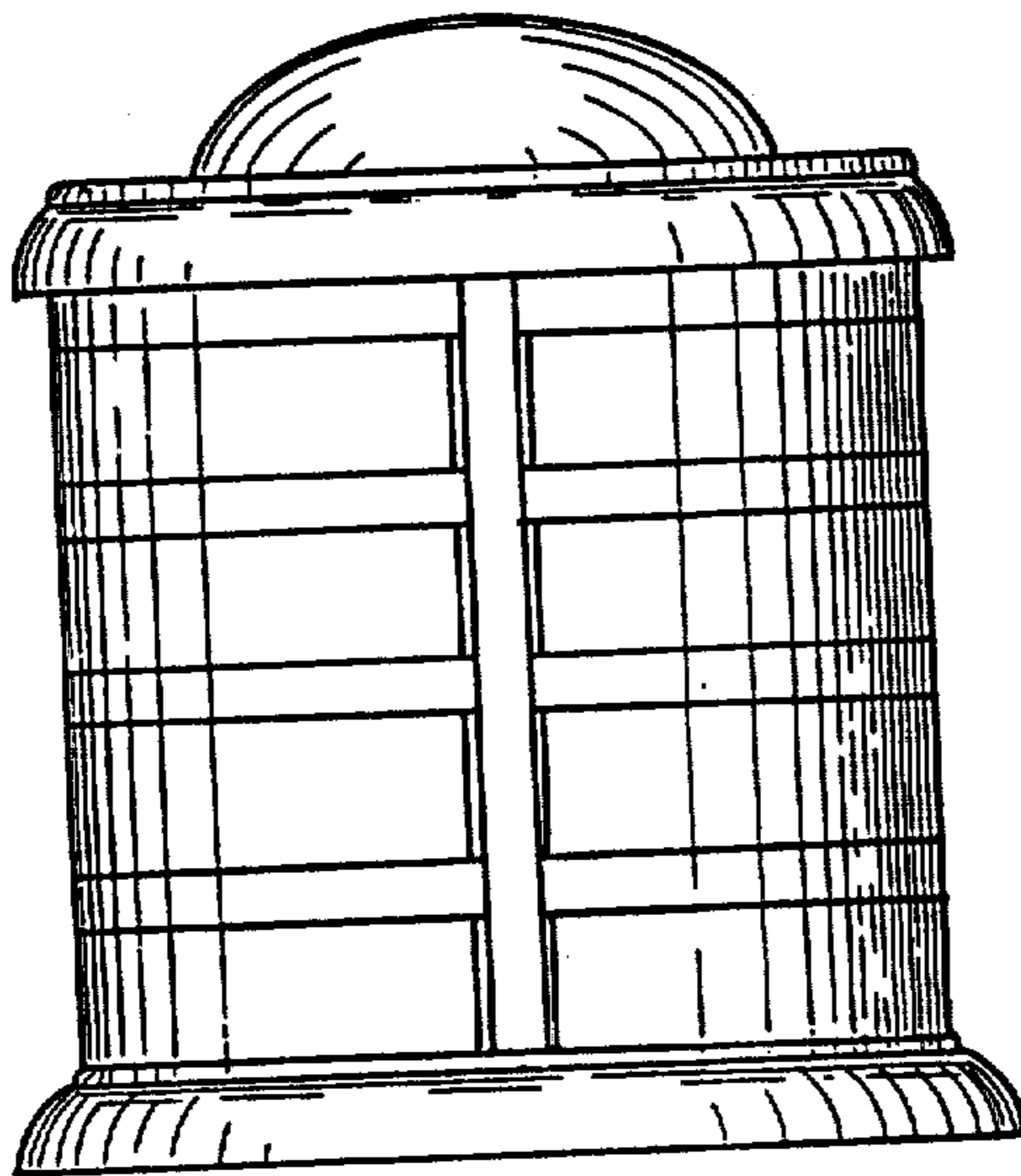

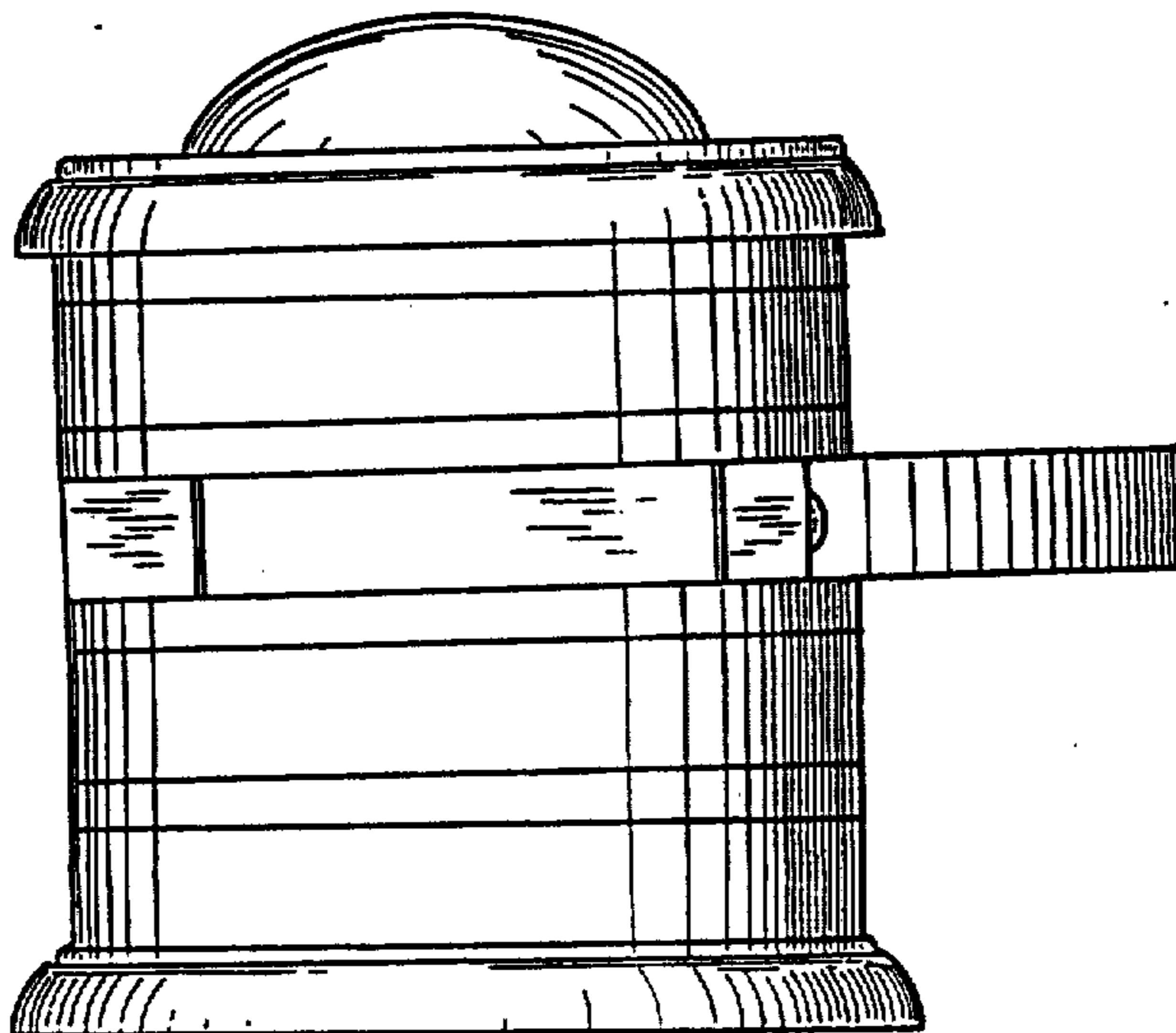
