DESCRIPTION

FIG. 1 is a top, front perspective view of a disposable camera showing our new design;

 FIG. 14 is a right side elevational view thereof.

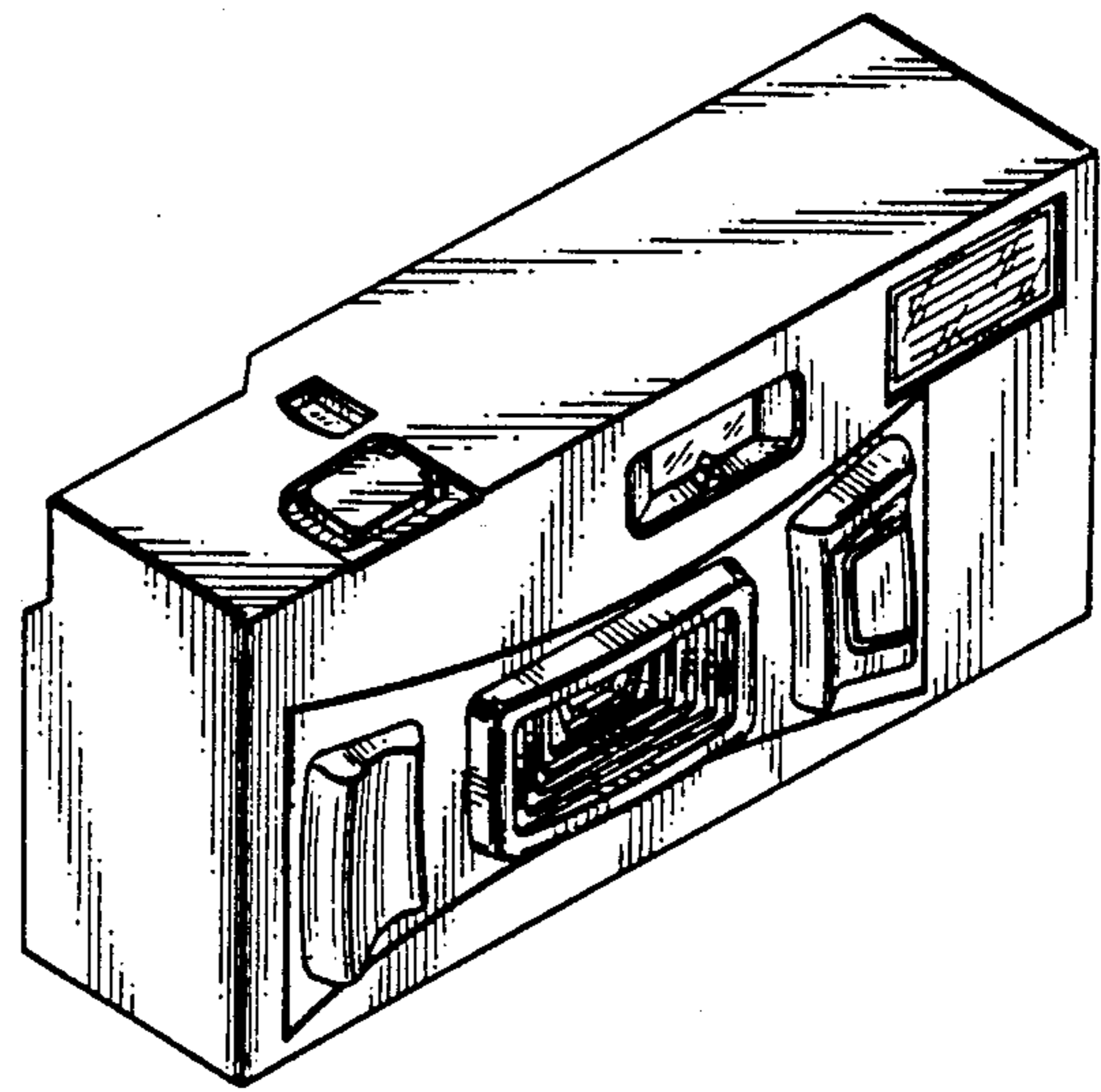
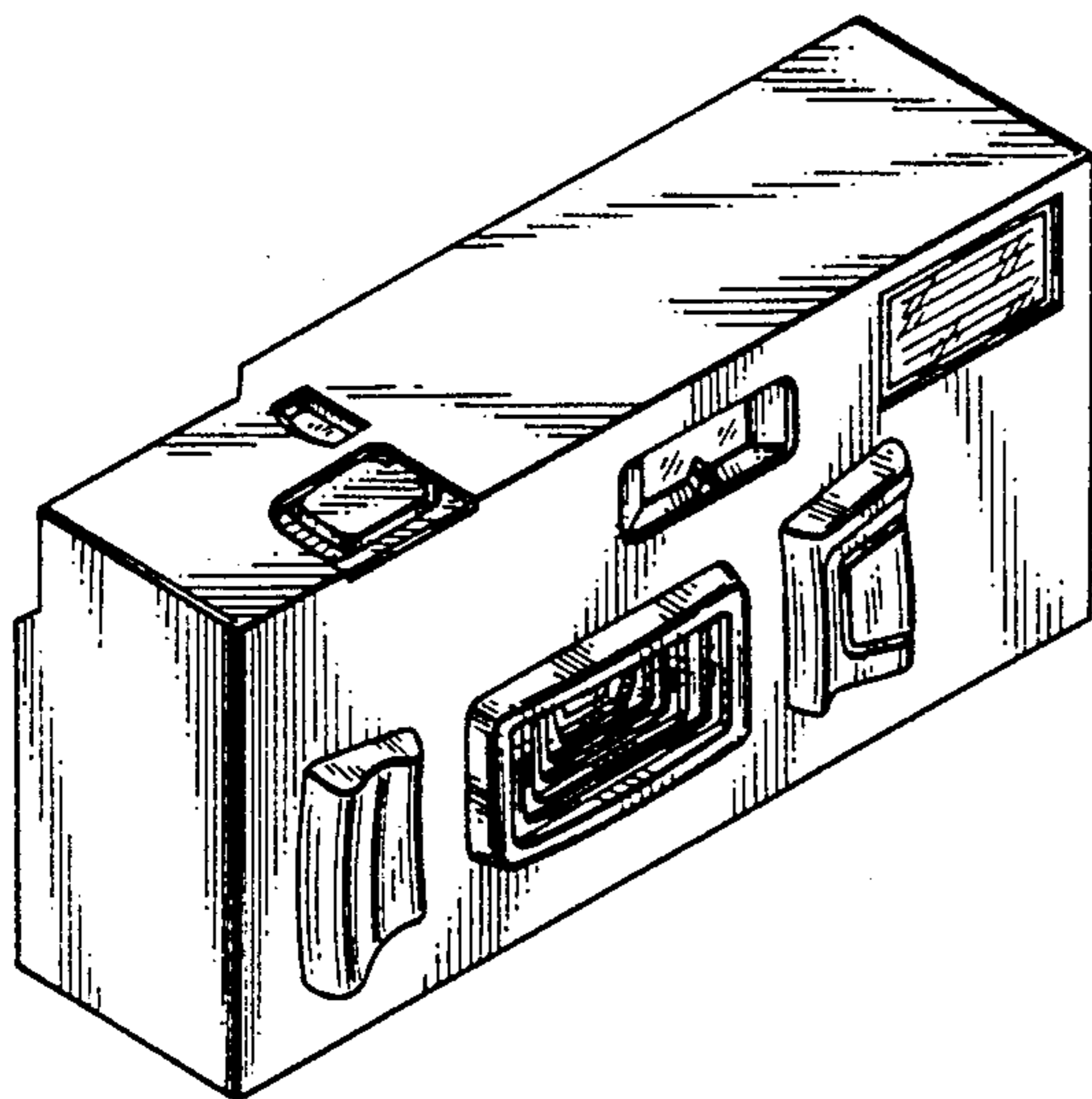

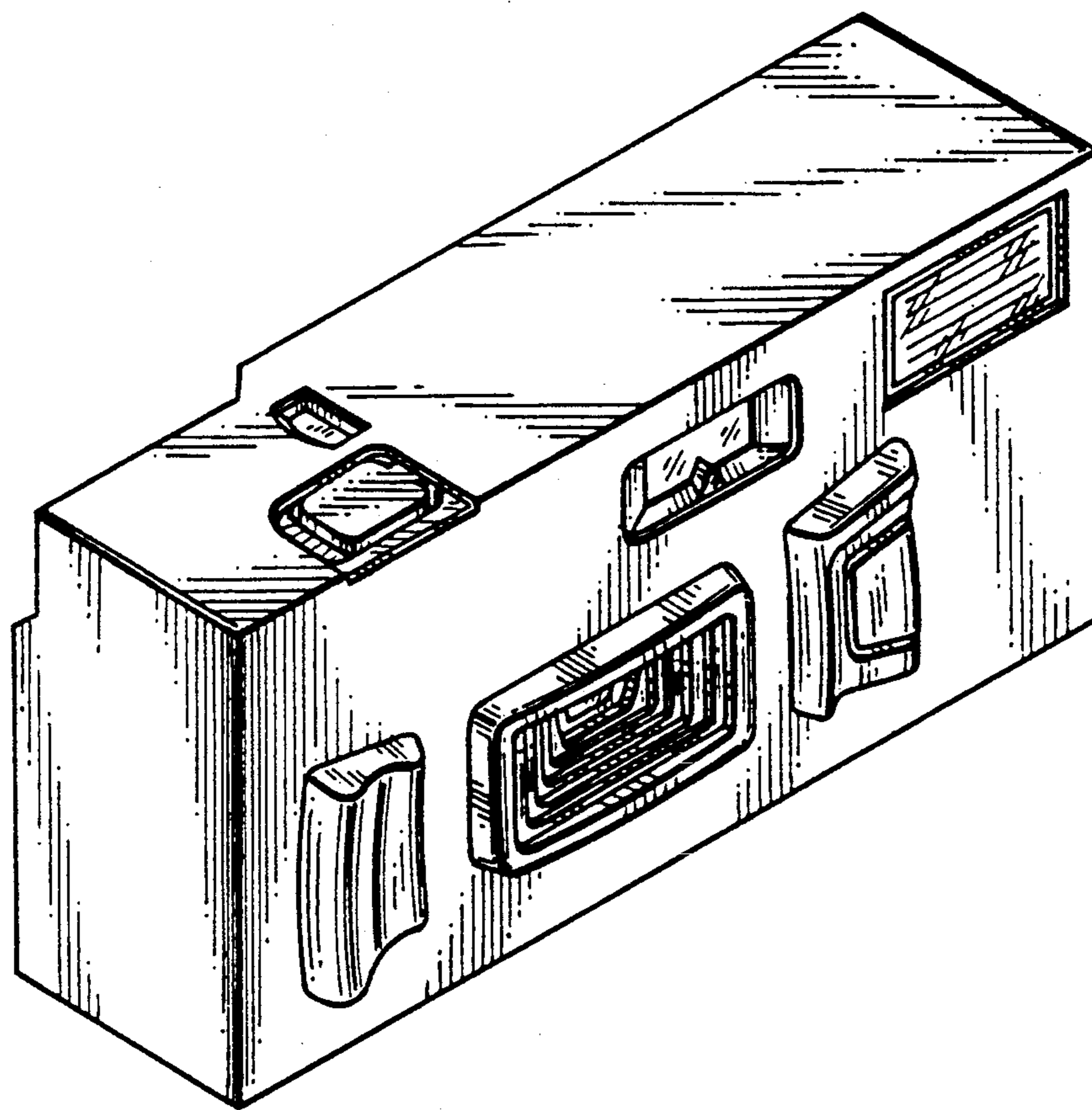

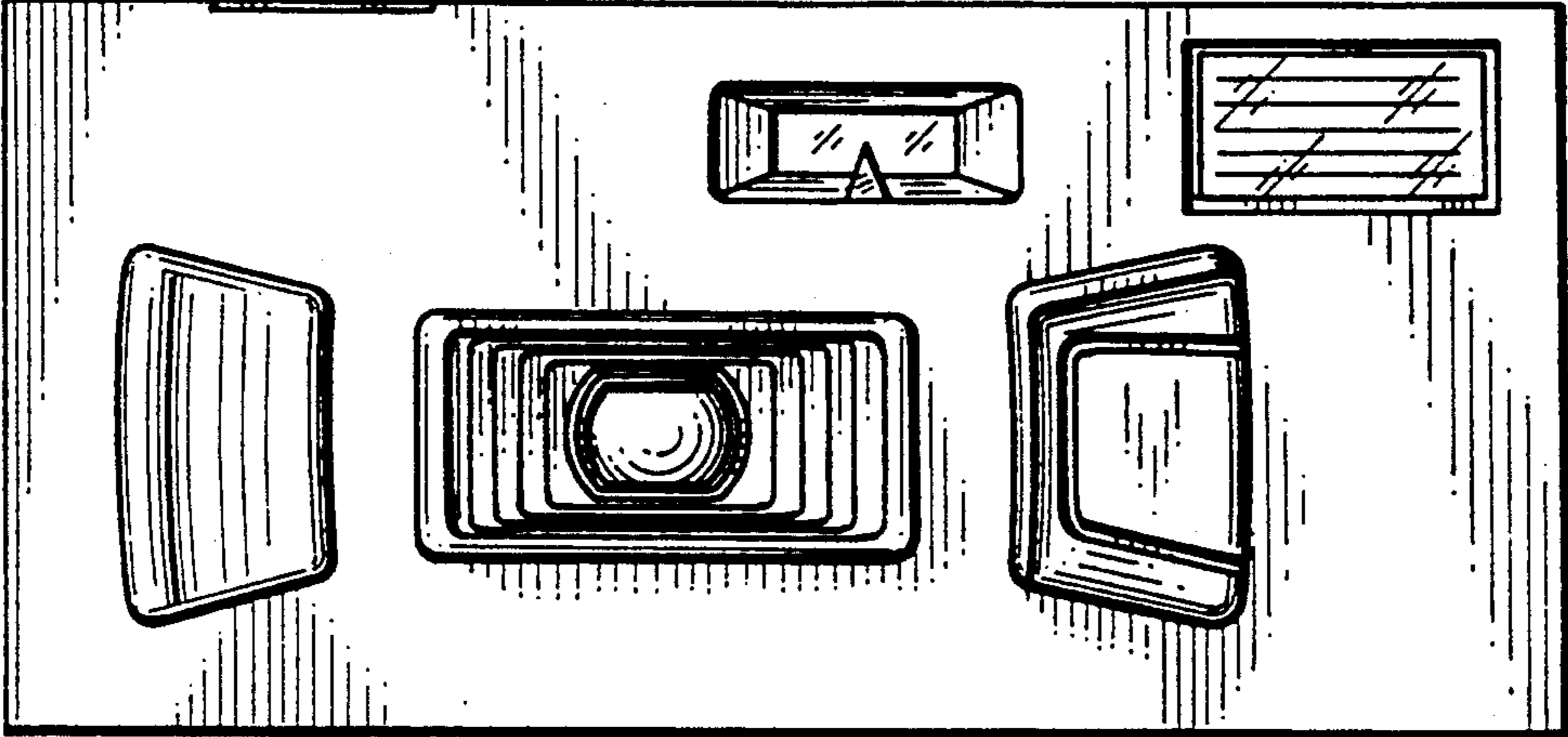

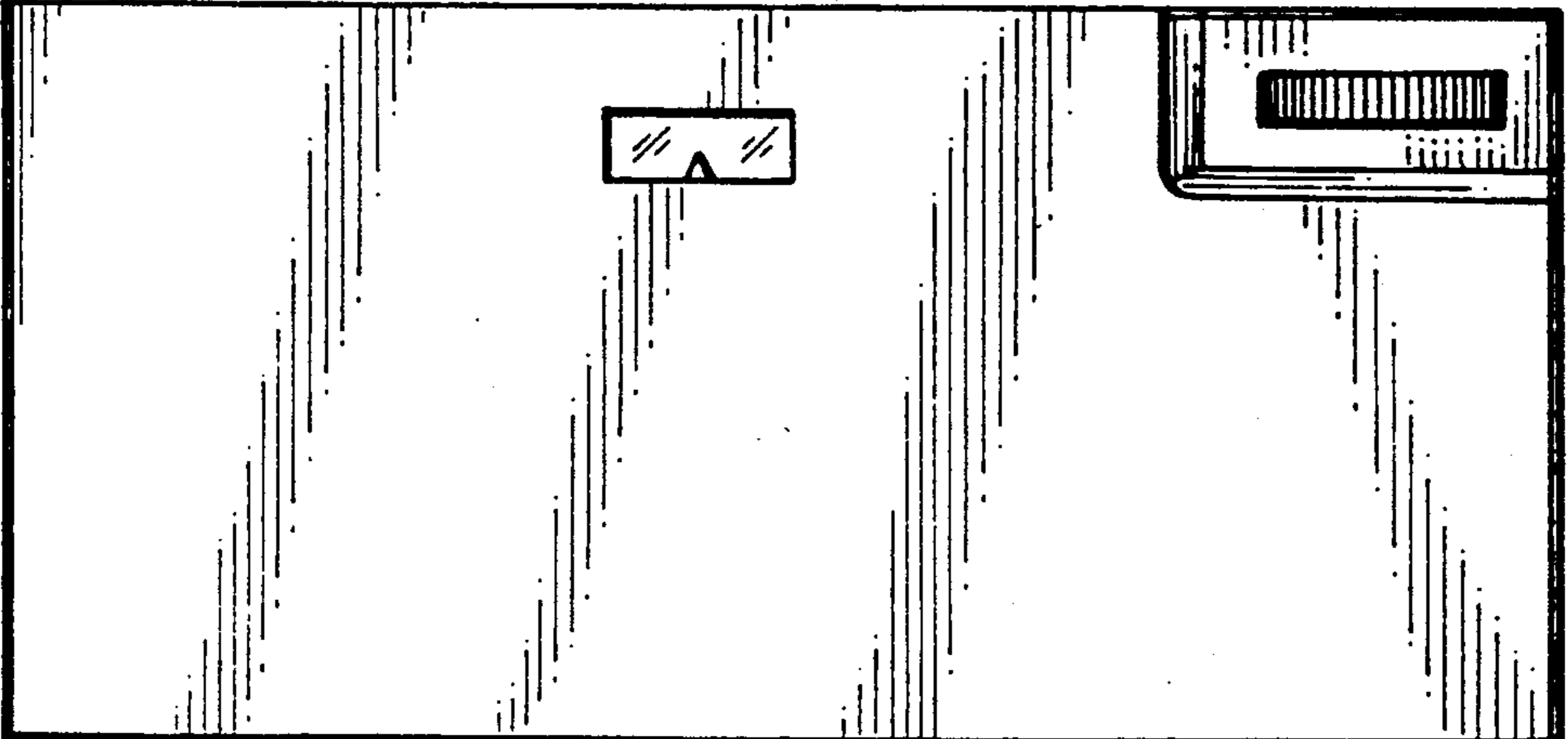

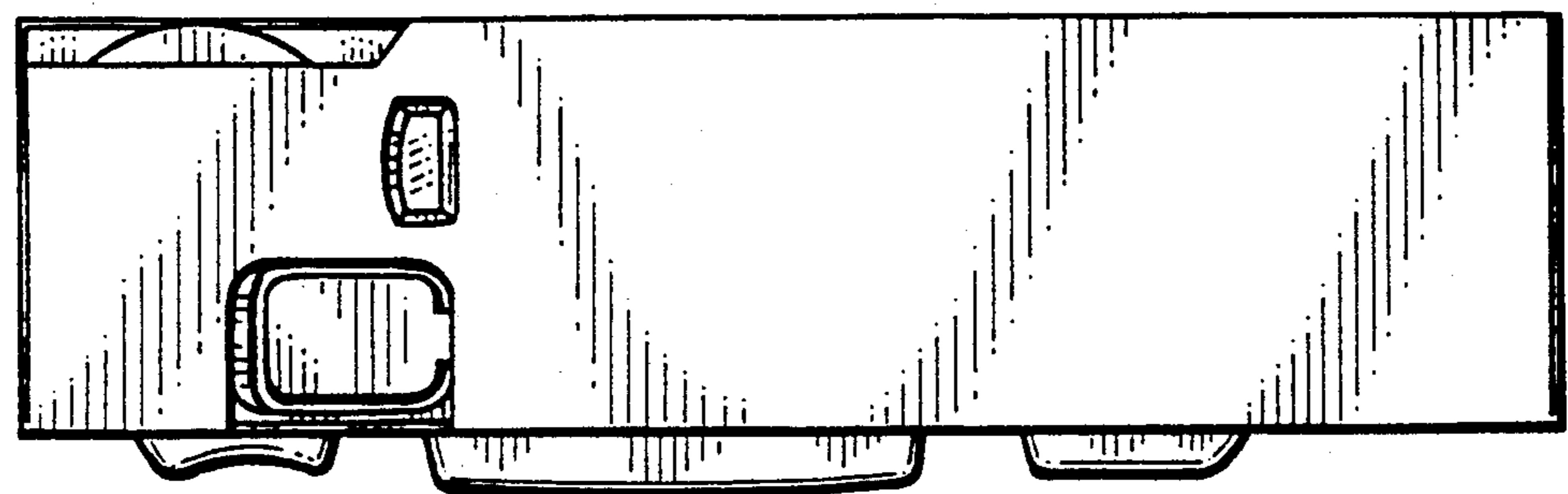

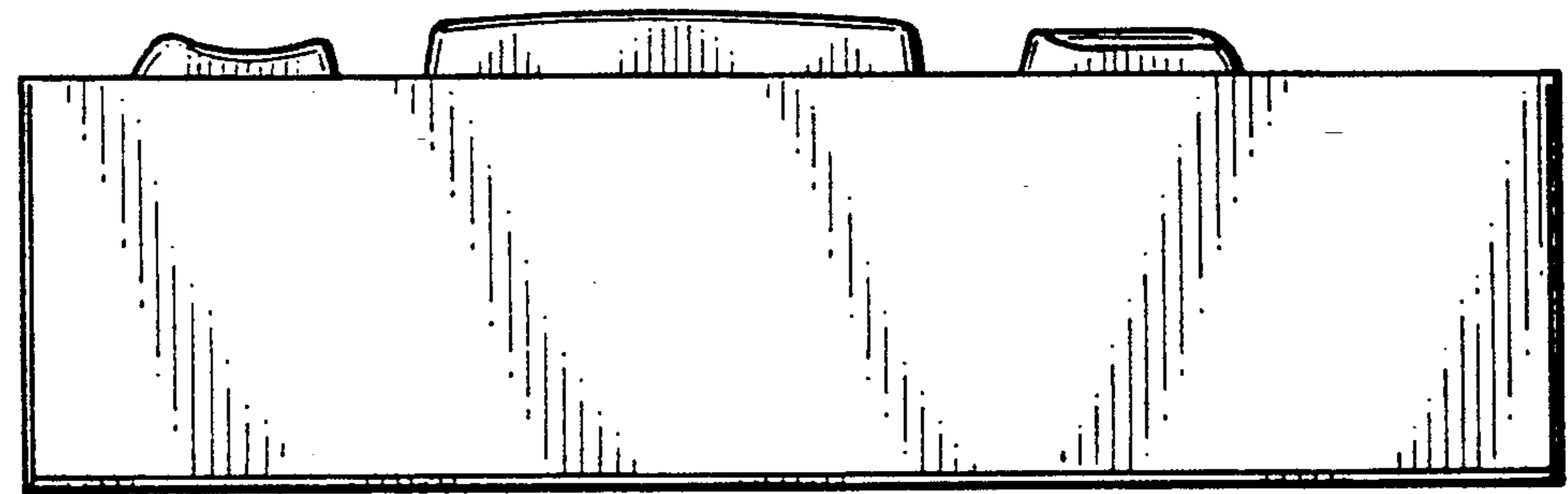

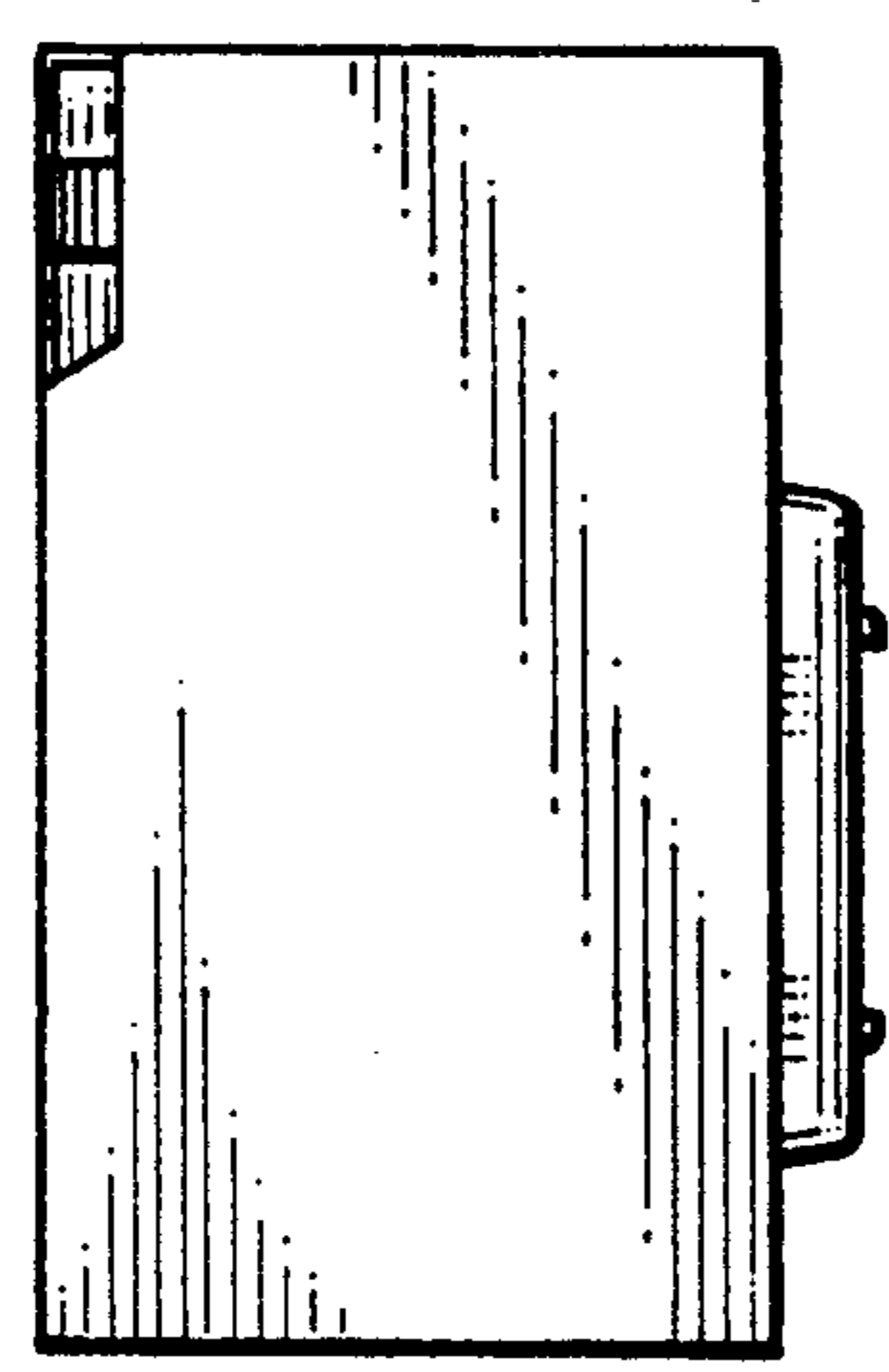

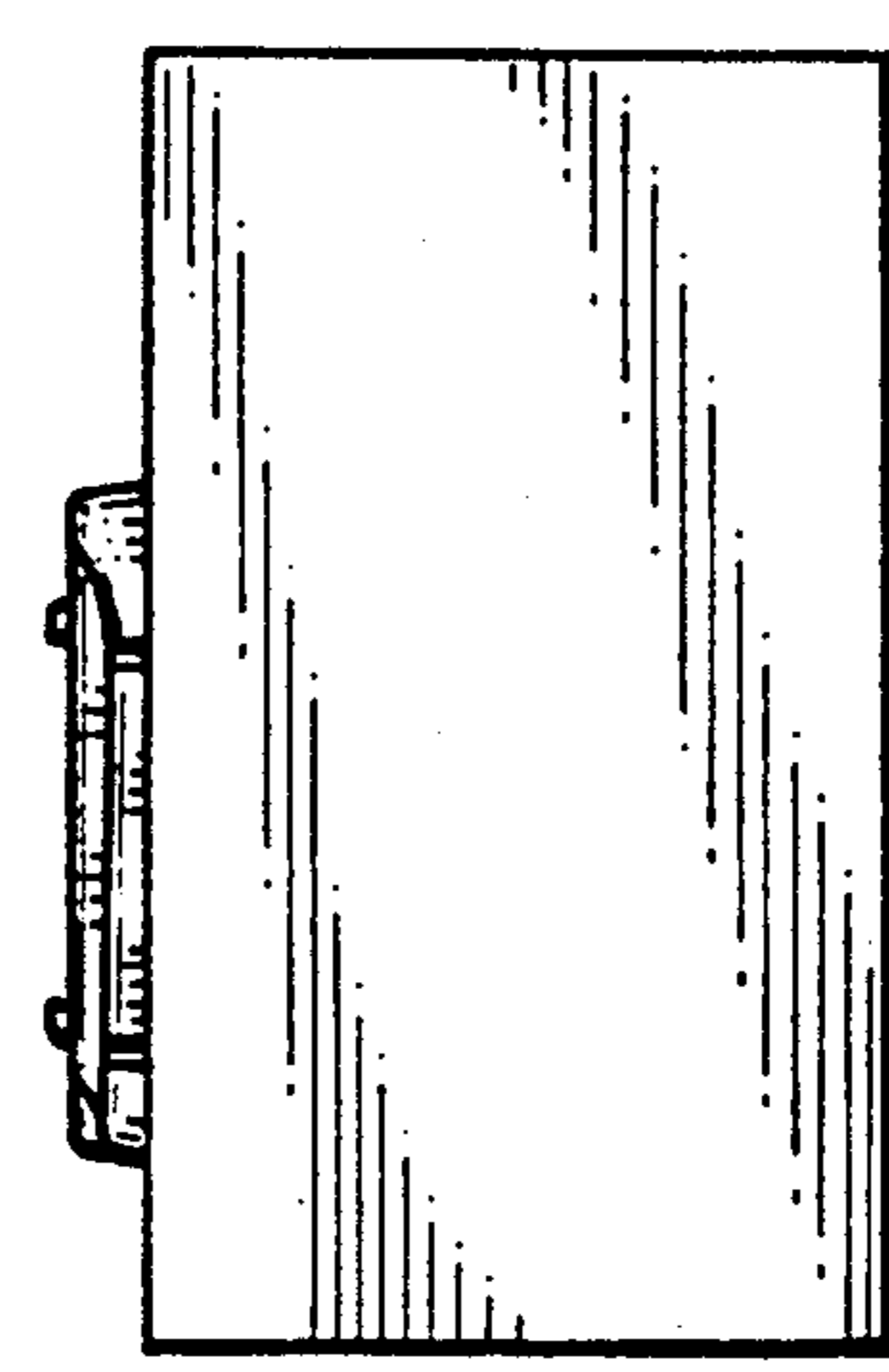

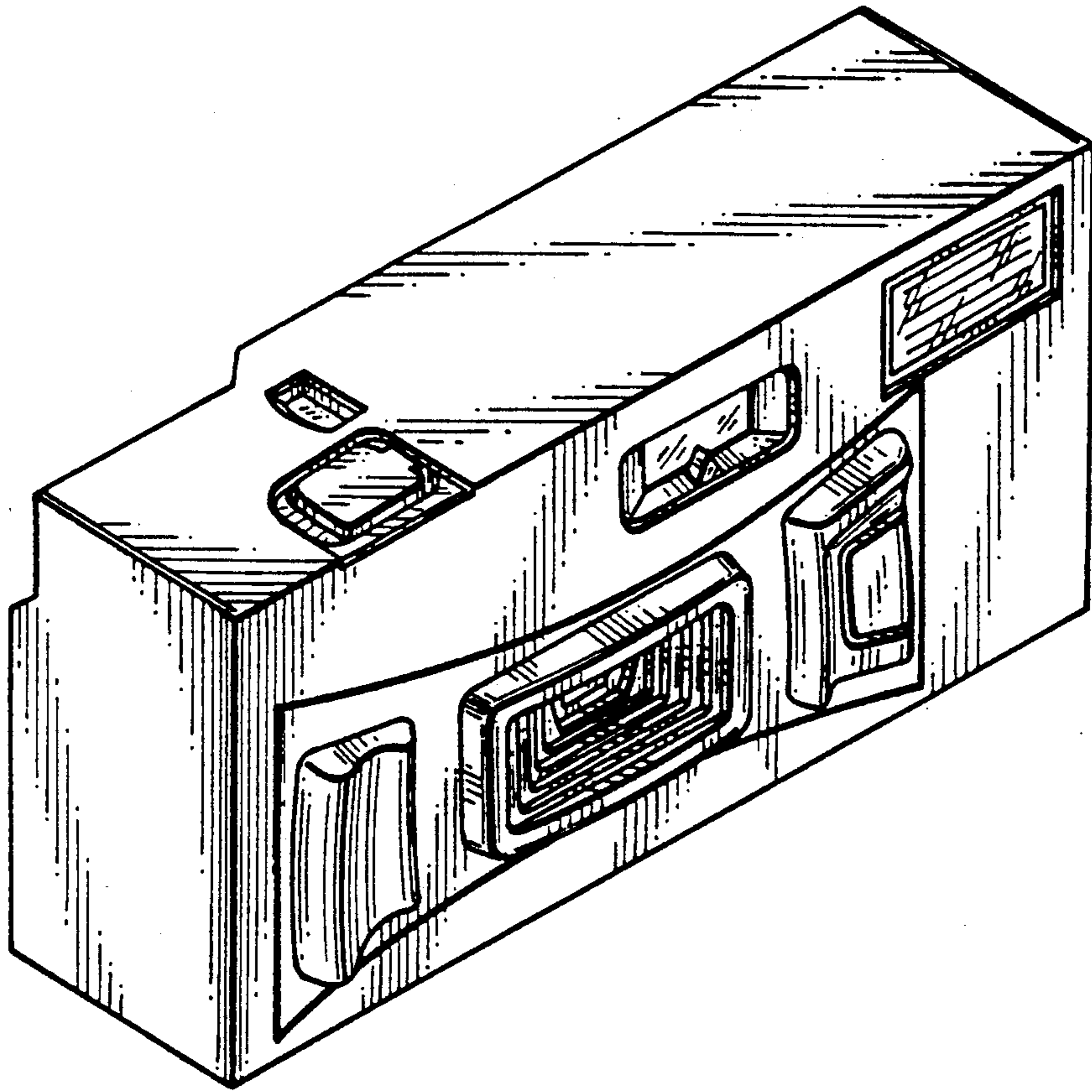

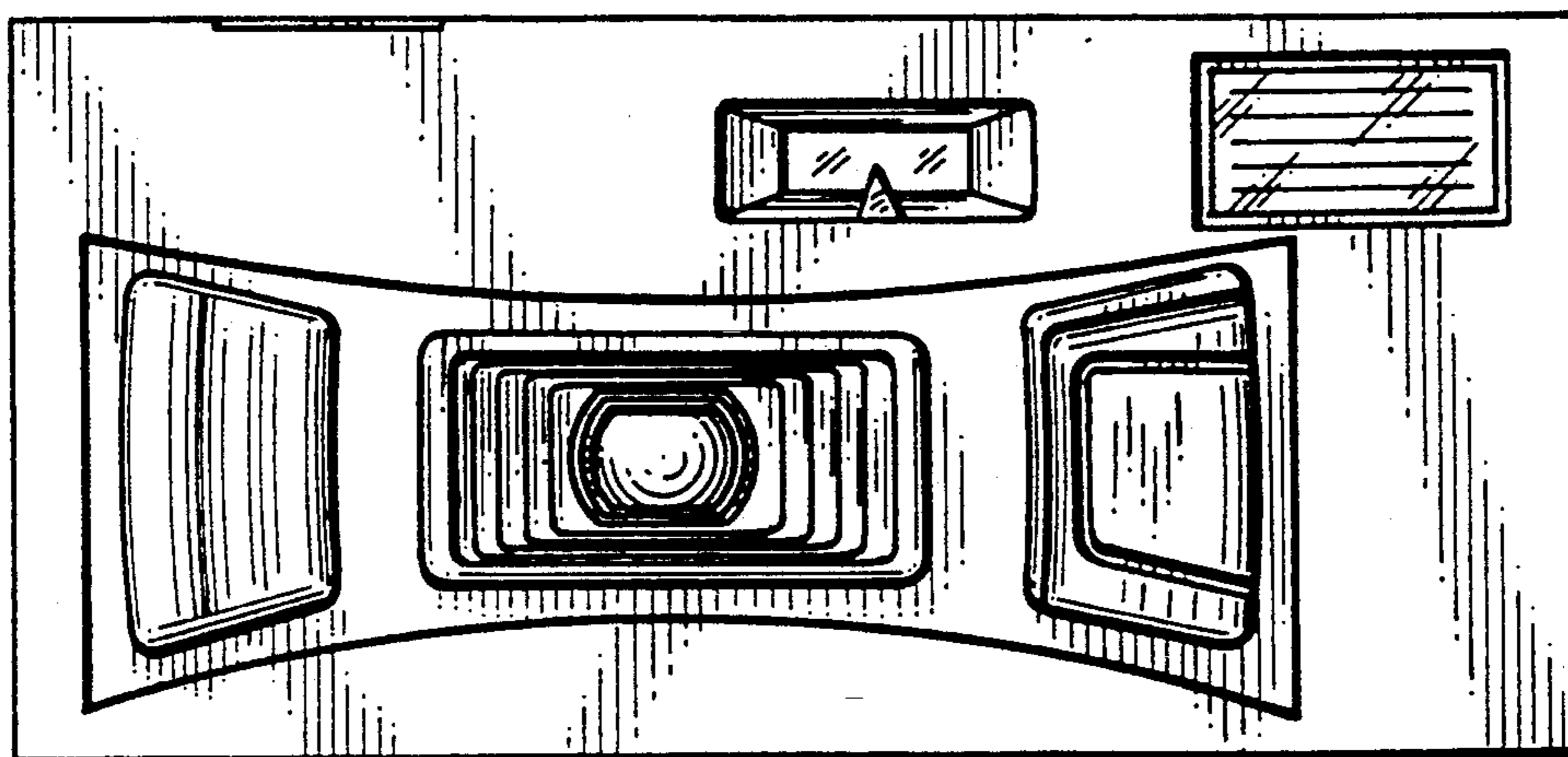

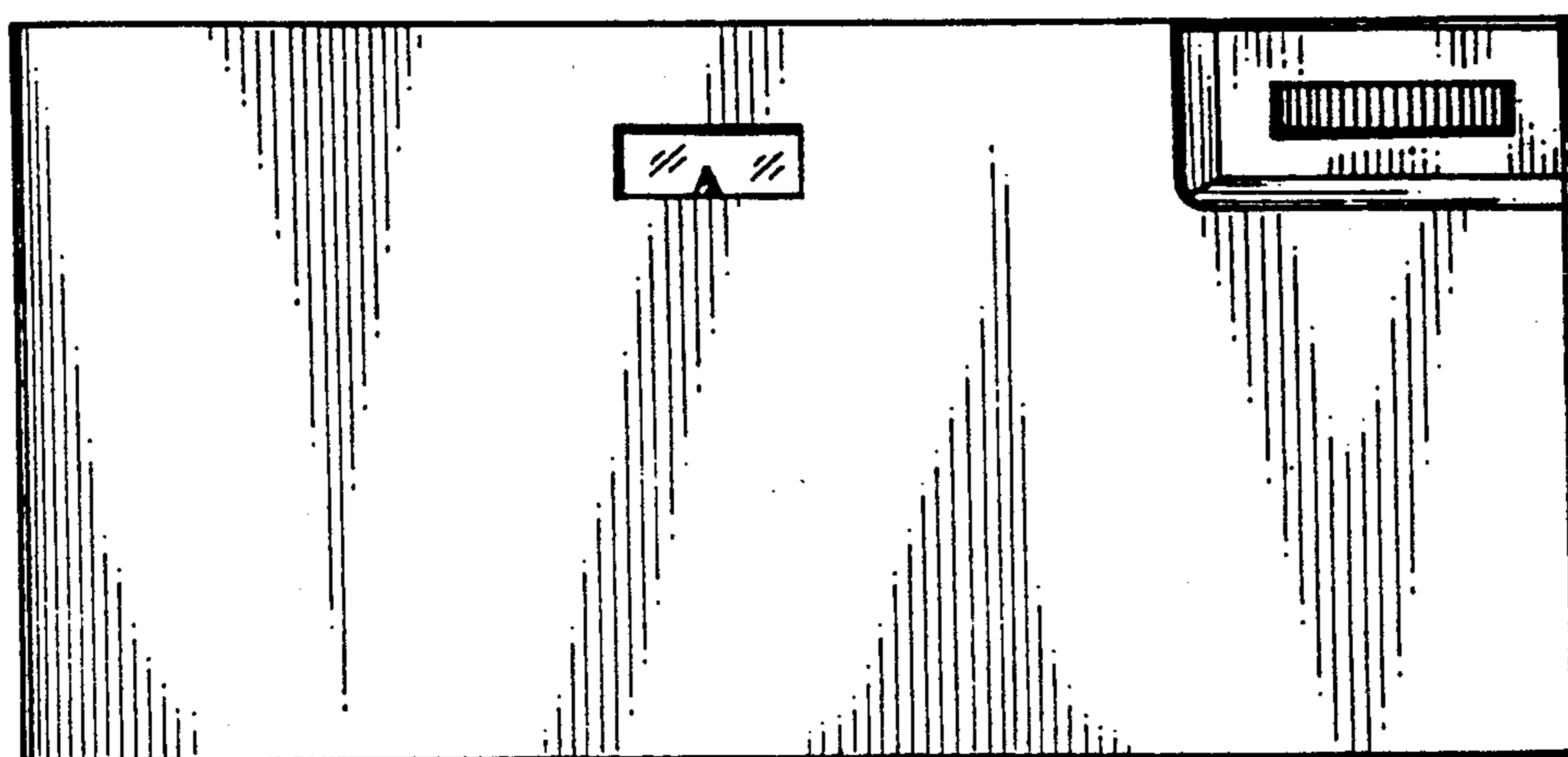

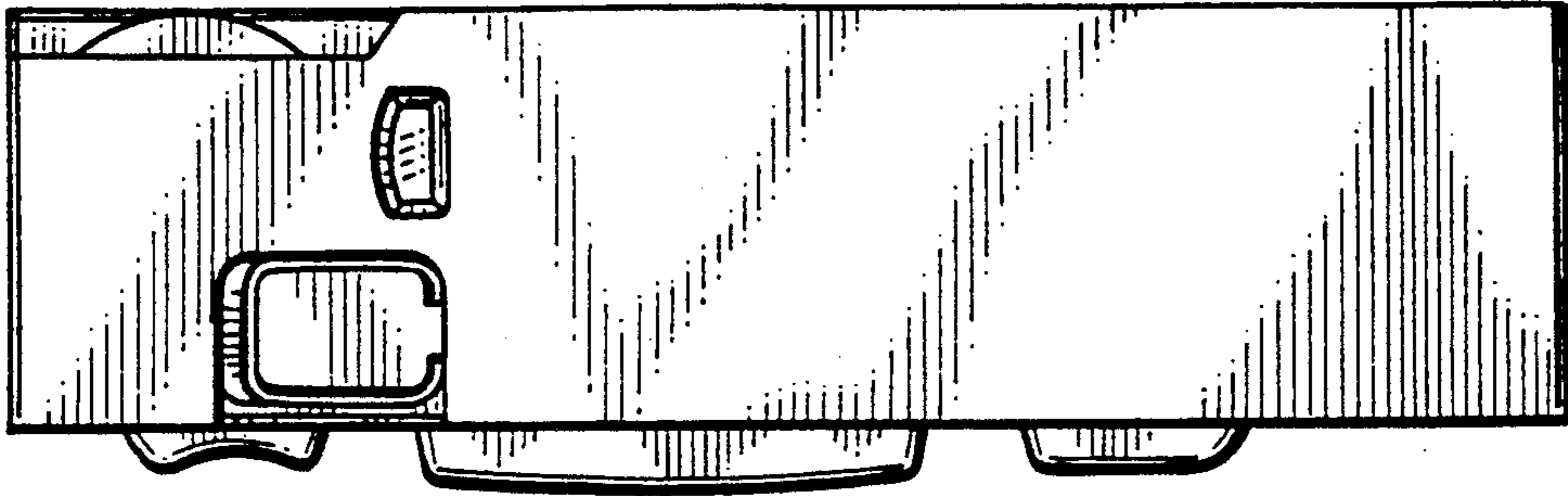

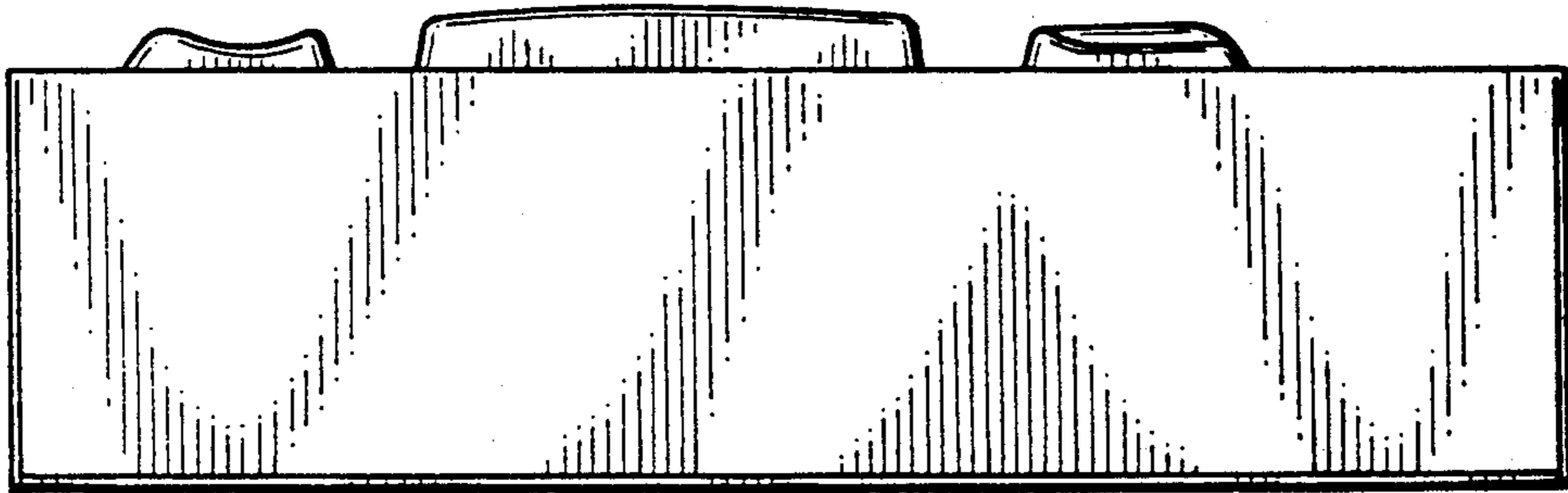

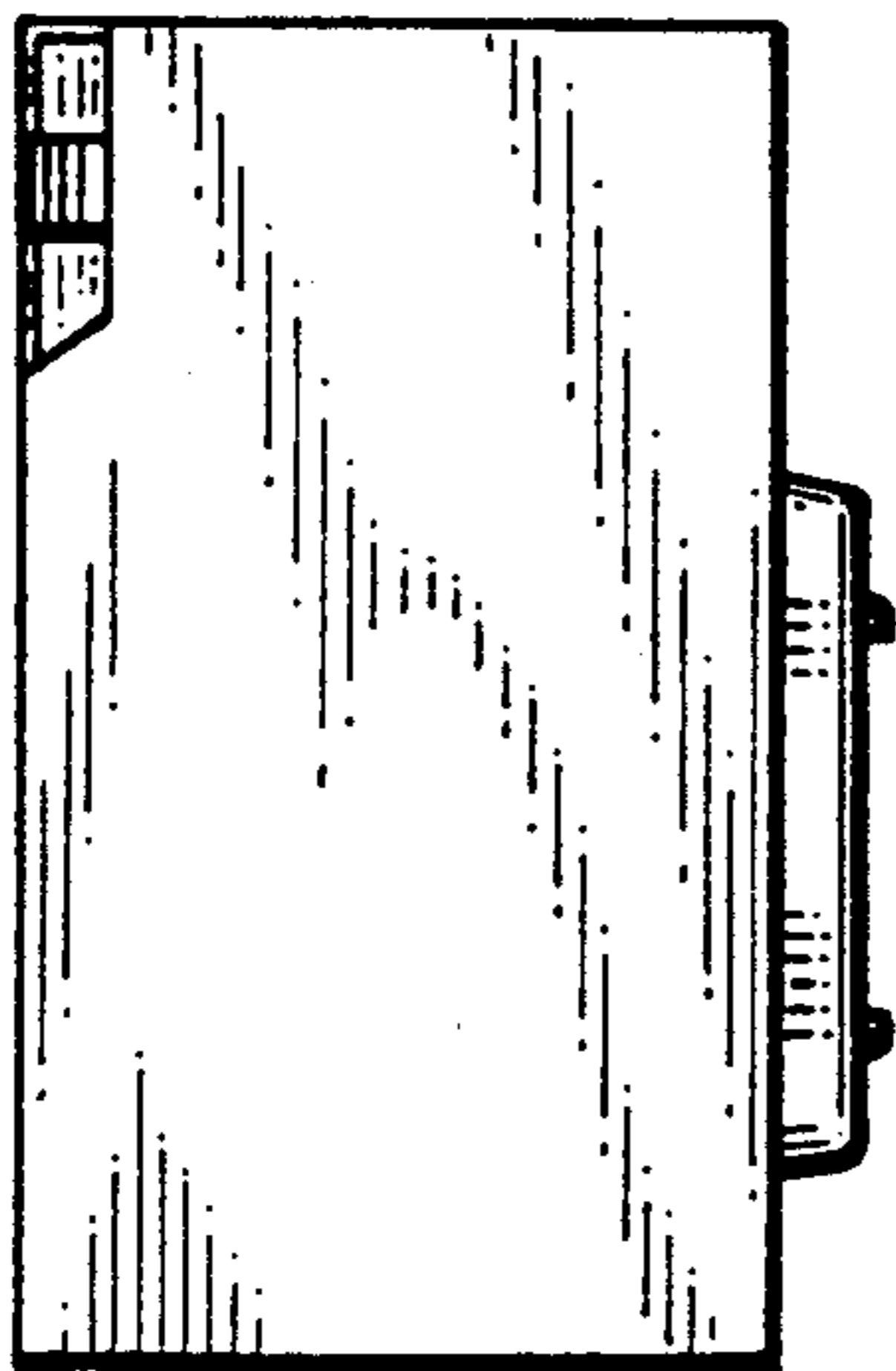
