FIG. 2 is a top plan view;

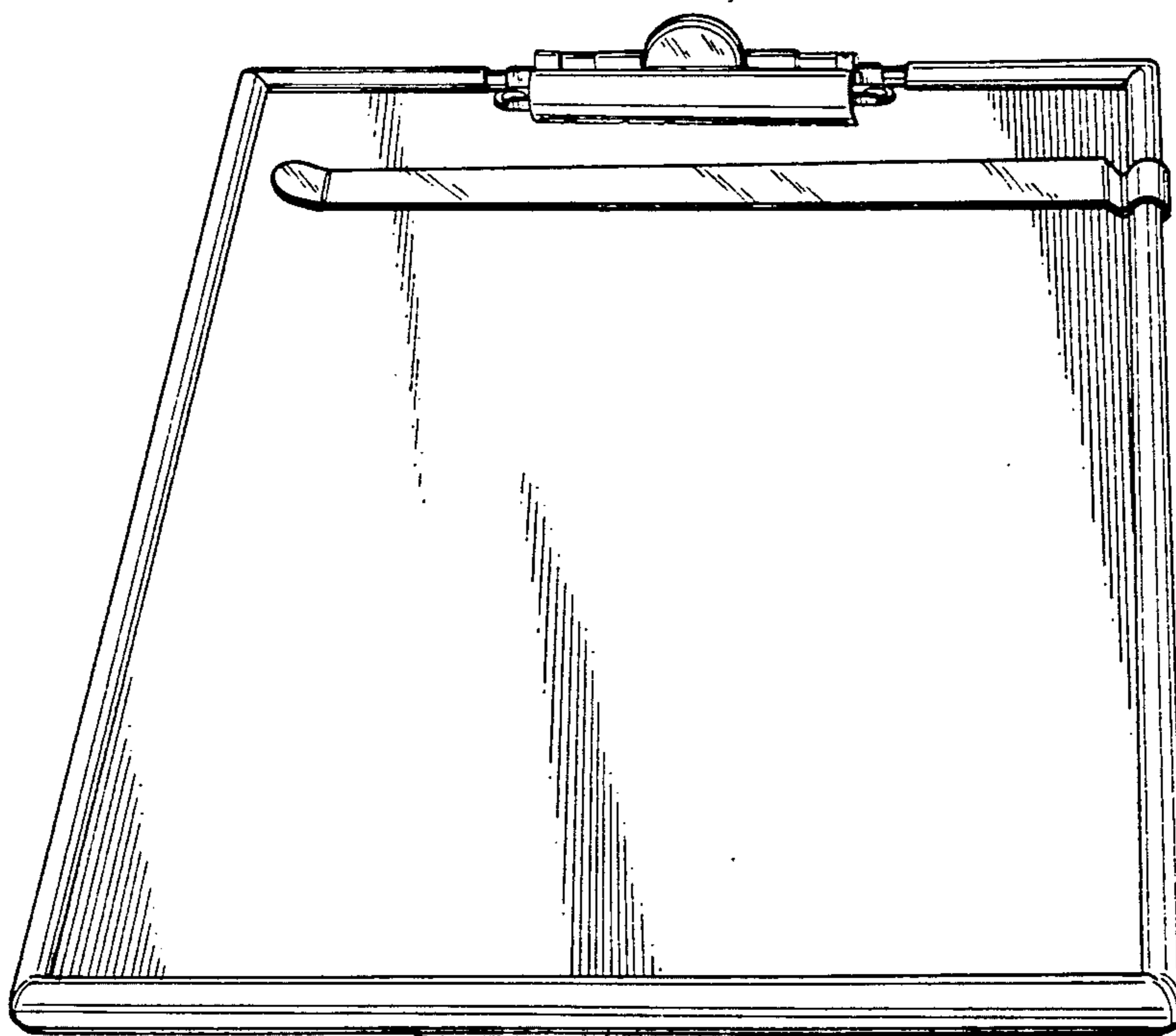
FIG. 3 is a bottom plan view;

FIG. 7 is a right side elevational view thereof.



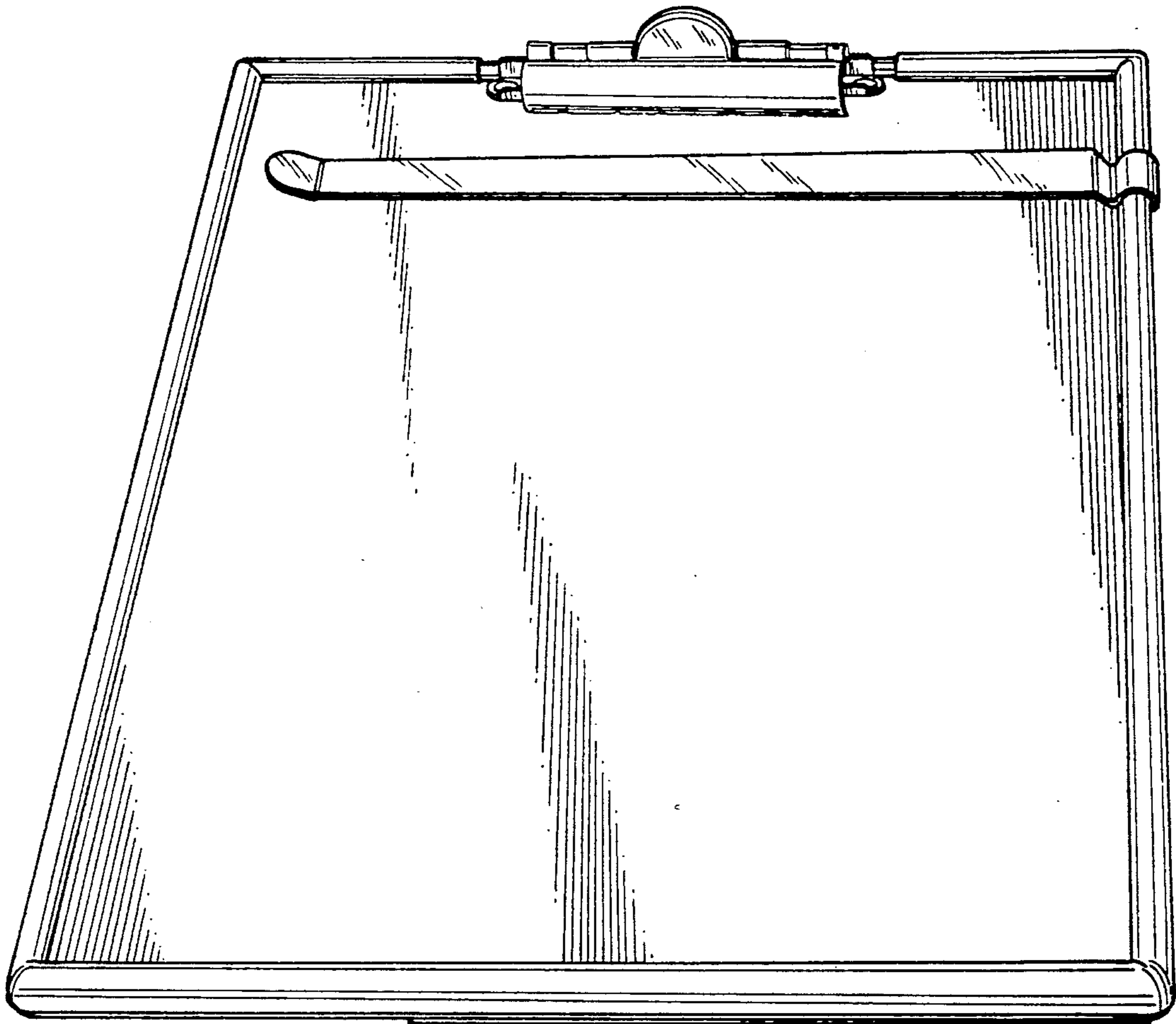

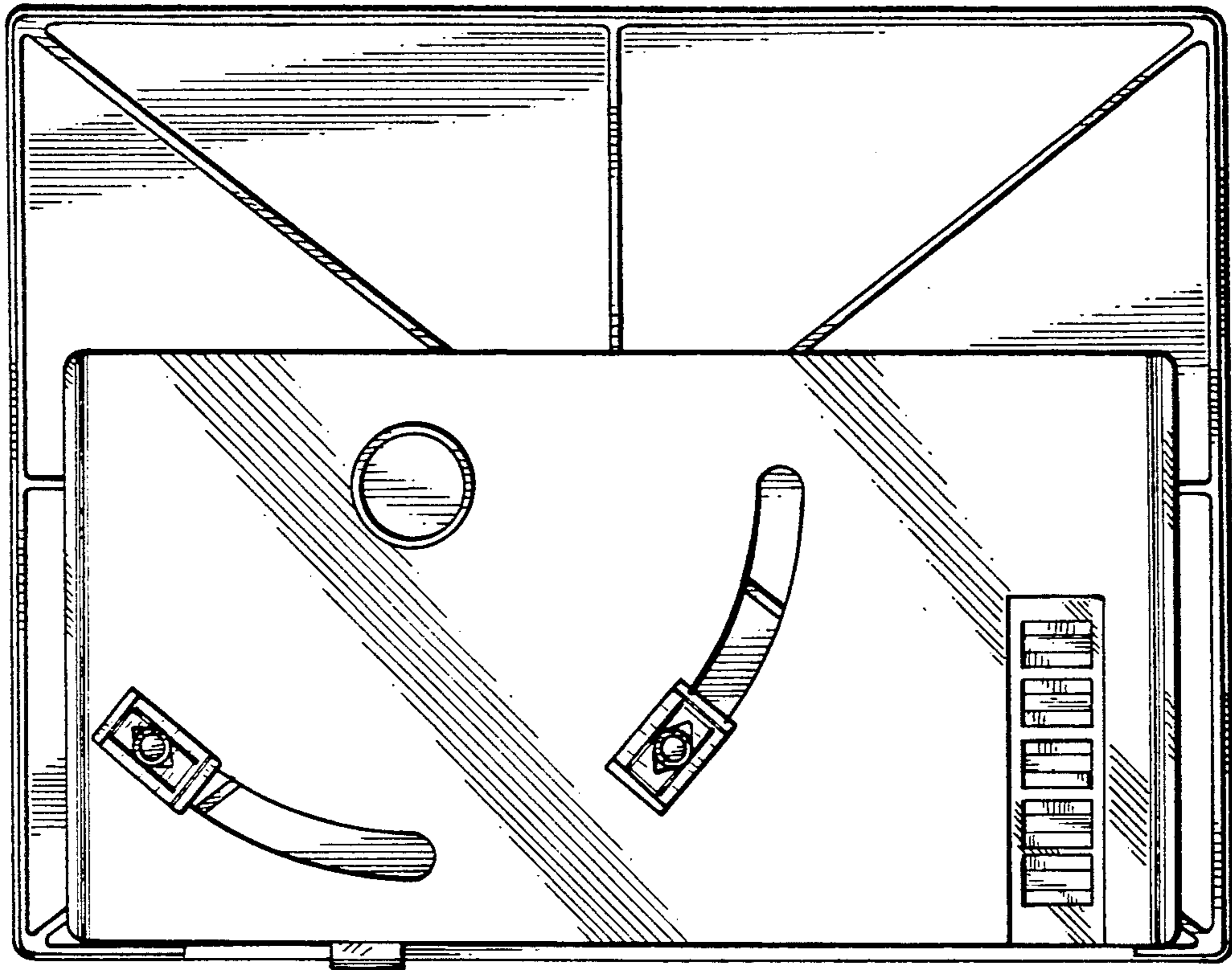

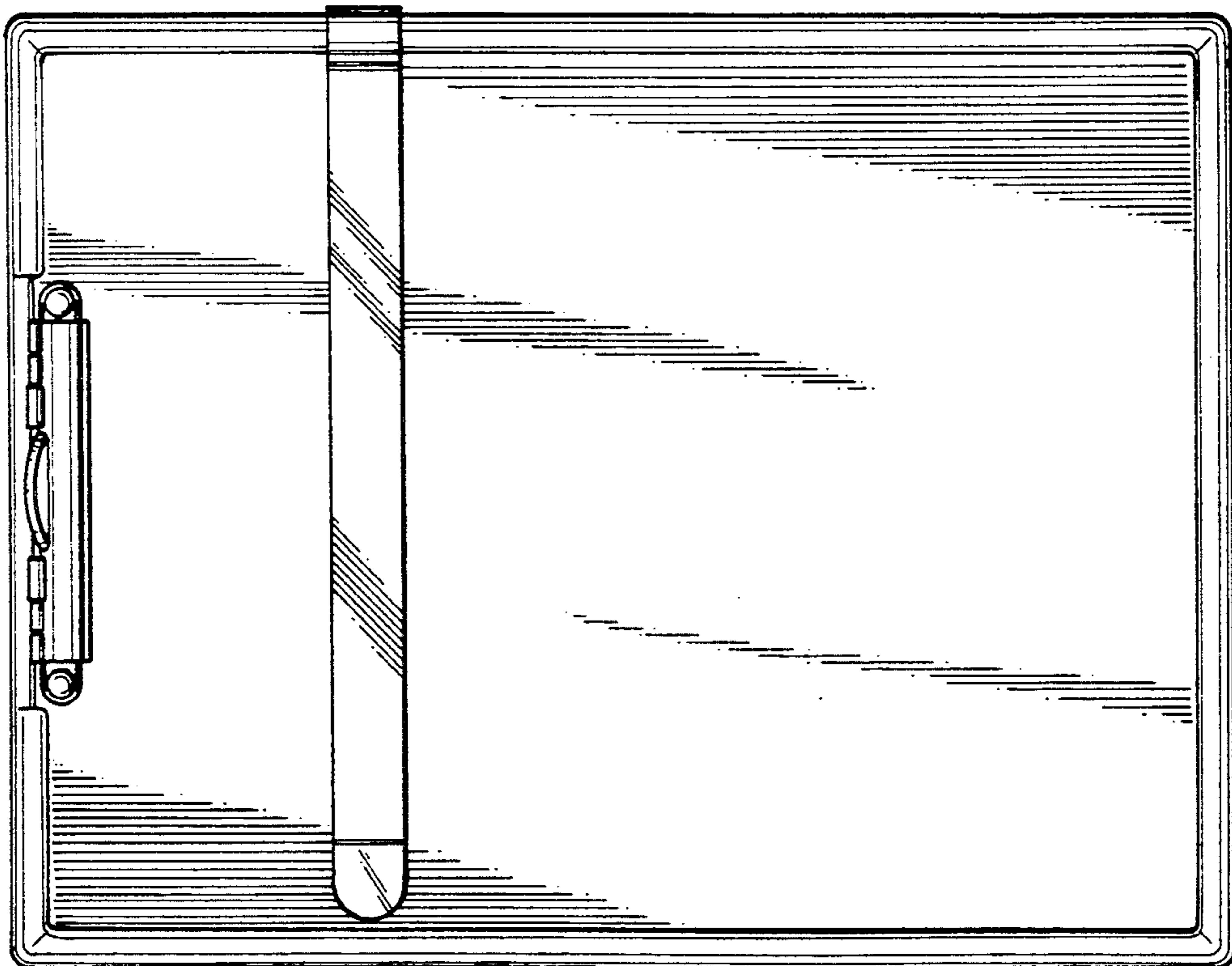

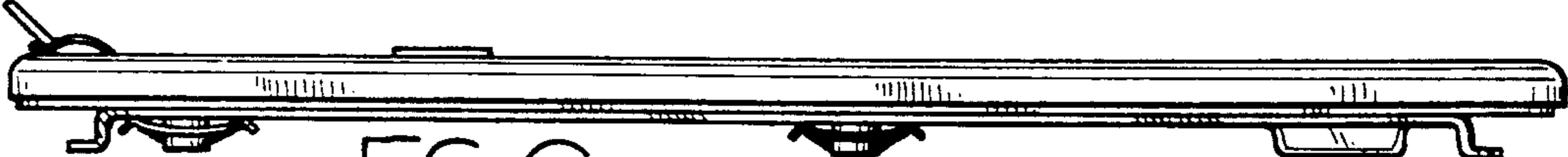

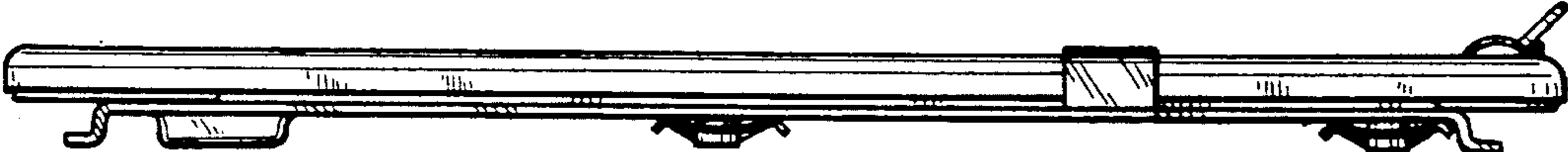
