The ornamental design for a bathtub or the like, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view taken from the top, front and right side of a bathtub or the like showing my new design;

FIG. 2 is a top plan view thereof;

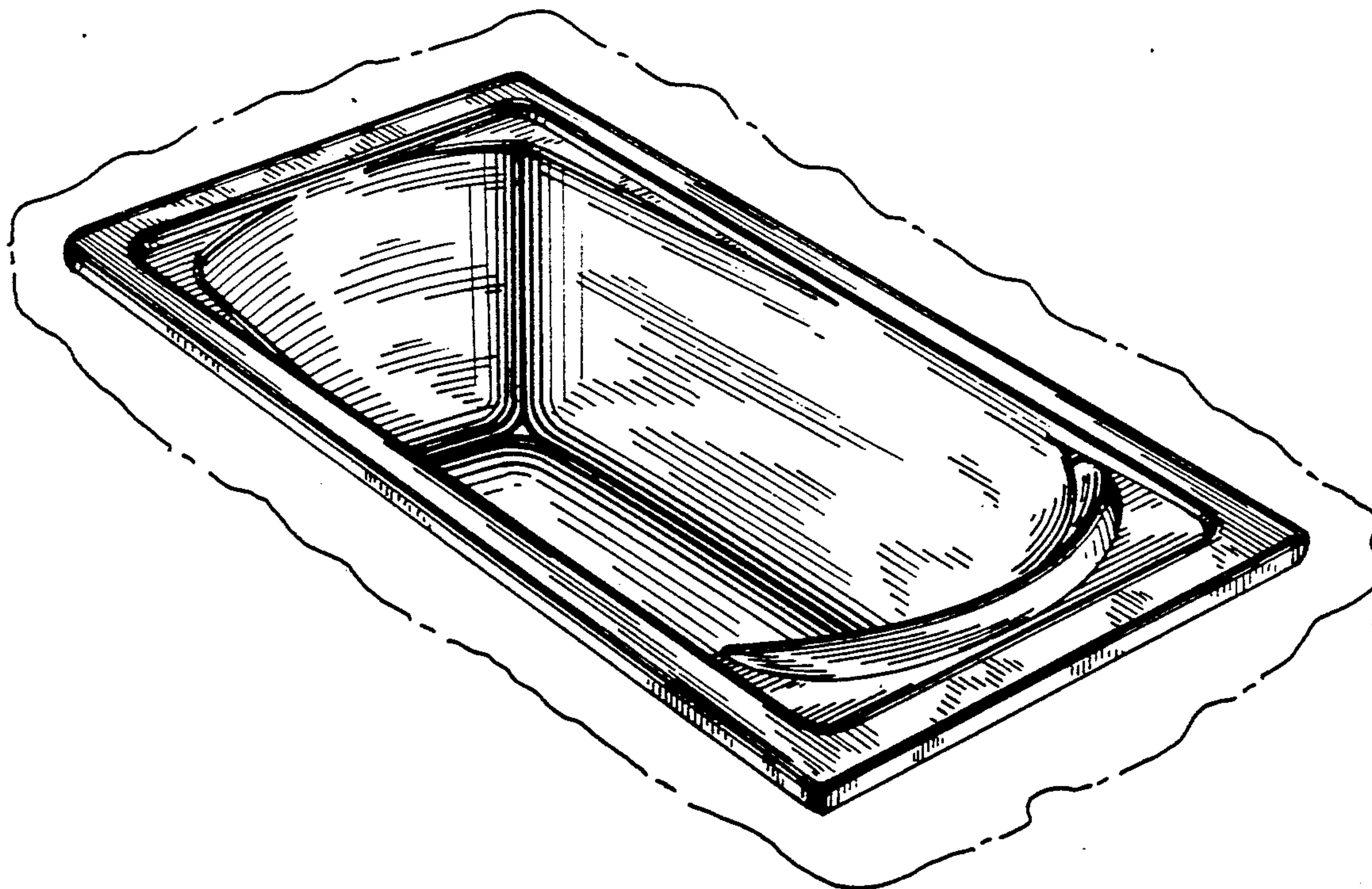
FIG. 3 is a cross-sectional view taken on line 3—3 of FIGS. 2 and 8;

FIG. 4 is a cross-sectional view taken on line 4—4 of FIG. 2;

FIG. 5 is a cross-sectional view taken on line 5—5 of FIG. 2; and,

FIG. 6 is a top plan view of a second embodiment thereof.

The broken line representation of a deck in FIG. 1 is for purposes of illustration only and forms no part of the claimed design.



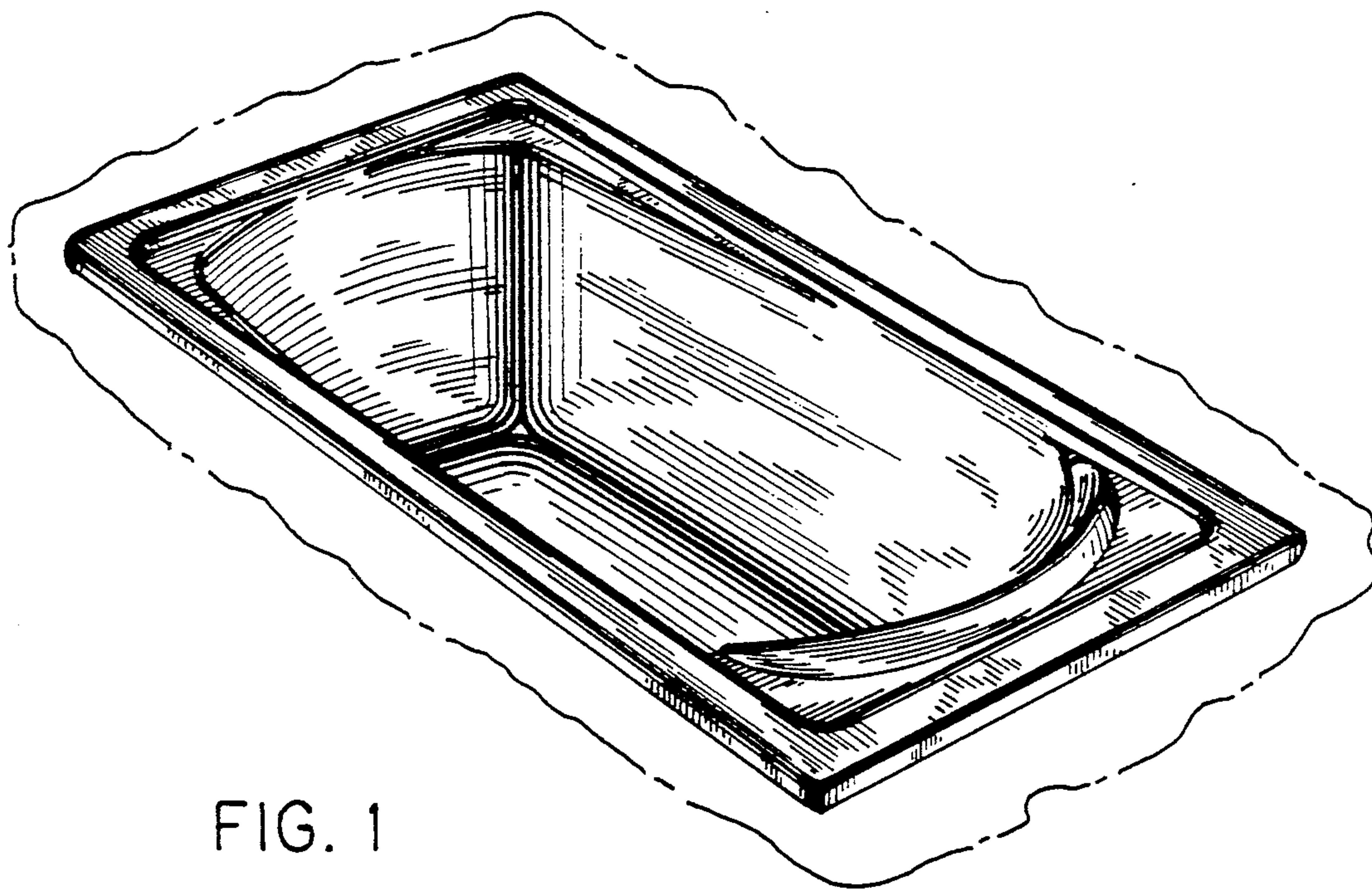

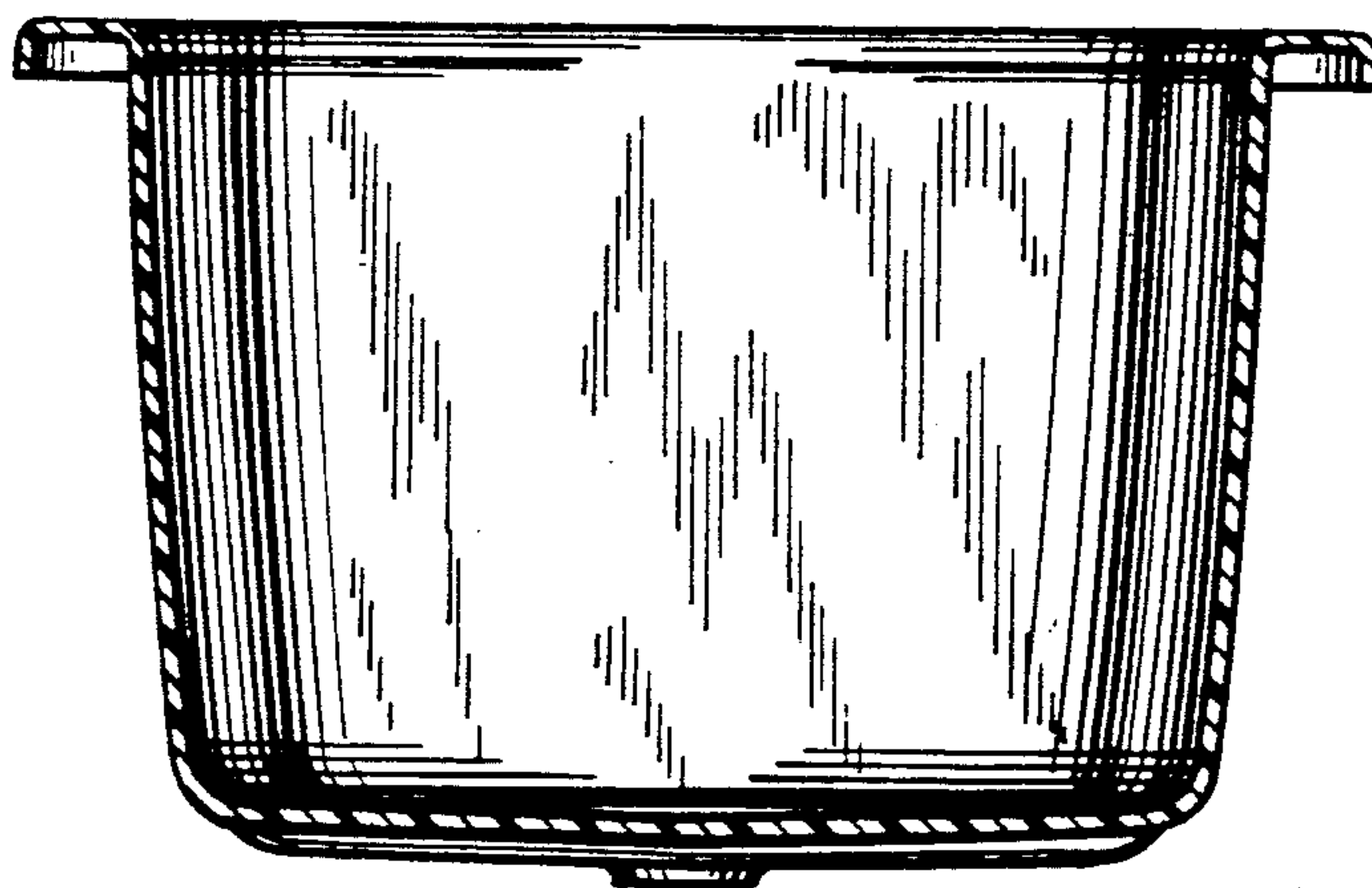

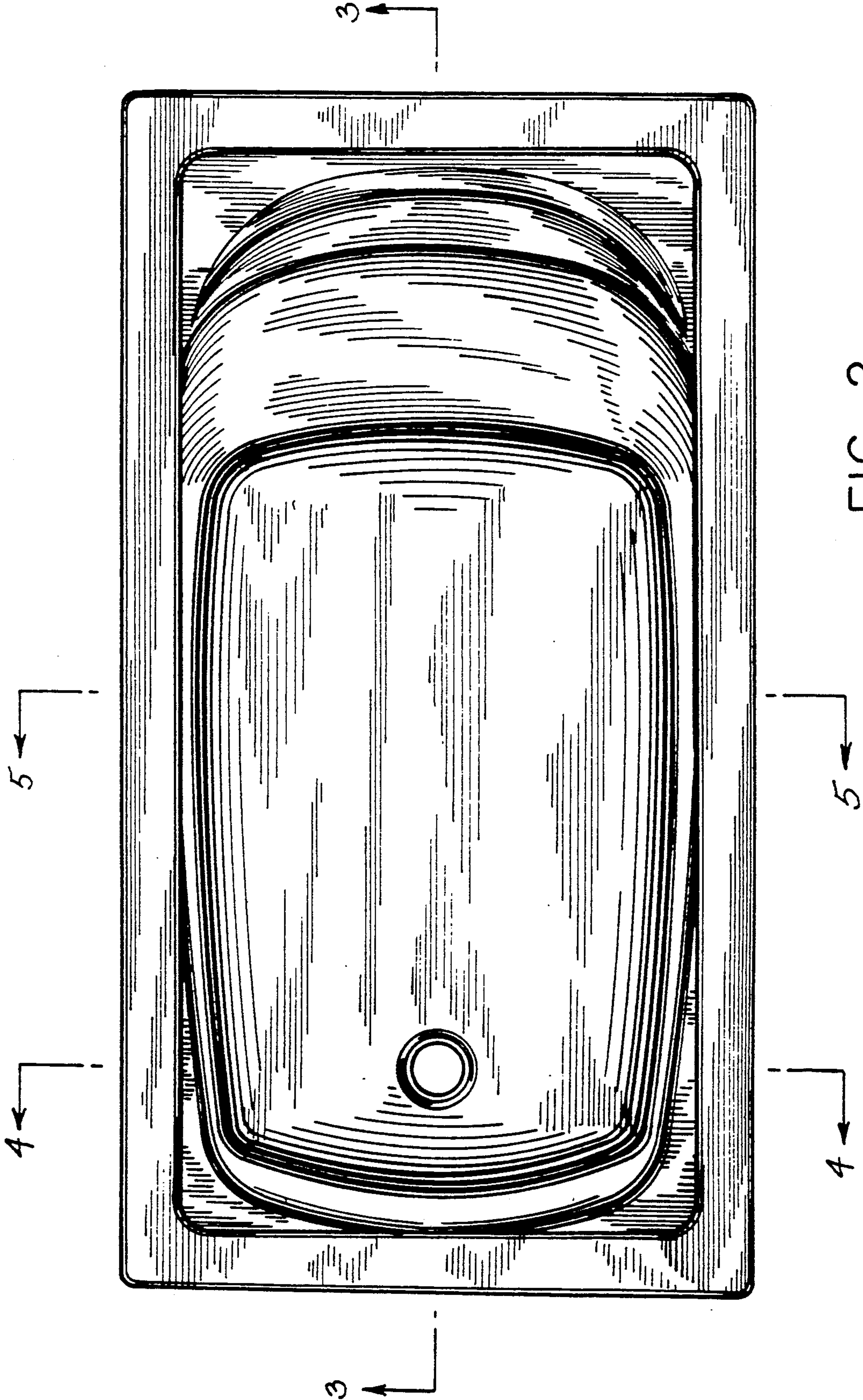

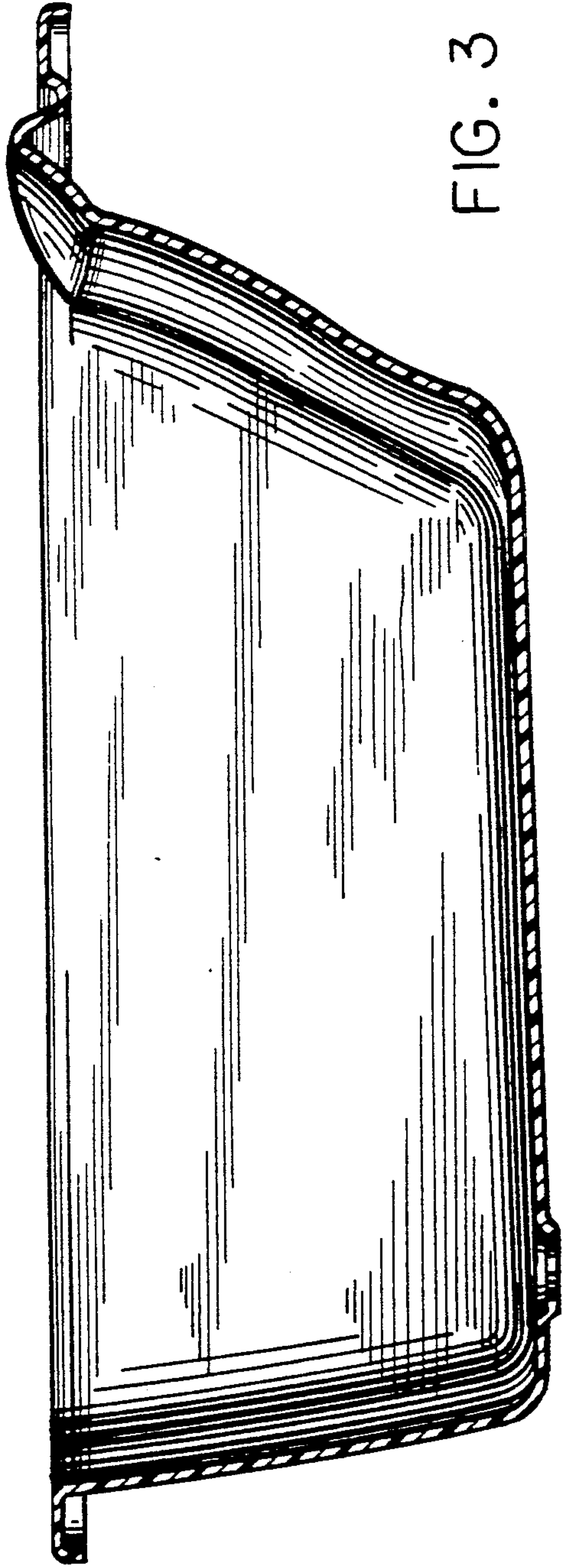

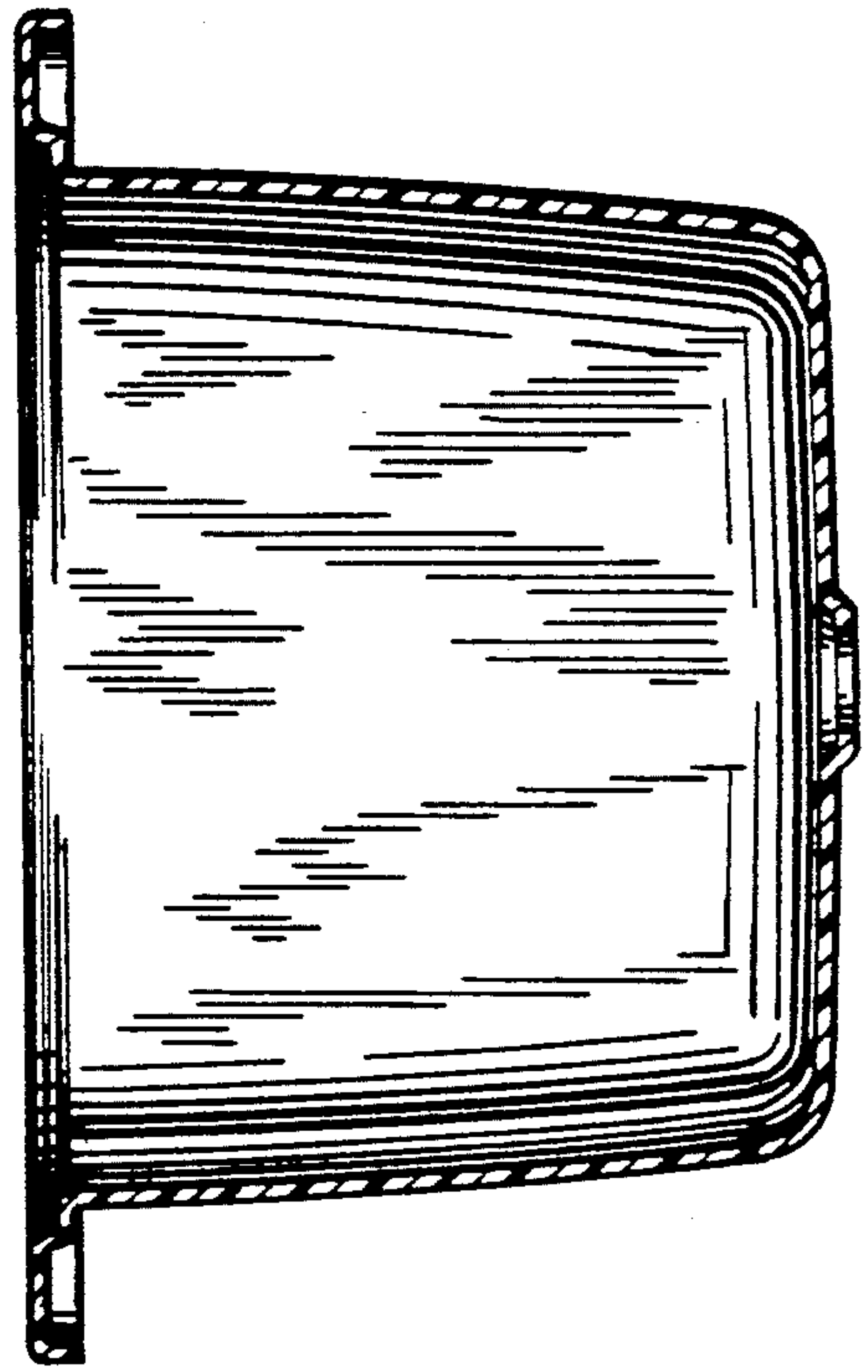

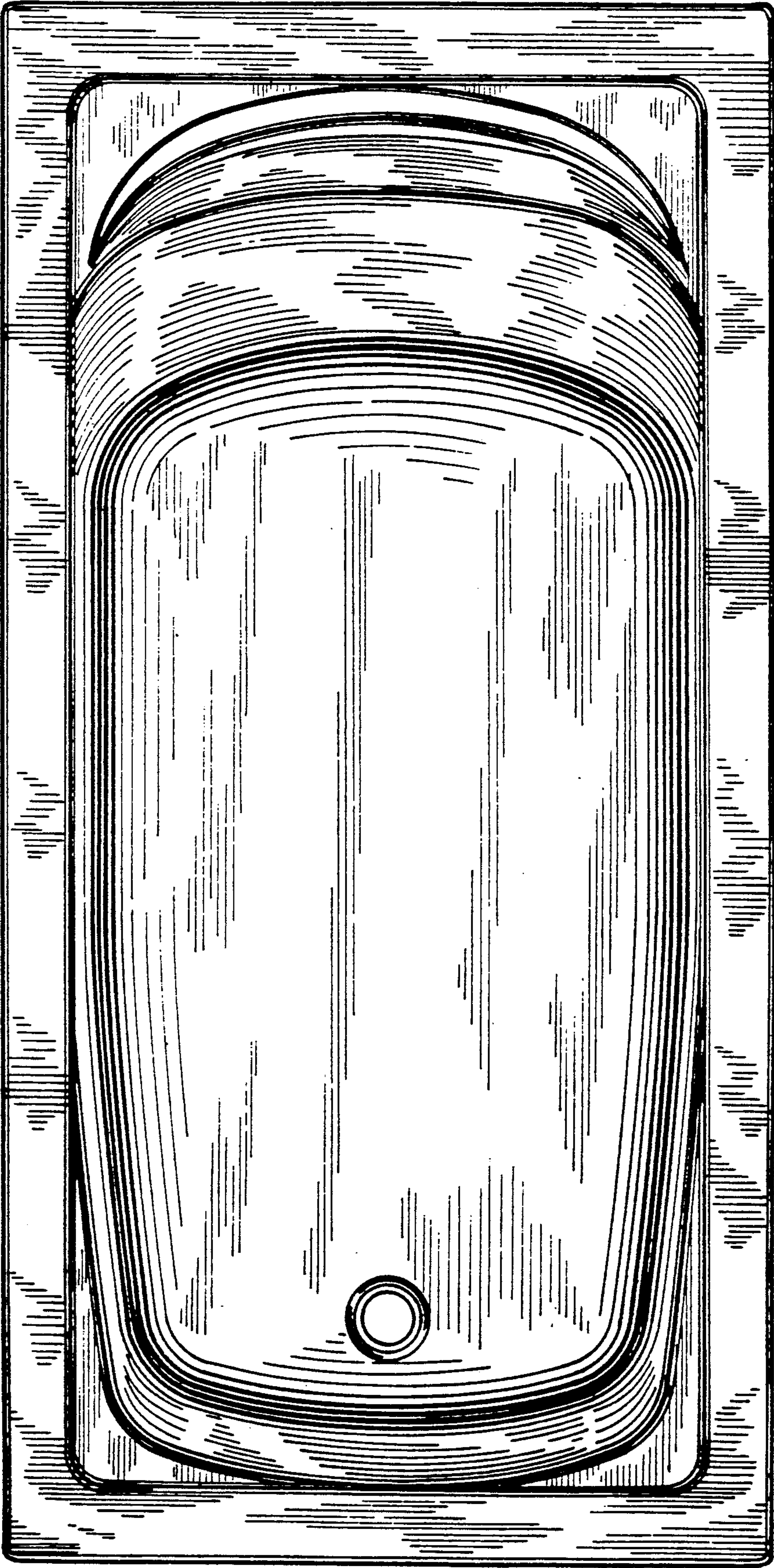
